One Phase Of Sleep Found To Regulate Anxiety In People With PTSD

S leep spindles, which are brief bursts of brain activity occurring during a phase of sleep, may regulate anxiety in people with post-traumatic stress disorder (PTSD), according to a new research.

Challenging the findings of a recent work by other researchers, which indicated that spindles may heighten intrusive and violent thoughts in people with PTSD, this study from University of California - San Francisco (UCSF), US, throws light on their role in alleviating anxiety in PTSD as well as in the transfer of new information to longer-term memory storage.


"These findings may be meaningful not only for people with PTSD, but possibly for those with anxiety disorders," said senior author Anne Richards, of the UCSF Department of Psychiatry and Behavioral Sciences.

She said that there were non-invasive ways to harness the benefits of this sleep stage to provide relief from symptoms.

The findings are published in the journal Biological Psychiatry: Cognitive Neuroscience and Neuroimaging.

The researchers studied the spindles during non-rapid eye movement 2 (NREM2) sleep, the phase of sleep when they mainly occur, which comprises about 50 per cent of total sleep, in 45 participants who had all experienced combat or noncombat trauma.

Approximately half had moderate symptoms of PTSD and the other half had milder symptoms or were asymptomatic. They were made to attend a "stress visit" in which they were shown images of violent scenes, such as accidents, war violence, and human and animal injury or mutilation, prior to a lab-monitored nap that took place about two hours later.



• The researchers found that spindle rate frequency was higher during the stress visit than during the control visit, thus, providing compelling evidence of stress contributing to spindle-specific sleep rhythm changes, according to Nikhilesh Natraj of the UCSF Department of Neurology.

Anxiety surveys were conducted immediately after exposure to the images as well as after the nap when recall of the images was tested. The researchers also compared anxiety levels in the stress visit to those in a control visit without exposure to these images.

The researchers found that spindle rate frequency was higher during the stress visit than during the control visit, thus, providing compelling evidence of stress contributing to spindle-specific sleep rhythm changes, according to Nikhilesh Natraj of the UCSE Department of Neuralegy.

UCSF Department of Neurology. Notably, in participants with greater PTSD symptoms, the increased spindle frequency after stress exposure reduced anxiety post-nap.

The naps in the study took place shortly after exposure to violent imag-

es - raising a question about whether sleep occurring days or weeks after trauma will have the same therapeutic effect.

The researchers think this is likely and point to interventions such as prescription drugs like Ambien and electrical brain stimulation that could trigger the spindles associated with NREM2 sleep and benefit patients with stress and anxiety disorders.

Climate Change Impact On Larger, Migratory Birds More Worrisome: Study

A new study has found climate change to have more worrisome effects on larger birds and migratory birds than on smaller, sedentary species.

Researchers on this international study assessed changes in the annual production of young by female breeders in 201 populations of 104 bird species covering all continents between 1970 and 2019 and found that climatic changes affect offspring production through compounded effects on ecological and life history traits of species.

They have published their findings in the journal Proceedings of the National Academy of Sciences (PNAS).

Overall, they said in the study, average offspring production has declined in recent decades, with 56.7 per cent of the populations showing a declining trend and 43.3 per cent exhibiting an increase. However, considerable differences were found among species and populations.

The researchers found that migratory and largerbodied species experienced reduced offspring production with increasing temperatures during the chickrearing period, whereas sedentary smaller-bodied, species tended to produce more offspring."The study suggested that the body mass is one of the key factors for the adaptability towards climate change, in which the larger body sized species are struggling to synchronise with weather anomalies compared to the small and sedentary species," said J. Pandiyan, Assistant Professor. Department of Zoology and Wildlife Biology, Anbanathapuram Vahaira Charities College, Tamil Nadu.

Further, multi-brooded species showed increased breeding success with increasing temperatures, whereas rising temperatures were unrelated to reproductive success in single-brooded species, the researchers said.

The study also found that the egg laying process has decreased with the preponing of egg laying mechanisms among the bird species. The study explained that the clutch size (number

that the clutch size (number of eggs per nest) and success (fledgling and nestling) are positively influenced by

various ecological factors. However, the offspring production, clutch size, nest success, date of first egg, egg laying process are examined towards various ecological factors in which the temperature influenced the offspring production, clutch size and nest success.

"The global warning and the elements causing climate change should be measured, monitored and managed properly to save the species, which are facing vulnerability otherwise, existence of biodiversity especially intolerable species would be extinct from the world due to human life style," said Pandiyan.

However, Pandiyan said, the study did not deeply investigate the bird population in the Asiatic region, including those in India. The migratory species birds are using diversity of habitat in India as a vital stop over sites or refuel sites during their migration, he said, and therefore, the status of migratory birds in India must be studied.

"We demand capital punishment to those involved in the ghastly act and at the same time appeal to the Pakistan government to rise against the issue and act stringently against terrorists so that such incidents that bring disrepute to Muslims are not repeated in the future," protesters added.

RINAGAR: Even as the patient who was operated upon at the Sher-i-Kashmir Institute of Medical Sciences (SKIMS) for removal of suspected stones is stable, the controversy surrounding the surgery lingers on. While the doctors are almost unanimous there was no negligence in the matter, the patient's relatives are sore at the way an un-necessary surgery was forced on her.

According to reports, Aaliya Liaqat w/o Liaqat Hussein of Court road here was operated upon Saturday for suspected stones in her kidneys though repeated X-rays taken on the fateful day did not show any de nite presence of the calculus. Her relatives alleged the surgery was not warranted after the X—rays were negative. The surgery evoked instant protest from the relatives of patient, mother of an 8-month old baby. They alleged the head of concerned department, Dr' Baldev Singh, had insisted to have the surgery performed. They accused the doctor of having threatened them following a tiff a few days earlier.

In a communication to Kashmir Observer, Dr Singh denied he had conducted the operation and described the report, circulated by CNS news agency, as baseless and aimed at maligning his image. He said, "The fact is that I had advised an X-ray for the patient before any surgical intervention but a consultant urologist conducted the said surgery with my knowledge". Later on, he said, "on the request of Director SKIMS I helped the concerned urologist in closing the patient and stent was put for effective drainage". Talking to Observer News Service, Dr Singh denied there was

Talking to Öbserver News Service, Dr Singh denied there was any negligence on the part of doctors. 'These things can happen in the medical profession'', he said, adding the surgery was done with the written consent of a close relative of the Patient. He said the patient was admitted by Dr Tajamul the consultant who was not required to seek any directive from him. Denying that he has threatened the patients' relative, Dr. Singh Said he might have told them to leave the ward during the morning round.

When contacted Dr, Tajamul Fazili told Observer News Service that patients was admitted by Dr. Singh. The X-rays of the obese patient had shown stones at the OPD stage and admitted accordingly. On Saturday he said the first two X-rays revealed thre were no stones. A third one was taken with double exposure which showed a shadow coinciding with the X-ray taken at the 'OPD stage'. Dr Fazili said, "Most probably it was a friable (soft) stone which got crushed and passed down the ureter during the surgical manipulation." He said a small stent was kept inside to ensure safe passage of any small bit.

Dr Fazili said 'Saturday was utilised as an additional theatre day to make good for the hartal days. "We were convinced the patient did have stones. But when I could not locate it, I sought help from Dr Singh", he said.

The director of the Institute, Prof Me'raj-ud-din, said there was nothing abnormal about the surgery nor was there any negligence on the part of doctors. "The stone must have been friable going down the ureter and the gravel coming out of its own", he said. He ruled out any enquiry into the episode. Joining the issue, a close relative of the patient, pleading anonymity, told Observer News Service the surgery was absolutely uncalled for the moment the doctors knew there was no stone. The written consent had been given when she was brought to operation theatre in the morning. However, she was turned back from there and asked to get in her X—ray done. After that an anesthesia was given to her for the second time and the surgery conducted despite the relatives' pleas against it and without seeking a fresh consent from them. The relative said the patient had suffered heavy blood loss which could have proved fatal. The relative alleged Dr Singh had visited the ward against asking them to return the X-rays which were lying with them.

Electricity – Between Hooks and Hikes

The authorities **G G** have often blamed insufficient generation, the vagaries of the weather, theft and pilferage and other malpractices on part of consumers as prima facie reasons for the energy deficit of the state. On the other hand, masses have been aghast over erratic power cuts, acute electricity shortage during winters, irrational and exorbitant tariffs and the adoption of means and measures by the department which are antithetical to the climatology and the economy of the place we live in

S mart meters have arrived ahead of "Smart City" in Srinagar, leaving consumers fuming and the poorer sections lamenting the move. For a long time now, Kashmir has been defined as the hub of hydro-electric power in India and the energy mapping has pegged the hydroelectric potential of the state around a mammoth figure of 20,000 MW. But all this abundance has not helped ease the energy crisis of the state.

The authorities have often blamed insufficient generation, the vagaries of the weather, theft and pilferage and other malpractices on part of consumers as prima facie reasons for the energy deficit of the state. On the other hand, masses have been aghast over erratic power cuts, acute electricity shortage during winters, irrational and exorbitant tariffs and the adoption of means and measures by the department which are antithetical to the climatology and the economy of the place we live in. Fixing this imbroglio calls for an analysis and evaluation of both the ends of the Producer-Consumer chain and spotlighting the flaws and malpractices on part of each to escape the recursive cycle of energy vacuums.

The recent drive of smart-meter installation was supplemented by the revision of tariffs, hiking both the fixed and variable charges. The public resentment against both the moves was contained by the age old slogan of "Electricity round the clock", but what was seen was effectively the worst form of energy curtailment and the valley was literally plunged into darkness for the entire winter span - the period when energy requirements peak up and electricity becomes indispensable for survival. These moves, irrespective of their legitimacy and rationale, have come as back-burden to the masses and a welfare state like ours ought to have shouldered the burden of its citizens, instead of causing a spike therein. It has been emphatically said in the report accompanying tariff hikes that the tariff still remains lower than neighbouring states like Haryana, Punjab and others. This is a doubly fallible line of reasoning for the fact that the economic profile of these states is better than that of the Kashmir and the electricity available therein usually comes from thermal plants, which incur heavy running costs, in opposition to the hydroelectric power predominant in Kashmir with no running cost.

A document prepared by the high power committee and released by the then government of Jammu and Kashmir revealed in 2016 that the



transmission and distribution losses amounted to the gargantuan 55% of the production. This is crudely analogous to purchasing 100 eggs from the market and spoiling 55 on the way – wasting more than half of the resources in the transit. This requires the immediate structural up gradation of the existing T&D networks not only to minimise losses they presently incur, but to also make them future proof and improve their energy transmission capability. The aforesaid has majorly analysed the production-end-dynamics of the electricity route and it only represents half the picture. Once the distribution networks deliver electricity at the consumer terminals a more diverse and nuanced mechanism pops up and the multidimensional components of the consumption matrix call for the corrective measures of diverse forms. It must be understood that our sense of energy consumption is pathetically backward and ill formed by all means and measures. Recall the energy consumption pattern - leaving the water boiling for hours, the pressing iron plugged without reason and rhyme, the bulbs switched on during the broad daylight and a host of other malpractices which have now become a norm for us, but which are in fact regressive and ill founded.

This is compounded by the malice of pilferage and electricity theft. Despite all the measures taken by the department in terms of constituting inspection squads, levying fines on those found guilty, this habit of pilferage isn't going away and is a major obstacle towards the realisation of efficient energy deliverance. Another computing nuisance posed by the consumers for the department is that the consumers consume much more than the agreement made with the department – this not only creates temporary spikes in the load but also drastically impacts the load forecasting. What we have tried is an attempt at presenting the scenario of electricity and the factors which lead to its scarcity and the wastage. In an attempt to create a better energy scenario, both the department and the consumers need to work on the respective areas delineated above. That may help us towards energy security and sustainability.

Beyond The 'Fastest-Growing Economy' Tag

While the economic growth CAGR of 3.1% over the 2019 level is impressive for India, the fact is that the growth rate needs to be a lot higher to generate the jobs needed.

he epithet of 'fastest-growing economy' for India has been a confidence-booster, especially since the world economy is poised for a major slowdown in 2023, according to the International Monetary Fund (IMF). While the IMF forecasts 5.9% growth for India in FY2023 against RBI's 6.5%, the number is still very impressive. Without going into the intrinsic quality of the growth rate of 7% or it's thereabouts for 2022, it would be interesting to compare growth rates with other countries.

Based on IMF data, what strikes us is that there are some smaller economies that are part of the group of emerging economies which also registered fairly impressive growth rates in 2022. Ireland, for example, is the fastestgrowing country with 12% recorded for the year. It would not have been significant but for the fact that it was part of the infamous PIGS group which was responsible for the euro crisis in the early part of last decade. In fact, growth was very impressive even during 2020, the Covid year, at 6.2%. Quite clearly, being small has its advantages.

The other three countries that are much smaller in size than India and had impressive growth rates in 2022 were Philippines (7.6%), Malaysia (8.7%) and Bangladesh (7.1%). A comparison with these nations may not be proper but should be recognised.

Single-year comparisons can always be misleading as base effects play a major role. Such distortions began in 2020, when Covid ensured lockdowns of various magnitudes across several na-



tions. This was the time when negative growth was the norm is most economies as economic activity had halted for a period of 2-4 months depending on the intensity of the disease there. It was coincidental that no country had an alternative solution to a lockdown, and this caused GDP to fall.

Not surprisingly, as countries started to come out from the lockdowns, there was a tendency for the growth rates to get pushed up due to the negative base effect. Therefore, positive effects were felt across the board in 2021 and, further, in 2022. This added impetus to these smaller nations in 2022.

In 2020, negative growth was the norm. Turkey, Taiwan, Bangladesh, China and Ireland were the only nations not to witness a fall in GDP as growth rates were positive. The UK witnessed a 11% de-growth as did Spain (11.3%). This helped bring about buoyant growth in 2021 (7.6% and 5.5%, respectively) as well as 2022. Growth in the UK was 4% and 5.5% in Spain in 2022. But the UK will draw little comfort from the same as it is expected to register negative growth in 2023 once again.

Argentina witnessed 9.9% degrowth in 2020 and 10.4% and 5.2% in 2021 and 2022, respectively. Even in the case of US, growth fell by 2.8% in 2020 but recovered to 5.9% in 2021 before moderating to 2.1% in 2022. Therefore, the important conclusion is that growth rates over 2021 have a base effect—this has propped up growth numbers across countries.

How does then one look at growth rates, given that base effects distort numbers in both directions? One way is to look at growth over a neutral year, say 2019. By calculating a compound growth rate for these nations a better picture emerges on the recovery pro-

cess. Here the results are interesting as the growth now pertains to average annual for a period of three years.

Ireland continues to be the best performer with 10.5% CAGR growth. This is followed by Turkey with 6.2%, Bangladesh 5.8%, Taiwan 4.1%, China 4.5% and India 3.1% (this will be slightly higher if 2022 is taken at 7% instead of 6.8% as per IMF). The Indian performance is still very impressive, given, other than China, the countries in the pool are much smaller to warrant comparison.

India would rank third in terms of size going by PPP, with China being the

largest. Turkey would be around 29% of India's GDP and is the largest among the other nations which have witnessed higher growth rates. Taiwan is around 12% the size of India, Bangladesh 10% and Philippines 6%. Intuitively, it may be seen that with a smaller size of GDP it is easier to post higher growth rates, which is what has happened for the smaller nations.

While a 3.1% CAGR for economic growth for three years is creditable, it will still take some time for India to clock the 8% growth rate that it requires on a sustained basis to create more jobs and ensure that poverty is under check. Job creation is important, given, the debated on whether poverty has come down or not notwithstanding, the fact that the government gave 'free food' under the Pradhan Mantri Garib Kalyan Yojana till March 2023 to over 800 million indicates that the number of needy requiring support from the government is high. This can only be addressed by creating more jobs.

Hence, while the epithet of fastestgrowing economy should be inspirational, there is still a lot of work to be done and should not lead to complacency. Growth of 6-6.5% in FY24 is achievable but will only be improving, albeit marginally, the status quo.

Myth Of Two Nation Theory Pakistan: Origins, Identity and Future

Pervez Hoodbhoy's latest book makes a compelling claim that the ideological foundations of the Pakistani state have to be rewired and the two-nation theory must be replaced with a more inclusive brand of nationalism.

r. Pervez Hoodbhoy is a prominent nuclear scientist, wellknown author, columnist, and human rights activist. In his latest volume, he presents robust and provocative arguments in what can only be described as a daring, and must-read book. He sets the stage in his introduction by asking striking questions: was the partition of India worth the price in Muslim blood? What is the ideology of Pakistan, and why does it matter? Why couldn't Pakistan become an Islamic state? Why is Pakistan a praetorian state? Just what are Pakistanis, and how do they self-identify?

In August 1947, the British colonial administration presided over the hasty division of the Indian subcontinent into two independent nation-states: Hindu-majority India and Muslim-majority Pakistan. Religious communities that had coexisted for almost a millennium were torn asunder during the madness of the partition. It forced millions of Muslims to move to West and East Pakistan, while millions of Hindus and Sikhs headed for India.

Hundreds of thousands did not survive the communal massacres, arson, forced conversions, mass abductions, and savage sexual lence. The weight of this tragic history, hatred, and self-interest still bedevils relations between India and Pakistan. And minorities still live in fear of the majority in India and Pakistan.

nations. But, after the colonial conquest, India lost its diversity in just a couple of centuries. The basis for the partition that Hindus and Muslims are separate nations has remained contentious. The fact that most Muslims did not cross over to Pakistan in 1947 and represent around 15% of India today defies the argument of a deep civilizational divide, or that Muslims were inherently incompatible with India as a motherland.

The author argues that contrary to official history, the case for the division of India, based on the flawed premise that Hindu and Muslim were separate nations, known as the two-nation theory, was hugely speeded up by the British colonialists and the political and religious leaders of the period to serve their narrow interests. He suggests that just religion is not a sufficient reason for the existence of Pakistan and that there is more to a nation than just religion. He argues that seventy-five years later, if Pakistan is to survive and prosper, the two-nation theory will have to be abandoned in favor of a more inclusive identity.

Hoodbhoy states: "The myth of the two-nation theory emerged towards the tail end of the British Raj and had both Muslim and Hindu versions. With enormous explosive power, these myths fueled political movements that ultimately led to new political boundaries and reconfiguring the Indian subcontinent." The invention of rival Muslim and Hindu variants of the two-nation theory served diametrically opposite purposes: one was to split India, and the other was to impose Hindu hegemony on a united India.

Undoubtedly, the defining of 'communities' based on Muslim and Hindu religious identity and attached political representation quickly unraveled India's deeply intermixed and profoundly syncretic culture. The polarization of Hindus and Muslims and the growth of competing nationalisms led to the belief of many on both sides that adherents of the two religions couldn't live together peacefully. Yet, the events of 1971, which led to the creation of Bangladesh, suggest that ethnicity, language, and geography are more solid attributes of a sense

of nationhood than religion. The book dissects the pivotal role of the founders of Pakistan – educa tionist Syed Ahmed Khan, poet Muhammad Iqbal, and Muslim League leader Muhammad Ali Jinnah – in conceptualizing and propagating the two-nation theory. It offers the opposing view of noted skeptics of the Pakistan movement and the partition of India – pan-Islamist Abul A'la Maududi and Congress politicians Abul Kalam Azad and Abdul



PAKISTAN Origins, Identity and Future

Hoodbhoy makes a convincing case that Igbal and Maududi, who was a late convert to the Pakistan cause, have left a more lasting influence on Pakistan when compared to Syed and Jinnah because the country veered towards religious fundamentalism amid brief periods of modernization Mohandas Candhi and Jawaharlal Nehru have met a similar fate in India as Sardar Patel and Damodar Savarkar found favor with Hindu nationalists. One question crosses the book; what is Pakistan? How can one make sense of its identity, its reality, and its future? It discusses the official history of Pakistan that revolves around the Indus Valley Civilization, the Arab invasion of Sind under Muhammad bin Qasim, and the Delhi Sultanate. It is a non-Hindu version of history that ignores pluralism and cultural assimilation built over centuries of co-existence. And imagination, invention, and fable bind the past, present, and future to construct a purified Muslim identity. Hoodbhoy discusses why

The Objectives Resolution adopted in 1949 by all religious and secular groups saw the future constitution as one modeled on European constitutions following Islamic guidelines. Pakistan incorporated Islamic clauses in the 1956 and 1973 constitutions, but the constitutions "did not give any special privilege or exclusive power to the Ulema (religious scholars)."

Like Jinnah, who kept the idea of Pakistan ambiguous to attract a mass following, the tiny militarycivilian elite that controls Pakistan does not want to alarm its external Western and Arab patrons with talk of an Islamic state to ensure the flow of aid. The populace, with little stake in the system, has consistently rejected Islamic parties at the polls. client state of external powers instead of trusting the strength of its people and self-governing democracy.

Spineless politicians, a subservient judiciary, and an iron fisted civil service made military control and intervention easier. The military has developed like an octopus, with its tentacles firmly embedded in politics, economy, and society. It zealously guards Pakistan's ideology crafted around the ideas that Pakistan and Islam are in danger and that extreme centralization of power, militarization, and elimination of dissent can only contain this danger. Yet, the national security state has failed to remove national insecurities. In fact, the cost of maintaining the security state has pushed Pakistan dangerously close to the precipice of economic disaster.

Pakistan is in a state of confusion and unsure of itself. Created as a selfprofessed Muslim state, it rejected theocracy; it did not fully embrace political Islam. It flirted with democracy and Western constitutionalism, remained prone to military dictatorships, and seems resigned to a hybrid-democratic model, where the military calls the shots looking over pliant civilian governments.

The author discusses why Pakistan is a praetorian state. It is an intriguing question because there is no record in the narrative of the Pakistan movement to confirm that the founders of Pakistan created the country for its armed forces. Yet, very early on, Pakistan developed a fortress mentality and the uncompromising attitudes of a military state. It became introspective and defensive, tending to protectionism and determined to maintain a large military despite the prohibitive costs of doing so. So afraid of the erosion of national sovereignty, it became a of Pakistan is the shortest chapter in the book. The incoherent national ideology, the parasitic militarycivil-feudal elite, the rampaging Mullah, enforced religious homogeneity, and dogmatic thinking are the primary obstacles to building a modern state. Pakistan needs justice, fairness, and equal representation of all its citizens to progress. Hoodbhoy suggests replacing the failed two-nation theory with a Single Nation theory, keeping religion out of politics, and embracing science and technology. This would be a very tall order indeed.

In conclusion, the book makes a unique scholarly contribution to South Asia and Pakistan studies. It is a well-argued book – contesting the standard Pakistani social science texts. Whether one agrees with it or not, the reader will find it worth the while.

Hoodbhoy emphatically rejects the idea that India had separate Muslim and Hindu nations in the distant past. He says there were zero

persistent clamors, Pakistan couldn't become an Islamic State. The Qur'an or the Hadith do not specify an Islamic state, nor are there examples of Islamic states in history. Jinnah made vague statements that Pakistan wouldn't be a theocracy, and that the Qur'an and the Prophet's life were the primary sources of guidance for Pakistan's future.

How You Can Use Islamic Practices for Emotional Regulation

Tave you ever been absolutely enraged with someone, and they volunteer a homicide-inducing suggestion such as 'would you just calm down?

I can only imagine what your reaction must have been like. You're probably reliving it right now and laughing that crazy laugh that suggests wa'eed, a promise of retaliation. This interaction is a perfect example of what to avoid when a nervous system is dysregulated: tell it what to do. The eye-opening fact I came to learn a bit too late in life is that the state of your body creates your thoughts, rather than the other way around.

This means that an angry body will only create angry thoughts, whereas calm(er) thoughts will not make your body less angry. Instead, we should care for the body first, release the anger or anxiety or shame or whatever you're holding, and calmer thoughts will follow automatically. The good news is we already do many practices that are considered somatic, simply because we follow the Sunnah of our beloved Prophet 3.

This article aims to highlight many of the already existing benefits in some of the practices we already do. I continue an exploration into the relationship between dhikr and somatic practices). It represents a process of translation between parts of myself seemingly different yet never contradictory.

Here are five more instances where somatic therapy and Dhikr are intertwined:

Cultivating Wonder – Subhan Allah

A child is fascinated by things he sees for the first time, and we often find ourselves

jealous of that lightheartedness. Think about the last time you revelled at something with such wonder that it filled you with joy and you managed to forget that looming deadline for example. With a conscious effort, we can cultivate that sense of wonder again, precisely through the invocation of 'Subhan Allah'. 'Subhan Allah' allows for a re-enchant-

ment with the world. When we engage in a careful witnessing and paying attention to the little things, beyond the dhahir (apparent), we never fail to discover new meanings and become in awe of God's creation.

Consider a miracle that has become so commonplace we forget to give its due attention, like a particularly colorful sunset or a cluster of birds moving like one entity.

Beyond the cognitive effort of contemplation (tafakkur) that the invocation of 'Subhan Allah' allows, it can be considered as a somatic practice par excellence. If you say out loud the following invocations: Subhan Allah. alhamdulillah, astaghfir Allah, hasbiah Allah, vou'll notice a common feature – all these letters come from the throat. In fact, the letters Haz & Ha . & kha ż belong to the classification of 'throat letters' ensuring proper pronunciation in the principles of tajwid. These letters engage a constant stimulation of the Vagus Nerve in the throat area, which is similar to gargling - an effective somatic exercise that releases blocked energy in the vocal cords.

Cultivating Gratitude – Alhamdulillah

In the literature of psychotherapy, gratitude is hailed as the most healing practice for the nervous system. It is healing in two main wavs:

It allows us to cognitively shift our perception of a situation, and this helps us locate opportunities within the same event.

Similarly, in a somatic sense, the practice of gratitude calms our nervous system and brings it out of the state of fight/flight and into a state of safety.

This is because we cannot embody two opposite feelings at the same time, which means that we cannot be fearful and also grateful.

Once we allow gratitude to fill our body and mind, we can easily quieten the chatter of our mind. A perpetual practice of gratitude alters the chemical make-up of our body. So when we practise being grateful often enough, it starts to become our default. Dhikr is an excellent way to achieve this – the more we utter 'Alhamdulillah', as we connect each blessing in our life to a bead in our misbaha, the lighter and more peaceful we feel.

Cultivating Trust – Allahu Akbar

There is a fine line between planning to the best of your ability and trusting that Allah's plan will turn out better than you ever expected. It is often difficult to walk this line without falling to either side, because we are only human. This constant rumination is a symptom of our nervous system being triggered to to take immediate action because it believes it is in danger.

When we worry about the future, we are wasting time and energy in refusing to accept that very little is within our control. Our peace of mind lies precisely in letting go of this illusion of control and trust in Allah's workings. Through Allahu akbar, we are reminded that God is the greatest and that we are always safe in His hands. Allahu Akbar allows us to

rest, knowing that whatever the outcome, it will always be the best case scenario.

Loving-Kindness Mediation – Du'a for Your Enemy

Growing up, my mother had a strict no gossip policy which she still maintains, something I respect deeply since I experienced first-hand how much it can break the social fabric of a community. Imagine gossip as weaving an invisible web of intricate threads throughout a community, which then becomes impossible to detangle.

Instead, my mother made it a habit of saying 'May Allah bless that person' with a particular tone. It became a shorthand for gossip but also brought the conversation to a halt.

"Good and evil cannot be equal. [Prophet], repel evil with what is better and your enemy will become as close as an old and valued friend," [Qur'an 41:34]

In a similar vein, I had learned of the loving-kindness mediation which is what advanced monks use to heal their consciousness, a purification of the soul (tazkiyyet al nafs) of sorts. The idea is simple, yet far from simplistic.

This type of meditation invites you to think of someone you dislike, who has done you harm, and focus all your energy on wishing them well and sending kindness their way. I tried it, not without difficulty, and I was astounded at the amount of positive energy I was filled with. To do that efficiently, one has to only focus on the good in them and concentrate on finding empathy for their weaknesses and faults.

I found the parallel between both practices fascinating and the bonus point is that once

you make du'a for someone, the angels reply Ameen' and whisper 'Likewise to you' - an absolute win-win.

> 'The supplication of a Muslim for a fellow Muslim in his absence is answered. Whenever one invokes good for his brother, the entrusted angel says, "amen, and likewise to you".' [Sahih Muslim]

> This practice allows our minds to reframe the situation and shifts it from holding on to bitterness and anger to releasing it with kindness. In this way, it helps us cultivate neuroplasticity by creating new neural pathways, until it becomes our default.

Ablution Wudu' - Calming Anger

Our dear Prophet 3 narrated the following hadith:

"Anger comes from the devil, the devil was created of fire, and fire is extinguished only with water; so when one of you becomes angry, she should perform ablution." [Sunan Abu Dawud 4784]

"If a prompting from Satan should stir you, seek refuge with God: He is the All Hearing and the All Knowing." [Qur'an 41:36]

This beautiful hadith suggests a somatic practice long before the theory even existed. Evidence in neuroscience through thermal infrared imaging suggests that anger manifests in high temperatures in the upper body. Anger flushes blood to our face, hands, and chest.

Performing wudu is a way to shock the body with cold water and decrease its temperature. The number of signals transferred from the body to the mind is greater than the other way around. Therefore, when we show our bodies that we are no longer angry simply by decreasing its temperature, we begin to calm down as a consequence.

Recently, the lovely Chaplain Sondos, our somatic guru and favorite Dhikr hero, launched an Instagram challenge #100DhikrWalk. In her explanatory video, she started with a great comparison. The idea behind #HotGirlWalk invites us to be out in nature, moving our bodies, getting some fresh air and basically considering our healthy practices as 'hot'.

Pursuing a similar end goal, Chaplain Sondos invites us to do the #100DhikrWalk. where our search for physical and mental health can be done through our relationship with Allah - that is we take a walk, and we get healthy all the while silently praying and performing dhikr. Her comparison was an incredibly effective invitation since it incorporated two different dimensions of mental health. First, a somatic practice intended for all of us to consider yourselves worthy and attractive (hot girl walk), one that fulfills the horizontal dimension of our soul in its relationship to our body, our world and others. Second, a spiritual practice fulfilling the vertical dimension of our soul, between us and our beloved (100DhikrWalk).

Within the same structure of thought, she managed to square two dimensions that can often be contradictory. Without saying it, she communicated the idea that we do not need a blank slate or a total makeover of our lives to be worthy of doing dhikr. Instead, she gave us tacit permission to do a switcheroo whenever possible, and that we can instill dhikr to fit anywhere in our lives and it is always worth it.

Sporadic violence reported in Manipur; 13,000 rescued as more forces arrive

Imphal: The Imphal Valley in Manipur which remained peaceful for most of Friday witnessed sporadic clashes later in the day as more security forces were rushed in from other states by road and air to calm down a state which had witnessed bloody ethnic rioting over the last 48 hours.

A Defence spokesperson said a total of 13,000 people were rescued and shifted to safe shelters, some in army camps as the army brought Churachandpur, Moreh, Kakching and Kangpokpi districts under its "firm control"

Intermittent gunfights between militant groups and security forces were also reported in the morning hours from various hill districts surrounding the valley, but a wary peace seems to be reigning there since.

"In the past 12 hours, Imphal East and West districts witnessed sporadic incidents of arson and attempts by inimical elements to establish blockades. However, the situation was controlled by a firm and synergised response," the Defence official said on Friday night.

Details of the incidents, however, were not available.

The exchanges of fire between militant groups, who have involved themselves in the ethnic clashes in the state. and security forces were reported at Kangvai in Churachandpur district, western hill range of Phougakchao in adjoining Bishnupur district and Dolaithabi and Pukhao in Imphal East district, a senior police officer said.

However, it was not immediately known whether there was any casualty on either side.

"Prompt response by Security Forces led to rescuing of civilians of all communities from various minority pockets of areas affected by violence. As a result, Churachandpur, Kangpokpi, Moreh and Kakching are now under firm control with no major violence reported since yesterday night," the

PRO said.

Nearly 10,000 soldiers from the Army and the Assam Rifles have been deployed in the state which was rocked by clashes since Wednesday between the Meitei community, which mainly live in Imphal Valley, and Naga and Kuki tribals who are inhabitants of the hill districts.

"Total of approximately 13,000 civilians have been rescued and are currently staying in various ad-hoc boarding facilities specifically created for the purpose within Company Operating Bases & Military Garrisons, the defence official said.

Union Home Minister Amit Shah reviewed the situation in Manipur with Chief Minister N Biren Singh and top officials, even as the Centre dispatched additional security forces and anti-riot vehicles to maintain peace there.

Around 1,000 more central paramilitary personnel with anti-riot vehicles reached Manipur on Friday, sources said.

At least five Deputy Inspector General (DIG) rank officers and seven senior superintendents of police (SSP) and SP rank officers of the CRPF have been tasked to coordinate the deployment of various security forces in violence-hit Manipur, official sources said in New Delhi.

Multiple sources said the fighting between communities had left several scores of people dead and nearly a hundred injured. However, the police were unwilling to confirm this.

Trains to Manipur have been cancelled with immediate effect on Friday due to the prevailing in the state, a Northeast Frontier Railway (NFR) spokesperson said.

The Defence PRO, in a statement, earlier said, "The Indian Air Force (IAF) undertook continuous sorties from two airfields in Assam employing C17 Globemaster and AN 32 aircraft.

"Induction commenced on the night of May 4 and additional columns commenced domination with effect from the wee hours of May 5. Domination & evacuation of civilians of all communities from affected areas continued throughout the night. Flag march in Churachandpur and other sensitive areas are underway," it added.

Violence first erupted in Torbung area in Churachandpur district during the 'Tribal Solidarity March' organised by the All Tribal Student Union Manipur (ATSUM) on Wednesday to protest the demand of Meiteis for Scheduled Tribe (ST) status.

The march was organised by tribals -- including Nagas and Kukis -- after the Manipur High Court asked the state government last month to send a recommendation to the Centre within four weeks on the demand for ST status by the Metei community.

During the march in Torbung, an armed mob allegedly attacked people of the Meitei community, leading to retaliatory attacks in the valley districts, which escalated the violence throughout the state, police said.

Meiteis account for about 53 per cent of the population and live mostly in the Imphal Valley. Tribals, who include Nagas and Kukis, account for another 40 per cent of the population and live mostly in the hill districts which surround the Valley.

Two shopping malls in New Checkon and Chingmeirong areas of Imphal city were vandalised and torched by an angry mob on Thursday evening.

People were not seen gathering in large numbers or venturing out of their houses in Imphal and other areas on Thursday night as patrolling was intensified on the streets, he said.

A tribal MLA, Vunzagin Valte, of Thanlon constituency was critically injured and was undergoing treatment at a hospital after he was assaulted by a mob on Thursday, the officer said.

The violence between the majority Meiteis and tribals over the demand of the former for ST status has displaced over 13,000 people from both communities

5 Soldiers Killed

Kandi - Khadyoon village road, falling under Kandi Police Station, around 35 kilometers far from district headquarters Rajouri. These reports quoting police said that during the CASO, teams established contact with terrorists ensuing a heavy exchange of fire.

"Five army personnel from elite Para Special Force got killed while one Major ranked officer is injured and under treatment at Command Hospital Udhampur," an army officer confirmed, adding, "Two paratroopers suffered fatal casualties after terrorists triggered an explosive device in retaliation, while three succumbed to injuries later during treatment".

The People's Anti-Fascist Front (PAFF), a shadow organisation of the Jaish-e-Mohammed outfit, has claimed responsibility for Friday's attack.

Before Friday's attack, the twin border districts of Poonch and Rajouri have witnessed seven major militancy incidents since October 2021 in which 29 people, including 22 Army personnel, have been killed.

As the operation was underway, mobile internet facilities in the Rajouri area were suspended.

According to a statement from the Army's Northern Command in the morning, its personnel have been conducting "relentless intelligence-based operations to flush out a group of militants involved in an ambush on an Army truck in the Tota Gali area of Bhata Dhurian in Jammu region last month".

"On specific information about the presence of terrorists in the Kandi Forest in the Rajouri Sector, a joint operation was launched on May 3. Around 7.30 am on Friday, a search team established contact with a group of terrorists well entrenched in a cave. The area is thickly vegetated with rocky and steep cliffs.

Officials said additional troops of the Central Reserve Police Force (CRPF) and the Army were inducted into the area to put it in tight cordon so that militants do not escape from the spot.

The forces deployed drones and sniffer dogs and troops hit a cave hideout with heavy fire of mortars and grenades, they said

"I convey my heartfelt condolences to the families of the brave army personnel martyred in a joint operation against terrorists. We are firmly resolved to combat and defeat the terrorist menace, which is sponsored from across the border," Sinha said.

National Conference vice president Omar Abdullah said terrorism deserves "unreserved condemnation".

"Tragic news from Rajouri where 5 army personnel have laid down their lives in the line of duty. I send my sincere condolences to the families of those we lost today," the former chief minister said on Twitter.

Democratic Party president Peoples Mehbooba Mufti termed the loss of lives in the blast "terrible".

Apni Party chief Altaf Bukhari said the sacrifice of the soldiers for the safety of the nation will never be forgotten.

"Deeply saddened by the tragic news from Rajouri. My thoughts are with the families of the brave soldiers who lost their lives in the ongoing encounter. Their sacrifice for the safety of our nation will never be forgotten," he tweeted.

India hosted the SCO foreign ministers' conclave in its capacity as the current chair of the grouping.

The SCO is an influential economic and security bloc and has emerged as one of the largest transregional international organisations.

The SCO was founded at a summit in Shanghai in 2001 by the presidents of Russia, China, the Kyrgyz Republic, Kazakhstan, Tajikistan and Uzbekistan.

India and Pakistan became its permanent members in 2017.

India was made an observer at the SCO in 2005 and has generally participated in the ministerial-level meetings of the grouping, which focus mainly on security and economic cooperation in the Eurasian region.

India has shown a keen interest in deepening its security-related cooperation with the SCO and its Regional Anti-Terrorism Structure (RATS), which specifically deals with issues relating to security and defence.

"There is a likelihood of casualties in the terrorist group and the operation is in progress," it said.

The slain soldiers were lance naik Ruchin Singh Rawat from Gairsain in Uttarakhand, paratrooper Siddhant Chettri from Darjeeling in West Bengal, naik Arvind Kumar from Kangra district in Himachal Pradesh, havildar Neelam Singh from Jammu and paratrooper Pramod Negi from Sirmaur in Himachal Pradesh.

Additional Director General of Police (ADGP) Mukesh Singh rushed to the spot and reviewed the security setup, they said.

The security forces have been engaged in a massive combing operation for the past 15 davs in the twin border districts of Rajouri and Poonch districts. The operations started after the attack on Army vehicle in Bhatta Dhurian in which five soldiers were killed and another was injured on April 20.

More than 250 people were detained for questioning during combing operations. Six overground workers who extended full support to militants were arrested, they said.

The militants have adopted a twin strategy of engaging troops or attacking people and then laying improvised explosive devices to trigger blast to target security forces.

This also happened in Dhangri village in Rajouri where militants killed seven civilians in twin attacks on January 1 this year.

Militants carried out an attack on 11 October 2021 in Surankote, killing five soldiers, followed by the killing of three soldiers and two jawans in Dera ki Gali on October 13 and 15.

Two jawans were killed in an IED blast in Kalal in Rajouri in October 30.

On August 11 last year, five soldiers were killed in a fidayeen attack on a military camp in Raiouri.

In the last one-and-a-half years, Poonch and Rajouri districts in Jammu and Kashmir have witnessed more killings of Army personnel than the militancy-hit Kashmir Valley, officials said. Inputs from PTI

said Friday. Sinha, he said, is in touch with the top officials of Army and Jammu Kashmir Police.

The LG also extended his deepest condolences to the families of the slain army personnel.

Chairing the conclave, Jaishankar said taking the "eyes off terrorism" would be detrimental to the security interests of the grouping and that when the world was engaged in facing the Covid-19 pandemic and its consequences, the menace of terrorism continued unabated, in another veiled reference to Pakistan.

Benazir Bhutto's assassination at the hands of terrorists

"When I speak on this topic, I do so not only as the Foreign Minister of Pakistan whose people have suffered the most in terms of number of attacks and number of casualties. I also speak as the son whose mother was assassinated at the hands of terrorists," Bhutto Zardari said.

"I feel the pain of this loss, empathize with victims across the world in a way most can't. I and my country are firmly committed to being part of regional and global efforts for eradicating this menace. This requires not only a comprehensive approach but also a collective approach," he added.

"It requires that we let this challenge unite us to fight it rather than divide us to become its victim. Our success requires us to isolate this issue from geo-political partisanship," he said.

Bilawal Zardari also made a special mention of China for its role in bridging differences between Saudi Arabia and Iran.

"I want to make a special mention of the commendable role China has recently played in bridging differences between Saudi Arabia and Iran- two countries that are also associated with the SCO. When great powers play the role of peacemaker, we can unlock the potential of peace while paving the way for greater cooperation, regional integration and economic opportunities for our peoples," he said.

In his address, Jaishankar noted that current crises facing the world have exposed a credibility and trust deficit in the ability of global institutions to manage challenges in a timely and effective manner. He said reform and modernisation of the SCO will aid a more contemporary outlook which India will actively support.

"As a result of the COVID-19 pandemic and geopolitical upheavals, the world is today facing a multitude of challenges. These events have disrupted global supply chains, leading to serious impact on the supply of energy, food and fertilizers and cascading effects on developing nations," he said.

'These crises have also exposed a credibility and trust deficit in the ability of global institutions to manage challenges in a timely and efficient manner," he noted.

"These challenges, however, are also an opportunity for Member States of the SCO to colaborate and address them collectively. With more than 40% of the world's population within the SCO, our collective decisions will surely have a global impact," Jaishankar said.

West-Pak Refugees

We used to get angry. We are Hindustani, India is our country. We are Hindus. We thank Sinha sahib from the core of our heart," he added.

In a major decision, LG Sinha announced on May 1 that the administration will grant ownership rights to the refugees for land allotted to them on their migration to India from Pakistan in 1947.

Some of the refugees said Articles 370 and 35A had denied political rights and other benefits to them and hindered their prosperity and upward mobility. Abrogation of these special provisions made them citizens of India, they added.

Soom Lal Saini, 70, whose family came from Beri Pind in Pakistan in 1947, said he had been living with 11 members of his family in a oneroom house for several years. He said they sustained their lives by working as labourers for generations.

"It is the biggest gift of my life. Now I will get ownership of the house. It will restore our dignity," Saini said, adding it corrected a historic wrong.

"We are very happy that the LG sahib gave us the rights. We thank him, it is a matter of happiness," he said, adding that now his children will get government jobs too.

Rani Devi too thanked LG Sinha for "thinking about our children".

"Neither we have our own place to live nor any land for farming. It was an insult to us. Our children could not get jobs. But he (LG) has done so much to help us. We are happy now," she added.

After these refugees came to India in 1947, they were given voting rights.

But Article 370 barred them from applying for government jobs, owning lands, avail scholarships and get admission to colleges. The abrogation of the article on August 5, 2019, paved the way for them to get the domicile status. And now, they will get land ownership rights.

"As per official records, 5,764 families who migrated from Pakistan to the border areas of Jammu having lands of 46,666 kanals with them. But today families have extended and as per our records there are 21,160 families in

longer constitutes a public health emergency of international concern (PHEIC).

The head of the WHO said at least seven million people died in the pandemic before adding that the true figure was "likely" closer to 20 million deaths - nearly three times the official estimate.

"The worst thing any country can do now is to use this news as a reason to let down its guard, to dismantle the systems it has built, or to send the message to its people that Covid-19 is nothing to worry about," he said.

Covid-19 first emerged in central China's Wuhan city in 2019 and spiralled into a pandemic.

While at the time, outside China there were fewer than 100 reported cases, and no reported deaths, in the three years since then, "COVID-19 has turned our world upside down," the WHO chief said.

He said Covid-19 has been so much more than a health crisis and has caused severe economic upheaval, erasing trillions from GDP, disrupting travel and trade, shutting businesses, and plunging millions into poverty.

It has caused severe social upheaval, with borders closed, movement restricted, schools shut and millions of people experiencing loneliness, isolation, anxiety and depression, he said.

Covid-19 has exposed and exacerbated political fault lines, within and between nations. It has eroded trust between people, governments and institutions, fuelled by a torrent of mis- and disinformation, he said.

"And it has laid bare the searing inequalities of our world, with the poorest and most vulnerable communities the hardest hit, and the last to receive access to vaccines and other tools," he added.

The Covid-19 Weekly Epidemiological Update issued by WHO on Thursday said that as of April 30, 2023, over 765 million confirmed Covid-19 cases and over 6.9 million deaths have been reported globally.

Globally, nearly 2.8 million new cases and over 17,000 deaths were reported between April 3 and 30, a decrease of 17 per cent and 30 per cent, respectively, compared to the previous 28 days.

The picture is mixed at the regional level, with increases in reported cases and deaths seen in the South-East Asia, Eastern Mediterranean, and Western Pacific regions, and decreases in other regions, it said.

3 OGWs Held In South Kashmir

SRINAGAR: Three over-ground workers (OGWs) of militants were arrested in separate search operations in the twin districts of Pulwama and Shopian in South Kashmir, police said Friday.

He further claimed that the timely and effective action of police and security forces by busting the militant associate module have resulted in averting a possible major tragedy as well as avoided the nefarious designs of JeM to recruit young boys for their illegal and unlawful Activities.

Pollen Allergy Hits Northern Baramulla District

Tree Cutting Going On In A Phased-Manner Along Sgr-Bla Highway; For Private Land, People Themselves Can Play A Great Role, Says DC Baramulla

SRINAGAR: Despite freaky weather conditions in Kashmir, north Kashmir's Baramulla district is gripped with pollen allergies which is now turning into a perennial health hazard with people alleging that they are falling prey to allergies due to government apathy to cut down the Russian female Russian poplars.

Though pollen allergies in the spring are common, but the roads, streets and corners across north Kashmir particularly Baramulla and Sopore - where thousands of poplars line up is giving a tough time to peor

the person affected with the pollen-induced allergy needs proper medical advice especially for those who are battling Asthama else it could exacerbate, which may have serious consequences.

"The common symptoms of pollen-induced allergy include nasal irritation, running nose and watery eyes coupled with redness and skin rashes. These symptoms may further exacerbate in patients having Asthma - in which a person's airways become inflamed, narrow and swell and produce extra mucus, which makes it difficult to breathe," he said. "The patients suffering from allergies are advised to take precautionary medicines include anti-allergic tablets and in case the infection is high then antibiotic is prescribed. Meanwhile, deputy commissioner Baramulla, Dr Sved Sehrish while speaking to media over the issue said that every year they are taking measures and old/toxic trees are being axed. She assured that people will not face pollen issues along Srinagar-Baramulla national highway, as they have taken up the process of cutting down the trees in a phased manner. About army cantonment areas, the DC said that the government has a role to play over state land rather than private. In terms of privacy, people better can play a great role themselves, she said. Pertinently, in 2015, High Court passed directions banning plantation and trade of pollen producing poplar trees particularly Russian poplar trees across Kashmir. However, the government has miserably failed in stopping the perennial health hazard by cutting down

DAK Suggests Hand Wash To Cut **Diarrhea, Respiratory Infections**

SRINAGAR: On world hand hygiene day, Doctors Association Kashmir (DAK) on Friday said hand washing is one of the most effective ways to prevent infections and save lives.

"Hand washing acts like a vaccine that prevents deaths," said DAK President Dr Nisar ul

Hassan. Dr Hassan said various studies have found that the simple act of washing hands with soap and water can reduce the incidence of diarrhea in children by almost 50% and cut respiratory infections by 25%.

of death in children in Kashmir "Reducing the number of these infections by washing hands

would also help prevent the overuse of antibiotics-the single most important factor leading to antibiotic resistance which has reached to unprecedented levels in the valley," he said.

The DAK President said many people die from antibiotic resistant infections acquired while receiving healthcare in hospitals.

"Up to 70% of these infections could be prevented if healthcare providers follow infection prevention and control practices which include hand hygiene," he said.

Dr Nisar said despite saving lives, hand hygiene adherence among healthcare workers is suboptimal.

"There is moral imperative for hospital staff to practice recommended hand hygiene while dealing with patients," he said adding "patients entrust healthcare workers with their lives and clinicians should not be the ones to make them sick. "Every year on May 5, world

hand hygiene day is observed with the aim to raise awareness among general public and healthcare workers about the importance of regular and proper hand washing both at community level and hospital setting," he said.

NEW DELHI: The protesting wrestlers on Friday formed two committees to advice them on the future course of action in their fight against outgoing Wrestling Federation of India (WFI) chief Brijbhushan Sharan Singh.

The aggrieved wrestlers started the day contemplating their next move after the Supreme Court closed proceedings on their plea even as Sports Minister Anurag Thakur requested them to have faith in the system, saying the investigation will make everything crystal clear.

"Vinesh is discussing it with the legal team. We will inform tomorrow. Today we made two committee -- one is a 31-member committee and the second is a nine-member one.

Khap panchayat, farmers and women organisations are there in 31 member committee. The nine-member committee will decide on the wrestling part," said Bajrang Punia. "I request the sports minister to come and stand on the side of truth." "We will restart our fight, maybe by going to the high court. This fight is not restricted to three wrestlers," he added. With the Delhi Police blocking the entry of more wrestlers to the protest site, only a few farmers could reach Jantar Mantar on Friday to extend their support.

The usual fervour was missing as the protest entered the 13th day though political and farmer leaders continued to visit the wrestlers. Congress leaders Kumari Selja, Kiran Choudhary and Anil Kumar extended their support to the grapplers.

"It feels like we are in prison. There are barricades on all sides. The police is also misleading our supporters. So many are sitting on the Delhi borders." "Our legal team and the mentors are still discussing the next move. We will let you know once we finalise something," Olympic medallist Bajrang Punia had earlier told PTI.

The wrestlers have the option of moving to a lower court or the Delhi High Court if they are not satisfied with the police investigation into the sexual harassment charges against the outgoing Wrestling Federation of India (WFI) chief Brijbhushan.

The Supreme Court on Thursday closed the proceedings on the women wresters' petition, saying the prayer for an FIR has been answered. The wrestlers said the apex court order was not a setback for them.

The Delhi Police has registered two FIRs, including one on POCSO Act, against Singh.

The police have also recorded statements of five wrestlers, including the minor.

"It is my request to all the sportspersons who are agitating there that whatever their demands were, they were met. Court has also given its directions and they should let an unbiased probe to complete," Thakur said in Lucknow on the sidelines of a Khelo India event.

"Delhi police will do 'doodh ka doodh pani ka pani' and take strict action as per law," he added. The wrestlers, who alleged that police personnel misbehaved with them on Wednesday night, have threatened to return the awards the government has

bestowed on them in the past. Renowned wrestling coach Mahvir Phogat, the uncle of Vinesh Phogat, who is the face of the protest, also made a similar threat.

He is a Dronacharya awardee, having received the honour in 2016.

"I will return my medals if justice is not delivered in the case," Phogat said.

"The kind of allegations he (WFI chief) faces, action should be taken against him and he should be arrested," Phogat, who had joined BJP over three years ago, added.

Real Madrid Play Copa Final Before Man City Game

MADRID: It's time for Real Madrid to switch back into championship mode for the final part of what has been an inconsistent season.

Madrid will play Osasuna in the Copa del Rey final on Saturday following a stretch of poor showings in the Spanish league, where the title has long been out of reach.

Carlo Ancelotti's players have been playing far from their best with their focus clearly on the game in Seville against Osasuna and on what's to come just after. Three days later, Madrid will

play the first leg of its highly anticipated Champions league semi-

ciedad game, while attack partner Vinícius Júnior was suspended for an accumulation of yellow cards. So both should be rested for the critical week ahead.

Madrid is trying to win its first Copa since 2014, when Gareth Bale scored a late winner to beat Barcelona 2-1. It has won the cup 19 times, third most behind Barcelona (31) and Athletic Bilbao (23). But when it comes to pure

motivation, Osasuna most likely has the advantage over its starstudded opponent. The modest club based in Pamplona has been waiting almost two decades for another shot at winning its first major trophy.

This will be just the second Copa final in Osasuna's history. It

While Madrid's top priority is to defend its continental title and lift a record-extending 15th European Cup, a victory over Osasuna would secure its first Spanish cup in nearly a decade
