Jammu: Defence Minister Rajnath Singh on Saturday reviewed the security situation along the borders in Jammu and Kashmir as he visited the district of Rajouri, a day after five elite para commandos of the army were killed during an anti-militancy operation in the forested Kandi area of the district

Singh condoled the deaths of the personnel and commended the security men for their valour and zeal while operating in challenging situations.

The minister's visit also assumes significance as militants have killed 35 people, including 26 soldiers, in eight attacks in the twin border districts of Rajouri and Poonch since October 2021. The two districts were declared

militancy-free more than a decade ago. "Visited the Army Base Camp in Rajouri, J&K today. Reviewed the operational capabilities and security situation along the border. Also, interacted with the brave soldiers of the Indian Army. India salutes their devotion towards protecting our motherland," he wrote on his Twitter account.

In another post in response to a tweet by the Additional Directorate General of Public Information (ADGPI)-Indian Army paying tributes to the fallen soldiers, Singh said, "I pay homage to these brave soldiers who made the supreme sacrifice in service to the nation. Their sacrifice will never be forgotten. My thoughts are with the

## **Loneliness is deadly like smoking a dozen** cigarettes daily, says US Surgeon General

bout half of US adults say they have experienced loneliness, posing health risks and costing the health industry billions of dollars annually, according to an advisory from the US surgeon general.

Loneliness is a common feeling the body sends when something needed for survival is missing, Dr. Vivek Murthy said in the report, adding that the issue needs to be addressed to help the millions of Americans struggling in the shadows. The declaration aims to raise awareness of the issue but won't unlock federal funding or programming devoted to combatting it.

We now know that loneliness is a common feeling that many people experience. It's like hunger or thirst. It's a feeling the body sends us when something we need for survival is missing, Murthy told The Associated Press in an interview.

Research shows that Americans, who have become less engaged with worship houses, community organizations and even their own family members in recent decades, have steadily reported an increase in feelings of loneliness. The number of single households has also doubled over the last 60 years.

But the crisis deeply worsened when COVID-19 spread, prompting schools and workplaces to shut their doors and sending millions of Americans to isolate at home away from relatives or friends.

People culled their friend groups during the coronavirus pandemic and reduced time spent with those friends, the surgeon general's report finds. Americans spent about 20 minutes



a day in person with friends in 2020, down from 60 minutes daily nearly two decades earlier.

The loneliness epidemic is hitting oung people, ages 15 to 24, especially hard. The age group reported a 70% drop in time spent with friends during the same period. Loneliness increases the risk of premature death by nearly 30%, with the report revealing that those with poor social relationships also had a greater risk of stroke and heart disease. Isolation also elevates a person's likelihood for experiencing depression, anxiety and dementia.

The surgeon general is calling on workplaces, schools, technology comcommunity organizations, parents and other people to make changes that will boost the country's connectedness. He advises people to join community groups and put down their phones when they're catching up with friends; employers to think carefully about their remote work policies;

and health systems to provide training for doctors to recognize the health risks of loneliness.

Technology has rapidly exacerbated the loneliness problem, with one study cited in the report finding that people who used social media for two hours or more daily were more than twice as likely to report feeling socially isolated than those who were on such apps for less than 30 minutes a day.

Murthy said social media is driving the increase in loneliness in particular. His report suggests that technology companies roll out protections for children especially around their social

media behavior. There's really no substitute for inperson interaction, Murthy said. As we shifted to use technology more and more for our communication, we lost out on a lot of that in-person interaction. How do we design technology that strengthens our relationships as opposed to weaken them?

## **Elderly Woman Scheduled To** Perform Hajj Dies In Aali Kadal Blaze

Three-Storey House Suffers Substantial Damage

Srinagar: A 62-year-old woman was charred to death after a fire broke out in the Aali Kadal area in the old city this morning.

The interior parts of the three-story house were completely destroyed while a couple of adjacent houses suffered partial damages in the inferno.

Locals said fire broke out in the house of one Gulzar Ahmed Mir in the congested Aali Kadal area. Lone elderly woman present in the house as per locals couldn't come out of the house due to her poor eyesight.

The deceased woman was my cousin who was alone in the house when the fire broke out in the kitchen. I tried to save her, even opened the door but the flames emanating from the room pushed me back," said a man, adding that the deceased woman along with her husband was scheduled to leave for the Hajj pilgrimage in the coming days.

Thousands of people participated in her last rites. Locals identified the deceased woman as Nafeesa Begum, wife of Gulzar Ahmed Mir. She is survived by her two married daughters and a son.

Some locals claimed that leakage of gas was the cause of the fire; however, a police official said that they have registered a case and are trying to ascertain the cause of the fire.

Locals thanked police and firefighters for the timely help. "With the efforts of firefighters, police, and locals, the fire could not spread to other houses. We thank them wholeheartedly,' they said.

## Sumo-Borne Men Abduct, Beat Cop

RINAGAR: A traffic police constable was admitted in the hospital in a critical condition after being dropped half dead by some unidentified abductors outside the Batwara gate of the army headquarters in Badamibagh cantonment here this afternoon.

According to reports, Ghulam Muhammad (belt No1556), a constable in the traffic control department deployed in the Regal chowk to enforce one way movement stopped a white Sumo from proceeding in the wrong direction. At this, the unidentified persons pounced on the constable and beat him.

Watching the scuffle, some shopkeepers tried to rescue the policeman. But, the Sumo-borne men putted him in and fled away. The incident took place in broad day light at 3:45 p.m. At about 6.30 p.m. the army authorities informed the police about the constable lying at the mail gate of the BB Cantt almost half dead. However, the police refused to pick up the injured constable and instead demanded the in-spector general of police or any other senior officer to go to the spot for the purpose. Eventually, it was the superintendent of police traffic, Riyaz Ahmad Bedar, who went to the BB Cantt gate and removed the constable to the SMHS hospital where the doctors attending on him said, late in the evening, that his condition was stable.

## **UK Enters Era Of King** With Charles' Coronation

LONDON: King Charles III was on Saturday crowned the King of the United Kingdom at Westminster Abbey, in a solemn religious ceremony that dates back almost a thousand years.

The king and his wife, Camilla, the queen consort, travelled from Buckingham Palace to Westminster Abbey - a distance of 2.2-km - at a stately pace in the Diamond Jubilee State Coach bearing a gilded crown, which was commissioned for Queen Elizabeth II

The king entered through the great west door of the abbey. He wore a long dark red robe as he slowly proceeded through the church behind his wife, Camilla. He was greeted by a congregation of around 2,200 - made up of heads of state and government, worldwide royalty as well as community champions.

Vice-President Jagdeep Dhankhar and his wife Dr Sudesh Dhankhar represented India on the historic occasion and sat alongside other Commonwealth Heads of State.

Westminster Abbey has been the site of every British Coronation since that of William The Conqueror in 1066 and King Charles III and his wife, Queen Camilla, followed in the footsteps of this grand tradition in a service themed "Called to Serve".



The Service was conducted by the Archbishop of Canterbury, the Most Reverend and Right Honourable Justin Welby, with faith leaders and representatives of the Hindu, Sikh, Muslim, Buddhist and Jewish communities process-ing through the Abbey ahead of the service.

King Charles III took the solemn oath to govern the people of the United Kingdom with "justice and mercy" and to foster an environment where people of all faiths and beliefs can live freely after placing his hand on the Bible. He later kissed the holy book.

For his coronation, King Charles III wore the crimson velvet Robe of State, a Crimson Coronation Tunic and cream silk overshirt with Royal Naval trousers. The king's Robe of State is made of crimson velvet and was worn by King George VI at the Coro-

Queen Camilla, the queen

consort, wore a crimson robe, this one originally made for Queen Elizabeth II in 1953. Underneath she is wearing a tailored dress designed by Bruce Oldfield and created in Bruce Oldfield's couture workrooms in Battersea, London.

Rishi Sunak made history as the first Indian-origin British Prime Minister to perform a reading at the Coronation ceremony.

As the country's first Hindu head of government, the 42-year-old read from the Epistle to the Colossians from the New Testament reflecting the theme of service to others, in keeping with the recent tradition of UK Prime Ministers giving readings at State occasions.

He and wife Akshata Murty, the daughter of Infosys cofounder Narayana Murthy, led the procession of flag-bearers as the UK's Union Jack flag was carried into the Abbey by a high-ranking Royal Air Force (RAF) cadet.

## **Death Toll In Manipur Violence Rises To** 54; Imphal Valley Returning To Normalcy **Riyadh Seeking Flights Between**

IMPHAL: The death toll in the ethnic violence which has engulfed Manipur increased to 54, officials said even as unofficial sources placed the figure at several scores dead and more than 150 injured.

Life returned to a wary normalcy in Imphal Valley on Saturday as shops and markets reopened and cars started plying on the roads.

Security presence which has been bolstered by flying in more Army troops and Central police forces was clearly visible on all major roads and areas. Roadblocks and cordons have been set up in areas where militant groups had engaged security forces on Friday.

Large number of people, including students, were seen assembled at Imphal airport to try get a flight out of the troubled state.

Meanwhile, an Assam Rifles column has been instructed to pick up all Naga students in Imphal from



pick up points on Sunday for a trip back to Kohima.

Survivors at various refugee camps set up for victims of the riots which broke out on Wednesday night said several villages have been

Nearly 10,000 Army, paramilitary and central forces have been deployed in the state where rioting broke out after demonstrations were organized by tribals, including Kukis and Nagas, on Wednesday against a move to give the majority Meitei community,

scheduled tribe status. Meiteis account for about 53 per cent of the population

and live mostly in the Imphal Valley. Tribals, who include Nagas and Kukis, account for another 40 per cent of the population and live mostly in the hill districts which surround the Valley.

Of the 54 officially declared dead, 16 bodies were kept in the morgue of the Churachandpur district hospital, while 15 bodies were at the Jawaharlal Nehru Institute of Medical Sciences in Imphal East district, officials said.

The Regional Institute of Medical Sciences at Lamphel in Imphal West district reported 23 dead, the official said.

## "Homosexuality A Disorder, Will Rise If Same-Sex Marriage Legalised": RSS Body Survey

**NEW DELHI:** Many doctors and allied medical professionals believe that homosexuality is "a disorder" and it will increase further in society if same-sex marriage is legalised, according to a survey by Samwardhini Nyas, an affiliate of the women's wing of the RSS.

A senior functionary of the Rashtra Sevika Samiti, a women's organisation which parallels the Rashtriya Swayamsevak Sangh (RSS), said the findings of the survey are based on 318 responses collected across the country covering medical practitioners from eight different pathies of treatment from modern science to Ayurveda.

In their response to the sui vey, according to Samwardhini Nyas, nearly 70 per cent of the doctors and allied medical professionals stated that "homosexuality is a disorder" while 83 per cent of them "confirmed transmission of sexual disease in homosexual relations."

"From the survey, it is observed that the decision to legalise such marriages may promote more disorder in the

society rather than curing patients and bringing them to normalcy," the RSS body said.

"Counselling is the better option to cure patients of such psychological disorder," it

The Samwardhini Nyas's survey recommended that public opinion should be taken before taking any decision on the demand for legalising same-sex

"Over 67 per cent of the doctors in their response to the survey questionnaire felt that homosexual parents cannot raise their offspring properly," the Rashtra Sevika Samiti affiliate added.

The survey has been conducted by the Samwardhini Nyas against the backdrop of a five-judge constitution bench, headed by Chief Justice D Y Chandrachud, hearing arguments on a batch of pleas seeking legal sanction for same-sex marriage

"Over 57 per cent of the doctors who responded to the survey disfavoured the Supreme Court's intervention in the matter," a senior functionary of the Samwardhini Nyas said.

## 8 Decades On, 93-Year-Old Woman Wins **Court Battle For 2 Flats In South Mumbai**

MUMBAI: The Bombay High Court has directed the Maharashtra government to hand over two south Mumbai flats to their owner, a 93-year-old woman, putting an end to a property dispute that dragged on for eight decades. The flats are situated on the

first floor of Ruby Mansion in south Mumbai and measure 500 sq ft and 600 sq ft. On March 28, 1942, the building was requisitioned under the then Defence of India Act, which allowed the British rulers of the time to take possession of private properties.

A division bench of Justices R D Dhanuka and M M Sathaye in its order of May 4 noted that despite de-requisition orders passed in July 1946, the flats were never handed back to the owner – Alice D'souza.

The properties are presently occupied by the legal heirs of

a former government official. D'souza in her petition had sought a direction to the Maharashtra government and the Collector of Mumbai to implement the July 1946 de-requisition orders and to hand over



possession of the flats to her. The nonagenarian's plea was opposed by the present occupants of the flat who are the legal heirs of one DS Laud, who was inducted into the premises in the 1940s under the requisition order. Laud was a government officer in the civil services department

D'souza in her petition claimed that the requisition order was withdrawn but still the possession of the flat was not handed over to the rightful owner. Possession of other flats in the building was handed back to its owners, the plea said.

The bench in its order noted that physical possession of the premises was never handed over to the owner (D'souza) and hence the de-requisition was not complete.

"We have no hesitation to hold that in the present case, the premises have continued to be under requisition," HC

The court directed the state government to "hand over vacant and peaceful possession of the subject matter premises to the petitioner owner (D'souza) after taking its possession from the present occupants within eight weeks".

## **Scorpion Bites** Woman On Air India Nagpur-Mumbai Flight: Report

NEW DELHI: In a rare incident, a woman passenger was bitten by a scorpion onboard an Air India flight from Nagpur to Mumbai last month. On landing at the airport, the passenger was attended by a doctor, subsequently treated at a hospital and discharged, the airline said in a statement today.

Air India said there was an "extremely rare and unfortunate incident involving a scorpion biting a passenger onboard our flight AI 630 on April 23, 2023".

According to the airline, it followed the protocol and conducted complete inspection of the aircraft and found the scorpion after which a due fumigation process was carried out.

Following the incident, Air India asked the catering department to advise dry cleaners to check their facilities for any bed bugs infestation and if necessary, carry out fumigation of the facilities as there is a possibility of bugs finding their way into the aircraft through the supplies, an Air India official told Press Trust of India.

Earlier also, there have been instances of reptiles being found onboard aircraft.

In December last year, a snake was found in the cargo hold of an Air India Express plane from Calicut after it landed at the Dubai airport.

## **Artists Protest Near Amartya** Sen's House

SANTINIKETAN: Intellectuals held a sit-in near the ancestral house of Nobel laureate Amartya Sen here on Saturday protesting against the notice by Visva-Bharati university to the economist to vacate 0.13 acres (5,500 sq ft) of the

total 1.38 acres allegedly held by him 'illegally' or face eviction.

Rabindranath Tagore's songs of protest were sung during the sit-in. Among the intellectuals

who took part in the protest, held for the second consecutive day, were film maker Goutam Ghosh, painters Suvaprasanna and Jogen Choudhury.

In another podium, set up near by, leaders of the ruling TMC sat in protest. They included state minister Chandranath Sinha, Suri MLA and Birbhum zilla parishad president Bikash Roy Choudhury, Labhpur MLA Abhijit Sinha and Nanoor MLA Bidhan Majhi. Scores of party activists too sat with them.

The TMC is opposing the Visva-Bhara-

ti notice to Amartya Sen tooth and nail. "I have come all the way from Kolkata to voice my protest against the harassment and insult to an internationally respected economist like Amartya Sen, who is among the country's pride. The way his land issue is being treated by Visva-Bharati authorities is unfortunate as the matter is sub-judice," Goutam

"This is not the Visva-Bharati we have

known. We demand that Amartya babu should not be subjected to such treatment any more," the filmmaker told PTI over phone.

Abhijit Sinha said people of Bengal are aghast over the treatment meted out to Sen by the university and the "democratic protest" against it will continue for the next

ins by the 'Committee for Protection of Social Dignity', which too was held in front of of Pratichi on the same issue on Friday. Tagore's famed drama 'Rakta Karabi' was staged as a mark of protest and local people and Ashramites of Visva-Bharati protested by singing the Bard's songs.

'Rakta Karabi' is a powerful and poignant play where commercial expoitation, oppression, power, love and obsession operate on different levels and manifest themselves in different shades.

Visva Bharati spokesperson Mahua Banerjee said, "The matter is in the court. We respect its order and the law of the land. We have lodged a complaint to the competent authorities.

## **J&K's Sex Ratio At Birth Better Than National Average: NHM Director**

Says Sex Determination Being Regulated Through Effective Implementation Of PCPNDT

SRINAGAR: The sex ratio at birth in Jammu and Kashmir is better than national average while sex determination is being regulated through effective implementation of PCPNDT, NHM Director Ayushi Sudan said on Saturday.

Talking to reporters on the sidelines of an event in Srinagar, she said that the sex ratio in J&K is definitely better than the national average because of social factors.

"There is still need of capacity building for Pre-conception and Pre-Natal Diagnostic Techniques (prohibition of sex selection) Act, 1994 and the main aim of the act is to prohibit sex determination especially at the time of pre-natal diagnosis," Sudan said.

She said that gender bias and sex determination is a critical public health concern which is being regulated through effective implementation of PCPNDT Act for which a comprehensive action strategy has been devised and monitored.

"Here is a need for capacity building of our stakeholders, so as to get the final details of the act for what we have gathered here and a similar workshop will be held in Jammu division as well so that this act can be handled in a better and more effective way," she said.

we are hopeful of further improvement on sex ratio at birth while district teams in this regard have been conducting inspections and with proper timeline and monitoring, registrations are being given to diagnostic centres," she said.

"With better understanding,

She said that as per the NHFS-5 data, the sex ratio at birth in I&K has improved vastly and it is better than most of the states and union territories of the country.

"We have seen an improvement in the last 10 days and we believe with women empowerment, there will be further improvement in the future," Ayushi Sudan said.

She said that streamlining of PCPNDT act is only one aspect to improve sex ratio but there are several other aspects like women empowerment and different programmes that can help in further improvement of the sex ratio at birth in J&K.

Notably as per the National Family Health Survey (NHFS-5), sex ratio at birth for children born (females per 1,000 males) has increased from 923 in 2015-2016 to 976 in 2019-2020.

As per the NHFS-5 data, against the national average of 929 girl children born for every 1,000 boys, J&K has 976 girl children born for every 1000 boys.

The urban areas have a slight edge over rural pockets, she said. "In urban areas of J&K, 978 girl children were born for every 1,000 boys while in rural areas the rate was 976," she

# Women, Recreation and a Walk to Remember in Kashmir

"412 complaints of crimes against women in the three years preceding 8th March 2023." "30-year-old woman killed in Budgam." "Human trafficking increased by 15.56% in the last year in Jammu & Kashmir."

These were only some of the many headlines I encountered recently whilst sifting through the news. Add to these the innumerable videos of unruly men harassing women circulating online recently, shared often to bring them to the attention of the authorities for action. Perhaps violence against women has not increased but is only being reported more now.

The more I pondered upon this, the more I realised that such happenings do not revolve around mere quantitative figures or accounts to be underplayed. In fact, these are unmistakable indicators of the social evils that continue to plague the women of the valley. And naturally, these only deepen the fear that they have been accustomed to possess.

One of those who remain trapped in this state of fear is a friend, Sana. She resides in a compact house situated in a narrow alleyway in Dalgate and confines herself to the four walls of her room, spending a majority of her time studying for online classes; she prefers the seclusion of her house instead of being exposed out in public.

For a long time, I did not unreservedly understand why she would choose to remain in this solitude when she could be out in the bustling streets of Srinagar, exploring the city and living the life of any ordinary teenager.

Growing up outside Kashmir, I would normally give up an arm and a leg to have chai from Dalgate, windowshop the latest trends in pherans and shawls, and eat street food that I would possibly regret for the next week.

But this was my idea of Kashmir.

So when I visited the valley last year, I was with Sana when she mentioned that every time she stepped outside, she covered herself from head to toe. This was not because of religious obligations or any other understandable reason- she told me in Urdu, 'yahan toh log aakhon se hi khaa jaate hain' (here, people devour one just through their gaze).

Now, this is quite an intense statement to be uttered by a human being, let alone a teenage girl. And I failed to comprehend why this was a concern in Kashmir, a region with a rich Islamic heritage where men would justifiably be expected to lower their gaze and women would be obligated not to judge anyone.

Then why this atmosphere of letting women feel stifled and targeted?



I started to get answers when I recalled how my own time in Kashmir is usually spent, which in a way is much like my friend Sana's.

Every evening, we have a stall of aaelve munj or potato fries set up in our village. So each time I visit the valley, it's almost tradition to relish these like there's no tomorrow.

When I was to go to this stall, I would plan for its walk which was nearly five minutes. Even so, it did not suffice for me to go with a friend; I was conditioned to be accompanied by a male or an older woman.

While I wholeheartedly resisted this, I was left with no choice in the end but to succumb to these restrictions. Because in fact, the fear of leaving unescorted in one's own neighbourhood is extreme.

And, the reason for this is that there is something inherently unsafe about being a woman and walking in a dark night, given the present conditions.

Whilst this is a small, specific example, it speaks clearly of the reality we as women face, constantly fearing for our lives and our wellbeing.

ring for our lives and our wellbeing. In a sense, every single step we take outside of our homes is a constant reminder that we could be walking closer to a danger that may be creeping up on us from anywhere.

So the next time we hear about the latest survey or statistical report on the conditions of women in Kashmir, let's take a step back and remind ourselves that what we're

presented with is not fictitious, but a reflection of the social attitudes that we see around us, that we tolerate, and that we often enable.

It is certainly a state of affairs that we have come to endure, but it should not be one we accept as the truth and least of all settle for in the end.

he world is on the verge of entering an era where the walking-talking teacher in the classroom will be replaced by a robot, which can process information and organise ideas much faster and more accurately than any human being. There are many reasons for this prediction. The ability to teach online from remote locations has attuned learners to see the instructor only as a virtual image on a screen. The powers that control the industry of education are increasingly pushing institutions to bring a uniformity in instruction pedagogy and evaluation methods, leaving little scope for classroom experimentations. Finally, the technology of robotics makes teaching through machines possible. No higher educational institution feels existentially secure unless it pays money to get some form of recognition from an accreditation agency. Every detail to be taught, in every class session, has to be planned and aligned with predetermined course objectives and programme objectives. All other activities related to teaching and evaluation are rigidly streamlined so as to provide the 'assurance of learning'.

There are a number of forces that have created this straitjacket for classroom teaching. The explosion of higher education as a mass-produced, marketable commodity has necessitated pervasive controls. There are excellent institutions of higher learning followed by extremely poor institutions that do not provide any learning worthy of mention. Hence, regulators are needed. As all regulators do, they force the regulated entities to become clones of one another. The model for cloning is often constructed at a level of mediocrity since the fear is that not all institutions can be brought up to a desired standard. The best institutions are made to converge to the worst. The additional paperwork required for the regulator to check compliance to the prescribed norms needs quite a bit of extra effort from teachers. This takes time away from teaching and research. The regulators of higher education are also becoming increasingly focused on research. Research, or the production of knowledge, is supposed to be far



more important than teaching. Pure teaching institutions are considered to be at the bottom of the pile. On the other hand, pure research institutions are considered 'five star' in terms of human and financial resources. The compulsion to focus on research allows teaching to be considered secondary by young faculty members. The bulk of the research produced for survival — for tenure and for promotions — is of poor quality and socially irrelevant. It is a paper chase in an absurd numbers game.

In my four decades of teaching experience, I had seen the beginnings of the changes described above. I found that compared to the decades of the Seventies and Eighties, fewer and fewer of the really first-rate students want to pursue academics. Yet, teaching as a profession is much better paid now compared to the past, both in absolute amounts as well as relative to other occupations. Academic pursuits are no longer considered attractive. During my own student days, I had the fortune of being taught by some outstanding teachers. Indeed, most of my peers who pursued academics had been inspired by their teachers. Not all were great researchers, but most were able to instil ideas for research in the students they taught, to think beyond the textbook. This set of outstanding teachers was excellent in quite different ways. There was no set model of a great teacher.

One aspect of great teaching is to be able to make the weakest in the class understand the basics of what is being discussed, while stimulating the best



to know more about the topic. This requires great mastery over the subject and lucidity in communicating to students over a wide spectrum of receptivity. Another aspect I had noticed was the ability to relate abstract ideas to issues in everyday life, through relatable examples and through references from seemingly unrelated subjects. One teacher became a role model for me because he had a relentless way of probing a problem deeper and deeper. He would keep on asking 'why' after every answer we could think of. At the point of our exasperation, he would reveal an explanation that none of us had been able to anticipate.

Great teachers came in all types of personalities too. I have had teachers who exuded a great deal of confidence in dealing with classroom mischief with a fine sense of humour and a wry wit. I remember another teacher who had the rare ability to teach extremely complicated and difficult topics in an extremely lucid manner, where arguably the worst student in the class would be able to grasp the topic. Yet another teacher taught things that were not part of any published material or textbook, at least not in the way the subject was presented. There were funny instances of great teachers too. One teacher would often, after proving a theorem rigorously on the chalkboard, ask the class how they would make the janitor understand the logic without using the mathematics. Another famous teacher would have a remarkably succinct response to questions asked: he would either respond by saying 'interesting' or else he would

say 'I don't know'. Then he would continue to lecture. We later learnt from seniors that the first response meant it was a good question and the student should go to his office and discuss the matter in greater detail. He did not want other students to benefit from the answer without the consent of the questioner. The latter response meant that the question was silly and not worth pursuing.

A great teacher must know the subject really well, have depth enough to raise researchable questions, should demonstrate being passionate about the subject and, of course, have great communication skills that can create rapport in the classroom. One iconic teacher who I never had the occasion to meet in the classroom had described teaching as a performance in front of a live audience with a dynamic script. It was having the ability to keep creating without going beyond the grammar of the subject, like a musician expounding on a raga.

Technology is breaking boundaries as far as access to academic learning is concerned. Classroom teaching is being mechanised to a remarkable extent where even if human teachers existed, their ability to be creative would be stifled. The classroom as an institution of higher learning is on its way to oblivion. What is also disappearing is the profession of teachers who helped students 'learn how to learn'. Large amounts of data are eroding the skill to think and analyse. Higher learning is now about mechanically learning to use the tools of any subject. In all these disruptions, the usefulness of asking questions and doubting things is being lost. The student believes what is taught as truth — from history to economics to biology. Controlling the classroom content facilitates influence over the minds of a whole generation of learners. It is the era of the eclipse of the classroom and the creative master of its universe.

## The Silver Screen Journey One-to-One with Actor Mir Sarwar

'Critical to understand the world and the craft in order to create films that make a difference in society'

ir Sarwar, an actor from the valley who made his Bollywood debut in Kabir Khan's 'Bajrangi Bhaijaan', is now making a name for himself in the industry

He has given notable performances in his roles in movies and web series and is not only doing Hindi movies but also Marathi movies, as his film 'Ravrambha' is set to hit theatres on May 12th.

Mir Sarwar spoke briefly with Kashmir Observer about his journey and experiences in the Bollywood film industry.

What prompted you to relocate to Mumbai and pursue a career as an actor? What was the influence?

Mumbai is, of course, the final destination for anyone who wants to become an actor so that they can be a part of movies and web series. I initially spent the majority of my time in Delhi. I did my theatre, modelling, and basic training there, and I worked in theatres for many years. I was a sportsman in Kashmir, which helped me in other fields. After 5-6 years in theatre, I saved up some money and planned to relocate to Mumbai but for various reasons, I was unable to do so. But after a while, I moved to Mumbai and began visiting the city for film purposes.

plete your education, whatever you're doing in life, and if you want to get into this field, there are many institutions you can join in many cities, and if you're really serious about it and your family is supportive, it's a blessing, especially financially. Just chase your dreams, nothing can stop you. "Acchi niyat se aage badho toh uparwala bhi saath deta hai!"

What films did you watch growing up, and where/how did you watch them in Kashmir?

There was only Doordarshan when I was a kid, and we didn't have any say over what kind of movies we watched. But I've always liked sensible movies. And I've always enjoyed watching Bollywood films as well as other films from my childhood. I recall an incident in 1996, when I used to travel for sports events and championships. I used to read all the magazines, and on Filmfare, there was a list of films that had come out that year. There were 120 films released that year, and I saw them all in the theatre. I used to always extend my stay in a particular city or Jammu. So I can watch all the movies, and most of the theatres in Jammu are nearby. I remember there used to be three or four shows a day, and I used to dash from one cinema hall to the next to catch the film on time. To save money, I did not take the bus or an auto rickshaw. That was my obsession. And as I grew older, I began to watch world




and the dedication. If you are dedicated to your craft, there will be no obstacles. There is no impediment, and no one can stop you. And, yes, you must work very hard to make contacts. You can only do that if you know some people and have met them. In terms of acting, auditions are the best way to get work. It takes some time. It doesn't happen in a day, a month, or even many months. It can take years at times, but all you have to do is hang in there.

What are your thoughts? What were your initial challenges as a Kashmiri when you first moved to Mumbai?

Every city has its own set of challenges. and moving to Mumbai was no exception. I also went to those auditions and fest receptions, got appreciated, and got some work. It's a long, never-ending process, and you keep learning until the end. And yes. always advise young people to work on their skills, work on their language, body language, and accent, and learn some new things. You have mobile phones, so record your voice, listen to it, and correct it. Create funny reels, scenes, and auditions, then upload them to YouTube and share them with your teachers. Every city has a teacher, every city has a theatre group, and every city has an institute, large or small. If you're an actor, it's always a good idea to join a theatre group. If you want to start singing, go to some masters. "Guru har cheez mein zaroori hota hai!" So, whatever field you want to pursue, all you have to do is read more and watch more good stuff. The internet is the greatest invention of our time. You can search and google. It has benefits and drawbacks. You can harness its power. There's a lot to learn on the internet, so watch some good stuff.

collaborate with talented filmmakers, and I'd like to work with all of them.

What is your take on Indian cinema, and what role do you believe it plays in changing public perceptions of Kashmir?

Anyone making a film about Kashmir should do their research and not follow the same formula as everyone else. Many films are made on the same subject, with only minor differences, but the central theme remains constant. There are many other aspects to Kashmir. There are also suitable subjects if you are making a film in Kashmir. Aside from that, many people, whether rural or urban. Many people have a negative perception of Kashmir, and when they visit, they return with a completely different perspective. What do you think about becoming an actor/filmmaker and in order to create art? How important is formal education?

Every field requires some level of expertise, whether obtained through doing, assisting, or being a part of groups. It all depends on your situation. Everyone comes from a different background. Nobody can plan things in advance, and some people are fortunate in that their family is stable and willing to assist them financially, especially financially, and they accept their journey and career choice. The majority of people are not so fortunate. Many societies do not accept or support filmmaking and acting as a profession. Things have changed in recent years, but this was not always the case. It is essential to study and rely on education. Never rely on just one thing in life. Comcinema, including French, Iranian, and other films, as well as Bollywood and Hollywood classics. It is critical to understand the world and the craft in order to create films that can make a difference in society. Tell the world your story as an actor and filmmaker. It is beneficial to learn the craft, to develop your own basic idea that you believe in, and then to hire professionals in each department so that you can do justice to the story.

## How has Mumbai so far treated you?

Mumbai has been extremely kind to me, and it is the best city in terms of the acting and filmmaking professions. There are no obstacles if you have talent and potential. Nobody can stop you, and there is the point of the point



things online. It is always preferable to visit the location and conduct proper research before writing and producing a film about Kashmir in order to spread understanding. Because people who only watch television channels and debates have a completely different perception and image of Kashmir.

You've worked with a lot of experienced actors. What do you learn from working with such actors?

It's always fun to work with different actors in the industry. And because humans differ in appearance, voice and personality, their acting style differs as well. Everyone has their own individual and unique style of acting, and while they use different techniques to portray, most actors use their own personality traits. Mir Sarwar as a person will be Mir Sarwar in a particular character, but there will be some differences, some mannerisms, some observations, whatever the character requires. I've already worked with talented actors and learned a lot from them; I'd like to work with even more in order to continue learning and honing my craft.



## Cigarette Butts Leak Deadly Toxins Into Environment, Study Finds

igarrete filters leak thousands of toxins and plastic fibers into the environment that are toxic to aquatic larvae, according to a study that calls for these filters to be completely banned.

A research team at the University of Gothenburg in Sweden found that microfibers and the chemicals that leak out of the filters in cigarette butts are toxic to aquatic larvae.

"The filter is full of thousands of toxic chemicals and microplastic fibers, so it's not just any piece of plastic that's being discarded into the environment. It's hazardous waste," said Bethanie Carney Almroth, Professor of Ecotoxicology at the University of Gothenburg.



The study, published in the journal Microplastics and Nanoplastics, tested the effects of the toxins that are found in the filter after smoking, as well as the substances that are in the filter from the start, on aquatic mosquito larvae.

It found that the toxins lead to a 20 per cent higher mortality rate among mosquito larvae. Previous research has shown that the toxins in the filters also have adverse effects on many other aquatic organisms.

For example, fish can die if they are exposed to concentrations corresponding to the toxins exuded by barely two cigarette butts in one liter of water for four days. "Cigarette filters are also a major source of the microplastics that find their way into our environment—something we know has a major negative impact on biological life. The EU has already classified cigarette filters as hazardous waste," said Almroth. The researchers also observed in the study how smokers in Gothenburg behave when it's time to put out their cigarettes.

It turns out that many people throw their cigarette butts on the ground even if there are ashtrays nearby.

## After Go First, aircraft lessor files insolvency plea against SpiceJet

**NEW DELHI:** SpiceJet too seems to be facing headwinds, with a lessor filing a plea seeking insolvency resolution proceedings against the no-frills airline and the petition is scheduled for hearing before the National Company Law Tribunal (NCLT)

It also comes at a time when competitor and cash-starved Go First has cancelled flights and has filed for voluntary insolvency resolution proceedings.

Aircraft lessor Aircastle (Ireland) Ltd has filed the petition against SpiceJet for initiating insolvency resolution proceedings. The plea was filed on April 28 and it is to be heard by the NCLT Principal Bench on May 8, according to an update on the tribunal's website.

A SpiceJet spokesperson said currently, there are no aircraft from this lessor in the airline's fleet on the two petitions.

and that the development will in no way affect its operations.

"All aircraft from this lessor have already been returned by SpiceJet...

"We are confident of resolving the matter without court proceedings and we are in discussions with their senior leadership team for the same," the spokesperson said in a statement.

Further, the airline spokesperson said the comments provided here are without prejudice to the airline's rights and in no way should be deemed as admission of any liabilities.

According to the NCLT website, two more petitions for insolvency resolution proceedings against SpiceJet are pending. The plea by Willis Lease Finance Corporation was filed on April 12 and the one by Acres Buildwell Private Ltd was filed on February 4. There was no immediate comment from SpiceJet

## **Govt To Launch Special Drive To Detect Fake GSTINs**

**NEW DELHI:** The CBIC will undertake a two-month-long special drive to detect fake GST registrations and take action to identify the masterminds/beneficiaries as it aims to weed out fake ITC claims

Fake/non-genuine registrations are being used to fraudulently pass on input tax credit (ITC) to unscrupulous recipients by issuing invoices without any underlying supply of goods or

services or both. This menace of fake registrations and issuance of bogus invoices for passing fake ITC has become a serious problem, wherein fraudulent people engage in dubious and complex transactions, causing revenue loss to the government, the GST Policy wing of the CBIC said.

be launched by all Central and State Tax administrations during the period 16th May 2023 to 15th July 2023 to detect suspicious/fake GSTINs and to conduct requisite verification and further remedial action to weed out these fake billers from the GST eco-system and to safeguard Government revenue," the Central Board of Indirect Taxes and Customs (CBIC) said in a communication.

Currently, there was 1.39 crore taxpayers registered under Goods and Services Tax (GST).

The identification of fraudulent GST identification numbers (GSTINs) would be based on



detailed data analytics and risk parameters

GSTN will identify such fraudulent GSTINs and share the details of such suspicious GSTINs with the concerned State/ Central Tax administration for initiating a verification drive and conducting necessary action subsequently.

National Coordination Meeting of the State and Central GST officers on April 24 discussed the issue of unscrupulous elements misusing the identity of other persons to obtain fake/ bogus registration under GST. On receipt of data from GSTN,

time-bound exercise of verifica tion of the suspicious GSTINs shall be undertaken by the concerned jurisdictional tax officer(s). If, after detailed verification, it is found that the taxpayer is non-existent and fictitious, then the tax officer may immediately initiate action for suspension and cancellation of the registration.

'Action may also be taken to identify the masterminds/ beneficiaries behind such fake GSTIN for further action, where ever required, and also for recovery of Government dues and/or provisional attachment of property/ bank accounts, etc. as per provisions of section 83 of CGST Act," the CBIC said.

"Looking at the business in India, we did set a quarterly record, grew very strong, double-digits year-over-year. So it was quite a good quarter for us, taking a step back, India is an incredibly exciting market," Cook said.

The Apple CEO praised the "dynamism in the market" and asserted that its "vibrancy is unbelievable"

"It's a major focus for us. I was just there, and the dynamism in the market, the vibrancy is unbelievable. Over time, we have been expanding our operations there to serve more customers, and three years ago, we launched the Apple Store online, and then, as you just mentioned, we launched two stores just a few weeks ago, and

The new stores in Mumbai and Delhi come at a time when Apple is trying to deepen its retail push in India, the world's second-largest smartphone market.

## **India's Forex Reserves** Rise USD 4.532 Bln To **USD 588.78 Bln**

MUMBAI: India's foreign exchange reserves jumped USD 4.532 billion to USD 588.78 billion for the week ended April 28, the Reserve Bank of India said on Friday.

The overall reserves had dropped USD 2.164 billion to USD 584.248 billion in the previous reporting week.

In October 2021, the country's forex reserves had touched an all-time high of USD 645 billion. The reserves had been declining as the central bank deployed the kitty to defend the rupee amid pressures caused mainly by global developments.

For the week ended April 28, foreign currency assets, a major component of the reserves, increased nearly USD 5 billion to USD 519.485 billion, according to the Weekly Statistical Supplement released by the RBI.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves. Gold reserves dropped USD 494 million to

USD 45.657 billion, the RBI said. The Special Drawing Rights (SDRs) were up USD 35 million to USD 18.466 billion,

The country's reserve position with the IMF was down USD 4 million to USD 5.172 billion in the reporting week.

In 2020, the foreigners' footfall in the Kashmir valley received another blow following the outbreak of Covid-19 and travel restrictions.

However, the Valley received over 24 lakh tourists this year in a record footfall. The tourism official said the foreign tourists have also preferred to visit Kashmir now.

According to official data, in 2020, 3897 foreign tourists arrived in Kashmir, while in 2021, the number declined to 1615. However in 2022 around 20000 foreigners visited the region.

India is hosting the G-20 meeting this year, as G-20 Presidency, the country will be inviting Bangladesh, Egypt, Mauritius, Netherlands, Nigeria, Oman, Singapore, Spain and UAE as Guest countries. Over 200 meetings are expected to be held across the country.

Srinagar city is also going to host one of the G20 events from May 22 and 24, despite strong opposition from neighbouring countries-Pakistan and China.

Notably, this will be the first international event in Kashmir post abrogation of Article 370—that granted special status to the Himalayan region.

The tourism secretary said there is a onestop centre for all the necessary permissions. There is an online portal, there is an enabling

atmosphere so that the film production units do not face any difficulty, he said.

On the shooting of Shah Rukh Khan-starrer movie "Dunki" in Kashmir last month, Shah said major production houses and film stars are coming to the Valley for shooting films.

"I want to give an open-hearted invitation to

all those, whether inside the country or outside, interested in shooting in Jammu and Kashmir. This year, we are projecting 300 new destinations and they can choose any. The government of Jammu and Kashmir will be forthcoming and facilitate you in every way," he said. (PTI)

The loss of five jawans in Kandi forest is the third major incident this year. It took place at a time when the forces had been engaged in a massive combing operation for the past 15 days following an ambush on an army truck in Bhata Dhurian (Poonch).

Five soldiers were killed and another was injured on April 20 when an army truck was bombed and strafed with bullets by militants.

More than 250 people were detained for questioning during combing operations in the wake of the incident. Six overground workers who extended full support to militants were arrested, they said

According to military officials, militants now have adopted a strategy of engaging troops or attacking people, and then laying improvised explosive devices to harm government forces engaged in combing operations.

This also happened in Dhangri village in Rajouri where militants killed seven civilians in two attacks that came close on the heels of each other on January 1 this year.

In two major incidents in Rajouri in 2022, five army personnel and two militants were killed in a suicide attack at a security camp at Pargal-Darhal on August 11, while two civilians were killed in a firing incident outside an army camp near Rajouri town.

Four blasts rocked Kotranka in Rajouri district between March and April last year. All these cases were worked out by police with the arrest of the accused.

Nine army personnel were killed in two separate encounters with terrorists in Bhatta Durrian in Mendhar tehsil of Poonch districts in October 2021.

Two army personnel, one of them a lieutenant, were killed in a mine blast in Nowshera sector of Rajouri on October 30, 2021. Rajouri and Poonch districts have witnessed more killings of army personnel than the militancy-hit Kashmir Valley.

Northern Army Commander Visits Encounter

Amid an exchange of fire between militants and government forces, Northern Army Commander Lt Gen Upendra Dwivedi visited the encounter site in the Rajouri district on Saturday, an army spokesman said.

According to a defence spokesperson, contact has been established with hiding militants around 1.15 am on Saturday and the firing between the two sides was continuing when the last reports were received.

The Army said that General Officer Commanding-in-chief, Northern Command, was briefed on all aspects of the ongoing "Operation Trinetra" by ground commanders.

In a tweet, the Army Northern Command said, "OP TRINETRA Lt Gen Upendra Dwivedi Army Commander Northern Command at ground zero, reviewing the operational situation on the ongoing operations at Kandi in Rajouri where contact was re-established with militants."

"He was briefed on all aspects of the operations by ground commanders," the tweet read. The spokesman said a wreath laying ceremony for the Army personnel killed in the operation will be held at the Air Force station

## **Pakistan Will Only Come For WC** If BCCI Gives 'Written Guarantee' On 2025 CT Participation

KARACHI: Pakistan Cricket Board chairman Najam Sethi will seek a "written guarantee" from BCCI supremo Jay Shah about Indian team's participation in 2025 ICC Champions Trophy in Pakistan before committing on their national team playing its ODI World Cup games in India, later this year.

The 2023 World Cup will be played from October 5 and BCCI have zeroed in on Ahmedabad (for India game), Chennai, Bengaluru and Kolkata as possible venues for Babar Azam's side.

However with ACC chairmanship of Jay Shah not confirming the proposed 'Hybrid Model' for the upcoming Asia Cup, where India played its matches in UAE and Pakistan play their games in their home country, Sethi apparently has been advised to play the hardball.

According to a reliable source, Sethi is scheduled to leave for Dubai on 8th May where he will hold meetings



with ACC and International Cricket Council officials

The source in PCB said that during his Dubai visit, Sethi is also expected to start lobbying to garner support for Pakistan's "principled stance that it will not play its World Cup matches in India unless the BCCI and ICC give written guarantees India will come to Pakistan to play in the 2025 Champions Trophy." "Sethi has recently met with some government officials and also

obtained advice from them on whether Pakistan should play in the Asia Cup if it is not held in Lahore and Dubai as proposed by the PCB under its hybrid model plan to the ACC," the source said.

He added that Sethi has got tacit approval from the government quarters to convey a strong and blunt stance to the ACC members about hosting the Asia Cup in September.

'Sethi is expected to make it very clear to the ACC members that either they accept Pakistan's hybrid proposal or the PCB will not take part in the competition this year if it is moved from Pakistan." The PC chairman is unwilling to accept more delays on sched-

uling of Asia Cup. 'Apparently, Sethi has now realized that it is time for some hard decisions and is not willing to accept any more delays from the ACC on finalization of venues and schedule for the Asia Cup." "Sethi is clear now no Asia Cup matches in Pakistan, no Pakistan team in Asia Cup," the source claimed.

## Kohli Writes To BCCI, Claims He Said **Nothing Wrong To Opposing Players**

**NEW DELHI:** Former Royal Challengers Bangalore (RCB) captain Virat Kohli wrote a letter to BCCI officials saying that he didn't say anything wrong to Lucknow Super Giants mentor Gautam Gambhir and pacer Naveenul-Haq during an altercation in the Indian Premier League (IPL) 2023 match in Lucknow on May 1.

The match was marred by an on-field altercation involving Kohli, Naveen, Amit Mishra and Gambhir.

The ugly clash between the two Indian cricketers - Kohli and Gambhir wasn't a pleasant sight, and as a result of that, both of them were fined 100 per cent of their match fees for the altercation. On the other hand, Afghanistan fast-bowler Naveen-ul-Haq was fined 50 per cent of his match fees.

In a report published by the Hindi daily Dainik Jagran, the former RCB captain has written a message to a few BCCI officials explaining the situation and expressing his disappointment after being handed a fine of 100



per cent match fee.

irked by the constant barrage of bouncers and throws that Kohli had asked Siraj to bowl. But in his message, Kohli denied doing that and said he did not direct Siraj to hit Naveen but instead only instructed him to bowl bouncers.

After the game, during the customary handshake, Kohli and Naveen had a heated exchange, and the former India captain reportedly complained about the pacer's aggressive behaviour.

Soon after that, Kohli and Mayers were having a conversation when Gambhir stepped in and took the West Indies cricketer away. Kohli then told Gambhir to stay away from the matter, to which the LSG mentor replied that his players are like his family and he won't tol-

erate anyone abusing them. Since that day, a lot has been written and reported about that incident, and several videos and pictures of the ugly on-field fight between the two went viral on the internet. (IANS)

After the coronation, the new monarch will have to follow certain rules ranging from no autographs and selfies to some eating restrictions.

#### 1. King cannot refuse to accept gifts

As per the royal tradition, the members of the British royal family must accept all gifts presented to them during tours or engagements. However, the gift policy of the royal family states that the members must not accept any gift, hospitality or service which would or might appear to place that royal "under any obligation to the donor". The policy also says that "before declining the offer of a gift, careful consideration should be given to any offence that might be caused by such action".

#### 2. King Charles II cannot

#### travel with Prince William

After being crowned the King, Charles will not be allowed to travel in the same plane as his son Prince William who is the heir to the British throne. As per royal tradition, the two must take separate flights so that lives of both the royals are not in danger in the event of a mishap.

#### 3. Dressing rules

The King must also follow some dressing rules when travelling to foreign countries. According to the rules, the royals should do "diplomatic dressing". This means that their dress should reflect the local tradition of the country they are travelling to.

#### 4. No selfies or autographs

As the new monarch, King Charles III will not be posing for selfies or giving autographs. This rule applies to all members of the British royal family though there is no official protocol regarding selfies.

#### 5. No shellfish for the King

The British royals, including the King, are advised not to consume shellfish to avoid food poisoning. The King also cannot accept food from strangers which is to ensure his safety.



# "Papa, Please Come Back," Says Daughter Of Soldier Killed In J&K Attack

**Dalpat:** "Why are you not getting up? I don't want anything, papa. Please come back," 10-yearold Pawana Chib cried as she stretched out her hand to touch the face of her father, Havildar Neelam Singh, who lay in a coffin before her on Saturday.

Standing next to her, Chib's mother Vandana is staring in disbelief at her husband's lifeless face held between her hands before she breaks down.

The Havildar's seven-year-old son Ankit is also inconsolable.

Havildar Singh was among the five soldiers who died in an explosion triggered by terrorists on Friday in the thickly forested Kandi area in Jammu and Kashmir's Rajouri district where an operation is underway to flush

As Havildar Singh's body reached his Dalpat-Chak Kripalpur village here in a Tricolourwrapped coffin, some wept and others tried to make their way through a crowd of hundreds who had gathered to catch one last glimpse of the "brave son of

The body was brought in a cavalcade from the Indian Air Force station in Jammu, where Lieutenant Governor Manoj Sinha and Northern Army Commander Lieutenant General Upendra Dwivedi, among other top Army, police and administration officials, paid homage to the soldier at a wreath-laying ceremony.

Chants of "Neelam Singh Amar Rahe" echoed through the village as Vandana saluted her husband one last time.

Havildar Singh was cremated with full military honours. His brother and CISF jawan Angad Singh lit his pyre amid chants of "Jai Shaheed, Jai Army, Jai Hind". Recalling the last time Singh vis-

ited home, his father Hurdev Singh Chib said he is proud of his son. "I am proud of my son. He was a brave commando who laid

down his life fighting terrorists. He was born a warrior. As a child, he always wanted to join the Army," Hurdev told PTI.

A few days ago, he had come home for a while, the distraught father recalled, adding, "He was so dutiful that he just had tea and

left." According to Hurdev, Singh was inducted into the Army in

Havildar Singh's father-in-law Captain Raghvir Singh Bhau (retd) echoed Hurdev's senti-

"He was brave and never feared anything. He was part of dozens of successful operations in various parts of Jammu and Kash-

unit and the Army," he said. Havildar Singh's cousin Suresh, however, was angry.

## Saudi Arabia developing high-tech visa service

RIYADH: The Saudi Ministry of Foreign Affairs has launched a new initiative to cancel the visa sticker on passports and switch to the e-visa, from which data will be read via a QR Code.

This initiative falls within the framework of automating and improving the quality of consular services provided by the ministry.

As a first stage, the procedure has been activated at Saudi missions in the UAE, Jordan, Egypt, Bangladesh, India and the Philippines.

The ministry aims to develop a visa-issuing mechanism — including work permits, residence and visit visas – in accordance with the latest technology.

Last year, the ministry an-

ing a "personal visit" visa, which enables visitors to enter the Kingdom to visit friends or acquaintances who are Saudi citizens.

The visa also allows individuals to travel between the Kingdom's regions and cities, perform Umrah rituals, visit Makkah and Madinah and other religious and historical sites, and attend cultural events.

The ministry said that people can apply for the visa through easy and convenient electronic steps on the visa platform website.

Saudi citizens can invite friends to visit Saudi Arabia and perform Umrah by submitting a request for a personal visit on the visa platform and applying for a "visit" request, by logging in through the unified national access platform and filling out the data for the in-
