## Extremely Rare Bird Western Tragopan Spotted In Kashmir

**Auqib Javeed** 

**Srinagar:** An acclaimed bird photographer from Bangalore has captured Western Tragopan—a globally threatened species of birds in the Kashmir Himalayas, much to the excitement of bird watchers and wildlife enthusiasts.

The highly elusive bird Western Tragopan (Tragopan melanocephalus) is an extremely rare and vulnerable bird in the world.

The bird was captured by Jainy Maria and Mudasir Manzoor, a

Wildlife Guide and photographer, in a local wildlife sanctuary after 10 days of intense search, an official of wildlife department told Kashmir Observer.

Western tragopan is a medium-sized brightly plumed pheasant found along the western Himalayas from northwestern Pakistan through Jammu and Kashmir into Himachal Pradesh and possibly the western parts of Uttarakhand.

"The bird is not critically endangered but globally threatened," Wildlife Warden, Shopian division, Intisar Suhail

#### Rajouri Operation Enters Day 4

**Jammu:** Security forces continued "Operation Trinetra" for the fourth consecutive day on Monday to track down militants hiding in the Kandi forested area in Jammu and Kashmir's Rajouri district, officials said.

A few persons were questioned about the suspected movements of militants. However, security forces are yet to establish any fresh contact with the militants, they said.

"There was no fresh contact with militants hiding in the forested Kandi area. A massive search operation to track down ultras is on," an official said.

Five Army personnel were killed while a major-rank officer was injured in an explosion triggered by the militants in the Kesari hill forest area of Rajouri

on Friday morning.

A militant, who is said to be the part of a group that carried out an attack on civilians in Dhangri village of Rajouri early this year, was killed the next morning. His associate was believed to have been injured in the exchange of fire with security forces but managed to slip

away, the officials said.

Jammu: The Shri Amarnath Shrine Board (SASB) on Monday made Aadhaar card and registration slip mandatory for the pilgrims intending to undertake this year's pilgrimage to the cave shrine of Amarnath in South Kashmir.

This was decided in a meeting chaired by Principal Secretary to Lieutenant Governor and Chief Executive Officer (CEO) Shrine Board Mandeep K. Bhandari on Monday with the concerned Deputy Commissioners (DCs) and line departments to review the arrangements for this year's annual pilgrimage, an official spokesperson said.

In the meeting, he said, it was informed that the adding Aadhaar number on the designated portal will automatically

Srinagar: The family members were shocked to see their house in the Baghat area in uptown Srinagar burgled on Monday upon their return from a wedding function of a close relative.

Living in the Jahangir Colony of Baghat, the family members said they had gone to attend a marriage party two days ago, and upon their return, they were shocked to see their house looted and vandalized.

"As soon as we entered our house, we found everything scattered. Wardrobes and lockers were broken, and gold, cash, copper, and other valuable items were missing," they said.

One of the members said the thieves looted the money they had saved for the up-gradation of the house, the work on which was scheduled to begin in the next few days.

"Me and my younger sister had bought some jewellery, but thieves have not spared anything and looted all of it," she said.

Another member said, "I could not leave my father alone due to health issues and there was no one to look after him as my mother had passed away. Thieves after entering our house have looted gold, cash, copper and other valuable items.

The family members said they were shocked and terrified to see their house looted. "We don't know exactly how much they have looted, but so far we made tentative calculations which are: jewellery around Rs 4 to 5 lakh, copper utensils of nearly 5 to 6 lakh rupees, silver items, cash of Rs 2 to 3 lakh and other valuable items," he said.

## **Srinagar Reports 271 Car Theft Cases Last Year, 69 Vehicles Recovered**

Srinagar: 271 cases of car lifting were reported in Srinagar city last year of which 69 stolen vehicles have so far been recovered by the police, while 202 such vehicles are vet to be traced.

Out of 271 stolen vehicles, Srinagar Police after strenuous efforts managed to recover 69 stolen vehicles.

The data provided by Srinagar

police Trust reveals that 202 stolen vehicles are still missing.

Police have arrested several accused in connection with vehicle theft incidents and filed chargesheets in the court of law in this direction.

Car lifters have stolen the vehicles mostly at those places where CCTV cameras have not been installed. Police sources said that CCTV footage helps police to zero in on the thieves while in the absence of any footage, it takes time to apprehend the criminals.

Data shows that from 2020 till 2021 ending motor vehicle thefts have doubled, however, there was a slight dip in 2022.

The last three years' data from 2020 to 2022 reveals that car lifters managed to steal 657 vehicles across Srinagar city out of which Srinagar police have recovered 199 vehicles and 458 vehicles are still missing.

## Major Among 7 Killed In J&K

RINAGAR - An army major and a Congress block president were among, seven persons killed as militants set off three explosions and clashed with security forces at various places, in Jammu and Kashmir. The army major was killed when militants ambushed a search party at Pazipora-Batpora village of Handwara in the border district of Kupwara late last night, an official spokesman said.

He said an unidentified militant, believed to be a foreigner, was also killed in the retaliatory fire. Some arms and ammunition were recovered from him. In a separate incident, militants detonated an improvised explosive device (IED) at Donipora-Sangam, 45 kms from here on Srinagar-Jammu National Highway, this morning killing an army jawan, the spokesman said. Hizb-ul-Mujahideen militant outfit has claimed the responsibility for the blast.

Militants abducted and later hanged to death Congress block president and village head Abdul Rahim Paul in Tangmarg area Of Baramulla district, the spokesman said. Paul, a resident of Kuthama, was abducted by militants from his house last last night and his body was found hanging from an electric pole at Saraipul today, he said

The spokesman said militants kidnapped one Ghulam Mohammad Lone from his house at Basman-Wadwan in Doda district on Wednesday and later killed him. In a separate incident, three security personnel were injured in a landmine explosion triggered by militants at Dachi-Makhvari in Mandi sector of Poonch district last night, the spokesman said. He said militant's also carried a grenade explosion at Nai Basti in Anantnag district when CRPF personnel were patrolling the village, injuring a civilian Shabir Ahmad Bhat.

Security forces recovered 24 under barrel grenade launcher (UBGL) grenades, ten IED switches and 1740 rounds of all ammunition during search operations at Bindigala and Nanyan in Noushera sector of Rajouri district last night, the spokesman said. (Kashmir Observer, 09 May, 2005)

## At Islamabad Meeting, A Key Agreement Between China, Taliban

**ISLAMABAD:** The agreed with China and Pakistan to extend the Belt and Road Initiative to Afghanistan, potentially drawing in billions of dollars to fund infrastructure projects in the sanctionshit country.

Chinese Foreign Minister Qin Gang and his Pakistani counterpart Bilawal Bhutto Zardari met in Islamabad on Saturday and pledged to work together on Afghanistan's reconstruction process including taking the \$60 billion China-Pakistan Economic Corridor to the Taliban-ruled nation.

"The two sides agreed to continue their humanitarian and economic assistance for the Afghan people and enhance development cooperation in Afghanistan, including through extension of CPEC to Afghanistan," according to a joint statement issued by Pakistan's foreign ministry following the meeting.

Chinese and Pakistani officials have previously discussed extending the project to Afghanistan built under President Xi Jinping's flagship Belt and Road initiative that started almost a decade ago. The cashstrapped Taliban government

has expressed readiness to participate in the project and the prospect of getting much needed infrastructure investment.

The Taliban's top diplomat, Amir Khan Muttaqi, traveled to Islamabad to meet his Chinese and Pakistani counterparts and reached an agreement, his deputy spokesman Hafiz Zia Ahmad said by phone.

The Taliban have also harbored hopes for China to boost investments in the country's rich resources, estimated to be \$1 trillion. The government inked its first contract in January with a subsidiary of China National Petroleum Corporation to extract oil from the northern Amu Darya basin.

The Chinese and Pakistani ministers also stressed on the need to unfreeze Afghanistan's overseas financial assets. The Taliban has been blocked from accessing about \$9 billion of Afghanistan's central bank reserves held overseas on con-cerns the funds will be used for terror activities.

Frozen Assets

Washington later agreed to release half of it to bolster the economy but put it on hold after the Taliban imposed certain school and work restrictions on Afghan women last year.

## **Another Explosion Near** Golden Temple In Punjab, **Second In 3 Days**

AMRITSAR: One person was injured in a low-intensity explosion that took place on a heritage street near the Golden Temple here today morning, close to the spot where a blast was reported on May 6, police said.

No detonator has been found and it appears that the explosive was kept in a container, Di-rector General of Police (DGP) Gaurav Yadav said, adding that it is too early to say whether the blast was someone's "mischief" or there's a terror angle to it

Police and forensic teams reached the spot soon after the explosion and security was stepped up in the area.

Speaking to reporters here, DGP Yadav, who visited the spot, said one person was injured in the explosion which was reported around 6:15 am.

The explosive was very crudely made and assembled. Though no shrapnel was used, there was a loud sound, he said. The officer said the two explosions in the area are being scientifically investigated".

"Our forensic team is present on the spot," he said. "We have not found any triggering device or any detonator," he said referring to the two incidents.

The absence of a triggering mechanism means it is a crude device. It appears that the explosive was kept in a container, Yadav said on Monday's blast.

"At this moment, we are not ruling out anything... It could be someone's mischief, but it is too early to say whether it is a mischief, or there is a terror angle to it," he said. The DGP said CCTV footage is being scanned and details are being sought from eyewitnesses.

"I want to assure the people that everything is normal and we will maintain peace and harmony. People should not lend an ear to any rumours. Punjab Police is there to keep the state safe and secure." he said.

## **Special Flights Help Meet Demand As People Scramble To Leave Manipur**

KOLKATA/GUWAHATI: Several airlines were operating special flights from Imphal to help people stranded in violence-hit Manipur return home, officials said on Monday, maintaining that this resulted in airfares on the route not rocketing out of control despite the massive jump in demand.

Regional carrier Flybig said it operates a Guhahati to Imphal flight via Tezu six days a week. But, since Saturday it has operated three additional flights between Imphal and Guwahati, on which people Arunachal Pradesh, Meghalaya and Maharashtra returned from Imphal.

"A total of 150 passengers were brought back from Imphal to Guwahati over the three days. On Saturday, people from Arunachal Pradesh were brought back, while people of Meghalaya came on Sunday, and a group from Maharashtra were brought to Guwahati on Monday," Flybig's director of corporate affairs Ajay Jasra told PTI.

"Flybig operates under the UDAN scheme, and our average fare from Imphal to Guwahati is ₹3,500. There is no question of charging more from distressed passengers," he said.

## **National Security Advisor Ajit Doval Meets US Counterpart In Saudi Arabia**



WASHINGTON: US National Security Advisor Jake Sullivan had a meeting with his Indian counterpart Ajit K Doval in Saudi Arabia on Sunday, the White House said, adding that the two leaders are scheduled to meet again in Australia later this month on the sidelines of the Quad Summit.

This is the first meeting between Doval and Sullivan after they launched the ambitious India US ICET (Initiative on Critical and Emerging Technology) dialogue here in January. Sullivan is currently travelling to Saudi Arabia.

"National Security Advisor Jake Sullivan met with Saudi Prime Minister and Crown Prince Mohammed bin Salman, UAE National Security Advisor Sheikh Tahnoon bin Zayed Al Nahyan, and National Security Advisor of India Ajit Doval on May 7 in Saudi Arabia to advance their shared vision of a more secure and prosperous Middle East region interconnected with India and the world," the White House said Sunday in a readout of the meeting.

"Sullivan also held bilateral meetings with the Crown Prince, Sheikh Tahnoon, and



Mr. Doval to discuss bilateral and regional matters. He looks forward to further consulting with Mr. Doval on the margins of the Quad Summit later this month in Australia," the White

With Crown Prince Mohammed, he reviewed significant progress in talks to further consolidate the now 15-month long truce in Yemen and welcomed ongoing UN-led efforts to bring the war to a close, as well as covering a range of other issues.

"Mr. Sullivan thanked the Crown Prince for the support Saudi Arabia has provided to US citizens during the evacuation from Sudan. The four delegates agreed to maintain regular consultations and follow up on the matters discussed throughout the day," the White

## **Mob Lynches Pak Man At Imran Khan's Party Rally Over Blasphemy Charge**



**PESHAWAR:** A man was beaten to death by a mob after being accused of blasphemy at a rally for former Pakistan prime minister Imran Khan's party, officials said Sunday.

Blasphemy is a hugely sensitive issue in Pakistan, where even unproven allegations can stir mobs and violence.

Video of the lynching has been shared widely on social media, with police seen vainly trying to stop a frenzied mob from beating the man.

The incident took place on Saturday in the Sawal Dher area of Mardan city in the country's ultra-conservative northwestern Khyber Pakhtunkhwa province bordering Afghanistan.

Police said a man identified as Nigar Alam was asked to deliver the concluding prayer at a rally organised by Mr Khan's Pakistan Tehreek-e-Insaf (PTI) party when the crowd took offence to his comments.

He managed to flee the

scene, police said, but a mob tracked him down to a relative's house.

"A group of individuals climbed over the wall, barged inside, and beat him to death with sticks and batons," said district police chief Najeeb-ur-

"The mob was so agitated that it became extremely challenging for the police to even recover the body," he told AFP. Another local police offi-

cial, Umair Khan, confirmed the incident. PTI leader Imran Khan was

not present at the rally and party officials had no immedi-

ate comment on the incident. According to the Centre for Social Justice -- an independent group advocating for the rights of minorities -- more than 2,000 people have been accused of committing blasphemy since 1987, and at least

88 people killed by lynch mobs

## **Agra Man Arrested For Raping American** Woman, 62, After **Promising Marriage**

NEW DELHI: The Delhi Police has arrested a man from Agra for allegedly raping a 62-year-old American woman on the pretext of marriage, officials said on Monday

The accused, identified as Gagandeep (32), owns a homestay in Agra, they said.

The victim, in her complaint, alleged that in 2017 she came to India and stayed at Gagandeep's homestay. Later, they became friends and eventually got into a relationship, police said.

Over the next few years, she kept visiting India to meet Gagandeep and on several occasions, he allegedly had physical relations with her on the pretext of marriage, they said. The woman further alleged that once he also took

her to Surjamal Vihar in Shahdara where he again had physical relations with her. Gagandeep also took her to Amritsar and other places and his family knew about their relationship. However, she later found out that the man was cheating on her, police said.

On May 4, an FIR was registered under sections 376 (rape) and 328 (causing hurt by means of poison, etc., with intent to commit an offence) of the Indian Penal Code at Vivek Vihar Police Station, a senior police officer said.

"A case was registered and based on the inquiry, accused Gagandeep was arrested from Agra on May 6," he said.

"The state government has already said that this film aims to create division in the society. As the BJP has nothing to project in terms of development ahead of the Karnataka assembly polls and the 2024 Lok Sabha elections, they are trying to create a communal narrative," TMC MP Santanu Sen claimed.

## **Tamil Nadu Girl Sets Record In State School Exams With** 600/600 Score

CHENNAI/DINDIGUL: A class XII student in Tamil Nadu created a record on Monday by emerging topper in the higher secondary examinations while scoring centum in all subjects.

Education Department officials said S Nandhini of Dindigul district achieved the rare feat. The results were declared on Monday by the Directorate of Government Examinations (DGE).

Daughter of a carpenter, Nandhini was studying in a government-aided institution in the district.

The student scored centum in Tamil, English, Economics, Commerce, Accountancy and Computer Application, scoring an overall 600 marks, officials added. Speaking to a Tamil news TV channel, she said she wanted to become an auditor.

According to the results declared by the DGE on Monday, 94.03 per cent of the over 8 lakh students who appeared for the class 12 exams in Tamil Nadu have passed.

The pass percentage of girls was 96.38 while 91.45 per cent of the boys cleared the exams.

A total of 8,03,385 students appeared for the exams, held in March-April, with 7,55,451 of them

Last year, the pass percentage was 93.76 per cent. As many as 4,398 differently-abled candidates appeared for the exams and 3,923 of them passed.

Further, 79 out of 90 prisoners who wrote the exams also passed, DGE said.



## **Avalanche Closes Srinagar-Leh Highway**

WHO on Friday last an-nounced that Covid-19 no longer warranted the status of a global emergency, more than 3 years after it raised the disease to its highest alert level.

We are no longer seeing major surges in infection, severe illness or death. This is because people have developed hybrid immunity from widespread infections and vaccinations.

The virus has settled now. Infections are less severe and hospitalizations are minuscule," he said.

The DAK President said the end of Covid-19 as a global health emergency means that countries no longer need to implement public health measures like masking and social

distancing. deci-"WHO sion makes a symbolic end the pandemic which has had a profound impact on our lives over the last 3 years," he said adding pandemic has affected our health, our economy, our everyday activities and caused

devastation through the loss of so many lives. "We have entered into the endemic stage of Covid-19,"

said Dr Nisar. "It is yet another infection joining many other diseases that humanity has learned to live," he said.

"With the transition from pandemic to endemic stage, Covid is going to stay with us, but will no longer be a disruptor of daily family and community life," he added.

## **G20 Should Keep Eye On J&K Situation: Cong; PDP**

Say Govt Wants To Project 'All Is Well In Kashmir'

SRINAGAR: Opposition Congress and PDP on Monday said the government wanted to falsely project normalcy in Jammu and Kashmir by holding a G20 event while there was an "emergency-like situation" in the Union Territory.

The BJP hit back and asserted that holding of a G20 event proves that Kashmir is now a peaceful destination".

The G20 countries should also internally keep an eye on the situation in Jammu and Kashmir. The democracy has been wiped out here, there is an emergency-like situation created by the BJP," Pradesh Congress Committee (PCC) president Vikar Rasool Wani told reporters at a party function here.

He said the government has destroyed the roads in the city and now is putting up hoardings to impress the G20 delegates.

They are showing the roads to the G20, roads have been destroyed, now only pictures are being put up the G20 should also know about the internal situation in J-K, the lack of democracy, the absence of an (elected) assembly, snatching of the statehood and the division of the state, Wani said.

Wani claimed that he was denied permission to hold public rallies in the Valley but the BIP's of the G20 meeting. like-minded parties are continuously allowed to do so.

"We had applied for permission to hold rallies at Baramulla, Budgam, Kupwara and Kishtwar but permission was not granted. Other parties like Apni party and DPAP are getting permissions continuously," he said.

Wani said it was evident that the government has failed to improve the situation in J and K.

"(Union Home Minister) Amit shah claims to have ended terrorism in Jammu and Kashmir. But there is no decrease in target killings. In one month, we have lost 10 soldiers in Rajouri. The BJP only only uses Kashmir for election campaigns," he alleged.

PDP leader Ghulam Nabi Lone Hanjura said while holding the G20 working group meeting in Kashmir may boost tourism in the valley, the government's main aim was to falsely project normalcy in the Union Territory.

"Holding G20 event is good and it may help to boost tourism here. However, there is no change in the ground situation, particularly after the revocation of Article 370. I think



a message globally that all is well in Kashmir," Hanjura told reporters here.

The PDP general secretary said the situation on the ground was not good as two incidents of militancy-related violence happened in Rajouri and Poonch.

"Firstly, I strongly condemn the incidents. It should not happen because the PDP believes guns are not the solution. Issues can be resolved through talks but unfortunately the BJP government cannot digest this. They are not ready for talks. Even, for instance, if war prevails for 100 years, ultimately the solution is through dialogue," he added.

Hajura said the people in Kashmir were facing problems as authorities have tightened the security measures ahead

On demands surgical strike on Pakistan, he said, "After first surgical strike, the situation is as it was. Gun is not the solution the PDP advocates dialogue only. India and Pakistan should come on table for talks along with stakeholders to find a solution.'

In response to a question on the involvement of locals in the pooch incident, Hanjura said, "That's the duty of security agencies. If anyone is involved, he should be punished."

He, however, questioned as to how the incident took place in such a huge presence of security forces.

"The BJP is answerable for that. They claim that they made the situation better here, stone pelting is not happening, militancy is over." he said.

On the spat between the foreign ministers of India and Pakistan on the sidelines of the SCO meeting, Hanjura said, "They (two countries) should bring down the bitterness and overcome the hatred. I think Bilawal Bhutto Zardari should not have said what he said and the response he got was also

not valid." BJP leader Altaf Thakur reacted sharply to Congress leader Wani's remarks, saying his party was habitual in raising fingers on the democratic set up of the country.

"The Congress is a failed party...they can't see democracy of the country. Vikar Rasool should also understand that he is living in a democratic setup that has freedom of speech. It is because of this democracy he has got this right," Thakur told PTI.

He said holding G20 event in Kashmir proves that the valley is a peaceful destination now where international events can be held.

"G20 event may be a showoff for Congress but for people of J-K and rest of country, this is a big achievement. Twenty countries are coming here which will give boost to economy and tourism of J-K. This will be remembered in history," Thakur added.

National Conference spokesman Imran Nabi Dar said while holding international meetings anywhere in the country was the prerogative of the government, the delegates who are coming to Kashmir too have the responsibility to see the political scenario here.

"No election has been held in J-K since eight years now. Assembly elections, which are due, have been delayed since four years. If we want to convey the message to the delegates that democratic system is being upgraded, why is democracy weakened here (in Kashmir). The government has responsibility that they should understand issues cannot be solved by bureaucratic system for which elected government is required," Dar said.

He also said Jammu should not have been ignored.

"If J-K is promoted through these events, why is one region completely ignored. That shouldn't happen. We are repeatedly saying if they planned this meet here, it should be held in Iammu as well." he added.

## India, Pak SCO meltdown

he Shanghai Cooperation Organisation (SCO) summit in Goa has once again highlighted the deep-seated distrust between India and Pakistan. External Affairs Minister S Jaishankar launched a scathing attack on his Pakistani counterpart Bilawal Bhutto Zardari, calling him a "promoter, justifier, and spokesperson of the terrorist industry." Jaishankar also accused Pakistan of committing acts of terrorism and stated that Pakistan's credibility "is depleting faster than its forex reserves."

The meeting was meant to focus on the SCO agenda, but as happens often at the geopolitical events jointly attended by India and Pakistan, the spotlight soon turns to bilateral issues between the two neighbours. Pakistan, once again, raised the issue of the revocation of Article 370 and the China-Pakistan Economic Corridor. Jaishankar responded by stating that Article 370 is history, and the so-called CPEC violates India's territorial integrity and sovereignty of India. He also called out Pakistan for trying to play the victim card saying it was, in fact, India that was the victim of terrorism emanating from Pakistan. Jaishankar ruled out engagement with Islamabad, pointing out that "victims of terrorism do not sit together with perpetrators of terrorism to discuss terrorism."

The fact that the meeting failed to achieve any breakthrough in ties between the two countries shows that India and Pakistan cannot normalize relations anytime soon. The trust deficit between the two countries remains deep, and there seems to be no political will on either side to bridge the divide. More so in New Delhi which seems to have given up on any near term prospect of engaging Pakistan.

The SCO summit was an opportunity for the two countries to engage in dialogue and explore avenues for cooperation. However, the meeting has only served to highlight the deep-seated distrust. New Delhi made it clear that as long as Pakistan continued to support terrorism, India will remain on guard and will continue to take measures to defend itself.

The path to normalization of relations between India and Pakistan is fraught with challenges. It requires both countries to move beyond their historical baggage, put aside their differences, and engage in constructive dialogue. However, the SCO meeting offered no such hope.

India does desire normal neighbourly relations with Islamabad in an environment free of terror, hostility, and violence. But Pakistan puts Kashmir above everything else. The positions of the two countries have thus become too irreconcilable to start a dialogue. But it is still possible that, in the interest of regional peace, the two neighbours would transcend their differences and talk to each other. This alone will change the situation in the region for the better.


## New king, new challenges

he event marked the culmination of plans that were set in motion last September upon the passing of King Charles' mother, Queen Elizabeth II. During the seven decades of her reign, emerging post-colonial nations grew in self-confidence, and some challenged the idea of the Commonwealth, while at home, the traditional public deference to the monarchy faded, requiring the members of the royal family to reposition themselves as good Samaritans working towards the greater good of British society. King Charles, in his prior avatar as the Prince of Wales, was quick to embrace the successive waves of change, particularly when it came to climate change and the environment. As a passionate supporter of sustainable ecosystems and architecture, he has advocated for organically maintained parks and natural reserves in the U.K. Under the aegis of the Prince's Trust, which operates under a royal charter to help disadvantaged youth in the U.K., more than a million young people had benefited by 2020.

While the new king has made a name for himself in the climate and social welfare spaces, he will have to work hard to tackle rifts within the royal family, potentially deal with an independence movement in Scotland, and face up to the longstanding challenge of Commonwealth nations that no longer wish to have the U.K. monarch as their head of state. Within the Windsor clan, King Charles's younger son Prince Harry has renounced his royal trappings and moved to California with his American wife Meghan Markle, and his recent novel, Spare, does not mince words in spelling out deep-seated resentment that he claims they felt while at the palace. The King will have to either make peace with the new arrangement forced by Prince Harry or build bridges with his second son. In Scotland, Humza Yousaf has now taken the reins of the Scottish National Party after the long tenure of Nicola Sturgeon. While the party has numerous internal issues to resolve, there is a distinct possibility of another independence referendum, which would pose sharp challenges to the U.K.'s economy and society, particularly in a post-Brexit context. King Charles would also have to engage with Commonwealth nations such as Antigua and Barbuda, Australia, the Bahamas, Belize, Grenada, Jamaica and St. Kitts and Nevis — nations that have signalled their intention to appoint their own heads of state. To tackle and effectively deal with these challenges, King Charles III will have to continue to embrace modern values while carrying the mantle of hoary royal traditions.

# Advocacy for Digital RTI Regime in J&K

an you believe that a simple application filed under the Right to Information Act (RTI) will act as a strong tool to sensitize not only the local government but also even the Govt of India? Since long, the Jammu & Kashmir RTI Movement has been doing advocacy for having an online RTI facility available in Jammu & Kashmir. Many articles were written and videos were made to mobilise the advocacy around the issue. All this work did sensitize the Govt to some extent but no positive results were seen.

One of our committed activists namely Syed Adil from Ganderbal used RTI application as a tool to do advocacy on ensuring RTI goes digital in J&K. Adil sought information about all this from the Govt of India around January end this year. He filed an application before the Central Public Information Officer (CPIO) in the Ministry of Electronics and

Information Technology (MeITY).

The Ministry forwarded the application under section 6 (3) to Department of Personnel and Trainings (DoPT) Govt of India which works under the Prime Ministers Office (PMO). The DoPT further forwarded Adil's application to J&K Govt (General Administration Department-GAD) and the Govt had no option but to say in writing that online RTI will be a reality in J&K very soon.

#### Advocacy on RTI via RTI

It is official now: The Jammu & Kashmir Govt is mulling to provide the facility for online RTI application filing along with filing of the first appeals soon. This was revealed by the General Administration Department (GAD) in a reply provided to Syed Adil, a committed RTI activist and IT professional.

When Govt of J&K was not acting on the ground vis a vis providing online RTI facility for citizens of J&K in spite of assurances from Govt that all offline services would go online from January 15th 2023, Adil decided to seek information on this issue from Govt of India around January end this year. The applicant sought information related to the online RTI facility from the Ministry of Electronics and Information Technology (MeITY) Govt of India. The application filed in the Ministry reads:

'Whether the Central Government or Jammu & Kashmir Administration proposes to set up Online service of RTI Application in Jammu & Kashmir UT if so, the details thereof. If not, the time by which such facilities are likely to be set up or easily available in the said UT – Jammu & Kashmir as LT LG J&K claimed all offline services have been shut down after 15th January 2023? Whether the Central Government or Jammu & Kashmir Administration has also launched 'RTI Application Services' on 15th January 2023 if so, the details thereof"

As explained above, the Ministry forwarded the RTI application to the Department of Personnel & Trainings (DoPT) Govt of India who further forwarded it to the General Administration Department (GAD) of J&K Govt.


The GAD vide its RTI reply dated 2.05.2023 told RTI applicant Syed Adil that online RTI filing and first appeal was under active consideration of the Govt.

The response provided by Mohit Raina -Under Secretary who is

around 3 months to do the advocacy but this advocacy on RTI using RTI application as a tool worked actually.

The RTI applicants continue to seek information under Right to Information Act 2005 (RTI Act) through an offline mode with obsolete methods. The applicants write down an RTI application, take its printout, then go and purchase the Indian Postal Order (IPO) of Rs 10 which isn't available in local post offices.

For getting this postal order,



Officer (PIO) in General Administration Department- GAD Civil Secretariat Srinagar reads:

"It is informed that the matter with regard to registration of Union Territory of Jammu & Kashmir with Online RTI portal of Department of Personnel and Trainings (DoPT) GoI, for facilitating the general public to file online RTI applications and first appeals is under active consideration in the GAD in consultation with Govt of India. As soon as the modalities are finalized, the same shall be shared in public domain through designated website www. gad.jk.nic.in"

#### Online RTI in J&K

In December last year, the J&K Chief Secretary Dr A K Mehta had impressed upon all the Govt offices to make all the offline services online. As per the Govt statement issued on December16th 2022, the Chief Secretary while reviewing the performance of the Information Technology (IT) Department in a meeting, directed the officers to prepare a list of all the services provided by the Govt departments. The Chief Secretary directed the officers to through offline mode and prepare a roadmap for offering the same through an online platform with end-to-end digitisation by January 15th 2023. The Chief Secretary during the meeting asked the officers of the IT department to issue advisories to different Govt departments for conducting security audits of their official websites as well without any delay. By January 15th 2023, all the offline services had to be made online but this didn't happen at all.

Adil filed an RTI application to get information on this after the Jan 15th deadline was over. It took GPO Srinagar or some bigger post office located in district headquarters. After this, the applicants are in search of a post office to send the application and it takes weeks for the RTI application to reach a Govt office.

On the contrary, this is not the case with central Govt offices. One can file an RTI application on a cell phone and pay application fees online. If J&K is being directly ruled by the centre for the last many years, why are not the same facilities given to people of J&K?

#### Conclusion

If the J&K Chief Secretary has given clear directions to make all the offline services online by Jan 15th 2023, what is preventing Govt officers from adhering to his orders? More than 2 years back, the then Secretary Information Technology J&K Govt Mr Amit Sharma told me that filing of online RTI applications will be a reality within a few weeks. Mr Sharma said this publicly in a TV debate but again nothing happened. A lot of funds are provided for e-governance in J&K. More than 5 lakh files were digitized in civil secretariat J&K, but when it comes to giving online RTI facil ity to citizens of J&K, Govt officers are reluctant to do it. Now as the Govt has said in writing that online RTI application filing plus filing of first appeal is under active consideration of Govt, people hope that by May end this would be a reality.

## **Self-Styled Seminaries**

hat if I tell you that Kashmir is turning into a paradise for religious business? You will be shocked to hear that many self-styled clerics have made darsgah (religious seminary) the centre of business.

Earlier, there were only a few Darasghahs in the valley which were well managed by the authorities and the facilities provided to the children were good enough especially for the students.

Every day we see a huge number of vehicles with loudspeaker asking for donations in city streets and villages too, have we ever wondered why people from one district go to another district to collect donations?

Because new small seminaries are being built by self-made clerics to earn their livelihood as it costs no money to run your own seminary.

Children are being treated like animals in such seminaries. I once saw that children were washing their clothes with cold water on bank of a stream in the bitter cold in Bandipora district of North Kashmir. When I spoke to them, one of them said that they use the same cold water daily for bathing and wudu(ablution) etc as their Darasghah lacks proper infrastructure. The seminary they were staying in was poorly built and one of the student was standing on the road side with a receipt book from the same Madrasa to collect donations

from commuters.

Who forced them to study there when we have so many good Madarasas in the valley as well as in Bandipora district?

Every child has the right to live happily, self styled religious clerics treat students in such Madrasas like animals.

Recently, a case where teachers was booked for beating a minor student was reported. Thus, times have changed; corporal punishment is banned in schools, daycare and alternative child care institutions, but alas! no one dares to talk about the hardships faced by minors un these seminaries.

Such Darasghah lack proper registration and get no funds from

any Madrasa organizations. Self styled clerics force student to collect donations.

tion clearly states that, "No child below the age of fourteen years shall be employed to work in any factory or mine or employed in any hazardous employment."

# In Praise of Silence



A lot of wise people have broken their silence in praise of silence. In the words of Will Rogers, "Never miss a good chance to shut up." # Unrealistic Beauty Standards for 'Beautiful' Kashmiri Women?

YPICALLY, Kashmiri women are perreived to have a fair white com ■ ion and bright red cheeks, the perfect example of standard beauty. But what we mostly don't realize is that Kashmir is situated in the South-Asian geographical belt, which implies that naturally, people have an inherent tendency to have more melanin, which is the main component in brown skin. Here in Kashmir, if you are slightly brown skinned, you will be constantly asked if you're Kashmiri or not, because god forbid a Kashmiri woman be brown skinned. Kashmiris use the word 'gyeshoum' meaning 'brown skinned', as a slur to describe someone as undesirable.

Kashmiris fret brown skin so much that it is impossible to find skin products as a brown skinned person here, for example- while buying a concealer, even at one of the best supermarkets in Kashmir, the only option you have is white — as if brown skin does not exist. Moreover, the salespersons have the audacity to tell you that brown products will make you look wheatish and ask you to opt for white products to conceal your skin colour.

"Don't be out in the sun for too long", "Don't play outdoor sports too often, you will catch a tan", "Don't eat too much of your favorite dessert, you could gain some pounds", are some statements that most of us often get to hear, in some instances on a daily basis. From a very young age, women are exposed to a variety of unrealistic beauty standards imposed upon them by society. Throughout history, women have felt the pressure to measure up to these standards which are lauded and labeled as beautiful.

In the early years of our childhood, we mostly looked at an ice cream as a source of utmost delight and happiness but as we grow older, we only come to think of it as a source of few calories that could make us look fat. This constant worry of gaining a few pounds eventually eradicates every such sense of joy which we earlier related to food that made us happy.

Although it is significantly important to have a healthy lifestyle, it is important for us to understand that a flat stomach is not an indication of good health and that body toning is simply an aesthetic practice.

In innumerable instances, the idea of a



toned body emphasizes more on appearance rather than health and physical well-being. In Kashmiri society, it is inherently impossible to live in peace in your body. People are constantly fat shamed and if not, then shamed for being too skinny or dark-skinned. The list just goes on.

In 21st century, with easily accessible social media platforms these unrealistic 'ideal' body types have consumed more and more of young women's minds. Social media has also provided a stage for ceaseless body shaming and criticizing people for their appearance has become an overlooked evil for society.

Body shaming is a phenomenon that almost everyone has to face, in many instances from their family and friends. "You are too heavy for a young girl", "You are too skinny, men should be more muscular", "You are so skinny you could get carried away by the wind", "Young women shouldn't be so fat, stop eating that!", are some of the very common phrases we hear daily, even from people who are close to us.

We mostly tend to confuse self-hate with self-care pertaining to the ideals set by the society, which require us to shun every other practice of self-care except the ones that make us look more attractive. This materialistic idea of self-care is a silent mental assault- seeing oneself as just as an entity that needs to be constantly spruced up becomes a significant predictor of substandard mental health. These unrealistic body standards create an extreme sense of pressure among teenage girls to achieve a 'perfect' body, the idea of which is perpetuated through impractical photos of women portrayed in the media. Underweight and photoshopped- models or 'ideals of beauty' are everywhere, acting as examples of what young girls should aspire to look like.

While growing up young girls often find themselves in an amalgam of various standards they feel they need to measure up to in order to look 'prettier' and 'perfect'- small waist, clear skin, silky hairthe quintessential perfect woman. But it is clearly evident that these standards are

very utopian, unrealistic and unachievable- having clear skin is a myth, real skin is textured has pimples, scars, pigmentation and facial hair- contrary to the made up and photo-shopped looks of otherwise 'beauty' and 'fashion' icons. Not just body type and weight, young girls face criticism for the color of their skin too- colourism exists in almost every sphere of the society, there is a rigid sense of perception that correlates lighter skin tone with beauty and femininity – even in the 21st century. Colourism is widely prevalent in Indian society, where fairer skinned women are considered to be beautiful and brown skinned women mostly have to hear unsolicited advice on skin whitening procedures. It is humorously ironic that in a country colonized and tortured upon by white people, the standard of beauty is white skin, while most of its population is brown skinned.

Western beauty ideals, including fair skin, dominate the world, while it is clearly factual that people belonging to different races have different skin and hair. Colourism is so deeply imprinted on people's minds that they knowingly or unknowingly pass it on to the next generation.

For instance, cartoon and animation is the very first interaction a child has with media, and media has unrequited power to deeply influence a human's mind, it is mostly observed that animations feature 'fairies' and 'princesses' as fair skinned and 'villains' as dark skinned. This representation makes a child recognize white skin to beauty and positivity and dark skin to ugliness and negativity. Although in the contemporary time, media has adopted a more liberal approach which gives representation to skin of all colours, but the ratio of non-white skin depiction is fairly unequal. This sense of relating white skin to 'beauty' and 'superiority' roots back to the colonial era where white people had an unspoken privilege over people of colour, the phenomenon has a very dark history that we are all aware of. Yet for Indian society, white skin is somehow essential, as if the effects of colonization are still prevailing.

Having a normalized yet unrealistic societal standard drilled into your mind as soon as you start to grow, can have serious mental and physical consequences, which

is quite prevalent in young girls. Social media, magazines, and the entertainment industry keep introducing high and unachievable standards, making people think that they need to look a certain way for society or the masses to perceive them as beautiful or desirable. Even if they try to achieve these, there is always criticism behind everything.

Women can wear makeup but not too much, they should look 'natural', should be slim but not too slim, almost everything a woman does, criticism is instantly derived.

While makeup is very popular among young girls, it has unhealthy implications too- more often, they feel the need to wear makeup to hide their 'flaws' which are inherently normal but not acceptable by the society, it becomes more of a mask for them behind which they hide their insecure self- they never get to admire who they really are. Having to mask up almost every day, to hide their real skin makes them think low of themselves, as if there is something wrong with who they really are and end up with extremely low selfesteem, low confidence and often body dysmorphia. Young girls mostly end up hating their normal features like scars, discolouration, body shape and push them to the edge of mental crises.

Why are these images slammed and forced upon women? The society leaves no stone unturned to burden women with stereotypes and expectations, which mostly put women under constant pressure. Human civilization should have been past these ignorant notions of treating another human differently owing to how the person looks, way long ago.

These standards are not just mere standards but chains imprisoning women from being able to express themselves freely, to be comfortable in their own skin, these standards strip women off the very basic right of existing unfiltered. Women and young girls need to realize that there is no harm in not accepting these standards, they don't stand for beauty or grace but are yet another societal norm made up to hold back and put women down.

## **Sons Of Women With PCOS 3 Times More Likely To Develop Obesity**

ons of women with polycystic syndrome (PCOS) are three times more likely to develop obesity, a new study has shown.

The study from Karolinska Institutet, Sweden, said that it highlighted a previously unknown risk of passing PCOS-related health problems across generations through the male side of a family.

The study is published in the journal Cell Reports Medicine.

Using registry data and mouse models, the researchers determined if and how PCOS-like traits are passed from mothers to their sons.

Just over 460,000 sons born in Sweden between July 2006 and December 2015 were included in the registry study. Of these, roughly 9,000 were sons of women with PCOS.

The researchers then identified which of the children were obese.

'We discovered that sons of women with PCOS have a threefold risk of



obesity and of having high levels of "bad" cholesterol, which increases the risk of developing insulin resistance and type 2 diabetes later in life," said lead researcher Elisabet Stener-Victorin, professor at the Department of Physiology and Pharmacology, Karolinska Institutet.

Studies in mice confirmed these findings, where the researchers examined male offspring of female mice that before and during pregnancy were fed either a standard diet or a diet rich in fat and sugar, and were exposed to high levels of the male sex hormone dihydrotestosterone during pregnancy to mimic the pregnancy of normal weight individuals and

obese women with PCOS.

The male mice were then fed a standard diet until adulthood when their fat distribution and metabolism were examined.

'We could see that these male mice had more fat tissue, larger fat cells, and a disordered basal metabolism, despite eating a healthy diet," said Stener-Victorin.

To investigate the re-

the offspring and whether characterphysiological istics could be passed on from generation to generation, the first-generation male mice were mated with healthy female mice that were not exposed to male sex hormones or a diet rich in fat and sugar.

The whole process was repeated in the second generation to reach the third generation which is the first generation not to be affected by the mother condition.

experiments showed, the researchers said, that obesity and high levels of male hormones in the woman during pregnancy can cause long-term health problems in the male offspring because their fat tissue function, metabolism, and reproductive function deteriorate, which in turn affects future generations.

"These findings may help us in the future to find ways to identify, treat and prevent reproductive and metabolic diseases at an early stage," said Stener-

## New Android Malware **Discovered That Steals** Your Passwords, 2FA Codes

new Android malware known as 'FluHorse' has been discovered, which targets users in Eastern Asia with malicious apps that look like legitimate versions with over 1,00,000 installs.

According to Check Point Research, these malicious apps are designed to extract sensitive information, including user credentials and Two-Factor Authentication (2FA) codes.

FluHorse malware targets multiple sectors in Eastern Asia and is typically distributed via email.

In some cases, high-profile entities such as government officials were targeted at the initial stages of the phishing email attack.

One of the most concerning aspects of FluHorse is its ability to go undetected for long periods of time, making it a persistent and dangerous threat that is difficult to detect.

According to the report, Flu-Horse attacks start with targeted and malicious emails sent to high-profile individuals, urging them to take immediate action to resolve an alleged payment issue.

Usually, the target is directed to a phishing website through a hyperlink included in the email. Once there, they are prompted to download the phonev APK (Android package file) of the fake application.

The FluHorse carrier apps mimic 'ETC,' a Taiwanese toll collection app, and 'VPBank Neo,' a Vietnamese banking app.

On Google Play, both legitimate versions of these apps have over a million downloads.

Moreover, the report said that upon installation, all three fake



apps request SMS access in order to intercept incoming 2FA codes in case they are required to hijack the accounts.

The fake apps mimic the original user interfaces but lack functionality beyond two to three windows that load forms that capture the victim's information.

Following the capture of the victims' account credentials and credit card information, the apps display a "system is busy" message for 10 minutes to make the process appear realistic while the operators act in the background to intercept 2FA codes and leverage the stolen data.

## Can Right Music Prevent Virtual Reality Headaches? Find Out

istening to music might help reduce the dizziness, nausea, and headaches that virtual reality users may suffer after using digital gadgets, as per a study.

Cybersickness -- a type of motion sickness from virtual reality experiences such as computer games -- significantly reduces when joyful music is part of the immersive experience, the study found. The intensity of the nausea-related symptoms of cybersickness was also found to substantially decrease with both joyful and calming music.

Researchers from the University of Edinburgh assessed the effects of music in a virtual reality environment among 39 people aged between 22 and 36. They conducted a series of tests to assess the effect cybersickness had on a participant's memory skills reading speed and reaction times.

Participants were immersed in a virtual environment, where they experienced three roller coaster rides aimed at inducing cybersickness. Two of the three rides were accompanied by electronic music with no lyrics by artists or from music streams that people might listen to which had been selected as being calming or joyful in a previous study. One ride was com-

pleted in silence and the order of the rides was randomised across participants.

After each ride, participants rated their cybersickness symptoms and performed some memory and reaction time tests. Eye-track-



ing tests were also conducted to measure their reading speed and pupil size. For comparison purposes the participants had completed the same tests before the rides.

The study found that joyful music significantly decreased the overall cybersickness intensity. Joyful and calming music substantially decreased the intensity of nausea-related symptoms. Cybersickness among the participants was associated with a temporary reduction in verbal working memory test scores, and a decrease in pupil size. It also significantly slowed reaction times and reading speed. The researchers also found higher levels of gaming experience

were associated with lower cybersickness. There was no difference in the intensity of the cybersickness between female and male participants with comparable gaming experiences.

Researchers say the findings show the potential of music in lessening cybersickness, understanding how gaming sickness levels, and the significant effects of cybersickness on thinking skills, reaction times, reading ability and pupil size, Dr Sarah E MacPherson, of the University of Edinburgh's School of Philosophy, Psychology & Language Sciences, said: "Our study suggests calming

or joyful music as a solution for cybersickness in immersive virtual reality. Virtual reality has been used in educational and clinical settings but the experience of cybersickness can temporarily impair someone's thinking skills as well as slowing down their reaction times. The development of music as an intervention could encourage virtual reality to be used more extensively within educational and clinical settings.'

## Russia Says It Has **Billions Of Indian Rupees** That It Can't Use

MOSCOW: Russia has accumulated billions of rupees in Indian banks which it can't use, Foreign Minister Sergei Lavrov said Friday, pointing to a ballooning trade surplus with the South Asian nation.

This is a problem," Lavrov told reporters in Goa on the sidelines of the Shanghai Cooperation Organization meeting. "We need to use this money. But for this, these rupees must be transferred in another currency, and this is being discussed

India's total exports to Russia shrunk 11.6% to \$2.8 billion in the first 11 months of the 2022-23 financial year, while imports rose nearly fivefold to \$41.56 billion, according to data from the Ministry of Commerce and Industry. That surge came as refiners have scooped up discounted Russian oil in the past year that's been shunned by the West in response to President Vladimir Putin's invasion of Ukraine.

Imports of Russian crude by India reached a record 1.68 million barrels a day in April, up sixfold on a year earlier, according to Vortexa Ltd, a data intelligence firm.

The Kremlin initially encouraged India to trade in national

on Russian banks and a ban on transactions using the SWIFT messaging system.

But volatility in the ruble soon after the war began meant plans for a rupee-ruble mechanism for oil imports were abandoned. India has resisted pressure from the US to scale back relations with Moscow since the invasion of Ukraine.

'Frozen Funds'

The imbalance in trade for Russia means "the volume of 'frozen funds' can reach tens of billions of dollars," said Alexander Knobel, director of the Institute of International Economics and Finance of the Ministry of Economic Development. "The situation is aggravated by India's historically high aggregate trade deficit, which reduces the possibilities of clearing settlements with third countries."

Russia is India's largest supplier of weapons and military hardware, though defense supplies to the South Asian nation have stalled for lack of a payment mechanism that doesn't violate US sanctions.

Indian payments for weapons amounting to more than \$2 billion have been stuck for about a year as New Delhi has been unable to settle the bill in dollars because of concerns about falling foul of secondary sanctions, while Russia is reluctant to accurrencies following sanctions cept rupees for purchases.

Governor Shaktikanta Das. The secretary also said there was a view that the government should expedite the required legislative changes to give effect to the proposals announced in the Union Budget.

On the unclaimed deposits matter, Seth said the FSDC was be undertaken to ensure people get their unclaimed denosits by ing with financial institutions.

About Rs 35,000 crore unclaimed deposits as of February 2023 were transferred to the Reserve Bank by public sector banks (PSBs) in respect of deposits, which have not been operated for 10 years or more.

These unclaimed deposits belong to 10.24 crore accounts transferred to the RBI as of the end of February 2023.

Last month, the Reserve Bank Governor said that a centralised portal would be ready in three to four months wherein depositors and beneficiaries can access details of unclaimed deposits across various banks.

# Stop Sale Of Tickets Immediately, DGCA **Tells Go First**

**NEW DELHI/MUMBAI-** Skies are getting more cloudy for the cash-starved Go First with aviation regulator DGCA on Monday directing the airline to immediately stop ticket sales, lessors seeking deregistration of another 13 planes and the NCLT yet to give its ruling on the voluntary insolvency resolution proceedings plea.

On Monday, Go First requested the National Company Law Tribunal (NCLT) for an early decision on its plea for voluntary insolvency resolution proceedings before the two-member bench headed by tribunal President Ramalingam Sudhakar.

Another bench which heard the petition of an operational creditor SS Associates Services Pvt Ltd seeking insolvency proceedings against the carrier said the matter needs to be listed before the bench headed by the president.

As uncertainties rise over the future of the no-frills airline, the Directorate General of Civil Aviation (DGCA) has directed

the carrier to immediately stop bookings and sale of tickets till further orders.

The regulator has also issued a show cause notice to the budget carrier under the relevant provisions of the Aircraft Rules, 1937, for its failure to continue the operation of the service in a safe, efficient and reliable manner, the source said.

In a setback to the ailing airline, lessors have so far sought the deregistration of 36 planes of Go First.

As many as 28 planes or more than half of the airline's fleet are grounded due to non-supply of engines by Pratt & Whitney (P&W), the airline's chief Kaushik Khona said on May 2.

Earlier, Go First suspended ticket sales till May 15 and cancelled flights till May 12. The cash-strapped carrier has not flown since May 3, a day after filing for voluntary insolvency resolution proceedings before

The source said the DGCA has asked the airline to submit its reply within 15 days of the receipt of the show cause notice, and further, a decision on the continuation of its Air Operators Certificate (AOC) will be taken on the basis of the reply submitted by it.

With liabilities worth Rs 11,463 crore and a financial crunch, the airline has sought voluntary insolvency resolution proceedings as well as an interim moratorium on its financial obligations.

The lessors of the carrier have opposed Go First's plea for an interim moratorium contending that it would have "harmful and serious consequences"

The carrier has total liabilities of Rs 11,463 crore to all creditors, including a default of Rs 3,856 crore towards operational creditors. The dues towards aircraft lessors are Rs 2,600 crore.

Meanwhile, the NCLT on Monday issued a notice to SpiceJet on a petition filed by an aircraft lessor, seeking initiation of insolvency resolution proceedings against the budget carrier and the next hearing is scheduled for May 17.

The petition was filed by Aircastle (Ireland) Ltd.

## **Govt Bans Apple Imports If Its Price Is Less**

**NEW DELHI:** The government on Monday banned the import of apples if its imported price is less than Rs 50 per Kg.

The directorate general of foreign trade (DGFT) said in a notification that the imports are free if the price is above Rs 50 per kg.

'Import of apples...is prohibited wherever the CIF (cost, insurance, freight) import price is less than equal to Rs 50 per Kg,' DGFT said in the notification.

The minimum import price condition shall not be applicable for imports from Bhutan,

In 2023, India imported apples worth USD 296 million against USD 385.1 million in 2022.

The main countries which export apples to India include the US, Iran, Brazil, UAE, Afghanistan, France, Belgium, Chile, Italy, Turkey, New Zealand, South Africa and Poland Imports from South Africa rose 84.8 per cent to USD 18.53 million during April-February 2022-23.

Similarly from Poland, the inbound shipments of apple increased by 83.36 per cent to USD 15.39 million. However, imports declined from countries like the US, UAE, France and Afghanistan.

**NEW DELHI:** The Reserve Bank's gold reserves increased by 34.22 tonne yearon-year to reach 794.64 tonne at Marchend 2023, showed central bank data on Monday.

The Reserve Bank held 760.42 metric tonnes of gold (including gold deposits of 11.08 metric tonnes) at the Marchend of 2022.

"As at end-March 2023, the Reserve Bank held 794.64 metric tonne of gold (including gold deposits of 56.32 metric tonne)," the central bank said in its Half Yearly Report on Management of Foreign Exchange Reserves: October 2022 -March 2023. While 437.22 tonne of gold is held overseas in safe custody with the Bank of England and the Bank of International Settlements (BIS), 301.10 tonne

of gold is held domestically. In value terms (USD), the share of gold in the total foreign exchange reserves increased from about 7.06% as of September-end 2022 to about 7.81% as of Marchend 2023, the report said. During the half-year period, reserves increased from \$532.66 billion as of September-end 2022

to \$578.45 billion as of March-end 2023. Forex reserves comprise foreign currency assets, gold, special drawing rights



and reserve tranche position in the International Monetary Fund.

Although both the US dollar and Euro are intervention currencies and the Foreign Currency Assets (FCA) are maintained in major currencies, the foreign exchange reserves are denominated and expressed in US dollar terms.

Movements in the FCA occur mainly on account of the purchase and sale of foreign exchange by the RBI, income arising out of the deployment of foreign exchange reserves, external aid receipts of the central government and changes on account of revaluation of the assets.

As of March-end 2023, out of the total FCA of \$509.69 billion, \$411.65 billion was invested in securities, \$75.51 billion was deposited with other central banks and the Bank of International Settlements (BIS), and the balance of \$22.52 billion comprised deposits with commercial banks overseas.

# Panama Papers: ED Seizes Over Rs 41-Cr Valued Prime Real Estate Of Zavareh Poonawalla

New Delhi: The Enforcement Directorate on Monday seized three properties at a prime location in Mumbai, valued more than Rs 41 crore, as part of a foreign exchange violation probe against Zavareh Soli Poonawalla whose name figured in the Panama Papers.

Zavareh Poonawalla is the brother of Cyrus S Poonawalla, the founder and CMD of vaccine major-- Serum Institute of India (SII). The company and its promoters are not linked to this

In a statement, the federal probe agency said Zavareh Poonawalla and his family member are accused of "remitting foreign exchange abroad by mis-utilising the provisions of the LRS (Liberalised Remittance Scheme)".

The Enforcement Directorate

(ED) seized three immovable assets located at the Ceejay House in Mumbai's Worli area to the extent of Rs 41.64 crore under the provisions of the Foreign Exchange Management Act (FEMA), the statement said.

Zavareh Poonawalla and his family "used the maximum permissible limit (as available under the LRS) and from the year 2011-12, they remitted money abroad via mis-declarations under the pretext of 'family maintenance and self-maintenance' etc", the agency said.

"However, none of their family members was residing abroad

or holding NRI status," it alleged. The entire funds remitted by (Zavareh) Poonawalla, whose name was found in the Panama Papers revelations regarding offshore entities, and his family members under LRS were invested into British Virgin Islands-based Stallast Limited,

Dubbed the 'Panama Papers', an investigation of a stockpile of records from Panamanian legal firm Mossack Fonseca by Washington-based International Consortium of Investigative Journalists (ICIJ) in 2016 had named several world leaders and celebrities who allegedly stashed away money abroad in offshore companies.

Investigators have said not all people whose name figured in this list were offenders.

The ED found that funds remitted by Zavareh Poonawalla and his family members were utilised by Stallast Limited to "purchase" four apartments in the Paddington area of central London. Multiple FEMA contraventions were seen in these transactions, it alleged.

The ED said besides "misdeclarations" in remittances, Zavareh Poonawalla and his

family members also "wrongly" claimed these investments as foreign portfolio investments. In reality, the foreign entity was completely controlled by them and thus, they did overseas direct investment in a foreign wholly owned subsidiary without due permission of the Reserve Bank of India (RBI), the agency said.

The foreign assets were not declared to the RBI, and they continued to hold the foreign assets and are in continuous enjoyment of the same, it alleged.

"The properties abroad were

acquired through the funds remitted under LRS to avoid reporting requirements to RBI and thus, (Zavareh) Poonawalla mis-utilised the LRS," the ED said. "Therefore, the equivalent value of properties held by them in India have been seized under the provisions of Section 37A of the FEMA," it said.

# DC Pulwama Reviews Mineral Mining Scenario In DLTFC Meeting

Says Adherence To Scientific Management Of Mining Is Imperative

Pulwama: Deputy Commissioner (DC) Pulwama, Dr. Basharat Qayoom today chaired a meeting of the Multi Departmental District Level Task Force Committee for Geology and Mining to discuss and review the status of mineral mining in the district.

Initially Additional Deputy Commissioners, Pulwama, Tral and Awantipora apprised the chair and participants about the latest status of the mineral- mining scenario in the district and gave some suggestions for complete ban on instances of illegal mining.

Giving details, DMO informed that a total of 10 mineral blocks have been e-auctioned, 04 are operational and rest are awaiting environmental clearance from JKEIAA.

The DC while speaking on the occasion, asked for mapping of mineral mining areas keeping in view the impact assessment. He also called for the need to streamline the extraction of minerals in the district.

He added that scientific mechanisms in place should be adhered to deal with the issue of mining. Outlining the importance of the District level Committee constituted for the purpose, he impressed upon the concerned to prescribe SOPs and take all the necessary steps needed for enforcement of the same. He emphasized submitting reports about illegal mining on a weekly basis and stern action against those involved in illegal mining in the district.

The DC asked the members of the District level Task Force Committee to work in close coordination and liaison in the best interest of checking illegal mining in the district to control this menace of illegal mining from the district forever.

He further directed the DMO to make a detailed plan highlighting the role of Police, Revenue, Forest, Irrigation and Flood Control departments so as to check illegal mining, transportation and dumping of minerals in the district.

DC also passed directions to police to extend all possible support needed to the checking squads of the district for ensuring a blanket ban on the instances of illegal mining.

DMO was also directed to establish Nakas/check points at the sensitive points to keep a strict and close vigil on illegal transportation and storage of minerals.

The meeting was attended by Additional Deputy Commissioners of Pulwama, Tral and Awantipora, ASP Pulwama, ACR, DFO and DMO, representatives from Irrigation, Flood Control and other concerned officers.

An official from the wildlife department told Kashmir Observer that the department was planning for a long time to get photographic evidence of the bird and they did it finally with the help of Jainy Maria.

According to a study conducted by a group of scientists and wildlife experts, there is an urgent need to plan long-term monitoring and initiate appropriate measures to conserve the species.

The study titled as "Distribution and Conservation Status of the Western Tragopan Tragopan melanocephalus in Jammu and Kashmir. India" reveals that the major reasons for its global decline are habitat degradation is livestock grazing, fuel wood collection, disturbance by grazers and mushroom collectors, hunting and trapping for meat.

The study further noted that in J&K, historically, western tragopan has been reported from Rampur, Uri, Keran and Lolab areas, and also the southern slopes of the Pir Panjal Range.

Records of western tragopan have also been obtained from Kishtwar (part of which is now the Kishtwar National Park (NP), Padder and Bhaderwah, which fall in the Chenab Valley of the UT.

The study also noted that J&K is one of the strongholds for the species.

"The modelling of habitat also showed that there is a reasonably good po-tential tragopan habitat in the state, although its presence needs to be confirmed through field surveys,"

Jay Shah, the current ACC president and secretary of BCCI, has also assured broadcasters that losses suffered due to absence of Pakistan in Asia Cup 2023 will be compensated during a series involving India in

BCCI has been asked by the Centre to adopt a strict stance on the matter during the next ACC meeting. The governing body of cricket in India is also unlikely to accept the hybrid model proposed by Pakistan Cricket Board (PCB) for the Asia Cup, under which India would have played its matches at a neutral venue.

Earlier, Najam Sethi, the chairperson of the PCB Management Committee, called for a rational approach to solve the crisis looming over the country's hosting of the Asia Cup and its participation in the ICC Cricket World Cup later this year, which will be held in India. Talking to the media at the occasion of the National Assembly Standing Committee on Inter-Provincial Coordination (IPC) meeting, Sethi said that Pakistan's chances to travel to India for 50-over World Cup are low. ## **AC Milan Faces City Rival Inter Milan In Champions League Semifinal**

MILAN: The Milan teams are back. AC Milan faces city rival Inter Milan in the semifinals of the Champions League, but only one will get the opportunity to reach the Champions League final and compete for European soccer's top

The victor will face either Real Madrid or Manchester City in the final.

Three-time European champion Inter was the last Italian club to lift the José Mourinho in 2010.

Milan won the last of its seven titles in 2007.

"To be part of a club like this is a dream," Milan defender Fikayo Tomori said in an interview with The Associated Press. "To go and play in the San Siro, seeing it on the Champions League nights ... it's such an iconic stadium, such an

"The fact that two Italian teams are in the semifinals ... it's obviously good for



the league, good for Italian football. We're obviously focusing on us. We want to be the best.'

Milan hosts Inter on Wednesday before the return leg the following Tuesday. Both games will be at the San Siro as the teams share the stadium.

"We got two really exciting games coming up," Tomori said. "Two games that we can really show ourselves, prove ourselves and you know, we can hope-

Since the Milan teams' last triumphs in Europe, there have been slumps on the field and turmoil off it, with both clubs changing ownership several times and coaches even more frequently.

However, after years of mediocrity, Inter and Milan ended lengthy waits for a Serie A title before finally making it back to the top level of European soccer.

**COACHING CHANGES** 

Inter has had 14 different coaches since Mourinho left the Nerazzurri after winning the Champions League - an average of more than one a year.

Rafael Benítez replaced Mourinho but he lasted a matter of months before being fired. The rest of the list includes Claudio Ranieri, Roberto Mancini and Antonio Conte. Current Real Madrid coach Carlo Ancelotti steered Milan to the Champion League trophy in 2007 – and also in 2003 – but he quit just two years later.

Since then there have been 10 different coaches in the Rossoneri hot seat. The incumbent Stefano Pioli was also in charge of Inter in the 2016-17 season.

Inter is now coached by Simone Inzaghi, who has emerged as somewhat of a cup specialist. He steered both previous clubs Lazio and Inter to the Italian Cup trophy and the Nerazzurri are back in the final of this year's competition.

Inzaghi also led Inter to back-to-back Italian Super Cup titles to match the two he won with Lazio.

## Man City's Haaland Takes On Real **Madrid's Attacking Trio In CL Semis**

MADRID: Two of the best attacking teams in Europe face off in the Champions League semifinals this week, with Manchester City's record-seeking Erling Haaland going against Real Madrid's red-hot trio of Vinícius Júnior, Rodrygo and Karim Benzema. It will be a rematch of

last year's semifinal, when Madrid got the better of a City team that didn't have Haaland in the squad. City fell short of European success yet again, while Madrid went on to win a record-extending 14th title. The addition of Haaland could be the differencemaker for Pep Guardiola's

team this time. The 22-yearold Norwegian scored 12 of City's 26 goals in the Champions League this season. He is five short of Cristiano Ronaldo's single-season record of 17 goals for Madrid in 2013-14. Haaland added a new

## Mystery China Spacecraft Returns To Earth After 276 Days

**BEIJING:** An experimental Chinese spacecraft returned to Earth on Monday after staying in orbit for 276 days, China's state media reported, completing a landmark mission to test the country's reusable space technologies.

The uncrewed spacecraft returned to the Jiuquan launch center in northwest China on Monday as scheduled, according to state media. No details were given on what the spacecraft was, what technologies were tested, how high it flew, and where its orbits had taken it since its launch in early August 2022. Images of the craft have also yet to be released to the public.

The test marks an "important" breakthrough in China's research into reusable spacecraft technology that will provide a more con-

venient and inexpensive way to mount future space missions, state media reported.

In 2021, what may have been a similar spacecraft flew to the edge of space and returned to Earth on the same day in a mission that was also kept largely under wraps. It landed on Earth "horizontally," according to China's main space contractor at the time.

Commentators on Chinese social media have speculated that Beijing has been developing a spacecraft like the US Air Force's X-37B, an autonomous spaceplane that can remain in orbit for years.

The uncrewed and reusable X-37B returned to Earth in November last year in its sixth and latest mission, after more than 900 days



## Farmers Break Through Barricades to Join Wrestlers' Protest

New Delhi: Several farmers broke through police barricades on Monday to join the wrestlers' protest against Wrestling Federation of India chief Brij Bhushan Sharan Singh here even as Delhi Police denied any untoward incident at the site. Purported videos showed farmers climbing the barricades and even dragging and pushing some of them away in a bid to enter the protest venue.

Hours later, the police barricades, which were damaged during the hustle, were welded together and placed at the site as part of a precautionary measure to ensure that no untoward incident takes place.

Deputy Commissioner of Police (New Delhi) Pranav Tayal said some farmers were "in a hurry" to reach the dharna site.

The barricades were removed to escort the farmers into the site and the meeting was being held peacefully, he added.

peacefully, he added.

"Agroup of farmers were escorted to Jantar Mantar. At entry barricades they were in a hurry to reach the dharna site and some of them climbed the barricades which fell down and were removed by them. Policemen kept the barricades aside to facilitate their entry," the DCP said in a tweet.

"The protestors have reached the dharna site and the meeting is going on peacefully," he added.

is going on peacefully," he added. Police insisted that there was no clash with the protesters and that the cops at the site were facilitating the protesters and ensuring a peaceful gathering

suring a peaceful gathering.

"All are requested not to believe in fake news. The protestors at Jantar Mantar are being facilitated. Entry is being regulated through DFMD to ensure safety. Please remain peaceful and abide by the law," a tweet by Delhi Police's official Twitter handle said.

Farmers in large numbers reached the site to express their solidarity with the protesting wrestlers. Demanding justice for female wrestlers, the farmers, carrying their union flags, raised anti-Modi slogans. Shiv Sena MP Priyanka Chaturvedi also joined the protesters and addressed them. Taking to Twitter, she shared pictures from the protest site and demanded justice for the wresters.

"In solidarity with our women wrestlers. Justice needs to be served, the GoI should stop shielding the accused," she tweeted.

In a statement, Sanyukt Kisan Morcha (SKM) said thousands of farmers gathered at Bangla Sahib Gurudwara around 11 am and marched on foot towards Jantar Mantar. Farmer leaders said they stand united with the wrestlers and that they will work under the leadership of protesting wrestlers. Today they will have to fight to save the honour of the daughters of this nation as well as their agriculture at the same

time, the leaders said.

"A case under the POCSO Act has been registered against WFI chief Brij Bhushan Singh. Yet he has not been called by Delhi Police for questioning. He is being shielded by BJP leaders. These female wrestlers are our daughters and we will fight for their hon-

our," a farmer leader said.

The wrestlers are on a sit-in at Jantar Mantar since April 23 demanding action against the WFI chief over allegations of sexual harassment against him.

In last week of April, Delhi Police registered two FIRs in connection with the sexual harassment allegations levelled by women wrestlers against Singh. The first FIR pertains to allegations levelled by a minor which has been registered under the Protection of Children from Sexual Offences (POCSO) Act along with relevant sections of the Indian Penal Code concerning outraging modesty, according to

a police officer.

The second FIR has been registered for carrying out comprehensive investigations into the complaints by adult complainants under relevant IPC sections pertaining to outraging of modesty, the officer said, adding investigation into both the FIRs was being taken up in right earnest.

Delhi Police has recorded statements of all the seven complainants in the case, including the minor girl.

## In A First, An Arrest Over ChatGPT In China After Fake Train Crash News

Beijing: Chinese police have detained a man for allegedly generating fake news of a train crash and disseminating it online using artificial intelligence technology, in what was reported to be China's first arrest for misuse of ChatGPT.

Police in northwestern Gansu province said in a statement on Sunday that a suspect surnamed Hong had been detained for "using artificial intelligence technology to concoct false and untrue information".

The case first caught the attention of the cyber division of a county police bureau when they spotted a fake news article that claimed nine people had been killed in a local train accident on April 25, the Hong Kong-based South China Morning Post reported on Monday.

The cybersecurity officers in Kongtong county found the article simultaneously posted by more than 20 accounts on Baijiahao, a blog-style platform run by Chinese search engine giant Baidu. The stories had received more than 15,000 clicks by the time it came to authorities' attention, it said.

The Gansu public security department said Hong was suspected of the crime of "picking quarrels and provoking trouble", a charge that normally carries a maximum sentence of five years. But in cases that are deemed especially severe, offenders can be jailed for 10 years and given additional penalties, the Post reported.

This is the first time the public has been made aware of an arrest

by Chinese authorities after Beijing's first provisions to regulate the use of "deepfake" technology officially took effect in January, it said. The police said they traced the origins of the article to a company owned by the suspect Hong, which operated personal media platforms registered in Shenzhen in Guangdong province in southern China. Some 10 days later a police team searched Hong's home and his computer and detained him.

The statement said Hong confessed to bypassing Baijiahao's duplication check function to publish on multiple accounts he had acquired. He input the elements of trending social stories in China from past years into Chat-GPT to quickly produce different versions of the same fake story and uploaded them to his Baijiahao accounts, it said.

While ChatGPT is not directly available to Chinese IP addresses, Chinese users can still access its service if they have a reliable VPN connection. Chinese IT outlets were experimenting with their versions of the ChatGPT after Microsoft and Google announced their innovations. China closely monitors its social media through firewalls, especially Sina Weibo, which has over 592 million users to ensure no critical content against the ruling Communist Party of China (CPC).

China's top internet regulator has long voiced concern that unchecked development and use of deep synthesis technology could lead to its use in criminal activities such as online scams or defamation.
