Dubai Cheaper Than Srinagar, Soaring Airfares Cause Decline In Bookings

'Visitors Find Dubai, Other Destinations Economical As Compared To Valley'

Srinagar: Several tourism stakeholders have expressed concern over the soaring air prices which they say have dampened the tourist inflow with the arrival of the peak season.

The tourism stakeholders said they are facing a massive decline and cancellations of fresh bookings.

Many tourists aspiring to visit the valley have cancelled their plans due to skyrocketing airfares, said Nisar Shah, chairman of the Jammu and Kashmir Tourism Alliance, "None of



their fresh queries are maturing and all our potential clients are turning down the travel programme due to

skyrocketing airfares," he said A group of eight people from Mumbai had planned a visit to Kashmir

with my agency but due to the "extremely high price" of air tickets, they changed the destination. The air tickets for each individual cost them around Rs 40,000 for the two-way trip, so they dropped the plan, he said.

Shah said the halting of operations by Go First airlines has also added to their woes. Those who had booked tickets in advance are yet to get alternatives while the air prices are soaring with every passing day, he said.

Earlier in the week, Go First airlines in a tweet informed that their flight operations will remain cancelled till May 19, 2023, citing operational reasons.

Following this, the Directorate General of Civil Aviation (DGCA) directed the cash-strapped airline Go First to stop the sale of tickets with immediate effect, asking the airline to issue refunds to passengers against cancelled flights.

Bridge Dividing Kashmir **Gives Tourism Potential To Uri**

Uri: Like a bridge over troubled water, the Kaman Sethu stretches from India to Pakistan controlled Kashmir (PoK), giving the town of Uri tourism potential and offering visitors a chance to come face to face with contemporary history and the heroes who made it happen.

The small town of Uri, about 70 km from Srinagar, has long been in the line of enemy fire with soldiers controlling access to the 220-ft Kaman Bridge that connects Kashmir Valley to PoK, just across the small river treated as the Line of Control between India and Pakistan.

But with tourists being able to walk up to the bridge, also called Aman Sethu (Bridge of Peace), things have changed.

Tourists, say locals, started coming to the town after the Bollywood film "Uri", based on India's surgical strike after an attack by four Jaish-e-Mohammed militants in September 2018 left 18 soldiers dead. The situation was tense at the time and the film was shot in Serbia.

The change since is visible. The number of visitors have been steadily rising since the bridge opened for tourists at the end of March. About 3,000 people visit each day and there is a view from the other side too.

Civilians on the other side can be seen taking selfies against the bridge under the strict vigil of Pakistani army snipers.

The gates were locked after India suspended the bus service between two parts of Kashmir in February 2019 when 40 CRPF jawans were killed in a suicide attack by JeM in Pulwama.

Locals employed at the tourist facilitation centre, set up with the help of the army, greet tourists eager to visit the Kaman post, about 18 km from the main town.

"There are many scenic spots on the way with breathtaking landscapes that enthral tourists. We hope the move by the Indian Army to open the bridge will go a long way in boosting the economy of this area," said Imran

HC Notice To J&K Govt On Imposition of Property Tax

Petitioner Says It's Also Against 'Doctrine Of Federalism'

Srinagar: The High Court of J&K and Ladakh has issued notice to Centre and J&K government on a petition challenging as "unconstitutional" and against "Doctrine of Federalism" the imposition of Property Tax in Jammu and Kashmir.

Hearing the petition filed by one Hanan Moumin Feroz Khan, a bench of Justice Vinod Chatterii Koul has asked Union of India through Secretary, Legislative Department, Ministry of Law & Justice, Secretary, Jammu, Kashmir and Ladakh Affairs Division, Ministry of Home Affairs, and J&K government through Principal Secretary, Housing & Urban Development Department, to file their reply to the petition within four weeks.

The petitioner, a resident of Lal Bazar Srinagar, has submitted that enactment of Jammu & Kashmii

Reorganisation Act, 2019 changed the constitutional status of J&K from a state to a Union Territory and hence ensued the process of "overhauling" the administrative and legislative structures of the erstwhile State.

Accordingly, he says, by virtue of Reorganization Third Order, 2020 dated 5 October 2020 issued MHA, Section 84(1), Section 86, Section 88, Section 89, Section 90, Section 95, Section 132, Section 133 and Section 143A, of the Jammu & Kashmir Municipal Corporation Act, 2000 were substituted by repeal with the incorporation of few new sub-

tive provisions and consequent notifications issued vide S.O 49 dated 12 February 2021 and S.O 86 dated 21 February 2023 by J&K government, whereof "Property Tax" was/is implemented within the Municipal Iurisdiction of Srinagar city.

The petitioner submits that the amendments or repeal carried out in the J&K Municipal Corporation Act, 2000 were violative of Article 14, 21, 246, 265, 300A, Schedule VII, Doctrine of Federalismwhich means the demarcation/ distribution of the legislative powers of Union Legislature and the Legislatures of States and Union Territories as enshrined under the Article 246 of the Constitution of Indiaand other express provisions of Constitution of India.

Therefore, the petitioner has sought the court's indulgence

J&K HC Stays Judgment On 2022 VDG Scheme

The Jammu and Jammu: Kashmir High Court on Friday stayed a judgment, pending outcome of appeal, with regard to the new village defence guards scheme announced last year by the Centre as part of efforts to tackle militant activities in the Union Territory. The

scheme came into effect on August 15 last year and replaced a 1995 scheme of the Jammu and Kashmir government. However, the new

village defence guards (VDG) scheme was challenged in the high court and petitions were filed, mostly by special police officers (SPOs) heading these groups whose honorarium was reduced from Rs 18,000 to Rs 4,500.

On April 6, a single-judge bench had quashed the 2022 scheme and directed authorities to treat Special Police

Officers (SPOs) as having been appointed under the village defence committee of 1995 with all powers and privileges of SPOs under the Police Act.

A division bench comprising Chief Justice N Kotiswar Singh and justice Rahul Bharti stayed the single-judge bench's verdict. "Keeping in mind all the fac-

How To Move Without Legs Or Wings: Helping Trees Migrate To New Regions

Artificial Seed Transfer And Planting Can Accelerate The Natural Migration Process

hile it is true that individual trees are immobile, as a species they can actually move and migrate as well as birds do! However, this takes place over a much different time frame.

This is what we will explore in this article, the first in our new summer series. As researchers in forest ecophysiology, we study basic tree physical functions and relate them to broader ecological dynamics. Rapid climate change is challenging the sustainability of forest ecosystems in many ways. To deal with the new problems associated with climate change, we need new tools: assisted tree migration is one of these.

And to inspire us, this excerpt from a song by Qubec poet Gilles Vigneault:

Let's get the definitions out of the way first: assisted migration refers to the humanassisted movement of species in response to climate change. We usually associate the term migration' with the movement of people or the seasonal flights of birds.

We don't typically think about forest migration, however, and it may even seem weird to associate these two terms. After all, trees are typically rooted to the ground and don't move. Or do they?

Tree migration occurs through seed dispersal, and the germination and establishment of new seedlings. After some time, these seedlings will start producing new seeds and contribute to this slow geographical expansion.

Migration strategies may differ among tree species. For example, maple samaras are wind-carried seeds that can travel faster and further than the acorns of an oak tree, limited by their heavy weight. However, new seedlings require years, often decades to grow and produce seeds that can migrate further than their parents.

This movement, which takes place over



a period of centuries generally too slow for our conception of time can become limiting in the face of rapid human-induced changes in climate systems.

Current climate change is quickly modifying environmental conditions. No natural warming event in the past has occurred at a comparable rate. Such rapid changes are putting great pressure on forest ecosystems, particularly by modifying habitat conditions.

The migration speeds of the vast majority of tree species are slower than the shift of favourable habitats. This means that their migration to new favourable habitats (e.g. cold regions in the north becoming warmer) will not compensate for the loss of habitats in other areas (e.g. warm regions in the south becoming drier)

This mismatch between changing habitat conditions and natural tree migration entails a loss of forest vigour. A decline is predicted for many tree species, which may in turn jeopardize local forest ecosystems.

We are being called upon to find strategies to help forests adapt to new climatic conditions. This motivates researchers and forest managers to consider new approaches to solving this problem, including assisted migration.

Artificial seed transfer and planting can accelerate the natural migration process and help overcome geographical barriers, such as mountain ranges or large water surfaces. Assisted migration could therefore be used to help maintain functional forest ecosystems in the future.

This is not only important for the conservation of species, but also for the maintenance of all the services forests provide, from wood production to carbon sequestration from the atmosphere.

In general, short-distance relocation is easier to achieve, while longer-distance migration requires careful planning. Since the latter presents higher ecological risks, it is generally only considered for the conservation of endangered species.

But enough theory, let's move on to concrete examples.

The sugar maple (Acer saccharum) is an iconic tree species in Canada. As climate change intensifies, sugar maples in the southern por-

tion of the range are suffering from increased competition from trees that are more tolerant to warmer, drier conditions, such as American beech (Fagus grandifolia).

At the same time, researchers have found that areas near the northern limit of maple's range are becoming increasingly suitable for this species. In this case, assisted migration could help northern forests adapt faster to new conditions, and provide valuable services such as maple syrup production. So why not just go ahead with the technique?

In 2019, the University of Qubec in Chicoutimi (UQAC) established an experimental sugar maple plantation at the northern edge of its range, in the Saguenay region of Qubec. The experiment is being conducted in partnership with a local family farm, which has chosen to dedicate part of its land to scientific research and the vision of a productive sugar bush for future generations.

The plantation, counting 500 young trees issued from several populations in Qubec and the United States, will celebrate its fourth year of life in the spring of 2024. In a few decades, excellent maple syrup may be produced here, in addition to all the valuable scientific data collected up to that point.

Similar studies have been conducted by the DREAM-Qubec research network, a project of the Qubec government (Ministry of Natural Resources and Forests), the US Forest Service and Laval University. The experiments consist of mixed plantations of a dozen tree species, located in the Portneuf region of Qubec and in Wisconsin in the United States.

Here, the effects of factors such as microclimate, herbivore browsing and plant competition on tree establishment and growth can be tested. In addition, the performance of trees from southern populations adapted to conditions similar to the predicted future climate can be compared with that of local populations.

Do We Really Need Bicycle and Pedestrian Tracks?

Transportation researchers have come to the consensus that traffic-related problems are primarily due to car-oriented policies. and cycling infrastructure

HILE everyone these days talks about the Srinagar Smart City Project, most of the conversations I have had are negative, especially related to the transportation infrastructure. Although the Smart City mission covers a broad spectrum of issues, in this article, I will confine my arguments and discussion to transportation alone.

Cars are amazing but traffic is a mess! Right? Can infrastructure like more roads, widened roads, flyovers, underpasses, and multilevel parking solve all these issues?

To understand this from a scientific perspective, we need to understand the game between demand and supply. Here, demand refers to the growth of vehicles (cars) and supply refers to all the infrastructure that cars need from parking spaces to road width to intersection designs and so on. If we can maintain optimality between these two, the problem is resolved. But the issue is that car growth is exponential and providing infrastructure at a similar pace is not possible. Let me quote a silly example so that we can understand it better. No matter how big your house is, it has a capacity. What if you flood it with stuff at an exponential pace? Very soon, you will have to either expand the house or think of a new one. Let us assume you even have all the resources to do that. But is it sustainable? Certainly not! What it means is that providing car infrastructure is only an expensive shortterm solution to traffic congestion, leaving other issues aside.

Are these problems new? Are there any options that would move more people while occupying less road space and being sustainable?

In recent years, Srinagar has been witnessing some serious traffic-related problems, with congestion being at the top of the list. The good news is that these problems are not new to the world. Owing to the growth of cities and urbanization, countries in the west have already faced it two to three decades back. As more and more people began driving cars, roads became crowded and traffic jams became more common. Traffic congestion is horrible as it not only wastes a huge amount of time, fuel and money but also leads to increased air pollution, frustration, and reduced productivity. All these issues have serious health consequences, including respiratory, cardiac, and even psychiatric problems.

Transportation researchers have come to the consensus that traffic-relat-



ed problems are primarily due to caroriented policies. Car-oriented policies prioritize the need of cars over other modes of transportation and the need of the community as a whole. These policies often prioritize the construction of highways, flyovers, the availability of parking, and the convenience of driving cars over the development of public transportation, walking, and cycling infrastructure. Researchers have concluded that people-oriented policies that prioritize the needs of the community holistically, focussing on accessibility, safety, and environmental sustainability is what can save us from massive adverse impacts of traffic. It does not mean banning cars right away. What it means is that cars cannot be the only mode of transport given sheer importance. Other modes need equitable road space, if not more, In fact, the modes that are less polluting and environment friendly should be given preference

What did they (the West) do about it?

Having faced these pressing issues, following are some of the examples that reflect their (West) course of action:

1) Amsterdam (Netherlands) has long been a leader in promoting cycling as a primary mode of transportation. The city has invested in extensive cycling infrastructure, including dedicated bike lanes, bike parking facilities, and traffic signals that prioritize cyclists. As a result, cycling now accounts for over 60% of all trips within the city.

2) Copenhagen (Denmark) has also prioritized cycling as a primary mode of transportation. The city has invested

heavily in cycling infrastructure, including a network of bike lanes and bicycle tracks, and has implemented traffic-calming measures to make streets safer for cyclists and pedestrians. These efforts have resulted in cycling accounting for over 50% of all trips within the city.

3) Bogota (Colombia) is known for its extensive public transportation system, including a rapid bus transit system called TransMilenio. The city has also implemented a number of measures to reduce car use, including carfree days, pedestrian-only zones, and a bike-sharing system called Ciclovia. These efforts have helped to reduce traffic congestion and air pollution within the city.

4) Barcelona (Spain) has implemented a number of policies to reduce car use and promote sustainable transportation options. The city has introduced a bikesharing system, expanded pedestrian zones, and implemented traffic-calming measures to make streets safer for cyclists and pedestrians. Barcelona has also introduced a "superblock" model, which involves closing off several city blocks to through traffic and prioritizing public space for pedestrians and cyclists.

What's more, a study of over 18,000 commuters in the UK found that cycling to work was associated with lower levels of stress and greater feelings of wellbeing compared to driving cars. Regular cycling has been associated with a lower risk of cardiovascular disease, cancer, and premature death. In fact, a study of over 260,000 participants in the UK found that regular cycling was associated with a 41% lower risk of premature death than non-cyclists. Addition-

ally, outdoor cycling has been found to improve overall well-being, happiness, and enjoyment more than indoor cycling or other forms of exercise, according to a study of over 1,000 adults in the US. Research papers are flooded with many such examples. It would be unfair not to mention here a famous quote by H.G. Wells:

"Every time I see an adult on a bicycle, I no longer despair for the future of the human race."

These are few examples signifying how cities can reform their policies to prioritize sustainable transportation options and reduce the dominance of cars. But why did their policies suppress car dominance? Research has proved that by investing in public transportation, cycling infrastructure, and pedestrianfriendly streets, these cities have been able to reduce traffic congestion, air pollution, and greenhouse gas emissions while improving the quality of life for their residents. While you are reading this, I am sure you must be thinking of weather, distance, and social symbols. Of course, cycling is not for commuting longer distances and who would prefer it in rain and snow! But how often does it rain and snow across the year in Srinagar? Do you have similar thoughts on motorbikes? The weather being a deterrent to cycling is only true for a very small period considering the climate of Srinagar, in particular. The only deterrent remains the social symbol associated with it. Being a researcher myself, I strongly believe that if government officers, educational institutions and sports fraternity lead this movement of green mobility in the city, it will have an amazing impact on the behaviour and attitudes of the public. I conclude this article by leaving some questions for you to ponder. They (the West) have understood and acknowledged it. When will we? Can we learn from them? Can we leapfrog or repeat those mistakes? The answers to these questions will decide what future we are looking for in the people and city of so-called paradise!

hen US treasury secretary Janet Yellen visited India late last year, on a mission to deepen economic and strategic ties between the two countries, her Indian counterpart, finance minister Nirmala Sitharaman, highlighted "skilling at scale" as one of India's major challenges. Studies by the National Skill Development Corporation and the National Policy on Skill Development and Entrepreneurship merely confirm what is well known-India has a serious skill deficit. In this year's Budget, several new government initiatives were announced for skills and training. And in April, in Washington, DC, the FM gave the same message, saying, "We are now focusing very much on skilling people, each according to their level.... Businesses and private sector entrepreneurs are also tied into it so that there is a link between the kind of training businesses want and actually those who are getting the training.

This all sounds very promising, and it may indeed be that Indian policy making and implementation are finally getting to grips with what may be the country's largest obstacle to attaining the levels of economic growth required by its demographics. But there is another side to the picture of a government push for imparting skills at scale.

Also in April, a news story noted the problem of worthless degrees being offered by new private colleges that are popping up everywhere to take advantage of those desperately seeking both skills and credentials that might land them a decent job. The news story referred to a study (India Skills Report, 2022) produced by a talent assessment firm, in partnership with private sector, government and international organisations. The report itself offers standard analyses of changes in the kinds of skills that are needed, as well as an optimistic spin on new skilling initiatives, but the largest lesson of the report is that half of India's young jobseekers lack the skills for employability. In this context, the mushrooming of institutions offering poor quality education only makes things worse.

In principle, fraudulent educational institutions can face legal repercussions, and sometimes do, but this is often too little and too late for those who are duped. One problem, of course, is that the Indian accreditation system for colleges is not comprehensive and is widely known to be a guide for prospective students. A deeper problem is that India has not expanded higher education in a rational manner. Of course, public education at lower levels has been most seriously underfunded, which has repercussions for those seeking a college education—they may not even have the preparation they should to go to that level. But much of public higher education has subsidised the upper middle class, making it difficult to fund

expansion. Private colleges are a relatively new phenomenon in India, and they, too face many constraints to expansion.

Recently, the Indian government has started to allow foreign universities more room to operate in India. But this is the likes of Oxford, Stanford and Yale—they will do nothing to solve India's skilling challenge. They will not be operating in India's smaller cities and towns, serving students who cannot even get admission to good domestic colleges, public or private. On the other hand, there are easily over 300 universities and colleges in the US and the UK alone, which could provide decent educations to the tens of millions of desperate young Indians. Many of these colleges are facing shortages of students themselves, as their domestic demographics change in the opposite direction to India's. And they are producing domestic surpluses of doctorates in many fields. But why would they be different than existing domestic fraudsters or mediocrities?

The key features that India needs to develop in its higher education system are competition, reputation and effective regulation. Take the US, for example. There are reasonably strong regional accreditation organisations, to which every reputed college or university belongs. In some cases, the institution is strong enough not to need this accreditation, but not getting it would be a negative signal. India needs to import this system wholesale—a consortium of universities and colleges

that will compete in India, but also operate within their now-globalised regulatory framework. They will compete for faculty globally, bring in organisational expertise and modern curricula, and find their own niches. They have existing reputations, both in the market and under their domestic regulators.

latory umbrellas, which they will want to protect. India's current problem in higher education is a severe shortage of qualified faculty, organisational capital, and regulatory capacity. There is no way to develop all of these quickly enough through a purely domestic effort. All three of these have to be imported at scale, in order to jumpstart "skilling at scale." Doing anything quickly runs the risk of making mistakes. But India has also filled universities in the US, the UK and elsewhere with its best and brightest. They may not be in a position to return to India, but they can provide the expertise to examine potential entrants, and even oversee the first steps towards entry. Enormous time and thought has been given to FDI in sectors such retailing, but hardly any to one of India's most important shortages, in the education sector. It is time to change that, and quickly.

How Clinical Psychologists Can Help Save Your Marriage

arriage is considered one of the most important events in one's life, but it can also be one of the most challenging experiences, especially if there are issues that arise within the relationship. Signs That You're An Extraordinary Altruist

e've likely all experienced the kindness of a stranger, but what can we learn from the minority of true heroes that help others at a substantial personal cost?

Before she was a neuroscience researcher, Abigail Marsh was in a nearly fatal car mishap. While attempting to dodge a darting dog along an eight-lane freeway, her vehicle began to fishtail. Before she knew it, she had spun into the fast lane of the oncoming traffic. When the car stopped and she got her bearings, it wouldn't turn on. The car was stuck on a part of the road not visible to drivers until they swerved around the corner. She knew it was only a matter of time until another driver failed to notice her in time.

As she began to panic, a man approached her passenger window and offered assistance. Despite the potential danger, the stranger got into her car and managed to start it, driving them both to safety. Had the man not intervened, Marsh might not have survived to share her story.

What caused the man to pull over and help? And would we do the same had we passed Marsh that winter midnight? Many people in our lives are kind, generous, and full of wisdom. But would they be classified as an Altruist with a capital A?

Altruists are people who do good for others without any thought of how it may benefit them. They simply care about the welfare of others—no strings attached. Marsh tells us,

The world is absolutely bursting with people who have committed



moving acts of altruism. They volunteer to help needy animals or children or the mentally ill. They donate money to strangers in faraway cities or countries. They open up their veins to give their blood to the sick or injured. They remove garments from their own bodies to clothe impoverished people in their communities—sometimes in real time. (p. 105)

Marsh considers these acts ordinary. It's not uncommon for us humans to be generous toward one another. After all, we've evolved to engage in reciprocal altruism. Our early ancestors who helped others in hopes that they would return the favor were more likely to survive and reproduce. We've also evolved to practice kin altruism, which makes it more likely for our offspring to survive and carry on our bloodline.

But how do we make sense of heroic acts toward complete strangers? Especially ones who have no way of ever paying us back? Marsh describes this type of altruism as extraordinary. Would you make the cut?

Signs that you could be an extraordinary altruist include these:

You've done something exceptional for someone you didn't

know. To meet Marsh's definition of an extraordinary altruist, you would need to have committed a generous act for someone where

The recipient was someone unrelated to you and unknown to you at the time you decided to act.

2. The behavior required a personal risk or cost to you.

3. The act wasn't something you were required or expected to do.

Marsh decided to study a tiny fraction of the US population—people who had donated a kidney anonymously to a stranger. This unique group certainly qualifies as having demonstrated extraordinary altruism. The following are some characteristics of extraordinary altruists:

You don't believe humans can be truly evil. You may have assumed that extraordinary altruists show higher levels of empathy or religiosity compared to typical populationsbut little evidence has been found to support these differences. Interestingly, Amormino et al. (2022) did find that altruists scored lower on the Belief in Pure Evil scale compared to controls. This included items such as, "Some people are just pure evil" and "Evil people harm others for the joy of it." The researchers found that even after "controlling for empathy and religiosity, for every oneunit decrease in belief in pure evil, the odds of classification as an altruistic donor increased

by 31%" (p. 2).

You're good at detecting others' fear. Researchers have found that altruists have larger and more active amygdalae compared to control samples. The amygdala is an almondshaped structure in the limbic system that aids in emotion processing, especially in detecting fear and threat. It may be that the better we can recognize fear in others, the more equipped we are to act and alleviate their distress.1

 You don't see yourself as special. Altruists don't see themselves as anything but ordinary. While altruists score lower on beliefs in pure evil, they were no different than controls to believe that humans can be purely good. Many of us would likely classify anonymous kidney donors as the select few who qualify as all good, yet altruists see no distinction between themselves and others.

Perhaps it is this last characteristic that truly makes them unique. Altruists don't view the world in terms of "us versus them." There is no othering, nor hierarchies. There are no lines separating groups by deservingness. What sets extraordinary altruists apart is their ability to recognize the inherent value in all people and to act on that recognition, even at personal cost.

As the study of human nature progresses, it's important to keep an open mind. Altruism has largely been examined through limited data sets, such as the population of kidney donors who were few and not randomly selected. Yet, Marsh's story serves as a powerful reminder that acts of extraordinary altruism can have a profound impact on the lives of others. While we may not have the opportunity or ability to donate a kidney anonymously, there are still many ways we can prioritize the welfare of others.

Even though I don't consider myself an exceptional altruist, I'm learning. I envision a world filled with exceptional altruists, and the thought is exhilarating. Each small act of kindness can lead us on the path to remarkable heroism.

MHA prepares new 'Model Prisons Act' to replace pre-independence era law

New Delhi: A new 'Model Prisons Act 2023' that will replace the 130-year-old pre-independence era law has been prepared by the Centre to address lacunae in the existing law and focus more on reformation and rehabilitation of inmates, the Union home

ministry said on Friday. Among the salient features of the model Act are provisions of punishment for prisoners and jail sta? for use of prohibited items like mobile phones etc. in jails and providing for legal aid to prisoners, provision of parole, furlough and premature release etc. to incentivise good conduct, the ministry of home affairs (MHA) said in a statement.

Prisons in the country and 'persons detained therein' are a State subject and the existing law in this context, the Prisons Act of 1894 is a pre-independence era Act and is almost 130 years old, it said.

Two other related laws are quite old--The Prisoners Act, 1900 and The Transfer of Prisoners Act, 1950.

The home ministry found there were "several lacunae" in the existing Prisons Act and there was "conspicuous omission" of the correctional focus in the existing Act. The ministry, hence, directed the Bureau of Police Research Development, a Union

government think tank on policing subjects, to review the laws and prepare a new draft.

"The (existing) Act mainly focuses on keeping the criminals in custody and enforcement of discipline and order in prisons. There is no provision for reform and rehabilitation of prisoners in the existing Act," it said.

The home ministry said a comprehensive 'Model Prisons Act, 2023' was finalised with the objective of holistically providing guidance and addressing the gaps in the existing Prisons Act including the use of technology in prison management, making provisions for grant of parole, furlough, remission to prisoners to encourage good conduct,

special provision for women/ transgender inmates, physical and mental well-being of prisoners and focus on the reformation and rehabilitation of inmates.

The model Act, it said, may serve as a "guiding document" for the states, and for adoption in their jurisdiction.

"Under the visionary leadership of Prime Minister Narendra Modi and decisive guidance of Union home minister Amit Shah, a decision was taken to review and revise colonial-era outdated Prison Act, in tune with contemporary modern day needs and correctional ideology.'

"The Ministry of Home A?airs assigned the task of revision

of the Prisons Act, 1894 to the BPRD. The Bureau, after holding wide ranging discussions with state prison authorities, correctional experts etc. prepared a draft," the ministry said in the statement.

Along with The Prisons Act, 1894, The Prisoners Act, 1900 and The Transfer of Prisoners Act, 1950 have also been reviewed by the MHA and relevant provisions of these Acts have been "assimilated" in the 'Model Prisons Act, 2023', it said.

State governments and Union Territory administrations can benefit from the Model Prisons Act, 2023 by adopting it in their jurisdictions, with such modi?cations which they may

consider necessary, and repeal the existing three Acts in their jurisdictions, the MHA said.

Some of the focus areas of the model Act provide for security assessment and segregation of prisoners, individual sentence planning; grievance redressal, prison development board, attitudinal change towards prisoners and provision of separate accommodation for women prisoners, transgender, etc.

The model Act also talks about provision for use of technology in prison administration with a view to bring transparency in prison administration, provision for video conferencing with courts, scienti?c and technological interventions in prisons, etc.

Among other stress areas are provision of punishment for prisoners and jail sta? for use of prohibited items like mobile phones etc. in jails, allocation regarding establishment and management of high security jail, open jail (open and semi open), etc. and provision for protecting the society from the criminal activities of hardened criminals and habitual offenders, etc.

The model Act also has provisions for legal aid to prisoners, provision of parole, furlough and premature release etc. to incentivise good conduct and focus on vocational training and skill development of prisoners and their reintegration into the society, the MHA said.

After checking for documents, including a pass from the local police station, visitors head to the Khalin-Da-Khas Nalla, the river flowing between the two sides of Kashmir.

Civilian heroes commemorated near the bridge include Zuma Mohamed, a civil porter of the 4th battalion of Kumaon regiment who was awarded the Vir Chakra for his service during the war, and Maqbool Sherwani, a National Conference worker who had helped stave off an attack by giving wrong directions to the raiders from Pakistan and stopped them from moving towards Srinagar.

Besides, there are busts of Maj Somnath Sharma, who was awarded the highest military honour, Param Vir Chakra, for his service to the nation in the war, and Brig Rajinder Singh and Lt Col Dewan Ranjit Rai who were awarded the Mahavir Chakra.

A huge 'Akhand Bharat Varsh' painting, carved out of stones showing Afghanistan, Pakistan as one, faces Pakistan army posts located across the LoC.

The army has also created an artificial bunker with toy guns and bullet proof vests for children.

As the buzz slowly builds up, Mehak Khursheed is among those who walked the bridge. She is a resident of Salamabad, somewhere between Uri and the Kaman post.

Pakistan Situation Will Not Impact J&K: BJP

SRINAGAR: The situation in Pakistan will not have any impact on Jammu and Kashmir, the J-K BJP said on Friday after some regional political parties expressed concern about the state of the affairs in the neighbouring nation and its ramifications.

National Conference president Farooq Abdullah and PDP chief Mehbooba Mufti have expressed worries about the "dangerous" situation in Pakistan, claiming it will affect India.

Widespread protests broke out across Pakistan after the arrest of former prime minister and Pakistan Tehreek-e-Insaf founder Imran Khan by the paramilitary Rangers, prompting the deployment of the army as well as in Punjab, Khyber Pakhtunkhwa and Balochistan provinces.

"Whatever the situation is in Pakistan, it will not have any impact on the situation of Jammu and Kashmir. Whatever Pakistan has done in the last 30 years, it will fall into its own pit," BJP general secretary organisation, Jammu and Kashmir, Ashok Koul, said.

He also told reporters that the regional parties in the Union Territory are worried about Pakistan and had made statements that the worsening situation there would have an adverse impact on Jammu and

BGSBU Sacks Tainted Officials As Rajbhawan Orders Probe

SRINAGAR: In a significant development, the authorities at Baba Ghulam Shah Badshah University (BGSBU) sacked two officials in a week's time after the Office of Lieutenant Governor, J&K, ordered probe into the alleged large-scale financial irregularities in the varsity, especially in the whooping Rs 12 Crore TEQIP project.

The probe has been ordered as a special audit report of the Government of Jammu and Kashmir pertaining to Baba Ghulam Shah Badshah University, Rajouri, earlier pointed out large-scale financial irregularities in the centrally-sponsored Rs 12 crore TEQIP-III project, besides several other financial matters.

In wake of this, the Registrar BGSBU in an order issued on Friday has stated that the process of Special Audit regarding allegations of Financial Misappropriations, besides verification and audit of Service Books including Pay-Fixation of Permanent, Regular, Superannuated, Deputationist employees including that of Suneet Gupta has been initiated by the University "in pursuance to instructions received from Lieutenant Governor's Secretariat".

"All the concerned sections are therefore required to keep the relevant data available for perusal of the special audit team." the order reads.

The probe has been launched days after the authorities at BGSBU relieved a retired official of the University after outcry over his continuation as Dean Academic Affairs (contractual) in the University. The Registrar BGSBU in his

order stated that the outgoing retired official Iqbal Parwez opted to get relieved from the affairs of the University.



lqbal Parwez, Dean Academic Affairs (Contractual) is hereby relieved from the services of the BGSB University with immediate effect," the order reads.

As per the order Iqbal Parwez shall be required to properly handover the record pertaining to charges he was looking after.

Sources said the retired official was handling the TEQIP project and was told to put in his papers after teachers resumed their strike this week seeking his removal. Notably no official can continue on any administrative position after attaining age of 65. The BGSBU official had attained the age of 70.

As already reported, the Vice Chancellor BGSBU earlier stripped the official of all administrative and financial powers, amid the weeklong strike launched by the teaching faculty of the university.

Prof. Parvez Iqbal retired as Dean Academic Affairs of the varsity in 2018 but he was reengaged as Dean academic affairs, much to the annoyance of the University faculty.

Meanwhile in another fresh order, the BGSBU authorities have shifted Suneet Gupta to Camp office Jammu.

"The Vice Chancellor has been pleased to approve transfer and posting of Sh. Suneet Gupta Joint Registrar to Camp Office Jammu. Consequently, he is relieved of the additional assignment of OSD (Nursing "On his own request Prof. Colleges)," the order reads.

Earlier, Suneet Gupta was removed as special secretary to VC following allegations of favouritism and corruption.

"In pursuance to instructions received from Hon'ble Lieutenant Governor's Secretariat, the process of Special Audit regarding allegations of Financial Misappropriations, besides verification/ audit of Service Books including Pay-Fixation of Permanent/ Regular/ Superannuated / Deputationist employees including that of Mr. Suneet Gupta has been initiated by the University," the Registrar's new order has stated.

Notably, the Teaching Association of Baba Ghulam Shah Badshah University (BGSBU) has already called for an indefinite strike over allegations of bungling and the demand for career progression. The strike has been initiated by the university's teachers, who claim that the institution established in the name of the famous saint Baba Ghulam Shah Badshah is going through a tough phase.

The Vice-Chancellor of BGS-BU however has claimed that an inquiry into allegations of financial bungling before his tenure had already been ordered by the office of the Chancellor through the Jammu and Kashmir Finance Department.

Meanwhile, teachers of BGSBU welcomed the decision to sack "tainted officials" and said that will work hand in hand with VC to weed out all corrupt elements.

Met Predicts Rains, Thunderstorm In J&K From Today

Work On Delayed 4-Lane Jammu-**Akhnoor Highway Back On Track**

IAMMU: The much-awaited Jammu-Akhnoor four-laning road project, sanctioned by the Union Government in 2015, is several deadlines.

Jammu-Akhnoor a stretch of national highway 144-A, which connects the border districts of Rajouri and Poonch with Jammu and is also a very important defence road.

"Almost all the hindrances have been cleared and the construction work has gained pace from 2021 to 2023. We have made the road stretch up to 4.4 kilometres under phase-1 and hope the work of other' phases may be completed by 2025 February and March", General Manager, National Highway and Infrastructure Development Corporation Limited (NĤIDCL), Col Surajpal Singh Sagwan told PTI.

The NHIDCL, a company under the Ministry of Roads and Highways, is executing the

Jammu-Akhnoor road widening project costing Rs 1,345 crores, which has been divided into four Packages.

The flyover under Package II has been fully functional back on the rails after missing and more than 72 per cent of work on the 20-kilometrelong stretch under Package III. has been completed, Package I work on a 0.8 km long stretch from Bhagwati Nagar Chowk (4th Tawi Bridge) to Canal Head in Jammu city is also under progress.

"The work was assigned during 2018 but, got started in 2019. Earlier the work was delayed due to the abrogation of Article 370 in 2019 as the state was converted to UT the work was delayed due to a lack of materials and land acquisition. It was further delayed in 2020 due to the Covid-19 pandemic and land acquisition and other issues where many houses and structures had to be demolished", GM said.

People hope that company will meet the deadline and make this fully stretch operational. They say that several patches of the road are in very bad shape due to a delay in ongoing work.

Sandeep Khajuria, a local resident, said that the project should be completed within the time frame

2,500 Mobile Toilets To Be **Set Up For Amarnath Yatra**

JAMMU: Over 2,500 mobile toilets will be set up for the Amarnath Yatra in Jammu and Kashmir, with most on the two routes to reach the cave shrine located at a height of 3,880 metres in the Himalayas, officials said.

Scheduled to begin on July 1, the 62-day-long yatra this year could see more pilgrims, they said and added that in total, 1,500 personnel will be manning the toilets from Lakhanpur in Kathua district to the shrine.

"Over 940 toilets will be set up at the Baltal axis and 1,345 toilets at the Pahlagam axis," an official said and added that 1,370 personnel, including sanitation workers and supervisors, will be deployed for managing these toilets. The officials said that an additional 120 toilets will be set up at the Yatri Niwas and at other locations in Jammu city. Lakhanpur, which is the entry point to Jammu and Kashmir, will also have more toilets this time, they said. Tenders for installation of the mobile toilets have been floated, the official said. Deputy commissioners of Kathua, Samba, Jammu, Udhampur, Ramban, Anantnag, Srinagar and Ganderbal districts have



been asked to share details on requirement of toilets, the officials said.

Engineers of the Jal Shakti department will also be involved during the installation of toilets to ensure that there is no shortage of water during the yatra. The Jammu and Kashmir administration will also prepare a contingency plan to accommodate 7,500 pilgrims in Kathua district in case of inclement weather or any other emergency, the officials said.

For smooth issuance of RFID tags to registered pilgrims, the administration has increased the number of counters at different locations to control the rush at the Jammu Base camp, they said.

NEW DELHI: All but out of playoff reckoning, Delhi Capitals will expect a more purposeful approach from its Indian batting unit as it plays for pride against Punjab Kings in a 12th round IPL match, here on Saturday.

With four wins in 11 games, DC are staring at an unceremonious exit as winning the next three matches will only take them to 14 points, which might not be enough to earn them a place in the top four, leaving their fate in the hands of other teams.

The specialist Indian batters have hardly contributed and it has all been about either skipper David Warner, keeperbatter Phil Salt or all-rounder Mitchell Marsh, who have given the team some momentum with willow.

The likes of Manish Pandey, Ripal Patel and Aman Hakim Khan have lacked the killer punch as they have not been able to change their game according to the match situation.

Skipper Warner, who looked good during the first half of the season, has struggled in the last five innings with single digit

scores in three of them.

Salt sizzled with two whirlwind innings but he also was dismissed cheaply in three matches, including two ducks.

Marsh exploded once against Sunrisers Hyderabad with the bat but couldn't do much in the rest. However, the Australian has chipped in with regular wickets in the last three games.

The bowlers have fared better with spin duo of Axar Patel and Kuldeep Yadav bowling a good line, while pacers Ishant Sharma and Khaleel Ahmed getting wickets most times. The absence of speedster Anrich Nortje, who had to return home due to personal reasons, however, was felt in the last match.

Punjab Kings, with 10 points from 11 games, too are looking at a must-win game, following back-to-back defeats against Mumbai Indians and Kolkata Knight Riders respectively.

Leg-spinner Rahul Chahar has lacked consistency, while Liam Livingstone too just has two wickets to show in five games. Left-arm spinner Harpreet Brar too has taken just 5 wickets in 10 games but he had done well, taking a wicket for four runs against KKR but he

If India Doesn't Come To Pakistan, We'll Not Go To India For WC: PCB Chief Najam Sethi

PROVO: Pakistan Cricket Board chairman Najam Sethi on Friday made it clear that Pakistan will travel to India for the ODI World Cup only if the Rohit Sharma-led team is allowed to play the upcoming Asia Cup and the 2025 Champions Trophy in his country.

The Asian Cricket Council (ACC) recently rejected the "hybrid model", which the former journalist feels is the only feasible solution until India and Pakistan start playing each other in their respective nations.

Sethi also said that if India comes to Pakistan, their national team will have no issues playing in any Indian city, including Ahmedabad.

Excepts from an exclusive interview with the PTI:

Q: What is the status of Asia Cup and what is ACC's reaction to your proposed Hybrid Model?

A: In the current scenario, we have made it clear that let's play four matches in Pakistan and we will play the rest of the games at neutral venue which we can mutually agree upon. The Asian Cricket Council can take two decisions. Either they can say 'Okay, let's go ahead and issue the schedule' according to my proposal or they can say 'No, we want to play all the matches at neutral venue'.

If they take the first position, everything will be sorted out and we will get cracking. If they take the second position, then I am afraid we won't participate in Asia Cup. That is the current position. We are waiting for response from Mr Jay Shah and other colleagues.

Q: Does it make sense for Pakistan to stay in ACC if they don't play Asia Cup?

A: That is for Asian Cricket Council to consider. The next



turn for Asian Cricket Council presidency belongs to PCB. That's our turn. So we are very keen to stay in Asian Cricket Council. Let me go beyond that. There can't be any ACC without Pakistan. The two most important members who bring revenue to ACC are India and Pakistan. It's their matches that bring 80 percent of the broadcast rights. If Pakistan doesn't play Asia Cup, then the broadcaster, that is Star, is going to have problems.

The 45 or 46 million dollars that are supposed to come for the series (Asia Cup) is mostly going to come from these matches and the way Asia Cup is structured, Pakistan and India play two matches minimum and if they qualify for final, there is a third match.

That's why India and Pakistan are both critical to the cup and to the council. Therefore it must be mentioned that in Bahrain at last ACC meeting, I had presented the hybrid model to save the Asia Cup as India had refused to play in Pakistan, which is the host country, that's where the problem arose. I had said, one solution is I will find neutral

venue for India games.

The BCB president had then said, option of Pakistan not playing Asia Cup is ruled out. If India comes to Pakistan, the crowds will be hospitable but if India doesn't come and gives no rational reason for not coming to Pakistan, when the whole world is coming to Pakistan, then this is the solution I have in mind. We will play India at a neutral venue but rest of the countries must come and play their matches in Pakistan.
