# No Road Digging, Cuts Without Permission, Warns R&B Dept

Asks heads of departments to 'clearly mention the purpose' of road cut, execution plan & time of completion

**Srinagar:** Authorities on Saturday reiterated that no digging or road cuts will be allowed without getting a No Objection Certificate (NOC) from the Roads & Buildings (R&B) Department.

A senior R&B Department official said that they have already asked all the heads of the departments and executing agencies of the de-partment to strictly adhere to the instructions while issuing road cut permissions to various government and

private organisations. He said that an NOC from the "road owing department and the department owning the service" is mandatory.

G-20 meeting related events are scheduled to be held at SKICC on 22nd & 23rd May, 2023 and a large number of delegates from India and abroad are expected to attend. In order to avoid congestion on various routes during the meeting. following route plan/advisory is issued for general public to avoid any inconvenience.



- On 22nd May 2023, traffic movement on Boulevard Road from Nehru Park and Gupkar upto Kralsangri shall be restricted from 1030 Hrs. till 2200 Hrs.
- On 23rd May 2023, traffic movement on Boulevard Road from Nehru Park and Gupkar upto Kralsangri shall be restricted from 0800 Hrs. till 2200 Hrs.
- All such motorists intending to travel towards Nishat, Shalimar & Harwan are advised to adopt the alternate road from Dalgate, Rainawari, Hazratbal route instead of Boulevard Road axis.
- Traffic assistance points for all such vehicles shall be placed at Badyari, Nehru Park, Gupkar, Kralsangri & Nishat for ensuring smooth movement towards Nishat, Shalimar & Harwan.
- Likewise, motorists intending to travel from Harwan-Shalimar-Nishat and other adjacent areas towards Lal-Chowk are advised to travel via Foreshore- Hazratbal route instead of Nishat-Boulevard Road axis to reach their respective destinations.
- Traffic assistance points for all such vehicles shall be placed at Shalimar, Nishat, Kralsangri, Habbak Crossing, Duck Park & Habak crossing for ensuring smooth movement towards Lal
- Tourists intending to visit Mughal Gardens & other destinations are advised to follow the traffic advisory.
- Locals and Tourists from Nehru Park should use Gagribal, Buchwara road and Exit via Dalgate, likewise one way shall be followed from UNO office, CD Hospital upto Nehru Park.
- Motorists intending to travel from Gulab Bagh-Zakoora-Naseembagh-Habbak and adjacent areas should adopt Habak - Dargah- Khanyar route to reach Lal Chowk instead of Foreshore
- Motorists are advised to park their vehicles at designated parking places only and avoid parking their vehicles on roadside. Wrongly parked vehicles will be towed.

# **SMC Suspends Ward Officer For Facilitating Illegal Constructions**

Srinagar: A ward officer in charge of two wards on the Srinagar outskirts has been placed under suspension for allegedly facilitating illegal construction without approval from the competent authority.

Srinagar Municipal Corporation has said that due to the action of the said ward officer, the Corporation has incurred losses, which will be assessed.

Official sources said that after receiving a complaint that the ward officer Sajad Ahmad Panjabi in charge of Ward 16 (Soura Bachpora) and Ward 14 (Zakoora) has illegally facilitated the construction work at a particular place, not encouraging the party to seek legal permission, the civic body placed ward officer under suspension.

In order to assess the losses incurred by the Corporation due to the ward officer's action, Joint Commissioner Planning Ghulam Hasan Mir has been appointed as inquiry officer. He has been directed to furnish his report within a week.

The suspended ward officer has been attached to the office of the Chief Sanitation Officer.

Meanwhile ward officer Sheikh Ilyas of Ward 13 (Batapora) has been given additional charge of Ward 14 (Zakura) while Basharat Ahmed ward officer Nowshera (Ward 17) has been given additional charge of Ward 16 (Buchpora Soura).

# Move To Shift Capital Sparks Debate

RINAGAR - Even as the proposal to shift the summer capital of Jammu and Kashmir is yet to take off, controversy dogs the idea with debate rag-ing for and against the govern¬ment move.

Giving vent to the opposi-tion to shifting of the capital, several political parties, includ¬ing main opposition National Conference, said the massive expenditure needed for moving the secretariat and other offices could be diverted to building schools, hospitals and roads in the state.

'We need no new capital at an exorbitant expenditure of Rs 3.500 crore which could be uti-lized for the betterment of Kashmiris by constructing schools, colleges, hospitals and roads which are in a dilapidated condition across the valley." NC President Omar Abdullah told PTI.

Ridiculing the idea, another senior leader of the party Ali Mohammad Sagar said "instead of finding ways and means to mitigate the problems of the people the PDP-led coalition government is trying to squan¬der the funds for unproductive projects.' He asked the coalition gov-ernment to desist from changing the capital for "petty politi¬cal gains."

CPI(M), which supports the coalition government from out-side, opposes the idea. State Secretary of CPI(M) M Y Tarigami said "I don't think it is a very serious move yet The government complexes should be moved a little away

from the market and the beauti-ful city but not relocated in any other place. Why go there (Parihaspora) to Lalitaditya. The kings are buried there let them rest in peace. "It is wrong to assume that government wants to benefit

villagers by moving the capital city. The government has in fact done very little for the upliftment of rural areas," he said. Author of the proposal to shift the capital and Finance

Minister Muzaffar Hussain Baig said the basic objective behind a new capital was to decongest and develop Srinagar as an exclusive tourist resort 'with heritage villages and other amenities to make it among the most attractive tourist destinations on the globe. The proposal for a new capital has received the Centre's nod

which would be ready within next three years at an. estimated cost of Rs 3.500 crores, he said. Opposing the idea, Chair¬man of National Democratic Front and former MP Abdul Rashid Kabuli accused the

gov-ernment of not attending to the problems of Srinagar, a city of 15 lakh people. Shifting capital from Srinagar to Parihaspora and moving

# Once Highly Sought After, Horologists Stare At Death Of Their 'Art'

Srinagar: Once a thriving and profitable vocation, clock and watchmakers in Srinagar today are living a life of penury with some even converting their repair shops into tea stalls to make ends meet.

These horologists blame the advent of smartphones for replacing traditional watches and alarm clocks, leading to the current decline in their trade.

Mohammad Yousuf Khanday who once was considered to be an expert in the craft now sells



tea at the same shop. "Once I was a technically

equipped watchmaker. Today 1 am a chaiwala," Khanday said, adding that he was associated with the trade for nearly 30 years.

"Due to the advent of smart phones, gradually this business started to die. We were very happy and satisfied with our profession. Being technically skilled, I used to service clocks and wristwatches and sell calculators as well," Khanday added.

However, as the demand for horology started declining, the 48-year-old changed his line of activity. "For the survival of my family, I started selling tea. Fortunately, I had the shop which I converted into a tea stall.'

Mohammed Hussain continued this profession for almost five decades.

"It is my family business. My father and uncle also used to do the same. I learned the skill of the trade at a very young age from my father. I was passionate about my work," Hussain said. The watchmaker said he has

seen good days as well.

"Earlier our work used to go on very smoothly and several people used to work in this line of profession. They were quite prosperous too. We used to

be busy repairing clocks and watches of all shapes and sizes," he recalled.

However, now smartphones have replaced the traditional clocks and watches and they have all of its features like the timer and alarm, Hussain added. Back in those days, there

There's a need to look into the intersection of economy and happiness to allow for a growth that is citizen focused, sustainable and effective.

Happiness is an inherent human desire, and economists have been concentrating a lot of their research on this topic. A sub-field of economics termed "the economics of happiness" deals with the correlation between happiness and economic growth.

### What Does Happiness Mean Economically?

Although it can be challenging to define happiness, economists have made an effort to measure it using a variety of indicators, including happiness indices, subjective well-being, and life satisfaction. These measures, which are aimed at capturing people's opinions of their own well-being, can be influenced by a variety of factors, such as personal values, wealth, health, and social relationships.

When we discuss the economics of happiness, we fundamentally want to know how variables like income and employment affect people's happiness and sense of fulfilment in life. Happiness measurement is a complex task, though. It is a complicated, multifaceted idea that is susceptible to a wide range of internal and external variables.


Surveys and questionnaires that allow participants to rate their own level of life satisfaction or subjective well-being are methods economists have used to measure happiness. In these surveys, individuals are frequently asked how happy they are with their jobs, relationships, health, and other aspects of their lives. The average level of life satisfaction or well-being for a population can be calculated by adding together these responses.

The use of happiness indices, which are composite measurements that account for a variety of different variables thought to influence happiness, such as wealth, health, education, and social ties, is an additional strategy. The World Happiness Report, which evaluates nations based on a variety of characteristics including money, social support, freedom, and charity, is an illustration of a happiness index. It's important to keep in mind that these measurements do have some constraints, despite the fact that they can be insightful into how societal and economic issues affect happiness. For instance, a variety of biases and cognitive heuristics, such as the propensity to place more emphasis on negative than positive experiences, can have an impact on how people perceive their own well-being. Additionally, these measures could miss out on crucial components of happiness, including finding meaning and purpose in life, which are determined by individual values and beliefs.

Despite these drawbacks, the economics of happiness has grown in importance as a field for

The necessity of reorienting economic policy away from straightforward, conventional economic development, towards more comprehensive measurements of progress is another significant conclusion of the economics of happiness. The effects of economic policies on well-being must be considered by policymakers, who must also make sure that economic growth is equitable and sustainable

research recently. This is due in part to the fact that decision-makers have begun to realize that ensuring citizens' well-being cannot be achieved solely through economic growth. We must consider how economic policies affect people's happiness and sense of fulfilment in life in order to build a truly prosperous and sustainable society.

The creation of gross national happiness (GNH) measures is one way that policymakers

are doing this. GNH is a counterpart for the gross domestic product (GDP) that considers not just economic development but also other aspects including cultural preservation, environmental sustainability, and the promotion of well-being and happiness. Countries like Bhutan have already made GNH a national policy objective, and other nations are now beginning to consider this type of approach as well.

"The economics of happiness" is a fascinat-

ing and vital area of research that intends to comprehend the connection between economic factors and people's well-being. Even though quantifying happiness is not an easy process, economists have created a number of indices and measures that can offer important insights into this intricate and multidimensional topic. We can build a more sustainable and prosperous society for all if we consider how economic policies affect people's happiness and well-being.

### The Relation Between Happiness and Income

To a certain extent, there is a positive correlation between income and happiness, which is one of the main findings of the economics of happiness. This relationship is often termed the "Easterlin Paradox," so named after the economist Richard Easterlin who initially studied it. This paradox asserts that while money and material belongings do make people happier, the impact of income on well-being actually diminishes as income rises. While income plays an important role in determining happiness, other factors additionally have a big impact. Social ties, health, education, and personal values are a few of these. For instance, research has found that socially connected individuals typically experience greater levels of happiness than socially isolated individuals. Similarly, people who prioritize their own development and education tend to be happier and have more satisfaction with their lives.

## Policymakers' Implications

The economics of happiness has significant implications for policymakers, who are becoming increasingly conscious of the necessity to give happiness preference when making decisions. This has prompted the development of policies like the gross national happiness (GNH) initiative, which aims to evaluate and promote happiness and well-being alongside economic progress.

The necessity of reorienting economic policy away from straightforward, conventional economic development, towards more comprehensive measurements of progress is another significant conclusion of the economics of happiness. The effects of economic policies on well-being must be considered by policymakers, who must also make sure that economic growth is equitable and sustainable.

The relationship between economic growth and well-being has become more widely recognized owing to the economics of happiness. Despite the fact that income is a key indicator of happiness, other elements including social ties, health, and personal values are as crucial. In making decisions, those making decisions must prioritize people's well-being and make sure that economic policies support fair and sustainable growth. We can make everyone in society happier and more successful by doing so.

# What Is The Political Agenda Of Artificial Intelligence?

he hand mill gives you society with the feudal lord; the steam mill society with the industrial capitalist," Karl Marx once said. And he was right. We have seen over and over again throughout history how technological inventions determine the dominant mode of production and with it the type of political authority present in a society.

So what will artificial intelligence give us? Who will capitalise on this new technology, which is not only becoming a dominant productive force in our societies (just like the hand mill and the steam mill once were) but, as we keep reading in the news, also appears to be "fast escaping our control"?

Could AI take on a life of its own, like so many seem to believe it will, and single-handedly decide the course of our history? Or will it end up as yet another technological invention that serves a particular agenda and benefits a certain subset of humans?

Recently, examples of hyperrealistic, AI-generated content, such as an "interview" with former Formula One world champion Michael Schumacher, who has not been able to talk to the press since a devastating ski accident in 2013; "photographs" showing former President Donald Trump being arrested in New York; and seemingly authentic student essays "written" by OpenAI's famous chatbot ChatGPT have raised serious concerns among intellectuals, politicians and academics about the dangers this new technology may pose to our societies.

In March, such concerns led Apple co-founder Steve Wozniak, AI heavyweight Yoshua Bengio and Tesla/Twitter CEO Elon Musk among many others to sign an open letter accusing AI labs of being "locked in an out-of-control race to develop and deploy ever more powerful digital minds that no one – not even their creators – can understand, predict, or reliably control" and calling on AI developers to pause their work. More recently, Geofrey Hinton – known as one of the three "godfathers of AI" quit Google "to speak freely about the dangers of AI" and said he, at least in part, regrets his contributions to the field.

We accept that AI – like all era-defining technology – comes with considerable downsides and dangers, but contrary to Wozniak, Bengio, Hinton

and others, we do not believe that it could determine the course of history on its own, without any input or guidance from humanity. We do not share such concerns because we know that, just like it is the case with all our other technological devices and systems, our political, social and cultural agendas are also built into AI technologies. As philosopher Donna Haraway explained, "Technology is not neutral. We're inside of what we make, and it's inside of us."

Before we further explain why we are not scared of a so-called AI takeover, we must define and explain what AI – as what we are dealing with now – actually is. This is a challenging task, not only because of the complexity of the product at hand but also because of the media's mythologisation of AI.

What is being insistently communicated to the public today is that the conscious machine is (almost) here, that our everyday world will soon resemble the ones depicted in movies like 2001: A Space Odyssey, Blade Runner and The Matrix.

This is a false narrative. While we are undoubtedly building ever more capable computers and calculators, there is no indication that we have created – or are anywhere close to creating – a digital mind that can actually "think".

Noam Chomsky recently argued (alongside Ian Roberts and Jeffrey Watumull) in a New York Times article that "we know from the science of linguistics and the philosophy of knowledge that [machine learning programmes like ChatGPT] differ profoundly from how humans reason and use language". Despite its amazingly convincing answers to a variety of questions from humans, ChatGPT is "a lumbering statistical engine for pattern matching, gorging on hundreds of terabytes of data and extrapolating the most likely conversational response or most probable answer to a scientific question". Mimicking German philosopher Martin Heidegger (and risking reigniting the age-old battle between continental and analytical philosophers), we might say, "AI doesn't think. It simply calculates.

Federico Faggin, the inventor of the first commercial microprocessor, the mythical Intel 4004, explained this clearly in his 2022 book Irriducibile (Irreducible): "There is a clear distinction between symbolic machine 'knowledge' ... and human se-

mantic knowledge. The former is objective information that can be copied and shared; the latter is a subjective and private experience that occurs in the intimacy of the conscious being."

Interpreting the latest theories of Quantum Physics, Faggin appears to have produced a philosophical conclusion that fits curiously well within ancient Neoplatonism – a feat that may ensure that he is forever considered a heretic in scientific circles despite his incredible achievements as an inventor.

But what does all this mean for our future? If our super-intelligent Centaur Chiron cannot actually "think" (and therefore emerge as an independent force that can determine the course of human history), exactly who will it benefit and give political authority to? In other words, what values will its decisions rely on?

Chomsky and his colleagues asked a similar question to ChatGPT.

"As an AI, I do not have moral beliefs or the ability to make moral judgments, so I cannot be considered immoral or moral," the chatbot told them. "My lack of moral beliefs is simply a result of my nature as a machine learning model."

Where have we heard of this position before? Is it not eerily similar to the ethically neutral vi-

sion of hardcore liberalism? Liberalism aspires to c

Liberalism aspires to confine in the private individual sphere all religious, civil and political values that proved so dangerous and destructive in the 16th and 17th centuries. It wants all aspects of society to be regulated by a particular – and in a way mysterious – form of rationality: the market.

AI appears to be promoting the very same brand of mysterious rationality. The truth is, it is emerging as the next global "big business" innovation that will steal jobs from humans – making labourers, doctors, barristers, journalists and many others redundant. The new bots' moral values are identical to the market's. It is difficult to imagine all the possible developments now, but a scary scenario is emerging.

David Krueger, assistant professor in machine learning at the University of Cambridge, commented recently in New Scientist: "Essentially every AI researcher (myself included) has received funding from big tech. At some point, society may stop believing reassurances from people with such strong conflicts of interest and conclude, as I have, that their dismissal [of warnings about AI] betrays wishful thinking rather than good counterarguments."

If society stands up to AI and its promoters, it could prove Marx wrong and prevent the leading technological development of the current era from determining who holds political authority.

But for now, AI appears to be here to stay. And its political agenda is fully synchronised with that of free market capitalism, the principal (undeclared) goal and purpose of which is to tear apart any form of social solidarity and community.

The danger of AI is not that it is an impossible-to-control digital intelligence that could destroy our sense of self and truth through the "fake" images, essays, news and histories it generates. The danger is that this undeniably monumental invention appears to be basing all its decisions and actions on the same destructive and dangerous values that drive predatory capitalism.

# **Zelensky Meets With G7 Leaders As Ukraine Wins Access To F-16s**

**HIROSHIMA:** President Volodymyr Zelensky made a landmark visit to Hiroshima for talks with G7 leaders Saturday, after securing longsought access to advanced US fighter jets for Ukraine's war

He arrived significantly buoyed by what he called a "historic" White House decision to allow Ukraine access to F-16 jets, among the most sophisticated materiel yet supplied by the West.

But it was Zelensky's arrival, and debate about the future of the war in Ukraine, that has dominated the summit.

# **Air Force Grounds Entire** MiG-21 Jet Fleet For Checks **After Rajasthan Crash**

**NEW DELHI:** The Indian Air Force (IAF) has grounded the entire fleet of MiG-21 fighter aircraft till the checks are carried out and investigations into the reasons behind the crash over Rajasthan earlier this month are ascertained

Three people lost their lives in the crash when a MiG-21 Bison aircraft airborne from the Suratgarh air base crashed over Hanumangarh in a village on May 8. "The MiG-21 fleet has been grounded till the investigations are carried out and reasons for the crash are ascertained," senior defence officials told ANI here.

The MiG-21 aircraft variants started getting inducted into the Indian Air Force over five decades and are on the verge of being phased out.

There are only three MiG-21 squadrons operating in the IAF

and all of them are going to be phased out by the early part of 2025, they said. The fighter jet that crashed

over Rajasthan was on a routine training sortie when it met with an accident. The pilot suffered minor injuries after which an inquiry had been launched to probe the exact cause of the crash.

The IAF has 31 combat aircraft squadrons including three of the MiG-21 Bison variant.

The MIG-21 was inducted into the IAF in the 1960s and 800 variants of the fighter have been in service.

The crash rate of the MiG-21 has been a cause of concern in recent times as many of them have met with accidents. The IAF is also looking at induction of the indigenous aircraft including the LCA Mark 1A and LCA Mark 2 along with the Advanced Medium Combat Aircraft



# Iran Asks Kabul to Supply Its **Share Of Water In A Month**

Asenior Iranian official has Aurged Afghanistan's Taliban government to commit to a major water treaty signed between the two countries nearly half a century ago and supply Iran with its share of water from the Hirmand River, also known as Helmand, within a month.

Iran's special representative for Afghanistan, Hassan Kazemi Qomi, made the remarks on Friday, reiterating that the Taliban must be held accountable for their refusal to deliver Iran's water rights if it is proven that there is enough water in dams built on the Hirmand River.

ban officials are well aware that if they want to establish a stable government in the country, they must have constructive relations with their neighbors, including Iran.

The Helmand River, the longest watercourse in Afghanistan, rises in the Hindu Kush Mountains west of Kabul and flows in an arc southwest until it empties out into the Hamoun wetlands, located in Iran's Sistan and Baluchestan Province.

Qomi further noted that nearly two billion cubic meters of water flew to Godzareh Lake last year due to the dam's condition contrary to what Taliban officials have claimed about the shortage of water due to drought and technical

He added that Taliban technical officials say that over time, the dam's reservoir is filled with 60 percent of mud, arguing that this means the capacity of this dam is about 1.7 billion cubic meters, and if this water were to flow. Iran could have its share of water.

"Now the claim is that there is 60% mud. This should be seen by our technical experts," he stressed.

Qomi also reminded the ruling dministration in Kabul that Irai has provided assistance to the people of Afghanistan more than any other country over the past decades.

Iran and Afghanistan have been locked in a long-running dispute over shared water resources. At the heart of the dispute is the Helmand River, which flows 700 miles (1,126 kilometers) south before flowing into Hamoun wetlands, located in Sistan and Baluchestan province.

# **Supreme Court Relief For Man Facing Death Penalty In Rape And Murder Case**

**NEW DELHI:** The Supreme Court has quashed the conviction and death penalty awarded to a man for the alleged rape and murder of a six-year-old girl in 2010, saying "multitudinous lapses" in the investigation have compromised the quest to punish the doer of such a barbaric act in absolute peril.

Referring to the manner in which probe into the case was undertaken by the Maharashtra Police, the top court said numerous lapses blot the entire map and there were "yawning gaps" in the chain of circumstances rendering it far from being established.

A bench headed by Justice B R Gavai delivered its verdict on the appeals filed by the accused against the October 2015 judgement of the Bombay High Court which had affirmed the conviction and death sentence awarded to him by a trial court.

While allowing the appeals, the top court quashed the verdict convicting the

The bench, also comprising justices Vikram Nath and Sanjay Karol, said it was true that the unfortunate incident did take place and at a tender age of six, a life for which much was in store in the future was terrifyingly destroyed and extinguished.

It said the parents of the victim have suffered an unfathomable loss, a wound for which there is no remedy.

"Despite such painful realities being part of this case, we cannot hold within law, the prosecution to have undergone all necessary lengths and efforts to take the steps necessary for driving home the guilt of the appellant and that of none else in the crime," the bench said in its judgement delivered on Friday. There are, in fact, yawn-

ing gaps in the chain of circumstances rendering it far from being establishedpointing to the guilt of the appellant," it said.

The top court noted that an FIR was lodged in June 2010 at Thane in Maharashtra and the trial court, in November 2014, had convicted the accused and imposed capital punishment for the offence of murder.

It said the courts below concurrently found the prosecution to have established the case beyond reasonable doubt that the accused, after sexually assaulting the minor girl, had put her to death and thrown the body in a drain to destroy the evidence.

The top court noted that it was a case of circumstantial evidence, as none has witnessed the crime for which the appellant stands charged.

# **Now Money Laundering Case Against Gujarat Conman**

NEW DELHI: The Enforcement Directorate on Saturday said it has conducted searches at a dozen locations in Gujarat against alleged conman Kiran Patel who is accused of cheating people by impersonating as a PMO official while taking the Jammu and Kashmir administration on a ride.

The searches, carried out on May 19. resulted in seizure of documents related to immovable properties apart from recovery of "highly incriminating" material, the agency said in a statement.

"Further investigation in respect of his activities in J-K and other places is in progress," it said.

A total of 12 locations in Ahmedabad, Gandhinagar, Morbi and Mehsana in Gujarat in the investigation relating to Kiranbhai Jagdishbhai Patel and his associates Jay Savjibhai Sitapara, Hardik Kishorebhai Chandrana, Vitthalbhai Motibhai Patel, Amit Pandya and Piyush Kantibhai Vasita were searched.

The ED alleged Patel, with criminal intention, employed high degree of forged means, impersonated himself as senior government official serving in PMO as 'Dr Kiran Patel, Additional Director, PMO (Strategies and Campaigns)'.



By resorting to cheating, forgery and impersonation, Patel duped gullible people and also intentionally induced people to do and also to omit to do activities, under a well-knit plan for securing monetary as well as material benefits, it said.

The money laundering case stems from an FIR of the Jammu and Kashmir Police.

# **HC Stays Official Notification** For Conduct Of Gurdwara **Prabandhak Board Elections Across Jammu**

JAMMU: The Jammu and Kashmir High Court has stayed a notification issued by the divisional commissioner, Jammu, early this month for conduct of elections to the Gurdwara Prabandhak Board (GPB) across the division.

Hearing a petition filed by Satinder Singh on Friday, high court judge Justice Wasim Sadiq Nargal said the Sikh Gurdwaras and Religious Endowment Act and the rules framed thereunder provide that the Board is a single constituent body and its members -- 15 in all -- can be elected by a single process both at Kashmir and Jammu divisions simultaneously and not otherwise.

"The divisional commissioner, Jammu, has issued the notification (on May 9) illegally by directing conduct of the elections in Jammu division only Subject to objections and till next date of hearing before the bench, the operation of the impugned notification shall remain stayed," the judge said, listing the case for next hearing on May 26.

Singh had earlier moved a petition challenging the process of conduct of the elections to the Gurdwara Prabandhak Board issued in terms of notification on January 28.

"It has been brought to the

notice of the court by the applicant, appearing in person, that the said process of conduct of the elections to the aforementioned Board was also challenged in Srinagar Wing of this Court in a writ petition in which a co-ordinate bench of this court (on February 22) has shown indulgence and granted status quo with regard to the holding of the elections to the board although in a different

"The applicant appearing in person has further brought to the notice of the Court that after passing of the status quo order by the Srinagar Wing of this Court in the aforesaid writ petition, the process of election to the Board so far as it pertains to the Kashmir/Jammu Division in terms of Notifications (January 28) by the concerned Returning Officers of Jammu and Kashmir Division - the Divisional Commissioner, Jammu and the Divisional Commissioner, Kashmir was deferred," the court said in its five-page order.

Further, the court was informed that the Board consists of 15 members, eight from Jammu division and seven from Kashmir division, which clearly shows beyond any shadow of doubt that the members are to be elected for both the divisions and the election process has to be a composite election

# **MeT Predicts Widespread** Rain From May 22-25

SRINAGAR: Amid forecast for mainly dry weather for now and widespread rains from May 23 to 25, night temperature recorded a rise but hovered below normal in Jammu and Kashmir on Saturday.

A meteorological department official here said that Srinagar recorded a low of 9.7°C against 9.2°C on the previous night and it was 1.7°C below normal for the summer capital.

Qazigund, he said, recorded a low of 7.6°C against 7.0°C on the previous night and it was below normal by 2.6°C for the gateway town of Kashmir.

Pahalgam, he said, recorded a low of 3.6°C against 2.7°C on the previous night and it was 2.3°C below normal for the

famous tourist resort in south Kashmir's Anantnag district.

In Kupwara town, he said, the mercury settled at 8.3°C against 6.7°C on the previous night and it was 1.8°C below normal for the north Kashmir

Kokernag recorded a low of 8.3°C against 7.2°C on the previous night and it was 1.7°C below normal for the place, the officials said.

Gulmarg recorded a low of 4.8°C against 3.0°C on previous night and it was below normal by 2.0°C for the world famous skiing resort in north Kashmir's Baramulla district, he said.

Jammu recorded a low of 22.6°C against 21.0°C on the previous night and it was 1.5°C below normal for J&K's winter

capital, he said.

Banihal recorded a low of 9.3°C (below normal by 2.4°C), Batote 13.0°C (1.1°C below normal), Katra 18.6°C (2.3°C below normal) and Bhaderwah 9.6°C (below normal by 0.8°C). Ladakh's Leh and Kargil recorded a low of 1.6°C and 6.2°C respectively, he said.

Regarding the forecast, he said, till May 22 weather is likely to be mainly clear. However, he said, a brief spell of rain/thunderstorm may occur at a few places towards late afternoon and evening.

From May 23 to 25, the weather department forecast widespread light to moderate rain/thunder/lightning with possibility of hailstorm and gusty winds at few places.



# **Vaishno Devi Shrine Gears Up For Heavy Pilgrim Influx**

JAMMU: Anticipating an increase in the footfall of devotees with the onset of summer holidays in many states across the country, authorities on Saturday called for extra measures for the safety of the pilgrims visiting the Mata Vaishno Devi shrine atop Trikuta hills in Reasi district of Jammu and Kashmir.

Chief Executive Officer of Shri Mata Vaishno Devi Shrine Board (SMVDSB) Anshul Garg exhorted that security forces and other personnel deployed at all entry points should remain vigilant so that no pilgrim without frisking and registration enters the track for the pilgrimage. He also stressed on verifica-

tion and census of pony porters, besides any suspicious element on the track.

More than 33 lakh pilgrims from January 1 to May 15 this year, marking an increase of nearly four lakhs compared to the same period last year, officials said. Garg was chairing a meet-

ing with security agencies for a comprehensive security and operational preparedness in anticipation of the burgeoning of devotees over the next couple of months. The meeting discussed fool-

# **Sebi Proposes To Cut Down IPO Listing Timeline To 3 Days From 6 Days**

**NEW DELHI:** Capital markets regulator Sebi on Saturday proposed to reduce the time taken for the listing of shares on stock exchanges after the closure of initial public offerings (IPOs) to three days from six days at present.

The proposed reduction in timelines for listing and trading of shares will benefit both issuers as well as investors.

"Issuers will have faster access to the capital raised thereby enhancing the ease of doing business and the investors will have opportunity for having early credit and liquidity of their investment", Sebi said in

its consultation paper. The markets regulator, in November 2018, introduced Unified Payment Interface (UPI) as an additional payment mechanism with Application Supported by Blocked Amount (ASBA) for retail investors and prescribed the timelines for listing within six days of closure of issue (T+6). 'T' is the day of closure of the issue.

Over the last few years, Sebi has ensured that a series of sys-



temic enhancements have been undertaken across all the key stakeholders of the IPO ecosystem to streamline the activities involved in the processing of public issues which will pave the way to reduce the listing timelines from T+6 to T+3.

In its consultation paper, Sebi has suggested the reduction of the time period from the date of issue closure to the date of listing of shares through public issues from the existing six days to three days (T+3).

The Securities and Exchange Board of India (Sebi) has sought comments from the public till June 3 on the proposal.

This comes after Sebi has done extensive back-testing and simulations by all stakeholders including stock exchanges, sponsor banks, NPCI, depositories and registrars in respect of various key activities involved in the public issue process.

# Withdrawal Of Rs 2,000 Note Will Have No Impact On **Economy: Ex-Finance Secy**

**NEW DELHI:** Withdrawal of Rs 2,000 currency notes is a 'nonevent' and will have zero impact on the economy and monetary policy, former finance secretary Subhash Chandra Garg said on Saturday.

The higher denomination currency note of Rs 2,000, he said, was pressed into service at the time of demonetisation in 2016 for 'accidental reasons' to meet the temporary currency shortage.

With rapid growth of digital payments over the last five-six years, Garg said withdrawal of Rs 2,000 currency notes, which is actually a replacement by other denominations, will not affect total currency in circulation and therefore will have no monetary

"Neither will it affect the operation of India's economic and financial system. There is going to be zero impact on GDP growth or public welfare," he told PTI.

In a surprise move, the Reserve Bank on Friday announced withdrawal of Rs 2,000 currency notes from circulation but gave public time till September 30 to either deposit such notes in accounts or exchange them at banks.

It is quite easy to expect almost all the Rs 2,000 currency notes in circulation to come back to RBI and there is unlikely to be any inconvenience or loss to anyone because these notes form a small part of the currency in circulation and not widely used for day-to-

day transactions, he said. Clarifying that the withdrawal of currency notes by RBI is not demonetisation, he said, it is the government which has the authority



Rs 2,000 currency notes will continue to remain perfect legal tender therefore, he said, adding, RBI's measures are largely an attempt to nudge people holding these notes to get the same exchanged for other currency notes

Garg, who was Economic Affairs Secretary and in-charge of coin and currency division during remonetisation days, said Rs 2,000 notes were introduced not as a well thought out measure but something which was only available readily to latch on.

The government had perhaps approved printing of Rs 2,000 currency notes a few months before demonetisation to introduce a higher denomination note, he said. The fate of Rs 2,000 currency note was sealed even before it was introduced and it had to make its way out as soon as possible, he added. Garg said the process of reducing the circulation of Rs 2.000 notes for its eventual phase-out started soon after demonetisation.

The total value of Rs 2,000 currency notes was about Rs 7 lakh crore when an in-principle decision was taken in July-August 2017 to not print any more Rs 2,000 notes, he said, adding, a small quantity of such notes were printed in March-April 2018 to

# At G7 Summit, PM Modi **Calls For Building An Inclusive Food System**

HIROSHIMA: Prime Minister Narendra Modi on Saturday called for building an inclusive food system that focuses on the world's most vulnerable people and pitched for checking the "expansionist mentality" occupying the fertiliser resources.

In an address at a session of the G7 summit in Hiroshima, Modi also strongly batted for the democratisation of technology, saying it can become a bridge between development and democracy.

There is a need to focus on the holistic use of natural resources and the development model inspired by consumerism has to be changed, Modi said.

The prime minister said efforts should be made to build an inclusive food system that focuses on the world's most vulnerable people, especially "marginal farmers should be our priority"

'The global fertiliser supply chains have to be strengthened. Political obstacles in this have to be removed. And the expansionist mentality that is occupying the fertilizer resources has to be stopped. This should be the purpose of our coopera-

tion," he said. The prime minister, however, did not name any country.

Modi also emphasised on preventing wastage of food saying it should be "our collective responsibility". "It is essential for sustainable global food security," he said.

The group of seven (G7), comprising the US, France, the UK, İtaly, Germany, Canada and Japan, represent the world's richest democracies. Under its G7 presidency, Japan invited India and seven other countries to the summit.

Modi also underlined the need for focusing on develop-



ment, technology and democracy together.

"It is necessary to democratise technology. Technology can become a bridge between development and democracy,"

The prime minister also noted that the model of development should pave the way for welfare and not become a hindrance to the progress of developing

"I am confident that our discussions today will be useful in creating an important link between the agenda of the G20 and the G7. And will be successful in prioritising the hopes and expectations of the Global South," he said.

The prime minister also highlighted the importance of natural farming.

"We can create a new model of natural farming as an alternative to fertilisers around the world. I believe that we should take the benefit of digital technology to every farmer in the world," he said.

Modi said that there is a need to separate organic food from 'fashion statement and commerce" and instead, it should be linked to nutrition and health.

He also spoke about the advantages of millets.

"Millets simultaneously address the challenges of nutrition, climate change, water conservation and food security. Awareness should be created on

Among the newly joined members, the highest enrolment is registered in the age group of 18-21 years with 2.35 lakh mem-

of the members joining the organised sector workforce of the country are first-time job seekers.

With batting maestro Virat Kohli back at his absolute best and skipper Faf du Plessis leading from the front with 600-plus runs this season, RCB will hope their dazzling opening duo fires in this must-win game for them.

# **Decision By Khap Panchayat Could Hurt Nation: Vinesh**

**NEW DELHI:** The protesting wrestlers on Saturday warned that a "big decision", which might "not be in the interest of the country", could be taken on Sunday to protest the "inaction" against Wrestling Federation of India (WFI) president Brij Bhushan Sharan Singh for his alleged sexual harassment of women grapplers.

The wrestlers have set May 21 as the deadline for the khap mahapanchayat to decide on taking the agitation forward.

The wrestlers have been protesting at Jantar Mantar since April 23 demanding the arrest of Brij Bhushan, who they have accused of having sexually harassed seven female wrestlers, including a minor.

Asian Games gold medallist Vinesh Phogat said the decision of the khaps could hurt the country just like the farmers' agitation, which lasted nearly 13 months.

The decision our elders take (on Sunday) could be big one, one that might not be in the interest of the country. It could hurt the nation," said Vinesh at a press conference at Jantar Mantar.

She said that it wasn't an easy fight and that the wrestlers too had suffered a lot in terms of missing out on training and competition.

"We too have suffered a lot. An issue that could have been solved in a minute has taken a month... the farmers' agitation lasted 13 months and definitely hurt the nation, so if there is another agitation (like that), definitely the country will suffer," warned Vinesh.

Olympics bronze medallist Bajrang Punia said the marches to create awareness about their plight would continue with a candle-light march planned at the India Gate on May 23.

"We will organise a candlelight march at 4:00 pm at India Gate on May 23," said Bajrang.

"Be it mosque, temple, gurdwara, church we will take our message for justice everywhere," added Vinesh.

Asked if the wrestlers had missed an opportunity by not marching to the Ferozeshah Kotla stadium where the IPL match between the MS Dhoniled Chennai Super Kings and Delhi Capitals is taking place, Vinesh said, "We are doing our best and will continue to do so (to create awareness).

barrass and never looked like belonging to this level.

Even the crowd was supporting the visitors as it continued to chant 'Dhoni Dhoni' through out the game and even cheered when Delhi lost wickets.

Chahar (3/22) was the standout bowler for the visitors while Maheesh Theekshana (2/23) picked up two wickets in the last over With the win, CSK moved up to 17 points and become the second team to move to the qualifiers. It was maybe fitting that a goal by Casemiro moved United so close to that top-four place, with the Brazil midfielder playing an influential role since joining from Real Madrid last year and running the game at Vitality Stadium.

# **City Loss & Brazil Opening** won four European Cups after win-

BARCELONA: Carlo Ancelotti says he will finish his contract with Real Madrid despite their defeat in the Champions League semifinals and with rumors swirling that Brazil would love the Italian to become its next coach.

"I have a contract until June 2024 and the club has already guaranteed I will see out my contract. Everyone knows that's exactly what I want to do," Ancelotti said on Saturday in his first news conference since he spoke immediately after Manchester City routed his Madrid 4-0 this week to reach the final 5-1 on aggregate.

That stinging defeat fueled speculation that perhaps Ancelotti's second stint at Madrid was near its end. Madrid has won the Copa del Rey, the Club World Cup, and the UEFA Super Cup this season, but it lost the Spanish league title to Barcelona and failed to defend its Champions League crown.

Meanwhile, Brazil is apparently ready to embrace the 63-year-old Ancelotti, the only coach to have ning it twice with AC Milan and

Ancelotti's contract with Madrid lasts until the end of next season but speculation about his potential departure increased after Brazil said it was interested in hiring him to replace Tite. Brazil has been without a manager since the end of the World Cup, and the Brazilian Football Confederation hinted it was willing to wait until the end of the European season to hire its next coach.

Madrid president Florentino Pérez also has no trouble firing coaches who don't reach the 14time European champion's incredibly demanding standard for success. Pérez cut Ancelotti's first stint short in 2015, just a year after he led Madrid to Champions League title No. 10. Ancelotti said on Friday he has received renewed backing from Pérez.

'We spoke yesterday, as we do most weeks. We had a meeting, assessed the match and he showed me his affection and support," the coach said. "We also spoke about

# CBI questions TMC leader Abhishek for more than 9 hours over school jobs scam

**Kolkata:** CBI officers questioned TMC leader Abhishek Banerjee, who appeared before them Saturday as part of the agency's probe into the school jobs scam, for more than 9 hours before letting the young politician off.

ting the young politician off.

Banerjee told newspersons keeping vigil outside the CBI's office at Nizam Palace here, that the questioning was a waste of time for both him and the investigative agency's officers, but that he "cooperated in all that was asked".

"I was questioned for 9 anda-half hours by CBI Questioning was a waste of time for them (CBI officers) as well as for me," said Banerjee after emerging from Nizam Palace.

He claimed the real reason why he was called in was because, he had refused to be a "pet dog of Delhi's bosses" and that is why he has been "targeted".

He also alleged that while TMC leaders who were unwilling to bend were being harassed, BJP leaders who had been involved in various cases were allowed to go scot-free.

"CBI summoned me on the



basis of the letter of Kuntal Ghosh, then why were those politicians Sudipto Sen named in his letter to CBI in the Saradha scam case not summoned?" Abhishek questioned.

Sen was the kingpin of the Saradha chit fund scam, which rocked the state some years

"A person was caught on camera taking bribes, but the CBI never summoned him as he has joined the BJP," he alleged.

Banerjee's name cropped up

in a complaint filed by Kuntal Ghosh, a local businessman and an accused in the school jobs scam, where he alleged that central investigating agencies were pressuring him to name Abhishek Banerjee in the case.

The West Bengal Chief Minister Mamata Banerjee's nephew, entered the CBI office at 10.58 am and came out at around 8.40 pm,

"I don't blame them (CBI officers), as they are acting on orders from the BJP. However, such harassment will not deter me from continuing my mass outreach campaign or put an end to our political battle with the BJP," he said

Reacting to the questioning of the MP and the accusations that the saffron party had a hand in it, the BJP state spokesperson Samik Bhattacharya said, "The party has nothing to do with the CBI probe. If the TMC leaders have nothing to hide, why are they so bothered about being summoned and making such allegations?".

"I dare the CBI to arrest me if they have any proof of corruption against me. They have been probing many cases in Bengal for the last several years. They should arrest me if they have any proof against me," Abhishek said.

The two-time TMC MP from Diamond Harbour has been questioned by the Enforcement Directorate (ED) twice in the coal pilferage case in the agency's office in the national capital in 2021 and also in Kolkata in

CBI officers are believed to have asked the TMC leader on

Saturday why Kuntal Ghosh has alleged that he was being pressured to name him, according to

Abhishek is believed to have stated that he has no knowledge of the reasons behind Ghosh's statement.

A senior CBI officer told PTI that the TMC leader, was questioned in three shifts.

As her nephew was being questioned by the CBI, the chief minister tweeted that the centre's "agency-raj" has made her task of running the state challenging.

"The agency-raj of an authoritarian government at the centre makes our task challenging, but millions (all) over the country are with us in our march," Banerjee said on Twitter.

Before driving to the probe agency's offices, the TMC leader wrote a letter to the CBI informing it of his decision to move the Supreme Court challenging the High Court order which allows investigative agencies CBI and ED to question him.

"At the very onset, I state that I am rather shocked to find that

the notice under reference was served upon me ... providing me less than a day's time to comply," he wrote.

Stating that he was in the midst of a two-month-long state-wide yatra to connect with the people of West Bengal, he said that while he wished to cooperate with the agencies and hence was abiding with the summons, it should be noted that he had "preferred a Special Leave Petition before the Hon'ble Supreme Court of India, thereby challenging the order dated 18.05.2023 (passed by

Calcutta High Court)".

Earlier in the day, the Enforcement Directorate conducted a raid at the residence of Sujay Krishna Bhadra, considered to be close to TMC top brass, in connection with its probe into the school jobs scam, an official of the central agency said.

The official said the raid which was still on, was carried out at the Behala house of 'Kalighat er Kaku' (Kalighat's uncle) as he is popularly known.

On March 15, Bhadr

appeared before the CBI for his alleged involvement in illegal appointments made in different state-run and state-aided schools in West Bengal.

While the Central Bureau of Investigation is probing the criminal aspect of the scam, the ED is looking into the money trail involved in the alleged irregularities in school recruitment.

Abhishek Banerjee, who was on the campaign trail in Bankura in western Bengal, had rushed back to Kolkata Friday night to answer the summons sent by the central investigative agency.

The investigative agency's summons came within 24 hours of the Calcutta High Court dismissing on Thursday, a petition filed by Banerjee seeking recall of a previous court order, which said that investigative agencies such as CBI and ED could interrogate him in the teacher recruitment scam.

An attempt on Friday to get a division bench and, after that, the chief justice of Calcutta High Court to hear his revision plea did not yield results.

As per the 2022 circular, the road cut permission shall be issued by the competent authority only to alter the realisation of the deposit money as restoration charges from the intending department/agency, after following the due procedure.

The circular states that the road cut shall be executed by the intending agencies strictly as per the permission, with due care to the public and road safety, under the guidance of the concerned R&B Division.

Referring to the 2022 circular, the official said that any deviation in respect of the road or period shall warrant action against the intending agency under the law, including confiscation of machinery and equipment. KNO

The official said the investigations so far have shown that cadres and workers of these outfits are involved in collection and distribution of sticky bombs, magnetic bombs, IEDs, funds, drugs and weapons and ammunition, as well as in spreading activities relating to militancy, violence and subversion in Jammu and Kashmir.

Highlighting the **lack** of certain healthcare facilities due to a shortage of staff and equipment, the officials said the jail authorities had to shift the ailing inmates to government hospitals for dental and eye treatment.

The medical officer informed Justice Tashi that out of the four sanctioned posts, three medical officers are available round the clock,

whereas, one post was lying vacant.

She also informed that an X-Ray technician is posted in the jail, whereas, no X-Ray machine was installed, the official said.

She said the dental setup was established but no dental surgeon is posted and there is no facility for eye checkups as well. So the jail inmates are referred to a dental hospital and government medical college for dental and eye treatment.

The official said Justice Rabstan inspected the barracks, dining and kitchen area, e-mulakat centre, video conferencing facility, 10 bedded hospital, vocational centres, Subscriber Trunk Dialling (STD) facility and mini stadium.

"All the inmates of the jail during interaction admitted that they are being served proper diet and are being represented in their respective cases by the lawyers either engaged by them or provided by Legal Services Authority," the official said.

Justice Rabstan also visited the newly installed in-house bakery in the jail which as per the superintendent would be made operational very soon, the official said.

During a visit to the library, Justice Rabstan was introduced to the two teachers deputed by the education department who informed him that 25 jail inmates were appearing in graduation course exams through distance mode and 87 were undergoing certificate courses.

The Jail Superintendent also briefed the team about security arrangements and said the jail is equipped with surveillance cameras and there is complete restriction on mobile networks within the jail premises.

Subsequently, a case (FIR No. 55 of 2022) was registered for commission of offences under section 8/22-29 NDPS Act and investigation was started in the matter.

Opposing their separate bail applications, the prosecution said that the accused are involved in commission of "heinous offences" for which they cannot claim bail as a matter of right. "The quantity of the seized drug falls within the definition of commercial quantity, as such the applications are hit by the provisions of Section 37 of NDPS Act," the prosecution said while opposing their pleas.

"The total weight of the contraband drug seized in this case comes at 289.52 grams. Whereas, in terms of the notification No. SO 1726 (E) dated 26.04.2018 the commercial quantity prescribed for Tramadol, which is a psychotropic substance, is 250 mgs and above," Principal Sessions Judge, Srinagar, Jawad Ahmad said. "Thus, the rigor of Section 37 of the NDPS Act is attracted in the present bail matters," the court said, adding, "Therefore, in terms of Section 37 of NDPS Act, bail can be granted in this case only if there are reasonable grounds available to believe that the accused/applicants are not guilty of the offences for which they are seeking bail and they are not likely to commit any offence while on bail." Subsequently the court rejected the bail pleas.

# **Assam's New Dress Code For State-Run School Teachers**

uwahati: The Assam government on Saturday issued a notification bringing a dress code for teachers in all state-run schools in the state and has banned jeans and leggings, officials said.

The Department of School Education of the state government has asked both male and female teachers not to wear T-shirts, jeans, leggings etc in schools.

A notification issued by the Department of School Education said that a teacher is expected to be an example of all sorts of decency especially while discharging their duties, hence it has become necessary to follow a dress code.

"It has come to the notice of the undersigned that some teachers of educational institutions are found in the habit of wearing the dress of their choice which sometimes does not appear to be acceptable by the public at large. Since a teacher is expected to be an example of all sorts of decency especially while discharging their duties, it has become necessary to follow a dress code that should reflect a sense of decorum, decency, professionalism and seriousness of purpose at the workplace," the notification said.

The department also directed the teachers that both male and female teachers should be dressed up in clean, modest and decent clothes in sober colours, which should not look flashy. Casual and party apparel should be strictly avoided.

"In view of the above, the Government in the Department of School Education is hereby pleased to prescribe the following dress code for teachers of all educational institutions. Male teachers should attend their duties in appropriate formal attire only (formal shirtpant and not casual attire such as T-shirt, jeans etc.), Female teachers should attend their duties in decent Salwar Suit/Saree/Mekhela-Chador and not Casual Attire such as T-Shirt, Jeans, Leggings etc," said in the notification issued by Narayan Konwar, Secretary of Department of School Education.

It further said that the above order shall be complied with scrupulously by all concerned and any deviation from this may invite disciplinary action as per rules.

Reacting to this, Assam Education Minister Dr Ranoj Pegu said that the Assam government is going to introduce a school rule book for all government schools which is having broader things about how the school is to be managed, and how the classes are to be conducted.



# Saudi Naval Cadets Take Part In First Joint Exercise With Indian Navy

NEW DELHI: Cadets from the Royal Saudi Naval Forces have arrived in India to take part in three weeks of training with their counterparts from the Indian Navy, the first such collaboration between the two nations.

The Saudi contingent comprises 55 trainees and five instructional staff from the King Fahd Naval Academy. They arrived this week at a naval base in Kochi, in Kerala

state on the southwestern coast of India, the Southern Naval Command said on Thursday.

The planned 24-day exercise was "a major stride toward mutual cooperation" between the Indian Navy and Royal Saudi Naval Forces, the command said in a series of tweets.

"On arrival, a warm welcome was accorded to the trainees," it said. "To provide firsthand experience of sail ships, the cadets would be attached to sail training

ship INS Sudarshini."

The cadets, from the Kingdom's main naval academy at the King Abdulaziz Naval Base in Jubail, arrived aboard their host's First Training Squadron vessels INS Tir and INS Sujata.

The First Training Squadron of the Indian Navy are the first ships that newly commissioned naval officers train on.

The training program for Saudis is seen as a display of growing defense ties between the two countries.

# Cash, Gold Worth Crores Found In Rajasthan Govt Building's Basement

Jaipur: Over 2.31 crore in cash and one kg of gold was recovered from a locked almirah in the basement of Yojana Bhawan in Jaipur, police said.

Seven employees of the Yojana Bhawan having access to the basement have been detained for questioning, according to officials.

The trolley suitcase kept in the almirah contained 2,000 and 500 denomination notes, police said, adding that the recovery took place on a day when RBI withdrew 2,000 currency notes from circulation.

Chief Secretary Usha Sharma, Director-General of Police (DGP) Umesh Mishra, Additional Director General of Police (ADGP) Dinesh MN and Jaipur Commissioner Anand Srivastava held a joint press conference thereafter at the Secretariat late Friday night.

"Files were found from one almirah and the trolley suitcase full of cash and gold from another, following which the employees informed the Ashok Nagar police station," Mr Srivastava said, adding that the cash amounted to 2.31 crore and gold weighed 1 kg.

"The files are being scanned and digitised under the e-filing project. Two locked cupboards were also opened today after their keys were found," he said.

Seven employees have been detained and are being interrogated. An investigation into the entire matter has started, Mr Srivastava said.

The Jaipur Police Commissioner said he would disclose the entire matter soon.

The cupboard from which the cash and gold were recovered was locked for several months. The basement from where the cash was found was accessed by Aadhaar-UID-linked staff. The police will question those having access to the shelves in the basement.

"Whose money is it, how did it come, investigation is being done. CCTV footage is being scanned. It seems like this wardrobe has been closed for a long time but is not even two or three years old," he said.
