### 7 Workers **Killed In Kishtwar** Accident **Press Trust Of India**

Jammu: Seven persons includ-ing two from Jharkhand were killed and three others critically injured after a vehicle ferrying workers of a power project rolled down a hill in Kishtwar district of Jammu and Kashmir on Wednesday, police said.

Lt Governor Manoj Sinha, Union minister Jitendra Singh, and leaders from almost all political parties expressed their grief over the accident which occurred near Dangduru power project site in remote Dacchan area around 8.35 am.

Since the accident, the officials said, hundreds of workers have been staging a protest at the work site demanding the company to compensate the families of the victims and pay for the treatment of the injured. Commissioner, Deputy Kishtwar, Devansh Yadav said the accident took place amid heavy rains in the area.

"Seven persons are confirmed dead and three others critically injured in the accident," Senior Superintendent of Police, Kishtwar, Khalil Ahmad Poswal told PTI.

He said the injured were rushed to a hospital by the rescuers who were helped in the operation by locals.

According to the officials, the driver of the vehicle lost control while negotiating a blind curve and drove down the hill.

The vehicle turned into an iron mangle after falling down several hundred feet before coming to halt, they said, adding six persons were found dead on-thespot, while one more succumbed while on way to hospital.

## **Houses Of 8 Pak-Based Militants Raided**

Jammu: The Jammu and Police Kashmir Special Investigation Unit (SIU) on Wednesday conducted raids on houses of eight Pakistan-based militants at multiple locations in Kishtwar and Ramban districts, senior officials said.

The raids were carried out in Padder, Keshwan and Thakrai in Kishtwar and Khari and Banihal in Ramban to scuttle attempts by these militants to revive militancy in the Chenab valley region, they said. Senior Superintendent of

Police, Kishtwar, Khalil Ahmad Poswal said the searches at the houses of Azad Hussain, Ghaziud-Din, Bashir Ahmed Mughal and Sattar Din, alias Rajab, were conducted after search warrants were obtained from a special NIA court in Jammu in a case under the Unlawful Activities (Prevention) Act.

'The searches are aimed at eliminating the militant ecosystem in the district by identifying various over-ground workers and supporters of militancy," the officer said.

Earlier on May 18, teams of the SIU raided houses of five militants, who are currently operating from Pakistan and Pakistan-controlled Kashmir, besides three suspected individuals in the district.

The evidence collected shall be investigated so as to subject the accused persons to judicial determination for their involvement in anti-national activities and perpetuation of militancy," Poswal said.

## **Persons With Disabilities Now Have Grievance Redressal Officers**

Jammu: The Jammu and Kashmir administration on Wednesday nominated grievance redressal officers for persons with disabilities in all the departments concerned in the Union Territory. The appointment of these of-

ficers has been made to ensure that the persons with disabilities enjoy the rights to equality, life with dignity and an appropriate environment with zero tolerance for discrimination on the ground of disability, an official spokesman said, quoting a notification. He said the Rights of Persons

with Disabilities Act makes it mandatory to follow certain principles for empowerment of persons with disabilities.

These inter alia included respect for inherent dignity, individual autonomy including freedom to make one's own choices

and independence of persons, full and effective participation and inclusion in society.

It also comprises respect for difference and acceptance of persons with disabilities as part of human diversity and humanity, accessibility, equality between men and women and respect for evolving capacities of children with disabilities and respect for the right of children with disabilities to preserve their identities.

The spokesman said the Social Welfare department framed the Jammu and Kashmir Rights of Persons with Disabilities Rules for effective implementation of provisions of the Rights of Persons with Disabilities Act.

The sub-rule (2) of Rule 14 of lammu and Kashmir Rights of Persons with Disabilities Rules provides that the grievance redressal officer appointed by everv department shall maintain a register of | More on P10

Jammu: The authorities have cancelled all leaves of doctors and paramedical staff members, except those granted time off on maternity and medical grounds, from June 19 in view of the start of the annual Amarnath Yatra.

The annual pilgrimage to the 3,880-metre cave shrine is scheduled to commence on July 1 from the twin tracks -- the traditional 48-kilo-Nunwan-Pahalgam metre route in Anantnag district and the 14-kilometre shorter but steeper Baltal route in Ganderbal district.

According to a circular issued by Director - Health Services (Jammu) Rajeev K Sharma, "In view of the Shri Amar Nath Ji Yatra, all types of leaves of



doctors and paramedical staff except maternity leave and commuted leave on medical grounds, stands cancelled with effect from June 19."

# **Every Water Source 'Is And Shall Remain' Govt's Property: HC**

Says No Individual Or Group Can Claim Exclusive Right Over Natural Resources

Srinagar: Observing that every water source in the State is and shall remain the property of the Government, the High Court of J&K and Ladakh has held that no individual or group can claim any right to exclusive use of natural resources.

"Under Article 39 of the Constitution of India it is the goal of the State to ensure that the ownership and control of the material resources of the community are so distributed as best to subserve the common good," a bench of Justice Rajnesh Oswal said, adding, "The respondents (authorities) have undertaken the exercise to ensure fair distribution of the natural resources and no individual or group of individuals can claim any right to exclusive use of natural resources.'



The court made the observations while dismissing a petition, filed by residents of the village Qasba Yar of Shopian district, in which they had sought directions to the authorities not to change, divert or take any water from Yari Kohal (a local water body). Further, they had sought

directions to restrain the authorities from raising and completing the construction of the new Kohal. ## **Humour Appreciation Found To Involve 'Work' Brain Circuits**

cientists have found that highfrequency neural activity, seen in tasks that require a lot of cognitive engagement, such as work, is also a mark of humour appreciation.

The scientists from Institut Du Cerveau (Paris Brain Institute), France, and Bar-Ilan University in Tel Aviv, Israel, studied the cognitive and neuronal mechanisms on which appreciation of humour was based. They have described their findings in

the journal Neuropsychologia.

Previous studies have shown the involvement of the temporal lobe in the processing of droll stimuli, or stimuli associated with goof.

The scientists analysed intracerebral electrophysiological recordings of 13 epileptic patients, which made it possible to look at neuronal activity directly with a high spatial and temporal precision (at the millisecond scale) in several cortical areas.

So far, the preferred technique for these studies was fMRI. However, the researchers of this study said, the signal obtained via fMRI does not allow the detection of the entire spectrum of electro-

magnetic waves generated by the brain: part of the information is lost.

The patients being studied had been implanted with deep brain electrodes as part of a pre-surgical assessment of refractory epilepsy.

The researchers asked the patients to watch a three-minute excerpt from Charlie Chaplin's Circus (1928) while their brain activity was measured live. Beforehand, the amusing nature of each sequence had been evaluated, frame by frame, by a group of healthy volunteers.

The team then compared the patients' neural activity recorded during the funniest scenes in the film with that recorded during the least funny scenes.

"We observed that the funniest sequences were associated with an increase in high-frequency gamma waves and a decrease in low-frequency waves.

"These results indicate that high-frequency neural activity, which is seen in tasks that require a lot of cognitive engagement, such as work, is also a mark of humour appreciation.

"Conversely, scenes that are not funny, such as transition sequences where the character moves from one

place to another without doing anything, promote inattention and introspection... and a preponderance of low frequencies," explained Vadim Axelrod, who led the experiment.

More importantly, the scientists said, this inverse relationship between high and low frequencies was observed in temporal lobe regions but not in others. It seemed that humorous content was not

processed in the same way throughout the cortex and depended on brain areas and functions.

According to a dominant theory, the treatment of humour is based on two complementary mechanisms and involve two neural circuits - cognitive and emotional.

Cognition is first employed to detect an incongruous element of reality. For example, in Charlie Chaplin's The Gold Rush (1925), the hero eats shoelaces like spaghetti.

Following this, a positive emotion related to this incongruity emerges through the emotional neural circuit.

What is funny would, therefore, be both unexpected and pleasant.

"Our results support this theory, as we confirm the prominent role of the temporal lobe in the appreciation of humour.

"As the anterior parts of this area are involved in semantic memory, we can imagine that their activity is linked to the analysis of the scene and the detection of its incongruous content.

"Conversely, the activation of its posterior parts could correspond to understanding the unusual and, therefore, amusing aspect of certain social interactions," said Vadim Axelrod.

## Indian-origin teen who crashed truck into White House barrier says he wanted to kill President Biden

19-year-old Indian-origin teen accused of deliber-Ately crashing a rented U-Haul truck into a White House barrier told authorities that he wanted to get inside the mansion to "seize power" and "kill" US President Joe Biden, according to media reports.

US Park Police arrested Sai Varshith Kandula after he crashed the truck into the security barriers on the north side of Lafayette Park shortly before 10 pm on Monday, sending multiple pedestrians running from the scene, The Washington Times reported.

The crash was a good distance from the White House gates, but the incident prompted road and sidewalk closures, and the nearby Hay-Adams hotel had to be evacuated. No one was injured in the crash.

Kandula, of Chesterfield, Missouri, rented the truck on Monday night immediately after flying from St Louis to Dulles International Airport on a oneway ticket, a Secret Service agent

said in a statement of facts filed in federal district court in Wash-

ington DC, NBC News reported. He drove the vehicle onto a sidewalk outside the White House and into a metal barrier just north of the White House, according to the document.

Kandula put the truck in reverse and crashed into the barrier a second time before

Kandula told authorities he had been planning the attack for six months and detailed the plans in a "green book," the document says.

He "stated his goal was to 'get into the White House, seize pow-

When Secret Service agents asked Kandula about a flag with a swastika he removed from a backpack, he allegedly said he'd bought it online because Nazis have a great history, according to the court document.



Rahul Gandhi, No Longer An MP, Approaches Court For An "Ordinary Passport"

New Delhi: A court in Delhi today posted the hearing on a plea for a fresh passport by Congress leader Rahul Gandhi, an accused in the National Herald case, on May 26.

Rahul Gandhi had moved the court on Tuesday seeking a 'no objection certificate' to secure a fresh "ordinary passport" after having surrendered his diplomatic travel document upon his disqualification as an MP.

Additional Chief Metropolitan Magistrate Vaibhav Mehta posted the matter on Friday for the filling of written submissions and the arguments of BJP leader Subramanian Swamy.

During the proceedings, Ra-

hul Gandhi's advocate sought the grant of the NOC document, saying there are no criminal cases pending against him.

Mr Mehta, however, said Mr Swamy had the right to file a reply on the application.

The applicant ceased to be a Member of Parliament in March 2023 and as such he surrendered his diplomatic passport and is applying for a fresh ordinary passport. By way of the present application, the applicant is seeking permission and no objection from this Court for issuance of fresh ordinary passport to him," the application said.

The court had on December 19, 2015, granted bail to Rahul Gandhi and others in the case.

## 70 Admitted To Hospital After Eating 'Rasgulla' At Wedding Feast In UP

wedding feast in a village in UP's Kannauj, a senior official said today. Sub-Divi sional Magistrate Garima Singh said the patients ate at the function in Madharpur village on Tuesday evening.



Of the around 200 people who consumed the food, about 70 complained of vomiting and diarrhoea after eating 'rasgulla' (a milk-based sweet) served there, she added.

Arzoo (1), Yusuf (2), Shifa (4), Asra (5), Sazia (7), Irfan Khan (48), Sultan (52), and Riyazuddin (55) were admitted to the district hospital after their condition worsened, Mr Singh said.

Dr Shakti Basu, Chief Medical Superintendent of the district hospital, said the condition of all the patients in the district hospital is stable, adding that some were taken to private hospitals.

Munna, a resident of the village, said almost everyone who attended the feast had eaten the rasgulla, following which several fell ill.

SRINAGAR: Chief Secretary, Dr Arun Kumar Mehta Wednesday launched the PSGA auto-appeal system for 103 services offered by different government departments through eUnnat dashboard in presence of Commissioner Secretary GAD, Sanjeev Verma; Commissioner Secretary IT. Prerna Puri and Secretary Revenue, Piyush Singla

The system shall trigger appeal to appellate authorities once the time lines specified under the Public Services Guarantee Act (PSGA) for availing these services are breached for anv of them

Dr Mehta complimented the IT Department for integrating the feature in the vital digital services offered by these Departments to the citizens. He observed that this feature is going to act as a turning point in maintaining transparency and accountability in delivery of services to the public and eradicating corruption.

He maintained that the auto escalation feature of online services is going to put an end to malpractices besides promoting fairness, a priority set by the current dispensation in all its affairs. He reiterated that it would ensure prevalence of discipline on part of both public servants and applicants itself. He made out that any sort of indiscipline or breach of timelines in providing the services would attract a penalty as per the PSGA.

It was given out that the majority of services belong to Departments providing important day to day services to the public and constitutes the bulk of G2C services provided here. These includes 25 services of Revenue Department, 26 of Industries & Commerce, 19 of H&UDD, 4 of Social Welfare, 5 of Horticulture, 6 each of Forest and Labour & Employment Departments, 2 each of FCS&CA and Home Departments, 3 of Jal Shakti and 1 of Rural Development & Panchayati Raj Department.

On the occasion it was brought out that the delivery of services through online mode has greatly reduced the waiting period for processing of applications. It was revealed that the bulk of applications in the Revenue, Social Welfare and Housing Departments pertain to such applications and it is going to benefit a large number of people on a daily basis.

Some of the significant services brought under the Autoappeal system are Issuance of Category Certificates by Tehsildar. It also includes Income, Property, Character, Legal Heir Certificates as well. Moreover attestation of Mutations, acquiring of Fard and Revenue Extracts from the Tehsil Offices across J&K too had been

brought under this appellate system. In addition the services like Issuance of Job Card under MGNREGA, obtaining of Water Connection from Jal Shakti, obtaining of marriage assistance, financial assistance under LadliBeti or Pensions from the Welfare Department, Social obtaining of Birth Certificate, Death certificate, Street Vending (Rehri) Licence from H&UDD, obtaining of Credit Cards by Artisans, Weavers from the Industries and Commerce Department too form part of the Auto-appeal system launched today by the Chief

# **Rains Lash Plains In J&K, MeT Predicts More**

Mercury Records Drop At Most Places, Farmers Advised To Suspend All Operations For Now

SRINAGAR: Overnight rains lashed the plains in Kashmir Valley while the weather department on Wednesday forecast more precipitation in Jammu and Kashmir till May 26. Quoting a meteorologi-

cal department official, news agency GNS reported that Sri-nagar received 6.9mm of rain in last 24 hours till 0830 hours, Qazigund 8.2mm, Pahalgam 22.5mm, Kupwara 10.6mm, Kokernag 10.5mm, Gulmarg 21.0mm, Jammu 8.1mm, Banihal 9.2mm, Batote 14.6mm, Katra 4.8mm and Bhaderwah 14.2mm.

He said that there will be intermittent rain/thunderstorm and snowfall over higher reaches at most places. "Possibility of hailstorm and strong

gusty winds at a few places can't be ruled out." On May 25-26, he said, the weather will be generally cloudy. "A brief spell of rain/ thunderstorm may occur to-

wards late afternoon/evening." He said from May 27-30, weather will be "partly to generally cloudy."

The weather department has advised farmers to suspend all farm operations till weather improves.

"Commuters are advised to confirm road status from concerned traffic police prior to embarking long journey especially Zojila, Srinagar- Jammu etc."

Regarding temperature, the meteorological department official said that Srinagar recorded a low of 13.5°C against 14.8°C on the previous night and it was 1.8°C above normal

for the summer capital. Qazigund, he said, recorded a low of 12.6°C against 10.8°C on the previous night and it was above normal by 2.3°C for the gateway town of Kashmir.



## **Woman Feared Drowned Amid Downpour In Pooch. Raiouri**

JAMMU: A woman was feared drowned while three people trapped in flash floods were rescued in the nick of time as heavy rains led to sudden rise in water bodies in the twin border districts of Poonch and Rajouri on Wednesday, officials said.

Two women -- Naseema Akhtar and Kulzum Bi -- were swept away while crossing Betar stream in Poonch district late afternoon on Wednesday, the officials said.

They said while Akhtar was rescued by a joint team of police and the State Disaster Response Force (SDRF), Kulzum Bi (28) remained untraced.

A rescue operation is on to trace her, the official said, adding they were trapped by the sudden rise in the water level.

In Rajouri district, two men - Ankush Kumar of Rajouri and Sunil Kumar of Punjab were rescued by a joint team of police and SDRF in an hour-long operation after they were found trapped in flash floods in Darhali river near Tarig bridge.

Meanwhile, the civil and police officers in the twin districts issued separate advisories, asking people not to move close to water bodies, especially rivers, in view of apprehensions of flash flood amid rainfall.

While these people may have the luxury of deciding how long they want to keep working, most of the world's population abides by a certain cut-off age to retire.

The concept of retirement age came about in 1881, when German chancellor Otto Von Bismarck set it at 70 years in an appeasement response to social-

concept of retirement age is under debate in many nations. Some like France recently legalised advanced ages to retire. Others like Germany, UK, Italy and China are also expected to advance their retirement ages soon. In India, too, which has one of the lowest retirement ages at 60, many a strong case have been made to postpone retirement age.

When it comes to economics, it is the number of years that people will live post-retirement as a result of higher life expectancies that is now a figure of concern. While this number globally was less than 20 just 50 years ago, presently people are expected to live

improve with age. Moreover, remaining occupied in a working role checks both physical and mental decline in individuals. The refrain that emerges is: it's the job and not the age that should matter.

And while this might be contested for jobs requiring rigorous manual labour and optimal physical condition, a cut-off retirement age no longer seems valid in general.

The issue of different retirement ages for men and women also needs to be tackled. Ironically, in most countries, women are forced to retire earlier despite having higher lifespans than men.

Take the issue of minimum public shareholding and foreign portfolio investors. This matter revolves around whether the 13 overseas entities (including 12 foreign portfolio investors), that hold Adani Group stocks, are compliant with disclosure norms. As per the committee's report, the regulator has uncovered 42 contributors to the assets under management of these overseas entities. But, the "ultimate chain of ownership" in these entities is not clear. The regulators in the jurisdictions where these contributors are located have not provided the SEBI with any information. The committee notes that the "legislative policy" stance of the regulator has moved in the opposite direction of its "investigation and enforcement" — the provision requiring FPIs to disclose "every ultimate natural person" at the end of every chain in the FPI was removed. So, while the regulator may well suspect "wrongdoing", it has "drawn a blank" because of this odd "dichotomy". On the equally contentious issue of the Adani Group's share price movements, while concerns had been voiced over the companies trading at valuations considerably higher than those in the same sector, "no evidence of any artificiality to the price rise" has been found. Further, the rise in share prices could not be attributed to "any single entity or group of connected entities"

The Supreme Court has given the SEBI till August 14 to complete its probe in the matter. Considering the wider implications of such an investigation — the Adani Group holds sway across large parts of the economy — the regulator would do well to provide greater clarity than the committee has done on the issues raised, address the questions that remain unanswered, and bring finality to the matter. SEBI's duty must be towards safeguarding the interests of investors, and preserving the integrity of the Indian stock market. Indian Express

# **Entertainment for Pattern Seeking, Puzzle Solving Apes**

Humans are not only compulsive information hunters, we are also avid pattern-seekers and puzzle solvers. We see people and objects in the arrangement of stars in the night sky. We see faces in random marks on the wall. If a crow sits on the branch of a tree and immediately a fruit falls, we infer that the action of the crow caused the fruit to fall.

We are driven to seek patterns and meaning in the information we gather about the world, and if there are no patterns, we often impose them. Pattern seeking and pattern recognition have obvious survival advantages. Being able to recognize a hidden lion from just a few spots of yellow behind green foliage may mean the difference between life and death. Being able to correlate changes in the seasons with cycles of animal movements can give you a predictable source of food. The better you are at detecting patterns and drawing useful inferences from them, the more opportunities you are likely to have for gainful action. But this instinct can also go too far, and create a cognitive bias, which is called a narrative bias or narrative fallacy. Once we have hit upon a narrative to explain a set of events, we tend to interpret new information to fit that narrative. And whatever information cannot fit in is usually ignored. An everyday example of this bias at work is in the way we create post-facto explanations for events we could never have predicted. History for example, is often presented as a grand narrative leading to an inevitable conclusion rather than a chaotic mishmash of random events that led to unforeseeable consequences. As Daniel Kahneman points out in Thinking Fast and Slow, if history actually had as neat an order as it seems to have in most books, why can't historians ever predict the future? Stock market pundits are as good at explaining yesterday's market movements as they are hopeless at pre-



dicting what will happen tomorrow. And yet, we are drawn to the 'analysis' of these pundits, instead of sifting through the raw data ourselves - and admitting that there is no discernable pattern.

In life this tendency can lead us horribly astray, and in his book Kahneman offers advice on how to counter this bias, but for our purposes the important insight is this - narratives are seductive because they create an illusion of understanding of the world. They are so powerful that we often prefer them to unfiltered reality. This might explain why structure and plot are so important in narrative. In his Poetics, Aristotle assigned primary importance to plot (mythos) and considered it the very "soul" of a tragedy. In Aspects of the Novel, E.M. Forster famously illustrated the difference between story and plot:

Story: The King died and then the queen died.

Plot : The King died and then the queen died of grief.

It is the causal connection of the plot that gets us hooked. We want to understand why.

No wonder narratives which have a well-defined causal link between events and an end that rewards the reader/audience with a deeper understanding of the story-world are usually preferred to ones that present a world of random events without causal links or clear resolution.

Stories offer opportunities to exercise our capacities for pattern detection at multiple levels. We detect personality traits from patterns of action and speech. We infer psychological states and conflicts from variations and inconsistencies in those patterns. In my favourite scene from the 2005 film Pride and Prejudice Darcy and Elizabeth Bennet insult each other in the rain right after she refuses his proposal for marriage. She says she hates him and he is the last man she would consider marrying. But then her eyes go down from his eyes to his lips. He makes a small movement towards her mouth and she reciprocates but then with visible effort, both stop themselves and Darcy says a cold goodbye. The tension in the scene is electric and we are fascinated because we detect at least two patterns - a pattern of speech signifying hatred and anger, and a second, conflicting one of gestures and looks, signifying attraction. As in music or poetry, in story too patterns create expectations which can then be subverted or contrasted with other patterns. This allows the audience to draw deeper, more subtle inferences - and continuously derive pleasure from the very act of successful pattern detection.

There are patterns of action - plots and counterplots by protagonists and antagonists. There can be patterns in the rhythm of speech not only in dramatic verse but in the work of many dramatists or screenwriters writing in prose. There are patterns in the design of the story - exposition, conflict, rising action, crisis, climax, resolution, etc. There are patterns in the design of characters - how they contrast with or set-off each other. There are patterns in the use of themes, or motifs. There are patterns that we immediately grasp without any effort, and there are patterns which can be discovered by audiences or teased out by critics years or even centuries after a novel or play has been written.

Complete absence of pattern is boring - there is no meaningful inference to be drawn from it. A completely predictable pattern is boring too - it does not repay the effort invested in continuing to pay attention. A pattern with the right degree of unpredictability is fascinating - there is reason to continue to pay close attention and new, rich inferences to be drawn at every moment. Once more, everything becomes relevant.

# Food Insecurity: A growing threat to global stability

Threats to security are not just measured in missiles, armies and terrorists. Political and economic turmoil can also be overwhelming.

That's why fighting hunger and thirst is no longer just a challenge for aid workers. The scale of the global crisis is so great that hunger now represents a threat.

Don't take a chef's word for it. Over the past decade or so, the US intelligence community assessed the likely impact of global food and water insecurity.

The agencies predicted a world, right around now, when water shortages and floods would "risk instability and state failure, increase regional tensions."

The time has come for us all to prioritise food in our public policy — at home and internationally.

Consider one of the most divisive factors in politics today, both in the United States and in Europe: immigration from the Global South.

What is driving so many families to risk their lives on perilous journeys through the jungle, across rivers or on the open seas?

Violence and lack of opportunity are nothing new in the Western Hemisphere. Though they are clearly factors in the surge to the US southern border, there is something new about what is moving so many people today.

That is food. To be precise: malnutrition, hunger and food price inflation.

Three years ago, the majority of migrants came from the Northern Triangle countries: Honduras, Guatemala and El Salvador. Now, most migrants at our border come from other countries, including Venezuela, Colombia, Nicaragua and Cuba. What ties these countries together?

Cuba is suffering extraordinary food shortages and price hikes. About threequarters of Venezuelans live on less than



\$1.90 a day, which, economists say, is nowhere near enough to feed one person, never mind a family. In some regions of Nicaragua, almost 1 in 4 children under the age of 5 has chronic malnutrition. I could tell you the same stories about the Northern Triangle countries a few years ago. Or I could tell you about the Honduran family we fed as they sheltered under a bridge in McAllen, Texas. They recognised the logo of World Central Kitchen, the non-profit, because it had fed them in Honduras the year before, when back-toback hurricanes wiped out their farm.

As severe drought devastates crops across South America, the World Food Programme recently warned that "the whole continent is on the move." We cannot build a wall high enough to stop the army of mothers with hungry children in their arms.

Our problem is not that we lack the resources or know-how to relieve these unbearable pressures. Our problem is that we lack focus.

The United States spends around \$25 billion a year on Customs and Border Protection and Immigration and Customs Enforcement. Texas alone wants to spend \$4 billion on the border.

That's what the United States spends on feeding the whole planet through the World Food Programme in a normal year. It's four times what the administration proposes to spend on stabilising the democracies and economies of Central America to help stop migration.

Food is not just an existential challenge beyond our borders. In the United States, about half of the adult population either has diabetes or is prediabetic. Two in five adults are obese. Last year, supplies of baby formula collapsed because of contamination at one factory, and the shortages endure.

The Government Accountability Office recently found that the federal government leads 200 different efforts across 21 different agencies to improve our diets. Yet US still cannot match the farming subsidies to its nutritional needs.

Everybody and nobody is in charge of food.

Food can be the solution to multiple crises: from our health to our climate, from immigration to global security. But only if we think differently and prioritise our food.

The global food systems are broken, and it urgently needs structural change.

## **Study Uncovers Details About Cells'** "Self-Destruction' Mechanism

#### Press Trust Of India

Researchers have uncovered details about how infected or damaged cells eliminate themselves by starting a built-in "suicide" program and that a specific protein, called ninjurin-1, serves as a breaking point for cell membrane rupture.

They found that ninjurin-1 assembles into filaments that work like a zipper and open the cell membrane, thus leading to the disintegration of the cell.

Publishing their results in the journal Nature, the researchers from University of Basel, the University of Lausanne and ETH Zurich, Switzerland, have provided new insights into the final step of cell death, which prevents the development of tumors and the spread of pathogens in the body and is crucial for all organisms.

Every day, millions of cells die in our body and contrary to what is generally assumed, cells do not simply burst at the end of their lives, they say.

Various signals, such as bacterial components, trigger the cell death machinery at the final stage of which, the cell's protective membrane is compromised by tiny pores which allow ions to stream into the cell.

'The common understanding was that the cell then swells until it finally bursts due to increasing osmotic pressure," explained Sebastian Hiller who heads a research group at the Biozentrum, Univer-

sity of Basel. 'We are now resolving how the cells really rupture. Instead of bursting like a balloon, the protein niniurin-1 provides a breaking point in the cell membrane, causing rupture

at specific sites," said Hiller. Using highly sensitive microscopes and nuclear magnetic resonance spectroscopy, the scientists have elucidated the cells' destruction mechanism by which ninjurin-1, a small protein embedded in the cell membrane, induces membrane rupture at the level of individual atoms.

They found that upon receiving the suicide command, two nin-

jurin-1 proteins initially clustered together and drove a wedge into the membrane."Large lesions and holes are formed by many further proteins attaching to the initial wedge. In this way, the cell membrane is cleaved open piece by piece until the cell disintegrates completely," explained Morris Degen, first author of the study.

"The cell debris is then removed by the body's own cleaning service," said Degen.

"It is now evident that the cells do not burst without ninjurin-1. They do swell to a certain extend due to the influx of ions, but membrane rupture is contingent on the function of this protein," said Hiller.

Since some tumour cells have been known to evade programmed cell death, this deeper understanding of cell death could facilitate therapeutic interventions to treat cancer.

On the other hand, interfering with premature cell death observed in neurodegenerative diseases such as Parkinson's disease through drugs could be a potential treatment option.

## Some Bank Branches Run Short On Day 2 Of ₹2,000 Note **Exchange: Report**

NEW DELHI: Some bank branches ran out of cash and temporarily halted the exchange of withdrawn ₹2000 currency notes as they awaited replenishment of supply from the currency chest on the second day of note swap on Wednesday.

More than anticipated demand during the first half in some of the branches led to the shortage of ₹500 and below denomination currency temporarily at some places, sources told Press Trust of India.

Customers had to wait for some time till replenishment came from the currency chest, sources added.



However, senior officials of various banks said there were no major complaints of currency shortage for exchange. "We are maintaining a continuous supply of ₹500, 200 and 100

denominations notes at all our all branches across Delhi circle to ensure smooth exchange process of 2,000 rupee notes," Canara Bank Chief General Manager (CGM) Bhavendra Kumar said.

Reserve Bank on May 19 announced withdrawal of ₹2,000 notes and permitted exchange of such notes up to a limit of ₹20,000 at a time till September 30.

Unlike November 2016, when old 500 and 1000 rupee notes constituting some 86 per cent of the currency in circulation were banned overnight, ₹2000 currency notes continue to be legal tender for now, and the exchange window is more than double of that provided in 2016. While the Reserve Bank of India (RBI) has not made the presentation of a valid ID or filling of deposit forms mandatory, there were complaints from some places that banks were demanding customers to submit identity cards as proof.

Reserve Bank Governor Shaktikanta Das on Wednesday said that RBI is monitoring the situation regularly with regard to the withdrawal of ₹2,000 currency notes and expressed confidence that the entire exercise will be completed in a

non-disruptive manner.

## **SpiceJet Hikes Salaries For** Pilots To ₹7.5 Lakh Per Month

Attendees at a luxury conference in Paris organized by Morgan Stanley flagged a "relatively more subdued" performance in the US, according to Edouard Aubin, an analyst at the investment bank.

# HC upholds dismissal of IPS officer who probed Ishrat Jahan encounter case

New Delhi: The Delhi High Court on Wednesday upheld a central government order dismissing former IPS officer Satish Chandra Verma, who assisted the CBI in its probe in the Ishrat Jahan fake encounter case, a month before his scheduled retirement.

Verma, a 1986-batch Gujarat Cadre IPS officer, was dismissed from service on August 30 last year, a month ahead of his scheduled retirement on September 30, 2022, after a departmental inquiry found him guilty of various charges, including "interacting with public media".

had approached Verma the high court following the Supreme Court's order allowing him to file a plea here.

A bench headed by Chief Justice Satish Chandra Sharma said there was no reason to interfere with the findings returned by the inquiry authority or the order passed by the disciplinary authority when the petitioner himself has not denied the media interaction which was done without any permission or authorisation.

The interaction with media was not in the bonafide discharge of the petitioner's duties, the court observed.

"We find no merit in the writ petition. The same is accordingly dismissed," ruled the bench, also comprising Justice Sanjeev Sachdeva.

It was also alleged that Verma did not make it clear that the views expressed by him were his own and not that of the government.

An inquiry was conducted and it concluded that the articles of charge have been proved.

it noted that the video footage clearly shows the petitioner "sitting at a place with the microphone attached to his lapel and is answering questions".

"Petitioner has not denied the interaction with the media, he has also not denied that he did not have any permission or authorisation to speak to the media. He has also not denied that he did speak about the encounter and issues that were not within the sphere of his duties.

"Clearly the interaction with the media was not in the bonafide discharge of his duties as CVO, NEEPCO (Chief Vigilance Officer, North Eastern Electric Power Corporation). He also did not specify that the views expressed by him were his own and not that of the Government," the court noted.

It said at no point of time Verma disputed the contents of either the footage or the transcript. "It is not the case of the Petitioner

that the contents are doctored, edited or altered," it added.

The court also noted nothing was on record to infer that the inquiry authority did not act as an independent adjudicator but as a representative of the government.

one where the findings returned by the inquiry authority are based on no evidence and the petitioner has not showed any procedural irregularity or violation of the principles of natural justice and fair play," said the court.

It said it does not find any reason to interfere with the findings returned by the inquiry authority or the order passed by the disciplinary authority.

Verma had probed the high-profile Ishrat Jahan case of 2004 between April 2010 and October 2011.

Ishrat, a resident of Mumbra near Mumbai, and three others, were killed in a staged encounter on the outskirts of Ahmedabad on June 15, 2004.

Those killed were dubbed as LeT terrorists who had plotted to assassinate the then Gujarat Chief Minister Narendra Modi to avenge the post-Godhra communal riots of 2002.

Based on his investigation report, a Special Investigation Team had concluded that the encounter was "fake".

The Gujarat High Court had later directed the Central Bureau of Investigation (CBI) to probe the case and avail Verma's services.

The apex court had on September 19, 2022 stayed the Centre's dismissal order for a week and said it is for the high court to consider the question as to whether the stay or vacation of dismissal order is to continue. Subsequently, on September

26 of the same year, the high court had refused to stay the Centre's order dismissing Verma.

# No Role For Anchor In T20 Cricket: MI Captain Rohit Sharma

MUMBAI: India captain Rohit Sharma believes T20 cricket has changed and there is no role for anchors left in the format, adding that he has been exploring what he can achieve more as a batter even though his change in approach has brought about failures.

The Indian captain across formats, Rohit says as a batter he wants to do things 'differently' now without worrying too much about the outcomes, and that power-hitting could never be his forte.

"As I see it, there is no role for an anchor now. It is just how T20 cricket is played these days, unless you are 20/3 or 4, which is not going to happen every day," Rohit told Jio Cinema.

"Once in a while, you will be in that position and then someone needs to anchor the innings and finish off to a good score. There is no role for an anchor anymore, guys are playing differently." Rohit feels a change in mindset is mandatory.

"If you do not change your mindset, you are going to get smashed. People on the other side are thinking about the game differently and taking it to the next level.

"All seven batters need to play their role, I believe that if you get a good score, it is good, but even if you get a good 30-40 off just 10-15 or 20 balls, it is (just) as good because you are doing the role for the team. The game has changed," he added. The Mumbai Indians and In-

dia captain said he has played T20 cricket long enough for him to stick to a particular approach to batting.

"I just want to play that way and see what I can do. I have played this format for a long time and in a certain manner. But I want to do different things now. While doing that, (if) I get out, (it) does not really bother me," he said.

Rohit added, "If you see, in Chennai (vs Chennai Super Kings) and before that in Mohali (vs Punjab Kings), I got out zero.



In the third game, against RCB, I stepped down the first ball. I thought I have failed thrice in as many attempts but it is fine, this is what I am going to do."

The 36-year-old said he cannot switch to power-hitting because others are doing so and would prefer to get the runs the way he can.

"I know (that) I cannot match the power of guys like Tim David, Kieron Pollard and Cameron Green. They are powerful hitters; they can hit 100 metres easily," he said. Rohit also doesn't believe in fetish in hitting 100m sixes.

"But my thinking is that if I am getting a six after 65-70 metres, I only have to hit 80 metres. Why do I need to hit 100 metres? I will do that once you allow eight runs for it.

"I will hit 80 metres only because I am getting six runs

for it, and for that I need to time the ball. I do not need to muscle the ball like the other guys do – that is their strength. My strength is to get the ball in the middle of the bat, which is what we call the sweet spot," Rohit added. Rohit said batting star

Suryakumar Yadav is reaping the benefits of the hard work he has put in over the last several years.

'Look at Surya; he is not hitting it big. He can also hit 100 metres but his thinking is also the same. Everyone has been watching Surya for the last one or one-and-a-half years.

"But he is a seasoned cricketer, he has been playing since 2008. If I am not wrong, he made his debut in 2010-11. So from the last 10-12 years, he is playing the Ranji Trophy.

"His bats have gone from white to red — he hits that many balls. I have seen him from agegroup cricket; he has done his hard yards from local cricket to Ranji Trophy," Rohit said.

The five-time IPL winning captain Rohit admitted Mumbai Indians are a team of superstars but said the franchise has a system to create superstars from players they bring in through their impressive scouting process.

'Yes, it is a superstar team, but it is because the franchise has worked for it. All these players are part of the big auction pool – we have bought them. "Our team of scouts had worked day and night to get Jasprit Bumrah and Akshar Patel here from Ahmedabad. Hardik (Pandya) and Krunal (Pandya) were spotted in 2015 and we got them here. We have worked hard for it. It was a fiveyear journey from 2015-2020," he said.

Rohit claimed young players Tilak Varma and Nehal Wadhera will be 'huge stars' not only for Mumbai Indians but also for India.

"It is going to be the same story with what has happened with Bumrah, Hardik and all these guys. Tilak Varma and Nehal Wadhera... you watch the next two years. But then people will say 'it is a superstar team'. Yes it is, we are making them here. These two guys are going to be huge stars for us (MI) and for India," he said.

Rohit, who will lead India in the final of the World Test Championship and the 50-over World Cup later this year, revealed he did not watch most of the 2011 World Cup due to disappointment of not being selected.

"2011 was a big setback year for me only because I was not a part of the World Cup squad. It just hit me really hard, I realised a lot has to change. I made a conscious effort to change my game, my routines, everything about myself.

"I used to live by myself; I said 'I am just going to stay alone'. Honestly, I did not watch the World Cup except the semis and the final, because I was so disappointed, I did not want to watch," he said.

## **Brazilians Protest Outside Spanish Consulate After Vinicius Racism Row**

SAO PAULO: About 100 Brazilian protestors gathered outside the Spanish consulate in Sao Paulo on Tuesday to condemn the racist abuse of Real Madrid forward Vinícius Júnior in Spain's top-flight soccer league. The protesters chanted "La

Liga is racist" and "end with racism in Spain and in Brazil" for about an hour. They brought flares, banners and stickers that read "Vini Jr, I am with you." They projected the words "it is not soccer, it is racism" onto the walls of the consulate.

Vinícius, who is Black, has been subjected to repeated racist taunts since he arrived in Spain five years ago. Since the Spanish league season began in September, he has experienced racist abuse by fans of at least five rival teams.

Former soccer player Claudia Rodrigues, 51, one of the orgaquickly and show the Spanish goverment it needs to act.

"Vini behaved as a warrior, Brazilian man that honors our ancestors," Rodrigues said. "Vini is facing racism in Europe. Regardless of financiers, sponsors, it is very important for our society and very important for young Black people, who look at them as heroes.

Spanish police have arrested seven people accused of racially insulting the Real Madrid player. Three were detained in Valencia for alleged abuse against Vinícius in a Spanish league match on Sunday. ## Man Who Spends 2 Million A Year To Look 18 Swapping Blood With Father, Son

n April 3, the tech entrepreneur Bryan Johnson, 45, turns up at a health services clinic near Dallas with his 70-yearold father Richard and 17-year-old son Talmage. They arrive early in the morning, and, over the course of several hours, the men (and boy) engage in a tri-generational swapping of their blood plasma.

Talmage goes first, having a liter of his blood removed and converted via a machine into its piece parts-a batch of liquid plasma and then a batch of red blood cells, white blood cells and platelets. Bryan next undergoes the same process and then has an additional procedure in which his son's plasma is fed into his own veins. Richard goes last and receives Bryan's plasma after making room for the fluids by having his own blood drained.

At this point, you probably have a lot of questions. One might be: Is this like the "blood boy" thing? And yes, it is exactly like the blood boy thing.

There's a longstanding public fascination with stories of wealthy tech types injecting themselves with the precious bodily fluids of younger people. Experiments in mice have suggested that older rodents experience rejuvenating effects by absorbing the life force of their younger counterparts. Inspired by these results, some people have opted to experiment on themselves and tap into this vampiric-sounding fountain of youthalthough, it should be noted, the science here is anything but settled. For Johnson, the plasma ex-

For Johnson, the plasma exchange is not an unusual hap-



pening. He's been to the Dallasarea clinic for several consecutive months and received plasma-not from a family member but from a young, anonymous donor. Johnson carefully screened the donor to make sure the person had an ideal body mass index, lived a healthy lifestyle and was free of diseases.

Johnson made a name for himself in the technology field as the former head of Braintree, a digital payments company that owned Venmo. He pocketed a fortune after selling the venture and started Kernel, a brain-machine interface company. Of late, though, he's been focused on his body through something called Project Blueprint. As Bloomberg Businessweek reported in January, Johnson is spending millions of dollars per year on medical diagnostics and treatments combined with a meticulously crafted regimen of eating, sleeping and exercise to see if he can slow, and perhaps even reverse, the aging process. He has a team of doctors aiding in this quest; through Blueprint, Johnson is publishing the vast majority of his methods and results. hoping others can evaluate and benefit from his work.

## Zimbabwe Named "Most Miserable Country In The World", India's Rank Is...



Zimbabwe has emerged as the most miserable country on renowned economist Steve Hanke's Annual Misery Index (HAMI), which judges nations on mainly economic conditions. The African country that has surpassed war-torn nations like Ukraine, Syria, and Sudan, has majorly been plagued with skyrocketing inflation, which touched 243.8 percent last year. A total of 157 countries were analysed for the rankings, as per New York Post.

"Thanks to stunning inflation, high unemployment, high lending rates, and anemic real GDP growth, Zimbabwe clocks in as the WORLD'S MOST MISERABLE COUNTRY in the Hanke 2022 Annual Misery Index. Need I say more?" Steve Hanke tweeted.

Mr. Hanke also blamed the country's reigning political party ZANU-PF and its policies for inflicting "massive misery."

Venezuela, Syria, Lebanon, Sudan, Argentina, Yemen, Ukraine, Cuba, Turkey, Sri Lanka, Haiti, Angola, Tonga, and Ghana are the other countries in the top 15 list of most miserable nations.

Meanwhile, Switzerland had the lowest HAMI score, meaning its citizens are the happiest. "One reason for that is the Swiss debt brake," Mr. Hanke wrote, crediting the low debt-to-GDP ratio for the nation's joyous success.

The second-happiest country was Kuwait, followed by Ireland, Japan, Malaysia, Taiwan, Niger, Thailand, Togo, and Malta.

India, on the other hand, ranked 103 on the list, with the contributing factor to the misery being unemployment, according to the index.

The US ranked 134th on the list, with unemployment as the leading culprit of unhappiness. Finland, which has been ranked the world's happiest country for six years in a row by the World Happiness Report, was ranked 109th on the misery index.

Bulgarian writer Georgi Gospodinov and translator Angela Rodel won the International Booker Prize on Tuesday for Time Shelter, a darkly comic novel about the dangerous appeal of nostalgia.

The book beat five other finalists to the prize, which recognizes fiction from around the world that has been translated into English. The 50,000 pounds (\$62,000) in prize money is divided between the author and the translator.

Time Shelter imagines a clinic that recreates the past, with each floor reproducing a different decade. Intended as a way to help people with dementia unlock their memories, it soon becomes a magnet for people eager to escape the modern world.

Gospodinov, 55, said he began writing his book about the weaponization of nostalgia in 2016, the year of the election of Donald Trump and the U.K.'s Brexit referendum. He said it was a time when anxiety was in the air. I wanted to write a novel
