### **Gusty Winds** Wreak Havoc, **Kill 4 Of A Family**

Residential house, vehicles damaged, many trees uprooted; Hailstorm causes extensive damage to crops, rains lash plains; MeT predicts more rains till May 30

**Srinagar:** Gusty winds coupled with rains and hailstorm at many places in the valley on Thursday afternoon left at least four people dead and caused considerable damage to buildings and crops. The winds also affected the electricity supply in several areas of the Valley.

Four members of a tribal nomadic family died in Kishtwar district on Thursday morning when a pine tree fell on their tent due to gusty winds.

The incident took place in the Bhalna forest area of Keshwan belt, officials said, adding that high-speed winds and heavy rainfall uprooted the big tree.

"A pine tree fell on a tent pitched by the nomadic family in the forest belt. In this tragic incident, four family members lost their lives early today," Senior Superintendent of Police, Kishtwar, Khalil Poswal told PTI.

The family was going towards Dachan with its sheep and goats, and had halted in Bhalna forest due to heavy rains, they said.

Commissioner, Deputy Kishtwar, Devansh Yadav said four people, including three women, died on the spot.

"A police team immediately rushed to the spot and started a rescue operation," Yadav said, adding that the bodies are being taken to a hospital for legal formalities.

In the Kashmir valley rains continued to lash plains bringing down the temperature further.

Normal life got disrupted due to the moderate rainfall this afternoon while several areas of Srinagar and other districts witnessed gusty winds too, which led to the damage to the vehicles and a residential house as well.



# **HC Dismisses Petitions Seeking Quashing Of FIR**

Jammu: The Jammu and Kashmir High Court has dismissed three petitions challenging an FIR registered in 2011 under various sections of prevention of corruption act in a drug kit scam, saying the "power of quashing criminal proceedings has to be exercised very sparingly and with circumspection and that too in the rarest of rare cases".

The FIR was related to an inquiry by Anti-Corruption Bureau (ACB) against the then director of health services (Jammu) Ashok Kumar Sharma, members of tender opening committee, officers and officials of National Rural Health Mission (NRHM) and the members of the verifying committee as also others, into allegations regarding purchase of medicines worth crores of rupees on exorbitant rates.

It was also alleged that the medicines were procured from firms which had been permanently de-registered or

blacklisted by the Directorate General Health Services (Medical Stores Organization), New Delhi.

The petitioners - verification board member Deepak Kapoor, the then managing director (MD) of Bengal Chemicals and Pharmaceuticals Limited Suprakash Kundu, the then MD of Karnataka Antibiotics and Pharmaceuticals Limited Suhas Laxman Phadke and the then director (finance) of Hindustan Antibiotics and Pharmaceuticals limited Sitaram Vaidya - chal-

lenged the FIR in the court. After hearing the petitioners through their lawyers and Additional Advocate Senior General Monika Kohli, Justice Sanjay Dhar said the inquiry conducted, prima facie, established the allegation that the director of health services purchased the drug kits during 2010-11 on exorbitant rates in total disregard of codal formalities prescribed for purchase of drug kits thereby causing huge loss to the public exchequer.

# **Govt Okays Disaster** Recovery Centre Outside J&K Moved Aimed To Save Govt's Digital Services,

**Data In Wake Of Any Natural Disasters**

Srinagar: In a major decision aimed to overcome any natural disaster, the Lieutenant Governor, Manoj Sinha on Thursday approved establishment of Disaster Recovery (DR) Centre outside Seismic Zone of Jammu and Kashmir along with its upkeep and maintenance for 5 years.

The decision in this regard was taken in the Administrative Council (AC) which met here under Lieutenant Governor Manoi Sinha, an official spokesperson said Thursday. LG's Advisor Rajeev Rai

Bhatnagar, Chief Secretary Dr. Arun Kumar Mehta, Principal Secretary to the Lieutenant Governor attended the meeting.

The project, the spokesperson said, has been considered as a part of adoption and launch of e-Office Software



in all major departments and offices of the Government of Jammu & Kashmir.

He said that the digital services of J&K government, including e-Office operate out of the servers installed at the primary site in the Data Centre at Jammu.

"However, the establish-ment of a Disaster Recovery Centre outside of J&K Seismic Zone, would protect the entire data of the primary site against any natural or technical disaster with a backup at the secondary site, in a different seismic zone," he added.

The spokesperson said that it is important to have a disaster recovery plan in place to mitigate disaster related interruptions, which makes the establishment of disaster recovery site an essential part of the system, especially when entire Government working is becoming digital.

# J&K Special Tribunal Not Toothless Body 'Altogether': HC

Srinagar, May 25: The High Court of J&K and Ladakh on Thursday said that J&K Special Tribunal is not a "toothless body altogether" and possesses sufficient powers to deal with those who "dare to commit its contempt.

"...the J&K Special Tribunal is not a toothless body altogether and is pos-sessed of sufficient powers to deal with the citizens who dare to commit its contempt. Though it is ideal as also to make the functioning of the Tribunal effective to make an amendment in the Act of 1988 to confer upon it specifically the power to punish for contempt in relation to itself or any member thereof, as has been done in various statutes," a bench of Justice Sanjeev Kumar said.

"The Administrative Tribunals constituted under the Administrative Tribunals Act, 1985, National Company Law Tribunal and the National Company Law Appellate Tribunal constituted under the Companies Act have

been specifically conferred the powers to punish for contempt of itself, which power is akin and identical to the power conferred upon

the High Courts under Article 215 of the Constitution of India and Section 10 of the Contempt of Courts Act," the court said, adding, "It is, however, for the Legislature vested with the power to legislate to take a call in this regard."

# **Director Health Faces Heat For Shifting Suspended Doctor**

Srinagar: The Health and Medical Education Department of Jammu and Kashmir government has once again sought an explanation from the Director of Health Services Kashmir (DHSK) after an under-suspension doctor was transferred from one district to another.

The explanation comes just two weeks after the department ordered an inquiry into the alleged violation of government rules and regulations by the Director.

The Director has allegedly delegated financial powers to Chief Medical Officers (CMOs) in contradiction to the established protocols. The government has

appointed Director Medical Supplies Corporation limited Pankaj Gupta as inquiry officer and directed him to submit a report within 20 days.

According to a fresh order, a copy of which lies with Kashmir Observer, the department has asked the Director Health to explain as to why the name of Dr. Arshad Hussain Wani, Medical Officer was incorporated in the proposal while submitting it to the Administrative Department when the latter was under suspension.

Notably, the department has suspended Dr Arshad Ahmad Wani, Medical Officer, SDH Kokernag in the month of February this year.

# **Experts To Draft White Paper On Methane Management**

paper on capturing methparticularly coal bed methane, would soon be drafted and submitted to the government for it to take policy measures as potential of methane to warm environment is 84 times more than that of carbon dioxide.

The white paper would also incorporate findings of the experts that investing in methane capture mining companies can increase revenues by 30 per cent.

Methane is the second leading cause of climate change after carbon dioxide.

The white paper shall be drafted on the basis of deliberation during day-long workshop Sustainable Mining & Methane Management' jointly organised last week by International Centre for Climate and Sustainability Action Foundation (ICSSA), Society for Clean Environment (SOCLEEN) and the Maharashtra government.

It will be submitted to Ministry of Environment, Forests and Climate Change, Maharashtra, and State Environment Impact Assessment Authority (SEIAA).

During the workshop, climate scientists suggested to state governments to incentivise and urge coal mining companies on methane handling, considering that methane's potential to warm environment is 84 times more than that of carbon-di-oxide (CO2).

Experts also suggested that somebody should be made accountable to capture methane from abandoned coal mines that continue to emit methane in environment, which has not been addressed as yet.

In his special address at the workshop, Vijay S Nahata, Chairman SEIAA suggested using modern tools in mining to reduce environmental and climate impact.

"India is committed to Net-Zero by 2070, and we will continue to cooperate and work with industries and other stakeholders for the betterment of our environment," he added.

Rakesh Kumar Council for Scientific and Industrial Research (CSIR) suggested that mining companies should also be made aware of the revenue potential that methane capture can have.

By increasing their operational spending by 10 per cent towards methane capturing, the mining industries can create a separate revenue stream that can give them three times the returns on the investment, he said.

While mining companies shall be able to increase their revenues in the short term, allied benefits relating to the environment and health of people residing in areas closer to mining, will take some time to show.

Growth in coal production is directly proportional to the release of methane from mining activities.

Professor A D Sawant, President SOCLEEN suggested that having government policy towards climate change is definitely the first step in the right direction, but the know-how should also be shared with mining officials

who are there at the site. Professor C K Varshney, Professor and Advisor ICCSA said utilisation of coal mine methane has the potential to benefit India by reducing emissions and increasing domestic energy security.

# **Padma Awardees, Eminent Scientists Join 3-Day Symposium At KU**

Srinagar: Three Padma Shri awardees are among a galaxy of scientists who will be a part of deliberations during a three-day national symposium on 'Earthquake. Landslide and Glacial Hazards' inaugurated at the University of Kashmir on Thursday.

The Padma awardees include earth scientist Prof Harsh K Gupta, geophysical scientist Dr V P Dimri and geologist Dr V C Thakur.

Vice-Chancellor, University of Kashmir, Prof Nilofer Khan presided over the inaugural session of the symposium as well as the 7th Annual Convention on 'Advances in Earthquake Sciences', organized by Indian Society of Earthquake Sciences (ISES) and KU's Department of Geography and Disaster Management. Nazim Zia Khan, IAS, Secretary to J&K Government, Department of Disaster Management, Relief and Rehabilitation (DDMRR) was the chief guest on the occasion, while Prof Talat Ahmad, former VC KU and Prof Harsh K Gupta were the guests of honor.

In her presidential remarks, Prof Nilofer said that disaster management is a "multidimensional issue" and needs active support from all stakeholders to help develop a disasterconscious citizenry. She said students can lead effective awareness camnaigns on disaster management, while such scientific deliberations in the University can feed into poli-

cymaking on the subject.

In his address, Nazim Zia Khan highlighted the importance of capacity building of various stakeholders for effective disaster management on the ground. He said the Government of J&K has developed a multipronged approach for good structuring of the disaster management mechanism, including creation of two separate battalions of SDRF.

In his special remarks, Prof Talat Ahmad called for addressing new challenges in disaster management with active involvement of teachers and students. He also highlighted the fallout of various disasters including landslides and earthquakes in vulnerable places like J&K. Prof Talat also said the KU's Department of Geography and Disaster Management must evolve into a Centre of Excellence given its potential and expertise.

Prof Harsh K Gupta said the best way to deal with natural disasters is to learn to live with natural disasters by developing resilience and capacities in the society at large. He said when other countries like Nepal or Haiti can develop such resilience in the wake of large-scale earthquakes, the same could be replicated in places in the country which are vulnerable to earthquakes and



# **Large-Scale Fish Deaths In Dal Lake Raise Alarm Among Residents**

# Authorities Say 'Annual' Affair

Srinagar: Thousands of fish in the Dal Lake here have died over the past few days with authorities blaming a sudden fluctuation in temperature in the region.

Dal Lake dwellers expressed alarm over such large-scale fish deaths even as authorities said the occurrence was an annual affair.

"I received reports about the deaths of fish in Dal Lake yesterday. We sent a team to scout the lake for samples. We found that a lot of dead fish had been collected around Centaur Hotel," Deputy Director Fisheries department Rafiq Ahmad told PTI.

"It seems that the fish have died due to sudden fluctuation in temperature. This is not unusual as it happens every year. You will find similar occurrences in other lakes like Manasbal (Lake) as well," Ahmad said.

It is an annual phenomenon which affects only one type of fish, the official claimed.

Asked if there can be any other contributing factors, Ahmad said pollution could also be a contributing factor as it changes the parameters of the water. "Coupled with temperature variation, it causes mortality among the fish " he said

It seems that the fish have died due to sudden fluctuation in temperature. This is not unusual as it happens every year. You will find similar occurrences in other lakes like Manasbal (Lake) as well

A senior inspector of the department has been asked to submit a detailed factual report ascertaining the cause of the fishes' death, he added.

However, lake dwellers, who live in houseboats in the lake, contradicted the official's claim saying they had never seen such large-scale fish deaths there.

The reason for the deaths is the increase in the water level of the lake. The lake authorities have kept the water level up.

Now, it has become a problem as the fish have died. It has caused a foul smell already and one cannot sit here," said Ghulam Mohammad, a Dal Lake dweller.

"A few fish would die earlier also but this is unprecedented. I have not seen this in 60 years of my life here," he added.

Some blamed the addition of chemicals to sewage water before it is released into the lake for the

"They put chemicals in these drains which have caused the deaths. These drains should be closed. This lake provides us with livelihood," said Bashir Ahmed, a fisherman for over 40 years at the lake. The fisherman also said he had not seen fish deaths of this scale in his lifetime.

Adil Ahmad, a frequent visitor to the lakeside, said the pollutants discharged from houseboats and waste material dumped into the lake was responsible for the situation

"I think it is due to the sewage that comes out of houseboats. People should avoid polluting the lake. They should use dustbins which have been installed. I am a frequent visitor to the lake and I am seeing this for the first time that so many fish have died. I was shocked!" he added.

# Israel Quickens Retreat: Lebanon Jail Stormed

'HAYAM: Hizbollah fighters poured into Israel's crumbling occupation zone and villagers stormed a notorious orison Tuesday as the Jewish state hastened the end of Laits bloody 22-year presence in south Lebanon The speed of the Is¬raeli pullout came as a surprise and has tened the collapse of the mainly Christian South Lebanon Army

(SLA) militia set up as a buffer against guerilla at-tacks. "We will redeploy in the next few days on the international border," Israeli Prime Minister Ehud Barak said as the Muslim

guer¬rillas moved on foot and in civilian vehicles into large swathes of the so-called security zone Is¬rael carved out of the hills of its northern neighbor. Scores of detainees rushed out with tears in their eyes to em-

brace their liberators who fired volleys into the air. More than 100 villagers overran the prison at Khayam and

freed 130 Lebanese pris oners held by Israelis for up to 15 years. SLA ON VERGE OF COL¬LAPSE: SLA men began giving themselves up in the eastern sector of the zone, their last bastion.

Militiamen also gave themselves up to the Lebanese army in the village of Hasbaya as Israeli warplanes destroyed bridges and heavy equipment aban-doned during their accel-erated retreat. Once the surrender is completed Hizbollah guerrillas were ex-pected to flow in and tighten their control over virtually all of the zone running from the Mediterranean Sea to the foot of the Golan Heights.

Hizbollah leader Sheikh Hassan Nasrallah said his men would continue their war if Israel did not release Lebanese prisoners held as bargaining chips and give up an area of land known as Shebaa Farms. Israel has indicated it will hold on to the farms, at the foot of the Golan Heights, saying the land is Syr-

ian and hot Lebanese Panic Among Christians: The Hizbollah advance sparked panic in the Christian population and jubilation among Muslims A stream of Christians and SLA members headed for the Israeli border seeking sanctuary. Some will be housed in a holiday

resort on the Sea of Galilee SLA commander General Antoine Lahd left Paris Tuesday for Tel Aviv to return to his crumbling army.

Despite the haste of their retreat, Israeli soldiers were clearly relieved to be out of a conflict that looked tin winnable and was deeply unpopular with the Israeli public.

At the Egel border crossing, dozens of returning soldiers gave the thumbs-up sign, unloaded their rifles and shed flak jackets. "In the end we took down the flag in haste and we sang the Tikva (national anthem)... so that we would have the good feeling we aren't leaving with our tail between our legs," said one soldier. He was in a convoy of 10 armored vehicles that had dashed to the border under cover of darkness.

Israeli newspapers, however, likened the withdrawal to the U.S. rout from Saigon in 1975. One headline ran "Day of Hu¬miliation" — a sentiment that Hizbollah clearly felt as its years of struggle to drive Israel from Lebanon succeeded in dramatic fashion. "This 18-year tragedy is over," Barar said, referring to

Israel's 1982 invasion. Israel first crossed into Lebanon in 1978 to stop attacks by Palestinians who had been housed in refugee camps-since the creation of the Jewish state 30 years earlier.

Hizbollah took more than 20 villages in south Lebanon on Tuesday, Witnesses said guerril-las established positions inside a cluster of villages, swiftly moving through abandoned posts, capturing suspected SLA members and seizing weapons and ammunition. In Biut Jbeil, residents lined the streets, showering the

guer¬rillas with rice and saluting them with V-for-victory signs amid shouts of Islam's rallying cry of Allahu Akbar (God is

# Iran Launches 2,000 km-Range **Ballistic Missile Kheybar**

**DUBAI:** Iran successfully tested a 2,000km-range ballistic missile on Thursday, Iranian state media said, two days after the chief of Israel's armed forces raised the prospect of "action" against Tehran over its nuclear program.

Iran, which has one of the biggest missile programs in the Middle East, says its weapons are capable of reaching Israel and US bases in the region.

Despite opposition from the United States and European countries, Tehran has said it would further develop its "defensive" missile program.

"Our message to Iran's enemies is that we will defend the country and its achievements. Our message to our friends is that we want to help regional stability," said Iranian defense minister Mohammadreza

State TV broadcast what it said was footage of an upgraded version of Iran's Khoramshahr 4 ballistic missile with a range of 2,000km that can carry a 1,500kg warhead.

State News agency IRNA said the missile was called Kheibar, a reference to a Jewish castle overrun by Muslim warriors in the early days of Islam.

Israel, which the Islamic Republic does not recognize, sees



Iran as an existential threat. Iran says its ballistic missiles are an important deterrent and retaliatory force against the United States, Israel and other potential regional adversaries.

On Tuesday, the top Israeli general raised the prospect of "action" against Iran as efforts by six world powers to revive Tehran's 2015 nuclear deal have stalled since last September amid growing Western fears about Tehran's accelerating nuclear advances.

The nuclear agreement, which Washington ditched in 2018, imposed restrictions on Iran's nuclear activities that extended the time Tehran would need to produce enough fissile material for a nuclear bomb, if it chose to. Iran denies seeking

# After Shireen Mazari, Fawad **Chaudhry Quits Pakistan** Tehreek-e-Insaf

Imran Khan Says Party Leaders Being Forced To Quit Amid Standoff With Army

ISLAMABAD: Former Pakistan prime minister Imran Khan said Wednesday that senior leaders were being pressured into resigning from his party amid a crackdown, as a former cabinet minister became the latest to quit.

Rights monitors said authorities have detained thousands of supporters of Khan's Pakistan Tehreek-e-Insaf (PTI) party since days of street violence erupted over his brief arrest earlier this month.

Party spokesman Fawad Chaudhry, who served as information minister in Khan's government, quit the party while general secretary Asad Umar, the former finance minister, said he would step down from his position but remain with PTI. It came after senior vicepresident Shireen Mazari parted ways with Khan on Tuesdav.

All three made their announcements after being released from custody on allegations of instigating street violence after Khan's arrest.

"This is a crackdown that I have never seen in the history of Pakistan before," Khan said in a video address on Wednesday night.





If you say that you are part of PTI, then you will face oppression and violence, you will be locked up," he said.

"If you say the magic words, 'We are no longer in PTI', then you will be released.'

Khan claimed the suppression was being targeted at grassroots supporters, as well as officials. "They have put everyone in jail, I don't even know who to contact anymore," he said from his home in the eastern city of Lahore.

Chaudhry announced his resignation on Twitter, denouncing the civil unrest and saying he would "take a break from politics".

Umar meanwhile held a press conference, saying he had not been pressured into the decision to step down as general secretary.

Amnesty International on Tuesday said "a pall of fear hangs over Khan's supporters following the arbitrary arrests of many opposition leaders".

"Authorities must clamping down on the political opposition" they said in a joint statement with other organisations, accusing the government of using "vague anti-terrorism laws" to justify detentions. Since he was ousted from

office, 70-year-old Khan has waged an unprecedented campaign of defiance against the powerful military establishment, long regarded as Pakistan's powerbrokers.

He accuses the top brass of orchestrating his downfall and even plotting a November assassination attempt in which he was shot in the leg, allegations that the army denies.

# **20 Richest Countries Account For** Over Half Of 50 Million People In 'Modern Slavery': Report

UNITED **NATIONS:** The world's 20 richest countries are fuelling forced labour and account for over half the estimated 50 million people living in "modern slavery," according to a report released Wednesday. The report by the Walk Free

foundation, a rights group that focuses on modern slavery, said six members of the Group of 20 nations have the number of people in modern slavery - either in forced labour or forced marriage. India tops the list with 11 million followed by China with 5.8 million, Russia with 1.9 million. Indonesia with 1.8 million, Turkey with 1.3 million and the United States with 1.1 million.

"Most of the countries with lowest prevalence of modern slavery - Switzerland, Norway, Germany, Netherlands, Sweden, Denmark, Belgium,



Ireland, Japan, and Finland - are also members of the G20," the report said.

tries, thousands of people continue to be forced to work or marry, despite their high levels of economic development, gender equality, social welfare, and political stability, as well as strong criminal justice systems.'

Last September, a report by the UN's International Labour Organization and International Organization for Migration and Walk Free estimated that 50 million

people were living in "modern slavery" – 28 million in forced labour and 22 million end of 2021. That was a 10 million increase in just five years from the end of 2016.

"Modern slavery permeates every aspect of our society," Walk Free Founding Director Grace Forrest said in a statement. "It is woven through our clothes, lights up our electronics and seasons our food" - and it "is a mirror held to power, reflecting who in any given society has it and who does not.'

## **Turkiye-Syria Shocks: Earthquake Triggering "Doublet" Uncommon, Not Anomalous**

They said that while the oc-currence of two large earthquakes taking place so close in time as a "doublet" was uncommon, the first mainshock may have created stress changes in the area of the second earthquake's epicentre that caused failure at the Surgupublished in the journal The Seismic Record, including details on how, where, and how fast the earthquakes ruptured and how they combined as a "devastating doublet" to produce damaging ground shak-

An analysis led by Gesa M. Petersen of Helmholtz Centre Potsdam GFZ German Research Centre for Geosciences, Germany, suggested that the first mainshock ruptured up to 560 kilometres in multiple phases over a total of 117 seconds, while the second earthquake ruptured about 115 kilometres over 32 seconds, with aftershocks being distributed



Misis Fault Zone (SMFZ), about 90 kilometres to the north of the first earthquake.

Offering an initial look at the earthquakes in south-central Turkiye and northwestern Syria, three studies have been

along roughly 160 kilometres of the SMFZ. In this study, the researchers traced the rupture direction of each earthquake, showing that the first involved multiple directional phases and segmented rupture.

# **Tipu Sultan's Sword Sold For ₹ 140 Crore At London Auction**

The bedchamber sword of Tipu Sultan, the 18th century ruler of Mysuru, has sold for 14 million pounds (\$17.4 million or ₹140 crore) at an auction in London. Auction house Bonhams, which organised the sale, said the price on Tuesday was seven times the estimate. Bonhams further said that the sword was the most important of the weapons with proven personal association with the ruler. Tipu Sultan won fame in wars of the late 18th century. He fought against the Marathas on several occasions between 1775 and 1779.

"This spectacular sword is the greatest of all the weapons linked to Tipu Sultan still in private hands. Its close personal association with the Sultan, its impeccable provenance traceable to the very day it was captured, and the outstanding craftsmanship that went into its

The sword was found in the private quarters of Tipu Sultan's palace.

"The sword has an extraordinary history, an astonishing provenance and unrivalled craftsmanship. It was no surprise it was so hotly contested between two phone bidders and a bidder in the room. We are delighted with the result," Nima Sagharchi, group head of Islamic and Indian Art at Bonhams, said in a Tipu Sultan was given

the nickname "Tiger of Mysore" for the ferocity with which he defended his kingdom.

He pioneered the use of rocket artillery in wars and transformed Mysore into the most dynamic economy in India, Bonhams said on its website.

After Tipu Sultan was killed, his sword was presented to British Major General David Baird as a token of his courage, according to the auction house.

"We are focusing on the digitisation of the archival records (containing manuscripts, books, journals, newspapers and historic records of erstwhile kings). We have a total archival record of 55,88,000 and we have already digitised 38,88,000 records," Director, Archives, Archaeology and Museums, Jammu and Kashmir, Pradeep Kumar told PTI here.



The department has laid focus on digitisation of the archival records of rare and precious documents and files concerning the armies of the erstwhile 'maharajas' of Jammu and Kashmir.

# **Weather Woes**

ashmir has seen an extended rainy season after a winter that was mainly dry and also saw a significant jump in temperature in February. The meteorological department has been predicting erratic weather since March. And as things stand, the weather seems likely to remain uncertain going forward. This has pushed the temperature down, which is not good for farming.

Another fear is that the recurrent rain could trigger floods. We have been on the verge of floods for the past two months due to the prolonged rain. The possibility of another flood will persist if the weather doesn't get better. And if this happens, it would be a disaster. The memory of the 2014 deluge and its destructive fallout is still fresh in the minds of the people. And it could very well happen again.

These are legitimate fears considering we are still far from building credible safeguards against the prospect of a future flood. The carrying capacity of Jhelum is yet to be adequately enhanced to accommodate excess water. Though a government project to do so has been ongoing since 2014, it is yet to be completed. So, the administration would need to proactively work on the project to reduce the chances of yet another big flood. And until that happens, people will continue to live in dread of rain.

Every time, erratic rain extends for a longer duration in a warmer season, we are reminded of our hapless vulnerability to flooding. More so, in Srinagar whose new-found susceptibility to flood threatens to put a question mark on its viability as a summer capital. That is, unless we conceive and execute a course of action that drastically reduces this vulnerability.

On the other hand, one benefit of colder weather in spring has been the rise in tourist inflow. Tourists are flocking to Kashmir in large numbers. Around 2.5 lakh tourists visited the Valley in the first two months of this year and since then the numbers have only gone further grown. The recently concluded tulip festival attracted over 3.75 lakh tourists, while Gulmarg saw over 2 lakh tourists during the winter. Last year, J&K witnessed over 26.7 lakh tourist arrivals, the highest in the last three decades. These are impressive figures.

The growing tourism has gone a long way to shore up Kashmir's economy and bring back employment lost to the successive security and COVID-19 lockdown. The boom in the sector is also having a positive spillover effect on other sectors. That said, a big flood has the potential to undo the gains of tourism. So, the administration needs to ensure that the city's water bodies such as Jhelum and flood channels have sufficient capacity to take the rainwater.



he lack of stable employment opportunities offering a reasonable income and a modicum of security can be identified as the single most important challenge facing the Indian economy. If this issue could be adequately resolved, then the associated problems of poverty, insecurity, crime, and a host of other social problems could be dramatically reduced. The data on unemployment — its measures, its incidence, and its different forms — become extremely important for policymakers in this context. However, during the past seven or eight years, the quality of the data on unemployment has become contentious. The deterioration in the quality of official Indian economic statistics as well as the reliability of what is available has been part of a bigger problem of the government not willing to face unpleasant realities. The unemployment figures measured by official sources are available from the Periodic Labour Force Survey. These statistics show an improvement in unemployment rates in recent times. The rate of unemployment was measured at around 4.1% in March 2022, down from 4.2% in March 2021. On the other hand, the most well-known nongovernment source of data on the Indian economy is available from the Centre for Monitoring Indian Economy. According to the CMIE, unemployment in India in May 2022 was 7.14%; the figure has increased to 8.11% in April 2023. The trends for and the levels of unemployment are quite different in the two measures.

One reason for the variation in estimates stems from the way employment is defined. The PLFS defines activity as employment. Hence, if a person has been engaged in an activity for the better part of 365 days preceding the survey, the activity is taken as primary. If the respondent engaged in some additional activity during the 30 days preceding the survey, then the activity is taken as secondary. There is no direct reference to income. The estimate of the unemployment rate turns out to be lower because this methodology includes unpaid work, such as women's work in a household, as gainful employment. On the other hand, the CMIE estimates, keeping to more accepted international norms, treat employment only as some form of paid activity. One cannot be gainfully employed without receiving a remuneration. The PLFS methodology reveals the attitude of the government. It reduces the importance of increasing women's labour force participation rate by treating women engaged in household work as already employed. It also shows that the government is unwilling to face the unemployment problem squarely. This is unwarranted and worrying.

# WORKING FROM HOME AND REALISING WHAT MATTERS

The US economy has experienced a remarkable recovery from the Covid recession of 2020. The much-feared scarring effects of the pandemic never materialised: Employment, labour force participation and gross domestic product are right back in line with projections made before the pandemic struck.

We're still waiting to see whether House Republicans will squander that achievement by pushing America into a completely gratuitous debt crisis. But today I thought I'd take a break from the anxiety and talk about one important way in which the US economy is doing even better than the standard numbers suggest. One silver lining of the Covid-19 crisis has been a major change in the way Americans work; we're wasting a lot less time and fewer resources on commuting.



A few days ago, my colleague Farhad Manjoo wrote an excellent article about the benefits of reduced commuting, which inspired me to take a deeper dive into the issue. Although it has its downsides — what doesn't?

— the shift to remote and hybrid work is, overall, a very good thing, even if (or maybe especially if) Elon Musk hates it.

The shift to remote work is also a teachable moment, in at least two ways. First, it's an object lesson in the fact that taking advantage of new technological possibilities often requires major changes in how business operates. Second, it's a reminder that economic numbers like GDP, while useful, can sometimes be misleading indicators of what really matters in

First things first: The reduction in commuting time is a seriously big deal. Before the pandemic, the average American adult spent about 0.28 hours per day, or more than 100 hours a year, on work-related travel. (Since not all adults are employed, the number for



workers was considerably higher.) By 2021, that number had fallen by about one-quarter.

Putting a dollar value on the benefits from reduced commuting is tricky. You can't simply multiply the time saved by average wages, because people probably don't view time spent on the road (yes, most people drive to work) as fully lost. On the other hand, there are many other expenses, from fuel to wear and tear to psychological strain, associated with commuting. On the third hand, the option of remote or hybrid work tends to be available mainly to highly educated workers

with above-average wages and hence a high value associated with their time.

But it's not hard to make the case that the overall benefits from not commuting every day are equivalent to a gain in national income of at least one and maybe several percentage points. That's a lot: There are very few policy proposals likely to produce gains on that scale. And yes, these are real benefits. CEOs may rant about lazy or (per Musk) "immoral" workers who don't want to go back into their cubicles, but the purpose of an economy is not to make bosses happy.

What's interesting is that this transformation of the way many Americans work wasn't driven by new technology. True, it wouldn't have been possible if many people didn't have fast Internet connections, but the big surge in home broadband took place from 2000 to 2010, then levelled off. It was only under the pressure of the pandemic that businesses learned to take advantage of the technological possibility of remote work.

The thing is, while the pandemic economy is now behind us, the change in how we work is looking permanent. Overall, work from

home looks like a classic example of an infant industry — an initially uncompetitive industry given a temporary boost (typically provided by tariffs or subsidies but in this case by a virus) that learns by doing and remains competitive even after the support is removed.

If the rise in remote work does turn out to be permanent, it will have profound economic effects, with some losers (such as commercial real estate and the tax bases of many cities) but many winners. One thing it won't do, however, is show up as a rise in measured GDP: The time Americans waste in traffic jams isn't subtracted from national income, and the time they spend with their families isn't added.

I'm not one of those critics who say that GDP is a useless number; it's an informative statistic and not easily replaced. But it can be misleading when societies make different choices. Anyone who does international comparisons knows that America has higher GDP per capita than European countries but that a large part of the difference doesn't reflect higher US productivity; it reflects the fact that Europeans get a lot of vacation time, while we're the "novacation nation." So are we better off? Are you

Now we're seeing major gains at home that aren't captured in GDP. True, these gains are accruing largely to higher-income workers, which is unfortunate; however, we've also seen large wage gains at the bottom, somewhat alleviating the unfairness.

And one implication is that if we look at what an economy is for — namely, to serve human needs, not generate favourable statistics — America's bounce back from the pandemic has been even more impressive than you may realize

## The End Of King Dollar? The Forces At Play In De-Dollarisation

LONDON: Rivalry with China, fallout from Russia's war in Ukraine and wrangling once again in Washington over the U.S. debt ceiling have put the dollar's status as the world's dominant currency under fresh

Russia's sanctions-imposed exile from global financial systems last year also fuelled speculation that non-U.S. allies would diversify away from dollars.

Below are some arguments why de-dollarization will happen - or possibly why it won't. **SLIPPING RESERVE STATUS** 

The dollar share of official FX reserves fell to a 20-year low of 58% in the fourth quarter of 2022, according to International Monetary Fund data.

Stephen Jen, CEO of Eurizon SLJ Capital Limited, said that shift was more pronounced when adjusted for exchange

"What happened in 2022 was a very sharp plummeting in the dollar share in real-terms," Jen said, adding this was a reaction to the freezing of half of Russia's \$640 billion in gold and FX reserves following its 2022 invasion of Ukraine

This had sparked a re-think in countries such as Saudi Arabia, China, India and Turkey about diversifying to other currencies. TAKING THE LONGER VIEW

The dollar share of central banks' foreign reserves in the

final quarter of 2022 did hit a two-decade low, but the move has been gradual and it is now at almost a similar level as 1995.

Central banks put rainy day funds in dollars in case they need to prop up exchange rates during economic crises. If a currency weakens too far against the dollar, oil and other commodities traded in the U.S. currency become expensive, raising living costs and fuelling inflation.

## **I-T Exemption Limit For Leave Encashment Upon Retirement For** Salaried Employees Hiked To Rs 25 Lakh

**NEW DELHI:** In line with the Budget announcement, the finance ministry on Thursday hiked the tax exemption limit for leave encashment upon retirement for private sector salaried employees to Rs 25 lakh.

So far, the tax exemption on leave encashment for nongovernment employees was Rs 3 lakh which was fixed in 2002, when the highest basic pay in the government was Rs 30,000 per month.

The Central Board of Direct Taxes (CBDT), in a statement, said the aggregate amount exempt from income tax under section 10(10AA)(ii) shall not exceed the limit of Rs 25 lakh, where any such payments are received by a non-government employee from more than one

A simple scan of the QR code at the back of pamphlet is being provided to farmers during Kisan Sampark abhiyan which takes them to Daksh Kisan Portal where he can register for free and undertake any skilling course of

Attributing the credit of this rare accomplishment to ambitious 'Kisan Sampark Abhiyan', the offcial said that the initiative launched on 24th April 2023 has completed five rounds till this week with coverage of about 1367 panchayats. He asked them to completely desist from taking mining materials without issuance of proper e-Challan and making maximum utilisation of e-Marketplace created by the department for sale and purchase of minor minerals across the UT of J&K.

While reviewing overall performance of the department over the last few months, Secretary assessed the current status of e-auctioning of mining blocks in all districts and issued directions towards maximising revenue targets through royalty, fees, penalties, etc. He asked the concerned officers to step up efforts towards creation of new mining blocks in all districts which should be put at e-auction through Single Window Clearance. # **Foreign-Registered Online Game Portals Sent** ₹4,000 Crore Abroad, Raided By ED

**NEW DELHI:** The Enforcement Directorate (ED) on Wednesday said it detected illegal foreign remittances of about ₹4,000 crore after it carried out multistate raids against foreignregistered online gaming websites and companies operating in the country in alleged violation of the foreign exchange law.

In a statement, it said that ₹19.55 lakh and more than USD 22.600 in cash were seized apart from freezing ment Act (FEMA)

55 bank accounts during this operation carried out under the provisions of the Foreign Exchange Manage-The searches were carried out on May 22-23 at 25 premises in Delhi, Gu-

jarat, Maharashtra, Mad-

hya Pradesh and Andhra

The federal probe agency said the raids led to the finding that these online gaming companies and websites were registered in small island countries like Curacao, Malta and Cyprus. "However, all of them are

linked to Indian bank accounts opened in the name of proxy persons who have no links with online gaming activity. The amount collected from the general public through gaming websites is then routed through multiple bank accounts and finally remitted out of India by mis-declaring the purpose of remittances against import of services and goods.

"Remittances out of the income from racing/riding etc., or any other hobby are not allowed under the provisions of FEMA, 1999," it said.

Vipin Kumar Tripathi, former professor at IIT, Delhi, lauded the efforts of the author and the IOS for bringing out an in-depth book on Gandhi at a time when speaking the truth is so dangerous that one's premises can be raided or even bulldozed.

The hailstorm was recorded in several areas in north Kashmir including Khamoh, Rafiabad, Wagoora, Kreeri, Ladoora, area of Baramulla, Haihama, Gutlipora, Kralpora, Trehgam, Sogam, Drugmulla, Salkoot and other areas in Kupwara. A few districts including Kulgam in South Kashmir also witnessed hailstorm this afternoon.

Kashmir Power Distribution Corporation Limited (KPDCL), Chief Engineer, Javed Yousuf Dar said that there was no major breakdown in the electricity due to the inclement weather conditions.

However, he said that some of the places witnessed damage after tree branches fell on the power lines, adding that the electricity was being restored.

"The men and machinery have been pressed into service and the electricity will be restored at earliest," he said. Electricity was restored in most of the places after a two to three hour breakdown, reports said.

Meanwhile the weatherman here has predicted intermittent light to moderate rainfall at most places of Kashmir in next 24 hours.

foregoing analysis of law on the subject, it is clear that, at the time of considering a petition for quashing of an FIR, the court has only to consider whether the allegations made in the FIR disclose commission of a cognizable offence. It is not required to analyse the merits of the allegations and the court has to permit the investigating agency to investigate the allega-

"It is further laid down that the power of quashing criminal proceedings has to be exercised very sparingly and with circumspection and that too in the rarest of rare cases and the Court should not embark upon an enquiry as to the reliability or genuineness or otherwise of the allegations," the court said.

Dismissing the petitions, Justice Dhar observed that the allegations clearly disclose commission of cognisable offences, and therefore, it would not be open to the court to stifle a genuine prosecution by interdicting the investigating agency from undertaking investigation and launching prosecution against the arraigned officials and parties.

On the contentions raised by Kapoor, the court said it has been established during investigation of the case that most of the drugs supplied were not manufactured by the suppliers but by other private drug manufacturers as was evident from the labels affixed upon these

"It was also found that the members of the verification board including the petitioner had certified that the procured drugs are of standard quality without actually undertaking any check in this regard," the judge said.

The court rejected the argument of other petitioners that they do not fall within the definition of "public servant" as contained in Jammu and Kashmir Prevention of Corruption Act, as such, the respondent does not have jurisdiction to probe their role.

The argument, it appears, is without any merit for the reason that, even if, it is assumed that the petitioners/Managing Directors of CPSEs (Central Public Sector Enterprises) are not public servants within the meaning of sub Section (2) of Section 2 of J&K P.C Act, still then, it is a settled law that a person, who is not a public servant can be prosecuted for the offence of criminal conspiracy along with other public servants, who have been booked for substantive offences under the said Act," the judge observed.

Apart from this, he said the expression "public servant" as per clause 15 of Section 21 of RPC includes every officer or servant of a corporation or of a government company.

... Therefore, while investigating an offence under the provisions of J&K P.C Act that has been committed within the erstwhile State of Jammu and Kashmir, if role of a person, who qualifies to be a public servant surfaces, he can be booked and prosecuted for having committed an offence under the provisions of J&K PC Act even if he resides beyond the limits of the State of J&K," the judge said.

allowing a challenge regarding initiation of contempt proceedings by the J&K Special Tribunal regarding SMC authorities with regard to a building permission case. While the Tribunal is not vested with any

power, directly or indirectly, to punish for contempt in relation to itself or any member thereof, the court held that the Tribunal is conferred the power of Civil Court to punish a person for contempt in relation to itself or any member thereof under Rule 21 of the Jammu and Kashmir Special Tribunal Rules, 1986.

"Since the Civil Court is not vested with any power to punish a person for contempt in relation to itself, as such, such power should be understood to mean the power conferred upon a Civil Court under Order 39 Rule 2-A of the Code of Civil Procedure, to punish for disobedience of interim injunctions passed by a Civil Court under Rules 1 and 2 of Order 39 of the Code of Civil Procedure only," the court said.

That would mean that the Tribunal too shall have jurisdiction to punish a person for disobedience of its interim orders of injunction passed to maintain the equilibrium or to preserve the list (complaint or petition) etc. etc, it said.

..the Tribunal shall be deemed to be a "court" subordinate to the High Court for the purposes of Section 10 of the Contempt of Courts Act and, therefore, shall be well within its powers to refer an appropriate case to the High Court for initiating appropriate proceedings against the violators of its orders or against those who commit its criminal contempt."

The Tribunal shall also be entitled to proceed under Section 345 of the Cr. P. C, where the contempt committed in the view of or in presence of the Tribunal is an offence described under Sections 175, 178, 179, 180 and 228 of the Indian Penal Code, the court added.

It will be imperative for the defending champions that their batting clicks in unison, since Shubman Gill and Vijay Shankar have done bulk of the

# Final Call On Asia Cup Venue To Be Taken After IPL Final: Jay Shah

**NEW DELHI:** A decision on Asia Cup's fate will be taken on the sidelines of the IPL final, which will be attended by a host of top Asian Cricket Council (ACC) dignitaries, BCCI secretary Jay Shah said on Thursday. Pakistan have the hosting

rights for this year's Asia Cup but with BCCI deciding against sending its team to the neighbouring country without government permission, PCB chairman Najam Sethi had proposed a 'hybrid model' where they will organise at least four games on home soil and India will play their matches at a neutral venue.

It couldn't be confirmed whether Sethi has been formally invited for the IPL final. "As of now, the decision with regards to hosting of Asia Cup hasn't yet been finalised. We are busy with IPL but the top dignitaries of Sri Lanka Cricket (SLC), Bangladesh and Afghanistan Cricket Board are coming to watch the IPL final. We will have a discussion and take a final decision in

due course," Jay Shah told PTI. It has been learnt from ACC sources that Sethi's proposed hybrid model looks like a feasible solution although ACC had made no formal statements. According to the model, Sri Lanka, Bangladesh, Nepal and Afghanistan play four preliminary matches in Pakistan and India would play all their games at neutral venues, The two India-Pakistan games will also be held in Sri Lanka although the PCB wants them in Dubai. The weather in UAE in September is not at all conducive for 50- over games although to make the 'hybrid model' work logistically,

UAE is a far better option for the Asian Cricket Council.

"ACC head Jay Shah will summon an executive body meeting where a formal announcement will take place. The PCB doesn't mind playing India at a neutral venue. "PCB would prefer Dubai because it would lead to more gate receipts but it is open to playing in another country (read Sri Lanka) provided the ACC matches the gate receipts amount (USD 0.5 million) that Sri Lanka Cricket (SLC) received in 2022 from the Indo-Pak games in Dubai," an ACC source privy to development told PTI on conditions of anonymity.

# **Bharat Obvious Choice In** WTC Final: Shastri
