### **Central Agency** Warns Of Dangerous **Phone Virus**

### **Press Trust Of India**

New Delhi: An Android malware called 'Daam' that infects mobile phones and hacks into sensitive data like call records, contacts, history and camera has been found to be spreading, the national cyber security agency has said in its latest advisory.

The virus is also capable of "bypassing anti-virus programs and deploying ransomware on the targeted devices", the Indian Computer Emergency Response Team or CERT-In said.

The agency is the federal technology arm to combat cyber attacks and guard the cyber space against phishing and hacking assaults and similar online attacks.

The Android botnet gets dis-tributed through third-party websites or applications downloaded from untrusted/unknown sources, the agency said.

### **NIA Seeking Death Penalty For Yasin Malik**

New Delhi: The National Investigation Agency (NIA) Friday approached the Delhi High Court seeking death penalty for separatist leader Yasin Malik, who was awarded life term by a trial court here in a funding case.

The plea by the agency has been listed for hearing on May 29 before a bench of Justices Siddharth Mridul and Talwant Singh.

On May 24, 2022, a trial court here had awarded life imprisonment to Malik, Jammu Kashmir Liberation Front (JKLF) chief, after holding him guilty for various offences under the stringent Unlawful Activities (Prevention) Act (UAPA) and the IPC.

The trial court, which had rejected the NIA's plea for capital punishment, had said the crimes committed by Malik struck at the "heart of the idea of India" and were intended to forcefully secede Jammu and Kashmir from Union of India.



## Bread, Pasta Made From Air? Revolutionary Food Gains World's Attention

t doesn't look particularly appetizing - a mustard yellow-hued powder with the texture of starch - but the ingredient that made its global debut in Singapore on Thursday is being touted as the latest breakthrough in food technology. Produced from air, water, electric-

Produced from air, water, electricity and microbes by Finnish startup Solar Foods, the substance can be used to make anything from bread to pasta. It had its first official tasting after the city-state approved the sale of products containing the ingredient last October.

The powder itself resembles tur-

meric and tastes like a light, nutty mix of cashews and almonds. It's 65% to 70% protein, 5% to 8% fat and has a composition similar to that of dried soy or algae. Making food from air? That's how this nutty, turmeric-like powder was made by Finnish startup @Solar\_Foods.@DextLow gets a taste of the ingredient as it makes its global debut in Singapore


Solein, as it's called, builds on a growing microbial fermentation trend. It's made in a similar way as brewing beer. Instead of sugar, microbes feed on nitrogen and carbon dioxide, and begin to grow. Excess water is removed and then it's dried, forming a powder.



The technology's gaining attention, even as investors cool on the broader alternative protein sector, given it has the potential to produce edible calories without farmland. Crop giant Archer-Daniels-Midland Co. is lending its heft, announcing a strategic partnership this month with California company Air Protein to build and operate a commercial-scale plant.

It will take "a couple of decades" for food-from-air production volumes to have a real impact on the world, Solar Foods Chief Executive Officer Pasi Vainikka said in an interview. "There's a lot of interest and pull from the consumer, and that's a positive." Solein won't be widely available until 2024 at least when a small-scale proof-of-concept plant is fully operational. The glacial pace of approvals is one factor that's slowing its rollout. Singapore is the only jurisdiction that's given Solein the green light. Approval in the European Union isn't expected before 2025, Vainikka said.

For now, the Finnish firm is working with food companies and restaurants to incorporate the product in dishes, or as an alternative dairy ingredient. It's also on a marketing blitz, releasing videos demonstrating the practical uses of Solein, including in ice cream and ravioli.

"After the conclusion of the G-20 event in Srinagar, the execution of works will gain even more pace," he said.



'EW YORK, MAY 05: Copycat variants of the "Love Bug" vi¬rus labeled "Joke" and "Moth¬er's Day" infected computers around the world on Friday, a day after the most widespread cyberattack ever-wreaked havoc on business and govern¬ment operations.

Tens of millions of the com¬puters have been disabled so far as the virus, first detected in Asia, spread around the globe, forcing network admin¬istrators to shut down e-mail systems at major companies and penetrating the Pentagon, the Central Intelligence Agency and Britain's Parliament.

Security experts said the vi¬rus was far more devastating than last year's Melissa bug, with losses now counting in the billions from damaged data and the distractions of fighting the software scourge, and warned that it could take weeks to stem the invasion

"There's a potential ' that anyone who receives this virus can go to the Internet and (nd) tools to change codes within the virus program that can give the e-

mail or the attachment a new name," said Simon Perry, vice president for security products at Computer Associates International Inc. (NYSE : CA - news).

The Islandia, N.Y is a leading maker of anti-Virus software such as inoculuteIT.

For the time being, most of the virus variants are only cos-metically different from the original virus. "Based on our research, we believe that the variants are coming from a number of different people," Perry said.

ASIA AND EUROPE TAKE STOCK OF IMPACT: Computer users woke up on Friday to the chilling implications for a world that is now so wired up that quarantining such bugs may prove an endless cat-and—mouse game — with far- reaching financial consequences.

Computer Economics, a market research firm located in Carlsbad, Calif, estimated that the virus already had caused \$2.61 billion dollars in damages worldwide, but most experts said precise figures would be difficult to pin down.

The impact of the bug in Asia on Friday was possibly muted by the fact the markets in four countries-Japan, South Korea, China and Thailand - were closed for pub-lic holidays on Friday

European Enterprise Com-missioner Erkki Liikanen said: "The Love Bug is a warning to us all that security must be given top priority if consumer and user confidence is to be maintained as we move into the information age."

A German government spokeswoman said the virus had penetrated its foreign, jus¬tice, interior and economics min¬istries. The spokesman re¬ported no serious damage as the interior ministry called in a special task force to advise on coun¬ter-measures.

Britain's Consumers Asso-ciation said 30 to 50 percent of UK businesses seemed to be af-fected. "It is spreading very rap¬idly. Yesterday we had 10 to 15 percent," said Alan Stevens. Kit experts warned the full effects of the bug may carry

through the weekend.

### Hirmand River water rights

"We have mentioned to Afghan officials that the issues relating to water rights will not be resolved through political statements and that they must be followed through via a legal framework," Amir-Abdollahian added. Iran and Afghanistan have been locked in a long-running dispute over their shared water resources. At the heart of the dispute is the Hirmand River, which flows 700 miles (1,126 kilometers) south before flowing into Hamoun wetlands, located in Sistan and Baluchestan province. Following more than a century of rifts over Hirmand's water supply, Iran and Afghanistan signed a treaty in 1973 to establish a means of regulating each country's use of the river. Iran should receive an annual share of 820 million cubic meters from Hirmand under the accord, which Afghanistan has grossly violated in letter and spirit, endangering the lives of many Iranians who rely on Hamoun wetlands for drinking water, agriculture, and fishing.

ISLAMABAD: Pakistan's former Prime Minister Imran Khan today thanked the country's government for putting him on a 'no-fly list' stating that he does not plan to go overseas as he does not have any property or businesses abroad and does not hold even a bank account outside the country.

"I want to thank the government for putting my name on the ECL (Exit Control List) as I have no plans to travel abroad. because I neither have any properties or businesses abroad nor even a bank account outside the country. If and when I do get an opportunity for a holiday, it will be in our northern mountains, my favourite place on earth," Imran Khan tweeted.

On Thursday several media outlets reported that Mr Khan, his wife Bushra Bibi and other leaders and former assembly members of his Pakistan Tehreek-e-Insaf (PTI) party were reportedly barred from leaving the country.

This statement came after various media reported citing sources that Imran Khan would be added to the no-fly list.

"IK (Imran Khan) added in No Fly List," The Pakistan Daily tweeted quoting sources. The Pakistan Daily is a digital news portal in Pakistan mainly reporting about the political updates of Pakistan. However, there has been no official confirmation of Imran Khan being

added to the no-fly list. This comes a day after Pakistan Defence Minister Khawaja Asif said that the government is considering imposing a ban on the Pakistan Tehreeke-Insaf (PTI) over the incidents that took place on May

9, Dawn reported. The Pakistani news channel, Geo News sources reported over 600 Pakistan

Tehreek-e-Insaf (PTI) leaders and former assembly members including Chairman.

According to sources within the Federal Investigation Authority (FIA), the names of the PTI leaders and its party chief have been added for their involvement in the May 9 violence.

The names have been added to the FIA's Provisional National Identification List (PNIL) to prevent them from going abroad, added the sources.

The former prime minister's wife Bushra Bibi's name has also been added to the list. The list includes Murad Saeed, Maleeka Bokhari, Fawad Chaudhry, Hammad Azhar, Qasim Suri, Asad Qaiser, Yasmin Rashid and Mian Aslam Iqbal, reported Geo News.

The sources further claimed that some of the PTI leaders and office bearers tried leaving the country in the last three days, however, they were stopped at the airports.

## **Kidnapped Woman Found After 17** Years In Delhi: Cops

NEW DELHI: A 32 years-old woman who was kidnapped 17 years ago in 2006 was found in Delhi's Gokalpuri, police said on Thursday.

According to DCP Shahdara Rohit Meena, "On 22 May, a team of Seemapuri Police Station on secret information traced the kidnapped girl age 32 years (now) who was kidnapped 17 years ago.

Accordingly, a case registered under section 363 IPC, was registered in 2006 at Gokulpuri Police Station, Delhi on the complaint of her parents, they added.

"The girl was kidnapped in 2006 and during the investigation, the girl disclosed that after leaving her house she was residing with a person namely Deepak in the village Cherdih District Baliya, UP and thereafter she left Deepak in lockdown after some dispute and started living in Gokalpuri in rented accommodation," police stated. According to DCP Shahdara Rohit Meena, 116 kidnapped/abducted children/persons, and 301 missing persons were recovered by Shahdara district to date in 2023.

### Bangladeshi Man Tries To Fly To Rome With Fake Indian Passport, Arrested

MUMBAI: A 32-year-old Bangladesh national, who claimed to be a Buddhist monk, has been arrested here for trying to travel to Rome on an Indian passport that he had obtained by providing fake documents, an official said on Friday.

Bipon Anil Barua, a resident of Bandarban in Bangladesh, was apprehended at Chhatrapati Shivaji Maharaj International Airport on Wednesday night, the official said.

Barua was to fly to Rome via Muscat from Mumbai in the early hours of Thursday.

When an immigration officer keyed in his passport details in their system, he found that a Look Out Circular (LOC) has been issued against him by the Foreigners Registration Office (FRRO), Mumbai, the official said.

An LOC is a notice which prevents a person from leaving the country.

According to remarks on the LOC, Barua is a Bangladeshi passport holder. He used fake papers to fraudulently acquire an Indian passport.

Barua told officials that he is a Buddhist monk and came to India from the neighbouring country via the Haridaspur border in 2015 to propagate Buddhism, he said.

During his stay in Chhattisgarh capi-

tal Raipur in 2016, Barua said he procured an Indian passport with the help of bogus papers.

Since then, the official said, Barua used the Indian passport to visit Malaysia, Thailand, Laos, Myanmar, Vietnam, and the United Kingdom, Immigration officials also re-

covered PAN and Aadhaar cards from him, he said.

Barua was taken to the Sahar police station where a case was registered against him under Indian Penal Code sections 420 (cheating), 465 (punishment for forgery), 468 (forgery for purpose of cheating), and 471 (using fraudulent document as genuine) and the Passports Act.

## **Farmers In Doda Switch To Medicinal Plants Cultivation To Keep Hungry Monkeys Away**

JAMMU: Farmers in Jammu and Kashmir's Doda district are switching to cultivation of medicinal plants instead of crops like rice, maize and wheat to save their farms from hungry monkeys. The depletion of forests have forced the primates to raid farms in search of food, leading to substantial losses to the farmers.

In response, agricultural experts from the AYUSH Ministry have advised farmers to grow herbs instead of traditional crops like rice, wheat and corn, as this not only safeguards their crops but also brings in higher profits.

Many farmers from villages located near forest areas in Doda have embraced this solution and are now cultivating aromatic plants such as lavender and Tagetus Minuta, along with medicinal plants like Trillium (Nag-Chatri), Saussurea Costus (Kuth), Inula (Mannu), Dandelion (Handh), wild garlic and Balsam apple (Ban-Kaakri). These plants taste bitter and have strong pungent smells, making them unappealing to monkeys, officials said. Touqeer Bagban, a local en-

trepreneur, said farmers are now reaping better profits due to surging demand for herbs from domestic companies making medicinal and personal care products.

"Officials from the AYUSH Ministry have been actively educating farmers on cultivating suitable crops based on the soil, water and air conditions in their respective areas. They also provide necessary training and planting materials to support the transition," Bagban said. The transition to cultivate medicinal plants has revitalised the

## **HC Quashes PSA detention Order**

### **Detention Verbatim** Except 'Cosmetic' Changes

SRINAGAR: The High Court of J&K and Ladakh on Friday quashed detention order under Public Safety Act against a resident of Pattan Baramulla and ordered his immediate release if not required in any other case.

"A comparative perusal of the grounds of detention and the dossier furnished by the sponsoring authority would reveal that the grounds of detention are verbatim reproduction of the contents of the dossier except the cosmetic changes," a bench of Justice Rajnesh Oswal said.

The detaining authority, the court said, was required to apply its mind independently with regard to the material placed before it so as to derive satisfaction that it has become necessary to

detain the petitioner (detainee), Farhad Ahmad Lone of Zangam Pattan Baramulla. "But the same has not been done in the instant case. This too renders the detention order illegal."

The perusal of the record, the court said, also revealed that the petitioner was already in custody when the detention order was passed. "From the ground of deten-

tion, nothing is forthcoming as to what compelled the respondent (district magistrate Baramulla) to pass the detention order when the petitioner was already in custody," the court said, "There is no reference either in the dossier or in the grounds of detention that the petitioner had preferred any bail application before the trial court."

Accordingly, the court quashed the detention order passed on 9 April 2022 and directed authorities to release him from preventive custody forthwith "if not required in any other case."

## Why the Future of Kashmiri Literature is Promising?

**This process** is important to the fact that Kashmiri language is not decaying but flourishing in its literary episteme. There may be lacunae here and there and they call for the necessary remedial measureS but these can't be equated with the downfall and decay of language and literature

hen Nighat Sahiba re-leased her poetry collection "Zarred Panneki Daer" (Piles of Pallid Leaves), it put speculations about the decay of Kashmiri literature to rest. The book heralded, as critics and readers observed, a new era in Kashmiri poetry; its feminine adding to its thematic nuance. The book went on to earn Sahitya Academy Yuva Puruskar in 2017 and is still being discussed, scrutinised, evaluated and critically appreciated. It is not the book which concerns us here, but the active participation of the younger generation in the production of quality literature in Kashmiri language, meaningful engagement with the mother tongue and wearing Kashmiri language on sleeve. It is not only in the domain of poetry that quality creations are brought forth, but the genre of prose, literary criticism, aesthetics and other allied branches of literature have seen similar sprouting and blossom in terms of the quality and quantity of works being produced. On the whole, the horizon is promising and what is more interesting is that the production of these quality works is coming through the younger generation of writers and scholars. This state of affairs is at variance and polar opposition to the apprehensions being expressed now and then that Kashmiri literature is on the decline and the younger generation of writers has shunned away their mother tongue. What is seen on the contrary is that there is a situation of hope and optimism and an entire cadre of writers has emerged who are not only taking pains to preserve the literary legacy of Kashmiri lan-

ing to its treasure. In the contemporary global village of closely knit world, translations have come to play an important role both in enriching any language with the translations of classics and rendering the literary works from the native language into other global languages for the wider readership – and so consoling and promising it is to see exchange taking place both the ways. Mufti Muddasir's rendition of Mahmud Ghami into English recent-

guage, but also enriching it and add-



ly, published under Penguin Classics is a glaring illustration of the scope and appeal of Kashmiri literature and the kind of interest people are cultivating towards the same. Rehman Rahi, the poet laureate of Kashmir, of whom we had complained elsewhere that he was lost without translation has been translated into English and an anthology of his translated poems is set for a release.

On the other hand, a massive work and a world classic like War and Peace by Tolstoy has been rendered into Kashmiri, not to speak of Wuthering Heights, King Lear, Qaseeda Burda, Payam E Mashriq etc. Likewise Lal Ded has been translated more than once and exhaustive works on her life and times, her poetry and mysticism has been produced world over. This process is important to the fact that Kashmiri language is not decaying but flourishing in its literary episteme. There may be lacunae here and there and they call for the necessary remedial measureS but these can't be equated with the downfall and decay of language and literature. In our previous ar-

ticle, we made a point that we do not remember our literary ancestors and now we are pleading the bright future of Kashmiri literature. Something important is to be noted here if we want to avoid the apparent conflict between these two statements.

The production of literature is the task specific to the literary elite, who either specialise in language and literature or have an innate propensity for literature which manifests in their literary outpour. But the consumption of literature, reading books written by authors and to give any work of prose or poetry an ascent to acceptability is usually the function of masses, not en masse, but a larger section thereof. It was in reference to this general distancing of masses from their language and literature that a caution was raised

in the last article. But let it be stated with a stamp of confidence and evidence that the men of literature are doing wonderful in their respective domains and are bringing laurels, not only to themselves, but the Kashmiri language and literature in general. With that caveat in place, those having little hope for the future of Kashmiri Literature can only be invited to the works of younger writers like Adil Mohiuddin, Masroor Muzaffar, Sagar Sarfaraz, Showkat Sufi, Dheeba Nazir, Rafia Wali and countless others to discover for himself that the future of Kashmiri literature is bright indeed.

The environmental cost and the financial pressures of securing good sleep are rising.

he world celebrated 'sleep day' in March in the hope of good and healthy sleep, but a survey on sleep among Indians by LocalCircles has thrown up jarring numbers on the quality of sleep in India. Titled "How India Sleeps", the survey of 13,438 people across India found that 55% of respondents take less than 6 hours of continuous sleep per night. Only 43% are taking 6-8 hours of uninterrupted sleep while 21% are sleeping up to 4 hours without interruption.

Are we living in a sleep epidemic? If we analyse the figures presented by the survey, we can safely see a pattern where the majority

of respondents have a sleep deficit of 2-3 hours daily, 60-90 hours monthly, and 730-1,095 hours annually. Most of us sleep unevenly. Fractured and reduced sleep has, evidently, become a standard feature not only in India but, as other studies have indicated, also in the United States of America and the United Kingdom.

Historians of sleep have tried to understand how people have slept over centuries. A. Roger Ekirch suggested that people's sleeping habits changed with industrialisation since the nineteenth century. According to him, before industrial work ethics, people in the West took biphasic sleep — that is, they slept in two halves with a break around midnight. But with the growth of artificial lighting, industrial work culture, and socialisation at night, people shifted to a single-segment sleep — one consolidated long sleep.

What is happening now is that even that consolidated sleep is getting reduced. The LocalCircles survey reveals that in 2022, about 50% people slept less than 6 hours; in 2023, this percentage has increased to 55. Pressures on sleep continue to grow with the entrenchment of information technology, visual media, flexible work hours, and the rapid growth of the 24x7 service economy. An accelerated economy needs labour power that is available 24x7 in shifts. At the same time, the sleep industry, which has commodified sleep, is to touch the 101-billion-dollar mark in 2023. A sleepless person can buy comfort pillows, perfect bedding, sleeping pills, sleep-inducing beverages, sleep music, sleeping apps, and self-help books on how to sleep better. Coolers, air conditioners, heaters, and air purifiers have all made permanent abodes in our bedrooms to improve our sleep. The environmental cost and the financial pressures of securing good sleep are rising.

The LocalCircles survey points out various factors causing sleep disturbances in this order: waking up to go to washrooms (61%); going to bed late and early morning domestic work (27%); disturbances resulting from mosquitoes and noise pollution (24%); medical conditions (20%); childcare and partner needs (12%); mobile calls and messages (14%); uncomfortable bedding (10%); and other interruptions (10%). Now compare this survey to a 2005 study in the UK where the key sleep disrupters were childcare (41%), work worry (15%), and noise. These surveys capture quite a lot but they also miss various individual circumstances, varied cultures of sleep, and climate change. For example, changing climate and hotter nights are adding to our sleep distress.

Sleeping little is associated with various diseases, reduced productivity, and increased stress. While some of the factors of sleep deprivation — work schedules, noise pollution, phone calls and messages, uncomfortable bedding — are controllable, others are not. The growing validity of late-night socialisation and online entertainment continues to steal hours from our sleep. Sleep is thus prey to the demands of both work and leisure. Rescuing sleep from these artificial factors needs to be the priority of governmental initiatives, family ethos, and personal care.

## **Previous Smallpox Vaccine Provides Immunity To Mpox: Study**

accines against smallpox given until the mid-1970s offer continuing immunity against monkeypox, a study conducted in Sweden has found.

During last year's mpox (formerly monkeypox) outbreak, the virus spread for the first time outside Africa, causing over 85,000 cases of the disease to date.

Men who have sex with men account for the most infections, with a marked skew towards the young, the researchers said.

The virus that causes mpox is known as an orthopoxvirus and is very similar to the virus that caused smallpox until the mid-1970s when it was finally eradicated.

Since there was data indicating that the old smallpox vaccine could protect against mpox, the researchers at Karolinska Institutet in Sweden wondered if the individuals who were vaccinated decades ago against the former would have some protection against the latter owing to a remaining memory response.

"Our study shows that this is the case, which implies that the memory cells are very long-lived and that they can recognize closely related viruses such as the mpox virus and provide overlapping, or cross-reactive immunity," said the study's corresponding author Marcus Buggert, researcher at Karolinska Institutet.

By analyzing the T-cell im-mune response in 105 healthy blood donors, the study, published in the journal Cell Host & Microbe, showed that individuals born before 1976 had a significantly stronger immune response against both

The researchers also analysed the immune response in 22 men with a recent mpox infection and showed that they also exhibited a strong immune response to the virus, which may

Mpox is a viral infection spread mainly through close physical contact with an infected person. Sexual contact poses a particularly high risk.

Common symptoms are blistering, sores and rashes, fever, and swollen glands. It can also cause

provide future immunity.

The current study was too small to judge how much protection previous smallpox vaccination provides, but Buggert refers to a recently published British observational study examining the effect of a smallpox vaccine given to riskgroup males in 2022.

This study shows that smallpox vaccine can provide about 80 per cent protection against mpox," he said.

In Sweden, the smallpox vaccination programme started in the early 19th century and was discontinued in 1976 when the disease was eradicated.

The vaccine was mandatory for the entire population. The vaccine currently given for mpox is essentially a smallpox vaccine.

## **Hailstorm Aftermath: Govt Deputes Teams To Access Damage To Horticulture Sector**

**KUPWARA:** The authorities in Jammu and Kashmir Friday said that they have deputed teams on the ground to access the situation caused due to the heavy intensity of the hailstorm on May 25. Also, the report collected shall be shared with the revenue department for compensation to those affected.

The unexpected natural calamity has resulted in widespread damage to fruit crops, leading to concerns for the horticultural community. The Director Horticulture

Kashmir, G. R. Mir Friday conducted an extensive tour of the affected areas. During the tour, the Direc-

tor visited villages of District Baramulla viz. Panzalla. Kangroosa, Chatoosa, Dazna and villages of District Kupwara viz. Hirri, Trehgam, Shumnag, Gugloosa and Awoora to assess the extent of the damage caused by the hailstorm, with particular focus on the severely affected regions of Rafiabad and Trehgam.

In this connection, the Joint Director Horticulture, Kashmir Z.A. Bhat also visited District Budgam to evaluate the impact on fruit crops in the area. Talking to reporters in Lan-

gate, Handwara the Director said that parts of Kashmir valley including both north and south Kashmir witnessed



heavy hailstorms. "Areas in north Kashmir were reported to have experienced a heavy hailstorm."

In Trehgam's belt, he said that the fruit has suffered up to 70 per cent damage due to hailstorms. "Apple, Cherry, Apricot, Walnut, and many other fruits have suffered immense damage. The hailstorm was of very high intensity leading to damage," he said.

The Director said that even the fruit still on tree branches is damaged. "Advisories about safety sprays have al-ready been issued but that is subject to weather conditions," he said, adding that teams have been sent to all areas across Kashmir valley to assess the situation. "Directions have been issued to officers to visit the affected areas. Teams are on field visits to access everything," he said. "There is a threat of scabs followed by a hailstorm to fruit trees. Teams on the

#### field remain in touch with the growers to advise them about safety measures. We work for the good of people," the director said.

Earlier in the day the director visited the Trehgam belt in Kupwara, where he interacted with the fruit growers and others associated with horticulture activities.

About the damage, he said that his team is accessing the condition and there is no denying in accepting that the growers have suffered damage.

"In some orchards, about 70% of the fruit suffered damage. An Advisory has already been issued about preventive measures. A lot of the precautionary measures depend on stable weather conditions as well," he said. "The damage caused is being accessed. It will be shared with the revenue department. As per norms the compensation after proper assessment shall be given to those affected."

SRINAGAR: Kashmir is witnessing a sharp decline in cocoon production in the last few years due to constant financial losses.

News agency KNO quoting anonymous officials reported that in last five years, the number of farmers associated with silk rearing has declined thereby declining the cocoon production



have been associated with silk rearing for long said that there is unavailability of quality leaves.

They said as leaves are being damaged by insects and pests due to which farmers are unable to maintain quality and produce more cocoon.

He said that farmers aren't being provided technical guidance as they don't have skills and there is need to create awareness camps and workshop to guide silk rearers.

Another farmer said that Sericulture department has failed in producing quality seed, breed of silk worms resulting in less production of cocoon.

#### trained and quality silk worms, mulberry leaves must be kept available for them.

Farmers said that due to unavailability of quality leaves, silk worms and less scientific intervention along technical guidance farmers have been facing losses and several farmers have already switched to other businesses.

A top official of the department said that during 2017-18, over 27,181 farmers were associated with cocoon rearing in Kashmir thereby producing 893 metric tons of cocoons and generating an income of about Rs 22.337 crore.

However, in year 2018-19, the number of farmers declined to 25,000, thereby producing 790 metric tons (MT) and generating revenue of Rs 23.486 crore. An official said that in the year 2019-20, the number of farmers further declined to around 24,000 and the produc-

tion increased to around 810 metric tons (MT) and Rs 17.845 crore revenue was generated. He said that during 2020-21,

due to Covid-19 pandemic the number of farmers declined to around 22,000 thereby producing just 563 MT of cocoons and generating only Rs 12.183 crore.

However, in 2021-22, the number of farmers increased again to around 25,000, thereby 694 MT of cocoons and generating an amount of Rs 17.185 crore

### **Govt Attempting To Link Tax Collected At Source With Tax Deducted At Source: CEA**

NEW DELHI: The government is attempting to link tax collected at source for payments made by individuals with tax deducted from their income sources, a move that will help in ensuring cash flows of the individual taxpayers are not impacted, according to a senior official.

The move also comes at a time when the government is set to impose a 20 per cent Tax Collection at Source (TCS) on certain international spends from July 1.

Generally, TCS is the tax collected by a seller at the time of sale of goods or services while Tax Deducted at Source (TDS) is the amount levied as tax by the government.

The government has exempted transactions up to Rs 7 lakh from the TCS, providing relief to small taxpayers. So, bulk of the transactions made by most will not be covered under 20 per cent TCS, Chief Economic Advisor (CEA) V Anantha Nageswaran has said.

Defending the decision, he said, "And it (government) also attempts to link the TCS with your TDS such that if there are TCS payment made by you it has to reflect a lower TDS. Such that it simply is a matter of making sure that you are not affected from a cash flow perspective."

It will also provide a huge amount of relief for people who are concerned about this annoyance or irritation of seeing this TCS apart from TDS, he said at industry body's CII's event on Thursday.

The 20 per cent TCS levy on international credit card spends is to come into force from July 1.

Facing backlash, the finance ministry last week, exempted up to Rs 7 lakh spend from the TCS ambit.

"The exemption was done... The pass through of TCS into TDS deduction will also make sure that ordinary taxpayers do not see impact as far as they are concerned," he said.

Further, CEA said one point of view is that all that "you needed was to levy 1 per cent or 5 per cent so that you can track it".

But there are people who are happy to stay out of tax net by even paying 1 per cent or 5 per cent. So there has to be a deterrent effect as well, he noted.

According to him, data is available with the government that do point out that this mechanism has been not just abused by a small set of people but the volumes involved are fairly substantial.

## Serbia puts troop on high alert on border with Kosovo following clashes

PRISTINA (KOSOVO): Serbia put its troops on the border with Kosovo on the highest state of alert on Friday following clashes between ethnic Serbs and Kosovo police that left more than a dozen injured on both sides.

The Serbs in northern Kosovo, who represent a majority in that region, were trying to block the entrance of municipal buildings to prevent recently-elected ethnic Albanian officials from entering them.

Police fired tear gas and several cars

were set ablaze. In response to the clashes, Serbian President Aleksandar Vucic said that he put the army on a "highest state of alert." Vucic also said that he ordered an "urgent" movement of Serbian troops closer to the borderline with Kosovo.

Vucic will attend a rally in support of him in Belgrade after two mass shootings earlier this month that killed 18 people and left 20 others wounded.

He said in a statement that because of "violence" against Kosovo Serbs, Serbia demanded that NATO-led troops stationed in Kosovo protect them from the Kosovo police.

Kosovo police acknowledged their increased presence in the north "to assist mayors of the northern communes of Zvecan, Leposavic and Zubin Potok to exert their right of work."

Police said that five officers were injured by stun grenades and other hard objects thrown from protesters. A police car was burned while three others were damaged. Police also reported that shots were heard.

Police used tear gas to disperse the crowd and let the new officials into

the offices. Kosovo Serb hospital officials said that about 10 protesters were injured. US Ambassador to Kosovo Jeff Hovenier condemned "the ongoing action by Kosovar authorities to access municipal buildings in the north of Kosovo. Today's violent measures should be immediately halted," he tweeted.

New mayors in three communes in

northern Kosovo, which is mostly populated by an ethnic Serb minority, were prevented from entering the buildings with small groups of Serbs keeping their hands up at the entrance of the municipalities, apparently in a sign that they were not there to take part in violence, Albanian indexonline.net website wrote, also showing photos.

In Zvecan, the Kosovo-online.com site showed clashes with police in front of the public building while in Leposavic they also had blocked the main square with cars and trucks.

Earlier, Serbs also switched on their alarm sirens in the four communes, including in the main northern Mitrovica town, in a warning sign and call to gather, "sirens which are used by criminal structures for mobilisation and gatherings," according to police.

The April 23 snap election was largely boycotted by ethnic Serbs and only ethnic Albanian or other smaller minority representatives were elected in the mayoral posts and assemblies.

'Daam' is also capable of hacking phone call recordings, contacts, gaining access to camera, modifying device passwords, capturing screenshots, stealing SMSes, downloading/uploading files, etc. and transmitting to the C2 (command-and-control) server from the victim's (affected persons) device, the advisory said.

The malware, it said, utilises the AES (advanced encryption standard) encryption algorithm to code files in the victim's device.

Other files are then deleted from the local storage, leaving only the encrypted files with .enc" extension and a ransom note that says "readme\_now.txt", the advisory said.

The central agency suggested a number of do's and don'ts to avoid getting attacked by such viruses and malware.

The Cert-In advised against browsing "untrusted websites" or clicking on "un-trusted links". Caution should be exercised while clicking on any link provided in unsolicited emails and SMSes, it said. Install and maintain updated anti-virus and anti-spyware software, it suggested

It also suggested that users should be on the lookout for "suspicious numbers" that don't look like "real mobile phone numbers" as scammers often mask their identity by using email-to-text services to avoid revealing their actual phone number.

"Genuine SMS messages received from banks usually contain sender ID (consisting of bank's short name) instead of a phone number in the sender information field," it said.

It also asked users to exercise caution towards shortened URLs (uniform resource locators), such as those involving 'bitly' and 'tinyurl' hyperlinks like: "http://bit.ly/" "\nbit.ly" and 'tinvurl.com/".

Users are advised to hover their cursors over the shortened URLs to see the full website domain which they are visiting or use a URL checker that will allow the user to enter a short URL and view the full URL, the advisory suggested.



## **6 Ex-Yorkshire Cricketers Found Guilty Of Racism**

LEEDS: Six former Yorkshire cricketers found guilty of racial abuse at the club were on Friday fined a total of 22,000 pounds by the Cricket Discipline Commission. But the punishments, which include suspensions if they return to cricket, are down from what the ECB had pushed for fines totalling £37,000 at a hearing on May 3.

John Blain, Tim Bresnan, An-drew Gale, Matthew Hoggard and Richard Pyrah were all found guilty of breaching ECB Directive 3.3 following a CDC hearing in March.

Gary Ballance did not contest the charge while former England skipper Michael Vaughan, eight-week ban, but his sanction has been reduced to £3,000 and a six-match ban. The 33-year-old retired from all cricket in April soon after signing a two-year deal to play for Zimbabwe.

Former Yorkshire captain and head coach Gale has been handed the biggest fine of £6,000 (down from the £7,500 the ECB asked for) and a four-week suspension from coaching.

The governing body asked for an increased punishment due to Gale's previous behaviour, which includes a discriminatory remark towards Ashwell Prince during a Roses County Championship match in 2014 and an anti-Semitic tweet sent in 2010. Ex-England internation-

**NEW DELHI:** Vinesh Phogat on Friday said if WFI chief Brij Bhushan Sharan Singh attends the inauguration of the new Parliament building on May 28, it will send a clear message about the state of affairs in the country.

As part of their fight against Singh, the protesting wrestlers will now hold a women's Mahapanchavat before the new Parliament building on Sunday, the day of its inauguration by Prime Minister Narendra Modi.

"If Brij Bhushan is there at the new Parliament on May 28, then the whole country will automatically get the message," Vinesh said when asked what kind of message it will convey if WFI chief is present during the inauguration.

'Whosoever is trying to save Brij Bhushan, is against us. I don't know what is happening internally in the government but someone is trying to shield him and it is not right.
