Srinagar: While most parts of the country are reeling under heat wave conditions, tourists are enjoying the pleasant weather in Kashmir as the Valley has witnessed rains over the past few days, leading to a drop in the mercury.

Jammu: Union Minister Jitendra Singh on Saturday said heavy rush of pilgrims is expected during the upcoming annual yatra to the 3,880-metre high holy cave shrine of Amarnath in south Kashmir Himalayas.

The two-month-long pilgrimage is scheduled to commence on July 1 from the twin tracks -- traditional 48-km Nunwan-Pahalgam route in Ananthag district and 14-km shorter but steep Baltal route in Ganderbal district. Srinagar: The fisheries department of Jammu and Kashmir has submitted a report on sudden death of a large number of fish in Dal Lake to the administration attributing the mass death to thermal stratification. Experts say that the thermal

stratification is a natural occurrence, in any static body of water. It occurs when the surface layer of water, warmed by the sun, becomes less dense than the water underneath it. The surface layer remains on top and the lower layer, deprived of surface contact and insulated from the sun, continues to get colder.

The pictures and videos of floating dead fish went viral on social media sites leaving Dal dwellers and locals worried. Rafiq Ahmad Sofi, Chief Project officer, told Kashmir

Observer that the department had constituted a team to ascertain the facts that led to the death of fish in the Lake. "We dispatched a team to

collect the samples and found that the fish had died around Sher-e- Kashmir International

Convention Centre (SKICC) and to incessant rainfall.

Sofi, who was heading the team, said they found that most of the fish were "trash fish" and not "food fish" and the thermal stratification occurred in a small patch of the lake.

"The water around the SKICC and Nishat area is stagnant. No water channel feeds this patch so there is less oxygen for fish and the temperature of the water doesn't remain maintained in these patches," Sofi said.

55,000 Smart Meters To Be Converted Into Prepaid: CE

Srinagar: In an effort to give consumers access to cuttingedge technologies, Kashmir Power Distribution Corporation Ltd. (KPDCL) is all set to convert 55,000 previously installed postpaid smart meters into prepaid meters in the valley from June this year.

The corporation has urged the consumers to cooperate with the government to avail uninterrupted power supply in their localities. It also said that of the total 1, 70,000 smart meters installed in the valley, 50,000 postpaid smart meters will be converted into prepaid meters. Addressing the media at his office, Chief Engineer KPDCL

Kashmir Zone, Javed Yusuf Dar said process of conversion will be done in the phased manner and that the consumers have to login to Sahulat App to recharge their prepaid smart meters.

Dar said consumers could



now recharge their smart meters from the comfort of their homes rather than wasting their time in long queues at the bank branches.

"Consumers could now recharge as per their need, there is a recharge option available in the Sahulat App. Consumers could also keep a track of how much power was used the day before and how much was remaining. Most of the consumers pay electricity bills at bank branches and wait in long queues. They can pay bills at home by opting for prepaid mode. We have also issued an advertisement in newspapers in this regard," he said.

Meteorite And Volcanic Particles May Have Driven Origin Of Life On Earth: Study

articles from meteors or volcanic eruptions on Earth around 4.4 billion years ago may have generated the precursors of the molecules needed for the origin of life on the planet, according to a study.

Previous research has suggested that the precursors of organic molecules-hydrocarbons, aldehydes and alcohols-may have been delivered by asteroids and comets or produced by reactions in the early Earth's atmosphere and oceans.

These reactions may have been pro-

moted by energy from lightning, volcanic activity, or impacts. However a lack of data has meant that it is unclear what the predominant mechanism that produced these precursors was.

The new research, published in the journal Scientific Reports, analysed whether meteorite or ash particles deposited on volcanic islands could have promoted the conversion of atmospheric carbon dioxide to the precursors of organic molecules on the early Earth. The researchers simulated a range of

conditions that previous research has suggested may have been present on the early Earth by placing

heated and pressurised system (an autoclave) under pressures ranging between nine and 45 bars and temperatures ranging between 150 and 300 degrees Celsius.

They also simulated wet and dry climate conditions by adding either hydrogen gas or water to the system.

The team mimicked the depositing of meteorite or ash particles on volcanic islands by adding different combinations of crushed samples of iron meteorites, stony meteorites, or volcanic ash into the system, as well as minerals that may have been present in the early Earth and are found in either

The researchers found that the iron-rich particles from meteorites and volcanic ash promoted the conversion of carbon dioxide into hydrocarbons, aldehydes and alcohols across a range of atmosphere and climate conditions that may have been present in the early Earth.

They observed that aldehydes and alcohols formed at lower temperatures while hydrocarbons formed at 300 degrees Celsius.

The researchers suggest that as the early Earth's atmosphere cooled over time, the production of alcohols and aldehydes may have increased.



Srinagar: Residents of Dargah Hazratbal Saturday appealed to the Chief Engineer, R&B Department to macadamize a dilapidated road patch near J&K Bank to avert accidents.



Patient Stable As Controversy About 'Needless' Surgery Lingers On **Observer News Service**

RINAGAR: Even as the patient who was operated upon at the Sher-i-Kashmir Institute of Medical Sciences (SKIMS) for removal of suspected stones is stable, the controversy surrounding the surgery lingers on. While the doctors are almost unanimous there was no negligence in the matter, the patient's relatives are sore at the way an un-necessary surgery was forced on her.

According to reports, Aaliya Liaqat w/o Liaqat Hussein of Court road here was operated upon Saturday for suspected stones in her kidneys though repeated X-rays taken on the fateful day did not show any de nite presence of the calculus. Her relatives alleged the surgery was not warranted after the X—rays were negative.

The surgery evoked instant protest from the relatives of patient, mother of an 8-month old baby. They alleged the head of concerned department, Dr' Baldev Singh, had insisted to have the surgery performed. They accused the doctor of having threat ened them following a tiff a few days earlier. In a communication to Kashmir Observer, Dr Singh denied he

had conducted the operation and described the report, circulated by CNS news agency, as baseless and aimed at maligning his image. He said, "The fact is that I had advised an X-ray for the patient before any surgical intervention but a consultant urologist conducted the said surgery with my knowledge". Later on, he said, "on the request of Director SKIMS I helped the concerned urologist in closing the patient and stent was put for effective drainage

Talking to Observer News Service, Dr Singh denied there was any negligence on the part of doctors. 'These things can happen in the medical profession", he said, adding the surgery was done with the written consent of a close relative of the Patient. He said the patient was admitted by Dr Tajamul the consultant who was not required to seek any directive from him. Denying that he has threatened the patients' relative, Dr. Singh Said he might have told them to leave the ward during the morning round.

When contacted Dr, Tajamul Fazili told Observer News Service that patients was admitted by Dr. Singh. The X-rays of the obese patient had shown stones at the OPD stage and admitted accordingly. On Saturday he said the first two X-rays revealed thre were no stones. A third one was taken with double exposure which showed a shadow coinciding with the X-ray taken at the 'OPD stage'. Dr Fazili said, "Most probably it was a friable (soft) stone which got crushed and passed down the ureter during the surgical manipulation." He said a small stent was kept inside to ensure safe passage of any small bit.

Dr Fazili said 'Saturday was utilised as an additional theatre day to make good for the hartal days. "We were convinced the patient did have stones. But when I could not locate it, I sought help from Dr Singh", he said. The director of the Institute, Prof Me'raj ud-din, said there was nothing abnormal about the surgery nor was there any negligence on the part of doctors. 'The stone must have been friable going down the ureter and the gravel coming out of its own", he said. He ruled out any enquiry into the episode.

Joining the issue, a close relative of the patient, pleading anonymity, told Observer News Service the surgery was abso lutely uncalled for the moment the doctors knew there was no stone. The written consent had been given when she was brought to operation theatre in the morning. However, she was turned back from there and

asked to get in her X-ray done. After that an anesthesia was given to her for the second time and the surgery conducted despite the relatives' pleas against it and without seeking a fresh consent from them. The relative said the patient had suffered heavy blood loss which could have proved fatal. The relative alleged Dr Singh had visited the ward against asking them to return the X-rays which were lying with them.

Meanwhile, according to Dr Singh the patient was stable. (Kashmir Öbserver, 28 May, 2005)

Child Labour: An Ongoing Issue in Kashmir

C In any case, the longstanding problem with the employment of children is simply that at an age when a child is reasonably expected to go to school, play with their peers, and learn the multiplication tables or the periodic table, they are stripped of this innocence and forced to become an adult

hild labour in Kashmir is pervasive particularly in the handicraft industry, brick kilns, automobile workshops, and among domestic labour as well as vendors. Being made to work in these tedious and sometimes hazardous occupations, this practice for children is nothing short of an epidemic.

In technical terms, any employment which is undertaken by a child under the age of fourteen years on financial terms, constitutes child labour.

In Kashmir, the number of children engaged in employment was recorded at a stagerring 25,528 for the year 2011. This was down by 4.15% from the year 2001, suggesting a general decline since then.

Regardless, the fact that several around us remain constrained in this form of exploitation is certainly a matter of concern. It is essential to examine the conditions that they may be subject to and the factors that push them to seek employment at such an early age.

To understand this phenomenon in its entirety, we may consider the example of a common sight in Kashmir: minors working in street stalls and roadside restaurants. Here, they are exposed to harsh climatic conditions, being forced to face the scorching heat in summers and heavy rains in monsoon. On top of everything, they often do not even have the suitable clothing or nutrition to suitably adapt to such a work environment.

Yet, this state of affairs can be seen extending far beyond this one segment; another industry which is equally- if not more infamous for exploiting minors, is the traditional carpet-weaving industry of Kashmir.

These workplaces in India are poorly crafted, lack appropriate lighting, have unsuited furniture, poor ventilation, and a lack of heating and cooling arrangement with respect to the relevant season. Here, several children suffer from a range of illnesses caused



by the nature of their work including numerous eye problems, joint and bodily aches, and respiratory issues, among others.

Nevertheless, one thing to keep in mind about the carpet industry is that it is home-based; this is how it becomes convenient for families to employ their own children in this trade. Parents wish for their children to learn the skill of carpet weaving due to its market benefits, and make them work at an early age to help them master the skill in good time. Not only this, the establishment of looms in homes then acts as a tool in boosting labour participation of children in their wider community.

Now, for some, it may seem odd to suppose that parents in today's dayand-age are making their children toil away in wage labour. Because of the various white-collar occupations that are being created, one could perhaps attain a relatively well-paying and dignified job with a proper education.

Hence, we must ask ourselves: what causes parents to push their children into employment?

Broadly, scholars regard child labour as a result of poverty, unemployment, overpopulation, illiteracy, and low income of parents. A 2017 study provides another interesting insight into this; Aasif Hussain Nengroo and Gulam Mohammad Bhat found that if the head of a house is educated, the probability of them making their child work is lower than if otherwise.

This was inferred to mean that a literate head understands the significance of education for their child and is less likely to deprive them of education. In other words, low literacy levels among parents enables the employment of their children in the labour force, as they do not perceive the importance of education.

In reality, an education does not act as a guarantee for decent employment, which is why parents drop the notion of a white collar job and make

their children work in odd jobs with low educational requirements. The evidence for this lies in the ongoing crisis of the educated unemployed in Kashmir, which only encourages the dispatch of minors into the workforce.

However, even if parents feel that obtaining an education is substantial for their child, they may lack the resources to send them to school. And to counter this, we have seen some headway recently with the J&K government instructing private schools functioning on state land to provide free of cost education to children from disadvantaged socio-economic backgrounds. With this move, we can expect a reservation of 25% in these schools, ultimately promoting greater accessibility to quality education for economically disadvantaged children who would otherwise be unable to attain this.

In any case, the longstanding problem with the employment of children is simply that at an age when a child is reasonably expected to go to school, play with their peers, and learn the multiplication tables or the periodic table, they are stripped of this innocence and forced to become an adult. And it is precisely because of this that the youth of Kashmir is grappling to achieve their true potential.

Hence, it is to be hoped that with greater infrastructural development and a widespread change in attitudes, perhaps these children who have been trapped in factories and workshops for ages can someday be free.

heart. I added, "Until AI experiences heartbreaks, we must trust human teachers to nurture the hearts and minds of the next generation."

Yet it's hard to ignore the growing questions and concerns emerging from — and about — the teaching community on the impact of AI on their jobs, their classrooms and their very vocation.

Governments, foundations and corporations have channelled billions of dollars to research, develop, and deploy AI systems in recent years, which broadly speaking, can perform intelligent tasks normally associated with humans.

For instance, Bard and fellow conversational chatbot ChatGPT can write essays, give feedback on computer code, and even pen elegant poems. AI is also employed to power voice assistants like Siri, recommend products on e-commerce sites, and detect deadly diseases among others

At the moment, AI still lags behind humans in most disciplines, especially complex tasks that require a blend of technical competencies and socio-emotional skills. In fact, many experts agree that in the near term, AI will mostly complement rather than replace humans.

Importantly, even as AI advances, we must not relinquish all things cognitive to machines. Doing so would not only exacerbate tech dependence but also undermine critical thinking and reflection which are essential aspects of the human experience. We must continue to teach children how to think.

However, AI is forcing us to reimagine education as a vehicle for democratising thinking and knowing. There is no denying that. About 40% of the world's population is under 24. If schools fail to prepare this generation of youth for the age of thinking machines, the consequences on social and economic peace may be dire.

AI has the potential to underpin positive transformation in education.

For instance, AI-powered computer vision and voice-to-text apps can significantly boost school accessibility for learners with visual and hearing impairments. AI can also reduce teacher workloads, especially in environments where teachers' capacity and headcount are low. However human educators must remain central to teaching and learning.

On the flip side, the technology also has a high potential for harm. Generative AI could help students cheat in exams. Moreover, AI chatbots often throw up results that are sexist, racist and factually incorrect.

So what should teachers do?

Prepare students to ask better questions

A young university official in Cameroon recently told me that he and his colleagues were "trying to see how our classes will prepare students for technology and AI.'

Going forward, more teachers and education officials will have to think in this way. On the surface, this requires reviewing curricula, syllabi and teacher professional development programmes, and incorporating objectives and content on AI literacy, risks, ethics and skills, among other things. At a deeper level, as machines be-

come better at answering questions, educators should guide students to ask better questions. This will go beyond writing good prompts for conversational AI. Today's schools should inspire students to be curious as this is an essential ingredient to conducting primary research, including in frontier areas, where humans have an edge over AI.

Additionally, as AI heralds rapid transformation and change in labour markets, socio-emotional skills like adaptability should become central

Help avoid echo chambers

AI is almost certain to worsen the problem of misinformation. Very soon, anyone with an internet connection will be able to produce solid arguments on any subject simply by inputting a prompt into an AI platform.

Echo chambers could grow exponentially if we don't train today's young people to find common ground and hold peaceful conversations with people they don't agree with.

Short of action, AI may feed the flames of extremism and polarisation.

Tackling the most pressing challenges of our time — climate change, pandemics, migration — will require

unprecedented levels of collaboration at the global, regional and national levels. While AI will unlock new possibilities to analyse, organise, and process information necessary to fix these issues, this potential will be useless if we can't talk to each other.

That is why teaching learners the ability to find common ground is so important.

Use AI as a teaching assistant

We've known for decades that students learn better when teaching is personalised. However, limited teacher headcounts and rapidly growing student populations, especially in lowincome countries, have prevented tailored teaching approaches from fully taking off.

AI could change this.

Adaptive learning technologies powered by AI are already showing promising results in literacy and numeracy. Typically, AI-powered adaptive learning solutions assess students' current knowledge and competencies, identify gaps, deliver content and guizzes at the right level, and provide feedback to improve learning outcomes.

A World Bank review has reported promising results from adaptive learning pilots around the globe. AI can thereby help complement teachers' efforts and underpin significant improvements in educational outcomes.

To be clear, human educators will remain pivotal to learning. In the same way that libraries and search engines don't take away instruction responsibility from teachers, human educators must remain central in the age of educational AI. Teachers will still set ambitious learning goals, lead instruction, and motivate and inspire learners among other key tasks

Al needs education

Importantly, the use of AI educa-

can also apply a rigorous research lens to separate hype from reality and ensure that the technology serves rather than harms shared human development.

Academics can also play a vital role in helping governments to anticipate and manage the disruptive effects of AI. For instance, as AI disrupts sectors and occupations replacing old jobs and creating new ones, tertiary education institutions will be vital to skill, upskill, and reskill today's workforce for the future.

The future

Innovation works in mysterious ways, and we are barely witnessing the first moments of AI's Cambrian explosion.

No one knows what the Age of AI will bring.

However, we know that the pace of change will accelerate. The skills landscape will shift. Education will have to evolve. Therefore, we can adapt our curricula and instructional techniques to match a world where machines think.

We can teach learners to find common ground and hold peaceful conversations, even when they don't agree with their interlocutors. We can empower our teachers and lecturers not only to use AI for adaptive learning, but also to make AI solutions in education and beyond more safe, inclusive, secure and obedient.

The journey will be long. We may stumble. We may fall. But we must rise again. We must keep walking, to ensure that AI contributes to creating a world where knowledge is democratised and used for the common good.

In an experiment described by Dr. Ramachandran in The tell-tale brain, rats were repeatedly shown one of two images - either a square or a rectangle. Every time it was shown a rectangle, the rat was also given a piece of cheese. After a while, it began to prefer the rectangle. No surprises so far. But when the rat was shown a rectangle which was more elongated than the first one, it began to prefer the elongated rectangle even to the original one.

Why does this happen? It is because the rat has learnt to prefer the property of rectangularity. How does a rectangle differ from a square? It is elongated. So the more elongated (and therefore more rectangular) the figure is, the more the rat will be attracted to it.

Dr. Ramachandran points out that the same principle explains our responses to portraits, caricatures and cartoons. How would an artist bring out the essence of a person, say Indira Gandhi? If you take her face and subtract the average woman's face from it, what you have left are the features in which Mrs. Gandhi's face differs from the norm. It is these that make her recognizable as Mrs. Gandhi. The most obvious of these is her prominent nose. What an artist might do is to subtly enhance those features, so that the portrait looks even more like Indira Gandhi than Indira Gandhi herself. If you take this too far, of course you get a cartoon.

Could this phenomenon (which Dr. Ramachandran calls a peak shift) be one of the reasons why we are drawn to animated films? An animated Disney princess can be made more feminine than any human actress by enhancing those features by which a woman's face differs from that of a man. Can you ever hope to use a real animal to convey the innocence of Bam-bi? The essence of any character can be brought out more strongly in an animated film without having the features of a human or animal actor stand in the way. This is not only applicable to the look of the characters, but also their gestures, posture and behaviour. The same principle applies to storytelling as well. Many genres like mythologicals, science fiction and fantasy use hyperbole as a matter of course. We speculated in the previous chapter that the reason why we accept these 'unrealistic' genres is because we recognize the basic categories of the environment like goals, obstacles, etc. in them. But it could

be that we like these genres more because they deviate from reality. Storytellers in these genres can use the principle of peakshift in their design of character and situation to a much greater extent than those working within the straightjacket of realism. If a story of a human fighting a lion is good, then a story of a demigod fighting a ten-headed monster is better, because it captures the essence of heroic struggle against dangerous adversaries. Or take the most common plot of romance stories. A naive young woman meets a powerful man fighting inner demons. He could be a neurosurgeon, a soldier or a billionaire. The woman faces social or physical dan-ger from this man but ultimately heals the troubled and tempestuous soul by the application of the magical balm of feminine love. This is the plot of scores of Mills and Boon romances. But all those stories are limited by one constraint: the characters are human. They may be extraordinary almost to the point of being incredible, but they still cannot transcend the limitations of biology. So if you want to transcend those limitations as a writer, what can you do? You identify the features that make the human hero of romance different from the average man: power, capacity for aggression, strong internal conflict, ir-resistible desire for the heroine. Then you create a world where you can multiply these qualities tenfold. Instead of a rich, powerful man, take an aristocratic vampire: he is a rich, immortal predator, and has powers that no man can dream of. The hero of the typical romance desires the hero ine typical formatice desires the heroine romantically. Make your vampire hero lust for the blood of your heroine. And yet of course the vampire hero loves her and so will never do anything to hurt her - how's that for internal conflict? Bella gets to be with a supernatural being who desires her intensely but is not a slave to his desire, and is powerful enough to be able to protect her from any danger; and Stephanie Meyer sells over a hundred million copies of her books. But of course she did not discover the power of this plot, or the benefits of setting your story in the supernatural realm. Beauty and the Beast predates Twilight by two and a half centuries, and is itself indebted to similar motifs in folktales and literature going back millennia.



The rescue operation was launched on Friday evening by police owing to the significant influx of tourists and local passengers requiring assistance. Besides the UTDRF rescue



and GREEF rescue teams also actively participated in the

collective efforts, no untoward incidents occurred, and all the passengers were safely evacuated to Leh, police said. The rescue operation became

necessary due to continuous intermittent snowfall over the past two days, resulting in icy and slippery road conditions. Several vehicles, including taxis and private cars, especially

those belonging to tourists, became immobilized at Changla Top.

But amid a boycott by 20 opposition parties of the inauguration ceremony, the Sengol too was dragged into the political row.

Congress leader Jairam Ramesh on Friday claimed there was no documented evidence of Lord Mountbatten, C Rajagopalachari and Nehru describing the Sengol as a symbol of transfer of power by the British to India.

The other side of the coin shall bear the image of Parliament Complex, and the year '2023' in international numeral below the image.

The new Parliament building, constructed by Tata Projects Ltd, will have a grand constitution hall to showcase India's democratic heritage, a lounge for MPs, a library, multiple committee rooms, dining areas and ample parking space.

The triangular-shaped four-storey building has a built-up area of 64,500 square metre. The building has three main gates-Gyan

Dwar, Shakti Dwar and Karma Dwar. It will have separate entrances for VIPs, MPs,

and visitors. The material used for the new building

has been acquired from various parts of the country. The teakwood used in the building was

sourced from Nagpur in Maharashtra, while the red and white sandstone was procured from Sarmathura in Rajasthan. The sandstone for the Red Fort and Humayun's Tomb in the national capital was also known to have sourced from Sarmathura.

The Kesharia green stone has been procured from Udaipur, the red granite from Lakha near the white marble has been sourced Aimer and

stones or granite and not by dredging of river beds.

The fly ash bricks used in the construction were sourced from Haryana and Uttar Pradesh, while brass works and pre-cast trenches were from Ahmedabad in Gujarat.

The new Parliament building can comfortably seat 888 members in the Lok Sabha chamber and 300 in the Rajya Sabha chamber.

In case of a joint sitting of both the Houses, a total of 1,280 members can be accommodated in the Lok Sabha chamber.

The prime minister had laid the foundation stone of the new parliament building on December 10, 2020.

The present Parliament building was completed in 1927, and is now 96 years old.

Over the years, the old building was found to be inadequate for present day requirements. Lok Sabha and Rajya Sabha had passed resolutions urging the government to construct a

new building for Parliament. The existing building served as indepen-

dent India's first Parliament and witnessed the adoption of the Constitution.

Originally called the Council House, the building housed the Imperial Legislative Council. The Parliament building witnessed the addition of two floors in 1956 to address the demand for more space.

In 2006, the Parliament Museum was added to showcase the 2,500 years of rich democratic heritage of India.

Officials said the present building was never designed to accommodate a bicameral legislature and the seating arrangements were cramped and cumbersome, with no desks beyond the second row.

The Central Hall has seating capacity only for 440 people and the need for more space was acutely felt during joint sittings of both the houses.



Devotees Protest Against Inadequate Facilities

SRINAGAR: A group of Kashmiri Pandit devotees on Saturday held a protest in Ganderbal district, alleging inadequate facilities for the pilgrims at the annual Kheer Bhawani Mela.

A group of devotees who reached the revered temple shrine of Ragnya Devi in Tul-mulla area of the central Kashmir district for the annual fair to be held on Sunday alleged that they faced a lot of problems due to inadequate facilities.

The devotees, including women and children, raised slogans against the administration.

"We have been here since yesterday and are facing a lot of problems. There are no facilities for pilgrims like drinking water, accommodation, etc," a protesting devotee claimed.

The authorities were aware that we are coming here and they should have made proper arrangements for us," she said, adding that they were so dejected that they decided to leave last night only.

Another protester said authorities had ensured the community that all facilities would be made available at the temple shrine, but there were no such arrangements.

"No one, not even the deputy commissioner, visited here yesterday They are only making money in the name of Kashmiri Pandits," he said.

The protestors alleged they had to sit under the open sky for the whole night.

"There are inadequate facilities for the pilgrims. There is no drinking water, no water in the toilets no facility is here,' another devotee said.

However, deputy commissioner, Ganderbal, Shyambir, said some anti-social elements were spreading misinformation. "Last night, pilgrims reached

here, food and other facilities for their stay were in place, but due to inclement weather, water penetrated some tents. We had a meeting with all pilgrims and we are resolving their issues," Shyambir told reporters at the shrine complex.

He said volunteers and langar' providers were providing their services, "but some antisocial elements are spreading misinformation".

"We have adequate lodging, and accommodation facilities here, but, despite that, there was a protest. We should understand that there were 2,400 pilgrims here and only 12 people protested," the deputy commissioner said.

Residents Threaten Stir For Station Near World's Highest Rail Bridge In Reasi

REASI: Residents of Kauri in Reasi district, the home to world's highest rail bridge over the Chenab, are up in arms in support of their demand for a railway station which they believe will safeguard the future of their coming generations after parting

away their land for the project. The 1.3-km Chenab rail bridge -- located 359 metres above the riverbed and 35 metres higher than the iconic Eiffel

Tower in Paris -- forms a crucial link in the 111-km stretch from Katra to Banihal, which is part of the prestigious Udhampur-Srinagar-Baramulla Railway Link (USBRL) project.

The work on the famed bridge is nearing completion but the railway station is still nowhere in sight, the Kauri residents said, seeking personal intervention of Railway minister Ashwini Vaishnaw and Jammu and Kashmir Lt Governor Manoj Sinha.

"At the start of work on the bridge about 20 years ago, we were promised of railway station in our area to cater to the heavy rush of prospective tourists to the iconic bridge Today, we are feeling deceived as the dream shown to us to uplift our economy and secure the future of our children seems not being fulfilled," local resident Angrez Singh told PTI.

He claimed that the railway officials had abandoned the plan to have a station near the notable bridge, citing "some technical issues

"Many people gave up their land for the project with a hope for a better future. They are rendered unemployed and the future of their children also looks bleak," Singh said.

The base of the steel and concrete arch bridge between Bakkal and Kauri, 42 km from Reasi town, was completed in November 2017, allowing for the start of the construction of the main arch which was done in April 2021.

Another milestone on the bridge was achieved in August last year when the overarch deck of the bridge was completed with a 'Golden Joint', paving the way for the laying of the track which was finally completed recently.

"Without railway station, we will not allow the train to cross the bridge. We will sit on the track and let them pass the train over our bodies," said Rajinder Singh, a retired Captain.

He said the railway station in Kauri is going to benefit people of six tehsils of Reasi district.

"We have already submitted memorandums in support of our demand to higher authorities many times. If anything untoward happens, the government will be responsible," he said.

Panch Om Prakash said it is very "unfortunate that nobody in the government is listening to the residents of Kauri"

"If our demand is not met, we will boycott the coming elections to convey our resentment. The lack of a railway station in Kauri will have a negative impact on five lakh people," he said.

Out of the total 272-km Udhampur-Srinagar-Baramulla Rail link (USBRL) project, 161 km was commissioned in phases with first phase 118-km Qazigund-Baramulla section commissioned in October 2009 followed by 18-km Banihal-Qazigund in June 2013 and 25-km Udhampur-Katra in July 2014. The work on the project, billed

as the most challenging railway infrastructure project being undertaken post-independence, was started in 1997 and has missed several deadlines amid huge cost escalations.

The under-construction 111km Katra-Banihal section is likely to be made operational early next year to connect Kashmir with the rest of the country by train.

Contractor Blacklisted For Delaying Execution Of Allotted Work In Doda

Singh said the Rural Development Department has decided to follow a zero-tolerance policy against the contractors who keep delaying the execution of important public work.



AHMEDABAD: Revenge will fuel Gujarat Titans' title defence when they clash with four-time winners Chennai Super Kings in Sunday's Indian Premier League (IPL) final in Ahmedabad.

Gujarat, who won the title in their debut season last year, topped the group stage this season but went down to Mahendra Singh Dhoni-led Chennai in the first qualifier on Tuesday. Hardik Pandya's men bounced back from that defeat to thrash the league's most successful team, Mumbai Indians, in Friday's second qualifier to set up a rematch with Chennai at Gujarat's home ground in Ahmedabad.

Gujarat also have the personnel to become the first IPL franchise to win the league in their first two attempts. Opener Shubman Gill, the seasons leading scorer, is in sublime form having smashed three hundreds in his last four innings.

"He is a superstar and is going to do big things to franchise cricket and Indian cricket," Pandya said of his India team mate Gill. The top three



bowlers this season -- Mohammed Shami, Rashid Khan and Mohit Sharma -- are also from Gujarat.

While seamer Shami has been particularly impressive in the powerplay overs, Rashid has spearheaded Gujarat's spin attack claiming crucial wickets at important junctures.

"When things are not going the way I like, he is someone who comes and changes momentum and makes sure we keep getting wickets," Pandya said of the Afghan spinner.

"We have spoken enough about Rashid but sometimes I am short of words for what he does." Chennai will have an opportunity to match Mumbai's five IPL titles in what

could be their talismanic lead-
