3 Militants Held After LoC Firefight: Army

Jammu: The Army on Wednesday foiled an infiltration attempt with the arrest of three militants along with a huge consignment of arms and narcotics along the Line of Control (LoC) in Poonch district of Jammu and Kashmir.

A defence spokesman said the militants, who were also in possession of a 10 kg power-ful Improvised Explosive Device (IED), were arrested after an exchange of fire near the border fence when they were attempting to sneak into this side. An Army personnel and one of the militants were injured in the firing.

"In a joint operation by Army along with police, likely threefour militants were intercepted on LoC in Poonch sector while attempting to cross the fence on the night of May 30 and 31, taking advantage of bad weather and heavy rains," Jammu-based Army PRO Lt Col Devender Anand said in a statement.

After tracking the movement at about 1.30 am, the spokesperson said an Army ambush, on challenging them, was fired upon and in the retaliatory firefight some militants have been hit.

NIA Raids 3 Locations In Kashmir Press Trust Of India

Srinagar: The National Investigation Agency (NIA) on Wednesday carried out searches at three locations in Kashmir in connection with its ongoing crackdown on the newly floated militant outfits, an official said.

The daylong raids and searches were conducted in Srinagar and Budgam districts, during which incriminating literature and several digital devices were seized, a spokesperson of the federal agency said.

The spokesperson said the raids were conducted at the residential premises of sympathisers and cadres, hybrid militants and Over Ground Workers (OGWs) linked to newly-formed offshoots and affiliates of proscribed Pakistan-backed militant outfits such as the Laskhar-e-Taiba (LeT), Jaish-e-Mohammed Hizb-ul-Mujahideen (IeM). Eating junk food linked with reduced deep sleep quality: Study

EW DELHI: Consuming an unhealthier diet is associated with a lower quality of deep sleep, according to a smallscale study.

Deep sleep, the third stage of sleep, repairs and restores necessary functions such as memory, muscle growth, and immunity.

Researchers at Uppsala University in Sweden analysed how junk food affects sleep. Healthy participants consumed an unhealthier as well as a healthier diet in a randomised order.

The study, recently published in the journal Obesity, shows that after eating junk food, the quality of the participants' deep sleep deteriorated, compared with those who followed the healthier diet.

"Both poor diet and poor sleep increase the risk of several public health conditions," said Jonathan Cedernaes, Associate Professor at Uppsala University.

A total of 15 healthy normalweight young men participated in two sessions of the study. Participants were first screened for aspects such as their sleep habits, which had to be normal and within the recommended range of seven to nine hours per night.

The participants were randomly given both a healthier diet and an unhealthier diet. The two diets contained the same number of calories,



adjusted to each individual's daily requirements. Among other things, the unhealthier diet contained a higher content of sugar and saturated fat and more processed food items.

Each diet was consumed for a week, while the participants' sleep, activity and meal schedules were monitored at an individual level.

"What we saw was that the participants slept for the same amount of time when they consumed the two diets. This was the case both while they were following the diets, as well as after they had switched to another,

identical diet," said Cedernaes. The researchers looked at slowwave activity, a measure that can reflect how restorative deep sleep is.

"Intriguingly, we saw that deep sleep exhibited less slow-wave activity when the participants had eaten junk food, compared with consumption of healthier food," Cedernaes said.

This effect lasted into the second night, once participants switched to an identical diet. Essentially, the unhealthy diet resulted in shallower deep sleep, the scientist said. Similar changes in sleep occur with ageing and in conditions such as insomnia, the researchers said.

It can be hypothesised, from a sleep perspective, that greater importance should potentially be attached to diet in such conditions, they added.

Srinagar: Students in Srinagar, the summer capital of J&J UT have suffered loss of 71 school hours due to curtailment in timings during the past three months.

Following the reopening of schools after winter vacations in February, the School Education Department announced school timing across Kashmir division from March-01 wherein it has shortened one hour for those institutions falling within the municipality limits of Srinagar.

From March 01 to May 31, the School timing within the limits of Srinagar Municipal Corporation was

9:00 am to 2:00 pm, a departure from normal school timing in the city. The normal school timing in the

city is 9:00 am to 3:00 pm. The shortening of school timing meant a loss of one hour daily for thousands of children studying in private as well as government institutions in the city.

There were a total 71 working days from March 01 to May 31. This means students in Srinagar suffered an academic loss of 71 hours due to revision of school timing on Feb 28.

Principal Secretary, School Education Department, Alok Kumar said the department would look into the matter. "We are assessing it," he said.

40 Medical Colleges Lose Recognition, 100 More Face Similar Action: Sources

NEW DELHI: Around 40 medical colleges across the country have lost recognition over the past two months allegedly for not following standards set by the National Medical Commission (NMC), official sources said.

About 100 more medical colleges in Tamil Nadu, Gujarat, Assam, Punjab, Andhra Pradesh, Puducherry and West Bengal may also face similar action, they said on Tuesday.

The colleges were not found to be complying with the set norms and several lapses related to CCTV cameras, Aadhaarlinked biometric attendance procedures and faculty rolls were found during inspections carried out by the Commission, an official source said.

According to government data, the number of medical colleges has increased significantly since 2014. There is an increase of 69 per cent in the medical colleges from 387 before 2014 to 654 as of now, Minister of State for Health Bharati Pravin Pawar had told the Rajya Sabha in February.

Further, there is an increase of 94 per cent in MBBS seats from 51,348 before 2014 to 99,763 as of now and an increase of 107 per cent in PG seats from 31,185 before 2014 to 64,559 as of now.

5 Palestinian Fighters **Killed In Lebanon Blast Blamed On Israel**

The Popular Front for the Liberation of Palestine – General Command (PFLP-GC) has blamed Israel for the killing of five of its members in a blast in eastern Lebanon, near the Syrian border

Anwar Raja, a PFLP-GC official, said an Israeli strike on Wednesday hit positions in the Lebanese town of Qusaya. He said 10 people were wounded, of which two were in critical condition. However, unnamed Israeli sources told news agencies that Israel was not involved in the attack. No official comment came from Israel, nor from the Lebanese army or the Iranbacked Hezbollah group. There were conflicting reports from Lebanese and Palestinian sources that the blast was a result of an old rocket going off in an arms depot or mines exploding while they were being moved.

The measures and steps taken by the government to increase the number of medical seats in the country include a centrally-sponsored scheme for establishment of new medical colleges by upgrading district/referral hospitals, under which 94 new medical colleges are already functional out of 157 approved.

Reacting to the derecognition of medical colleges, experts from the medical field said the NMC is largely relying on the Aadhaar-enabled biometric attendance system for which it considers only the faculty which are on duty during daytime from 8 am to 2 pm.

"But the working hours of doctors are not fixed. They have to work in emergency and in night shifts also. So the NMC's rigidity with the working hours has created this issue. Such micro-management of medical colleges is not practical and the NMC needs to be flexible to such issues," an expert said.

HRW Urges Pakistan To Not **Try Civilians In Military Courts** AGENCIES The HRW released its statement shortly after Interior Min-

ISLAMABAD: A leading rights group has urged Pakistan not to try civilians in military courts, reminding the government that the practice violates the country's obligations under international law. Pakistan plans to try in army courts dozens of its citizens accused of attacking military installations during protests this month after the dramatic arrest of former Prime Minister Imran Khan.

In a statement issued on Wednesday, Human Rights Watch (HRW) said international human rights standards provide "no basis for Pakistani authorities to try these cases in military courts, especially as the civilian courts are functioning".

"The Pakistani government



has a responsibility to prosecute those committing violence, but only in independent and impartial civilian courts," said Patricia Gossman, HRW's associate Asia director.

"Pakistan's military courts, which use secret procedures that deny due process rights, should not be used to prosecute civilians, even for crimes against the military," she said.

Amend Laws To Punish Rape Of Dead Bodies: Karnataka High Court To Centre

BENGALURU: The High Court of Karnataka has asked the Centre to amend the relevant provisions of the Indian Penal Code (IPC) or bring in new ones criminalizing and providing for punishment for 'carnal intercourse' with corpses.

The high court made the recommendations after acquitting a person under Section 376 of the IPC as the 'rape' provision does not have clause for convicting a person accused of having intercourse with a dead body.

The accused had murdered a woman and then had sexual intercourse with her body. The court, however, confirmed the rigorous life imprisonment and a fine of ₹50,000 for the accused under Section 302 (mur-

ment on May 30. Citing the examples of several countries, including UK and Canada, where Necrophilia and crime against dead bodies are punishable criminal offences, the high court recommended that such provisions be introduced in India.

"It is high time the central government amended the provisions of Section 377 of IPC and included dead body of men, woman or animal as contemplated under the said provision," the high court said in its judgement.

The central government shall amend the new provision in the IPC with regard to sadism or necrophilia against the person whoever voluntarily has carnal intercourse against the natural including the dead body of the woman, punishable w imprisonment of life or with imprisonment of either description for a term which may extend to 10 years and also shall be liable for fine," it suggested. The high court also directed the state government to ensure that CCTV cameras are installed in mortuaries in all government and private hospitals to prevent offence against dead bodies within six months. It also recommended maintaining mortuary services properly and sensitization of the staff. The murder and rape incident dates back to June 25, 2015 and both the accused and victim are from a village in Tumakuru district.

"Will Hang Myself Even If A Single **Charge Proven'': Wrestling Body Chief**

are like his children and he will not blame them as his blood and sweat have also gone into their success.

"I am once again saying that if even if a single allegation is proved against me, I will hang myself," Singh said while addressing a programme at the Mahadeva auditorium in the Ramnagar area here.

"It has been four months since they (wrestlers) want me to be hanged, but the government is not hanging me. So they were going to

immerse their medals in the Ganga. Brij Bhushan will not be hanged by throwing medals in the Ganga. If you have proof, give it to the court and if the court hangs me, I will accept it."

> He said he will not blame the wrestlers as his blood and sweat have also gone into their success. "All the players are like my children. Until a few days

ago, they used to call me the god of wrestling. When I took over as the wrestling federation chief, India was ranked 20th in the world. Today, after my hard work, India's name is included among the five best wrestling teams in the world.

"I have lived wrestling day and night. Five of the seven Olympic medals (in wrestling) came to India during my tenure. The allegations levelled against me are baseless," the outgoing WFI chief said.

IIT Bombay Student's Death: Chargesheet Mentions Grades, Depression

MUMBAI: A chargesheet filed by Mumbai police in connection with the alleged suicide of Indian Institute of Technology Bombay (IITB) student Darshan Solanki stated that he had sought help from someone for improving his academic performance and also mentioned depression.

The special investigation team of police on Tuesday filed a chargesheet against Arman Khatri, a fellow student, who had allegedly threatened Solanki over a religious comment. Khatri, arrested for allegedly abetting suicide, is currently out on bail.

Solanki, a first-year student of B Tech (Chemical) course hailing from Ahmedabad, allegedly jumped to death from the seventh floor of a hostel building on IITB campus in suburban Powai on February 12, 2023, a day after the semester exams ended.

Three weeks later, the SIT found a one-line note from Solanki's room saying "Arman has killed me".

Police had said earlier that Khatri allegedly threatened to kill Darshan



with a paper cutter after the latter had spoken offensively' about religion.

The investigators recorded the statements of 55 witnesses including students and professors, the chargesheet said. Most of the student witnesses lived on the same floor of the hostel as Solanki.

Referring to certain phone chats between Solanki and Khatri, police said it was clear that Darshan was apologizing for the alleged communal remark he had made.

Some witnesses spoke about Darshan shivering when Arman threatened him and others trying to comfort him, the chargesheet said.

Solanki had told some witnesses that Khatri was influential and would not spare him, the chargesheet claimed.

Lucknow Family Booked For Demanding Rs 30 Crore As Dowry

LUCKNOW: The daughter of a prominent businessman in Lucknow has lodged a complaint with the police that her husband, mother-in-law and brother-in-law had been torturing her and demanding a dowry of Rs 30 crore.

DCP Central Zone, Aparna Rajat Kaushik, said an FIR had been registered on the complaint of the victim.

The victim has alleged that she was being harassed for more dowry even though her parents gave costly gifts and organised a grand wedding in 2010.

"They used to taunt me saying it was of no use marrying into such a prominent family as they got only simple dowry," she alleged and added that she was beaten up for opposing them.

The victim said she was forced to ask her maternal uncle to arrange a contract for her husband and she did it to save her marriage.

"My maternal uncle arranged a contract for my husband who earned



Rs 4 crore though the business. But they did not stop beating me. One day my mother-in-law slapped me and dragged me by my hair while my husband pushed me down on the ground," the victim alleged.

SRINAGAR: On world no tobacco day, Doctors Association Kashmir (DAK) on Wednesday has sought blanket ban on all tobacco products in Kashmir.

"Ban on tobacco products would prevent cancer that has reached to epidemic proportions in the valley," said DAK President Dr Nisar ul Hassan.

Dr Hassan said according to union health ministry figures, Jammu and Kashmir has reported an estimated 51,577 cancer cases in last four years with lung cancer prominent most due to high rates of smoking

"Research has shown that smoking is linked to about 90 percent of lung cancer cases," he said adding that after lung cancer, foodpipe, stomach and colon are the other types of cancer that have been found to have high prevalence in Kashmir and smoking is a big factor.

The DAK President said not only does smoking cause cancer, but it also increases the

risk of dying from heart attack and stroke, the two leading causes of death and disability in the valley.

"Smoking is a gateway for drug abuse which has reached to unprecedented levels in Kashmir," he added.

Dr Nisar said JK is emerging as the smoking capital of North India as JK's cigarette

consumption is almost double the n a

> tionwide prevalence.

According to Global Tobacco Survey 20.8 percent of JK people smoke, against the national average of 10.7 percent.

"The prime reason for increased use of tobacco in Kashmir is its availability," he said adding that "cigarettes and other tobacco products are freely available in Kashmir and can be purchased by anyone, whatever the age."

J&K Gets Approval For 12 More DNB Seats

SRINAGAR: As a significant step towards strengthening the public healthcare scenario in Jammu and Kashmir, 12 more seats have been sanctioned by National Board of Examinations in Medical Science (NBEMS) under DNB for the public institutions of the Union Territory. These seats shall be in addi-

tion to the earlier granted 270 DNB seats. As per detailed breakup, Sri-

nagar Hospital received approval for 2 seats in Orthopedics; GMC Rajouri for 2 seats in Paediatrics; DH Poonch for 2 seats in Surgery, DH Reasi 2 seats in General Medicine and Department of Anesthesiology GMC Baramulla given accreditation for starting DNB courses with intake of 4 PGs, 2 primary DNB and 2 Secondary DNB seats per year.

Secretary Health & Medical Education (H&ME) Department, Bhupinder Kumar, congratulated the entire health and medical education department for this achievement. He expressed happiness over the fact that even far-flung facilities like DH Poonch and DH Reasi have been able to start Post Graduate Courses in these hospitals.

Ayushi Sudan, Mission Director, NHM J&K, while giving details about the development, said that implementation of DNB courses at the district level in J&K has been termed as a best practice in the Country.

Under the DNB programme in the UT, a total of 270 seats were granted to the accredited departments during session 2022 and start of 2023.

"All the efforts are being made to scale up the DNB courses in all the District Hospitals and potential CHCs of J&K. During the upcoming session, J&K is planning to submit more than 30 applications in all District Hospitals", she added.

The Chief Secretary lauded the efforts of the IT Department and local chapter of NIC for development of all these services in-house with their own expertise and resources. He said that the performance of the Department is excellent with more to be done in the davs ahead. He advised the concerned

to further expedite the auto appeal feature on the national platform of Serviceplus. He asked them to onboardatleast 100 services on this portal by next week and all the eligible services under the Auto-appeal system by 15th of next month. He also directed for all incorporating of all required improvement relating to the departmental websites by upgrading their content and utility besides making them compliant with the standards set under National e-Governance Service Delivery Assessment (NeSDA). He asked them to improve their ratings by bringing all the services and portals at par with

their guidelines so that our score reaches the optimum range of 1 within this time period. The Commissioner Secretary, IT, PrernaPuri informed the meeting that by launching these 6 services of H&UDD today the number of online services offered by the UT reached

to 480 today. She apprised tgat all these services have been linked with payment and SMS gateways for ease of applicants. She further added that soon more services would be made online as these have been identified for development and in coming weeks the number of

such services is going to touch 500 mark here. During the meeting the Chief Secretary also reviewed the progress made in development of ser-

vices like online FIR registration, online billing of water connections besides other services. He enjoined upon the officers that by offering services

online and bringing them into the ambit of Auto-appeal system is not only ensuring their timely delivery but weeding out of corruption and malpractices from government offices. He observed that with the system of auto-escalation under PSGA in place both the quality and delivery of services to

public would improve a lot as is reflected from the statistics of services brought under this prudent system during the past vear or so.

A Dangerous Escalation

he drone attack on Moscow high-rises on Tuesday marks a dangerous escalation in the ongoing conflict between Russia and Ukraine. President Vladimir Putin's accusation that Kyiv seeks to "frighten" Russians reflects the Kremlin's attempt to deflect attention from its own aggressive actions and shift blame onto Ukraine. However, it is clear that the intensification of hostilities is a direct consequence of the bitter nature of the conflict in Ukraine..

The attacks in Moscow, though causing only minor damage and no serious injuries, have shaken the perception of invulnerability among ordinary Russians. The Kremlin has long maintained that the conflict in Ukraine does not pose a threat to its own citizens, but the drone attacks have shattered this narrative.

President Putin has claimed that the attacks were a response to a Russian strike on Ukraine's army intelligence headquarters. The use of drones to target residential areas in Moscow demonstrates a deliberate intent to sow fear and uncertainty among the Russian population.

The Russian defense ministry's report that eight drones were used in the attack, with five downed and three disabled, highlights the effectiveness of Moscow's air defense. However, this success should not overshadow the fact that drones breached the country's airspace and struck civilian areas.

The United States, in response to the attacks, reiterated its commitment to supporting Ukraine's territorial integrity but clarified that it does not endorse attacks inside Russia. The State Department's statement emphasizes the focus on providing Ukraine with the necessary equipment and training to reclaim its sovereign territory, rather than engaging in offensive actions.

The drone attacks in Moscow and the retaliatory strikes in Kyiv demonstrate the perilous turn that the Russia-Ukraine conflict has taken. It is imperative for diplomatic efforts to be intensified, and for both sides to prioritize dialogue.

Now in its second year, the war in Ukraine continues to rage. Neither Russia nor Ukraine seem to have a clear edge on the ground. If anything, this shows that both sides are fighting to ensure the defeat of the other side. There is little effort for a negotiated settlement. Meanwhile, the human tragedy is unfolding in Ukraine on a vast scale in terms of the deaths of civilians. The war has rallied western nations and many other countries from around the world behind Ukraine. This could drag the war endlessly. While it is nobody's case to countenance the invasion of a sovereign smaller country by its powerful neighbour, the solution to the evolving fraught situation can be resolved if the US-led West and Russia sit down and work towards addressing each other's grievances and fears.

rime Minister Narendra Modi's visits abroad are carefully choreographed events, given their optics domestically. Perhaps, this is even more so today as general elections loom ahead and in Hiroshima, Modi was taking the stage after the crushing defeat in the Karnataka election, which was as much political for the ruling BJP as personal for Modi himself.

But the optics were great. President Biden who is a past master in the art of flattery stooped to conquer Modi, even seeking an autograph and remarking that he envied the latter's "popularity".

It must be one of the paradoxes of our disjointed times that Hiroshima, a sleepy, southwestern coastal city, was handpicked as the setting for the G7 summit for its symbolism to "send out a strong message" against nuclear weapons. But it is a reminder too the United States is still the only country that ever used the atomic bomb as a weapon, when it dropped "Little Boy" on Hiroshima in 1945 quite unnecessarily as historians since concluded — killing an estimated 140,000 people and turning the theory of nuclear warfare into a terrifying reality.

Hiroshima was turned on its head to censure Russia and China. Innuendos were galore at the G7 summit packed with world leaders who preach one thing and practice something entirely different. The UK PM Rishi Sunak flew into Hiroshima after supplying depleted uranium munitions to Kiev, which soon exploded in the central Ukrainian city of Khmelnytsky, leading to a significant increase in gamma ra-

However, it was Modi's meeting with Ukraine's president Zelensky that brought out his outstanding techniques of communication. Even the insipid MEA readout written in staccato English brings out the flavour of their brief conversation.

Modi made three key points: one, for him, Ukraine war is not a political or economic issue but "an issue of humanity, of human values." Two, India supports dialogue and diplomacy "to find a way forward" and is willing to lend a hand in conflict resolution. Three, India will continue to provide humanitarian assistance to the people of Ukraine.

We don't know how Zelensky handled this tricky conversation. Perhaps, he actually limited himself to brief Modi "on the current situation in Ukraine." Modi's remarks message that he stuck to India's neutrality and neatly side-stepped the tendentious issues concerning the genesis of the Ukraine crisis or the complexities of Russia's confrontation with the West, leave alone the core issue of NATO's expansion into Ukraine (which Zelensky inherited) and the country's loss of sovereignty.

Instead, Modi took to high ground and harped on the human suffering due to the war and stressed the primacy of "dialogue and diplomacy". We may never know whether this would have caused uneasiness in Zelensky's

great opportunity was lost for Modi to hold the hands of Brazil's Luiz Inácio Lula da Silva and pool their intellectual resources — two giants who champion the Global South. But then, Washington may have queered the pitch by derailing Zelensky's appointment with Lula. (Zelensky failed to show up.)

Modi travelled to Hiroshima with an eye on his upcoming state visit to the US (June 21-24.) Besides, there have been signals from the Biden Administration lately that a kinder look at India's pleas for technology transfer may be possible.

Western pressures will continue on Modi government to give up its neutrality on Ukraine. The European Union has lately waded into the topic formally. (See my article EU calls out India on Russia sanctions.) But trust India to push back. The surest sign of it is Modi's reversion to "hug diplomacy," the appeal of EAM Jaishankar's abrasive style to BJP's "core constituency" in the social media notwithstanding

The heart of the matter is that the strategic ties that bind India and Russia signify a mutually beneficial partnership that is fully in conformity with international law and imbued with a "win-win" spirit and mutual trust and confidence in a volatile international climate of which Ukraine is only a symptom.

Confusing Airwaves

uctions have become a sort of buzzword when it comes to the allocation of spectrum of any kind in the communications world. Take, for example, the commotion over the methodology of allocating airwaves for satellite communication services or to enterprises for constructing private 5G networks. In both these cases, there is a vocal section arguing against auctions, only to be countered by another equally vocal section asserting that any allocation without an auction amounts to violating the Supreme Court judgment of 2012. There is no denying that auctions are the most transparent manner to allocate natural resources in the absence of any other methodology that is fair and in line with the principles of natural justice. This was also the essence of the Supreme Court judgement in 2012.

Spectrum auctions in the country began in 2010 following allegations of corruption and loss of revenue to the exchequer when the UPA government granted 122 telecom licences in 2008 at prices that were fixed in 2001. Since the demand for spectrum at that time was much higher than its availability (the number of operators in each area was 10-12), such allocation was seen to be highly arbitrary and the Supreme Court rightfully cancelled them in 2012. However, with the number of operators shrinking to just three after 2016, and the amount of spectrum increasing, sticking to auctions in each case doesn't make sense. For instance, the auctions of 2016 and 2021 saw the sale of only 40% of the spectrum and that too at the reserve price set by the Telecom Regulatory Authority of India (Trai). This proved that price discovery, which is the key objective of auctions, was not being met. The 5G auctions held in 2022 saw 71% of the spectrum being sold and were a huge success compared to the previous two. However, with the exception of one area, again all spectrum was sold at the reserve price.

The success of the 2022 auction was because Trai had lowered the reserve price by around 39% across bands, by changing the methodology of determining the base price. Past auction prices were not used as a benchmark for setting a fresh base price if the entire spectrum on sale in a given band didn't get sold. The message is clear: auctions are no longer held because too many players are chasing a commodity that is in short supply, so a price discovery mechanism is needed. In fact, the situation today is the opposite. Since the reserve price is fixed by the Trai according to a formula, and everything is sold at that very price, it is not very different from administrative allocation.

diation levels that could contaminate the earth in surrounding areas for decades.

The G7 was dripping with doublespeak. The erstwhile colonial powers waxed eloquently about "economic coercion" but craftily excluded South Africa as special invitee and instead chose Comoros. Why Comoros? Because, Comoros' most significant international relationship is with the erstwhile colonial power France, which will guarantee its good behaviour at Hiroshima.

To be sure, the cynical spectacle at Hiroshima couldn't have escaped Modi's attention. His "undiplomatic" remarks at the Working session 9 of the G7 Summit - on the ludicrous reality of the UN being a mere "talking shop"; the imperative need for respect for the UN Charter, International Law and sovereignty and territorial integrity of all countries; the unilateral attempts to change the status quo and so on would have made western leaders present in his audience squirm with embarrassment.

Even if that was not Modi's intention, what he stated — commas, semi-colons and full stops included — actually epitomised the US' continued illegal occupation of one-third of the territory of Syria, which was, by the way, one of the original members of the UN since 24th October 1945. The G7 presents a pathetic spectacle, indeed.

Ironically, but for a series of blunders on the part of Zelensky, the war wouldn't have erupted or escalated to the current level of violence — his rejection of the Minsk agreements that provided for provincial autonomy to the Donbass within a federal union; his obduracy to pursue a military solution to Donbass' alienation; his retraction from the Istanbul deal in late March last year within weeks of Russian intervention due to the back seat driving by the US and UK who had their own agenda to force regime change in Moscow

The government shouldn't be delusional about an enchanting prospect of India leading the West and Russia the door that never really opened in the post-cold war era into a rose garden. It simply isn't there. Neither has India the credentials nor the clout to be a peacemaker.

What is really disheartening is that a

sia energy cooperation, which is an evesore for the West, may even deepen, given the mutual interest. Bloomberg reported in the weekend that oil trade apart, in April, China and India also accounted for more than two-thirds of Russia's coal exports to Asia and that set to further increase in the coming weeks due to the emergence of El Nino, a recurring warm climate pattern that could cause droughts in the region.

According to a study in the prestigious journal Science, this year's El Nino is expected to develop between May and July and is likely to be especially strong. Bloomberg quoted an expert opinion:

"The worst place to be right now amid these searing temperatures is South Asia... [South Asians] are asking themselves: would I rather risk falling afoul of the US or forgo steep discounts on energy?

New Low-Cost Smartphone Attachment To Monitor Blood Pressure At Fingertip

cientists have developed a simple, low-cost clip that uses a smartphone's camera and flash to monitor blood pressure at the user's fingertip. The clip developed by researchers at the University of California (UC) San Diego, US, works with a custom smartphone app and currently costs about 80 cents (5.6 rupees) to make.

The researchers estimate that the cost could be as low as 10 cents (0.7 rupees) apiece when manufactured at scale.

The technology, described in the journal Scientific Reports, could help make regular blood pressure monitoring easy, affordable and accessible to people in resource-poor communities, they said.

It could benefit older adults and pregnant women, for example, in managing conditions such as hypertension, according to the researchers.

'We have created an inexpensive solution to lower the barrier to blood pressure monitoring," said study first author Yinan Xuan, a Ph.D. student at UC San Diego.

"Because of their low cost, these clips could be handed out to anyone



who needs them but cannot go to a clinic regularly," said study senior author Edward Wang, a professor at UC San Diego and director of the Digital Health Lab.

Another key advantage of the clip is that it does not need to be calibrated to a cuff, the researchers said. "This is what distinguishes our device from other blood pressure monitors," said Wang.

Other cuffless systems being developed for smartwatches and smartphones, he explained, require obtaining a separate set of measurements with a cuff so that their models can be tuned to fit these measurements.

"Our is a calibration-free system, meaning you can just use our device without touching another blood pressure monitor to get a

trustworthy blood pressure reading," Wang said.

To measure blood pressure. the user simply presses on the clip with a fingertip. A custom smartphone app guides the user on how hard and long to press during the measurement.

The clip is a 3D-printed plastic attachment that fits over a smartphone's camera and flash. It features an optical design similar to that of a pinhole camera. When the user presses on the clip, the smartphone's flash lights up the fingertip.

That light is then projected through a pinhole-sized channel to the camera as an image of a red circle. A spring inside the clip allows the user to press with different levels of force.

The harder the user presses, the bigger the red circle appears on the camera.

The smartphone app extracts two main pieces of information from the red circle. By looking at the size of the circle, the app can measure the amount of pressure that the user's fingertip applies.

By looking at the brightness of the circle, the app can measure the volume of blood going in and out of the fingertip.

An algorithm converts this information into systolic and diastolic blood pressure readings.

The researchers tested the clip on 24 volunteers from the UC San Diego Medical Center. Results were comparable to those taken by a blood pressure cuff.

"Using a standard blood pressure cuff can be awkward to put on correctly, and this solution has the potential to make it easier for older adults to self-monitor blood pressure," said study co-author Alison Moore, from UC San Diego School of Medicine.

Alexa Can No Longer Talk Like Amitabh Bachchan

The feature is going away globally, plus Amazon will discontinue support for celebrity voices on Alexa-powered devices in the coming days.

While purchasing Bachchan's



voice on Alexa, the page stated, "This skill is no longer available for purchase. Customers who previously purchased this experience will continue to have access for one year from the date of purchase".

On purchasing Jackson's voice on Alexa, the page mentioned that the personality voice for Alexa is no longer available for purchase,

and the customers who previously purchased the experience may continue to use the skill until April 30, 2023, by saying "Hey Samuel".

Jackson was the first voice to be introduced and could tell users jokes and stories or answer questions.

The celebrity voices, which debuted in 2019, make use of Amazon's neural text-to-speech model, which employs machine learning and is intended to sound more lifelike. Rather than using pre-recorded responses, the model generates voices with entertaining personalities.

In 2020, the feature came to India, and Bachchan became the first celebrity voice for Alexa in the country

Twitter Now Worth One-Third Of What Elon Musk Paid For It: Report

WASHINGTON: Twitter may now be worth one-third of what Elon Musk paid for the social media platform just seven months ago.

Financial services company Fidelity has reduced the market value of its equity stake in Twitter for a third time, now putting it at USD 6.55 billion. That's down from the nearly USD 20 billion Fidelity valued its stake at in October.

It is unclear how Fidelity came up with its valuation figures, but as a public company it's required to provide investors with updates on its holdings. Because Twitter is a private company now called X Holdings Corp., information about its finances can't be verified

Musk took control of Twitter in October, after a protracted legal battle and months of uncertainty. The CEO of Tesla, who also owns SpaceX, bought Twitter for USD 44 billion.

The billionaire financed the purchase with funds including loans from a group of banks. Musk has said the USD 44 billion price tag for Twitter was too high but that the company had great potential. By April Musk was telling the

BBC that running Twitter has been "quite painful" but that the social media company is now roughly breaking even after he acquired it late last year. Musk predicted at the time that Twitter could become "cash flow positive" in the current quarter "if current trends continue"

BEIJING: Tesla CEO Elon Musk has met top ministers in China to discuss the development of electric and "intelligent networked" vehicles as well as the expansion of the carmaker's operations in the communist nation.

The mercurial American tycoon, one of the world's richest men, is on his first trip to China in more than three years. He met Commerce Minister Wang Wentao on Wednesday and praised "the vitality and potential of China's development", according to a ministry readout.

Musk "expressed full confidence in the China market and was willing to continue deepening mutually beneficial cooperation", the ministry said. "China-US relations are not zero-sum game," it quoted

Musk as saying.

China accounts for half of the world's electric vehicle sales and is the site of Tesla's first factory outside the United States.

Tesla opened the first wholly foreign-owned car factory in China in 2019 after Beijing eased ownership restrictions to increase competition and speed up industry development.

In another meeting, Musk "exchanged views on the development of new energy vehicles and intelligent networked vehicles" with Industry Minister Jin Zhuanglong, his ministry said on its website.

The statement cited Musk as saying Tesla was willing to expand its business in China and

On Tuesday, Foreign Minister Qin Gang told Musk that China "unswervingly promote will high-level opening-up" and create a "market-oriented, lawbased and internationalised business environment", according to a government statement.

Go First Extends Flight Cancellations Till June 4

NEW DELHI: As uncertainties continue over its future course, crisis-hit Go First on Tuesday announced extending cancellation of flights till June 4.

Go First stopped flying on May 3 and the latest an-nouncement means that the budget carrier will remain grounded for one month.

This is the eighth time that the carrier has extended the cancellation of flights since the first announcement was made on May 2 when the services were cancelled for three days till May 5. "We regret to inform that due to operational reasons, Go First flights scheduled till 04th June 2023 have been cancelled," the airline said in a tweet.

According to the tweet, a full refund will be issued to the original mode of payment shortly.

"As you are aware, the company has filed an application for immediate resolution and revival of operations.

"We will be able to resume bookings shortly," it added. The carrier is undergoing insolvency resolution process and last week, aviation regulator DGCA asked it to submit a revival plan within 30 days.

On Monday, senior executives of the airline held discussions with senior DGCA officials on the revival plan.

The budget carrier, filed a petition for voluntary insolvency resolution proceedings on May 2, citing its inability to carry out operations due to the non-delivery of engines by the US engine maker Pratt & Whitney. The plea was admitted by the National Company Law Tribunal (NCLT) on May 10.

India Can Look For Another Year Of Solid Economic Performance: CEA

NEW DELHI: Enthused by higher than expected GDP number in the fourth quarter of FY23, Chief Economic Adviser V Anantha Nageswaran on Wednesday said India can look for another year of solid economic performance.

India's economy grew by 6.1 per cent in the January-March quarter of 2022-23, pushing the annual growth rate to 7.2 per cent on account of better performance by agriculture, manufacturing, mining and construction sectors.

Briefing media on the quarterly number, the CEA said the risk to the projected 6.5 per cent GDP number is evenly balanced and there is a good chance of this number may be exceeded in the current fiscal.

"So, we are very pleased to have been able to present a story of sustained economic momentum combined with macroeconomic, financial and fiscal stability, and we look forward to another year of solid economic performance by India," he said.

Last week, Reserve Bank Governor Shaktikanta Das said the growth for 2022-23 is expected to be more than the advance estimate of 7 per cent.

As per the second advance estimate released by the National Statistical Office (NSO) in February, the economy was estimated to grow at 7 per cent in 2022-23 against 8.7 per cent in the preceding fiscal.

Aircraft Bill

NEW DELHI: The civil aviation ministry has come out with a draft bill for putting in place a simplified approach for regulations pertaining to the aviation sector.

The Draft Aircraft Bill, 2023, has been prepared after reviewing the existing Aircraft Act, 1934.

As per the preamble of the Draft Aircraft Bill, 2023, it aims to have an Act to make better provisions for regulation and control of the design, manufacture, possession, use, operation, sale, import and export of aircraft and for connected matters.

The bill has been issued by the ministry for public consultations for a period of 30 days, according to a communication dated May 30.

"The existing Aircraft Act, 1934 has been reviewed and accordingly a bill providing for regulating provisions in a simplified manner, identifying existing redundancies and to provide for provisions to meet the current needs for regulation of civil aviation in a simplified language...,' the ministry said.

According to the preamble, it is expedient to make better provisions for regulation and control of the design, manufacture, possession, use, operation, sale, import and export of aircraft and for matters connected therewith or incidental thereto, and to remove the redundancies in the Aircraft Act, 1934.

Sensex, Nifty Trip Over **Profit Taking In Banking, Energy Shares**

MUMBAI: Benchmark stock indices Sensex and Nifty cut short their four-day gaining streak and closed lower by half a per cent on Wednesday due to profit-taking in banking, energy and metal stocks amid weak trends in global markets.

Snapping its four-day rally, the 30-share BSE Sensex fell 346.89 points or 0.55 per cent to settle at 62,622.24. During the day, it tumbled 568.11 points or 0.90 per cent to 62,401.02. The NSE Nifty declined 99.45 points or 0.53 per cent to end at 18,534.40.

In the four-day rally to Tuesday, Sensex advanced by 1,195 points or 2 per cent while Nifty rose by 348 points or 2.26 per cent.

"Markets witnessed profit-taking and shed over half a per cent, tracking mixed cues. After the initial downtick, the Nifty index traded with a negative bias for most of the session however a marginal rebound in the final hours trimmed some losses," said Ajit Mishra, SVP -Technical Research, Religare Broking Ltd.

Global headwinds, especially from the US markets, are causing intermediate volatility however the positional up trend is still intact, Mishra said.

From the Sensex pack, Axis Bank, State Bank of India, Reliance Industries, HDFC, HDFC Bank, NTPC, Tata Steel and UltraTech Cement were the major laggards on Wednesday.

OTT Platforms To Carry Anti-Tobacco Warnings; Health Ministry Amends Rules

New Delhi: India became the first country on Wednesday to make it mandatory for OTT platforms to display anti-to-bacco warnings and disclaimers as seen in movies screened in theatres and television programmes.

The Union health ministry notified the amendments in the Cigarettes and Other Tobacco Products Act, 2004 on the World No Tobacco Day.

According to the notification, the publishers of online curated content displaying tobacco products or their use will be required to display anti-tobacco health spots of a minimum of 30 seconds each at the beginning and middle of a programme.

The over-the-top (OTT) platforms shall also be required to exhibit an anti-tobacco health warning as a prominent static message at the bottom of the screen when tobacco products or their use are displayed during a programme.

Also, an audio-visual disclaimer of a minimum of 20 seconds on the ill-effects of tobacco use will have to be displayed at the beginning and middle of a programme, a source said.

"The anti-tobacco health warning message as specified in clause (b) of sub-rule (1) shall



be legible and readable, with font in black colour on white background and with the warnings 'tobacco causes cancer' or 'tobacco kills'," the notification stated.

Besides, the anti-tobacco warning messages, health health spots and audio-visual disclaimers will have to be in the same language as the one used in the online curated content.

The display of tobacco products or their use in online curated content shall not extend to the display of brands of cigarettes or other tobacco products or any form of tobacco product placement and display of

At an event organised at the health ministry, Union Health Minister Mansukh Mandaviya expressed concern over the rising tobacco consumption among the young generation.

He appealed to people to break free from the shackles of tobacco and embrace a healthier lifestyle.

"It is time to create wide awareness among youth and the nation regarding the seriously debilitating and harmful effects of tobacco consumption,"

Mandaviya said.

He mooted the idea of a "lok bhagidari" campaign on mission mode through a "jan abhiyan" (people's movement).

Enlisting the measures taken by India to free people from tobacco addiction and prevent tobacco use, Mandaviya highlighted that the OTT guidelines will go a long way to dissuade tobacco consumption.

Dr Poonam Khetrapal Singh, regional director, WHO-South East Asia Region, said, "Congratulations India on becoming the first country in the world to regulate anti-tobacco warning on OTT platforms. Today's move demonstrates India's unstinted commitment to protect the health of people from the harmful effects of tobacco. I commend the country's strong leadership and all stakeholders for this landmark step."

Bhavna Mukhopadhyay, chief executive, Voluntary Health Association of India, said the country has set an example in protecting young people from exposure to tobacco use and depiction of smoking scenes in the entertainment media. She said India has become a global leader by closing the regulatory gap in OTT media by extending the rules to such platforms.

BJP Can Be Defeated If Opposition Is 'Aligned Properly': Rahul Gandhi

Santa Clara (US): The ruling BJP can be defeated if the Opposition is "aligned properly' and the Congress party is working towards it and it is "coming along very nicely", Rahul Gandhi has told Indian Americans here, citing his party's emphatic victory in the recent assembly elections in Karnataka.

Responding to questions from the moderator and the audiences at an event at the Silicon Valley Campus of the University of California in Santa Cruz on Tuesday, Gandhi said he can clearly see "vulnerabilities" in the BJP. "As a political entrepreneur, I can clearly see vulnerabili-ties in the BJP... The BJP can be defeated if the Opposition is

aligned properly," he said. "If you look at the Karnataka elections, the general sense is that the Congress Party fought the BJP and defeated the BJP. But what is not well understood is the mechanics that we used," he said.

The Congress party used a completely different approach to fighting an election and building a narrative, Gandhi said, adding that elements of what happened in Karnataka came out of the 'Bharat Jodo Yatra'. In the May 10 elections to the

224-member Karnataka Assembly, the Congress won 135 seats, while incumbent BJP and the former prime minister H D Deve Gowdaled Janata Dal (Secular) got 66 and 19, respectively. Gandhi said in the Karnataka elections, the BJP spent 10 times more money than the Congress party. He said the country needed an alternative vision to defeat the ruling Bharatiya Janata Party (BJP), in addition to having a united Opposition in the 2024 general elections.

"On the matter of opposition unity, we are working towards it and it is coming along very nicely. But I think in order to defeat the BJP, you need more than just opposition unity. Just opposition unity, in my opinion, is not going to be enough to do the job. I think you need an alternative vision to the BJP," he said.

"Part of Bharat Jodo Yatra was the first step in proposing such a vision. It's the vision that all opposition parties are aligned with. No opposition party would disagree with the idea of the Bharat Jodo Yatra," he said.

Bharat Jodo Yatra (Unite India March) was a Gandhi-led mass movement aimed at uniting India. The yatra began on September 7 from Kanyakumari, passed through 12 states and culminated in Jammu and Kashmir on January 31.

A Mix Of Beckham & Gazza, Man City's Grealish Emerging As The Face Of English Football

MANCHESTER: Armed with the boyish charm and marketability of David Beckham and the skills and playfulness of Paul Gascoigne, Jack Grealish has a potent mix that has seen him quickly emerge as the face of English football.

Now that he is starting to add trophies to his growing list of endorsement deals that already include Gucci and Puma, the possibilities appear endless for the Manchester City winger who is the most expensive English football player of all time.

Grealish – he of the bulging calf muscles and swept-back hair – was already hot property in the English game before a 2021 move from Aston Villa to City for 100 million pounds (then \$139 million) that took his appeal to a new level.

Nearing the end of his second season at City, the 27-year-old Grealish has finally established himself as a key part of a Premier Leaguewinning team that is seeking to clinch the second leg of a treble of major titles this season by beating Manchester

United in the FA Cup final on Saturday. He is far more than a foot-

ball player these days, though. "People like Jack Grealish are the new sports lifestyle icons," Alan Seymour, a sports academic and author in business and marketing, told The Associated Press. "As he's matured and got more attuned to what is required of him as a footballer, on the field and off the field, it's why he is right up there with the very best sports personalities for marketability, not only in football but away from football."

Elements of the wild-child image that shadowed him in the early years of his career remain.

At the height of the lockdown amid the pandemic, Grealish was found slurring his words after crashing his car in a residential estate and was later banned from driving for nine months. Then there were those images of him playing a prominent role in City's Premier League title celebrations last year, when he was seen swigging a beer and – blearyeyed and with a croaky voice – aiming a dig at Newcastle



midfielder Miguel Almiron that gained plenty of air time. Grealish unashamedly accepts that's who he is. He recently said he might have been a nightclub promoter if he wasn't a football player and that he'd always be prone to the kind of excesses that mean he embodies the spirit of a regular football fan.

But the loveable, charming part of Grealish's personality is

inescapable. It shines through in every interview he does he pinches himself that he is a football professional, playing against the likes of Real Madrid in the Champions League – and in his public friendship with a young City fan named Finley, who has cerebral palsy. He's a popular member of the City squad, striking up a particularly close relationship with superstar striker Erling

Haaland off the field.

"I feel so much more confident in this team," said Grealish, who was left out of many of City's big games last season while he adapted to the demands of manager Pep Guardiola. "I feel fitter and back to what I know, what I can do. This is why City bought me and I have so much to offer."

Big brands think so, too. He is an ambassador for fash-

ion house Gucci and for Bose audio equipment, and this year signed a boot deal with Puma that's reportedly the most lucrative by a British player, worth about 10 million pounds per season over the next five years.

He has 7 million followers on Instagram and 4.2 million on TikTok. The British press are even starting to liken Grealish and his girlfriend, fashion model Sasha Attwood, to David and Victoria Beckham, and the way Grealish wears a handband – boyband-style - to manage his floppy hair furthers the comparisons with Beckham, even if their playing style is very different.

"He has boyish charm and likeability, that impish, roguish element to him," Seymour said. "If I put it into marketing speak, you have a point of difference and point of parity his point of difference is his appeal

"The synergy (with Beckham) is clearly there," he added. "But a sportsperson always says I don't want to be compared to, I want to be the new, 'I am.' I think Jack Grealish will always go out of his way

to point that out. He is putting himself out there and that is what sponsors look for."

The comparisons with Gascoigne, the mercurial central midfielder who helped England to the semifinals of the 1990 World Cup and the 1996 European Championship, come in the way Grealish carries the ball with such pace and directness that he is constantly one of the most-fouled players in the Premier League.

Grealish knows he needs to score more goals and have more assists to be rated as one of the world's best attackers, but his technique and first touch is up there with the game's finest players.

Guardiola values, in particular, the control Grealish brings to the team from his spot on the left of the team's front three and that – plus his work rate - is why he is now a first-choice pick for the biggest games.

Like the FA Cup final on Saturday and the Champions League final against Inter Milan the following weekend.

'We still have some massive games left," Grealish said, "and we feel unstoppable."

Artificial Intelligence Threatens Extinction, Experts Say In New Warning

Scientists and tech industry leaders issued a new warning Tuesday about the perils that artificial intelligence poses to humankind.

Mitigating the risk of extinction from AI should be a global priority alongside other societalscale risks such as pandemics and nuclear war, said the statement posted online.

Sam Altman, CEO of ChatGPT maker OpenAI, and Geoffrey Hinton, a computer scientist known as the godfather of artificial intelligence, were among the hundreds of leading figures who signed the statement, which was posted on the Center for AI Safety's website. Worries about artificial intelligence systems outsmarting

ligence systems outsmarting humans and running wild have intensified with the rise of a new generation of highly capable AI chatbots such as ChatGPT.

More than 1,000 researchers and technologists, including Elon Musk, signed a letter earlier this year calling for a six-month pause on AI development because, they said, it poses profound risks to society and humanity.

Countries around the world are scrambling to come up with regulations for the developing technology, with the European Union blazing the trail with its AI Act expected to be approved later this year.



Why China Is Drilling A 32,808-Feet-Deep Hole Into The Earth's Crust

Chinese scientists have begun drilling a 10,000-meter (32,808 feet) hole into the Earth's crust, as the world's second largest economy explores new frontiers above and below the planet's surface. Drilling for what is set to be

China's deepest ever borehole began in the country's oil-rich Xinjiang region on Tuesday, according to the official Xinhua News Agency. Earlier that morning, China sent its first civilian astronaut into space from the Gobi Desert. The narrow shaft into the ground will penetrate more than 10 continental strata, or lavers of rock, according to the

than 10 continental strata, or l layers of rock, according to the report, and reach the cretaceous system in the Earth's crust, which features rock dating back some 145 million years.

"The construction difficulty of the drilling project can be compared to a big truck driving on two thin steel cables," Sun Jinsheng, a scientist at the Chinese Academy of Engineering, told Xinhua. President Xi Jinping called for greater progress in deep Earth exploration in a speech addressing some of the nation's leading scientists in 2021. Such work can identify mineral and energy resources and help assess the risks of environmental disasters, such as earthquakes and volcano eruptions.

The deepest man-made hole on Earth is still the Russian Kola Superdeep Borehole, which reached a depth of 12,262 meters (40,230 feet) in 1989, after 20 years of drilling.

Indian Women Embark On First Hajj Without Male Guardians

NEW DELHI: As she prepares to fly to Saudi Arabia, Gulzar Begum will soon see her dream of two decades come true: She will embark on the spiritual journey she has been saving for by teaching the Qur'an. The 74-year-old from the Dakshinpuri area of South Delhi will be among thousands of Indian female pilgrims who next month will perform the Hajj on their own, without a mahram, or male guardian.

"I cannot express my feelings and joy," Begum told Arab News. "For a long time, I have been saving money for the Hajj. I am not a rich woman. I don't have a husband, and my two sons are not rich enough to go with me."

She and other women pilgrims traveling to Saudi Arabia alone can do so now, after the Kingdom's decision last year to lift a rule that required women to be accompanied by a mahram. Those who had no such companion could only travel in large groups of other women.

Following the new rule, India has tweaked its Hajj policy and over 4,300 pilgrims in the Ladies Without Mahram category will, according to the Ministry of Minority Affairs, mark the country's "largestever contingent of women proceeding on Hajj alone without a male (family) member." Last year, the figure was 2,000.

With over 200 million Indians professing Islam, Hindu-majority India has the world's largest Muslimminority population. Under the



2023 Hajj quota, 175,000 of them are traveling to Saudi Arabia for the pilgrimage, which is one of the five pillars of Islam.

Special flights for pilgrims started earlier this week.

Munawari Begum, the vice president of the Haj Committee of India, just returned from the Kingdom after making all the necessary arrangements for female pilgrims.

"Hajj this year is special," she told Arab News. "We have made special arrangements for the stay of women in Saudi Arabia...Their attendants will also be women."

Many Muslim women have welcomed changes in India's Hajj policy since its announcement in February. Kausar Jahan, chairwoman of the Delhi Haj Committee, told Arab News it was an "attempt to empower women."

She said: "It is inducing not only economic independence of women but also self-reliance.

"There were many women who earlier wanted to go for Hajj alone, but the rule was strict, and they could not go. Now, women have their own independence."
