# **Unpredictable Weather, Unprepared Farmers: Kashmir Fruit Growers Hit Hard**

short month ago, the blooming trees in Ghulam Rasool Ganaie's apple orchard in South Kashmir's Kulgam were a sight to behold, with their vibrant hues of white filling his heart with anticipation for a good yield this year. He watched over the orchard day and night, tending to each tree with utmost care, but nature threw a wrench in his plan. It felt like the skies were conspiring against the fate of his produce as the quick burst of hailstorm earlier this month rendered his fruit worthless.

"The pea-sized hails have caused deep depressions and deformed the young fruit. We didn't earn any profit last year despite a bumper crop, and it seems like this is going to be another year of loss for us," Ghulam Rasool said. "I am struggling to pay off my previous debts. This is a disaster," he added, as he tried to avoid the sight of the bruised apples.

Budgam: Stating that the security forces have been given clear-cut directions "not to touch any innocent", Jammu Kashmir's Lieutenant and Governor Manoj Sinha Saturday said elections in J&K will be held in a transparent manner first time and nobody will be allowed to "hijack democracy" as seen in the past.

Addressing a public gathering at Beerwah here, the LG said that gone are the days when elections were rigged and democracy hijacked in J&K.

"Everything is taking place in a transparent manner. Whenever elections are held in J&K, the process will be held in a transparent manner as well for the first time. Nobody will be allowed to hijack democracy as seen in the past," he said.

The LG said that "clear-cut directions" have been passed to the security agencies and "I can tell you with full authority, no innocent will be touched by the



security agencies in J&K." Taking a jibe at the previous governments, Sinha said that people were given hollow prom-

ises and tall claims in the past. "Things changed immensely after 2019. Our motive has been to serve people and to come up to the expectations of the masses. Every challenge has been turned into opportunities," he said, adding that before 2019, development was confined ous regimes," he said.

### Daily Traffic Jams On Sgr-Jammu **Highway Challenge For Commuters**

Jammu: The daily traffic congestion on the Ramban-Banihal sector of the 270-kilometre-long Jammu-Srinagar national highway has become a major concern for thousands of commuters.

This highway otherwise known as NH 44 is the only allweather road linking Kashmir with the rest of the country.

According to commuters, while a majority of the construction work that started in 2016 on the highway has been completed, some tunnels, bypasses, and flyovers are yet to be finished.

The main causes of the traffic congestion include landslides, mudslides, stone shooting, movement of nomads, and narrow roads at various locations along the route", an entrepreneur named Arvind Koul said. Koul, who often visits Kashmir, says that traffic jams and potholes on highways pose

a danger to commuters' lives. In comparison to 2021 and 2022, the highway in the Ramban section is in a bad state this year. It feels like torture to travel via it these days, he said.

Authorities have recognised the need for immediate measures to control the traffic congestion in the Ramban-Banihal sector, particularly with the annual Shri Amarnath Yatra pilgrimage, starting July 1.

# Srinagar To Develop 80-Km Walking **Space Under Smart Cities Mission**

Srinagar: Srinagar will develop 80 kilometres of walking space in an "unprecedented" development for any Indian city, besides introducing water transport and electric buses under the Smart Cities Mission, a top official said.

Cycling tracks, a robust sewerage system and an underground electricity network across the city are also being set up, Srinagar Smart City CEO Athar Aamir Khan said.

According to the plan, electricity poles through which power is supplied to domestic consumers will be replaced with smart distribution plugs in Srinagar.

Of the 125 projects under the Smart Cities Mission -- one of the Narendra Modi government's flagship programmes -- 55, including redevelopment of the city's famous Polo View Market, have been completed and the rest are planned to

be executed by the year end. Projects under the mission aim

to transform Srinagar into a mod ern, sustainable and economically vibrant city with a dedicated focus on improving infrastructure and services and increasing mobility.

Khan said all the projects under the mission, being implemented by the Union Housing and Urban Affairs Ministry, will strengthen urban infrastructure, improve city services, public aesthetics and ease of living and provide a clean and sustainable environment.

"We have plans to develop 80 kilometres of walking infrastructure in Srinagar, which is unprecedented for any city in the country. The city should be walkable and pedestrian-friendly and nonmotorised infrastructure is of the highest priority," he said.

The Srinagar authorities are also installing 1,500 smart CCTV cameras for multiple purposes. Of

these, 500 cameras have already been installed, Khan said. Talking about the redevelop-

ment of the famous Polo View Market, executed at a cost of around Rs 10 crore, he said there was choas as nothing was in order earlier. "We recently completed the re-

development project of the Polo View Market under which it has now become a non-motorised and pedestrian-friendly zone," the officer said. Mohammad Yaseen, vicepresident of the Polo View Market

Association, said there has been a 20 per cent rise in footfall since the redevelopment. "We are hoping that our busi-

ness will also grow with the redevelopment of the market. The traders appreciate the Srinagar authorities' efforts to redevelop the market," Yaseen told PTI. Khan said they are also pro-

curing 100 electric buses and added it will be the first time that electric buses will be part of the public transport system.

"We are looking at how to have better public transport for the city. To begin with, we are procuring 100 electric buses, 25 of which will start operating by the end of July," Khan added.

The Srinagar Smart City Limited aims for a comprehensive overhaul of the city's urban infrastructure, making it resilient, safe, sustainable and significantly improving the quality of life of citizens.

Khan said the Srinagar authorities are also working on an integrated public transport system, describing it as the most efficient and equitable solution for urban mobility and climate change.


Public transport saves money. facilitates movement and, hence, increases opportunities and increases land value, he added.

According to officials, 17 ghats are being improved for dedicated boarding and alighting for water transport apart from redevelopment of 25 others as public spaces around the Jhelum river.

All these water transport ghats are designed on the principle of universal accessibility and have amenities such as public toilets and kiosks. The development of parks and community spaces along the ghats has been taken up as public spaces in the densely populated Shehr-e-Khas neighbourhood.

Last month, the Union Housing and Urban Affairs Ministry extended the deadline for the Smart Cities Mission till June 2024 following requests from some cities that sought more time to complete their ongoing projects.

The earlier deadline was June 2023. The Modi government launched the Smart Cities Mission in June 2015 with 100 cities being selected for redevelopment through a two-stage competition from January 2016 to June 2018.

# **BRICS Open To** Expansion, Gives Call For a 'Multipolar' World

NEW DELHI: Foreign ministers from the five-country BRICS group called for a "rebalancing" of the world order in Thursday talks held in South Africa.

"Our gathering must send out a strong message that the world is multipolar, that it is rebalancing and that old ways cannot address new situations," said foreign minister S. Jaishankar in his opening remarks. "We are a symbol of change and must act accordingly," he added. The minister also said that the concentration of economic power "leaves too many nations at the mercy of too few

### What BRICS foreign ministers discussed

Talks among the BRICS group comprising Brazil, Russia, India, China and South Africa centered on the potential use of alternative currencies to the US dollar for international trade and strengthening the group's New Development Bank.

Members of the bloc also discussed reforming global decision-making, with South African foreign minister Naledi Pandor criticising the lack of permanent African representation on the United Nations Security Council.

# Could BRICS expand to in-

clude new members? Russian foreign minister Sergey Lavrov said that "more than a dozen" countries had expressed their interest in joining the BRICS group. Possible expansion could include the oil producing nations of Saudi Arabia, Iran and the UAE.

Lavrov said that the issue of the enlargement was discussed with Saudi foreign minister Faisal bin Farhan, who was also in Cape Town. Chinese vice foreign minister Ma Zhouxu said that Beijing expects the group to take on new members. "We expect more countries to join our big family," Ma said. Will Putin participate in the

### **BRICS summit in August?**

The talks come ahead of an August summit to be held in Johannesberg and to which Russian President Vladimir Putin is invited.

South Africa is a member of the International Criminal Court (ICC), which has issued an arrest warrant against Putin. South Africa would thus be required to arrest the Russian president under the terms of the treaty that established the ICC.

# **Odisha Tragedy Shifts Focus From ₹2.4 Trillion Rail Revamp To Safety**

NEW DELHI: India's vast rail network is undergoing a \$30 billion transformation with gleaming new trains and modern stations but Friday's deadly train accident shows more attention should be paid to safety, industry analysts said. At least 261 people were

killed in the country's worst rail accident in over two decades after a passenger train went off the tracks and hit another in Odisha.

Indian Railways runs the fourth largest train network in the world. It transports 13 million people every day and moved nearly 1.5 billion tonnes of freight in 2022. Long-considered the lifeline

of the world's most populous country, the 170-year-old system has seen rapid expansion and modernisation under Prime Minister Narendra Modi's push to boost infrastructure and connectivity in the fast-growing economy.

This year, the government made a record 2.4-trillion-rupee (\$30 billion) capital outlay for the railways, a 50 per

cent increase over the previous fiscal year, to upgrade tracks, ease congestion and add new trains.

A new, semi-high-speed train built in India and called the "Vande Bharat Express", or "Salute to India Express", is showcased as evidence of this modernisation, with PM Modi himself flagging off the first journeys of many of the trains around the country.

But Friday's crash has come as a jolt to this makeover, experts said.

"The safety record has been improving over the years but there is more work to do,' said Prakash Kumar Sen, head of the department of mechanical engineering at Kirodimal Institute of Technology in central India and lead author of a 2020 study on "Causes of Rail Derailment in India and Corrective Measures".

"Human error or poor track maintenance are generally to blame in such crashes," Sen said

The railways have been introducing more and more trains to cope with soaring demand but the workforce to maintain them has not kept

pace, he said.

Workers are not trained adequately or their workload is too high, and they don't get enough rest, Sen said.

The east coast route on which Friday's crash occurred, is one of the country's oldest and busiest, as it also carries

much of India's coal and oil freight, he said. "These tracks are very old . the load on them is very

high, if maintenance is not good, failures will happen," Sen said. 'Good safety record' Indian Railways maintains

that safety has always been a key focus, and points to its low accident rate over the years

"This question (on safety) is arising because there has been one incident now. But if you see the data, you will see that there have been no major accidents for years," a railways ministry spokesperson said.

The number of accidents per million train kilometres, a gauge of safety, had fallen to 0.03 in fiscal 2021-22 from 0.10 in 2013-14, the spokesperson said.

### "There Is Always A **Counter": Air Force Chief On Emerging Chinese Threat Press Trust of India**

NEW DELHI: Indian Air Force chief Air Chief Marshal V R Chaudhari on Friday said the IAF is "fully aware" of the developments that are taking place across the northern borders and asserted that since the Galwan Valley crisis in 2020, the force is continuously upgrading its capabilities and changing tactics to be able to handle any threat. At an event here, the IAF chief also said that three winters

down the line, "we have created adequate infrastructure" and ensured "adequate deployment of all our assets" to have a "credible deterrence in that area".

The Indian and Chinese troops are locked in an over-three-year confrontation in certain friction points in eastern Ladakh even as the two sides completed disengagement from several areas following extensive diplomatic

and military talks. The ties between the two countries nosedived significantly following the fierce clash in the Galwan Valley in June 2020 that marked the most serious military conflict between the two sides in decades.

"We are always on 24x7 readiness to take on any challenge. We are fully aware of the developments that are taking place across our northern borders. We keep a regular surveillance over what is happening there and our acquisition and deployment philosophy is always based to counter such kind of threats that are likely to emerge from there," Air Chief Marshal Chaudhari said in response to a question on threat from China

since the Galwan clash. He said that after the Galwan crisis, the primary aim was to "enhance our surveillance in that area, to actually see what is happening across the border". "So, we had to deploy a large



number of radar of all sizes in that area. We had to bolster it by deploying surface-to-air guided weapons. We had to redeploy our fighter aircraft," he said.

The IAF chief was speaking during an interaction held at the Times Network's India Economic Conclave.

Air Chief Marshal Chaudhari added that "we had taken all measures to ensure that our presence was felt, and it was in deterrence to the adversary".

He shared that the primary issue that had hit the Indian side at that time was maintaining a steady logistics chain in such kind of a harsh environment.

"In 2020, we were sceptical how we will overcome the harsh winter. But three years down the line, three winters down the line, I think, we have created adequate infrastructure, we have ensured logistics supplies are available and adequate deployment of all our assets are there to have a credible deterrence in that area," he said, when asked about India's response since the 2020 crisis.

On handling any emerging Chinese threat, he said, "We are continuously upgrading our capabilities, and changing our tactics, techniques and procedures, to be able to handle the threat." Asked if there are any gaps in countering such threats, he said, gaps cannot be quantified, but those are being overcome with better tactics and technologies.

Iran, Saudi, UAE to **Form Joint Naval Force Facilitated by China** Agencies

ran, Saudi Arabia, the UAE, and Oman, in coordination with China, will form a joint navy to protect security in the Persian Gulf, Qatar's Al-Jadid news website announced. This past March, China, Russia, and Iran held joint naval drills in the Gulf of Oman, near the mouth of the Persian Gulf. Top Saudi and Iranian diplomats also met in China for the first time in over seven years in April, confirming the reopening of their embassies and consulates and resuming direct flights and visa facilitation for citizens. China Iran and Saudi Arah each have interests in friendly relations. China purchases oil from the other two countries. Iran's oil sales are limited by U.S. sanctions, so it needs the Chinese as buyers. Saudi Arabia's crown prince Mohammed bin Salman wants to focus on national economic projects instead of expending resources on the war in Yemen, where the Iran-backed Houthi militia launches drone attacks on the UAE and Saudi Arabia. Ties between China, Iran, Saudi Arabia, the UAE, and Oman are at odds with U.S. interests. The UAE recently halted participation in an American-led maritime security coalition in the Gulf region without formally notifying the U.S. That

move followed Iran's seizures of multiple oil tankers in the region and may have been driven by the sense that the U.S. is not adequately protecting Gulf allies from Iranian aggression. U.S. officials viewed the seizures as a violation of international law and a threat to regional security. Still, the Biden administration has failed to enforce sanctions

on Iran as its oil sales rise. The joint navy's formation may reflect the statement of Iranian Revolutionary Guard Corps naval commander Alireza Tangsiri, who said that "the security of the Persian Gulf is provided by Iran and the countries of the region, and there is no need for you [the U.S.] or any other country to be present.'

### **Odisha Train Crash**

## **Investigate If Anti-Collision Device Was Installed On Route: Dr Farooq**

SRINAGAR: National Conference (NC) president Farooq Abdullah on Saturday said a probe should be carried out to ascertain if the anti-collision

device was installed on the route that witnessed a horrific train crash in Odisha's Balasore and fix the responsibility for the accident that has claimed at least 261 lives.

"Recently, the honourable railway minister announced that they have now got a major device whereby these accidents will not take place. I think this must be investigated whether that device was there and if it was, why was it not functioning? It is a major disaster that has not occurred for a long time in the country. I think we all want to know what happened," the former Union minister told PTI TV.

The Indian Railways, which has initiated a high-level probe into the train crash to be headed by the commissioner of

railway safety, South Eastern Circle, has clarified that antitrain collision system "Kavach" was not available on the route. "The rescue operation has been completed. Now, we are starting the restoration work.

# **Kishtwar To Be North India's Major 'Power Hub': Singh**




HERE is no doubt to the fact that technology has changed our lives beyond any imagination. It created tools which made our life easy in multiple ways. It's funny to think how so many Bollywood movies back in 60s and 70s revolved around this story of separated brothers at a Kumbh mela, and who years later reunite. In present era its unthinkable. We have Google, social media et al. We'll just look them up.

A part of my maternal family is based in Egypt. My maternal great grandfather Khoje Mohammed Syed Khan had trade business in Alexandria Egypt, for which he would often travel there. In the early spring of 1935 he left for Cairo and never returned. For next few years he exchanged letters with his family in Kashmir. That stopped too later. I've looked them up many times on the internet- using keywords like Kashmiri family in Egypt. Haven't had much success till now, but I'm still trying.

We can book a air ticket for any part of the world, and in minutes be travelling there. From the comfort of my house I can book a Uber cab and within minutes I can reach to my destination. Few days back my mind wandered towards my College. Partly anxious about how students must be coping with social distance in hostels. I joined a facebook page and I literally had a virtual tour of my college. Someone had posted a live feed of semester exam, with proper physical distance and SOPs being followed. I heaved a sigh of relief, to look at the development of my college and its responsible attitude to current crisis. I could watch it all thousands of miles away.

But there is a flipside to all this. Social media platforms like Facebook, Instagram, Twitter, Snapchat have become so big now that they have taken a life of their own, and not necessarily in a correct way. Studies have shown direct link between mental issues and excessive social media use. There has been an incredible increase of mental health cases since social media became what it is. Unfortunately the problem is even more grievous.

We are clearly living in a more polarized world. The decades after World War 2 were liberating at societal and cultural level. The world had suffered inordinately in the second world war. People wanted a change. Imperialism was on its way out from sub-continent and Africa. Newly independent nation states opted for democracy and liberalism. India's socialist Prime Minister Jawahar Lal Nehru set India out on its path of progress and liberty, Pakistan ruled by army was focusing on its own path - a very liberal society where you had the freedom to choose. Immigrants from Asian countries were welcome in more developed west. There are multiple stories of immigrants bringing laurels to their adopted home. When France won the 1998 FIFA World Cup, 6 of its players were immigrants. Champs-Elysees celebrated the success together. This was probably the great immigrant dream coming true. A world that was shrinking into a Global Village.



So how did we land up here? A world where democracies are under threat, right-wing politics is on rise and what should have been an age of information, is clearly turning to a world of disinformation.

When we look around, you see that world is turning crazy. Is it acceptable? Is it normal? No. It cannot be. And that is exactly what I will try to explain.

Social media platforms like Facebook, Instagram, Twitter are currently used by billions of people on earth. Never in the history of mankind have people come together across ethnicities on one platform. That is the power of social media. With all the good it can do, and it has, these systems are run by giant computers. I'm not questioning the intent of these platforms. When developers in facebook invented the 'like' button, it was meant to spread positivity. The developer had no inkling to the fact that it could lead a preteen into depression, when his/her post didn't get enough likes. The platforms on their own are not evil, but it's what technology does with it, that should be our cause of concern.

And cause of worry is the business model that these platforms use — which in broader terms means — we the users being the product, and we being sold to the advertisers, who in turn pay to facebook, twitter, YouTube and others. The idea of this business model is to get as much as possible our attention. The more time we spend on Facebook, YouTube, Google, more money we are generating for them.

Ok, but then what's so wrong about it? I use facebook to stay in touch with my friends, I use YouTube to watch videos and etc. Right? Naive. It's this naivety of us which has brought us to the point we are at.

So if I'm slightly bent towards right politics, or I'm anti-Muslim, I'll open a link or a video on

Facebooks or Twitter that endorses this idea, AI will run an algorithm in the background, notifying it that this person probably is interested in right politics and is anti-Muslim. Next time I login back, my feed will be filled with videos or links about right politics and anti-Muslim speeches. It is a viscous system . So even if I think I'm clicking a link or video with my own will, it is not entirely the truth. We are told, we are programmed to watch the stuff that the AI wants us to. That is how this system is meant to work and become monetized.

So someone who was probably 10% a radical the first time he logged onto social, by few months he would be at 100%. Because he is constantly fed this information. He thinks this is how the world operates. Hence we are seeing hate crimes, Islamphobia, crime against minorities, banning immigration gaining traction in the world.

And to envisage its whole repercussions is scary. Political movements are run using this data. Elections can be fought and won by using all this data. Despots could be ruling our institutions which we have created with great difficulties. Our fragile social fabric can be shredded to pieces, because this new market place is unregulated. Every single click is monitored by these social media giants. Facebook, Twitter, Instagram, YouTube can sell all this data to anywhere without any intervention of a regulatory body. And then to imagine what possibly could be done with all this data. It's insane we have let this happen.

In the end we must be asking this question to ourselves. What sort of world are we leaving behind for our children. If that matters, we as a people must come together and force governments to intervene. We cannot ignore the elephant in the room.

# How Much Work Is Enough?

ASHINGTON, DC – The pandemic COVID-19 might be officially over, but much like a railway switchyard, it has already diverted countless lives onto wildly different paths. Millions of individuals will never revert to their pre-pandemic work routines, compelling both employers and employees to establish new models that cater to their evolving needs. But amid the ongoing experiments with hybrid models, we find ourselves confronting a deeper question: How much work is enough?

At least in developed countries, these post-pandemic shifts and experiments could trigger a labor-market revolution as profound as the changes in workplaces, schedules, and compensation that marked the transition from the agricultural age to the industrial era.

These changes can be viewed on two levels. At the macro level, the legally mandated eight-hour workday and 40-hour workweek are gradually giving way to a new equilibrium. This will likely be a long process, given that it took half a century of labor struggles, union action, and corporate experimentation to reduce daily working hours in the United States from 14 to eight and workweeks from seven days to five.

In 1914, the Ford Motor Company stunned its competitors by shortening the factory workday to eight hours while paying its workers a minimum wage of \$5 per day. Congress codified this innovative practice in 1938 through the Fair Labor Standards Act, creating what cultural historian Fred Turner calls the "industrial-era social compact." Similarly, recent experiments with a 32-hour workweek resulted in less fatigue, improved mental health, and enhanced life satisfaction. In fact, most participants say they will not revert to the old model. At the micro level, millions of

So, when companies began to demand that workers return to the pre-pandemic status quo, the question, "How much work is enough?" prompted another: "Enough for what?" To earn a living? To meet our employers' productivity expectations? To support our pursuit of happiness, or perhaps to retire? The answers vary, depending on who asks and who responds. For millions of low-income workers, the answer is simple: "Enough" means earning a living wage that enables them to support themselves and their families.

Among those privileged enough to be able to consider the tradeoffs between time and money, two groups of workers have, through their words and their actions, emerged as key players in the broader discussion about what constitutes an adequate

amount of work.

The first group consists of caregivers, a sector still dominated by women but gradually attracting more men. In labor economics, "work" traditionally refers to paid labor involving the production of goods and services in return for monetary compensation. But following the integration of women into the workforce (including the workforce of labor economists), the field has expanded its focus to encompass unpaid work. This includes raising a family, making a home, and meeting the needs of those who cannot care for themselves. This care work, as activist Ai-jen Poo reminds us, is the "work that makes all other work possible." For many, this form of labor holds as much

meaning as their formal employment, or even more.

Suppose we expand the question "How much work is enough?" to encompass both paid and unpaid work. In that case, it becomes apparent that millions of people with caregiving responsibilities and paid jobs often find themselves working well beyond the conventional eight-hour workday. It should come as little surprise, then, that given the opportunity, many would opt to reduce their paid working hours in order to care for others. Given the social importance of care work, economic statistics and government benefit programs must recognize and account for this critical but unpaid form of labor.

Another significant group of workers asking, "How much work is enough?" comprises young people, particularly younger Millennials and Gen Z workers, many of whom entered the workforce during the pandemic. Just as many young people in the 1960s "turned on, tuned in, and dropped out," embraced the counterculture, and rejected what they saw as the conformist striving of their parents' generation, many Gen Z'ers are now questioning and rejecting "hustle culture" as yet another toxic Silicon Valley export.

Gen Z'ers were raised during two tumultuous decades marked by the 9/11 terrorist attacks, the introduction of the smartphone and social media, the 2008 financial crisis, and the pandemic. Today, they face downward social mobility, democratic backsliding amid intensifying political polarization, and a looming climate catastrophe. Given this historical backdrop, it is natural for them to question their parents' habits and focus on maintaining their own mental and physical health.

Gen Z icons like Simone Biles and Naomi Osaka, who withdrew from major sporting events to protect their mental health, embody the drive, grit, and grind necessary to excel at the highest levels of their fields. But by rejecting the notion that their selfworth – particularly as trailblazing women of color - hinges on meeting others' expectations of them, they demonstrated a profound understanding that personal well-being should not be sacrificed for external validation. Their insistence that life must be about more than producing and winning is an act of defiance against capitalism itself.

Since the emergence of ChatG-PT and its competitors, discussions about the future of work have revolved around the extent to which human labor will remain necessary. To be sure, the integration of generative artificial intelligence into the labor market will bring about significant disruption, rendering traditional industrial-era work and workplaces obsolete. But regardless of what lies ahead, we cannot address the questions of where and how long we work without first answering the fundamental question of why we work.

# An American Journalist's Kashmir Dateline

Here's an excerpt from the book: A Trip to the Country... or, Escape From Waterhal David Lepeska



NY journey into rural Kashmir is bound to be fraught with danger, what with its hidden, un-Apredictable militants, secretive paramilitaries, anxious soldiers, and conflicted locals caught in the crossfire. Yet last Thursday morning my colleague Farooq Shah and I set off in search of that rare ani-mal: an outdoor primary school, with mud seating for upwards of fifty children, little or no facilities, barely-trained teachers, and nothing but the Valley's bitter late autumn for a roof. A disconcerting image of just such a beast had appeared without warning in our paper the previous week and, being enterprising journalists' game for a good story and an adventure, we packed up our gumption, a Twix bar and some chewing gum, and sallied forth into the relatively uncharted southern reaches of Budgam district.

We hit the road at the crack of 11, my little motorbike as game as could be after 19 Valley winters. Thrumming joyously and adding to the warmth kindled by our huddled torsos and reportorial verve, the old blue lady zoomed around curves and bobbed up and down, in and out of vast water-filled potholes, we two riders twittering like morning sparrows. Neither the previous few days' downpours and bitter cold nor the threat of a run-in with armed men of indeterminate allegiance could dampen our spirits.

Shortly after noon, however, our rural jaunt began to feel more wild goose chase-y. The mud sucked greedily at our bald tires. The road, with its jeep-sized potholes, became a minefield, and our destination, the tiny village of Waterhal, increasingly mythical. Minimal signage, suspicious, tight-lipped villagers, and a bland brown landscape bereft of identifying markers added to the sense of foreboding. Yet we soldiered on, querying a few locals to regain our bearings, and soon enough crossed a little concrete bridge into our dust speck of a destination. Middle-aged men commiserated next to tea shacks. Women carried baskets of spinach-like greens and bulging plastic sacks of rice on their heads. The road grew yet muckier and still on we ventured, finally hearing the high-pitched voices of young children just off to our right as we neared the top of a small rise.

We parked and clambered up a short, slippery slope and found ourselves in the Middle Ages, which is to say the very school from the photo. Children as young as three and four were bundled in sweaters and scarves and pherans, faces unwashed, noses drip-ping and feet bare and purpling. Shivering yet smiling at their visitors, they sat one behind the other on ruddy jute mats. The two teachers taught while we

"OK," he said. "Let me talk to Faroog."

I handed the phone over and took in a changed scene. Perhaps a couple enterprising villagers had employed the mosque loudspeaker to announce our plight, because Waterhalis had gathered from far and wide. Young and old, big and small, pheran-wrapped and kangri- wielding, staring at my strange mug, fin-gering my gleaming, muddy machine and foisting up potential solutions. We've got to fix the bike, they told us; it can be very easily done. No, no, others disagreed, you'll never fix it; leave the bike here, hop a Sumo back to Srinagar and come get it later.110 That's no good, still others interrupted: walk the bike over to Budgam and they can fix it in a jiffy.

Manzoor, the school headmaster, recalled a fellow villager who owned a motorbike, and thought perhaps he could help. He scurried to retrieve him as Farooq and I endeavored to entertain the remaining audience. I made silly faces and pretended to attack the little boys. Learning that the teachers occasionally beat the youngsters, Farooq found a thin switch and

made to whip a little boy, to great hilarity. Manzoor soon returned and after ten minutes of tinkering the man. Ahmed, announced his diagnosis: our accelerator cable was broken and needed to be

fixed. Duly noted. A second plan formed: Farooq and I would walk the bike in a weaving northeasterly direction towards

tried to start the bike. Inexplicably, it roared to life. He grabbed the rubber- sheathed accelerator cable near his right thigh and employed it as a sort of jerry-rigged gas controller. He put the bike into gear and chugged wobbily up the hill. Seeing this, the man who had gone off to call his mechanic friend decided we were in no need of mechanical assistance. He stomped off to the fields to resume his work. I went up to Farooq and patted him on the back. "Hey, nice job," I told him.

"Yeah, yeah, but let me work on it," he said, sputtering off and tinkering with his new system.

Reverting to plan three, I rejoined Yusuf and Manzoor and we continued to stroll towards the neighbouring village, Harden, and the man with the pick-up truck. Minutes later we found Farooq in what passed as the village square, chatting with a young local.

"I fixed it," Farooq said, with obvious pride. "I've figured it out. We don't need the truck at all! Let's just ride to Budgam, we'll be fine.'

"Are you sure, Farooq?" I asked.

"Yes, this cable basically works just like the accelerator,' he explained, reaching down near his knee and tweaking a black rubber cord. "You try it."

"Are you sure?" I asked again, not wanting to start something we couldn't finish.

"Yes, I told you," he said, getting impatient with my suspicion. "Try it for yourself."

"No, no, you figured out how to do it," I said. "You can drive.

Yes, loyal reader, plan five: employ Farooq's halfbaked accelerator controller to matriculate over hill and vale to Budgam. We climbed on, shook hands with Manzoor and Yusuf and started off down a steep, serpentine decline. Progress was slow, but steady, and we began to feel our little ordeal had ended, that all would be fine. We came to the bottom and just over a muddy concrete bridge the road angled up and away into infinity

snapped photos and asked questions. After an hour or so our work was done and we headed towards my bike, and home. But I couldn't get the old girt started. And when Farooq tried he found that the accelerator cable, which should be attached to the right handlebar grip, had been severed. Oops.

"You've got to be more gentle, Dave," Farooq admonished. "You can't just – rgegh, gerhehr, rghea!! - attack everything like a wild animal.

"Yeah, I know, you're right," I admitted.

Then I grabbed my colleague by his puffy coat and shook him.

The sky filled with clouds as the clock ticked past two. My bike had become little more than a useless mass of heavy, rusting metal and worn rubber. I stared at her proud blue gas tank. I considered the wonderful times we had together. I considered pitching her into the stream.

Finally, I considered what Kashmir's most revered foreign observer, Sir Walter Lawrence, would do with such an excellent opportunity. Investigate the local flora and fauna? Query the villagers about their religious practices? Decipher the make-up of their pre-industrial economy? I decided I didn't care; I was cold and wanted to go home. Luckily, my phone had just enough juice to call our editor and apprise him of the situation.

"Hey, Sajjad, we found the school and got a really nice story," I told him.

"Oh, really," he responded, just slightly pleased. "Yes, but my bike broke down and now we're stuck." "Oh," he said, not surprised.

the main road, which would lead us to salvation.

"It's only four, five kilometers," said Yusuf, a 17-year-old who was studying in Budgam to become a doctor and was one of the few villagers who spoke English. "You can definitely make it, and then in Budgam they will fix bike."

The prospect of pushing a motorcycle five kilometers up and down winding valley roads in near-freezing and possibly drizzly conditions did not titillate. I wracked my brain for an alternative.

"Isn't there someone who has a truck around here?" I asked no one in particular. "There's got to be one truck, right? If not in this village, then somewhere near here...

Excited murmuring in Kashmiri rose. Index fingers pointed northwest among a general nodding of heads and just like that, praise Allah, plan number three solidified: push the bike the kilometer or so to the next village and find the man with the truck.

"Yes, I think it's best idea," said Manzoor, dropping the clincher.

Farooq and I began making our way, pushing the old lady through the muck and up the hill with much of our Waterhal entourage in tow. Thirty meters on we were stopped by an interested passer-by, an eagleeyed villager with a great red beard. Apprised of our plight he offered up strategy four in the Escape from Waterhal sweepstakes: he would call a nearby mechanic to come and fix the bike straight away! Off he went to retrieve his mobile phone.

Again we sat waiting, the sky darkening as the clock ticked three, children getting restless and finally wearying of staring at the shiny-headed, palefaced alien. Farooq had a sudden brainstorm and

As if in fear or awe, the bike halted at the base of the incline and the engine – eehrerhhr!!!!! – roared loudly, stuck on peak acceleration as the bike stood stock-still. I jumped off in fright and nearly fell down a small cliff. Time froze. The ear-splitting whine echoed across the ravine. Blue smoke shot out the exhaust. Vaguely visible through the haze as he tamed that neighing stallion with steely nerve, Farooq fingered gears and twitched his heels. I thought momentarily that this would be the last I'd see of my charming friend, bravely riding out the death throes of an overheating 1987 blue Yamaha. But it wasn't to be.

The engine fell silent. The smoke and dust settled. Farooq clambered off like a hero, exasperated yet relieved.

"Hey down there!" a disembodied voice called out from overhead. "Yeah!" the two of us shouted nearly in unison.

"Do you need the pick-up truck?" the voice asked. "Yes, we do," Farooq shot back.

We looked meaningfully at each other then caught our breath and took in our surroundings. A tiny trash strewn creak dribbled under the nearby bridge and on three and a half sides steep, aspen-pocked hills loomed. We were about half a kilometer from the surface world: no place to be broken down. Thankfully, a revised plan three was back in effect.

"Some friend you are," Farooq said. "You just left me to handle that thing all on my own!"

"You were driving!" I responded. "What could I do?" "I don't know, but don't leave me to die," he said, making a decent point.

There was a long pause. The creek gurgled. An over-flying kite peered down hungrily.

"I totally thought the bike was gonna blow up," I said, starting to smile. "And you were a goner."

He giggled. "I thought I was going to fly!"

Fly from that ravine we did when the pick-up pulled up some ten minutes later. A pleasant, mostly silent ride to Budgam followed, Farooq and I warming ourselves and thinking of butter chicken and a hot bath. The Budgam pit stop was beyond easy: drop bike at mechanic's, get tea and a snack, retrieve bike ten minutes later and we're on our way to Srinagar. There was just one problem: I left my helmet in the back of the pick-up.

"Look at it this way," said Farooq, wind whipping through his hair, "we owed them."


We arrived in Srinagar in 15 minutes. So our brush with oblivion in a relic of a previous century - a village without electricity, without any sewage system or running water, with roads of foot-deep mud and nearstarving children dressed in tattered clothing endeavoring to learn their multiplication tables in the bitter cold – took place only about 25 kilometers from Srinagar, a city of a million inhabitants, a place of Internet cafes and lush golf courses, cozy restaurants and swish hotels. Walk to Budgam? We could've walked home.

On the 34th anniversary of his passing today, we reproduce three of his Ghazals for the interest of our readers. It's being said that Imam Khomeini's poetry is a kind of play with the images and themes of Hafiz, the undisputed master of the ghazal.



The idea expressed in this poem is that even in the hiddenness of God, He is manifest to the true lover. The very hiddenness itself becomes a mode of manifestation. The pain which is described in the first eight lines is the pain of the lover, the longing for union with the divine. The cruelty is the experience of this longing caused by the

need for union. The word translated as 'cruelty' here, jafa', indicates the kind of torment a mistress may inflict upon her lover, as by withholding her favors. The lover wants this cruelty, because he wants to feel the union with the divine. He wants no other fulfillment of any promise by God except that he should be so favored as to feel the need for union with Him. Safa and Marwa are the two hills between which pilgrims must run back and forth during the Hajj ceremony, to commemorate the searching of Hajar, the wife of Abraham, for water herself and for the son Isma'il. Lines (15) and (16) recall the ayah of the Qur'an: "Withersoever you turn, there is the face of Allah" (2:115).

NEW DELHI: Automakers, led by Maruti Suzuki India, Hyundai, Mahindra & Mahindra, Toyota Kirloskar Motor, on Thursday, reported robust wholesales of passenger vehicles in the domestic market in May riding on strong demand for SUVs.

The company's sales of mini cars, comprising Alto and S-Presso, fell 30 per cent to 12,236 units as compared with 17,408 units in the year-ago period, while compact cars sales, including models such as Swift, Celerio, Ignis, Baleno and Dzire, increased 5 per cent to 71,419 units as against 67,947 units in May 2022.

NEW DELHI: Crisis-hit Go First Airlines on Friday informed that its scheduled flight operations will remain cancelled till June 7, adding that a full refund will be issued to the passengers.

"We regret to inform you that due to operational reasons, Go First flights scheduled till June 7, 2023, have been cancelled. We apologise for the inconvenience caused by the flight cancellations. A full refund will be issued to the original mode of payment shortly. We acknowledge the flight cancellations might have disrupted your travel plans and we are committed to providing all the assistance we can," the official statement said.

The airline operator had recently filed for voluntary insolvency.

Earlier Directorate General of

Civil Aviation (DGCA) advised Go First Airlines to submit a comprehensive restructuring plan for a sustainable revival of operations.

A senior DGCA official earlier said that Go First has submitted their response to a show cause notice, issued on May 8, wherein they have requested that they may be allowed to use the moratorium period to prepare a comprehensive restructuring plan for restarting operations and present the same to DGCA for the requisite regulatory approvals before restarting operations. Accordingly, DGCA had advised the airline to submit a

comprehensive restructuring/ revival plan for a sustainable revival of operations, within a period of 30 days. The revival plan once submitted by Go First shall be reviewed by DGCA for further appropriate action in the matter.

### **Unpredictable Weather**,

leaving Kashmir's apple growers perennially unprepared to tackle the resulting damage.

Is climate change playing a role in Kashmir's agricultural challenges?

"It is the month of June, but the weather feels like winter," almost everyone can be heard saying the same in Kashmir. But what could be causing such an unusual weather pattern, with temperatures much lower than expected for this time of the year? Experts have indicated that climate change can result in unpredictable weather, including unseasonal rain. "Climate change doesn't necessarily only mean a rise in temperatures, it refers to any disruption in normal weather. Early snowfall, warmer winters and the prolonged rain with erratic weather events that Kashmir is currently witnessing can all be linked to climate change," Dr. Irfan Rashid, senior Assistant Professor, Department of Geo informatics, University of Kashmir, told Kashmir Observer. "Most of the rainfall in Kashmir comes from western disturbances and the pattern of these disturbances has also changed over the past years," he added.

According to the data shared by Independent Weather Forecaster, Faizan Arif Keng, Jammu and Kashmir recorded 96.3 mm rainfall in the month of May, a surplus rainfall of 24% as against the normal precipitation of 77.5 mm. In April, the region experienced 113.5 mm of rainfall, marking a 14% surplus compared to the average rainfall of 99.6mm. The rainfall of last month in J&K is higher than the similar months of previous two years.

Studies suggest that climate change is expected to worsen the frequency, intensity, and impacts of some types of extreme weather events. "The Intergovernmental Panel on Climate Change (IPCC) Special Report on the Ocean and Cryosphere in a Changing Climate also speculated that the indicators of erratic weather patterns will accentuate and amplify by the end of

this century over Himalayan and other regions of the world," Dr. Irfan said.

"If the irregular weather patterns persist, it will certainly have negative consequences on the horticulture sector of Kashmir."

Hailstorms can be challenging to predict


Most of the weeks in the month of April and May were forecasted to be particularly cloudy with intermittent rains and strong wind, which also made the conditions conducive for hailstorms. Advisories to postpone spray of orchards on particular days were made through different mediums, however, the potential for hailstorms, the exact timing, location, and intensity of hailstorms can still be difficult to determine with precision, meteorologists suggest. "It is nearly impossible to predict a

hailstorm and pinpoint where exactly a hail will strike," Deputy Director, Meteorological Department, Jammu and Kashmir, Dr. Mukhtar Ahmad said. "Jet stream positioning, western disturbances and ground heating are important factors to consider when predicting hails. Hailstorms cannot be predicted with certainty in every rainfall event," the weather forecaster added.

Why do excessive rains and hails cost so much?

Dr. Tariq Rasool, Senior Scientist and Assistant Professor of Plant Pathology at Sher-e-Kashmir University of Agricultural Sciences and Technology of Kashmir (SKUAST-K), while highlighting the vulnerabilities of the horticulture sector said that hailstorms cause injuries to the fruit, that even when treated can leave blemishes, ultimately leading to a devaluation of the crop. "Temperature dipping can impact the fruit set process by reducing pollination rates. The reduction in the number of sunny days can affect the overall development of the fruit," Dr. Tariq said.

Despite one's best efforts, "it is nearly impossible to adequately prepare for the unpredictable and frequently devastating effects of anomalous climate behavior," Bashir Ahmad Basheer,

President of Kashmir Fruit Association, said. Hailstorms strike suddenly and leave a trial of devastation in their wake, nevertheless, "preventing the further spread of diseases by spraying the necessary fungicide or pesticides after storms should be the first step towards mitigating the impact of erratic weather events," he said.

Is netting a possible solution?

The installation of protective hail netting is one effective way that countries like Germany and China – the major producer of apples in the world – and many growers in India's Himachal take up to prevent the loss of crops due to hail. The nets are usually made up from a sturdy, hail-resistant material such as high-density polyethylene (HDPE), nylon or polyester. The demand for these nets is picking up in Kashmir as well but "Nearly 95% of orchardists in Kashmir valley are marginal growers with small land holdings and netting is a costly affair for them," Bashir Ahmad opined.

"Fruit growers of Kashmir are incurring losses for the last many years due to back to back lockdowns, highway hassles and inclement weather. The rates of agrochemicals have escalated, and with no expectation of generating profits or returns, the growers fear that they won't be able to cope with the added financial burden," he said.

Over 78% of India's annual apple production comes from Jammu and Kashmir, making it a crucial source of livelihood for over 3.5 million people. Of the total 3.31 lakh hectares of land used for fruit cultivation in the region, about half, around 1.67 lakh hectares, is used for growing apples. Kashmir's economy, majorly dependent on agriculture. has experienced a significant setback in recent years. Many have shifted to high density Italian species to enhance apple production and for greater economic returns on their yield. However, the vast majority of apple farms continue to cultivate the traditional variety of the fruit and "netting is not a viable option for traditional orchards,' Dr. Tariq said, "Anti-hail nets are more

commonly installed in newer, high-density orchards that use more advanced cultivation techniques. In contrast, traditional orchards tend to have a different structure and layout, which may not be suitable for anti-hail net installation." He also reiterated that not every grower can afford a hail net, as the initial establishment cost of high density orchard is very expensive.

Other than the nets, the Himachal Pradesh government will be testing the use of indigenously developed 'anti-hail guns.' To help out horticulturists who face crop damage due to hailstorms, an anti-hail gun generates shock waves to disrupt the growth of hailstones in clouds, according to its makers. These shock waves supposedly stop water droplets in clouds from turning into hailstones, so that they fall simply as raindrops. However, there is a working on this and will soon start offering real-time weather-based agricultural advice to the farmers," Dr. Tariq said.

No crop insurance

Despite an official announcement that the Pradhan Mantri Fasal Bima Yojana (PMFBY)/crop insurance scheme has been approved for all the districts of J&K in February this year, it has not been implemented yet. The scheme is, however, successfully running in parts of Jammu region. "Insuring their crops would help the farmers mitigate the financial risks of weather related losses and receive compensation for the damage," Nisar Ahmad, an orchardist said.

Dr. Tariq also said that with crop insurance in place, growers can take risks and adapt innovative techniques and technologies. "It will significantly enhance the resilience of farmers against climate change-driven events," he said.

"The machines and raw material have been airlifted through helicopters and the work is going on at a rapid pace," he said, adding that the work is expected to be completed by June 15.

Shocked survivors recalled their brush with death, while families in several states including West Bengal, Tamil Nadu and Odisha underwent a painful wait to know the fate of their loved ones.

"The train was running at a high speed. Around 7 pm, a loud sound was heard and it was chaos after that. I fell down on the floor from the upper berth. It was ghastly, many people with grave injuries were lying around," Mizan UI Haq, a resident of Bardhaman who was in a coach at the rear of the Howrah Superfast Express train, said.

Another Bardhaman resident, a carpenter who works in Bengaluru, said he was injured in the chest, feet and head when the coach in which he was travelling turned turtle.

"We had to break open the windows and jump out of the compartment to save ourselves," he said, adding he saw many dead bodies after the accident.

The unreserved compartments were packed, carrying mostly migrant workers to Tamil Nadu or Kerala, according to survivors.

Nityam Ray, a resident of Bhomrail village in West Bengal's Malda district, was also killed in the accident. He was travelling on the Coromandel Express, his family said.

Ray, 30, called his wife on phone moments after he boarded the train from the Shalimar station in Howrah district. "That was the last time I spoke to him," she said. The Balasore district hospital and Soro hospital looked like a war zone as the injured were rushed in.

More than 2,000 people gathered at the Balasore Medical College and Hospital at night to help the injured and many of them donated blood, officials said.

Mechanised spraying can trim down the expenses

Accentuating the need of newer technologies as a measure to deal with the changing weather patterns. Dr. Tariq said, "Farmers in Kashmir spray their fields manually which is a very labour consuming process and has low efficacy. This process could be mechanised by introduction of advanced technology like power tractors that save a lot of time, reduce the amount of pesticides/ agrochemicals by approximately 30% and increase fruit

quality and profitability." Wet weather triggers diseases like scab and it also hinders spraying schedules. It is very challenging to manage these infections in regular rains using the prevailing spraying technology, "so mechanisation is a good risk management strategy that can also help make farming sustainable."

Weather based strategy When the climate is changing, the strategies too should. Relying solely on the traditional approaches to crop management may no longer be sufficient. 'Weather based decision support system for crop risk management' is what the experts suggest as another measure to reduce the input loss. It is a technology that aids farmers in making weather-based agricultural decisions through SMS, mobile apps, and information kiosks. "We at SKUAST are keen at developing Artificial Intelligence (AI) driven system which would provide location specific and custom advisory for farmers. We are

Seventeen coaches were derailed and severely damaged in the accident, trapping hundreds of passengers. Both passenger trains were at a high speed and it has been cited by experts as one of the main reasons for the high number of casualty.

From a vantage point high above the ground, the disaster site looked as if a powerful whirlwind had thrown the coaches like toys on top of each other. Closer to the ground, bloodied, disfigured bodies and dismembered body parts lay enmeshed, creating a grotesque sight.

Large cranes were deployed to move the wreckage and gas cutters were used to extricate the bodies from the mangled, toppled coaches.

The rescue operation was wrapped up Saturday afternoon and restoration work started. The injured were admitted to four hospitals.

Preliminary investigations have revealed that a signal was given to Coromandel Express to enter the main line but it was taken off and the train entered the loop line, where it crashed into a goods train parked there.

The Bengaluru-Howrah Superfast Express which was coming at high speed crashed into the coaches of Coromandel Express that had scattered The highway traffic officials cited one-way traffic restrictions at its various points, movement of nomads, and ongoing construction projects as the causes of congestion.

Hundred-foot caravans of cattle being ferried by the tribals on the highway are the biggest cause of the traffic jams, they said.

They further explained that the entire stretch in the Ramban and Banihal sector is prone to landslides, which cause disruptions on National Highway 44 with every rainfall.

Efforts are underway to complete the three km-long Banihal town bypass and one km-long Ramban town bypass by this year, they said.

These developments are expected to alleviate some of the traffic congestion issues, officials added.

# **Tendulkar Reveals Playing With Painful Toe Injury In 2011-12**

MUMBAI: Cricket legend Sachin Tendulkar has revealed he had to manage the recurrence of a painful, decade-old toe injury during India's tour of Australia in 2011-12 which caused him a lot of trouble.

Tendulkar had suffered a toe injury in the year 2000 and the same had resurfaced in the next year, which had kept him out of action for a tri-series in Sri Lanka with New Zealand being the third side. The batting legend recalled how the same affected him badly in the second half of India's tour of Australia in 2011-12, a series which the visiting side lost 0-4 to cede the Border-Gavaskar Trophy to the home side.

Having won the 50-over World Cup in April, it was the same period in which the Indian Test side had gone through one of its worst phases, having lost 0-4 in England earlier the same year.

"In the year 2000, I had a toe injury in South Africa following which I took injections as well. The same injury resurfaced after the 2011 World Cup. I don't even know; I did not do anything which would have put strain on it.

"In fact, I was in London for leave and I was going to join the (Indian) team there," Tendulkar told a large gathering of audience here on Friday evening during an event to launch a book titled 'Scintillating Sachin', and titled 'Shatkant kach' in Marathi.

Tendulkar, speaking in Marathi, informed that he was in so much pain and frustration that he found it very difficult to manage, and the local doctors suggested that he undergoes surgery.

"(In Australia) it was very painful and unbearable. I had used bandages, changed my insoles twice, and was just managing to play somehow. Most of the tour was over but my



frustration was only increasing. "The Australian grounds are hard, which was making it even more difficult. The doctor suggested getting a surgery done," he said.

Tendulkar said his wife Anjali flew down from India to Australia in a matter of 48 hours and helped take the right call.

"I had to run, so my pain increased too much and I consulted a doctor in Australia. He suggested that I need to do a surgery, and even my other leg was hurting. So I shared this with Anjali, I told her that I can't take this pain anymore and that 'I have had enough' and I will do surgery," he said.

"I said 'I am informing the team that I cannot play, I am in pain and it is difficult', after hearing this, Anjali came to Brisbane literally in 48 hours only to stop me, to not have this surgery," said Tendulkar, adding that doctors said if the surgery was unsuccessful, it would have impacted his career, leaving him on wheelchair for at least six weeks.

Even Tendulkar's doctor, Dr Anant Joshi, who was also present on Friday evening, said such an injury affected ballet dancers. Former India cricketers Kiran More, Zaheer Khan, Pravin Amre and former coach Aunshuman Gaekwad also spoke at length about their memories with Tendulkar at the launch.

Tendulkar also recalled one of his most memorable centuries – an epic 613-minute 241 from 436 balls against Australia at Sydney during the 2003-04 tour - in which he did notplay a single cover drive, which

is considered one of his trademark shots.

He said that a conversation with his brother Ajit Tendulkar, who helped shape Tendulkar's career at the beginning and remained a pillar throughout, helped him overcome a string of ordinary scores and pile up a massive total at Sydney. Tendulkar said, "I was batting well in Australia, but was not scoring big runs. So, I had a conversation with Ajit before the Syd-ney Test. He had observed my batting and said: 'There was not any technical fault in your batting. But the flaw is in your shot selection'. He said I need to be more disciplined while playing shots."

"One more thing he said: 'I don't think a bowler is getting you out. You played the wrong shot and that's why you got out. So take the challenge that no one would get you out in this Test'. I accepted that challenge. "Fortunately, I scored in both innings and remained

unbeaten throughout the Test. So he was instrumental in finding solutions and I am sitting in front of you just because of him.

The batting legend said some of the methods that Ajit asked him to follow were ingrained in his subconscious forever.

"I actually learnt how to do pre-match preparation when was in school, because since then only Ajit made sure that prepared better for the next day's match. He used to tell me that 'match would not start at 9.30 am next day; you started thinking about it on the eve of the game'. Since then I got into the habit of ironing my own clothes," he said.

"I still remember when I was playing my 200th Test and I was ironing my whites on the eve of that Test. The reason for doing that is when I was seeing my whites while ironing, my subconscious mind started preparing for the game," Tendulkar added.

### **Centre Bans 14 Fixed Dose Combination Drugs, Cites They** May Involve Risk To People



New Delhi: The government has banned 14 fixed dose combination drugs including Nimesulide and Paracetamol dispersible tablets and Chlopheniramine Maleate and Codeine syrup citing there is "no therapeutic justification" for these medicines and that they may involve "risk" to people.

The Union Health Ministry issued a notification on Friday in this regard.

The banned drugs included those used for treating common infections, cough and fever -- combinations such as Nimesulide + Paracetamol dispersible tablets, Chlopheniramine Maleate + Codeine Syrup, Pholcodine +Promethazine, Amoxicillin + Bromhexine and Bromhexine + Dextromethorphan + Am-monium Chloride + Menthol, Paracetamol + Bromhexine+ Phenylephrine + Chlorpheniramine + Guaiphenesin and Salbutamol + Bromhexine.

The move comes following recommendations by an expert committee. The expert committee said that there is "no therapeutic justification for this FDC (fixed dose combination) and the FDC may involve risk to human beings. Hence, in the larger public interest, it is necessary to

prohibit the manufacture, sale or distribution of this FDC under section 26 A of the Drugs and Cosmetics Act, 1940. In view of the above, any kind of regulation or restriction to allow for any use in patients is not justifiable." "And whereas, on the basis of the recommendations of the Expert Committee and the Drugs Technical Advisory Board, the Central Government is satisfied that it is necessary and expedient in public interest to regulate by way of prohibition the manufacture for sale,

sale and distribution for human use of the said drug in the country," the notification stated. FDC drugs are those which contain a combination of two or more active pharmaceutical ingredients (APIs) in a fixed ratio. In 2016, the government had announced the ban on the manufacture, sale and distribution of 344 drug combinations after an expert panel, set up at the behest of the Supreme Court had stated they were being sold to patients without scientific data and the order was challenged by the manufacturers in court. The currently banned 14 FDCs are part of those 344 drug combina-

# **Blood Test To Detect 50** Types Of Cancer Hailed As 'Revolutionary'

blood test that can de-Atect more than 50 differ-ent types of cancer could speed up diagnosis, a study suggests.

The Galleri test was able to detect signs of cancer in 323 out of the 6,238 people who had visited their GP with suspected symptoms, in England or Wales, the study showed.

Of those 323 patients, 244 were subsequently diagnosed with cancer, giving a positive predictive accuracy of 75 per cent, the researchers said. The findings could mean the

blood test has the potential to spot and rule out cancer in people with symptoms, speeding up diagnosis. In 85 per cent of those posi-

tive cases, the test was able to pinpoint the original site of the cancer.

The test, which is being trialled by researchers at the University of Oxford, detects fragments of tumour DNA in the bloodstream.

Some cancer tumours are known to shed DNA into the blood a long time before a person would start experiencing symptoms. The test predicted 37 per cent

of bowel cancer cases, 22 per cent of lung cancer cases, and eight per cent of uterine cancer cases, as well as six per cent of oesophago-gastric cases, and four per cent



of ovarian cancer cases.

However, the accuracy of the test varied depending on the stage of the cancer. The Galleri test was able to accurately predict 95 per cent of advancedstage tumours, while it was only able to predict 24 per cent of very early-stage cancers.

The test does not detect all cancers and does not replace NHS screening programmes, such as those for breast, cervical and bowel cancer.

Researchers said the test is a "work in progress", but the NHS trial is showing "real promise".

Developed by Californian company Grail, the test is also being trialled in the NHS to see if it can detect hidden cancers in people without symptoms, with results expected later this year.

NHS national director for cancer Prof Peter Johnson said: "This study is the first step in testing a new way to identify cancer as quickly as possible, being pioneered by the NHS - earlier de-

tection of cancer is vital and this test could help us to catch more cancers at an earlier stage and help save thousands of lives."

Brian Nicholson, associate professor at the Nuffield Department of Primary Care Health Sciences, University of Oxford, said the findings suggest that multi-cancer early detection tests (MCEDs) can play a role "to confirm that symptomatic patients should be evaluated for cancer before pursuing other diagnoses".

He said: "Most patients diagnosed with cancer first see a primary care physician for the investigation of symptoms suggestive of cancer, like weight loss, anaemia, or abdominal pain, which can be complex as there are multiple potential causes.

"New tools that can both expedite cancer diagnosis and potentially avoid invasive and costly investigations are needed to more accurately triage patients who present with non-specific cancer symptoms."

Professor Helen McShane, director of the NIHR Oxford Biomedical Research Centre, said: "We are committed to diagnosing cancers earlier, when they can be cured, and this study is an important step on that journey."

The findings from the trial were presented at the American Society of Clinical Oncology conference, in Chicago, and published in The Lancet Oncology iournal.

## **Stop Giving Coverage To** Ex-PM Imran Khan, Pakistan **Govt Tells Media Houses**

LAHORE: The Pakistan government on Friday urged the country's media houses to refrain from publishing or broadcasting speeches, statements, tweets or pictures of former prime minister Imran Khan.

The government said it was making sure that the 70-year-old Pakistan Tehreek-e-Insaf (PTI) chief's social media activities are also blocked.

According to a government official, both print and electronic media have been directed not to publish or broadcast Khan's speeches, statements, tweets or display his pictures.

""We will make sure that media blackout of Imran Khan is completely enforced,"" the official said. An informed source told PTI that the Pakistani media houses have been categorically told by the 'powerful circles' to give no

coverage to Khan. He said Khan's media blackout

was enforced from Friday. The government order comes

a day after the Pakistan Electronic Media Regulatory Authority (PEMRA) directed all satellite TV channels not to promote the perpetrators of the May 9 violence. It also directed them to ensure that coherence and national har-

mony are promoted and "hate mongers, rioters, their facilitators and perpetrators" are completely blacked out from the media. Without naming Khan, PEM-

RA said: "Refrain from providing

airtime to those who propagate hate speech and provoke public sentiments against the federation and state institutions".

It said the hate mongers, representing political outfits, are abusing their power against Pakistan and state institutions by instigating the public.

"All such anti-state activities were orchestrated by the politically charged-up zealots of a political party behaving largely as hate mongers to instigate political activists," it said.

There has been a crackdown on the PTI leaders and workers after their alleged involvement in attacking army installations in the country following the arrest of Khan.

Violence erupted across Pakistan on May 9 when cricketerturned-politician Khan was arrested from the premises of the Islamabad High Court in a corruption case.

Khan was released on bail two days later.

Over 20 military installations and government buildings including military headquarters in Rawalpindi were damaged in the unrest that ensued.

Over 100 vehicles of police and other security agencies were also set on fire in the violence that left more than 10 persons dead.

Khan has said over 25 PTI workers were killed in the violence and that law enforcement agencies arrested over 10,000 PTI workers across Pakistan.

As many as 4,000 of them are from Punjab.
