Airlines Told To Devise Pricing Mechanism

New Delhi: The government on Monday asked airlines to devise a mechanism to ensure reasonable airfares amid a surge in air ticket prices, particularly on certain routes that were earlier served by Go First.

In the case of the unfortunate Odisha tragedy, airlines have been advised to provide free carriage (cargo) services to the families of the deceased, the civil aviation ministry said.

During an hour-long meeting of the airlines advisory group, Civil Aviation Minister Jyotiraditya Scindia shared his concerns about the steep rise in airfares on certain routes.

Airlines have been asked to self-monitor airfares on routes that have seen a considerable rise in ticket prices, particularly those that were served by Go First earlier.

Go First stopped flying from May 3 and the reduction of capacity due to the crisis at the budget airline has come at a time when the peak domestic air travel period is round the corner. A mechanism should be devised by airlines to ensure reasonable pricing within the high RBDs (Reservation Booking Designator) and the same would be monitored by the Directorate

KU Figures at 33rd Rank in **NIRF Rankings**

Srinagar: Among top 100 universities of India, the University of Kashmir (KU) has figured at 33rd rank in National Institutional Ranking Framework (NIRF) 2023.

In the top 100 overall educational institutes of India, KU has secured 58th rank, a result of which was released by the Union Ministry of Education on Monday.

According to Kashmir News Observer, among the top 100 in engineering, Indian Institute of Technology Jammu has secured 67th rank and National Institute of Technology Srinagar has figured at 82nd rank.

Similarly, among the top 100 in management, Indian Institute of Management Jammu (IIMJ) have secured 41st rank.

Likewise, among the top 30 in Architecture and Planning, Shri Mata Vaishno Devi University Katra have secured 26th rank and among the top 40 in Agriculture and Allied Sectors, Sher-e-Kashmir University of Agricultural Science and Technology of Kashmir Srinagar have figured at 9th rank.

Ironically, among the top 100 in colleges and medical colleges or institutes from India, no college from Jammu and Kashmir

have figured in the list.
The NIRF-2023 results further state that among the top 50 in Research Institutions, no research institution from Jammu and Kashmir was in the list.

Similarly, no pharmaceutical institutions, dental college, law college or department from Jammu and Kashmir have figured in the list.

Pertinently, KU has jumped up by 20 notches in the 2023 NIRFs ranking in comparison to previous year's ranking. In 2022, KU will be ranked at 53rd rank.



Employer Can't 'Arbitrarily' Abandon Selection Process At Any Time: HC

Srinagar: While an employer has a right to abandon the selection process at any time, the same cannot be done arbitrarily or at its sweet will, the High Court of J&K and Ladakh said on Monday.

"The fundamental questions that arise for consideration in the instant petition is as to what are the rights of a candidate, who competes in a selection process and can an employer, who, admittedly, is a "State" within the meaning of Article 12 of the Constitution selectively



make appointments regardless of the merit determined in a selection process," said a bench of Justice Javed Iqbal Wani while allowing a petition filed by candidate who had challenged his

non-selection as driver in J&K State Sports Council in 2014 despite being meritorious. One of the two candidates selected then, the petitioner—Ravider Singh— through official documents revealed, was also ineligible being overage on the cut-off date provided in the advertisement notice.

'There can be no dispute on the proposition of law that mere selection does not confer any right of appointment and that an employer has a right to abandon the selection process at any time, but the question would be, can it be done arbitrarily without any reasonable and just cause on the sweet will of the employer and can an employer be permitted to resort to pick and choose method while making appointment from a selection list by appointing a less meritorious candidate and leave more meritorious candidate?"

The answer, the court said, has to be emphatic "no not at all" because "ours is a country governed by rule of law and arbitrariness is an anathema to the rule of law."

Iran to Reopen Diplomatic Missions in Saudi Arabia This Week



"The Islamic Republic of Iran's embassy in Riyadh, consulate general in Jeddah and Iran's permanent representative to the Organization of Islamic Cooperation (OIC) will be officially reopened on Tuesday and Wednesday," Nasser Kan'ani said on Monday.

Kan'ani said Iran's embassy in Riyadh and its consulate general in Jeddah have started activities before the departure of Iranians to attend the annual Hajj pilgrimage.

Following several days of intensive negotiations in Beijing, Iran and Saudi Arabia agreed on March 10 to resume diplomatic ties and reopen embassies within two months. In a joint statement after signing the agreement, Tehran and Riyadh highlighted the need to respect national sovereignty and refrain from interference the internal affairs of one another.

They also agreed to implement a security cooperation agreement signed in April 2001 and another accord reached in

May 1998 to boost economic,

commercial, investment, tech-

nical, scientific, cultural, sports, and youth affairs cooperation. Last month, Iran appointed Alireza Enayati as its ambassador to Saudi Arabia.

Enayati had previously served as Iran's ambassador to Kuwait, assistant to the foreign minister and director-general of Persian Gulf affairs at the Foreign Ministry.

In a Friday meeting with his Iranian counterpart Hossein Amir-Abdollahian on the sidelines of a meeting of the BRICS group of emerging countries, Saudi Foreign Minister Prince Faisal bin Farhan Al Saud said he would pay an official visit to Tehran in the near future.

He extended his gratitude to the Iranian side for warmly welcoming the Saudi technical delegation and providing valuable assistance as to the reopening of the Saudi embassy and consulate general in Iran.

"Made It Very Clear": Nitish **Kumar Delays Mega Opposition Meet, Names Congress**

PATNA: Bihar Chief Minister Nitish Kumar today said that he was insistent upon "heads" of respective parties attending the opposition meet, which was scheduled on June 12, but has been postponed.

with other parties. "But I have made one thing very clear. All parties which agree to attend the meeting, must be represented by their respective heads," Mr Kumar

If any party insisted that it be represented by someone else, that would not be acceptable, he said.

"For example, there was an impression that the Congress may send someone else other than its president. This was something we could not accept", added Mr Kumar, who has, since his exit from the NDA last year, embarked on a drive to bring together all parties op-



posed to the BJP ahead of the Lok Sabha polls next year.

Last week, state Congress president Akhilesh Prasad Singh had said that his party was planning to send "one chief minister and another senior leader" for the meeting.

This had evoked taunts from the BJP, now in opposition in Bihar, which claimed neither Rahul Gandhi, who is abroad, Mallikariun Kharge, the Congress president, was assigning much importance to the initiative of Nitish Kumar, despite being his ally in the state. The idea of a meeting of opposition parties in Patna was first mooted by West Bengal Chief Minister Mamata Banerjee at a press conference she addressed jointly with Mr Kumar in April.

Accompanied by his deputy Teiashwi Yaday Nitish Kumar had visited Kolkata to meet the TMC chief who exhorted him to carry forward the legacy of Jayaprakash Narayan, referring to the socialist leader's revolt against the Indira Gandhi government before and during the Emergency.

US Defence Secretary Meets Rajnath Singh

Putting 'Full Weight' Behind India's Defence Modernisation: US

NEW DELHI: India and the US have a unique role in preserving the rules-based global order, US Defence Secretary Lloyd Austin said on Monday while citing "bullying and coercion" by China and Russian aggression against Ukraine.

After holding wide-ranging talks with Defence Minister Rajnath Singh here, Austin said that the US government is putting its "full weight" behind supporting India's defence modernisation.

Describing the US-India relationship as one of the most "consequential" ones, Austin said the partnership is a "cornerstone" for a free and open Indo-Pacific and that the growing military cooperation between the two "great powers" can be a force for global good.

The US is "absolutely committed" to "our historic investment" in ensuing technology cooperation with India, the US defence secretary said at a media briefing.

In their talks, Austin and Singh concluded an ambitious roadmap for defence-industrial cooperation to fast-track technology tie-ups and coproduction of military platforms such as air combat and land systems.

"I can tell you that the US government is putting our full weight behind supporting India's defence modernisation. I look forward to continuing to work with Minister Singh going forward," Austin said.

In his comments to the media, the US defence secretary spoke about various dimensions of the growing defence

and strategic cooperation between India and the US and its significance in the current geo-political scenario.

This all matters because we all face a rapidly changing world. We see bullying and coercion from the People's Republic of China and Russian aggression against Ukraine that seeks to redraw borders by force and threatens national sovereignty, as well as transnational threats such as terrorism and climate change," he said.

His remarks come amid rising tension in the Taiwan Strait where a Chinese naval ship cut sharply across the path of an American destroyer on Saturday, forcing the US vessel to slow to avoid a collision.

The US defence secretary also rejected China's allegations that the US was trying to establish an Asian NATO in the Indo-Pacific.

"We are absolutely not trying to establish a NATO (North Atlantic Treaty Organisation) in the Indo-Pacific. We continue to work with like-minded countries to ensure that the region remains free and open," he said.

China has been very critical about the Quad comprising India, the US, Japan and Australia and calls the coalition

Trains 'Slowly' Cross Odisha Crash Site Days After Disaster

As the Vande Bharat Express crossed the site of the triple train crash at Bahanaga Bazar Monday morning successfully, the first train to cross the disaster site during day hours, passengers on board gasped as the horror of the devastation unleashed by the train pile up last Friday unfolded before their eyes.

As the train which started from Howrah slowed down as a mark of caution running across freshly repaired tracks, a few muttered Jagannath, Jagannath, the name of the presiding deity of Puri, the destination of the train, but most were too stunned to speak.

The railway authorities had on Sunday informed passengers through a group



SMS that the train would leave on time.

The train left on time from Howrah station at 6.10 am but no one was sure of the route it would take as news on the state of the tracks which had broken up because of the accident which claimed 275 lives was unknown.

Passengers were heard discussing the route it might take, especially as the display board in the compartment showed it was travelling at a speed of over

110 km per hour.

The majority of the passengers were bound for Puri, the sea side pilgrim town and a favourite go-todestination for tourists in eastern India.

However, after the train reached Kharagpur the announcements that the next station would be Baleswar made the passengers rush to the large windows of the train, ready with their mobile phones.

The train speed was still between 110 km and 122 km.



80 Afghan Girls Hospitalised After Being Poisoned At **Schools: Report**

KABUL: An education official in Afghanistan said almost 80 girls were hospitalised after being poisoned at schools, Fox News said.

According to reports, the incidents happened over Saturday and Sunday in the province of Sar-e-Pul in the north.

Mohammad Rahmani, the director of the provincial department of education, said the poisoning had occurred in the Sangcharak district among female pupils in grades 1 through 6.

He said that 60 children at Naswan-e-Kabod Aab School and 17 more at Naswan-e-Faizabad School had been poisoned, Fox News reported.

"Both primary schools are near to each other and were targeted one after the other," he said, adding, "We shifted the students to the hospital and now they are all fine."

The department's investigation is ongoing and initial inquiries show that someone with a grudge paid a third

party to carry out the attacks, Rahmani said, without sharing further details. He gave no information on how the girls were poisoned or the nature of their injuries, according to Fox

It is thought to be the first time this kind of assault has happened since the Taliban swept to power in August 2021 and began their crackdown on the rights and freedoms of Afghan women and girls.

Girls are banned from education beyond sixth grade, including university, and women are barred from most jobs and public spaces Fox News reported.

The attack serves as a reminder of a wave of poisonings in neighbouring Iran targeting school-age girls, dating back to November. Thousands of students said they were sickened by noxious fumes in the incidents. But there has been no word on who might be behind the incidents or what -- if any, chemicals have been used, Fox

Fighter Jets Chase Small Plane In Washington Area Before It Crashes In Virginia

WASHINGTON: The United States scrambled F-16 fighter jets in a supersonic chase of a light aircraft with an unresponsive pilot that violated airspace around Washington DC and later crashed into the mountains of Virginia, officials said.

No survivors were found at the crash site, Virginia state police

The jet fighters created a sonic boom over the US capital as they pursued the errant Cessna Citation, officials said, causing consterna tion among people Washing-

ton area. onboard the Cessna, a source familiar with the matter said. A Cessna Citation can carry seven to 12 passengers.

After several hours first responders reached the crash site but found no one alive, the Virginia State Police said in a statement.

The Cessna was registered to Encore Motors of Melbourne, Florida, according to the flighttracking website Flight Aware. Encore owner John Rumpel

told the Washington Post his daughter, a grandchild and her nanny were on board. "We know nothing about the

crash," the Post quoted Rumpel

as saying. "We are talking to the FAA now," he added before ending the call.

The U.S. military attempted to contact the pilot, who was unresponsive, until the Cessna crashed near the George Washington National Forest in Virginia, North American Aerospace Defense Command (NORAD) said in a statement.

The Cessna appeared to be flying on autopilot, another source familiar the matter

> said. "The NORAD aircraft were authorized to travel at supersonic speeds boom may have heard by residents of the re-

gion," the statement said, adding that NORAD aircraft also used flares in an attempt to the pilot's attention.

A US official said the fighters did not cause the crash.

The Cessna took off from Elizabethton Municipal Airport in Elizabethton, Tennessee, and was bound for Long Island MacArthur Airport in New York, about 50 miles (80 km) east of Manhattan, the FAA said in a statement, adding that it and the National Transportation Safety Board would investigate.

PATAN: A group of people allegedly assaulted a Dalit man and chopped off his thumb after his nephew picked up a cricket ball during a match at a school playground in Gujarat's Patan district, police said.

The incident took place in Kakoshi village in the district on Sunday, an official

According to the FIR, the accused got angry and threatened the boy who had picked up the ball while watching a cricket match at a school playground in the village, he said.

They also allegedly hurled casteist slurs with the intention to insult and intimidate members of the Dalit community, the official said.

When the boy's uncle Dhiraj Parmar objected to this, the matter was settled for the time being, he said.

However, later that evening, a group of seven men armed with sharp weapons assaulted the complainant Dhiraj and his brother Kirti, the official said.

One of the accused chopped off Kirti's thumb and injured him seriously, he said

An FIR has been registered under sections 326 (voluntarily causing grievous hurt by dangerous weapons), 506 (criminal intimidation) and other relevant provisions of the Indian Penal Code and the SC and ST (Prevention of Atrocities Act), the official said.

Efforts are on to apprehend the accused, he added.

Gangster-Politician Mukhtar Ansari Gets Life Term For 1991 Murder

A court in Varanasi on Monday sentenced gangster-politician Mukhtar Ansari to life imprisonment for the murder of Awadhesh Rai, the brother of a Congress leader, more than 30 years ago.

Awadhesh Rai, the brother of former MLA Ajay Rai, was shot dead on August 3, 1991, at the gate of his Lahurabir residence in Varanasi. A case was registered against Mukhtar Ansari and others.

The MP-MLA court's special judge Avanish Gautam awarded life sentence to Ansari in the case, a lawyer told reporters outside the Varanasi court. Reacting to Ansari's conviction earlier in

the day, Ajay Rai said, "This is the end of our many years of waiting. I, my parents, Awadhesh's daughter and the whole family kept patience... Governments came and went and Mukhtar strengthened himself. "But we did not give up. Because of our

Mukhtar guilty in the murder case of my brother," Rai added. Lawyers said that around 1 am on August 3, 1991, Congress leader Ajay Rai and his brother were standing at the gate of



their house in Varanasi when some assailants, including Ansari, came there in a car and shot Awadhesh.

Ajay Rai fired from his licensed pistol in retaliation, following which the assailants fled, leaving the car behind, they said. Awadhesh was rushed to a hospital in Kabirchaura, where doctors declared

Govt Refutes News Report On Road Connectivity To Ahadwah Village In Ramban

Says Two Projects Underway To Provide Connectivity To The Hilltop Village

RAMBAN: The Jammu and Kashmir administration on Monday strongly refuted a news report published in a daily local newspaper regarding delay in road connectivity to remote Ahadwah Panchayat, in Ramban District.

Describing the contents of the news report published in daily "Greater Kashmir" today as misleading, a government spokesperson stated that attempts are being made to connect Ahadwah panchayat through two national schemes, one under PMGSY and another under NABARD.

"While directions have been given to complete the last mile coverage of 4.93 km up to Ahadwah via Marog-Balihote under PMGSY, the survey of Phase II under NABARD is currently underway to provide alternate connectivity through Neera and Batiya panchayats," he

Countering the claim made by the news report that the said PMGSY road was sanctioned in the year 2003-04, the spokesperson informed that the Phase I of the said road was sanctioned in 2005-06 while its Phase II was sanctioned in the year 2017-18.

He said that out of total length of 24.33 km, road upto 19.40 km has already been constructed which also stands blacktopped upto 15 km and the remaining portion has been prioritized for completion in this fiscal.

Highlighting the challenges in providing road connectivity in hilly and mountainous terrain in Ramban district, the spokesperson said the Marog-Ahadwah road via Balihote was foreclosed twice in the past due to local hindrances and forest clearance issues. "Ahadwah panchayat is literally on a mountain top and despite stiff challenges, substantial progress has been achieved", he said assuring to give connectivity to Ahadwah in this financial year.

Conveying an assurance on behalf of the government to connect all unconnected villages, the spokesperson said that more than 1000 souls will be benefitted once the 12 km NABARD road to Ahadwah gets completed, adding that the project amounting Rs. 2.49 crore sanctioned in Phase I shall be completed shortly.

Odisha **Train Tragedy**

bout 275 people were killed and around 1000 were injred in Odisha train tragedy, one of the worst in decades. According to Union Railways Minister Ashwini Vaishnaw, a change in electronic interlocking may have caused the horrific accident. He said that "whoever did it and how it happened will come out during the detailed investigation." The interlocking error means that due to an 'incorrect signal', the train that was supposed to go via the main 'up line', changed tracks at a speed of more than 125 kmph and collided with a goods train that was parked there. How did this happen? That is a matter of investigation. Some reports have pointed out that it could have also happened due to an 'electronic interlocking' error. And some reports also suggest that the railway ministry had been warned about the error weeks ago.

This is a serious issue and the government needs to get to the bottom of this. Whether it is a human or electronic error, the accountability should be fixed and heads should roll. The train collision has left a trail of devastation. As the dust settles, it is imperative to focus on what lies ahead. Several critical questions need answers: How will responsibility be assigned? Will this tragedy serve as a catalyst for the changes in railways which is the mode of transport for a large mass of people all over the country. Data says it all: India has the fourth largest railway network with over 22,593 operating trains with a daily passenger count of 24 million passengers and 203.88 million tonnes of freight. In 2022, passenger traffic stood at 3.54 billion as compared to 1.28 billion in 2021.

However, the recent performance audit by the Comptroller and Auditor General of India revealed that maintenance of tracks played a significant role in three-quarters of the consequential train accidents between 2017-18 and 2020-21. This highlights the importance of prioritizing track maintenance and addressing related issues to prevent derailments.

The tragic events in Odisha is a wane-up call and should not be forgotten or dismissed as another unfortunate incident. It should serve as a catalyst for change, spurring the government to take decisive action and improve track management. Lakhs of people travel by railways in India. And their safety deserves the highest priority. And first step towards this goal is to find out what happened in Odisha and to fix responsibility.

Beating El Niño

ost economy watchers are upbeat about India's growth prospects in the current fiscal, more so after the revised better-than-expected GDP numbers for 2022-23. But there are three possible headwinds: A general global economic slowdown that can impact exports, the cumulative effect of interest rate increases in the past one year, and El Niño. It's the last one that poses the most immediate threat. Most climate models are indicating high probabilities for El Niño developing by July-August. This has also led the India Meteorological Department to forecast aggregate rainfall over the country during June-September at 96 per cent of the long period seasonal average, making it a just-about normal monsoon.

In the event of a subnormal season, the most obvious casualty would be the kharif crops that are mainly planted during June-July. The more the delay in the monsoon's onset and coverage across the country, it reduces the sowing window as well the period for plant growth. Also, if the transition to El Niño happens midway through the season, and given its usually lagged effect on actual rainfall, the resultant moisture stress could extend to the rabi winter-spring crops. Of course, these are extreme scenarios for now. But the fact remains that the Indian economy's fortunes are still tied to the monsoon, which has a bearing not just on agriculture production, but also hydro power generation and drinking water availability. And after four consecutive good monsoon years from 2019, this is one risk factor that simply cannot be wished away while making any growth projections.

The redeeming part, however, is that the overall food supply situation is fairly comfortable compared to a year ago at the height of the Russia-Ukraine war, or even two months back, when there was a lot of uncertainty over India's wheat crop and milk had turned the policymakers' next big headache. Thankfully, the yield losses in wheat from unseasonal rains weren't all that much and government agencies have procured enough grain to meet the requirements of the public distribution system. Surplus pre-monsoon showers, alongside a surprisingly mild summer so far, have been favourable for fodder growth and milk production, improving supplies to dairies and easing price pressures. The availability position is good in edible oils (courtesy of a crash in global prices) and reasonably so in pulses too (due to ample stocks of chana with the government and imports of masoor). Both the government and the RBI should keep a close watch on the monsoon, but there's no need to sound the alarm bell. The Indian Express On World Environment Day

Plastic Pollution Needs Behavioural Solutions

Govt must work towards bringing sustainable behavioural change to counter plastic waste

If our Govt is really serious about seeing our forests, rivers and lakes, mountains, grasslands, farms and urban landscapes free from plastic pollution, they must seriously work on bringing sustainable behavioural change among people to address waste management issues especially to counter plastic pollution

lastic is found everywhere. It has deeply impacted our lives. We see plastic as deep as 7 miles below the sea level or on top of the highest Himalayan peaks. Plastic production and consumption contribute greatly to greenhouse gas emissions. It devalues marine ecosystems, chokes the wetlands and wildlife and impacts our rivers. The effect that plastic is having on our world is difficult to fathom. It is estimated by the World Economic Forum and Ellen MacArthur Foundation that by 2050 there will be more plastic by weight than fish in our oceans by 2050? The world is facing a plastics crisis. Plastic pollution is found all around the globe. Plastics are negatively affecting people and the environment at each stage of their lifecycle - extraction of fossil fuel, production, manufacturing, use, recycling, and disposal. The impacts of plastic pollution is felt in a wide range of areas like biodiversity, climate & human health. Micro- and nanoplastics which enter into our human bodies directly or through food have harmful effects on health. The main route for microplastic entering into our bodies is ingestion, followed by inhalation and dermal (skin) exposure. Although there is no scientific certainty of the amount of plastics humans ingest, estimation guesses around 0.1-5 gram per week. Not only are our cities and towns impacted by plastic pollution but even the villages are impacted as well. This is more dangerous in villages located in Himalayan region which includes Jammu &

Kashmir as well.

The plastic in Jammu & Kashmir is not only impacting our mountains, forests and rivers but this is choking our drainage system as well which to flooding in urban areas like Srinagar and other towns. In villages also there is water logging as plastic has choked our rural areas. To address plastic waste in rural areas

launched Swachh Bharat Mission Gramin's phase II programme but this programme is not picking up and we hardly see any district or block that can be a role model for other places in J&K. When the Government launched a waste management programme for rural areas of J&K last year , the Govt began supplying steel trash bins to Block Development Officers (BDOs) who further provided the same to people at panchavat level. On November 21st I wrote a piece titled "A Tale of Forlorn Garbage Bins" I had made a prediction that these trash bins would be of no use as there was no service available to clear the trash bins or collect waste at household level. It has been more than 7 months since these trash bins have been installed, but they are of no use at all? The reason is lack of service to collect the waste. **Apex Committee** Government in October 2021 constituted an Apex Committee for implementation of Swachh

Bharat Mission Gramin (SBM-G) phase II in J&K. The eight member committee is headed by the Chief Secretary. Other members of the committee include Administrative Secretaries of Finance, Health, Rural Development, Information and Jal Shakti. Experts in the field of sanitation, hydrology, IEC, HRD, Media, NGOs shall also be the members of this high level committee. This apex committee which was constituted vide Govt order No: 1116-JK(GAD) of 2021

Dated: 21.10.2021 will be advising the Mission Directorate of SBM - Gramin J&K (Directorate of Rural Sanitation). Till date people are not aware of the number of meetings this committee organised and what kind of advises it gave to Mission Director SBM

Gramin guidelines SBM makes it mandatory for the Government to have at least one Solid Liquid Waste Management (SLWM) Consultant at the State level and one SLWM Consultant in each district to guide the preparations of the solid and liquid waste management projects for each Gram Panchayat (GP). People in rural areas haven't seen such projects prepared.

Even the District Development Council Members and Chairpersons are not aware of all this. Last year, the DDC Chairman Nazir Budgam Ahmad Khan took up this issue with Ms Vini Mahaian, Secretary Ministry of Drinking Water & Sanitation. He wrote a detailed letter to her complaining that as Chairman Zila Swach **Bharat** Mis-Gramin sion he has no information at all about what kind of projects are being taken up in Budgam. The Secretary in fact responded back but on

The unscientific plastic waste management is not a challenge in urban areas but this is an uphill task for rural areas of Jammu & Kashmir as well.

Challenges of Plastic Pollution

According to the United Nations Environment Programme (UNEP), humans produce more than 430 million tonnes of plastic annually. In addition to it 46% plastic waste is landfilled, while 22% is mismanaged and littered here and there. UNEP also adds that as per global estimates. around 75 to 199 million tonnes of plastic is currently found in our oceans and it is estimated that 1,000 rivers are accountable for nearly 80% of global annual riverine plastic emissions into the ocean, which range between 0.8 and 2.7 million tonnes per year. According to Plastics, The Potential and Possibilities report prepared in association with the Indian Institute of Sci ence (IISc) and Praxis Global Alliance, India generates around 3.4 million tonnes (MT) of plastic waste annually and only 30% of it is recycled. In Jammu & Kashmir the situation is worse. The plastic waste produced in tourist places like Gulmarg, Pahalgam, Yusmarg, Sonamarg or Doodhpathri is landfilled inside forests.Large amounts of it is thrown in local streams as well which is dangerous.

LG Manoj Sinha's Speech

As LG Manoj Sinha in his address on World Environment Day today said that the world cannot exist without nature and people have to accelerate their actions and bring behavioural changes in their lifestyles, I would appreciate that the Government must work towards hand holding people towards achieving it. LG Sinha must seek updates from the Rural Development Department especially about the progress of Swachh Bharat Mission Gramin Phase II wherein rural waste management programme has to be undertaken. He must also call for a review meeting of SBM urban as well and make sure all the ULBs in J&K have a scientific waste management system in place. If our Govt is really serious about seeing our forests, rivers and lakes, mountains, grasslands, farms and urban landscapes free from plastic pollution, they must seriously work on bringing sustainable behavioural change among people to address waste management issues especially to counter plastic pollution.

Will AI really change ERYTHING 5 NOT LIKELY

falling behind in the race to the future, both function to keep consumers credulous and anxious. So the next time you hear a platitude spoken in worship of AI, feel free to roll your eyes."

o you have AI fatigue yet? Not a day goes by without breathless commentary on the increasing power of artificial intelligence models. A deluge of new apps and services promises to disrupt everything from health care to law to education.

"The future is here," we are told. "Are you ready?"

There is an endless supply of grand prognostications on exactly how artificial intelligence will "change everything." But these prophecies tend to fall into one of two camps. Either they are blindly optimistic, claiming that AI will magically solve everything from climate change to the opioid crisis, or they are darkly dystopian, warning us that Al could escape its silicon chains and destroy humanity.

Even when AI developers themselves "warn" people of the existential threats AI could pose, as they did in an open letter recently calling for a pause in development, it functions as a marketing campaign. The tech companies are essentially congratulating each other for creating something too good. Google's CEO Sundar Pichai has called AI, without irony, a technology "more profound than fire or electricity."

The public doesn't know what to believe and they're worried. A newly released poll conducted by Innovative Research Group for the 2023 Provocation Ideas Festival shows that 47 per cent of Canadians are more concerned than excited about the increased use of AI. Only 9 per cent are more excited than concerned. Even those who are more ambivalent about an AI-saturated future will become exhausted by the constant exhortations to "future-proof your career" or "become AI literate."

The reality is that most of what we read about AI is hype. In the near term, this new crop of AI tools will probably give us slightly better-written spam in our inboxes and reams of crappy, machine-generated



websites. Real, life-saving applications are indeed possible in fields such as health care and agriculture, but they'll be hard to spot amidst all the junk. Although tools like ChatGPT and Midjourney are fun to play with and can astonish us with their output, they are not operating anywhere near human intelligence.

They are essentially performing a clever parlour trick.
The reason we are astonished by their output is because, as a species, we're gullible. We tend to read human characteristics into any pattern that even mildly resembles a human. We see faces in electrical sockets and spot human silhouettes in evening shadows. We feel bad for a discarded teddy bear. And when it comes to language, we tend to attribute human intention to even the most banal sentences if they're writ-

Appealing to this state of heightened empathy is one of the ways technology companies have captured the public's attention in recent months. OpenAI launched ChatGPT (which generates text) and DALL-E (which generates images) online and for free so the public could play around with them. It let the public work itself into a frenzy as they identified characteristics in the programs that were previously thought to

be exclusively human: reason, humour, emotion, creativity. But generative AI can do none of these things. It has the form of human expression but no content.

The technology that runs under the hood of these tools is not fundamentally new. The mathematical models have changed in recent years and new chips are making computation cheaper and more efficient, but ChatGPT only functions like a powerful autocomplete feature. Trained on an enormous amount of data, the model predicts which words are likely to come next in a sentence. That's it. It feels like there's a human behind the curtain, but it's re-

The hype will allow tech companies to pump their valuations sky-high, further concentrating capital and technological know-how in the hands of very few billionaires. As such, the field of AI is desperately in need of regulation. This is necessary not because tech companies might unleash a mathematical model that will suddenly become conscious and take over the world, but for the very real, boring reasons that have always existed: so they don't take advantage of poorly paid temp workers, or refuse calls to be transparent with their algorithms, or flood social media with misinformation, or violate copyright laws by scraping the web for data without the permission of its owners. Sadly, these are things that Big Tech is already doing and governments have been slow to act.

Fear, as populist politicians and headline writers know well, is best evoked by appealing to the un-known. Whether it's the fear of Al-gone-rogue or the fear of falling behind in the race to the future, both function to keep consumers credulous and anxious. rom sleep trackers to wakefulness drugs. the 21st century has seen an influx of new technology that could radically alter the way we sleep.

Many of these new technologies chase the dream of optimised slumber. They promise to help tailor our sleep schedules to fit around our social lives, help us sleep for longer or even skip a night's sleep altogether.

Here's how technology is permeating our sleep, and what the future holds.


Time to wake up

Sleeping pills have recently been joined by a wave of wakefulness drugs, purportedly safer and more powerful alternatives to caffeine.

It seems that they work best on people who are already sleep deprived and don't have a huge effect on those who are already well rested.

Modafinil is touted for its cognition enhancing effects (especially in sleep-deprived people) and can supposedly keep people awake and alert for several days at a time. Some scientific studies are showing that this may indeed be the case, although results are mixed, with other research showing the effects are similar to caffeine.

The drug was developed to help people with narcolepsv but some have started using it for its focus-enhancing

effects. It is a controlled drug (prescription only) in most countries. People who use it for cognitive enhancement or wakefulness are buying it on the black market or getting it from friends who have a prescription.

Modafinil is popular with students in 2020, Loughbor-

ough University researchers found that, of 506 students surveyed at 54 UK universities, 19% had taken cognitive enhancement substances

But people who take them for non-medical purposes are risking their health. Studies of the safety of these drugs do not consider this type of

use. We don't know what using these drugs to stay awake for long periods of time does to people's bodies. But we do know that disrupting your sleep pattern (for example, shift work) is linked to health problems such as diabetes and cardiovascular disease.

Recent studies suggest

some people are combining sleep and wakefulness pills to manage their body rhythms and optimise their sleep or unwind after a day of hard work. The effects of taking wakefulness pills with other drugs is largely unknown.

In the UK sale or supply of a prescription-only or unlicensed medicine is a criminal offence. Whereas in the US, even possession of stimulants without a prescription is a crime.

Smart sleep

Many people already use smart watches, smart jewellery and fitness bands to track their sleep for example, alarms that wake people up at the optimal point in their sleep cycle and motion sensor apps that analyse sleep patterns.

New ways of tracking sleep could soon include donning a pair of pyjamas embedded with sensors to track changes in posture, respiratory and heart rate, or hugging a robot pillow, whose algorithm creates a breathing pattern to mimic and help you fall asleep.

Meanwhile, care robots have already been trialled in Japan to test whether they could help older people sleep better. Designed to watch over residents at night in care homes, they give staff information on how well the residents are sleeping and let them know if anyone goes for a nocturnal wander.

'Vitamin D Deficiency More **Common In Children With TB'**

Vitamin D deficiency is more common in children with tuberculosis (TB) than those not infected by the bacterial disease, according to a study conducted in hospitalised patients in Telangana.

The study, recently published in the journal Cureus, also found that a severe form of vitamin D deficiency -- less than 10 nanogrammes per millilitre (ng/mL) -- was higher among children with TB.

The team, including researchers from Osmania Medical College (OMC) and Government Medical College, Siddipet, carried out the study in a tertiary care centre at Niloufer Hospital, Telangana over a period of one year and five months.

A total of 70 children with TB between the ages of 6 months and 12 years were included in the study. The partic-

ipants were divided into three groups according to age: 1-4 years, 5-8 years, and 9-12 years.

"The mean vitamin D level in our study was 10.43 ng/ml among the cases and 22.84 ng/ mL among the controls," the

authors of the study noted. "The study found that prevalence of vitamin D deficiency (VDD) was high among children with TB than with controls. In addition, the severe form of VDD was higher among children with TB," they added.

The researchers noted that clinicians should be aware of associated malnutrition and low socioeconomic status as risk factors for severe vitamin D deficiencies among them.

Tuberculosis (TB) is one of the most devastating and widespread infections in the world. It is a leading cause of morbidity and mortality, particularly in developing countries, the researchers said.

Explained: Why Is OPEC Cutting Crude Oil Output

LONDON: The Organization of the Petroleum Exporting Countries and allies including Russia, a group known as OPEC+ which pumps around 40% of the world's crude, agreed on a new oil output deal on Sunday.

Saudi Arabia, the group's biggest producer, will make a deep cut to its output in July on top of a broader OPEC+ deal to limit supply into 2024 as the group faces flagging oil prices.

A surprise announcement by OPEC+ in April to deepen production cuts helped to raise prices by about \$9 a barrel to above \$87 per barrel in the days followed.

Yet benchmark crude prices have shed those gains since, with Brent futures on Monday trading at just under \$78 a barrel. [O/R]

On Sunday, in addition to extending the existing OPEC+ cuts of 3.66 million barrels per day (bpd), the group agreed to reduce overall production targets from January 2024 by a further 1.4 million bpd to a combined output of 40.46 mil-

The changes, however, included lowered targets for Russia, Nigeria and Angola simply to bring them into line with current production levels.

devise a mechanism to ensure reasonable airfares amid a surge in air ticket prices, particularly on certain routes that were earlier served by Go First. In the case of the unfortu-

nate Odisha tragedy, airlines have been advised to provide free carriage (cargo) services to the families of the deceased, the civil aviation ministry said.

During an hour-long meeting of the airlines advisory group, Civil Aviation Minister Jyotiraditya Scindia shared his concerns about the steep rise in airfares on certain routes.

Airlines have been asked to self-monitor airfares on routes that have seen a considerable rise in ticket prices, particularly those that were served by Go First earlier.

Go First stopped flying from May 3 and the reduction of capacity due to the crisis at the budget airline has come at a time when the peak domestic air travel period is round the corner.

A mechanism should be devised by airlines to ensure reasonable pricing within the high RBDs (Reservation Booking Designator) and the same would be monitored by the

Directorate General of Civil Aviation (DGCA), the ministry said in a statement.

Govt Asks Airlines To Devise

Mechanism For Reasonable

Airfares are deregulated under the current regulatory regime.

Besides, the ministry has said that during any calamity, "The airline pricing system runs in multiple levels (buckets) which are in line with practices being followed globally. The prices are fixed by airlines keeping in mind the market, demand, seasonality and other market forces. The



airlines need to keep a tight check on the pricing of air tickets "in view of the humanitarian situation and monitor and control any surge in ticket prices to/ from that region".

After the deregulation of the country's airline sector, airfares are market-driven and are neither established nor regulated by the government. Airline pricing runs in multiple levels (buckets or Reservation Booking Designators).

Scindia, on March 16, informed the Lok Sabha that "airfares are neither established nor regulated by the government".

airfare increases with an increase in demand for seats as the lower fare buckets get sold out fast when bookings are offered by airlines," he had said in a written reply.

India is one of the fastestgrowing civil aviation mar-kets in the world and domestic passenger traffic has been rising after being significantly impacted by the coronavirus pandemic.

India's Services Sector Output Increases At 2nd-Fastest Pace In Close To 13 Yrs In May: PMI

NEW DELHI: India's services sector growth eased slightly in May, but registered the second-strongest rate of growth in close to 13 years, on favourable demand conditions and new client wins, a monthly survey said on Monday.

The seasonally adjusted S&P Global India Services PMI Business Activity Index fell from 62 in April to 61.2 in May. Despite falling from April, the latest reading indicated that output increased at the second-quickest pace since July 2010.

For the 22nd straight month, the headline figure was above the neutral 50 threshold. In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion while a score below 50 denotes contraction.

"The PMI data for May stand as a compelling testament to prevailing demand resilience, impressive output growth and job creation within India's dynamic service sector," said Pollyanna De Lima, Economics Associate Director at S&P Global Market Intelligence.

monitored Additionally, companies expanded their workforces to accommodate for higher intakes of new work.

Going ahead, services companies maintained an upbeat view that business activity would increase over the coming 12 months.

"Advertising, demand strength and favourable market conditions were among the reasons cited for optimistic forecasts," the survey said.

Meanwhile, the S&P Global India Composite PMI Output Index -- which measures combined services and manufacturing output -- stood at 61.6 in May, unchanged from April.

"India's private sector built on the strong momentum recorded in April by posting a rate of expansion in business activity that was the joint-best in just under 13 years," the survey said.

'Massive Opportunities' In Indian **Aviation Market: IATA**

ISTANBUL: There are "massive opportunities" in the vibrant Indian aviation market, the International Air Transport Association (IATA) Director General Willie Walsh said on Monday.

Talking about the Indian market, he highlighted that there are CEOs of two Indian airlines on the Board of Governors (BoG) of IATA and it is the first time that has happened.

"It reflects the opportunity and vibrancy... there are massive opportunities and we are really excited about the future of aviation in India," he told a media briefing on the sidelines of the IATA Annual Gen-

Air India CEO and Managing Director Campbell Wilson and IndiGo CEO Pieter Elbers are among the 31 airline CEOs on the BoG. On Monday, IATA announced that Elbers will serve as Chair of the BoG from June

India is one of the fastest growing aviation markets in the world and Air India has embarked on an ambitious expansion plan, while IndiGo is set to fly to more international destinations.

Earlier this year, Air India placed a historic order for 470 planes with Airbus and Boeing. On domestic routes, Indian

carriers flew 5.04 crore passengers during the 2023 January-April period, as against 3.53 crore in the year-ago period, recording an annual growth of 42.88 per cent, as per latest official data.

Meanwhile, at the briefing, Walsh said airfares are often high due to factors outside



the control of airlines such as

He was responding about high airfares in the country.

About India's stance of common but differentiated responsibilities in efforts to reduce carbon emissions, Walsh said it has a been a long standing decision. "... We acknowledge and recognise the decision of India and many other countries do highlight the need to reflect differentiated responsibilities".

Last month, India said that the International Civil Aviation Organization (ICAO) should continue to be guided by "common but differentiated responsibilities" in the efforts to achieve net zero carbon emissions for the aviation sector.

Based on "realities and infrastructure constraints", India has set a target of achieving net zero emissions by 2070, Civil Aviation Secretary Raiiv Bansal had said at an ICAO symposium.

He had also said that the transition towards a lower carbon and Sustainable Aviation Fuels (SAF) will be fundamental to achieving the net zero target by 2050.

"The process of SAF legislation, regulation, production, and deployment is external to civil aviation and requires The competition for biofuels from other sectors, especially road transport poses a chal-

Further the credit states that the promoters completed the sale of shares in four listed group entities to GQG Partners, a leading global investment firm, for \$1.87 billion (Rs 15,446 crore).

US short-seller Hindenburg Research in January released



counting fraud and stock price manipulation at Adani Group, triggering a stock market rout that had erased about \$145 billion in the conglomerate's market value at its lowest point.

Adani Group has denied all allegations by Hindenburg and is plotting a comeback strategy. The group has recast its ambitions as well as prepaid some loans to assuage investors.

Automobile Retail Sales See 10% Growth In May: FADA

NEW DELHI: Automobile retail sales rose 10 per cent in May on the back of robust demand across segments including passenger vehicles, two-wheelers and tractors, automobile dealers' body FADA said on Monday. The total automobile retail sales jumped to 20,19,414 units last month, from 18,33,421 units in May 2022.

Passenger vehicle sales rose by 4 per cent to 2,98,873 units in May, as compared to 2,86,523 units in the year-ago period.

The Federation of Automobile Dealers Associations (FADA) President Manish Raj Singhania said improved availability of vehicles coupled with pending order list and the robust demand for new launches drove a positive momentum, helping the passenger vehicle segment rebound after a slump in the previous month.

Two-wheeler retail sales last month rose 9 per cent to 14,93,234 units, as compared to 13,65,924 units in May 2022.

"The two-wheeler sales were positively influenced by seasonal factors like the marriage season, changes in the FAME subsidies ef-



fective from June, and the recovery of rural demand," Singhania said. Commercial vehicle retail sales rose by 7 per cent to 77,135 units last month, as against 71,964 units in May last year. Three-wheeler retail sales rose

79 per cent to 79,433 units last month, as compared to 44,482 units in the year-ago period.

Tractor sales rose to 70,739 units, up 10 per cent, as compared to 64,528 units in May 2022.

On business outlook, FADA said that the anticipated stable interest rates by RBI's Monetary Policy Committee could maintain vehicle demand and positively impact auto sales.

However, supply chain issues, demand-supply dynamics, and regulatory changes also play a role in shaping the auto retail outlook, it added.

India Committed To Minimising Digital Health Divide: Niti Aayog's VK Paul at G20 meet

Hyderabad: Niti Aayog member (Health) Dr VK Paul on Monday said India is committed to minimising the digital health divide by promoting digital solutions and innovation to aid universal health coverage.

Addressing an event related to the 3rd Health Working Group of G20 India here, Dr Paul said India's digital goods are for the world and that the country's digital infrastructure and capabilities are enablers of global economic growth and human development.

He gave the keynote address for the event titled 'Digital Health Innovations and Solutions to Aid Universal Health Coverage and Improve Healthcare Service Delivery' during the second day of the G20 meet in the city

day of the G20 meet in the city.

"India as the voice of Global South is committed to minimising the digital health divide by promoting digital

solutions and innovation to aid universal health coverage," Paul said.

Quoting a previous statement by Prime Minister Narendra Modi on Digital India, Paul said, "I dream of a digital India with quality healthcare is accessible right up to the remotest regions powered by e-healthcare."

He said deliberations in the health working groups suggest that digital technologies can play a very critical role in achieving universal health coverage and combating health emergencies.

Digital health, through initiatives such as telemedicine and mobile apps, can enable universal health coverage by increasing access to people irrespective of location or socio-economic status, he said.

The G20 Health Working Group is deliberating to create a global digital health initiative to provide a platform to promote equitable access to digital tools and technologies among

the countries concerned towards ensuring universal health coverage, he

"There is concurrence among the participating countries and multilateral agencies that a global system of this nature should be created that should become an enabler of universal health coverage through technologies," Paul

Digital technologies are playing a crucial role in healthcare and are changing rapidly from artificial intelligence to 5G virtual reality and block chain, he said.

Paul said that there is an agreement that to build a platform where digital health tools are stored in a repository and are made accessible to any country or a partner.

He cited the example of Ayushman Bharat Digital Mission and said that "it brings together state governments, Union government, laboratories, insurance providers, health tech companies, doctors, NGOs' programme managers, other stakeholders keeping the citizens at the centre of the endeavours".

"Let us envision a world where a comprehensive package of digital health tools and services are accessible to all, where digital health is for all by 2035," he added.

The G20 will focus on finalising the ministerial declaration ahead of the fourth working group ministerial meeting scheduled for August. Fifteen countries have given written comments on the zero draft declaration document that was circulated in the last meeting held in Goa.

"Discussions were held on the first draft and the delegates urged India to organise two or four video conferencing meetings before the August meeting. Those who did give a comment are able to refine the changes," said an official, adding that the presidency hopes to have a 90 per cent ready

document ahead of the ministerial meeting.

Speaking at the meeting, Dr Christopher Elias, President, Global Development, Bill and Melinda Gates Foundation, said the world has seen momentum in development of lower and middle-income countries in the last decade, especially after the Covid pandemic.

World Health Organization official Dr Alain Labrique said "quality, efficiency, equity and inclusion" of global health systems will depend on how the group works together.

"We must as a group invest strategically. This will enable cross border exchange of credential health information now available to all member states," said Dr Labrique, Director, Department of Digital Health and Innovation, WHO.

Union Health Secretary Rajesh Bhushan said that all countries need to be adequately prepared for the next pandemic and must act with "a sense of urgency". He urged all stakeholders to come together and act for 'One Earth, One Family, One Future', theme of India G20 Presidency.

The 3rd Health Working Group meeting as part of G20 India Presidency is being held at Hyderabad from June 4-6 and will focus on the three key priorities of the G20 health track.

One of the priorities is health emergency prevention, preparedness and response with a focus on anti-microbial resistance and the 'One Health' framework.

The other is strengthening cooperation in the pharmaceutical sector with a focus on access and availability to safe, effective, quality and affordable medical countermeasures. The third is digital health innovations and solutions to aid universal health coverage and improve healthcare service delivery.

"Every year, thousands of tons of

"Every year, thousands of tons of waste is generated from Dal Lake,

which poses problems for local people in the area and adds pollutants to the environment. We are aiming to resolve this problem at the root level," said Maninder Singh Nayyar, Founder & CEO of CEF Group.

He further said that they have the technology, expertise and experience of converting this extracted waste into 24,000 tons of organic manure annually.

"It will help farmers go organic farming and serve waste management purposes for people involved in jobs at Dal Lake. Moreover, organic manure produced from the waste will be available at local farmers' disposal, boosting their yield and promoting organic farming in the region," Nayyar added.

Notably, the farmers of Kashmir pay heavy prices for organic manure as currently it is supplied from states like UP and Haryana because of which they have to bear high transportation costs.

"With this project, organic manure will be available to farmers at reasonable costs. In addition, the waste processing plant will generate employment opportunities for local people," he said.

Lake waste like weeds, lilies, and others accounts for 70,000 tonnes of waste every year in Dal Lake hindering boat movements in the lake and causing problems for locals earning from Dal Lake tourism.

"With the help of CEF Group's waste processing plant in Srinagar, Kashmir, these wastes will be extracted and provided to the company at their project site to convert them into usable organic manure and allied products," Nayyar added.

Dr. Bashir Ahmad Bhat (IRS), Vice Chairman of Lake Conservation and Management Authority (LCMA), said, "Lake waste has been a long-time problem, and we are glad that CEF Group and NAFED in collaboration are providing sustainable solutions. In addition to waste processing, organic manure will be produced in the state itself, which will benefit local farmers and communities financially. Local employment by the company will aid the earnings of the area's local people. We hope to take this collaboration to a greater height so that rising climate change concerns are addressed."

The efforts to reduce waste from Dal Lake will contribute mainly to reducing carbon footprints and access to high-quality organic manure for the people of Jammu & Kashmir.

India Batters Must Grind In WTC Final: Rohit

LONDON: India's batters should be prepared to grind out runs in tricky English conditions against Australia's fiery pace attack in the World Test Championship (WTC) final at the Oval, skipper Rohit Shar-ma said on Monday. Facing a prodigiously swinging Dukes ball fired by Pat Cummins or Mitchell Starc would be a totally different experience for Rohit's team mates most of whom were busy in the Indian Premier League T20 c9ompetition until last week.

Rohit mastered these conditions during the 2019 World Cup when he smashed five hundreds in nine innings and, two years later, stroked a matchwinning century in an Oval test

against England. "England, in general, is pretty challenging conditions for the batters, but as long as you are prepared to have a good grind you can have some success as a batter," he said ahead of the WTC final beginning on Wednesday.

The key was not to be lulled into any false sense of security while batting, he said. "One thing I realised batting here was you are never in actually, because the weather keeps changing a lot.

"So you've got to keep concentrating for longer periods of time and that is the challenge of this format." "You'll get that intuition when it is your time to take the bowlers on and that is when you

should be ready for it." Rohit is particularly keen to

capitalise on his strength square off the wicket. "We know that this is probably one of the best batting wickets, as well you get value for your shots, you know the square boundaries are quite quick," he said.

With Jasprit Bumrah recovering from a back surgery, Mohammed Shami will lead the pace attack for India who were beaten by New Zealand in the inaugural WTC final in Southampton two years ago. Indian have yet to make up their mind about fielding second spinner Ravichandran Ashwin along with all-rounder Ravindra Jadeja but Australia's Steve Smith ruled out being complacent against them.

"They've got a good mix of quality seam bowlers," he told

Will Continue Our Fight: Wrestlers **Rubbish Reports Of Their Withdrawal**

NEW DELHI: Olympic medallists Sakshi Malik and Bajrang Punia on Monday said they will continue their fight for justice, asserting that none of the wrestlers have backed down and rubbished reports of their withdrawal from the protest as attempts to "sabotage" the movement.

The news of our withdrawing from the movement is just a "rumour", Punia said, adding that the report of women wrestlers taking back the FIR is also "false"

Bajrang, Sakshi along with fellow Olympian and World Championship medallist Vinesh Phogat have been protesting against outgoing Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh, demanding his arrest on allegations of sexual harassment against seven wrestlers, including one minor. Singh has denied all the charges.

"This news is completely wrong. In the fight for justice, none of us has backed down, nor will we. Along with Satyagraha, I am fulfilling my responsibility in Railways. Our fight continues till justice is served. Please don't spread any wrong news." Malik tweeted

Reacting to the reports, Punia said,"This news is being spread to harm us. We have neither retreated nor have we withdrawn from the movement. The news of women wrestlers taking back the FIR is also false. The fight will continue till justice is served."

Their reactions came amid reports that both of them have withdrawn from the protest. dealing a big blow to the more

than two-month-old protest. Asked if she has distanced herself from the movement since she resumed her duties in the Railways, Sakshi told reporters,"Let me make it clear, we are making our strategy to take our fight forward.

We will ensure that there is no violence, how we can take the protest forward, we are working on that.

"I am (an) OSD (officer on special duty) first and I have a lot of responsibilities, so as long as we are making our strategy and not sitting on the protest, I will take care of my official duties.'

Messi Keen On Rejoining Barcelona, Says Father

BARCELONA: Lionel Messi, who last week played his last game for Paris St Germain, is open to making a return to LaLiga side Barcelona, the Argentine forward's father said on Monday. Barca were forced to let their talisman leave in 2021 because his high wages coupled with strict LaLiga financial rules could have jeopardised the club's future.

Messi, who joined Barcelona's youth set-up aged 13 and went on to become the club's all-time top scorer and appearance maker with 672 goals in 778 games in all competitions, moved to PSG as a free agent on a two-year contract. Barcelona's finances have slightly improved since then, but according to La-Liga, they are still over the cap and remain unable to register new contracts signed months ago, including defender Ronald Araujo and midfielder Gavi.

The LaLiga champions' president Joan Laporta has often spoken of his desire to bring Messi back to Camp Nou, but any move for the 35-year-old would likely further complicate their ability to adhere

to Financial Fair Play (FFP) rules.

"Leo wants to return to Barca and I would also like him to return. We are confident that Leo can come back," Messi's father Jorge said in an interview with Twitch channel Jijantes FC.

Messi, who led Argentina to the World Cup title in Qatar and also boasts a record seven Ballon d'Or awards, won the Ligue 1 title in the 2021-22 and 2022-23 seasons with PSG as well as the French Super Cup in July 2022. However, he opted not to renew his deal with the Ligue 1 champions.

His future has been the subject of much speculation recently, with a source close to the Argentina captain telling Reuters that he had received a formal offer to join Saudi Arabian club Al-Hilal next season. A move to Saudi Arabia would see him once again playing in the same league as rival and Al Nassr star Cristiano Ronaldo, while Real Madrid striker Karim Benzema is also expected to complete a move to the Middle Eastern nation.

The United States' Major League football club Inter Miami have also been touted as a possible destination for Messi.

Undercover Observers Track Racism, Discrimination At European Football Games

DUSSELDORF: Blend in. Stay alert. Feign excitement if you

Among the thousands of fans in the stands at Europe's biggest football games are a few people operating undercover. Trained volunteer observers listen for racist chants and watch for extremist symbols on

environment and fit in without standing out. You have to be discreet," one observer, who has worked at games involving some of football's best-known clubs and national teams, told The Associated Press.

"Obviously nothing gets published on social media. You have to be anonymous. You have to just sort of blend in. Don't engage in conversations

with anybody. The observer, who spoke on condition of anonymity because the job requires it, is part of a program run on be-

half of European football's governing body, UEFA, by the Fare Network, a prominent anti-discrimination group. Fare monitors about 120 games per season in Europe's main three men's club competitions, executive director Piara Powar told the AP, and more around the world in national team events like World Cup qualifying.

Evidence from the program, including photos taken surrep-"You have to be aware of the titiously from the stands, is used in disciplinary cases against clubs or national teams whose fans display racist behavior in European competitions like the Champions League.

It's not a career, but a way to make football better for the future, the observer said.

Observers work on a volunteer basis, with expenses covered, and are expected to keep tabs on hardcore fan groups' social media to track where incidents may occur.

Inside the stadium, an observer watches the stands for signs of racist, homophobic,



sexist or other discriminatory chants or banners, while also keeping an eye on the action on the field, which shapes what happens among fans.

"If you get a disgruntled fan base and they're getting beaten 5-0 and they get knocked out of a competition that they felt that they were going to progress in, then that could be another catalyst," the observer said. "You have to constantly read the situation as it unfolds.'

"You need to get as close as you can, but be as far away as your safety requires," the observer said.

Fare's work isn't always welcome. In a case at the Court of Arbitration for Sport over a banner at a 2019 game that was judged to contain a coded racist message, Georgian club Dinamo Tbilisi sought to challenge Fare's assessment, arguing that the observer collecting the evidence was "professionally trained to recognize potentially racist symbols and is therefore biased." The panel rejected the argu-

ment and pointed out that even if the banner's message wasn't clear to most fans, it still broke rules against racist messages. Like referees, Fare observers

can't work at games involving clubs they support. The observer said the goal is to make the atmosphere at games safer and more inclusive for the future. Over several years working

games, the observer has seen change for the better, but so far only "baby steps." "It's a professional endeavor. It's not going for the sake of it," the observer said. "I'm indifferent to the results. When a goal's scored, sometimes I have to stand up to feign excitement, but they are teams that I have zero emotional moments with."

IIT Madras Best Institution For Fifth Consecutive Year, IISc **Bengaluru Best University'**

The Indian Institute of Technology (IIT) Madras retained the top spot among institutes in the country for the fifth consecutive year, while the Indian Institute of Science (IISc) Bengaluru was adjudged the best university and research institution, according to the ministry of education's National Institutional Ranking Framework (NIRF).

The rankings were announced by Union Minister of State for Education Rajkumar Ranjan Singh on Friday.

Seven IITs-Madras, Bombay, Delhi, Kanpur, Kharagpur, Roorkee and Guwahati-figured in the top 10 in the overall rankings.

The All India Institute of Medical Sciences (AIIMS), which was ranked ninth last year, improved its ranking to sixth this year, while Jawaharlal Nehru University retained its tenth position in the overall category.'

The ranking framework, now in its eighth edition, evaluates institutions on five broad generic groups of parameters of teaching, learning and resources, research and professional practice, graduation outcomes, outreach and inclusivity and perception.

Ranks are assigned based on the total sum of marks assigned for each of these five broad groups of parameters.

In the universities category, IISc Bengaluru bagged the top spot, followed by JNU and Jamia Millia Islamia at second and third ranks. The trio were on the same positions last year too.

Banaras Hindu University, which was ranked sixth last year in the category, improved its rank and bagged the fifth spot.

Manipal Academy of Higher Education, Amrita Vishwa Vidyapeetham in Coimbatore, Calcutta University, Vellore Institute of Technology, Aligargh Muslim University and University of Hyderabad bagged the subsequent positions in the universities category.



Eight IITs-Madras, Delhi, Bombay, Kanpur, Roorkee, Kharagpur, Guwahati and Hyderabad—were in the top 10 ranks in the engineering institutions category.

The National Institute of Technology (NIT) Tiruchirapalli slipped by one spot this year and bagged the ninth rank, while Jadavpur University made its entry in the top 10 in the category and bagged the 10th position.

Among colleges, Miranda House, Hindu College and Presidency College-Chennai retained the first and second and third positions.

IIM Ahmedabad and Bangalore retained the first and second ranks respectively among the B-Schools in the country. IIM Calcutta, which was at the third spot last year, slipped to the fourth position while IIM Kozhikode bagged the third position.

In the pharmacy category, the National Institute of Pharmaceutical Education and Re-search, Hyderbad rose to the first spot from second position while Jamia Hamdard which was on first position last year slipped to the second spot.

In the medical colleges category, AllMS, Delhi bagged the top spot, followed by PGIMER Chandigarh and Christian Medical College, Vellore. The trio bagged

the same positions last year. Among the dental colleges, Saveetha Institute of Medical And Technical Sciences-Chennai, Manipal College of Dental Sciences and DY Patil Vidyapeeth-Pune retained the top three positions.

Paris' Iconic Champs-Elysees Hosts Mass Dictation Event

Paris: Not to be outdone by USstyle spelling bee extravaganzas, Paris's most famous street the Champs-Elysees was transformed into an open-air mass "dictation" spellathon Sunday, pitting thousands of France's brainiest bookworms against one another.

Revealing a very French love affair with words, over 50,000 applied to participate in the event, a world first, in which hopefuls attempt to faithfully and without error transcribe a text read to them.

Over 5,000 applicants aged 10-90 were chosen to participate in three sessions led by

novelist Rachid Santaki. With 1,779 desks laid out on Paris' most famous boulevard in each session, organisers had sought to break the world record for a dictation spelling competition.

In the first round, an excerpt of La Mule du Pape by renowned French writer Alphonse Daudet was read by journalist Augustin Trapenard, of Libraries Without Borders.

Silence fell when the first session started, but for 10-yearold Samson, the dictation was "too fast". He gave up.

In his final year of primary school, top student Antoine attended with his father and, despite being a star pupil, he had struggled to fill his page.

"It was impossible! The dictation was for adults," he said. His father Adrien Blind, 42, was equally relieved when the session wrapped, saying he "was in a state of stress and worry". But 65-year-old retiree Touria

Zerhouni was more upbeat. "I only made two mistakes! I expected it to be much harder," she said.

The competition went beyond the French classics, with a sport themed round read by rugby player Pierre Rabadan, and another with a contempo-rary flavour read by writer and journalist Katherine Pancol.

Marc-Antoine Jamet, president of the Champs-Elysees Committee which hosted the dictation during , said the event went beyond spelling.

Deadly Heart Attacks More Likely To Occur On Monday: Study

Serious heart attacks are more likely to happen at the start of the working week than at any other time, according to a study.

The researchers at the Belfast Health and Social Care Trust and the Royal College of Surgeons in Ireland analysed data of 10,528 patients across Ireland admitted to hospital between 2013 and 2018 with the most serious type of heart attack.

This is known as an STsegment elevation myocardial infarction (STEMI) and occurs when a major coronary artery is completely blocked.

The research, presented at the British Cardiovascular Society (BCS) conference in Manchester, UK, found a spike in rates of STEMI heart attacks at the start of the working week, with rates highest on a Monday.

There were also higher rates of STEMI than expected on a Sunday, the researchers said.

"This study adds to evidence around the timing of particularly serious heart attacks, but we now need to unpick what it is about certain days of the week that makes them more likely.' said Professor Nilesh Samani, Medical Director at the British Heart Foundation.

"Doing so could help doctors better understand this deadly condition so we can save more

lives in future," Samani said. Scientists have so far been unable to fully explain why this "Blue Monday" phenomenon oc-

Previous studies suggesting that heart attacks are more likely on a Monday have highlighted an association with circadian rhythm the body's sleep or wake

There are over 30,000 hospital admissions due to STEMI each year in the UK. It requires emergency assessment and treatment to minimise damage to the heart, and this is normally performed with emergency angioplasty a procedure to re-open the blocked coronary artery.

"We've found a strong statistical correlation between the start of the working week and the incidence of STEMI. This has been described before but remains a curiosity," said Jack Laffan, who led the research at the Belfast Health and Social Care Trust.

"The cause is likely multifactorial, however, based on what we know from previous studies. it is reasonable to presume a circadian element," Laffan added.
