Miscarriages In Kashmir: Burden Of Tragic Losses & Unheard Woes

n the centre of a petite room, bathed in a faint glow that filtered through the curtains, casting patterned shadows on the walls, Shaista Gulzar, 34, laid curled up in a blanket. Her eyes wide open, staring at the ceiling and her breaths coming in short, uneven gasps, unveiled the silent turmoil within her. Shaista had recently miscarried a child and the emotions were still raw and fresh. She felt like a part of her had been ripped away, leaving a void that would never be filled.

Every once in a while, her mother would come in, sit next to her bed and make an effort to console her, "but no amount of words can ease the pain I am feeling," she said. The mere mention of the loss gnawed at her soul, a constant reminder of the precious connection that was abruptly severed.

The day that Shaista found out that she was pregnant was one of the happiest in her life. She and her husband had been trying to conceive for three years and the news of a baby on the way was a pinnacle of unbridled bliss. What followed were tearful phone calls made



to close friends and family, as an unforeseen turn, when she she sought support and solace started having cramps and spotting in the tenth week of in sharing the long-awaited news. However, things took her pregnancy. She was taken

to her gynaecologist, who told her that she was having a miscarriage. After undergoing a Dilation and curettage (D&C) - a surgical procedure used to remove any remaining tissue from the uterus after a miscarriage or abortion, Shaista experienced immense physical pain. The soreness even persisted for days after the operation, but it was the psychological trauma that affected her the most.

"It was devastating. One minute we were planning and dreaming of the arrival of the baby and the next I was lying in a hospital bed. I couldn't understand what went wrong, why did my body fail us." she said in a despondent tone. More on P10

Unauthorized Occupation Of Migrant Property Force To Be Used If Land **Not Surrendered: HC**

Srinagar: The High Court of I&K and Ladakh on Friday said that if a person, unauthorizedly occupying migrant property, fails or refuses to surrender its possessions, force is to be used by competent authority.

A bench of Justice Vinod Chatterii Koul also reiterated immovable properties belonging to migrants shall be deemed to be in possession of District Magistrate irrespective of the nature of possession of any person other than the migrant himself. The court made the obser-

evict the illegal occupant and take over the possession of land measuring two kanals 17 marlas at Chowgam Tehsil of the south Kashmir district. The petitioner had stated

he has been in continuous peaceful exclusive possession of land prior to the year 1971. He had stated that the rights of ex-owner S Pandith regarding the land were extinguished under Section 4 of Agrarian Reforms Act and the petitioner was declared as prospective owner.

He had submitted that the land was later on mutated in his favour under Section 12 of the Agrarian Reforms Act and he came to be in absolute possession of the said land. On the other hand, counsel

representing migrants argued that the petition was not maintainable in view of provisions contained in Jammu and Kashmir Migrants Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997, therefore, the same was liable to be dismissed.

CEO ERA, WB Team Inspects Work On 120 Bedded B&J Hospital, Barzula

Srinagar: Chief Executive Officer, Jammu and Kashmir Economic Reconstruction Agency (ERA), Jhelum Tawi Flood Recovery Project (JTFRP), Dr Syed Abid Rasheed Shah, today inspected progress on construction of 120-bedded Specialized Orthopedic Unit (additional hospital block) at Bone and Joint Hospital, Barzulla.

The CEO was accompanied by a World Bank team led by Lead Disaster Risk Management Specialist at the World Bank, Deepak Singh and officers of JKERA, JTFRP, Chief Engineer Department of Roads and Buildings (R&B) among others.

During the inspection, the CEO directed the concerned agency to speed up work and ensure that the project gets completed at the earliest. He along with experts from the World Bank inspected all the stories of the building and directed the concerned agency to speed up execution on the remain-

ing works. Notably, the prestigious project has been taken up

under the component "Critical Infrastructure" of JTFRP funded by the World Bank. Inspecting the ongoing works, Dr Abid directed the

During the inspection, the team also analyzed the technical specifications of the building.

Earlier, the executing agency had been directed to initiate the process of procuring necessary medical infrastructure for the hospital which is part of the composite tender given to NPCC Limited.

Why Can't Chinar Trees Be Lopped **For Srinagar Smart City Project?**

Srinagar: Several chinar trees, which line the iconic Polo View Road in Srinagar, have been lopped by the authorities as part of the Smart City project, leading to an outcry by environmental activists. The authorities defended the move saying it was done following the set procedure.

Under the Jammu and Kashmir Specified Trees Act-1969, some tree species such as mulberry, walnut and chinar cannot be felled or lopped in view of their importance in local economy or heritage.

Raja Muzaffar Bhat, an environmental activist, said chinar trees are a heritage of Kashmir and if the government had to cut down these trees because of roadwidening projects or construction of flyovers, there is a provision of transplantation.

"Even if the trees are 300 to 400 years old, they can be transplanted. There is a tree transplantation policy in different states. The Delhi government has a policy for tree transplantation and they have transplanted 100-150 year old trees as well. So I don't think that the government should have any problem with transplanting or replanting chinar trees which were lopped around the Polo View area," Bhat said.

He cited the example of the first chinar transplantation done in February last year.

"The chinars could have been easily transplanted to different locations like the government did in the case of Ruplank island in Dal Lake," he added.

Athar Aamir Khan, Srinagar Municipal Corporation Commissioner who heads the Srinagar Smart City project, said the lopping was necessary and has been done after following all legal provisions.



"Smart City project cannot touch a chinar on its own and we did not. It has gone through a proper process, proper channel. At places where the committees and authorities concerned found that lopping or cutting of dried branches or removal of old dried chinar was required, they have done that," Khan said.

Khan said the Smart City project has given priority to maintaining ecology and safeguarding the trees.

"For us, ensuring that the ecology and the trees are safeguarded has been paramount. Polo View Market itself is a witness to that. So wherever we have laid footpaths, wherever any kind of work has been done, there is adequate space which had been left for the breathing space for trees so that they thrive. In addition to that, whether you look at the MA Road or Airport Road, you would see thousands of plantations have been done," he added.

Srinagar Airport Launches E-Carts For **Drop And Go Facility**

Srinagar: Airport Authority of India has introduced a "drop and go" facility at the entry to the Srinagar international airport to address "long standing" grievances from passengers about delays and hassles at the Airport.

According to the Airport Director, the facility, a complimentary one, would allow a passenger to leave their vehicles at the drop gate, then directly put their baggage on xray and after screening, they can board e-carts

stationed at Drop Gate. "There is a long-standing grievance from our passengers about delays and hassles for entry to the Airport at Drop Gate," the Director said in a state ment. The vehicle checking, baggage checking and personal frisking is a time consuming process and

this results in delays to the passengers seeking entry to the airport, he noted. 'Hassles are increasing to such an extent that we have to often advise the passengers to come to the airport four hours in advance so that they do not miss their flights," he said, "Despite such adding,

precautions there are frequent complaints that passengers are still missing their flights." However, he said there

would be no such delays and hassles with the introduction of the facility.

"We have introduced a Drop and Go facility at the entry to the airport. Our esteemed passengers can leave their vehicles at the drop gate, and the vehicles can go back to the city," he said, adding, The passengers will then

directly put their baggage on x-ray and after screening can board our e-carts stationed at Drop Gate."

Muezzin Murdered Inside Mosque

Brutality Gives Blood-Soaked Kashmir Another First

RINAGAR- In an indication of the heights, brutality has scaled in Kashmir, a 40 year old villager was done to death in a local mosque in a Shopyan village on Friday night, and his bleeding body left on the floor for the locals to discover.

The victim, Muhammad Yaseen, was the muezzin (one who gives the call for prayer) for the Harpora village, who at usual, had left home to offer night pravers in the local mosque.

Concerned when he didn't return by 10 pm, Yaseen's family set out to search for him and were told by sev-eral villagers that he had been seen at prayer in the mosque. When a group of people entered the premises, they found the

muezzin lifeless on the blood-splattered floor.

On being informed, the local po¬lice took the body for an autopsy. The police said that Yaseen, a farmer by profession, had been killed by a heavy, sharp-edged weapon, probably an ace, as could be judged from the wounds on his head.

The body was handed over to his family after a post-mortem and other police formalities.

The police has registered a case under section 302 and started investigation, but no arrests had been made when reports last came in.

Sources said that police had ob-tained some vital clues, and taken down the statement of several villag¬ers.

The police expects to unearth the facts about the murder in the coming few days.

The wave of grief swept across the village when the Yaseen's body was handed over to his family. Hundreds of people attended his funeral prayers, and staged demonstrations demand-ing the swift exposure of the killers

Top police officers have assured the family that the guilty would be arrested within the coming few days.

'End Of Justice': Imran Khan Says **Stage Set For His Court Martial**

ISLAMABAD: Pakistan's former prime minister Imran Khan has said the stage has been set for his "court martial" after the country's all-powerful army vowed to try the "masterminds and planners" of May 9 violence in military courts.

His remarks came a day after Interior Minister Rana Sanaullah accused Khan of planning the countrywide violence that erupted after his arrest in a corruption case on May 9.

Talking to reporters after appearing before the Islamabad High Court (IHC) on Thursday in connection with 10 different cases, including two ongoing petitions and eight new bail petitions, the 70-year-old Pakistan Tehreek-e-Insaf chief said he knew he would be tried by a military court.

He termed a civilian's trial in the military court as the "end of democracy" and the "end of justice" in Pakistan.

"The trial in the military court will be illegal," he was quoted as saying by the Dawn newspaper. "They knew that over 150 cases registered against me are baseless and there is no chance of my conviction in these bogus cases, therefore, they have decided to conduct my trial in the military court," Khan said.

Pakistan's powerful army on Wednesday vowed to tighten the "noose of law" around "planners and masterminds" who mounted a "hateripened and politically-driven rebellion" against the state.

Khan dispelled the impression of being sidelined within the party and also dismissed the rumours about leaving Pakistan.

"I don't have money to live in



any other country because the [UK] pound has crossed ₹400 and I can't afford to stay there," he said.

He also rejected the rumours of a "bitter" meeting with PTI Vice Chairman Shah Mehmood Qureshi and said that he has cordial relations with the former foreign minister. Earlier, Khan spent four hours in the office of the National Accountability Bureau (NAB) in Rawalpindi and replied in detail to the queries of the accountability watchdog in the Al Qadir corruption case.

It was Khan's second appearance in the case. During the last hearing, he was asked to provide further details regarding the questions asked by the NAB. In a setback to Khan, scores of disgruntled leaders who quit his party on Thursday launched a new political party to fight the general elections likely to be held in October. Sugar baron and Khan's old friend Jahangir Khan Tareen, who is leading the group of leaders announced the launch of the Istehkam-e-Pakistan Party (IPP) during a press conference in Lahore on Thursday. "We are laying the foundation of a new political party - Istehkam-e-Pakistan Party," said Mr Tareen, flanked by former PTI leaders. Tareen, who played a major role in the formation of the Imran Khanled government in 2018, said that he joined politics to play his role for the betterment of the country.

"We have gathered at one platform to make joint efforts to lift the country out of this quagmire," said Mr Tareen, who was disqualified for life after the Supreme Court ruled in 2017 that he was found guilty in assets beyond means case.

He said that the country needed a political leadership which could resolve all prevailing issues including social, economic and others.

Reacting to the launch of the new party, the PTI rejected it, saying the country's issues could not be resolved by launching parties with people who were "coming after forced divorces".

Street Harassment is not harmless, it perpetuates rape culture

he recent National Family Health Survey reveals that there has been an upsurge in violent crimes and sexual harassment against women in J&K. The survey report suggests that in 2019-2020, 9.6% women in the age group of 18-49 experienced domestic violence , and 1046 rape cases were registered during this year. These numbers are a grim reminder of the lopsided power dynamics which relegates a lower status to the women in our society. It is this position of authority and power which gives men a sense of impunity and license to get away scott free after committing heinous and barbaric crimes.

Uprooting patriarchy is the only way to end the systemic suppression that women face in our society. Change in social attitudes, coupled with a robust justice system can put an end to the myriad forms of atrocities that women face on a daily basis and make the society a habitable place for women.

Violent and unfathomable crimes do not emerge out of a vacuum, they are a consequence of ignoring and trivialising sexist jokes, catcalling, whistleblowing and groping etc. These behaviours exhibited towards women are not harmless, they create an environment conducive for men to assert their power over women and perpetuate rape culture. A society which tolerates any form of harassment (verbal pr physical) against women capacitates the harasser and gives him the confidence to disregard a woman's agency and violate her consent. An outcry against harassment is the first step in the long haul of subverting the rape culture that exists in our society. Refusing to accept it as something harmless is essential for reclaiming our agency and public spaces and moving around freely with calmness and comfort without the fear of being visually profiled and assaulted.Reports indicate that 50% of the women who face harassment chose not to report it and this is why no statistical survey can reveal the actual extent of the harassment faced by women in the society.

This reluctance to report harassment stems from the warped notion of honour that is fed to women from a very early stage. Young girls are conditioned to believe that harassment erodes their honour, it leaves them scarred, this stigma and shame attributed to the victim makes rape and harassment an instrument to control women, to subdue them and discourages women from speaking up.Eradicating the stigma and shame attached to the victim is essential to take this power away from men and empower women.The prevalence of victims shaming makes speaking up against harassment more morally reprehensible than harassment itself,



this needs to be countered.

The flailing justice system and the apathy shown by the law enforcement agencies dissuades women from reporting instances of harassment. Additionally, the burden of proof that rests on the victim makes seeking justice traumatic. The fear of harassment, harassment and the process of seeking justice are distressing and adversely impact women, their quality of life and their well being.In our society every woman is either a victim or a potential victim and has to live in trepidation and constantly tweak her choices to ensure her safety. We cannot claim that we live in a civil and democratic state if women have to be hyper vigilant whenever they step out.It is incumbent upon the state to play an active role in ensuring that women's rights are protected and their freedom of movement is not restricted

and that they are able to live life freely without fear. Apart from the effective implementation of laws that safeguard and protect women's rights, the government also needs to ensure that women are adequately represented in all spheres of the society, representation is the tool through which women can assert themselves and reclaim their agency, otherwise the only way women can ensure their safety is by being invisible in the public sphere.

The True Picture On The Economy

www.ith the release of recent economic data in India, there has been several attempts to dissect the data and interpret it in a variety of ways. There remains considerable disagreement regarding the state of the economy, its likely future trajectory, and recent economic performance. This disagreement is not new, but rather a function of different hypotheses and competing narratives.

Some might wonder how the same information can contribute to professional commentators, economists and policy wonks drawing different, often contrary conclusions. The existence of strong prior beliefs explains a part of the disagreement while the rest can be explained with the difference in the way information is processed by economists.

The optimists, for example, would point out that India's economic growth came in at 7.2% in the last financial year—an impressive achievement as it makes the India as the fastest growing major economy of the world. The pessimist might point at low tractor sales or muted consumption growth. Both of these are important and true data points—but some might focus on the former while others might focus on the latter.

Another example is for people to compare the annual growth rate for the last three years and conclude the average growth rate to be just 3.28%. Again, this is true, but incorrect from an analytical standpoint, given that 2020-21 was the pandemic year with lockdowns imposed not just in India but across much of the world. What would have been more meaningful is to compare India's average growth rates during the last three years as a ratio of average growth rates or the median growth rate of emerging markets over the last three years. The result would be a ratio greater than 1, which shows that India's growth process has been rather good.

It is likely that much of the disagreement regarding the health of India's economy originates from priors, which also influence the way professional commentators process information. As a

result, the disagreement among experts has been widening. Public discourse, unfortunately, is collateral damage, as unassuming consumers of public debate are effectively left more confused while some end up just reconfirming their priors.

Not surprisingly, strong priors have led to bias proclamations and forecasts for the Indian economy—many of which have been found to be incorrect, inefficient, and inconsistent. The fact that many such forecasts have now been ridiculed diminishes public confidence in experts, which tends to have unintended consequences. Needless to say, this disagreement among experts will only intensify over the coming months as two competing economic narratives are constructed purely to serve political purposes. In the process, we will see many "experts" deviate from well-established analyses attempting to be too creative in their interpretation of statistical data. It is therefore important to distinguish the reality from these narratives and explore the current state of the Indian economy.

In terms of sheer numbers, the Indian economy has indeed performed well post the pandemic. Much of this growth recovery has been led by investments, more so, public investments. That is, government building roads, highways, airports and other infrastructure. This is desirable given the sheer infrastructure gap that existed in India adding to overall logistics costs for businesses.

The bulk of these investments are being financed through domestic sources, which implies domestic savings. One of the effects of the pandemic on household balance sheets was either increased borrowings or reduction in savings. Some households who could not consume due to lockdowns saw an increase in their savings. To focus on aggregate effect would be misleading given the distributional consequences .

Those with surplus savings are now spending, while those with depleted savings are now building them back. This is what is influencing the consumption patterns that are visible in the economy at the moment, with high consumption growth in tourism and related services sectors and an aggregate of 2.8% consumption growth in Q4 of FY 2022-23. There is a process through which households have started to restore their balance sheets, and this process is likely to continue through the first two quarters of the current financial year. No surprise that some see consumption slowdown. However, if you talk to people in the hospitality sector, they are operating at a higher capacity than prior to the pandemic. Two competing narratives-yet, the reality is closer to the latter.

It is a fact that despite a sharp monetary tightening over the last few months, the Indian economy has managed to grow at above 7% while simultaneously easing inflationary impulses. It is also important to point out that the government of India and the finance ministry deliberately desired to engineer an economic recovery driven by investments post the pandemic. Their policy prescriptions have been successful in achieving that objective, as revealed by the data released last week.

KO INTERVIEW DAVIDLEPESKA An American Journalist Lays Out Lively Kashmir Journey

WARD-winning American journalist David Lepeska's first full-time reporting job was for the Kashmir Observer, from the summer of 2006 until mid-2007. His new book, Desiccated Land: An American in Kashmir, highlights the time he spent in Kashmir and his KO reporting from that period, alongside personal and geopolitical observations about South Asia.

KO: The book is a blend of reportage, memoir and travelogue. How did you arrive at this unique way of telling the Kashmir story? And how did you approach weaving these disparate elements together?

David Lepeska: Well, it wasn't easy. It all started when KO editor Sajjad Haider came to me in the summer of 2020 and said that Kashmir Observer's 25th anniversary year is coming up and we want to release a few books in conjunction with that. He said his initial thought was collecting my writing for the paper and he'd talked to a publisher who expressed interest.

My immediate thought was, well, we can't just put 15-year-old news reports and features together in a book. It would need some context, to present it to the reader in a way that sheds light on how they were created, the circumstances, the personal journey, the reality. What did these writings mean at the time and what do they mean now?

I remembered that while I was living in Kashmir I'd kept a personal blog. That was the age of the blog — long before podcasts. So I was blogging every week, maybe every few days, and I dug up a handful of those old blog posts and put them alongside my Kashmir Observer reports from 2006-7 and they helped flesh out the reality of that time in Kashmir.

seemed the only way to do this: sharing the old KO articles, showing my life at that time and explaining how I got to that point and how Kashmir got to that point, by intertwining my personal story with the history of Kashmir. I also examine how my experiences and Kashmir's reality fits into my broader worldview. Does it work, as a book? I've gotten some good feedback, so I feel like I did okay. I hope people give it a chance.

In your book you detail how you were drawn into journalism by 9/11, wanted to find a Muslim region to report from, and ended up coming to Kashmir and Kashmir Observer – in part because you had visited Kashmir years before as a tourist and enjoyed your time here. So, upon returning to Kashmir as a journalist in 2006, what were your impressions? Did the Valley and its people seem different once you lived and worked here? What stood out about your initial weeks reporting for Kashmir Observer?

Of course I found Kashmir beautiful. The food was fantastic. The people were so kind, helpful and warm. I felt close to everybody almost immediately. Those were my first impressions And then I started my work at Kashmir Observer. Sajjad was very open and helpful and just made me feel comfortable and welcomed. And I remember being surprised about how calm everybody seemed in the office at Kashmir Observer. Also about the journalism community in general, that whole community of people. Coming from the West, I expected Kashmir to be a very high pressure place, a very stressed out and anxious place, because of the regular violence, the persecution and the constant trauma. Just the inability to control one's situation, the inability to find relief, to ensure security and stability, for yourself and your family and your community. Being an American, I imagined all that would be absolutely debilitating, paralyzing mentally and emotionally. But of course, unless you find a way to accept that, you're just going to go crazy. You're gonna be incredibly stressed and anxious all the time and it's gonna keep you from doing anything productive, from having a real life. So within a few weeks I came to realize that Kashmiris had found a way to adapt to a difficult, high stress, high pressure, impossibly traumatic environment. It taught me a lot about being a reporter, especially in conflict zones and dangerous and difficult situations, and just a human being dealing with trauma.

As I explain at the end of the introduction that a century ago, 80 years ago, America held so much promise for the world. Everybody saw my homeland as the shining beacon of democracy and millions of people emigrated there. But in the end, the US largely disappointed the world — undermining and eroding democracy and the rule of law and inciting violence, toppling governments, and so on. The unjust invasion of Iraq, the destruction in Afghanistan and Libya and beyond. Many would describe the US in recent days, in the post-Cold War era, as a global failure. It failed to live up to its expectations, its ideal of exceptionalism , and in doing so damaged the world.

So, as some people talk about "the Indian century," I hope to show Kashmir as a potential lesson for Indians. So that's one thing I want Indian readers to take away, avoiding the troubled course America has taken.

The book is titled Desiccated Land — a reference to the ancient myth of Kashmir's origin being a result of Balarama clearing a path through the mountains to allow the water to flow out of the beautiful lake, Satisar, and kill the water demon, Jhalodbhava. Kashmir today remains a beautiful, if troubled place. So is this title meant to refer to Kashmir, or to something, or somewhere, else?

The title does refer to this myth, this origin

incredibly well read and eloquent Kashmiri. There just aren't many of those left today, sadly. So he was kind of a throwback to an earlier era for Kashmir.

Also, he was a kind of a social center, a social hub. Almost every week he would have people over to have drinks and talk politics and art and culture and books and eat and just have a fantastic time. Just socializing and connecting. There's very little of that in Kashmir, It's not like Kashmir has wild nightlife or fancy restaurants. People generally keep their heads down. They don't want to get into trouble. They don't want to make a lot of noise. They rarely have big gatherings. Not that his gatherings were big but, you know, 8-10 people getting together and talking and having great conversations and connecting and understanding each other. Rare and wonderful. Beyond that, he was terribly good fun. He was an incredibly vibrant and energetic man, even when I knew him at age 81, 82 - so full of life. Every moment he had something interesting to say. He wanted to eat incredible food, read the best books, have the best conversations. He fizzed with interesting thoughts and random ideas. One day for no good reason he just started calling me Professor of Honolulu. I guess it just rolled off the tongue and had a nice ring to it. From then on it was "Hello, Professor!" every time I visited. That to me just kind of highlighted his energy, his verve, his love for life and interesting people. I like to think I have some of that verve myself, so there was a personal connection.



So you've got the Kashmir Observer reports, you've got my blog posts from that period, and then to explain it all, to add context and insight, I added a good deal of new writing — the introduction, the epilogue, little intros to the chapters and some of the articles. The book contains 50-60 pages of new writing, almost a quarter of the total, so the reader bounces back and forth between the past and the present, hopefully learning about both as they go.

The late educator Agha Ashraf Ali, to whom you dedicated the book, seems to have had a big impact on you during your time in Kashmir. You wrote a lengthy profile of him for Kashmir Observer. What about him stands out to you? What does he mean to you, or represent Kashmir?

> First and foremost he was just deeply interesting. He was kind of a remnant of a Kashmir that has largely passed — well educated and well-traveled and accomplished and a raconteur. He knew so many people, spent time with Gandhi-era Indian

You have not been to Kashmir since your last visit in 2008. Why?

The opportunity hadn't come up to return to Kashmir, to return to India. It was always in my mind. I've kept in touch with people there. Now I've done this book, and I've been planning for the last year and a half to come to Kashmir.

What message do you hope readers take away from Desiccated Land and how do you want it to contribute to the broader conversation about Kashmir and its future?

Well, first, the book is mainly intended for readers outside Kashmir. Of course, I want Kashmiris to read it, and I think they'll enjoy it. But I also think Kashmiris know much of what's in this book. I mean, if I've done a good job, this book presents their daily lives. It may feel good and humanizing to see their stories told on the page, but as I said the book is primarily aimed at people in mainland



story, and to the idea that Kashmir was a paradise that has been desiccated, destroyed. After that it was built up again into a paradise, and lost again. That's the story of Kashmir, over and over, and it all starts with that origin story.

Second, it's a reference to how outsiders, conquerors, and rulers — almost all of whom were not Kashmiris — have persistently over the centuries desiccated Kashmir.

Lastly, as I touched on in my previous response, it also refers to my homeland, to the United States, which has long been seen as this beacon of democracy, this shining light, American exceptionalism and all that. But it has largely disappointed. My country has shown its principles to be largely hollow. Many Newborns Dying Due To Loss Of **Efficacy Of Antibiotics Against Sepsis: Study**

any newborns are dying because the antibiotics used to treat sepsis are losing their effectiveness, according to a global observational study which involved over 3,200 newborn babies suffering from the infection in 11 countries, including India.

The study, conducted from 2018 to 2020 and co-authored by a team of over 80 researchers, found there was high mortality among infants with culture-positive sepsis (almost 1 in 5 across the hospital sites), and a significant burden of antibiotic resistance.

The research, published on Friday in the journal PLOS Medicine, provides a wealth of high-quality data aimed at improving the treatment of newborn babies with sepsis.

"It was very important to undertake this study to get a better understanding of the kind of infections we are seeing in newborns in hospitals, the bugs causing them, the treatments that are being used and why we are seeing more deaths," said Manica Balasegaram, Executive Director of Global Antibiotic Research and Development Partnership (GARDP).

"The study has given us vital information which will help us to better design clinical trials and ultimately improve the care and outcome of babies with neonatal sepsis," Balasegaram said.

Sepsis is a life-threatening bloodstream infection which affects up to 3 million babies a year globally. Every year, 214,000 newborn babies, mostly in low- and middle-



income countries (LMICs), die of sepsis that has become resistant to antibiotics.

Newborn babies are particularly at risk of severe infection because of their underdeveloped immune systems.

"One of the study's most striking findings is the wide disparity in deaths from neonatal sepsis, depending on where people live," said Nishad Plakkal, Additional Professor of Neonatology and Associate Dean (Research) at JIPMER, Puducherry.

"It's not unusual in my unit for one nurse to take care of five or six very ill babies at one time. This makes it easier for infections to spread," Plakkal said.

There was extensive variation in mortality between the 19 hospitals in the study, ranging from 1.6 per cent to 27.3 per cent, with markedly higher rates in LMICs, the researchers said.

"The study exposed the glaring reality of antibiotic-resistant infections, especially in hospitals in LMICs, where we are often faced with a shortage of nurses, beds and space," said Sithembiso Velaphi, head of paediatrics at Chris Hani Baragwanath Academic Hospital in Johannesburg, South Africa.

'The risk of infections is very high and most infections are resistant to antibiotics. If an antibiotic doesn't work, the baby often dies. This urgently needs to change. We need antibiotics that will cover all bacterial infections," said Velaphi, More than 200 dif-

ferent antibiotic combinations were used by hospitals in the study, with frequent switching of antibiotics due to high resistance to treatments.

Many physicians were forced to use antibiotics such as carbapenems due to the high degree of antibiotic resistance to the recommended treatments in their units. These are classified by the World Health Organization as "Watch" antibiotics.

They are recommended only for specific, limited indications as they need to be preserved. However, these were often the only antibiotics available to treat the infection.

Last-line antibiotics were prescribed to 15 per cent of babies with neonatal sepsis enrolled in the study

Using the data collected, the team developed two tools that could be used in clinical trials and in any neonatal intensive care unit worldwide.

The NeoSep Severity Score, based on 10 clinical signs and symptoms, could be used by clinicians to identify newborns who have a high risk of dying, and ensure they get special attention more quickly, the researchers said.

The NeoSep Recovery Score uses many of the same clinical signs and symptoms and could provide clinicians with key information on whether to escalate treatment, they said.

'The observational study has been instrumental in providing the high-quality data that we need to design trials of appropriate treatments for sepsis in newborn babies. It has been a huge collaborative effort by researchers and clinicians in Africa, Asia, Latin America and Europe," said Neal Russell, Principal Investigator for the neonatal sepsis study at St George's, University of London (SGUL), UK.

The study also aims to inform WHO guidelines on treatment for newborn babies with sepsis.

The results of the study have been used to design a pivotal strategic public health clinical trial to find better treatments for newborn infections in the context of increasing resistance to existing treatments.

The trial will also look at appropriate formulations and dosages for newborn babies. It will be expanded to other countries and regions from 2024, with a target of recruiting up to 3,000 newborns overall.


Billions In Frozen Iranian Assets To Be Released From Iraq And South Korea

ED Issues Notices To Xiaomi, 2 Senior Executives For FEMA 'Violations' To Tune Of Rs 5,551 Cr



NEW DELHI: The Enforcement Directorate (ED) on Friday said it has issued show-cause notices to the Indian arm of Chinese mobile phone manufacturer Xiaomi, its chief financial officer and director Sameer B Rao, former managing director Manu Kumar Jain and three foreign banks for alleged violations of the foreign exchange law to the tune of more than Rs 5,551 crore.

The Adjudicating Authority (of the Foreign Exchange Management Act) has issued the notices to Xiaomi Technology India Private Limited, the two executives, the CITIbank, the HSBC bank and the Deutsche Bank AG under section 16 of the FEMA, the federal agency said in a statement. A show-cause notice is issued after the completion of a FEMA probe and once it is settled, the accused may have to pay a penalty that could be three times the amount contravened.

The authority, while confirming the seizure, held that the ED is right in holding that foreign exchange equivalent to Rs 5,551.27 crore has been transferred out of India by Xiaomi India in an unauthorised manner and is held outside India on behalf of the group entity in contravention of section 4 of the FEMA, 1999 and the same is liable to be seized in terms of provisions of section 37A of the FEMA." it said.

Rajouri Experiencing Apricot Boom; 511 Hectares Of Land Under Farming

JAMMU: Jammu and Kashmir's Rajouri is experiencing a boom in apricot farming, with an annual yield touching 2,500 metric tonnes of fruit from 511 hectares under apricot production, officials said. The border district is also experiencing an increasing trend among progressive farmers opting for apricot production.

"At present, 511 hectares of area is under the apricot production in the district bearing an annual production of 2,500 metric tonnes of fruits," Chief Horticulture Officer (CHO), Rajouri, Madan Lal told PTI. He further said that several progressive farmers are opting for apricot production.

"Apricot is an important fruit crop of the intermediate region of Jammu Division. In Rajouri, it was grown traditionally with old local varieties but with the introduction of quality plant material and with proper guidance by the department of horticulture Rajouri, the production and quality of apricot fruit has increased in manifolds," Lal said.

Qumar Rubani -- a resident of Aitti, Rajouri -- has set an example of becoming a successful orchardist by planting 250 apricot plants during the



year 2016-2017, producing approximately more than 1.5 metric tonnes of fruit every year.

"During the year 2021-22, he has earned more than Rs 5 lakh from his orchard," the CHO said.

"This crop matures earlier than all other fruits produced in Rajouri, thus, providing better income to the farmers.

'There is immense potential of the horticulture and allied sectors in Rajouri and farmers need to embrace and benefit from the government schemes available to them," Khan said.

Lucknow Court Shooting: 2 Police Teams Formed, Security Tightened At Court Premises

Lucknow: Two police teams have been constituted to investigate the murder of gangsterpolitician Mukhtar Ansari's aide Sanjeev Maheshwari Jeeva here, while steps have been taken to tighten security at court premises in the wake of the incident, a senior police officer said on Friday.

Jeeva (48) was shot dead on the premises of a Lucknow court on Wednesday, police said. A policeman and a two-year-old girl were injured in the incident.

"Two teams with four policemen each have been formed for prompt and successful disposal of the investigation of the case registered at the Wazirganj police station here," Joint Commissioner of Police (Law and Order) Upendra Aggarwal told reporters.

Wazirganj police station incharge Manoj Kumar Mishra will head the investigation, he said.

"The second team constituted for technical assistance includes Rajdev Prajapati, in-charge of the surveillance cell, western zone with three others," Aggarwal said.

Apart from this, Inspector Ramphal Prajapati has been assigned the task of making adequate security arrangements

Bench, the officer said. He said an application will be moved in court on Saturday over the police custody of the accused

The senior police officer said a meeting was also held with lawyer organisations on Friday and a consensus was reached on several points regarding security on court premises. There will be separate entry gates for officers and advocates besides

other elaborate security arrangements, he said.

"Steps are being taken to ensure security in court. We also held a meeting with the Central Bar Association and the members have assured their cooperation in this process," he said.

Meanwhile, the police have increased the number of police personnel deployed in the district and sessions courts, and installed metal detectors at every gate.

Lawyers coming to court now

have to show their identity cards and are frisked by police officers. The alleged assailant, identified as Vijay Yadav (24), a resi-dent of Jaunpur district, was caught on the spot after the shooting took place right outside a courtroom, police said. Eyewitnesses said the assailant was dressed as a lawyer and fired around six shots. Uttar Pradesh Chief Minister

Yogi Adityanath has directed the formation of a three-member Special Investigation Team (SIT) to probe the incident.

The assailant opened fire when Jeeva, who was serving a life term in a Lucknow jail, was brought to the court for hearing in a case, police officials said.

A resident of Muzaffarnagar district in Uttar Pradesh, Jeeva is an accused in the murder cases of Bharatiya Janata Party (BJP) MLA Krishnanand Rai and former state minister Brahm Dutta Dwivedi as well as in 22 other cases, including those of fraud and criminal conspiracy.

Meanwhile, chief medical superintendent of King George's Medical University Trauma Centre said the girl, who was shot in the incident, has been successfully operated and the bullet has been removed.

Activists stand in solidarity with Umar Khalid as he completes 1,000 days of incarceration in Delhi riots case

New Delhi: Scores of students, civil rights activists and media personalities gathered here on Friday to express solidar-ity with former JNU student leader Umar Khalid after he completed 1,000 days of incarceration in the 2020 northeast Delhi riots case.

The activists gathered at the Press Club to talk about 'Democracy, Dissent and Censorship', saying Khalid's 1,000 days of imprisonment equals to "1,000 days of resistance".

The event was earlier sched-uled to be held at the Gandhi Peace Foundation, but the activists claimed police forced the venue managers to cancel their booking.

Khalid was arrested by Delhi Police in 2020 and charged under the Unlawful Activities (Prevention) Act (UAPA) and provisions of the Indian Penal Code. Police claimed he was the mastermind of the northeast Delhi riots which had left 53 people dead and over 700 injured.

Rashtriya Janata Dal (RJD) leader and Rajya Sabha MP Manoj Jha said, "This is 1,000 days of imprisonment as well as 1,000 days of resistance. Umar Khalid will be very happy to know that in this scorching heat, hundreds of people gathered to defend democracy.

"This solidarity is not just for Umar, but for every political prisoner. This is a fight of

memory. A dominant memory is mainstream today, while the memories of marginalised communities are ignored," he said. journalist Ravish Senior Kumar said the road to the door of justice has been stretched too far for those like Khalid. "Remember 1,000 days that

have passed. Remember that these are not just 1,000

days since Khalid's incarceration, but also 1,000 days of

shame for the Indian judicial system," he said.

Present at the event was also Khalid's father S Q R Ilyas who said the confines of the prison walls has not dampened the

spirit of his son. "Has 1,000 days of jail dented Umar's confidence, has it dampened the spirits of his friends? Absolutely not. When see all those who have been jailed during their court hearings, I see confidence in their faces, they know that they are in jail for a cause," he said.

He said his son is fighting for the country and democracy.

Ilyas demanded the release of all 'political prisoners', including his son, Sharjeel Imam, Khalid Saifi, Shifa Ur Rehman and others.

On the row over the event's venue, Supreme Court advocate Shahrukh Alam said the venue was cancelled following an intervention by the Delhi Police.

"We were told Delhi Police gave a notice to the management of the earlier venue that the booking should be cancelled. They did not quote any sections under which the order was made," she claimed.

Khalid, who completed his PhD on tribals in Jharkhand Jawaharlal from Nehru University (JNU), was arrested on September 14, 2020.

Ilyas said Khalid was not in Delhi when the riots took place, but the police refused to accept it as "evidence of his innocence"

Meanwhile, RJD MP Manoj Jha also slammed the BJP-led Centre over the sedition law.

"Now the Law Commission is recommending that more stringent punishment should be given under the sedition law... That would mean those who cannot be targeted by agencies like the CBI and ED will be booked under the UAPA to crush dissent," he said.

Opposition parties, including the RJD, have been alleging that the Union government is misusing probe agencies like the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED) against their leaders

Prabhat Patnaik, Professor Emeritus, INU said the continued detention of Khalid is not just a personal tragedy, but "social waste" of a talent.

After informing about her pregnancy, Shaista was showered with congratulations, visits, and well-wishes. "but after my miscarriage, the support and attention from friends and family quickly dried up." she said. "Nobody asked me how I felt. Instead, I was told that I broke the news of my pregnancy too quickly and invited bad luck."

It isn't a woman's fault!

When an unborn baby dies, society often reacts differently than the loss of a healthy baby, remarked Nelofar (name changed), who has had two miscarriages in a span of five years. "The thing with miscarriage is that most people don't realise what we have actually lost. They don't understand the intensity of our grief," she said, adding that people think the loss is not significant since the baby was not a 'real' person.

For Nelofar, the burden of being unustly accused and blamed for the loss

atmosphere of shame and silence surrounding the topic," he said.

He added that it can be challenging for a woman when those around her fail to recognize the depth of pain. "This lack of empathy can leave her further isolated and misunderstood. It makes it more difficult for women to open up and seek the support they need

The myths persist

"This must have been a son," Filory Jan, recalled being told after her medically advised abortion following a non-viable pregnancy in the first trimester. "The insensitive remarks and the false beliefs in Kashmir make it worse for us. I was told that I would never be able to conceive again and I had started to feel hopeless," until she gave birth to a healthy baby girl two vears later.

It is not limited to this, as some women also reported encountering dietary myths that suggest certain foods

emotional distress can potentially affect hormone levels, disrupt the normal functioning of the reproductive system, and potentially contribute to complications in pregnancy. "Society keeps on forcing a woman to have kids, but they must know that it is very important for a woman to be mentally fit to be able to conceive again after a miscarriage.

Waseem Kakroo also emphasized on the need to provide a non-judgmental space to women. He suggested promoting open conversations and educating people about the emotional impact of pregnancy loss as a way to assist them in finding healing and resilience.

Her sister's marriage was scheduled shortly after she conceived for the first time, and she couldn't help but notice the insinuations made by her in-laws, implying that her miscarriage was due to her involvement in the wedding preparations. "I was labelled as careless for not being able to take care of my pregnancy," she said. She confessed lingering on the bathroom floor for hours and crying freely without any judgement or interruption, as she was often told, "tchea osuy ne zyad time gomut, thaw wani aith seith bihun (you weren't pregnant long enough, stop holding on to the grief too much)."

The data from the National Family Health Survey for 2019-21 reveals that 8% of foetuses are lost due to abortion, miscarriage, or stillbirth, whereas 92 percent of pregnancies result in a live birth in Jammu and Kashmir. The most prevalent type of foetal wastage is a miscarriage, which accounts for 5% of all pregnancies, and abortions, which account for 2%. Globally, about 1 in 10 women will have a miscarriage over a lifetime. According to a series of articles in The Lancet, an estimated 23 million miscarriages occur every year, translating to 44 pregnancy losses each minute.

In a simple yes or no poll on Yakjut - a facebook group exclusively for Kashmiri women, out of 23 women who participated, 18 reported to have suffered from a miscarriage or an abortion due to medical needs. Despite the high incidence, miscarriage is still a hushed topic in Kashmir that is often associated with secrecy, taboo and shame. The stigmatisation, where the mother is largely held responsible for miscarrying leads to emotional distress and anxiety among the women.

Waseem Ahmad Kakroo, a clinical psychologist based in Kashmir believes that miscarriage is a deeply personal and emotional experience for women and their partners. The loss of a pregnancy can bring about a range of intense emotions such as grief, sadness, guilt, and even feelings of failure, "however, societal attitudes and cultural beliefs often contribute to the perception that miscarriage is a private matter and should not be openly discussed. This can create an or eating habits can cause miscarriages. "People who visited me during those days frequently enquired if I had eaten bananas or tomatoes. Had that been the case, my doctor would have advised me to avoid consuming certain things," Filory said. In her view, misinformation about pregnancy could be more harmful than helpful. She did her own research and talked with her healthcare provider, and learned that the vast majority of miscarriages are caused by genetic or developmental issues, and that no single food or behaviour can completely prevent or cause a miscarriage.

The confluence of infertility, stress and miscarriages

According to the National Family Health Survey for 2019-21, Jammu and Kashmir has the lowest fertility rate in the country, with a 0.6 percent decrease in the fertility rate from the last survey in 2015-16. This only compounds the challenges that women who experience miscarriage face. Miscarriage can be an isolating experience under any circumstances, but in a society where childbearing is viewed as central to women's roles and identities, the emotional impact of miscarrying a baby can be especially difficult to navigate.

"Because of the high infertil-ity, women may feel pressured to carry pregnancies to term, which can heighten their disappointment and frustration when a miscarriage happens," another woman who has experienced recurrent miscarriages and is trying for a child, said.

According to Dr. Munaza Farooq, an Obstetrician and Gynecologist working at Sher-i-Kashmir Institute of Medical Sciences, health factors such PolyCystic Ovarian Syndrome (PCOD), obesity, torch infections and sedentary lifestyle are associated with the risk for miscarriages. "These factors can give rise to certain metabolic disorders like diabetes and thyroid which in turn can contribute to miscarriages," she said.

"Not just biological and medical reasons, social factors also play a role," she told Kashmir Observer, adding that high levels of stress, anxiety, or Chief of Army Staff and General Officer Commanding in Chief Commendation Cards twice, an apt recognition of his selfless and distinguished service, the spokesperson said.

A seven years old girl, Surat Jan daughter of Mohammad Ashraf from Mitragam, Kulgam in south Kashmir was seriously injured by stray dogs outside her makeshift home. She was admitted at Children's Hospital Bemina here.

Annoyed by the huge population of dogs in his area, another elderly man from Shalimar area in Srinagar was arrested for tying a stray dog to his twowheeler with a rope and dragging it down the Fore-Shore Road in April this year.

According to the data, nearly 5000 dog bite cases have been reported to Anti Rabies Clinic in Kashmir, with nearly 4,000 such cases reported from Srinagar city alone.

When contacted, Commissioner Srinagar Municipal Corporation (SMC), Athar Amir Khan said that two sterilization centers have been set up in Srinagar.

Not only this, the court referred to its Division Bench observation in a case in which it has been held that that it is not necessary that a person in possession of the immovable property of migrant ought to be in illegal or unauthorized possession as neither Section 3 nor Section 4 contemplates about the nature of possession of immovable property belonging to migrants, "meaning thereby that immovable properties belonging to migrants shall be deemed to be in possession of District Magistrate irrespective of the nature of possession of any person other than the migrant himself.

at 151 for five in response to Australia's 469, managed to score 109 runs in the 22 overs bowled in the first session.

The way Scott Boland and Cummins got the ball to kick off length in the first hour, one could sense a wicket off every ball.

Boland ripped through the defense of KS Bharat on the second ball of the day as the Indian wicketkeeper had no answer to a ball that jagged back in sharply

from length.

Cummins looked equally threatening from the other end and hit Thakur's forearm on back-to-back balls with extra bounce, forcing the batter to seek the physio's intervention.

Like Thakur, Rahane too had luck going his way as he was dropped by David Warner at first slip when he was on 72.

After getting a few streaky boundaries, Rahane got to his fifty with a spectacular six off Cummins over fine leg. The Australian skipper angled one into his body and Rahane made room to pull it for a maximum.

His best shot of the morning was a cover drive off Green, and it came after a thick edge that flew over the slip cordon, showing that one had to take his chances on this wicket.

The final moments of the session were full of action. Rahane got consecutive fours off Nathon Lyon via a back foot punch and a crisp drive through the cover.

The last over before lunch saw Thakur being adjudged lbw but it ended up being a no ball from Cummins. The Aussie skipper had also overstepped after trapping Rahane in front of the stumps on day two.



Latest 'Deadline' Looms In Man Utd Takeover Saga

LONDON: Manchester United fans can be forgiven if they refrain from eagerly checking the news on Friday as the latest "deadline" looms in the meandering seven-month saga of the club's sale that is beginning to resemble the final series of TV's Succession.

In this real-life battle of the billionaires, Qatari Sheikh Jassim bin Hamad al-Thani and Briton Jim Ratcliffe have each seemingly taken turns to be the preferred bidder, but in what has been something of a vacuum of confirmed news, and against virtual silence on the matter from the club, almost their every move comes with the caveat of "reportedly." Britain's Daily Mail said this

week that Sheikh Jassim, the son of a former Qatar Prime Minister, has made a "fifth and final" offer of more than five billion pounds (\$6.28 billion) for total control of the club, with a deadline of Friday, after which he will not enter any further negotiations. That comes two months after a "third and final offer" was said to have

been tabled. Representatives of the Sheik did not reply to Reuters' request for clarification of their current bid status on Friday, as The Guardian reported that the bid would remain on the table beyond the deadline. The current owners, the American Glazer family, initially invited

bids for United, arguably still the biggest "brand name" in the world's most popular sport, in November.

Media reports in the UK suggested that the Glazers are seeking six billion pounds (\$7.5 billion), which would be a world record for any sports club or franchise, but that neither bid is that high.

Representatives of both bidders met officials from Raine Group, the American banking operation overseeing the sale, at Old Trafford in March and were given access to details of the club's finances, after which both sides made second, improved bids. Further bids followed, up to the Qatari's earlier this week, which is said to include clearing nearly a billion pounds of club debt and a commitment to a major redevelopment of Old Trafford.

Manchester-born Ratcliffe, who owns clubs in France and Switzerland as well as the Ineos Grenadiers cycling team, is "reported" to be the preferred bidder at the moment, potentially because his plan would allow Ioel and Avram Glazer, the executive co-chairmen, to retain a 20 percent stake for an undisclosed time period. Britain's Times newspaper reported last month that Ratcliffe is set for "final talks" with the Glazers and Raine Group, who did not comment on the current status of the deal when approached by Reuters on Friday.

Man City, Inter Milan Meet In Champions League Final Of Contrasting Club History

ISTANBUL: Manchester City will enter the Champions League final on Saturday as a modern soccer and financial heavyweight compared to Inter Milan.

That is a new twist in the European history of two clubs who have rarely operated at the same level and whose respective status, on and off the field, flipped about 12 years ago.

Inter had the aristocratic, storied tradition and trophies while City was an English thirdtier team when crosstown rival Manchester United lifted the iconic European Cup trophy in 1999.

"One is a kind of old nobility," European soccer consultant Olivier Jarosz told The Associated Press about Inter, "and one comes from a working-class family that has made a nice marriage with money." Yet both City and Inter were teammates on the failed Super League project in 2021, albeit for different

reasons. Loss-making Inter was seeking to avoid being left behind by English Premier League dominance; financial juggernaut City, backed by Abu Dhabi sovereign wealth, didn't want to be left out.

Abu Dhabi's petrodollars have been spent wisely so debt-free City goes to Istanbul for its second Champions League final in three years and fresh from sealing a seventh Premier League title in 12 seasons.

In the same era, Inter went through three owners, racked up record losses, won Serie A just once and did not advance through any Champions League knockout round until this season. Inter failed even to qualify

for six straight years. City's sustained success now sees it with the highest overall and sponsorship revenue of any club in world soccer last year, and the most expensive squad costing about \$1.3 billion in total. Inter earned less than half of City's income of about 730 mil-



lion euros (\$784 million) in 2022 and ran up a loss of 140 million euros, according to UEFA's latest industry analysis

The entire Inter lineup that started the second leg of its semifinal game against AC Milan cost less in total transfer fees than just one City player – 117.5 million euros (\$126 million) record signing Jack Grealish – in the team that dismantled Real Madrid one night later.

"(Inter) are in the Champions

League final despite the ownership, and Manchester City are in the final because of the ownership," Kieran Maguire, author of "The Price of Football," told the AP on Thursday.

It was very different for most of the 68-year history of what started as the European Cup and became the Champions League.

When Inter last won in 2010, the Nerazzurri had been European champion more often than City had played total games in the competition: three titles for Inter, two games for City.

Inter won back-to-back titles in 1964 and 1965 and reached two more finals in 1967 and 1972. Three UEFA Cup titles also were won in the 1990s when Serie A was still the best, richest and most fashionable league in Europe

Owned for most of this era by the Moratti family, billionaires in the oil industry, Inter also broke the world record transfer fee four times, including when it signed Brazilian striker Ronaldo from Barcelona.

City's only European Cup adventure lasted two weeks and ended in Istanbul in October 1968, eliminated by Fenerbahce in the first round. The European Cup Winners' Cup title was won the next season, but the club had no serious European status for decades

By 2018, when both were again in the Champions League groups, much had changed. City had just regained the Premier League title, a first coached by Pep Guardiola who was reunited with former executives from Barcelona and built a dominant team in the world's richest do-

mestic league. "The quality of (City's) decision-making is extremely high," said Maguire, who described Inter as "a classic case of random, unstructured ownership." Inter was sold first by Massimo Moratti into the control of Erick Thohir. a former owner in the NBA, and then in 2018 to the Chinese corporation Suning, which installed 26-year-old family scion Steven Zhang as chairman.

Suning is subject to global financial pressures and in 2021 shut down its Chinese club, Jiangsu, months after winning a first domestic league title.

This season, Inter Milan's stretched finances led UEFA to deduct 4 million euros (\$4.3 million) from its prize money. The club also paid 6 million euros (\$6.5 million) in 2015 for breaking "financial fair play" rules.

City also has two FFP punishments from UEFA – totaling 30 million euros (\$32 million) though evaded Champions League bans in cases related to having too much income, not too little. The club is currently fighting more than 100 charges from the Premier League related to alleged breaches of financial rules.


"For me, they are siblings," Jarosz, an executive with the LTT Sports consultancy, said of the two finalists. "You really have a very small pool of clubs who have the same financial capacities." Saturday's game is the third Champions League final since April 2021 and all those finalists since – Man City, Chelsea, Real Madrid, Liverpool, Inter Milan – were Super League members.

New Delhi: The prevalence of diabetes in India is 11.4 per cent, while 35.5 per cent of people suffer from hypertension, according to the findings of a nationwide survey published in The Lancet Diabetes & Endocrinology journal.

The study, conducted by the Madras Diabetes Research Foundation in collaboration with the Indian Council of Medical Research (ICMR) and other institutes, also found that the prevalence of generalised obesity and abdominal obesity in India stood at 28.6 and 39.5 per cent, respectively.

The results, assessing the burden of non-communicable diseases (NCD) across the states, are based on a survey of 1,13,043 (over 1.1akh) people (33,537 urban and 79,506 rural residents), in 31 states and Union Territories in the country, between 2008 and 2020.

The survey also showed that 35.5 per cent of Indians suffer from hypertension, 15.3 per cent of people have pre-diabetes, while an alarming 81.2 per cent have dyslipidaemia -- the imbalance of lipids such as cholesterol, low-density lipoprotein cholesterol, (LDL-C), triglycer-

Air India Operates India's First All-Women Haj Flight To Jeddah

Safe Diabetes Pill Metformin, **Reduces Long Covid Risk By 40 Per Cent Study Finds**

two-week course of the safe, affordable diabetes medication, metformin, following a positive Covid test could reduce risk of long Covid by 40 per cent over the subsequent 10 months, a study published in The Lancet Infectious Diseases journal found.

Participants chosen for the study were over 30 years of age, at a higher risk of severe COVID-19 because of being overweight or obese and had tested positive for SARS-CoV-2 within the last three days, with no prior Covid infection. The study, which included researchers from the Univer-sity of Minnesota, US, recruited

1,126 participants from December 2020 to January 2022 who were given either metformin or an identical placebo pill after they returned a positive Covid test. Follow-up data over the 10 months was collected through questionnaires every 30 days.

The study also found that 6.3 per cent (35 out of 564) of the patients administered with metformin reported a long Covid diagnosis over the follow-up period, compared to 10.4 per cent (58 out of 562) of those receiving placebo. The diabetes medication had been previously found to have prevented 40 per cent of emergency department visits, hospitalisations, and deaths due to COVID within two weeks of starting the treatment, compared to a placebo, the study said.

Long Covid, consisting of symptoms Covid infected patients face in the long-term, is an emerging chronic illness potenso that might be what is causing the reduction in both severe COVID-19 and Long COVID diagnoses seen in this trial," said coauthor David Odde, University of Minnesota biomedical engineer.
