After Its Recent Revival, Hokersar Is Now Swamped With Solid Waste

onths after the wildlife department had I managed to restore Hokersar Wetland to its earlier status following its degradation during the implementation of flood management project for the Srinagar city, the wetland is now swamped with heavy solid waste pollution.

The solid waste pollution problem in the wetland started after the trash guard (a wire mesh gate), which was installed at the spot where



water from flood spill channel flows into Hokersar for stopping trash entering into the

wetland, was destroyed by flooding as a result of incessant rains a few weeks back.

WISE USE OF WETLANDS IS THE MAINTENANCE OF THEIR ECOLOGICAL CHARACTER, achieved through the implementation of ecosystem approaches, within the context of sustainable development."

Solid waste, which includes household trash, wrapping materials, plastic containers and fast-food wrappers, can be seen floating everywhere in the wetland which not only bodes ill for ecological health of the wetland, but also presents an ugly scene. Even carcasses of

animals have also found their way into the wetland.

Locals said that they had noted the restoration of the wetland with great satisfaction following its almost complete degradation until last year as its ecosystem integrity and functioning had got hugely

compromised. "In recent months, Hokersar has got a new lease of life. We were happy to see a lot of birds and their chicks in Hokersar in recent months, something

which we had missed for many years. But, the waste which is now floating in it, poses a threat to the wetland," said Arif Ahmad, a milkman. He said that the trash gate

Srinagar: Family members and relatives of Banyari village in Bandipora on Friday staged protest in Srinagar's Press Enclave demanding impartial inquiry into the mysterious death of their kin.

A 15-year-old Shakir, who was a student at an orphanage on the outskirts of Srinagar, was found dead in mysterious conditions in Kunzer Baramulla Thursday morning

Talking to reporters, the deceased's sister said they received a distressing call from Shakir's teacher on Thursday at 8pm informing her that their ward was missing for several hours.

"We made several attempts to contact him, but

to no avail. Around 11:30 PM, we received another call informing us that Shakir might be in some area of Kunzer Baramulla. On Friday morning, his body was found in Kunzar Pattan under mysterious circumstances," she said.

"We had admitted him to a Trust two years ago so that he gets education as we were unable to afford tuition fees. Our dreams were shattered and we have lost our beloved little brother. Our brother has been murdered and we demand an investigation into it," she added.

The protesters appealed to Police and LG Manoj Sinha to personally intervene in the matter.

Police officials said that the investigation is underway in the case.

Kargil War Could Have Led To Nuke Attack: Book

Tashington - During the Kargil war, the Pakistan military had prepared their nuclear-tipped missile to fight back a possible Indian attack, and former US president Bill Clinton had informed about the military's move to the then Pakistani premier Nawaz Sharif. Bruce Riedel, a close aide of Clinton, has been quoted as saving this in a forthcoming book "Pakistan between Mosque and Mili¬tary" written by a Pakistani writer Husain Haqqani.

On learning about the military's plans. Sharif was taken aback and said that India was probably doing the same, writes Haqqani, a former Paki-stani diplomat, journalist and senior adviser to Pakistan's gov¬ernment. Presently, he is a scholar at the Carnegie Endow¬ment for International Peace in Washington.

According to the Dawn, Riedel further says: "Clinton asked Sharif if he knew how advanced the threat of nuclear war really was? Did Sharif know his military was prepar-ing their nucleartipped missiles? Was that what Sharif panted. Clinton asked? Did Sharif order Pakistani nuclear missile force to prepare for ac¬tion? Did he realize how crazy that was? You have put me in the huddle today, set the US to fail and 1 won't let it hap-pen. Pakistan is messing with nuclear war."

Riedel, a special assistant to Clinton and a senior direc-tor of Near East and South Asian affairs at the National Security Council in the Clinton era, says that he was present in the July 4, 1999, meeting between Clinton and Nawaz.

During the meeting, Clinton also raised the issue of Pakistan's reluctance to help the US catch Osama bin Laden and other al Qaeda leaders. "The president was getting angry He told Sharif that he had asked repeatedly for Pakistani help to bring Osama bin Laden to jus¬tice from Afghanistan. Sharif had promised often to do so but had done nothing. Instead the ISI worked with bin Laden and the Taliban to foment tenor-ism. Riedel adds.

The former US official re¬calls that Clinton's draft state¬ment on the Kargil crisis also mentioned Pakistan's role in supporting terrorists in Af-ghanistan and India.

Apparently hinting that Sharif had withdrawn troops under US' pressure, Riedel says that at the end of that meeting. Sharif agreed to announce i Pakistani withdrawal from Kargil and restoration or the sanctity of the Line of Control in return for Clinton taking a personal interest in resumption of the India-Pakistan dialogue

Japan Redefines Rape & Raises Age of Consent

apan has passed a law that changed the definition of rape to non-consensual sexual intercourse" from "forcible sexual intercourse", aligning its definition with those of other countries. The nation also raised the age for legal consent from 13 to 16. The previous laws dissuaded people from reporting cases where victims were coerced into having sex.

This led to inconsistent court rulings, fuelling calls for change. The new laws, which were passed by the upper house of the National Diet - Japan's parliament - on Friday outline eight scenarios where it is difficult for a victim to "form, express, or fulfil an intention not to consent" to sex.

A few of the scenarios include where the victim is intoxicated, or subject to violence or threats; or is "frightened or astonished". It also includes the situation where it might be an abuse of power, where the victim is "worried" about the consequences of refusal.

Writer Arundhati Roy has been award-ed the 45th European Essay Prize for lifetime achievement, the Charles Veillon Foundation has announced.

Roy has been awarded the prize for the French translation of her compilation of essays titled 'Azadi' (2021).

"The jury of the Prix Europeen de l'Essai wishes to highlight an enriching work in terms of reflection on the construction of the world and the relationship with language. Arundhati Roy uses the essay as a form of combat, analysing fascism and the way it is being structured. This is

an issue that is increasingly occupying our lives. Her essays offer shelter to a multitude of people," the Foundation said in a statement. The jury also acknowledged Roy's "commitment to political action".

In 'Azadi', Roy has reflected on the meaning of freedom in a world of "growing authoritarianism". The essays include meditations on language, public as well as private, and on the role of fiction and alternative imaginations in current times.

The Delhi-based author's works, including Booker Prize winning 'The God of Small Things', 'The Ministry of Utmost Happiness', and 'Mv Seditious Heart' have garnered her national and international acclaim.

Roy will receive the award, along with the prize money of CHF 20,000 (approx Rs

18 lakh), at a ceremony on September 12 in the Swiss city of Lausanne.

Since its inception in 1975, the award by the Charles Veillon Foundation has honoured a book or the work of an author "who, through their writings, contributes to nourishing and spreading the evolution of thought".

"It draws attention to authors whose work bear witness to and offer a fertile commentary on current societies, their practices, and ideologies," the foundation said.

Earlier, authors including Alexandre Zinoviev, Edgar Morin, Tzvetan Todorov, Amin Maalouf, Siri Hustvedt, Alessandro Baricco, Jean Starobinski, Iso Camartin, and Peter von Matt have been awarded the European Essay Prize.

MOSCOW: Russian President Vladimir Putin on Thursday lauded his "dear friend" Xi Jinping in a message for the Chinese leader's 70th birthday.

Putin told Xi "it is difficult to overestimate the efforts you have been making to foster the comprehensive partnership" between Russia and China, which have ramped up cooperation in recent years.

The two leaders have grown even closer as Moscow, isolated in the West since launching the offensive in Ukraine, has increasingly looked toward Beijing. Analysts say that China holds the upper hand in the relationship, and that its sway is growing as Moscow's international isolation deepens.

Putin said he expected the "constructive dialogue... to continue for the sake of the Russian and Chinese people". Xi was handed an unprecedented third term as president by China's rubber-stamp parliament in March.

The beginning of his term however comes as the world's second-largest economy faces major headwinds, from slowing growth and a troubled real estate sector to a declining birth rate. The re-election "confirmed your high political authority, and the wide support for the path you have chosen", Putin said.

"Under your leadership, the People's Republic of China achieved impressive successes: the economy is showing steady growth, the well-being of citizens is increasing, and Beijing's position in the world is strengthening," Putin said.

What won't Mr. Modi do to distort, disparage and destroy the name & legacy of the architect of the Indian nation-state. A small, small man overburdened by his insecurities is the self-styled Vishwaguru.'

This came after a special meeting of the Nehru Memorial Museum and Library Society, resolved to change its name to the Prime Ministers' Museum and Library Society. The Special Meeting was presided by Defence minister Rajnath Singh who is also the Vice-President of the Society.

SRINAGAR: Chief Secretary, Dr Arun Kumar Mehta on Friday released the 3rd edition of District Good Governance Index (DGGI 3.0) here along with performance of Districts in achieving a set of 385 Deliverables given to them during 22-23.

At the outset, the Chief Secretary praised the whole team of Planning Development & Monitoring Department headed by Administrative Secretary, Raghav Langar for carrying out this massive exercise and compiling rankings right from Panchayats up to District level.

Dr Mehta called this exercise path breaking for adopting an evidence based planning tool enabling targeted interventions. He said that it would assist the administration in evolving a more focused approach towards each sector. He observed that these rankings have helped pinpoint the lacunae in each area of development thereby making the impact of interventions measurable which would lead to better outcomes.

The Chief Secretary termed it a tool towards ensuring good governance in the UT. He urged all the Deputy Commissioners to thoroughly go through these rankings and formulate plans accordingly to fill the developmental voids pointed out in this ranking system.

The DGGI parameters to measure the performances of Districts consists of 58 indicators

with a score of 6.1799, Srinagar (6.0045) at 3rd, Rajouri (5.8696) at 4th, Bandipora (5.7651) at 5th, Anantnag (5.7110) at 6th, Budgam (5.4924) 7th, Pulwama (5.2814) 8th, Doda (5.2622) 9th, Ganderbal (5.2588) 10th, Baramulla (5.0285) 11th followed by Shopian (4.9446), Udhampur (4.9332), Kupwara (4.8881), Kathua (4.8179), Kishtwar (4.7800), Kulgam (4.6391), Ramban (4.6354), Poonch (4.4623), and Reasi (4.4608) at the bottom among the 20 Districts of J&K.

Similarly it gives insights about previous rankings and scores earned by each District during DGGI 2.0 as well. 




All About 'Good' Grades

Very hour one student commits suicide in India, an average of Twenty-eight students commit suicide every 24 hours during 2022. India saw 1.3 Lac suicides in 2022, of which students made up 8%, while 10% of them were unemployed people.

Imagine a situation where you are fed with the ill-notion that your grades and percentage scored will determine the kind of person you will become in life. Imagine that your academic score will determine the courses which you can opt for and the ones you can't, the colleges or educational institutions you will be admitted to or dropped out from. When the stakes are so high and when the entire course of your life seems to be determined by the examination you are sitting for, the reasons for getting stressed, anxious and even depressed are more than justified. It is not only about these facets of life that hinge on the pivot of grades, but to aggravate the matter, parental and peer pressure cumulates the existing stress and pushes students to the boundary, where, according to reports, "two-thirds (66%) of students reported that their parents pressurize them for better academic performance" and "every day, 6.23 students commit suicide due to peer pressure". These are no empty numbers to be brushed under the carpet, they are instead the most vital indicators of social health and have relevance in pointing out the direction we are headed towards - and unfortunately the direction is one of self-annihilation and the creation of suicide regime. These figures clearly reveal that education, instead of bringing intellectual liberation and social emancipation, is positing our kids against anxiety, depression and a host of psycho-social problems. A study on the question of high grades reports that "rates of anxiety, depression and even suicidal ideation have spiked dramatically, and academic stress tied to grades is a leading cause of this escalation". If human life has some worth and if it is agreed upon that life precedes and exceeds all grades, marks sheets and percentages, then the issues arising out of poor academic performance deserve a thorough revisit and in order to save our kids from the brunt of undue performance related stress, a deeper understanding of the students' issues has to be gained and an ambience is to be created which addresses the issue at its roots.

The incidents of students committing suicide after scoring low grades are scattered all across the search engines, so are the studies investigating the correlation between psycho-social disorders of various orders among the students and their academic performance. A reference to these has been made above, but what concerns us here are mainly the remedial measures and a change of mindset which engenders these negative episodes among students. The concern for grades and percentage consciousness starts very early in our lives when we witness the classmates scoring high re-



ceiving special treatment, being accorded a special place, presented as an example to the entire class and his/her ability to score good grades presented as a feat of extraordinary importance. On the other hand those. who score low are infamously bracketed as back-benchers and are deprived from dignity, self-esteem and a sense of purpose. Here, at the very beginning, a tune is set which programs the minds to think in terms of grades and percentiles, to associate the meaning of life with the quantum of marks, to evaluate individual worth and merit based on the grades and percentages scored. It is but obvious that a scenario like this can only foster a mindset which stakes everything on good grades and where even a minimal fluctuation in grades amounts to spike in stress and other disorders already discussed. Are our teachers aware of this brute fact and do they understand the precedent and the consequences thereof they set by their words and deeds? If our teachers, the ideals and the most cherished figures in our academic hierarchy promulgate such a mindset and behavioural patterns, how is it to be expected that students won't give undue importance to grades; that they won't develop the physical and mental health issues on scoring low, that they won't think of low grades as the end of life and the end of the world? What crops up in classrooms is only fostered and irrigated at homes, as parents are after kids to score high, so as to add to their social prestige and image, to enable them to boast of the success of their ward to their colleagues, neighbours and relatives. In the midst of all this, parents do not even bother to look at the stress levels of their children and the wreckage their expectations are causing to the health of the children. Figures to this end have already been given, but on the qualitative side, it turns kids into economic entities or the objects of order execution. It erases the traces of human empathy, love and fellow feeling and thwarts them into a system of competition, where the way forward is secured only by bringing others down and an academic version of the Darwinian "Survival of the fittest" is enacted in classrooms.

What is happening in Kota - the pre-

mier coaching hubs of India makes a regular round on news channels and the suicidal cases shakes everyone of us to the spine. Such incidents have now cut across the age barriers and students as young as 14 years are turning to suicides in order to escape the consequences of poor grades. We aren't hereby pleading a case for poor performance or low grades, which if given ascent can undermine the performance and potential of students, and mediocrity will become the order of the day. But what our parents, teachers, students and society need to understand is that poor academic performance is not litmus test determining the rest of the students' life. An academically poor student may have commendable entrepreneurial or other skills which may place him far ahead of his peers. A failure in mathematics may be genius at Urdu, somebody who failed to qualify NEET may one day be teaching and guiding thousands of NEET/JEE aspirants - these are all real life possibilities and openness to these possibilities is the beauty of life and the secret of keep going successfully. There are other aspects, much serious and fundamental on which stands the entire edifice of grading and this system has been for long now surrounded by controversies and criticism. Though we don't intend to venture into the mechanics of this system, but it must be noted that the system is infested with inherent flaws and fallacies, which the experts have been decrying for long now. What follows is that the grades, despite their importance aren't the moot axes of our lives and there are possibilities, beyond grade profiling, where people can excel and achieve the best in their lives. Education has come up as a full scale industry and has emerged as multi-crore business, but the fact is not lost to the readers that we have acute shortage of career counsellors, who could have trained students and parents as to how should one cope up with the ghost of poor percentage and what options are there, within the academia and beyond it, even for those who score low otherwise. Parents have to stop gambling on their kids and need to understand their propensities, predispositions and preferences in order to help them in making right career choices instead on thwarting on them their expectations and aspirations. Students themselves need to be resilient in putting across their life preferences before parents, so that much time, effort and guilt can be saved. If the readers still think that the num-

If the readers still think that the numbers on the marks-sheet will determine our prosperity, success and fortune, it is time to look around and see for yourself that the successful and rich don't have much in their marks-sheets.

Concentration, Not Dilution

here are 44,000 colleges in India. Often, there used to be arguments about the best. Other than perceptions, the only means of answering that was the rankings undertaken by assorted magazines. Thanks to the education ministry's National Institutional Ranking Framework (NIRF), since 2016, we have a better methodology.

Ranking anything is difficult and subjective. What variables? How do we get data? What weights? Are there different heads, or only one aggregate ranking? NIRF uses five broad heads of teaching, learning and resources; research and professional practice; graduation outcomes; outreach and inclusivity; and perception. There are variables under each head. That methodology has evolved after consulting several experts. It is possible to quibble about variables, heads and weights. However, that quibbling is pedantic. In the scores, if there is a significant difference between higher education institution (HEI) A and HEI B, tinkering with methodology won't change relative ranking. But yes, if the difference is slight, a change in methodology can jolt relative ranking.

Whenever any such ranking exercise starts, since one knows the exercise isn't perfect, there is a temptation to incrementally improve, as one should. However, any such change makes comparison over time difficult.

The 2023 NIRF rankings have recently been announced. To quote, "The ranking exercise for the year 2023 continues with the practice of providing a common "Overall" rank in addition to a separate rank for Universities, Research Institutions, Degree Colleges, and discipline-specific ranks in Engineering, Management, Pharmacy, Law, Medical, Dental and Architecture & Planning. Agriculture & Allied Sectors and Innovation are two verticals added to the ranking exercise from 2023 onward."

That sounds complicated. But since there are different types of HEI, some complication is inevitable. In list of best-100 colleges, Miranda tops the list, followed by Hindu. Both are old colleges. Miranda was established in 1948, Hindu in 1899. The three constituent colleges that came together to establish Delhi University in 1922 were St. Stephen's, Hindu and Ramjas. Decades ago, say in 1970-s, when there was no NIRF ranking, Miranda and Hindu would still have been counted amongst the best, though not necessarily first and second.

But take something like PSGR Krishnammal College for Women, in Coimbatore. In the 2023 ranking of colleges, it is fourth. It was established in 1963 and certainly, in the 1970s, no one would have mentioned it in the same breath as Miranda and Hindu. The point is simple. A hoary tradition is no guarantee of success. As in every sphere of economic activity, new entrants challenge the old order.

What's the worst college? We don't know. The All India Survey on Higher Education (AISHE) tells us 24.5% colleges have enrolment less than 100 and 48.5% have enrolment between 100 to 500. To be part of NIRF, there must be enrolment of at least 1000 (there is an exception for Union-government-funded HEIs). Hence, a huge chunk of colleges wasn't part of ranking. To state it impolitely, they aren't worthy of being ranked. If I have understood it right, 1,288 colleges were worthy of being ranked and NIRF has reported the top 100. Therefore, we don't know the worst among all colleges. We don't know the worst among 1,288. We only know the worst among the 100. The worst of this lot is Scottish Church College, Kolkata. It has around 2,000 students in under-graduate programmes. For under-graduate, annual intake is 765. But in the last year for which we have data, 56% graduated. The rest dropped out.

Among those who graduated, 7.3% were placed. (The ratio is almost the same for postgraduate and median salaries are lower for postgraduate than under-graduate.) Those unfamiliar with Kolkata and its history may not know that Scottish Church College's antecedents, as General Assembly's Institution, go back to 1830. The alumni (and faculty) list is impressive and includes Swami Vivekananda, Paramahansa Yogananda, AC Bhaktivedanta Swami Prabhupada, Subhas Chandra Bose, Bishweshwar Prasad Koirala, Manna Dey and Nirad C Chaudhuri (not to speak of the fictional Professor Shonku and Feluda). There are many more illustrious names in that list.

All this establishes is that Scottish Church College has a proud legacy. That's no guarantee of a proud present.

In that list of top-100 colleges, there is a clear concentration in Delhi and Tamil Nadu (Chen-

nai, Coimbatore). In other spheres of economic activity, people talk of clusters and there are positive externalities associated with such concentration. There is no reason why higher education shouldn't exhibit similar traits.

There is a famous shloka in Sanskrit. A disciple (shishya) learns one-fourth from the teacher (acharya), one-fourth through his/her own efforts, one-fourth from fellow students (brahmacharis) and one-fourth in course of time. This is mistakenly attributed to Udyoga Parva of Mahabharata. It is not quite from Mahabharata, but from Nilakantha's Commentary on Mahabharata. Especially with urbanisation picking up, why should inclusion be interpreted as establishing colleges in rural areas? Shouldn't inclusion be interpreted as ensuring access for students in centres of higher education that have positive externalities, with geographical centre not interpreted as an individual HEI alone, but as a cluster of those? That's probably what's happening in, and around, Delhi and Tamil Nadu.

As things stand, 61.4% of colleges are in rural areas, not integrated into the education mainstream; 78.09% of students are in under-graduate courses, with one-third in arts. They are not integrated into the economic mainstream and we complain about both unemployment and lack of skills, despite the increase in enrolment in higher education.

affirm I am the best one to speak about this. I am a first-generation lawyer, I am based in Kashmir, I am a girl. Given the odds stacked up against me, the journey of becoming a lawyer has been anything but easy. In this deeply personal account, I invite you into my world, where dreams are tested, resilience is forged, and the weight of societal expectations becomes an unwelcome companion. This is the story of a first-generation lawyer in Kashmir, fighting against the tide to find her place in the legal profession. Harriet Tubman's words resonate deep-

ly within the chambers of my heart. As a dreamer and a lawyer, I have faced countless challenges on this arduous path. Being a first-generation lawyer means charting unfamiliar territories, devoid of the guidance and connections that come with a legal lineage. It means relying solely on personal determination and sheer willpower to break through the barriers that lie ahead. It means not get paid for weeks on end and working relentless without any guidance or accountability. As a girl growing up in this region, societal expectations sought to confine me within predefined roles, limiting the scope of my aspirations. The path to becoming a lawyer is paved with skepticism, disapproval, and countless raised eyebrows. Yet, persistence fuelled by an unyielding desire to challenge the status quo and make a difference is the chemical required to bring change and make a difference.

The challenges faced by a first-generation lawyer are not limited to societal expectations. Financial constraints loom large, threatening to derail dreams at every turn. Seniors lawyers do not pay junior lawyers for weeks on end. Not even a minimum basic



wage is given to budding lawyers. In a profession that often values connections and recommendations, the absence of a legal background leaves one feeling like an outsider. The legal fraternity, with its unwritten rules and invisible barriers, sometimes seem impenetrable. Graduating from a prestigious law schools like NLUs bear no significance. Did You Know That English Language Offers So Many Different Ways Of Saying 'Nonsense'?

ahir is the iconic romantic literary poet known for his sensitivity towards human suffering and his easing optimism for a better tomorrow. His intense anti-war poem, parchhayiyaan, visualised apparently by two ordinary lovers, bringing reminiscences of the prime period of the poet & his beloved's ('where journey of our love commenced'); probably conceived by Sahir around 1944-45AD, connects the reader's heart, rhythmically, and concludes on a covenant for peaceful resolution. Since it is a very long poem, and space in newspapers cannot afford rendition in entirety, a carefully selected portion is attempted herein for giving readers an overall feel of this great Urdu poem but please read the original poem of Abul Hai Sahir Ludhyanvi.

onsidering that "nonsense" literally means something that makes no sense, it seems paradoxical that English offers so many ways of saving "nonsense". Some of them have amusing origins as well, including in other languages. One of the words commonly used in England for foolish ideas, talk or activities was "bosh", as in "that entire theory is utter bosh". Bosh, it turns out, comes from bo , a Turkish word meaning "empty; useless". In similar vein, I would have expected British colonials in India to create "buckwash" out of the Hindustani "bakwaaas", but they never got beyond "eyewash". Or you could tell someone to "stop talking rot", and it amounted to the same thing; something that was rotten could not be consumed, just as an idea that was "bosh" could not be ingested.

An even more dismissive term for nonsense was "codswallop" - which remains one of the most colourful words for describing nonsense. When words or language were dismissed as meaningless or conveying no comprehensible or intelligible ideas, they were called "codswallop". So "his explanations for not turning in his work on time were codswallop" could mean they were unbelievable, foolish or nonsensical. The etymology of the term is shrouded in controversy. The most interesting explanation is that "wallop" once meant a kind of beer and a 19th-century manufacturer of soft drinks, Hiram Codd, made such undrinkable beer that "codswallop" became a derogatory term for a drink you couldn't swallow hence, by extension, for an explanation or argument you couldn't swallow either. A more prosaic theory suggests that hearing codswallop was the equivalent of being whacked (or "walloped") with a dead fish (a "cod"), and codswallop was nonsense so insulting that it was like being assaulted with a fish. Take your pick - either theory might turn out to be codswallop too!

If Hiram Codd's beer was undrinkable, so too was "balderdash", which also referred to an odd and usually disagreeable mixture of unsuitable drinks (such as a cocktail of beer and milk or beer and wine). No one is able to pinpoint the incompetent bartender who came up with such "balderdash", though. A more straightforward etymology can be found for "folderol", since the French term fol-de-rol referred to a nonsense refrain in songs, usually in the theatre. And the even more evocative "poppycock" comes



from a Dutch dialect word "pappekak" or "soft dung."

American equivalents of codswallop – words to describe foolish, empty, specious or nonsensical talk, ideas, or opinions - range from "bunkum" to "claptrap" by way of "flapdoodle" and "hogwash", taking in "garbage", "bull", and its unprintable longer form, as well as "bellywash" and "mumbo jumbo". The British could counter with "twaddle", "gibberish", "tommyrot", "phooey", "piffle", "tripe", "tosh", and "double Dutch". If a Brit considers something to be "cobblers", an American is more likely to call it "baloney". A Brit might say something is "blah" while a Yank might suggest it's "waffle". (And thanks to infusions of Yiddish from Jewish immigrants, a New Yorker might prefer "meshuggas").

All in all, there are many ways to describe something that old-fashioned people used to dismiss as "stuff and nonsense". Some of these terms were born in very specific circumstances. "Bunkum" came from American politics in 1820, when Representative Felix Walker delivered a particularly lengthy and tire-some peroration of limited substance, claiming he

was speaking for the people of Buncombe County, North Carolina. "Buncombe" was pronounced "bunkum", and the hapless county soon found itself, thanks to its political representative, a synonym for pointless speech – mercifully spelled differently. "Blatherskite", on the other hand, is of Scottish origin, and meant a blustering and often contemptible person given to voluble and inconsequential talk. But it was popularised in America by the immortal Walt Disney, whose character Scrooge McDuck liked to exclaim, "blathering blatherskite!"

Of course, if all these terms are too exotic for you, there is a simple synonym for "nonsense" that is perfectly respectable English: "drivel". If you want to be rude, you could dismiss something as "rubbish", or metaphorically urge someone not to release "hot air". But if you wished to react to nonsense in more memorable language, the terms in this article should be more than enough to settle multiple scores!

Food Choices Key To Tackling Global Warming, Study Finds

ood consumption in the five highest greenhouse gas (GHG) emitting countries, including India, was responsible for more than 40 per cent of global food supply chain emission in 2019, according to a study.

The research, published in the journal Nature Food, found that action to protect the planet against the impact of climate change will fall short unless emissions are reduced from the global food system, which now makes up a third of man-made GHG emissions.

The largest emission increase within food supply chains is triggered by beef and dairy consumption in rapidly developing countries, such as China and India, while emissions per head in developed countries with a high percentage of animal-based food declined, the researchers said.

The team noted that the growth of the global population and rising demand for emissionintensive food are likely to boost emissions further.

"A global shift in diets, including reducing excessive intake of red meat and improving shares of plant-based protein will not only reduce emissions but avoid health risks such as obesity and cardiovascular disease," said study corresponding author, Professor Klaus Hubacek from the University of Groningen in The Netherlands. Yuli Shan, from the University



of Birmingham, UK noted that the agrifood system drives global land use and agricultural activities—contributing to around one-third of global anthropogenic greenhouse gas.

"Population growth, expansion of food production, and an increase in animal-based diets are likely to further increase emissions and squeeze the global carbon budget," said Shan, corresponding author of the study.

The study first author, Yanxian Li, a Ph.D. student at the University of Groningen said mitigating emissions at every stage of food supply chains from production to consumption is critical if we are to limit global warming.

"However, widespread and lasting diet shifts are very difficult to achieve quickly, so incentives that encourage consumers to reduce red meat or buy products with higher environmental dividends could help to reduce food emissions."

Li said. Researchers analysed data linking emissions to consumers between 2000 and 2019, revealing that in 2019, food consumption in the five highest emitting countries, China, India, Indonesia, Brazil, and the US, was responsible for more than 40 per cent of global food supply chain emission.

Annual global GHG emissions associated with food increased by 14 per cent over the 20-year period. The substantial increase in consuming animalbased products contributed to some 95 per cent of the global emissions rise, accounting for almost half of total food emissions, the researchers said.

Beef and dairy contributed 32 per cent and 46 per cent of the increase in global animal-based emissions, they said.

Consumption of grains and oil crops is responsible for 43 and 23 per cent of global plantbased emissions respectively, while rice contributes to over half of the global grain-related emissions, with Indonesia, China, and India being the top three contributors, the researchers added.

The 30-share BSE benchmark zoomed 466.95 points or 0.74 per cent to settle at a record closing high of 63,384.58. During the day, it rallied 602.73 points or 0.95 per cent to 63,520.36.

The Sensex is just 198.49 points away from its lifetime intra-day peak of 63,583.07 on December 1, 2022.

Thanks to the rebound in equities, the market capitalisa-tion (mcap) of BSE-listed firms reached a record high of Rs 2,92,78,245.41 crore.

The rally in equities also made investors richer by Rs 2 lakh crore on Friday.

The previous record high of the market capitalisation of BSE-listed firms was Rs 2,91,25,007.45 crore, registered on December 14, 2022.

Apple Leaf Blotch Miner: 'All Types Of Measures Being Taken To Curb Infestation'

Orchardists requested not to panic & follow the ad hoc advisory framed by SKUAST-K **Observer News Service**

SRINAGAR: With the diversification of crops as well as the climate driven changes in pest dynamics, some areas of Kashmir valley especially the districts of south Kashmir, have witnessed the emergence of a new insect pest namely Apple Leaf Blotch

Miner. The pest was reported during the year 2021 from Zainapora and other adjoining areas of district Shopian and can be identified by circular necrotic blotches on apple leaf like Alternaria Leaf spot. During high pest incidence the leaf shows multi spots especially in heavily infested pockets, and trees show a burnt appearance from a distance.

The surveys conducted by SKUAST-K and Department of Horticulture revealed that the pest infestation is prevalent in the orchards of some villages of district Shopian, Kulgam, Anantnag and Pulwama. The economic threshold level of blotch leaf miner is 0.5 to 1 blotch/leaf. Dispersal of

blotch leafminer to new areas takes place through infested fruits, Bud/graft wood and plant material. In order to ensure the

containment of any further resurgence and to reduce the intensity of the pest, Financial Commissioner/ Additional Chief Secretary, Atal Dulloo has already instructed SKUAST-K and Department of Horticulture, Kashmir for working out the strategy of its management and to delineate



the areas into various infestation zones, such as red, yellow and green depending upon the severity of the infestation, so that the pest can be efficiently managed.

the Department of Horticulture, Kashmir and SKUAST-K proactively initiated a proan imminent outbreak.

In this respect all the viable means and methods both physical and IT enabled will be put in place. SKUAST-K has already developed google form for receiving the responses from various stakeholders, particularly orchardists regarding the presence and severity of the pest. To Cryptocurrency Fraud Gets It Back After 1 Year Press Trust Of India

THANE: A mobile shop owner residing in Maharashtra's Thane district, who lost ₹36 lakh in a cryptocurrency fraud more than a year ago, has got his entire amount back after the police cracked the case and found that a Chinese national was involved in the offence, an official said on Friday.

The probe into the case was conducted by the cyber cell of the Mira Bhayandar-Vasai Virar (MBVV) police commissionerate, he said.

Sujitkumar Gunjkar, a senior inspector of the MBVV cyber cell, said the victim was lured into cryptocurrency trading in February 2022 after he joined a WhatsApp group involving cryptocurrency traders. The group administrator, a woman, got in touch with him and sought investments in cryptocurrency promising goods returns. "Falling prey to the tactics, the victim invested the money through a mobile app and bought cryptocurrency worth USD 39,596," he said.

However, in May last year, the WhatsApp group was stopped and despite several attempts, he failed to contact the group administrator, the official said.

"The victim then realised that he has been cheated. After that, he approached the

cyber police and lodged a complaint. A probe was launched and worked on various leads. During the process, the police came across OKX, a Seychellesregistered cryptocurrency exchange," Mr Gunjkar said.

During the probe, the police came across a suspicious cryptocurrency wallet. The police contacted OKX and came to know that the wallet belonged to a Chinese national, he added. A cryptocurrency wallet is a software or hardware that comes in many shapes and sizes, enabling users to store and use cryptocurrency.

Based on the complaint and the inquiry, an offence under section 420 (cheating), 34 (common intention) of the Indian Penal Code (IPC) was registered at the Kashimira police station, the official said. The cyber cell then approached the local court with the details of the offence and their findings. They informed the court that the victim's money was in the wallet of the Chinese national and the numbers from which the victim was contacted were from Hong Kong, he said.

Govt, Wholesalers Benefitting From Falling Prices Of Essential **Commodities, Not Consumers: Cong**

NEW DELHI: Close on the heels of fresh inflation data, the Congress alleged on Friday that wholesalers and the government are "benefitting" from the falling prices of essential commodities, whereas the consumers are not getting any benefit.

spokesperson Congress Gourav Vallabh said the government should not remain a mute spectator and wondered why the prices of commodities and petroleum products are not coming down in the retail market. "Why suit-boot ki sarkar is just acting as a mere spectator and keeping silent when wholesalers and the government are benefitting from the falling prices of the majority of essential commodities and the final consumers are not getting any benefit?" Vallabh asked at a press conference here. "When there is a reduction (in prices) in the crude petroleum wholesale market by 27 per cent from May 2022 to May 2023, why even a one paisa benefit is not being given to the consumers of petrol and diesel? "When the prices of most essential commodities are falling in the wholesale market, why are the benefits not transferred to the final consumers?" he asked.

dex (WPI) numbers for May 2023 for vegetables, potato and oilseeds were at minus 20.12 per cent, minus 18.71 per cent and minus 15.65 per cent respectively, the consumer price index on food and beverages was 3.29 per cent.

"Farmers are selling their products at lower prices and buying the same products for self-consumption at higher prices. King Charles Confers Highest Scottish Honour On Wife Camilla

London: King Charles III has conferred Scotland's highest royal honour on his wife Queen Camilla, the Buckingham Palace said on Friday.

The Most Ancient and Most Noble Order of the Thistle, which was revived by King James VII in 1687, are entirely in the personal gift of the British monarch.

It currently recognises 16 knights as well as men and women who have held public office or who have given a particular contribution to national life. "The King has been gracious-

ly pleased to appoint the Queen to the Most Ancient and Most Noble Order of the Thistle," the palace statement read.

The King's son and heir, Prince William, and sister Princess Anne are also members of the

Order of the Thistle, besides various members of the aristoc-

racy and House of Lords. Charles turned 74 on November 14 last year but this weekend marks his first official birthday as monarch, celebrations for which fall in early or mid-June as part of the royal Trooping the Colour display of regal pageantry.

The King's Birthday Parade, to take place on Saturday, will involve over 1,400 military officers together with 200 horses, over 400 musicians from 10 bands and corps of drums.

The parade route extends from Buckingham Palace along the Mall to Horse Guards Parade, Whitehall and back again in the heart of London. During the ceremony, the King is greeted by a royal salute and carries out an inspection of the troops. The parade concludes with

the King joining senior mem-bers of the royal family on the balcony of Buckingham Palace for a fly-past by the Royal Air Force (RAF). The RAF display this weekend is expected to be particularly spectacular as the display planned for the Coronation on May 6 was rescheduled due to rainy weather.

"We have planned a fitting and appropriate tribute for our monarch, that should be a true spectacle for the United Kingdom and the Commonwealth," said Air Chief Marshal Sir Richard Knighton,

the UK's Chief of Air Staff. The Ministry of Defence (MoD) said aircraft from across the Royal Navy, British Army and Royal Air Force will take part in a spectacular flypast for the King's Birthday Parade, marking the first Birthday Flypast for King Charles III.

gate was functioning, the wetland was clean. But, the wetland has got much polluted now," Ahmad said adding that those responsible for fixing this problem should act swiftly so that the wetland is not damaged again. According to Ahmad, villagers around Hokersar are worried about the new threat facing the wetland. Villagers, especially dairy farmers who entirely depend on the wetland for the fodder for their cattle, said that the wetland is not only a bird sanctuary, but an important resource supporting their livelihoods.

People's Environment Council (PEC), a Srinagar based environmental watchdog has taken a serious note of the situation and has written a letter to the concerned department urging it to get the new trash gate installed as quickly as

An important precondition for the dredging was setting up a sluice gate so that the wetland could retain 3-4 feet water throughout the year. But this important precondition was overlooked for four years and the work for sluice gates was started only late last year. Locals say the wetland had dried up so much that they were able to drive mini trucks on it to collect cattle fodder.

Kumar (27), a resident of Udhampur district, was shot dead by two motorcycle-borne militants from a close range when he had gone to the market to buy milk on the night of May 29. He worked at a circus in the Janglat Mandi area in the south Kashmir district.

Addressing a press conference in Anantnag, Deputy Inspector General (DIG), South Kashmir Range, Rayees Mohammad Bhat said five JeM terrorists have been arrested in connection with Kumar's killing.

"Investigations and searches were launched after the incident. During the investigations, we got some technical leads and some clues. In the meantime, we zeroed in on some suspects and they were interrogated," Bhat said.

He said the investigations pointed at two people, Sehran Bashir Nadaf and Ubaid Nazir Laigroo, both residents of Anantnag town who had gone missing.

"We launched a massive search operation to nab them. Based on technical and human intelligence, we were ultimately able to arrest these two accused after which the whole conspiracy was revealed," he said.

Apart from Nadaf and Laigroo, three other militants -- Umer Amin Thoker, Huzaif Shabir Bhat and Nasir Faroog Shah -- have been arrested, the DIG said.

the court said, has resulted in death of the deceased inside the jail.

'The jail authorities have, therefore, failed to ensure safety and security of the unfortunate undertrial prisoner. Therefore, respondents cannot escape their responsibility for the custodial death of the deceased," the court said.

The court said that even though the deceased, Mohammad Ismail Shah, was an undertrial in a murder case. the authorities were not absolved of their liability to ensure his safety and security in the jail. "A prisoner cannot be deprived of his constitutional rights except in accordance with law. Therefore, the deceased in the instant case despite being an undertrial prisoner in a murder case was entitled to protection by the jail authorities," the court said, adding, "Since his killing took place while he was in jail, he was deprived of his life in contravention of the law." Shah's untimely death, the court said, has deprived his widow, sons and daughters of his love and affection as also his company, as such, they are entitled to compensation from the authorities whose "negligence" has resulted in his untimely death. "Having regard to the age of the deceased, who, as per the postmortem report, was 48 years old at the relevant time, and keeping in view the fact that all the children of the deceased are major, ends of justice would be met if an amount of Rs.5.00 (lakh) is awarded as compensation in favour of the petitioners (widow and children) to be paid by the respondents," the court said and accordingly directed the government to pay Rs 5 lakh within three months. "In case the amount of compensation is not paid to the petitioners within the aforesaid period, it shall carry interest @ 6% per annum from the date of this judgment."

"Last week our local partners informed us that the trash gate for stopping solid waste inflow into the wetland that was installed at the spot where water inflows into Hokersar has been damaged and (has) become totally dysfunctional. Attached photographs show the extent of damage, and seem to reflect a tell-tale precursor of, God forbid, another ecological disaster in the making," the letter reads.

"I am sure you share our concern and the need for early action given that Hokersar is of great local, national, and global ecological, cultural and historical importance. As well known to you, this wetland is not only a significant node of the Central Asian Flyway (CAF), but has been declared as a Wildlife Conservation Reserve by the Government of India (GoI) and Ramsar Bureau. GoI has also shown a renewed commitment to wetland protection in its recent official pronouncements," the letter further reads.

Urging the department to act promptly, the department head has been requested for initiating remedial measures urgently, especially the restoration of the trash gate so that solid waste doesn't find its way into the wetland.

Zaffar Mustafa, executive engineer of Flood and Irrigation department told Kashmir Observer that he and his colleagues in the department are trying their best to install the new trash gate as soon as possible. "Hopefully, we will be able to install the gate within the next three days. We couldn't do it so far because the water level is still high." Mustafa said.

Hokersar is a winter migratory route for 68 waterfowl species like large egret, great crested grebe, little cormorant, common shelduck, tufted duck and the endangered white-eyed pochard visiting from Siberia, China, Central Asia, and Northern Europe.

Pertinently, the wetland has only started recovering since November last month after suffering extensive degradation. Started in 2018, a government project to deepen a flood channel through Hokersar had drained out its moisture and had turned almost the entire wetland into a land mass. The dredging was aimed at providing

media here, the general officer commanding of the army's 28 Division, Major General Girish Kalia, said that based on the input, multiple ambushes were set up along the expected routes of infiltration.

"Simultaneously, the entire area, the LoC fence or the anti-infiltration obstacle system (AIOS), was kept under surveillance," he said.

Around midnight, the movement of militants was picked up by the alert troops who braved challenging terrain and weather conditions.

"The infiltrating terrorists were engaged with precise and accurate fire, and in the ensuing firefight, five unidentified terrorists were neutralised," Maj Gen Kalia said, adding there was no collateral damage.

He said the militants were heavily armed and appeared to be very well trained.

During a search of the site Fridav morning, a large amount of arms and ammunition, including five AK series rifles, 15 magazines and grenades, and equipment such as night vision devices and binoculars were recovered, he said.

Maj Gen Kalia said while there is a ceasefire understanding between India and Pakistan, the security forces have been getting a large number of intelligence inputs of likely infiltration from across the LoC in the recent past.

The army commander said the operation is a reflection of the high level of synergy between the Indian Army and the Jammu and Kashmir Police who have been working tirelessly to ensure that "our beloved J-K remains peaceful and continues to progress on the path of development and prosperity".

West Indies, Zimbabwe & Sri Lanka Head Into World Cup Qualifier Unbeaten

DUBAI: West Indies, Zimbabwe and Sri Lanka will enter the ICC Men's Cricket World Cup 2023 Qualifier high on confidence, having won both their warm-up matches ahead of the tournament.

Netherlands and Nepal will also both enter the group stages on the back of victories, with the Netherlands overcoming Ireland while Nepal beat Oman.

Powell powers West Indies to big win against UAE

Big-hitting Rovman Powell's rapid century helped the West Indies defeat UAE by 114 runs at Takashinga, Harare on Thursday.

Nicholas Pooran's 74 had helped the Windies to a commanding position before three wickets in nine balls saw his side slip to 198-7 midway.

But Powell combined with Keemo Paul to put on 139 for the eighth wicket, the former eventually dismissed for 105 from just 55 balls as the Windies posted 374 for nine.

The UAE had a centurion of their own in the form of Basil Hameed, who batted valiantly to reach 122 not out as his side fell 114 runs short.

Yannic Cariah was again the star of the West Indies attack as he took four for 58 to back up his four-wicket haul in the first warm-up game.

Zimbabwe go two from two after dominant Scotland victory

Brandon McMullen fell one run short of a half-century as Scotland were bowled out for 163 having been put into bat by hosts Zimbabwe.

The right-hander put on an innings-high partnership of 47 runs with Matthew Cross for the second wicket before the latter was bowled by Brad Evans for 32.

McMullen was unable to build another partnership before he was dismissed by Ryan Burl for 49, with late cameos from Jack Jarvis (26) and Christopher McBride (20) pushing Scotland past 150.

In response, Zimbabwe chased the modest total inside 25 overs with six wickets to spare.

Sikandar Raza top scored with 44 from 28 balls while



Joylord Gumbie and Craig Ervine both made 37, with Micheal Leask's two quick wickets only providing temporary resistance.

Karunaratne century sets up big win for Sri Lanka

Dimuth Karunaratne made a sparkling century as Sri Lanka handed USA a 198-run defeat in Bulawayo.

Karunaratne was joined at the crease by Kusal Mendis in the seventh over with Sri Lan-

ka 39 for one, before the pair combined for a 191-run partnership to power the Lions to 392 for five.

Mendis departed for 105 from 91 before Karunaratne retired not out on 111 from 100 balls to leave time for strong middle-order striking from Charith Asalanka and Dasun Shanaka, who added 112 for the fifth wicket.

After losing both openers for just 10 runs to begin their response, the USA rebuilt through Monank Patel who scored 68 before becoming one of three wickets in an over for Matheesha Pathirana to leave USA on 106 for seven.

Shayan Jahangir was left stranded on 63 not out as Usman Rafiq was run out with USA falling 198 runs short.

Barresi guides Netherlands to win

Ireland were bowled out for 193 in the 40th over with Harry Tector, who made a century against USA earlier in the week, one of seven players to score single figures against Netherlands as Scott Edward's side shared the wickets around.

Lorcan Tucker rebuilt from 58 for five in the 20th over, helped by a quick-fire 46 from 25 balls from Gareth Delany, who became Shariz Ahmad's second wicket.

Tucker was stumped by Ed-wards for 74 off the bowling of Clayton Floyd before Craig Young fell three balls later to Saqib Zulfiqar to bring Ireland's innings to a premature close.

Wesley Barresi's 90 helped see the Netherlands home, with Barresi and Max O'Dowd putting on 89 for the second wicket, though Ireland did not go down without a fight.

Three balls after O'Dowd departed, Noah Croes was also dismissed by Ben White, who returned figures of five for 61 as Ireland reduced Netherlands to 114 for six in the 19th

In reply, Nepal made a strong start as opener Kushal Bhurtel scored 101 before retiring as he and Bhim Sharki added 115 runs for the second wicket.

With Nepal needing just one run to win, Oman hit back with three quick wickets as Aqib Ilvas took four for 42 before Sandeep Lamichhane hit a six from the first ball that he faced to secure the win.

LONDON: Umpiring at home over the past three years under the constant pressure put by the big Indian stars has helped Nitin Menon grow immensely as an ICC Elite Panel umpire, preparing him well for his much-awaited Ashes debut next month.

After being inducted into the ICC Elite Panel in June 2020, Menon did majority of India's home games due to COVID-19 induced travel restrictions put in place for foreigners.

He also got to officiate in couple of T20 World Cups in UAE and Australia and he was in England last year for their home series against South Africa, taking his match tally to 15 Tests, 24 ODIs and 20 T20 Internationals since June 2020. In an exclusive interview

to PTI ahead of the Ashes, Menon said it was a blessing in disguise that he got to do so many games over the past three years.

'It has been an amazing experience working in Indian subcontinent in the first two years, doing Test matches and then getting to officiate in T20 World Cups in Australia and Dubai. I

WHO Says Toxic Syrup Risk 'Ongoing', More Countries Hit

There is an ongoing global threat posed by toxic cough syrups, the World Health Organization (WHO) told Reuters, saying it was now working with six more countries than previously revealed to track the potentially deadly children's medicines.

The U.N. agency has already named nine countries where tainted syrups may have been on sale, after the deaths of more than 300 infants on three continents last year were linked to the drugs.

Rutendo Kuwana, the WHO team lead for incidents with substandard and falsified medicines, declined to name the six new countries the agency is working with, while investigations are still underway.

He warned that contaminated medicines could still be found for several years, because adulterated barrels of an essential ingredient may remain in warehouses. Cough syrups and the ingredient, propylene glycol, both have shelflives of around two years.

"This is an ongoing risk," said Kuwana.

Unscrupulous actors sometimes substitute propylene glycol with toxic alternatives, ethylene glycol and diethylene glycol, because they are cheaper, several pharmaceutical manufacturing experts told Reuters.

The alternatives are more commonly used in brake fluid and other products not meant for human consumption.

The WHO's working theory is that in 2021, when prices of propylene glycol spiked, one or more suppliers mixed the cheaper



toxic liquids with the legitimate chemical, Kuwana said. He did not say where the suppliers were based, and added that obscure supply chains have made proving this difficult. Pharmaceutical manufactur-

ers, including those alleged to have produced the tainted syrups that have been found so far, typically source ingredients from external suppliers.

Liberia and Cameroon

Earlier this week, Nigeria's regulator issued a warning about contaminated paracetamol syrups sold in Liberia, although no deaths have been reported there. The Nigerian regulator was testing the syrups, which were not sold in Nigeria, because Liberia has no testing facilities.

The WHO issued safety alerts solast year for Indian-made products found in Gambia and Uzbekistan, and this year in Micronesia and the Marshall Islands. It also issued an alert last year for Indonesian-made syrups that were only sold domestically. In-



Three Indonesian-based manufacturers – PT Yarindo Farmatama, PT Universal Pharmaceutical Industries, PT AFI Farma – have had their licences revoked. A fourth, PT Konimex, said it had recalled all of the relevant products and its website says it was cleared by the Indonesian regulator to sell new batches as of December 2022. The Indonesian regulator did not immediately respond to a

request for comment. In January, the WHO named four other countries it was working with – Timor Leste, Cambodia, Senegal and the Philippines – to track whether any of the tainted syrups had reached their markets. There is no current risk to the population in the countries the WHO has named, Kuwana said, either because contaminated medicines had been pulled from shelves or because they never reached the market in the first place.

The countries' governments either confirmed this, said there was only a minimal risk, or did not respond to requests for comment. The WHO said it has also offered help to Liberia and Cameroon – which recently signalled that it too may have contaminated cough syrups for sale. Cameroon's health regulator

said in April it was investigating the deaths of six children linked to a cough syrup branded as Naturcold. The manufacturer named on the packet is China's Fraken Group, which did not immediately respond to requests for comment.

Groundwater Pumping Tilting Earth's Spin, May Impact Climate: Study

Good shifted such a large mass of water that the Earth tilted nearly 80 centimetres east between 1993 and 2010 alone, which could impact our planet's climate, according to a study.

The research, published in the journal Geophysical Research Letters, found that during the study period, the most water was redistributed in western North America and northwestern India.

Scientists have previously estimated humans pumped 2,150 gigatons of groundwater, equivalent to more than 6 millimetres of sea level rise, from 1993 to 2010. However, validating that estimate is difficult.

"Earth's rotational pole actually changes a lot," said Ki-Weon Seo, a geophysicist at Seoul National University in South Korea, who led the study.

"Our study shows that among climate-related causes, the redistribution of groundwater actually has the largest impact on the drift of the rotational pole," Seo said. The researchers noted that wa-

ter's ability to change the Earth's rotation was discovered in 2016, and until now, the specific contribution of groundwater to these rotational changes was unexplored.

The model only matched the observed polar drift once the researchers included 2150 gigatons of groundwater redistribution. Without it, the model was off by 78.5 centimeters, or 4.3 centimeters of drift per year.

The researchers said attempts by countries to slow groundwater depletion rates, especially in those sensitive regions, could theoretically alter the change in drift, but only if such conservation approaches are sustained for decades.
