### **Pak Agencies Trying To Keep Militancy Alive: DGP**

**Srinagar:** There are attempts to keep militancy, which is "gasping and dying", alive by Pakistani agencies but the anti-infiltration grid along the Line of Control (LoC) is doing its job, Jammu and Kashmir DGP Dilbag Singh said on Saturday.

Talking to reporters after inaugurating the Jashn-e-Dal festival here, he said the ceasefire understanding between India and Pakistan along the LoC is being respected "by and large" by both sides. However, there have been some infiltration attempts by militants, Singh said.

"Ceasefire understanding is being respected by and large by either side but in between some activities, some infiltration bids, have taken place, especially in the Rajouri-Poonch sector and the Kupwara sector. We have taken action against the infiltrating groups," the director general of police (DGP) said.

Singh said while some infiltration attempts have been successful, the number of militants who have managed to sneak in has been very low. "There are attempts to keep militancy, which is gasping and dying, alive through such activities by Pakistani agencies but our anti-infiltration grid along the LoC is alert and they are

# Power Outages In Kashmir To Continue Till Debts Cleared

PDD Supplies 1200-1250 MWs Against Required 1400-1450 MWs

Srinagar: As the number of tourists from India and abroad began to rise with soaring mercury, Kashmir valley has been experiencing sporadic power outages, as a result of 25 percent reduction in energy supply by hydro power utilities, including National Hydro Power Corporation Private Ltd (NHPC).

A senior official at the Power Development Department (PDD) told Kashmir Observer that J&K faces a 20 to 25 percent power deficit at the moment, while the department supplies 1100 to 1200 megawatts against the required 1400-1450 megawatts.

He said the sudden reduction in energy supply as a result of nonpayment of outstanding debts to the hydro electric giants including that of the Union Territory's own power plants, forced the department to resort to the curtailment amidst rise in temperature.

The official further said the crises that might have arisen out of the spontaneous power cuts, will end once all debts are



cleared. The department, he said, purchases energy from hydro power utilities as a commodity.

"We cannot say as to when the crises may end. It's for the centre to take a call on the issue. Our present requirement is 1400-1450 megawatts and despite a 25 percent sudden shortfall,

the department supplies 1100 to 1200 megawatts," the official said, adding the government always makes sure that there is round the clock power supply in

commercial areas. It may be in place to mention that J&K for the past couple of weeks has been facing frequent

Regarding smart power meters, sources said that people have to bear with the government, as there is no other way out to deal with the power pilferage.

"When consumers could pay monthly bills for mobiles, manage other bills, why can't they manage smart meters? Smart meters are aimed at providing uninterrupted supply to the consumers on subsidized rates," sources added.

They also said the government is likely to provide electricity to the Below Poverty Line (BPL) category on subsidized rates once the smart meter installation process is completed in the UT. **BJP Ready For J&K Polls: Raina**



# **Mammals During Lockdowns Moved Farther, More Liberally, Study Finds**

uring strict Covid lockdowns between January and May 2020, animals had travelled up to 73 per cent longer distances in 10 days and occurred on average 36 per cent closer to roads than the lockdown-free year before, researchers say.

The study findings suggested, they said, that most animals in these locations were exploring more of the landscape when vehicle movement was reduced.

The researchers also suggested that venturing closer to roads was because animals were less fearful of the road traffic or human presence in these regions.

They said their study, published in the journal Science, showed how animals responded directly to human behavioural changes and that it provided valuable insight into future conservation strategies, be-



cause it meant that humans making behavioural adjustments could impact animals' lives positively.

Exploiting the unique, natural opportunity afforded by lockdowns to study the effects of abrupt changes in human presence on wildlife, Marlee Tucker from Radboud University, Nijmegen, The Netherlands, and 174 colleagues collated movement data of

43 different land mammal species around the world, tracked using GPS devices.

They then compared the mammals' movements during the first period of lockdowns with movements during the same months a year earlier.

Altogether, there were more than 2,300 individuals included in the study, from elephants and giraffes to bears and deer.

"There were many media reports that nature was recovering during those first lockdowns. For example, cougars were roaming the streets of Santiago, Chile, but we wanted to know: is there any evidence of this? Or were people simply paying more attention to everything while being at home?' said Tucker.

There were several explanations for the results, the researchers said. Fewer people outside during lockdowns gave animals the opportunity to explore new areas.

"In contrast, in areas with less strict lockdowns, we saw that animals travelled shorter distances. This may have to do with the fact that during those lockdowns, people were actually encouraged to go into nature.

"As a result, some nature areas were busier than before COVID-19," said Thomas Mueller, Goethe University Frankfurt, Germany, who designed the study together with Tucker.

# 13 Children Rescued From 'Unregistered' Orphanage In Srinagar

Srinagar: At least thirteen children were rescued during a raid from an 'unregistered' orphanage at Lawaypora area on the outskirts of Srinagar, following the death of an inmate under mysterious circumstances.

Police along with child rights organizations raided Al Muzammil Welfare Trust at Lawaypora area and evacuated thirteen minor children.

Action comes following the mysterious death of an inmate in the orphanage, which was operating illegally for years, Chairman Child Welfare Committee, Dr Khair-un-Nissa told Kashmir Observer.

"I had also served a legal notice to the owner of the so-called orphanage during my visit; however the trustees failed to respond, prompting us to conduct a surprise raid. This orphanage was being run illegally and action warranted under will be initiated against the owners very soon,' she added.

She also said that police have also taken cognizance of the mysterious death of the inmate and have set investigation into motion. She said few suspects have also been detained for questioning in connection with the case.

The joint raid was conducted late last evening after an inmate died under mysterious circumstances, while three children who were rescued disclosed the owners of the trust had taken them to some unknown location. Police are investigating the matter," Khair-un-Nissa said.

A police official while confirming the action said that thirteen children were evacuated from the orphanage while investigations have been taken up into the mysterious death of an inmate of the said illegal orphanage.

### Saudi, Iran Foreign **Ministers Meet In Tehran Amid Warming Ties**

**TEHRAN, IRAN:** Iranian Foreign Minister Hossein Amirabdollahian welcomed his Saudi counterpart at the foreign ministry ahead of bilateral talks and a press conference on Saturday afternoon.

The Saudi minister said he would also have a meeting with Iranian President Ebrahim Raisi, who has just finished a tour of Latin America.

During the press conference. the two diplomats hailed re-establishment of diplomatic relations, which they said would be paramount to improving security across the region.

'The Islamic Republic of Iran has never equated security with militarism, and considers security to be a comprehensive concept, which includes political, economic, cultural, trade and social dimensions between all the countries of the region," Amirabdollahian said.

The Iranian foreign minister added that he discussed a wide range of issues with his counterpart, which included trade ties and joint investments, in addition to accommodating Saudi tourists and pilgrims who may be interested in visiting Iran.

For his part, bin Farhan said "mutual respect, non-interference in the two countries' internal affairs and commitment to the United Nations Charter" will be at the centre of bilateral

relations going forward, with an eye on securing the interests of both nations.

"I would also like to highlight the two countries' discussions on cooperation on ensuring maritime security and reducing proliferation of weapons of mass destruction," he said.

China-brokered deal Amirabdollahian and bin

Farhan last met in early June in South Africa on the sidelines of a meeting of BRICS, the economic bloc consisting of Brazil, Russia, India, China and South

But this is the first visit by a Saudi official to Iran since 2016, when Riyadh broke diplomatic relations after its diplomatic missions in Tehran and Mashhad were attacked after it executed a Shia religious leader in Saudi Arabia.

Tehran and Riyadh agreed to reopen their embassies within two months as part of a Chinabrokered deal signed in Beijing on March 10, but while diplomatic relations have been restored, reopening the embassy buildings has proved more challenging.

Tehran has reportedly selected Alireza Enayati, a former envoy to Kuwait and a foreign ministry deputy for regional affairs, as its ambassador to the kingdom. But Enayati was absent at the reopening ceremony, and Iran has not confirmed that he has started work at the embassy in Riyadh.

# **National Medical Commission Revises Regulations, Physics Marks To Get Priority Over Biology In Case Of Tie**

National Medical Commission (NMC) has decided to revise the process for determining ranks of aspirants having an identical NEET score, prioritising marks obtained in Physics, followed by Chemistry and Biology.

This is unlike the current practice of giving priority to marks obtained in Biology, followed by Chemistry and then Physics.

According to the Graduate Medical Education Regulations-2023 issued recently, if the subject marks do not resolve the tie, then draw of lots using computers will be conducted to draw the merit list. There would be no human intervention in the draw of lots.

The new regulations, notified on June 2, are likely to be implemented from next year.

The National Testing Agency, which conducts the National Eligibility cum Entrance Test for admission to undergraduate medical courses, and the National Medical Commission (NMC) will be deliberating on the issue further, sources said.

"In case of tie in marks of the students appearing for NEET-UG, the respective marks obtained in Physics, followed by Chemistry and further followed by Biology in the NEET UG shall be considered; Pro-



vided if the tie were to continue, then draw of lots by using the computer, with no human intervention, the eligible candidates shall be selected," according to the regulations.

The NEET-UG results were declared on June 13 this year.

According to the existing guidelines, if two or more candidates obtain equal marks/percentile scores, the tie-breaker rule is followed to decide their ranks.

A candidate with higher marks in Biology is ranked above the rest. In case of identical marks in Biology, the same rule is applied for Chemistry, followed by Physics. If the scores still remain identical, the elder candidate gets the higher rank.

According to the new regulations, students pursuing MBBS course need to complete it within nine years from the date of admission, while tempts to clear the first year.

The NMC has also stated there shall be a common counselling for admissions to graduate courses at all medical institutions in the country on the basis of the NEET-UG merit list.

"Under no circumstances the student shall be allowed more than four (04) attempts for first year (First Professional MBBS) and no student shall be allowed to continue undergraduate medical course after nine (09) years from the date of admission into the course,' the NMC regulations stated.

The student admitted into a graduate medical education programme shall not be deemed to have completed his graduation until he completes his rotating medical internship as per Compulsory Rotating Medical Internship Regulations, 2021.

### **At Least 41 Killed In Rebel Attack On Ugandan School Near Congo Border**

KAMPALA: Ugandan authorities recovered the bodies of 41 people, including 38 students, following an attack by suspected rebels on secondary school near the border with Congo, the local mayor said Saturday.

The victims included the students, one guard and two members of the local community who were killed outside the school, Mpondwe-Lhubiriha Mayor Selevest Mapoze told The Associated Press. An unknown number of people were abducted by the rebels, who fled across the porous border into Congo after the raid on Friday night.

of the students suffered fatal burns when the rebels set fire to a dormitory, others were

in volatile eastern Congo, carried out the raid on Lhubiriha Secondary School in the border town of Mpondwe.

The school, co-ed and privately owned, is located in the Ugandan district of Kasese, about 2 kilometers (1.2 miles) from the Congo border.

"A dormitory was set on fire and a food store looted. So far 25 bodies have been recovered from the school and transferred to Bwera Hospital," police said in a statement, adding that eight others were in critical condition.

Police said Ugandan troops tracked the attackers into Congo's Virunga National Park. The military confirmed in a statement that Ugandan troops inside Congo "are pursuing the enemy to rescue those abducted."

Joe Walusimbi, an official

**MUMBAI:** Parents and political activists staged a protest on Friday at a private school in suburban Kandivali after 'azaan' or the Islamic call to prayer was allegedly played during the morning assembly.

While the school principal said that the teacher responsible for playing azaan has been suspended, police said they were conducting an inquiry though no case has been registered yet.

Azaan was played on the loudspeaker during the assembly session of the school around 7 am, some parents said.

Local BJP MLA Yogesh Sagar, who joined in the protest, claimed that it was done intentionally and not by mistake, and the school was trying to shield the teacher who was responsible.

The school principal told mediapersons that the teacher was suspended.

"We promise that this won't happen henceforth," the principal said, adding that Saraswati pooja, Ganapati pooja and Navratri pooja are also conducted at the school.

t least 34 people have died in the past two died in the past the of the north Indian state of Uttar Pradesh swelters under severe heat, officials said on Saturday, prompting doctors to advise residents over 60 to stay indoors during the daytime.

The dead were over 60 and had pre-existing health conditions that may have been exacerbated by the intense heat.

The fatalities occurred in Ballia district, some 300km (200 miles) southeast of Lucknow, the state capital.

Twenty-three were reported on Thursday and another 11 died on Fridav, Ballia's Chief Medical Officer Jayant Kumar said.

"All the individuals were suffering from some ailments and their conditions worsened due to the extreme heat," Kumar told The Associated Press news



agency on Saturday. He said most of the deaths were because of heart attacks, brain strokes and diarrhoea. Diwakar Singh, another medical officer, said the people were admitted to Ballia's main hos-

pital in critical condition. "Elderly people are vulnerable to extreme heat too," he said.

India Meteorological Department data shows Ballia reported a maximum temperature of 42.2 degrees Celsius (108 degrees Fahrenheit) on Friday, which is 4.7C (8F) above normal. The scorching summer

has caused power outages across the state, leaving people with no running water, fans or air conditioners. Many have staged protests.

Uttar Pradesh Chief Minister Yogi Adityanath from the Bharatiya Janata Party (BJP) assured the public that the government was taking all necessary measures to ensure an uninterrupted power supply in the state. He urged citizens to cooperate with the government and use electricity judiciously.

### Students To Remove Burqa Before Exam, Minister's "Less Clothes" Shocker

HYDERABAD (TELANGA-**NA):** A few girl students who appeared for the Urdu medium degree examination on Saturday at KV Ranga Reddy College in Santosh Nagar, Hyderabad were allegedly asked to remove their burqa before taking the examination.

Telangana Home Minister Mahmood Ali condemned the incident and assured that the necessary action will be taken against the perpetrators. However, he cautioned women from wearing short dresses.

"Some Headmaster or Principal might be doing this but our policy is totally secular. People can wear whatever they want," Mahmood Ali said. "Nowhere it is written that a burqa can't be worn. We will take action," he added.

"If you wear European dress, it will not be correct. We should wear good clothes, especially women," he said. He added, "For women, if they are in less clothing it might be a problem. People will be at



peace if they wear more

clothes.' "College authorities forced us to remove our burqa before entering the examination centre. They

asked us to wear the burga outside," one of the women students who came for the examination said. A few girl students who

appeared for the examination at KV Ranga Reddy College alleged that the college management stopped them from appearing in the burga. The college staff at the examination centre asked them to remove the burqa, they

The girl students further alleged that in this confusion, they were prevented from appearing in the examination for about half an hour. While some girl students took off their burga and went to the examination centre. Following this incident, the parents of the girl students complained to Home Minister Mahmood Ali about this issue.

### **Ameesha Patel Surrenders Before Ranchi Court In Cheque Bounce Case**

 ${f B}$  ollywood actress Ameesha Patel on Saturday surrendered before the Ranchi Civil Court in connection with a cheque bounce case.

Senior division judge DN Shukla granted her bail and asked her to appear before the court personally again on June 21. The case dates back to 2018 when Jharkhandbased film producer Ajay Kumar Singh had registered a case of fraud and cheque bounce against the actress.

"Earlier, the court had issued her summons many times in the case but she did not appear. Later, the court issued a warrant against her," said the complainant's advocate Vijava Lakshmi Srivastava. According to the complaint, Singh had transferred Rs 2.5 crore to the actor's bank account for the production of a movie titled "Desi Magic". Patel, however, did not proceed with the film later. She sent a cheque of Rs 2.50 crore but it had bounced.

The Supreme Court in August 2022 stayed criminal proceedings for the offence of cheating and criminal breach of trust against Patel in connection with summons issued by the trial court in Jharkhand. The top court had, however, said proceedings for offences punishable under Section 138 (cheque bounce) of the Negotiable Instruments Act can continue in accordance with the law.

## "Adipurush Not Fit For Public": Request Against Movie In Delhi Court

NEW DELHI: Hindu Sena filed a writ petition in Delhi High Court against 'Adipurush' demanding that the film not be certified for public exhibition.

"That the petitioner has preferred the aforesaid Writ petition in the shape of PIL against the feature film "ADIPU-RUSH" directed by Om Raut which has hurt the sentiments of the Hindu community by depicting the religious leaders/characters/figures in an inaccurate and inappropriate manner contrary to the description of Hindu religious leaders/characters as described in Ramayana authored by writers like Maharishi Valmiki. Saint Tulsidas etc. The Petitioner being aggrieved, concerned and hurt by such an inaccurate description of the religious leaders/characters in the film 'Adipurush' gave a Representation dated 04.10.2022 to the Secretary, Ministry of Information and Broadcasting. However, the said representation has not been responded to as of date", the petition read.

The petition further stated the depiction of Ravana, Lord Ram, Mata Sita and Hanuman in the feature film Adipurush is contrary to the image and descriptions of these religious leaders /characters/figures as depicted in Maharishi Valmiki's Ramayan and Tulsidas' Ramcharitmanas.

### House Sealed In Jammu **After Sex Racket Busted**

**JAMMU:** Authorities in Jammu sealed a house on Saturday in connection with a case registered following the arrest of six people over a week ago for allegedly running a sex racket, officials said.

### Free Telemedicine **Mobile Camp Inaugurated In Kathua**

JAMMU: Union Minister Jitendra Singh on Saturday dedicated to the public a free telemedicine mobile camp in Jammu and Kashmir's Kathua district.

This is the third phase of the Union Territory's first-ever mobile telemedicine service -- Doctor on Wheels -- being provided with funds purely from non-government sources.

The first phase covered more than 60 villages in the remote Gandoh area of Doda district. The second phase covered far-flung villages along the International Border in Kathua district.

"This free telemedicine facility at Billawar today will overcome the problems of accessibility, availability and affordability," Singh, the Union Minister of State in the Prime Minister's Office said, after inaugurating the service at the Mandli block in Billawar tehsil. The minister, who represents the Udham-

pur parliamentary constituency that als covers Kathua and Doda, said all the three obstacles such as quality of services, doctors and assistance, the distance of travel and the cost of consultation or treatment are targeted and resolved efficiently through this facility.

"Ordinarily, (treatment at) a metro hospital will cost a patient more than Rs 50,000 and may take two to three weeks' time. This type of free telemedicine mobile camp will solve all the problems, especially for those from weak socio-economic backgrounds," he said.

The minister said the camp at Mandli is being run by two startup groups from north and south India, respectively.

# Keep Calm

How do we make sense of the observed deficits with brightened growth prospects following acutely negative shocks that include a full-blown pandemic and oil price spikes?

ly-ended fiscal year has outstripped all expectations and forecasts. The 7.2% increase in GDP in 2022-23 (FY23), upon 9.1% recorded the previous year, has generated extreme optimism. This is reflected in the near-universal chorus about the economy's resilience, the resurgence of animal spirits and private investments, a new growth trajectory fired by public spending, reforms, digitalisation and more. It is bolstered further by India's placement as the fastest-growing major economy in the world by the International Monetary Fund's projections. The euphoria inspires deeper thinking, an examination of longer trends in the macroeconomy, if only because the antecedents of this strength are unusual — a series of negative macroeconomic shocks over a three-year slowdown, leading up to the pandemic in 2020-21. A look back illuminates the economy's evolution and provides a perspective as to where it stands at present.

conomic growth in the recent-

Commentators have flagged that absenting the -5.8% contraction in GDP inflicted by the pandemic in 2020-21 and retaining a steady growth rate of 4-5% in the last three years would imply a 2%-5% higher GDP level (the range reflects different counterfactual rates). This is a crude measure of the slack or the gap that remains to be recouped; alternatively, it represents the permanent loss of output after the pandemic.

Further clues are offered by simple comparisons of three-year averages of key macroeconomic aggregates in FY21-FY23 with the matching prepandemic period (2017-18 to 2019-20 or FY18-FY20), a time of continuous deceleration in growth (this had slowed from 8.2% in 2016-17 to 6.8%, 6.5%, and 3.9%, respectively, over FY18-FY20, or up to the pandemic).

Using this gauge, overall GDP growth averages 3.5% in the last three years against 5.7% in the pre-pandemic

reference period. Final consumption expenditure, adjusted for inflation, is slower, at 4.5% on average compared to a corresponding pre-pandemic 6.2%, which itself had been a sharp fall from the successive annual growth of 8% before. Fixed assets' creation has been more stable across the two time periods, with the average growth and share in aggregate output both improving a bit by the public capex support growth in the last three years. What is surprising is that government consumption grew slower on average in the last three years at 1.9%, contrasting poorly with the robust 7.5% three-year average growth recorded before the pandemic.

The biggest difference is made by exports' growth, an average 11.2% in the last three years and 2.6 times more than before the pandemic. The export stimulation added an average 3 percentage points annually to GDP growth after the pandemic, a significant increase from the single-point contribution before.

A similar appraisal of production or supply-side trends is equally instructive. Features that stand out here are the following: one, manufacturing has grown faster after the pandemic, at an average 5% compared to 3.3% in the reference interval of comparison. This is no doubt closely linked to the robust export growth observed above.

The biggest difference is made by exports' growth, an average 11.2% in the last three years and 2.6 times more than before the pandemic. The export stimulation added an average 3 percentage points annually to GDP growth after the pandemic, a significant increase from the single-point contribution before.

Two, the construction segment also increased pace by a similar magnitude (2 percentage points higher), upheld by public investments in the post-pandemic period. Three, the segment of trade, hotels, transport, communication, and broadcasting services displays a steep slowdown. Growth in this segment

has averaged a third of that recorded in the pre-pandemic period, a reflection of the harsh incidence of Covid-19 upon services in general. The share of this segment, which is marked by significant informality, has reduced on an average 2 percentage points in the gross value added after the pandemic. In FY23, while GDP accelerated to 7.2%, the share of this category in aggregate output was still one point lower than that in 2019-20. This broadly states the extent of the persisting deficit in the informal economy. A clear offset of this gap is mirrored in the agriculture sector, the fluid counterpart of the informal economy. Agriculture's share in overall value-added stands enlarged after the pandemic, with a corresponding increase in workers' engagement in agriculture captured elsewhere by official employment reports.

Altogether, these trends reveal that the pandemic's economic scars still linger despite the brisk growth recovery. Bear in mind that our reference period of comparison here was itself a time when economic performance was below potential or full capacity. At one level, this enables us to see the distance from those lowered levels. On another plane, our understanding must also factor in the growth support from catchup demand due to normalisation and

the economy's full reopening last year (FY23). The robust consumer spending of 7.5% annual growth may not be sustained as it was boosted by unspent incomes. Then too, much of this consumption strength is likely to be explained by inequality and asymmetry that have been systematically observed in the recovery period

The quarterly GDP data display signs of fading demand, the lower tiers pulled down by inflation. In the January-March 2023 quarter, private consumption contracted -3.2% over the previous quarter, slowing down to almost half its rate of growth one year ago. The consumption slowdown is part of a longer trend highlighted above. Joining these dots, including the enduring gap in the major services segments, there's enough ground for concern about the largest component of India's domestic demand. It is reinforced by the eventual slowing of the global economy that will undoubtedly impact exports that have dominantly upheld economic growth after the pandemic.

Does the optimism resonate with these macroeconomic trends or appear to be a paradox? How do we make sense of the observed deficits with brightened growth prospects following acutely negative shocks that include a full-blown pandemic and oil price spikes? Other than conclude that catch-up is still some way to go, do future uncertainties induce more caution than confidence? It is easy to get excited at data points but what matters is the trend, which shows us where economic well-being was, and is, at present.

# The Decline of Respect Towards Teachers: A Troubling Trend in Education

Moreover, the perception of teaching as a highly valued profession has waned in the present era. This is partly due to institutions hiring individuals without the prescribed professional qualifications for teaching roles, undermining the expertise and respect associated with the profession. Additionally, the negative portrayal of teachers in the media and popular culture further contributes to the

disesteem of the teaching profession.

Another contributing factor to this issue is the lack of support from parents and school administrations. Teachers are often left to handle disciplinary issues on their own, which can be overwhelming. When the authority of teachers is not upheld, students perceive them as powerless, thereby disrespecting them even more. Furthermore, the rise of technology and social media has transformed the way students communicate and interact with teachers, further eroding the respect traditionally accorded to them.

Moreover, the decline in respect towards teachers can be attributed to various other factors, including societal changes, moral



degradation, technological advancements, and a shift in values and attitudes towards authority and education. However, it is essential to delve into the scientific explanations that shed light on this issue.

From a behavioral psychology perspective, indiscipline in schools can be seen as a learned behavior resulting from a lack of reinforcement of acceptable behavior, both at home and within the school environment. Social psychology attributes indiscipline to various social issues, such as peer pressure to break rules, as well as societal norms that prioritize social status over academic achievements, devaluing the role of teachers. Neuroscience research suggests that environmental factors, including stress, can impact cognitive function, leading to indiscipline and poor motivation among students, thereby contributing to the devaluation of teachers. Furthermore, cultural differences play a significant role in shaping behaviors and values. Cultural norms within schools and classrooms can

influence indiscipline behaviors and the devaluation of teachers, with individualistic cultures prioritizing personal interests over academic achievement, while cultures emphasizing respect for hierarchy discourage constructive criticism of teachers.

While it is important to recognize the challenges faced by teachers in maintaining a healthy student-teacher relationship, it is also necessary to acknowledge that teachers themselves can contribute to the decline in such relationships. Here are a few reasons why teachers may be partly responsible for the erosion of a healthy student-teacher dynamic:

Lack of empathy and understanding: Some teachers may fail to empathize with their students' challenges and individual circumstances. This lack of understanding can create a disconnect between teachers and students, leading to a breakdown in trust and respect.

Ineffective communication: Communication plays a crucial role in building posi-

tive relationships. Teachers who struggle to effectively communicate with their students may find it challenging to establish a healthy rapport. Poor communication can lead to misunderstandings, frustration, and a sense of disengagement among students.

Failure to adapt teaching methods: Every student has unique learning needs and preferences. Teachers who rigidly adhere to a one-size-fits-all approach may struggle to engage and connect with their students. Failing to adapt teaching methods to cater to different learning styles can result in disinterest and disengagement among students.

Lack of enthusiasm and passion: Teachers who lack enthusiasm and passion for their subject matter may find it difficult to inspire and motivate their students. A lack of enthusiasm can lead to student apathy and a diminished sense of respect for the teacher.

A nationwide survey conducted by the EdWeek Research Center and commissioned by the Winston School of Education and Social Policy at Merrimack College revealed that teachers feel under pressure, lacking support, and facing increasingly high expectations. They often feel micromanaged and excluded from decision-making processes.

To address this issue, it is crucial to involve parents and school administrators in the disciplinary process, providing support to teachers and upholding their authority. Additionally, implementing behavior management programs that focus on positive reinforcement for good behavior can help cultivate respect in schools. Professional development opportunities


¶hain-Gang All-Stars is an ambitious novel by a determined author. Most novelists who want to address hideous social conditions imagine what might happen next and let the damaged characters and grim circumstances do the work. Adjei-Brenyah certainly does this. But via footnotes, he adds messages from history, contemporary and otherwise, to his tale of a world in which the treatment of people convicted of murder is even worse than what incarcerated men and women face in this country. And America leads the world, at least among allegedly democratic nations, in imprisoning its citizens. One such footnote makes that precise numerical point. Another footnote refers to the real life inhumane treatment of three men, Albert Woodfox, Robert King, and Herman Wallace, who all spent decades in isolation before two of them were released and one of them had died.

The characters in this narrative have been given an alternative to incarceration and constant, unimaginably painful torture. They can elect to fight each other like ancient gladiators, killing each other legally. This blood sport entertains large crowds conditioned to love mayhem as audiences today have been taught to swallow and wallow in fantasies of Reality TV. The two most significant warriors are women: Hurricane Staxxx and Loretta Thurwar. Each is worshiped by fans who follow every aspect of their idols' lives, in and out of the arena, via tiny, mobile cameras that fly constantly about their favorites. The two women are the primary "links" in a "chain," or squad, of lesser contestants trying to reach "High Free." Theoretically, if a warrior is successful enough in the arena, he or she can earn the right to walk away from the hellish world created by the profit-driven megacorporation that runs the private prison system, among other entities. ("Lowfree" is death sustained in the arena, the idea being that one way or another, free

free.)

the spectacle of men and women killing each other in order to gain "blood points," and perhaps even their release, there is a small group opposing establishment of a mad and murderous circus. But the novel is less about following the efforts of seek-

ing to not only end gladiatorial combat but incarceration itself, than it is about the development of Hurricane Staxxx and Loretta Thurwar. Their relationship is complicated. They depend on each other, they love each other, and, inevitably in a novel built the way Chain-Gang All-Stars is built, they must fight each other.

Adjei-Brenyah's politics are clear. He has the most significant member of the group opposed to the gruesome, statesanctioned combat recognize that al-

though "many politicians" had "implored non-violence" among the spectators in advance of the combat, this was "an absurd thing for the murderous state to plead for, but, as always, the massive violence of the state was 'justice,' was 'law and order,' and resistance to perpetual violence was an act of terror." But, because the author creates a world at least as repressive and violent as that of, for example, The Handmaid's Tale, he's had to be inventive and explicit in his descriptions of the grim things the authorities can do to incarcerated people and the almost equally violent punishments the combatants in the arena can inflict on each other with a variety of weapons. The latter will leave video game fans who read the novel drooling. But that raises the thorny issue of exploitation. Adjei-Brenyah's hope is that not too many readers of Chain-Gang All-Stars will think the combat the novel creates is cool. Who can be sure?

One function of dystopian novels is to alert readers to the awful potential of the systems we often take for granted. The implication is that — if all goes along as it has been going along — the future will be much worse than the present. Adjei-Brenyah felt that the best way to accomplish that is to educate his readers, via the aforementioned footnotes, about the cruelty and injustice that infests the carceral state in this country today, where men and women in prison are often so effectively isolated that people on the outside hear very little about what incarcerated people endure on a daily basis, for years. As of 2018, while 392 out of every 100,000 white men are incarcerated, 2,272 out of every 100,000 Black men claim that hideous distinction. He also points out that, under the U.S. Constitution, enslaving the incarcerated is legal.

Nana-Kwame Adjei-Brenyah is an energetic story-teller with a vivid, sometimes grotesquely grim imagination. He creates a terrifying future world. I'm glad that he chose to anchor that creation so powerfully in the shameful present.

### **Govt Likely To Come Out With Logistics Cost Estimate By Sept: DPIIT**

**NEW DELHI:** The government is working on a framework to assess the logistics cost in the country and is expected to get a realistic estimate by September, a senior DPIIT official said on Friday.

At present, the government is going by certain estimates, which suggest that India's logistics cost stands at about 13-14 per cent of the country's GDP (gross domestic product).

Special Secretary in t partment for Promotion of Industry and Internal Trade (DPIIT) Sumita Dawra said that the government is coming out with its logistics cost framework.

The framework would include elements of this cost and how to measure that.

"So our framework is being done with the help of our technical partner and it's almost done. But then we have to calculate and I think by the month of September, we will have realistic logistics costs in the country. We will define what are the components and we will have our own estimates," she said while speaking at CII's conclave on

trade facilitation.

Logistics cost plays a key role in facilitating trade and enhancing the competitiveness of traders.

The department conducted a workshop in March on the logistics cost framework, and a task force was set up to formulate a framework to determine the cost in the country.

The task force members include representatives from Niti Aayog, the Ministry of Statistics and Programme Implementation (MOSPI), the National Council of Applied Economic Research (NCAER), academic experts, and other stakeholders.

The government has rolled out a national logistics policy and PM Gati Shakti initiative to boost the competitiveness of the

industry and cut logistics costs. Speaking at the conclave, Sanjay Budhia, Chairman of CII National Committee on EXIM and Managing Director of Patton Group, said that continued focus on creating a paperless trading ecosystem by measures like faceless assessment, risk management system, and direct port delivery have started showing results at the ground level.

### **India's Forex Kitty Declines By USD 1.32 Bn To USD 593.75 Bn**

MUMBAI: India's forex reserves dropped by USD 1.318 billion to USD 593.749 billion for the week ended June 9, the Reserve Bank of India said on Friday.

The overall reserves had jumped by USD 5.93 billion to USD 595.067 billion for the previous reporting week. It can be noted that in Octo-

ber 2021, the country's forex kitty had reached an all-time high of USD 645 billion. The reserves have been declining as the central bank deploys the kitty to defend the rupee amid pressures caused majorly by global developments.

For the week ended June 9, major component of the reserves, decreased by USD 1.128 billion to USD 525.073 billion, according to the Weekly Statistical Supplement released by the RBI on Friday. Expressed in dollar terms, the

foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves dropped by USD 183 million to USD 45.374 billion, the RBI said. The Special Drawing Rights

(SDRs) were up by USD 2 million to USD 18.187 billion, the apex bank said.

# Module Forging Driving Licences For J-K Residents Using Details Of Security Forces Busted In Gujarat

New Delhi: A retired Navy official and another person were arrested after a major fake driving licence module was uncovered in Gujarat with links to Jammu and Kashmir where they forged the documents using details of security forces, officials said on Saturday.

The fake driving licence racket, which was active in Ahmedabad for nearly four years, was busted by the crime branch of the Gujarat Police based on inputs from the Southern Command Military Intelligence, they said.

The officials said 284 driving licences, 97 service motor driving license books, nine fake rubber stamps, three laptops, four mobile phones, 37 'No-Objection' certificates, nine serving certificates, five confirmation letters, 27 'speed post' stickers and digital pens were seized from the accused.

A case was registered and further investigation is on, they said, indicating that more arrests are likely soon.

Earlier, the country's biggest arms licence scam was detected in Jammu and Kashmir in 2017 which is currently being investigated by the CBI. The federal agency registered the first set of FIRs on October 16, 2018, in connection with alleged



irregularities in the grant of 2.78 lakh arms licences in 22 districts during 2012-16.

The officials said the Army's Southern Command Military Intelligence busted the driving licence scam, leading to the arrest of Santosh Singh, who was employed with the Indian Navy from 1991 to 2012, and Dhaval Rawat, an RTO agent in Gandhinagar who used to provide driving licences to individ-uals of Jammu and Kashmir on

the basis of fake certificates of security forces

The accused, who were apprehended on Friday, revealed that they have supplied more than 1,000 driving licences to their handlers, the officials said, adding they used to work on the behest of Ishfaq, Waseem and Nassar Mir, who are based in Uri, where they reportedly run a driving school.

The officials said the accused also revealed that they earned

more than Rs 50 lakh this year alone, though they were active for nearly four years.

"Obtaining a driving licence on fake documents belonging to security agencies is a matter of grave concern as these driving licences can further be used for obtaining other official documents like passports by inimical persons. The module could also have been exploited to make fake driving licences of illegal Bangladeshi migrants," an official privy to the probe said. He said Singh, originally from

Madhya Pradesh, started making driving licences for soldiers of various battalions of the security forces in Gandhinagar.

During this time, he was contacted by the three Jammu and Kashmir residents and some others and was asked to forge driving licences using details of jawans and security forces battalions, the official said

"Singh has been making licences for security forces for the past several years and knows very well what documents are required. His contacts in Jammu and Kashmir used to send the Aadhaar card and the photo of the person whose driving licence is to be made," he said. The official added that Singh ordered a coin-making machine online to forge coins for various battalions.

Rawat worked with Singh for two years and knew how he was making fake driving licences, he said.

In order to avoid having to appear in person for document verification and live photo taking, applicants used to get driving licences by paying middle-men at the RTO office, the official said, adding the licences were delivered to Ayan Umar, who forged RTO 'No-Objection' certificates to change the addresses to Jammu and Kashmir.

## **Pre-arrest Bail** Extraordinary Remedy To Be Granted In Extraordinary Cases, Says Delhi court

New Delhi: A Delhi court has denied pre-arrest bail to a man accused of involvement in organised cyber crime, saying anticipatory bail was an extraordinary remedy and is to be given only in extraordinary cases. Vacation Judge Aparna Swami dismissed the application filed by Shivam Kumar, and directed him to join the investigation.

"Anticipatory bail is an extraordinary remedy and is to be given only in extraordinary cases. The present (case) does not warrant the same and thus, in light of the above discussion, I do not find this to be a fit case for grant of anticipatory bail," the judge said in an order passed on June 12.

The court noted the case involved around 600 victims who were cheated of Rs 4.47 crore.

The court also noted cyber police of seven states had issued notices for freezing the bank account of the company of the accused.

"This being an economic offence, it must be dealt with

sternly in the matter of bail... For the case to be taken to its logical end, it requires detailed investigation, which in turn is dependent on sustained interrogation of the applicant/accused," the judge said.

The accused had sought anticipatory bail, claiming he was only a director in the company and had no role in the offence. He alleged he was falsely implicated in the case.

The prosecution opposed the application on the ground that an amount of Rs 14 lakh cheated from the victims was yet to be recovered and his custodial interrogation was needed to unearth the conspiracy.

According to the prosecution, Rs 14 lakh of the cheated amount was transferred to the bank account of the company where the applicant was one of the directors. An FIR was lodged under various sections including 420 (cheating) and 120B (criminal conspiracy) of IPC.

The prosecution claimed the accused had not joined the investigation despite notice and also switched off his mobile phone.

## HC seeks presence of Delhi Waqf Board CEO over non-payment of salaries to employees

New Delhi: The Delhi High Court has directed the chief executive officer of Delhi Waqf Board to come before it and explain the reasons for non-payment of salaries to board employees for several months in spite of a court order directing clearance of the outstanding dues.

Justice Jyoti Singh said the petition of the Delhi Waqf Board Employees depicts a "very sorry" state of affairs as admittedly the employees have not received their salaries for nearly nine months. The authorities

were "totally insensitive" to the plight of the employees who were finding it difficult to make two ends meet, the judge said.

Prima facie, the court said, there is scant regard for court orders, as despite there being an assurance on the last date of hearing, there was no certainty as to when salaries would be paid and now the "usual and casual response" is that the matter is under consideration and there is deficiency of funds.

"In this view of the matter, this Court deems it appropriate to direct Md. Rehan Raza, Chief Executive Officer/Respondent

No. 1 (Delhi Waqf Board) to remain present in Court on the next date of hearing i.e. 11.07.2023 at 02.30 PM, to explain the alleged non-compliance of the orders passed by this Court and nonperformance of the statutory obligations of the Delhi Waqf Board to pay salaries and allowances to its employees," said the court in

its order passed on June 1. "It appears that the Respondents are totally insensitive to the plight of the employees who are without their salaries and it needs no emphasis that they are finding it difficult to make two ends meet and fend for themselves and their

families," it said.

It said prima facie the court is of the view that the respondents have scant regard even for the orders passed by it as despite an assurance given on the last date of hearing that the dues will be cleared within two weeks, even today there is no certainty as to when the petitioners will receive their salaries.

The petitioner association along with an individual employee had moved the court earlier this year, claiming they had not received their salaries since October last year and were facing "unfathomable financial hardships".

The petitioners alleged there was non-compliance of an order passed by the court on March 27 directing the respondents- the city government and Delhi Waqf Board authorities- to clear the outstanding salaries of board employees of over six months

within two weeks.

Advocate M Sufian Siddiqui, appearing for the petitioners, argued before the high court that the aggrieved employees have been robbed of their right to a dignified life in a brazen infraction of their fundamental and constitutional rights.

"The employees of Delhi

Ali has figures of 1-82 from 18 overs — including being hit for six three times, twice by Khawaja – but went into the match knowing England captain Ben Stokes was happy to back a bowler always on the attack even at the cost of being expensive.

After dismissing Head, Ali deserved Green's wicket two balls later but Jonny Bairstow spilled a clear stumping chance in what has otherwise been a superb Test for the wicketkeeper-batter.

### **Bangladesh Thrash Afghans** In Record 546-Run Win

MIRPUR: Bangladesh crushed Afghanistan by 546 runs in their one-off test on the fourth day in Mirpur on Saturday for the biggest test win by runs in the 21st century after fast bowler Taskin Ahmed claimed career-best figures of 4-37. The visitors, playing their first test since 2021, were set a daunting target of 662 and were dismissed for 115 after last batter Zahir Khan retired hurt after being hit by a Taskin bouncer.

Bangladesh, whose ous biggest win was by 226 runs against Zimbabwe, earned the biggest test win by runs since Australia's 562-run victory over England in 1934. England hold the all-time record with a 675-run

win over Australia in 1928. Taskin spearheaded the pace attack that combined to take 14 wickets in the match, with Shoriful Islam chipping in with 3-28 as Afghanistan, who resumed at 45-2 on Saturday, stumbled early when Nasir Jamal (6) edged Ebadot Hossain in the third over.

Shoriful had Afsar Zaxai (6) caught at gully and dismissed Bahir Shah (7) before Rahmat Shah, who top-scored with a dogged 73-ball 30, was caught behind the stumps off Taskin. Karim Janat hit two sixes before Taskin bowled him for 18 while Mehidy Hasan removed Amir Hamza (5) to leave Afghanistan at 106-8.

Taskin had Yamin Ahmadzai caught at mid-off to get his fourth in the next over before Zahir was hit on the elbow while trying to duck a short ball and had to retire hurt. Bangladesh made 382 in the first innings, with Najmul Hossain Shanto scoring 146, and bowled out Afghanistan for 146 in reply.

# FIFA Says Vinícius Júnior Will Help Tackle Racism In Revived Task Force

GENEVA: Brazil and Real Madrid star Vinícius Júnior has agreed to join a new task force to tackle racism in soccer, FIFA president Gianni Infantino said Thursday Vinícius, who is Black, has

been the target of sustained racist abuse by fans in Spanish stadiums throughout the season, with little done by referees or soccer bodies to protect him. That must stop, Infantino

said in an Instagram post after he met the player at a Brazil training camp in Barcelona.

"There is no football if there is racism! So let's stop the games," Infantino wrote.

"We will also strengthen the engagement with players on this crucial topic so I am glad Vinicius accepted to be part of a task force which will include other important players and will elaborate concrete and efficient measures to end racism in football once and for all."

Vinícius spoke to reporters for the first time since he was racially abused in a Spanish league match in Valencia last month. He thanked everyone who supported him.

"Everyone has been giving me strength so I can continue in this battle," he said. "We needed someone to stay strong to try to improve this. I want to keep going for all the youngsters and for all the people who suffer with this but don't have the same voice that I have.'

Vinicius did not take any questions from reporters.

FIFA created an anti-racism task force in 2013 after a notorious incident of abuse suffered in Italy by AC Milan midfielder Kevin-Prince Boateng, who is

Boateng worked with the task force which FIFA shut down in 2016, months after Infantino was elected. FIFA said then the task force had "completely fulfilled its temporary mission.'

Shutting down the antiracism panel had been "a monumental mistake," one of its members, British-Nigerian journalist Osasu Obayiuwana, said Thursday.

# **Been Partitioned If Netaji** Was There": Ajit Doval

New Delhi: Netaji Subhas Chandra Bose had the audacity to fearlessly challenge the British and India would not have been partitioned if he was there at that time, National Security Advisor Ajit Doval said on Saturday.

Mr Doval said Bose was determined to fight the British for India's Independence and never wanted to beg for freedom, adding he not only wanted to end political subjugation but felt that the political, social, economic and cultural mindset of the people has to be changed and "they should feel like free birds in the sky".

The National Security Advisor (NSA) said this while delivering the first Netaji Subhas Chandra Bose memorial lecture organised by the industry chamber ASSOCHAM.

In the course of his address, Mr Doval delved into various aspects of Bose's life and noted that he even had the audacity to challenge Mahatma Gandhi. But at the same time, Mr Doval noted that Bose had a deep respect for Gandhi.

"The seed, the idea that came to his mind was 'I will fight the British, I will not beg for freedom. It is my right and I will have to get it'," Doval said.

"India would not have been partitioned if Subhas Bose was there. Jinnah said I can accept only one leader and that is Subhas Bose," he added. Mr Doval said Bose's contribu-

tion to India is exemplary. "In Indian history, there are very few parallels or in global history where people had the audacity to sail against the current -- and not an easy current. It was the current of the mighty British empire," he said.

"Netaji said I will not compromise for anything less than full independence and freedom," Mr Doval said.

Netaji said "I want to free this country not only from political subjugation" but felt that the political, social, economic and cultural mindset of the people has to be changed, and "they should feel like free birds in the sky", the NSA added.

"Bose possessed audacity like no other. He had the courage to challenge the prevailing powers, regardless of the consequences. His



audacity was evident throughout his life, from his journey to London for the ICS to his escape from India during detention. He displayed un-paralleled bravery and determination," Mr Doval said.

Highlighting the legacy of Bose, Mr Doval spoke about Netaji's ability to unite people from diverse backgrounds and how he envisioned a unified and strong India.

"Bose's leadership was exceptional. He recognised India as a reality, transcending divisions of caste, religion, and ethnicity. His vision of a united India is encapsulated in his famous slogan 'Kadam Kadam Badhaye Ja'.

"It resonated with people across all walks of life. He inspired them to fight for their country, united in their pursuit of freedom," Mr Doval said.

The NSA said Bose was a secular person and that he was deeply religious. Mr Doval said Bose's efforts were driven by his passion for patriotism and his unwavering dream of a great India. The NSA said Bose was a highly religious man.

"Bose's efforts were monumental, fuelled by his romantic ideals of patriotism and his unwavering

hope for a great India.

"History may have been unkind to him, but his impact and nationalism continued even after his passing. He left an indelible mark on the hearts and minds of countless Indians who were inspired by his extraordinary journey," he said.

**London:** Britain's King Charles celebrated his first official birthday parade as sovereign on Saturday, riding on horseback to inspect soldiers in a ceremony that has been an annual event since 1760.

In what is the British military's annual tribute to the monarch, Charles was greeted by a Royal Salute, and carried out an inspection of soldiers in front of 8,000 spectators, followed by his son the Prince of Wales, his sister Princess Anne and his brother the Duke of

Antoine Arnault shared a few pictures from the lunch on Instagram Stories where Elon Musk and Bernard Arnault are seen posing together.

After lunch, Elon Musk attended the seventh edition of the Viva Technology conference, which was held from June 14 to June 17 in Pairs, France. The annual conference was founded by the Publicis Groupe SA and Les Echos, which are owned LVMH. It is "Europe's biggest startup and tech event" aimed at promoting innovation by connecting tech leaders, startups, major corporations, and investors.

Elon Musk and Bernard Arnault were among the official speakers at the technology conference. Other speakers included French President Emmanuel Macron, Co-Founder of Salesforce Marc Benioff, and VP and Chief Al Scientist at Meta Yann LeCun among others.

Emmanuel Macron also shared a picture with Elon Musk on Twitter where the two were seen smiling and shaking hands. "Let's work together!" the French president wrote.

According to Forbes, Elon Musk is the world's wealthiest person with a net worth is \$236.9 billion while Bernard Arnault and family is ranked second with a net worth of \$233.4 billion. The Tesla CEO recently reclaimed the title of being the richest person in the world. Bernard Arnault had surpassed him in December when the tech industry was struggling but luxury showed resilience in the face of inflation. Bernard Arnault's LVMH owns brands including Louis Vuitton, Hennessy, and Fendi.
