

# **'Cancer Medication Helps To Fight Against Malaria'**

group of UCF researchers are looking to use cancer pharmaceuticals to hasten the development of fresh, life-saving malaria treatments because the disease is getting more and more resistant to existing medications.

The findings of the study were published in the ACS Infectious Diseases journal.

Malaria, one of the most prevalent infectious diseases in the world, is a potentially fatal condition brought on by parasites of the Plasmodium species and spread through the bite of infected mosquitoes. It causes more over 600,000 fatalities annually, primarily in sub-Saharan Africa. Around 80% of these

fatalities involve youngsters under the age of five.

'Over time, genetic mutation of the malaria parasite makes it resistant to current drugs," Chakrabarti says. "The World Health Organization reported that malaria parasites are increasingly becoming resistant to the current therapy used to treat malaria, which was discovered in the 1990s. So, new and more effective drugs for malaria are long overdue as about 30 years have gone by since we have had a new class of compounds in the market against malaria." But drug discoveries can take years, even decades, Chakrabarti explained, as compounds go through many phases of testing for efficacy and safety.

"One of the ways we can accelerate the discovery of new treatment options is to use existing



drugs that are already approved by the Food and Drug Administration," Chakrabarti saiys. "This is called taking a piggyback approach, looking at existing drugs that are already on the market to see if they have antiinhibitors -- drugs originally develmalarial properties. This will help oped for cancer treatment -- for an

to shorten the initial stages of drug discovery which is usually quite time-consuming." To meet the urgent need for new drugs, the team

decided to repurpose protein kinase

accelerated path to drug therapy for malaria. Protein kinases are enzymes that regulate proteins in the body and are heavily targeted for cancer and other disease therapies by the pharmaceutical industry. Protein kinases are very important for the malaria parasite's life cycle and as such make good drug targets As part of the study, Ph.D. can-

didate Monica Bohmer, working under Chakrabarti's supervision, tested a range of anti-cancer protein kinase inhibitors to identify inhibitors that are known to target human Polo-like kinase, a type of protein kinase that plays an important role in cell division in humans. She discovered that a group of inhibitors, specifically BI-2536, a known human Polo-like kinase 1 inhibitor, exhibited strong antimalarial properties.

#### **Kashmir Sizzles At** 34.8 Deg Celsius

Second Warmest June In A Decade

#### Agencies

Srinagar: Sweltering heat conditions continued unabated in Kashmir Valley as Srinagar recorded season's hottest day and 2nd warmest June day in a decade on Thursday.

Quoting a meteorological department official, news agency GNS reported that the maximum temperature in Srinagar soared to 34.8°C and it was 5.6°C above normal for the season. Today's temperature surpassed the previous highest of 34.0°C recorded only yesterday and was the second warmest day in June in a decade, the official said. He said barring 3 June 2018 when mercury increased to 35°C, never in a decade the mercury has soared above 34.8 in the summer capital of J&K. Other places including Pahalgam (29.3°C), Qazigund (34.6°C), Kokernag (32.7°C), Kupwara (33.7°C) and Gulmarg (26.0°C) also recorded the hottest day of the season so far, he said.

Qagizund and Kokernag, he said, recorded the hottest June day in more than a decade

He said Gulmarg recorded the hottest June day in nine years as mercury had on 15 June 2014 touched 26.2°C. Night temperature also saw an increase at most places as Srinagar recorded a low of 20.5°C against 19.7°C on the previous night and it was above normal by 4.79°C for the summer capital. More on P10

**Srinagar:** In order to combat the ongoing heat wave in Kashmir, the School Education Department Thursday issued detailed instructions to be followed by all educational institutes.

In the guidelines regarding precautions to be observed by schools to combat the ill-effects of heat wave, Directorate of School Education Kashmir (DSEK) in a circular said that the prevailing heat wave in various parts of Kashmir Division may pose a risk at times to the health of the school going Students.

# Air Conditioning In India **Poses Risk Of Dramatic Rise In Emissions: Study**

The increasing use of air conditioners in India could lead to a rise in emissions by as much as 120 million metric tonnes by 2050, according to a study.

The research, published in the journal Scientific Reports, is the first to illustrate the impacts of climate change on the demand for air conditioners and electricity for cooling in Europe and India.

Between now and 2050, with the current fuel mix, there is a risk of a mismatch between what is done for adaptation and mitigation, with increased



emissions as a result, the researchers said.

The rush to buy new air conditioners in the residential sector and the resulting increased use of electricity associated will characterise both relatively richer but more temperate European countries, and relatively poorer but warmer Indian states, they said.

The study estimates that by 2050, under an over 2-3 de-

#### grees Celsius warming forecast, air-conditioning uptake could double in Europe and grow fourfold in India, reaching about 40 per cent of homes in both regions.

More air conditioning will bring benefits to the population by reducing the heat exposure connected to global warming. Researchers have estimated that cooling technologies will lead the population being exposed to 40 per cent less heat in Europe and 35 per cent less in India by 2050.

On the other hand, this will have a strong impact on emissions. Between now and 2050 the energy production required by the increased use of air conditioners will cause a rise in annual CO2 emissions between 7 and 17 million tonnes in Europe, and between 38 and 160 million tonnes in India.

"With electricity production still based essentially on fossil fuels, air conditioning as a heat adaptation strategy risks undermining our mitigation efforts, i.e., reducing greenhouse gas emissions," said Enrica De Cian, professor at Ca' Foscari University of Venice, Italy.

Researchers noted that mitigating these increases would require a significantly higher energy efficiency of air conditioners sold, which, especially in India, is far below the efficiency of the best available models

WASHINGTON DC: Prime Minister Narendra Modi, who is on his first state visit to the US on Wednesday (local time) gifted a handcrafted sandalwood box with Das Danam to US President Joe Biden and a lab-grown green diamond to First Lady Jill Biden.

The gifts were exchanged during the private dinner hosted by Joe Biden and Jill Biden for PM Modi at the White House.

The special sandalwood box presented to US President Joe Biden has been handcrafted by a master craftsman from Jaipur, Rajasthan. The sandalwood sourced from Mysore, Karnataka has intricately carved flora and fauna patterns, officials said.

The box contains a silver idol of Lord Ganesha, the Hindu deity considered as the destroyer of obstacles and the one who is worshipped first among all gods. The idol has been handcrafted by a family of fifthgeneration silversmiths from Kolkata.

The box also contains a diya (oil lamp) that occupies a sacred space in every Hindu household. This silver diya has

also been handcrafted by artisans from the family of fifth-generation silversmiths in Kolkata. The copper plate also called tampra-patra has been sourced from Uttar Pradesh and a shloka has been inscribed on it.

The handcrafted delicate silver boxes contain symbolic Das Danam or the ten donations which denote the donations made on the occasion when a person becomes Drishta Sahasrachandro or the one who has seen one thousand full moons when he completes the age of eighty years and eight months.

At this stage of life, the individual (who has seen one thousand full moons) is honoured and celebrated for the sheer experience of human life. During Sahasra Poorna Chandrodayam celebrations, there is a custom of Das Danam or donations of ten different kinds, which include - Gaudaan (cow), Bhudaan (land), Tildaan (sesame seeds), Hiranyadaan (gold), Ajyadaan (ghee or clarified butter), Dhaanyadaan (food grains), Vastradaan (clothes), Guddaan (jaggery), Raupyadaan (silver) and Lavandaan (salt).

## **Pregnant Woman** Accidentally Shot Dead By 2-Year-Old Son In US

WASHINGTON, UNITED STATES: A pregnant woman and her unborn child died last week in the US state of Ohio after her two-year-old son shot her in the back with a handgun left loaded in the house, police said.

Police chief David Smith told local media on Tuesday that 31-year-old Laura Ilg had called 911 on the afternoon of June 16.

"She explained she was 33 weeks pregnant and her two-year-old had accidentally just shot her in the back with a firearm," Smith said to local ABC affiliate News 5 Cleveland.

Police on Friday arrived quickly at the home in Norwalk, Ohio, and Ilg was rushed to hospital, but her unborn baby could not be saved after an emergency c-section, Smith said.

Ilg died from her injuries hours later, he added. Early Saturday, the Norwalk Police Department said on its Facebook page that it offered "sincere and heartfelt condolences to the family, friends, and all those affected by the tragic passing of the young mother and her unborn son.

Ilg was conscious when police arrived and told officers that her son had somehow gotten into the usually locked bedroom while she was doing laundry and started playing with the gun, according to Smith.



Quit Worrying On Hurriyat: PM To Atal

EW DELHI - Brushing aside the charge that the Govern-ment mishandled Hurriyat leaders' visit to ' Pakistan, Prime Minister Manmohan Singh has affirmed its commitment to take the Indo-Pak dialogue process forward while ensuring that India's vital interests are fully safeguarded. Replying lo a letter from former Prime Minister Atal Bihari

Vajpayee on June 15. Singh emphasised that there was no room ambiguity regarding India's position on Jammu and Kashmir in its discussions with Pakistan or actions.

'I have reiterated on every possible occasion that there can be no redrawing of boundaries. We have also ruled out any role for a third party — either through intervention or as guarantor or as mediators—in am form." he said in his letter dated June 20 to Vajpayee

He said that India had consistently held that the dialogue with Pakistan was predicated on its commitment to end cross border terrorism, as outlined in the joint statement of January six 2004. 'The centrality of this position was recently reflected in the Joint Statement released after my meeting with President Musharraf." With regard to the Hurriyat leaders' visit to Pakistan. he said it was not correct to stale that the authorities on the Indian side had mishandled it.

By allowing the Hurriyat leaders to travel beyond Pakistanadministered Kashmir. Islamabad violated the understanding reached between the two countries on the Srinagar-Muzaffarabad bus service

Drawing Vaipavees 'attention to the fact that the Hurrivat leaders have regularly met dignitaries from Pakistan visiting India as well as its diplomats in the last four or five years, the Prime Minister said that their track to Pakistan-administered Kashmir using Srinagar-Muzaffarabad was cleared on the basis of agreed procedures. "That Pakistan decided to invite them to visit Islamabad and other cities in Pakistan violated an understanding on these procedures that had been reached between India and Pakistan." Singh said.

He said passports were issued to those Hurrivat leaders who did not possess it and made request for the issue of such documents

Noting that Hurriyat Conference was one of the groups that is outside the electoral process in Jammu and Kashmir, the Prime Minister said that nevertheless, the Government was willing, to enter into dialogue with such groups provided they agree to abjure the path of violence.

# PM's US visit

S President Joe Biden warmly welcomed Prime Minister Narendra Modi to Washington on Wednesday, terming ties with India as. "one of the defining partnerships of our age." Spanning two days of crucial talks, the visit highlights the growing recognition of India's rise as a key global player.

The United States sees India as a strategic counterweight to China, seeking to harness the potential of the world's most populous democracy. President Biden aims to bolster India's influence on the world stage, acknowledging its significant role in shaping the Indo-Pacific region and beyond.

The anticipated agreements between the two leaders encompass a wide range of areas, including defense cooperation and sales, artificial intelligence, quantum computing, and investments by prominent US companies like Micron Technology. The American multinational corporation General Electric (GE) on Thursday announced it has signed an agreement with India's state-owned Hindustan Aeronautics Ltd (HAL) to make fighter jet engines for the Indian Air Force (IAF). These collaborations not only enhance bilateral ties but also underscore India's emergence as a vital partner in key technological and strategic domains.

Prime Minister Modi's visit, distinguished by its full diplomatic status of a state visit, signifies the importance that the US gives to its relationship with India. But more than that it shows India's arrival on the global stage as a major power whose cooperation is sought to address the key global concerns of the day. The reception accorded to PM Modi by American CEOs and his meeting with Tesla's Elon Musk showcase the recognition of his role in bolstering economic growth and innovation in India.

Both the PM Modi and Biden face the common challenge of navigating China's growing influence in the Indo-Pacific region and other spheres. While the visit is not solely centered on China, discussions regarding China's role in military, technology, and economic domains are expected to feature prominently.

The visit included a private dinner at the White House and visits to key institutions such as the National Science Foundation. There was a colourful arrival ceremony on the White House South Lawn before Oval Office talks. The high-profile visit served as a platform for deep strategic discussions and tangible progress across various dimensions of the bilateral relationship.

That said, the visit is also about the evolving new geopolitics in the world where China is fast emerging as a rival to the US. So, the primary motivation behind the US outreach to India is to draw India into its orbit. But India has traditionally zealously guarded its independence and refused to be part of any geopolitical bloc. It has always acted in the interest of its people. With the US also, India will rather prefer a relationship based on accommodation of each other's interests and concerns rather than act in subservience to the US interests.

arious studies over the years have shown a disconcerting trend of rising domestic abuse in Jammu and Kashmir. Recently, a study conducted by Department of Community Medicine, Government Medical College, Srinagar, revealed that 6.5 percent women in Srinagar started experiencing intimate partner violence during covid-19 lockdowns. ## On Danger at Sea: Looking Out for all those in Peril

nly about 100 survived, making this one of the deadliest disasters in the Mediterranean. Greece and the EU blame eople smugglers, who overcrowd boats and abuse those aboard them. But both have profound questions to answer about their own role in such disasters. Activists say authorities were repeatedly warned of the danger this boat faced, hours before it went down, but failed to act.

Greece has said that the vessel was moving steadily, was not at risk, and that passengers refused help; survivors and tracking data paint a very different picture. The Greek coastguard's record includes forcible and dangerous pushbacks of asylum seekers, with a recent video showing a family including small children being set adrift on a raft. Frontex, the EU's border and coast guard, is also rightly – under growing scrutiny.

Ursula von der Leyen, the European Commission president, has praised Greece as the bloc's "shield" against migration - not only applauding its role, but using the language of combat and selfdefence. Josep Borrell, the EU's foreign policy chief, last year described Europe as a "garden" and most of the world as a "jungle" which "could invade" it unless there was greater engagement. Following the backlash, he said he was sorry "if some were offended" and insisted he was referring to the rule of law in contrast with lawlessness. On the most generous interpretation, he showed a startling ignorance of the implications of such language. On a more cynical one, he pandered to it.

The rhetoric of a hostile world's encroachment upon Europe is used in part to try to stem the advance of the far right, showing that mainstream politicians and officials are not ignoring the issues it exploits to win support. But this contributes to an environment in which there is a growing sense of an "us", living in safety and relative comfort, menaced by a "them" seeking the same things. Most of those on board the boat last week are believed to have been Pakistani nationals, who had grown desperate as the country's economic situation deteriorated.

prepared. Inside the shed, classrooms have been created using thighhigh tin sheets and their walls are dotted with whiteboards, maps and various charts. Teachers' lessons from different classes overlap.

Due to the metal sheets, the students and teachers sweat profusely in the summer and shiver in the winter.

On some days, when the heat gets unbearable, teachers prefer to take classes under the shade of a tree.

With the village shooting into the limelight due to Basit's achievement, the students hope that the authorities will soon take steps to construct a school building.

A student, Munazah Nisar, told PTI that the heat becomes

so unbearable at times that children find it hard to even

"I hope the school building is constructed expeditiously," she said.

Another student, Toiba Jan, said "Our school does not have a building. There is no water facility or even a toilet. We study inside a tin shed which was built by our teachers."

It is due to the teachers' efforts that the students are able to study, she said, adding, "We appeal to the government to construct a school building for us at the earliest.'

Jammu and Kashmir Civil Society chairman Mohammad Altaf said the condition of the school was brought to his notice by locals when he visited the village to facilitate Basit.

"Two schools have been clubbed and are housed in a tin shed. The teachers also suffer as other classes have to be stopped when one class is in session," Altaf said.

He appealed to the administration to address the issue on priority.

While Pulwama's Chief Education Officer (CEO) Abdul Qayoom refused to comment on the matter, Deputy Commissioner Basharat Qayoom said he has sought a report from the CEO and will comment only after receiving it.

# Lab-Grown Meat Approved For Sale In US, Becomes 2nd Country To Do So

#### AFP

Washington: The United States has granted its first ever approvals to two companies to sell chicken grown directly from animal cells, becoming only the second country to allow lab-grown meat to be offered to consumers.

The US Department of Agriculture (USDA) approved food safety systems at facilities of Upside Foods and Good Meat, a spokesper-



son for the agency told AFP Wednesday, with the companies adding the products would be available soon at select restaurants.

Both Upside Foods and Good Meat were cleared on safety grounds by the Food and Drug Administration in November, and the USDA last week reviewed and approved their product labels to ensure they were not misleading.

"This approval will fundamentally change how meat makes it to our table," said Uma Valeti, CEO and founder of Upside Foods, in a statement.

"It's a giant step forward towards a more sustainable

future -- one that preserves choice and life."

Josh Tetrick, CEO of Good Meat, the cell-cultured food division of Eat Just, added its "cultivated meat" was now "approved to sell to consumers in the world's largest economy."

Producing the meat in large, high-quality volumes is expensive.

But, following approval, Upside processed its first order, placed by three-Michelinstar Chef Dominique Crenn's restaurant Bar Crenn in San

Francisco. Good Meat, meanwhile, started production of its first batch that will be sold to celebrity chef and philanthropist Jose Andres.

Andres will sell the product at a yet-to-be-revealed restaurant in the capital Washington.

Several start-ups are aiming to produce the so-called lab-grown meat, which would allow humans to consume animal protein without the associated environmental harms of farming or animal suffering.

The products differ from plant-based substitutes such as soy burgers that mimic the texture and flavor of meat but do not contain any animal protein. Eat Just was the first

to receive authorization to make artificial meat, in Singapore in 2020.

While succeeding in the general lab-meat market has proven complicated, some companies have set their sights on pet food, whose consumers are less picky.

SRINAGAR- With the onset of Tourist Season in the Union Territory of Jammu & Kashmir and huge tourist inflow in the tourist areas, Enforcement Wing of Quality Control Division, Directorate of Handicrafts have

started special Inspection drives to check if the deal-



ers are carrying on the business of notified craft items in conformity to the Jammu & Kashmir Tourist Trade Act 1978, Jammu & Kashmir Namdha Quality Control Act 1960 and Jammu & Kashmir Handicraft Quality Control Act 1978. The aim of such inspec-

tions is to preserve the centuries old cottage industry and safeguard the interests of Handicraft artisans, whose livelihood is at stake due to the influx of machine made products in the market often misbranded and sold in the just by the click of a button. The label also provides the details of an artisan/manufacturer. This step will go a long way in empowerment of the real stake holders, who shall also have to play a vital role in promotion of the GI labeling/ QR coding of notified craft products.

Meanwhile, on 21 June, 2023, a special inspection drive was conducted by the field inspection team in respect of Handicrafts dealers operating in the Nishat and Shalimar tourist areas. During the course of inspection some handicraft dealers found violating the norms of the above acts and were penalized with an amount of Rs 40,000. The dealers were strictly warned to desist from the sale of fake machine made lookalikes of Kashmir art products and advised to affix tags depicting price and composition on each item displayed for sale.

It was advised that they should also refrain from any kind of malpractice such as touting and impersonation, which carries huge penalties under the said acts.

All the visiting tourists through the medium of this press release are hereby informed, to ensure purchase of only genuine handicraft items especially GI tagged notified Kashmir Art products from such handicrafts business establishments which are registered with Directorate of Handicrafts & Handloom. They should also seek from the dealer Cash memos for every purchase and retain /preserve the copy of the same for any future use

#### **Biden Welcomes**

Modi is seeking to raise the influence that India, the world's most populous country at 1.4 billion, has on the world stage in the wake of strained ties with neighboring China

"This grand welcome ceremony at the White House today is an honor and pride for the 1.4 billion people of India," Modi said, speak-ing in Hindi. "This is also an honor for more than 4 million people of Indian origin living in the U.S. For this honor, I express my heartfelt gratitude."

Both leaders noted that their country's constitution started with the same three words, "We, the people."

The festival-like opening cer-emony featured violinist Vibha Janakiraman and a cappella group Penn Masala performing renditions of songs by the American group Maroon 5 as well as from movies featuring Bollywood superstar Shah Rukh Khan.

Biden said in the Oval Office before their private conversation that the two countries' relationship needed to be "one grounded on democracy, human rights, freedom and rule of law.

Modi, reading from prepared remarks, said all eyes were on the world's two largest democracies. NEW US INDIA DEALS

Biden administration officials say sweeping agreements to be announced on semiconductors, critical minerals, technology, space cooperation and defense cooperation and sales will ring in a new era in relations between the two countries.

Some are aimed at diversifying supply chains to reduce dependence on China. The United States has also sought to address China's rising influence in the Indo-Pacific region by bolstering defense ties with countries like India and Australia.

Biden and Modi will sign off on what one official called a "trailblazing" deal to allow General Electric (GE.N) to produce jet engines in India to power Indian military aircraft, through a memorandum of understanding with Hindustan Aeronautics to produce the engines.

U.S. Navy ships in the region will be able to stop in Indian shipyards for repairs under a maritime agreement, and India will procure U.S.made armed MQ-9B SeaGuardian drones.

U.S. chipmaker Micron Technology's \$2.7 billion plans a new semiconductor testing and packaging unit, to be built in Modi's home state of Gujarat. The U.S. will also make it easier for skilled Indian workers to get and renew U.S. visas.

India also agreed to join the U.S.led Artemis Accords on space exploration and to work with NASA on a joint mission to the International Space Station in 2024.

Modi has been to the United States five times since becoming prime minister in 2014, but the trip will be his first with the full diplomatic status of a state visit. The two leaders held a private, intimate dinner at the White House on Wednesday night. Biden and his wife lill were set to give Modi gifts including a vintage American camera, a print of George Eastman's patent of the first Kodak camera, a book of American wildlife photography and a signed first edition of Robert Frost poems. Modi will address U.S. CEOs at a reception on Friday, as American companies plan new investments in India.

President Biden described the relationship between the US and India as one of the most defining relationships in the 21st century.

They are likely to take questions from journalists. Normally each side takes two questions, but sometimes it can be one from each side. During the last Indian State visit of former prime minister Manmohan Singh in November 2009, the two sides took one question each.

The prime minister would then head to the Congress to deliver an address to the joint meeting of the US Congress, which would be attended by Congressmen and senators in the presence of several hundred Indian Americans from the visitor's gallery.

In the evening, President Biden and the First Lady will host a State Dinner at the South Lawn of the White House, which is expected to be attended by 400 guests.

Preparations for the visit have been going on for more than six months now and a lot of efforts have gone to ensure that the deliverables are historical in nature.

The major areas include space, education, defence, technology, climate change and health.

missed by Lt Governor Manoj Sinha under Article 311 of the Constitution. Under this provision, government officers can be dismissed summarily without any enquiry.

The LG is satisfied after considering the facts and circumstances of the case and on the basis of the information available, that the activities of Dalal, medical officer, New Type Primary Health Centre (NTPHC), Shopian, and Chilloo, consultant gynaecologist in Sub-District Hospital, Chadoora are such as to warrant their dismissal from service, official orders stated.

Dalal and Chilloo are among 13 people who were charge-sheeted by the CBI in December 2009. A hearing in the case is yet to take place because almost all of the accused had approached the Jammu and Kashmir High Court separately. The two doctors have been charge-sheeted by the CBI for fabricating evidence and twisting the

accidental deaths due to drowning as rape and murder. Dalal was the first doctor to conduct an autopsy of the bodies,

whereas Chilloo was a part of the second team of doctors that conducted post-mortem examination, the officials said.

In a gross violation of medical ethics, Chilloo took vaginal swabs of two women admitted in her hospital and projected them to be of Asiya Jan, who she had claimed was raped and murdered, they said.

However, an AIIMS forensic team comprising Dr T D Dogra and Dr Anupama Raina got the bodies exhumed and found that Asiya Jan's hymen was intact. The same reports were part of the CBI charge sheet, they said.

In December 2009, the CBI concluded that the two women were neither raped nor murdered.

The CBI filed the charge sheet against six doctors, five lawyers and two civilians, including the brother of one of the deceased women, for fabricating evidence.

Five police officials were arrested in connection with the case and the subsequent protests.

The 66-page CBI report absolved the policemen, who were in jail for around 47 days in connection with the case and against whom a stateappointed judicial commission had levelled charges of destruction of evidence, of all the charges.

The CBI report accused the 13 accused of hatching a criminal conspiracy to stir public anger against

AIIMS doctors who conducted post-mortem examination on the exhumed bodies found the same diatoms (algae) in the lungs of two women that exist in the area where the bodies were found.

The CBI probe found that both teams of doctors lied in the postmortem reports. The first team of doctors said Asiya Jan died due to cardiovascular arrest and Neelofar died due to neurogenic shock.

The second team of doctors from Pulwama claimed Asiya Jan was sexually assaulted and died due to haemorrhage and shock caused by bleeding from multiple injuries. Neelofar, the team had claimed, died due to neurogenic shock following sexual intercourse.

The CBI report quoted the medical opinion of AIIMS doctors who conclusively stated that the deaths took place "due to asphyxia as a result of ante-mortem drowning". They said the lacerated wound on Asiya Jan's forehead was not sufficient to cause death.



# **Codebreakers Hope To Use** Al to Unearth History's **Well-Kept Secrets**

ore than 400 years ago, Mary, Queen of Scots, was imprisoned in an English castle on charges that she'd conspired against Queen Elizabeth I, her cousin. As she tried to save her head, Mary wrote dozens of secret letters to friends and allies. In several of them, she discussed with France's ambassador how rivals had abducted her son; in others she complained about conditions of her captivity and said she supported a controversial marriage that would've aided a political alliance between France and England. Mary used a "spiral locking"

technique to fold the letters, so the recipients would be able to tell if anyone had opened them before they were received. She and her associates also corresponded in a complex code, which protected the content for 436 years. Then in February, a group of codebreakers detailed in a paper how they'd designed a computer system to break it. In the paper, they showed how Mary had used a type of encryption known as a complex homophonic cipher, substituting various symbols for individual letters of the alphabet.

The researchers, part of a group of computer-savvy historians who call themselves the Decrypt Project, have spent the past decade poring over manuscripts from European archives, trying to solve hidden messages. The inspiration for the idea came

of the Copiale cipher, a 105page collection of handwritten characters that German occultists wrote in the 1700s. Among the things depicted in those decoded manuscripts

maticians said they'd cracked the cipher that the Zodiac serial killer used when communicating with police officers in 1969. Like many coded messages, the notes used a complex substitution methodology, in which one or multiple characters were used in the place of the alphabet. The Zodiac killer used multiple symbols for each letter, varying which symbols he used in a way that made the code harder to break. Using custombuilt software, the mathematicians found that, in one note, the killer had cycled through the symbols in a regular pattern, allowing them to break the code, says Kevin Knight, a professor of computer science at the University of Southern California, who was involved in the Copiale cipher decryption and analyzed some Zodiac correspondence.

The decoded message, which the FBI confirmed, said, "I hope you are having fun in trying to catch me. Other Zodiac letters remain encrypted, and the killer's identity is still a mystery. But Knight says the evolution of code-breaking techniques is giving historians a leg up in revealing long-kept secrets. "The historical significance is big," he says. "It's been an arms race since ancient times between the codemakers and the breakers.
