Cairo: Prime Minister Narendra Modi arrived here on Saturday for a two-day state visit during which he will hold talks with the Egyptian leadership, including President Abdel Fattah El-Sisi, as the two nations seek to enhance their strategic partnership.

Court Trashes Detamation Suit Against Journo

Srinagar: A court here referred to eminent jurist, late Nani A. Palkiwala's article, underscoring need for freedom of press, while as it junked a defamation suit filed against a scribe.

"Freedom is to the press what oxygen is to the human being; it is the essential condition of its survival. To talk of a democracy without a free press is a contradiction in terms. A free press is not an optional extra in a democracy," the court of 1st Additional District Judge Srinagar said while reproducing a few lines from Palkiwala's article, 'The Fourth Estate' in his book. The court made the reference while dismissing a defamation suit filed against a Kashmir based journalist.

"Since the defendant (journalist) has substantiated his claim by placing on record the certified copies of various cases pending against the plaintiff in different courts, and the article has a reference of these cases and prima facie it cannot be said that the article has been published with the sole purpose of maligning and defaming the plaintiff," the court said, adding, "The application of the plaintiff if



Firefighter Among Two Injured In Srinagar Shopping Mall Blaze

Srinagar: A firefighter and a civilian were injured after fire broke out in a shopping complex at Regal Lane in Lal Chowk area of the city here this morning, officials said.

Officials and witnesses told Kashmir Observer that fire broke out in a two-storey shopping complex around 10: 30 this morning creating total chaos and confusion among the shoppers and shopkeepers at Regal Lane in Lal Chowk.

They said the Fire and Department emergency squad reached the spot and doused off the flames with the help of police and locals.

Fire, officials said, broke out in a shop and intensified quickly, engulfing another one adjacent to it in a jiffy. However, the cause of fire could not be immediately as-

A firefighter identified as Gulzar Ahmad and a civilian working as a salesman at a local shop, suffered minor injuries in the incident and were immediately evacuated to the hospital for treatment.

'We alerted the fire and emergency department as soon as we noticed thick smolders emanating out of the shop which had caught fire. Police and locals assisted firefighters in dousing off the flames, but before the inferno could be contained, property worth lakhs of rupees was destroyed," a shopkeeper told Kashmir Observer.

Confirming the incident, a senior official from the Fire and Emergency Department said that a civilian and a firefighter were injured during the firefighting operation. He said a case was registered in this regard and investigation to ascertain the actual cause of fire is on.

Woman Held For Murdering Husband In Srinagar

Incident Sparks Massive Protests, Police Assures Action

Srinagar: In a shocking incident, a woman allegedly killed her husband at Rawatpora Bhagat locality in uptown Srinagar here this evening, following a family feud, witnesses said.

The incident triggered massive protests in the locality, with protesters demanding stern punishment to the accused woman and her two daughters, who they alleged were torturing the victim day in and day out.

A fifty-year old man identified as Abdul Rashid Dar of Rawatpora Bhagat was allegedly killed by her wife inside their residence this evening, triggering protests in the entire locality. The accused woman, locals alleged, fled from the scene soon after murdering her husband. She has been identified as Shaheena Begum.

However, the police arrested the accused hours after killing her husband and registered a formal case FIR

No. 54 of 2023 under section 302 IPC at police station Saddar.

Confirning the incident, Srinagar police in a tweet said "one accusend namely Shaheena Begum w/o Abdul Rashid Dar victim r/o Rawatpora Bhagat arrested for killing her husband. FIR No. 54 us 302 ipc registered at PS Sadder. Prima facie Facie it appears the crime was done in a fit of rage, investigation on'

They alleged that the accused and her two daughters were torturing the deceased, a labor by profession, even as he was paying hefty monthly maintenance in their favor.

'The accused lady had filed a case against the deceased, which was pending adjudication before the court. The court had directed the victim to pay monthly maintenance to the accused and her two daughters, which he was paying without any delay," said one of the neighbors, protesting against what was termed as 'cold blooded' murder.

He alleged that the accused was of-

ten telling her husband that she doesn't care for the judiciary or the police as the constitution favors women only.

"Litigation was pending between the couple in the court, however the deceased was paying monthly maintenance to the accused as directed by the court well on time, but despite that he was being tortured and threatened with dire consequences in case he informs his relatives about the atrocities he was suffering at the hand of the accused" he added.

Locals said the deceased was critically injured and was evacuated to the hospital for treatment, where doctors declared him as brought dead.

Meanwhile a police team from police station Saddar reached the spot and assured protesters that action warranted under law will be taken against

Station House Officer (SHO) Saddar police station, Mudasir Nazar said investigation is on in the case.

3 Ikhwanis Taste Their Own Medicine

They worked with Awoora camp of the security forces. Later talking to Kashmir Observer, Ashkoor Warn said the three had let loose reign of terror in the area and were wanted by the police.

He also asserted that beating of a surrendered Ikhwanis would send the right signal to others involved in extortions, kidnapings and other such acts. He said such acts won't be tolerated in future; ONS adds from BaramulIa According to reports surrendered trio, working with the secu-

rity forces, had picked up Rather from his residence and taken him to a security camp where he was given a thrashing. They demanded money from him which he promised to get from his home.

On being let off to get the promised money, Rather straightaway went to Kupwara to lodge a complaint with SSP who got the surrendering arrested immediately. A case has been registered against them at the police station. Sources said the trio had relieved one Mahda Wani of Chowkibal of Rs 6,000 a few days ago.

Eu Border Agency Says Greece Did Not Respond To Offer To Send Plane To Monitor Capsized Migrant Boat

BEIRUT: Having faced widespread criticism over its dealings with a migrant boat that capsized earlier this month, Greece has now been accused of not responding to an offer to send a plane to monitor the

Eighty-two people were of-ficially confirmed dead in the incident last week, but the UN said it is likely as many as 500 may have drowned.

On Saturday, the BBC quoted the EU border agency Frontex as saying the migrant boat had been spotted by one of its planes "hardly moving in the hours before it capsized," which contradicts Greece's claim that the vessel was on a "safe and steady course."

According to the report, Frontex offered to send a plane to monitor the vessel, but received

no reply from Greek authorities. The overcrowded boat is believed to have set sail from Libya. It was detected for the first time in the early hours of June 13 heading toward Greece.

The Greek authorities said that the boat's crew told coast guards that the vessel was heading to Italy, and asked to be left alone. The authorities deny not acting swiftly enough to avoid the tragedy, but have not commented on Frontex's claim about its offer of aerial assistance.

Having analyzed the passage of other vessels on that day, the BBC claimed in its report that the migrants' boat had barely moved for almost seven hours before capsizing around 80 kilometers away from Pylos, a coastal town in Greece.

More than 100 people are said to have been rescued, but according to survivors there were more than 700 on board, including around 100 children.

Pakistan's interior minister has said that more than 350 Pakistanis were onboard. Media reports have claimed that there were Egyptian and Syrian passengers as well.

"Internal Treason" In **Russia: Timeline Of Events That Unfolded In 24 Hours**

Mutinous Russian merce-nary fighters barrelled towards Moscow on Saturday after seizing a southern city overnight, with Russia's military firing on them from the air but seemingly incapable of slowing their lightning advance.

Here is a timeline of events as they have unfolded over the last 24 hours. **FRIDAY**

Yevgeny Prigozhin, the boss of the private army called Wagner, releases a video stepping up his feud with Russia's military top brass and for the first time rejects President Vladimir Putin's core justifications for invading Ukraine.

In a series of subsequent audio recordings posted on Telegram, Prigozhin says the "evil" of Russia's military leadership "must be stopped" and his Wagner mercenary force will lead a "march for justice" against the Russian military.

Wagner fighters have entered the southern Russian city of Rostov, Prigozhin says in an audio recording posted on Telegram.

The White House says it is monitoring the situation involving Russia and the Wagner force, and will be consulting with allies and partners on developments.

The governor of southern Russia's Rostov region adjoining Ukraine tells residents to remain calm and stay indoors as it becomes clear that Wagner forces have taken control of the city of Rostov.

Russian's Defence Ministry issues a statement appealing to Wagner fighters to abandon Prigozhin, saying they have been "deceived and dragged into a criminal adventure".

A Russian security source tells Reuters Wagner fighters have taken control of all military facilities in the city of Voronezh, about 500 km (300 miles) south of Moscow.

Putin makes a televised address vowing to crush what he calls an armed mutiny. He accuses Prigozhin of "treason" and a "stab in the back".

Chechen leader Ramzan Kadyrov, a Putin ally, says his forces are ready to help put down the revolt by Prigozhin and to use harsh methods if necessary.

Centre's Pan-India Move **To Help Citizens Save 20% On Electricity Bill**

NEW DELHI: The Government of India has introduced two changes to the prevailing power tariff system and now across the country consumers can save up to 20 per cent in power bills by planning usage during solar hours or daytime as the government is set to implement a 'time of the day' tariff.

The Government of India has introduced two changes to the prevailing power tariff system, through an amendment to the Electricity (Rights of Consumers) Rules, 2020.

The changes are the introduction of the Time of Day (ToD) Tariff, and the rationalization of smart metering provisions, the Ministry of Power said.

"Under the ToD Tariff system, the Tariff during solar hours (duration eight hours in a day as specified by the State Electric-Regulatory Commission) of the day shall be

10 per cent-20 per cent less than the normal tariff, while the tariff during peak hours will be 10 to 20 per cent higher, the release

ToD tariff would be applicable for Commercial and consumers having Maximum demand of 10 KW and above, from April 1, 2024, and for all other consumers except agricultural consumers, latest from April 1 2025. Time of Day tariff shall be made effective immediately after installation of smart meters, for the consumers with smart meters, it further said.

Union Power and New and Renewable Energy Minister RK Singh said that the ToD is a winwin for consumers as well as the power system.

"The TOD tariffs comprising separate tariffs for peak hours, Solar hours and normal hours, send price signals to consumers to manage their load according to the Tariff. With awareness and effective utilization of the ToD tariff mechanism, consumers can reduce their electricity bills,"

"Since solar power is cheaper, the tariff during the solar hours will be less, so the consumer benefits. During non-solar hours thermal and hydropower as well as gas-based capacity is used their costs are higher than that of solar power - this will be reflected in the Time of Day Tariff. Now consumers can plan their consumption in order to reduce their power costs - planning more acties during solar hours

when power costs are less," he added The Union Minis-

ter said that the ToD mechanism will also ensure better grid integration of Renewable Energy sources thereby facilitating faster energy transition for India. The ToD tariff will

improve the management of renewable generation fluctuations, incentivize demand increase during the periods of high RE generation hours and thereby increase grid integration of larger quantity of renewable power," RK Singh said.

Most of the State Electricity Regulatory Commissions (SERC have already implemented ToD tariffs, for large Commercial and Industrial (C-I) categories of consumers in the country. With the installation of smart meters, ToD metering at the domestic consumer level will be introduced as per Tariff Policy mandate.

Time of Day (TOD) tariff, is recognized globally across electricity industries, as an important Demand Side Management (DSM) measure which is used as a means of incentivizing consumers to shift a portion of their loads from peak times to offpeak times, thereby improving the system load factor by reducing the demand on the system during peak period.

What Is Russia's Wagner Group And Why Is It Accused Of Mutiny?

Tension between Yevgeny Prigozhin, head of Russia's Wagner private militia group, and the nation's defense establishment exploded in dramatic fashion on Friday. The mercenary chief vowed to punish Russian military leaders, saying Defense Minister Sergei Shoigu had orchestrated a missile attack that killed "huge" numbers of his fighters. The Kremlin responded swiftly, denying the attack and accusing Prigozhin of mutiny. The internal conflict is

the biggest test of President Vladimir Putin's authority since he sent troops into Ukraine 16 months ago. In a short televised address to the nation on Saturday. Putin denounced the rebellion by Wagner forces and its leader as "treason" and promised harsh punishment.

What is the Wagner

Founded by Prigozhin in 2014, Wagner at its peak had about 50,000 mercenary recruits - many of them ex-prisoners - fighting in Ukraine. The US designated the group as a trans national criminal organization earlier this year, and Wagner

has been sanctioned by Australia. Canada. Japan, the UK and the European Union. The group has operated for years on battlefields in the Middle East, Africa and Latin America, where it's been accused of committing widespread

human rights abuses. Wagner has murky legal status, and mercenaries are technically illegal in Russia.

The group operates independently of the nation's official armed forces, and recently rebuffed Moscow's demands that its recruits sign formal contracts with the military.

Gujarat Man Arrested For Posing As PMO Official, Conning Private School

VADODARA: A man from Gujarat's Vadodara city has been arrested for posing as a PMO official to secure the admission of two children in a private school here and trying to dupe it of huge sums with his fake identity, an official said on Saturday.

The arrest of Mayank Tiwari on Friday comes months after an Ahmedabad resident, Kiran Patel, was held from a five-star hotel in Jammu and Kashmir for posing as a senior official from the Prime Minister's Office (PMO). Hospitality apart, Patel had also enjoyed security cover by tricking officials in the Valley.

Identifying himself as a director (strategic advisory) at the PMO in New Delhi, Tiwari first got in touch with the school and its trustee in March 2022, during the admission season, said the official from Waghodia police station in the city.

Tiwari, a middle-aged man, sought the school's help with the admission of two sons of his "family friend", whom he described as Indian Army official Mirza Baig and said he was being transferred to Vadodara from Pune, the official said.

The school's director asked Tiwari, whose WhatsApp status said he was a "PMO official", to meet the trustee, who is also associated with a private university in Vadodara. To impress upon the trustee,

Tiwari told her that he could use his clout as a "PMO official" and get the school involved in the field of education research and get them various projects if they took care of the expenses, the official said.

The smooth-talker took the trustee and the school's director into confidence with the intention of cheating them of huge sums, said the first information report (FIR). He also

secured the admission of the two children as special cases, the official said.

A few months later, the trustee had doubts about Tiwari's claims of being a PMO official and the education research projects mentioned by him. She then started talking to people in her circle and made a discrete inquiry about Tiwari, the official said.

The trustee later found out that Tiwari was not a PMO official and had conned them by spinning a tale about his "immense influence". Also, his profession was not clear. said the FIR. The trustee then alerted the school last month.

On a complaint by the school administration, the Waghodia police on Friday registered a case against Tiwari under Indian Penal Code sections 406 (criminal breach of trust), 420 (cheating), and 170 (personating a public servant) and arrested him.

BEIRUT: A son of late Libyan leader Muammar Qaddafi was briefly taken to hospital this week after his health deteriorated nearly three weeks into a hunger strike to protest his detention without trial in Beirut, a person familiar with the case has said.

The health of Hannibal Qaddafi, who has been only drinking small amounts of water, deteriorated on Wednesday the person said, speaking on condition of anonymity because of the sensitivity of the case.

Qaddafi, who started his hunger strike on June 3, was taken to Beirut's Hotel-Dieu de France hospital on Wednesday after suffering a drop in blood pressure and inflammation in the

He further said that stringent action shall be taken against all those involved in any militant activity.

Rs 3.50 Lac Fine Slapped On **Traffic Violators**

SAMBA: The enforcement team of the Motor Vehicle Department (MVD) on Saturday recovered Rs 3.50 lakh fine from traffic violators during an early morning checking on National Highway Way in Samba District.

Pakistan's Political Chaos Echoes Its Cricket

he first thought that springs to mind when thinking about the Pakistani cricket team is its unpredictability. This is a squad that is turbulent, aggressive, hard-charging and yet gives up occasionally without much fight. That is why, on its day the team can defeat the strongest opponent in the game but lose to a minnow the following day. And it is a familiar fact. The point of repeating it is to wonder aloud whether sports behaviour of a national team somehow also echoes the character of a nation. The question becomes particularly relevant in view of the ongoing turmoil in Pakistan. The country is going through a deeply uncertain and vulnerable phase. And incidentally, the nation's most legendary cricketer Imran Khan is at the centre of it.

We are witness to an unremitting war of attrition between Khan on one hand and the combined might of the Pakistani establishment - read Army - and its coalition government on the other. However, it is the establishment which is believed to be the power behind the throne, so essentially the fight is between Khan and the Army chief. Khan himself framed it as one upon his release from the prison earlier in June. The fight has now become a zero sum game, as is apparent from the way Khan framed it and from the way it has developed over the past year. One party's survival means the decimation of the other; either Khan or the Army Chief General Asim Munir will win. As things stand, it is the latter who seems to have come out trumps.

Past few weeks have witnessed Khan's party Pakistan Tehreek-i-Insaaf (PTI) disintegrate. Senior leaders have left Khan in what is said to be under duress. He was also arrested, but only to be let off by Supreme Court a few days later. During the three days that Khan was in custody, protesters

in Pakistan went on a rampage and some of them even attacked defence installations, something unheard of in Pakistan. Scores of cases have been filed against the PTI chief ostensibly to keep him busy with court appearances

Going forward, the situation doesn't look promising for the PTI, more so, with the entire might of the establishment and Pakistani government aligned against Khan. With leaders also deserting him and the structure of the PTI being dismantled, Khan's ability to contest future national elections is being undermined.

That said, it is necessary to draw a distinction between Khan and the other senior leaders of his party: The prevailing groundswell of support in Pakistan for the PTI is exclusively commanded by Khan and the other party leaders are only basking in his glory. It is, in a sense, similar to the following for the prime minister Narendra Modi in India: votes are largely cast in his favour than the candidates

contesting the election on behalf of the BJP. So,Khan would still have a clear advantage if fair elections were held.

But as the last one year and the years before this make it amply clear, this is not how things play out in Pakistan. Democracy for all its trappings isn't organic. The establishment is widely believed to have a role in who rules Pakistan. Khan himself was accused of being propped by the Army and now the current rulers are also facing the same accusation.

That said, this is not the concern that is at the heart of the current turmoil in Pakistan. The question is a larger one: What constitutes a nation and who does it essentially belong to? A no-brainer answer to this is that people make up a nation. And by that definition, the legitimacy or otherwise of any action can be gauged by how many of its decisions are taken with reference to its people. To put it in another, what should matter in a nation? Is it the will of a large majority of its people or just that of a power-

ful elite who act largely to perpetuate themselves? In Pakistan it is this contest that is currently playing out, a tug of war between its people and its elite. Truth is imran Khan is arguably the most popular leader of Pakistan now in the country, something that is also borne out by an overwhelming public groundswell in his favour and also by the recent by-polls.

It is true that elites rule everywhere. Every ruling arrangement begets its own network of elites who, in turn, act in their self-interest. But in Pakistan we have a variation on this power mantra: The elites are not entirely responsible for electing and replacing themselves. The establishment, more often than not, is an influential factor.

There are two solutions to the current crisis in the country: one, the establishment rules directly than behind a democratic facade. Another is that a true democracy is allowed to take root and a free and fair election is held at the appointed time. But as of now, the country seems working towards neither. As a result, the current turmoil looks set to continue for some more time. Like its cricket team, Pakistan will remain volatile, unstable and unpredictable. But this may not necessarily mean down and out. Things may eventually fall into place as happens in many of the matches of the country's cricket team. At the same time, they might even unravel further if the people at the helm continue to pursue a zero sum game than work for a win-win solution.

Titan And The Trawler

Whose Lives Matter?

global interest are unmistakably stark. In the last week, the unquiet seas have folded wo vessels into their depths. One is an unnamed fishing trawler carrying as many as 750 people desperate to reach safety, most of whom are still missing, unlikely to have survived, about 92.6km (50 nautical miles) off the coast of Greece. The other is the Titan, a small submersible with five men on board that has still not been found 685km (370 nautical miles) off the Atlantic coast of Canada at the time of writing. A massive hunt for the submersible is ongoing involving the US and Canadian coast guards, a French rescue team, the Pentagon, private vessels, and top-notch equipment, including Remote Underwater Vehicles and aerial support.

The missing submersible has elicited round-the-clock coverage with many media websites hosting "live" updates and news programmes leading with the story. There are even question-and-answer forums hosted by the RPC to address all possible details.

BBC to address all possible details. The sinking of the fishing vessel last Wednesday has been covered, of course, but with an air of weary repetition. Here was another boat full of "illegal" brown people making a risky bid to enter Fortress Europe which has repeatedly warned them not to attempt the journey. The Greek coastguard is now embroiled in controversy about whether, when and how it responded to the vessel's clear distress over a period of several hours. In stark contrast to the heavy multinational rescue efforts for the Ocean-Gate submersible, the trawler, like other refugee vessels, had little help. Human Rights Watch notes: "No EU ships actively patrol anywhere near where most boats enter into distress. Frontex, the EU's border and coast guard, conducts aerial surveillance in service of interceptions and returns, not rescues.

Some of the five men on board the privately-owned adventure submers-

ible, including British billionaire Hamish Harding, may have paid a quarter of a million dollars each for a seat on the Titan. We have been told the others in the vessel were wealthy British-Pakistani businessman Shahzada Dawood and his son Suleman, Stockton Rush, chief executive of OceanGate, the expedition firm behind the dive, and a French explorer, Paul-Henry Nargeolet.

Of those on the doomed fishing vessel en route from Libya to Italy we know nothing other than over half are Pakistani, likely poor, and that there were probably Syrians, Libyans and other North Africans on board as well. Facelessness and anonymity are the buffer between those of us ensconced in our homes and those who risk everything after leaving theirs. Without that buffer, we would have to acknowledge the singularity and worth of the 25,000 human beings, more than 1,200 in 2022 alone, who have drowned in the Mediterranean trying to get to Europe since 2014 and who have become, in our minds, little other than numbers with brown faces. They too would be worthy of full-blown high-tech rescue efforts instead of being criminalised as "illegal" with rescuers also risking being charged with "facilitating" asylum seekers.

This disparity is built into the stories we, and the media, tell ourselves and who gets to figure as a hero in them. Accounts of refugees and asy-

lum seekers in the European media repeatedly play down the dangers they face in their places of departure, usually their homes, painting them collectively as "economic migrants" (read "greedy") or making fraudulent claims in order to access Europe's welfare systems. They are also portrayed as gullible and foolhardy, giving their money to criminals in exchange for passage and risking their safety in craft that are patently not seaworthy. By flouting deterrents, it is implied, refugees bring catastrophe upon themselves.

Contrast this with the air of tragic heroism and bravery already invested upon the five men in the Titan, its classical Greek name invoking not just the Titanic, the doomed object of its underwater tourism, but the might of the Greek pantheon. The men have been referred to as "explorers" and "adventurers", a category familiar to us from colonial lore, courageous men in pith helmets ready to venture where no one has dared go before (even if what they "discovered" was already inhabited). Today's context for such expensive and generally superfluous expeditions is not so much the hope of finding new horizons as it is personal gratification, manifest in space travel for fun touted by billionaires like Richard Branson and Elon Musk. OceanGate's website offers its clients a "thrilling and unique travel experience" with a "chance to step outside of everyday life and discover something truly extraordinary"

If refugees knowingly risk their lives by coming aboard unseaworthy

craft, there are also questions to be asked of OceanGate's "experimental submersible" which is apparently not certified by an outside body. The company has explicitly alluded to SpaceX and Virgin Galactic in indicating that inside experts are sufficient and that the time taken for outside bodies to certify experimental vehicles is "anathema to rapid innovation". Its well-heeled clients must sign a waiver accepting the risk of death during an expedition.

Death is a reality that many refugees and asylum seekers also accept, though arguably they have far less luxury of choice in the matter. "If I die right now, I'll die with no regrets...It was hell. Nothing less than hell," said one refugee who left Libya in 2020 after being rescued from an overcrowded rubber boat in distress in the Mediterranean. Yet the courage of refugees in seeking to leave hellish situations and make new lives in strange new places is rarely lauded. As the poet Warsan Shire famously declared, "No one leaves home until home is a sweaty voice in your ear saying- leave... anywhere is safer than here.

No tragedy, at sea or elsewhere, requires us to forfeit grief. We are obliged, however, to ask ourselves whose lives we are inclined to mourn and whose lives we consign to our collective equanimity. Who gets to be the hero of an epic or the protagonist of a tragedy, and who is relegated to the margins of human history? Unlike Homer who believed that only a few could survive an Odyssey, perhaps we can hope that all who brave the dangers of the unkind seas may emerge "alive through a big surf to crawl, clotted with brine, on kindly beaches in joy, in joy, knowing the abyss behind."

READING THE SILENCE OF OUR MOTHERS

The feeling of being unwanted and unloved is the biggest of all burdens. Being unwanted leaves you with a debilitating sense of loneliness and can then feed into a pattern of being an outsider in adulthood. If the family you are born into makes you feel unwanted, you grow up believing that you will be unwanted your whole life. Then, you diminish yourself — you measure your words or self-censor, you feel compelled to make every moment of your existence productive to make it count, you work hard to be more likeable and, loveable. Then when a semblance of something akin to love or respect comes your way you are hooked. This is how most women end up in bad marriages and this is why they stay.

I have never felt good enough. When I met my husband, suddenly! was important to someone, someone cared about me. It brought me so much confidence. My grades in college improved. I cleared competitive exams with flying colours. For the first time, I began to like myself. For the first time I didn't stand in front of the mirror and cry. I knew he was aggressive by nature but the fact that he liked me for what I am and that he gave me attention was like a feel good drug that I couldn' let go of. I was in absolute denial about the red flags in his personality because my need to be appreciated was so much stronger,' Suchi told me.

"And then he went against his family to marry me, I was so grateful that he chose me over his family'

She was so grateful that she normalised abusive behaviour, which began right after they got married. Suchi now teaches psychology in a reputed institution in eastern India. But the little girl who wanted to be no trouble, and who waited for hours every day for her father to pick her up from school, is still trapped inside her somewhere

Meanwhile, Anima, who had fought with her father to continue her education, found out that the patriarchy she fought at home extended to institutions too. When she began her engineering degree at the university, she was shocked at the hostility of her male classmates.

They openly told the girls in the class that we were wasting the seats that could have gone to a deserving male candidate because we were going to do nothing with our degrees. We would get married and ultimately leave everything and be a homemaker.


Anima, who had bet on her education to change her

Anima, who had bet on her education to change her life, found that her classmates had shown great prescience — she worked as a chemical engineer for a while after marriage but was forced to quit.

'Women get married for all the wrong reasons in this country,' she tells me. 'I was determined not to marry because I grew up seeing my mother being abused and humiliated by my father and his family.

And yes, I fell in love, but mostly I married because my parents had died by then, I had no guardian and everyone, including my elder sister, thought marriage would bring me some security.

In India, however, many men take on the role of the 'master' soon after marriage, falling back on established power dynamics to make sure that their wives fall in line. Soon, both Suchi and Anima realized the mistake they had made.



Suchi told me, 'He would ask me to massage his feet every day and that went against everything that I thought I was — the educated, empowered woman who was not less than her husband. And then he wanted me to become pregnant immediately. I didn't but I gave in because I, too, wanted a child, though maybe not so soon in our marriage. But he did, and that was the end of the discussion. He sarted hitting me when I was pregnant. I was a bad homemaker, I couldn't cook properly- he complained endlessly.

While for Suchi the abuse was a gradual progression from the emotional to the physical, for Anima, the physical abuse started right after her marriage. He would fly off the handle at the smallest thing. And then my mother-in-law would ask me to apologize. She would tell me this is how women have to be, Anima recalls. 'I was made to understand the verbal abuses and a slap here and there were okay. It went against everything that I believed in, the person I had wanted to be. He began to clip my wings and I let him because I wanted the security of a family. I put up with the abuse because I wanted my children to live in a happy family. It was also then that I truly began to understand my mother, her desperation, her silences.'

Qurbani All Your Questions Answered

reshly pressed clothes in all styles and hues, the careful precision of women painting henna designs on hands, streets teeming with people distributing meat and those receiving it, the aroma of specialty foods being prepared, and rows of the faithful bowing in congregational prayer.

These are some universal sights as Muslims around the world celebrate Eid al-Adha, one of two major holidays in the Islamic calendar. This year it is likely to begin on June 28, its date to be confirmed upon the sighting of the moon.

Known as the Feast of the Sacrifice, the holiday falls at the end of the annual Islamic pilgrimage of Hajj, where thousands



flock to Saudi Arabia each year to visit Islam's holiest site in Mecca.

Eid al-Adha is the commemoration of the Quranic tale of Prophet Ibrahim's willingness to sacrifice his son Ismail as an act of obedience to God.

Muslims believe that before he could carry out the sacrifice, God provided a ram as an offering instead. In the Christian and Jewish telling, Ibrahim is ordered to kill another son, Isaac,

As such, the holiday is celebrated with the slaughter of goats, cows, sheep, and other livestock, which is shared with family, friends, and the poor.

Over time, despite many shared traditions, Muslims in different countries have developed Eid customs that are distinctly their own, combining regional cultural practices with the celebration of the religious holiday.

Here are some Eid traditions around the world:

Middle East

From Yemen to Syria, traditional sweets are prepared, with food an integral part of all Eid celebrations. Many communities have traditional snacks and dishes that are prepared solely for the holiday.

From jalabia hanging from storefronts in the streets of Manama to Libyan horsemen garbed in turbans and robes, people pull out their very best clothes for Eid.

From lighting incense to torches, celebrations in East and Southeast Asia are a sensory experience.

From Pakistan to Afghanistan, and beyond, hands adorned with henna are a common sight beginning the night before Eid. Everyone from young girls to elderly women decorates their hands for the occasion.

From the Ivory Coast to Kenya, and elsewhere in many Muslim countries, livestock is slaughtered in public, and the practice is sometimes a spectacle for crowds.

Opulence is on display but so are acts of charity during Eid, from a ceremony welcoming the emir of Kano in Nigeria, to an NGO in South Africa preparing meals for the less fortunate.

According to the Pew Research Center, there are roughly six million Muslims in Latin America, although they warn the figure could be inflated. A minority religion in the region, it is celebrated by both immigrants and people indigenous to the country. In Mexico, for example, while Muslims are less than 0.2 percent of the population, according to the 2020 government census, immigrants and Mexicans converting to Islam make up the Muslim community there. Eid celebrations revolve around food, prayer, and family time.

North America

According to the Pew Research Center, there are nearly four million Muslims in the United States. Canadian government data from 2022 puts the number at more than 1.7 million in Canada. The two nations are host to vibrant immigrant communities who bring Eid traditions from their home countries, with mosques drawing multicultural gatherings on Eid mornings.

Minority communities, including refugees and immigrants, celebrate Eid across the continent. Those fleeing violence or persecution from parts of Africa, Asia, and the Middle East will celebrate the occasion thanks to provisions from aid groups.

In Ukraine, Muslim soldiers have managed, in the past year, to take a respite from fighting in their battle with Russia, celebrating Eid by sharing a meal with their compatriots.

According to 2021 government figures, More than 800,000 people in Australia are Muslim, many part of immigrant communities. Shops selling clothes and decorations pop up in Sydney, while guests and new converts are welcomed to partake by local Muslim groups.

All Ten Adani Group Stocks Fall; Adani Ent Tumbles Nearly 7%. Here's The Reason

NEW DELHI: Adani Group stocks ended in the negative territory on Friday, with Adani Enterprises falling nearly 7 per cent, in-line with weak trend in the broader market, amid reports that the United States authorities are looking into the representations that the conglomerate made to its American investors in the wake of allegations of stock manipu-

"Adani group stocks came under selling pressure on Friday when the broader market was anyway under profit-taking mode. An additional reason for the group stocks to fall was the news of Adani Group drawing regulatory scrutiny in the US after a short seller report.

"The US Attorney's Office in Brooklyn, New York, has reportedly sent inquiries in recent months to institutional



lation levelled by Hindenburg Research.

Shares of Adani Enterprises tumbled 6.79 per cent, Adani Transmission plunged 6.38 per cent, Adani Power declined 5.61 per cent and Ambuja Cements tanked 4.19 per cent on the BSE.

Adani Ports fell by 4.16 per cent, NDTV slumped 3.46 per cent, ACC declined 3.46 per cent, Adani Wilmar skidded 3.42 per cent, Adani Total Gas went lower by 3.21 per cent and Adani Green Energy dipped 1.50 per cent.

In the equity market, the 30-share BSE Sensex fell 259.52 points or 0.41 per cent to settle investors with large holdings in Adani Group. The requests for information were focused on what Adani Group told those investors," said Deepak Jasani, Head of Retail Research, HDFC Securities.

Adani Group stocks have in the past taken a beating on the bourses after Hindenburg made a litany of allegations, including those about fraudulent transactions and share-price manipulation, against the business conglomerate.

Adani Group has dismissed the charges as lies, saying it complies with all laws and disclosure requirements.

Silicon Valley CEOs Get Biden, PM Modi Pitch To Invest In India

WASHINGTON: US President Joe Biden and Indian Prime Minister Narendra Modi met with some of the most powerful executives in Silicon Valley at the White House on Friday, as the two leaders sought to boost economic cooperation on artificial intelligence and advanced manufacturing.

The gathering in the East Room of the White House included Alphabet Inc. Chief Executive Officer Sundar Pichai, Microsoft Corp. Chief Executive Officer Satya Nadella, and Apple Inc. Chief Executive Officer Tim Cook – who is assembling more units of his company's iPhone on the subcontinent as part of a shift from manufacturing in China. Cook was seated next to PM Modi in the meeting.

The Biden administration is increasingly courting India as a key ballast against Chi-na, particularly amid Covid-19-related supply chain disruptions, intellectual property theft, and concerns that Beijing may push forward with efforts to reunify with tech and semiconductor hub Taiwan. India is also eager to become a key partner on critical technologies, with PM Modi announcing this week he was working to remove regulatory constraints, particularly for tech companies, in a bid to make it easier for US firms to



"Our countries are taking innovation and cooperation to a new level," Biden said. Thanks in large part to the folks around this table.'

He encouraged the executives to take an active role in strengthening economic ties between the two nations, including by speaking to other corporate leaders and alerting the administration to regulatory obstacles.

"We need your help, and I'm talking to CEOs around this table, Indian and American, we need your help to seize the moment, to help manage the risks to our societies, our economies, and to our nation's national security," he said. "Innovation and collaboration are rarely without obstacles, and so you raise our ambitions and I want you to let us know what stands in the way of our ambitions."

On Thursday, the president and prime minister capped a state dinner for India with a slew of economic deals, including plans for Micron Technology Inc. to invest more than \$800 million toward a \$2.75 billion semiconductor assembly and testing facility in India. Applied Materials Inc. announced a new semiconductor center for commercialization and innovation, while chip manufacturer Lam Research is announcing a training program in India for up to 60,000 engineers.

Other attendees at the meeting included Advanced Micro Devices Inc. Chief Executive Officer Lisa Su and Revathi Advaithi, the chief executive of multinational manufacturing giant Flex Ltd.

The discussion Friday also touched on emerging concerns over the use of artificial intelligence, as the Biden administration is readying regulatory safeguards related to the emerging technology.

India's Forex Reserves Jump USD 2.35 Bn To **USD 596 Bn**

MUMBAI: India's forex reserves increased by USD 2.35 billion to USD 596.098 billion for the week ended June 16, the Reserve Bank said on Friday.

The overall reserves had dropped by USD 1.318 billion to USD 593.749 billion in the previous reporting week. It can be noted that in October 2021, the country's

forex kitty had reached an all-time high of USD 645 billion. The reserves have been declining as the central bank deploys the kitty to defend the rupee amid pressures caused majorly by global developments.

For the week ended June 16, the foreign currency assets, a major component of the reserves, increased by USD 2.578 billion to USD 527.651 billion, according to the Weekly Statistical Supplement released by the RBI on Friday. Expressed in dollar terms, the foreign currency as-

sets include the effect of appreciation or depreciation

of non-US units like the euro, pound and yen held in the foreign exchange reserves. Gold reserves dropped by USD 324 million to USD 45.049 billion, the RBI said.

The Special Drawing Rights (SDRs) were up by USD 62 million to USD 18.249 billion, the central bank said. The country's reserve position with the IMF was up by USD 34 million to USD 5.149 billion in the reporting week, the apex bank data showed.

The minister said 4-5 semiconductor plants are expected to be set up in the country within a year.



Ruckus At JMC Meet As Oppn Protests Dropping Of 'Public-Interest' Resolutions

the dropping of a few "public interest"

resolutions.

The opposition also staged a walkout after Mayor Rajinder Sharma called marshals in to escort a protesting corporator. The mayor's decision came after he and his BJP colleagues took strong exception to purported remarks of the opposition against Prime Minister Narendra Modi.

"We are proud of our prime minister who has taken the country to new heights on the global stage. No remark against him will be tolerated," Sharma told reporters after adjourning the house in the afternoon amid the ruckus.

He said Modi was working day and night for the betterment of the country and its people. "He was the one who saved the people during the Covid pandemic, provided food to everyone and ensured vaccination of every individual," the mayor said.

He said the member he called the marshals on was asked to stay away from the proceedings of the House for

However, opposition corporators, who were on their toes throughout the session, accused the BJP members of "twisting the facts" and undermining the sanctity of the House.

"Nobody spoke against Modi who is the prime minister of all citizens of India. One of the (independent) members questioned the rejection of public interest resolutions like property tax, installation of smart electricity meters, whopping electricity bills, frequent power cuts and inadequate water supply in the city.

"He was of the view that the failure of the BJP-run JMC to mitigate the sufferings of the public is harming the image of the prime minister. The BJP members started shouting 'Modi, Modi' slogans," Congress corporator Bhanu Mahajan said.

She said the JMC was nearing the completion of its five-year term and this was the 20th General House Meeting of the urban local body which took place after five months due to the "failure of the BJP to follow the JMC Act and convene one such meeting in every month".

"The members were agitated over the rejection of the public-interest resolutions by the mayor-led advisory committee but marshals were called in.

Monsoon Likely To Cover Delhi And Mumbai Around Same Time: IMD

New Delhi: In a rare event, the monsoon is likely to cover both Delhi and Mumbai around the same time within the next two days, the India Meteorological Department said on Saturday.

The monsoon, which had a slow start, has now made swift progress, covering numerous regions including some parts of Maharashtra, entire Karnataka, Kerala, Tamil Nadu, Chhattisgarh, Odisha, northeast India, West Bengal, Jharkhand, Bihar, east Uttar Pradesh, Uttarakhand, most parts of Himachal Pradesh, and some parts of Haryana, according to an IMD official.

Normally, the rain-bearing system reaches Kerala by June 1, Mumbai by June 11, and the national capital by June 27.

Although the monsoon has covered a significant portion of north India, including Ladakh, Himachal Pradesh, Uttarakhand, and a large part of Jammu and Kashmir, on schedule or slightly ahead, it is currently running 10-12 days behind schedule for a considerable part of central India, where a significant number of farmers heavily rely on it.

D S Pai, a senior scientist at the IMD, explained that Cyclone Biparjoy had impacted the monsoon's progress over southern India and the adjoining western and central parts of the country.

He said, "Since the system absorbed most of the moisture, the monsoon's progress along the west coast was slow.

However, the Bay of Bengal branch of the monsoon, responsible for bringing rains to northeast and east India, remained stronger between June 11 and June 23.

Pai attributed this to a lowpressure system that formed over the Bay of Bengal in mid-June and the remnants of cyclone Biparjoy, which aided the monsoon's advancement over east India.

Pai noted that the Arabian Sea branch of the monsoon is now gaining strength with a low-pressure system developing over the Bay of Bengal.

"The monsoon may cover entire Maharashtra and some parts of Gujarat and Rajasthan by tomorrow (Sunday)," added the senior meteorologist.

He said that it represents a new pulse of the monsoon, and rapid progress is expected.

"Conditions are favourable for the further advance of the monsoon over most parts of Maharashtra, including Mumbai, Madhya Pradesh, Uttar Pradesh, Jammu and Kashmir, and Ladakh, more parts of Haryana, including Chandigarh, Delhi, some parts of Gujarat, east Rajasthan and Punjab, during the next two days,' the IMD said in a statement.

According to IMD data, the monsoon

reached the capital on June 30 last year, July 13 in 2021, June 25 in 2020, July 5 in 2019, and June 28 in 2018.

It hit Mumbai on June 11 last year, June 9 in 2021, June 14 in 2020 and June 25 in 2019.

This year, the monsoon arrived in Kerala on June 8, a week after its usual date of June 1. In comparison, it reached the southern state on May 29 last year, June 3 in 2021, June 1 in 2020, June 8 in 2019, and May 29 in 2018.

Research indicates that a delay in the monsoon onset over Kerala does not necessarily result in a delay in the monsoon onset over northwest India nor does it impact the total rainfall over the country during the season.

The IMD previously stated that India is expected to receive normal rainfall during the southwest monsoon season despite the evolving El Nino conditions.

Northwest India is predicted to experience normal to below-normal rainfall, while the east, northeast, central, and south peninsula regions are expected to receive normal rainfall at 94-106 percent of the longperiod average.

According to the IMD, rainfall between 96 and 104 percent of the 50year average of 87 cm is considered 'normal'. Rainfall below 90 percent is categorised as 'deficient', between 90 and 95 percent is 'below normal', between 105 and 110 percent is 'above normal', and anything above 100 percent is classified as 'excess' precipitation. Normal rainfall is critical for India's agricultural landscape, with 52 percent of the net cultivated area relying on it. Additionally, it plays a crucial role in replenishing reservoirs essential for drinking water and power generation throughout the country.

Rainfed agriculture accounts for approximately 40 percent of the country's total food production, making it a vital contributor to India's food security and economic stability.

"Tell him that his performances are being recognized. Otherwise, stop playing Ranji Trophy. Say, it's of no use, you just play IPL and think you are good enough for the red-ball game as well." With the help of three centuries, Sarfaraz amassed 556 runs in six games at an average of 92.66 in the 2022-23 Ranji Trophy.

The 25-year-old right-handed batter had scored 982 runs at an average of 122.75 in the 2021-22 Ranji season, including four hundred.

In all, Sarfaraz has scored 3,505 runs in 37 first-class matches at an average of 79.65, including 13 centuries.

As far as Pujara is concerned, his absence from the Indian Test team for the Windies tour has been one of the talking points.

FIFA Delays Campaign And Vote To Pick Men's 2030 World Cup Hosts

GENEVA: FIFA's search for the men's 2030 World Cup hosts was postponed on Friday after failing to agree on rules for bid campaigns and a date for the final vote.

The vote by about 200 FIFA member federations was moved to the last quarter of 2024 instead of a previously expected meeting in September next year.

Bid rules will aim to be settled on at a FIFA council meeting before the end of October, soccer's governing body said, "with the bidding process to be officially launched thereafter."

FIFA did detail basic needs for the 48-team, 104-game tournament: 14 stadiums, of which only seven can be new construction projects; "explicit public commitments" to human rights and climate action; worker protections; and "non-interference with journalists and human rights defenders" involved in work

related to the World Cup. One speculated project



appeared to drop out this week when media in Greece reported a Saudi Arabia-led co-host bid that included Egypt will not go ahead.

Saudi Arabian soccer officials had not publicly confirmed what would have been an unprecedented threecontinent hosting plan in line with the kingdom's aggressive big-spending ambitions in global soccer. A bid for the 2034 World Cup has been seen as a more likely target.

Still, Saudi involvement could yet be revived even if it would mean bringing the World Cup back to Asia just eight years after Qatar hosted in 2022, and likely again in November-December in the middle of the European club season.

Europe has long committed to bidding for the 2030 World Cup with Spain and Portugal, and that project has added near-neighbor Morocco from Africa. Ukraine also is involved in that bid.

South America also wants to host the centenary World Cup, with original 1930 host Uruguay in a four-nation bid with Argentina, Chile and Paraguay.

Even if the South American bid loses, Uruguay could still be honored as the inaugural host by being given some of the 104 games to stage at the same Estadio Centenario in Montevideo.

FIFA said on Friday it wanted "additional consultation with all key stakeholders (for the 2030 World Cup) which will mark the centenary of men's football's showpiece tournament."

The 2027 Women's World Cup vote is scheduled on May 17 next year and FIFA said its annual meeting to decide the host will be held in Bangkok. The four candidates are Brazil; South Africa; a European co-hosting bid from Belgium, Germany and the

CWC 2023 Qualifiers: Netherlands Beat Nepal, Storm Into Super 6

An explosive half-century from Max O'Dowd helped the Netherlands storm into the Super Six of the ICC Cricket World Cup 2023 qualifiers with a seven-wicket win over Nepal in Harare on Saturday. After their bowlers had bowled out Nepal for 167, Max O'Dowd & co. ensured that there were no slip-ups in the Dutch batting effort. With this Netherlands has qualified for the Super Six, while Nepal's World Cup qualification hopes have ended. With this win, the Netherlands are in third position in Group A with two wins and a loss, a total of four points. On the other hand, Nepal is in fourth place with one win and three losses, a total of two points.

In the chase of 168, after scoring merely one run in the first three overs of their chase, Netherlands openers took off. Max O'Dowd and Vikramjit Singh blasted 86 runs off the first 13 overs before the latter fell the Sandeep Lamichhane (2/60). While Vikramjit (30) had three fours and one six to his name, O'Dowd was even more aggressive, striking four fours and sixes during their partnership. He brought up his fifty in merely 30



balls. This blistering start had already helped the Dutch to 97 in the first 15 overs. Despite losing Wesley Barresi in the 15th over, the batting side looked in complete control of the chase.

Along with Bas de Leede, O'Dowd added 62 for the third wicket to get Dutch near the finishing line. Unfortunately, O'Dowd was bowled by Gulsan Jha in the 27th over and could not be around when his side finished the game. O'Dowd finished with 90 in 75 balls, consisting of eight fours and four sixes. Leede scored 41* in 39 balls, consisting of six fours. Nepal reached the target in The Nepal innings never got

going as the Dutch bowlers struck regularly and restricted the sub-continental side to a sub-par total. Nepal batters had to contend against a high-quality new-ball spell from the Logan van Beek (4/24) and Ryan Klein. The duo got the ball to jag around and beat the bat on several occasions. Nepal were 23 for the loss of Aasif Sheikh at the end of the first powerplay.
