Bhopal: Prime Minister Narendra Modi on Tuesday made a strong pitch for the uniform civil code UCC), saying the Constitution also mentions having equal rights for all citizens.

Addressing a gathering of par-ty workers here, Modi also said the Bharatiya Janata Party (BJP) has decided it would not adopt the path of appeasement and vote bank politics.

Modi said the opposition is using the issue of UCC to mislead and provoke the Muslim

community. "You tell me, in a home, how can there be one law for one member and another law for another member?" Modi said.

"Will that home be able to function? Then how will the country be able to function with such a dual system? We have to remember that even in India's Constitution, there is a mention of equal rights for all," he said.

'These people (opposition) level allegations against us but the reality is that they chant Musalman, Musalman. Had they really been (working) in the interests of

Situation From Kashmir To Kerala Makes It **Must To Retain Sedition Law: Law Panel Chief**

New Delhi, June 27: Amid a clamour for repeal of the law on sedition, Law Commission chairman Justice Ritu Rai Awasthi on Tuesday said the present situation from Kashmir to Kerala and Punjab to the North-East makes it must to retain the law to safeguard the "unity and integrity of India".

Defending the panel's recommendation to retain the law, which is at present under abeyance following directions of the Supreme Court issued in May last year, he said enough safeguards have been proposed to prevent its misuse.

In an exclusive interview, he told PTI that special laws such as the Unlawful Activities (Prevention) Act and the National Security Act operate in different fields and do not cover the offence of sedition and therefore, the specific law on sedition needed to be there too. Justice Awasthi asserted that while considering the usage of the law on sedition the panel found that "the present situation right from Kashmir to Kerala and Punjab to the



North-East is such that the law on sedition is necessary to safeguard the unity and integrity of India"

He also said that the sedition law being a colonial legacy was not a valid ground for its repeal and several countries, including the US, Canada, Australia and Germany, have their own such laws.

In its report submitted to the government last month, the 22nd Law Commission headed by Justice Awasthi supported retaining section 124A of the Indian Penal Code (IPC) with safeguards to prevent its misuse.


The recommendation triggered a political uproar with several opposition parties alleging that it was an attempt to stifle dissent and voices against the ruling party ahead of the Lok Sabha elections next year.

While the government said it will take an "informed and reasoned" decision on the Law Commission report after consulting all stakeholders and that the recommendations were "persuasive" but not binding, the Congress has alleged that the government wants to make the sedition law more "draconian".

Referring to the "procedural safe-guards" recommended by the commission, Awasthi told PTI that the preliminary inquiry will be held by a police officer of the rank of inspector or above.

The inquiry will be done within seven days from the occurrence of the incident and the preliminary inquiry report will be submitted to the competent government authority for permission for lodging of FIR in this regard, he added.



SMC Deploys Vehicles To Collect Hides, Offal Of Sacrificial Animals In Srinagar: City Mayor

Srinagar: Mayor Srinagar Junaid Azim Mattu Tuesday said proactive measures have been taken to promote cleanliness and address water scarcity in the city ahead of Eid-ul-Azha.

With the city witnessing a surge in population and increased challenges surrounding the disposal of sacrificial waste, Mayor Mattu, along with the Srinagar Municipal Corporation (SMC), said they have introduced a comprehensive plan to manage these issues effectively.

The Mayor, while addressing a press conference in the Mayor's Conference Hall at the SMC Central office in Karan Nagar, Srinagar, said that during Eid-ul-Azha, there are significant challenges concerning the sacrifice of animals in the city. The proper disposal of waste and maintenance of religious rituals are of utmost importance, he said.

To address this, 104 copper vehicles have been deployed in Srinagar to handle the hides and offal of sacrificial animals. Mattu said, adding that the list of schedules has already been published in newspapers and other media outlets.

vices to keep Srinagar clean, he said, adding that the service is available throughout the year, and the contact numbers have been provided for assistance. "It is a doorstep delivery service, and 104 vehicles have been allocated for this purpose. The service will be available on June 29, 30, and July 1 - the 3rd day of Eid - for the collection of hides and sacrificial waste," he informed.

Regarding water scarcity in the Srinagar district, the Mayor said the water supply from Ganderbal has been reduced due to agricultural activities, resulting in a 25 to 30 cusec water decrease. For its solution, I have requested the Lieutenant Governor to temporarily shut down the hydropower project to increase the water flow into the Srinagar district by 15 to 20 cusecs, he said

Junai said that

the festival, efforts are being made to address water scarcity by urging the Public Health Department (PHD) to regulate water misuse. We are also coordinating with the Division of Public Health Engineering (PHE) and have deployed water tankers throughout the city for the past week, he said, adding, "We will continue these efforts during Eid and reach wherever possible. Additionally, we are working on fixing potholes as needed.'

Commissioner Srinagar Municipal Corporation (SMC) Athar Amir, as per KNO, said people should not dispose of sacrificial remains on roads, rivers, or any other inappropriate locations. "Immediate action will be taken against those found violating this. Eid is a festival of happiness, and it is everyone's responsibility to celebrate it in a proper manner," he said.

In the vehicle services initiated in Srinagar City for collecting sacrificial waste and other garbage, Amir said the vehicle number along with the driver's contact number has been included. "We have also provided contact numbers for the ward officers. If the driver is unable to reach your area, you can contact the ward officer. If the ward officer is unreachable, you can contact our

Free Trade Area On Both Sides Of LoC Soon

RINAGAR- Prime Minister's working group for strengthening relations across the Line of Control (LoC) has suggested creation of a free trade area between Jammu and Kashmir Pakistan controlled Kashmir.

The ultimate aim (of recommendations) would be to encourage, in stages, the creation of a free trade area comprising Jammu and Kashmir and PcK, modalities of the same being worked out between the two sides, said the group headed by M Rasgotra, which submitted its report to the third roundtable conference on Kashmir in April.

The report said representatives of trade and commerce including the chambers of commerce, have al-ready visited the LoC and reported that there was lot of enthusiasm for opening up of trade and commerce between the two sides.

The group recommended setting up of a joint consultative machinery of officials and representatives of I commerce from both the sides to resolve any difficulties in flow of trade. The list of items for export and import should include, handicrafts, fruits, cement, iron, medicines, sugar, basmati, rice, machinery and equipment, sports goods including raw material like willow, plastic pipes and other items that are manufactured or assembled by small scale industry in Jammu and Kashmir, the

To facilitate the travel of traders across the LoC, the working group recommended that the traders should he given multiple entry and exit permits, which should be valid for a minimum period of one year. The issue of state taxes on the goods traded across the LoC may be determined by the state government after due consideration of all relevant aspects, it added.

How Fake Customs Officials Interrogate, Loot Man Of Lakhs At Delhi Airport

NEW DELHI: A 53-year-old man, who works as a labourer in Saudi Arabia, was allegedly cheated of more than ₹4 lakh in foreign currency outside the Indira Gandhi International Airport in Delhi by two persons posing as Customs department officials, police said today.

According to the FIR, Mohammad Suleman, a native of Rajasthan's Ajmer, landed at the Delhi airport early on Sunday morning from Saudi Arabia.

Outside the airport, the two accused, posing as customs officials, led Suleman to the parking area. On the way, they took his passport and belongings. They then took the victim

to Mahipalpur in a car being driven by another person, the

complaint stated. The accused stopped the car in an isolated area, and snatched his mobile phone, Saudi Riyad 19,000 (valued at ₹4.15 lakh) and ₹2.000 in Indian currency. They interrogated him where he got the mobile phone and the foreign currency, a police official said.

The accused then forced the man to step out of the car and sped away while telling that they would return with their senior officer, the police official said.

ARTIFICIAL INTELLIGENCE:

An Existential Risk To Humanity

PARIS, FRANCE: The warnings are coming from all angles: artificial intelligence poses an existential risk to humanity and must be shackled before it is too late.

But what are these disaster scenarios and how are machines supposed to wipe out humanity?

PAPERCLIPS OF DOOM

Most disaster scenarios start in the same place: machines will outstrip human capacities, escape human control and refuse to be switched off.

"Once we have machines that have a self-preservation goal, we are in trouble," AI academic Yoshua Bengio told an event this month.

But because these machines do not yet exist, imagining how they could doom humanity is often left to philosophy and science fiction. Philosopher Nick Bostrom

has written about an "intelligence explosion" he says will happen when superintelligent machines begin designing machines of their own.

He illustrated the idea with the story of a superintelligent Al at a paperclip factory.
The Al is given the ultimate

goal of maximising paper-clip output and so "proceeds by converting first the Earth and then increasingly large chunks of the observable universe into paperclips".

UP Hospital's License Cancelled After 'Circumcision' Of 3-Year-Old Boy

BAREILLY: Taking cognizance of the case of the circumcision of a 3-year-old boy in a hospital in Bareilly, the license of M Khan Hospital was cancelled on the instructions of Deputy Chief Minister Brajesh Pathak.

In a tweet in Hindi on Saturday, Deputy Chief Minister Brajesh Pathak, who also holds the health portfolio, said he has sent a health department team to the hospital to investigate the matter.

"If the complaint is found correct, orders have been given to the CMO, Bareilly, to register an FIR against the guilty doctor and hospital management, to cancel the registration of the said hospital with immediate effect, and to make the complete report of the proceedings available within 24 hours," Mr Pathak had said.

On June 23, a two-and-ahalf-year-old boy was circumcised at M Khan Hospital, Sta-

dium Road, instead of surgery of his tongue. After the incident, the relatives complained about the matter to the police.

As soon as the incident became public, several Hindu organisations reached the spot and protested against the circumcision.

Taking cognizance of the incident, Deputy CM Brajesh Pathak directed Bareilly Chief Medical Officer Dr Balbir Singh to investigate and take action into the matter.

According to the Chief Medical Officer Dr Balbir Singh, the panel of doctors went to the hospital and investigated the matter and the statements of the doctor and the entire staff were also taken.

Apart from this, statements of the family members of the child were also recorded. Dr Balbir Singh said that all the necessary documents of the hospital were taken into custody and the license of the same hospital was suspended.

SRINAGAR: Amid the drowning incidents at picnic spots, the School Education department (SED) on Tuesday directed all the school heads in north and central districts to get proper permission before organizing any outing and ensure that no student below 18 years of age is forced to go for picnic.

Directorate of School Education (Central and North) has issued an advisory in this regard to the Chief Education Officers of Srinagar, Budgam, Ganderbal (Central) and Baramulla, Kupwara and Bandipora (North) districts.

The Joint Director (Central &North) School Education, in the order said that the recent episodes of drowning and deaths of children in different rivers, nallahs and streams in picnic spots of Kashmir have given sleepless nights to parents, children and teachers who have approached the department for intervention in

"In order to handle this significant and sensitive issue pertaining to student community, parents, there is an immediate need of attention, consideration and disposal, redressal of these grievances on safety, security and well being of tender boys and girls studying in government as well as private schools of various districts of Kashmir division, the order reads.

It further reads that a new trend has begun, which is Summer Camps. "There are many reports where students have drowned, or got hurt, or indulge in eve teasing, molestation, theft and other crimes during these camps. The matter needs to be looked upon seriously and a proper modus operandi should be adopted on these Summer Camps up to 8th or 10th class at least; besides, other matters of overcharging the parents should be looked in to.'

"In this behalf, all the Chief Education Officers, Zonal Education Officers concerned are requested to be extra vigilant and walk an extra mile to check the violations and nab the guilty involved in such illegal practices and sensitise the Head of the Institutions, Headmasters of private as well as government schools to maintain high standards of professionalism in their respective schools and desist children without seeking proper permission from Chief Education Officer, Zonal Education Officer concerned and in no case children below 18 years of age be forced to go for picnic or get consent of the parents top priority as it involves the after putting undue influence further reads.

The Heads of the institutions, schools shall also designate 5 to 10 staff members as nodal officers, supervisors to safeguard the students and monitor their to and fro movement from school premises to picnic spots and back to their homes.

The school heads shall handle, monitor and regulate the entire program personally with higher standards of professionalism and responsibility, the order added.

"All Heads of the Institutions, school heads shall approach Chief Education Officers concerned who in turn will get it verified, examined and checked by Zonal Education Officers concerned in case the permission to conduct/organize an excursion, picnic, camps required and the clearance shall be granted only after proper permission is sought from the administration of the area and the names of places of picnic, excursion and out station camps to which any particular school/ educational institutions proceeds shall be communicated in writing well in advance to Zonal Education Officers, Chief **Education Officers and District** Administration concerned, so that in case of any exigency, emergency the rescue teams can be sensitized/ activated in that area well in advance as a precautionary manner, to en sure safety, security and well being of students of tender age," the order added.

8 Killed, 16 Injured in 3 **Road Accidents in J&K**

BHADERWAH/JAMMU: Eight persons were killed and sixteen others injured after three vehicles skidded off the road and plunged into deep gorges in the hilly Doda and Ramban districts of Jammu and Kashmir in three separate incidents on Tuesday, police officials said.

In the first accident near Chattergalla top on Bhaderwah-Pathankot National Highway in Doda, five persons died after the vehicle they were travelling in skidded off the road and fell 250 metres into a gorge, said Vinod Sharma, Additional Superintendent of Police, Bhaderwah.

Stakeholders Seek Revision Of 20% Duty Waiver On **American Apple**

SRINAGAR: The Centre's decision to remove 20 per cent advanced than us. The farmers retaliatory import duty on get subsidies, technologies and American apples will pile on there are a number of schemes for the already stressed Kashmiri horticulture industry, fruit dealers and growers in the valley said.

The farmers and dealers were suffering due to hail storms and unexpected weather conditions, including unseasonal rain, this year, Bashir Ahmad, president of the Fruit Growers and Dealers Association of Kashmir, told PTI

The fruit industry of Kashmir is already struggling. Reducing 20 per cent import taxes on Washington Apple will add more difficulties and have an adverse impact on the horticulture industry, he said.

"Now, if we won't get adequate rates of the apples, it will be very unfortunate. Though the production of apples is quite high, a decrease in rates will raise our difficulties tremendously. We request the Government of India to immediately roll back the waiver," Ahmad added.

He said this will not only benefit the apple farmers of Kashmir but also those from Himachal and Uttarakhand.

Shahid Chowdhury, General Secretary of the New Kashmir Fruit Association, said the 20 per cent waiver will substantially bring down the prices of

Kashmir apples.

"Foreign countries are quite that make their products far superior in quality. If tax is lower, growers of Kashmir and apples of Kashmir would not be able to compete with them," Chowdhury said.

Farooq Ahmad Rather, an apple grower, said that in 2017, the government of India raised the duty of the apple from the United States from 50 per cent to 70 per cent.

"But now the unfortunate news came that Washington Apple's duty is reduced by 20 per cent. It will adversely affect the local produce of Kashmir.

"For three to four years, the US product was not affecting our market but now produce from other countries was coming up in the market that is having very bad consequences on growers of Kashmir. We are already at a great loss ... I believe this is a wrong decision and the government should look into this," he added.

Mehraj Ahmad, a fruit seller, said if the cost of American apples is reduced, the market of the local apple will get affected.

"As Kashmiri apples are famous all over India, we don't want our apple demand to be reduced. We want our apple industry to grow," he added.

Hope Fading Fast

he political landscape in Jammu and Kashmir has witnessed significant changes since the abrogation of Article 370 on August 5, 2019. But the delayed Assembly elections have become a topic of concern. While defence minister Rajnath Singh has reiterated the government's commitment to restoring the democratic process, the absence of a specific timeline has raised questions about the reasons behind the delay. Addressing a security conclave in Jammu on Monday, the defence minister emphasized that the government's primary objective is to restore normalcy swiftly and fulfill the long-standing aspirations of the people. Singh also assured that the process to hold elections in the union territory won't be lengthy. The assurance would go some way to make people in J&K happy.

Even as the country braces for 2024 general elections, there are no signs that the Assembly elections will be held in Jammu and Kashmir. And with every passing month, the hope that the polls will be held in the union territory before the national elections is fading fast. This, despite the fact, that the entire political class in the UT, except the BJP, want the elections to be held in the near future.

J&K has not had an elected government since June 2018 when Governor's rule was imposed after the PDP-led coalition government lost its majority following the withdrawal of support by the BJP. Subsequently, on August 5, 2019, New Delhi abrogated Article 370 that granted J&K special status under India's constitution. Since then the Lieutenant Governor has taken over from Governor.

Earlier in March, a delegation of political leaders led by National Conference president Dr Farooq Abdullah met the Election Commission of India, seeking early elections in the Union Territory. The delegation requested the ECI to hold elections as soon as possible now that the delimitation process had been completed. The political leaders also submitted a memorandum to the ECI, in which they called for the restoration of the democratic process in the UT. But there has been no election-related move from the Election Commission to hold the polls in the UT. And this is happening at a time when, for once, there is a palpable desire for elections in the region.

However, after the defence minister's assurance, people would expect some concrete action on the holding of Assembly elections by the central goevrnment.It is now less than one year before general elections are held. So people would expect J&K polls to be held later this year, or early next year. However, things are likely to become clearer in the weeks and months to come.

Thin ice

ccording to a report by the International Centre for Integrated Mountain Development, the Hindu Kush Himalayan region, which contains the largest volume of ice on earth outside the polar stretch, is undergoing "irreversible" changes triggered by climatic impacts and, consequently, can lose up to 80% of its glaciers by 2100 at current levels of global warming. This is alarming. These glaciers are the primary source of water for most north and east Indian rivers, not to mention the only source of water for regions like Ladakh. In the long run, this will aggravate droughts across the northern and eastern plains, which is where a majority of India's food is grown. In the short term, it will cause floods, landslides, and glacial lake bursts like the one in Chamoli, Uttarakhand, that claimed over 200 lives. If mitigatory measures are not taken at the earliest, 13% of the world's population in India, Bangladesh and Pakistan will be left without adequate food and water. A key step to alleviate the impacts of glacial melt is to restore forests and shrubs on mountain slopes. While this will not stop glaciers from melting immediately, over time, it can bring down surface temperatures and, in effect, the rate of melt. It can also reduce landslides and help replenish the underground water table. It is thus concerning that the State of Forest Report, 2021 shows that the Himalayan states lost 1,072 square kilometres of forest cover in two years.

This World Environment Day, the prime minister, Narendra Modi, had assured that India is moving along a "very clear roadmap" to tackle climate change. The contours of that roadmap seem ominous in light of the fact that the Union ministry of mines recently urged the ministry of environment, forest and climate change to do away with the requirement of forest clearance for exploration of mining activities. India claims that it is leading the charge for developing nations demanding greater accountability from the developed world when it comes to fighting climate change. Yet the ground underneath its own feet is shaky. It is time to walk the talk. India's global commitments to tackle climate change must be accompanied by a robust framework to protect its domestic ecologies.

ing clean drinking water to every household in India, the Government of India launched Jal Jeevan Mission (JJM) around 4 years back. This centrally sponsored scheme was formally launched by Prime Minister Narendra Modi on 15th August 2019. The aim of JJM is to provide 'Functional Household Tap Connections' (FHTC) to every rural household in India by 2024. The Jal Jeevan Mission -JJM is aimed at creating a people's movement - Jan Andolan for water.

Pertinently, in Jammu & Kashmir a major chunk of this year's annual budget has gone to the water sector. More than Rs 5000 crores (Rs 50 Billion) have been allocated by Government of India to J&K under Jal Jeevan Mission and we can see a large number of projects being executed by PHE-Jal Shakti Department across J&K.

At a time when massive work is being executed under this national flagship programme, we see our roads being damaged in many areas to lay the drinking water pipelines. Infact the damage being caused to roads to lay water pipelines is not a new but this has been prevalent in the past as well due to a lack of coordination and proper governance.

It is quite evident that there is hardly any coordination between the Public Works Department-(PWD -R&B), PM Gram Sadak Yojna-PMGSY & PHE Jal Shakti Departments. Roads which were metalled and blacktopped have been dug down by the contractors using JCB cranes within months and nobody knows when these roads will ever be repaired back.

No coordination between PHE & PMGSY

According to a news report published in some local dailies of Srinagar last year, a road which was blacktopped after a decade was damaged within months by the Public Health Engineering Department -PHE in Shopian. The blacktopped road from Kellar to Pehlipora villages in Shopian district was metalled and blacktopped under the national rural roads programme called Pradhan Mantri Gram Sadak Yojna-PMGSY after 15 years. Within two months of construction of this beautiful road, the PHE Jal Shakti contractors came and started digging the road surface to lay water pipeline under Jal Jeevan Mission -JJM. This caused massive

damage to the road. Pertinently, the PMGSY roads are not wide enough and when they are dug it causes a lot of damage to them. Even the drains that are constructed also get damaged. This news was reported by several newspapers but authorities were unmoved. This is not a single case but there are dozens of such cases happening daily in J&K but such issues get unreported now as this

has become a routine exercise. It was reported by local newspapers that no official permission was sought from PMGSY by the PHE Jal Shakti department in the Kellar Pehlipora road digging case. The Assistant Executive Engineer -AEE PMGSY Shopian said this on record and he was even quoted by news agency KNO as well. The engineer said that PMGSY had constructed the road just two months back and the PHE Jal Shakti department damaged it without even obtaining a No Objection Certificate -NOC. The PMGSY had even threatened to lodge an FIR against the contractors. When the local PHE Jal Shakti Assistant Engineer was asked by reporters as to why they damaged the road surface constructed by PMGSY he had said that they had a valid permission as a joint permission has been sought at higher level to open up all those

not been repaired back. Infact information under RTI Act was also with regard to this issue but there was no positive response from the Government's end

JJM in J&K

The substantial increase in Jal Jeevan Mission(JJM) budget every year in J&K makes it evident that Govt of India is concerned about addressing drinking water issues in Jammu & Kashmir and towards materializing its commitment of providing tap water connections to every household plus capacity building of Water Quality Management through testing, monitoring and surveillance. J&K contemplates becoming 'HAR GHAR JAL' Union Territory by the financial year 2022-23 and to achieve this target, the Government officials aren't caring much for proper coordination with PMGSY,PWD-R&B during laying of water pipelines. As per a 2022 report, 18.35 lakh rural households in J&K, 10.39 lakh

PMGSY had constructed the road just two months back and the PHE Jal Shakti department damaged it without even obtaining a No Objection Certificate -NOC.

PMGSY roads where they intend to lay water pipelines under JJM. The officer has assured that roads would be repaired if they get damaged but on the ground this isn't happening as of now.

Nowhar Changund Road

After repeated requests, the work on Nowhar Chanagund road in Charari Sharief Budgam was taken up by PWD (R&B) last year in July and within a few months the road surface was opened up using JCB cranes to lay water-pipelines by PHE Jal Shakti contractors under JJM. I raised this issue from ground zero but to no avail.

As our legislative assembly is also in a state of suspended animation, these issues are not even raised on the floor of the house. The institution of District Development Council -DDC is yet to get evolved and most of these members are not taken seriously by our bureaucracy.

If PWD R&B had plans to repair this 2 kms link road, wasn't it the duty of the then local Executive Engineer PWD -R&B to have a meeting with his PHE Jal Shakti counterpart?

Had the R&B Executive Engineer waited for two more months, the road would not have been damaged and drinking water pipeline would have been laid and the road would also have been repaired and macadamised. Now this road surface is in shambles again and till date the road has

households have tap water connections which is around 57 %. Srinagar and Ganderbal districts have already achieved the target of having 100 % households with tap water connections.

It is evident that Govt officers are forced to achieve targets under Jal Jeevan Mission -JJM by their seniors and that is the reason we lack coordination between various Govt organisations and engineering wings while executing JJM projects in J&K. This has resulted in complete chaos and confusion. At a time when people are being supplied with portable drinking water through taps, a huge population in many districts of J&K are deprived of good road connectivity. Blacktopping and metalling of roads is going on at great pace nowadays but we don't know when these roads will be damaged again. The Govt must address this issue as the digging of roads has become a routine exercise in J&K and taxpayers money is getting wasted.


"Verily, Allah does not disregard the supplications of the supplicants. (Prophet Muhammad Pbuh)

Zil Hajj: What Does the Day of Arafah Represent?

Tawmul 'Arafah is considered the most important day of the entire Hajj pilgrimage. In fact, the Prophet (saw) said: "Hajj is 'Arafah" (Tirmidhi). It is so important that if one misses 'Arafah, their Hajj is not complete or valid. On this day all the pilgrims – woman, man, old, young, rich or poor, of every race, colour and nationality - journey to the desert plains of 'Arafah. They begin the journey from Mina after the dawn prayers, and they remain until sunset.

As they make their way, they will continuously recite the Talbiyah "lab-bayka Allahuma lab-bayk, lab-bayka laa sharika laka lab-bayk, in-nal hamda wan-ni'mata laka wal Mulk, laa sharika lak'

The powerful meaning of those words are: "Here I am in Your service, O Allah, here I am. Here I am, You have no partner, here I am. Verily all praise and blessings are Yours, and all sovereignty, You have no partner." [Muslim].

The Talbiyah captures the purpose of the whole journey, to serve Allah and worship Him and Him alone. The day is spent praying and making du'a (supplication) to Allah - all the hujjaj (pilgrims) are gathered in one place, with the same goal, the entire plain is filled with worshippers dressed in their simple white cloth. It is a day of deep reflection and connection with God.

Allah says in the Qur'an: "Then when you pour down from Arafaat, celebrate the praises of Allah at the Sacred Monument, and celebrate His praises as He has directed you, even though, before this, you went astray."Surat al-Baqara 2:198

The verse shows that no one is exempt from God's Mercy on this day - Allah's forgiveness is for everyone who seeks it. It is a profound and humbling experience for all those who witness 'Arafah on Hajj.

Many connections with other events are made on this day. The word 'Arafah comes from the word 'to know', or to be introduced. It is the place where Adam (as) and Hawa' (as) were reunited after being sent down from Jannah, and after they had repented to Allah. It was thus the first ever meeting place on earth for any human. Every year, people are gathered on 'Arafah to repent to Allah, just as had been the case with our greatest grandparents. "'Arafah" also symbolises the fact Muslims seek to renew their relationship with God on this

day.

Even more poignant is the fact that this is the place where all humanity will be gathered for the start of the Day of Judgment. When the pilgrims stand before Allah on yawmul Arafah, they inevitably remember that the next time they return may well be on Yawmul Oiyamah, when there will no longer be an opportunity for

There is no shade on the plains of 'Arafah - these days there are some tents where people can shelter. But when you speak to elders who went on Hajj decades ago, they will tell you how difficult it was back then. They used to stand before Allah, seeking His Mercy, dishevelled in dust and in tears, under the burning heat of the desert sun. They report that it felt as if they were already experiencing Al-Qiyamah...the type of struggles pilgrims faced back then may have changed now. But the significance of 'Arafah, the reconnection with Allah, has remained the same. The day is not only for those who go on pilgrimage - it is a special day for every Muslim, even if they are in the furthest part of the globe.

The Prophet (saw) said the following: 1."The best of du'a is du'a on the day of 'Arafah." (Hasan)

2.(For those not on Hajj): "Fasting on the day of 'Arafah absolves the sins for two years: the previous year and the coming year" (Muslim)

3."There is no day in which Allah saves more people from the fire than the Day of `Arafaĥ." (Muslim, Nasa'i, Ibn Majah)

4."Anyone who has an atom's weight of faith in their heart will be forgiven by Allah on this day, whether or not they actually stand at `Arafah." (Abu Dawud)

We also remember that 'Arafah is the day when Allah revealed the following verse: "Today, I have perfected your religion for you, and have completed My blessing upon you, and chosen Islam as D n (religion and a way of life) for you". (Al Maidah: 3).

Just as Ramadan and its last 10 nights was honoured with the first revelation of Qur'an, so Dhul Hijjah and its first 10 days were honoured with the final ever revelation of Qur'an. the Day of 'Arafah was the last time Angel Jibril (as) came to earth as a messenger to the Prophets. 'Arafah was also the day and place where our beloved Prophet (saw) delivered his farewell sermon, on his last ever Hajj, to crowds of

hundreds and thousands of Muslims. It was a beautiful message, but also bittersweet, for it heralded the fact the Prophet (saw)'s remaining time on earth was short.

"O People, lend me an attentive ear, for I know not whether after this year, I shall ever be amongst you again. Therefore listen to what I am saying to you very carefully and take these words to those who could not be present here today" ..

The Prophet's farewell also acts as a reminder that none of us knows how long we still have on this earth. Just as all the hujjaj have to arrive at 'Arafah before it is too late, we too have to make the most of this day before the sun sets – and make the most of our lives before it too slips away.

The Prophet (saw) ended his sermon by saying: All those who listen to me shall pass on my words to others and those to others again; and may the last ones understand my words better than those who listen to me directly. Be my witness, O Allah, that I have conveyed your message to your people". May we live up to the hope and trust that the Prophet (saw) had in us. And may Allah accept everyone's deeds and prayers on this day, from the hujjaj and

Al Can Help Build Solutions To Advance Healthcare Systems: WEF Study

rtificial Intelligence (AI) can help fight systemic challenges straining global healthcare systems with AI-driven diagnosis, infectious disease intelligence and clinical trial optimisation showing the highest potential, a new study said on Monday.

The report published by the World Economic Forum (WEF) cited several case studies, including one from India, to highlight the transformative potential of AI in healthcare and the importance of public-private collaboration in driving its global adoption.

The Indian case study found that Apollo Hospitals was using AI to assess cardiovascular risk more accurately than established benchmarks and at a massive scale.

Nearly 18 million people die each year from heart disease, accounting for an estimated 32 per cent of worldwide deaths

and this burden is especially high in India, where cardiovascular disease is characterized by early onset, rapid progression and high mortality rate.

"Apollo Hospitals operates more than 50 hospitals serving more than 300 million patients across India. Given its position on the front lines of the disease, Apollo aspired to create a risk stratification algorithm that would provide a heart disease 'score' for any patient in India to be more accurate than traditional risk stratification approaches, the WEF said.

The study, conducted in collaboration with global management consulting and technology firm ZS, aims to spur publicprivate collaboration to accelerate the responsible application of AI in healthcare, the WEF said.

It proposed a global taxonomy for healthcare AI uses and shows how global healthcare systems could unlock the full potential of these new technologies to transform patient care, reduce costs and enable



people to live healthier, longer lives.

We are at a critical juncture in global health and healthcare, as mounting headwinds threaten collective wellness as well as employers, economies, budgets and societal resilience," said Shyam Bishen, Head of the Centre for Health and Healthcare and Member of the Executive Committee at WEF.

'Closely governed advancements in AI are critical to supporting a broader digital and data-driven transition to intelligent healthcare systems, which can meet populations' needs and transform healthcare outcomes, access, and efficiency," he added.

ZS CEO Pratap Khedkar said, "The question is no longer whether the technology exists for AI to transform healthcare. It does..

'The question is whether or not stakeholders can pull together to set the conditions for its widespread use and adoption. If adopted broadly and responsibly, AI holds the potential to radically transform healthcare systems and improve health outcomes for all," he added.

The WEF said its report is based on a comprehensive analysis of more than 400 existing AI use cases as well as in-depth interviews with 50 global leaders across technology, healthcare delivery, biopharma, government, academia and more.

It underlined AI's potential to diagnose a range of diseases at scale, leading to early interventions for individuals at greater risk, as well as counter infectious diseases

through AI-powered systems that can predict future outbreaks, map their spread and deliver customized mitigation strategies to reduce their impact.

Clinical trials can be enhanced by facilitating optimal site selection, participant recruitment and the creation of more representative synthetic data, it added.

Besides highlighting the potential of AI in healthcare, the report also identified common barriers to its adoption. These barriers include insufficient highquality data, low trust in AI solutions and inadequate technological infrastructure, among others.

Public-private support for creating a strong data foundation and improved privacy laws, responsible and transparent design of AI algorithms, and significant investment to adopt these technologies at scale will be crucial to overcome these barriers and ensure equitable access to these innovations worldwide, the WEF said.

Blood Sugar Levels Better Controlled By Higher Dose Of Oral Semaglutide

Higher doses of oral semaglutide, a widely taken blood sugar medication, have been associated with better control over blood sugar levels and more weight loss than lower doses, scientists have published in the journal The Lancet.

They found that once-daily oral semaglutide taken at 25 milligrams (mg) and 50 mg did a better job in lowering blood sugar levels and promoting weight loss than the lowest dose of 14 mg.

"Low doses of GLP-1 receptor agonists are really powerful for reducing A1C, or the average glucose in the blood whereas, the higher doses are really good for weight reduction.

"On average, patients lost eight kilograms at 50 milligrams, which is nearly twice as much weight loss that we saw with the lowest dose," said John Buse, study author and professor of Medicine, University of North Carolina Health Care, US.

Diabetes is characterised by abnormally high blood glucose levels, excessive urination and persistent thirst and becomes more severe over time, making it more difficult for the patient to manage blood sugar levels.

Semaglutide, a glucagon-like peptide-1 (GLP-1) receptor agonist, has been known to grant patients more control in lowering of blood sugar.

Blood sugar levels are measured through a percentage, called A1C. According to the American Diabetes Association, diabetic adults with A1C less than 7 per cent are considered healthy.

In this study, 1,606 diabetic participants, on average male

algo Gluco.

and aged 58.2 years, were divided randomly into three groups and asked to take oral semaglutide once a day. For 52 weeks, each group took either a 14 mg dosage, a 25 mg dosage, or a 50 mg dosage. All the participants had an A1C between 8 and 10.5 per cent.

Those receiving the 25 mg and 50 mg doses of oral semaglutide were found to be more likely to reach the A1C target of

less than 7 per cent, compared with those who took 14 mg.

Semaglutide is known to also cause weight loss by suppressing appetite.

At the end of the 52 weeks, the participants who took 50 mg of oral semaglutide had lost, on average, 8 kilograms (kgs). Those who took 25 mg and 14 mg lost about 7 kgs and 4.5 kgs, respectively, the researchers found.

However, the researchers noted, the participants also experienced side effects, the most common of which was nausea, owing to the effect the drug has on the fullness of the stomach.

Some of the participants also reported experiencing vomiting, diarrhea, and/or constipation, particularly those who took the higher doses of 25 mg and 50 mg.

Sacrificial Animals Sold At Arbitrary Prices, Allege People

No rate fixed by Govt; mutton dealers say rates are 'between the buyer and seller'

SRINAGAR: Ahead of Eid-ul-Azha, people complain that the sacrificial animals are being sold at arbitrary prices in the absence of the rate regulatory body for livestock in Jammu and Kashmir.

The consumers told Kashmir News Observer that there are no fixed rates for sacrificial animals and that the sellers are pitching the rates of their choice.

"From Eidgah to Soura, not a single seller told me a fixed rate; some were selling sheep at Rs 350/kg while some at Rs 430/ kg. There is no enforcement or checking of rates," Tariq Ahmad, a Srinagar resident, said.

Tariq, who was present at the Eidgah, where the sacrificial animals are sold, said he is not able to select the 'Qurbani' due to high rates. He said he along with his family has been visiting the market for the last two days.

"The rates should be reasonable. I selected a sheep that was of a good size, but its owner asked for a huge price. I even offered him a rate beyond the ongoing market rate, but he insisted on his price tag," Ahmad said.

Many visitors said the market is comparatively down in the last few years. "The people's purchasing power is low this time. The livestock at Eidgah used to be less, but you can see how much still stands unsold," said another person



out to buy the animal. A non-local seller from Ra-

jasthan said that he has so far sold around 30 percent of his livestock. "I have paid the freight of more than Rs 1 lakh for transportation. I brought 160 sheep here, of which I have sold around 40 only. There are no fixed rates, I have sold some at Rs 350/kg and some at Rs 360/kg even though there should be a rate of Rs 400/kg," he said.

Similar reports were received from other districts of the valley where people complained of unregulated rates of sacrificial animals for Eidul-Azha.

According to the Mutton Dealers Association general secretary Me'raj-u-din they have no say in regulating the rates of sacrificial animals. The rates are purely in an agreement between the buyer and seller, he said.

"There is nothing much our

association can do about it. It is purely between a buyer and a seller when both are satisfied at a specific rate. And more importantly, the rates depend upon the quality one purchases," he said. "Even those who are not of our trade sell sacrificial animals on these days. We cannot make any pre-announcement on the rates."

Last year, ahead of Eid-ul-Azha, the J&K government fixed the rates for sacrificial animals. For Delhi Walla and Merino Cross varieties, it was Rs 310 per kg, for Bakerwal and local Kashmiri sheep, it was Rs 295/kg and the rate for goats was fixed at Rs 285 per kg.

Earlier this month, the administration instructed the officials to refrain from regulating the prices of mutton and other livestock products.

Divisional Commissioner Kashmir did not respond to the call for his comment on the issue. (KNO)

To ensure uniform utilization of CAPEX budget

J&K Govt Tells Admin Secretaries to Hold Monthly Reviews

SRINAGAR: In a significant move, the Jammu & Kashmir Government has directed administrative secretaries to hold monthly review meetings in their departments to ensure the uniform utilization of capital expenditure budget and to avoid rush of expenditure in the last quarter of a

financial year. According to the Kashmir News Observer these directions were passed during the meeting held on June 08 under the chairmanship of Arun Kumar, chief secretary, to review physical/financial progress achieved under J&K's capital expenditure budget for 2022-23 and 2023-24.

"In order to ensure the uniform utilization of capital expenditure budget over the entire financial year and to avoid the rush of expenditure in the last quarter particularly the month of March, all administrative departments shall hold monthly review meetings in their respective departments," reads the record note of the meeting.

rected the Development Expenditure Division (DED)-II shall also put an arrangement in place for monthly review of capital expenditure budget vis-a-vis financial and physical targets.

In the meeting director general, Development Expenditure Division-II informed that the annual expenditure under the capital expenditure budget is showing an increasing trend since 2019-20.

"The number of projects completed under the UT sector has risen from 6933 in the year 2019-20 to 22766 in the year 2022-23. The current year's target has been negged at 32615 which is a substantial increase over last year's achievements," the minutes of the meeting state.

CAD Narrows To 0.2% Of GDP In Q4 FY23 On Lower Trade **Deficit, Higher Services Exports**

MUMBAI: India's current account deficit narrowed to USD 1.3 billion or 0.2 per cent of GDP in the January-March quarter of FY23, mainly due to moderation in the trade deficit and a robust increase in services exports, RBI data showed on Tuesday.

However, for the 2022-23 fiscal, the current account balance recorded a deficit of 2 per cent of GDP compared to 1.2 per cent in 2021-22.

"India's current account deficit (CAD) decreased to USD 1.3 billion (0.2 per cent of GDP) in Q4:2022-23 from USD 16.8 billion (2.0 per cent of GDP) in Q3:2022-231, and USD 13.4 billion (1.6 per cent of GDP) a year ago [Q4:2021-22]," as per the RBI's 'Developments in India's Balance of Payments during the Fourth Quarter (January-March) of 2022-23'.

The sequential decline in CAD in the fourth quarter of 2022-23 was mainly on account of a moderation in the trade deficit to USD 52.6 billion from USD 71.3 billion in the preceding quarter, coupled with robust services exports, it

Net services receipts increased, on a sequentially and



year-on-year (y-o-y) basis, on the back of a rise in net earnings from computer services.

The central bank had been maintaining that the CAD, a key indicator of the country's balance of payments, would remain manageable.

Private transfer receipts in the January-March period, mainly representing remittances by Indians employed overseas, increased to USD 28.6 billion, up by 20.8 per cent year-on-year.

In the financial account, the RBI said net foreign direct investment (FDI) at USD 6.4 billion was higher than USD 2.0 billion in Q3 2022-23, although lower than a year ago (USD 13.8

Net foreign portfolio investment (FPI) recorded an outflow of USD 1.7 billion driven by the equity segment compared to an outflow of USD 15.2 billion during the corresponding period a year ago.

'India's Online Retail Sector **Market Size Likely To Touch** USD 325 Bn By 2030'

NEW DELHI: The country's online retail market size may touch USD 325 billion by 2030 against USD 70 billion in 2022, mainly due to rapid growth of e-commerce in tier-2 and tier-3 cities, according to a Deloitte India report released on Tuesday.

It also said that online retail penetration is projected to grow at an extraordinary rate, and it would outpace offline retail by 2.5 times in the next decade.

As India ascends to become the world's third-largest consumer market, Deloitte Touche Tohmatsu India LLP's (Deloitte India's) 'Future of Retail' report "foresees the online retail sector, which stood at USD 70 billion in 2022, to surge to USD 325 billion by 2030".

The report attributes these projections to the rapid growth of e-commerce in tier-2 and tiertier-1 markets in terms of total

In 2022, these cities accounted for over 60 per cent of all orders,

with tier-3 cities experiencing a remarkable 65 per cent growth in order volume and tier-2 cities witnessing a substantial 50 per cent growth, it said.

The surge in online retail can be attributed to various factors. The convenience of ordering and returns, bolstered by a robust logistics infrastructure spanning over 19,000 pin codes, has played a pivotal role," it added.

Additionally, the report said that India boasts a digitally savvy consumer base of 220 million online shoppers, further driving the growth of e-commerce.

Furthermore, the sector has witnessed significant investments from private equity and venture capital firms, totalling USD 23 billion over the past five years, the report said. Online sales are poised to

surpass organised retail, with a growing emphasis on omchannel retail strategies w retailers seamlessly integrate their offline and online channels to provide consumers with the best of both worlds, it added.

Very Optimistic About FTA With India: **UK Investment Minister**

LONDON: An India-UK free trade agreement (FTA) is really important for both nations and it is for businesses on both sides to help drive that agenda, UK Minister for Investment Lord Dominic Johnson said in London on Tuesday.

Addressing a UK-India Infrastructure Summit hosted by the City of London Corporation as part of the India Global Forum UK-India Week, Johnson said he is "very optimistic" about an FTA even as he declined to put a timeframe to it.

India and the UK recently concluded their tenth round of FTA negotiations and an 11th round is set to begin in the next few weeks towards a comprehensive agreement expected to significantly enhance the bilateral trading relationship worth an estimated 34 billion pounds in 2022.

"I'm very optimistic about a free trade deal with India," said Johnson. "It is hugely important for India if it wants to get the capital flows it needs

to take itself to the next step, which is to become a global hyperpower economically. And it's very good for the UK if we're going to ensure that we've got the investment coming from India," he said. The minister went on to make a

clarion call for representatives of business and industry gathered at the summit to be more vocal about voicing their support for such an FTA. "It's really important for business-

es to express their support for such a deal because it's about allowing businesses to function more effectively with greater profits, wealth and security for the world." he said.

Describing the India-UK relationship as the "most symbiotic partnership", the minister also backed a City of London suggestion for a new UK-India Green Finance Partnership to promote greater two-way green investment flows.

"I truly believe India has reached escape velocity as an economy. And, I truly believe that the UK is literally India's best friend, and the best placed country to take advantage of what is such a mutually beneficial long-term financial partnership," he added. Under the theme of "Financing

a Sustainable Future", the summit highlighted the immense scope and potential for investment in sustainable infrastructure development in India, and London's expertise in meeting India's growing demand for green finance.

"The UK, particularly the City of London, has excellent capabilities in structuring and funnelling finance where it is needed. The UK has demonstrated technological capabilities while India is at the frontiers of innovation. Combining technology with financing would enhance the cooperation," said BVR Subrahmanyam, CEO of NITI Aayog.

"I would argue that your interests are best served in aligning with us in making sure that the transformation of India happens in a way that does not replicate any of the faults of the past," noted Vikram Doraiswami, the Indian High Commissioner to the UK.

Prof. CED), Coordinator of the event, Dr. Sabzar Gani Batoo and faculty coordinators of Rajbhasha cell and ministerial staff of NIT Srinagar attended the workshop.

In his key address, Mr.Jagdish Ram Pauri, Joint Director, Department of Official Language, MHA highlighted the brief history of Rajbasha and its importance. He said the central government has taken steps to encourage the use and propagation of Hindi as Rajbhasha while also recognizing and supporting the diversity of languages in the country.

Mr. Pauri said on 14th September 1949, the Constituent Assembly adopted Hindi in Devanagari script as the official language of the Indian Union.

"Hindi is connecting language of the country and is being spoken by millions of people and is the dominant language of the Indian subcontinent,"

While sharing his long association with the Hindi language, Mr. Pauri highlighted the rules and regulations of the Official language act.

"We need more efforts for its implementation and the main aim of organizing such events is to raise awareness regarding the official language," he added.

Addressing the workshop, Prof. Yedla appreciated the efforts of Rajbhasha Cell and Coordinators in implementing official language in the administrative work

He also expressed his gratitude to resource person Mr. Jagdish Ram from MHA for extending their full support in achieving the target set up by the Parliamentary Committee to ensure Hindi is used increasingly in the

The statement reads that during the search operation, as the joint search party approached towards the suspected spot, the hiding terrorist fired indiscriminately upon the joint search party, in which one police personnel got injured who was subsequently shifted to hospital for treatment.

"The hiding terrorist was also given an opportunity to surrender, however he kept on firing on the joint forces. The fire was effectively retaliated, leading to an encounter. In the ensuing encounter, a local terrorist linked with proscribed terrorist outfit Al-Badr was killed and his body was retrieved from the site of encounter."

It added that he has been identified as Adil Majeed Lone son of Abdul Majeed Lone, a resident of Akbarabad, Hawoora, Kulgam.

"Incriminating materials, arms & ammunition including 01 Pistol with live ammunition and a grenade were recovered from the site of encounter. All the recovered material has been taken into case records for further investigation," the police statement said.

It reads that a case under relevant sections of law has been registered and further investigation is in progress.

9 Infiltrators Killed

and Army, security officials said

Both the joint operations are this year's major infiltration bids which were foiled in joint operations.

Kupwara district shares its border with neighbouring Pakistan. Over the last 2 to 3 years the hasn't seen any encounters. Peace has prevailed in the district with youth engaging in mainstream activities and taking up different opportunities for their own good.

Infiltration has always been a challenge in this district even during the 1990s. In recent years this district has seen narcotics as a major challenge given that it has been made as a gateway. A number of individuals were also detained for illegally acting as courier to transport drugs and narcotics. Desperate and hard attempts have been reported from time to time to push illicit things into the valley.

As per the details a total of 9 infiltrators were killed in two different joint operations of the Jammu and Kashmir police and Indian Army at the Line of Control (LoC) in Kupwara district in the ensuing month leading to the recovery of arms, ammunition, warlike stores and narcotics.

On June 16 this month five foreign militants were killed in a joint operation of Army and Police at Jumagand close to LoC. "The specific inputs were generated by Kupwara police about the likely infiltration and movement of the infiltrators," reveal the details.

From the killed infiltrators, the figures reveal that a huge quantity of arms, ammunition and other warlike stores was recovered. "Recoveries include 5AK-47 Rifles, 14 Hand Grenades, 500 AK rounds, Night Vision Goggles and other huge quantities of warlike stores," reveal the figures available.

The details available also reveal that on 23 June four foreign militants were killed in a joint operation close to the LoC in forward Machil sector.

"Four infiltrators were killed in a joint operation at Kala Jungle. They were killed while trying to infiltrate into this side. Huge quantity of arms and ammunition was recovered from them including the suspected narcotics as well," reveal the details.

The recoveries as per the figures include, 9-AK Rifles, 3 Pistol, 4, grenades, 288 AK & Pistol rounds. "Apart from these 55 suspected narcotics packets were also recovered from killed infiltrators."

On June 17 Jammu and Kashmir Director General of Police (DGP) Dilbagh Singh said that the continuous infiltration bids are being made along the LoC in the region to keep "terrorism alive." He also had said that this year major infiltration bids have been foiled but yes some terrorists have managed to enter into this side from Rajouri- poonch and Kupwara sectors.

Notably earlier on 03 May, two infiltrators were killed in a joint operation at Pichnad in Machil sector. As per the figures available a total of 2 AK 47 Rifles, 8 AK 47 Magazines with 159 rounds, 2 hand grenades, eatables and cigarettes with Pakistan markings were recovered from them. "Pakistan currency of rupees 660 was also recovered from the killed infiltrators in Machil sector."

Security forces in all the aforementioned operations stated that these infiltration attempts were aimed to disrupt peace in the valley. Also they and Kashmir police. Another trader from Srinagar said, "Sales on Eid-ul-Fitr were low but today, it is very low". We are very much worried, he said, adding, "Inflation and poverty due to Covid-19 lockdowns have badly hit J&K and the poor are hardly able to make ends meet."

Irfan Ahmad, a shopkeeper dealing with readymade garments, said he used to make lakhs of rupees in sales on festive occasions but this year, very few customers are visiting his shop. "One out of ten customers is able to afford an item," he said.

President of Kashmir Chamber of Commerce and Industry (KCCI), Javaid Ahmad Bhat says that business is slumping in Kashmir as well as in other parts of the country, including Delhi, due to the recession. He said that online shopping is also playing a part as the young generation prefers online shopping.

"Market is not good, and as per the ground situation, business is down by around 50 percent as compared to Eidul-Azha last vear." he said.

He said the horticulture sector was hit last year and its impact is coming to the fore. The handicrafts and industries are also suffering badly. According to the President Kashmir

Traders and Manufacturers Federation (KTMF) Mohammad Yaseen Khan business is down mainly because of inflation and markets are witnessing a He said that people owe money to fi-

nancial institutions as in the last fe business was almost on halt and people have to first clear the debt amount.

"There is no business on the ground that too on the festival. We won't say how much percent down is business but the fact is that there is no business on the ground," Khan said, adding, "Even the main markets that used to remain jam-packed on such occasions are deserted today.'

"We have found that there is a big gap in the punishment provision as the punishment of up to three years imprisonment or a punishment of life imprisonment with or without fine may be given.

"We found this gap to be very odd and, therefore, we have said that this punishment of up to three years with or without fine maybe increased to seven years with or without fine," he explained.

It will give discretion to the courts while imposing the punishment, he said, adding that if the courts find that the offence of sedition is proved and feel that the punishment of three years would be less, but the punishment of life in jail would be very severe, "it will have the discretion to give the punishment up to seven years with or with-

out fine". "In fact, if you see the punishments provided for various offences under IPC, you will not find any such big gap. The Law Commission had earlier too considered this issue and made its recommendations on the same terms in its previous two reports," he pointed

He said the panel considered that the special Acts such as the Unlawful Activities (Prevention) Act and the National Security Act operate in different fields and do not cover the offence of sedition, and the provisions of the law on sedition are necessary to be retained in the IPC.

"We have held that the law on sedition is a reasonable restriction under Article 19 (2) of the Constitution of India," he pointed out. Justice Awasthi felt that sedition

being a colonial legacy is "not a valid ground for its repeal". "The realities differ in every jurisdic-

tion. Even countries such as the United States, Canada, Australia, Germany, the Netherlands, Ireland, Spain, Norway and Malaysia have the law on sedition in their country in one form or the other." he said.

So far as the United Kingdom is concerned, the Law Commission of the UK had recommended the repeal of law on sedition in 1977.

"But the law on sedition was repealed only in 2009 only when the sufficient range of other provisions to deal with sedition-like offences were enacted and the threat of secessionist subversive activities from the Irish Republican Army (IRA) ceased to exist following the signing of the Good Friday Agreement in 1998.

"So, even the UK has sufficient safeguard to deal with the offences affecting the security and integrity of their State," he explained.

In order to provide clarity to section 124A, the panel has suggested to add words "with a tendency to incite violence or cause public disorder". It has been borrowed from the judgment of the Constitution bench of the Supreme Court in the case of Kedarnath Singh.

2023 ODI WC: India To Play Across 9 Cities, Face Pakistan On October 15

NEW DELHI: The Indian team led by Rohit Sharma will be the most travelled team among top contenders in the upcoming ODI World Cup, covering a distance of approximately 8400 km while crisscrossing nine cities for nine league games in 34 days.

In case India reaches semifinal and then the final, the distance covered would be close to 9700 km for 11 games in 42 days.

While 8400 kms in 34 days might not seem a lot, considering that Indian players will finish their games around 11 pm and will have a flight to catch every third day, it indeed becomes very tiresome after gruelling 100 over games.

When Indian team plays at home, it usually travels by char-

ter flights and not by commercial flights which reduces the duration and distance travelled considerably but business class is not available always. Little leg space will make it tough for fast bowlers. India is the only team that will play league games in each of the nine cities.

All other prominent teams play at least two games in one city. Hence once team lands in Chennai for the Australia game, the aerial distance traversed will be in this order: Chennai to Delhi (1761 km), Delhi to Ahmedabad (775 km), Ahmedabad to Pune (516 km), Pune to Dharamsala (1936 km), Dharamsala to Lucknow (748 km), Lucknow to Mumbai (1190 km), Mumbai to Kolkata (1652 km) and Kolkata to Bengaluru (1544 km). The cumulative distance travelled is 8361 km.

Institutional Racism & Sexism Infects English Cricket: Report

LONDON: Institutional racism, sexism and class-based discrimination continue to infect English cricket. an independent commission has

A long-awaited report into the state of the sport was published on Tuesday by the Independent Commission for Equity in Cricket, known as the ICEC. Among its findings, racism was "entrenched" in the English game, women were treated as "second-class citizens," and cricket was a rare option in state schools.

Then, if anybody wanted to complain about the problems, the ICEC says the system was confusing and not fit for purpose.

England and Wales Cricket Board chair Richard Thompson issued a public apology and described the report as a "wake up call."

"I apologize unreservedly to anyone who has ever been excluded from cricket or made to feel like they don't belong," Thompson said.

"Powerful conclusions within the report also highlight that for too long women and Black people were neglected. We are truly sorry

English cricket was rocked in

2020 when former Yorkshire player Azeem Rafiq said he was a victim of racial harassment and bullying through two spells at the nation's most successful club from 2008-18.
