

# Do's for the Yatris

- Every Yatri must collect his/her RFID Card from designated locations in J&K before embarking on the Yatra.
- It is mandatory for all Yatris to wear the RFID cards issued by SASB at all times during the Yatra.
- Yatris should wear comfortable clothes during the Yatra. Yatris are advised to wear trekking shoes.
- Yatris are advised to walk slowly while ascending and take time to acclimatize themselves.
- Yatris should drink adequate quantity of water to keep themselves hydrated.
- In case a Yatri is experiencing shortness of breath/ discomfort, he/ she must contact the nearest medical facility, and try to descend to lower altitude if possible.

# Don'ts for the Yatris

- Yatris must avoid exerting themselves beyond their capacities and take frequent breaks and rests en-route.
- No Yatri shall be allowed to enter the Yatra area without RFID card.
- Yatris must avoid polluting the environment by littering waste material along the trekking route and surroundings.
- Yatris are advised not to commence journey empty stomach.
- Yatris must avoid drinking alcohol, caffeinated drinks and smoking.
- Yatris should not attempt to take any short cuts en-route and watch out for "danger zone" signages where they must move cautiously.

# For India-Pak World Cup Game, Ahmedabad Hotel Prices As High As Rs 1 Lakh

hmedabad: Hotel room rates here have skyrocketed, nearly ten-fold in some cases, for October 15 after the International Cricket Council (ICC) on Tuesday announced the fixtures for the ODI World Cup, showing that India and Pakistan would face off in Ahmedabad on that day.

Rates on various hotel booking websites suggest that unprecedented demand may have led to the sharp surge in the room tariff for October 15, when the arch-rivals will be playing at the Narendra Modi stadium here.

Room rentals have gone up nearly 10 times, with some hotels charging close to 1 lakh, while many are already sold out for that day.

On normal days, room rent in luxury hotels hovers between 5,000 and 8,000 in the city. It has jumped to 40,000, and 1 lakh in some places, for October 15.

As per the hotel booking portal 'booking.com', the rent for one deluxe room for July 2 is 5,699 at Welcome Hotel by ITC Hotels in the city. But, the same hotel will charge 71,999 if one wants to stay for a day on October 15.

Renaissance Ahmedabad Hotel on SG Highway, which now charges nearly 8,000 for a day, is

showing the per-day room rent at 90,679 on the match day in October.

Similarly, Pride Plaza Hotel on SG Highway has upped its rental to 36,180 for that day. The Cama Hotel on Sabarmati Riverfront, an otherwise budget-friendly hotel that would charge little over 3,000 for the upcoming Sunday, has hiked its rental

Owing to the unprecedented demand, rooms are not available for October 15 at ITC Narmada, Courtyard by Marriott, Hyatt and Taj Skyline Ahmedabad, all five-star hotels in the city.

According to the office-bearers of the Hotels

According to the office-bearers of the Hotels and Restaurants Association (HRA) – Gujarat, the prices were hiked by hotels in accordance with the demand, mostly from Non-Resident Indians (NRIs) as well as upper-middle-class cricket fans living in other states.

When inquiries start pouring in for some particular dates, hotels would increase their tariff, said HRA-Gujarat spokesperson Abhijeet Deshmukh.

"If the hoteliers think that the demand is very high for a particular period, they will try to make some revenue because they are assured that rooms will be full despite higher rates. Once the demand drops, the room rentals will also come down," said Mr Deshmukh

he 94-room Belmond Hotel Cipriani has a storied history. It was opened in the 1950s by the inventor of the Bellini, with a bar that continues to be legendary to this day. It has an Olympic-sized outdoor swimming pool at the edge of the Canale di San Giorgio Maggiore, apparently the result of confusion between feet and meters during construction. And on Thursday it was named the best hotel in the world by a new list that gives properties a composite score based on information that's compiled from a wide array of sources.

compiled from a wide array of sources.

The list, called Top 1,000 World's Best Hotels, is by French company La Liste. Its rankings are not a result of a judging panel that conducts in-person visits, but rather a compilation of customer ratings on booking websites, published reviews from travel magazines, global and local media coverage, as well as other travel guides. It's a similar format and methodology as what the company uses to produce the namesake global restaurants list for which it's best known.

Helene Pietrini, managing director of La Liste, said she saw a gap in the market for a resource that pulls together various reviews into one place that travellers can scroll through to get their imagination going.

"People love to be inspired with hotels ranked from the best to not the worst, but all the great hotels in the world," she said in an interview. "They want to see a longer list of great places to go to, not always the most expensive." Sustainability and uniqueness are more important to some consumers than luxury, she added, which is in part why some specific hotels are pulled out and highlighted.

La Liste joins a crowded field of rankings and guides for travellers-though few have tackled hotels specifically. Other rankings, for instance, offer insight on the world's best destinations, restaurants, bars and airlines. Even Michelin began as a travel guide, scoring eateries for road trippers criss-crossing Europe. But La Liste will soon gain important competition: In September, 50 Best will release its own inaugural hotel ranking to complement its influential lists of the World's Best Restaurants and Bars. (Pietrini used to work at 50 Best.)

The publications usually make money through sponsorships with culinary or beverage brands, credit-card and travel-related companies. The Michelin Guide, 50 Best and others also take money from municipalities, states or publicly funded tourism agencies, who wish to promote and lend credibility to their local dining scenes.

# **Vehicles Running 100% On Ethanol To Be Launched In August: Gadkari**

New Delhi: Union Minister for Road Transport and Highways Nitin Gadkari on Thursday said that new vehicles running 100 per cent on ethanol will be launched in August.

In an interview with ANI Editor Smita Prakash, Mr Gadkari said, "From August, I will be launching vehicles running 100 per cent on Ethanol. Bajaj, TVS and Hero have manufactured motorcycles running 100 per cent on Ethanol."

He said that just like Toyota company's Camry car, which runs on 60 per cent petrol and 40 per cent on electricity, will now be bringing vehicles that run on 60 per cent ethanol and 40 per cent electricity.

"Like Toyota company's Camry car which runs on 60 per cent petrol and 40 per cent electricity, through Toyota we will also be launching vehicles which run on 60 per cent on ethanol and 40 per cent on electricity," he added.

Mr Gadkari said that this initiative will be a revolution in the country

in the country.

"This will be a revolutionary initiative because it will be import-substitute, cost-effective, pollution-free and indigenous. This is prepared by farmers because now ethanol is made from sugarcane juice," the Union Minister said.

Talking about development works in the country, Mr Gadkari asserted that he has always done work beyond politics and BJP has taught him to do justice to all.

"I make sure that everyone's work gets done when it's important. I have always done that even beyond politics. That is what the BJP has taught us: to do justice to all, and that is

what makes us strong. Politics and development should not be mixed up. I am a Karyakarta of the BJP, but the government belongs to the people of the country. That is why Prime Minister Modi said, Sabka Saath Sabka Viswas Sabka Prayas," Mr Gadkari said.

He said road development has been undertaken in all states beyond politics. Mr Gadkari said that Chief Ministers from South or other states where BJP doesn't have a state government also come to meet him to discuss developmental projects and he has undertaken most of them.

"The works are being undertaken in all states beyond politics. Mamata Ji from Bengal recently came to meet me, and we discussed some projects. Chief Ministers and other officials from southern states also come to meet me and I hold meetings with all of them, and discuss projects to be undertaken there. It doesn't make us look bad. It makes our government look strong," the Union Minister said.

He said, "Roads go through

all states. One state may be governed by Congress another by BJP. That doesn't mean I should shut down the road development works. Roads are for the people of India. And I'm not just a BJP minister but a minister of the Government of India. And being in service for the country's people is my primary duty and responsibility. I will work for those who voted us to power. I will also work for those who didn't give us the mandate and I will also do work for those who criticize us. Everyone's work should be done. This is Bharatiya Janata Party's culture and we

work based on that."

"I can assure you that in my 9 years in office, I have not mixed political thoughts with governance. The roads of our country are our assets and the people who travel on these roads are our family. Mr Gadkari also slammed the opposition for attacking Veer Savarkar and the syllabus revamp. The party which brought Emergency and kept many revolutionaries locked up in jail does not de-

serve to comment," he said.

Mr Gadkari also claimed that the BJP will be sweeping the upcoming legislative elections in states as well as the general elections in 2024.

Mr Gadkari is called the Highwayman of India due to the transformational change he has brought in the country's infrastructure and connectivity in the last nine years as minister of road transport and highways.

Mr Gadkari comes from the city of Nagpur where he started his political career as a Karyakarta of Akhil Bhartiya Vidyarthi Parishad.

Mr Gadkari is also credited for being the man behind the first ever expressway (Mumbai-Pune) by bringing new technologies into the country and helping private companies to ensure quality work in creating modern infrastructure.

Mr Gadkari is also a strong advocate of sustainable development and his eco-friendly initiatives in road construction have led to the use of garbage in road construction as a raw material.

Before taking charge as union minister, Mr Gadkari donned several hats in the organisation as well as governance and has served as BJP national president from 2009 to 2013 and PWD Minister from 1995-1999 in Maharashtra.

# **UN Drops India From Children Of Conflict Report Over 'Improvement' In J&K**

**United Nations:** UN Secretary-General Antonio Guterres has removed India from his annual report on the impact of armed conflict on children, citing measures taken by the Indian government to better protect them.

India was mentioned in the report of the Secretary-General on Children and armed conflict since 2010 along with other countries of Burkina Faso, Cameroon, Lake Chad basin, Nigeria, Pakistan, and the Philippines for alleged recruitment and use of boys by armed groups in Jammu and Kashmir; detainment of boys by Indian security forces in J&K for their alleged association with armed groups, or on national security grounds.

Guterres said in his report last year, he had welcomed the engagement of the Indian government with his special representative and noted that it might lead to the removal of India as a situation of concern.

In his 2023 report on Children and Armed Conflict, the UN chief said, "In view of the measures taken by the government to better protect children, India has been removed from the report in 2023."

Guterres highlighted the technical mission of the office of his special representative in July 2022 to identify areas of cooperation for child protection, and the workshop on strengthening child protection held in Jammu and Kashmir last November by the government, with the participation of the United Nations.

In his latest report, he also called upon India to implement the remaining measures identified in consultation with his special representative and the United Nations.

These include the training of armed and security forces on child protection, prohibition of the use of lethal and non-lethal force on children, including ending the use of pellet guns, ensuring that children are detained as a last resort and for the shortest appropriate period of time, Guterres said.

He also stressed the implementation of measures to prevent all forms of ill-treatment in detention and the full implementation of the Juvenile Justice (Care and Protection of Children) Act and the Protection of Children from Sexual Offences Act.

Briefing reporters on Tuesday, Special Representative of the Secretary-General for Children and Armed Conflict Virginia Gamba said that for the last two years, "we have been working very closely with India".



by the government to better protect children, India has been removed from the report in 2023."

"India decided to start a prevention engagement," she said, adding the country indicated that it was ready to start engagement to see if it could put in place measures that could be sustained through time and would allow for it to be removed from the report.

In last year's report, Guterres had said he was concerned by the "increased number of

violations against children verified in Jammu and Kashmir", and had called upon the Indian government to strengthen child protection.

The UN chief had welcomed the legal and administrative framework for the protection of children and improved access to child protection services in Chhattisgarh, Assam, Jharkhand, Odisha and Jammu and Kashmir, and progress in the creation of a Jammu and Kashmir Commission for Protection of Child Rights.

The Government of India had been consistently engaged in efforts to exclude the country's name from this ignoble list, the Ministry of Women and Child Development said in New Delhi.

It led to an agreement to appoint a national focal point to identify priority national interventions to enhance the protection of children, a joint technical mission to hold inter-ministerial, technical-level meetings with the UN to identify areas of enhanced cooperation for child protection, it said in a press release.

Under the guidance and leadership of Smriti Zubin Irani, Union Minister of Women And Child Development, a road map for cooperation and collaboration on child protection issues was developed by the Ministry.

New Delhi had expressed concerns that the 2022 report included situations that are "not situations of armed conflict" or threats to the maintenance of international peace and security.

In his annual report on children and armed conflict released here Tuesday, Guterres said that globally in 2022, children continued to be disproportionately affected by armed conflict, and the number of children verified as affected by grave violations increased compared with 2021.

The United Nations verified 27,180 grave violations, of which 24,300 were committed in 2022 and 2,880 were committed earlier but verified only in 2022.

Violations affected 18,890 children (13,469 boys, 4,638 girls, 783 sex unknown) in 24 situations and one regional monitoring arrangement, it said.

The highest numbers of violations were the killing (2,985) and maiming (5,655) of 8,631 children, followed by the recruitment and use of 7,622 children and the abduction of 3,985 children. Children were detained for actual or alleged association with armed groups (2,496), including those designated as terrorist groups by the United Nations, or for national security reasons, Guterres said in his report.

The United Nations verified the killing (253) and maiming (656) of 909 children (732 boys, 177 girls), attributed to unidentified perpetrators (694), Islamic State in Iraq and the Levant-Khorasan (ISIL-KP) (112), the Taliban (98) and cross-border shelling from Pakistan (five).

### Searing Heat Takes Toll On Hajj Pilgrims

**Riyadh:** Hundreds of pilgrims have suffered heat stroke since the start of the Hajj season the Saudi Ministry of Health reported on Thursday.

There were 1098 cases, the ministry said in a statement, adding it had witnessed an increase in the number of cases of people suffering from the effect of extreme heat.

The statement went on to warn pilgrims that they needed to take extra care by following the instructions issued.

This year Hajj season is taking place in the summer months which is witnessing a significant rise in temperatures.

The ministry advised people to use umbrellas, drink plenty of fluids, avoid physical exertion, and follow health guidelines to avoid heatstroke. It went on to add that its hospitals in Makkah were ready to provide all kinds of medical care to pilgrims.

## Complaint Filed Against Mehbooba Over 'Anti-Army' Tweet

Jammu: A social and political activist has lodged a complaint against PDP chief Mehbooba Mufti in Nawabad police station in Jammu for "spreading misinformation" and levelling "fake and irresponsible" allegations against Army.

Bodh Raj Sharma in his police complaint said that the People's Democratic Party (PDP) chief shared a message on her Twitter account which may be described as "provocative" and requested the police to lodge an FIR against her under relevant sections of the law.

Sharma in his complaint said that it was "irresponsible" on the part of Mehbooba Mufti to post a message against the army "without any proof," and that too just before the Amarnath Yatra.

He warned that if no action is taken against the PDP chief he will be forced to approach the court.

# Sweetener in Diet Coke A Possible Carcinogen

Aspartame Sweetener, Used In Diet Sodas And Chewing Gum, Likely To Be Named A Carcinogen By WHO's Cancer Research Agency

London: One of the world's most common artificial sweeteners is set to be declared a possible carcinogen next month by a leading global health body, according to two sources with knowledge of the process, pitting it against the food industry and regulators.

Aspartame, used in products from Coca-Cola diet sodas to Mars' Extra chewing gum and some Snapple drinks, will be listed in July as "possibly carcinogenic to humans" for the first time by the International Agency for Research on Cancer (IARC), the World Health Organization's (WHO) cancer research arm, the sources said.

The IARC ruling, finalised earlier this month after a meeting of the group's external experts, is intended to assess whether something is a potential hazard or not, based on all the published evidence.



It does not take into account how much of a product a person can safely consume. This advice for individuals comes from a separate WHO expert committee on food additives, known as JECFA (the Joint WHO and Food and Agriculture Organization's Expert Committee on Food Additives), alongside determinations from national

regulators. However, similar IARC rulings in the past for different substances have raised concerns among consumers about their use, led to lawsuits, and pressured manufacturers to recreate recipes and swap to alternatives. That has led to criticism that the IARC's assessments can be confusing to the public.

# First Batch Of Pilgrims To Leave From Jammu Today

**Jammu:** Amid stringent security cover, the first batch of Amarnath yatris will be flagged-off from here on Friday, heralding the 62-day pilgrimage to the cave shrine of Amarnath in South Kashmir.

The first batch of pilgrims in convoy of buses and cars carrying the pilgrims to the Kashmir valley for the Amarnath yatra will leave from base camp here early Friday morning.

early Friday morning.
So far, over 3 lakh devotees have already got themselves registered for the pilgrimage.
LG Sinha is reportedly to flag-off the first batch of pilgrims tomorrow.

The 62-day-long pilgrimage will commence on July 1 from the twin tracks the traditional 48-km Nunwan-Pahalgam route in Anantnag district and the 14-km shorter but steep Baltal route in Ganderbal district.

Over 1,500 pilgrims, including sadhus, have arrived in Jammu city for the yatra to the 3,880-metre shrine starting on July 1.

# Muslim Leaders Say Qur'an Burning In Sweden Fuels Extremism

DUBAI: Muslims around the world have joined Saudi Arabia in condemning the burning of a copy of the Qur'an by an Iraqi national outside Stockholm's largest mosque on Wednesday.

Under a heavy police presence, Salwan Momika, a 37-year-old who fled to Sweden several years ago, on Wednesday stomped on the Qur'an before setting several pages alight in front of the mosque in the Sweedish capital.

Police had granted him a permit for the protest in line with free-speech protections, but said later it had opened an investigation into the Qur'an burning which sparked anger across the Muslim world.

It is not the first time such an act has happened in Sweeden.

In January, a Swedish-Danish right-wing extremist burned a copy of the Qur'an near the Turkish embassy in Stockholm, also triggering outrage in the Muslim world.

Swedish Prime Minister Ulf Kristersson said Momika's protest was "legal but not appropriate," and it was up to the police to permit it or not.

The incident occurred as Muslims around the world marked the Eid al-Adha holiday.

The Iraqi government in a statement issued late Wednesday strongly condemned "the repeated acts of burning copies of the holy Qur'an by individuals with extremist and disturbed minds."

"These acts demonstrate a hateful and aggressive spirit that goes against the principles of freedom of expression," it said. "They are not only racist but also promote violence and hatred." "These irresponsible actions, in direct conflict with the values of respect for diversity and the beliefs of others, are unequivocally condemned."

The United Arab Emirates summoned the Swedish ambassador on Thursday to protest against the burning of the holy book, the UAE foreign ministry said in a statement.

Jordan summoned Sweden's ambassador in Amman on Thursday, said it considered the act as an "incitement and racism."

The Foreign Ministry said burning the Holy Qur'an was an act of "dangerous hate and a manifestation of Islamophobia" that incites violence.

The Ministry's statement said burning the Quran "cannot" be considered a form of freedom of expression, adding there is a "need to stop irresponsible behavior and actions."

The Ministry said hate speech and action must be countered and there must be promotion for a culture of peace and acceptance.

And Kuwait's Ministry of Foreign Affairs said the burning of the Quran offended Muslims around the globe, adding that people needed to promote the values of tolerance and coexistence. "This serious provocative move offends Muslims around the world," the ministry said in a statement.

"The state of Kuwait reminds the international community and all countries concerned of their responsibility for acting against hate and religious extremism, and stopping the hostile acts that target the Muslim's sanctities."

Sharia is an Islamic religious law based on the teachings of the Quran and the traditional sayings of Muhammad.

In an editorial in its mouthpiece 'Saamana', the Uddhav Thackeray-led party said Prime Minister Narendra Modi should first respect uniform law by disqualifying 40 MLAs including Maharashtra Chief Minister Eknath Shinde, whose Urban Development department has taken action against 18 ex-corporators from the Bhiwandi Nizampur City Municipal Corporation (BNCMC).

Earlier this week, 18 former Congress corporators of BNCMC were disqualified from contesting any elections for the next six years for voting against their party's official mayoral candidate in 2019 and defying party whip.

"Only opposing the Sharia law of Muslims is not the basis for Uniform Civil Code. Having equality in law and justice is also Uniform Civil Code," the editorial said.

What law is it if "corrupt people, ministers, businessmen of the ruling party" are protected and leaders from opposition parties are implicated under anti-corruption statutes, it asked.

The Shiv Sena (UBT) also questioned the Comptroller and Auditor General (CAG) inquiry initiated by the Centre into alleged irregularities in the reconstruction expenses of Delhi Chief Minister Arvind Kejriwal's official residence.



# **'Internet Shutdowns Cost Indian Economy \$1.9 Billion So Far In 2023'**

umbai: Internet shutdowns by law enforcement agencies like the one in Manipur and Punjab cost USD 1.9 billion to the Indian economy in the first half of 2023, a report said on Thursday.

The shutdowns also led to a loss of nearly USD 118 million in foreign investment and triggered over 21,000 job losses, the global non-profit Internet Society said in its report 'Netloss', according to Press Trust of India.

The non-profit arrived at the financial impact of the shutdown going beyond the loss of output and included factors like change in the unemployment rate, Foreign Direct Investment (FDI) lost, risks of future shutdowns, population in the working age etc.

"Governments often mistakenly believe that internet shutdowns will quell unrest, stop the spread of misinformation, or reduce harm from cybersecurity threats. But shutdowns are extremely disruptive to economic activity," the report said.

India's regular use of shutdowns as a tool to maintain public order gives India a shutdown risk of 16 per cent so far this year, one of the highest in the world as of 2023, it said.

Shutdowns halt e-com-

financial and reputational risks for companies, it said.

The non-profit started in 1992 made it clear that it is opposed to shutdowns and urged governments to refrain from implementing them due to the damage they inflict on a nation's economy, civil society, and internet infrastructure.

"The global rise in internet shutdowns shows that governments continue to ignore the negative consequences of undermining the

# US Supreme Court Bans Use Of Race, Ethnicity In University Admissions

Washington: The US Supreme Court on Thursday banned the use of race and ethnicity in university admissions, dealing a major blow to a decades-old practice that boosted educational opportunities for African-Americans and other minorities.

One year after overturning the guarantee of a woman's right to have an abortion, the court's conservative majority again demonstrated its readiness to scrap liberal policies set in law since the 1960s.

The justices broke six to three along conservativeliberal lines in the decision, which came after years of ring-wing antipathy to "affirmative action" programs that have sought diversity in school admissions and business and government hiring.

Chief Justice John Roberts wrote in the majority opinion that while affirma-



tive action was "well-intentioned and implemented in good faith," it cannot last forever, and amounted to unconstitutional discrimination against others.

"The student must be treated based on his or her experiences as an individual - not on the basis of race," Roberts wrote.

The court said that universities were free to consider an applicant's background -- whether, for example, they grew up experiencing racism -- in weighing their application over more academically qualified students.

But deciding primarily

based on whether the applicant is white, Black or other is itself racial discrimination, Roberts wrote.

"Our constitutional history does not tolerate that choice," he said.

In a scathing reputtal

Justice Sonia Sotomayor accused the majority of being colorblind to the reality of "an endemically segregated society."

"Ignoring race will not equalize a society that is racially unequal. What was true in the 1860s, and again in 1954, is true today: Equality requires acknowledgment of inequality," she wrote.

- Elite universities - The court sided with an activist group, Students for Fair Admissions, that sued the oldest private and public institutions of higher education in the country - elite Harvard University and the University of North Carolina (UNC) - over their admissions policies.

# New Law In France Requires Parental Consent For Social Media Platforms

Paris: France approved a new law Thursday requiring social media platforms like TikTok to verify users' ages and obtain parental consent for those under 15 years in an effort to protect children online.

The legislation is part of a string of recent moves by the government to reduce children's screen time and protect them from cyberbullying and other crimes.

The "landmark" law would be "applied as soon as possible", Digital Transition Minister Jean-Noel Barrot told lawmakers.

But the exact date the age verification bill will come into force remains unclear following Thursday's Senate approval, as no specific date was set and the European Commission has yet to check it that it conforms with EU law.

Sites will then have a year to comply with the policy for new subscribers, and another two years to apply the requirements to existing users.

Lawmakers' concerns ranged from pornography to cyberstalking, unattainable beauty standards and the attention-grabbing addictive nature of the platforms, which pose a particular risk for youth.

Existing regulations mainly focused on collection of personal data have failed to have an impact on children's access to social media. Sites are in theory closed to those under the age of 13 in France.

But with some users signing up from just eight years of

age, according to the French National Commission for Technology and Freedoms (CNIL), more than half of children aged 10-14 use social media sites like Snapchat and Instagram.

The new law will explicitly require sites to obtain approval of a user's parent or guardian if they are under 15, using technical solutions that comply with guidelines set out by the French Arcom regulator.

Social media firms who breach the law will face a fine of up to 1 percent of their global revenues.

The law will also allow parents to request suspension



of accounts belonging to their children under 15, and will require sites to offer tools to limit the time children spend on the platform.

It will not be enough to put an end to concerns of children's safety online, admitted the lawmaker who spearheaded the act, Laurent Marcangeli, on Wednesday.

He further called for "advancements in age verification technology online and heavily investing into digital education for parents, children and teachers."

# '72 Hoorain' Trailer Hasn't Been Denied Certification, Says Censor Board

Mumbai: The Central Board of Film Certification (CBFC) today dismissed reports that tar Hoorain (72 Hoorain)' has been refused certification by Central Board of Film Certification. Contrary to the reports, CBFC states that the



the trailer of '72 Hoorain' was denied certification, saying the matter is "under due process".

On Tuesday, the film's co-producer, Ashoke Pandit, claimed the censor board refused to give a certificate to the trailer of the movie, set to be released on July 7.

"Misleading reports are being circulated in certain sections of media that a film and its trailer titled 'Bahatfilm 'Bahattar Hoorain (72 Hoorain)' was granted 'A' certification and the certificate was issued on 4-10-2019," the board said in a press note.

Starring Pavan Malhotra and Aamir Bashir in the lead, the Sanjay Puran Singh Chauhan directorial focuses on the consequences of violent extremism. The filmmaker won the National Film Award for best direction for the film in 2021.

# 'NatGeo magazine lays off last 19 staff writers'

ew Delhi: Finding it hard to sustain in the digital era, the 135-year old Walt Disneyowned National Geographic magazine has laid off the last 19 staff writers, the media reported.

The staffers were notified in April of their terminations. The layoffs are the second over the past nine months, and the fourth since a series of ownership changes began in 2015, the Washington Post reported. As part of the cost-cutting measures, the company had removed six top editors in September last year.

The latest cuts also eliminated the magazine's small audio department, the report said.



"My new National Geographic just arrived, which includes my latest feature — my 16th, and my last as a senior writer," Craig Welch, senior writer at NatGeo, wrote on Twitter. "NatGeo is laying off all of its staff writers. I've been so lucky. I got to work w/incredible journalists and tell important, global stories. It's been an honour," he added.

The company said its fu-

ture editorial work will be done by freelance writers and the few editors remaining on staff, the Post reported.

The famous bright-yellow-bordered print publication, which had more than 1.7 million subscribers at the end of 2022, will continue to publish monthly issues, a magazine spokesperson told CNN in a statement.

"Staffing changes will not

change our ability to do this work, but rather give us more flexibility to tell different stories and meet our audiences where they are across our many platforms," the spokesperson said. "Any insinuation that the recent changes will negatively impact the magazine, or the quality of our storytelling, is simply incorrect."

# "Godfather Of AI" Asks Governments To Stop Takeover Of Society By Machines

oronto: Geoffrey Hinton, one of the so-called godfathers of artificial intelligence, urged governments on Wednesday to step in and make sure that machines do not take control of society.

Hinton made headlines in May when he announced that he quit Google after a decade of work to speak more freely on the dangers of AI, shortly after the release of ChatGPT captured the imagination of the world.

The highly respected AI scientist, who is based at the University of Toronto, was speaking to a packed audience at the Collision tech conference in the Canadian city.

The conference brought



together more than 30,000 startup founders, investors and tech workers, most looking to learn how to ride the AI wave and not hear a lesson on its dangers.

"Before AI is smarter than us, I think the people developing it should be encouraged to put a lot of work into understanding how it might try and take control away," Hinton said. "Right now there are 99

very smart people trying to make AI better and one very smart person trying to figure out how to stop it taking over and maybe you want to be more balanced," he said.

Hinton warned that the risks of AI should be taken seriously despite his critics who believe he is overplaying the risks.

"I think it's important that people understand that this is not science fiction, this is not just fear mongering," he insisted. "It is a real risk that we must think about, and we need to figure out in advance how to deal with it."

# **Char Chinari: The Jewel Crowns of Dal Lake**

It used to be a haunt of tourists for its serenity and aesthetics owing to four gigantic chinars which stood on the four corners of the small island amid the vastness of the pristine lake

arooq Ahmad, a resident of downtown Srinagar is fond of old Bollywood songs with legendary Bollywood stars like Shammi Kapoor, Asha Parik, Shashi Kapoor, Rajindra Kumar, Rishi Kapoor, Dimple Kapadia, Rajesh Khanna and Amitabh Bachan.

For Farooq, the main aim of watching old songs is to see the past beauty of Kashmir valley especially locations like the Dal Lake, Char Chinari, Gulmarg and Pahalgam.

However, the main attraction of the Bollywood stars in 1970s, 80s and 90s was the Dal Lake and quite a few Hindi film songs were recorded at the two Char Chinaris (small lake islands) located on two different sides of Dal Lake.

Dal is a lake in Srinagar (Dal Lake is a misnomer as Dal in Kashmiri means lake), the summer capital of Jammu and Kashmir. The urban lake is integral to tourism and recreation in Kashmir. It is called the "Jewel in the crown of Kashmir" or "Srinagar's Jewel" for this reason. The lake is also an important source for commercial operations in fishing and water plant harvesting

fishing and water plant harvesting. The shore line of the lake is about 15.5 kilometers (9.6 mi), and is encompassed by a boulevard lined with Mughal era gardens, parks, houseboats and hotels. Scenic views of the lake can be witnessed from the shore line Mughal gardens, such as Shalimar Bagh and Nishat Bagh built during the reign of Mughal Emperor Jahangir and from houseboats cruising along the lake in the colourful shikaras. During the winter season, the temperature sometimes reaches 11 °C (12 °F), freezing the lake and migratory birds float in the lake making it a magnificent scene. The Dal Lake offers splendid colours and moods with every change in the weather that mesmerises the visitors and offers the ultimate shot to a photographer.

The lake covers an area of 18 square kilometres (6.9 sq mi) and is part of a natural wetland which covers 21.1 square kilometres (8.1 sq mi), including its floating gardens. The floating gardens, known as "Raad" in Kashmiri, blossom with lotus flowers during July and August. The wetland is divided by causeways into four basins; Gagribal, Lokut Dal, Bod Dal and Nagin (although Nagin is also considered as an independent lake). Lokut-dal and Boddal each have an island in the centre.



known as Rup Lank (or Char Chinari) and Sona Lank respectively.

Murad Baksh, brother of the Mughal emperor Aurangzeb, constructed the Rupa Lank. The second Chinar Island, known as Sona Lanka (Gold Island), is located on the Lokut Dal, and overlooks the holy shrine of Hazratbal.

Sona Lank "golden isle", at the south end in the third portion of the lake was raised by Sultan Zain-ul-Abidin in 1421 AD for the shelter of the boatmen in Bod Dal (Big Dal). He built a three-storeyed house on the island which was destroyed by an earthquake.

Emperor Jahangir also built a cottage there, which also vanished. It was rebuilt by Afghan governor Amir Khan Jawansher (1770-76). Nehru Park is an island just a few yards away from the roadside near Shankar Acharya hill.

The famous Dal Lake of Srinagar city includes three islands, two of which are marked with beautiful Chinar trees located at Bod Dal and Lokut Dal and known as Rupa Lank (Silver Island) and Sona Lanka (Gold Island) respectively. These are marked with the presence of majestic Chinar trees at all four corners, thus giving it the name Char-Chinari (Four Chinars).

The garden in between the four chinars used to be the favourite place for visitors during peak summers to get some time away from the noise of the city. All

the visiting tourists and locals would enjoy their trips through Shikaras to reach both islands of Dal Lake.

The Char Chinar Island gardens came into limelight in 1970 with the movie song of Achha To Hum Chalte Hain of Aan Milo Sajna movie of 1970 filmed on Rajesh Khanna and Asha Parekh. It used to be a haunt of tourists for its serenity and aesthetics owing to four gigantic chinars which stood on the four corners of the small island amid the vastness of the pristine lake.

Chinar trees can be found almost in every corner of valley, hills, planes, cities, villages and parks. Due to these reasons, they are widely preferred in gardens. They have many medicinal properties.

Chinar trees characteristically grow in the Eastern Himalayas. They have been an important part of Kashmiri tradition, in that, a Chinar tree is found in almost every village in Kashmir. These trees have survived for ages because Chinar is basically a long-living tree. The tree has several properties—leaves and bark are used as medicine, the wood, known as lace wood, has been used for delicate furniture and the twigs and roots are used for making dyes.

Chinar Leaf is a symbol of Kashmir which is green in summer season and in Autumn the color changes to blood red, amber, and yellow.

Over the years the size of the lake has shrunk to a large extent. Due to environmental changes and population growth. Protection measures to save the Dal lake from further hazards have been the prime concern of the authorities and people connected with the tourism industry in particular.

Earlier, the 2014 floods left two mighty chinars damaged, denting its iconic view from the boulevard around the lake.

On the directions of Lt. governor of Jammu and Kashmir, the J&K Forest Department formulated a strategy in October 2021 in consultation with technical experts of Floriculture Department, LCMA and Scientists of SKUAST and JKFRI for the restoration of 'Ropa Lank'.

The unique operation was executed on February 19, 2022 and completed on the unique date 22-02-2022 when the two Chinars were finally planted, braving rain and snow on the day.

In February, 2022, Jammu and Kashmir Forest Department successfully completed transplantation operation of two tall Chinars at the Char Chinar in Dal Lake to restore its erstwhile glory and it was marked as a big achievement; a first-of-its-kind achievement in the country.

# Drama in Manipur: Rahul Gandhi visits Churachandpur camps by chopper as police halt convoy midway

Imphal: Ethnic strife-torn Manipur witnessed high drama on Thursday over the visit of Congress leader Rahul Gandhi to relief camps in Churachandpur after his convoy was stopped by the police midway and he had to take a helicopter to reach his destination. Gandhi who interacted with those sheltering in relief camps in Churachandpur, 63 kms from Manipur's capital Imphal, said "Manipur needs healing. Peace has to be our only priority." The blocking of his convoy triggered a political slugfest as the Congress alleged that the BJP-led government is trying to thwart the leader's visit, while the saffron party accused him of being "stubborn" and choosing to take the road trip even though he was advised to take a chopper as his trip was opposed by vari-

ous quarters.

"People of all communities are very welcoming and loving. It's very unfortunate that the government is stopping me," Gandhi tweeted.

"I came to listen to all my brothers and sisters of Manipur. Manipur needs healing. Peace has to be our only priority," he said in the Twitter post. During his visit to Churachandpur, he interacted with the inmates in relief camps set up at a school and a college there, where around 200 people are camped. The Congress leader, who had earlier flown into Imphal in the morning was stopped by the local police at Bishnupur, around 20 kilometres from Imphal, citing demonstrations on the way.

"There is a security threat. We cannot take the risk of allowing Rahul Gandhi to proceed," a senior police official said

nior police official said.

A large number of people, mostly women, gathered near the spot and demonstrated both for and against the visit.

Gandhi's supporters demanded that he be allowed to go to Churachandpur, referring to the visit of Union Home Minister Amit Shah there late last month.

One of the demonstrating women said, "If Amit Shah could go to Churachandpur, why not Rahul Gandhi?" The police used tear gas shells to disperse the mob.

After remaining stuck for a few hours in Bishnupur, Gandhi returned to Imphal airport and took a helicopter to go to Churachandpur, one of the worst affected towns in the ethnic rioting which broke out in the state nearly two months back.

limits. For example, an adult weighing 60 kg (132 pounds) would have to drink between 12 and 36 cans of diet soda – depending on the amount of aspartame in the beverage – every day to be at risk. Its view has been widely shared by national regulators, including in the United States and Europe.

An IARC spokesperson said both the IARC and JECFA committees' findings were confidential until July, but added they were "complementary", with IARC's conclusion representing "the first fundamental step to understand carcinogenicity". The additives committee "conducts risk assessment, which determines the probability of a specific type of harm (e.g., cancer) to occur under certain conditions and levels of exposure." However, industry and regulators fear that holding both processes at around the same time could be confusing, according to letters from US and Japanese regulators seen by Reuters.

"We kindly ask both bodies to coordinate their efforts in reviewing aspartame to avoid any confusion or concerns among the public," Nozomi Tomita, an official from Japan's Ministry of Health, Labour and Welfare, wrote in a letter dated March 27 to WHO's deputy director general, Zsuzsanna Jakab.

The letter also called for the conclusions of both bodies to be released on the same day, as is now happening. The Japanese mission in Geneva, where the WHO is based, did not respond to a request for comment.

The IARC's rulings can have a huge impact. In 2015, its committee concluded that glyphosate is "probably

carcinogenic".

Years later, even as other bodies like the European Food Safety Authority (EFSA) contested this, companies were still feeling the effects of the decision. Germany's Bayer in 2021 lost its third appeal against US court verdicts that awarded damages to customers blaming their cancers on use of its glyphosate-based weedkillers.

The IARC's decisions have also faced criticism for sparking needless alarm over hard to avoid substances or situations. It has previously put working overnight and consuming red meat into its "probably cancer-causing" class, and using mobile phones as "possibly cancercausing", similar to aspartame.

"IARC is not a food safety body and their review of aspartame is not scientifically comprehensive and is based heavily on widely discredited research," Frances Hunt-Wood, the secretary general of the International Sweeteners Association (ISA), said. The body, whose members include Mars Wrigley, a Coca-Cola unit and Cargill, said it had "serious concerns with the IARC review, which may mislead consumers".

The International Council of Beverages Associations' executive director Kate Loatman said public health authorities should be "deeply concerned" by the "leaked opinion", and also warned it "could needlessly mislead consumers into consuming more sugar rather than choosing safe no-and low-sugar options." Aspartame has been extensively studied for years. Last year, an observational study in France among 100,000 adults showed that people who consumed larger amounts of artificial sweeteners

- including aspartame - had a slightly higher cancer risk.

It followed a study from the Ramazzini Institute in Italy in the early 2000s, which reported that some cancers in mice and rats were linked to aspartame.

However, the first study could not prove that aspartame caused the increased cancer risk, and questions have been raised about the methodology of the second study, including by EFSA, which assessed it.

Aspartame is authorised for use globally by regulators who have reviewed all the available evidence, and major food and beverage makers have for decades defended their use of the ingredient. The IARC said it had assessed 1,300 studies in its June review.

Recent recipe tweaks by soft drinks giant Pepsico demonstrate the struggle the industry has when it comes to balancing taste preferences with health concerns. Pepsico removed aspartame from sodas in 2015, bringing it back a year later, only to remove it again in 2020.

Listing aspartame as a possible carcinogen is intended to motivate more research, said the sources close to the IARC, which will help agencies, consumers and manufacturers draw firmer conclusions.

But it will also likely ignite debate once again over the IARC's role, as well as the

safety of sweeteners more generally.
Last month, the WHO published guidelines advising consumers not to use nonsugar sweeteners for weight control. The
guidelines caused a furore in the food
industry, which argues they can be helpful for consumers wanting to reduce the
amount of sugar in their diet.

# **Prices Of Tomato, Ginger** Soar In Jammu Amid Heavy Rainfall, Landslides

**JAMMU:** Poor crop yield due to heavy rainfall and landslides over the past few days here has hiked the prices of vegetables such as ginger and tomato, with consumers demanding government intervention to address the issue.

The recent price surge due to a demand-supply gap has posed significant challenges for low-income individu- als who

struggle to afford essential commodities. With toma-

toes priced at

around Rs 120 per kg and ginger at Rs 400 per kg, people are being compelled these items, Bharat

Bhushan, a customer, said. Bhushan emphasised the urgent need for government intervention to alleviate the burden of price hikes on poor families.

Local vegetable vendors have attributed the low crop yield of ginger and tomatoes to the heavy rainfall owing to the ongoing monsoon.
"We have witnessed a price

hike in ginger and tomatoes as the heavy rainfall has adversely affected crop production. Every monsoon, there is a price hike in vegetables, especially mountaingrown vegetables because of landslides and increased transportation time", Chamail Singh, a vegetable vendor told PTI.

Singh said it is anticipated that vegetable prices may rise more if there is no improvement in the inclement weather.

Balbir Bakshi, a vegetable vendor, said that over the past 3-4 days, tomatoes have been priced exorbitantly high, ranging from Rs 80 to Rs 120 per kg.

The limited supply caused by the rainfall has increased the prices right at the source -- the farms, Bakshi added.

Official data points towards an average price trend of Rs 30 to 35 for per kg of tomato and

Rs 120 to 150 for per kg ginger. As retail prices of the kitchen staple shot up to Rs 100 per kg in major cities of the country on Tuesday, a top government official said the spurt in prices of tomatoes is a temporary seasonal phenomenon, and

rates will cool down soon. Most parts of Jammu and Kashmir received heavy rains on Monday, triggering landslides at multiple locations that blocked the key Jammu-Srinagar National Highway and other roads, officials said.
