# 'PRASAD, PONY AND PALKIS' How Kashmiri Muslims Put Hands & Hearts In Annual Amarnath Yatra

Baltal: The annual Amarnath Yatra to the holy cave shrine in the south Kashmir Himalayas has been a shining example of Hindu-Muslim bonhomie as the local population has not only welcomed, but assisted the hundreds and thousands of Shiva devotees in their arduous journey of faith.

The support of the local Muslims has been instrumental for a smooth conduct of the



pilgrimage year after year, irrespective of the political atmosphere or security scenario in the rest of Jammu and Kashmir.

The Muslims put up tents for the yatris to stay, provide palanquins and pony services for those devotees who cannot undertake the difficult trek to the 3,888-metre-high cave shrine housing a naturally formed ice-lingam -- the edifice of Lord Shiva. And they are also the first responders in case of any emergency.

The services have more to do with keeping the traditional communal harmony alive than the economic aspects.

"The necessary arrangements and other things that we need are taken care of by our Muslim brothers. From cleanliness to the 'prasad', pony, pal-kis -- all the help is rendered by local Muslims. This brotherhood is an example for the world. I have not witnessed a better example of brotherhood than this anywhere else and

I travel across India," Sadhu Nagaraj, here for the yatra, said. A local who works as a caretaker for the belongings of the pilgrims said they provide their services for free because of the age-old brotherhood.

"We come here for the yatris. We keep their bags, cameras, mobile phones here and take care of those for free. This is our brotherhood. We are keeping Kashmiriyat alive," he said. Expressing satisfaction over the support of More on P6

**SC's Hearing On Art-370 Likely In August**

New Delhi: The Supreme Court on Wednesday indicated that it is likely to start hearing petitions challenging the abrogation of Article 370 and bifurcation of the erstwhile state of Jammu and Kashmir into two Union territories in August.

The top court, however, did not mention the date of hearing, though as per the cause list, the cases were listed for July 11.

Justice BR Gavai was hearing the plea filed by activist Teesta Setalvad when senior advocate Kapil Sibal suggested that the hearing in her petition may be scheduled in August. Justice Gavai then said that in August, the apex court will hear pleas relating to Article 370.

"It will be too late because we will begin hearing the challenge against Article 370," Justice Gavai said.

To this, Sibal said the hearing in the Article 370 case was supposed to begin on July 11.

"That (July 11) is only for directions. Tentatively, we will be starting in August," Justice Gavai told Sibal.

As per the cause list, the matters are listed "for directions" on July 11. It means on July 11, the five-judge Constitution bench will pass direction on the completion of the procedural formalities, such as the filing of the documents and submissions, setting out the order of arguments and allocation of time. 
# Mental Ailments, Drug Addiction In J&K Up Post-Covid: LG

Jammu and Srinagar: Kashmir's Lieutenant Governor Manoj Sinha Wednesday said post Coronavirus pandemic in the Union Territory; the mental ailment and drug addiction related cases have shown a spurt. He, however, extended allout support to the Health and Medical Education (H&ME) department and Institute of Mental Health and Neurosciences (IMHANS) for addressing both the issues effectively.

Addressing the Health Conclave at SKICC here on Health Wednesday, the LG said that in the past three to four years, health care has changed a lot right from primary to district level.

"Patient care has improved and massive health care related infrastructure has been set up across the UT," he said. 'New technological tools have been introduced that saves time and helps the doctors ensure best possible treatment



to the patients." The LG said that as per the study done by the IMHANS Srinagar, post Covid-19 pandemic, mental ailments that include common mental disorders, severe mental disorders and drug addiction among youth has shown a surge. "The UT administration

extends its full support to the H&ME, IMHANS and doctors to pull out the youth from anxiety and the vicious cycle of drug abuse," he said.

## 4 Killed As **Vehicle Falls Into Rajouri Gorge** Press Trust of India

Jammu: Four people died and eight sustained critical injuries when their vehicle skidded off a road and rolled down a deep gorge in Rajouri district in the early hours of Wednesday, officials said.

The accident took place in the Thanamandi subdivision when the car was on its way to Bhangai village from Poonch, where the victims had gone to attend a funeral, they said.

The officials said the driver of the vehicle lost control over it on the Thanamandi Bhangai road, hardly a few hundred metres from its destination.

"Twelve passengers in total were travelling in the vehicle at the time of the accident. All were rescued by locals and police and taken to the sub-district hospital in Thanamandi where four of them were declared brought dead," a police official said.

The deceased were identified as Shamim Akhtar (55), Rubina Kouser (35), Zarina Begum and Mohammad Younis (38), all residents of Bhangai.

# If Companies Want To Stop Quiet Quitting They Need To Take Burnout Seriously



### The Conversation

n 2023, between a quarter and a third of Canadians are feeling burned out. Burnout has not declined compared to last year. A full 36 per cent of employees are more burned out now than last year.

If you aren't burned out, it may well be because you did some quiet quitting to keep work at bay. Most workplaces haven't changed their workload or how work is done, although there are a growing number of exceptions. My research focuses on organizational governance. I study organizations and employees' experiences of their workplaces. Last summer, I wrote about how employee burnout remained high in Canada and discussed how it could be addressed. I cautioned that often, workplaces hold employees responsible for managing burnout. However, addressing the root causes of burnout requires workplaces to examine the workload and expectations they place on employees. How can workplaces change their approach to burnout? Are they now more concerned with handling the root causes of burnout? Burnout and quiet quitting According to the Canadian Centre for Occupational Health and Safety, burnout includes a variety of symptoms from being emotionally depleted to detachment and cynicism to a sense of low personal accomplishment and depersonalization — the feeling that work does not belong to oneself. The fact that burnout hasn't decreased suggests that organizations have not addressed its root causes. Instead, employees have taken matters into their own hands and done some quiet quitting. Quiet quitting refers to doing what our job requires and nothing more. Gone are the days of overwork and constant availability. According to a 2023 Gallup report, most employees around the world are quiet quitting. Because employees who quiet quit may set better boundaries around their work, quiet quitting enables them to prevent burnout. The fact that many employees have resorted to quiet quitting suggests



left a job due to burnout. One in four businesses in Canada have had challenges with employee retention.

### How workplaces can address burnout

Employers need to revisit the workload they place on their employees. They should consider how realistic it is for employees to complete their work within the required time frame.

They also need to address their culture and question how it can be toxic,

workplaces are not addressing or taking burnout seriously enough.

As a result, work remains the primary source of stress for Canadians. We have too much work, work in organizational cultures that are too toxic and don't feel supported enough.

Not surprisingly then, a recent survey found one third of Canadians have

and how toxicity can be addressed.

Finally, organizational leaders need to listen to their employees and set a tone that is supportive, shows empathy and is not merely rhetoric. Words have to be followed by actions to ensure the work environment fits the needs of employees.

Paying employees more isn't sufficient. Having a good work-life balance is often more important than higher salaries.

There are signs that some workplaces are serious about addressing the root causes of burnout. They are concerned with reducing workload. For instance, they can offer prolonged, or even unlimited, paid leave. They can provide more days off to allow employees to recharge.

A growing number of businesses are also embracing four-day work weeks as a way of boosting employee morale. Other workplaces give their employees the flexibility to work onsite and remotely.

Flexibility is essential for employees who also shoulder care work. Care work in many households is still done by women more than men. Women with young children take time away from their paid work for family responsibilities and miss more than twice as many days at work than men, leaving many mothers drained.

More than one third of working mothers in Canada say it is difficult for them to arrange child care. Mothers are about 20 per cent more likely than fathers to consider leaving their job because they struggle to find child care.

Employees need accommodating and flexible workplaces that understand their needs. Workplaces need to be mindful of that flexibility and should not view employees who seek it as less reliable than those who can work in offices for longer hours.

# **Ease Restrictions For Visitors During Yatra: TASK Urges Admin**

Srinagar: Travel Agents Society of Kashmir (TASK) has urged the government to either declare Kashmir a 'no go zone' for tourists during the Yatra period or stop harassment and problems being faced by the tourists in view of the security arrangements for the ongoing Amarnath Yatra.

In a statement issued by Waseem Gosani - Secretary General TASK said that not everyone coming from outside Kashmir is a yatri. There are tourists who visit Kashmir to enjoy its scenic beauty and face immense problems, much to the disappointment of the travel agents.

Muhammad Akram Siah, president TASK said that tourists who visit Kashmir give vent to their frustration and blame local travel agents. "These tourists feel they are not in Kashmir but in a fortified forest. This is not a positive sign for ledger tourism

outside Jammu Kashmir have stopped promoting Kashmir till mid-August bringing down the tourist

influx abruptly." Siah said. 'Tourists visiting Sonamarg have been directed to leave the destination before 2 pm. The same is the case with Pahalgam. How can it be satisfactory for a tourist visiting Sonmarg or Pahalgam or Gulmarg if he is not allowed to stay there as per his wish." he added.

TASK said that if Sonmarg and Pahalgam are the routes for the Amarnath Yatra then why are there restrictions in Gulmarg? Gulmarg has nothing to do with Yatra and still tourists and those associated with the tourism industry including cab drivers are not allowed to stay at the destination after 3 pm.

"We wholeheartedly welcome Yatris but at the same time, we don't want the tourism industry to suffer. We appeal to Home Minister Amit Shah and LG Manoj Sinha to review their decision and ensure hassle-free movement of tourists and locals in Kashmir during the yatra period.

"Not only have such restrictions put the general tourists in a lot of inconveniences but the travel agents


Haji Mohammad Is-

Country-Wide Security Alert EW DELHI - An alert was sounded today in

major capitals and sensitive towns across India following the terror attack on the makeshift temple in Ayodhya this morning. Security was particularly tightened around important temples and other place, if worship across the country in view of the targeting of the makeshift shrine where once the Babri Masjid structure stood and the possible repercussions it may have.

In Delhi, security was beefed up near the temples and the RSS headquarters in Jandewalan area in a crowded area in the central part.

Additional personnel of police and para-military forces have been mobilised in Delhi and patrolling has been intensified. In Mumbai, the scene of serial blasts and riots after the December 1992 demolition of the disputed structure in Ayodhya, security was beefed-up.

"We have taken special measures outside temples and other religious places in the city following the the Ayodhya incident, Police Commissioner A N Roy, said.

Additional forces have been deployed at prominent temples and other places of worship. Security has also been beefed up an the Department of Atomic Energy (DAE) installations across the country, Chief Security Officer of DAE N C Gop, said.

Security was also alerted across West Bengal with special emphasis on communally-sensitive areas. In Surat, where the RSS is holding a conclave, a security cordon was thrown around the venue of the meeting.

A high alert was also sounded in the Char Dham shrine circuit comprising Badrinath, Kedarnafh, Yamunotri and Gangotri in Uttaranchal and Krishna Janamabhoomi. "Our police force has been put on high alert," Deputy Inspector General of Police R Singh Meena, said in Dehra Dun.

Police have been asked to be on patrol day and night in Badrinath temple area as it is one of the famous shrines in Uttaranchal, he said. Uttaranchal is attracting hundreds of pilgrims as the Chardham Yatra is going on.

# SCO summit

he Shanghai Cooperation Organisation (SCO) Summit, hosted virtually by the Prime Minis-ter Narendra Modi, saw the virtual participation of Chinese President Xi Jinping, Russian President Putin, Pakistan's Shehbaz Sharif, and newlyinducted member Iran's President Ebrahim Raisi. The summit focused on crucial issues such as cross-border terrorism, regional stability, and enhancing cooperation among member nations.

In an oblique reference to Pakistan, Prime Minister Modi once again emphasized the importance of unequivocal condemnation of nations employing cross-border terrorism and urged the SCO not to shy away from criticizing such practices. India has repeatedly accused Pakistan of using terrorism as instruments of state policy.

A point of contention arose when India abstained from supporting China's Belt and Road Initiative (BRI) in the SCO's New Delhi declaration. India's stance is rooted in concerns over the China-Pakistan Economic Corridor, which it believes violates its territorial integrity and sovereignty.

The New Delhi declaration signed by the member nations at the end of the meeting stated that the international community must come together to "counter the activities of terrorist, separatist and extremist groups, paying special attention to preventing the spread of religious intolerance, aggressive nationalism, ethnic and racial discrimination, xenophobia, ideas of fascism and chauvinism."

In his address, PM Modi indirectly referred to the ongoing Ukraine war, highlighting the challenges faced by the world, including conflicts, tensions, and pandemics. By acknowledging these global issues, Modi emphasized the need for collective efforts and cooperation among nations to address common challenges, such as food, fuel, and fertilizer crises.

Pakistan's Prime Minister Shehbaz Sharif denounced terrorism in all its forms and manifestations, stressing the need for resolute action against both individual and state-sponsored terrorism.

Although the SCO summit was successfully organized, an undercurrent of bitterness between India's relations with China and Pakistan was obvious. Ever since China's incursions along the Line of Actual Control, India has drifted closer to the west and rightly so. And as for ties with Pakistan, the SCO summit offered little hope that the two countries are any closer to getting back to some working relationship. In fact, the two neighbours confronted each other in even more antagonistic terms.

The SCO summit was an opportunity for India and Pakistan to engage in dialogue and explore avenues for cooperation. However, the meeting has only served to highlight the deep-seated distrust. New Delhi has once again made it clear that as long as Pakistan continued to support terrorism, India will remain on guard and not resume dialogue. Similarly with China, India wants the status quo ante along the LAC to restore for normal neighbourly ties to resume.

# The US and India's **Non-Aligned Alliance**

'ndian Prime Minister Narendra Modi is riding high. His triumphant visit to Washington, which featured a state dinner at the White House and a rare second address to a joint session of Congress, appears to mark a new chapter in the relationship between the United States and India following a quarter-century of ups and downs.

Modi's visit was preceded by several major breakthroughs, including the recent US-India initiative on Critical and Emerging Technology, which seeks to foster bilateral collaboration on technologies such as artificial intelligence, biotechnology, quantum computing, 5G, and cybersecurity. US semiconductor manufacturer Micron Technology recently announced that it plans to invest \$825 million in a new chip assembly and testing facility in India.

The US and India have also unveiled several defense agreements, including a deal for India to acquire 30 MQ-9B Predator armed drones from the US and a separate plan to produce F414 fighter jet engines for the Indian Air Force jointly with General Electric. These deals, which have not been previously extended to a country that is not formally an ally, highlight the intensifying bilateral defense partnership.

The transformation is striking. Throughout the Cold War, the world's oldest democracy and its largest remained essentially estranged. America's initial indifference toward India was evident in President Harry Truman's reaction when Chester Bowles asked to be the US ambassador. "I thought India was pretty jammed with poor people and cows wandering around the streets, witch doctors, and people sitting on hot coals and bath-ing in the Ganges," Truman said, "but I did not realize that anybody thought it was important."

America's preference for alliances with anticommunist regimes led the US to establish relationships with a series of increasingly Islamist dictatorships in Pakistan. Meanwhile, India's non-aligned democracy gravitated toward the secular Soviet Union. Non-alignment was not well-received in the US, where President Dwight Eisenhower's Secretary of State, John Foster Dulles, famously declared that "neutrality between good and evil is itself evil."

The end of the Cold War, together with the reorientation of India's foreign policy and its integration into the global economy, led to improvement in US-India relations, but India's detonation of a nuclear device in 1998 triggered US-led economic sanctions. President Bill Clinton's visit to India in 2000, his final year in office, marked a major turning point, and George W. Bush's administration built on the momentum by signing a defense agreement with India in 2005 and a landmark accord on civil nuclear cooperation in 2008. The positive trend persisted under both Barack Obama and Donald Trump and now appears to have reached a zenith under President Joe Biden.

Today, the US seems much more willing to accommodate India's post-colonial obsession with strategic autonomy. Whereas the Hindu nationalist Modi stands in stark contrast to his secular predecessor, Manmohan Singh, there has been remarkable bipartisan support for deepening ties by five successive US presidents and three Indian prime ministers. This shift has been partly driven by China's geopolitical assertiveness under President Xi Jinping, which represents a radical departure from his predecessors' adherence to the doctrine of China's "peaceful rise." The US clearly views China as its primary adversary and has been ac-

tively pursuing regional alliances to counter its growing influence.

India has traditionally been reluctant to pick sides, but China's repeated encroachments on its territory across the disputed Himalavan border. and its killing of 20 Indian soldiers in June 2020. have rendered neutrality untenable. While India maintains its independent posture, the recent G7 summit in Hiroshima notably included the second-ever in-person Quad summit between Biden, Modi, Japanese Prime Minister Fumio Kishida, and Australian Prime Minister Anthony Albanese. During the gathering, the four leaders reaffirmed their commitment to a free, open, and inclusive Indo-Pacific.

The message to China is clear. While India maintains that it is not a US ally but a partner, it has increasingly aligned itself with the democratic West in its escalating rivalry with communist China.

But it would be a mistake to view India-US relations solely through a Chinese lens. America and India have far more in common than is generally acknowledged: democracy, a common language, and dedication to fostering innova

tion and entrepreneurship. As Henry Kissinger once observed, the two countries have "no conflict of interest in the traditional and fundamental sense.

The most important factor contributing to the deepening ties between the US and India is the growing number of Indian-Americans, which exceeds four million. Indian-Americans are disproportionately affluent, with the highest median income of any US ethnic group, including whites. They are also becoming an increasingly influential voting bloc, and their prominent roles in political fundraising, on Congressional staffs, and in government offices have given rise to a so-called Samosa Caucus. The US has had two governors and seven members of Congress of Indian heritage. US Vice President Kamala Harris's mother is Indian, and Former US Ambassador to the United Nations Nikki Haley - currently running for president - is the daughter of Punjabi Sikh parents.

While their political views vary, many Indian-Americans have been increasingly outspoken on issues related to India. The continuous influx of more than 150,000 Indian students to the US every year contributes to this dynamic. In addition to injecting nearly \$8 billion into the US education system and related services, these migrants ensure a constant infusion of fresh ideas and perspectives. In the long run, Indian-Americans may help shape US policy on India in the same way that Jewish Americans play a role in shaping US policy on Israel.

In the past, it was often said that Pakistan was a US ally but not a friend, while India was a friend but not an ally. With the US out of Afghanistan, Pakistan has become a less significant ally. But, while India still isn't one, owing to its insis tence on strategic autonomy, even US skeptics who say the two countries' interests are more aligned than their values concede that those interests warrant closer cooperation. Modi's visit was one more indication of how close that cooperation has become.'

'ith Reliance Jio launching an Internet-enabled feature phone (Jio Bharat) to tap the 250 million users of 2G services, the debate on whether such a subsidy-led model to produce handsets really works for telecom operators will start once again. Let's look at the numbers.

When Jio first launched its 4G, VoLTE feature phone (JioPhone) in 2017, there were around 500 million 2G users. Not all of them moved to Jio, but the fact is that the number is now down to 250 million. This means an ecosystem has been created to help operators migrate a substantial number of 2G users to 4G and enhance their average revenue per user (Arpu). It is true that the JioPhone and the entry-level smartphones priced at Rs 6,500, which it later launched in partnership with Google, were not hugely successful. That explains Jio's latest move to entice 2G users by playing the price card.

Another factor behind the launch of the phone at this point could be that operators are looking at revenue-enhancing measures. With the last headline tariff increase having happened in 2021 and chances of another one looking bleak before the 2024 general elections, telcos are left with no option but to make some tweaks to the existing structures. The sequential Arpu growth for both Jio and Bharti during the January-March quarter was flat.

This is despite Bharti Airtel recently raising entry-level tariffs for 2G users by around 57%. Jio is a fully 4G network, which has always marketed itself on price points, but has only 1% of its subscriber base as post-paid users. Thus, it has very little elbow room to raise tariffs at the lower end and needs a substantial increase in the subscriber base. Jio's rival, Bharti, however, has consistently resisted any temptation of getting into a subsidy-led handset business as it believes it is not possible to sustain a subsidy-driven subscriber addition model in the long run. The company, therefore, looks at working on strategies that can help it migrate subscribers to a higher tariff pack. This way, Arpu would also rise, and the company would not have to rely solely on headline tariff hikes. The economics is simple: when customers switch to 4G, Arpu doubles. Similarly, when a prepaid customer moves to post-paid, Arpu further doubles, and when a post-paid customer buys all other services like DTH, wireline broadband, etc, the Arpu quadruples. So, there is a lot of Arpu enhancement that can come through upgrades

# **Creating Safe Spaces** A Comprehensive Look at the Prevention of Sexual Harassment Act

The Prevention of Sexual Harassment Act of 2013 is a landmark legislation that seeks to address the pervasive issue of sexual harassment in various spheres of society. Recognizing the urgent need for legal protection and redressal mechanisms for victims, this act was enacted to ensure a safe and conducive environment, free from sexual harassment, for everyone, regardless of gender.

Sexual harassment is a grave violation of an individual's rights and dignity, often resulting in profound physical, emotional, and psychological consequences. It can occur in workplaces, educational institutions, public spaces, and even within the family. The Prevention of Sexual Harassment Act of 2013 acknowledges the detrimental impact of such behavior and endeavors to establish a robust framework to prevent and address instances of sexual harassment effectively.

This legislation defines sexual harassment comprehensively, encompassing a wide range of unwelcome acts or behavior, including physical advances, verbal or non-verbal conduct, or any form of sexually colored remarks or jokes. It recognizes that sexual harassment is not limited to physical contact but extends to creating a hostile, intimidating, or offensive environment that interferes with an individual's safety, dignity, and well-being.

One of the crucial provisions of the act is the establishment of Internal Complaints Committees (ICCs) in organizations with ten or more employees. These committees play a pivotal role in handling complaints related to sexual harassment. They are responsible for receiving, investigating, and resolving such complaints in a fair and impartial manner. The ICCs serve as a crucial avenue for victims to seek justice and obtain appropriate redressal within their workplaces.

Furthermore, the act also em-



providing legal protection, establishing redressal mechanisms, and promoting awareness, this act seeks to empower victims, hold perpetrators accountable, and create a safer and more inclusive society. Its implementation is crucial in ensuring that individuals can live and work free from the fear and trauma of sexual harassment, fostering an environment that upholds the principles of equality, dignity, and respect for all.

### **BRIEF OVERVIEW OF THE PROVISIONS**

The Prevention of Sexual Harassment Act of 2013 encompasses several sections that outline the rights and responsibilities of victims and the procedures for dealing with instances of sexual ployees are required to establish an ICC. The ICC is responsible for receiving complaints, conducting inquiries, and recommending action against the perpetrator.

# COMPLAINT OF SEXUAL HARASSMENT

Lengthy and delayed inquiry processes can discourage victims and undermine their faith in the system. It is important to ensure expeditious and fair investigations and appropriate disciplinary action against perpetrators.
- Compliance issues: Some organizations may struggle with compliance, either due to a lack of understanding or unwillingness to adhere to the requirements of the act. This can result in inadequate implementation and insufficient measures to prevent and address sexual harassment.
- Limited awareness in informal sectors: The POSH Act primarily focuses on formal workplaces, leaving out individuals working in the informal sector, such as domestic

#### CONSTITUTION OF INTERNAL COMPLAINTS COMMITTEE (ICC)

According to this section, organizations with ten or more emComplaints Committee or Local Complaints Committee may extend the deadline. The committee must be convinced that the woman was unable to submit a complaint within the allotted time frame due to the circumstances. According to Section 9 of the POSH Act, complaints of sexual harassment at work may be made to the Internal Committee or Local Committee. The process is as follows:

Within three months of the occurrence date and, in the case of repeated incidences, within three months of the most recent incident, an aggrieved woman may report sexual harassment at work.

If the victimised lady is unable to file a complaint within the allotted three months, the Internal Complaints Committee or Local Complaints Committee may extend the deadline. The committee must be convinced that the woman was unable to submit a complaint within the allotted time frame.

#### PUNISHMENT AND COMPENSATION:

According to the POSH Act, an employer may discipline an employee in the following ways for sexual harassment:

The penalty outlined in the organization's service regulations; There may be written apologies, warnings, reprimands, censures, withholding of promotions, pay increases, or increments, termination of the respondent's employment, counselling sessions, or community service if there are no service rules in the organisation; and

Paying the woman who was wronged compensation by reducing the respondent's salary (Section 13 of the POSH Act). According to Section 15 of the POSH Act, harmed women may also get compensation. The following considerations must be made when calculating compenmaliciously" invoke the provisions, according to Section 14 of the POSH Act. According to the POSH Act, disciplinary action can be taken against a complainant whose claims have been proven to be false, malicious, or made with knowledge that they are false in accordance with the service norms of the organisation. In cases where there are no service standards in place, the Act allows for disciplinary measures such as written apologies, warnings, reprimands, censure, withholding of promotions, withholding of raises and increments, terminating employment, going to counselling, and completing community service. The POSH Act makes it clear that a complaint does not necessarily have to be untrue or malicious just because there is not enough evidence to back it up. It is true that Section 14 appears to be a saving clause, but the language of the section is regarded as a deterrent in nature. It is possible to conclude from different perspectives that the provisions incorporated in Section 14 to punish false and malicious complaints or false evidence may deter frivolous complaints, but they may also deter genuine witnesses or complainants who may not collect sufficient evidence to prove their allegations.

#### WHAT STEPS SHOULD A VICTIM TAKEN WHEN BEING SEXUALLY ASSAULTED

- . Recognize the harassment: Understand and identify the behavior as sexual harassment, whether it involves physical advances, unwelcome remarks, or creating a hostile environment.
- ii. Document incidents: Keep a record of the incidents, including dates, times, locations, and any witnesses present. Maintain any related evidence such as emails, messages, or photographs, if

about the progress of the me against the perpetrator. If unsatisfied with the outcome, consider filing an appeal with the Appellate Authority.
vii. Preserve confidentiality: Maintain the confidentiality of the proceedings and refrain from discussing the details of the case publicly, as it may hinder the investigation or legal processes.

It is important for victims to remember that they have the right to be treated with respect, dignity, and fairness throughout the entire process. Seeking legal advice or counseling services can also be beneficial in navigating through the procedures and coping with the emotional impact of the harassment.

#### CHALLENGES FOR THE IMPLEMENTATION OF THE POSH ACT:

The implementation of the Prevention of Sexual Harassment (POSH) Act in India faces several challenges. Some of the key challenges include:

- Lack of awareness: One of the significant hurdles is a lack of awareness about the provisions and requirements of the POSH Act among both employees and employers. Many individuals are unaware of their rights and the procedures for filing complaints, leading to underreporting and inadequate implementation.
- Inadequate training: Proper training and sensitization programs are essential for employees, employers, and members of Internal Complaints Committees (ICCs) to understand the nuances of sexual harassment, prevention strategies, and the process of handling complaints. Insufficient or inconsistent training can hinder effective implementation.
- Fear of retaliation: Victims of

Addressing these challenges requires collective efforts from all stakeholders, including employers, employees, ICC members, and the government. Continuous awareness campaigns, robust training programs, strengthening ICCs, promoting a culture of zero tolerance towards sexual harassment, and ensuring accessible support systems are crucial for effective implementation of the POSH Act and creating safer work environments.

# SOME FAQS RELATED TO THE POSH ACT:

a. Is it possible for both men and women to be victims of workplace sexual harassment?

Both men and women can experience harassment. However, POSH Act safeguards and protections are only offered to women. b. Does language/ verbal conduct

alone qualify as sexual harassment?

Sexual harassment may include sexually explicit verbal abuse. Words can be offensive in the same way that touching and physical deeds can be. Sexually explicit jokes, remarks, and anecdotes can encourage sexual harassment at work and foster a hostile environment.

c. Do the parties involved in a claim of sexual harassment have a chance to resolve the issue through mediation or conciliation?

Yes, a settlement may be reached at the request of the aggrieved woman, but no monetary settlement can be reached.

# Tuesday set an unofficial record for the hottest day on Earth. Wednesday may break it

Maine, Jul 5 (AP) The planet's temperature spiked on Tuesday to its hottest day in at least 44 years and likely much longer, and Wednesday could become the third straight day Earth unofficially marks a record-breaking high, the latest in a series of climatechange extremes that alarm but don't surprise scientists.

The globe's average temperature reached 62.9 degrees Fahrenheit (17.18 degrees Celsius) on Tuesday, according to the University of Maine's Climate Reanalyzer, a common tool based on satellite data and computer simulations and used by climate scientists for a glimpse of the world's condition.

On Monday, the average temperature was 62.6 degrees Fahrenheit (17.01 degrees Celsius), breaking a record that lasted only 24 hours.

While it is not an official National Oceanic and Atmospheric Administration record, "this is showing us an indication of where we are right now," NOAA chief scientist Sarah Kapnick said. Even though the

dataset used for the unofficial record goes back only to 1979, she said that given other data, it's likely the hottest day in "several hundred years that we've experienced."

The previous hottest day was in August 2021, Kapnick said.

'A record like this is another piece of evidence for the now massively supported proposition that global warming is pushing us into a hotter future," said Stanford University climate scientist Chris Field, who was not part

of the calculations. With many places seeing tempera-tures near 100 degrees Fahrenheit (37.8 degrees Celsius), the new average temperatures might not seem very hot. But Tuesday's global high was nearly 1.8 degrees Fahrenheit (a full degree Celsius) higher than the 1979-2000 average, which already tops the 20th- and 19th-century averages.

Higher temperatures translate into brutal conditions for people all over the world. When the heat spikes, humans suffer health effects especially



young and elderly people, who are vulnerable to heat even under normal conditions.

"People aren't used to that. Their bodies aren't used to that," said Erinanne Saffell, Arizona's state climatologist and an expert in extreme weather and climate events.

"That's important to understand who might be at risk, making sure people are hydrated, they're staying cool, and they're not exerting themselves outside, and taking care of those folks around you who might be at risk.'

The highs come after months of

"truly unreal meteorology and climate stats for the year," such as off-the-chart record warmth in the North Atlantic, record low sea ice in Antarctica and a rapidly strengthening El Nino, said University of Oklahoma meteorology professor Jason Furtado.

Scientists generally use much longer measurements months, years, decades to track the Earth's warming. But the new figures are an indication that climate change is reaching uncharted territory, even if the data aren't quite the type used by gold-standard climate measurement entities such as the National Oceanic and Atmospheric Association.

The figures legitimately capture global-scale heating, and NOAA will take them into consideration for its official record calculations, said Deke Arndt director of the National Centre for Environmental Information, a division of NOAA.

High-temperature records were surpassed this week in Quebec and Peru. Beijing reported nine straight days last week when the temperature exceeded 35 degrees Celsius (95 degrees Fahrenheit).

Cities across the US from Medford, Oregon to Tampa, Florida have been hovering at all-time highs, said Zack Taylor, a meteorologist with the National Weather Service.

Wednesday may bring another unofficial record, with the Climate Reanalyzer again forecasting record or near-record heat. Antarctica's average forecast for Wednesday is a whopping 4.5 degrees Celsius (8.1 degrees Fahrenheit) warmer than the 1979-2000 average. In the US, heat advisories are in ef-

fect this week for more than 30 million people in places including portions of western Oregon, inland far northern California, central New Mexico, Texas, Florida and the coastal Carolinas, according to the National Weather Service Weather Prediction Center. Excessive heat warnings are continuing across southern Arizona and California. (AP)

Various petitions are pending before the top court challenging the validity of the law scrapping Article 370 of the Constitution and special status to Jammu and Kashmir and bifurcating the state into two Union Territories.

On August 5 2019, the Central government announced its decision to revoke the special status of Jammu and Kashmir granted under Article 370 and split the region into two Union territories.

A five-judge Constitution bench in March 2020 had declined to refer to a larger 7-judge bench a batch of petitions challenging the Constitutional validity of the Centre's decision to abrogate provisions of Article 370 on August 5, saying there were no reasons to refer the matter to a larger bench.

"By keeping the employee under suspension for four long years, the applicant (employee) has been put to lot of stress and temporary deprivation of his full wages over this period, and such inaction on part of the respondents indicate a total lack of seriousness in dealing with the matter as it was expected on the part of the respondents to have acted with promptitude by conducting the inquiry within the stipulated time period," the high court had said and dismissed the appeal filed by the government.




