### **SC Defers Hearing On Early Poll Plea**

**New Delhi:** The Supreme Court on Thursday deferred hearing on a plea seeking directions to the Election Commission and the government for holding early assembly polls in Jammu and Kashmir.

A bench comprising Chief Justice D Y Chandrachud and Justices P S Narasimha and Manoj Misra noted that petitions challenging the abrogation of Article 370 were listed for hearing on July 11.

"We will adjourn this.The 370 matter is listed for directions on July 11," the bench said.

The counsel appearing for the petitioners submitted that this is a different case as the residents have been disenfranchised and urged the apex court to issue notice in the matter. The bench, however, refused to issue notice and adjourned the matter.

**Srinagar:** Weather department here has forecast rain and thunderstorm at some places in Jammu and Kashmir

"Light to moderate rain/ thunderstorm is expected at scattered places on July 7," a meteorological department official here said.

On July 8-9, he said, intermittent light to moderate rain was likely at many places of J&K. "Some places in plains of Jammu region may receive moderate to heavy rain during morning hours."

Regarding the minimum temperature today, he said, Srinagar recorded a low of 17.8°C against 17.3°C on the previous night and it was 0.7°C above normal for the summer capital.

Qazigund, he said, recorded a low of 16.0°C against 17.0°C on the previous night and it was 0.5°C above normal for the gateway town of the Kashmir Valley. Pahalgam, he said, recorded a



low of 12.8°C against 11.6°C on the previous night and it was above normal by 2.0°C for the famous tourist resort in south Kashmir's Anantnag district.

# **Scientists Unveil Mystery Of Huge** 'Gravity Hole' In Indian Ocean

esearchers at the Indian Institute of Science (IISc) Bangalore have identified the cause of an over three million square kilometreswide 'gravity hole' in the Indian Ocean.

Located just south of Sri Lanka, it is at this location the Earth's gravitational pull is weakest & sea level is over 100 metre lower than global average.

The researchers noted that in the absence of tides and currents on the oceans, all the water would settle onto a smoothly undulating shape called a geoid, rising wherever there is high gravity, and sinking where gravity is low.

The resulting unevenness in the ocean surface, known as "geoid anomalies", are

generated by uneven mass distribution within the deep Earth. One such anomaly is found just south of Sri Lanka, spanning a vast extent.

Known as the Indian Ocean Geoid Low (IOGL), it is dominated by a significant gravity low where the ocean surface plunges down to 106 metres.

"The existence of the Indian Ocean geoid low is one of the most outstanding problems in Earth Sciences. It is the lowest geoid/gravity anomaly on Earth and so far no consensus existed regarding its source," said Attreyee Ghosh, an Assistant Professor at the Indian Institute of Science, Bangalore.

In a study published in the journal of Geophysical Research Letters, the team from IISc, in collaboration with researchers from the GFZ German Research Cenbehind the missing mass that is causing

Though several studies in the past have tried to answer this, most of them attributing it to a remnant of an earlier plate that dived into the Earth's mantle beneath another plate millions of years ago, there had been no convincing explanation of the

The new study employed numerical

This convective movement within the

models that use seismic waves to obtain a 3-dimensional picture of the Earth's interior.

The researchers found that 'low density anomalies' or the presence of lighter materials in the upper to mid mantle below the IOGL, were responsible for the gravity low in this region.

Mantle plumes or the rising up of abnormally hot rock within the Earth's mantle can result in low density anomalies. However, no known mantle plume exists the researchers said.

# Middle Aged Man Held For **Raping Minor In Srinagar**

Srinagar: A middle aged man was arrested by the police under stringent POSCO act in Srinagar for allegedly raping his 15-years old minor relative on Thursday

The shocking incident took place day after a 22-year old youth was arrested under the same act for allegedly raping a minor girl child in Old Barzulla area in uptown Srinagar.

Police said the accused: a 46-years old man was arrested for allegedly raping a minor girl, who is also said to be his relative. The accused has been identified as Mohammad Iqbal Sheikh son of Ghulam Qadir Sheikh of Kanthpora, Sogam area in north Kashmir's Kupwara district.

Police said the accused

was putting up in a rented accommodation at Pamposh Colony Srinagar.

A formal case under FIR No 92 of 2023 under sections 352, 376, 506 of IPC and 3/4 of POSCO act has been registered in this regard at police station Safakadal. Confirming the arrest, Srinagar police in a tweet said the accused has been arrested and is presently lodged at Safakadal police station.

# Bid On Minster's Life In City Centre

Militants Attack Motorcade In Crowded Budshah Chowk

rinagar: Minister of state for Public Health Engineering, yed Basheer Ahmad Andrabi, narrowly escaped a bid on his life when militants opened fire on his bullet-proof am-bassador car and escort vehicle near the Budshah Chowk in the crowded heart of the city this afternoon.

Three of his security guards were injured in the attack, and the two vehicles damaged, while the attackers fled from the scene leading behind their weapons and two pherans. The Islamic Front group has claimed responsibility for the bid on the minister's life.

Two pheran-clad militants opened fire on the minister's cars from a close range when the vehicles slowed down near the old KMDA bus-stand because of traffic jam, the KNS quoted the police as having said.

The attack took place at around 4:50 p.m. when the minister was returning from the secretariat to his official residence. Three personal security guards of the minister were injured in the firing, the initial bursts ripping the tyres of the ambassa-

dor car and the escorting Gypsy.

Windowpanes of the two vehicles were smashed by the militants' sustained firing, but the attackers fled when the minister's guards and patrolling policeman began to return the fire. According to eyewitnesses, the militants escaped in the

crowd towards- Maisuma by-lanes.
Police guards surrounded the minister and whisked him off

The police said that they had recovered two AK asault rifles, two pouches and two pherans from the Maisuma area. The firing threw the heart of the city into panic and chaos, with people running for cover, and traffic coming to a standstill. Long traffic iams were witnessed on key crossings in the city centre, as policemen diverted vehicles and cordoned off the area

in order to facilitate search operations.

The director-general of the police, the IGP, SSP Srinagar, SP East and other police officials arrived on the scene soon after the attack on the minister to oversee the operations.

**ISLAMABAD:** Pakistan's former Prime Minister Imran Khan has been named in six cases, including three under the tough Anti-Terrorism Act, for the unprecedented attack on Pak Army's General Headquarters (GHQ) of the army in Rawalpindi on May 9, local media reported.

Supporters of Imran Khan, also chief of the Pakistan-Tehreek-e-Insaf party, allegedly breached the gates of the Paki-stan Army's GHQ in Rawalpindi on May 9, dubbed as a "Black Day" by the country's military.

The joint investigation teams (JITs) are investigating all the cases, including the attacks on military installations and the incident of arson at a metro station, Pakistan's Geo News quoted sources as saying.

According to Press Trust of India, sources told Geo News that three of these cases were registered against 70-year-old Imran Khan on May 9 while the other three on May 10 under the Anti-Terrorism Act (ATA).

Imran Khan's party has found itself in hot waters after violence erupted across the country on May 9 following his dramatic arrest from the premises of the Islamabad High Court in a corruption case.

# **Earth's Average Temperature Remained At A Record High**

For The Third Day In A Row, The

**Press Trust of India** 

Earth's average tempera-ture remained at a record high on Wednesday, after two days in which the planet reached unofficial records. It's the latest marker in a series of climate-change-driven ex-

The average global temperature was 17.18 Celsius (62.9 degrees Fahrenheit), according to the University of Maine's Climate Reanalyzer, a tool that uses satellite data and computer simulations to measure the world's condition.

That matched a record set on Tuesday of 17.18 Celsius (62.9 Fahrenheit), and came after a previous record of 17.01 Celsius (62.6 degrees Fahrenheit) was set on Monday.

Scientists have warned for months that 2023 could see record heat as human-caused climate change, driven largely by the burning of fossil fuels like coal, natural gas and oil,

warmed the atmosphere.
They also noted that La Nina, the natural cooling of the ocean that had acted as a counter to that warming, was giving way to El Nino, the reverse phenomenon marked by warming oceans. The North Atlantic has seen record warmth this year.

A record like this is another piece of evidence for the now massively supported proposition that global warming is pushing us into a hotter future, said Stanford University climate scientist Chris Field, who was not part of the calculations.

University of Maine climate scientist Sean Birkle, creator of the Climate Reanalyzer, said the daily figures are unof-ficial but a useful snapshot of what's happening in a warming world.

official government record, this is showing us an indication of where we are right and Atmospheric Administration chief scientist Sarah Kapnick. And NOAA indicated it will take the figures into

record calculations. Even though the dataset used for the unofficial record goes back only to 1979, Kapnick said that given other data, the world is likely seeing the hottest day in several hundred years that we've experienced.

Scientists generally use much longer measurements months, years, decades to track the Earth's warming. But the daily highs are an indication that climate change is reaching uncharted territory.

On Wednesday, 38 million Americans were under some kind of heat alert, Kapnick said.

That included communities that aren't used to feeling such heat. In North Grenville, Ontario, the city turned ice hockey rinks into cooling centres as temperatures on Wednesday hit 90 degrees Fahrenheit (32 degrees Celsius), with humidity making it feel like 100.4 degrees (38 degrees Celsius).

I feel like we live in a tropi-

grees Fahrenheit (37.8 degrees Celsius), the average temperature records might not seem very hot. But Tuesday's global high was nearly 1.8 degrees Fahrenheit (a full degree Celsius) higher than the 1979-2000 average, which already topped the 20th- and 19thcentury averages. High-temperature records

were surpassed this week in Quebec and Peru. Beijing reported nine straight days last week when the temperature exceeded 35 degrees Celsius (95 degrees Fahrenheit), and ordered a stop to all outdoor work on Wednesday as more high temperatures were forecast.

Cities across the US from Medford, Oregon to Tampa, Florida have been hovering at all-time highs, said Zack Taylor, a meteorologist with the National Weather Service.

Alan Harris, director of emergency management for Seminole County, Florida, said the county has already surpassed last year for the number of days they've activated their extreme weather plan something that happens when the heat index hits 108 Fahrenheit or greater.

It's just been kind of brutally hot for the last week, and now it looks like potentially for two weeks, Harris said.

"This particular meeting will discuss organisational issues in all state units in the east and northeast," he added.

Before the meeting, the BJP leaders paid their obeisance to Jana Sangh founder Syama Prasad Mookerjee on the occasion of his birth anniversary at the party's state headquarters.

There are a total of 142 Lok Sabha seats in these 12 states and in 2019, BJP won 68 of

them. eight northeastern The states have a total of 25 Lok Sabha seats with Assam having the highest of 14. Arunachal Pradesh, Meghalaya, Manipur and Tripura have two seats each, while Mizoram, Nagaland and Sikkim have one seat each.

Among the eastern states, West Bengal has 42 seats, Bihar has 40 seats, Odisha has 21 and Jharkhand has 14 seats.

The meeting is also likely to discuss the assembly elections in Mizoram, which would be due later this year.

JP leaders of the northern, central and western states will meet in New Delhi on July 7, and those of the southern states in Hyderabad on July 8.

families by the turn of the decade and a large chunk of the growth will come from rural areas - home to the nation's poorest, according to a study.

The number of super rich households, those earning more than 20 million rupees (\$243,230) a year, almost doubled to 1.8 million in five years to 2021, showed a report released Wednesday by People's Research on India's Consumer Economy and India's Citizen Environment, or PRICE. The growth of such households in villages was 14.2% compared to 10.6% in cities.

Super rich households will swell further to 9.1 million by 2031, aided by faster growth in rural areas, showed the study by the think tank which polled more than 40,000 people in



25 states.

"People are increasingly engaged in commercial agriculture businesses as well as non-agriculture activities in rural areas," said Rajesh Shukla, chief executive officer of the organization and the author of the report. "Entrepreneurs are flooding into rural areas, creating jobs and small businesses that drive the economy."

Global wealth managers and foreign banks are expanding in India as the nation becomes home to a rising number of millionaires. Oxfam International estimates India minted 70 new

millionaires each day between 2018 and 2022, putting spotlight on the nation a growing consumer market. Along with a burgeoning middle class which is

spending on luxury cars and foreign holidays, Asia's third-largest economy is also seeing a rapid rise of billionaires such as Gautam Adani. While this underscores the growth potential of the the country, it also highlights the rising inequality in the nation.

The survey also found that the country's middle class population of 432 million earning between \$6,000 and \$36,000 annually - is the fastest-expanding category, and is predicted to reach 715 million by 2031. The "destitute" class, with income less than \$1,520, will shrink by more than half to 79 million by that time.

# **Inter-State Narco-Smuggling** Racket Busted, 2 Held: Police

**SRINAGAR:** Senior Superintendent of Police (SSP) Anti-Narcotics Task Force (ANTF) J&K, Raj Kumar Thursday claimed to have busted Inter-State narco smuggling racket by arresting two Punjab residents along with 35 poppy straw packets.

"Acting on information, we seized an Innova vehicle bearing number PB-08 CP 0517 at Shampora, Qazigund. Two persons Amandeep Singh and Manohar Singh, both residents of Gurdaspur, Punjab were arrested along with 35 packets of poppy straw. The vehicle has been seized as well," the SSP ANTF said as per news agency KNO.

He said more forward and backward links of the case are being investigated and there are chances of more arrests likely.

"He said that once the narcosmuggling links are established. we also seized the properties of the accused," the SSP said.

He said in the last one month, 5 kg Charas, 200 bottles of codeine, 900 tablets of Alprazoam besides other drugs were seized. "Heroine was also seized as well," the SSP said. He said ANTF is specialized in investigating narco-smuggling cases and people must come forward and provide leads about peddlers and smugglers.

As per the statement of ANTF, last month one person from West Bengal and another from Maharshtra were arrested as well along with two kgs of Charas. A resident of Gujrat was also arrested along with 3 kgs, 800 grams of charas last month. "Further investigations are on," he said

### 100-Bedded Hospital Built In Record 15 Days At Baltal Base Camp

**BALTAL:** Healthcare workers, including doctors and paramedical staff, are working round the clock at the 100-bedded specialty hospital at the Amarnath Yatra base camp here in Jammu and Kashmir's Ganderbal district, ready to tackle any eventuality.

Last year, flash floods near the holy cave shrine had killed 15 people and injured many others.

The J-K administration has set up two specialty hospitals at the base camps of Baltal, in Sonamarg area of central Kashmir's Ganderbal, and Chandanwari, in Pahalgam area of south Kashmir's Anantnag district, the twins routes for the yatra. Both the hospitals -- 100-bed-

ded each -- were built by the DRDO in a record time of 15 days. They were inaugurated by J-K Lieutenant Governor Manoj Sinha on June 28.

two makeshift and state-of-the-art hospitals are equipped with the most advanced equipment, separate blocks for doctors and nursing staff, ICU wards, oxygenated wards and triage areas and other required inventories for all critical medical care.

At the Baltal hospital, chief medical officer (CMO), Ganderbal, Dr Afroza Shah said the medical facility carries 100 beds, which include 30 residential beds and 70 clinical beds.

"Among these, 29 are oxygen peds and nine are triage beds.

Intensive Care Unit has four beds," she told PTI.

The CMO said the staff working at the hospital has been acquired from all over the country and has been facilitated by the Ministry of Health and Family Welfare.

"Around 1,200 healthcare workers -- both doctors and para-medical workers -- including from outside Jammu and Kashmir, are working here," Shah said.

The official said the hospital has two separate OPDs for male and female patients.

Abundant space is available in the form of a waiting area including washroom facilities. Fully functional and wellequipped laboratories are also available where all kinds of tests can be performed, she added.

Radiologists, X-rays, ultrasonography machines, and cardiac monitors are provided. A liquid medical oxygen plant has been installed here, the CMO said.

Shah said to cater to high-altitude-related sickness, oxygen is readily available at the facility including medium size, portable and bulk oxygen cylinders.

A total of 16 oxygen booths are set up along the 16-kilometre track, that is from Baltal to Domail -- out of which six booths are permanent and the rest 10 are mobile, she said.

"Where the hill becomes steeper, four to five mobile booths are also provided along the stairs " she added

# **Govt Adopts 'School Complex** System' To Rationalize 10K **Surplus Teachers**

SRINAGAR: The School Education Department (SED) has adopted a 'school complex system' to rationalize over 10,000 surplus teachers in Jammu and Kashmir.

The information was revealed by the Ministry of Education (MoE) in a Project Approval Board (PAB) for the Union Territory of Jammu and Kashmir under Samagra Shiksha Scheme for the financial year 2023-24.

In the meeting, Jammu and Kashmir School Education Department has said that it has adopted and implemented School Complex System wherein 746 School Complexes have been notified as per NEP-2020 for optimum utilisation of resources in a complex. "The rationalization of staff

is being done," it reads. It states that the J&K has rationalised the teachers within the cluster by empowering



Cluster Heads to make best use of men and material available within the cluster.

"It has also helped to improve the PTR, especially at Primary and Elementary level," the government said.

Moreover, the department has also notified that most of the surplus teachers have been adjusted against vacancies through online mode.

"In order to balance the PTR in every school, the UT has made the rationalization of teachers and the extra teachers from the over-served schools have been put in the deprived ones to ensure that there is no urban-rural imbalance in teaching posting," it reads.

According to official figures of 2022-23, MoE has stated that there were 22 percent schools at Primary level and six percent schools at Upper Primary level with adverse PTR.

In order to balance the PTR in every school, MoE had suggested the UT to go for rationalization. "All this could be done by the school level analysis using the latest UDISE data.

### Jammu's Mahakali Temple **Introduces Dress Code For Visitors**

JAMMU: Jammu and Kashmir's renowned 'Bawe Wali Mata' temple management has introduced a dress code, urging visitors to dress "decently" and cover their heads and refrain from wearing shorts, miniskirts, ripped jeans and capri pants on the premises.

proper and traditional dress code while entering the temple premises, saying visitors should wear respectable attire and cover their heads as a sign of reverence.

The temple management has stationed several staff members at the gate to educate visitors about the dress code. "We have kept head cloth and longis at the gate for visitors. Nobody is being forced to wear it," the head priest said.

Many devotees said they were happy with the dress code and commended temple authorities for the move.

Dhananjay Patil of Uttar Pradesh said devotees should religiously comply with the dress code and cover their heads when visiting the temple. "It is good for the revival of Hindu samskaras and I welcome it," he told PTI.

# **Endless Wait**

he Supreme Court's has deferred hearing on a plea seeking early assembly polls in Jammu and Kashmir. The bench comprising Chief Justice D Y Chandrachud and Justices P S Narasimha and Manoj Misra chose to adjourn the matter, citing the upcoming hearing on petitions challenging the abrogation of Article 370 on July 11. The petition filed by National Panthers Party leaders, Manju Singh and Harsh Dev Singh, highlights the critical issue of "disenfranchisement" faced by the people of Jammu

The apex court will start hearing a batch of 23 petitions challenging the union government's decision to revoke Jammu and Kashmir's special status to decide on the legality of this move. The decision to scrap Article 370, which granted special rights and privileges to the people of Jammu and Kashmir since 1954, has been a contentious issue since its implementation in August 2019.

With the matter last heard in March 2020 and subsequently put on hold, the Supreme Court has formed a five-judge constitution bench led by Chief Justice D.Y. Chandrachud to "pass directions" and schedule hearings on the challenge to the Presidential Order of August 5-6, 2019, and the Jammu and Kashmir Reorganisation Act, 2019. Legal experts reckon that the actual hearings will likely take place in August, following the initial directions issued by the bench.

Former Chief Justice N.V. Ramana agreed to list the matter for an "early" hearing but failed to follow through. However, the Supreme Court's recent decision to prioritize the case and finally schedule hearings has been welcomed by political parties, including the Peoples Democratic Party and the National Conference.

Former Jammu and Kashmir Chief Minister Mehbooba Mufti, who heads the People's Democratic Party, expressed her hope that justice would be upheld and delivered to the people of Jammu and Kashmir. She referred to the Supreme Court's previous ruling, which stated that the abrogation of Article 370 could only occur upon the recommendation of the J&K constituent assembly. Similarly, former Chief Minister Omar Abdullah of the National Conference expressed his desire for the hearings to begin earnestly.

Since the court has now linked the question of holding of Assembly elections with the long-pending hearings on Article 370, J&K may have to wait for some more time before the polls are held. And this may not be a good news for people of the union territory. Will elections be held in J&K until after the decision on the legality of the revocation of Article 370 is decided by the apex court. For now, things are not clear on this score. But if we go by the public opinion in Jammu and Kashmir, holding of Assembly elections in the UT has a widespread support. And it is time that both the union government and the supreme court sympathetically consider this sentiment.

# Thwarting Twitter

t is unfortunate that the petition by Twitter, Inc. challenging the validity of the spate of blocking orders passed by the Union government was rejected by the Karnataka High Court. While success in litigation involving the government's power to restrict speech and expression on grounds permitted in Article 19(2) of the Constitution was always expected to be difficult, it is disconcerting that the court refused to countenance all arguments based on the absence of notice to users and the apparent lack of proportionality involved in large-scale suspension of accounts and posts that contained political content, especially dissenting views against the government's farm laws and the farmers' protests they sparked. There was some expectation that judicial review will temper the authorities' zeal to go in for account-level blocking rather than ordering the removal of specific tweets, links or URLs that it deemed injurious to public order or national security. What is quite disappointing is that the court both ruled that Twitter cannot espouse the cause of its users who have voiced no grievance and discouraged an intervenor from among those who suffered account-level suspension. It ruled that a foreign entity such as Twitter could not invoke the constitutional guarantee of free speech and expression on behalf of users. In the ultimate rebuff to the platform, the court imposed costs of 50 lakh for indulging in much-delayed "speculative litigation" despite not complying with the blocking orders for a long period and then doing so only under protest.

There is little doubt that social media content can degenerate into incitement, hate speech and hostile propaganda against the state or its instrumentalities. Laws exist in most countries to order intermediaries such as social media platforms and Internet service providers to remove any offending content, but it is a common principle that established democracies should frame policies and regulations rooted in fairness and natural justice, and not impose undue curbs on freedom of speech and expression. Section 69A of the IT Act, which sets out the power to issue blocking orders, was upheld by the Supreme Court in Shreya Singhal (2015) mainly on the ground that it came with adequate procedural safeguards. Twitter argued that lack of notice to the originators of content and the account users was in breach of that verdict. The court has ruled that issuing notice to users was not mandatory, especially when they may not be identifiable. Conclusions such as this, and the wide berth given to authorities to opt for account-level blocking may require reconsideration. A definitive verdict from the Supreme Court may be needed to clarify both the rights and obligations of large media companies in relation to user-generated content. Degrees To Dismay

# **Addressing Educated Unemployment and Nurturing Kashmir's Talent Pool**

he largest problem that the people of Kashmir are facing at the moment is unemployment. Even as the young are getting advanced degrees, the issue seems to only be worsening. This is why the issue of educated unemployment is a cause for alarm.

Unemployment among the educated is the outcome of a mismatch between the supply of young people with high qualifications and the demand for highly skilled labour.

The causes of educated unemployment in Kashmir are many. To begin with, the lack of government investment in numerous industries is one of the key reasons behind educated unemployment in Kashmir. Their mental health is impacted, and social unrest results. More concerning is the possibility that educated youth could succumb to the temptation and take to violence and other criminal activities

Even as the situation seems beyond repair, several steps might be implemented to alleviate the problem of educated unemployment in Kashmir.

The government should prioritise supporting and fostering entrepreneurship. The youth should be given access to simple loans. better training facilities, and mentoring so they can launch their businesses and work for themselves. This can be accomplished by using start-up incubators, which offer an atmosphere that is beneficial to the growth of



also implement a well-planned career counselling and advice programme. The students will be able to plan their careers early and avoid choosing programmes that won't be valued by employers.

Through tax breaks, incentives, and subsidies, the government should also support the growth of local industries. This will boost economic growth, generate more jobs, and attract more investment to the area. The government should also concentrate on enhancing the educational system by promoting experiential learning as opposed to just theoretical instruction. 

# "Is It Love?", with a Twist

# The Crucial Difference Between "Love" And Psychopathological Relationships — A Psychoanalytical Breakdown

Very basic but crucially important difference between "love" which one maturely absorbs as a mode of being and (toxic) "relationships" which are mostly psychological conditions/fixations bordering on pathological.


Based on the testimonies one receives from friends and people around, one can confidently say that a large percentage of our youth has been debilitated by the so-called love relationships with the consequent breakups. It creates lifelessness within people. Why does it give rise to such psychological pain? Why do people get fixated with a person to the point of madness?

The simple point to note is that in almost all these cases, the primary root cause is the failure to distinguish between one's mother/father & the world with whatever it contains. Let us properly flesh this out.

Every human has been an infant once; the primary mode of being, therefore, that one starts this life with is what we may refer to as "maternal mode of relationship" i.e. we (when we were children) were at the centre of our relation with people around to love us unconditionally; in fact one felt at the centre of the whole cosmos. This becomes our "unconscious" psychological expectation even when we grow up.

Now, the reason behind the psychological pain of breakups or for that matter any "failure" or upset in life is nothing but the fact that the person hasn't consciously realized (as of yet) that the world or the woman/man or career is not one's "mother". The woman (one has "fallen" in love with, for example) or the people or the world that one faces is not one's mother. Even though, consciously, no one would call some girl or world as their mother, the unconscious expectation of maternal mode of relation is always hidden. And thus the natural shock: how dare so & so leave me? How is it possible that I didn't get this & I failed at that?

This is referred to as "mother complex" which is one of the main causes of escapism and death drive within people particularly in modern times when psychological rites of initiation are extinct.

The psychological wish of leaving this world in order to hide in some cave in mountains, after someone hurts you or one has failed in some exam, is the unconscious desire to recede back into the age old warmth of the mother's womb.

All great fairy tales and myths of the past that deal with confronting the "unknown" (for example adapted in movies like: Frodo in Lord of the rings, Harry in Harry Potter, Neo in Matrix) – fundamentally aim at triumphing one's "mother complex" within in order to actually face the world on the outside, in kind. Please see our article "Ancient Myths in Contemporary Cinema". Why would people in love call each other "baby"? The whole relation naturally erupts from a childish mode of being.

Therefore, coming back to our main subject matter, we may say that the primary feature of these love relations is inherently a childish mode of being; a mode of being where mother (who represents whole world for child) is perfect, loyal, predictable, exclusively in love with child, the child has to just brood for a while and there the wish is made true (a simulation of jannah/heaven); most young people even after

coming out of their childhood (biologically) haven't come out of it (psychologically) as of vet. One may like someone to the point of developing deep attachment with them but it is perfectly plausible that things might not turn out well because this is neither childhood nor heaven but rather "world" which is inherently flawed & imperfect. Thus, one may be sad over this thing or that thing but will never be diseased with fixations, possessions and unconscious childish psychological "complexes", only if one understands the basic fact that we have been discussing above. This is the psychoanalytic principle of "truth sets you free". Now let us see few evidences for the problematic childish mode of being in most of the so-called

love relations.

Why do these so-called "love" relations fail so often, so miserably and more often than not, bitterly, as Erich Fromm asks in his Art of Loving, even though it receives disproportionately huge amounts of time, attention and investment from our youth? The answer is, as we have mentioned in the beginning that love is actually, as Fromm explains, a mature mode of be-

ing where one actually loves another person i.e. one loves someone out of one's own nature of "being", what one may call "virtue", developed over a long period of time through self-work & not because one actually wants to be "loved" which is the main feature of "childish" mode of being where one is not in "love" but in love with the feeling of being loved.

What people take for granted, Fromm notes, is that they assume that the feeling of "falling" in love necessarily entails a successful relation when in fact the primary prerequisite of any loving relation is that the two partners involved themselves should be "good", loving, mature, understanding & giving individuals. These are one's permanent "traits" (virtues) that one develops over time through strenuous self-work. If the individuals comprising the relationship are (psychologically) still children then one may only expect inevitable mess. This prerequisite of one's own inner goodness is bypassed in these relationships by positing a magical feeling of "falling" in love which then becomes parasitic upon psychological "complex". Whether it be philosophers or poets, we need to note, with due respect, that more often than not, most of them have completely ignored or missed this distinction between "love" (as virtue) and psychopathological fixations. A great deal of literature is spent in tribute to "love" without separating psychological complexes out of it.

These are childish (sometimes pathological) relationships simply because the two people are still "infants" (still living in their childish mode of being) & thus end up loving/worshipping their own selves (in garb) because an infant cannot but put itself in the centre of relation. Now, let us ponder over the kind of infighting that happens in these relationships. How can two people be in "love" when in fact both of them want the other to revolve around them? This is pathology not love. Let us become cognizant of all these poetry clips saturating social media. Everything isn't love. We aren't mere spiritual beings. We are ignoring our psychological situatedness. All the theatrics that we see in these fixations is shocking when one sees & hears different reports. One person does things for the reason that the other person "in relation" cries for them or feels ashamed or hovers around them. Is this love? This is the highest proof of one's childish mode of being. An infant/child cannot actually maturely love the "other" understood as the "other".

A child just moves in the direction where food or toys are kept. This is what Erich Fromm calls "immature" relationships. Investing in gym or guitar skills or Instagram profiles or twitter theatrics, if done with the intention to self-objectify oneself i.e. putting oneself out there as a shiny object "to be loved" (i.e. typical childish mode of being) by increasing one's "functionalities" then one hasn't come out of childish state of being as of yet. All these skills/profiles/theatrics done to increase one's "market value", as Fromm would say, exposes the fact that this mode of being can be anything but love.

# Water Fast Could Help With Weight Loss, But Benefits May Not Last Long

ater fast, in which participants consume only water for a period of time, may help with weight loss, but it's unclear how long it will remain, according to a study from the University of Illinois at Chicago. The researchers also found that the other metabolic benefits of water fasts, such as lower blood pressure and cholesterol, seemed to disappear shortly after the fast.

#### The study was published in Nutrition Reviews.

According to Krista Varady, professor of kinesiology and nutrition and the study's lead author, there do not appear to be any significant negative effects for those who adhere to water fast or a similar fast in which they consume very few calories per day.

"My overall conclusion is that I guess

you could try it, but it just seems like a lot of work, and all those metabolic benefits disappear," Varady said. She stressed, however, that no one should undertake one of these fasts for more than five days without medical supervision.

Varady, an expert on intermittent fasting, said she wanted to study water-fasting because she suddenly started getting contacted by journalists last fall who wanted to hear what she thought about it. She figured if she was going to comment, she should investigate the existing research.

The new paper is a literature review of eight studies on water fasting or Buchinger fasting, a medically supervised fast that is popular in Europe where people consume only a tiny amount of juice and soup a day. Varady's team looked at the results from each of those papers to see what story they cumulatively tell about the fasts' impact on



weight loss, as well as a number of other metabolic factors

Only a few of the studies in the review tracked whether participants gained back the weight they had lost once the fast ended. In one of those, people gained back all they had lost in a five-day water fast within three

months. In two other studies, only a small amount of the lost weight returned, but those studies encouraged participants to restrict their calorie intake after the fasts ended.

In contrast, it was clear that the metabolic benefits of the fasts disappeared soon after the fasts ended. Improvements to blood pressure, cholesterol and blood sugar levels were short-lived, returning to baseline levels quickly after participants started eating again.

Some of the studies included participants with Type 1 and Type 2 diabetes, who suffered no ill effects from the fasting, though they were monitored closely and had their insulin doses adjusted while fasting.

The most common side effects of these prolonged fasts were similar to those from intermittent fasting, Varady said, such as headaches, insomnia and hunger. There were no serious negative effects in the studies, such as metabolic acidosis or death.

She did note that the participants in these prolonged fasts lost about two-thirds of their weight in lean mass and one-third in fat mass. This is the opposite of what happens most of the time during weight loss, where more fat is lost than muscle. It makes sense that these extreme fasts would have this result, she said, because "your body needs a constant intake of protein. If it doesn't have that, then it draws from muscles.' Varady's research into intermittent fasting has looked at how well the regime works for weight loss, as well as at specific questions, such as whether intermittent fasting affects fertility -- she found it does not.

Varady said she would encourage someone hoping to lose weight to try intermittent fasting instead of water fast, "because there's a lot more data to show it can help with weight management.

SHANGHAI, CHINA: Electric car giant Tesla is set to realise fully autonomous vehicles "later this year", CEO Elon Musk said Thursday, in the billionaire's latest forecast for the longanticipated milestone.

"In terms of where Tesla is at this stage, I think we are very close to achieving full self-driving without human supervision," Musk said via video link at the opening ceremony of an artificial intelligence conference in Shanghai.

"This is only speculation, but I think we'll achieve full self-driving, maybe what you would call four or five, I think later this year," the billionaire added, referring to two of the most advanced levels of autonomous driving technology.

The mercurial entrepreneur and Twitter owner admitted that he had been wrong in previous predictions on this timeline, but added: "I feel like we're closer to it than we ever have been.'

Musk has missed his own deadlines for a fully autonomous vehicle - and Tesla's driver-assistance technology has provoked regulatory probes in the United States.

Rahul Kumar, a volunteer who hails from Madhya Pradesh, expressed his enthusiasm for the work at the langar. "Our dedicated team has eagerly awaited the start of the Amarnath Yatra. Now, we are serving pilgrims day and night, pouring our hearts into this selfless service," he said.

Pilgrims have also expressed

# Israeli forces shell southern Lebanon border village after rocket lands near disputed territory

**Beirut:** Israeli forces shelled a southern Lebanese border village on Thursday after several explosions were heard in a disputed area where the borders of Syria, Lebanon and Israel meet.

Tensions continue to flare in the border area over two tents erected by the militant group Hezbollah and Israel's building of a wall around the Lebanese part of a village that Israeli troops captured during the 2006 Israel-Hezbollah war.

A Lebanese military official who spoke on the condition of anonymity because of not being cleared to provide information to journalists said one rocket was fired toward Israel from the border town of Kfar Chouba and that Israeli forces responded with two rocket

The Israeli military confirmed that it had shelled Kfar Chouba. It said later Thursday that it had identified the

incoming projectile as an anti-tank missile fired near the town of Ghajar with some fragments landing in Lebanon and others inside Israeli territory.

It was unclear who fired the rocket from Lebanon. The Lebanese army did not immediately comment on the explosions.

The UN peacekeeping mission in southern Lebanon, known as UNIFIL, said it could not verify that rocket fire caused the explosion but that the sounds were "consistent with a possible launch." UNIFIL sent peacekeepers to investigate what happened while the head of the mission speaks to both Lebanese and Israeli authorities to ease the situation.

"This incident comes at a sensitive time and in an area that has already experienced tensions earlier this week," UNIFIL said in a statement. "We urge everyone to exercise restraint and avoid any action that could cause further escalation."

Minutes after the explosions, Iran-backed Hezbollah issued a statement about Israel's wall in the village of Ghajar. The village is split into Lebanese and Israeli sides along a border known as the blue line that was demarcated after Israel's withdrawal from southern Lebanon in 2000.

"It is not just a routine breach of what the occupation forces are accustomed to from time to time," the statement said. It did comment on the explosions.

As part of the UN Security Council resolution that ended the 2006 war between Israel and Hezbollah, Israel is to withdraw from the northern part of Ghajar, which has not happened. UN peacekeeping forces in Lebanon have called on Israel for years to end its building work in northern Ghajar and to withdraw its troops.

Netherlands needed to chase down their victory target of 278 in 44 overs to not only win the game but also leap-frog Scotland into second place in the table on net run rate.

It was a feat they achieved in 42.5 overs to join Sri Lanka as the second qualifiers from the preliminary tournament.

Netherlands will appear at a fifth World Cup and their first since 2011. This year's global finals will be staged from Oct. 5-Nov. 19.

"We had a look at the targets, where we wanted to be at the halfway point," De



Leede said at the post-match presentation.

"The rate was 10 to 11 runs per over, so we had to go into T20 mode and try and score as many runs as we could and see where it would take us.

"It's amazing, I can't describe the feeling, it's going to be one big party tonight!"

Netherlands elected to field and restricted Scotland to 277 for nine in their 50 overs on a good batting wicket. In-form Brandon McMullen smashed

106 for the Scots, his second century of the qualifiers, while De Leede took 5-52.

The Dutch were up with the rate for most of their innings, knowing they had only 44 overs to achieve their target, and a burst from De Leede sealed the win to cap a fine individual performance.

# PSG Sign Skriniar, Asensio **On Free Transfers**

PARIS: Paris St Germain have signed defender Milan Skriniar and forward Marco Asensio on free transfers, the Ligue 1 champions announced on Thursday.

Slovakian Skriniar was signed on a five-year deal, with his Inter Milan contract having expired in June. Skriniar joined Inter from Sampdoria in 2017 and made nearly 250 appearances in Serie A, the Coppa Italia and the Italian Super Cup during his time at the club. He also has 60 caps for Slovakia.

The 28-year-old was linked with a move to PSG in January but the two clubs did not work out a deal before the transfer window closed. Inter had reportedly rejected bids of more than 50 million euros (\$54.32 million) for Skriniar last year. The centre back's final season in Italy was interrupted by injuries as he missed more than 20 games in all competitions, including the Champions League final when

Inter lost to Manchester City.

"There is always pressure when you join a club like Paris St Germain. I feel it a little bit," Skriniar told PSG's website. "But I feel that I am ready, ready to be part of this very big club. "I like pressure. I'm a defender so we know what it's like, you always have to be ready."

Former Real Madrid attacker Asensio was signed on a threeyear deal until 2026, PSG said. The Spaniard, who broke out under Zinedine Zidane in the 2016-17 season and scored in Real's 4-1 win against Juventus in that season's Champions League final, had gradually fallen out of favour at the LaLiga club over the last few years.

The 27-year-old made 51 appearances for Real across all competitions last season, scoring 12 goals, but was used mainly as a substitute. Skriniar and Asensio are PSG's first signings of the transfer window, announced a day after the club appointed Luis Enrique as manager to replace Christophe Galtier.

## Real Madrid Sign 18-Year Old **Turkish Midfielder Arda Guler**

MADRID: Real Madrid reached a deal to sign Arda Güler on Thursday, adding another young player to its midfield.

Dani Ceballos in the midfield. Ceballos also had his contract extended recently.

Mohammed Ashi's haute couture show -- his first as part of the official roster after years of dressing top celebrities -- is "the peak of my career," he told AFP at a cocktail soiree at the Ritz Hotel in Paris this week, part of a lavish Saudi PR campaign throughout this fashion season.

Mr Ashi forged his own path, having left the kingdom three decades ago, but his promotion to the top league is neatly timed as Riyadh announces its own fashion week in October and says new freedoms will create retail opportunities worth \$32 billion a year.

Fashion is just one strand of a strategy that has seen de facto ruler Crown Prince Mohammed Bin Salman divert its oil wealth into movies, sports, video games and tourism, while overseeing dramatic social changes within the kingdom.

Many worried it was all just a smokescreen to defuse criticism of his human rights record, especially after the gruesome murder of dissident journalist Jamal Khashoggi in the Saudi consulate in Istanbul in 2018. But the changes ran further and deeper than almost anyone expected.

"For the first two years, I almost didn't believe it was real, but then I realised, wow, it IS real," said Yousef Akbar, 37, who began his eponymous fashion label in Australia in 2017 and has dressed the likes of Nicole Kidman and Rita Ora.

"I really never thought when I was growing up that this would happen. When I started my brand in Australia, I thought my whole life would be there since I'm a fashion designer," added Mr Akbar, who now also runs his business from Jeddah.

# UK Woman Pilot Recreates Flight Of British Indian Spy Noor Inayat Khan

**London:** A female pilot from the UK has used her scholarship towards a special flying mission to recreate the deadly mission behind enemy lines undertaken by British Indian spy Noor Inayat Khan during the Second World War.

Fiona Smith, who won the British Women Pilots' Association (BWPA) scholarship in 2021 by inviting an aviation enthusiast to carry out a "special mission", decided to link this to the Special Operations Executive (SOE).

Noor Inayat Khan, a descendant of the 18th-century Mysore ruler Tipu Sultan, was an SOE agent who had been airdropped to a field in Nazi-occupied France to carry out covert intelligence.

"Located somewhere near the town of Angers, I was encouraged to discover there is a decently serviced airfield nearby, and a quick calculation suggested it was within reach of London within the day," shares Smith.

"My mission was clear: to fly from the south of England to Angers, lay a wreath for Noor, and fly back. As it happened, our actual flight coincided with the 80th year of her leaving England," she said of her recent flying mission.



Noor Inayat Khan was born in 1914 in Moscow to an American poet mother and an Indian Sufi teacher father.

When the Second World War began, Noor's family returned to England, and despite her Sufi and pacifist views, she went on to join the Women's Auxiliary Air Force in 1940 in her determination to fight fascism.

She was flown to France in a Lysander aircraft from a Royal Air Force (RAF) base to a field near Angers in June 1943, and 80 years later, she has inspired a female pilot to recreate that journey.

# Twitter Rival Threads Crosses 10 Million Users Within Hours Of Launch

**WASHINGTON:** More than 10 million people have signed up to Threads, Meta's rival to Twitter, within the first few hours of its launch, the Facebook parent's CEO Mark Tuckerberg said Thursday.

Threads is the biggest challenger yet to Elon Musk-owned
Twitter, which has seen a series
of potential competitors emerge
but not yet replace one of social
media's most iconic companies,
despite its epic struggles.

The app went live on Apple and Android app stores in 100 countries at 2300 GMT on Wednesday, and will run with no ads for now.

"10 million sign ups in seven hours," Zuckerberg wrote on his official Threads account Thursday.

Accounts were already active for celebrities such as Jennifer Lopez, Shakira and Hugh Jackman, as well as media outlets including The Washington Post and The Economist.

Zuckerberg spent the first few hours of the platform's launch replying to new users.

"One thing that's up is the number of world champion MMA fighters on Threads, especially now that you're here!" he wrote in a reply to American MMA fighter Jon Jones.

"Round one of this thing is getting off to a good start," he said in another.

Zuckerberg also offered a shot across the bow at Musk -- the pair

are known to be bitter rivals, and have even offered to meet each other in a fighting case to wrestle it out.

er in a fighting cage to wrestle it out. In his first tweet in over a decade, Zuckerberg posted a Spiderman pointing at Spiderman meme in an apparent reference to the

similarity of the two platforms.

Back on Threads, he wrote:
"It'll take some time, but I think there should be a public conversations app with 1 billion+people on it. Twitter has had the opportunity to do this but hasn't nailed it. Hopefully we will."

Twitter has said it has more than 200 million daily users.

#### 'Re kind'

Threads was introduced as a clear spin-off of Instagram, which offers a built-in audience of more than two billion users, thereby sparing the new platform the challenge of starting from scratch.

Zuckerberg is widely understood to be taking advantage of Musk's chaotic ownership of Twitter to push out the new product, which Meta hopes will become the go-to communication channel for celebrities, companies and politicians.

"It's as simple as that: if an Instagram user with a large number of followers such as Kardashian or a Bieber or a Messi begins posting on Threads regularly, a new platform could quickly thrive," strategic financial analyst Brian Wieser said on Substack.
