# Himalayan Brown Bear Roams Kashmir Villages As Habitats Shrink

**Srinagar:** Highlighting the escalating conflict between humans and wildlife, the Jammu and Kashmir Wildlife Department in an incident in May successfully captured a Himalayan brown bear in a village in North Kashmir. The bear's behavior had become increasingly weird as the beast raided graveyards possibly in search of human carcasses and venturing into residential areas of Handwara, posing a threat to lives and livestock.

feared the presence of multiple bears in search of food. To protect the graveyards, villagers took turns to stand guard, but the situation remained challenging. Experts believe that the unusual behavior of the bears can be attributed to insufficient food in their natural habitat. Wildlife Warden, north Kashmir Mohammad Maqbool Baba told Kashmir Observer that brown bears venture into human habitations in search of food and their presence, at times, prove lethal.

Baba also said that growing urbanization and transformation of forest areas into tourist places besides using agricultural land for residential purposes are the primary causes of wild bears venturing into human habitations, resulting in encounters.

was created in the "Big Bang" from pure energy, and is now composed of about 5 per cent ordinary matter, 27 per cent dark matter, and 68 per cent dark energy.

However, the discovery of evidence of 'early' galaxies in advanced stages of cosmological evolution by NASA's James Webb Space Telescope and the existence of stars like the Methuselah, one of the oldest stars known, has puzzled many scientists.

These 'early' galaxies, whilst surprisingly small in size and said to exist a mere 300 million years or so after the Big Bang, have been observed to possess a level of maturity and mass typically associated with billions of years of cosmic evolution, which the researchers of this study say is insufficiently explained by the standard model.

# **Imran Khan Reveals Plan If His Political Party Gets Banned In Pakistan**

ISLAMABAD: Pakistan Tehreeke-Insaf (PTI) chief Imran Khan has said in the event that his party is banned, he will float a new political party to contest the upcoming general elec-tions and will win the elections, Dawn reported citing Nikkei Asia.



In the wake of the violent nationwide protests on May 9 and the subsequent clampdown on the protesters and the Pakistan Tehreek-e-Insaf, many government figures had called for a ban on the party.

Pakistan Interior Minister Rana Sanaullah had said ban-

ning the Pakistan Tehreek-e-Insaf was the only solution. Defence Minister Khawaja Asif said a move to that effect was being considered and Pakistan Peoples Party (PPP) chairman and Foreign Minister Bilawal Bhutto Zardari had also said his party will not resist any move to impose a ban on the

Pakistan Tehreek-e-Insaf. Questioned on the impact of a possible ban on his electoral future by Nikkei Asia, Imran Khan said, "If they remove the party then we will form a party with a new name and still win the elections."

Imran Khan was quoted say-ing that "even if they disqualify me and throw me in jail, the party will still win".

The Pakistan Tehreek-e-Insaf chief emphasised to the outlet that his base of supporters "remains intact", claiming that the national politics had "fundamentally changed".

On the continued crackdown on his party, Imran Khan said the government was "still trying to break it through intimidation".

## Laws Of Preventive **Detention Must Be Strictly Applied: Supreme Court**

NEW DELHI: Laws on preventive detention are necessarily harsh and curtail the personal liberty of an individual who is kept behind bars without trial, and so the procedure prescribed should be strictly adhered to, the Supreme Court has said while ordering the release of a man whose detention was extended twice without the authorities considering his representation

A bench of Justices Aniruddha Bose and Sudhanshu Dhulia set aside an order of the Jharkhand High Court upholding the detention of Prakash Chandra Yadav alias Mungeri Yadav, who was declared an 'anti-social element' under the Jharkhand Control of Crimes Act, 2002.

The bench, in its order dated Iuly 10, held the procedure of law was not followed, and ordered Yadav's release from Rajmahal prison in Jharkhand's Sahibganj district.

"All laws on pro



The bench said the extended period of detention of the appellant beyond the period of three months was unauthorised and illegal.

"The orders dated November 7, 2022 and February 7, 2023 which extended the detention period are hereby quashed. The orders of the Division Bench of Jharkhand High Court dated March 2, 2023 and November 2, 2022 of the Single Judge... are also set aside," it said.

The top court agreed with the submission of Jharkhand's Additional Advocate General Arunabh Chowdhury that there were no grounds for challenging the initial detention order dated August 8, 2022 and said Yaday has only challenged the subsequent orders which extended the period of detention. These orders were dated November 7, 2022 and February 7, 2023 which extended Mr Yadav's detention by three and six months respectively. Yaday was served with a copy of the initial detention order dated August 8, 2022 passed by the district magistrate of Sahebganj when he was in judicial custody in Rajmahal prison. The order mentioned the grounds for detaining Yadav and gave the details of 18 pending cases against him which ranged from causing simple hurt to extortion and murder.

## **Non-Codified Muslim Personal Law Poses Challenges For Women: Panel**

**NEW DELHI:** The non-codified nature of Muslim personal law has led to misinterpretation and posed significant challenges for Muslim women, the National Commission for Women (NCW) said during a deliberation on Saturday. The NCW held the delib-

eration to discuss the rights of Muslim women, with a specific focus on reviewing Muslim Personal Law.

The consultation took place against the backdrop of the Law Commission's recent call to seek responses from various organisations and the public regarding the implementation of the Uniform Civil Code (UCC).

The chairperson of the NCW, in a statement, underscored the urgency of codified laws and questioned if a law that fails to protect the rights of Hindu, Christian, Sikh, and Buddhist women can truly be considered only for Muslim women.

The need for codified laws was deemed crucial, with a strong call to work towards a legal framework that guarantees equal rights for all, regardless of their religious affiliation, the statement added.

"The discussion also emphasised that the absence of a Uniform Civil Code has perpetuated inequalities and incon-

sistencies in our diverse nation, hindering progress towards social harmony, economic growth, and gender justice," the NCW said in a statement.

The deliberation saw the participation of key stakeholders, including the Attorney General of India, the Additional Solicitor General from the Supreme Court, representatives from high courts, Vice Chancellors of law universities, legal luminaries, and civil society organisations.

During the deliberation, R Venkataramani, the Attorney General of India, emphasised the need for reforming and strengthening the institution of marriage.

He stressed the importance of equal regard and status for men and women, along with ensuring equality in processes that uphold the dignity of individuals entering and exiting marital relationships, irrespective of their religion.

Other important points discussed during the deliberation included the need to reform the divorce process, transforming it into a judicial process with exceptions for divorce by mutual consent.

Furthermore, the participants emphasised the need to reform inheritance rights based on universal principles governing succession, both testamentary and intestate.

# **Architect Jailed For Using Dead Man's Fingerprint On Forged Documents**

**NEW DELHI:** A Delhi court has awarded jail term to an architect and his associate for using the thumb impression of a dead person and forging the signature of sub-divisional magistrate (headquarters) to get water harvesting certificate for a building, whose plan was already sanctioned by the DDA in 2010.

Special Judge Sanjeev Kumar Malhotra sent architect Charan Singh Solanki and his associate Parmod Garg to jail for two years, while refusing to release him on probation, saying that being an architect he had greater responsibility while attesting signatures and thumb impressions and issuing certificates as per law. The judge noted Solanki was already facing jail in another case.

"Convict Charan Singh Solanki, being an architect, was having more responsibility to attest signature/thumb impressions and to issue certificates as per rules/law. After considering the rival submissions and role of convict Charan Singh Solanki, I am not inclined to grant the benefit of probation to him," the judge said in an order passed on July 12.

The prosecution had opposed the argument for leniency, saying such forgery affects the "conscience of the society".

According to the prosecution, Solanki was working as an architect, whose report was accepted by the DDA for the purpose of sanctioning a buildng plan.

He had given a water harvesting certificate which carried the forged thumb impression of the original allottee. He had also annexed a copy of a letter for extension of time, which had not been issued by the DDA, the prosecution said.

# **Azam Khan Gets Two-Year Jail In Case Of Hate Speech**

n MP/MLA court here on A Saturday sentenced senior Samajwadi Party leader Azam Khan to two years imprisonment in a case of provocative speech during the 2019 general elections.



Judge Shobhit Bansal convicted Khan and sentenced him to two years imprisonment. He also imposed a fine of Rs. 2500 on the former Uttar Pradesh minister.

The case was registered against Khan during the 2019 Lok Sabha general election for allegedly making a provocative speech during a rally in the Dhamora area on April 8 that year.

An MP-MLA court here had last year convicted Khan in another 2019 hate speech case which was registered after he addressed a public meeting in Khatanagaria village of the Milak Kotwali area.

He was sentenced to three years of imprisonment, following which he was disqualified from the UP assembly.

In May this year, a sessions court overturned the verdict of the lower court.

SRINAGAR: Looking at Azizur Rehman's tools, one can be forgiven for mistaking him for an exorcist. Rehman, however, does not deal with the occult. He is an artist who makes art from waste material, including animal bones.

The Jammu and Kashmir Handicrafts Department discovered Rehman -- the only bone artist of the Union Territory -- during a kisan mela.

"We met him at a kisan mela. He approached the department and wanted to exhibit his art work ... we gladly accepted his offer and provided him the space," Handicrafts Director Mahmood Shah told PTI at the exhibition organised for Rehman's art under the 'Know Your Artist' programme.

Faizan Zahoor, a visitor, said he was left speechless by Rehman's art.

"I can't say in words what I feel right now because it's absolutely mindblowing, creative and innovative. I liked this and art is something that purifies your soul and keeps (you) away from depression...," Zahoor said.

Talking about the programme, Shah said this space is being promoted as a craft space so that talented youth can showcase their talent.

"Today is the eighth exhibition and every time we try to give a platform to a new artist ... we want people from different art forms, experimenting with their crafts, to come here and showcase their art through this platform. Therefore, I, District Magistrate, Srinagar, by virtue of the powers vested in me u/s 144 CrPC direct that no gathering of 4 or more persons shall be allowed in the premises of District Court Complex Batamaloo or any other place for the purpose of conduct of elections till further orders," reads the order.

It reads that SSP Srinagar has reported that during the meet-ing held on 13-07-2023 by Kashmir Advocates Association(KAA) at Court Complex Srinagar,

members of another association under the nomenclature of JKH-CBA entered into the Bar room and started shouting upon the members of KAA which led to scuffle between the two groups. "Senior Superintendent of Police, Srinagar has highlighted that there is every possibility of internal rivalries between the two

# **PDP Activists Detained As Police Scuttle Protest Rally In Jammu**

eminism is a concept that encompasses both an "ideology and a movement for socio-political change based on a critical analysis of male privilege and women's subordination within any given society (or religion)". Applied to Islam, this ideology and movement makes for Islamic feminism that revolves around Muslim women's issues and critiques Muslim men's privilege while questioning the power dynamic between the two sexes within Islam with an aim to bring socio-political change among both the sexes using Islamic concepts and Islamic language. In its attempts to bring this change, it does not question the language or the concepts that supposedly privilege men over women but questions the way in which they have been leveraged to privilege men. It works with the same language and the same concepts but views with a different perspective to reach different conclusions that turn out to be better for women also. This is not questioning Islam itself but making Islam dynamic by exposing it to diverse perspectives. It is about exploring the full potential of Islam with regards to the existing power difference among the two sexes so that the power difference is minimum.

The question of exploring full potential arises because it is assumed that Muslim men are privileged because they interpreted the Quran and other sources of law from their own perspective, excluding women from the interpretations. Since Quran is one of the most basic sources of laws in Islam, it is a genuine concern that most traditional tafasir (exegesis) were exclusively written by men and as one of the Islamic feminists Amina Wadud claims, "men and men's experiences were included and women and women's experiences were either excluded or interpreted through the male vision, perspective, desire, or needs of woman". Further, Wadud says that the problem has been exacerbated because women's "voicelessness during critical periods of development in Quranic interpretation has not gone unnoticed, but it has been mistakenly equated with voicelessness in the text itself."

If we look into the existing interpretations of Quran using the theory of New Historicism, we find that the interpretation was influenced by the inherent biases -- "the attitudes or stereotypes that affect our understanding, actions, and decisions in an unconscious manner"-- of the interpreter and the specific context and the time in which that interpretation occurred. Writing about New Historicism, Lois Tyson argues that "the questions asked by traditional historians and by new historicists are quite different...tradi-

tional historians ask, 'What happened?' and 'What does the event tell us about history?' In contrast, new historicists ask, 'How has the event been interpreted?' and 'What do the interpretations tell us about the interpreters?"". Same can be said about the interpreters of the Quran. They might have started with an aim to interpret the Quran objectively to understand what it says, but when the interpreter is interpreted, it is observed that their interpretation was influenced by various factors. When the sex of the interpreter, the roles of the two sexes in his culture, the society of the interpreter and other aspects that could influence the interpretation are factored in, the interpretation be-comes subjective. Thus, "no method of Quranic exegesis is fully objective" because "each exegete makes some subjective choices" and "some details of their interpretations reflect their subjective choices and not necessarily the intent of the text". The interpretation thus does not become a fact but an opinion. Besides focusing on the gender of the interpreter, Islamic feminists also keep into consideration the power dynamics between the two genders during that time of interpretation. While arguing for the historicization of different verses of the Quran they do not give an exact historical background for the cited verses because of the difficulties that arise in looking into the historical background of verses as they are not generally historicized. Since the verses themselves do not have apparent contexts, they only analyse verses from different perspectives and question why those verses were interpreted only in one particular manner even though there could have been other alternative explanations Different explanations are based on

Different explanations are based on the fact that the Quran was revealed in seventh century Arabia and since it is considered as moral guidance by Muslims "it must relate to the perceptions of morality—no matter how genderspecified—which are held by individuals in various societies". Since the Quran was revealed at a time when the

misconceptions about women and were involved in certain specific lewd practices against them", this has resulted in "some injunctions specific to that culture". Even some prevailing practices in Arabia of that time were so bad they had to be "prohibited explicitly and immediately: infanticide, sexual abuse of slave girls, denial of inheritance to women, zihar, to name a few of the most common". In addition, there might be certain practices "encouraged by the Quran (that) may be restricted to that society which practised them, but the Quran is 'not confined to, or exhausted by, (one) society and its history...." . Therefore, while recognizing that the practises prescribed by the Quran are necessarily to be followed by Muslims but at the same time acknowledging that those practices cannot be replicated across all cultures at all times in the exact manner; there is a way out from being bound by those exact practices by going into the principles or the morals that are conveyed by the practices. Then it is those principles that are extracted that become eternal so that they can be applied to various social contexts. Though the principles or morals that can be extracted from the

different verses of the Quran would be subjective, and there would be further questions that it would attract but extracting these principles can be made less difficult by incorporating different perspectives of both the genders on the verses.

This would make the interpretation inclusive and a somewhat middle ground could be reached from which everyone would emerge better off. Further, this "movement from principles to particulars can only be done by the members of whatever particular context a principle is to be applied and "therefore, interpretation of the Quran can never be final". Hence, it is necessary to reinterpret the Quran again and again in the context of different times and different cultures.

Mohammad Iqbal once claimed that Islam provides for the greatest freedom with the caveats of Tawhid (the unity of God) and the lastness of the prophet. He was hopeful that Islam will not only face up to modernity but address various challenges of modernity. But the movement that Iqbal desired to see in Islam can be achieved only if Islam is taken to extremes and its full potential is realised. One way to achieve this potential is by including women in the institutions of interpretation and lawmaking in Islam. This would ensure that their views, which might differ from men, are also applied in order to realise the full potential of the Quran so that everyone benefits. It is this movement inside Islam that asks for the inclusion of women in the processes of interpretation and other lawmaking that can be termed as Islamic feminism. It arises within Islam itself and stays within Islam, using Islamic concepts and Islamic language to bring socio-political change by questioning the status quo of interpretation. Seen from a different perspective this is not a movement that seeks to advance only Muslim women's issues, it is one that seeks to advance the position of Islam so that the full potential of Islam is realised, and every follower of Islam feels content with Islam. Therefore, Islamic feminism exists, and it is distinguished from other feminisms from the fact that it uses Islamic language, Islamic concepts, and the sources of Islam from where laws and rules are derived to advance the position of women.

# Monsoon Havoc In India: How Floods Can Be A Valuable Resource

his year the monsoon began unusually. After 61 years, it arrived in Mumbai and New Delhi on the same day — June 24. The monsoon's onset in these cities is generally around June 10 and June 30, respectively. Immediately after its arrival, many places across India received heavy to very heavy rainfall. It is unusual to see flooded rivers and cities in June/early July since most of the flooding usually occurs in the later months of the monsoon.

Studies and expert appraisals have concluded that citizens, properties, and infrastructure in India cannot be provided with complete flood protection. Hence, we need to shift attention and efforts from flood control to flood management. But the hydro-infrastructure for river regulation in India is inadequate for effective flood management.

About five months after the end of the flood season in October, many parts of the country begin to face scorching summers and droughts. Currently, we see flood flows as a nuisance, to be passed on to the ocean at the earliest. If a large part of the flood flows can be safely conserved, damages would reduce. The saved water would help partially mitigate the upcoming droughts. Storage to manage river flow variability and mitigate droughts is an attractive opportunity for India.

In recent times, India has faced at least one major flood event each year. As the 2023 monsoon progresses, floods are beginning to repeat the pattern of damage and destruction. Every year 1,600 lives on average are lost due to floods, according to the National Disaster Management Authority. Floods also affect 75 lakh hectares of land and inflict damage worth Rs 1,805 crore to crops, houses and public utilities.

A range of tools are available to manage floods. Broadly, these are classified as structural and nonstructural. Structural measures include storage reservoirs, embankments, and diversions. These reduce flood hazards by keeping damage-causing waters away from agricultural areas, cities, industries, etc.



Storage reservoirs moderate the flood peak by storing water during high-flow periods and releasing it after they have subsided. They also conserve water for irrigation, electricity generation, water supply, etc. Their effectiveness in flood moderation depends on the space available. In addition, tanks and ponds are traditional means of water conservation in India. They also aid in groundwater recharge and promote biodiversity.

Non-structural methods such as flood forecasting, warnings, and flood plain zoning, help in the timely evacuation of people and regulate the use of floodplains. Note that floods are a hazard only when people go close to flood waters or hinder their movement.

A forecasting and warning system provides a priori estimate of approaching floods so that people and movable assets are relocated to safer places in time. India has more than 5,500 large dams. Accurate inflow forecasts help moderate floods by estimating the space needed for storage in reservoirs. A common saying goes: "Floods are acts of God but flood losses are largely acts of man".

Non-structural methods don't involve construction and hence don't create an adverse impact on the environment or otherwise. However, the resource (water) is neither conserved nor put to alternate use. Large and medium water conservancy projects can save huge quantities of damage-causing water. So, to manage increasing variabilities, existing infrastructure should be upgraded or new infrastructure created.

In India, most of the water comes from the Indus, Ganga, Brahmaputra, Godavari, Krishna, Cauvery, Mahanadi, Narmada and Tapi river basins. The monsoon's presence makes Indian rivers highly seasonal. During the four months of monsoon, Indian rivers carry about 75 per cent of their annual flows. Of this, about 15-20 per cent occurs in shorter, very high-flow periods. Flood flows are the flows present in a river for a short period that have huge volumes. Basins such as Ganga, Brahmaputra, Godavari, and Mahanadi have large flood flows. Although some part is currently conserved, unutilised flood flows are more than 100 (cubic kilometres) BCM. Storage space created in major river basins, such as the Ganga and the Brahmaputra, is inadequate for the available flows.

Options for water conservation vary in size from large storage to farm ponds. The impact also varies — local in scale to a large region. Each option will have some advantages, limitations, concerns and requirements. It is not wise to outright reject any option. Of course, it will be a challenge to find good sites to conserve water and build consensus.

Climate change will add a new dimension to flood management — rainfall patterns, intensities, and durations are likely to change. Recently IPCC released Assessment Report 6 where they noted that intense rains are likely to become more common in this warming world. Therefore, flows in Indian rivers and their variabilities will increase in the future. This will lead to more instances of floods and droughts. It is prudent we upgrade the hydro-infrastructure in the country now so that the tools to manage increased variabilities are available in time.

The entire suite of measures — structural and non-structural, appropriate mix of grey, blue and green infrastructure — needs to be considered for flood management. Mindsets need changing — flood flows should be seen as a resource to be conserved for subsequent use and water security. A river basin approach should be adopted for flood management while taking care of the environment.

A study completed in the US evaluated the performance of 383 flood control reservoirs and 8,500 miles of levees. They found that for every dollar spent on flood control, potential flood damages equivalent to \$6 were averted in the past six decades up to the year 2000. Similar benefits can be harnessed if India implements a comprehensive flood management programme.

# Nietzsche's Critique Of "Resentment" And Our Religious Moralising

Religious discourse and religious life can be positively enriched by significant external critiques from various sides/angles. Whilst participating within a religious cosmos, one may – over time – lose sight of a few things that occasionally some good external critics may point out or refocus our attention towards them. Let us, very briefly, rehearse Nietzsche's critique of "resentment" to refocus the psychological dimension of our religious lives to rejuvenate its inner integrity.

To start with, we may note that many religious people tend to forget one critically crucial point & that is religion (or for that matter any "body of thought") as "content" is one thing and the religious "subject" trying to appropriate that content is something else. Though, most of the religious intellectual thought & spirituality together aim at bridging that very gap by engineering a specific subjectivity wherein "thought" intersects with "being" (i.e. intersection of ilm & amal) but nevertheless, in the initial stages (at the very least), the distinction between "subject" & its absorption of "content" remains alive. Now, why did we turn our attention to this distinction at the start? The point that we are trying to make is that religion or any "content" for that matter may be perfect in and of itself but individual person as a "subject" is not.

The whole discourse on "niyyah"/intention & "nifaq"/hypocrisy within Islamic tradition is a case example. One may offer "salah" in the most perfect form i.e. fulfil the "content" part fully but if one does it to merely show off then the whole act becomes a meaningless mechanical exercise owing to the inauthenticty of the subject; here, the inner "subject" intervenes between "content" and its harmonious/ smooth/sincere application/absorption which aims at the transformation of the subject itself. In the case of show off, subject transforms the "content" for its own projection rather than allowing the (divine) "content" to completely transform and re-orient its own subjectivity. Thus, human being as a subject is the central node within religious dynamics, which we often tend to forget.

Now, where does Nietzsche come in all this? The point is that our psycho-spiritual quality of life is damaged by what Nietzsche calls "resentment". We are referring to Nietzsche here – even though such formulations may be found both inside and outside of the religious discourse – for the reason that in Nietzsche it receives a particularly potent psychoanalytic precision which is pregnant with transforma-tive potential, if properly internalized. Now, the first thing that we should begin with is by noting the fact that most of the moralizing, downplaying & ridiculing that takes place particularly from religious point of view, Nietzsche would say, has its roots in "resentment" (or at least the possibility is always there) i.e. since I am not out there in the world, active & highlighted, whereas others (mostly "irreligious" folk) are, but I still wish to subdue them (because for Nietzsche this inner will/ desire to dominate is one of the essential drives within human psyche & thus inevitable); therefore, what I do is that I invent

a psychological trick by positing that so & so is useless because this whole active posture in life is useless – it is nothing but mere love of "duniya", it is insincerity, so & so is arrogant, they are "evil", so on and so forth.

This applies to resentment per se and not just religious moralizing. Resentment is part of human reality & thus manifests within both religious and secular settings. Since Nietzsche primarily targeted religious moralizing that is why this article primarily focuses on that. But it takes on various shapes and forms. A person, for example, who is not active in the world whilst seeing others at the front or lags behind others in one thing or the other, if finds himself developing an allergic hateful reaction towards them, should immediately become cognizant of the inner resentment which might be taking the outer garb of ostensible criticism of the so-called flaws and faults of so & so just to subdue them psychologically.

Irrespective of the inner motivations of "others" & irrespective of the question whether love of "duniya" is evil or not (i.e. the "content" in and of itself is s separate matter, which in this case is the correct statement within Islamic tradition) but all of that is of no concern to me as a subject. What is of concern to me here is the fact that how am I appropriating that content as a subject? In the case of inner resentment, as explained above, I am only using religious morality to satisfy my own inner resentment. I might be quoting the right "content" which might be correct in and of itself but since I am a "subject", I do not invoke any content as an empty vessel but

rather the content passes through a particular mode of being. Nietzsche's question for the one who moralizes, judges and scolds others would be that whether the person is doing it objectively or is it a mere epiphenomenon of one's own inner hidden hate, jealousy, arrogance & resentment.

Nietzsche thinks that most of the moralizing that takes place has nothing to do with the pursuit of Truth but rather it is merely symptomatic of inner hidden resentments against this & that. When we moralize, the question that we should ask ourselves is that, are we sure within ourselves that we are acting as mere "channels" of God's message or is it the case that our own inner hatreds or arrogance or jealousies or superiority complex or resentments are merely putting on a religious garb. Whether it be our religious clerics sermonizing people on pulpits or our youth fighting tooth & nail on religious disputes, Nietzsche's warning of "resentment" is an eternal reminder.

It is for this reason that Islamic tradition organically developed its own science of the soul in the form of diverse schools of tassawuf to avoid "resentful" religiosity. Why is this all important? We may provide two main reasons: a) firstly, the whole function of "religion" amounts to human transformation which creates a particular mode of being that enables one to get through this world in the most beautiful way, given all the vagaries of life, i.e. it teaches life of "ihsan" so that one is prepared for one's eschatological station. Resentment damages this mode of being and liquidates the whole transformative potential & objective of religion. And secondly b) this lesson is of the utmost importance for our psychological wellbeing which is most definitive of one's quality of life i.e. inner resentment, contradiction & hypocrisy tortures the soul from within whereas organic mode of being which amounts to living as "one" inside out creates joyous mode of being.

Whether it be infighting within masjid committees or patronising advice that people throw at each other on social media platforms, the debates and fights within offices or schools, neighbourhoods or friend circles, all the rebukes given for one reason or another; all of these call for attention. Nietzsche would invite us to properly see whether the reasons we give to ourselves as to why I rebuked so and so, why I fought with so and so, why I hate so and so, why I looked down upon so & soare really the true reasons behind these actions i.e. the "apparent" reasons we give to ourselves like: "this is for truth", "I am giving God's message", "I am trying to help them", "I am just conveying truth", etc or the actual truth is that there are deeper resentments/jealousies/hatreds which are beneath these cooked up reasons and thus form the real genesis of all these fights. This self introspection, if done with sincerity, will eventually help individuals arrive at a certain mode of being where the previous "cooked up" reasons might in truth become the actual reasons for one's actions, stemming from within.

# **Raising a Champion** Father Recounts Son's Journey To IIT Kharagpur

ehran coincidentally shares his birthday with Neil Armstrong, **IVI** the American astronaut and aeronautical engineer. However, Mehran's birth in the strife-torn region of Kashmir presents significant challenges to living a normal life. In 2006, the year Mehran was born, Kashmir experienced one of its bloodiest periods in history including the tragic incident of 35 Hindus being killed by unidentified gunmen in the Doda district. This further accentuated the obstacles Mehran had to overcome in his pursuit of excellence. As a father, his last resort to secure an honourable personal escape from such a quagmire was to educate his children in the most exemplary manner. However, amidst an extremist environment nurtured by the vested interests, the challenge to protect the children's future was remarkably daunting. As an educator, I knew how crucial the formative years were in determining a child's future, especially when young children were targeted by "hawks" during this precarious age. In a poignant tale, a school principal found himself facing a heart-wrenching situation when his son, who was pursuing a B.Tech course, abruptly dropped off-grid one day. Much to their dismay,



him in a reasoned manner, which helped calm him down. I explained that there is an appropriate time to explore such complex topics, just as the Prophet of Islam declared his prophethood when he turned forty. However, I didn't stop there. The fol-

However, I didn't stop there. The following day, I visited Mehran's school and requested his discharge certificate, determined to find him a new school.

The school administration was perplexed because Mehran was an excelprofessional path and field of study, with a strong desire to secure a place at an IIT due to his early focus on Physics.

As the Covid-19 pandemic swept the world, Mehran had just finished his higher secondary exams. While everything was shutting down, Mehran's self-study journey was just beginning. He saw the pandemic as an opportunity to create his own world with minimal external influences and distractions. dedicating long



the son resurfaced as a militant and tragically met his demise soon after picking up gun. In a state of profound shock, the father took to Facebook to reveal how his beloved child had fallen victim to the exploitative clutches of "vested interests."

"Eisa your innocence is being exploited by some vested interests you are being used as a pawn or a poster boy," his father, Naeem Fazili, wrote on his Facebook page.

Unfortunately, Fazili's desperate appeals failed to reach his son, who continued to "play with fire", ultimately leading to his tragic demise.

Eisa Fazili's prospects for the future were tragically sacrificed on the altar of the Kashmir conflict, where vested interests fuelled extremism and lured countless young individuals into an inescapable cycle of violence. This situation finds resonance in the plight of Abhimanyu, a character from the Mahabharata, who entered the intricate Chakravyuha (a complex and impenetrable formation of defensive walls) but was unable to find a way out.

Mehran, from an early age, developed a keen interest in folklore from different faiths and cultures. I would often read heroic tales from Arabian Nights, Mahabharata, Panchatantra, and other fictional works as his bedtime stories. These stories might have instilled in him a sense of heroism and helped shape his formative years. One particular anecdote from the

Mahabharata stood out to Mehran. It recounted the story of Arjuna, the most accomplished student of Dronacharya, who displayed unwavering focus by shooting the eye of a toy bird perched on a tree with a bow and arrow.

With similar determination, Mehran embarked on his educational journey, attending local schools with the sole aim of studying Physics at an IIT. Eventually, he achieved an exceptional all-India rank of 5891 in the JEE Advanced Test, earning him admission to the prestigious IIT Kharagpur last year.

As a father who valued science, I understood that for Mehran to succeed in life, he needed to dedicate himself to his studies in a focused manner and avoid distractions that could hinder his progress toward a professional career.

Mehran initially attended an all-boys school near our home, where a strong emphasis was placed on learning about Islam. However, I noticed some peculiar behaviours in him, such as his refusal to shake hands with girls and his preference for wearing a skullcap, which I personally disliked.

I often wondered why the school placed such a significant emphasis on religion. Mehran was required to study additional subjects, including Arabic. Despite my trust in the school management, I realized I had made a grave mistake in choosing that school for Mehran. It wasn't because I couldn't answer his questions about topics like the Taliban and ISIS or that they were irrelevant, but rather because these discussions were entirely inappropriate for Mehran at his young age, with potentially far-reaching effects.

Instead of stifling Mehran's curiosity or discouraging his questions, I responded to

lent student loved by his teachers. They couldn't understand why I wanted to remove him from the school. I explained, "I am not comfortable with how you teach religion to young children." After a brief argument, I obtained the discharge certificate.

Mehran's new school wasn't fundamentally different, but being co-ed brought certain advantages, such as the disappearance of the skullcap. I had no issues with the more moderate teaching hours to studying late into the night.

Mehran's perseverance and hard work paid off when he qualified for the JEE MAIN test. He improved his percentile from 99.24 to 99.44, qualifying for the advanced test. A month later, he cracked the JEE Advanced, securing a national rank of 5891 and earning a place at the prestigious IIT Kharagpur.

The environment in which Mehran was raised played a crucial role in his success, although he deserves all the



of Islam at this school. Mehran found the new school more interesting because it supported and encouraged music programs, art, and painting.

One day, Mehran expressed his desire for a guitar. As a father who had also wanted one during his own childhood but couldn't have it, I immediately decided to buy him one. He quickly learned how to play the instrument using online tutorials and discovered that it was a wonderful stress reliever, especially during the Covid-19 pandemic when the world was in lockdown.

By the time Mehran completed his grade-10 board examination, he had transformed into a tall and happy young man ready to face life's challenges head-on. He had already made up his mind about his credit for his unwavering perseverance and hard work. Believing in internalizing discipline rather than imposing it, I granted Mehran a great deal of freedom without rigid supervision, and he thankfully embraced it without misusing it.

#### EMBRACE PORTFOLIO CAREER ADVANTAGES

I'm a Gen Xer, but for most of my career, I moved jobs every 18 months. I call it a "portfolio career," working a variety of roles and industries.

My father's generation thought this was crazy-he had stayed in his Defense Department job for 30 years—but they also moved him to a new challenge every two years. Most companies now make you do the work of managing your career advancement.

I found that jumping around the corporate world was the best way to keep learning and growing, the fastest way to get promoted, and the only way to get a salary bump. So I jumped to get bumped. What kept me happy was an empowering boss, a collaborative team, and challenging projects.

Millennials average 2.75 years in a job. As a sustainability career coach and ESG recruiter, I like to see at least three years on the resume. This is because it can take a year to get settled, a year to build your internal reputation and influence, and a year to create a measurable impact.

Ultimately, there isn't a specific timeframe that applies universally. It's a personal decision based on individual circumstances. It's advisable to periodically reassess your situation. set career goals. and evaluate if your current job aligns with those goals.

I have stayed at one job for 14 years and another for 14 months. Wherever I've worked. I evaluated whether I should stav or leave based on these four Fs: Fit, Function, Finance, and Forward.

Fit is how well you align with the organization's culture, mission, and vision. Function is about how much you enjoy the work you do each day. Finance is how much you are compensated, and Forward is how strongly your path within that organization sets you up for learning new skills and advancing within the company.

I know from my experience and my clients that when one of the Fs is off, it's not a dealbreaker. But when two or more Fs aren't aligning for you, it's an excellent opportunity to question why you are staying at that job and whether or not it's time to make a change.

#### CONSIDER A THREE- TO FIVE-YEAR TENURE

A mentor told me early on in my career to stay in a position for a minimum of three years, but not more than five if I haven't gotten a raise.

# Tomato Prices Ruling Up To Rs 250/Kg

Centre Selling At Rs 90/kg in Delhi-NCR, Patna, Lucknow

**NEW DELHI:** Prices of tomato in retail markets on Saturday remained at an elevated level of up to Rs 250 per kilogramme across major cities due to monsoon rains and lean season. The all-India average price

stood at nearly Rs 117 per kg, according to government data. To provide relief to retail

consumers, the Centre is selling tomato at a discounted Rs 90 per kg in select cities like Delhi-NCR, Patna and Lucknow.

National Cooperative Consumers' Federation of India (NCCF) and National Agricultural Cooperative Marketing Federation of India (NAFED) are selling tomato on behalf of the Centre through mobile vans.

"In addition to various parts of Delhi and Noida, sale of tomatoes at discounted rates started today at Lucknow, Patna and Muzaffarpur," Union Consumer Affairs Secretary Rohit Kumar Singh tweeted. From Sunday onwards,

NCCF plans to sell tomatoes through 100-odd Kendriya Bhandar outlets in the national capital. It is in talks with Mother Dairy to sell tomatoes through their 400 Safal retail outlets in Delhi-NCR.

As per the data compiled by the Department of Consumer Affairs, the average all-India retail price of tomatoes was ruling at Rs 116.86 per kg on Saturday, while the maximum rate was Rs 250 per kg and the minimum was Rs 25 per kg. Modal price of tomatoes is Rs 100 per kg.

Among metros, tomatoes were ruling at Rs 178 per kg in Delhi, followed by Rs 150 per kg in Mumbai, and Rs 132 per kg in Chennai.

The maximum price of Rs 250 per kg was in Hapur. Tomato prices normally

shoot up during July-August and October-November periods, which are generally lean production months.

Supply disruption caused due to monsoon has led to a sharp rise in the rates.

# India's Forex Reserves Rise USD 1.23 Billion To USD 596.28 billion

**MUMBAI:** India's foreign exchange reserves jumped USD 1.229 billion to USD 596.28 billion in the week ended July 7, the Reserve Bank of India said on Friday.

In the previous reporting week, the overall forex reserves increased USD 1.85 billion to USD 595.05 billion.

In October 2021, the country's forex kitty had reached an all-time high of USD 645 billion. The reserves have been declining as the central bank deploys the kitty to defend the rupee amid pressures caused majorly by global developments.

For the week ended July 7, the foreign currency assets, a major component of the reserves, increased USD 989 million to USD 528.968 billion, according to the Weekly Statistical Supplement released by the RBI.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves were up USD 228 million to USD 44.06 billion, the RBI said.

The Special Drawing Rights (SDRs) were down USD 4 million to USD 18.235 billion.

The country's reserve position with the IMF was up USD 15 million to USD 5.017 billion in the reporting week, as per the RBI data.

# **Amarnath Yatra Over 7,000 Pilgrims Leave For Twin Base Camps From Jammu**

Jammu: A fresh batch of over 7,000 pilgrims left Jammu city early Saturday for the twin base camps in the Valley to join the annual Amarnath pilgrimage, officials said.

The 62-day annual pilgrimage to the 3,880-metre-high holy cave shrine of Amarnath in the south Kashmir Himalayas commenced from the twin tracks -- the traditional 48km Nunwan-Pahalgam route in Anantnag and the shorter 14-km Baltal route in the Ganderbal -- on July 1.

The officials said the 13th batch of 7,392 pilgrims left the Bhagwati Nagar base camp in a convoy of 272 vehicles amid tight security.

While 4,024 pilgrims left for Pahalgam in a convoy of 146 vehicles, 3,368 devotees left for Baltal in 126 vehicles around 4 am, they said. With this, a

The study shed light on the significant challenges faced by the Himalayan brown bear population, primarily due to habitat destruction caused by human activities such as encroachment, tourism, and grazing pressure. With limited information available about this species, researchers estimate that only 500-750 bears remain in India, underscoring the urgent need for their conservation.

The survey conducted in critical bear habitats and prime tourist destinations, including Thajiwas Wildlife Sanctuary, Sonamarg, Laxpathri, and Sarbal villages, provided valuable insights into the decline of the bear population. Sonamarg, known for its role as a bear habitat, was particularly significant.

"The brown bear's diet includes mammals, berries, fruits, insects, alpine bulbs, plant roots, grass shoots, domestic goats, sheep, and voles. However, at times they consume polythene, chocolate wrappers thrown by people, when they find nothing to eat. This mostly happens in winters," Baba said.

In North Kashmir, he said, brown bears are found in Gulmarg, Rajwar forests and Delina hamlet of Baramulla district, while a good number of them are also found in some areas

# **1000-yr-old Tripura archaeological site, 2 others beckoning tourists**

Agartala: Pilak, an over 1000-year-old archaeological site in Tripura, is set to woo more travellers as the state government has initiated steps to develop it as a historical tourism circuit with two other places.

nestled in The place, Jolaibari, about 100 km from here, formed part of a chain of Hindu-Buddhist sites on the tri-junction of East Bengal (now Bangladesh), Tripura and Arakkan (Myanmar) region.

Several rock-cut images and terracotta plaques lie

scattered in the area and the Archaeological Survey of India is the custodian of the site.

Executive engineer of the Tourism department, state Uttam Pal, said, the state government has plans to develop the site for Buddhist tourists of South-East Asia and other places.

The Archaeological Survey of India (ASI) had taken over the site since 1999.

Pal said, "Since Pilak is declared an Archaeological site, no permanent structure can be built within 150 metres of it, but many facilities have been created for tourists outside the restricted zone. Footfall of visitors is remarkably good. The state government has built a tourist Bungalow at Jolaibari, near the site".

A senior official of the ASI, said, a stupa was excavated at Sundari Tilla under the supervision of ASI Superintendent, P Kumaran. Explaining its importance, the

official said, "This is a full-size

Buddhist stupa built in the 11th century on the pattern of architecture during the reign of Palas of Bengal.'

Panna Lal Roy, a writer, and a historian said, Pilak stands as an eloquent symbol of Hindu-Buddhist cultural affinity and the glorious cultural past of the state.

The dominant style of the rock-cut images and the sculptures in Pilak depict the influence of the Palas and Guptas of Bengal, the Arakkans in Myanmar (formerly Burma), and the local style, Roy said. "Various images of Tantric

Buddhist gods and goddesses are also found in the area. Buddha, Chunda (10th c) Avalokitesvara (8th -9th c), Marichi (9th c) made of stone and Tara, Avolokiteswar, Hariti (made of bronze). The style of Pilak sculptures was prevalent in Bengal during the 9th, 10th, and 11th centuries'," Dr Biswadip Nandi, a historian, wrote in his book 'Rock-cut and sculptures of Tripura'.

While brown bears have established habitats in various parts of the subcontinent, including Pakistan, Pakistan-controlled Kashmir, Uttarakhand, Himachal Pradesh, and Jammu and Kashmir, their presence has increasingly come into contact with humans as they venture into lower altitudes in search of food. The encroachment of human settlements into their habitats has played a significant role in the rising number of encounters.

Conservationists in Kashmir have observed a growing frequency of brown bear sightings in their natural habitats, including Sonamarg, Drass, Kupwara, Pahalgam, the Pir-Panjal range, and Gurez in the Bandipora district. This rise in sightings can be attributed to the encroachment of human activities into the bear's habitat.

The incidents of human-animal conflicts. Baba said, take place due to human interference as humans at times intrude into their habitation, resulting in encounters between the two sides.

"Otherwise, brown bears don't unnecessarily attack anyone," he added.

Improper disposal of kitchen waste by both residents and nearby hoteliers has worsened the situation, as the bears easily find food and frequently come into contact with humans. The availability of easy food sources has altered the behavior of the brown bears, delaying their hibernation and reducing their inclination to hunt for food.

Given that the global population of Himalayan brown bears is estimated to be less than 1,000, with potentially only half that number in India, urgent conservation measures are essential. These bears are listed as "critically endangered" on the IUCN Red List.

A study conducted in the western Himalayas predicts a significant decline of approximately 73 percent in the bear's habitat by 2050, highlighting the urgent need for preemptive spatial planning and habitat protection to ensure the long-term survival of the species.

After India declared their first innings at 421 for five midway into the afternoon session, an improved batting show was expected from the Caribbean batters but they were simply not up to the task and collapsed to 130 all out in 50 overs to ensure a three-day

finish. Ashwin followed his 33rd five-wicket haul in the first in-

nings with envious figures of seven for 71 in 21.3 overs, his best in an overseas Test.

The result was a foregone conclusion after the West Indies were bundled out for 150 on the opening day.

India's big win was also set up by Yashasvi Jaiswal who made a sublime 171 on debut. Virat Kohli contributed with 76 off 182 but it was not among his fluent knocks as he had to work extremely hard for his runs and was even dropped twice along the way.

The second and final Test starts in Port of Spain, Trinidad, from July 20. India, who have not lost a Test to West Indies since 2002, will be expected to complete a clean sweep and pick up crucial points in the

World Test Championship. The writing was on the wall

when the West Indies were reduced to 32 for four in their second innings.

With the conditions resembling the slow and dry tracks of India, Rohit Sharma introduced spin as early as the fifth over.

West Indies slipped to 27 for two in 19 overs at tea with Ashwin and Jadeja removing Kraigg Brathwaite (7) and Tagenarine Chanderpaul (7) respectively.

Jadeja trapped Chanderpaul in front with the one that turned from middle stump and DRS showed it was clipping the top of his leg-stump.

Brathwaite had little clue on what the skilful Ashwin was up to as he edged a straighter one to Ajinkya Rahane at first slip.

## CUET-UG Results Announced, 22,000 Candidates Score 100 Percentile

The National Testing Agency on Saturday declared the results for the Common University Entrance Test-Undergraduate (CUET-UG), which showed that over 22,000 candidates scored 100 percentile.

The maximum top scorers were in English, followed by Biology and Economics.

Over 11.11 lakh candidates had appeared for the second edition of the entrance exam.

While 5,685 candidates scored 100 percentile in English, 4,850 candidates got a top score in Biology/Biotechnology/Biochemistry, followed by 2,836 in Economics. "The performance of every

"The performance of every candidate has been evaluated using the equi-percentile method wherein normalised marks of each candidate have been calculated using the percentiles of each group of students in a given session across multiple days for the same subject," said Sadhana Parashar, Senior Director, National Testing Agency (NTA).

"The role of the NTA is confined to the registration of candidates, conduct of the test, hosting of answer keys, inviting challenges, finalising answer keys, preparing and declaring results, and hosting scorecard.

"A merit list will be prepared by participating universities and organisations. The universities will decide about their individual counselling on the basis of the scorecard of CUET (UG) - 2023 provided by NTA," she added.

The CUET-UG is the secondlargest entrance exam in the country in terms of the number of applicants. In its first edition, 12.5 lakh students had registered for the exam and 9.9 lakh had submitted their applications.

## Fishing Gear Plastic Found To Cause Most Of Coral Reef Plastic Pollution

Fishing gear plastic formed nearly three-quarters of the plastic debris documented through underwater visual surveys of coral reefs across the Indian, Pacific, and Atlantic oceans, new research published in the journal Nature said.

Revealing the extent of plastic pollution on coral reefs, an international team of researchers from the California Academy of Sciences (US), University of Sao Paulo (Brazil), University of Oxford (UK), and other collaborators found that debris increased with depth and is correlated with proximity to marine protected areas.

The team conducted more than 1,200 visual surveys across 84 shallow and mesophotic reef ecosystems located in 14 countries. Mesophotic, or 'twilight zone', coral reefs exist between 30 and 150 metres deep.

Of the total debris, 88 per cent was macroplastics larger than

about five centimetres. Human-derived debris was found in nearly all locations studied, including some of the planet's most remote and pristine coral reefs, such as those adjacent to uninhabited islands in the central Pacific.

The lowest density of plastic pollution was seen in the Marshall Islands, a coral island group in eastern Micronesia (Oceania), while the highest was recorded at Comoros, an island chain off the southeast coast of Africa, at nearly 84,500 items per square kilometre.

The study found coral reefs to be more contaminated by plastics than other marine ecosystems that were evaluated, and that the contamination, increasing with depth, peaked in the mesophotic zone.

"It was surprising to find that debris increased with depth since deeper reefs in general are farther from sources of plastic pollution," said Luiz Rocha, Academy curator of ichthyology, and senior author on the study.

# ISRO's First Human Spaceflight Programme Receives Major Boost With Chandrayaan-3 success

The historic launch of India's third Moon mission, Chandrayaan-3 on-board LVM3-M4 rocket has given a major fillip to the country's first human spaceflight programme as the same launch vehicle with

'human rated' capability, would be used for the ambitious Gaganyaan mission. The Bengaluru-headquartered Indian Space Research

tered Indian Space Research Organisation is busy working on its flagship project, Gaganyaan, which envisages the demonstration of human spaceflight capability by launching a crew of three members to an orbit of 400kms for 3 days and bring them back safely to earth, by

According to scientists at Satish Dhawan Space Centre, here, the 44.3 metre tall LVM3 rocket which carried the Chandrayaan-3 on July 14, would be the launch vehicle with 'human rated' capability. ing the reliability of the launch vehicle. LVM-3 is the heavy lift launch vehicle of ISRO for achieving a 4,000 kg spacecraft launching capability to the Geosynchronous Transfer Orbit.

The heavy lift launcher of ISRO, consists of three stages solid stage, liquid stage and cryogenic stage. For the Gaganyaan programme, LVM3 rocket is re-configured to meet the human rating requirements and has been christened as

said the first abort mission for Gaganyaan would be conducted by the end of August. ISRO has planned to launch an unmanned mission to orbit by the end of next year.

The test vehicle is currently ready here and the scientists are engaged in the assembly work of the crew module and crew escape system.

# Understanding Time May Be The Key To The Race Against Climate Change

Something has to change. Politicians and environmental organisations have invested millions trying to influence people's behaviour and tackle the climate crisis. But it's not working. No G20 country is on track to meet their climate goals.

So instead, researchers are turning their attention to the link between people's perception of time and the action they take on climate change.

One of the main areas researchers are exploring is how people interpret the vast time scales needed to comprehend climate change. People represent their life experiences on a mental timeline of past, present and future. But that timeline is not as straight as you might think. The nature of an event can influence how close or far into the past or future someone perceives it to be.

Traumatic past events can seem nearer in time, or more present, than neutral events. However, people seem to take the threat of negative events they anticipate in the distant future less seriously and perceive them as less risky compared to events closer to the present.

#### It's happening in your back yard

People who have suffered directly from climate change through floods, fires and extreme heat, often perceive the climate crisis as part of their present. However, people whose lives are just beginning to be touched by climate change perceive the time distance to be large. The crisis is still in their future. This doesn't mean people won't act unless their homes are devastated by extreme weather. But now-focused communication strategies that are highly localised may encourage more people to act.

We should be tailoring adverts to show how climate change is affecting people in their city, their local beauty spots, and how this is happening right now. Warping our sense of time

Clocks and calendars are systems to measure, record and manage time, which makes time seem like an objective concept. But research shows our experience of time is subjective, like our mental timeline.

For example, our sense of time changes as we age, often resulting in the sensation of time passing more quickly as we get older. Thoughts, feelings and actions affect our experience of time too.

It typically passes quickly when we are busy, happy and engaged, and slowly when we are sad, bored and isolated. This means we may be more perceptive to climate messaging depending on our mood and what's going on in our lives.

Our experience of time's cadence varies too. Some of the main rhythms include linear (I'm only getting older), cyclic (it's Monday again), progressive (look how much I've learned) and degenerative (we're hurtling toward the end times).

Researchers are trying to understand whether apocalyptic talk sparks action or nihilism. It's worth considering whether people would be more engaged in climate action if we framed the present as the bottom of a cycle, that, with the right intervention, can set humanity on a new upward swing, rather than a march toward Armageddon.

#### **Context is everything**

Culture also influences how people perceive time. Close your eyes and imagine a mental timeline of past, present and future. Is the past on the left or the right?

If you grew up in a left-right reading and writing household, chances are the past is on the left and the future is on the right. If you grew up in a right-left reading and writing household the past will be on the right and the future on the left.
