Studies On For Sudden Cardiac Arrest Cases Among Young After Covid ICMR's report on deaths due to sudden heart attacks to be out in two months

New Delhi: Sudden deaths due to cardiac arrest have been reported in young people after COVID-19, but sufficient evidence is not available to confirm the cause, Union Health Minister Mansukh Mandaviya told Parliament today.

The Indian Council of Medical Research is conducting three different studies to ascertain the facts regarding rising cases of cardiac arrest after the pandemic, Mandaviya said in response

deaths in young people through virtual and physical autopsy is underway.

aged 18 to 45 in India is ongoing at around 40 hospitals/research centres. Another multicentric hospitalbased matched case control study is underway at around 30 COVID-19 clinical registry hospitals to determine the effect of the Covid vaccine on thrombotic events among the population aged 18 to 45 in 2022 in India.

Besides, another study for establishing the cause of sudden unexplained deaths in young people through virtual and physical autopsy is underway, Mandaviya said.

To address the health issues related to cardiovascular disease, the Centre's Department of Health and Family Welfare provides technical and financial support to states and Union Territories under the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD).

Cardiovascular disease is an integral part of NP-NCD. Create Self-Employment Avenues For Drug Victims: LG

Says Safety And Security Of Women, Children Utmost Priority Of J&K Administration

Srinagar: At a time when his government has intensified war on drugs in Jammu and Kashmir, Lieutenant Governor Manoj Sinha on Friday directed the social welfare department to create avenues for the self-employment of drug abuse victims, besides offering them handholding for livelihood generations and capacity building to integrate them back into the society.

The LG passed these direc-

tions while chairing a meeting at the Civil Secretariat here to review performance of the department of social welfare, functioning of various verticals and implementation of Central and UT's welfare schemes.

"Social safety net, social and economic empowerment of the underprivileged is our top priority. The benefits of overall progress and economic growth must reach marginalised sections of society and it is our moral and constitutional duty to address the needs of the last man in the queue and ensure dignity to all." Sinha said.

The LG directed the officers



to ensure 100% saturation of all welfare schemes and impact assessment of ongoing schemes.

"The process for the documentation and sanctioning of the eligible applications should be responsive, seamless and simplified," he said.

"Bring about change in the delivery mechanisms by making field functionaries more accountable, participative and integrate efforts to achieve social objectives. Right to education, empowerment of women, joyful childhood, greater security and quality life to elderly to be ensured," he added.

While reviewing the implementation of welfare schemes for women and children, the LG said the safety and security of women and children in UT is of utmost priority for administration.

He directed for a dedicated integrated mechanism for conducting awareness programmes and ensuring cases are reported, investigated and stringent action is taken.

"All possible assistance must be provided to those in distress," he added.

The meeting also discussed the welfare measures for persons with disabilities, transgenders, old aged and senior citizens, SCs/STs, Pahari community and other beneficiaries.

"Adequate attention and sensitivity required to increase employment opportunities for disadvantaged groups under SC, ST, OBC Development Corporation and Women **Development Corporation and** Self Employment Schemes so that they can be made equal partners in development," the LG said.

Directing for impact assessment of rehabilitation efforts of the drug abuse victims, the LG directed the department to create avenues for their self-employment, handholding for livelihood generations and capacity building to integrate them back into the

3 Arrested **Over Sheshnag Clash: Police**

Srinagar: Three persons have been arrested for allegedly being involved in a scuffle at the Sheshnag base camp of the Amarnath Yatra last week which led to minor injuries to a few pilgrims and ponywallas, police have said.

The Additional Director General of Police (ADGP), Kashmir, Vijay Kumar said some people have uploaded a misleading and baseless video on social media claiming stones were thrown at pilgrims.

Taking cognisance of the matter an FIR has been registered," he said. Sheshnag is situated on the Pahalgam axis of the Amarnath yatra in south Kashmir's Anantnag district.

5876 Posts Of Medical Officers, Others Vacant In H&MED: Govt

HC Seeks Steps Regarding Filling Up Of Large Vacancies By Aug 28

Srinagar: The High Court of J&K and Ladakh has directed government to inform it about the steps taken to fill up the "large number" of vacancies in respect of Medical Officers as well as the non-gazetted and Class IV Employees in Health and Medical Education Department in Jammu Division as well as the Kashmir Valley.

Hearing a Public Interest Litigation, a division Bench of Chief Justice N.Kotiswar Singh and Justice M A Chowdhary passed the directions after perusal of a Status Report filed by the Deputy Secretary to Government, Health and Medical Education Department, dated 29th May this year, in which comparative staff strength in the posts of Medical Officers and non-gazetted and Class IV Employees in Jammu Division as well as in Kashmir Division was given.

As per government details,

5876 posts of Medical Officers, non-gazetted and Class IV lying vacant."

Employees are vacant in J&K. "In respect of the Jammu Division the total sanctioned strength of Medical Officers for all districts is 1390 posts of which 726 posts are

in position and remaining 664 posts are lying vacant. Similarly, in respect of non-gazetted and Class IV Employees in Jammu Division out of sanctioned

strength 6868, only 4379 are filled up with the remaining 2489 vacant." the court observed, adding, "On the other hand in respect of Kashmir Division total sanctioned strength of Medical Officers is 1467, out of which 1395 are in position and only 72 are lying vacant. Similarly, in case of non-gazetted and Class IV Employees in Kashmir Division, out of sanctioned strength of 8628 posts, 5976

are in position and 2651 are

Thus, the court said, it indicates a "skewed figure in respect of Jammu Division visa-viz Kashmir Division."

"Under these circumstances, we direct the respondent authorities to indicate the steps taken to fill up the large

number of vacancies in respect of Medical Officers as well as the nongazetted and Class IV Employees in Jammu

Division as well as the Kashmir Division," the court said, adding, "Let the same be placed on record by way of an affidavit. The affidavit shall also indicate the steps taken in respect of far flung areas of Districts of Reasi, Poonch, Ramban, Kupwara, Baramulla, etc.where the vacancies appear to be quite significant."

Selection, Appointment Different Parts Of Recruitment Process: HC

Dismisses Contempt Plea On Assistant Information Officers' Selection

Srinagar: Observing that selection and appointment are two different and distinct parts of a recruitment process, the High Court of J&K and Ladakh on Friday dismissed a contempt petition regarding Assistant Information Officer Grade-II posts which were advertised in 2006, 2008 and 2010.

"Selection and appointment are two different and distinct parts of a recruitment process which do not necessarily have to go together," said a division bench of Chief Justice N. Kotiswar Singh and Javed Iqbal Wani.

"There is no inevitability of appointment merely because a person has been selected for appointment by being included in the select list. Since, in the present case, there was no direction of the Division Bench to appoint the selected candidates, it cannot be said that petitioners have a vested right of appointment," the court said, observing that the recruiting agency, JKSSB, cannot be said to have done willful dis-obedience of court's its order in view of the "policy decision" by the Administrative Council in 2022.

2 Days Of Intense Exercise Has Same Heart **Benefits As Regular Workout: Study**

eople who engage in intense physical activity for 1-2 days reduce their risk of heart attack and stroke as much as those who do moderate physical activity for several days, a study suggests.

Current guidelines from the World Health Organization and American Heart Association recommend at least 150 minutes of moderate to vigorous physical activity (MVPA) per week for overall health benefits.

However, the impact of concentrated tween June 8, 2013, and December 30, 2015. versus evenly distributed activity has remained unclear.

The study, published in the journal JAMA, investigate the associations of cardiovascular event risk between a "weekend warrior" pattern of physical activity, where the majority of MVPA is achieved over 1-2 days, and a pattern of more evenly distributed MVPA across multiple days.

The researchers analysed data from the UK Biobank cohort study, focusing on participants who provided a full week of accelerometer-based physical activity data be-

With this data, the researchers compared 3 MVPA patterns. In the active weekend warrior group, participants achieved at least 150 minutes of MVPA with 50 per cent

of the total activity completed in 1-2 days. Participants in the active regular group achieved at least 150 minutes of MVPA but did not meet active WW criteria. In the inactive group, participants completed less than 150 minutes of MVPA.

They also assessed the same patterns using a median threshold of 230.4 minutes or more of MVPA per week.

Associations between these activity patterns and incident atrial fibrillation, myocardial infarction, heart failure, and stroke were analysed.

The analysis included 89,573 individuals with a mean age of 62 years, of whom 56 per cent were women, who underwent accelerometry.

Results showed that both concentrated and evenly distributed activity patterns were associated with similarly lower risks of all four cardiovascular events, the re-

No Signs Of Leopard In Badamwari, Search **Operation Called Off**

Rabid Dog Mauls 3 Officials, Civilian; Killed

Srinagar: The operation to catch a leopard sighted by some people in the Badamwari area of Srinagar was called off on Friday as the wildlife officials said they received no evidence about the presence of the wild animal.

The department had been searching for the leopard for three days and three nights, a senior wildlife official supervising the operation said.

"We have called off the rescue operation as we found nothing on the ground about the presence of a leopard in the Badamwari area," the official said.

We corroborated the evidence with the statements of those who were injured today, and it was established that it was a rabid dog, he added.

The official said that following the couple of "unidentified" animal attacks on Friday morning, the department scaled up the surveillance, after which it emerged that a "rabid dog" was roaming in the area.

"Earlier on Friday a person was attacked, after which our team spoke to him but the victim could not identify the animal. During the searches in the area, a dog tried to attack one of our officials too and later the same dog attacked one more civilian. Then we established that the animal is none other than the rabid dog," he said.

However, Fazal Hussain who was the first person attacked by the animal on Friday morning, said he identified the attacker as a "leopard cub".

To follow the proper protocols, we called up the authorities at Srinagar Municipal Corporation (SMC) to catch the rabid dog, the wildlife officials said, adding that after their arrival, the SMC authorities took the dog into their custody.

They, however, added that if people witness any suspicious animal movement in the area, they can call on the numbers already disseminated in the area.

2 Women Among 4 Members Of 'Honey Trap' Racket Held In Srinagar: SP South

Srinagar: Police on Friday claimed to have busted a 'honey trap' gang in Srinagar and arrested four of its members including two women, allegedly extorting money from people by enticing them into a romantic relationship.

Addressing a press conference here, Superintendent of Police (SP) south Srinagar. Gaurav Sikarwar said the arrests came after one of the victims informed police on how the gang operates and exhorts money from naïve people.

SP South said the gang's strategy consisted of "honey trapping" before demanding money from their victims, when they were finally going to meet the woman at her des-

arrested in this regard and a formal case is registered against them under relevant sections of Indian Penal Code (IPC).

According to Sikrawar, one of the women was interacting with the victim on social media including Facebook and Instagram, developing relations before enticing them into romantic relationships and finally asking them to meet her at the prearranged place.

Two of the gang members, including a woman, posed as police officers while another as a journalist, SP south said.

Firdous Ahmed Mir from Rainawari, he said posed as a superintendent of police, while Masrat Mir, a resident of Habba Kadal posed as an officer of the Crime Branch. Tariq Mir, a resident of Lal Bazar, posed as a journalist and Ashiya from Bemina honey-trapped the victims, they said.

Back To Back Stabbing Incidents

Administration Bans Sale, Purchase Of 'Sharp-Edged' Weapons At Public Places

Srinagar: Following several incidents of stabbing reported in parts of Srinagar, the authorities on Friday ordered ban on sale and purchase of sharp-edged weapons at public places across the district.

According to an order, sharpedged weapons include any object or instrument that possesses a blade, edge, or point capable of causing injury or harm to individuals, but not limited to knives, swords, daggers, box cutters, and razors.

The order stated that the step has been taken after the Senior Superintendent of Police Srinagar reported that during the past few months there have been multiple incidents of stabbing and attacks using sharp edged weapons in Srinagar. It added that the incidents

were witnessed in Qamarwari, Bemina, Kralpora, Batmaloo, Nowhatta, Kothibagh and Rambagh during the past 3 months. The order stated that the safe

ty and security of the public is of paramount importance and incidents involving the use of sharpedged weapons in public places pose a significant threat to the lives and safety of the citizens.

"Possession of sharp-edged

weapons whose blade is more than 09 inches long or whose blade is more than 02 inches wide for any purpose other than domestic, agricultural, scientific, and industrial purposes is a cognizable offence under Arms Act 1959. Now, therefore, I, District Magistrate, Srinagar, hereby impose a ban on sale, purchase and carrying of sharp-edged weapons in public places, in Srinagar with

ties, markets, schools, religious places, government buildings and any other locations accessible to the general public.'

It reads that the ban shall apply to all individuals except law enforcement agencies and individuals possessing such weapons for legitimate occupational purposes (e.g butchers, carpenters, electricians, chefs etc).

"Any individual possessing sharp edged weapon(s) shall sur-

Possession of sharp-edged weapons whose blade is more than 09 inches long or whose blade is more than 02 inches wide for any purpose other than domestic, agricultural, scientific, and industrial purposes is a cognizable offence under Arms Act 1959

It added that the ban shall be applicable to the business establishments engaged in, sale and purchase of such weapons.

"Sharp-edged weapons shall include any object instrument that possesses a blade, edge, or point capable of causing injury or harm to individuals, including but not limited to knives, swords, daggers, box cutters, and razors. Public places shall encompass streets, parks, recreational areas, public parks, transport facili-

render the same in the nearest police station within next 72 hours after which such weapons shall be seized by Srinagar police and appropriate action shall be initiated under the law. Any violation of this order shall be dealt with firmly, and appropriate legal action will be taken as per section 188 of Indian Penal code, 1860."

It added that Senior Superintendent of police Srinagar shall implement the order in letter and spirit.





Turned Down VP's Post For NC's Sake: Faroog

RINAGAR- The chief patron of the National Conference, Dr. Farooq Abdullah, today disclosed that to ensure the victory of his party in the coming elections he had turned down the offer of becoming the vice-president of

Addressing a public function in Hazratbal, Dr. Abdullah said that cross border efforts were on resolve the issue "though the peace process was temporarily stalled because of the recent events in Pakistan."

He said that everyone would have to extend co-operation to strengthen the peace process to restore peace in the state.

"I was offered the post of the vice-president of the country, but I turned it down because I want to strengthen my party and see it victorious in the coming elections," he said.

He said that the offer had been made by the central government when he was in Delhi, but during consultation with his party colleagues on his return he was advised that the party needed him in the forthcoming elections

"My colleagues told me that in the 2002 election I had stayed away from the party and the state because of presidential aspirations, and that had contributed to the NC's defeat," he said.

He said that the NC had not taken any decision so far in joining the emerging Third Front at the Centre. "The final decision will be taken by the executive committee which is meeting on July 17," he said. Criticising the coalition government on the law and order situation, Dr. Abdullah said that all sorts of slogans were being used to fool the public while no attention was being paid to development and the multitude of issues facing the people. Yasin Malik Appears in SC: 'He Could Have Been Killed', Says SG

NEW DELHI: Solicitor General of India Tushar Mehta wrote to Union Home Secretary Ajay Kumar Bhalla on Friday flagging a "serious security lapse" after Jammu Kashmir Liberation Front (JKLF) chief Yasin Malik, serving life term in Tihar jail, was brought to the Supreme Court for attending a case proceeding.

"It is my firm view that this is serious security lapse. A person with terrorist and secessionist background like Yasin Malik who is not only a convict in terror funding case but has known connections with terror organisations in Pakistan could have escaped, could have been forcibly taken away or could have been killed," Mr Mehta wrote.

He said that even the security of the Supreme Court would have been put to a serious risk if any untoward incident were to happen.

Mr Mehta highlighted that there is an order passed by the

Ministry of Home Affairs with regard to Malik under section 268 of the Criminal Code of Procedure which prevents the jail authorities to bring the said convict out of the jail premises for security reasons.

"In any view of the matter so long as the order under section 268 of CrP Code subsists, jail authorities had no power to bring him out of jail premises nor did they have any reason to do so," he said, adding, "I consider this to be a matter serious enough to once again bring it to your personal notice so that suitable action/steps can be taken at your end."

Malik appeared in the top court when a bench headed by Justice Surya Kant was hearing an appeal filed by the Central Bureau of Investigation (CBI) against the September 20, 2022 order of a trial court in Jammu in the 1989 kidnapping of Rubaiya Sayeed, the daughter of then Union home minister Mufti Mohammad Sayeed.

Muslim-Majority Nations Express Outrage, Plan Protests Over Quran Desecration In Sweden

Muslim-majority nations expressed outrage on Friday at the desecration of a copy of the Quran in Sweden. Some prepared for street demonstrations following midday prayers to show their anger.

In Iran, Iraq and Lebanon, protesters planned demonstraons after Swedish police permitted a protest Thursday in which an Iraqi Christian living in Stockholm kicked and stood on a Quran, Islam's holy book, outside of the Iraqi Embassy.

Hours before that, demonstrators in Baghdad broke into the Swedish Embassy and lit a fire to show their anger at his threats to burn the book.

Iraqi Prime Minister Shia al-Sudani has ordered the expulsion of the Swedish ambassador from Iraq and the withdrawal of the Iraqi charge

d'affaires from Sweden. But that may not be enough to calm those angered, and another protest in Baghdad is

planned for Friday afternoon.

In neighboring Iran, demonstrators also planned to take to the streets. Iranian Foreign Minister Hossein Amirabdollahian has written a letter to the United Nations secretary-general over the Quran desecration and has summoned the Swedish ambassador.

We consider the Swedish povernment responsible for the outcome of provocation reactions from the world's Muslims, Iranian Foreign Ministry spokesman Nasser Kanaani

The man in Stockholm also wiped his feet with a picture of Iran's Supreme Leader Ayatollah Ali Khamenei during his demonstration and did similar to a photo of Iraqi Shiite cleric Mugtada al-Sadr, a powerful leader there.

Lebanon's Shiite militant group Hezbollah also called for a demonstration Friday afternoon. Khamenei and Iran's theocracy serve as Hezbollah's main sponsor.

Before Parading Women Naked, Manipur Mob Killed Many, **Torched Homes: Police Report**

IMPHAL: The FIR registered in connection with the parading of two women naked in Manipur, charged that before kidnapping them, a group of armed men came to the village in Kangpokpi district and torched and looted houses, attacked people killing many besides sexually assaulting women.

The FIR, a copy of which is available with Press Trust of India, claimed that one person was killed by the mob as he tried to protect his sister from being raped on May 4 before the two were paraded naked and molested in front of others.

"Around 900-1000 persons carrying sophisticated weapons like AK rifles, SLR, INSAS and .303 rifles forcefully entered our village... in Island subdivision, Kangpokpi district, about 68 km south from Saikul police station.

"The violent mob vandalised all the houses and burnt them to the ground after looting all the moveable properties," the FIR lodged at Saikul police station claimed.

They took away cash, furniture, electronic items, foodgrains, furniture and cattle heads, it said.

The mob also snatched away five people who were rescued by police personnel from a nearby forest, the FIR claimed, according to Press Trust of India.



The police arrested four people in connection with parading the women naked and molesting them a day after a video showing their humiliation surfaced on July 19. The arrests were made a day after the video surfaced, the complaint in this connection was lodged around a month ago -June 21 - at Saikul police station in Kangpokpi district.

Meanwhile, the husband of one of two women paraded naked and molested by a group of men is a Kargil war veteran who rued that though he protected the country but could not save his wife.

Varanasi Court Orders ASI To Survey Gyanvapi Mosque, **Conduct Excavations If Needed**

VARANASI: A court here on Friday directed the Archaeological Survey of India to conduct a "detailed scientific survey"including excavations, wherever necessary-to determine if the Gyanvapi mosque located next to the Kashi Vishwanath temple is built upon a temple.

The mosque's 'wazukhana', where a structure claimed by Hindu litigants to be a 'shivling' exists, will not be part of the survey—following an earlier Supreme Court order protecting that spot in the complex.

District judge A K Vishvesh directed the ASI to submit a report to the court by August 4, along with videos and photographs of survey proceedings.

'The Director of ASI is also directed to conduct a detailed scientific investigation by using GPR (Ground Penetrating Radar) survey, excavation, dating method and other mod-ern techniques of the present structure to find out as to

whether same has been constructed over a pre-existing structure of Hindu temple," the order said.

It specifically directed the use of GPR technology for survey "just below the three domes of the building in question", and to conduct an excavation there "if required".

Hindu activists, who claim that a temple existed earlier at the site and was demolished in the 17th century on the orders of Mughal emperor Aurangzeb, hailed the court order.

A throng of people outside the court received the news with slogans of "Har Har Ma-

The court had on July 14 reserved its order after hearing both the Hindu and Muslim sides.

"Not Till September 4": What **Centre Told High Court On New Rules For Fake News**

MUMBAI: The Centre today informed the Bombay High Court that it won't notify till September 4 the 'Fact Check Unit' (FCU) under the recently amended Information Technology (IT) Rules to flag fake content on social media against the government.

Solicitor General Tushar Mehta sought a division bench of Justices Gautam Patel and Neela Gokhale to adjourn the earlier dates set by the court for the Centre to put forth its arguments justifying the new IT Rules.

The bench has been hearing a bunch of petitions challenging the amended IT Rules. Stand-up comedian Kunal Kamra, the Editors Guild of India and the Association of Indian Magazines have filed petitions in the high court against the Rules, terming them arbitrary and unconstitutional and claiming that they would have a chilling effect on the funda-

mental rights of citizens. The petitioners' advocates have completed their arguments after which the court posted the matter on July 27 and 28 for Mr Mehta to argue.

Reached Out 3 Times, No Response **From Manipur Authorities: Women's Panel**

NEW DELHI: National Commission for Women (NCW) Chairperson Rekha Sharma today said she had reached out thrice in the last three months to authorities in Manipur over incidents of violence against women but no response was received from them.

She was responding to reports in a section of the media that claimed the commission had on June about the incident of two women being paraded naked on May 4 in the ethnic violence-hit northeastern state but had not taken any action. The May 4 video sur-

faced online on July 19. Ms Sharma denied receiving any report of the incident and said she took suo motu cognisance of the incident on Friday after the video surfaced and sought explanation from authorities on the matter.

However, the NCW chief said that she had received other complaints regarding



women issues and for that she had reached out thrice to authorities in Manipur but no response was received from them.

She also shared the leters sent to authorities in the state.

Ms Sharma had written to them over complaints of incidents of violence against women.

"We had to verify the authenticity, and also the complaints were not from Manipur, some were not even from India. We reached out to authorities but no response was received from them but then we took suo motu cognisance when the video (of women being paraded naked) went viral yesterday," Ms Sharma said.

Manipur Video: Ex-Army Man Rues He Could **Not Save Wife From Being Paraded Naked**

IMPHAL: The husband of one of two women paraded naked and molested by a group of men in Manipur is a Kargil war veteran who rued that though he protected the country but could not save his wife from being humiliated.

The incident which sparked condemnation countrywide came to light when a video shot on May 4 surfaced on Wednesday

The husband had served the Indian Army as a Subedar of the Assam Regiment. "I fought for the nation in the Kargil war and was also in Sri Lanka as part of the Indian Peace Keeping Force. I protected the nation but am dejected that after my retirement, I could not protect my home, my wife and fellow villagers... I am sad, depressed," he told a Hindi news

He said that on the fateful May 4 morning, a mob burnt down several houses in the locality, dis-



robed the two women and made them walk on the village paths in front of people.

"Police were present but took no action. I want that all those people who burnt the houses and humiliated the women get exemplary punishment," he said.

Four people have been arrested in connection with the case on Thursday, a day after the video surfaced.

Supreme Court Disposed

Court has disposed of nearly 26,000 cases so far this year while the 25 high courts have settled over 5.23 lakh cases, Law Minister Arjun Ram Meghwal informed Lok Sabha on Friday.

On Thursday, the minister had informed Rajya Sabha that cases pending in various courts in the country had crossed the five-

Citing data from the Supreme Court's Integrated Case Management Information System (ICMIS), Meghwal, in a written reply in Lok Sabha, said the top court had settled 25,959 cases till July 15 this year.

The 25 high courts disposed of 5,23,338 cases till July 17 this year, he said, citing National Judicial Data Grid (NJDG) data.

Mr Meghwal said the disposal of pending cases in

courts is within the domain of

"No time frame has been prescribed for disposal of various kinds of cases by the respective courts. The government has no direct role in disposal of cases in courts," he said.

He said timely disposal of cases in courts depends on several factors, including availability of adequate number of judges and judicial officers, supporting court staff and physical infrastructure, complexity of facts involved, nature of evidence, cooperation of stakeholders -- Bar, investigation agencies, witnesses and litigants, and proper application of rules and procedures.

Article 370 Case Hearing

Framing the issue in terms of party politics alone detracts from the understanding of what the case about the revoked constitutional provision represents now

fter four years, the Supreme Court has finally decided to hear the Article 370 petitions every day from August 2. Incidentally, the decision to do so came shortly after a team of judges visited Jammu and Kashmir. The timing of the hearings is also significant for another reason: it will be only nine months before the general elections. So, the BJP will be interested in the case being decided during this period and in its favour. This will be a shot in its arm just before the polls which it is already favourite to win.

But the party will also be aware that being the favourite doesn't necessarily translate into a definite win. In 2003, the favourably placed Atal Bihari Vajpayee-led NDA government failed to secure a second term despite running a high-decibel Shining India campaign which appeared to resonate with people. So, ideally the BJP may not like the case about Article 370 passing into the hands of a successor government, should that be of an opposition party or a broader alliance of anti-BJP parties. They may choose not to defend the case as aggressively as the BJP does

This is but only one way of looking at the issue. That said, it would be very interesting to see how a non-BJP government would approach the case, should it by any chance succeed the saffron party. Would it be lukewarm in its defence? And if so, will it be politically easy for it to do so? There is no clear-cut answer as of now. The questions belong to a future that may or may not pan out.

But the BJP has every reason to be mindful of what might happen should it lose the power in May 2024. So, the party would prefer if a favourable decision on Article 370 comes along in the next nine months.

However, framing the issue in terms of party politics alone detracts from the understanding of what the case about Article 370 represents now. The reading down of the constitutional provision may have been on the BJP's agenda, but its opposition by the other parties has become more nuanced now. The past four years have witnessed emergence of a certain political and social consensus in India around the erasure of Article 370. One can't now find even the pretense of a

contrary view on the issue as a broad spectrum of regional and national parties deem that a large majority in the country supports the move. Whether this approach outlives the end of the BJP rule remains to be seen.

As things stand, the Modi government seems to have set a new Kashmir template which also aligns with India's core interests in Kashmir. The dominant perception outside Kashwithdrawal of Article 370 is no longer just an attempt to restore peace, or to reign in separatists and keep Pakistan at bay, it is about resolving Kashmir on New Delhi's terms. And calm over the past four years has given New Delhi confidence that it is on track to achieve it. And in this pursuit, the powerful countries in the world seem to have played along with New Delhi. A grumbling Pakistan, on the other

In the altered paradigm even appearances don't matter now. The hand, has chosen to watch the situation from the sidelines.

Such far-reaching ramifications of the repeal of Article 370 has made the move far bigger than the fulfilment of the BJP's political agenda. In this situation, one can only wonder aloud as to how the court would approach the case. Would it go ahead and deliver

hile India has more than 30 strategic partnerships with various countries, it would be misleading to say that they all are of the same significance. Two questions are crucial in this context. One, is it a full-spectrum strategic partnership? Two, has the strategic partnership in question stood the test of time? Measured against these two criteria, the Franco-Indian strategic partnership comes out on top. The Franco-Indian partnership spans the full spectrum of what may be considered strategic

defence, space, climate change, critical technologies and people-topeople ties. More importantly, France has stood by India through thick and thin from the time the strategic partnership was first established in 1998.

Prime Minister Narendra Modi has just concluded a hugely significant visit to France. For once, words like "unprecedented" and "historic" used are not just hyperbole. This was after all France, so of course, there was pomp and circumstance. France bestowed on PM Modi the highest civilian honour. Our tri-services contingent, which marched past Champs-Elysees, must have made every Indian's heart swell with pride. Three documents, namely, the joint communique, the Horizon 2047 roadmap and the list of specific outcomes put out by the two sides is enough to overwhelm even the most inveterate policy wonk. Some have compared this visit to the one that PM Modi undertook to the US not so long ago. It should be obvious that the fact that PM Modi went to France so close on the heels of the US is the ultimate expression of India's strategic autonomy.

The defence sector always grabs attention at Franco-Indian summits and this was no exception. Key agreements: Safran, the French company

and the DRDO (Defence Research and Development Organisation) will jointly develop jet engines for the advanced medium combat aircraft. Again, Safran will co-develop with Hindustan Aeronautics Limited engines for the Indian multi-role helicopter programme. Submarines are proposed to be jointly built by Mazagon Dock Shipbuilders and the Naval Group of France. In all of the above, the main takeaway is this: Franco-Indian defence ties have truly moved from a mere buyer-seller model to that of jointly designing, developing and co-producing it in India. This is a paradigmatic shift from the French side in terms of willingness to part with know-how and state-of-the-art technology. France can genuinely claim that it is one strategic partner which more than ever is contributing substantially to a Bharat which is "aatmanirbhar". Questions have been raised about the fate of the 26 Rafale marine aircraft for INS Vikrant. This will, no doubt, happen in due course. For India, following the war in Ukraine, diversification is the name of the game in defence acquisition. It is becoming increasingly clear that France will play a huge role in this.

The Indo-Pacific, predictably enough, occupied centre stage in discussions between the two leaders. A roadmap has been agreed upon. France is not just a resident power in the Indian Ocean but has massive real estate in the form of La Reunion, New Caledonia and French Polynesia. It has a long Exclusive Economic Zone with 1.5 million citizens living there, not to mention bases in the Indo-Pacific. The roadmap already talks of cooperation being comprehensive and including the field of defence.

Joint exercises between the two countries, use of French military bases by Indian forces and achieving realtime maritime domain awareness in the Indian Ocean are of paramount importance for India. Plurilateral arrangements with Australia and UAE are alluded to. More than anything else, it is refreshing to note that while there is boilerplate language on a free, open and inclusive Indo-Pacific, the roadmap underlines the fact that Franco-Indian cooperation seeks to secure not just economic but also security interests. This roadmap should attract attention in Beijing where it is often argued that it is "Indian Ocean", not "India's Ocean"! From our perspective, it should be clear that while we are on our own on the land border with China, in the maritime space India can count significantly on France along with our Quad partners.


The trust developed between the two countries over the last 25 years has been unshakeable. So, the divergence between the two countries on the war in Ukraine has not been allowed to jeopardise the remarkable development of their bilateral ties. There was a discussion at length between the two leaders on the situation in Ukraine in a spirit of mutual understanding of each other's positions. PM Modi would have benefitted enormously from the French assessment of the war in Ukraine in view of the forthcoming G20 summit to be chaired by India.

Franco-Indian cooperation on critical technologies, be it supercomputing, cloud computing, artificial intelligence and quantum technologies is crucial for India's future and may well determine the trajectory of the relations over the next 25 years. This will also give a fillip to the Indo-EU Trade and Technology Council, which has been slow to get off the blocks.

France has come to the informed conclusion that no global problem can be tackled meaningfully without India's participation. This explains the extraordinary emphasis on bilateral cooperation in the fields of climate change, energy security, biodiversity loss and counter-terrorism efforts, all of which figures prominently in the Horizon 2047 statement. This also illustrates France's determination to support India's candidature for permanent membership of the UN Security Council.

In sum, France and India are essentially taking long-term bets on each other. These are two middle powers, one in Europe and the other in Asia, with a similar conception of the world. In effect, both countries follow an independent foreign policy and practise strategic autonomy, which they hope will enable them to shape a multipolar world. More crucially, both these powers realise that there is a much better chance of this happening if they work in close concert.

Hassan Kak was least bothered — he was busy adjusting his skull cap and then the elegy reciter started to recall and relive the tragedy of Karbala. Hassan Kak was convulsing with weeping and with his head buried in his hands. 

Omega-3 Fatty Acids May Boost Lung Health, Study Finds

mega-3 fatty acids, which are abundant in fish and fish oil supplements, may be beneficial for lung health, according to large, multi-faceted study in healthy adults.

The research, published recently in the American Journal of Respiratory and Critical Care Medicine, provides the strongest evidence to date of this association.

It underscores the importance of including omega-3 fatty acids in the diet, especially given that many Americans do not meet current guidelines, researchers said.

"We know a lot about the role of diet in cancer and cardiovascular diseases, but the role of diet in chronic lung disease is somewhat understudied," said corresponding author Patricia A. Cassano from Cornell University in the US.

"This study adds to growing evidence that omega-3 fatty acids, which are part of a healthy diet, may be important for lung health too," said Cassano said.

Past studies have suggested that omega-3 fatty acids may help, due largely to their established anti-inflammatory actions. However, robust studies of this association have been lacking, until now.



The researchers developed a twopart study investigating the link between omega-3 fatty acid levels in the blood and lung function over time.

In the first part, the researchers conducted a longitudinal, observational study involving 15,063 Americans from the NHLBI Pooled Cohorts Study -- a large collection of studies that helps researchers to study determinants of personalised risk for chronic lung disease.

The participants studied were generally healthy when the study began, and the majority had no evidence of chronic lung disease. They comprised a racially diverse group of adults, with an average age of 56 years, and 55 per cent were female.

The study showed that higher levels of omega-3 fatty acids in a person's blood were associated with a reduced rate of lung function decline.

The researchers observed the strongest associations for docosahexaenoic acid (DHA), an omega-3 fatty acid that is found at high levels in fatty fish such as salmon, tuna, and sardines. DHA is also available as a dietary supplement.

In the second part, the researchers analysed genetic data from a large study of European patients (over 5 lakh participants) from the UK Biobank.

They studied certain genetic markers in the blood as an indirect measure, or proxy, for dietary omega-3 fatty acid levels to see how they correlated with lung health. The results showed that higher levels of omega-3 fatty acids including DHA — were associated with better lung function.

One caveat of the current study is that it only included healthy adults, the researchers said In addition to fish and fish oil, other sources of omega-3 fatty acids include nuts and seeds, plant oils, and fortified foods.

"This large population-based study suggests that nutrients with anti-inflammatory properties may help to maintain lung health," said James P. Kiley, director of the National Heart, Lung, and Blood Institute (NHLBI) Division of Lung Diseases.

"More research is needed, since these findings raise interesting questions for future prospective studies about the link between omega-3 fatty acids and lung function," Kiley added.

Centuries-Old 'Namda' Craft Of J&K Weaving Its Way **Back To Lost Glory**

SRINAGAR: Namda, the nearextinct traditional woollen rug of Kashmir, is not only making a comeback in the living rooms of locals but regaining its share of international glory.

Once the most exported handicraft product of Kashmir, Namda had gone out of production due to issues of raw material quality and lack of fresh hands to take up the art.

"Namda used to fetch us more revenue than Pashmina and carpets. In order to revive this art, the Department of Handicraft has established 11 training centres, where youth have been trained to make Namda," Director of the Department of Handicrafts Mahmood Ahmad Shah told PTI.

"In order to increase productivity, a small machine has been made by IIT Roorkee with whom we have collaborated and the machines have been installed at the centres," he said.

He said the raw material requirements have been facilitated by Bagh-e-Ali Mardan Khan Institute of Carpet Technology where carding of wool is being done and then supplied to training, corporate centres, and

Shah said Prime Minister Narendra Modi's tweet on the revival of Namda craft has encouraged the artisans.

"PM Modi's tweet on Namda is a huge encouragement for us and he is consistently promoting Kashmir's art through his attire. This is a highly motivating thing for the artisans and for the craft," he added.

Amina, one of the several Namda artisans, said she was not aware of the traditional art of Kashmir earlier.

"As this is a traditional art form of Kashmir, we as artisans want to keep this legacy alive,"

Another artisan Kausar said Namda making will generate

"Being associated with this art form and rug making will aid in employment generation opportunities as it has for me. This art was dying but through the efforts of the Department of Handicraft, this training

centre has been set up that will help in keeping the legacy alive," she added.

Imran Ahmad Shah, an instructor, said the idea behind setting up the centres was to revive and uphold the legacy of the traditional art form in Kashmir.

"At Mir Behri centre, 20 young women have been in Namda making trained which also helps in generating employment for these women and if we put more efforts into reviving this art form, it will increase employment opportunities for the youth of Kashmir," he said.

"I believe that if the youth of Kashmir start taking interest in the heritage and culture of Kashmir it will benefit in reviving the dying art as well as help in getting rid of the current unemployment rate of Kashmir,' the instructor said.

To boost the revival of Namda making, the government has brought it under the artisan credit card scheme and loans are given to artisans.

"My father was an artist who made Namdas. In the 1970s, export was in tens of crores of rupees but in the 1990s, Namda making faced a downfall. By opening up centres where young people are being trained and educated in this craft, a revival of the art is possible," he said.

Cold European countries were the prime international buyers for Namda. Besides woolen Namda, Pashmina Namda is also made by one of the artists of Kashmir which gets exported to Italy, the director said.

"But unfortunately due to lack of quality supervision and maintenance of the parameters of Namda, it resulted in its downfall. Now in order to address this issue, QR code-based labelling has been adopted," he

To further boost the Namda production, the Department of Handicraft Kashmir with the help of the central government has initiated the setting up of the raw material bank that has already been sanctioned. In order to boost production, a project to introduce machines is also in the pipeline.

Tomato Prices Expected To Fall After Higher Supplies From Maha, MP

NEW DELHI- The government on Friday said retail prices of tomatoes are expected to fall with higher supply of new crops from Maharashtra and Madhya Pradesh.

The retail prices have shot up to Rs 200-250 per kilogram in several parts of the country as supply chain got disrupted due to monsoon rains and other issues.

In a written reply to Rajya Sabha, Minister of State for Consumer Affairs, Food and Public Distribution Ashwini Kumar Choubey said, "Prices of tomato are expected to come down with the increase in arrival of new crop from Nashik, Naryangaon and Aurangabad belt in Maharashtra and also from Madhya Pradesh."

He said the "current increase in tomato prices may incentivize farmers to grow more tomato crop which is expected to stabilize the prices in coming months".

Choubey attributed the recent increase in prices to a combination of factors like "crop seasonality, white fly disease in Kolar (Karnataka), instantaneous arrival of monsoon rains in northern part of the country which adversely affected tomato crops in Haryana and Himachal Pradesh and logistics disruptions in isolated areas due to heavy rains.'

The minister informed that the average daily retail price of tomato had crossed Rs 150 per kg in Delhi, Punjab, Chandigarh and Andaman and Nicobar Islands during the week July 10-16.

As on July 18, the average retail price in Delhi declined to Rs 130 per kg and to Rs 127.70 per kg in Punjab. In order to check prices of tomatoes and make them affordable, the government has started their procurement under Price Stabilisation Fund and is making them available at a highly subsidised rate to consumers.

The National Cooperative Consumers Federation (NCCF) and National Agricultural Cooperative Marketing Federation (NAFED) are continuously procuring tomatoes from 'mandis' in Andhra Pradesh, Karnataka and Maharashtra and making them available at affordable prices in major consuming centres in Delhi-NCR, Bihar, Rajasthan, etc.

DGCA Clears Resumption of Go First Flights But Sets Terms

NEW DELHI/MUMBAI: Aviation regulator DGCA on Friday said it has approved Go First's plan to restart operations with 15 aircraft and 114 daily flights with a host of conditions, including the availability of required interim funding.

The Mumbai-based carrier Go First, which stopped flying on May 3, is undergoing an insolvency resolution pro-cess, and it has cancelled all its flights till July 23.

In a release, the Directorate General of Civil Aviation (DGCA) said the airline's resumption plan for operating 15 aircraft and 114 daily flights has been reviewed and accepted.

"The acceptance is subject to the outcome of the writ petitions/ applications pending before the Hon'ble High Court of Delhi & Hon'ble NCLT, Delhi," it said.

It may be mentioned that the airline's resolution professional in late June submitted a plan to resume operations with 26 aircraft, including four in reserve, and 160 flights per day.

However, after a special audit of the airline's facilities in New Delhi and Mumbai earlier this month and additional information sought by the DGCA, Go First revised its resumption plan, thereby reducing both the fleet and daily flights substantially.

"Go First as a going concern may commence flight operations subject to (certain) conditions ," the DGCA said in a communication to the Go First Resolution Professional Shailendra Ajmera.

The airline will comply with all the applicable regulatory requirements for holding an Air Operator Certificate and will ensure the airworthiness of the aircraft engaged in operations, the DGCA said in the communication.

It also said that Resolution Professional will submit the proposed flight schedule, commensurate with the available resources in terms of airworthy aircraft, qualified pilots, cabin crew, aircraft maintenance engineers, and flight dispatchers, among others for the consideration of DGCA, after making requisite arrangements for commencement of scheduled flight operations, including the interim funding required for resumption of operations.

Besides, the airline will be allowed to start bookings for its flight only after the DGCA approves its flight schedule as per the communication.

The airline's Resolution Professional (RP) submitted the resumption plan to DGCA on June 28, and subsequently, the regulator conducted a special audit of the carrier's facilities in Mumbai and Delhi.

COLOMBO: India A set up a potentially high-voltage Emerging Asia Cup final against Pakistan A after defeating Bangladesh A by 51 runs in the semifinals here

Bangladesh had India on the ropes, bundling them out for 211, a total made possible by captain Yash Dhull's impressive 66 off 85 balls.

Overall, Dhull batted for 30

overs in the match and he was the last man to be dismissed in the 50th over.

Dhull and Manav Suther added 41 runs for the eight wicket to carry India close to the 200run mark, which they eventually managed to go past.

But, the total looked sub-par once Bangladesh colts went off the block in thundering fashion. They scored at six runs an over as openers Tanzid Hasan (51, 56 balls) and Mohammad Naim (38, 40 balls) punished Indian bowlers.

Bangladesh reached 70 in a little over 11 overs. But once the ball began to lose the shine and hardness, Indian spinners brought their team back into the match.

Left-arm spinner Suthar evicted Naim and that kicked off a procession of Bangladesh batsmen back to the pavilion.

They lost the rest of the nine wickets for 90 runs to complete a spectacular implosion as Sindhu weaved his magic.

M. Hafeez Leads Race To **Become PCB Chief Selector**

KARACHI: Former Pakistan captain and all-rounder Mohammad Hafeez is a front-runner to become the national team's chief selector after the conclusion of the team's ongoing Sri Lanka tour. According to sources. Hafeez is favoured by the new chairman of the Pakistan Cricket Board's Cricket Management Committee (CMC) Zaka Ashraf, to be appointed as the chief selector - a post that is lying vacant after the pervious CMC was dissolved in June.

"Zaka met with former captain, Rashid Latif and Hafeez and spoke to them about becoming chief selector. Rashid was not reen on the job but Hafeez (has) expressed his availability for the job," the source told PTI.

"Rashid was more interested in working on anti-corruption issues. Hafeez who played 55 Tests, 218 ODIs and 119 T20Is for Pakistan before retiring last year, made it clear that he would like the challenge of working as the chief selector," the source added.

Haroon Rasheed was a member of the previous CMC headed by Najam Sethi and was named chairperson of the new-look national selection committee, which includes the team director Mickey Arthur and head coach Grant Bradburn.

"But with the previous CMC dissolved, technically Haroon Rasheed is no longer chairperson of the selection committee," the source said.

The source added that Ashraf was yet to decide whether to



mittee, which was formed by Sethi in consultation with Mickey Arthur, or just appoint a new chief selector in place of Rasheed.

"It is unlikely the entire selection committee will be changed because of the heavy schedule of the Pakistan team after the Sri Lanka tour as Afghanistan have also confirmed a ODI series in Sri Lanka in August before the Asia Cup," he said.

Ashraf has also decided to make other changes as well relating to the Pakistan team, as he is contemplating bringing in a new team manager and media manager for the Asia Cup and the World Cup India.

"Naveed Akram Cheema, who has remained manager in the past, is a strong candidate to become team manager soon in place of Rehan ul Haq," the insider said.

The new CMC, which has a four month mandate, has been given the responsibility of conducting fresh elections for all affiliated regional associations, revive departmental teams and to form a new board of governors who would elect a new chairman, has already started making changes in the board's corporate structure.

However, half-an-hour before the start of the event, Shah announced the schedule on social media.

The PCB had a clear understanding with the Asian Cricket Council (ACC) (that) it would release the schedule of the Asia Cup, five minutes after the ceremony started in Lahore. But unfortunately, half-an-hour before the cere-





mony started around 7.15 P.M. Jay Shah had announced it on social media." one reliable source in the board told PTI.

The source said that the decision to announce the schedule by Jay Shah had spoilt the PCB's ceremony, which was held but lost its relevance as the

schedule was already out. The source added that the PCB had conveyed its displeasure to the ACC over the incident, but was told it was

all due to a misunderstanding. "The ACC's explanation was about misunderstandings over the time difference and all that, but the thing is, India is half-an-hour ahead of Pakistan time, so Jay Shah's announcement was a shock," the source said.

More Than 60% Of **World Now On Social** Media, Says Study

Tearly five billion people, or slightly more than 60 percent of the world's population, are active on social media, according to a recent study. That represents an increase of 3.7 percent over the past year, according to calculations by digital advisory firm Kepios in its latest quarterly

The number of social network users is approaching the number that use the 5.19 billion which use the internet, or 64.5 percent of the world population. There are major differences between regions. Only one person out of 11 in east and central Africa use social media. In India, now the world's most populous nation, the figure is one out of

The amount of time spent on social media has also increased, by two minutes to 2 hours and 26 minutes per day. Here again there are large disparities, with Brazilians spending an average of 3 hours and 49 minutes per day on social media while the Japanese less than an hour.

The average social media user is on seven platforms. Meta has three of the favourite apps with WhatsApp, Instagram and Face-

China has three apps, We-Chat, TikTok and its local version Douyin. Twitter, Messenger and Telegram round out the top social media platforms.

Vivek Agnihotri Unveils Series 'The Kashmir Files **Unreported', Makes Big Claim**

Srinagar: Filmmaker Vivek Agnihotri today released the trailer of his upcoming series "The Kashmir Files Unreported" here and said the show consists of the research, archival footage and interviews he did for his 2022 movie "The Kashmir Files".

The seven-part ZEE5 series delves into the "historical, ethnical, and geopolitical details, encapsulating the events, mistakes, crimes and circumstances that led to the massacre and mass exodus of Kashmiri Pandits from the valley in the 1990s", the streaming service said in a statement.

According to the makers, the show features conversations with historians, experts, reallife victims and their families.

Vivek Agnihotri claimed "The Kashmir Files Unreported" is a "type of national archive" that will serve as a "document for future".

"We took viewpoints of historians, those who served here in the Army and police, Kashmiri Pandits, stories of victims recorded in video, and all the research that we had done. We have put it together which will be saved as a

document for the future. "It is a type of national archive, which ZEE5 is bringing to the world now. It is a valuable, im-



portant and priceless documentation," the filmmaker told reporters.

As part of his research, Vivek Agnihotri said the team interacted with authorities in Kashmir and went through Parliament records, archives, books, newspapers, international documentaries, videos. They also interacted with journalists who covered the events of the time in Kashmir, he added.

"With thorough examination, we put all common elements together and made a full series. People who will watch this, they will understand the perpetrators behind the genocide and terrorism in Kashmir. They will learn from that tragedy," Mr Agnihotri said.

In a statement, the filmmaker claimed "The Kashmir Files" which was released to polarised reactions in March 2022, "opened

Inspired By Termites, This Desert City Uses 'Natural ACs' To Beat The Heat

Yazd, Iran: Tall, chimney-like towers rise from centuries-old adobe houses in Iran's desert city of Yazd, drawing in a pleasant breeze for residents of one of the hottest cities on earth. The wind catchers, called badgirs in Persian, are just one of the engineering marvels inhabitants have developed in this ancient city in central Iran -- where temperatures reach well over 40 degrees celsius (104 Fahrenheit) in the summer.

And, unlike energy-guzzling air-conditioners, they're cost and carbon-free.

"For centuries, before we had electricity, they made it possible to cool dwellings," said Abdolmajid Shakeri, the provincial deputy of Iran's cultural heritage and tourism ministry.

The oldest of the city's 700 wind catchers dates back to the 14th century, but the architectural feature is believed to date back as far as 2,500 years when the Persian Empire ruled over much of the Middle East.

The badgirs played a key role in the city's prosperity," said Shakeri about the desert city that was a caravan stop on the ancient Silk Road.

"Thanks to them, people lived at ease," he added, describing how the wind catchers pull fresh

air into buildings and allow hot air to ventilate out through large

vertical slots. Majid Oloumi, the head of Dowlatabad garden, home to a towering 33-metre (100 foot) wind catcher -- one of the tallest in the world -- described the cooling method as "totally clean because it uses neither electricity nor polluting materials".

UNESCO listed Yazd as a World Heritage Site in 2017, describing the city as a "living testimony to intelligent use of limited available resources in the desert for survival".

'Simplicity'

The bioclimatic architecture which provides thermal comfort for the people of Yazd has attracted interest elsewhere on a heating planet.

"Badgirs demonstrate that simplicity can be an essential attribute to sustainability," said Paris-based architect Roland Dehghan Kamaraji, who has studied Iran's wind catchers.

"It goes against the common misconception that sustainable solutions need to be complex or high-tech."

At a sustainable urban community called Masdar city in the United Arab Emirates, buildings have been "designed to make use of the natural ventilation for cooling, like badgirs," he said.
