J&K Bank Earns Rs 326 Cr **Profit In June Quarter**

SRINAGAR: The Jammu and Kashmir Bank on Monday reported a 97 per cent jump in net profit at Rs 326 crore in the June quarter, compared to Rs 165.97 crore recorded for the April-June quarter last financial year. The Bank announced its Q1 results on Monday after the Bank's Board of Directors approved the quarterly numbers in a meeting held here at the Bank's Corporate Headquarters.

Performance Highlights The Bank's Net interest income (NII) rose 24% YoY to Rs 1283.30 Cr in the first quarter of CFY, while as, the Net Interest Margin (NIM) improved to 3.98% as compared to 3.46% registered in Q1 of FY 2023 and 3.94% recorded in the last quarter of FY 2023. Core operating profit of the Bank witnessed a sharp spike of 38% YoY and reached Rs 528.05 Cr from Rs 381.45 Cr. Besides witnessing rise of 22% YoY and 7% QoQ in its operating income, the Bank's Cost to Income Ratio for the quarter has reduced to 65.07% as against 69.17% recorded Q1 last FY. The Bank's Return on Assets (RoA) for the June quarter was at 0.94%

Commenting upon the Bank's results, MD & CEO Baldev Prakash said, "With an almost doubled Year-on-Year PAT, our Q1 performance gives us a very encouraging start to meet our annual guidance. Reflecting the gradual but marked improvement in our operations, our core operating profit has jumped 38% YoY while witnessing 17% rise on QoQ basis. With NIM at almost 4% along with 24% YoY increase in Net Interest Income, I see promising >> More On P6

Children In Food-Insecure **Homes At Higher Mental Health Risk: Study**

hildren and adolescents living in foodinsecure households have a 55 per cent higher frequency of visits to a doctor for mental health issues than those with adequate food supplies, according to a study.

The research, published recently in the Canadian Medical Association Journal, looked at population health survey data from the Canadian Community Health Survey on 32,321 children and adolescents. Researchers used a vali-

dated measurement tool to categorise household food access as food-secure, marginally food-insecure, moderately food-insecure, or severely food-insecure.

Of the total, 5,216 (16.1 per cent) were living in food-insecure, 1,952 (6 per cent) in marginally food-insecure, 2,348 (7.3 per cent) in moderately food-insecure and 916 (2.8 per cent) in severely food-insecure

"Given the diverse mental health conditions examined, it is unlikely that the mechanism of harm is lack of specific nutrients or poor diet quality," said Lynn McIntyre, a professor at the University of Calgary, Canada.

Researchers also found that children and adolescents in food-insecure homes had a 74 per cent higher prevalence of pastyear acute care visits, defined as an emergency department visit or hospitalisation for a mental or substance use disorder.

The most common visits were for neurodevelopmental disorders, mood and anxiety disorders followed by social problems and other mental health issues.

have negative consequences for social, educational and developmental outcomes among children and adolescents," said Kelly Anderson, associate professor at Western University in Canada.

"Taken together, these findings are concerning, and we need strong public policy to support families who face food insecurity," said senior study author Salimah Shariff, staff scientist



Two Held For Killing Stray Dog In Badamwari

Srinagar: Police on Monday arrested two persons for allegedly killing a stray dog at Badamwari area in the old city.

A police official told Kashmir Observer that two persons were arrested on charges of meting out cruelty and brutally killing a stray dog in Badamwari, days after purported presence of leopard created panic in the entire area. He said the incident took place on Friday last.

A formal case Fir No. 29 of 2023 under sections 429 of IPC and section 11(1) of PCA act was registered at police station Rainawari in this regard and both the accused

were arrested.

The accused duo has been identified as Gulzar Ahmad Beig of Rehmaniya Colony, Lal Bazar and Adnan Shah of Hawal Badmawari.

Confirming the incident and subsequent arrest of the accused involved in killing of stray dog, Srinagar police in a tweet said "Two people, Gulzar Ahmad Beigh of Rehmaniya colony, Lal Bazar, and Adnan Shah of Hawal Badamwari, were arrested for cruelty and brutally killing a stray dog near Badamwari Rainawari on July 21, 2023." Tourism Picking Up In Kashmir, Say Houseboat, Shikara Owners

Urges Govt To Formulate 'Comprehensive Policy' To Keep Industry Alive

Srinagar: The houseboat and Shikara owners on Monday said they are witnessing a "positive" change and "favorable economic improvements" in their business during the last few years.

Chairman of Kashmir Houseboat Owners Association (KH-BOA), Manzoor Ahmad Pakthoon said that post-Covid-19 pandemic; they are witnessing an upward trend in tourism arrivals in the valley. People's livelihood opportunities have increased in the sector. Pakhtoon said the last few

years have been "positively on the good side" as far as hosting of tourists in houseboats is concerned. However, the stay pattern is not the same as it used to be, he said, adding that the persistence in business has led to an improvement in livelihood.

"The booking pattern is now for a very short phase, but the consistency in the business has made us in a position to generate more employment to offer more and better services to our clients," he said.

President of Shikara Association, Wali Mohammad, said the past few years have been better than the previous times.

"There is no denial that the tourism activities have increased in the valley and it has surely had a positive impact on our work due to which our earnings have increased to a certain level," he said.


Secretary KHBOA, Abdul Rashid, however, said more needs to be done in order to ensure the sustainability of their business. "There is a marginal improvement in livelihood, but it can become good if the visitors

stay for a longer time," he said.

According to the KHBOA, the houseboats have scaled down from thousands to a few hundred only, while many more hundreds are offering to surrender their registrations and seeking "rehabilitation" as they cannot continue with their maintenance due to "inflation".

According to the Shikara Association, more than 3,000 Shikaras are registered with them which are currently in service at Dal, Nageen, Manasbal, and Hazratbal. However, the J & K Tourism Department has mentioned the Shikara numbers as above 4,000.


The tourism stakeholders have demanded sustainability and a comprehensive policy to keep the industry going and to pave the way for generating more employment in the valley.

Cong Unlikely To Extend Mufti's Tenure

EW DELHI - As the date draws nearer for Jammu and Kashmir Chief Minister Mufti Mohammad Sayeed to hand over the baton to a leader from alliance partner Congress, the party today sought to put an end to all speculation by indicating that the PDP leader would not be asked to continue.

Virtually putting at rest speculation that Congress might not be willing to take over the reins of the government after three vears in November as per an agreement between the two coalition partners, a senior leader said the party would suffer if did it.

"It will not go down well in the party," the leader close to J&K affairs said when asked whether the Congress would let Saveed continue for remaining three years of six year term as has been suggested by some reports.

When the two parties forged post-poll alliance to form government in November 2002, they had agreed that one party would lead the coalition for three years and the other for rest of the term.

Congress, with 20 MLAs in the 87-member Assembly, had then allowed junior partner PDP, with 17 MLAs, to lead the alliance in the first phase. The Deputy Chief Minister was from Congress for the first three years and from PDP for the remaining tenure.

Although some sections in the Congress are believed to be inclined to allow Sayeed to continue, the state unit of the Congress strongly disfavours any reunification move.

The state unit feels it was the much-awaited opportunity for the Congress to have its own Chief Minister and it should not be allowed to fizzle away.

On the question of whether the Congress had an appropriate leader to become Chief Minister, the party leader said there would be no problem on this count. The Congress leader, however dismissed possibility of Mohammad Shafi Qureshi or Saifuddin Soz be given the charge as had been reported in some sections of media.

The disadvantage with Soz's candidature is that he has joined the Congress only three years back after being expelled from National Conference. Qureshi also has been out of the party for a long time

Ethnic Conflict In Manipur

he harrowing sexual assault video from Manipur, India, has shocked the nation and brought attention to the ongoing ethnic conflict in this state. Here are the key points to know about the situation:

The disturbing video, lasting only 26 seconds, shows a mob of men from the Meitei ethnic majority parading two women from the Kuki minority, who are predominantly Christian, naked through a crowd of clothed men. The victims were subjected to sexual assault by groping their private parts. The incident occurred on May 4, during a period of intense violence between the two communities. According to a complaint filed with the police, the attackers stormed the victims' village with guns, and although the women were initially rescued by the police, they were later kidnapped and sexually assaulted by the Meitei mob.

Ethnic tensions in Manipur have simmered for years, and the recent violence is not an isolated incident. The state is composed of various demographic groups, with the Meiteis, mostly Hindus, dominating the political landscape. The Nagas and Kukis, both predominantly Christian minorities, have long-standing grievances with the Meitei community. The situation escalated in May when the Manipur High Court issued a ruling in favor of Meitei demands for tribal status, which would grant them land rights and other protections. However, the Kukis, who already have tribal status, opposed the court's decision, fearing it would lead to the loss of their land. This sparked widespread protests and retaliatory attacks on homes and villages, further escalating the conflict.

The video has ignited outrage across India. Prime Minister Narendra Modi condemned the attack, describing it as "shameful" and an "insult" to the country. Manipur Chief Minister Biren Singh has promised a thorough investigation and strict action against the perpetrators, potentially even capital punishment. Protesters across the nation have voiced their anger, highlighting the targeting of women during communal clashes as a form of retribution.

The sexual assault video from Manipur has exposed the grim reality of the ongoing ethnic conflict in the state. It is crucial for the authorities to act swiftly, conduct a thorough investigation, and bring the perpetrators to justice. The entire nation must stand united against such heinous acts, and the focus should be on addressing the root causes of the conflict and promoting peace and understanding among the various ethnic groups in Manipur. Only through a united effort can the state move towards healing and reconciliation.

Issuing Eviction Notices to Forest Dwellers Violates Apex Court Ruling

Grazing is a Community Forest Right of all the people living near forest areas. This should be respected by Forest Department and subordinate Judiciary

he Scheduled Tribes and Other Traditional Forest Dwellers (Recognition Of Forest Rights) Act, 2006 also known as Forest Rights Act 2006 or FRA is a historical legislation that recognises the rights of forest dwelling communities across India whether they belong to Scheduled Tribe or Other Traditional Forest Dweller (OTFD) community. The FRA encompasses Rights of Self-cultivation and habitation which are usually regarded as Individual Rights and Community Rights as grazing, fishing and access to water bodies in forests. In addition, the access to the traditional seasonal resource for nomadic and pastoral communities is part of the community forest right (CFR) and community forest resource right (CFRR). The pastoralist communities like Chopans, Gujjars and Bakerwals of J&K give them the right to use the forest land for their livelihood in a sustainable way without causing any harm to the environment and forests. Grazing of cattle and sheep is a part of this right.

Unfortunately, for many years, some local people with vested interest claim rights over the pastureland and demand ransom from grazing communities at high altitudes of J&K. Many such cases have been reported in J&K's Kishtwar and Budgam in the last few months.

The Forest Rights Act (FRA) further enjoins upon the Gram Sabha and rights holders the responsibility of conservation and protection of biodiversity, wildlife, forests, adjoining catchment areas, water sources and other ecologically sensitive areas as well as to stop any destructive practices affecting these resources. The Gram Sabha is an empowered institution under the FRA. The local tribal population and other traditional forest dwellers (non STs living near forests) have a decisive say in the determination of allocation of forest land and pasture land for grazing purpose as part of their community forest right.

The Forest Rights Act 2006 (FRA) acknowledges the fact that the forest-dwelling Scheduled Tribes and other traditional forest dwellers have been residing in forests for generations but their rights could not be recorded, recognized and accorded to them. Historical injustice has been done to the forest-dwelling Scheduled Tribes and other traditional forest dwellers who are integral to the very survival and sustainability of the forest ecosystem since the colonial period as well as in independent India.

FRA is therefore aimed at addressing the long-standing insecurity of tenure and access rights of forest-dwelling tribes and communities, including those who were forced to relocate their dwellings due to development interventions undertaken by the State. The FRA provides a legal framework for recognition of individual and community forest rights. It also provides an opportunity for democratization of forest management.

Until the process of deciding the claims under the FRA are completed by the authorities, eviction notices can't be issued at all.

Action against any claimant of the Forest Rights Act whose forest rights claim is under consideration by any authority (Gram Sabha/ SDLC/ DLC) will be considered a violation and liable for penal action under Section 7 of the Act and other Indian Penal Code. Even if the claims have not been filed due to lack of awareness about Forest Rights Act -FRA, the same can be filed at any point of time. Pertinently there is no given time frame for filing claims under the FRA.

Preamble of FRA

Before initiating any action against forest dwellers, the Forest Officials must go through the preamble of FRA. It reads:

"An Act to recognize and vest the forest rights and occupation in forest land in forest dwelling Scheduled Tribes and Other Tradimountain pass.

The locals of Branwar and adjoining villages told DDC Chairman that 5 to 6 local influential families have allegedly occupied the land to get ransom from grazers and this has been continuing since many years and now these families want to get benefits of FRA as well while as local grazers are deprived of the grazing rights and are asked to vacate the area.

Infact, the local court of Sub Judge Chadoora on July 22nd 2023 ordered that defendants (claimants of the grazing rights) have no right to interfere into the utilization of the suit property but the order never said that they can't graze the animals in the area. The order has also said that those who have documentary evidence to prove the grazing land belongs to them can use it. The biggest document to prove this can only be provided by the Gram Sabha and the DDC Chairman Budgam has already urged authorities to hold the same. Infact, the Chairman is empowered to order for holding the Gram Sabha in the vil

FRA is therefore aimed at addressing the long-standing insecurity of tenure and access rights of forest-dwelling tribes and communities, including those who were forced to relocate their dwellings due to development interventions undertaken by the State. The FRA provides a legal framework for recognition of individual and community forest rights. It also provides an opportunity for democratization of forest management

No quick fix

mong the most important pieces of legislation slated to be tabled in the current monsoon session of Parliament is the National Research Foundation (NRF) Bill, 2023. While a draft is not in the public domain, it envisages a new, centralised body to fund research, with a budget of 50,000 crore, over the next five years. The NRF draws on models such as the United States's National Science Foundation whose nearly \$8 billion budget is the major source of funding for college and university research, and the European Research Council, which funds basic and applied research. However, the NRF's plan, going by public statements of administrators, is to draw the bulk of its budget — 36,000 crore — from the private sector. For many years, India's spending on research has lagged between 0.6%-0.8% of GDP, or lower than the 1%-2% spent by countries with an economic base reliant on science and technology. In countries such as China, the U.S. and Israel, the private sector contributed nearly 70% of the research expenditure whereas in India, this was only about 36% of India's total research expenditure — roughly 1.2 lakh crore — in 2019-20. Therefore, the Centre reasons, the way to galvanise university research in India would be to attract more private money. While that is a reasonable expectation, it is unclear how such a proposal can be executed. One of the suggestions is to have the funds private companies allot, as part of their annual corporate social responsibility (CSR) obligations, directed to the NRF. Data from the Ministry of Corporate Affairs show that during FY-2022, companies spent 14,588 crore as part of their CSR obligations. CSR trends suggest that nearly 70% of such funds were spent in education, health care, and sanitation projects. Moreover, many of the companies spend this on initiatives that are located within their own communities, with the government not having a say on how this must be spent. Whether the government can force, or offer tax benefits, to coax some of these funds into the NRF remains to be seen.

The relatively greater contribution of private sector research in many countries is because of sustained government support to universities and research institutions, that have then encouraged individuals to build companies, and institutions that saw value in investing in research and development. The challenge in India is not the absence of such companies but the fact that there are too few of them. Organisations such as the NRF should work to create conditions which incentivise the development of private sector organisations that see value in invention and developing proprietary technology. Philanthropy is unlikely to be the panacea. The Hindu

Case Study 1: Meelyal Kupwara

Recently, the Forest Department in Kupwara issued an eviction notice to one Abdul Satar Lohar S/O Abdul Gafar Lohar a resident of village Meelyal Tehsil Kralpora District Kupwara. Abdul Satar Lohar belongs to the disadvantaged Lohar community (blacksmith) and has been living in Meelyal, a forest area, for centuries. Abdul Satar Lohar received a notice from the local Block Forest Officer on 20th July 2023 asking him to vacate the forest land under his occupation within ten days. The letter said that the Forest Department would take legal action against him if he failed to do so.

A copy of the served notice has also been sent to the local police station by the concerned officer. As per the documents submitted in various forums by Abdul Sattar Lohar, he is occupying forest land for his survival and grazing purpose and never made any house or commercial complex on it. He has submitted claim form A to the Forest Rights Committee constituted under the Forest Rights Act 2006. The forest department officials say that said claim was rejected, but the aggrieved says that he hasn't received any formal order by Sub Division Level forest committee (SDLC) or District level committee (DLC). To authenticate his claim, Abdul Satar Lohar has provided a photograph of the old Kotha (Mud / Log hut) to the Forest Rights Committee and Forest Department which has been constructed on the land for ages and the same was being used for grazing purposes by the family. Copy of the same is available with this author as well.

Can Forest Deptt issue Eviction Notice ?

In several write-ups of mine, I have made it clear that the Forest Department can't issue notices for the vacation of the forest land to people as the same has been stayed by the Apex Court in the case of Wildlife One v/s Union of India case.

Case Study 2: Chaskani Naad meadow

Chairman District Development Council Budgam Mr Nazir Ahmad Khan recently wrote a letter to J&K's Lt Governor Mr Manoj Sinha asking him to constitute a high level inquiry team of Forest, Tribal Affairs and Revenue Department to look into alleged encroachment of Chaskani Naad highland pastureland in Doodh Ganga forest range of Budgam district. He suggested that a Maha Gram Sabha of several villages be held so that pastureland is distributed among different pastoralist communities for grazing purposes.

DDC Chairman Budgam sent this communication to LG Mr Manoj Sinha on Thursday July 20th 2023 after a delegation of people mostly from the Scheduled Tribe (ST), Gujjar community of Branwar, Jabbad, Neegu villages in Budgam District apprised him regarding denial of the grazing rights to them in pasture land of Chaskani Naad by some local influential families.

The Chaskani Nad pastureland is located an altitude of 4000 meters in Doodh Ganga Range of Pir Panjal Forest Division Budgam bordering Poonch district near Choti Gali

lages soon.

Conclusion

The intent of FRA legislation enacted by the Parliament of India in 2006 is to address the long-standing issue of tenurial security of the forest-dwelling Scheduled Tribes and Other Traditional Forest Dwellers who have been residing or depending on forests & forest land for their survival. Though this law came into force on 31st December 2007, in J&K this law was rolled out with effect from Oct 31st 2019 after article 370 got abrogated. Even after more than 4 years of its enforcement in J&K, the Forest Department officials are still unaware of the provisions of this law. It is better that the Govt makes Tribal Affairs Department as the nodal agency for FRA in J&K. Even at the national level Tribal Affairs Ministry looks after implementation of this law and in other states respective Tribal Welfare Department has been given this work, one fails to understand why Forest Department was made the nodal agency for FRA. Preventing forest dwelling communities from using forest land goes against the Supreme Court ruling in the matter of Wildlife One v/s Union of India.

How Poetry Can Save Our World

he contemporary overarching paradigm that we breathe in today is what some thinkers have referred to as "metaphysics of violence". It has roots in post-Aristotelian Western philosophy where (organic/holistic/dynamic) Reality is broken down into static fragments/"things" to be arrested by categorical thought in order for the humans to dominate & exploit "nature". This metaphysics – which sees reality as pulverised static entities/things – in tandem with mod-ern humanism led to metaphysics of violence i.e. human being perceives reality as arrestable resources to "catch"/prey for the sake of human domination. This has manifested in modern scientific exploitation of nature resulting in catastrophic environmental crisis.

Modern humanism perceives humans to be ontologically disjointed from nature rather than being grounded in it and sustained by it. In Heidegger's terms, technology is not mere "technique" but rather a proper ontology (worldview, to use a popular word) under which Reality is revealed through the category/lens of "resources". Everything is reduced down to a mere resource/"use". Human beings cannot live without some ontological posture under which Reality reveals or unconceals itself through one category or the other. A tree, for example, reveals/ unconceals itself to a scientific laboratory through a particular category i.e. resources, chemicals, atoms, etc whereas the same tree reveals itself totally differently within the ontology of a poet – constituting realities such as wonder, mystery, beauty, life, etc.

The popularized version of objective scientific reductionism which is often posited at such an occasion, although may be problematized by Philosophy of Science and Sociology of Science, nevertheless becomes irrelevant if we take the scientific reductionism to its logical end conclusion. If someone says that colours, sounds, perceptions, emotions or experience in general is nothing but chemical reactions then one may proceed and ask as to what these chemicals are; if we say that the chemicals are nothing but atoms and molecules reacting with each other, we may consistently continue our reductionism and ask further as to what these molecules


and atoms are? The expected reply would be that the atoms are nothing but sub-atomic particles which in turn are waves of possibilities. We may continue our reductionism and ask further as to what these waves are? If we say that they are manifestations of physical fields or energy, the question doesn't stop there as per the logic of reductionism. One may continue further and ask as to what these fields are or what this energy is in its essence? Finally, at the end, one inevitably arrives at the dead end of mystery anyway. Science, particularly contemporary physics, therefore, arrives at "mystery" which the poet fundamentally registers at the very beginning in his very first step.

Moreover, reductionism is yet another feature of the same metaphysical posture that we have pointed out above i.e. reducing complex qualitative systems/wholes down to quantitative simplicities such that "control" becomes easy. Capitalism also finds itself at home within this contemporary dominant paradigm because it too is obsessed with "numbers" such that manipulating/controlling customers becomes easy in order to churn out more & more profit.

Coming back to our main subject matter, Reality reveals itself through multiple categories. In our



times, the dominant category is "resource". To paraphrase Iain Mcghilchrist's words, the contemporary scientific worldview is dominated by left (brain) hemisphere perspective wherein "detail" is of primary importance to get hold of specifics while as larger background context is largely missed or ignored which is the job of the right hemisphere. Poetry can help us redeem the mystery and larger/wider complexity of the world at hand. This richer lens which unconceals/reveals reality in a more organic/natural way (instead



of forcefully channelizing reality through the filter of "resource") can redeem both us & our world.

The contemporary paradigm of "resource" gives rise to "instrumentalist" mentality which gradually creeps into our own personal lives and the larger cultural milieu as potently argued by the Frankfurt school.

Art brings out the pure irreducible "thingliness" (Being) of a thing which otherwise we fail to see in "things" from an instrumentalist mentality. By de-contextualising things from their contexts where things are "concealed"/overshadowed, art unconceals the Being/"thingliness" of things. Art is a ground which is open to the rupture of Being such that unconcealment happens. Being "happens" in art. Art, therefore, is a rupture of Being. It, therefore, presents the actual nature of reality in itself wherein Being/existence ruptures (or comes) into being from behind/ mystery/void. This is the important alternative vision of Reality as an "event" (that happens) as opposed to a "present at hand" static things/ material to be captured by static categorial thought.

Art, therefore, teaches us to remain open to Reality/revelation which happens. This is why "thinking", for (later) Heidegger, means waiting for reality to reveal itself rather than calculating its arrest through prior manipulations. This poetic attitude can de-fang our technologybased-culture which cannot now be materially reversed by turning back the wheel. It is the "poetic" attitude – which does not reduce Being to "things"/resources - that can save us. One recalls here, Heidegger's student, Gadamer's pertinent message to the world by which we conclude, "I would say that it will remain a task for humanity to see the limitations of the great legacy of our scientific culture. Because otherwise, we will surely kill ourselves one day ... we cannot eliminate the risks which lie in misuse. And yet, I believe that we have to run the risk that the power that has been placed in the hand of mankind will become increasingly strong, increasingly great, and therefore, increasingly dangerous for selfdestruction. This is a monumental task if humanity is to be able to survive; and this will only be possible if we overcome this one-sidedness of the will to dominate and mastery of doing by cultivating other powers, such as that involving suffering & compassion, or to speak with a poet, if we learn to honor again the human soul's ability to dream".

Is The Net-Zero Transition Endangering The Asian Century?

sian countries' ability to thrive in the world economy over The next few decades hinges on their capacity to sustain their competitive advantages through continuous innovation. But to meet their commitments under the 2015 Paris climate agreement, the region's economies must overhaul their production, consumption, and resource-allocation strategies, potentially postponing the long-anticipated "Asian century."

With the latest Intergovernmental Panel on Climate Change report showing that global warming is on track to rise 1.5° Celsius above preindustrial levels within the next decade, the urgent need to accelerate efforts to mitigate climate change has moved to the forefront of the international policy debate.

In March, shortly after the United Nations warned that the "climate time bomb is ticking," a gathering of central bank governors from member states of the Association of Southeast Asian Nations (Asean) underscored the importance of aligning national policies to support the green transition. Two weeks later, the Spring Meetings of the World Bank and International Monetary Fund focused on the need to reform global institutions to address the climate threat. And at the end of April, more than 100 central bankers and regulators convened in Singapore to explore ways to reach the annual target of \$9.2 trillion in green investments required to achieve net-zero emissions by 2050.



Amid conflicting domestic and global priorities, varying levels of climate-risk awareness, and a dearth of comprehensive climate data, the policy debate has been shaped by countries that are better equipped to manage the effects of climate change. Consequently, while the scientific and policy consensus is that cutting greenhousegas emissions is the only way to avert climate catastrophe, the impact of emission cuts on Asia's economies remains uncertain.

There are two main approaches to cutting emissions: reducing economic activity to lower energy demand and implementing industry-specific measures to mitigate

emissions. It is easy to see why the first option, which means accepting slower economic growth, is a non-starter for many emerging and developing economies. But with fossil fuels accounting for more than 80 per cent of energy use in China, Japan, South Korea, and Asean countries - collectively known as Asean+3 - the second path would have profound economic implications as well.

The most likely shock would be an increase in the cost of living. To discourage the use of fossil fuels, governments must make them more expensive, starting with the elimination of the energy subsidies that played a crucial role in supporting consumer spending across the region during the energy price shocks of early 2022.

But even if Asean+3 policymakers resist domestic calls to impose a carbon tax, they may be compelled to act, owing to rapidly shifting climate policies elsewhere, such as the European Union's Carbon Border Adjustment Mechanism, which imposes tariffs on carbon-intensive imports. Either way, Asian exporters will face higher production costs and could be at risk of losing their long-established positions in global trade and supply chains.

Moreover, reducing greenhouse-gas emissions would require the retirement of many of the region's coal-fired power plants well be-

fore they reach even half of their projected lifespan. On average, coal power plants have an operating life of roughly 55 years. While early retirement may not present significant challenges in Europe and the United States, where the average age of a coal-fired plant is about 34 and 41 years, respectively, the average coal plant in Asean+3 countries is just 11 years old.

In addition to its significant costs, retiring coal-fired power plants could disrupt livelihoods and communities across the region. To mitigate the adverse socioeconomic effects of this shift, Asian policymakers must ensure a just transition that considers the impact on affected communities. But, given the potential impact of the net-zero transition on Asean+3 countries' finances, energy prices, and exports, the region will most likely face a period of challenging economic conditions before experiencing any improvements.

Still, the net-zero transition is an unavoidable necessity. By taking proactive measures and facilitating the allocation of public and private funding to where it is needed most, Asean+3 policymakers could allay the potential impact and sustain the region's economic prosperity without undermining global climatemitigation efforts.

To be sure, in recent years Asean+3 governments have made significant progress in promoting sustainable and green finance. But the lack of adequate transparency, incentives, and data impedes policymakers' ability to establish a "greenium" that investors would be willing to pay for the perceived advantages of investing in environmentally friendly instruments.

The lack of a unified global approach to transition financing, which aims to help "brown" (carbon-intensive) sectors become greener, poses another challenge for policymakers. For example, an emissions-reduction project that meets the criteria for a bank loan in Asean+3 countries might not qualify for a similar loan in Europe. In the absence of a global transition taxonomy, many foreign investors are understandably reluctant to bear the risk of policy uncertainty and reputational harm associated with funding the region's "brown" sectors, despite their economic significance.

With the window for decisive climate action rapidly closing, some may question whether the "Asian century" is already passé. But while the shift away from fossil fuels may impede Asean+3 countries' progress toward achieving long-term eco-nomic prosperity, the net-zero transition is also a unique opportunity for Asian economies to boost growth and job creation. Countries such as China, with its flourishing electricvehicle industry, and Vietnam, with its expanding solar capacity, are already capitalizing on growing demand for green energy.

Mobilising capital is crucial to achieving net-zero emissions. As William Shakespeare reminds us, "If money go before, all ways do lie open." To create a greener and more resilient region, we must reimagine climate finance in a way that aligns with the unique characteristics of Asean+3 economies and unlocks their tremendous potential.

Anju Will Return To India **On August 20; No Plan To** Marry Her: Pak Man

PESHAWAR: A married Indian woman who travelled legally to a remote village in Pakistan to meet her Facebook friend will return to India on August 20 when her visa expires, her Pakistani friend said on Monday, dismissing reports of any love affair between them.

Nasrulla, 29, said that he has no plan of marrying 34-yearold Anju, who was born in Kailor village in Uttar Pradesh and lived in the Alwar district of Rajasthan.

Nasrulla and Anju became friends on Facebook in 2019.

"Anju is on a visit to Pakistan and we have no plan to mar-ry," Narulla told PTI over the phone from village Kulsho in the district, some 300 km from Peshawar.

"She will go back to her country on August 20 after her visa expires. Anju is living in a separate room of his home with the other female members of my family," he said.

Anju has travelled to the Upper Dir district of Pakistan's tribal Khyber Pakhtunkhwa province on a valid Pakistani visa of Pakistan's to meet Nasrulla.

According to an official document of the Ministry of Interior sent to Pakistan's High Commission in New Delhi, the chancery was informed that it had been decided to grant a 30day visa to Anju, valid for Upper Dir only.

Nasrullah, a science graduate from a University in Sheringal, is the youngest among five brothers.

He has given an affidavit to local authorities, stating that there is no love angle to their friendship, and Anju will return to India on August 20.

The affidavit also states that she will not move out of the Upper Dir district. "She will definitely go back

on August 20 as per her visa documents," said Upper Dir District Police Officer (DPO) Mushtaq Khan.

Khan interviewed Anju in his office on Sunday and checked her travel documents on the basis of which a no-objection

certificate was issued to her. While Nasrullah has rejected any love angle to his friendship with Anju, police officer Khan said she came to Pakistan "for the sake of love".

"Anju has come to Pakistan from New Delhi for the sake of love and is living happily here," Khan was quoted as saying by Geo News.

He said the investigations into Anju's arrival in Pakistan have been completed.

"She travelled to Pakistan on a month-long visit visa and all her travel documents are valid and complete. Locals are presenting gifts to Anju, she is happy here," he said.

The DPO also stated that Anju does not want to interact with the media for any interview. According to the report, Anju

told local journalists her friendship with Nasrullah began on Facebook and later blossomed into a love affair.

She said she loved Nasrullah which prompted her to travel to Pakistan. Nasrullah said they have been provided adequate security by the district administration and Anju is safe and sound with his family.

The villagers, mostly Pashtuns who are very religious people, want Anju to return safely to India as they do not want any bad name for their community due to this incident. Anju's husband Arvind, who is in Rajasthan, is hopeful that

his wife will return soon. They have a 15-year-old daughter and a six-year-old son. Anju's incident is similar to Seema Ghulam Haider's case. Seema, a Pakistani mother of four, sneaked into India to live with Sachin Meena, a Hindu man she got in touch with while playing PUBG in 2019.

Seema, 30, and Sachin, 22, live in the Rabupura area of Greater Noida, near Delhi, where he runs a provision store, according to Uttar Pradesh Police.

Logjam In Parliament As Shah **Urges Oppn To Allow Truth To Come Out On Manipur Issue; AAP** MP Sanjay Singh Suspended

NEW DELHI: As the logjam in Parliament persisted for the third day, Home Minister Amit Shah on Monday asked the opposition to allow a debate on the Manipur issue to begin but both sides stood rigid on their stand while AAP MP Sanjay Sanjay Singh was suspended during uproar in the Upper House for the rest of the mon-

soon session. Relentless protests from opposition members, who insisted on a statement from Prime Minister Narendra Modi before any debate, marred the proceedings in both Houses while charges and countercharges flew thick and fast outside Parliament.

alleged Congress The that the prime minister was "scared" of a discussion in Parliament, but the BJP claimed the opposition was running away as it does not want certain facts to come to

the fore. Aam Aadmi Party MP Sanjay Singh, one of the more vocal voices in Rajya Sabha, was suspended for repeatedly "violating" the directives of the Chair after he rushed to the well of the House and pointed at the Chair during protest by opposition members on the Manipur issue.

Moving a motion for Singh's suspension that was adopted by voice vote, Leader of the House Piyush Goyal said such behaviour was not acceptable as the member was disturbing the House and was disregarding its ethics and rules. Prior to that, Rajya Sabha chairman Jagdeep Dhankhar named

Singh for his "unruly behaviour" and cautioned him. Opposition parties condemned the action against Singh and accused the government of trying to throttle their voice.

Sanjay Singh, however, remained inside the Rajya Sabha chamber as a mark of protest, and moved out after the house was adjourned for the day. He then sat on a protest before the Gandhi statue along with other opposition MPs.

Leaders of various parties urged the chairman to reconsider his decision and revoke the suspension.

The RS Chairman later met the Leader of the Opposition Mallikarjun Kharge and discussed the way forward to break the deadlock on both sides.

Protests ruled the day inside both Houses despite attempts by Dhankhar and Defence Minister Rajnath Singh to end the impasse. Since the session began on July 20, little work has been done in Parliament. Opposition members have

seized on the viral video of two women stripped and paraded by a mob from another community in the violence-hit state to corner the government.

While the government has expressed its willingness to a debate on the situation in the BJP-ruled state, the opposition has made a statement from Modi a precondition for any discussion on the issue.

As slogan-shouting by opposition members in Lok Sabha, many of whom were in the well of House, continued, Shah spoke briefly, questioning their intent despite his willingness to debate.

The government has said that the Home Minister will reply to any such debate on the Manipur issue.

"I am willing for discussion in Lok Sabha on the situation in Manipur but do not know why the opposition does not want it," Shah said.

He said opposition leaders should allow a debate, saying it was important for the truth

to come out before the country on the Manipur issue.

As opposition members continued their protest, Speaker Om Birla adjourned the proceedings for the day.

The MPs of the BJP as well as the Opposition staged protests near the Mahatma Gandhi statue to highlight their demands.

Addressing a press conference at the BJP headquarters here, Union Minister Smriti Irani said, "When the Home Minister is asking them to come and discuss, what are the facts of Manipur violence that the Congress wants to hide."

"What is it that the opposition doesn't want the country to know? Why is the opposition running away from the truth of Manipur?" she added. Congress leaders Shaktisinh

Gohil and Gaurav Gogoi accused the BJP of "shielding" the prime minister from speaking inside Parliament and treating the Manipur crisis as an ordinary law-andorder issue.

"We want a substantive and exhaustive debate on Manipur in Parliament. The prime minister is running away from scrutiny by members of opposition parties and is scared of a debate on Manipur in Parliament," Gogoi told

reporters. Congress president Mallikarjun Kharge accused Modi of insulting Parliament by choosing to speak on the Manipur issue not inside the House but outside.

Party leader Jairam Ramesh said parliament did not function for the third day because of the "continued refusal of the Modi Government to accept the demand of INDIA parties for a comprehensive statement by the Prime Minister in the House on the post-May 3rd situation in Manipur to be followed by a discussion".

Yamuna Floodwater Yet **To Recede, Despair Grips** Farmers At Relief Camps

NEW DELHI: Puja Devi (47) visited the area along the Yamuna river multiple times in the past 15 days in the hope that the water that inundated her home will have receded. But every time her hopes are dashed and she returns to the relief camp dejected.

Now, she fears that she will not be able to return to her humble home after officials told them that their shanties were "illegal".

They will not be allowed to return even after the water reduces, they were told.

While living under constant fear of losing their home, the abysmal conditions at the relief camp are causing further hardship for the family of 14.

Puja Devi has been living at the relief camp since July 11. 'The meals we get are half-

cooked most of the time. It would be better if the government provided us with ration instead of half-cooked food," Puja Devi alleged. She had been living along

the Yamuna's bank for decades with her 10 children, husband and mother-in-law, dependent on the agricultural land for sustenance.

The family was forced to vacate the area when water entered her home and destroyed the small agricultural land where she cultivated vegetables.

At 208.66 metres on July 13, the Yamuna surpassed its previous record of 207.49 metres set in September 1978 by a

significant margin. It breached embankments and penetrated deeper into the city than it has in more than four decades.

The consequences of the floods have been devastating, with more than 27,000 people evacuated from their homes. The losses incurred in terms of property, businesses and earnngs have run into crores.

The Yamuna in Delhi flowed more than a metre above the danger mark of 205.33 metres on Monday morning.

Puja Devi and her family are not the only ones suffering.

Kali Charan, a 44-year-old daily-wage worker, said his wife Sandhya Devi fell while being evacuated and is now suffering from a severe pain in her leg.

"The medicines that we are getting are not working properly. I don't have the money to provide proper treatment to my wife," he added.

Om Prakash, a 30-year-old father of three, said, "There are no jobs. I have no clue how I will earn my livelihood."

He also mentioned that the food and water at the camps are not regular and sometimes they have to sleep on an empty stomach. His children are unable to attend school as their books, bags and uniforms were washed away in the flood.

"I am not sure if I will get my land back but I request the government to let us stav here. We are poor people and we have nowhere to go. At least by farming here, we earn some amount to feed our families,' he said.

When asked if the discussion with the administration was held only on Muharram 8th procession, the Agha Mujtaba said that the two banned processions from Guru Bazar to Dalgate and 10th Muharram procession from Abi Guzar to Zadibal always remain on the agenda of his organization.

Meanwhile, later in the day, a meeting was held at the Police Control Room (PCR) Srinagar between senior police officers with the representatives of Shia organisations.

'The police want a cap on the numper of mourners participating in the 8th Muharram procession. They want around 200 mourners in the procession. It's practically impossible to limit this procession, if taken out after 34 years," said a Shia representative, wishing not to be named.

Business Growth

"However, on liability side there is slight de-growth on QoQ basis. Although this has opened which shall, over-time, accumulate sizable balances," he said.

Capital Position

The bank's Capital Adequacy Ratio stood at 14.83% as against 13.02% recorded last year.

Elaborating upon capital position, the MD & CEO said, "After achieving the target of 15% CRAR during the last year, we are looking at a capital adequacy ratio of about 16% by the end of this fiscal. Even though we expect major accretions from internal accruals but plans are in place to raise capital from the market, if required."

Pertinently, the Bank has an enabling board approval for raising of capital towards the end of current fiscal (Q3/Q4).

JKPC Leader Alleges 'Humiliation' By Bureaucrat In **Muharram Meeting**

Srinagar: The Jammu and Kashmir People's Conference on Monday alleged that senior party leader and influential Shia cleric Imran Ansari was "humiliated" by the administration during a meeting chaired by Lieutenant Governor Manoj Sinha on Muharram arrangements.

'JKPC strongly condemns the behaviour displayed by the state administration towards Imran Ansari, an eminent religious leader of the Shia community. We express deep concern over this dangerous precedent being set by the administration. It started the humiliation of political lead-ers, and now they are moving on into the domain of humiliating religious leaders," a spokesman of the party said.

He said it certainly does not behove the head of the state administration, even if "he is regrettably selected and not elected", to preside over and voluntarily facilitate the humiliation of a religious leader, who was invited cordially.

According to sources close to Ansari, the Shia leader had



taken exception to the administration setting a cap of only 100 persons for taking part in the Muharram processions on traditional routes in Srinagar, which have been banned for the past three decades

Ansari had highlighted while the entire administration and locals of Kashmir were welcoming the lakhs of Amarnath pilgrims, there was no justification for setting the limit on number of persons in the Muharram procession, the sources said. They said a senior bu-

reaucrat, who was present in the meeting, objected to Ansari hinting at sectarian discrimination by the administration which led to exchange of words between the two. Ansari later walked out of the meeting, the sources said.

When contacted, Ansari said it pained him to see "this daily dose of humiliation for Kashmiris".

Centre Likely To Reserve 3 Seats For Kashmiri Migrants, PoJK **Refugees In J&K Assembly**

Srinagar: The Central government is mulling to amend the Jammu & Kashmir Reorganisation Act to reserve three seats in the Jammu & Kashmir Legislative Assembly for Kashmiri migrants and refugees from the Pakistan occupied Jammu & Kashmir (PoJK).

Sources said that the Centre is planning to bring "The Jammu and Kashmir Reorganisation (Amendment) Bill, 2023, in Parliament to reserve two seats for Kashmiri migrants and one for refugees from PoJK. These members will be nominated by the Lieutenant Governor of Jammu and Kashmir Union Territory, they said.

According to sources, the bill states that Jammu & Kashmir's Lieutenant Governor may nominate not more than two members, one of whom shall be a woman, from the community of Kashmiri migrants, to the Jammu and Kashmir Legislative Assembly. It further states that LG

may nominate one member from displaced persons from Pakistan occupied Jammu and Kashmir to the Jammu and Kashmir Legislative Assembly.

The bill is aimed at "preserving political rights of the migrants and refugee communities as well as for their social and economic development"

It is worthwhile to mention that the delimitation commission headed by former Supreme Court judge Justice (retd.) Ranjana Desai had recommended to

SYDNEY: After missing out on Lionel Messi, Saudi Arabian soccer team Al-Hilal made a record 300 million euro (\$332 million) bid for Kylian Mbappe on Monday, an offer which could see the France striker join Cristiano Ronaldo in the oil-rich kingdom.

Paris Saint-Germain confirmed the offer for its player and has given Al-Hilal permission to open negotiations directly with Mbappe.

The 2018 World Cup winner is in a contract standoff with PSG after his decision not to take up the option of a 12-month extension on his deal. Instead, he plans to walk away as a free agent at the end of the upcom-

ing season when he is widely expected to join Real Madrid.

PSG cut Mbappe from its preseason tour of Japan on Saturday, with the French club determined to sell him unless he can be convinced to sign a new contract. A new deal now looks highly unlikely with relations between the 24-year-old Mbappe and PSG becoming increasingly tense. (AP)
