## **10,000 Woman Have Gone Missing** In J&K From 2019 To 2021: Centre

- Have Taken Various Steps For Safety Of Women: Union MoS Home; • Excessive Use Of Social Media Main Reason: Officials

Srinagar: In a shocking revelation, the Union government on Friday disclosed that almost 9,765 women have gone missing from J&K in three years (2019 to 2021) with officials citing excessive use of social media as the main reason behind the missing cases. The government of India gave the figures in parliament on Friday in response to a question in Rajya Sabha. The Minister of State for

Home Ajay Mishra informed the parliament that 9,765 women have gone missing from their homes in Jammu and Kashmir between 2019 to 2021.

In these three years, there were 1148 cases of missing girls below the age of 18 and 8,617

### **SIA Files Chargesheet Against Two** Jama'at Members

Srinagar: The Special Investigation Agency (SIA) Kashmir on Friday filed a chargesheet against two banned Jama'at-e-Islami members, one among them dead, in a case registered under the unlawful activities prevention (UAPA) Act.

The chargesheet was filed in case FIR No. 17/2019 u/s 10 UA (P) Act of Police Station Batmaloo, registered on 1 March 2019 and later transferred to SIA Kashmir in December 2021, an official spokesperson said.

SIA, he said, filed the chargesheet on Friday before the Special UAPA (TADA/ POTA) Court, Srinagar against Ab Salam Dagga of Bagji Islam Lal Nagar Chanapora Srinagar and abate chargesheet against Mohammad Shafi Dar of Barzulla Baghat Srinagar, who has expired.

### **Amit Shah Slams Oppn Alliance INDIA**

### Says Nothing Will Happen By Change In Name

Rameswaram: Union Home Minister Amit Shah on Friday slammed the Congress and its allies, including the DMK, saying nothing would happen by changing the name of their alliance to INDIA.

The senior BJP leader was addressing a rally here, ahead of kick-starting Tamil Nadu BJP President K Annamalai's statewide 'En Mann, En Makkal (My Land, My People)' padayatra.

"When Congress and its allies, including the DMK, go to the people seeking votes, the public would remember the corruption, including the 2G scam and CommonWealth Games scam during the UPA

### regime, " Shah said.

Congress-DMK and allies opposed the removal of Art 370; is Kashmir ours or not," he asked. Taking forward Prime Minister Narendra Modi's Tamil pitch, he said Modi honoured Tamil culture by installing the 'sengol' in the new parliament building.

Shah hit out at the DMK regime, calling it the most corrupt in the nation and said the BJP yatra is an attempt to usher in politics of development and good governance in Tamil Nadu. He named Congress and its allies one by one, including the DMK, Trinamool Congress and Shiv Sena (UBT), and accused them all of trying to empower their families and not the nation. More on P6

### **Unauthorised Absence Gravest Misconduct By Forces Member: HC** Upholds Dismissal Of Personnel By CRPF In 2018

Srinagar: Absence from duty without leave for a member of the Force is a gravest misconduct, the High Court of J&K and Ladakh has said while upholding termination of services of a paramilitary CRPF personnel. A bench of Justice Sanjay Dhar made the observations while dismissing a petition filed by the CRPF man, Reyaz Ahmad Khan, challenging an order by the paramilitary force dated 31 July 2018, by virtue of which he was dismissed from service.

According to Khan, he was appointed as a Constable in Central Reserve Police Force (CRPF) and was posted in 231 Bn. Khan said that leave was

sanctioned in his favour from 10 April 2017 to 9 May 2017 but after the period of leave was over, he was unable to resume his duties. Khan said his

son suffered vision disability, as a result of which he had to be admit-

ted to hospital at Srinagar for treatment. Khan later applied for extension of leave

which was granted, in the first instance, for eight days and thereafter for another ten days. Ultimately, Khan said that he joined the duties 12 December 2017 and performed his duties there upto 31st July, 2018. All of a sudden, he said, his

services were terminated in terms of order dated 31 July 2018 and even his appeal against the order was dismissed. Among others, Khan

had challenged the orders on the ground that he was furnished the notice of show cause in Hindi script which he was not able to understand, as such, he could not respond to the show cause notice.

On the other hand. CRPF said that a Court of Inquiry was also ordered by the Commandant on 17th October, 2017 and it came to the fore that Khan had overstayed his leave with effect from 29 May 2017 without any intimation and permission of More on P6

### **Novel Antibiotic To Treat Serious Bacterial Infections Being Developed**

esearchers are developing a new broad-spectrum antibiotic compound aimed at treating serious infections caused by multidrug-resistant bacteria, especially in high-burden countries, including India.

The compound, BWC0977, is hoped to treat patients in both critical care and community settings. It has the potential against infections that are becoming progressively difficult to treat due to the increase of antimicro-

bial resistance (AMR) in pathogens, such as Acinetobacter baumannii and Klebsiella pneumoniae.

Currently, the most difficult-to-treat infections are caused by Gramnegative bacteria, which have become resistant to most available antibiotic treatments, the researchers said. Development of new antibiotics that are effective against such infections is critical to counter the public health crisis in hospitals everywhere, but especially in countries with a high burden of AMR, they said.

"Since 2019, we have been following with interest the development of BWC0977 as a potential treatment for drug-

### Auqaf Jamia Pays Tributes To Martyrs Of Karbala



### Dramatic Encounter Rattles City Centre

1 Killed, scores hurt as militants target security forces in Budshah chowk

RINAGAR - Militants struck the busy business hub of the capital city this evening setting off a fierce gunbattle with security forces in which an unspecified number of people, including five media persons and half a dozen security personnel, were injured.

The militants hurled a grenade at a Maruti Gypsy of BSF (JKO1E-3803) setting it on fire and later opened fire at a BSF armoured vehicle at the KMD bus stand in the close vicinity of Akhara building at around 5 pm, official sources said adding the militants then barged into the Bengal-Gujarati hotel and began firing at security personnel outside. The security forces hit back triggering an exchange of fire and the gunbattle continued till late hours Friday.

Six mediapersons—four cameramen and two press photographers—were injured in the incident while performing. Three BSF personnel, a police constable and five civilians were also injured in the initial exchange of fire which erupted when the area was teeming with people most of them heading homes after office hours and some busy shopping. The injured civilians included a woman and son of a Congress worker. At least two militants remained holed up in Auqaf building

At least two militants remained holed up in Auqaf building and an adjacent one. The buildings are located near the Aknara building which houses the hol mace of Hindu diety Shiva besides large number of BSF troopers.

Later both the buildings were surrounded by security forces and intermittent firing between the two sides continued as the troops were making efforts to neutralize militants till late in this evening. Al-Mansoorian and Jamiat-ul-Mujahideen militant outfits claimed responsibility for the dramatic attack in separate statements to a local news agency but gave no further details about the intended target or about the number of militants involved in the strike.

A police vehicle which was passing the area at the time of the firing was hit by a stray bullet in the petrol tank setting it on fire. The vehicle was gutted in the fire but the driver managed to jump out of it in the nick of time, the sources said. Fire brigade personnel rushed to the scene immediately to douse the flames.

The heavy exchange of fire led to the closure of all shops and business establishments in the area and adjacent busy business centres of Lai Chowk, Koker Bazar, Gawkadal, Red Cross Road and Amirakadal.

The busy roads wore a deserted look with only security personnel moving the scene of the gunbattle as reinforcements

were called in. Movement of traffic came to a standstill in the area.

"This was a fidayeen attack. A group of militants fired at the paramilitary pickets in Akhara building and simultaneously a grenade was launched at a police jeep in the same area," Inspector General of Police Javaid Makhdoomi said.

"It was a coordinated terror act. The security forces foiled the attempt of the militants to enter the Akhara building, which houses a temple of Lord Shiva called Chhari Mubarak."

With all its glory and importance, it is however, in a state of wrath. It is appalling to learn that Vitasta (River Jhelum) has begun to intimidate its own caretakers and guardians because they have been fiddling with mother nature unabatedly.

Hydaspes very often swells up to incessant and torrential rains during summer seasons, and consequently, threatens Kashmiris of catastrophic fury. Kashmir valley has experienced the wrath of Jhelum in the past, at many occasions. Since the valley is a cold region, abundant rains and snow are indispensable for its sustenance. So, prolonged snow spells and pretty large amounts of rains are quite common during winter and spring seasons. But, summer months often provoke the Jhelum to spate and anger when it rains heavily. Monsoon winds coupled with occasional western disturbances often create frenzied visuals in the Veath. The havoc wreaked by relentless spells and showers in 2014, is still fresh on the canvas of our reminiscences. The fury of nature then had turned the valley into an ocean where commoners were terribly battling to survive.

Recent torrential rains in the Himalayan regions of India like Uttarakhand and UttarPradesh are enough to send shivers down our spine.

Though rains in the plains of Kashmir during June and July 2023 have been intermittent and scattered but the discharge in Hydespas (River Jhelum) and its other tributaries has been exceedingly high and horrifying. I won't deny the copious amounts of rains at higher altitudes of our valley which have been instrumental in the surge of the river.

But, the scary discharge levels in the river Jhelum were quite unusual and unanticipated.

The disproportionate gush in the river should not be attributed to rains alone but there is also probably an underlying phenomenon which infuriates the river. Rise in surface temperature of the planet, called global warming, is a bug responsible for this execrable change. Incendiary temperature at regional and global level, is aggravating the crisis. Our own valley of Kashmir is entrapped in this ghastly calamity.

River Jhelum is the chief source of irrigation and drinking water for major areas of the valley. So, sufficient flow in it is significantly important for our survival. But, the unusual discharge in its basin has become a double edged sword for us. On the one hand, it poses terrible threat to life and property, and on the other hand, it hollows us silently. The alarming recession rate of our glaciers is a serious cause of concern for all of us. Going by this rate, our aquatic resources are sure to dry up very soon. Our progeny and future generations will curse us for being callous and insensitive towards the grave issue. We can't afford to be complacent and callous. We must take concrete steps to minimise the recession rate of our glaciers.

Since our valley is an eco-sensitive region, so we must be extra cautious towards our environment and its different components. We have begun to fiddle with eco-sensitive regions. Polythene bags, wrappers of junk foods, plastic bottles and other materials are seen abundantly piling up in forests, water bodies, glacial sites and other eco-sensitive spots. Nature invites us to explore its hidden treasures, but unnecessary human intervention and meddling is proving costly for us. We definitely can't eliminate the plastic from our lives, but we can certainly safeguard and conserve our natural resources and treasures from its ill effects. Though management of non-biodegradable waste viz plastic products is a daunting challenge for the entire humanity, but there are certain ways to combat it.

Plastic alone is not the fons-et-origo of the drastic climate change. Deforestation is another detrimental factor which has caused severe damage to our environment. Plundering the green-gold has become a norm in our part of the globe. Both commoners and people at the helm chop trees in one or the other pretext. If axing trees to meet different human requirements and necessities becomes inevitable at times, then we must not forget to plant new trees against the chopped ones. It will help us to maintain the ecological balance of the susceptible and eco-sensitive regions like Kashmir. Ironically, we pay no heed to it. Even Islamic teachings stress upon the conservation and management of the environment. Sustainable development of natural resources is inevitable to sanctify the truth of " Live and let live.'

Emission of greenhouse gases is yet another detrimental factor for the obnoxious climate change. Impact of global warming on climate stirs the souls of sensitive people. Europe is bracing up for its hottest ever temperatures. Sicily and Sardinia in Italy are sizzling at 48 degrees centigrade. The whole world is caught up in the cruel pangs of the warming. Our valley is now no exception to it. Number of petrol and diesel vehicles has increased manifold. Consequently, the temperatures are soaring. And the mounting mercury infuriates the Vitasta and other rivulets. A potential flood threat is still looming large on us. But, we are in a deep slumber. The crisis may go from bad to worse, if a pragmatic approach is not adopted by both commoners and people at the helm.

### Nep2020: Leading India Into A Knowledge Revolution

nowledge is power. India's rich knowledge capacity is evident in the Vedas and Upanishads, serving as vast sources of wisdom for centuries. With our ancient Indian universities such as Nalanda and Takshashila, India has been an International Knowledge hub of the past. Over time, India's knowledge prowess and wealth attracted many, including the Mughals, Mongols, British, Dutch, and Portuguese, who invaded India in various periods of time in history resulting in a significant destruction of India's knowledge treasures. But it is well known and accepted, that while the invaders could loot our lands and destroy our universities, they remained defeated by the Gurus and Yogis of our land.

While Britain led the world during the second Industrial Revolution, it was the United States that led in the third. Today, as India surpasses Britain to become the fifth largest economy globally, the time is ripe for it to once again become the epicenter of knowledge and lead the world into the 4th Industrial Revolution marked by exponential growth in new and emerging technologies.

Amidst these expected changes, in 2014, Hon'ble Prime Minister Narendra Modi set forth a vision to transform India's education system into a global knowledge powerhouse of the 21st century. With over 260 million school-going children and over 40 million students in higher education, India's education system is one of the largest globally. After extensive discussions with stakeholders, including public, the National Education Policy (NEP) 2020 was launched after a gap of 34 years. As we approach July 29th, 2023, we celebrate NEP's third anniversary with a 2-day Akhil Bhartiya Shiksha Samagam – a 'Maha Kumbh' on Education.

Last three years of NEP has seen significant achievements. For the first time in India's history, Early Childhood Care and Education (ECCE) is integrated into the formal schooling system, recognizing the evidence that over 80% of the child's cumulative brain development happens before the age of 8. Additionally, a play-based pedagogy is emphasized in the development of the first National Curriculum Framework for Foundational Stage (NCF-FS), catering to children aged 3-8. This framework incorporates diverse activities like conversations, stories, music, arts, crafts, games, nature field trips, and interactive play with materials and toys. An exemplar of this approach, the Jadui Pitara (Magic box), has been created for schools to adopt.

Textbooks for classes 1 and 2 based on NCF-FS are released, complementing the national NIPUN Bharat Mission to achieve foundational literacy and numeracy by 2026. Around 150 new skilling and vocational training program to students and dropouts.

Furthermore, a unique National Credit Framework (NCrF) has been introduced that credits formal and informal learning, spanning school, higher, and skill education & training. NCrF enables multiple entry and exit at various levels, allowing students to re-enter the higher education system any time in their life. Credits will accumulate in a student's Academic Bank of Credit (ABC) for recognition.

Technology is enabling students to pursue degree programs online, offering increased flexibility to learners and enhancing access to quality

textbooks will be made available, aligning with the upcoming National Curriculum Framework for School Education (NCF-SE). These will be the books of the Amrit Kaal and will be developed in at least 22 Indian languages, promoting the vision of multilingual education under NEP2020. Digital versions of textbooks are being made accessible through PM e-vidya, ensuring equitable and ondemand access. PM SHRI Schools for Rising India representing the true spirit of NEP are also being set up across the country.

NEP 2020 has given special emphasis on vocational education through its integration and mainstreaming with general education. We are creating alignment between Samagra Shiksha and the Skill India Mission to introduce skilling programs at school level. 5000 Skill Hubs are being set up in schools to provide comprehensive education, especially in remote areas. Credits can now also be earned through online courses on the SWAYAM portal and soon, a Digital Universityone of its kind will be set up in India.

The digital ecosystem for skilling has also been further strengthened with a unified Skill India Digital platform for enabling demandbased skilling, linking with employers, including MSMEs, and facilitating access to entrepreneurship schemes. We are also working on to facilitate global mobility of skilled candidates. 30 India International Skill Centres are being set up aimed at imparting international standard skill training to the youth and enhancing overseas opportunities for the skilled workforce. Over 330 new age courses specifically tailored to meet the needs of Industry 4.0 have been developed.

To overcome language barriers in learning,

many Higher Education institutions are now offering technical programs in many Indian languages. AI translation tools are facilitating the translation of textbooks into different Indian languages. Major entrance exams like JEE, NEET, and CUET are now available in 13 languages.

In the realm of internationalizing education, India's institutions are setting up campuses overseas. While IIT Madras is going global with its planned campus in Zanzibar-Tanzania, an MoU to set up IIT Delhi in the UAE was also signed in the presence of PM Modi himself earlier this month. Notable foreign universities are also setting up their campuses in GIFT City in Gujarat, and there are ambitious plans to further expand the presence of other Indian institutions, including a school board, overseas in the near future.

The dream of Viksit Bharat under the Amrit Kaal can only be achieved by fulfilling the aspirations of the Amrit Peedhi. With about 65% of our population in the working age group, we must create frameworks for an age in which lifelong learning and skilling are expected to become the order of the day.

Driven by the spirit of Vasudhaiv Kutumbakam, India is on its way to becoming a de-facto leader of the 21st century. And NEP plays a vital role in connecting this transformation to the present reality. By emphasizing rootedness in India's Knowledge Systems with an outlook to make global citizens, it has the potential to be a guiding philosophy for creating a knowledge-based society anywhere globally, especially for the poor and emerging economies that are looking to break free from the shadows of colonization. As NEP enters into its fourth year, its success will mean a Viksit Bharat (Developed India) by 2047 and a global world order centered on knowledge sharing and peace.

# Hussain Ibn Ali Humanity's Lore

umanity is defined as the quality or state of being kind to others – humans or even animals. An approach derived from appreciation of human values and ofunique ability of the humans to express it.

In Islamic sense, it primarily stems from the divine direction - inni akhafullaha rabul aalameen (Holy Qur'an, 59:16) "... Surely, I fear Allah, the Lord of the worlds". Precisely, the sense of humanity demands capacity of a person to offer care, respect, express hospitality, exhibit love and tolerance, extend forgiveness and express ability to promote equality. Philosophers say, that in lighter sensehumanity means happiness and in wider sense it can be obtained by virtues, that is full understanding of our morals and strengths. But for the infallible Imams (a.s.), it is their divine *fikr o amal* and simple manifestation to guide us.

The lives of the infallible Ahlul Bayt, a.s., are not mere lives but a set of ideals – *Eisaar, Sabr, Ehtiram, Ibadat, Ikhlaq, Insaaf, Haya, Masawaat etc. (sacrifice, patience, respect,prayer, manners, justice, haya, equality, etc.)* to guide theadherents of faith to shape an ideal society based on these values. Remembering the martvdom of Hussain (a.s.), didn't want to affirm the arrogance and unjust dictates of Yazid so that anti Islam barbarous acts would get unduly established. In this pursuit his other companions of Madinah like Abdullah ibn Abbas, Abdul Rahman ibn AbiBakr and Abdullah ibn Zubair participated, being familiar with the habits and style of Yazid & thus wouldn't consider legitimacy of Yazid. This made smooth sailing for Yazid difficult, threatening his fragile empire and empty grandeur.

Yazid sent a letter to Walid, his cousin, formally informing about the demise of his father, Muawiya, on 22<sup>nd</sup> Rajab 60 Hijr. Then he wrote a second letter asking him to coerce Hussain Ibn Ali, a.s., and his companions for allegiance *(baiyyat)* of Yazid and in case of their defiance be harsh. He, as required by the soA small caravan, including women and children left on that common highway to Makkah which Abdullah ibn Zubair skipped and rather chose some uncommon route. The Imam (*a.s.*), thought that none should perceive that he left for war, accompanying the decedents of Abu Talib including women and children, and none should say that he fled deceptively. That is why he chose the highway.

The Imam *(a.s.)*, left from Madinah to the sacred land of Makkah where Hajj had to be performed after some months and possibility of meeting entire Muslim ummah on this sacrid & peaceful land. On 3<sup>rd</sup> Shaban, 60 Hijri, Thursday, the Imam, a.s., reached Makkah and stayed at Shaab e Ali. And people came in groups to meet and thus Imam attained focus and by then Abdullah ibn Zubair had also reached. Already having seen, sensed


the

ingly stood against him at Karbala, a twist apparently unperceivable. But all was designed.

After 150 days of tiring journey that saw his caravan cross over 900 miles, the Imam (*a.s*)., finally reached Karbala, also called *Nainawa, Ghazarya, Shabte Furat*, on 2<sup>nd</sup> Muharram 61 Hijri (2<sup>nd</sup>October, 680 AD), Thursday.

Wrote a letter to Habib ibn Mazahir, who along with Muslim bin Aqeel joined on 5<sup>th</sup> or 6<sup>th</sup> Muharram. Then followed initial defiance & subsequent martyrdom of Hurr, by some historians was the first martyr. In the small army of the Imam, a.s., comprising around 70 persons , were very elderly like Muslim ibn Owsaja and Habib ibn Mazahir. The army of Yazid would number between 35,000 to 1,00,000 as numerously written. On 10th Moharram night, the Imam, a.s., and his companions including children, and an African-Kaneez, Hazrat Fiza (r.a.), all showed gracious contentment. Hussain ibn Ali (a.s)., put off the candle during the

Ashura night, so that anyone desiring to leave could. But none left. The night passed in prayers. The dawn of Ashura saw the gloomed sky, the day saw the offering of sacrifices one by one, om six month old Ali Asgar ibn Hussain, a.s., to 75 year old Habib ibn Mazahir. Then came Zuhur (noon time) when Hussain ibn Ali (a.s.), stood for the prayer and lost his devout companions shielding him and finally around Asr (afternoon) the Imam was martyred most inhumanely with hundreds of body wounds with sacred head severed. Thus began another epoch of trail and tribulations for the survivingBani Hashim women, children and ill ones to cross numerous cities from Karbala to Syria and finally to Madinah, covering nearly 1414 miles. The legendary daughter of Ali ibn AbiTalib (a.s.), sister of Hussain ibn Ali, a.s., Hazrat Zainab, s.a., enroute delivered the sermons and at the Yazid's Court at Syria (Shaam) which shook the tyrants. The faith that once was groomed and nurtured after centuries of age of ignorance in the Arabian peninsula, saw its doomed canvass painted with blood of the pious and saintly, which renewed the Islamic message of humanity & peace. Historically seen, Hussain ibn Ali, a.s., could have sought the support from the neighbouring kingdoms "and even escaped to a fortress in the desert that had defied the power of Caesar and Chosroes and confided in the fidelity of the tribe of Tai, which would have armed ten thousand warriors in his defence", Writes Gibbon (Decline & Fall of the Roman Empire). But the Imam (a.s.), never wanted war but something beyond before the will of Allah. He chose victory of right over wrong, of fair over unfair, of just over unjust, of devout over deviated, of compassion over arrogance, of sacrifice over forbid, of benevolence over greed, of knowledge over ignorance. The message of humanity lives on even after 1400 years with its beauty of intention & expression.

While nurturing these virtues of humanity and sacrifice, the grandson of Prophet Muhammed (*s.a.w.a*) Hussain Ibn Ali (*a.s.*), avoided foreseeable blood shed at the holy land of Madinah and moved towards Makkah and then to Kaufaturning Hajj into Umrah. To understand the aforesaid ideals and wisdom (*hikmah*) of Hussain ibn Ali (*a.s.*), a brief glance at the historical events would lend credence to it. The history goes – Hussain Ibn Ali,

a.s., left Madinah in a state of hope and apprehension like Prophet Musa, a.s., who in hope and fear, when unjust Bani Israelites were planning for his murder, had left Egypt to Madinah as ordained by Allah (Holy Qur'an, Sura al-Qasas, 28: verse 21) " So he (Musa) lefttherefrom, fearing, awaiting (and) he said, My Lord ! Save me from the unjust people' An acclaimed Islamic scholar, Tabri in his book Tareekh e Islam (vol. 6) writes that when Hussain ibn Ali (a.s.), left Madinah on 28th Rajab, 60 Hijri, Sunday evening , in a similar state of hope and apprehension, same verse of holy Qur'an (28:21) was on his lips, seeking refuge of Allah from the unjust people to avoid foreseeable blood shed at Madinah. A similarity of situation and the will of Allah. Hussain ibn Ali, a.s., in a state of loneliness and estranged world, never intended to stir conflict in the turbulent land of his grandfather but to remain silent, sensing the fragile and unjust situation, barely 50 years after the Prophet's passing, so that blood of the innocents is not shed. He preferred silence over conflict & affliction, leaving no chance to the future historians to allege that Imam got into an avoidable conflict and wasted sanctity of Madinah. Simultaneously, by remaining silent, Hussain ibn Ali

### **KIMS Doctors Achieve** Breakthrough, Saves Young Girl's Life with Complex **Spine Surgery**

Bhubaneswar: Kalinga Institute of Medical Sciences (KIMS), Bhubaneswar has successfully given a new lease of life to a teenage girl from Bhadrak, who was battling a spinal deformity known as Scoliosis. The abnormal curve in her spine gave it an 'S-shaped' appearance, threatening her promising future. However, thanks to the expertise of the doctors at KIMS, her spine was meticulously corrected in a recent complex operation, and she is now on the path to a full recovery, ready to embrace a normal life once again. This ground-breaking sur-

gery marks the first time a private hospital in Odisha has performed such a complex procedure, reaffirming KIMS's position as a leading provider of ad-vanced healthcare in the state. The operation was skilfully carried out by Senior Consultant and Orthopaedic and Spine Surgeon, Dr. Jitendra Kumar Rout along with Anaesthsist Dr Sanjeev Giri and Dr Rajmohan. The girl's family visited several hospitals for treatment, including AIIMS, but had lost hope until they arrived at KIMS. After studying the case in detail, the medical team proceeded with the life-changing surgery, which was covered under the Biju Swasthya Kalyan Yojana (BSKY) scheme.

Notably, Dr. Rout, who is also the Secretary of the Spine Society of Odisha, accomplished the challenging operation in an impressive four hours, a procedure that typically takes 7-8 hours. The success of the surgery was further aided by the use of an advanced 'intraoperative neuro monitoring' machine, which promptly alerts the doctors to any potential complications during the procedure.

"We pressed for the permission of the 10th Muharram procession on the traditional Abiguzar route. However, as per the traffic advisory, Ashura procession will be taken out from Botakdal to Zadibal as usual," he said.

Mujtaba said allowing 10 Muharram procession through non-customary route was meaningless as tens of thousands of mourners from across the Valley used to participate in Ashura procession from Abiguzar that would pass through downtown Srinagar before culminating at Zadibal.

Ittihadul Muslimeen president Maulana Masroor Abbas Ansari meanwhile had urged authorities to allow Ashura procession as diverted at Firdous Cinema, Mill Stop, Lal Bazar, Bota Kadal & Chattipadshahi."

It further states that "Motorists intending to go towards Soura from Lal Chowk or vice versa shall adopt Dr. Ali Jan Road and Motorists moving towards Lal Chowk from Zakoora or vice versa shall adopt Foreshore Road."

### 2,155 Pilgrims Leave For Twin **Base Camps From Jammu**

JAMMU: A fresh batch of 2,100 pilgrims left Jammu city for the twin base camps in the valley to join the Amarnath Yatra on Friday, officials said.

The 62-day annual pilgrimage to the 3,880-metre-high holy cave shrine of Amarnath in the south Kashmir Himalayas commenced from the twin tracks -- the traditional 48-km Nunwan-Pahalgam route in Anantnag and the shorter 14-km Baltal route in the Ganderbal -- on July 1.

A total of 2,155 pilgrims, including 1,660 men and 443 women, left the Bhagwati Nagar Yatri Niwas here in a convoy of 95 vehicles. They

are accompanied by Central Reserve Police Force personnel, the officials said.

While 753 pilgrims left for Baltal in a convoy of 37 vehicles, 1,402 pilgrims left for Pahalgam in 58 vehicles, they said.

This year's Amarnath Yatra has received an overwhelming response. As many as 3,69,288 pilgrims have undertaken the yatra so far this year as against last year's 3,65,751, according to official data.

Over 1.35 lakh pilgrims have left the Bhagwati Nagar camp for the valley since June 29, when the first batch of pilgrims was flagged off by Lieutenant Governor Manoj Sinha. The yatra will end on August 31.

Dr Nisar ul Hassan. Dr Hassan said Kashmir is witnessing an alarming rise in drug abuse cases over the past few decades. "Drug addicts are at a higher risk of contracting hepatitis and have the potential to spread this deadly infection to others," he said.

In a recent study conducted at the Institute of Mental Health and Neurosciences Kashmir, 72% drug addicts were found to have

"Most of the dental clinics use unsterilized or improperly sterilized instruments. The tools are not cleaned in between patients. The disposable items which are for single-use are reused on patients. Unsterile needles are used in multiple dose medication vials," he said

"Dentists do not change gloves in between patients and use same gloves for every patient that leads to cross-infection."

"Patients are not screened for hepatitis prior to intervention resulting in transfer of these viruses from one patient to another," he added.

Dr Nisar said Hepatitis B and C infections are serious medical conditions and infected patients may not have outward symptoms of the disease for many years. That delayed onset makes screening important, Hepatitis B and C an

**JAMMU:** Security forces on Friday recovered nearly nine kilograms of narcotics along the Line of Control (LoC) in Jammu and Kashmir's Rajouri district, officials said.

### **Australia Trails England In The Final Ashes Test**

LONDON: Australia lost five more wickets in the afternoon to reach tea at 186-7 in its first innings, trailing England by 97 runs Friday on the second day of the final Ashes test. Stuart Broad (2-31) needed

five balls after lunch to claim the third Australian wicket and leave Australia on 115-3. Broad pinned Usman Khawaja leg before wicket for 47 and, despite the opener reviewing the out decision, the ball-tracker showed it would have hit leg stump. It brought Travis Head to the crease for an afternoon session that was braced to be more dramatic than a slow-moving morning. Broad was on a roll now



and Head feathered behind an edge to Jonny Bairstow on four to give England another wicket. It was Broad's 20th wicket of the series and left Australia on 127-4, still 156 runs behind

England's total of 283. James Anderson struck when Mitch Marsh played on for 16. Root got in on the act when Carey (10) spliced to Stokes, who claimed his 100th

test catch for England in the process. England picked up another

wicket when Mitchell Starc (7) pulled Wood to Ben Duckett. Earlier, Australia went to lunch at 115-2 in a morning highlighted by a brilliant slip catch from Joe Root.

England took 54.4 overs for its 283 all out. Australia was 130-4 after 54.4 overs. (AP)

At Al-Ahli, he will join Roberto Firmino, who was formerly one of City's rivals at Liverpool, and former Chelsea goalkeeper Edouard Mendy.


