Is Art-370 Being Equated To Basic Structure Of Constitution, Asks SC

'Is There No Mechanism To Abrogate Article 370 Even When Everyone In J&K Wants It?'

New Delhi: Is there no mechanism to abrogate Article 370 even when the people of Iammu and Kashmir want it, the Supreme Court asked on Thursday and wondered if the now repealed provision can't be touched will it not amount to creating a "new category" beyond the basic structure of the Constitution.

Hearing for the second day a clutch of petitions challenging the Centre's 2019 decision to abrogate Article 370 of the Constitution that accorded special status to Jammu and Kashmir, a five-judge constitution bench headed by Chief Justice DY Chandrachud wanted to know how the provision could be revoked in the absence of a constituent assembly.

The bench, also comprising Justices Sanjay Kishan Kaul,

Sanjiv Khanna, BR Gavai and Surya Kant, told senior advocate Kapil Sibal, appearing for National Conference leader Mohd Akbar Lone, there are only two highly debatable issues -whether Article 370 acquired a permanent status with the cessation of the constituent assembly of Jammu and Kashmir and whether the procedure adopted

for its abrogation was valid. Sibal submitted there was an understanding between the Constitution framers and then Maharaja of Jammu and Kashmir Hari Singh who, while in favour of independence of his state, signed the instrument of accession to India due to the trouble caused by Pakistani infiltrators, under which Article 370 was

"The Constitution is a live document and it is not static. Can you say that there is no mechanism to change it (Article 370) even when everyone wants to change it? Then you are saying that this can't be changed even if all of Kashmir wants it," Justice Kaul told Sibal.

Supplementing the views of Justice Kaul, the CJI asked Sibal, can Parliament, having powers under Article 368 to amend the

Constitution, not change or abrogate Article 370.

You are saying that there is a provision of the Constitution which lies even beyond the amending powers of the Constitution. So, if we accept your submission, we will be creating a new category apart from the basic structure of the Constitution," Justice Chandrachud said.

Article 368 says, Power of Parliament to amend the Constitution and Procedure therefor: (1) Notwithstanding anything in this Constitution, Parliament may in exercise of its constituent power amend by way of addition, variation or repeal any provision of this Constitution in accordance with the procedure laid down in this article.

HC To Hear NIA Plea To Virtually Produce Yasin Malik

New Delhi: The Delhi High Court on Thursday listed for hearing on August 7 a plea for virtual production of separatist leader Yasin Malik from jail in connection with the NIA's plea seeking death penalty for him in a militant funding case.

'Terror Funding' Case

The application by the jail superintendent was adjourned after a bench of Justices Siddharth Mridul and Anish Dayal, which was scheduled to hear the request, did not assemble.

The high court had on May 29 issued warrants for production of Malik, who is presently serving life term in the case in Tihar Jail, on August 9 when the NIA's plea for enhancement of sentence is listed for hearing.

In the application seeking modification of the order, the jail authorities said Malik was a "very high risk prisoner" and it was imperative to not

physically produce him in court to maintain public order and safety.

It also said that as per an order passed by the Home Ministry, Malik cannot be "moved from Tihar Jail" and shall not be taken out of jurisdiction of the national capital.

"Respondent/Convict Yasin Malik has been lodged in Tihar Jail, New Delhi under the category of very high risk prisoners and thus, the present application is in relation to a heavy security issue. Therefore, it is imperative that the respondent/convict Yasin Malik is not physically produced before this Hon'ble Court in order to maintain public order and safety," the application said.

eta Platforms is preparing to launch a range of artificial intelligence (AI) powered chatbots that exhibit different personalities as soon as September, the Financial Times reported on Tuesday.

Meta has been designing prototypes for chatbots that can have humanlike discussions with its users, as the company attempts to boost its engagement with its social media platforms, according to the report, citing people with knowledge of the plans.

The Menlo Park, California-based social media giant is even exploring a chatbot that speaks like Abraham Lincoln and another that advises on travel options in the style of a surfer, the report added. The purpose of these chatbots will be to provide a new search function as well as offer recommendations.

The report comes as Meta executives are focusing on boosting retention on its new text-based app Threads, after the app lost

more than half of its users in the weeks following its launch on July 5.

Meta declined to comment on the FT report, when contacted by Reuters.

The Facebook parent reported a strong rise in advertising revenue in its earnings last week, forecasting third-quarter revenue above market expectations.

The company has been climbing back from a bruising 2022, buoyed by hype around emerging AI technology and an austerity drive in which it has shed around 21,000 employees since last fall.



Located exactly near Hari Singh High Street, the mural is pretty large, and catches one's attention from afar. In a very artistic and aesthetic manner, the artwork depicts the independent and talented women artisans of Kashmir.

Fearless Collective is an international organisation popular for doing public interventions in the form of creating such murals and artworks in an activistic approach. Fearless does this while representing communities that they feel have a need to be spoken about. The website of the organisation mentions that they believe that given the ugliness of oppressions we fight, the creation of beauty is an act of resistance". Internationally, the mural in progress

at Jahangir Chowk is the organisation's 51st such project.



Vaishno Devi Board Snaps Ties With J&K Bank

AMMU - The Shri Mata Vaishno Devi Shrine Board has snapped its 20-year-old ties with the Jammu and Kashmir Bank in what appears to be a fallout of the bickering between Governor S.K. Sinha and the state government. The board - which controls the popular Hindu shrine of Vaishno Devi in Jammu and of which Sinha is the chairman -has withdrawn all its money from the bank and transferred it to the ICICI Bank, sources said.

Sinha, whose bickering with Chief Minister Mufti Mohammed Sayeed over a host of issues is only too well known, directed the board to withdraw all accounts from the Jammu and Kashmir Bank, the sources said.

The state government is a major shareholder in Jammu and Kashmir Bank Ltd.

The shrine board had a Rs.1 billion deposit with the bank, the source said. It had been rendering several services to the shrine board free of cost,

The shrine board had had its deposits with the bank since 1986, when the former was set up. The Vaishno Devi shrine attracts more than 5.5 million pilgrims.

The governor and chief minister have earlier sparred over the duration of the pilgrimage to the Hindu cave shrine of Amarnath in Kashmir. While the governor wanted it to last for two

months, the chief minister insisted on one month. Sinha, who also heads the Shri Amarnath Shrine Board, finally had his way.

The chief minister was worried over the impact of a longer pilgrimage on the security of the state, as a large number of

troops and police forces are committed to guard the pilgrimage He had also pleaded that the fragile ecology of the routes to the Himalayan shrine, located at a height of 13,500 feet, could not

withstand the rush of pilgrims. More than 200,000 pilgrims have visited the shrine so far this year, (IANS)

Pak Probe Agency Using Israel's Intrusive Cyber Tech Since 2012: Report

IERUSALEM: Israeli cyber tech firm, Cellebrite, has sold Paki-Federal Investigation Agency (FIA) and various police units products that are highly intrusive and can lead to gross human rights violations despite the two countries not having diplomatic ties and Israeli norms prohibiting such deals, a local media report said on Thursday.

The Israeli firm's products have been in use by Pakistani agencies since 2012, Ha'aretz newspaper reported in investigative report.

Cellebrite's flagship product, UFED, is traded in Nasdaq and enables law enforcement agencies to engage in digital forensic work by hacking into password-protected cell phones and can copy information stored on the device, including pictures, documents, text messages, call logs and contacts.

Unlike Israeli company NSO, whose sale of Pegasus cyber tech grabbed worldwide attention, and other manufacturers of offensive-cyber products, Cellebrite operates in a grey area between security exports and civilian ones.

In 2020, the export of forensic equipment such as that produced by Cellebrite came under the Defence Ministry's oversight, since it was included in the Wassenaar Arrangement on Export

Controls for Conventional Arms and Dual-Use Goods and Technologies, which defines which dual-use (security use and civilian use) products require oversight, the report noted

However, International shipment records show that until at least 2019, Cellebrite Asia-Pacific Pte (its Singapore subsidiary) sold products directly to companies in Pakistan and to its Federal Investigation Agen-

cy, the Israeli daily reported. This happened despite Cellebrite's enduser license agreement forbidding sales to Pakistan. In other proofs

presented in the report, the investigative piece notes that in 2012 it was reported in Pakistan that the Sind

Province police had acquired UFED Touch Ultimate devices made by Cellebrite, and their use has been expanding since.

The Express Tribune newspaper had also published pictures that clearly show Cellebrite's product, the Israeli daily said.

"Operating manuals, documents and official invitations for bids show that police units and the FIA regularly use these systems," Ha'aretz claimed.

"FIA officials, past and present who were tasked with enforcing the draconian cybercrime law. even state in their LinkedIn profiles that they have been trained and certified to use these systems and that they use them on a regular basis", it noted

Gurugram-Nuh Violence: Muslims Decide To Offer Friday Namaz At Home

GURUGRAM: Muslims here will not offer Friday namaz at any public place or mosques in view of violence that flared up in Nuh, Sohna, and Gurugram earlier in the week, a community leader has announced.

Mufti Saleem Qasmi, president of Jamiat Ulama in Gurugram, appealed through a video message to people to refrain from praying in public places or gathering in mosques for prayers.

Qasmi said it is the responsibility of the people to maintain brotherhood.

The decision comes in the wake of the communal clashes that broke out on Monday in Nuh district during a VHP rally. Six people including a cleric were killed in the violence that ensued after the clashes and several cars and food joint were set on fire.

"I appeal to the people to offer namaz at home. Only those people who live in a masjid can offer namaz in the masjid. No one else is allowed to enter it. May Allah protect our brotherhood," Mufti told PTI on Thursday.

Hindu-right outfits had on Wednesday submitted a memorandum to a Deputy Commissioner of Police demanding, among many other things, a ban on namaz in public places.

DC Prashant Panwar and SP Varun Singla of Nuh held a meeting with the Ulemas in Nuh on Thursday and appealed to them to pray at their homes. Ulemas assured police that

there will be public namaz.

Imran Khan's Party Could Lose Election Symbol, Warns Pakistan Poll Body

ISLAMABAD: The Election Commission of Pakistan (ECP) has warned the former ruling party, Pakistan Tehreek-e-Insaaf (PTI) that it could be declared "ineligible" to obtain election symbol over its failure to hold intra-party elections, Geo News reported on Wednesday.

In a notice issued on Wednesday, the top electoral body summoned PTI Chairman Imran Khan to appear before it on Friday, "failing which the Commission under Section 215 (5) of the Elections Act, 2017, may declare your political party ineligible to obtain election symbol for future election(s)".

The ECP referred to its earlier notices and said the PTI's intra-party elections were due on June 13 in 2021 under the party's constitution.

It added the PTI was "intimated/reminded" to conduct intra-party elections within the timeframe provided under sections 208, 209 and 215 of the 'Elections Act, 2017 but the party failed to "provide the requisite certificate to this effect", Geo News reported.

The polls organising authority also said it issued final notice to the PTI in May last year for ensuring the conduct of intra-party elections "on or before June 13, 2022 (extended



date) with the observation that no further extension shall be

After the notice, PTI submitted a copy of the amended party's constitution which was deemed "insufficient" by the electoral body.

The ECP referred to Section 209(1) of the Election Act saying every registered political party is bound to provide the ECP with a certificate regarding the conduct of the intra-party elections as provided by law, as per Geo News.

"[...] if any political party fails to comply with the provisions of the said section 209, this Commission is empowered to declare the said political party ineligible to obtain an election symbol," Geo News quoted the

Rajya Sabha Passes Advocates (Amendment) Bill, Which Seeks To Target 'Touts'

NEW DELHI: The Rajya Sabha on Thursday passed the Advocates (Amendment) Bill, 2023, which aims to regulate the legal profession by a single Act and seeks to target "touts"

The amendment would help to regulate the legal profession through a single Act, the Advocates Act, 1961, according to statement of objects and reasons of the legislation.

Replying to a debate on the Bill in the Rajya Sabha, Union Law and Justice Minister Arjun Ram Meghwal said the legal profession is a noble profession and unlawful practices should be dealt with firmly.

The Bill was passed by a voice vote, following which the House adjourned for the day.

The Bill provides that ever high court and district judge can frame and publish lists of touts (those who procure clients for legal practitioner in return for any payment).

As per the provisions, such persons named in the list of touts will be excluded from entering the court premises. Any violation of this provision will entail punishment with imprisonment up to three months and a fine.

In keeping with the Centre's policy of repealing all obsolete laws or pre-independence Acts which have lost their utility, the government in consultation with the Bar Council of India has decided to repeal the Legal

Practitioners Act, 1879, and to amend the Advocates Act, 1961, by incorporating the provisions of section 36 of the Legal Practitioners Act, 1879, in the Advocates Act, 1961. This will reduce the number of superfluous enactments in the statute book. Also it will help to regulate the legal profession by a single Act, the Advocates Act, 1961, the statement of objects and reasons of the legislation said.

BJD member Sujeet Kumar said there should be a single database to carry details about all the practicing advocates in the country, saying it will help in bringing a social welfare scheme for them.

He demanded to bring advocate's protection act to enable them practice fearlessly.

"Advocates are the officers the court. Advocates are most important stakeholders in the administration of justice," Kumar said. BJP member Vijay Pal Singh Tomar said the Bill has provision that will end touts from courts.

AIADMK's M Thambidurai asked the government to change the name of Madras High Court to Tamil Nadu High Court, and similarly, the names of all high courts in the name of the state and not in the names of cities.

YSRCP MP V Vijayasai Reddy said lawyers charge between Rs 5 to Rs 50 lakh per hearing in the Supreme Court which is very high and demanded to put some cap on the fees.

Rajya Sabha Passes Press **And Registration Of Periodicals Bill**

NEW DELHI: Rajya Sabha today passed a bill that replaces the existing legislation which governs the registration of print and publishing industry in the country.

The Press and Registration of Periodicals Bill, 2023 was passed by a voice vote.

Replying to the discussion on the bill, Information and Broadcasting Minister Anurag Thakur said this will lead to ease of doa paper or periodical," he said. The bill replaces the existing Press and Registration of Books (PRB) Act, 1867.

Union Cabinet last month approved the PRP Bill that seeks to simplify the registration process for periodicals and do away with the provision for prosecution and imprisonment of publishers and simplify the registration process for periodicals.

The new law also seeks to do away with two provisions that



ing business for media and publishing companies, simplify the process of registration and decriminalise several colonial-era penal provisions. He observed that the bill traverses the journey from bureaucratic burden to ease of doing business.

In Letter To Pope, Ayatollah Sistani **Urges 'Concerted Efforts' To Promote Respect Among Followers Of Religions**

Iraq's most prominent Shia cleric Grand Ayatollah Ali al-Sistani has underscored the significance of peaceful coexistence, calling for concerted efforts to reject violence and promote respect among followers of various faiths.

Ayatollah Sistani made the remark in response to a letter from Pope Francis, the leader of the Catholic Church, on the second anniversary of the pontiff's visit to Iraq and his meeting with the top Shia cleric.

Ayatollah Sistani said the Pope's historic visit to Iraq and their meeting in the Iraqi city of Najaf provided "impetus" for many followers of Islam and Christianity - and other faiths - to show greater tolerance and good coexis-



tence with those who have different religions or beliefs.

Recalling the topics raised in the meeting, the top Shia cleric underlined the importance of concerted efforts to promote a culture of peaceful coexistence and reject violence and hatred. Ayatollah Sistani also called for the establishment of the values of harmony among people, based on caring for rights and mutual respect among the followers of different religions.

"More needs to be done to defend oppressed people around the world as the tragedies experienced by many people and ethnic and social groups in many places in the east and west of the world, the suppression of fundamental freedoms and the absence of social justice play a role in the emergence of some extremist movements that do not hesitate to attack others with whom they disagree in thought or belief," he said.

Changing Healthcare Scene

he healthcare in Jammu and Kashmir has experienced a major transformation over the last four years. New medical colleges have been established, expanding the medical seat capacity from 500 to an impressive 2,000. The introduction of two All India Institute of Medical Sciences (AIIMS) has positioned the union territory as a hub for medical education. And the establishment of colleges across various districts has brought advanced healthcare within closer reach of people.

Historically, healthcare in J&K has faced numerous challenges, including limited accessibility to medical facilities, inadequate healthcare infrastructure, and geographical barriers that hindered the delivery of medical services. However, the current administration has made a determined effort to change this reality for the better..

In the upcoming academic session, two additional medical colleges, situated in Handwara and Udhampur, are set to commence operations, each accommodating 100 students. With their inauguration, the tally of medical colleges in Jammu and Kashmir will rise to 13, collectively offering 1,300 MBBS seats. This will not only make available more seats to MBBS aspirants in a place where medicine is one of the most sought after profession but also, in turn, enhance accessibility to healthcare.

Simultaneously, the development of two Medicities is currently in progress, one in Jammu and the other in Kashmir. An important initiative that has made a real difference to the lives of people has been the distribution of Golden Cards to over 60 lakh individuals in the union territory. This initiative aims to provide health insurance up to Rs. 5,00,000, encompassing all segments of the population. The health insurance schemes have alleviated financial burdens and facilitated cashless medical care. Also, specialized treatments worth Rs 221.66 crore have been provided under these initiatives.

Last week, doctors at SKIMS Soura were directed to prescribe generic medicines exclusively, and the entry of medical representatives into hospital premises was restricted. Similarly, the Pradhan Mantri National Dialysis Programme has established Dialysis Centres across various locations in the region, reducing the need for patients to travel elsewhere for such services.

People in Kashmir Valley generally head to other parts of the country for specialized treatment. But the last four years have witnessed some of India's major hospitals coming or planning to come to Valley which hopefully will address the need for the patients to go outside for expensive medical treatment.

However, challenges still persist. There is a need for continued investment in healthcare infrastructure, especially in the remote and mountainous areas. The healthcare system must also be prepared to tackle health emergencies effectively, whether they are infectious disease outbreaks or natural disasters. Going forward, the administration will be expected to address these.

Mercury rising

he United Nations Secretary-General, António Guterres, this week reiterated the consequences of the climate catastrophe that has enveloped the globe. The earth had passed from a warming phase into an "era of global boiling", he said at the U.N.'s headquarters in New York. His comments come even as scientific evidence converges on the conclusion that July is set to be the hottest month in the last 12,000 years. This was a "disaster" for the whole planet, he said, noting that "short of a mini-Ice Age over the next few days, July 2023 will shatter records everywhere". Scientists from the World Meteorological Organization (WMO) and the European Commission's Copernicus Climate Change Service described conditions this month as "rather remarkable and unprecedented", with July seeing the hottest three-week period on record. Average July temperature so far has been 16.95° Celsius, 0.2° C warmer than in July 2019 — a record in the 174-year observational data of the European Union.

With ocean temperatures on the rise and the Central Equatorial Pacific Ocean transitioning from La Niña conditions where average sea surface temperatures are below normal to El Niño conditions, the opposite, it was widely expected that temperatures would be warmer than that in the last three years (when La Niña prevailed). However, it is the distribution and impact of the 16.95° C, which includes temperature in northwest China touching 52° C; wildfires in Greece and the baking heat in the United States' Southwest. The extraordinarily high rains in north and western India, while largely due to prevailing monsoon conditions, were also due to the warm air increasing atmospheric capacity to hold moisture resulting in short torrential bursts, causing floods and devastation. While climate prognostication induces pessimism, Mr. Guterres said that it was still possible to limit global temperature rise to 1.5° C and avoid the very worst of climate change but only with "dramatic, immediate climate action". At a G-20 ministerial meet in Chennai the same day, the COP28 President-designate, Sultan Ahmed Al Jaber, also emphasised that the world's largest economies should be more ambitious with emission cuts. While Prime Minister Narendra Modi has promised to make India the "third largest economy" if his party is re-elected in the general election, it will also mean greater pressure on India to take on a greater share of greenhouse gas mitigation responsibilities. This could mean advancing its net zero commitments from 2070 to 2050, as Mr. Guterres says, and generating fossil-free electricity by 2040. While these are the testy points on which climate negotiations hinge, the climate — it bears reminding — waits for nobody.

It is also associated with certain personality disorders. Borderline Personality Disorder (BPD) is characterized by unstable self-image and intense fear of abandonment. Perfection-

ism in individuals with BPD may manifest as extreme efforts to avoid perceived rejection or criticism, leading to emotional volatility and difficulty in maintaining stable relationships.

Obsessive-Compulsive Personality Disorder (OCPD) is marked by a rigid need for orderliness and perfectionism in all areas of life. Individuals with OCPD may become excessively focused on detail, work, and rules, to the detriment of their social and interpersonal life.

Practicing Imperfection

How To Beat Extreme Heat: Fan-Cooled Beds And Other Gadgets

s extreme heat blankets the globe from Phoenix to Athens, entrepreneurs are responding with an array of personal cooling devices that can help reduce health risks for everyone from infants to outdoor workers.

At Tokyo's annual Extreme Heat Countermeasures Exhibition last week the focus was on how to keep workers in high-temperature environments, like construction sites and factories, cool and reduce the risk of heat stroke. As fossil fuel emissions accelerate climate change and with July set to become the world's hottest month on record, there is growing appetite for the products from consumers and public institutions.

"We're getting more orders from public facilities, like school gyms, to use our product," said Hayato Ohashi, who works in sales at industrial fan manufacturer Earth Blower Japan Inc. "The heat is just getting extraordinary in the last decade-it's not something that will suddenly disappear next vear.'

Japan has one of the world's oldest populations and its citizenry is particularly at risk from extreme temperatures. In 2020, 86% of heat wave deaths were among people above the age of 65, according to the environment ministry. And Japan isn't the only country aiming to safeguard people: last week US President Joe Biden said the nation is spending \$100 billion a year to protect Americans from extreme heat.

Here are six cooling products showcased at the trade show in Tokyo.

Baby carriers and beds

Tokyo-based Kuchofuku Co. has been making fan-equipped apparel like vests and jackets favored by many Japanese con-



struction workers for decades. The company has redesigned some of its products as casual wear and home products for general

Fan-based cooling apparel works by accelerating airflow to dry perspiration and typically uses less energy than air-conditioning. The approach works best in more humid places where perspiration doesn't evaporate efficiently.

Kuchofuku's offerings included a fanequipped baby carrier and a bed. The mattress, which is made of a sheet of flexible,

mesh-like padding, has an electricity-powered fan at the foot that sucks air from the headboard to boost circulation and keep sheets dry. The baby carrier fans are battery powered.

Large-scale fans

Earth Blower Japan produces largescale fans nearly 2 meters (6 feet 6 inches) tall that blew visitors passing its booth with a strong breeze. Fans come in a variety of models, with names of Japanese deities, like thunder god "Raijin" or wind god "Fujin Max."

Ohashi emphasized the flexibility that fans offer because they can easily be transported to new locations and provide immediate relief. Although factories and logistics centers are the regular customers, the company has also rented out its blowers for use at stadiums, including for some of the sporting events during the Tokyo 2020 Olympic

Fans can also limit power costs. Although expenses vary according to the cost of electricity, Ohashi said running its big-

gest fan for eight hours a day for a month excluding weekends typically only costs around 10,000 yen (\$72).

Safety helmets

Many of the products on display targeted outdoor workers. Because of Japan's aging population many of its laborers at construction sites or in agriculture are at higher risk of heat stroke.

Hyogo prefecture-based Toyo Safety Industrial Co. showcased a safety helmet with a fan installed at the base that circulates air around the wearer's head. The fans that are detachable and rechargeable.

Tokyo-based Biodata Bank Inc. has developed a wearable device that alerts people when they are at risk of heatstroke

The product is currently sold in Japan and Europe, and the company has seen demand increase in European countries amid heat waves in recent years.

Some firms are eyeing products for four-legged animals.

Manufacturer A-Mec Co. developed a mesh vest with pockets to carry cold packs for dogs to keep pets cool in hot weather. The vests, which come in four sizes and range in price between 4,950 yen and 7,150 yen, are also sold in the US market.

Businesses have become increasingly aware of demand for animal cooling products, and retailers like Sweet Mommy also offer fan-based cooling vests for pets.

Why India Can Afford To Wait And Watch Before Regulating AI

ndia should not rush with a comprehensive law that might become outdated quickly. India's position on regulating AI has swung between extremes from no regulation to regulation based on a risk-based,

no-harm approach. In April this year, the Indian government said it would not regulate AI to help create an enabling, which could possibly catapult India to global leadership in AI-relat-

ed tech. However, just two months later the Ministry of Electronics and Information Technology indicated India would regulate AI through the Digital India Act.

Taking a U-turn from the earlier position of no-regulation, minister Rajeev Chandrasekhar said: Our approach towards AI regulation or indeed any regulation is that we will regulate it through the prism of user harm.

In a labour intensive economy like India, the issue of job losses because of AI replacing people is relatively stark.

However, the minister claimed: While AI is disruptive, there is minimal threat to jobs as of now. The current state of development of AI is task-oriented, it cannot reason or use logic. Most jobs need reasoning and logic which currently no AI is capable of performing. AI might be able to achieve this in the next few years, but not right now.

Such an assessment seems only partially correct because there are many routine, somewhat low-skill tasks that AI can perform. Given the preponderance of low-skill jobs in India, their replacement by AI can have a significant and adverse impact on employment.

Drafts of the upcoming Digital Personal Data Protection Bill 2023 personal data of Indian citizens may be shielded from being used for training AI.

It seems this position was inspired by questions US regulators have posed to Open AI about how it scraped personal data without user consent. If this becomes law though it is hard to see how this can be implemented because of the way training data is collected and used the deemed consent that allows such scraping of data in the public interest will cease to exist.

The Indian government's position has clearly evolved over time. In mid-2018, the government think tank, Niti Aayog, published a strategy document on AI. Its focus was on increasing India's AI capabilities, reskilling workers given the prospect of AI replacing several types of jobs and evolving policies for accelerating the adoption of AI in the country.

The document underlined India's limited capabilities in AI research. It therefore recommended incentives for core and applied research in AI through Centres of Research Excellence in AI and more application-focused, industry-led International Centre(s) for Transformational Artificial Intelligence.

It also proposed reskilling of workers because of the anticipated job losses to AI, the creation of jobs that could constitute the new service industry and recognising and standardising informal training

It advocated accelerating the ontion of AI by creating stakeholder marketplaces. This would enable smaller firms to discover and deploy AI for their enterprises through the marketplace, thus overcoming information asymmetry tilted in favour of large companies that can capture, clean, standardise data and train AI models on their own.

It emphasised the need for compiling large, annotated, dynamic datasets, across domains possibly with state assistance which can then be readily used by industry to train specific AI.

In early 2021, the Niti Aayog published a paper outlining how AI should be used responsibly. This set out the context for AI regulation.

It divided the risks of narrow AI (task-focused rather than a general artificial intelligence) into two categories: direct system impacts and the more indirect social impacts arising out of the general deployment of AI such as malicious use and targeted advertisements, including political ones.

India Restricts Import Of Laptops, Computers

NEW DELHI: The government on Thursday imposed import restrictions on laptops, tablets, and certain types of computers with immediate effect for security reasons and the need to promote domestic manufacturing.

The move will also curtail inbound shipments of these goods from countries like China and Korea.

Importers of these items would now have to seek permission or license from the government for their inbound shipments

A senior government official said that there are a variety of reasons for imposing these restrictions but the primary is "to ensure that the security of our citizens is fully safeguarded".

The official also said that internet penetration is increasing in the country in a bigger way and in this background Indian citizens need to have an environment and ecosystem, where they are not exposed to machines or instruments which might have security risks.

"Some of the hardwares could potentially have security related issues and could com-

promise sensitive and personal data, we have taken into account few of those goods," he added.

The Directorate General of Foreign Trade (DGFT) in a notification, however, said certain exemptions have been given against these curbs.

"Import of laptops, tablets, all-in-one personal computers, and ultra small form factor computers, servers... is 'restricted' with immediate effect," it said.

The official further said that "safety is the top most priority" of the government and the move is in compliance with the rules of the World Trade Organisation (WTO).

Under the transition provisions of the foreign trade policy (FTP), if the bill of lading and letter of credit has been issued or opened before August 3, that import consignments can be

imported. An importer can apply for a license from August 4. The trader should have to be a regular importer to get a license.

"The idea is not to ban imtime," Mr Vij said, adding that ports but to regulate the inbound shipments of these authorities understand safety goods," the official said.

Brand Gurugram Takes A Hit After Haryana Clashes

GURUGRAM: Communal clashes in Delhi's neighbour Gurugram this week have worsened religious fault lines in the region and exposed a booming business hub to threats of violence and disruption, authorities and analysts said.

Seven people were killed and over 70 injured in rioting in Nuh and Gurugram districts of Haryana after a Hindu procession was targeted and a mosque attacked in retalia-

The 48-hour cycle of violence which was put out on Wednesday has brought to the fore Hindu-Muslim tensions brewing in the region since 2015, a year after the BJP came to power in the centre and Haryana.

The lynching of two Muslim men in the region earlier this year by suspected Hindu vigilantes and the failure to nab the main suspect had worsened tensions, with the main suspect saying on social media that he would participate in the procession this week.

Ultimately he did not show up, police said. "It has been shocking to see how distrust between two

communities spilled onto the streets," Haryana Home Minister Anil Vij told Reuters. "Security has been restored... bringing relief and social harmony will take concerns of businesses in Gu-

Gurugram, formerly known as Gurgaon, is a city of over 1.5 million people that shares a border with Delhi.

A new urban centre with glitzy high-rises, luxury hotels, malls and gated condominiums, it is home to multinational firms, large Indian corporates and start-ups, with 250 of the Fortune 500 companies having offices here.

Among the multinationals with offices here are Google, American Express, Dell, Samsung, Ernst & Young and Deloitte. Suzuki's main India plant is also located near Gurugram.

Because of the violence, many companies allowed employees to work from home on Tuesday while schools and colleges were shut before resuming classes on Wednesday.

In the past, Gurugram has seen tensions over Muslims holding Friday prayers in public spaces and meat sales during Hindu festivals, which Hindu groups wanted banned to respect their sentiment.

"Muslim men attacked the Hindu procession and killed many of our people," said Praveen Babbar, a leader of Hindu Yuva Vahini (Hindu Youth Force). "Every action will have not just equal, but sometimes even more brazen reaction," he said.

Nuh Congress MLA Aftab Ahmed blamed local police for not acting fast enough even though he had alerted them about "provocative statements" being made by Hindu leaders.

Haryana Police, however, said they acted swiftly and prevented riots from spreading, and that two of its men were killed in the violence.

Analysts said the violence is worrying for the message it sends to businesses at a time India is seeking more invest-ment under its "Make in India" campaign.

India's Construction Sector Second Largest Employment Generator: Report

NEW DELHI: India's construction sector is the second largest employment generator with 7.1 crore workforce employed currently and the number is set to cross 10 crore by 2030, according to Knight Frank-RICS report.

The output generated from the Indian real estate sector is estimated to grow to USD 1 trillion by 2030 from the existing USD 650 billion, it added.

Real estate consultant Knight Frank India and Royal Institution of Chartered Surveyors (RICS) on Thursday released a report 'Skilled Employment in Construction Sector in India' that assesses the growth in this sector emphasising on the existing levels and gaps in skilled employment in the sector.

"Growth in India's real estate and infrastructure sector will generate considerable demand for manpower in the industry. With the advent of technology, the construction sector has also adapted itself to improve productivity, raising the demand for skilled man-

power," the report said. As per the report, India's construction sector is the second largest employment generator and as of 2023, 71 million (7.1 crore) of



the workforce is estimated to be employed in the construction sector. However, 81 per cent of this workforce is unskilled and only 19 per cent are skilled employees.

Employment in the construction sector is estimated to grow to 100 million to attain nomic growth targets, it added.

"Owing to the growing demand for real estate and infrastructure, the demand for skilled employees will continue to arise from developers, construction companies, consulting firms etc whereas the supply of the skilled manpower is to be generated from government initiatives, academic and training institutes," the report said.

As per the estimates of the National Skill Development Council (NSDC), 87 per cent of the overall employees (skilled and unskilled) are absorbed by the real estate sector, whereas 13 per cent are absorbed by the infrastructure sector.

Parliament Passes Bill To Provide Fixed 50-**Year Production Lease For Offshore Minerals**

NEW DELHI: A bill to provide a fixed 50-year production lease for offshore minerals was passed by Rajya Sabha today amid a walkout by the opposition members over the situation in ethnic violence-hit Manipur.

When the Upper House reassembled for the postlunch session, Coal and Mines Minister Pralhad Joshi moved The Offshore Areas Mineral (Development and Regulation) Amendment Bill, 2023 for consideration even as the opposition parties insisted on a discussion on the Manipur situation.

The bill to amend the Offshore Areas Mineral (Development and Regulation) Act, 2002 was passed by Lok Sabha on Tuesday.

Discussion on the bill continued even after the members of opposition parties, including the Congress, RJD, TMC, AAP, CPI and CPM, staged a walkout from the Rajya Sabha for the second time in the day after they were not allowed to raise the Manipur issue.

Members including Sasmit Patra (BJD), Anil Sukhdeorao



Bonde (BJP), M Thambidurai (AIADMK), K Laxman (BJP), V Vijayasai Reddy (YSRCP) and Ramji (BSP) took part in the In his reply to the discus-

sion, Joshi sought to address the members over the impact of offshore mining on the marine ecosystem and its implications on the livelihood of those dependent on the seas, especially fishermen.

There are so many safeguards through legislations and rules, he said and asserted that "environment legislations will be followed and states and all other stakeholders also will be duly consulted and all laws will be applicable in the offshore areas." "This is not sea-bed mining. It happens in the continental shelf within our exclusive economic zone (EEZ) and the entire world is doing it and only India is not doing it," the minister said.

Before notifying any offshore area for the grant of lease, the ministry will consult many other tries, including ministries of fisheries, forest, climate change, home and defence along with state governments, he said adding there is no question of violation of any law and the priority remains the protection of marine biodiversity and livelihood of fishermen.

Citing examples of Myanmar, Thailand, Malaysia, Singapore, Indonesia and Namibia, Joshi said these countries are already doing offshore mining while protecting marine ecosystems and those people who are dependent on the sea.

Food Industry Impacted By High Commodity Prices: Britannia Ind

In 2022, a total of 1,165 CPLs and 720 ATPLs were issued.

An individual is eligible to apply for CPL after completing at least 200 hours of flying and fulfilling other conditions.

Besides, the individual has to clear theory papers and once successful, the CPL is given for a period of five years subject to complying with various reauirements.

The Directorate General of Civil Aviation (DGCA) issues three types of licenses -- CPL, Air Transport Pilot Licence (ATPL) and Private Pilot Licence

While CPL allows a pilot to start flying as a co-pilot, ATPL permits a pilot to be the commander. PPL is issued for operating private planes. The estimated supply of en-

gineers from DGCA-approved AME Training Institutes is around 3,500 per year to cater to the demands of the aviation industry," Singh said. Singh, in another written

doctrine of the Constitution and held that certain fundamental features such as democracy, secularism, federalism and rule of law cannot be amended by Parliament.

Sibal stuck to his stand that in the absence of a constituent assembly, the provision has acquired a permanent status and the Constitution of Jammu and Kashmir says that no bill for modification or abrogation of Article 370 can be moved in the legislative assembly.

"How would you then put into place the constitutional machinery? It cannot be that because there is no constituent assembly, you cannot at all deliberate upon a proposal for abrogation or modification of Article 370," the CJI said.

Sibal said though many people feel that the provision should go there has to be a constitutional way of doing it and that he is not going to tell the other side how to do it.

"You can't introduce a bill in Parliament at 11 am and pass a resolution without anyone knowing about it," the senior lawyer said, asserting the bill for abrogating Article 370 was passed without proper discussion.

He said abrogating the provision is a political process but it should fit within the constitutional

Article 370 has been titled as "Temporary provisions with respect to the State of Jammu and Kashmir" in Part XXI of the Constitution.

The top court had on Wednesday referred to proviso 3 of Article 370 which says, "Notwithstanding anything in the foregoing provisions of this article, the President may, by public notification, declare that this article shall cease to be operative or shall be operative only with such exceptions and modifications and from such date as he may specify, provided that the recommendation of the Constituent Assembly of the State referred to in clause (2) shall be necessary before the President issues such a

Many feel since Article 370 itself spoke of the way it can become inoperative, the framers of the Constitution did not intend the provision to be permanent.

Sibal has been arguing that the constituent assembly, which existed for seven years between 1951 and 1957, alone was given the power to recommend modifications to Article 370. Since it ceased to exist after drafting the Constitution for Jammu and Kashmir, the provision acquired a permanent status.

He has said Parliament of India could not have assumed the powers of the non-existent constituent assembly and abrogated Article 370.

The hearing in the matter remained inclusive and will resume on August 8.

On Wednesday, the apex court had asked who can recommend the revocation of Article 370 in Jammu and Kashmir when no constituent assembly exists there.

The top court had asked as to how can a provision (Article 370), which was specifically mentioned as a temporary provision in the Constitution, become permanent after tenure of the Jammu and Kashmir constituent assembly came to an end in 1957.

Several petitions challenging abrogation of the provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh- were referred to a Constitution bench in 2019.

Affidavit Attested

accompanying the petition has been attested by a Notary and not by the Oath Commissioner as required by the provisions contained in the Writ Proceedings Rules, 1997.

"So, any affidavit attested by any of the aforesaid authorities is legally permissible for its use in the High Court," the court said.

The court also said that it would be in the interests

of administration of justice if incharge of the jails are vested with powers of Oath Commissioners by the High Court so that the affidavits which are intended to be used by the prisoners before the Courts are attested by the said officers.

"Before parting, it would be necessary to record certain observations as regards the difficulties that are being faced by the undertrial and convict prisoners who intend to file cases before the High Court or before other Courts of the Union Territories of Jammu & Kashmir and Ladakh," the court said.

In the cases that are to be filed by the litigants, particularly of civil nature, more often than not, the "petitioners/respondents/applicants/plaintiffs/ defendants" are required to sign the pleadings and swear affidavits in support thereof.

"It becomes very difficult for the undertrial/ convict prisoners who intend to file such affidavits before different courts to secure the services of a Notary or an Oath Commissioner inside the jail," the court said.

The Bench said that the High Court, in terms of Clause (b) of Section 139 of the Code of Civil Procedure, has power to appoint any officer who can administer oath on affidavit(s).

"It is in exercise of this power that the High Court appoints the Oath Commissioners. It would be in the interests of administration of justice if incharge of the jails are vested with powers of Oath Commissioners by the High Court so that the affidavits which are intended to be used by the prisoners before the Courts are attested by the said officers", the court said, adding, "This would obviate the difficulties that are generally being faced by the prisoners while filing their pleadings/affidavits before different courts, particularly in cases of civil nature."

To overcome such difficulty, Allahabad High Court has, in terms of Proviso to Rule 4 of Chapter IV of the Rules of the said High Court, authorized an officer of jail in the State of Uttar Pradesh to attest an affidavit and the power of Oath Commissioner has been conferred upon such officers, the court

Incorporation of a similar Rule in the Jammu & Kashmir and Ladakh High Court Rules can be considered, the bench said.

"In view of the above, it is directed that a copy of this order be forwarded to the Registrar General of this Court, who may place the same before Hon'ble the Chief Justice for considering the aforesaid aspect of the matter."

Govt Schemes Give Wings To Women Entrepreneurs In Kashmir

84,000 SHGs In J&K, Over Rs 100 Crore Financial Help Given To Women: Mission Director JKRLM

Srinagar: Dilshada Bano, 28, from North Kashmir's Bandipora district had never thought that one day she would stand on her own feet and will support her husband in running the house.

She learned tailoring at a local government-run center and started work to earn some extra money for her family. However, the low dividends forced her to quit this job. So she decided to do "something big" that would cover all her expenses.

In 2019, Bano started a dairy farm after her friend informed her about the government's self-help groups (SHGs) scheme.

"My husband accompanied me to the DC office and we completed all the formalities. It was very smooth and the officials were very helpful," Bano told Kashmir Observer.

She received assistance from the Jammu & Kashmir State Rural Livelihood Mission (JK-SRLM) in the form of a revolving fund, community investment fund and bank linkage. Bano got Rs 50,000 and bought her first cow.

"I came to know about the government's Umeed Scheme that helps women to set-up their own ventures. That's how it all started,'

Initially, she said, she just started her new venture with just one cow. As the days passed, her hard work took the

shape of a milk processing unit producing dairy products like yogurt, milk and cheese.

Bano, a mother of three, not only sold her products in Bandipora, but parts of Sopore and Baramulla in the neighbouring district. In order to boost the business of the local potters, she also chose clay pots instead of plastic packing for her diary products.

'My friends and neighbors now come to my unit and try to learn the business," says Bano with a smiling face.

The new venture has also helped Bano to raise some assets. With around Rs 10 lakh financial help extended to her, Bano constructed three shops in her native village and also expanded her business.

She has priced 1 kg milk at Rs 45 and yogurt at Rs 50 to Rs 60 as per the size of the pot.

Strengthening Grassroots Democracy

Empowering PRI Institutions in the Last 4 Years

'n the past four years, significant strides have been made in strengthening grassroots democracy through the Panchayati Raj Institutions (PRIs) in India. Transparent and fair elections were conducted in 2019-20, resulting in the election of about 33,000 representatives across all tiers of PRIs in 20 districts, covering 4291 panchayats.

To bolster the infrastructure of PRIs, 20 District Development Council (DDC) and 48 Block Development Council (BDC) office buildings are under construction, aiming to provide better facilities and support for local governance.

Recognizing the importance of capacitybuilding, a massive exercise was undertaken, equating to over 6 lakhs mandays, to empower all PRIs. Around 6,000 Elected Representatives were also sent on exposure visits to other states and prestigious institutes to gain insights into effective governance practices. Furthermore, a plan to send 10,000 more representatives on such visits is underway for the current year.

Empowering PRIs at the local level, the power to grant building permissions in certain areas has been delegated to the panchayats. Additionally, all Panchayats have been e-enabled, streamlining communication and administrative processes.

Recognizing the dedication of elected representatives, monthly honorariums are being provided to representatives from all three



tiers of Panchayati Raj, ensuring financial stability and incentivizing their commitment to

Addressing security concerns, an ex-gratia compensation of Rs. 251 is provided to the next of kin of elected representatives in the event of loss of life due to militancy-related

incidents, safeguarding their families and encouraging their participation.

To facilitate effective planning and implementation, Panchayat Prabhari Officers have been nominated for all 4291 Panchayats, enhancing coordination and support at the grassroots level.

Promoting excellence, 23 Panchayats were awarded at the UT level for their exemplary work, fostering healthy competition and inspiring further progress.

Infrastructure development continues, with more than 2500 Panchayats having Panchayat Ghar, and a plan to construct 500

more during the current year, providing essential community spaces for local governance and activities.

Recognizing the significance of renewable energy, 1131 Gram Panchayats are being solarized, ensuring uninterrupted power supply and internet connectivity, thereby facilitating communication and development.

In line with capacity-building efforts, 1889 Posts of Panchayat Accounts Assistant were created and filled up through the Jammu and Kashmir Services Selection Board (JKSSB), enhancing financial management and account-

Acknowledging the efforts of PRIs, 22 Panchayats received national-level awards since 2018, with an additional 3 Panchayats being recognized this year, highlighting their contributions to the nation.

China Proposes To Limit Children's Smartphone Time To A Maximum Of 2 Hours A Day

Beijing: China's internet watchdog has laid out regulations to curb the amount of time children spend on their smartphones, in the latest blow to firms such as Tencent and ByteDance, which run social media platforms and online games.

The Cyberspace Administra-tion of China on Wednesday published the draft guidelines on its site, stating that minors would not be allowed to use most internet services on mobile devices from 10 p.m. to 6 a.m., and that children between the ages of 16 and 18 would only be able to use the internet for two hours a day.

Children between the ages of 8 and 15 would be allowed only an hour a day, while those under 8 would only be allowed 40 min-

Only certain services, such as apps or platforms that are deemed suitable to the physical and mental development of mi-nors, will be exempted. The CAC did not specify which internet services would be allowed exemptions.

The restrictions are Beijing's latest efforts to attempt to limit internet addiction, a problem it views as widespread among its youth. In 2019, Beijing limited children's daily online game time to 90 minutes a day and tightened those restrictions in 2021, allowing children only an hour a day of online game play



on Fridays, weekends and public

Short-video and online video platforms like Douvin, Bilibili and Kuaishou have offered youth modes that restrict the type of content shown to minors and the length of time they can use the service. Children are also pushed educational content, such as sci-

ence experiments. The latest restrictions would impact firms like Tencent, China's largest online game company, and ByteDance, which runs popular short-video platform Douyin. Firms in China are often responsible for enforcing regula-

"To effectively strengthen the online protection of minors, the CAC has in recent years pushed for the establishment of a youth mode on internet platforms, expanding its coverage, optimising its functions and enriching it with age-appropriate content," the CAC said.

"Since the mode was launched, there has been a positive impact in reducing youth internet addiction and the impact of undesirable information," it added.

The CAC said draft guidelines were open to public feedback until September 2. It did not say when the new rules would be into effect.

AI Tool GPT-3 Demonstrates Undergraduate-Level Reasoning Abilities

Researchers have found GPT-3 to possess reasoning capabilities akin to college undergraduate students. In a study, conducted by researchers at the University of California - Los Angeles (UCLA), the artificial intelligence large language model (LLM) was put to the test, solving complex reasoning problems, which are often used by colleges and universities worldwide for admis-

sion decisions. The UCLA researchers presented GPT-3 with challenging shape prediction tasks and asked it to answer SAT analogy questions, all the while ensuring that the AI had never encountered these specific problems before. To establish a fair comparison, 40 UCLA undergraduate students were also asked to solve the same problems.

In an impressive display of its prowess, GPT-3 achieved a remarkable success rate, accurately solving 80% of the shape prediction problems. This surpassed the average score of just below 60% achieved by the human participants, with some of them obtaining their highest scores. The results have left the research team astounded, highlighting the Al's ability to tackle complex reasoning tasks with

exceptional efficiency. GPT-3's performance in the SAT analogy questions further solidified its prowess, successfully providing answers to challenges that typically measure a person's capacity for logical thinking and problem-solving. The researchers were fascinated to witness the AI's capability to adapt to new scenarios and display its reasoning abilities on par with college students.

This breakthrough discovery has significant implications for the field of artificial intelligence and education. As GPT-3 continues to prove its mettle in solving complex problems, its potential applications in various industries and academic settings are likely to expand further.

"Surprisingly, not only did GPT-3 do about as well as humans but it made similar mistakes as well," said UCLA psychology professor Hongjing Lu, senior author of the study published in the journal Nature Human Behaviour.

In solving SAT analogies, the Al tool was found to perform better than the humans' average score. Analogical reasoning is solving never-encountered problems by comparing them to familiar ones and extending those solutions to the new ones.

The questions asked test-takers to select pairs of words that share the same type of relationships. For example, in the problem "'Love' is to 'hate' as 'rich' is to which word?," the solution would be "poor".

However, in solving analogies based on short stories, the AI did less well than students. These problems involved reading one passage and then identifying a different story that conveyed the same meaning.
