Uninvited Guests: Non-Native Species Reshape Kashmir's Biodiversity Landscape

Srinagar: In Kashmir, the emergence of non-native species is posing a significant threat to the region's biodiversity.

Alien plant species in the mountains, Alligator gar and Wild Boar have been identified as the potential invaders, posing an imminent threat to the ecologically sensitive landscape.

As scientists and conservationists scramble to assess the extent of the invasion and its ecological implications, concerns mount over the potential long-term consequences for both the environment and

local communities dependent on these ecosystems. Long term studies and targeted interventions are being called for to combat the spread of these alien species before irreversible damage is done.

Spread of Non-Native plants in mountain ecosystems

High-elevation ecosystems around the world including the mountains of Kashmir Himalaya have been relatively untouched by non-native plants. However, this is changing as these non-native species are moving higher up the mountains to adapt to their preferred climate and in



response to human disturbances. A 2023 study published in Nature Ecology and Evolution journal has revealed an increase in the incidence of nonnative species in mountainous regions, including in the Alps and the Himalayas.



Dengue Cases Likely To Surge In J&K, Say Experts

Srinagar: As dengue cases are projected to surge post monsoon in Jammu and Kashmir, medical experts on Tuesday advised people to take 'preemptive measures' to combat the painful mosquito-borne disease in the absence of any vaccine.

Although dengue fever, usually caused by a virus carried by infected mosquitoes, has always been a serious health concern for the people, experts say there is no vaccine available for the disease and that using insect repellents and bed nets is the best possible remedy to protect themselves from falling prey to the virus.

While 6-7 cases of dengue have so far been reported in the Kashmir valley, as many as 25 people have tested positive in the Jammu division of the Union Territory.

Pertinent to mention here that the administration, in view of the rapid spike in the number of dengue cases in Jammu, has taken a slew of measures after taking an overall review of the situation.

Study Finds How Pecans Curb Obesity, Reduce Inflammation

esearchers discovered that pecansprovide health benefits that may reduce inflammation and prevent obesity.

The findings of the study were reported in the journal Nutrients.

Obesity and diabetes numbers are increasing in modern society worldwide, and the trend in high-fat diet consumption is one of the main reasons besides lifestyle and genetic predisposition, said Luis Cisneros-Zevallos, Ph.D., professor of horticulture and food science in the Department of Horticultural Sciences in the Texas A&M College of Agriculture and Life Sciences and affiliate scientist in the Institute for Advancing Health Through Agriculture.

People are searching for healthi-

er options, and we have now shown pecans are a healthy tool consumers have in their hands. According to Amit Dhingra, Ph.D., chair of the Department of Horticultural Sciences, Cisneros-Zevallos' investigation "provides scientific evidence supporting the traditional knowledge in the Americas that pecans are highly nutritious." Thanks to Dr. Cisneros-Zevallos work, we now know what potential mechanisms underlie that nutritional benefit, he said. Our department is focused on the areas of sustainability, wellness and food security, and this research illustrates the relevance of horticultural crops for humanhealth.

According to Cisneros-Zevallos. researchers used pecans and high fat diets on mouse models and discovered that nuts enhanced energy expenditure while decreasing dysbiosis and inflammation. The research found that pecan sinfluence adipose tissue lipolysis as well as mitochondrial oxidative metabolism in the liver and skeletal muscle.

He also mentioned that the anti-inflammatory effects of pecans shown in the study lowered lowgrade inflammation, which contributes to chronic inflammation and the development of a variety of common ailments. He further stated that pecans help people maintain their weight and prevent diabetes while eating a high-fat diet.

The new functionality has the potential to turn pecans into a superfood that may be taken directly or used in the increasing markets of functional foods and nutritional supplements.

Show Cause Notices Issued To 143 Pharma Firms After Inspections

The Central Drugs Standard **■** Control Organisation along with state licensing authorities has conducted risk-based inspections of 162 pharmaceutical firms and issued show cause notices in 143 cases, Union Health Minister Mansukh Mandaviya said on Tuesday.

In a written reply to a question in Rajya Sabha, he said stop production order has been issued in 40 cases, cancellation and suspension of product/section licenses in 66 cases, issuance of warning letter in 21 cases and in one case, an FIR has been lodged and three persons have been arrested as per the provisions of the Drugs Rules, 1945.

He also said that the Directorate General of Foreign Trade, Department of Commerce, Ministry of Commerce and Industry issued a notification on May 22 for amendment in export policy of cough syrups, making it compulsory for cough syrup manufacturers to get certificate of analysis from a governmentapproved laboratory before exporting their products with effect from June 1.

Accordingly, more than 900 such cough syrup samples have been analysed and Certificate of Analysis (CoA) released as on date, Mandaviya said.

The manufacturing, sale and distribution of drugs in the country are regulated under the provisions of the Drugs and Cosmetics Act, 1940 and Rules, 1945. The regulatory control over the manufacture, sale and distribution of drug in the country is exercised through a system of licensing and inspection by the State Licensing Authorities (SLAs) appointed by the respective state governments.

Manufacturers are required to comply with the conditions of Licence granted under the said Act and Rules to manufacture any drugs for sale and distribution in the country, Mandaviya said.

When cases concerning quality or safety of drugs are reported, the matter is taken up with the State Licensing Authority (SLA) in order to take necessary action.

The SLAs are legally empowered to take action of violation of any conditions of such licenses, including prosecution in appropriate court of law, he said.

What US Said On Former Pakistan PM Imran Khan's Arrest

Agencies

WASHINGTON: The arrest of Imran Khan is Pakistan's "internal matter", a U.S. State Department spokesman said on Monday, declining to take a position on the legal troubles of the former prime minister and frequent U.S. critic.

Police arrested Khan in Lahore on Saturday after a court sentenced him to three years in prison for illegally selling state gifts. The guilty verdict could stop the opposition leader from the Pakistan Tehreek-e-Insaf party from contesting a national election later this year.

Khan denies wrongdoing and maintains the government and the powerful military - which has run the country for about half of its 75-year history - imposed fabricated charges on

"We believe that is an internal matter for Pakistan," State Department spokesperson Matthew Miller said in a press briefing on Monday, when asked whether the U.S. thought

Khan got a fair trial. "At times there are cases (around the world) that are so obviously unfounded that the United States believes it should say something about the matter. We have not made that determination here," Miller

Khan initially alleged that his ouster from office in a parliamentary vote last year was



backed by Washington and orchestrated by Pakistan's top generals. Washington and the military both denied this.

Analysts noted that the U.S. response to Khan's legal woes has been muted compared with the prosecution of other opposition figures around the

"I think Khan blaming the U.S. for his ouster last year certainly hasn't helped matters for clear of commenting in any specific terms on Pakistan's politics," said Madiha Afzal, a fellow in the Foreign Policy program at Brookings Institution, a Washington-based

think-tank. Critic Of Washington

Khan has been a critic of U.S. foreign policy almost throughout his political life. During his years as a rising politician, the former cricket star was among the fiercest critics of U.S. drone attacks targeting militants along the country's Afghan border, which he termed extraiudicial killings and a violation of Pakistan's sovereignty.

Day-1: Sparks Fly During No-trust Debate

Forced to bring motion to break PM's 'maun vrat' on Manipur: Oppn; govt calls it targeting of 'poor person's son'

NEW DELHI: Sparks flew on the first day of the debate on the no-trust motion moved by the Congress with the Opposition on Tuesday asserting that it was forced to do so to break Prime Minister Narendra Modi's 'maun vrat' (vow of silence) on Manipur and the treasury benches hitting back saying it was a no-trust vote against a "poor person's son" who has worked for the

welfare of the people.

The opposition leaders at various points during the debate also invoked BIP veteran Atal Bihari Vajpayee to target the Prime Minister and remind Modi of 'rajdharma'.

Initiating the debate on the motion in the Lok Sabha, Congress MP Gaurav Gogoi raised a series of questions on Manipur, asking why the Prime Minister had not visited the state, why it took 80 days to break the silence on the state and why he had not sacked Chief Minister N Biren Singh.

Launching a scathing attack, the Congress MP from Assam said it was a matter of grave concern that a government that talked about "one India" had created "two Manipurs - one living in hills and

the other in the valley". He also demanded that Modi should visit Manipur, lead an all-party delegation to the north-eastern state, and make sincere efforts to restore peace by meeting various organisations there.

The opposition grouping Indian National Developmental Inclusive Alliance (INDIA) was



forced to bring the no-confidence motion as this was never about numbers but about justice for Manipur, he said.

"If Manipur is burning, the entire India is burning, if Manipur is divided, the country is divided. It was our demand that as the leader of the country, Prime Minister Modi should come to the House and speak about Manipur. However, he kept a 'maun vrat' (vow of silence) that he will neither speak in the Lok Sabha nor in the Rajya Sabha," the Congress MP from Assam said.

"Through the no-confidence motion we want to break his vow of silence," he

Intervening in the debate, Union minister Kiren Rijiju said the Congress and other opposition parties have brought the no-confidence motion at a "wrong time and in a wrong manner." At a time when Prime Minister Modi has emerged as the world leader and the country was marching ahead to become a developed nation by 2047,

there was no need for such a motion against the government, the minister said.

Instead, the opposition should join hands with the government to celebrate 'Azadi Ka Amrit Mahotsav' and work towards achieving the target set by the prime minister for the next 25 years, the minister added.

"Congress and opposition parties will regret bringing in the no-confidence motion at the wrong time and in a wrong manner," the minister said.

Gogoi said he would like to ask the prime minister why he had not gone to Manipur when Rahul Gandhi had gone as also Home Minister Shah and the minister of state for home (Nityanand Rai).

As the lower house took up the motion moved by Gogoi, there were heated exchanges between the opposition and treasury benches after Parliamentary Affairs Minister Pralhad Joshi wondered why Rahul Gandhi's name as lead speaker was withdrawn last

WASHINGTON: U.S. government offices in the Washington D.C. area closed early on Monday because of threatening weather as forecasters warned people across the eastern U.S. of possible tornadoes, damaging winds and large hailstones.

Fast-moving thunderstorms and powerful winds toppled trees and knocked out power for nearly 200,000 homes and businesses in neighboring Maryland and Virginia, according to tracking website Power-Outage.us. As many as 800,000 customers had lost power in the southern and mid-Atlantic

Though drenched with rain and pelted with some hail, the nation's capital had escaped any twisters by the time a National Weather Service tornado watch expired at 9 p.m. EDT (0100 GMT)

A coastal flood advisory remained in effect for Washington until 4 a.m. 08000 GMT).

The National Weather Service said more than 29.5 million people from Alabama to western New York state had been at risk of tornadoes on Monday, but none had been reported as of 9 p.m. EDT.

The Federal Aviation Administration ordered departing flights grounded at airports in New York, Washington, Philadelphia, Atlanta and Baltimore because of thunderstorms. The FAA said it was rerouting aircraft around the storms as much as possible.

Libraries, museums, the National Zoo, pools and other municipal and federal services in the Washington area were also closing early. The U.S. Office of Personnel Management said federal employees had to depart no later than 3 p.m.

FlightAware, a flight tracking site, said more than 2,600 U.S. flights had been canceled, including 102 at Washington Reagan National Airport and 35 at Washington Dulles. Another 7,700 U.S. flights had been delayed.

Gujarat Court Sets Aside 2019 Order That Sentenced **Businessman To Life**

AHMEDABAD: The Gujarat High Court on Tuesday quashed and set aside a 2019 order of a NIA court sentencing a businessman to life imprisonment for leaving a hijack threat note on a Mumbai-Delhi flight in 2017, saying the trial court sentenced him for the offence of hijacking "on the premise of evidence which is tainted with doubt." Businessman Birju Salla was the first person to be booked under the stringent Anti-Hijacking Act, 2016.

The NIA had filed chargesheet against him under sections 3(1), 3(2)(a) and 4(b) of the Anti-Hijacking Act, 2016. A division bench of HC Jus-

tices AS Supehia and MR Mengdey said the appellant (Salla) is acquitted from the offences under sections 3(1) and 3(2)(a) tence under section 4(b) of the Act is set aside, it added.

The HC also directed that ₹5 crore fine which Salla was ordered to pay be refunded in case it is already paid.

The special National Investigation Agency (NIA) court in Ahmedabad on June 11, 2019 sentenced Salla to life imprisonment under the Anti-Hijacking Act, 2016, and imposed a fine of ₹5 crore for leaving a hijack threat note on a Mumbai-Delhi flight in October 2017.

Salla had become the first person to be booked under the stringent Anti-Hijacking Act, 2016, which replaced a vintage

law of 1982. He was also the first person to be put under the 'national no fly list".

While quashing and setting aside the NIA court order against Salla, the HC said it does not subscribe to "the view expressed by the trial court convicting and sentencing the appellant for the offence of hijacking on the premise of evidence which is tainted with doubt.'

It also directed that ₹5 crore fine which Salla was ordered to pay be refunded in case it is already paid, and his properties seized and ordered to be confiscated by the investigation officer under provisions of section 19 of the Act be released.

The high court also directed crew members of the affected flight to refund the amount of compensation in case the same was paid as per directions of

The trial court had said ₹5 crore fine submitted by the convict shall be distributed among the crew members and passengers on board the affected plane.

"In the alternative, the state is directed to pay the amount which is paid to the crew members, and it will be open for the state to recover such amount from the crew members." the HC bench said in its order.

Salla was accused of creating a hijack scare by planting a threat note written in English and Urdu in the tissue paper box of the aircraft's toilet on October 30, 2017.

Opposition Brought No-Confidence Motion To Test Its Own Unity: PM Modi secured parliamentary ap-

rime Minister Narendra Modi said on Tuesday that the opposition brought the no-confidence motion against his government to test the confidence of its own alliance members in each other as the INDIA bloc is marked by distrust among its constituents

In his address to BJP MPs at a closed-door meeting of its parliamentary party, he described the opposition alliance as "ghamandia" (marked by arrogance) and congratulated the party's Rajya Sabha members for the "semi-final" win in voting on the Delhi services bill, some of those present inside said.

Union minister Arjun Ram Meghwal quoted Modi as saying that the opposition brought the no-confidence motion despite the fact that the government enjoyed a strong majority as its mem-



bers wanted to see if they were united or not.

Even in the voting on the Delhi services bill in Rajya Sabha, the government got more votes than expected as the debate showed that its bill was guided by the Constitution, the prime minister said.

Modi, sources said, noted that some opposition members had described the voting in Rajya Sabha as a semi-final before the 2024 Lok Sabha polls as he exuded confidence about the BJP's prospects in the national elections.

The Delhi services bill

proval on Monday after the Rajya Sabha passed it with the support of 131 MPs while 101 of them voted against the legislation that will give the Centre control over bureaucracy in the national capital. Exuding confidence about

his return to power followtions, Modi told MPs that they will not have to push for railway ministry-related works during his third term after Railway Minister Ashwini Vaishnaw made a presentation, indicating that the ongoing development projects will take care of their demands.

The Modi government is now in its second term, with opposition parties forming the Indian National Developmental Inclusive Alliance (INDIA) to prevent the ruling BJP-led NDA from coming to power for a third term under him.

Maharashtra Farmer Installs CCTV Camera In Farm To Keep An Eye On Tomatoes

AURANGABAD: Heavy demand and skyrocketing prices of tomatoes have prompted a farmer from Maharashtra to install a CCTV camera on his farm to keep an eye on his plantation of the kitchen staple.

The red berries are being sold between ₹100 and ₹200 across the country.

The grower said he embraced digital surveillance for his farm at Shahpur Banjar, about 20 km from Aurangabad, after tomato thieves struck there.

Sharad Rawte told PTI that he cannot afford to lose more tomatoes, the most in-demand vegetable today. He said a crate of 22-25 kg of tomatoes is now being sold for ₹3,000.

mR Rawte said his farm is spread across 5 acres and he has grown tomatoes on 1.5 acres, which could easily fetch him ₹ 6-7 lakh.

"Around 10 days ago, 20-25 kilos of tomatoes were stolen from my farm in



Gangapur taluka. To protect the remaining crop that is yet to ripen, I've installed a CCTV camera worth ₹22,000," he said.

The farmer said the camera runs on solar energy so he doesn't have to worry about its power supply. "I can also check the visuals anywhere on my phone," he said.

Rahul Gandhi Gets Back Tughlaq Lane Bungalow, May Shift Soon

NEW DELHI: Congress leader Rahul Gandhi has been re-allotted the 12, Tughlaq Lane bungalow a day after his disqualification as Lok Sabha member was restored following a directive of the Supreme Court, officials said on Tuesday.

The House Committee of the Lok Sabha decided to allot the same bungalow he was asked to vacate after Gandhi was disqualified as member of the lower house on March 24 as a result of his conviction and a twoyear jail term awarded to him for the 'Modi surname' remarks.

"Mera ghar pura Hindustan hai (Whole country is my home)," quipped Gandhi when asked about being allotted the 12, Tughlaq Lane bungalow.



Sources said Gandhi has received the letter re-allotting the same house he occupied as Lok Sabha MP for the past almost two decades.

They said Gandhi would be shifting back to his residence soon. He is currently staying with his mother Sonia Gandhi, who is also the chairperson of the Congress

Parliamentary Party.
On Monday, the Lok Sabha Secretariat restored Gandhi's membership of the lower house after the Supreme Court stayed his conviction in the defama-

In April, Rahul Gandhi vacated his official residence in central Delhi, in line with protocol, after he was disqualified as an MP in March following a Surat court's conviction in the criminal defamation case.

A disqualified MP is not entitled to a government accommodation and gets a month's time to vacate the official residence.

Rajasthan Cook Beaten To Death As "Food Did Not Taste Good": Cops

JAIPUR: A cook at a restaurant was allegedly beaten to death by four people over food preparation in Rajasthan's Jaisalmer district, police

The accused were in an inebriated condition at the time of the incident, the police said, adding all four have been detained.

The incident occurred in the Ramgarh police station area when the accused arrived at the restaurant late Monday night and got into an argument with the cook that the food did not taste good, Station House Officer Mukta Pareek

The accused severely thrashed the cook, resulting in his death, he said.

The cook was identified as Shiv Deshmukh, a

resident of Telangana. The body has been kept at a hospital mortuary for post-mortem which will be conducted after the family members arrive, police said.

Machail Yatra Progressing Smoothly In Kishtwar

JAMMU: The annual Machail Mata yatra in Jammu and Kashmir's Kishtwar district is picking up pace with over 30,000 devotees already paying obeisance at the 9,705-feet-high shrine, officials said on Tuesday.

With the partially-constructed Pradhan Mantri Gram Sadak Yojana (PMGSY) road en route now accessible, the devotees can trek on foot to the shrine, cutting travel time by about two hours and making the journey less fatiguing compared to the steep and challenging ter-

devotees, the official said. Additionally, facilities such as tent city at Machail, Yatri Bhawan, Sapphire guest house and luxury mushroom tents at base camp Gulabgarh have been arranged to accommodate and host the devotees during their pilgrimage, he said.

He said the Machail Mata yatra holds immense spiritual and cultural significance and remains a cherished place of pilgrimage for devotees across the country. Describing the construction of PMG-SY road as a "major milestone", the official said the department concerned successfully cleared the challenging rocky stretch on Machail road in a short span of time.

"Road cutting in a crucial rocky stretch has resulted in achieving significant progress on this road which is now being used by pilgrims up to Hamouri village for on foot journey," he said.

135 People Dead In 1064 **Incidents Since Jan 2023**

Srinagar Records Highest Number Of 225 Accidents; Efforts On To Address Alarming Rise In Road Mishaps: SSP Traffic, Rural Kashmir

SRINAGAR: The first half of 2023 has witnessed a concerning surge in road accidents, resulting in 135 fatalities across Kashmir, reveals official data.

According to official figures a total of 1064 road accidents were reported in the valley since January 2023 to date, leading to 135 fatalities.

Srinagar district emerged as one of the most accidentprone areas, recording 225 accidents that claimed the lives of 28 people. Srinagar is followed by South Kashmir's Anantnag that saw 147 accidents and 25 deaths.

"Budgam reported 80 accidents, resulting in eight fatalities. In Kulgam, 74 accidents were reported, leading to the loss of 11 lives. Ganderbal district witnessed 83 accidents, with a death toll of 2 people. A total of 38 road accidents were recorded in Bandipora, resulting in three deaths. Pulwama experienced 59 accidents and four fatalities. Shopian saw 20 accidents and three tragic deaths," the official data reveals. adding that "Awantipora police district in south Kashmir reported 50 accidents, with 13 lives lost. Baramulla district reported 126 accidents, leading to 12 fatalities. Kupwara witnessed 57 accidents, resulting in seven deaths. Handwara reported 58 accidents, with a death toll of nine people.

Sopore saw 47 accidents and the

loss of 10 lives."

Expressing concern over the distressing statistics, Superintendent of Traffic Police for Rural Kashmir, Ravindar Pal Singh, emphasized the efforts undertaken to address this alarming issue. "Special drives against traffic violations have been carried out rigorously, and awareness programs targeting drivers, students, and local communities have been conducted to encourage adherence to traffic rules and regulations," he said.

To enhance enforcement measures, he said several initiatives have been implemented, including the use of E-Challaning for streamlined penalties, breath analyzers to detect intoxication, and the installation of trash barricades. "Over-speeding is being tackled through a state-of-theart speed radar system, and violators are being promptly booked in accordance with provisions of the Motor Vehicles Act. Special attention is being devoted to combat non-compliance with helmet-wearing, overloading, and reckless driving practices," he added.

"Efforts are also being focused on taking strict actions against habitual violators, including the cancellation of driving licenses, vehicle registrations, and permits for those involved in accidents resulting in fatalities," he said.

Singh urges drivers to follow traffic rules strictly: no speeding, wear helmets, avoid overloading, refrain from mobile use while driving, no stunts on bikes, and stay on the correct side of the road, ensure regular vehicle check-ups, drive sober, and possess a valid license and fitness certification—(KNO)





Peace With Democracy

ashmir has witnessed the end of a long turbulent period following the withdrawal of Article 370 in August 2019, the Lieutenant Governor Manoj Sinha's said in his interaction with journalists on Sunday. Significantly, the LG added for good measure that the decision on assembly elections rests with the Election Commission of India, following the completion of the delimitation process and electoral roll revisions. This is after a long time that a top government functionary has referred to long delayed Assembly polls in the UT.

J&K has not had an elected government since June 2018 when Governor's rule was imposed after the PDP-led coalition government lost its majority following the withdrawal of support by the BJP. Subsequently, on August 5, 2019, New Delhi abrogated Article 370 that granted J&K special status under India's constitution. Since then the Lieutenant Governor has taken over from Governor.

However, both the central and the UT governments have exhibited little urgency to hold Assembly elections. This despite the fact that the situation has visibly improved in the region. The militancy has progressively reduced over the last four years. This is borne out strikingly by the drastic drop in the number of militants and also the disappearance of unrest and stone throwing. And by that yardstick this is the most conducive atmosphere imaginable for a free and fair electoral exercise.

But there are no signs that Jammu and Kashmir is going to witness Assembly elections anytime soon. This too when the country is holding parliamentary polls next year. The former J&K Chief Minister Omar Abdullah had urged the election commission to hold Assembly polls simultaneously with general elections. However, there has so far been no response from either the commission or the central government. There is still some time left, giving people a reason to hope that the Assembly polls might be held. Around nine Assembly elections are due to be held across the country over the course of next nine months. And their outcome would be of a momentous significance for the country.

That said, J&K administration is gung-ho about peace holding in Kashmjr from hereon. The LG Sinha said they have a roadmap for the union territory for the next 25 years stating that the conflict entrepreneurs were not happy with the situation in valley post abrogation of Article 370. He also revealed that in first seven months 1.27 crore tourists have already visited the region. This shows that the situation is headed in the right direction. But it is time, the prevailing peace is topped up with restoration of democracy.

On Imran Khan's Arrest and Pakistan's Democracy

or the second time in three months, Pakistan's former Prime Minister Imran Khan has been arrested, this time after a conviction in a case involving the misappropriation of official gifts meant for the 'Toshakhana'. He was last arrested on May 9 in the 'Al Qadir' trust case charge sheet. The latest conviction, which carries a sentence of three years, means that he is now disqualified from Parliament for the next five years, and will not be able to stand for election in polls due by November. Last week, Prime Minister Shahbaz Sharif had announced that he would dissolve Parliament on August 9, after which an interim government will step in. It is significant that Mr. Khan's arrest came days before the transition. The legal battle Mr. Khan faces now is formidable, but he is by no means the first Pakistani Prime Minister to face jail time and disqualification. During his tenure, his government had pursued cases against former Prime Ministers Nawaz Sharif and Shahid Khaqan and other major Opposition leaders including former President Asif Ali Zardari. The common factor is that all these arrests appear orchestrated not so much by political rivalry, but due to problems with the powerful military. In Mr. Khan's case, he faced months of house arrest under former Pakistan President General Pervez Musharraf, but subsequently came to good terms with the military. His stunning electoral win in 2018 was believed to have been achieved with General Qamar Bajwa's blessings. However, after they developed differences, Mr. Khan's political troubles began to mount.

The government's actions are excessive by any measure. The case Mr. Khan has been arrested for is just one amidst about 100 cases he has been charged in ever since he was ousted from office in April 2022. Apart from the litany of legal cases against him and his family, there has been a systematic attempt to prosecute leaders of his party, the Pakistan Tehreek-e-Insaf. In addition, cases of terrorism, sedition and blasphemy against Mr. Khan and his colleagues indicate there could be more serious sentences to follow. At the same time, his ouster from power and the cases have not visibly challenged his popularity in Pakistan, going by the by-election results last October, and the anger after his arrest in May. In that sense, the fact that his conviction and arrest in the latest case were not accompanied by similar protests is not an achievement for Pakistan's government, but demonstrates the effectiveness of its establishment in silencing public expression. None of this augurs well for Pakistan's democracy.

Data Protection Bill Dangerously Overrides RTI Law

e live in a world which is driven by data. Indeed, sharing of data has a lot of benefits but data sharing is not safe as well, especially as far as personal data is concerned.

Many government as well as private sector organisations have personal data of citizens, clients and customers such as their names, addresses and contact details. Sensitive information like medical health data is also available.

If this personal information goes into the wrong hands, people could be harmed. Depending on the situation, they could become victims of identity theft, discrimination or even physical harm. That is the reason many countries have already enacted legislations to safeguard the personal data of their citizens.

Now, the Govt of India has also introduced the Digital Personal Data Protection Bill, 2023 (DPDP Bill) in parliament. This bill was passed by the Lok Sabha on Monday August 7th 2023 amid criticism from opposition parties and Right to Information Activists.

Although the law on data protection was much needed in India but some fear that provisions of the data protection bill will impact people's Right to Access to information under RTI Act 2005. The bill contains substantial penalties, which ranges between Rs 50 crore to a maximum of Rs 250 crore, for those found violating the provisions of this proposed law.

Objective of Data Protection Bill 2023

The basic aim of the Digital Personal Data Protection Bill, 2023 is to establish a legislative framework for the protection of personal data. The law allows to oversee the personal data collected within India, both online and offline data that has been subsequently digitized isn't misused. As per the data protection bill 2023 if the data processing takes place outside India but involves offering goods or services to the people within the country, the provisions of this bill would apply automatically.

The Union Minister of Communications, Electronics and Information Technology Mr Ashwini Vaishnaw had introduced the bill in the Lok Sabha on August 3rd 2023 in spite of the criticism from the opposition.

The opposition.

The opposition parties had been demanding to refer the bill to the standing committee for changes and modification. The Union Minister however defended the Govt's stand and called this bill a "normal bill" and moved it for discussion.

The proposed data protection law applies to all the business ventures, societies, groups, clubs or any other public enterprises. Even a sole trader or self-employed person working for himself or herself comes under the ambit of the new law. This means organisations or individuals having registered entities and only employ a handful of staff or not employ any staff at all, they too come under the purview of the proposed Personal Data Protection Law.

Background

In 2017, the Supreme Court of Indiadeclared the Right to Privacy a fundamental right, as this is "intrinsic" to our guarantee of "life and personal liberty" under the provisions of the Article 21 of the Constitution. To understand this in a more easy way, the citizens of the country in an age of

data are supposed to be granted the complete ownership of their personal data.

Unfortunately, the proposed Personal Data Protection legislation that is being debated, discussed and drafted since 2018 by the panel headed by Justice Srikrishna submitted a proposal to Govt in 2018. Several drafts were prepared and a joint parliamentary committee (JPC) was given several extensions to examine. The JPC on Data Protection Bill advised for extending the scope of this bill to cover non-personal data as well as specific breaches that may compromise the confidentiality, integrity or availability of such data. Among other

the right to demand the erasure and correction of data collected by the data fiduciary (company). Data principals will also have the right to nominate an individual who will exercise these rights in the event of their death or incapacity. Under the new Data Protection Bill there is a provision to establish a Data Protection Board (DPB) to ensure compliance with the Bill. In case of an unsatisfactory response from the Data Fiduciary, the consumers can file a complaint to the Data Protection Board.

DPDP Bill overrides RTI Act 2005 Several leading RTI activists formation as many people would take advantage of data protection law by not sharing public information under the garb of personal information as mentioned in section 8 (1) (J) of RTI Act 2005. The section 8(1)(j) of the RTI Act, 2005 reads:

"Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen

(j) information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the

things, it also wanted social media platforms that do not act as hands-off intermediaries to be held accountable as publishers for the content they host.

Principles of Data Protection

The usage of personal data by organisations must be done in a rightful manner through a transparent process. The personal data must only be used by the companies, organisations or any other legal entity for the same purpose for which it was acquired by them from people.

The data should be as minimum as possible and should be accuracy accurate as well. The personal data that is collected cannot be "stored perpetually by default" and the storage should be limited to particular fixed time duration and the data collecting organisations must ensure that no unauthorized collection or processing of the personal data is done.

The organisations and individuals who decide the purpose and means of the processing of personal data have to be held accountable for such acts.

Right to Consent

The Individuals need to give consent before their data is processed and "every individual should know what items of personal data a Data Fiduciary wants to collect and the purpose of such collection and further processing. Individuals also have the right to withdraw consent from a Data Fiduciary. The term 'Data Fiduciary", referring to any entity determining how personal data is processed. This encompasses organizations collecting data for services, research, or marketing. The Digital Personal Data Protection Bill (DPDP Bill 2023) has a provision of 'Significant Data Fiduciary' (SDF), which carries additional obligations. SDFs are determined based on factors like data volume, sensitivity, processes, turnover, and technology use. The proposed law makes it mandatory on data fiduciaries to safeguard personal data and privacy. The makes sure the consent is sought, requiring it to be informed, specific, clear, and reversible.

Data Protection Board

The data principal means the natural person/individual to whom the personal data relates. The Data principals will have

like Aruna Roy,Nikhil Dey, Anjali Bhardwaj and many others across the country have been opposing some provisions contained in the DPDP Bill 2023. The activists had urged upon the Govt to adopt an extensive and rigorous pre-legislative consultation process for the proposed DPDP Bill, including ensuring dissemination of the draft bill through various modes and in multiple languages.

The Govt is said to have held only a handful of consultations and RTI campaigners were not invited in it.

Their main concern is the amendments made to RTI Act 2005 (section 8(1) (j) by the DPDP Bill, 2023 passed in Lok Sabha. The amendments in the the RTI Act, 2005 through the DPDP Bill will severely restrict the scope of the RTI Act and adversely impact the ability of people to access in-

State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information:"

While speaking during the debate on the new Data Protection Bill, Congress MP Adhir Ranjan Chowdhury called it a "sinister move" to "trample" the Right to Information Act, 2005. He added that the change will introduce an "era of corruption" because personal data like assets and liabilities, and educational qualification of "corrupt government functionaries won't be revealed."

Civil society activists led by Aruna Roy in a letter to Govt said, "Through this amendment, all personal information can be denied, even if disclosure of that information is relevant to the larger part of public activity or in public interest as provided for in Section 8 of the RTI Act. This gives legal sanction for government entities, government functionaries and political executives to remain opaque in their functioning "

Conclusion

The enactment of Data Protection Law is a welcome step but the way section 8(1)(j) of RTI Act 2005 has been amended through this act is not a good decision at all. The Govt should have held more consultations before introducing this bill in Lok Sabha. The section 8 (1) (j) of RTI Act 2005 prevents a public authority from sharing anyone's personal information on two main grounds - that the disclosure will have no bearing on any public activity, and that revealing such information would cause unwarranted invasion of the privacy of an individual, unless such disclosure is justified in larger public interest. The DPDP Bill 2023 passed by the Lok Sabha says that the personal information of public officials will not be disclosed under the RTI Act 2005. The two key grounds, that such information could be disclosed provided it serves a larger public interest has been recommended to do away with.

Differently-abled Persons, Families & The Equalization Of Opportunities

Differently-abled persons can be converted from tax consumers to taxpayers, from beneficiaries to benefactors, given the opportunity for self-development and provided with equal opportunities for education, vocational training and employment.

When we look back in time, we find that the beginnings of work for the disabled leading to better opportunities, more services and programmes were initiated in many cases either by the dis-abled themselves or by their families. Perhaps the best example of this is Louis Braille, the inventor of what is now come to be known as the Braille Script which has provided blind people with the most satisfactory means of reading and writing by touch. Braille indeed opened the floodgates of knowledge to the blind and removed one of the major obstacles in the path of equalization of opportunity for blind people. Leading organisations for disabled people in India providing educational, vocational training and employment services were established by family members. Mrs. Fatima Ismail, the mother of a Polio affected child was the founder of the Fellowship of the Physically Handicapped in Bombay. Mrs. Mithu Alur, the mother of a Spastic Child established the Spastic Society of India. The motivating spirit behind the establishment of the organisation for the blind in the country was Mr. R. M. Alpaiwalla, a blind lawyer and its founder President for the first ten years.

Since the '70s, organisations of differently-abled persons have come into being in most countries. Perhaps the earliest of these organisations was the Blind Men's Association of Bombay established in 1974 by a group of blind persons. Today there are a number of similar organisations in India including the National Federation of the Blind and the All India Confederation of the Blind.

Economic independence is the most important factor that can lead to equalization of opportunity and meaningful existence with self-respect and dignity. In the developed and more affluent countries, economic independence can also be



secured through social security measures. In the developing countries, however, social security is virtually non-existent and hence employment with adequate wages is of prime importance. The disabled need jobs even more desperately than the able bodied but as may be expected with unemployment and underemployment plaguing the countries in the Third World, they find themselves on the lowest rung of the ladder. For most disabled people getting a job is difficult. By and large those who do succeed in finding jobs are able to do so in the lowest paid ones requiring little skill or ability – very often, far below their abilities and potential.

Education and vocational training facilities for the differently-abled people in most developing countries have remained stagnant. While science and modern technology have made tremendous leaps in the latter half of the 20th century opening up new avenues and new horizons for the able-bodied, the disabled are still being trained in traditional crafts and not in modern technology training and techniques. Differently-abled people themselves and their families cannot and should not wait for Governments and agencies / institutions to take action to improve the situation. They must now take steps themselves to initiate change. Most

Governments in the developing countries are faced with gigantic problems of economic growth, industrial development, social upliftment, health, building up of an infrastructure and so on. The disabled are only a small proportion of the general population and hence receive a low priority in their developmental plans.

Unfortunately, the organisations of the differently-abled have in recent years indulged in rivalry and infighting. This has resulted in dissipation of their energies. Much work needs to be done in developing countries. Organisations of the disabled could play a very important role in achieving equalization of opportunities

by coordinating their efforts and acting in cooperation with the agencies. Working jointly with the agencies they could become a strong force in persuading Governments to recognise the rights of the disabled and provide for equal opportunities.

The family plays the most crucial role in the life of a disabled person. Apart from basic personality traits of the person concerned, it is the attitude and the actions of the members of the family that determine the future course of the life of the disabled person. It is here that equalization of opportunities needs to and must begin. A differently-abled child rejected overtly or covertly by the family or at the other end of the scale given preferential treatment is most likely to grow up into an adult with unhealthy attitudes towards himself and towards society. It is imperative, therefore, that the family treats a disabled member as a part of the family without either rejection or "special" treatment. The family should provide equal opportunities of education, work, and socialization. This is the best training the family can provide and it is also a means of assuring that the disabled member is treated normally by other relations, friends and neighbours. Families can provide for some of the special needs of disabled people e.g. reading for the blind, assistance in mobility for the physically handicapped, interpretation for the deaf. Most important of all, the family can encourage and motivate independence to the extent possible depending upon the degree of impairment.

Differently-abled people in many developing countries are now taking the lead in promoting the setting up of much needed services and bringing about a change in attitudes towards disability. However, significant changes in attitudes and true equalization of opportunities will occur only when these people fully accept their responsibilities to contribute to the betterment of the community and

The Hollywood writers' AI fight is everyone's fight

Artificial intelligence is big business's new flavor of the month. Companies are rushing to showcase how they will be using new generative AI models, and the media is full of stories about the technology's transformative potential. There is no denying that it could significantly increase productivity. But who stands to benefit? The ongoing Writers Guild of America (WGA) strike may offer an answer.

Hollywood screenwriters are confronting a future that all knowledge workers will soon face – and without the benefit of union representation. At issue is how AI will be used, and by whom. Will TV and movie producers see AI as a way to replace writers and cut costs, or will they use it to create higherquality content, empowering creative workers to be more productive and earn higher incomes?

We have been down a similar road before. In the early twentieth century, rapid improvements in manufacturing technologies such as moving assembly lines and electrical machinery led to a sharp increase in productivity. Henry Ford, a pioneer in applying these technologies, estimated that motorenabled machinery "alone has probably doubled the efficiency of industry," while also making it possible to build much larger factories. But workers did not automatically share in these gains. On the contrary, that did not happen until new tasks had been created, and until workers had acquired enough bargaining power to demand higher wages. These are the two pillars of shared prosperity.

While Ford and his contemporaries certainly did automate some processes, their improved factories also introduced a lot of new activities that required human labor – from material preparation and machine maintenance to coordinating operations. These tasks expanded workers' contribution to production and translated into a big increase in the demand for labor. In 1899, the US car industry employed a few thousand workers, producing around 2,500 vehicles per year. By 1929, Ford and GM were each making 1.5 million cars annually (with total US auto production around 4.5 million), and the industry employed more than 400,000 people.

The second pillar is bargaining power. The famous sit-down strike at GM in 1936-37 was a key step in



achieving union recognition, improved working conditions, and higher compensation for workers. Over several decades, the new balance that developed between management and workers in automobile manufacturing contributed to rapid wage growth. Part of what made this possible was an emphasis on continually training and upskilling workers to handle new tasks. Both employers and employees benefited from the productivity gains.

By the 1960s, US auto production had doubled since the 1920s, with the four largest manufacturers employing 1.3 million workers - more than three times the industry's employment four decades earlier. Moreover, inflation-adjusted profits for the dominant firms, GM and Ford, were around five times higher than in previous decades.

The rise of organized labor in the auto industry

also established a model of capital-labor negotiations for other industries to follow. Imagine what would have happened if manufacturing companies attempted to adopt "worker-less factories" in the 1950s, as some had started advocating. Productivity growth (not to mention shared prosperity) would have suffered greatly as the human contributions to technical work, design, maintenance, inspection, and creative problem-solving were undermined or

Today, we are confronting equally revolutionary changes, now that executives are considering how to apply generative AI to all components of knowledge production and distribution. Leading techfocused companies face many of the same choices that car manufacturers had to make at the beginning of the twentieth century. Should powerful

new technologies be used to automate knowledge work and sideline workers? Or could AI become a tool to boost worker productivity and creativity? Much will depend on whether workers have a voice, and on how such choices affect productivity and product quality.

There are grounds for thinking that the WGA strike could be more important even than the struggles for union recognition at Ford and GM's factories a century ago. For starters, Hollywood's creative workers are uniquely well-organized and powerful compared to workers in other industries. If they fail, other knowledge workers will stand even less of a chance of shaping the future of work and technology.

The choices ahead of us are epochal, because there is an obvious temptation for movie producers to choose the low road of "just automate everything you can." This approach may be profitable in the short term if it allows for more shows to be cheaply produced, with fewer screenwriters, actors, and other staff. But studio profits and highquality output are not the same thing. There still is no substitution for human ingenuity and creativity. Look past the hype, and it should be clear that predicting the next word in a sentence and aggregating the "wisdom" available on the internet are unlikely to generate superior artistic output – even if large language models could produce mediocre sitcoms.

The low road is especially costly because of what it misses. Generative AI could become a tremendously beneficial tool in the hands of creative artists, by helping with research and the development of new ideas. If we can find our way to this high road, AI could drive further technological progress and bolster the returns from human ingenuity.

Much is riding on the writers' strike. Obviously, it would be a disaster for workers if they are sidelined by movie studios. Knowledge workers – and, indeed, all workers - should hope that the WGA and its members succeed in showing not only how unions can raise wages in the short term, but also how technology can be used to support creativity, rather than simply displacing it. – Project Syndicate

Study Finds How To Treat Food Allergy Diseases In Children

esearchers have discovered a new treatment for chronic immune system disease that can prevent children from eating.

Food allergies or airborne allergens cause eosinophils, a type of white blood cell, to accumulate in the lining of the oesophagus, causing eosinophilic esophagitis (EoE). This shortens the oesophagus and thickens the oesophagal wall, making swallowing difficult and causing food to become stuck in the throat.

The disease affects approximately one in every 2,000 adults, but it is more common in children (1 in every 1,500), where symptoms can be more difficult to diagnose and pose greater risks, as difficulty feeding can lead to malnutrition, weight loss, and poor growth.

The new study, published in Nature Communications Biology, discovered that the disease is caused by Interleukin-18 (IL-18), a protein involved in the innate immune response that, when produced in excess, can cause inflammation

When a food allergen enters the body, it activates

a pathway that regulates the innate immune system, causing the release of proinflammatory proteins such as IL-18. This results in the production of eosinophils, which cause esophageal damage.

The study discovered that inhibiting this pathway, known as the NLRP3 pathway, and the release of IL-18 successfully prevented the development of EoE from both food and airborne allergens.

"Parents and doctors may not be aware of this, but this is a very prominent and serious disease in the pediatric population, and it is increasing in number because the rise," said lead author Dr. Anil Mishra, director of the Eosinophilic Disorder Center at the Tulane University School of Medicine.

'In this study, we show that after treating the disease in animals, the disease is gone and completely in remission." The findings are crucial for a disease that was not identified until the 1990s. For many years, EoE was misdiagnosed as gastrointestinal reflux disease (GERD), despite GERD medication being ineffective in treating EoE.

Air Pollution Could Be Driving Rise In Antibiotic Resistance, New Lancet Study Finds

ontrolling air pollution could aid in reducing antibiotic resistance, which is when disease-causing microbes are able to resist the drugs designed to kill them, according to new research published in The Lancet Planetary Health journal.

The association between PM2.5 air pollution and increase in antibiotic resistance has strengthened over time, with enhances in PM2.5 levels leading to larger increases in antibiotic resistance in more recent years, the analysis found using data for 116 countries from 2000 to 2018.

Sources of PM2.5 include industrial processes, road transport, and domestic coal and wood burning.

Previous research indicates 90 per cent of the world's population, or 7.3 billion people, are directly exposed to unsafe average annual PM2.5 levels, with 80 per cent of them living in low- and middle-income countries.

PM2.5 air pollution was one of the leading factors driving antibiotic resistance, accounting for 11 per cent of changes in average antibiotic resistance levels globally, this study found.

Further, every 1 per cent rise in air pollution was linked with an increase in antibiotic resistance of between 0.5 and 1.9 per cent, depending on the pathogen, or the disease-causing microbe, the study covering nine bacterial pathogens

and 43 types of antibiotics found.

The highest levels of antibiotic resistance were found to be in North Africa, the Middle East and South Asia, while levels in Europe and North America were found to be low.

Misuse and overuse of antibiotics still remain the main drivers of antibiotic resistance. However, evidence suggests air pollution



also contributes to the spread of antibiotic-resistant bacteria and resistance genes, the study said.

PM2.5 air pollution-driven antibiotic resistance was also linked to an estimated 480,000 premature deaths in 2018, leading to additional economic costs of USD395 billion, the analysis said.

Owing to their huge populations, India and China are expected to face the greatest impact of PM2.5 changes on premature death toll from antibiotic resistance.

By 2050, levels of antibiotic resistance worldwide could increase by 17 per cent under no changes to current air pollution policies, the authors' modelling suggested.

India is expected to experience a 2.5 per cent increase in antibiotic resistance resulting from a 10 per cent increase in yearly PM2.5 levels.

In other scenarios, such as increased health spending, controlling air pollution, improving drinking water and reducing anti-

biotic usage, the level of antibiotic resistance could be greatly reduced, the study said.

or example, limiting PM2.5 to 5 micrograms per cubic metres in the atmosphere (recommended by the World Health Organization) could decrease global antibiotic resistance by 17 per cent by 2050. It could further reduce premature deaths linked to antibiotic resistance by 23 per cent and save USD 640 billion annually, the study said.

"Antibiotic resistance and air pollution are each in their own right among the greatest threats to global health. Until now, we didn't have a clear picture of the possible links between the two, but this work suggests the benefits of controlling air pollution could be two-fold: not only will it reduce the harmful effects of poor air quality, it could also play a major role in combatting the rise and spread of antibiotic-resistant bacteria," said lead author Hong Chen, Zhejiang University, China.

Future research should investigate underlying mechanisms of how air pollutants impact antibiotic resistance, the study said.

NEW DELHI: Citing increased workload, a parliamentary committee has said public sector banks have to be very fast with public dealing besides being absolutely updated on the latest technology.

In its latest report, the panel also said the pattern of recruitment examination needs to be changed from time to time taking into account the nature of the work of the bankers so that accuracy and speed of the prospective candidates are properly evaluated.

The philosophy of speed and accuracy required by bankers are changing from time to time. Around 10 years back, the workload and the nature of work perhaps did not need any speed or accuracy.

"But today, speed and accuracy play a very important role owing to the hundreds of central and state schemes being executed by the bankers and the nature of pro-poor schemes launched by the government," the Department-Related Parliamentary Standing Committee on Personnel, Public Grievances. Law and Justice has said.



The Committee emphasised that because of the technology being used nowadays, whether it is e-banking or online banking, "public sector banks have to cater to large number of customers including the Jan-Dhan Yojana account holders and hence bankers have to be very fast with public dealing an also absolutely updated on the latest technology"

28% GST On Face Value In Casinos, Online Gaming, **Horse Racing Will Increase Revenue Collection: FM**

NEW DELHI- Finance minister Nirmala Sitharaman on Tuesday said the 28 per cent GST on full face value of supplies in casinos, race courses and online gaming will result in higher

The online gaming segment to reach USD 1.9 billion, as per NITI Aayog estimates referred in the Draft National Policy for Growth of Animation, Visual Effects, Gaming, Comic & Extended Reality sector in India prepared by the Information and Broadcasting Ministry.

In a written reply to a question in the Rajya Sabha, Sitharaman said casinos are currently paying 28 per cent GST on Gross Gaming Revenue (GGR).

Online gaming industry supplying actionable claims and some horse race clubs are currently paying GST at the rate of 18 per cent on platform fees/ commission ranging from 5



value, while some horse race clubs are paying 28 per cent on the full face value.

Sitharaman said gaming companies supplying actionable claims and some horse race clubs paying 18 per cent on platform fee/commission are disputing the 28 per cent levy on actionable claims in the form of betting and gambling before various legal fora.

"It is anticipated that the levy of 28 per cent on full face value, as recommended in the 50th GST Council meeting, will result in increase of revenue from current levels," Sitharaman added.

Trai Recommends No Licence Fee **On Permits For Telecom Infra Firm**

NEW DELHI: Telecom regulator Trai on Tuesday recommended the government creates new permits for digital infrastructure service providers but no licence fee is imposed on the companies.

Entities registered under the proposed licence will be able to provide both active infrastructures like mobile antennae and base stations and passive infrastructure as service to telecom operators except core network elements and spectrum, according to Trai's recommendation on "Introduction of Digital Connectivity Infrastructure Provider (DCIP) Authorization under Unified

Licence" "The Authority recommends that the new category of licence be called 'Digital Connectivity Infrastructure Provider (DCIP) Licence'," The Telecom Regulatory Authority of India (Trai) said in its recommen-

The regulator has recommended an entry fee of Rs 2 lakh and an application processing fee of Rs 15,000 on DCIP permits.

"The Authority recommends that there should not be any licence fee applicable to DCIP authorization,"

Earlier, DoT had introduced Infrastructure Provider II licence which allowed companies to establish digital networks, provide transmission capacity, leasing and sale of end to end bandwidth and such firms were required to pay a

The government had discontinued IP II licences in December 2005 as telecom tower companies opposed paying any licence fee for providing infrastructure.

At present, entities that own and operate active network elements are required to pay an 8 per cent licence fee.

Trai has recommended that the proposed DCIP license should not be standalone license, but an authorization under Unified License.

"The Authority recommends that enabling provision should be made by DoT for DCIP Licensees to purchase radio equipment without assignment of any spectrum," Trai recommended.

Govt Lost Rs 1 Lakh Cr In Taxes In FY'21 Due To **Corporate Tax Cut: MoS Fin**

NEW DELHI: The government lost a little over Rs 1 lakh crore in 2020-21 on account of a cut in corporate taxes, Minister of State for Finance Pankaj Chaudhary said on

In September 2019, the government announced a cut in base corporate tax for then existing companies to 22 per cent from 30 per cent; and for new manufacturing firms, incorporated after October 1, 2019, to 15 per cent from 25 per cent. Companies opting for these new tax rates had to forego all exemptions and incentives. The effective tax rate for existing units, after considering surcharges and cess -- such as Swachh Bharat cess and education cess, which are levied on top of the income and corporate tax rates -- is 25.17 per cent as compared to 34.94 per cent earlier. For new units, it is 17.01 per cent as against 29.12 per cent previously.

In a written reply in the Rajya Sabha, Chaudhary had said the estimated revenue loss (due to reduction in corporate tax) in FY 2020-21 has been reestimated to be Rs 100,241 crore.

In February, the Minister had informed Parliament that the revenue loss in 2019-20 fiscal due to reduction in corporate tax rate from 30 per cent to 22 per cent was Rs 1,28,170 crore. As per the corporate tax collection data shared by Chaudhary, in fiscal 2022-23 the provisional revenues stood at over Rs 8.28 lakh crore, higher than over Rs 7.12 lakh crore in 2021-22.

Credit Card Default Rises To Rs 4,072 Crore In FY23

NEW DELHI: Credit card default rose to Rs 4,072 crore or 1.94 per cent at the end of March 2023, Parliament was informed on Tuesday.

"As per the inputs received from RBI, in respect of defaults in credit cards, the gross nonperforming assets (GNPAs) in credit cards was Rs 3,122 crore in March-2022 and Rs 4,072 crore in March-2023, while credit card outstanding in March-2022 and March-2023 was Rs 1.64 lakh crore and Rs 2.10 lakh crore, respectively," Minister of State for Finance Bhagwat Karad said in a written reply in Rajya Sabha.

GNPAs in credit cards have declined from 3.56 per cent in March 2021 to 1.91 per cent in March 2022, and stand at 1.94 per cent in March 2023 against the schedule commercial banks' GNPA of 3.87 per cent in March 2023, he said.

Replying to another question, Karad said, the total number of frauds as reported by the coop-

erative banks during FY23 was 964 with amount involved to the tune of Rs 791.40 crore. During FY22, the total number

of fraud was 729 and the amount involved was Rs 536.59 crore as against 438 frauds involving Rs 1.985.79 crore in FY21, he said.

All cooperative banks are required to comply with the guidelines issued by the Reserve Bank of India (RBI) from time to time, he said.

Compliance to RBI guidelines issued to banks is examined on sample basis during the supervisory assessment of the banks and any non-compliance observed is taken up with the banks for rectification apart from initiating supervisory/ enforcement action against the bank, as deemed fit, he said.

RBI and NABARD have informed that they undertake measures for strengthening fraud risk management in banks, including issuing caution advises, advising banks for rotation and mandatory leave of staff, compliance monitoring, cyber security advisories, etc., he said.

In a separate reply, Karad said,

as per inputs received from public sector banks, several steps have been taken to ensure ethical debt collection practices.

Banks conduct auction of the properties through online portals, as per their board approved policy framed under the guidance of fair practices code issued by Reserve Bank of India, and applicable laws and regulations of the SARFAESI Act, 2002, he said.

Banks also issue public auction notices of properties in two newspapers, i.e. in English as well as in vernacular local language, he said.

Further, he said, multiple valuations are obtained from empanelled/registered valuers to calculate reserve price of auction and the same is fixed with the approval of competent authority.

Besides, he said, RBI as part of its supervisory assessment, reviews adherence to its guidelines, and non-compliance observed are taken-up with banks for rectification apart from initiating supervisory/enforcement action, as deemed fit.

Dr Khuroo explained that the mountain ecosystems relatively remain untouched and less human-inhabited. Lately, these high-elevation areas are witnessing a change due to the expanding tourism sector and rise in road constructions. "This has resulted in an increased human foot-print in these ecologically fragile areas. Subsequently, some new types of seeds, alien plants or insects are getting introduced there along with the human and vehicular movement. Most of them are not able to adapt in the new habitat as they come from warmer regions. However, with changes in climate and increasing anthropogenic pressures, some of these alien plants are able to acclimatise," he

The botanist, with two-decade long experience in this area of research, pointed out that over a period of time, few of the acclimatised species can turn invasive and start proliferating the habitats of native flora. "With the result, they outcompete and slowly dislodge plant species that have evolved specifically to

For example, in Kashmir Himalaya, Dr Khuroo elaborated, the Mexican water lily, (Nymphaea mexicana) has proliferated across the Dal Lake. It is a species of aquatic plant that is native to the Southern United States and Mexico. "This plant species has a rapid growth rate and becomes weedy in dams, ponds and rivers. We are already witnessing the monopolization of this alien plant species in Dal which clearly shows its invasive characteristics."

Another example of invasive plant species in mountain ecosystems of Kashmir is Leucanthemum vulgare, commonly known as the ox-eye daisy. It was introduced in the valley around the 1950s-1960's. That time, it was growing in flower beds within gardens and parks. "Over a period of time, it has escaped and presently covers a large portion of Gulmarg and other meadows. This is how the diversity rich meadows are getting overpowered by these single invasive species," Dr Khuroo said.

Similarly, Kashmir Himalaya is also seeing an increase in the growth of ornamental flowers like Lupin in high-elevation areas like Gulmarg. It belongs to the legume family Fabaceae. Earlier, its cultivation remained restricted to the hotel parks. "Like other invasive plant species, it is also escaping the flower beds and is now found on a large scale in the meadow. Currently, the plant species extends its growth towards forest gaps. It means the plant in near future will continue to grow at cost of other native flora," he said.

Dr Khuroo emphasized that mechanical removal treatments are usually the first ones to look at when evaluating an invasive plant removal project. These procedures do not require special licensing or introduce chemicals into the environment. "Similarly, we can collect the seeds of the native plants in the autumn season. It's the time of the year when plants make grass and disperse its seed. We can identify the target invaded area and remove the invasive plants from it. This should be followed by mixing the soil with native seeds. This way, we can aim for the ecological restoration of the native plants," he detailed.

He added, besides public awareness, the relevant Government departments like Floriculture, Agriculture, Forests can also put in place some regulations. "We should not import every plant blindly, unless there are quarantine measures taken or initial studies done to rule out their adverse invasive impact on the native biodiversity and natural ecosystems."

Alligator gar sighted in Dal Lake

In May this year, a non-native predator fish, Alligator Gar was found in Dal Lake in Srinagar. Dr. Irfan Ahmad. Professor & Head. Div. of Fish Genetics & Biotechnology, Faculty of Fisheries, SKUAST, Kashmir explained that Alligator Gar is a native to North America and Central America primarily from the Mississippi River basin. It is an invasive torpedo-shaped freshwater fish with razor-sharp teeth, and is the largest species in the gar family.

"Gars have relatively short, broad snouts with two rows of sharp teeth in the upper jaw; other gars only have one row of teeth, and diamond-shaped interlocking (ganoid) scales. It can grow up to 8 feet long and weigh more than 300 pounds," he said.

He elaborated that Gars can live and hunt in both fresh and saltwater. The alligator gar is one of the top predators in its natural freshwater environment. It is an ambush predator that lies in wait for prev and then attacks with its large jaws. Besides, they can live for many decades. "They are considered monsters of fresh waters. They grow very fast when young, but growth slows with age.

Dr Ahmad emphasized that the reason behind the appearance of Alligator Gar in the Dal Lake is that people buy such fish for home aquariums without realising the size they grow to. Once that happens, they release the fish in the nearest water body.

"When you introduce any new species in an alien environment, the theory of invasion says the new species will fill an ecological niche in the environment. It will do so by breeding exponentially so that there are maximum chances that it survives and secures its place," Dr Ahmad pointed out.

The scientist added, for example, the Common Carp and Trout were introduced in 1956 and 1900 for the economic upliftment of people. Since its introduction (Common carp), the population of native fish species like Schizothorax or Snowtrout has declined drastically. This is because its faster growth, hardy characteristics suited the culturally eutrophicating water bodies which proved to be an extirpating factor for the local ichthyofauna. The breeding and feeding habits have also contributed to some extent.

"Research shows that the total catch composition of Schizothorax has reduced to less than 15 percent while as the common carp comprises of 80-85 percent. Amid the establishment of common carp as major catch and other exotic fish species, the sighting of alligator gar is disturbing," he said.

Dr Ahmad said, however, only one specimen of gar has been found in Dal Lake so far. "Also, we are not sure whether it was male or female. There is more probability of this specimen being sexually immature as of yet. It takes more than 5 years for a female alligator gar to mature

and more than two years for the male. He stressed that the J&K Lake Conservation and Management Authority should keep a close vigil on the functioning of the lake by pressing in their men and machinery. "Besides, the authorities can place hoardings at important places and conduct awareness programmes on how to prevent our ecologically sensitive aquatic habitats from the invasive species. For instance, they can talk about ethical fish keeping which if we plan to own an exotic pet, do your research and plan ahead to make sure you can commit to looking after it. It's not just large fish that can cause havoc. Grass carp and small ornamental fish species popular in aquariums can be just as great a threat to native fish

Wild Boars pose a threat to critically endangered Kashmir Stag

Wild boar or wild pig (Sus scrofa) is not native to Kashmir region but is said to have been introduced during the time of Maharaja Gulab Singh (1846-1857). The animal was mainly introduced in Dachigam national park and some selected areas which were used for hunting

Intesar Suhail, Wildlife Warden of Shopian district in South Kashmir told Kashmir Observer that the species almost vanished in the mid 80's. However, the wild pig showed signs of revival in 2013 after a gap of 30 years. It was spotted by a camera trap installed by SKUAST-Kashmir in Dachigam national park. Although, there is no population estimation done on wild boar as of yet, we have recorded its occurrence in Limber and Lacchipora wildlife sanctuary in North Kashmir, Shopian and Achabal in South

"It's quite possible that the wild pig resurfaced due to the change in climate and warmer winters as it cannot survive in extreme cold," Suhail said

The wildlife expert noted that the wild pig is regarded as an ecological hazard for the local flora and fauna. "One of most eminent threats posed by the animal is its feeding pattern. They have the ability to uproot and destroy vegetation, which is essential for the survival of many native animal species in the region. Boars are omnivores and will eat a wide range of plant and animal matter. However, as opportunistic feeders, they will eat much of what they come across on the forest floor. Moreover, wild boar population can increase rapidly. It is a prolific breeder can give birth to a litter size of six to eight individuals in a single time.'

He explained, secondly, it poses a threat to the critically endangered Kashmir stag aka Hangul. Both the animals share the same habitat, therefore puts wild boar in direct competition for critical resources like shelter, water, food etc, with the Hangul and other animal

"Also, food scarcity increases for Hangul in winters. It remains restricted to lower Dachigam in the extreme cold. Since the wild pig shares same habitat as Hangul, there are chances that it might not leave enough food for the latter. Besides, one positive outcome can also emerge out of it. The wild pig might offer an alternative prey to predators like leopard. But all these factors need to be studied and investigated properly," Suhail said.

During the third-day of the hearing on the pleas challenging the Centre's August 2019 decision, Sibal repeated his contention before the bench, also comprising Justices Sanjay Kishan Kaul, Saniiv Khanna, BR Gavai and Surva Kant.

"This court will remember Brexit. In Brexit, there was no constitutional provision (in England) seeking a referendum. But, when you want to sever a relationship which has been entered into, you must ultimately seek the opinion of the people because people are at the centre of this decision not the Union of India," Sibal asserted.

Chandrachud was, however, not impressed.

"In a constitutional democracy, seeking the opinion of people has to be done through established institutions. So long as a democracy exists as it does, in terms of constitutional democracy, any recourse to the will of the people has to be expressed and sought through established institutions. You cannot therefore envisage a situation like Brexit type referendum," he

He concurred with Sibal's view that Brexit was a political decision but said, "Within a Constitution like us there is no question of referendum."

Sibal said the repeal was a political decision taken unilaterally by the executive and it cannot be called a decision that was in consonance with the Constitution.

Sibal, who argued through the day, said whether Article 370 was a temporary or permanent provision does not matter now. He said the ultimate question is whether the Union of India can terminate that relationship which was constitutionally recognised under Article

"It is irrelevant. Temporary or permanent does not matter. The manner it was done is a fraud upon the Constitution. It is a politically motivated act. Executive orders are political acts not constitutional acts. Permanent or temporary at the moment is not the issue.

"The reason why I am saying this is because maybe there is a constitutional way of doing it. Though, I am not addressing that (issue) nor have they (Centre) resorted to constitutional methodology. If they resort to it, it will be tested in the court of law," Sibal said.

Sibal has been insisting that Parliament could not have assumed the role of the constituent assembly to repeal Article 370.

He questioned the Centre's decision of dividing the erstwhile state of Jammu and Kashmir into two Union Territories and said the Constitution did not allow it.

"You cannot divide Madhya Pradesh or Bihar into two union territories. This is a representative form of democracy. In this case, where are the voices of people of Jammu and Kashmir? Where is the voice of representative democracy? Five years have passed...have you had any form of representative democracy? This way the whole of India can be converted into Union Territories," he said.

Sibal said though the Constitution is a political document, one cannot manoeuvre or manipulate it as courts are not silent.

'That's not how you interpret a Constitution. It is a political document but you cannot misuse it politically. What is a Constitution? It's a set of values. Values on the basis of which people will represent themselves and their voice will be heard. If you do such executive acts and silence the voices of people, what is left of democracy?

"All I can say is that this is the historic moment, historic not for the present but for the future of India. And I hope this court is not silent,' Sibal said while concluding his arguments.

The hearing remained inconclusive and will continue on Wednesday when senior advocate Gopal Subramanian will advance his arguments for the petitioners.

Several petitions challenging abrogation of the provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh- were referred to a Constitution bench in 2019.

my view is that the doctrine of the basic structure of the Constitution has a very debatable jurisprudential basis. I would not say anything more than this."

In the landmark Kesavananda Bharati verdict of 1973, the top court had propounded the basic structure doctrine of the Constitution and held that certain fundamental features such as democracy, secularism, federalism and rule of law cannot be amended by Parliament.

During the hearing on Tuesday, senior advocate Kapil Sibal, appearing for National Conference leader Mohd Akbar Lone who has challenged the abrogation of Article 370 of the Constitution which had accorded special status to erstwhile state of Jammu and Kashmir, referred to Justice Gogoi's statement made in the Upper House.

Sibal contended that the manner in which the Centre abrogated the special status of J and K cannot be in any way justified "unless a new jurisprudence is brought so that they (Centre) can do whatever they like as long as they have

He said, "now one of your esteemed colleagues has said that in fact basic structure theory is also doubtful".

Responding to Sibal's submission, CJI Chandrachud said, "Mr Sibal, when you refer to a colleague, you have to refer to a sitting colleague. Once we cease to be judges, whatever we say, they are just opinions and are not binding."

It may be recalled that CJI Chandrachud had at a public event in January this year had called the basic structure doctrine a 'North Star' that guides and gives certain direction to the interpreters and implementers of the Constitution when the path ahead is convoluted.

The basic structure principle became the ground for setting aside several Constitutional amendments, including the quashing of the amendment and the corresponding NJAC Act on the appointment of judges in the higher

Solicitor General Tushar Mehta, who is appearing for the Centre in the Article 370 case, intervened when Sibal made the submission and said proceedings in Parliament cannot be discussed before the court just like the court's proceedings are not discussed in Parliament.

"Mr Sibal is addressing here, since he wasn't there in Parliament yesterday. He should have responded in the Parliament."

Sibal, who is an independent MP of Rajya Sabha, agreed with Mehta's submission and said he was not in Parliament on Monday during the debate on the GNCTD amendment bill. Delivering the Nani A Palkhivala Memorial

Lecture in Mumbai on January 21, CJI Chandrachud had said craftsmanship of a judge lies in interpreting the text of the Constitution with the changing times while keeping its soul

"The basic structure of our Constitution, like the North Star, guides and gives certain direction to the interpreters and implementers of the Constitution when the path ahead is convoluted." he said.

"The basic structure or the philosophy of our Constitution is premised on the supremacy of the Constitution, rule of law, separation of powers, judicial review, secularism, federalism, freedom and the dignity of the individual and

the unity and integrity of the nation." The remarks by the CJI came days after Vice President Jagdeep Dhankhar had questioned the Kesavananda Bharati case verdict and said

he does not subscribe to its conclusion that Parliament can amend the Constitution but not its basic structure.

Dhankhar, who is the Rajya Sabha chairman, had said the verdict set a bad precedent and if any authority questions Parliament's power to amend the Constitution, it would be difficult to say "we are a democratic nation".

He had asserted that parliamentary sovereignty and autonomy are quintessential for the survival of democracy and cannot be permitted to be compromised by the executive or judiciary.

Addressing the 83rd All India Presiding Officers Conference in Jaipur on January 11, Dhankhar said the judiciary cannot intervene in lawmaking.

"In 1973, a wrong precedent (galat parampara) started. In 1973, in the Kesavananda Bharati case, the Supreme Court gave the idea of basic structure saying Parliament can amend the Constitution but not its basic structure. With due respect to the judiciary, I cannot subscribe to this," Dhankhar, who has been a Supreme Court lawyer, said.

Dengue Cases

Covid-19 as there is no vaccine available for

He said Covid-19, a respiratory illness, caused by the virus known as SARS-CoV-2 is a communicable (contagious) virus, while dengue is caused through the bite of an infected Aedes species. He, however, said those having tested positive for dengue fever in Kashmir so far have a travel history.

The accumulation of stagnant water in waterlogged areas, according to the DAK president, provides an excellent breeding environment for Aedes mosquitoes, responsible for carrying the dengue virus.

However, he said the effect of dengue has always been insignificant in Kashmir as the patients having been tested positive had a travel history outside the valley into the neighboring states and that most of the patients, he said had duration of stay between 21-30 days in dengue prevalent areas.

"There is no specific treatment for dengue. However, preemptive measures like using insect repellents and the bed nets can reduce the incidence of dengue, although there is no vaccine available for the virus," Dr Nisar told Kashmir Observer.

"There is every possibility that a person once tested positive for dengue can again be infected as there is a long-term immunity to the type of virus that infects the individual, he said, adding, "Dengue causes a high fever and the signs and symptoms, include headache, muscle, bone or joint pain, nausea, vomiting, pain in eyes, swollen glands and rashes,"

State Surveillance Officer, Dr Harjeet Rai told Kashmir Observer that the vector borne disease (dengue) cases are expected to rise after monsoon and that the people must take preemptive measures to avoid getting infected.

He asked people to use mosquito repellents and wear full sleeves shirts so as to save themselves from the Aedes mosquitoes bite, which he said choose to breed in stagnant water accumulated by water logging mainly during

He said the dengue case usually goes up in September and October months when monsoon is over and that dengue mosquitoes breed in tires, barrels, plastic drums and jerry cans. But there are various other indoor and outdoor breeding sites for the Aedes mosquitoes.

Dr Rai said the health department may go for fogging, a conventional technique used to combat Aedes mosquitoes and prevent dengue disease, in case it takes the shape of an epidemic.

"Since there is no vaccine available for the disease, we recommend people to use mosquito repellents and bed nets to prevent themselves from being bitten by the Aedes mosquito. Wear full sleeves shirts, long socks and long pants when going out," Dr Rai added.

Replying to a question on the impact of Dengue in Kashmir, he said so far six positive cases with travel history have been detected in Kashmir that too through the rapid testing from a particular diagnostic lab.

He asked people having symptoms of dengue fever to adopt the proper procedure of testing other than rapid antigen testing.

He also advised people to spare at least ten hours on ten Sundays in getting their environment clean so that the Aedes mosquitoes won't have a breeding environment.

When contacted spokesman, Directorate of Health Service Kashmir, Dr Mir Mushtaq Ahmad said the prevalence of dengue has always been negligible in Kashmir compared to Jammu and that people need not to panic as the cases so far reported in the valley are

Kaul said he sees the development as a "tacit admission of the failure of state investigating authorities as the murder had taken place when the community was living in the valley. He was high on the hit-list and the government was complacent in saving his life.'

He said the reconciliation with open wounds is not possible and so is the denial of justice. "It should have been done much earlier but still we welcome it as open wounds need to be healed and the victim families provided justice." He said the government should not restrict it

'The timing of reopening of Ganjoo's case ahead of general elections next year creates a doubt in the minds of the community that the BJP wants to cash in on the development for garnering votes. They are in the government for the last nine years and should have done it before rather than at the fag end of their government," Bhat said.

He said they have talked about return and rehabilitation of the community but failed to provide any roadmap till date. "We feel that we are being remembered only at the time of the elections and no sincere effort is made to address our pain and problems."

Social activist Sunil Pandita said it is better late than never and called for setting up of a Special Investigation Team (SIT) to probe all cases of killings and arson so that people's confidence in the system is restored and such things do not occur again.

Anil Kumble's Way To Tackle

India-Pakistan Matches Is...

BENGALURU: India are set to play Pakistan in the Asia Cup and the World Cup in the coming two months, and legendary leg-spinner Anil Kumble said on Tuesday that the key will be to take it as just another game of cricket.

The former India captain has an outstanding record against Pakistan in both Tests and ODIs, having taken 81 wickets from 15 Tests, including snaring all 10 wickets in an innings (10/74) in 1999 at New Delhi.

In 34 ODIs against Pakistan, Kumble has grabbed 54 wickets. 'In our times, the word was 'lose even to Kenya but not to Pakistan'. There was pressure and expectation on the players.

"That's how the matches between India and Pakistan are being played and the key is to treat it as just another match,' Kumble said here while speaking during the launch of Pitchside, the memoir written by veteran cricket administrator Amrit Mathur.

"I did not go onto the field thinking of a 10-wicket haul, though that is the dream of any

"However, in the next Test match against Pakistan, the Asian Test Championship at Kolkata, I was struggling to take even one wicket. That is the game of cricket for you," he said.

Kumble had ended that match with figures 1 for 139 as Pakistan defeated India by 46 runs at the Eden Gardens in February, 1999.

Mathur was India's team manager during the 2004 tour to Pakistan.

He remembered the tight security which was given to the Indian team during that trip.

"Pakistan was ready to give any amount of security to us. There were police vehicles in front and behind our team bus. a helicopter above the team bus, Rapid Action Force in all major road points and snipers on top of buildings en route to the stadium, especially in Karachi.

"At one point, even players were feeling why we need so much security, but overall the tour went off well," said Mathur.

Barcelona & Madrid Face Uncertainty Ahead Of Spanish League Season

MADRID: Barcelona couldn't bring back Lionel Messi, and lost two other stalwarts in Sergio Busquets and Jordi Alba. Real Madrid couldn't sign Kylian Mbappé – so far at least – and saw veteran striker Karim Benzema leave for Saudi Arabia.

The Spanish league begins this week with the title favorites facing a transition year and squad changes that might oper the door for other challengers.

Diego Simeone's Atletico Madrid could be the team to take advantage after keeping most players in a squad that offered the best soccer in Spain at the end of last season. Real Sociedad is another outsider lurking after a strong fourth-place finish.

BARCELONA'S CHANGES

Barcelona, still not fully healthy financially, saw Busquets and Alba join Messi at Inter Miami, but it brought veteran Ilkay Gundogan from Manchester City to try to boost its chances of successfully defending its first league title since Messi left a couple of years ago.

Barcelona coach Xavi is also likely to keep Ousmane Dembélé after rumors of a transfer involving the France forward quietened recently. Dembélé was one of Barcelona's main



weapons in attack last season, along with Robert Lewandowski, the league's top scorer.

Xavi will still rely on the talent of Pedri and Gavi, who are now more experienced and more mature than when they debuted.

It didn't hurt Barcelona's confidence to beat Madrid 3-0 in a preseason game last month in the United States, when Dembélé scored one of the goals. "It's always good to win a clasico,' but there's still a lot to improve," Xavi said.

REAL MADRID'S LOSS

Madrid will be without Benzema, last year's Ballon d'Or winner, for the first time in more than a decade. The French striker was the team's top player the last few seasons, leading its attack after Cristiano Ronaldo's departure.

Benzema's exit will put more responsibility on the Brazilian duo of Vinícius Júnior and Rodrygo, who last season showed some signs that they could be ready to take on greater leadership roles.

Spain striker Joselu came on a loan from Espanyol to try to help make up for Benzema's absence, and Bellingham will add freshness to a midfield that will likely see the last seasons of veterans Toni Kroos and Luka Modric.

Also leaving the team were Eden Hazard, Marco Asensio and Mariano Díaz. Coach Carlos Ancelotti stayed to finish his contract despite repeated calls for him to join Brazil's

Messi's Exit Leaves A Big Hole At PSG As The Club Frets Over Mbappe & Neymar

PARIS: There's a big hole in the Paris Saint-Germain locker room where Lionel Messi used to sit. The way things are going at under-pressure PSG, Kylian Mbappe may also soon be vacating his spot — and maybe even Neymar too.

Soccer fans around the world took a greater interest in watching the French league last season when PSG boasted superstars Messi, Mbappe and Neymar in attack.

Those PSG fans who thought it wise to jeer the record seventime Ballon d'Or winner Messi last season may be regretting it now. Even more so if the club sells Mbappe to stop him leaving next summer for free as he

With Messi gone to Inter Miami, it should fall to Mbappe

and Neymar to lead the attack. But with Mbappe mired in a transfer standoff and Neymar still feeling his way back from his latest injury, there's a possibility neither will start the home game against modest

Lorient on Saturday.

Mbappe could be left out as PSG tries to sell him. PSG has received a world record \$332 million bid from Saudi Arabian team Al-Hilal for Mbappe, who is widely thought to want to join Real Madrid next season on a free transfer, complete with a massive signing-on fee. Mbappe has been training alone and was left off the recent tour to Japan and South Korea.

PSG president Nasser Al-Khelaifi is reportedly hugely disappointed at Mbappe, having offered him a massive contract to sign a new contract in May last year reportedly worth 6 million



euros (\$6.6 million) per month. Messi's move to Miami came after Argentina's World Cup winner didn't sign the contract

extension that Qatar-backed PSG offered him. If Mbappe goes as well, it would further deprive the French league of some star

quality, dampening early interest in the season particularly outside of France. "It's a decision that goes beyond the players. It's a question for the directors," PSG captain Marquinhos said. ''You always want great players next to you, I hope there will be a good solution so that he can come back and help us this season." France's leading sports daily L'Equipe said on Monday evening that Neymar, who is under contract until 2025, also wants to leave this summer. PSG did not comment.

Losing Mbappe and Neymar would be a massive blow to the prestige of the French league, which opens with Nice hosting Lille on Friday night, but would also be the wake-up call PSG needs after yet another season of complacency and over-reliance on Mbappe and other star performers. For while PSG won a record 11th French title last season, the second half of the campaign was dismal. Unbeaten before the World Cup started in November, PSG lost 10 matches overall in 2023 in all competitions.

PSG lost three home games in the league at Parc des Princes, which was once a fortress, including back-to-back defeats to Rennes and Lyon without scoring a goal. Even Lorient, which finished in 10th, won 3-1 in Paris, while a 3-1 defeat in Monaco saw Marquinhos and Neymar arguing with sporting director Luis Campos, who is now at odds with the club's hierarchy. Christophe Galtier was fired and the former Barcelona coach Enrique was hired to replace him.

The pre-season tour saw PSG winning only one of its four games. Although Neymar scored twice in the last game - a 3-0 win against South Korean side Jeonbuk — the intensity for this Saturday's game against Lorient will be higher and Enrique may not risk starting him.

But this gives a chance for fringe players and new recruits, like former Real Madrid attacking midfielder Marco Asensio. to stake an early claim.

Striker Hugo Ekitike and midfielder Fabian Ruiz were both disappointing last season and need to bounce back.

Mbappe's 16-year-old brother Ethan Mbappe will be hoping to get some playing time in a midfield which could yet lose Italy veteran Marco Verratti to Al-Hilal after 10 years with PSG.

If Verratti and Mbappe leave, PSG's season will start with a negative vibe surrounding the club and increase optimism that a contender can last the distance after Lens finished second by just one point last season.
