New Delhi: Union Home Minister Amit Shah on Wednesday ruled out any talks with the Hurriyat Conference, banned Jama'at-e-Islami and Pakistan, saying that the Centre will only speak to the youth of Jammu and Kashmir.

Speaking during the noconfidence debate in Lok Sabha on Wednesday, Shah also said that 40,000 people lost lives in Kashmir and that the BJP-led government at the centre has now improved the situation in the Union Territory. PM Modi, he said, took historic decision to completely merge J&K with India.

"Article 370 was a mistake by the Jawaharlal Nehru government. It was abrogated by this parliament on August 5 and 6, 2019. With that, two flags and two constitutions were gone from Kashmir and PM Modi ensured its complete integration into the country," Shah said. Yasin Malik Virtually Appears In Delhi HC

New Delhi: Separatist leader Yasin Malik on Wednesday virtually appeared before the Delhi High Court from jail in connection with the National Investigation Agency's plea seeking death penalty for him in a terror funding case.

Last week, the high court had directed that the Jammu and Kashmir Liberation Front chief, who is presently serving a life term in the case, be produced before it through video conferencing mode from Tihar Jail instead of physical appearance pursuant to the production warrant issued earlier this year.

On May 29, the high court had issued notice to Malik on the NIA's plea seeking death penalty for him in the terror funding case and said, "Let warrants of production be issued against Yasin Malik, before this Court on the next date of hearing".

Subsequently, the jail authorities had filed an application seeking permission for his virtual appearance on grounds that he was a "very high risk prisoner" and it was imperative to not physically produce him in court to maintain public order and safety.

Recently, the jailed separatist leader arrived in the Supreme Court in connection with a kidnapping case against him, prompting the Solicitor General of India Tushar Mehta to flag the "serious security lapse" to Union Home Secretary Ajay Kumar Bhalla.

HC Upholds PSA Detention Of 'Ameer' Jama'at

Says Those Responsible For National Security, Public Order Sole Judges Of What Is Needed To Be Done

Srinagar: The High Court of J&K and Ladakh on Wednesday upheld detention under Public Safety Act against Jama'at-e-Islami chief Abdul Hameed Ganie alias Dr.Hameed Fayaz. "Those who are respon-

sible for national security or for maintenance of public order must be the sole judges of what the national security, public order or security of the State requires," a bench of Justice M. A. Chowdhary said while dismissing a petition filed by Fayaz Hameed's wife, seeking quashing of the detention order under PSA by District Magistrate Shopian on



16 September last year.

"Preventive detention is devised to afford protection to society. The object is not to punish a man for having done something but to intercept before he does it and to prevent him from doing," the court said, adding, "Justification for such detention is suspicion or reasonable probability and not criminal conviction, which can only be warranted by legal evidence. Thus, any preventive measures, even if they involve some restraint or hardship upon individuals, as held by the Supreme Court in the case 'Ashok Kumar v. Delhi Administration & Ors., AIR 1982 SC 1143', do not contribute in any way of the nature of punishment."

Over 1000 Terrorists Killed Between 2018-2022 In J&K: GoI

Srinagar: Union Minister of State for Home Affairs Nityanand Rai informed Rajya Sabha on Wednesday that 174 civilians, 308 security personnel, and 1002 terrorists were killed in 761 terror attacks in Jammu and Kashmir between 2018 and 2022.

Rai in a written reply to a question said that 174 civilians were killed in J&K in 761 terror attacks in the erstwhile state in the last 5 years between 2018 and 2022.

"Furthermore, 35 civilians were killed in the Union Territory in 626 encounters occurred in the same period," he said, adding that the number of security personnel killed during the same period remained at 308 and 1002 terrorists were also eliminated by security forces.

He also said that the ministry of home affairs administers a central scheme for assistance to civilian victims, family of victims of terrorists, communal, LWE violence and cross border firing and mine or IED blasts on Indian territory for providing gratuitous assistance to the affected civilians as an immediate help for the sustenance and maintenance of the families of the victims.

Here's How Cycling Can Slow **Down the Aging Process**

t might not grant eternal youth, but cycling, scientists have found, can slow the aging process and keep your muscles and immune system healthy well into your golden years.

Aging, it turns out, can do a number on your muscles. Humans typically lose muscle mass as they get older. Fat and connective tissue also start invading, affecting the muscles' ability to contract. Furthermore, muscles can no longer suck up oxygen at the same rates.

However, a study questioned if these age-related muscle declines are inevitable, or if regular exercise-cycling, in this case-can slow down or even reverse them.

To figure this out, researchers at King's College in London biopsied the vastus lateralis muscle-the largest and most powerful part of the quad-in 125 male and female cyclists. Participants were all between 55 and 79 years old and deemed highly active (meaning the men could bike at least 62 miles at 15 mph. and the women 37 miles at 7 mph, twice within three weeks).

The researchers then analyzed muscle properties related to aerobic function and explosive muscle power. They found that, compared to sedentary populations, the cyclists showed less age-related muscle deterioration. That is, at the tissue level, muscle mass and strength stayed intact.

A second study turned the researchers' attention to the immune system, which can also decline as you age. Specifically, your thy-



mus-the part of your body that produces white blood cells-begins to shrink. It then produces fewer cells, meaning your body gradually loses the ability to protect itself against disease.

This trend, however, has been observed primarily in inactive populations, so the researchers wanted to see whether regular cycling could help prevent it. They compared blood samples from the same group of cyclists with blood from 75 older sedentary adults (aged 57-80) and 55 younger sedentary adults (aged 20-36).

They found that while cycling didn't protect against every single measure of immune-system decline, the cyclists had white blood cell levels comparable to those of the younger control group-meaning that their immune systems were acting "younger."

These studies are only two of many that demonstrate how physical activity like cycling can slow the aging process. One 2017 study found that high-intensity interval cycling increased mitochondrial capacity-a big deal when it comes to aging, as the decline of these organelles leads to the onset of age-related disease.

Another study from 2017 found that regular vigorous exercise protected telomere length. Shortened telomeres are what cause cell deathi.e., aging-and those who exercised saved themselves up to nine years of cellular deterioration.



Rahul Gandhi Says 'Bharat Mata' Murdered in Manipur

NEW DELHI: In a blistering attack against the BJP over violence in Manipur, Congress leader Rahul Gandhi on Wednesday alleged that its politics had "murdered Bharat Mata" in the northeastern state and termed members of the ruling party "traitors".

Participating in the no-confidence motion debate, Gandhi also slammed Prime Minister Narendra Modi for not visiting Manipur and alleged that he does not consider the state to be part of India.

"I went to Manipur a few days ago. Our prime minister has not gone there, he has not gone there till now. He does not consider Manipur part of India. I used the word Manipur, but the reality is there is no Manipur left. You have divided Manipur into two parts, you have broken up Manipur," Gandhi said.

Gandhi said he visited Manipur and met women and children at the relief camps, but the prime minister had not done.

The prime minister was not in the House when Gandhi spoke.

"I asked a woman, 'What happened with you?' She said, 'My small son, only child, was shot before my eyes. I spent the whole night with the body of my child and then I felt afraid. I left my house'. I asked her if she had brought along something with her and she said only the clothes she wearing and a photo," Gandhi said, nar-rating his experiences.

In another camp, he said he asked a woman the same question -- "What happened with you?" As he did so, she started trembling and fainted.

'These are the two examples. In Manipur, they (BJP) have murdered Hindustan. Their politics has not killed Manipur but killed Hindustan in Manipur. Hindustan has been murdered in Manipur....By killing the people of Manipur you have murdered Bharat Mata, you are not desh bhakts (patriots) but deshdrohis (traitors)," the former Congress chief said.

As the treasury benches protested and slammed Gandhi, Union minister Kiren Rijiju said the Congress leader should apologise for his remarks as it is the Congress which is responsible for insurgency and other



problems in the northeast.

Continuing his no-holds barred attack against the government in his over 30-minute speech, Gandhi went on to say that it is the Army that can bring peace to Manipur but the government is not deploying it. "You have murdered the voice of India, which means you have murdered Bharat Mata in Manipur... My mother is sitting here. The other mother, Bharat Mata, you killed in Manipur," he said, pointing to Sonia Gandhi who was present in the House.

'You have sprinkled kerosene everywhere. You have set fire to Manipur. You are now trying the same thing in Haryana," he added, referring to recent communal clashes in Gurugram and Nuh.

Gandhi alleged that the prime minister listens to only two people, Amit Shah and Gautam Adani, just as Ravan paid heed to only two. He did not elaborate on the point.

The former Congress president also said the Bharat Jodo Yatra is not over and he undertook the cross-country march to understand what was it he loved and for what had he faced abuse for 10 years.

The Congress leader also thanked Lok Sabha Speaker Om Birla for reinstating his membership of the House.

All No-confidence Motions Defeated or Inconclusive in Past

NEW DELHI: As the Lok Sabha debates a no-confidence motion brought against the Narendra Modi government by the opposition, the 28th such motion to be admitted in the Lower House, data compiled by a think tank shows all previous ones have either been defeated or remained inconclusive.

However, at least thrice governments have fallen during vote on a "motion of confidence", which is a motion brought by the government to prove its strength.

A no-confidence motion is a formal proposal moved by a member against the government in Lok Sabha under Rule 198 of the Rules of Procedure and Conduct of Business in Lok Sabha.

According to data compiled by PRS Legislative Research, the highest number of no-confidence motions - 15 - in the history of independent India was moved against governments led by Indira Gandhi.

Longest-serving prime minister Jawaharlal Nehru, whose tenure lasted 16 years and 286 days, faced only one no-confidence motion, which was moved in the aftermath of India's bitter loss to China in the 1962 war.

The motion was, however, defeated. The only time a noconfidence motion triggered the fall of a government was in 1979.

Iran Says It Has Technology **To Build Supersonic Missiles Amid US Tensions**

TEHRAN, IRAN - Iran has obtained supersonic cruise missile technology, state media have said amid rising tensions with the United States over military deployments in the region.

The missiles are now undergoing tests and "will mark the beginning of a new chapter in the defence power of our country", the state-linked Tasnim news website reported on Wednesday.

Tasnim said the new missiles could "significantly accelerate the Islamic Republic of Iran's response time in case of any combat, and take away attacking forces' opportunity for reaction".

It did not say when such a missile could potentially complete the testing phase and be publicly unveiled.

Iran has an array of cruise missiles, but none has so far breached Mach 1, or the speed of sound, which is 343 metres per second (1,125 feet per second). A projectile that could travel at speeds between Mach 1 and Mach 5 is considered su-

personic Projectiles moving at a speed greater than five times the speed of sound are classified as hypersonic. Iran unveiled its first hypersonic ballistic missile – capable of manoeuvring inside and outside the atmosphere - in June saying it is capable of evading radars and breaching any defence system. The Wednesday announcement on the supersonic cruise

missile comes as tensions between Tehran and Washington are on the rise over maritime security in regional waters.

The US Navy said on Monday that more than 3,000 military personnel have arrived in the Red Sea on board two warships to help protect shipping lanes, including those in the strategic Strait of Hormuz, from Iranian "harassment".

That only added to the US military buildup in the region, including the possibility of putting armed personnel on commercial ships travelling through the strait, which analysts have said risks a significant escalation in an already tense region.

Iran has repeatedly rejected the US military involvement in regional waters, saying it only serves Washington's interests.

"What do the Persian Gulf, the Gulf of Oman and the Indian Ocean have to do with America," said Iranian armed forces spokesperson Brigadier-General Abolfazl Shekarchi, as quoted by the semi-official Tasnim news agency. "What is your business being here?"

In response to the US military buildup, the Islamic Revolutionary Guard Corps (IRGC) last week said it has equipped its navy with new drones and 1,000km (600-mile) range missiles.

The IRGC also launched a surprise military drill last week on three islands it controls that the United Arab Emirates (UAE) claims as its own, deploying swarms of fast boats, paratroopers and missile units.



"Flies During Day, Insects At Night": **Imran Khan's SOS From Pak Jail**

ISLAMABAD: Pakistan's jailed former prime minister Imran Khan has told his lawyers to take him out from the Attock jail as he does not want to remain in a cell that is infested with flies during the day and insects at night.

Khan, charged with corruption in the Toshakhana case and sentenced to three years, is unhappy and worried as he remains holed up in his prison cell. The 70-year-old cricketer-turned-politician was arrested on Saturday shortly after an Islamabad trial court found him guilty of "corrupt practices" in the case.

Khan has appealed his conviction by filing a plea at the Islamabad High Court.

The Pakistan Tehreek-e-Insaf chairman has asked his legal team that he does not wish to remain in prison, Geo News quoted sources in the Attock jail privy to the meeting between Khan and his lawyer as saying. "Take me out of here; I don't



want to remain in jail," the officials quoted Khan, as saying.

Khan's counsel Naeem Haider Panjotha was granted access by the jail authorities Monday to meet him, who after seeing the PTI chairman said that the former premier was being kept in "distressing" conditions provided "C-Class jail facilities".

Panjotha said that Khan was in high morale despite all such difficulties and vowed to spend his lifetime in jail but wouldn't bow to slavery. However, the sources said that the PTI chairman, during the meet-

ing with his lawyer, conveyed his concerns regarding the environment at the prison with flies taking over his cell during the day and insects at night.

The former prime minister was arrested from his Zaman Park residence in Lahore after being convicted with accusations of misusing his 2018 to 2022 premiership to buy and sell gifts in state possession that were received during visits abroad and worth more than Rs140 million (USD 635,000).

Khan denies the allegations against him.

The party of the former prime minister, who was ousted from office after a no-confidence motion was moved against him in April 2022, has moved the Supreme Court against the trial court's order, seeking to declare Judge Dilawar's verdict "null and void". The PTI has also approached the Islamabad High Court (IHC) Chief Justice Aamer Farooq requesting Khan's transfer from Attock jail to Adiala jail.

'The Constitution Of J&K And Indian Constitution Were Speaking To Each Other Through Article 370'

NEW DELHI: Article 370, which bestowed special status on the erstwhile state of Jammu and Kashmir, was not a repository of untrammelled power but a medium through which the Constitution would apply to the state, the Supreme Court was told on Wednesday. A five-judge constitution

bench headed by Chief Justice DY Chandrachud was told by senior advocate Gopal Subramanium, appearing for petitioner Muzaffar Iqbal Khan, that the Jammu and Kashmir constituent assembly did not want to abrogate Article 370 and instead permitted its continuance.

Khan has challenged the two constitutional orders of the Centre issued on August 5, 2019 and August 6, 2019, by which Article 370 was abrogated.

"Even though the word 'temporary' appears in the marginal notes of Article 370 of the Constitution, the reso-lution passed by the Jammu and Kashmir constituent assembly said that the Constitution of India must apply with these modifications. The constitution of Jammu and Kashmir and Indian Constitution were speaking to each other through Article 370," Subra-

manium said. He told the bench also comprising justices Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surya Kant that Article 370 was not a repository of untrammelled power but a medium through which the Constitution would apply to the erstwhile state of Jammu

Subramanium, who commenced his arguments on the fourth day of hearing on a batch of petitions challenging abrogation of Article 370, said, "It is respectfully submitted that Article 370 ought not to be read or interpreted as an expression of power politics or a bargaining chip. ADGP Calls For Intensified Ops To Minimise Terror Threats

JAMMU: A senior police officer on Wednesday called for offensive operations to scuttle any possible terror attacks ahead of Independence Day.

Additional Director General of Police (Jammu Zone) Mukesh Singh called for high-level alertness, strengthening of the border security grid and intensified checking, especially around the venue of the Independence Day function on August 15, a police spokesperson said.

Representatives from the Army, Border Security Force and the Central Armed Police Force, and senior officers of the police and central and local intelligence agencies reviewed the arrangements ahead of the celebrations in a joint meeting here.

Singh also stressed on antidrone measures, border deployment grid, security of police and Army establishments, launching of offensive operations -- especially in the Rajouri-Poonch and the Doda-Kishtwar-Ramban ranges -- besides preventive measures in other districts.

He called for setting up joint checkpoints at vulnerable locations and inter-district boundaries, the spokesperson said. Singh also asked for a high level of alertness for peaceful

conduct of the Independence Day function and the ongoing Amarnath Yatra.

Earlier, Senior Superinten-

dent of Police (Jammu) Chandan Kohli and Senior Superintendent of Police (Security, Jammu) Shamsheer Hussain briefed the meeting about the proposed deployment by the district police and the security wing in and around the main Independence Day function venue.

Later, all the officers informed the meeting about the overall security assessment and emerging threats. A detailed discussion was held on each input shared by the intelligence and other security agencies. the spokesperson said.

Maulana Azad Stadium -- the venue of the main Independence Day function in Jammu -- has been virtually sealed off with additional deployment of police and paramilitary personnel.

Security personnel with sniffer dogs and metal detectors conducted a thorough search within and outside the stadium as part of the security drill, officials said.

Amarnath Batch Stopped In Jammu

JAMMU: A massive landslide blocked the Jammu-Srinagar national highway in Ramban district early Wednesday following which no fresh batch of Amarnath pilgrims was allowed to leave from Jammu, officials said.

"The yatra was suspended for the day from Bhagwati Nagar base camp due to the landslide on the highway," Divisional Commissioner. Jammu, Ramesh Kumar told PTI.

He said restoration work is going on at a war footing to make the highway trafficable.

Over 4.25 lakh pilgrims have paid obeisance at the 3,880 metre high cave shrine of Amarnath in south Kashmir Himalayas since the start of the 62-day long yatra on July 1.

ith Pakistan National Assembly being dissolved to pave way for the national elections without Imran Khan, and India set to hold parliamentary elections next year, there is not even a distant hope for a dialogue between India and Pakistan. Despite that, the outgoing Pakistan Prime Minister Shehbaz Sharif recently urged India to resume talks. This was followed by the country's ambassador to the US saying that refusing to talk would have dangerous consequences for all. He also said that there should be "some resonance of reciprocity" from New Delhi as well to Pakistan's overtures.

However, India has refused to resume talks with Pakistan, saying that Islamabad needs to create an environment for peace before the talks can resume. New Delhi has also said that it wants normal relations with Pakistan, but only if there is no support for terrorism or violence from Islamabad.

Considering India and Pakistan are the nations born out of a single nation in 1947, it makes a great case that the neighbours make up and work together for the prosperity of their people. This makes more sense in the backdrop of the changing global geopolitical landscape. The rise of new power centers, changing alliances, and economic interdependence have highlighted the interconnectedness of nations and the futility of prolonged conflicts. Both India and Pakistan possess immense potential for growth and development, and a peaceful resolution of their differences could unlock opportunities for progress, not only for their citizens but for the entire region. Ailing drug regulation

age holds immense importance in India and attracts a vast number of devotees each year. Participants embark on a challenging journey to reach the sacred Amarnath Holy Cave, nestled at an elevation of 3,888 meters amidst snow-covered mountains. This year's pilgrimage commenced on July 1st and is scheduled to conclude on August 31st. The month of July alone witnessed an impressive turnout of around 400,000 pilgrims who embarked on the expedition to catch a glimpse of the revered Ice-

Shivalingam. Amid the global turmoil caused by climate change-related disasters, even the revered Amarnath Yatra pilgrimage has not been spared from its detrimental effects. The escalating occurrence of severe weather incidents presents formidable challenges to this sacred journey. Regrettably, in 2015, the Amarnath Yatra witnessed the loss of three lives due to a sudden cloudburst at the Baltal base camp. Similarly, the previous year saw the tragic consequences of another cloudburst near the Amarnath Holy Cave, leading to the unfortunate demise of at least 15 individuals. While these incidents were deeply saddening, people raised concerns about the performance of the India Meteorological Department (IMD), alleging lapses in weather prediction and timely cautionary measures.

Was the IMD at fault, or is there more to the situation?

Cloudbursts tend to happen when monsoon clouds and moistureladen winds, occasionally linked to a low-pressure system, travel northward from the Bay of Bengal over the Indo-Gangetic Plains towards the Himalayas, leading to concentrated and heavy precipitation. On occasions, the moisture might also stem from winds originating in the Arabian Sea. These events predominantly occur during the southwest monsoon season in regions with significant orography.

The Amarnath Yatra takes place during the season when the likelihood of cloudbursts is at its peak, which is the southwest monsoon season. Additionally, there are two routes for the trek to the Amarnath Holy Cave: one through Pahalgam and the other through Baltal. Both routes are located above 2500 meters in a mountainous landscape. The final destination of the trek, the Amarnath Holy Cave sits at an elevation the mountainous terrain.

When a radar emits electromagnetic waves, they travel directly until they encounter obstacles like mountains. As these waves hit the mountains, they are blocked or weakened, leading to the radar's inability to detect objects or weather patterns behind these obstructions. This phenomenon creates a "shadow" region where the radar cannot effectively capture echoes or reflections from rainfall or cloudbursts. Consequently, the presence of mountains in the radar's coverage significantly limits its ability to provide accurate rainfall data for specific areas.

> Predicting short and intense showers accurately, especially without the radar's assistance, proved to be a challenging task for the IMD. Moreover, cloudbursts, as mentioned earlier, remain inherently unpredictable. Given these technological constraints and the available equipment, the IMD faced limitations in effectively addressing these weather conditions.

Developments since last year During this year, notable encasting capabilities. Unlike the previous scenario where the sole radar in Kashmir, located in Srinagar, couldn't cover the area near the Holy Cave, the newly installed radar has bridged this gap. This radar's implementation now provides more comprehensive insights into rainfall occurring along these routes. Additionally, it will contribute to improved nowcasting for areas such as Banihal, Ramban, and the Jammu-Srinagar National Highway –a route for the Yatra pilgrimage.

As part of this year's initiatives, the IMD has also set up a weather base camp at Nunwan Pahalgam. This camp is dedicated to offering weather services, including the dissemination of hourly forecasts to the Yatris.

These improvements in technology and forecasting capabilities hold promise for reducing damages and providing better warnings. However, the ongoing challenge posed by the increasing frequency of extreme weather events has not evaded, as highlighted in the IPCC's 6th assessment report, and observed firsthand in the Kashmir valley. As a result, climate change could continue to threaten the safety of the

hancements have been achieved in the IMD's capacities and infrastructure throughout Jammu and Kashmir. The network of weather stations has been improved, with the eight Automatic Weather Stations at Chandanwari, Panchtarni, Pahalgam, Sangam, Sheshnag, Sonamarg, Bararri, and Amarnath Holy Cave now providing updates every 15 minutes instead of the previous hourly updates.

I had a conversation with Mr. Mohammad Ashraf Wani, who serves as the IMD Incharge for AWS in Jammu and Kashmir. He mentioned that the Automatic Weather Stations have undergone an upgrade, transitioning from satellitebased to sim-based technology. As a result of this upgrade, these stations can now offer updates every 15 minutes. This advancement enables us to gauge the rainfall's intensity and enhances our capability to forecast occurrences of intense showers. In the event of rainfall near an AWS station, this technology can proactively alert both individuals and emergency response teams, contributing to improved preparedness. In a conversation with Mr. Mukhtar Ahmad, the Deputy Director of the Meteorological Centre in Srinagar, he shared that a new X-Band Doppler Weather Radar has been successfully installed at Banihal Top. This significant addition has greatly improved both forecasting and nowAmarnath Yatra pilgrims.

This would definitely require additional financial support from the government of India, which could contribute to covering the costs related to the necessary infrastructure and workforce. The government's support for research initiatives focused on understanding complex weather patterns, climate change impacts, and disaster preparedness can lead to improved forecasting methods and mitigation strategies. Also, collaborations between the government and private sector can provide additional resources and expertise, fostering innovation and better service delivery.

he government has now set deadlines for mandatory implementation—companies with a turnover of Rs 250 crore will have to comply within the next six months and those with a turnover below Rs 250 crore have to do it within a year. This is undoubtedly a course correction, but the time taken for implementation—five years is symptomatic of the ailments that drug regulation in the country suffers from.

India's image as pharmacy to the world has been sullied by repeat instances of drug quality and safety failure whether it is the allegations of toxins in Maiden Pharmaceuticals' and Marion Biotech's cough syrups killing children in Gambia and Uzbekistan, respectively, or the bacterial contamination of eye-drops exported by Global Pharma Healthcare to the US. Between 2019 and 2023 (year-to-date), the US Food and Drugs Administration has raised 21 Official Action Indications for Indian drugs, which means failure to comply with its standards.

In some cases, these have resulted in import alerts, meaning the drug-makers concerned are banned from supplying to the US. The situation isn't very different at home. In 2020, drugs made by a Himachal Pradesh-based manufacturer killed 12 children in neighbouring Jammu & Kashmir—after its products had been flagged at least 19 times by various government drug laboratories. This is quite telling of how drug regulation in the country continues to exist in silos.

Making the revised GMPs mandatory for all pharma companies fixes only part of the problem. Compliance will involve at least 11 specific changes to the manufacturing process, including the introduction of a pharmaceutical quality system, rigorous product quality review and stability tests, validation of equipment etc. These will certainly help assure the market on the quality and safety of drugs. A risk-based inspection of 162 manufacturing units and 14 testing labs found several failures—from absence of testing of ingredients before use to faulty design of testing areas.

While regulatory intent is the supplement drug, the main agent of treatment of the ailing drug regulation in India is fixing its fragmented structure. There are 37 nodal agencies across states and Union Territories under the Central Drugs Standard Control Organisation (CDSCO) umbrella, which means a double whammy of regulatory chaos and regulatory silos. On top of that, the federal nature of drug regulation means states that want to promote 'ease of manufacturing' at the cost of ensuring high-quality production are more likely to take an approach of regulatory forbearance

of 3,888 meters. Consequently, the risk of heavy rain, sudden floods, and cloudbursts is an ever-present concern in these areas.

In the late afternoon of July 08 last year, a strong downpour, potentially a cloudburst, occurred in the vicinity of the cave, triggering sudden floods that tragically claimed the lives of 15 individuals. Although the blame was swiftly placed on the IMD for its inability to forecast the cloudburst event, little did the public realize that predicting a cloudburst at a precise location is an impractical task.

Until the previous year, the IMD had only two radars in Jammu and Kashmir – one in Srinagar and another in Jammu. BILINGUAL SCHOOLS Theme, Prospect And Challenges

will reinforce the message that 'it's not so bad to be awake in the middle of the night', so that you don't fuel the fire with more anxiety."

Get up for a while

It feels counterproductive, says Hare, be-cause it's easy to tell ourselves that if we just lie still for a bit longer, we'll go to sleep. "If it does feel like you're about to fall back to sleep, or you're relaxed, and not worried or anxious, it's OK to stay where you are. But if you're starting to think 'this is terrible', or that you're actively trying to sleep, the best thing to do is to get up." By staying in bed, awake, "you start to develop a conditioned response – that 'bed' is about anxiety, frustration and being awake, when what we want is for 'bed' to be associated with sleep and relaxation". Get up for half an hour or so (don't look at the clock, or time it) and do something enjoyable but relaxing – no eating "because your body is not designed to be digesting in the middle of the night", and no strenuous exercise or work. "The idea is to break that cycle of negative thinking. Read, watch a bit of TV, as long as you're not going to get absorbed in some terrifying film, do a hobby, anything you like, as long as you're not on your device." She sometimes has to advise people not to watch pornography, because some can get too engrossed in it (but masturbation can be useful as a relaxation aid). Go back to bed, and if the same thing happens, get up again. "Trust that your sleep biology is very powerful. If you keep taking the wakefulness away from the bed, eventually you will be able to fall back asleep. It might not be within a timeframe that you're happy with, but the awakenings will get shorter and less frequent."

Crack a smile

It's easy to catastrophise in the middle of the night, says Alanna Hare, consultant in sleep medicine at the Royal Brompton and Harefield hospitals. "'I'm going to perform really badly at work tomorrow, then I'll lose my job, then my partner will leave me' – it can escalate quite quickly. Try to move away from this idea that being awake in the night is a dreadful thing that's going to lead to terrible consequences." Camilla Stoddart, a sleep coach, advises smiling, which may stop or slow the spiralling. "Smiling releases serotonin and dopamine, and triggers the parasympathetic nervous system, which is the opposite of the system that controls your fight and flight response. If you can disengage from the struggle, you're more likely to get back to sleep."

Tackle stress

When we can't get back to sleep, it's usually because our minds are busy or we're worried about something (though to rule out a sleep problem such as restless legs or sleep apnoea, it's best to see your GP). "Most of us don't have a sleep problem, we have an anxiety and stress problem," says Foster. In our waking life, Foster advises "finding techniques that work for you, whether it's mindfulness, yoga, whatever. It's important to de-stress." Talking to a therapist and tackling unresolved problems might be helpful; some simple meditation or gratitude practice might be enough, says Nerina Ramlakhan, physiologist and author of Fast Asleep, Wide Awake. "Don't push problems away, don't deny that you're not feeling great about your relationship or your job or whatever it is that's bothering you. Those emotions, if they're not expressed, have a tendency to pop up in sleep, either in nightmares, or in difficulty getting to sleep or staying asleep."

Consider your life stage

We tend to wake up more as we age, says Foster, "because the robustness of the circadian drive for sleep reduces – we're probably not going to get the sleep that we got when we were younger". Hormones underpinning urine production also change as we age, which is one reason why older people often need to get up to go to the loo at night. Menopause affects women's sleep in several ways, including body temperature - if you sleep with a partner, consider getting separate duvets to help with this - and changing hormone levels. "Oestrogen can promote sleep, and so can progesterone, by making you more relaxed and less anxious," says Foster. "Those changing hormones can disrupt those patterns, and it's the same with the menstrual cycle."

Adopt healthy habits

The way we sleep is a reflection of the way we live, says Ramlakhan, "so if you want to sleep better, you have to live better". You know what you need to do: exercise, nutrition, stress reduction. Ramlakhan has her list of "five non-negotiables, which can help you sleep more deeply. Eating breakfast within half an hour of rising [to stabilise your blood sugar levels], not using caffeine as a substitute for food, making sure you're well hydrated, getting to bed earlier - about 9.30-10pm – and cultivating a healthier relationship with technology." She isn't a particular fan of the label "sleep hygiene" because it can feel like a chore to run through a bedtime routine which might include putting devices away, dimming the lights and having a warm bath. "Those things might help," says Ramlakhan, "but actually, it's the way we live from the moment we wake up until the time we're getting into bed that is going to have an impact on how you sleep."

Do some journalling before bed

Getting worries or busy thoughts out of your head, even the next day's to-do list, before bed might help, says Stoddart. If the worries are bigger – such as the threat of nuclear war – "you just acknowledge that you can't really do anything about that, especially not in the middle of the night". Hare recommends "constructive worry' - vou can find examples online to print and follow. "It is a way of organising your thoughts by writing them down in a particular fashion, so that when you wake in the night, you're less likely to start list-making or worrying."

Avoid medication

Foster says sleeping pills can help you sleep, "but they can make it more difficult to wake

up and leave you feeling groggy in the morning, and may also increase daytime sleepiness later". Newer, shorter-acting sleeping pills may work for night waking, "but it's advisable to make sure you have at least four hours before you need to get up". Taking melatonin – the tablet form of the hormone that increases at night to make you feel sleepy - will not prevent you from waking, says Foster, but similarly to shorter-acting sedatives, it could help to take it in the night when you wake up. Like sleeping pills, it should be prescribed by your GP, he stresses. Overall, medication should not be used long-term and is "not the answer to waking at night. In almost all cases, non-pharmacological approaches will work."

Don't 'try' to get back to sleep

"The main mistake people make when they're struggling to get back to sleep is they lie in bed, often very still because they're trying not to wake up their partner - but sleep doesn't respond well to effort," says Hare.

Don't check the clock

When patients tell her they wake at 2.05am every morning, "therein lies the problem," says Ramlakhan. Looking at the time "is one of the biggest disruptors to being able to get back to sleep". It creates anxiety, and worse, says Ramlakhan, you'll probably check the time on your phone and get sucked into doing other things on it. "Use an old-fashioned alarm clock and turn it away from you," she says. "It's not important to know the time. Learn to let go."

Hare adds that once people start noticing they wake at a similar time each night, perhaps as a result of natural sleep patterns, they "start to develop rules: 'if I'm awake at this point, I won't go back to sleep; once I've woken at 3am, that's it for the night'. They're arbitrary and not true, but they become self-fulfilling prophecies. So try not to look at the clock."

Don't look at your phone

We all know we shouldn't be on our phones in the night but the lure is so great that Hare reports people even do it in her sleep laboratories. Some researchers think the detrimental effect of blue light on sleep from devices has been exaggerated, but with your phone in your hand it's too easy to check work emails or get sucked into social media.

... except to quickly put a mindfulness app on

"As long as you're popping the app or podcast on, and not looking at the screen after that," says Hare. "What you don't want is having bright light in your face for 10 minutes while you scroll through, trying to find something."

Mindfulness apps can be useful, says Ramlakhan, who has also recorded some of her own meditations including body scans (you can also find free examples on YouTube). "One is a body scan where you start with one foot and you say the words 'I love my left big toe' and you work your way up your body." If you find yourself worrying about something else, or becoming distracted, start again. Another way of quieting a busy mind, says Hare, is using counting techniques. "I often use a very simple one, which is trying to count back from 1,000 in sevens, and if you get stuck, you have to go back to the beginning again."

... or listen to a story

Foster finds the short plays on BBC Radio 4 Extra relaxing. Stoddart loves audiobooks and podcasts, rather than sitting up to read with the light on, "because there's no decision to be made as to when you turn it off". Something intentionally boring may not work for you. "A lot of my clients will listen to the same book over and over, or listen to boring stories designed to send you to sleep, and they don't really work because you're not engaged, so you can continue worrying." By finding something interesting, she has found, you're less likely to focus on negative thoughts and won't feel like you're actively trying to get to sleep, "and sleep is more likely to come".

Slow your breathing

"Don't concentrate on trying to sleep, but concentrate on reducing hyper-arousal," says Stoddart. "I get people to do slow breathing, or some sort of yoga or relaxation before they go to bed, but only with the expectation that it will calm the system down, rather than guarantee sleep." In the middle of the night, when you start to get anxious, it can take time for stress hormones such as cortisol to pass. "And usually in that time, you've found more reasons to keep it going, so slow breathing can speed up that timeframe and keep you calmer. But it is difficult, which is why I suggest reading a book or watching TV – something that makes it easier to be distracted, calmer and

Try to stay awake

It's what's known as "paradoxical intention" says Hare. Lie down and keep your eyes open. "Sometimes trying to stay awake can bring about sleep – it's very hard to keep your eyes open, even when you feel you're wide awake." It's not something Hare recommends as a first strategy, but she has recommended it to people who claim they endure being awake for several hours in bed. "It's unlikely they're fully awake. Why don't you try to stay awake for that whole period and see what happens with your eyes open? The whole point is that instead of trying to sleep, it's just adjusting that attention."

Don't give up and get up

With less than an hour before your alarm goes off, you might think you may as well get up, but Foster advises against this. If you can stay relaxed, "lie back and wait for the alarm clock to go off. Chances are, you will fall back to sleep and just that 15 or 20 minutes can be helpful in getting the sleep that you need. Even short sleep can be somewhat beneficial."

'I've Never Been More Organized' – The 'Move-Out' Decluttering Method Explained

ecluttering is a full-blown mission, and it's not the kind you can dive into without a plan of action. Blindly jumping into a disorganized closet or a cupboard full of hoarded stuff with hopes of throwing items away is only likely to overwhelm you to the point of abandon. That's why experts want you to know about the 'Move-Out' method.

This decluttering technique, first developed by organization expert Katie Holdefehr, could be the key to saving tonnes of time while effectively cutting the junk for good. As the name suggests, it encourages you to pack everything away in the space you plan to declutter as though you were moving out. Not only does it give you a fresh slate to work with, but it helps visualize everything you're dealing with when it comes to decluttering. (I can almost sense your guilty conscience from here...)

To help you understand how to put the method into practice when decluttering a room, we spoke with Katie alongside some other decluttering experts to learn more. Here's what they said.

WHAT IS THE MOVE-OUT DECLUTTERING METHOD AND HOW DOES IT WORK?

Put simply, the 'Move-Out' method involves removing everything from the cupboard, closet, or room you plan to sort out in order to make your decluttering efforts more productive.

The decluttering tip was originally developed by Katie Holdefehr, Associate Editorial Director at Real Simple and author of Embrace Your Space, after realizing the success she'd had with it in her own home. 'Having moved three times in the past seven years, I have come to realize that I am never more organized, more minimalist, or more deliberate in my decluttering than when I have to prepare for a big move,' she says. 'I believe that moving makes us all more ruthless declutterers.'

'It's all too easy to keep belongings you no longer need if they're just sitting around collecting dust—but if you have to do the hard work of packing, transporting, and unloading those items, then they better be worth their weight!'

HOW DO YOU USE THE 'MOVE-OUT' METHOD?

To apply the method, Katie suggests treating it like a real move by setting a move out date and buying boxes if you need to. It's best to start with a smaller contained space first, such as a closet, pantry, or desk drawer. Start by removing all the items inside and once empty, wipe down and vacuum the space. 'You're starting fresh with a clean slate, just as you would in a new house or apartment,' she says.

Next, sort through each item one by one, deciding whether or not it makes the cut for your hypothetical move. 'Ask: "Would I take this with me if I was moving to a new place?",' says Katie. 'If the answer is "no," donate it, recycle it, or toss it. If your goal is not only to tidy up but also to winnow your belongings, up the ante by pretending that the new house you're moving into is smaller than your current space.'

Professional organizer Melissa Gugni also thinks it's a great way to reassess your storage. 'I appreciate the chance to "think outside of the box" and question if even the layout of that space is the most efficient,' she explains. 'You can even go further on this method and use the time to up-



date, renovate, organize, and style the new space,' adds Di Ter Avest, owner of Di is Organized.

WHERE SHOULD YOU PUT ALL THE STUFF YOU'VE 'MOVED OUT' WHILE ORGANIZING?

So that you don't end up drowning in a pile of your own junk, you'll need to make sure you move everything out of the way so you have space to organize efficiently. That means taking it all into a different room if you have to.

'Move everything that you are clearing from the space to wherever you have room to sort through it,' says Melissa. 'I encourage folks to be realistic about their time and energy when it comes to this method.' By this, she means starting small. 'There is nothing worse than running out of time halfway through and leaving your home a bigger mess than when you started!"

Once you have a designated spot for decluttering (a bed, countertop, or garage will do) you then need to approach with a system. 'When emptying a space or purging your home for the "move," you should categorize your items into three main piles: keep (pack), donate, or trash,' says Di. You might want to use boxes for this, instead of just piling it all up. 'Once those categories are out of the way, divide the remaining items into piles of likes, and define a home for them,' Di adds.

Katie's keen to note that this can be an exhausting task that takes a considerable about of time. 'I recently used the Move-Out Method to

organize a closet, and the process took nearly two days,' she says. 'I tried on every single piece of clothing, deciding which jeans to donate and which to keep, which dresses to dry-clean and which to give away. Was it a ton of work? Yes. Is my closet more organized than it's ever been? Also yes!'

IN WHAT TYPE OF DECLUTTERING SITUATIONS IS THE 'MOVE-OUT' METHOD MOST USEFUL?

There are plenty of instances when the Move-Out method is handy, but it's best reserved when you have the energy and drive for a dedicated decluttering overhaul.

In terms of where to start decluttering, Katie thinks it works best in oft-overlooked storage areas that you may have neglected for a while. 'Living in a small (550-square-foot!) apartment, I use the space under my bed to stash off-season clothing, luggage, and a jumble of blue IKEA bags,' she explains. 'When a friend and her family came to stay at my place last week, it called for some thorough under-bed organization. I removed everything, dusted and vacuumed, and got rid of anything I wouldn't take with me if I was moving.'

If you've recently moved into a house, or a looking for a quicker 30 minute filler task, the Move-Out method probably isn't for you. Instead, use it in big situations that call for a clearout. 'I find this is a great way to go before a big transition, like living with a new roommate or partner, or before having a baby,' Melissa notes. 'It gives you a chance to re-evaluate how your things are serving you. Think critically, get the donations out of the house, and enjoy the fresh energy that comes with this method.'

Cabinet Clears Changes To GST Laws To Levy 28% GST On Online **Gaming, Casinos, Horse Race Clubs**

NEW DELHI: The Union Cabinet on Wednesday approved changes to GST laws to levy a 28 per cent tax on the full face value of bets in online gaming, casinos and horse race clubs, sources said.

The amendments to the Central GST (CGST) and Integrated GST (IGST) acts, which were approved by the GST Council last week, are likely to be introduced in the ongoing monsoon session of Parliament, which will end on August 11.

The GST Council in its 51st meeting on August 2 recommended amendments to the Schedule III of the CGST Act, 2017, to provide clarity on the taxation of supplies in casinos, horse racing and online gaming. The Council also recommended inserting a provision in the IGST Act, 2017, to im-

pose GST liability on online money gaming provided by offshore entities. Such entities would be required to get GST

The amendments will also provide for blocking access to online gaming platforms located overseas in case of failure to comply with regis-

tration and tax payment provisions. The amended provisions in the GST laws -- which would specifically define online gaming, online money gaming, virtual digital assets used to pay for online games and suppliers in case of online gaming -- will be effective from October 1.

Sources said the Union Cabinet in its meeting on Wednesday has cleared the amendments to CGST and IGST laws.

The Council, the highest decision-making body of the new indirect tax regime that comprises the Union finance minister and representatives of all states, on August 2 decided that 28 per cent Goods and Services Tax (GST) will be levied at the face value of entry-level

bets placed in gaming platforms and casinos.

Finance Minister Nirmala Sitharaman, after the Council meeting, had said that the CGST and IGST amendments are expected to be introduced in the monsoon session of Parliament. States will pass amendments to the State GST law in their respective assemblies.

The online gaming industry and some horse racing clubs are currently paying GST at the rate of 18 per cent on platform fees/commission ranging from 5 to 20 per cent of the full face value, while some horse race clubs are paying 28 per cent on the full face value. They are disputing the 28 per cent levy on actionable claims in the form of betting and gambling before various

legal fora. Casinos too are currently paying 28 per cent GST on

Gross Gaming Revenue (GGR). Levying 28 per cent GST on the full face face value of entrv-level bets would result in increased GST revenues.

Govt To Offload Additional 50 Lakh Tons Wheat, 25 Lakh **Tons Rice Under OMSS To Check Prices**

NEW DELHI: The government on Wednesday announced the sale of additional 50 lakh tonnes of wheat and 25 lakh tonnes of rice from the Central pool in the open market to boost domestic availability and contain rising prices of these two key staples.

The government also reduced the reserve price of rice by Rs 2 per kg to Rs 29 per kg amid few takers for the commodity under the Open Market Sale Scheme (OMSS)

On likely cut in wheat import duty, the government said it will take action based on the requirement in the future as things are dynamic and evolving.

State-owned Food Corporation of India (FCI) is selling wheat and rice from the Central pool to bulk buyers like flour millers and small traders under the OMSS since June 28 through an e-auction.

Briefing media, Food Secretary Sanjeev Chopra said, "Prices of two commodities have been in the news for the past couple of months because of the rising trend that we are noticing"

The offtake of wheat under the OMSS has been good so far. However, the weighted average price of wheat has been going up in the past two-three auctions. In rice, there has not been much offtake, he said. Chopra said the government

felt that tweaking the reserve price of rice may bring better results.

"The government has decided to offload 50 lakh tonnes of wheat and 25 lakh tonnes of rice in the open market through the OMSS," ĥe said.

This is over and above 15 lakh tonnes of wheat and 5 lakh tonnes of rice sales announced under the OMSS on June 28.

That apart, the secretary said the government has reduced the reserve price of rice by Rs 2 per kg to Rs 29 per kg from Rs 31 per kg.

The reserve price of wheat, however, has been kept unchanged as there is a good response from the traders under the OMSS.

About 7-8 lakh tonnes of wheat was auctioned under the OMSS so far, while rice sale was negligible, he said.

The government is hoping that these measures would not only improve the availability in the market but also help cool down the prices and control food inflation, Chopra added.

"...Based on the response in the next few weeks, we will keep tweaking them. The ultimate objective is to keep the food inflation under check," he said, adding that the government has adequate stock available for more aggressive auctions if required.

On the likely reduction of wheat import duty, the secretary said, "Right now, we have taken these steps. These are dynamic and evolving. Based on requirements in the future, we will take action"

He also said that the Centre is aggressively following up with states to ensure stock limits in wheat are not violated.

Sharing about the sale of foodgrains under the OMSS, FCI Chairman and Managing Director Ashok K Meena said the OMSS operation was started early this year on June 28, in view of the increasing trend of wheat and rice prices.

Markets Bounce Back On Fag-End Buying In RIL, ITC

"Markets were highly volatile as investors shunned local equities after Moody's warned of downgrading six major US banks, while weak Chinese exports data also dampened sentiment," said Shrikant Chouhan, Head of Research (Retail) Kotak Securities Ltd. JSW Steel was the biggest gainer on the Sensex chart, rising 2.68 per cent, followed by Tata Motors, Mahindra & Mahindra. Tata Steel, Titan, ITC, Tech Mahindra, NTPC, Reliance Industries and Larsen & Toubro. In contrast, Bajaj Finance, Maruti, ICICI Bank, Power Grid, Asian Paints and Axis Bank were major laggards. In the broader market, the BSE smallcap gauge climbed 0.57 per cent, and the midcap index advanced 0.39 per cent. Among the indices, metal jumped 2.32 per cent, consumer durables climbed 1.21 per cent, oil & gas (1.16 per cent), energy (1.11 per cent), commodities (0.82 per cent), industrials (0.76 per cent), auto (0.74 per cent) and FMCG (0.61 per cent).

Govt Should Propose To GST Council To Cut Tax Rates On Fertilisers From Current 5%: Par Panel

NEW DELHI: A Parliamentary panel has recommended that the government should propose to the GST Council to reduce tax rates on

In its report laid in Parliament on Wednesday, Standing Committee on Chemicals and Fertilizers said the committee have been informed that fertilisers were placed under the 12 per cent GST bracket. However, on demand of various states, GST on fertilisers was reduced to 5 per cent. "The issue to further reduce GST on fertilisers was placed before the GST council in its 45th and 47th meetings held in September 2021 and June 2022, respectively. The GST council, however, did not recommend any change in the rates of fertilisers or other organic farm inputs. "The committee strongly recommend that the issue to further reduce GST on fertilisers may be placed before the GST Council at the earliest in the best interest of the farmers of our country," it added. The panel noted that fertilisers are levied GST at 5 per cent and its raw materials, like sulphuric acid and ammonia, are levied a higher GST at 18 per cent on the recommendations of the GST council. "The Committee failed to understand this anomaly. The Department has clarified that the raw material of fertilisers like Sulphur has multiple uses and is also used in the production of detergents, paints, dyes etc. Similarly, ammonia too has multiple uses and is also used as refrigerator gas, manufacturing of plastics, explosives, textiles etc," the report said.

MUMBAI: Capital markets regulator Securities and Exchange Board of India (Sebi) on Wednesday cut the timeline for listing of shares on stock exchanges after the closure of Initial Public Offerings (IPOs) from T+6 to T+3 (T here refers to the days of the closure of issue). This is being done by the regulator to reduce the time period from the date of issue closure to the date of listing of shares through public issues. As per the Sebi circular, the new listing timeframe will be voluntary for all IPOs opening on or after September 1 and mandatory for all the issues which come after December 1, 2023

Srinagar: Doctors Association Kashmir (DAK) on Wednesday said curbing air pollution could reduce deaths from antibiotic resistance. "Controlling air pollution

could play a major role in combating the rise and spread of antibiotic-resistant bugs," said DAK President Dr Nisar ul Hassan.

Dr Hassan said according to a new study published in Lancet on Monday, air pollution was found to be a significant contributor to the rise of antibiotic resistance. Researchers have found that

air pollutants harbour antibiotic resistant bacteria and resistant genes which can be transferred between environments and inhaled directly by humans. He said antibiotic resistance

A life sentence, the NIA has asserted, is not commensurate with the crime committed by terrorists when the nation and families of soldiers have suffered loss of lives, and that the trial court's conclusion that Malik's crimes did not fall within the category of the "rarest of the rare cases" for grant of death penalty is "ex-facie legally flawed and completely unsustainable".

The agency has emphasised that it has been proved beyond reasonable doubt that Malik spearheaded terrorist activities in the Valley and with the help of dreaded foreign terrorist organisations, had been "masterminding, planning, engineering and executing armed rebellion in the Valley in an attempt to usurp the sovereignty and integrity of a part of India".

"Not giving capital punishment to such dreaded terrorist will result in miscarriage of justice, as, an act of terrorism is not a crime against society but it's a crime against the entire nation; in other words it's an act of 'external aggression', 'an act of war' and an 'affront to the sovereignty of nation'," the plea has said.

The trial court which had rejected the NIA's plea for capital punishment, had said the crimes committed by Malik struck at the "heart of the idea of India" and were intended to forcefully secede Jammu and Kashmir from Union of India.

The court had awarded Malik 10-year jail term each under sections 120 B (criminal conspiracy), 121-A (conspiracy to wage war against the government of India) of IPC and sections 15 (terrorism), 18 (conspiracy for terrorism) and 20 (being member of terror organisation) of UAPA.

PCB Names Asia Cup Squad; Masood Misses Out

KARACHI: The Pakistan Cricket Board's (PCB) newly selected Chief Selector Inzamam Ul Haq on Wednesday announced squads for the upcoming ACC Men's Asia Cup and the threematch One-Day International series against Afghanistan.

An 18-player squad will take on Afghanistan in Sri Lanka from August 22 to 26 and it will be trimmed to 17-strong for the Asia Cup, which begins from the Multan Cricket Stadium on August 30. The three-match series against Afghanistan will be played between August 22 to 26 before Pakistan begin their Asia Cup campaign against Nepal on August 30 in Multan.

The Asia Cup will kick off on August 30, with arch-rivals India and Pakistan set to lock horns in Kandy, Sri Lanka, on September 2. The tournament will follow a hybrid model, with four matches to be hosted by Pakistan and all of India's matches and a total of nine fixtures taking place in the Emerald Isle.

India is in Group A, which also have Pakistan and Nepal, while Group B comprises Bangladesh, Sri Lanka, and Afghanistan.

Tayyab Tahir, Faheem Ashraf and Saud Shakeel have been in-

cluded in the squad for the Af-ghanistan series. Shan Masood, who was selected as ODI vicecaptain in January 2023, has been left out of the Pakistan squads. Faheem returns to the side after two years and further adds to the balance of the side as a fast-bowling all-rounder. His last outing in the format was during Pakistan's three-match away series against England in July 2021.

This is Tayyab's second callup in the ODI side. His maiden call-up came ahead of the three ODIs against New Zealand in January following a stellar show in the Pakistan Cup 2022-23 that saw him finish as the leading run-getter in the event.

NADA Test: Jadeja Most Tested **Indian Cricketer In 2023**

NEW DELHI: Star India allrounder Ravindra Jadeja gave dope samples thrice between January and May this year, making him the most tested cricketer during this period, according to data released by the National Anti-Doping Agency (NADA). Altogether 55 cricketers (male

and female, 58 samples) underwent dope testing in the first five months of this year, with more than half of the samples taken 'Out Of Competition' (OOC), according to a recent list put up by the NADA on its website.

This meant that the number of samples collected from cricketers this year is expected to be much more than the previous two years. According to the data, the NADA had collected 54 and 60 samples respectively from the cricketers in 2021 and 2022 respectively. India captain Rohit Sharma and star batter Virat Kohli were not tested during the first five months of 2023. Hardik Pandya, who has been leading the India T20 International side for some time, underwent one test -- 'Out Of Competition' (OOC) urine sample in April. In 2021 and 2022, Rohit was the most tested cricketer with three samples each, according to NADA data of the two years. Kohli was not tested in 2021 and 2022 also. Around 20 samples in 2022 were from women cricket-



ers. But, in the first five months of this year, only two women cricketers -- India captain Harmanpreet Kaur and her deputy Smriti Mandhana -- were i once each -- out-of-competition urine samples collected in Mumbai on January 12. Around 20 samples were taken in competition, most of them likely during the Indian Premier League.

Take Ederson Moraes at Manchester City, for example: He can ping a pass 60 meters right onto the head of Erling Haaland or into the stride of Jack Grealish. Pep Guardiola has even said Ederson is the best penalty-taker at City. The Premier League will be

full of ball-playing goalkeep-ers this season, with the arrival of Andre Onana at Manchester United and Guglielmo Vicario at Tottenham adding to the list of keepers who are now expected to be the starter of attacks as much as the last line of defense.

Agenceis Bengaluru: Chandrayaan-3 spacecraft moved closer to the Moon's surface on Wednesday after it underwent another orbit reduction maneuver, ISRO said. ambitious third India's

Moon mission's spacecraft Chandrayaan-3 after the launch on July 14, had entered into lunar orbit or the Moon's orbit on August 5. "Even closer to the moon's sur-

face. Chandrayaan-3's orbit is reduced to 174 km x 1437 km following a maneuver performed today," ISRO said in a tweet.

The next operation is scheduled for August 14, between 11.30 am and 12.30 pm, ISRO said.

A similar orbit reduction maneuver was carried out by the ISRO on Sunday. As the mission progresses, a series of maneuvers is being conducted by ISRO to gradually reduce Chandrayaan-3's orbit and position it over the lunar poles.

According to ISRO sources, there will be two more orbit reduction maneuvers to bring the spacecraft closer to the Moon.

These maneuvers will be performed on August 14 and 16 to reach 100 km orbit, following which the landing module, comprising the lander and rover will break away from the propulsion module.

Chandrayaan-3 Gets Closer To The Moon's Surface: ISRO

After this, the lander is expected to undergo a "deboost" (the process of slowing down) and make a soft landing on the south polar region of the Moon on August 23.

Over five moves in the three weeks since the July 14 launch, ISRO had lifted the Chandrayaan-3 spacecraft into orbits farther and farther away from the Earth.

Then, on August 1 in a key maneuver -- a slingshot move -- the spacecraft was sent successfully towards the Moon from Earth's orbit. Following this trans-lunar injection, the Chandrayaan-3 spacecraft escaped from orbiting the Earth and began following a path that would take it to the vicinity of the moon

Chandrayaan-3 is a follow-on mission to Chandrayaan-2 to demonstrate end-to-end capability in safe landing and roving on the

lunar surface. It consists of lander and rover configuration.

It comprises an indigenous propulsion module, lander module, and a rover with an objective of developing and demonstrating new technologies required for interplanetary missions.

The propulsion module will carry the lander and rover configuration till 100 km lunar orbit. The propulsion module has Spectropolarimetry of Habitable Planet Earth (SHAPE) payload to study the spectral and polarimetric measurements of earth from the lunar orbit. The mission objectives of

Chandrayaan-3 are to demonstrate safe and soft landing on the lunar surface, to demonstrate rover roving on the Moon, and to conduct in-situ scientific experiments.

The lander will have the capability to soft land at a specified lunar site and deploy the rover that will carry out in-situ chemical analysis of the Moon's surface during the course of its mobility.

The lander and the rover have scientific payloads to carry out experiments on the lunar surface.

Brain-Like Power: Quantum Material Paves Way For Energy-Efficient Computing

A team of researchers from the Quantum Materials for Energy Efficient Neuromorphic Computing (Q-MEEN-C) con-sortium, led by the University of California San Diego, has un-locked a hidden potential in quantum materials. This potential, known as "non-local" behavior, holds promise in mimicking the intricate workings of the human brain and revolutionizing energy-efficient computing.

The recent strides in quantum material research have unearthed the potential for energy-efficient computing that emulates the brain's functions. The discovery of non-local behavior marks a critical milestone on the path to creating brain-like computers with minimal energy requirements, heralding a new era of computing innovation. Traditionally, computers have

outperformed humans in tasks such as complex calculations and quick data recall. However, the human brain remains unparalleled in its ability to process complex information layers swiftly, accurately, and with minimal energy consumption. Recognizing faces after a single encounter or distinguishing between various objects, like mountains and oceans, showcases the brain's astonishing efficiency. The journey toward creating

brain-like computers with minimal energy requirements has taken a significant stride forward, thanks to the recent discovery of non-local behavior in quantum materials. The breakthrough has opened the door to more energyefficient neuromorphic computing, where devices emulate the brain's intricate functions.

Professor Alex Frañó, co-director of Q-MEEN-C, explained that non-local interactions, which are common and effortless in the human brain, have been a rarity in synthetic materials until now. This newfound capability paves the way for the creation of more efficient machines capable of sophisticated learning processes.

The research, published in Nano Letters, builds on the


consortium's earlier work to emulate brain elements like neurons and synapses using quantum materials. The latest findings reveal that electrical stimuli transmitted between neighboring electrodes can also influence non-neighboring electrodes. This phenomenon of non-locality holds immense significance, marking a critical milestone in the journey toward brain-inspired computing.

The breakthrough was not without its challenges. The pandemic-induced closure of physical lab spaces compelled the researchers to devise innovative methods. Utilizing arrays of devices to simulate neurons and synapses, they confirmed the the-oretical possibility of non-locality in quantum materials.

Upon the reopening of labs, the team collaborated with UC San Diego's Jacobs School of Engineering Associate Professor Duygu Kuzum, who helped translate simulations into actual devices. The process involved manipulating a thin film of nickelate, a "guantum material" ceramic with rich electronic properties. By introducing hydrogen ions and applying an electrical signal, the researchers induced a memory-like configuration change in the material. This configuration remained even after the signal was removed, representing a breakthrough step toward creating more conductive pathways for electricity flow.

Innovatively, the design concept deviates from conventional circuitry. Drawing inspiration from the non-local behavior observed in the experiment, the Q-MEEN-C researchers realized that circuit wires need not be continuously connected. This design similarity to a spider web, where movement in one part resonates across the entire structure, offers a more efficient and cost-effective approach to creating networks for electricity transport.

While artificial intelligence (AI) software has made remarkable progress in simulating brainbased activities, the ultimate potential can only be realized when advanced hardware complements the software's capabilities.
