Govt To Set Up Cradle Centres To Prevent Dumping Of Newborns

Srinagar: The Jammu and Kashmir administration is all set to establish cradle centers across the major hospitals and healthcare institutions in the Valley to tackle the ghastly incidents of abandoning of newborn babies by couples near dumping sites.

The administration's move comes amidst multiple complaints of parents and couples abandoning their newborn babies near water bodies, garbage bins, or other dumping spots.

According to an order issued by the Director, social welfare department (SWD), a copy of which lies with Kashmir Observer, all the maternity hospitals across the Union Territory have been directed to set-up the cradle centers for abandoned new-born babies and spots near the hospitals. The department has also di-

rected them to put out signage of cradles centers at places considered most appropriate to receive such children like District Hospitals with Maternity, Gynecology and



Pediatric units which are visible from a distance, 24/7 and 365 days.

The Child protection unit, Mission Vatsalya of the SWD written to all district

social welfare departments and top hospitals in Srinagar city, including LD Hospital, Children's Hospital Bemina, JLNM Rainawari, SKIMS Soura Hospital and SKIMS Bemina (JVC) to set-up the cradle cen-ters inside the hospitals and put the signage so that people would get to know about it. Mission Vatsalya is a central-

ly sponsored scheme launched by the Government of India' s Ministry of Women and Child Development aimed at building a protective environment for the children. It lays emphasis on child rights, advocacy and awareness along with strengthening of the juvenile justice care and protection system with the motto to 'leave no child behind'.

The scheme is implemented by the SWD through J&K State Child Protection Society. Notably, in the past a num-

ber of videos went viral on social media where newborn babies were found near the dumping sites. In many videos dogs were seen mauling the newborns, sending shock waves across | More on P10

Govt Stops Bulk SIM Selling

Mandates Police Verification of SIM Dealers **Press Trust of India**

New Delhi: In a bid to check digital frauds, the government has made verification of dealers selling SIM cards mandatory and discontinued the provision of issuing bulk connections, Union minister Ashwini Vaishnaw said on Thursday. Earlier, while announcing the

new measures, the minister had said that the government has made police verification of SIM card dealers mandatory.

He later clarified that the verification of SIM card dealers will be carried out by "the licensee" or the respective telecom operator and added that a penalty of Rs 10 lakh will be imposed on violators. In a widespread crackdown against SIM card related digital frauds, the minister said that the government has disconnected 52 lakh mobile connections. While 67,000 dealers have been blacklisted, 300 FIRs have been registered | More on P10

ARTICLE 370 ABROGATION

SC To Only Examine Violation **Of Constitution**

Says National Interest Angle Won't Be Investigated

Srinagar: The Supreme Court on Thursday said that it will only examine whether there was any violation of the Constitution when the Central Government abrogated Article 370 in Jammu and Kashmir and will not go into the issue of whether the move was in the national interest as maintained by the government.

Chief Justice of India DY Chandrachud on the seventh day of the hearing in the case on Thursday said this while hearing a batch of petitions challenging the abrogation of Article 370 of the Constitution.

'You want judicial review to assess the intention of the government to abrogate Article 370? Judicial review will be for the constitutional violation. There is no doubt that if there is such a violation this court will intervene, but are you asking us to judicially review the wisdom underlying

the decision to abrogate 370?", CJI Chandrachud told Senior Advocate Dushyant Dave.

Dave in his submissions said "You can't resort to some kind of executive power, authorise the President to do this, do away with everything that Article 3 provides in the garb of 356 power. It makes a mockery of the constitutional safeguards. We know what majorities can do. We all saw what happened in 1975. If they don't do it in letter and spirit, your lords can strike it down and you must."

He said that the exercise of abrogating Article 370 suffers from "fraud" on the Constitution and was "completely done contrary" to the provisions of the Constitution. He emphasized

that the exercise of the power by the President or Parliament has to be done under the Constitution itself and in a constitutional sense. "In my sense, constitutional sense

AIDS SURGE IN J&K 6,158 HIV-Positive Cases **Detected In Six Months**

Srinagar: The cases of HIV AIDS are increasing with each passing year in Jammu & Kashmir as 6,158 patients have tested positive in the union territory till June 2023.

Reports quoting officials said that so far 1,400 HIVpositive patients have died while 3,478 patients are living on Anti-Retroviral Therapy (ART). He said 547 patients have left follow-up. He said that 5,060 cases of

HIV have been reported at GMC Jammu and among them, 1,228 have died, 503 have left followup and 2718 are living on ART.

LAHDC Polls: HC Upholds 'Plough' **Symbol For NC Candidates**

Srinagar: The High Court of J&K and Ladakh has upheld its single bench's verdict, alsymbol "plough" lowing to National Conference for contesting ensuing election to Ladakh Autonomous Hill Development Council (LAHDC), Kargil.

According to a notification issued by the election department on August 5, the election to 26 seats of the 30-member Ladakh Autonomous Development Council Hill (LAHDC), Kargil, is scheduled for September 10 and the counting of votes will take place four days later.

The UT of Ladakh had approached a division bench of the court against the single bench order of August 9 which directed the NC to approach the office of the Election Department of the Administration of Union of Ladakh for Territory

notifying the reserved symbol (Plough) already allotted to for the polls.

In their plea, the admin contended that even if the NC is entitled to be allowed to use the symbol, the authority to give such concession is the Election Commission of India and not the Election Authority of UT of Ladakh

"In the present case, it cannot be denied that the PetitionerParty, namely, the Jammu & Kashmir National Conference, is a recognized political Party in the Union Territory of Jammu & Kashmir. This Party has intended

to set up candidates in the upcoming elections for the Ladakh Hill Development Council in Kargil District of the UT of Ladakh," said a division bench of Chief Justice N Kotiswar Singh and Justice M A Chowdhary.

"It is also an admitted position that as of now that the Jammu & Kashmir National Conference is not vet a recognized Party in the Union Territory of Ladakh," the court said, adding, "However, since the symbol of "Plough" has been already allotted to the Jammu & Kashmir National Conference, which is a recognized Party in the Union Territory of Jammu & Kashmir, in terms of Paragraph No. 10 of the Election Symbols Order of 1968, any candidate set up by the said Jammu & Kashmir National Conference Party in the local elections in the District Kargil of the Union Territory of Ladakh will be entitled to the symbol of "Plough" as per the concession provided under | More on P10

Israel Rushed Arms To India During Kargil Crisis

EL AVIV- Israel agreed to speed up shipments of arms and military equipment to India during the recent crisis with Pakistan over Kashmir, the influential Hebrew daily Haaretz reported Thursday. The Israeli move came in response to a request from New Delhi and the Indian government expressed its appreciation, the daily said without elaborating on the equipment delivered.

All the orders had been placed before the May clashes in Kashmir. New Delhi charged were backed by Pakistani troops, the paper stressed.

Israel and India have maintained close military ties in recent years- the commander of Indian ground forces, Prakash Malik, visited Israel in May 1998 after the two governments named military attaches to their respective embassies the previous year.

Russia Hosts First-Ever Meeting Of Iran, Saudi **Defense Officials**

Talal al-Otaibi, an aide to the Saudi defense minister, on 16 August, met with the Deputy Chief of Staff of Iran's armed forces, Aziz Nasirzadeh, on the sidelines of the 11th Moscow Conference on International Security.

Coming a few months after the two nations normalized ties under a Chinese-brokered agreement, this marked the first-ever meeting between Iranian and Saudi officials.

According to the Saudi defense ministry, the officials reviewed bilateral relations in the defense and security fields and ways to improve them. Iranian state-run news outlet IRNA also reported that the officials agreed to exchange military attachés "as soon as possible.

The historic meeting occurred one day before the Iranian Foreign Minister set off on an official trip to the Saudi capital Riyadh, where he is scheduled to meet his Saudi counterpart Prince Faisal bin Farhan

This is the first trip by Iran's top diplomat to the kingdom since the signing of the détente in March. Iran's new ambassador to Riyadh, Alireza Enayati, will also officially begin his mission during Amir-Abdolla-

hian's visit. In June, an Iranian navy of-ficial revealed that the Islamic Republic, alongside Saudi Arabia, the UAE, Qatar, Bahrain, Iraq, Pakistan, and India, is looking to form a "naval alliance" to boost security in the northern Indian Ocean.

Two weeks after this announcement, Bin Farhan visited Tehran, where he met with Iranian officials and had this to say about the possible naval alliance, "I would like to refer to the importance of cooperation between the two countries on regional security, especially the security of maritime navigation ... and the importance of cooperation among all regional countries to ensure that it is free of weapons of mass destruction."

'How Could Bilkis Bano Convicts Be Released?' SC To Gujarat

State governments should not be selective in granting remission to convicts and the opportunity to reform and reintegrate with society should be given to every prisoner, the Supreme Court Thursday told the Gujarat government which defended its decision of premature release of all 11 convicts in the Bilkis Bano gang-rape case during the 2002 riots.

The top court's observation came in response to the submission by Additional Solicitor General S.V. Raju, appearing for the Gujarat government, that law says a chance must be given to even the hardened criminals to reform themselves.

The law officer submitted the crime committed by the 11 convicts was "heinous" but does not fall in the rarest of rare category. "Therefore, they deserve the chance of reformation. Person may have committed the offence...Something may have gone wrong in a particular moment. Later, he can always realise the consequences. "This can largely be determined from their conduct in jail, when released on parole, or furlough. All these show they have realised what they had done is wrong. Law is not that everyone should be punished perpetually. Chance should be given for reformation," Raju said. Responding to the submission, a bench of Justices B.V. Nagarathna and Ujjal Bhuyan wanted to know how far the

Indian Muslims Were First Hindus; Hinduism Much Older Than Islam: Azad

JAMMU: DPAP chairman Ghulam Nabi Azad said a majority of Indian Muslims have converted from Hinduism, adding that an example of this can be found in the Kashmir Valley where a majority of Kashmiri Pandits converted to Islam.

Asserting that religion should not used to get political mileage, Azad said whoever takes refuge in religion in politics is weak. "Some BJP leader said some

(Muslims) have come from outside and some have not. Nobody has come from outside or inside. Islam came to existence just 1,500 years ago. Hindu religion is very old. Around 10-20 of them (Muslims) must have come from outside, some were there in the Mughal army," the Democratic Progressive Azad Party (DPAP) chief told a gathering in Doda district. "All other Muslims convert-

ed from Hinduism in India. An example of this can be found in Kashmir. Who were the Muslims in Kashmir 600 years



ago? All were Kashmiri Pandits. They converted to Islam. All are born into this religion," the former chief minister of Jammu and Kashmir said.

Azad said that when Hindus die, they are cremated. "They are burnt in different places. Their ashes are placed in the river which mixes the water, and we drink that water," he said.

"Later, who sees that the water contains their burnt ashes? People drink that water," the DPAP leader said. Similarly Muslims' flesh

and bones become a part of the nation's soil, Azad said. "They, too, become a part of this land. Their flesh and their bones become a part of Bharat Mata's soil. Hindus and Muslims both merge into this land. What difference is there between them?" he added.

Taking a dig on the use of religion for votes, Azad said, Whoever takes refuge in religion in politics is weak. Religion should not be used as a vote bank in politics. Voting should not be based on Hindu and Muslim names.'

Targeted Christians Found Shelter With Muslims During Pakistan Rampage

JARANWALA, PAKISTAN: Pastor Javed Bhatti was roused from his sleep by the mosque's loudspeaker -- not the usual Islamic call to prayer, but a thundering call to protest against alleged blasphemy by Christians. Instinctively, he gathered

his family and ran to the street, where fellow Christians were already spilling from their homes into narrow alleyways.

"Some were running barefoot and some fled in rickshaws. There was chaos everywhere," he told AFP on Thursday, a day after hundreds of Muslim men rampaged through the streets, burning homes and churches.

"The children were shouting, 'Run, run, the clerics are coming! They will attack

Arms, Ammunition **Recovered In Manipur As Situation Continues To Remain Tense**

IMPHAL: Eight firearms and 112 rounds of ammunition were recovered from different districts of violence-hit Manipur during search operations by security forces, police said. Besides, the forces also seized six explosives, they said.

"The situation in the state was tense with sporadic incidents of firing and congrega-

tion of protesters," it said. Also, six bunkers have been dismantled in Tengnoupal dis-

trict, it added. Meanwhile, four people from Assam were arrested in Mantripukhri area of Imphal East district with 1,240 bottles of syrups containing codeine phosphate, an opioid analgesic. The arrests were made by the officers of Narcotics & Affairs of Border (NAB) on Tuesday, police said.

Ethnic clashes broke out in the state in May, and have been continuing for more than three months, leading to the deaths of over 160 people.

Indigo Pilot Dies After Collapsing At Boarding Gate Of Nagpur Airport

A40-year-old IndiGo pilot, who was going to operate the airline's Nagpur-Pune flight, died after collapsing near a boarding gate at the Nagpur airport on Thursday, officials said.

Captain Manoj Subramanyam (40) fell unconscious in the security hold area of the airport around 12 noon, they said. Prima facie, he died of "cardiac arrest following sudden unexpected loss of heart function", said KIMS-Kingsway Hospital where he was rushed.

Aejaz Shami, spokesperson of the hospital, said their emergency team administered him CPR (cardiopulmonary resuscitation) but he did not respond. Subramanyam was declared brought dead at the hospital.

In a statement, IndiGo said, "We are saddened at the passing of one of our pilots in Nagpur earlier today. He took unwell at Nagpur airport and was rushed to the hospital where he unfortunately passed away. Our thoughts and prayers are with his family and loved ones."

Man Jumps Off Eiffel Tower With A Parachute, Arrested

PARIS: A man was arrested in Paris on Thursday after jumping off the Eiffel Tower with a parachute, police and the monument's operator said.

The man, an experienced climber, entered the tower's perimeter shortly after 5.00 am (0300 GMT), well before its official opening.

He was quickly detected by guards, according to the site's operator Sete, but still managed to get to the top before anybody could stop him, carrying the parachute in a backpack.

Once he got near the top of the 330-metre-high structure, he jumped.

The man landed in a nearby stadium where he was arrested for endangering the lives of

"This kind of irresponsible action puts people working at or below the tower in danger,' Sete said in a statement.



The tower's opening, usually at 9:00 am, was slightly delayed due to the incident, Sete said, adding that it had filed criminal charges against

the man. Last week, the Eiffel Tower was evacuated twice on the same day following hoax bomb alerts.

And on Monday, two inebriated American tourists were found sleeping off a heavy night in the heights of the tower, having dodged security the night before.

New Covid-19 Variant Eris No Cause For Concern: DAK

SRINAGAR: With India reporting cases of new Covid-19 variant Eris in some states, Doctors Association Kashmir (DAK) on Thursday said the new variant is not a cause of concern for us and there is no need to worry about it.

'There is no evidence to suggest that the new variant causes more severe illness," said influenza expert and DAK President Dr Nisar ul Hassan.

Dr Hassan said the EG.5, dubbed as Eris is a sub-variant of Omicron variant of Covid-19. It is rapidly spreading across the UK and US and has also been reported in China, Europe and Japan.

The new variant was first detected in India in May 2023 and the fact that there has been no significant increase in the incidence of the new strain since its detection 3 months ago shows that it is not something to be bothered about," he said. The DAK President the new variant is basically a sub-lineage of omicron which most of us have gone through and our population has enough immunity against omicron and its sub-variants.

"With high vaccination rates and natural immunity, the possibility of a new wave in our population due to the variant is unlikely," he said.

Dr Nisar said new variants will keep coming as frequent changes in the genomic structure are part of the natural course of the virus. "We are going to see the new variant Eris for sometime before it is replaced by yet another variant. That is the nature of the virus," he said.

Surging Foreign Tourist Arrivals

ammu and Kashmir's tourism sector has witnessed a remarkable 59% surge in foreign tourist arrivals in the Kashmir Valley since the recent G20 event, compared to the previous year, Lieutenant Governor Manoj Sinha said on Tuesday.. Among the year's outstanding achievements, the ongoing Shri Amarnath Ji Yatra stands out as a historic milestone. This pilgrimage is the lengthiest to date. attracting devotees not only from various parts of the country but also from around the world.

The tourism sector has been granted official industry status, accompanied by the introduction of new measures such as the home-stay and film policies. Similarly, the tented colonies have been established to provide employment opportunities for the youth and those affiliated with the hospitality sector. According to the LG. around 1.27 crore tourists have visited J&K by July this year. This surge also includes an astounding 350 percent increase in foreign tourist arrivals compared to the previous year. It's well known that foreign tourists had been strictly avoiding Kashmir over the last three decades due to the prevailing turmoil. From January 1 to June 19 this year, over 15,000 foreign tourists have flocked to the Valley. The surge in international tourists is a big leap from the figures of the previous year when only 4,028 foreign visitors arrived during the same period. Foreign tourists are the most sought after in the Valley since they are seen as the high-end visitors, accounting for approximately 30 percent of the total tourist spending. As the year progresses, authorities are optimistic that the numbers will continue to climb, and Kashmir will once again reclaim its position as one of the prominent destinations for holiday makers on the global travel map.

The tourism sector in J&K makes a contribution of around 8.5 percent to its Gross Domestic Product (GDP). According to a recent study, the development of high-end tourism in Kashmir is projected to result in the creation of 10,000 new job opportunities within the next five years. Foreign tourists tend to extend their stay to an average of 7 days when visiting the region, a conspicuous contrast to the general average of 3 days for all categories of tourists.

Propelled by upgraded infrastructure and enhanced services, strategic marketing initiatives, the showcasing of its rich cultural heritage, and an improved security landscape, Kashmir stands on the brink of drawing an extra influx of 200,000 high-end tourists every year, says an estimate. Over the last four years, Kashmir Valley has largely been peaceful, paving the way for the current spurt in tourism. Here is hoping that peace continues in the Valley. This alone guarantees a year-round tourism and the consequent economic prosperity.

AUKUS, QUAD Transforming Alliance-Like

his week augurs an acceleration of strategic realignments among the big powers amidst growing signs of a new cold war globally with particular focus on the United States' containment strategy against China playing out in the Indo-Pacific region. Two back-toback events on Friday can be seen as major events in this direction.

First, the US President Joe Biden is hosting a trilateral summit at Camp David on Friday with Japanese Prime Minister Fumio Kishida and South Korean President Yoon Suk Yeol, which is expected to result in the signing of a defence, security and technology cooperation agreement between the three allies relating to the Indo-Pacific.

Second, the annual Malabar exercises participated by the navvies of the US. India, Japan and Australia begins on Friday, hosted by Canberra for the first time, surrounded by much hype that a QUAD collective maritime defence alliance is emerging in the Indo-Pacific.

The trilateral agreement to be signed tomorrow at the Camp David summit reportedly includes ballistic missile defence systems and the development of other highend defence technologies. Since the election of Yoon last year as the president, South Korea-Japan relations have markedly improved, which helps advance their 3-way cooperation with Washington. Evidently, the Biden administration hopes to take advantage of the recovery of Tokyo-Seoul relations to institutionalise some of the dialogue progress that the three countries have achieved.

The 3-way relationship still remains fragile as Yoon's efforts are not widely popular within South Korea, and Tokyo, unsurprisingly, remains cautious that the process is far from irreversible. Nonetheless, at the talks at Camp David, Biden, Yoon and Kishida may acknowledge the imperative of collective security for the three countries and agree that a threat to one of them would be considered a threat to all.

Conceivably, the Camp David talks signify an effort by the US to form a new military bloc in Asia and an attempt to encourage Japan and South Korea to join the mini military bloc known as AUKUS [Australia-UK-US]. Washington's intensification of military-technical and scientific-technological cooperation with Seoul and Tokyo makes it easier for them to interact with AUKUS projects. As regards the Malabar exercise, its main thrust appears to be to build up QUAD's operational capability within a collective maritime security strategy in five high-priority areas, including antisubmarine warfare and maritime domain awareness. Simply put, like AUKUS, QUAD is also transforming, as American ingenuity is creating an alliancestyle defence structure on a platform of non-military grouping by strengthening various modes of military cooperation with the intention to make it serve Washington's interests. Intrinsic to this is the flattering attention President Joe Biden has been paying to India lately — and to Prime Minister Narendra Modi personally. India's newfound activism Interestingly, the US and Australia perceive that the Indian leadership for the first time is showing an "activism [that] defies conventional skepticism that New Delhi's preference for nonalignment and its geo-strategic priorities militate against deeper military cooperation with its Quad partners," as an Australian establishment think tanker Tom Corben wrote recently in Nikkei Asia. That is to say, to quote Corben, Malabar exercises have "evolved to focus on increasingly sophisticated forms of high-end naval cooperation, particularly maritime domain awareness and anti-submarine warfare... [and] there is a political and strategic window of opportunity for the four countries



to make good on this potential." Corben is optimistic that "bilateral efforts are continuing to open the aperture for tangible Quad maritime defence cooperation."

Corben does some kite flying such as India integrating into US-Australia "force posture initiatives." Earlier in June, he had co-authored a study with two American colleagues at the Carnegie Endowment for International Peace titled Bolstering the QUAD: The case for a collective approach to maritime security, which lamented that the QUAD is not "not living up to its potential as a contributor to regional security and defence in the maritime domain. This is a problem for Indo-Pacific security."

In an oblique reference to the Modi government and the rising curve of India-China alienation. the US-Australian study, however, drew comfort that whereas political sensitivities and geo-strategic concerns hitherto prevented QUAD countries from embracing a collective security agenda, "these constraints are beginning to lessen ... as its members come to recognise China as a common military challenge that requires a degree of collective action and security coordination to address.

The study recommended that 'QUAD should capitalise on this diplomatic opportunity and geostrategic imperative to pursue a collective maritime security strat-

Truly radical 'Machiavellianism'

Evidently, contrary to the Modi government's theatrical public diplomacy upholding India's strategic autonomy, an entirely different perception has been generated at the political and diplomatic level with the QUAD partners that "Barkis is willing". This is no small achievement for India's foreign policy establishment. Max Weber's famous description of Kautilya's Arthasastra, one of the greatest political books of ancient India, as truly radical Machiavellianism'

of the guidance provided by the leadership is that the two countries regard each other as a partner, not adversary.

Now, this unstable equilibrium reached at Chushul-Moldo border meeting point will not last if the Malabar exercises turn into a geopolitical tool for Washington to transform QUAD. China had hitherto blithely assumed that QUAD is a mere. papa tiger.

Evidently, the US is stuck in the old Cold War groove despite the drastic changes in international relations that have taken place since the collapse of the Soviet Union, especially those that required the development of new approaches to maintaining strategic stability and building a new architecture of international security.

But the US' bloc thinking is the opposite of the development of stable, equal, constructive, mutually beneficial relations based on consideration of each other's interests and aimed at ensuring equal and indivisible security for all. Therefore, its preservation as the main intellectual tool for shaping foreign policy only underscores that the US is not ready, unable or does not intend to build such relations with leading global players such as Russia and China. Implicit in it is a stark message for India, too, that the time has come for it to stand up and be counted as ally.

There is no doubt that the US envisages a pronounced military-

eing an El Niño year, the expectation was that north India would see a sparse monsoon. However, the pendulum has swung the other way. July saw record rainfall in many parts of Himachal Pradesh, Punjab and Uttarakhand and the rare sight of the Yamuna nearly spilling into the Red Fort in Delhi. At least 150 were killed and losses worth 10,000 crore were reported by Himachal Pradesh alone. The worst, however, was yet to come as the week saw multiple floods in Himachal Pradesh and Uttarakhand that have claimed at least 60 lives since Sunday. A series of landslides has crumbled buildings and blocked highways. The immediate explanation for the landslides is the unexpectedly copious rainfall that these States have received and that these in turn are due to a surfeit of Western Disturbances (WD). These are tropical storms that originate in the Mediterranean region and normally bring winter rainfall to north India. However, right from the beginning of this year, the WD have been erratic. There were too few of them in December and January and their absence was cause for the hottest February recorded in India in at least a century. However, the WD appear to be overcompensating for their absence, with several of them incident over north India in the last two months — a time when they normally should not be around. While a combination of WD and monsoon can be dismissed as 'freak' weather, climate scientists have been warning of the increasing probability of such high-risk events. The awry WD are in part due to a warming Arctic that causes the polar jet stream, which carries moisture, to deviate from its regular path and bring the disturbances to north India during the monsoon.

It is in the context of these altered weather patterns that warnings by scientists and environmentalists of the perils of wanton construction in the Himalayas must be factored in. The ongoing Char Dham road building project has led to large-scale altering of the mountains with significant chunks carved away, rendering them vulnerable to upheaval. As recent fears of land subsidence in Joshimath, Uttarakhand demonstrated, ill-thought construction and haphazard building practices have magnified the risk to residents who live in these regions. While State governments tend to search for short-term solutions such as demanding compensation from the Centre for 'disaster relief', it is time that more serious thought is given to the nature of infrastructure development and, if need be, restrictions imposed in the larger interest of minimising hazards and maintaining stability

comes to mind.

The paradox is, against such complex backdrop of opacity or downright doublespeak - depending on how one views it - a contrarian wind may have begun blowing in the weekend presaging some forward movement at the 19th round of India- China Corps Commander Level Meeting held at Chushul-Moldo border meeting point on the Indian side on 13-14 August 2023.

As of now, the evidence is deemed too conjectural but the joint statement exudes a tone of optimism. The two sides considered it necessary to extend the discussion overnight, which has been estimated as "positive, constructive and in-depth."

The protagonists "exchanged views in an open and forward looking manner" and also "agreed to resolve the remaining issues in an expeditious manner and maintain the momentum of dialogue and negotiations through military and diplomatic channels.

strategic dimension to AUKUS and QUAD, which means a high probability of transformation of these interstate associations as cogs in the wheel of a full-fledged military-political bloc sooner rather than later. Its ideological basis is a perceived common interest of its participants to counter the rise of China [which nowadays Delhi euphemistically calls "multipolar Asia"].

Suffice to say, as in the case with the NATO on the European theatre, the function of confrontation is planted in the AUKUS and in QUAD, which will inexorably increase the military potential of Australia and the US in the Asia-Pacific region, causing a serious change in the balance of forces and generating a spike in regional and global tensions.

India is at risk of being caught in the eye of the storm, as it were, although its issues with China are neither one of geopolitical rivalry nor of being a gatekeeper for Western hegemony.

In Sickness and Strife: The Battle Against Narcissistic and Borderline Tendencies in Marital Bonds

Dersonality disorders can significantly impact individuals' lives, as well as the relationships they are involved in. Two commonly discussed personality disorders that have a profound effect on interpersonal relationships are Narcissistic Personality Disorder (NPD) and Borderline Personality Disorder (BPD). If you want to feel better about yourself, should you try improving your self-esteem or self-compassion? A journal article published on August 3, 2023, "A Narrative Review and Meta-Analysis on Their Links to Psychological Problems and Well-Being," can help answer that question.

Both self-concepts are assumed to play roles in well-being, which research supports. And both can be seen as relationships with the self.

Self-esteem

History shows that the concept is complex. The authors, Muris and Otgaar, highlight existing perspectives regarding the function of self-esteem. For example:

- Self-value already exists within and that prompts motivation to meet full potential.
- Self-esteem builds from achieving rewards and avoiding punishments (basically earning it as you go).
- Self-esteem is driven by building our place within our worldview that calms fears about not existing. (Think about "leaving a legacy").
- Self-esteem evolves as social value is reflected (e.g., signs of social rejection and acceptance from others).

Yet "whether conceiving self-esteem as a vehicle of motivation, a buffer against the fear of death, or a social thermometer, all these functional accounts align with the notion that the construct has a positive nature and hence may promote psychological well-being and protect

against mental health problems." The effects of higher (positive) and low (negative) selfesteem have been well-researched throughout the years.

On a day-to-day basis, many of us likely feel our self-esteem wavers. Yet according to the authors, we can probably relax about variations in self-esteem. There's a steadiness when viewed over time.

Self-compassion

Self-compassion can be conceptualized as how a person relates to themselves while experiencing personal challenges. Per Neff, the leader of self-compassion science, it's comprised of three elements (2011). Quotes from selfcompassion.org follow:

- Self-kindness vs. Self-judgment. Selfcompassion entails being warm and understanding toward ourselves when we suffer, fail, or feel inadequate, rather than ignoring our pain or flagellating ourselves with self-criticism.
- Common humanity vs. Isolation. Selfcompassion involves recognizing that suffering and personal inadequacy is part of the shared human experience – something that we all go through rather than being something that happens to "me" alone.
- Mindfulness vs. Overidentification. Self-compassion also requires taking a balanced approach to our negative emotions so that feelings are neither suppressed nor exaggerated.

According to Muris and Otgaar's research, the function is likely complicated. For example, self-

compassion may stem from something evolutionary. Compassion for others elicits bonding and survival of the species. Self-reflection allows for self-compassion in times of strife. Also, self-compassion enables people "to effectively cope with such emotional dysregulation, ensuring their full participation in social life."

Similarities

- Both self-esteem and self-compassion have significant research backing the positive benefits of healthy amounts. (Though self-esteem has more research than self-compassion at this time.)
- Both can feel fluid–easier or harder–at different times. Yet self-esteem and self-compassion are likely steady–like traits–when viewed over time.
- There's considerable overlap in the nuances of the two concepts and they may be considered complementary to each other (one adds to the other or boosts the other, and so on).
- Pursuing either can have a positive impact on a person's well-being.

Differences

Self-esteem interventions can involve thinking positively about oneself, which can be especially difficult for some people. Selfcompassion targets kindness, humanity, and mindfulness. Though also tricky for many, these can be more easily achievable than what can feel like self-praise. A study by Barbau and colleagues (2022) supports that phenomenon.

To me, self-esteem focuses on an intrinsic sense or the results of self-assessment, meaning "my evaluation of my worth as a human being." And self-compassion seems inherently action-oriented, meaning "I could utilize whatever compassion I have to get through this."

Finally, one of the two is commonly perceived to hold risk. Concern about attaining "too much" self-esteem and becoming narcissistic exists. However, Muris and Otgaar address this and assure readers that this is not typically a realistic risk.

Which is better?

In their research, the authors theoretically explored both concepts and analyzed 76 articles. They concluded that "no evidence was obtained to support the claim that self-compassion has more potential as a positive-protective variable than self-esteem." So it seems that which is better for you might be personal.

- Which appeals to you most
- Which you are more deficient in
- Which is easiest for you
- Which you want more of

Maybe ask yourself how you value or rate yourself. Then ask yourself how much compassion you give to yourself for your weaknesses. This exercise might point to which can serve your well-being the most.

What can I do to increase either?

It's important to know what science says. It's equally (or perhaps more) important to understand how to bring research and academics into practical reality. That said, Muris and Otgaar's article provides an informative list of approaches that offer promise, have research behind them, or are considered evidence-based. For targeting self-esteem:

- Cognitive behavioral therapy
- Reminiscence-based therapy
- Evaluative conditioning
- Support groups
- Art therapy
- Positive psychology

For targeting self-compassion:

- Compassion-focused therapy
- Mindful self-compassion
- Cognitively based compassion training

Bottom line

Instead of "Which is better, self-esteem or self-compassion?" it might be strongest to ask, "Which is better for me?" If you feel low in either self-compassion or self-esteem, there's always hope and ways to grow. Try either and see how you feel. Since they seem to build and bounce off each other, start with which appears the most realistically achievable to and for you.

Finally, and on a selfish note, I must introduce self-acceptance here. It's another selfconcept that could someday, I believe, compete with these others in helping people to live the contented, fulfilling lives they want. But at this time, there's not a lot of scientific research on it. Centre Makes Verification Of SIM Card Dealers Mandatory; Bulk Connections **Discontinued To Curb Frauds**

NEW DELHI: In a bid to check digital frauds, the government has made verification of dealers selling SIM cards mandatory and discontinued the provision of issuing bulk connections, Union minister Ashwini Vaishnaw said on Thursday.

Earlier, while announcing the new measures, the minister had said that the government has made police verification of SIM card dealers mandatory.

He later clarified that the verification of SIM card dealers will be carried out by "the licensee" or the respective telecom operator and added that a penalty of Rs 10 lakh will be imposed on violators.

In a widespread crackdown against SIM card related digital frauds, the minister said that the government has disconnected 52 lakh mobile connections. While 67,000 dealers have been blacklisted, 300 FIRs have been registered against SIM card dealers since May 2023.

Further, the minister said WhatsApp on its own blocked around 66,000 accounts that were involved in fraudulent activities.

"Indisputable verification of SIM dealers will be mandatory to curb frauds. Penalty of Rs 10 lakh will be imposed on dealers found violating norms,"



Vaishnaw said.

The verification will be done by telecom operators who will collect the details of each business owner and his business related documents for verification before appointing a dealer. Earlier, detailed documentation of dealer was not prescribed in the rule.

Vaishnaw said that there are 10 lakh SIM card dealers and they will be given sufficient time for verification.

The minister said that the Department of Telecommunications has also discontinued the provision of issuing bulk connections and instead a new concept of business connection will be introduced.

"Besides, KYC of businesses, KYC of person taking handover of SIM will also be done," Vaishnaw said.

The new rule will be implemented from October 1 and dealers will be given about six month time for the compliance.

Delhi court grants bail to pilot arrested for assaulting minor domestic help

New Delhi: A court here Thursday granted bail to a woman pilot arrested for allegedly assaulting her minor domestic help in southwest Delhi's Dwarka, saying she had been incarcerated for a month and that keeping her in further judicial custody would serve "no purpose".

The court also observed that as her husband was also in jail, there was no one to take care of their four-year-old child, who was suffering from "a chronic and life-threatening disease".

Additional sessions judge Vipin Kharb was hearing the bail plea of Pournima Nilkant Somkuwar against whom the Dwarka South police station had registered a case under various Indian Penal Code (IPC) sections, including Section 370 (buying or disposing of any person as a slave), besides provisions of the Child Labour Act and the Juvenile Justice (Care and Protection of Children) Act.

"Considering the...facts and that the accused is in judicial custody for the last one month and no purpose will be served by keeping her in custody, therefore, the application is hereby allowed and the accused is granted regular bail on furnishing personal bond in the sum of Rs 1 lakh with one surety in the like amount," ASJ Kharb said.

He said at the present stage, the court was not going to discuss whether the offence for buying or disposing of any person as a slave was made out as it would have a "bearing on the framing of charges and merits of the case".

The court said that medical documents of her four-year-old son showed that he was suffering from "ulcerative colitis, a chronic and life-threatening disease".

"For no fault of his, he (the child) has been deprived of constant care and love and affection of his parents and regular medical treatment. On the other hand, accused for her wrong and inhuman conduct is undergoing incarceration for the last one month," it said. The court noted that the ac-

used's husband was also in jail. It said, "There is no previous involvement of the accused in any case and she has to take care of her son."

The court also noted the medico-legal case of the minor victim, according to which she

had received simple injuries. Other conditions of bail included the accused not contacting the victim or her parents except for clearing their dues, attending trial, not tampering

with evidence, intimating any change of address, providing her mobile phone numbers and not leaving the country, the court said. The counsel for the complain-

ant or victim opposed the bail plea, saying the accused despite being an educated and working woman, she "mercilessly" beat the 10-year-old victim.

"She has not only given physical injuries to her (the victim) but also psychological injuries which will haunt her for many years. Considering the gruesome act done by the accused she does not deserve bail," the advocate said. The counsel for the accused

said the court should balance the rights of both the children, i.e. the injured and Somkuwar's son, and that there was no trafficking in the present case.

allegedly assaulted the 10-yearold girl working as a domestic help at their home. After the incident came to light on July 19 last month, they were manhandled by a mob.

In a purported video, the couple could be seen being manhandled and beaten up by a mob. Some of the women were also seen slapping and pulling the hair of the accused woman, who was in her uniform.

Army, NDRF teams rescue 300 people from flood-hit villages in Punjab's Kapurthala

Kapurthala/Gurdaspur: Army and NDRF teams on Thursday rescued nearly 300 people from marooned villages in Punjab's Kapurthala as relief and rescue work continued in some of the flood affected districts in the state.

Kapurthala Deputy Commissioner Karnail Singh said six teams of the National Disaster Response Force (NDRF) and Army pressed six boats to rescue the people caught in the floods and all those evacuated have been shifted to relief camps.

A total of 22 villages have been affected by floods in the Beas river due to release of excess water from Bhakra Dam, he said while expressing hope that the situation would improve by Friday.

He said some flood affected people are living inside 'dhusi bundhs' (embankments) in 'deras' to look after their fields, while nearly 40 people are reluctant to leave their marooned houses and their cattle.

Some parts of Hoshiarpur, Gurdaspur and Rupnagar and Kapurthala districts were submerged following the release of excess water from Pong and Bhakra dams this week.

In the afternoon, Punjab Chief Minister Bhagwant Mann toured the flood affected areas of Hoshiarpur district in a boat to take stock of the situation. Mann said the entire government machinery including the

helicopter of state government is at disposal of people in this hour of crisis. The chief minister said the

state government has already ordered a "special girdawari (survey)" to ascertain the loss incurred to people due to floods in the state.

Mann assured the people that his government will "compensate the people even if they had lost a hen or a goat due to the floods".

He said there is no need for people to panic as the state government is there to extend all help to those affected.

The flood situation in Rupnagar district remained grim as more water was being released into the Sutlej river from Bhakra Dam.

The Army is assisting in the rescue operations and NDRF teams are working round-theclock to prevent breaches and to rescue the people trapped in marooned villages.

Punjab minister Harjot Singh Bains has been camping in the district and is supervising the rescue and relief operations.

The Army and NDRF teams were also assisting in the rescue and relief work in some of the affected areas of Gurdaspur district. Medical teams in the district have been sent to houses via boats to check on people

stuck in their homes for three days and those who don't want to move out, officials said.

In Kapurthala, one person was feared to have drowned in the flood waters of Beas river in Mand areas of village Talwandi Kuka in the Bholath sub-division when he was rescuing his cattle, officials said on Thursday.

In Chandigarh, Chief Minister Mann told reporters that the latest flooding in some areas of the state was caused by heavy rains in neighbouring Himachal Pradesh and subsequent release of excess water from the Pong and Bhakra dams.

The Bhakra Beas Management Board (BBMB), which manages the Bhakra and the Pong dams, on Wednesday said it will release excess water in a controlled manner for the next four to five days to take the level in their reservoirs to a safe limit. The Bhakra dam on the Sutlej and the Pong dam on the Beas -- both in Himachal Pradesh -- are brimming after heavy rain in their respective

 catchment areas.
 Last month too, several parts
 of Punjab were affected by a downpour in the state between
 July 9 and 11 that flooded vast
 tracts of farmlands and other
 areas, besides paralysing daily
 r life.

Mann said the water levels s- in Bhakra and Pong dams stand le at 1,676 feet and 1,396 feet, respectively, and the water was being released in a controlled way.

In Harike, he said the water released from Pong and Bhakra gets collected and added "we are releasing water from there".

"We are in regular touch with the Himachal Pradesh government and BBMB authorities and we are hopeful that water will recede by evening," he said.

Mann reiterated that his government has urged the Centre to relax the norms for increasing disaster relief for flood victims.

In Hoshiarpur, the floodwater level in the villages near the banks of the Beas in Mukerian, Tanda, Dasuya and Talwara areas of this district slightly decreased on Thursday.

However, in the affected villages, the floodwater has caused significant damage to the residents' household belongings. Moreover, the crops standing in the flooded fields have also been adversely affected.

Raminder Singh, the Chief Agriculture Officer of Hoshiarpur, stated that standing crops, particularly paddy, spanning approximately 5,000 acres of farmland, have suffered severe damage in the flood-affected regions.

Approximately 90 per cent of the paddy crop has been adversely affected, he said.

JU student's death: Raging battle between activists outside univ; panel formed to probe lapses

Kolkata: A raging battle broke out between activists of an ultra-left organisation with BJP's Yuva Morcha members on Thursday as the saffron party leader Suvendu Adhikari's convoy came up to a gate of the Jadavpur University, where a student had died after being allegedly ragged and sexually harassed by seniors.

ragged and sexually harassed by seniors. The ultra-Left body, All India Revolutionary Students Federation (AIRSF), was holding a black flag demonstration against Adhikari who was trying to give a speech, outside the university on the issue of the death of the student which has shocked the megapolis, when the two sides came to blows.

Adhikari told Yuva Morcha activists: "We have already taught a lesson to the 'Tukde-tukde' gang in JNU... we will cleanse them in Jadavpur as well."

'Tukde-tukde' gang is a pejorative political catchphrase used by BJP against opponents accused of supporting sedition.

In his speech, the leader of the oppo-

blamed them for the state of affairs in the 67-year-old prestigious university.

"The state government has done nothing to stop ragging in state-run universities. The TMC is more interested in taking control of state-run universities. The TMC has turned universities into dens of anti-social activities," he said.

As activists from both sides engaged in a battle of fisticuffs, using motorcycle helmets as weapons, the city police had a hard time controlling and disengaging the two groups. Traffic outside the gate of the university snarled to a stop as the "war" raged across the road. Several activists already bloodied and hurt were seen dragged by the police into waiting vans to be carried away to

a lock-up after medical attention. The ruling TMC alleged that after Adhikari finished his demonstration, he was greeted with black flags by a section of the students who were then beaten up by BJP goons, aided by the Central Armed Forces.

"A student from the transgender community was hit by a helmet and was left bleeding," the ruling party claimed in a post on X, formerly known as Twitter.



The TMC also alleged that Adhikari created a ruckus outside JU, verbally abused the police and passed derogatory remarks.

On Adhikari's allegation, TMC spokesperson Kunal Ghosh said, "BJP is just trying to fish in troubled waters. Before pointing fingers at us, they should take stock of the situation in Central government-run universities." In separate protests, activists of CPI(M)'s SFI, Trinamool Chhatra Parishad and ABVP staged sit-ins at nearby spots outside gates four and five, but no untoward incident took place.

Even as the battle between rival bands of activists raged, the West Bengal government announced the formation of a four-member committee to probe into the administrative lapses connected with the death of the Jadavpur University student who

was allegedly ragged and sexually harassed by his seniors before he fell from the hostel's balcony.

The 17-year-old deceased, who was a resident of Bagula in Nadia district, was a first-year undergraduate student of Bengali Honours.

The committee, which will be functioning immediately, has been asked to submit its report in two weeks, said officials.

The members of the committee are the vice-chairperson (academic) of the West Bengal State Council of Higher Education, the member-secretary of the council, the director of public instruction and the special commissioner of the higher education department.

The notice, which referred to certain "administrative lapses and infrastructural gaps" in Jadavpur University, said the panel "will identify these and take corrective steps".

In another development related to the August 9 incident, the University Grants Commission (UGC) in Delhi reprimanded Jadavpur University for submitting a "generic" report about the incident. curb ragging on campus, the commission has told the university that it is not satisfied with the report.

"The report submitted was examined and it was found to be very generic in nature basically mentioning mostly the reactive approaches adopted in the matter than proactive measures taken to curb the menace of ragging. The commission is not satisfied with the report," a source told PTI in Delhi.

The UGC has further sought a compliance report on 12 queries raised by it and also documentary evidence within a day.

JU Registrar Snehamanju Basu told reporters it was a preliminary report and she was told by a UGC official it was "okay," (initial report) but the university will certainly file an actiontaken exhaustive report about every query which will be compiled within a few days.

Basu also announced that JU made identity cards issued by the university mandatory for visitors to enter the campus from 8 pm to 7 am and decided to install CCTVs at strategic points, including at the gates at the earliest.

Kashmir. The newborn babies suffering from autism, down syndrome, disabilities etc are also thrown around garbage bins and other dumping sites.

The issue of dumping newborns was taken up by Srinagar-based lawyer and Right to information activist Badrul- Duja with the SWD.

Duja told Kashmir Observer that he is witness to a number of cases regarding abandoning of newborn children, particularly at spots or locations such as dumping sites, outside hospitals, water-bodies, etc.

"These places are becoming easy spots for couples or parents to abandon their newborns and putting their lives and safety at risk," he said.

In order to prevent this, Duja said, it was imperative to provide cradle centers/spots especially across sites such as mosques, marriage halls, water bodies, private and public hospitals, dispensaries, garbage dumping sites etc, and also to ensure such couples/parents are protected from CCTV access identity.

"It was the need of the hour to put cradles across these spots immediately. Now since the Government has started the process. It's a good sign," he added.

Commissioner Secretary to Government SWD, Sheetal Nanda told Kashmir Observer that the process of setting-up cradle centers has been started in all the hospitals across the UT to ensure that no child is abandoned.

"The idea is if there is any abandoned or an orphan baby, we should come to know. We will take care of the babies," she said.

An official of the SWD said that over 2155 rescued children have been sheltered in childcare institutions in J&K under the Mission Vatsalya scheme in the last three years.

against SIM card dealers since May 2023. Further, the minister said WhatsApp on its own blocked around 66,000 accounts that were involved in fraudulent activities.

"Indisputable verification of SIM dealers will be mandatory to curb frauds. Penalty of Rs 10 lakh will be imposed on dealers found violating norms," Vaishnaw said.

The verification will be done by telecom

operators who will collect the details of each business owner and his business related documents for verification before appointing a dealer.

Earlier, detailed documentation of dealer was not prescribed in the rule.

Vaishnaw said that there are 10 lakh SIM card dealers and they will be given sufficient time for verification.

The minister said that the Department of Telecommunications has also discontinued the provision of issuing bulk connections and instead a new concept of business connection will be introduced.

"Besides, KYC of businesses, KYC of person taking handover of SIM will also be done," Vaishnaw said.

The new rule will be implemented from October 1 and dealers will be given about six month time for the compliance. PTI PRS ANZ HVA

hearing, he referred to his written submissions where the election manifesto of Bharatiya Janata Party has been quoted. "In that, they expressly said that they will work towards abrogation of Article 370 ... these manifestos cannot be contrary to the constitutional scheme. In 2015, EC issued guidelines that all manifestos must be within constitutional scheme and spirit," Dave told the 5-judge Constitution Bench.

He argued that Article 370 was abrogated to gain political weightage by the ruling party at the Centre. "You have not done it for any purpose. These arguments of impeding growth, etc., are not relevant at all. It doesn't exist. The only reason you have done it, is because you told people of India to vote for you as I will go and abrogate Article 370," he said, adding that power has been exercised for colourable considerations based on "irrelevant considerations".

Dave contended that there is no power to abrogate Article 370 under Article 370(3). "It has lived its purpose and its object. It is no longer available for exercise," he added.

He said that a false narrative has been built that Jammu and Kashmir is not part of India due to Article 370 of the Constitution, adding that it has always been an integral part of India. Dave repeatedly argued that the procedure adhered by the Centre to nullify Article 370 amounted to "fraud" and termed the exercise of power by Parliament as "colourable".

On this, the CJI said, "If 370 has served its purpose after the constituent assembly comes to an end, why were constitutional orders made applicable post 1957? But the fact that 370 served its purpose is belied by consequent constitutional orders made applicable thereafter, so 370 continued to be in existence."

The CJI further added, "If your submission is right qua clause 3, then once the constituent assembly completed its task in 1957 there cannot be any constitutional amendments at all, which is thus belied by the constitutional practice itself. Constitutional amendments happened and went on happening till 2019. If you are saying that 370(1) continues to exist, then you cannot say 370(3) ceases to exist. Either everything remains together or everything perishes together. We are talking about a practice being followed for 64 years."

A Constitution Bench of the Supreme Court headed by Chief Justice of India D.Y. Chandrachud has been hearing a batch of pleas challenging the abrogation of Article 370 of the Constitution from August 2.

Without medication, it may take years before HIV weakens your immune system to the point that you have AIDS.

Officials said that a person suffering from

AIDS is "unfortunately" often regarded as a stigma in society and such people become victims of ostracism, rejection and discrimination. They said that J&K is at a greater risk of HIV

AIDS because of being a tourist destination. Most of the patients who have tested posi-

tive for HIV AIDS in J&K have contracted the disease from outside the UT.

"Drug addicts are at a higher risk of contracting HIV/AIDS and if they are married or are sexually active, they transmit this to their partners as well," they said–(KNO)

Kylian Mbappé, Messi's for-mer teammate at Paris Saint-Germain, was sixth in the player voting by Europe-based coaches and journalists despite his tournament-leading eight goals at last year's World Cup, including three in the final against Argentina.

Ranked above Mbappé were Man City midfielders Ilkay Gündogan and Rodri, as the latter's goal decided the Champions eague final.

The only Inter player getting votes was Marcelo Brozovic in eighth place. The Croatia midfielder has since moved to the Saudi Pro League.

Cristiano Ronaldo and Neymar, others who have moved to Saudi Arabia, got no votes from the UEFA panel, which included coaches from clubs that played in the group stages of the three European competitions. (AP)

After Spending \$1B, Chelsea Heads To West Ham Ready To Kick On Under Pochettino

LONDON: So, after a change of ownership, two managerial firings, three wild transfer windows and the arrival of 23 players – and counting – at a staggering cost of around \$1 billion, is new-look Chelsea ready to compete for the English Premier League title again? Not yet, most would say.

However, there are signs that good things might be around the corner for a club which, for the past two years, has been consumed by chaos on and off the field and rarely out of the spotlight because of its outrageously expensive squad overhaul.

The record signing of Moises Caicedo and the imminent arrival of another highly rated defensive midfielder, Romeo Lavia, are likely to put the seal on another busy transfer window for Chelsea that was as interesting because of the names leaving the club as it was for those joining.

Out has gone Edouard Mendy, Kepa Arrizabalaga, Cesar Azpilicueta, Kalidou Koulibaly, Mateo Kovacic, N'Golo Kante, Mason Mount, Christian Pulisic, Ruben Loftus-Cheek, Kai



Havertz and Pierre-Emerick Aubameyang, among others. Through the revolving

Trained Scent Dogs May More Effectively Detect Covid Than RT-PCR tests: Study

Trained scent dogs exhibit a remarkable ability to detect COVID-19 infections with higher accuracy and efficiency compared to conventional RT-PCR tests, according to a review of studies. This innovative approach not only promises quicker results but also holds the potential to substantially reduce diagnostic costs, the researchers said

A growing number of studies over the last two years has highlighted the power of dogs in detecting the stealthy virus and its variants, even when they are obscured by other viruses, like those from common colds and flu.

"It went from four papers to 29 peer-reviewed studies that include more than 400 scientists from over 30 countries and 31,000 samples," said Tommy Dickey, Distinguished Professor Emeritus at the University of California (UC) Santa Barbara, US.

Dickey and collaborator Heather Junqueira from BioScent, Inc. noted that the collective research demonstrates that trained scent dogs are "as effective and often more effective" than the antigen tests we're keeping handy at home, as well as the goldstandard reverse transcription polymerase chain reaction (RT-PCR) tests



deployed in clinics and hospitals. According to the study, published in the Journal of Osteopathic Medicine, not only can dogs detect theS-CoV-2 virus faster, they can do so in a non-intrusive manner, without the environmental impact that

comes with single-use plastics. Dogs have hundreds of millions of olfactory receptors, compared to roughly five to six million for humans, and a full third of their brains is devoted to interpreting smells, compared to a scant 5 per cent in human brains, the researchers said. All these enhancements mean

that dogs can detect very low concentrations of odours associated with COVID infections, they said. "They can detect the equiva-

"They can detect the equivalent of one drop of an odorous substance in 10.5 Olympic-sized swimming pools. For perspective, this is about three orders of magnitude better than with scientific instrumentation," Dickey said.

The researchers found that in some cases, dogs were able to detect COVID in pre-symptomatic and asymptomatic patients whose viral load was too low for conventional tests to work. Dogs can also distinguish COVID and its variants in the presence of other potentially confounding respiratory viruses, such as those of the common cold or flu, they said.

Luna-25 Prepares For Soft Landing On Aug 21 As Chandrayaan-3 Progresses

Russia's ambitious Luna-25 mission is poised to achieve a remarkable feat as it inches closer to the moon's south pole for an historic soft landing scheduled for August 21. The mission, undertaken by the Russian space agency Roscosmos, seeks to rekindle lunar exploration after a hiatus of nearly five decades.

"All Luna-25 systems are functioning normally; communication with it is stable. Sessions are being taken to measure the current navigational parameters," Roscosmos said in a Telegram post.

Roscosmos has shared the initial images captured by Luna-25. These images provide a striking view of the spacecraft against the backdrop of both Earth, a planet left behind, and the Moon, the mission's imminent destination. The imagery also features the emblem of the Luna-25 mission and the bucket of the onboard manipulator, showcasing the craft's advanced capabilities.

"These pictures show the structural elements of the « Luna-25 » apparatus against the background of the Earth, from which we have forever flown away, and against the background of the Moon, to which we will very soon fly. In the third picture you can see the emblem of the mission and the bucket of the onboard manipulator," said a statement from Roscosmos Luna-25 embarked on its jour-

ney on August 10, 2023, launching atop a Soyuz rocket from the Vostochny Cosmodrome. This mission has a specific objective –



to land at the moon's south pole, an area believed to harbor vital ice resources. These resources could play a pivotal role in facilitating future space missions by enabling the extraction of oxygen and fuel.

The last Russian lunar mission predates the modern era of space exploration, with Luna-24 being launched back in 1976. Luna-25 stands as Russia's first lunar lander in nearly 47 years, marking a significant milestone for the nation's space program. The mission aims to surpass its predecessor's achievements by delving deeper into lunar exploration and research

As Luna-25 orbits the moon, Roscosmos reports that scientific instruments on board have been activated, providing valuable data on the mission's progress. The project's scientific team has commenced the processing of this data, contributing to a growing pool of lunar knowledge.

While Luna-25's journey is reaching a crescendo, the Indian Chandrayaan-3 mission is also making steady strides. Launched

on July 14, Chandrayaan-3 is currently in the final lunar-bound orbit maneuver. This maneuver brought the spacecraft closer to the moon's surface in preparation for its muchanticipated landing attempt.

Remarkably, Luna-25 could potentially touch down on the moon's south pole before Chandrayaan-3. Despite launching nearly a month later, Luna-25's trajectory and route could enable it to achieve a soft landing sooner than its Indian counterpart. Roscosmos plans to finalise Luna-25's lunar orbit on August 16, aiming for a soft landing attempt on August 21 or 22, just ahead of Chandrayaan-3's targeted landing on August 23.

On Wednesday, the spacecraft accomplished its fifth and final lunar-bound orbit manoeuvre, bringing it closer to the Moon's surface. It has now finished all the necessary manoeuvres to reach the Moon and will begin preparing to detach the lander module, which includes the lander and rover, from the propulsion module.

How Maternal Mental Health Influences Children's Well-Being

n a groundbreaking study published in the American Journal Lof Biological Anthropology, UC Berkeley Anthropology Professor Andrew Wooyoung Kim has unveiled transformative insights into the intergenerational effects of maternal mental well-being in rural Uganda. The study, titled "Maternal adverse childhood experiences, child mental health, and the mediating effect of maternal depression: A cross-sectional, population-based study in rural, southwestern Uganda," delves into the complex relationship between mothers' adverse childhood experiences (ACEs) and the mental well-being of their children, shedding light on the role of maternal depression as a mediating factor.

UC Berkeley study has illuminated a profound connection between maternal mental wellbeing, adverse childhood experiences, and their impact on the mental health of their children. The findings underscore the need for prioritizing mental health support, especially in areas with histories of societal oppression and elevated psychiatric morbidity rates. By understanding and addressing the intergenerational effects of maternal mental well-being, researchers hope to pave the way for healthier outcomes for both mothers and their children.

Adverse childhood experiences (ACEs) encompass a wide range of potentially stressful or traumatic events that an individual has encountered before the age of 18. These experiences can include violence, abuse, growing up in families with mental health or substance use issues, and exposure to various forms of societal oppression. Toxic stress resulting from ACEs can have lasting impacts on brain development and how the body responds to stress.

Professor Kim's research focused on rural Uganda, where historical post-colonial societal oppression and elevated rates of psychiatric morbidity provided a unique backdrop for the study. The findings were striking: a significant correlation was established between maternal ACEs and child mental health problems. Furthermore, the research highlighted the role of maternal depression as a potential mechanism through which maternal childhood adversity influences the mental well-being of the next generation.
