Parents To Face Rs 25K Fine, 3-Yr Jail For Allowing Minors Drive

Srinagar: Parents who allow their minor children to drive cars and motorbikes in Kashmir Valley will now face a penalty of Rs 25000 and 3 year imprisonment under the new Motor Vehicles Act, a senior officer said Saturday.

"Till now, we were counseling minors and their parents. However, now we take strict action against the parents in accordance with the law," Dy Sp, Traffic, Mehboob-ul-Haq told Kashmir Observer Saturday.

He said if a minor is found



driving a car or bike, his or her parents will have to shell out Rs 25000 fine, and 3 year imprisonment under the amended MV Act.

He argued that the underage

drivers not only put their lives at risk but also threaten the precious lives of others as well. He said that the crackdown against underage drivers was already in progress and in the coming days, it will be further intensified.

"The quick reaction teams (QRTs) of traffic police will step up crackdown against underage drivers. At the same time, regulation of traffic on roads is equally important. We will deal with both these issues simultaneously," Mehboob said.

"This move will definitely serve as a deterrent. We expect unending support of parents in our endeavor to make roads and streets safe for people," he added.



Renovation Of Ghats Along Jhelum River In Srinagar Undertaken

Srinagar: Authorities in Jammu and Kashmir's Srinagar have taken up an ambitious project to renovate about 40 ghats' as part of the Jhelum riverfront development project to restore them to their old glory.

As part of the project, under the aegis of the Srinagar Smart City Project, 20 ghats on the Jhelum River here have been restored so far.

The initiative aims to preserve these heritage sites and revive these important public spaces, reconnect the city with the river and develop infrastructure to support water transport.

Apart from being places to socialize, the ghats were important for business as well, which was done through the water transport system.

"As per the riverfront development project beyond Amira Kadal to Chattabal we have around 40 ghats. Those used to be important public places and also for water transportation. Twenty of them have been restored and we will inaugurate them in a few days," chief executive officer (CEO), Srinagar Smart City Project, Athar Amir Khan told PTI here.

He said the ghats helped people to connect and socialize.

"They were also used for water transportation.

We are working and many of these ghats are also getting converted into boarding and deboarding points for water transportation," Khan added.

Bilal Ahmad Dar, a washerman, who works at one of such ghats, said their renovation was essential.

"Ghats have significant importance as it generates employment for those who work at ghats. Renovation of ghats is essential as they are quite damaged. This step was much needed as it will help people like us to earn a livelihood. If the government will work more on ghats, it will bring in more benefits," he said.

Another washerman, Showkat Ahmad Dar, who washes shawls at one of the ghats over the river, said Kashmiri Pandits used to perform rituals at such places.

"Repairing ghats is very important and they should be cleaned properly," he said.

The ghats were once the backbone of the people of Kashmir as they used to live and do trade at ghats.

"In Srinagar, the art-

work of Kashmir is dependent on these ghats. Significant mosques, shrines and temples are on the bank of the Jhelum River. A number of ghats have been renovated as it was an important step because it added up beauty.

British Nurse Found Guilty Of Killing Seven Babies And Trying To Kill Another Six

LONDON: A British nurse, who wrote a note stating "I am evil", was found guilty on Friday of murdering seven newborn babies and trying to kill another six in the neonatal unit of a hospital in northwest England where she worked.

Lucy Letby, 33, was convicted of killing five baby boys and two baby girls at the Countess of Chester hospital and attacking other newborns, often while she was working night shifts, in 2015 and 2016.

The verdict, following a 10-month trial at Manchester Crown Court, makes Letby one of Britain's most prolific serial child killers. She was found not guilty of two attempted murders while the jury was unable to agree on six other suspected attacks.

Prosecutors told the jury during the trial that Letby poisoned some of her infant victims by injecting them with insulin, while others were injected with air or force-fed milk, sometimes involved multiple

attacks before they died.

"I killed them on purpose because I'm not good enough to care for them," said a handwritten note found by police officers who searched her

home after she was arrested. "I am a horrible evil person," she wrote.

Some of those she attacked were twins — in one case she murdered both siblings. She tried to kill one baby girl three times before finally succeeding on the fourth attempt.

Letby will be sentenced on Monday and faces a very long prison term, and possibly a rare full life sentence.

Her actions came to light when senior doctors became concerned at the number of unexplained deaths at the neonatal unit, where premature or sick babies are treated, over 18 months from January 2015.

With doctors unable to find a medical reason, police were called in. After a lengthy investigation, Letby, who had been involved in the care of the babies, was pinpointed as the "constant malevolent presence when things took a turn for the worse", said prosecutor Nick

Letby wept when she gave evidence over 14 days, saying she had never tried to hurt the babies and had only ever wanted to care for them, saying there had been unsafe staffing levels on the ward and its dirty conditions might have been a factor in the deaths.

China Military Drills Send 'Stern Warning' To Taiwan After Us Visit

hina has launched air and sea military exercises around Taiwan to send a "stern warning" to separatist forces on the island following a recent visit by Taiwan's Vice President William Lai to the United States.


Taiwan responded on Saturday saying the drills highlighted Beijing's "militaristic mentality" and that combat aircraft, naval ships and landbased missile systems had been tasked with monitoring Chinese forces.

The People's Liberation Army's Eastern Theatre Command, which has responsibility for the area around Taiwan, said in a brief statement earlier on Saturday that it was carrying out joint naval and air combat readiness patrols around Taiwan.

The eastern command said the exercises focused on ship-aircraft coordination to test seizing control of air and sea space, and to test combat capabilities.

"The patrols and exercises serve as a stern warning to the collusion of 'Taiwan independence' separatists with foreign elements and their provocations," a spokesperson for the eastern command told China's state-run Xinhua news.

State broadcaster CCTV reported that missile-equipped vessels and fighter jets were involved in the operation and that units worked together to



simulate the surrounding Taiwan.

Taiwan's defence ministry quickly condemned the drills, saying it had deployed appropriate forces to respond and had the ability, determination and confidence to ensure national security.

"The launch of the military exercise this time not only does not help peace and stability in the Taiwan Strait but also highlights [China's] militaristic mentality," the ministry said in a statement.

The ministry later reported that 42 Chinese aircraft and eight ships were involved in the drills, and 26 aircraft had crossed the median line which separates the two sides of the Taiwan Strait and previously stood as an unofficial border between the two sides.

Taiwan combat aircraft, land-based missile systems and naval vessels have been deployed to monitor the drills, the defence ministry said on social media.

'A troublemaker through and through'

Taiwan's Vice President Lai, the frontrunner to be Taiwan's next president at elections in January, returned from the US on Friday, where he had stopped over on his way to and from an official state visit to Paraguay.

Taiwanese officials and analysts had said China was likely to conduct military exercises this week near the island in response, using Lai's transit through the US as a pretext to intimidate Taiwanese voters ahead of next year's presidential election and make them "fear war".

China's foreign ministry issued a statement to coincide with Lai's arrival in the US, saying it was opposed to any form of a visit by "Taiwan independence separatists" to the US.

"Lai stubbornly adheres to the separatist position of Taiwan independence and is a troublemaker through and through," the ministry said.

African Swine Flu Reported In Kerala Village, Pigs Ordered To Be Culled

KANNUR, KERALA: An outbreak of African swine flu has been reported in Kanichar village in this north Kerala district, following which the district Collector ordered culling of pigs in two farms there.

The district animal husbandry official confirmed the flu at a private farm located at Malayampadi on Friday.

Subsequently, the district authorities ordered culling of the pigs there and in another nearby farm located in a 10km radius, and bury the carcasses as per protocols.

An area of one km around the pig farm, where the infection had been detected, was declared as an infected area and a radius of 10km as a disease surveillance zone, official sources said.

Distribution and sale of pork in the area and its transportation to other places have been banned for three months, they said

The Collector, the chairman of the district disaster management authority, also asked the local authorities to submit an urgent report to confirm whether the pigs from the affected farm were transported to other farms in the last

two months.

If any fresh case of the disease was reported anywhere in

panchayat, the disaster management a u t h o r i t y should be informed about it at the earliest, an order in this regard said.

The veterinary officer in the hamlet was directed to take urgent measures to check the further spread of the disease, it added.

Gujarat High Court Pulled Up Over Adjournment Of Abortion Request

NEW DELHI: The Supreme Court today expressed displeasure over the Gujarat High Court adjourning a rape survivor's petition for medical termination of her 26-week pregnancy, and said "valuable time" has been lost during the pendency of the matter.

In a special sitting on a Saturday, a bench of Justices B V Nagarathna and Ujjal Bhuyan observed that there should be a sense of urgency in such cases and not a "lackadaisical attitude" of treating the matter as any normal case and just adjourning it.

The Supreme Court was informed by the counsel for the petitioner that the 25-year-old woman had approached the high court on August 7 and the

7 and the matter was taken up the next day.

He said the high court

had on August 8 issued a direction for the constitution of a medical board to ascertain the status of pregnancy as well as the health status of petitioner. The report was submitted on August 10 by the medical college where she was examined.

The top court noted that the report was taken on record by high court on August 11 but "strangely", the matter was listed 12 days later i.e. on August 23 "losing sight of the fact that every day's delay was crucial and of great significance having regard to the facts and circumstances of the case".

The bench also noted that the petitioner's counsel has brought to its notice that the case status of the matter showed that the petition was rejected on August 17 by the high court but no reasons were dictated in the court and the order is yet to be uploaded on the high court's website.

"In the circumstance, we direct the secretary general of this court to inquire from the registrar general of the High Court of Gujarat and ascertain as to whether the impugned order has been uploaded or not," the bench said.

The petitioner has approached the Supreme Court through advocate Vishal Arun Mishra.

The counsel for the petitioner told the bench the woman petitioner was in her 26th week of pregnancy when the medical board was constituted. "On August 11, it was stand over to August 23. For

what purpose?," the bench asked, adding, "By then how many days are lost?".

The petitioner's counsel said the matter was listed on August 17 instead of August 23.

Observing that valuable days have been lost in just post-poning the case, the bench said when the petitioner had sought for the termination of pregnancy and had approached the high court, she was already 26 weeks pregnant.

"Therefore, we find that valuable time has been lost between August 11, when the report was placed before the high court, and the order stating that the matter would stand over to August 23," it said.

Uttar Pradesh: Muslim Couple Beaten To Death By Neighbours Over Dispute In Sitapur

SITAPUR: A couple was killed after allegedly being attacked with iron rods and sticks by their neighbours in Uttar Pradesh's Sitapur district, police said on Saturday.

The deceased has been identified as Abbas and his wife as Kamrul Nisha, they said.

According to officials, the incident took place in Rajeypur village under the Hargaon PS limits on Friday. Upon receiving the information, senior police officials reached the spot and started the investigation.

Officials said that the bodies have been sent for post-mortem examination, and a probe into the matter has been initiated.

"The couple died on the spot in the attack and all the accused fled," Sitapur Superintendent of Police (SP), Chakresh Mishra, said.

SP Mishra informed that a few years back Abbas's son had eloped with a girl from their neighbour's family and a dispute on the same triggered the incident on Friday.

"A case was registered in this and Abbas's son was sent to jail. When Abbas's son was released from jail a few days back, there was again a dispute between the families," he said.

"A case under relevant sections has been registered, and a hunt has been launched to identify and nab the accused persons," SP Mishra added.

Indian-Origin Lab Owner Sentenced To 27 Years In Prison For \$463 Million Genetic Testing Scam In Us

HOUSTON: An Indian-origin laboratory owner from the US state of Georgia was sentenced to 27 years in prison for his involvement in a USD 463 million genetic testing scam spanning over three years to defraud Medicare

Minal Patel, who owned LabSolutions LLC, was sentenced on Friday to 27 years in prison for his role in the scheme to defraud Medicare by submitting over USD 463 million in genetic and other laboratory tests that patients did not need and were procured through the payment of kickbacks and bribes

of kickbacks and bribes.

The 44-year-old conspired with patient brokers, telemedicine companies and call centres to target Medicare beneficiaries with telemarketing calls falsely stating that their package covered expensive cancer genetic tests, the Department of Justice said on Friday.

After the Medicare beneficiaries agreed to take tests, Patel paid kickbacks




and bribes to patient brokers to obtain signed doctors' orders authorising the tests from telemedicine companies, the department said in a press release.

To conceal the kickbacks, Patel required the patient brokers to sign contracts that falsely stated that they were performing legitimate advertising services for LabSolutions.

From July 2016 through August 2019, LabSolutions submitted more than USD 463 million in claims to Medicare, including for thousands of medically unnecessary genetic tests, of which the national health insurance programme paid over USD 187 million.

In that timeframe, Patel personally received over USD 21 million from Medicare in



genetic testing and telemedicine services to patients who need them," said Special Agent in Charge Jeffrey B. Veltri of the FBI Miami Field Office. "Patel bilked hundreds of millions of dollars from Medicare through a com-

plex testing fraud

He is now paying the price for this crime," he said. The case was brought as part of Operation Double Helix, a federal law enforcement action led by the Health Care Fraud Strike

Force under the supervision

of the Criminal Division's Fraud Section.

It focused on fraudulent genetic cancer testing, resulting in charges against dozens of defendants associated with telemedicine companies and cancer genetic testing laboratories for their alleged participation in one of the largest

healthcare fraud schemes

Bukhari condemned the arrest on the social media platform X, formerly known as Twitter, saying he was "arrested for doing a press con-



stance against all tyranny and pre poll rigging that is going on currently in Pakistan."

PTI party chairman Imran Khan is currently jailed for three years after being convicted on graft charges and is barred from contesting any election for five years. He denies any wrongdoing. Khan won the last election in 2018 and became prime minister

until he was ousted in a noconfidence vote in 2022.

The election is meant to be held within 90 days of parliament being dissolved last week, by November, but uncertainty looms over the date as the nation grapples with constitutional, political and economic crises.

The outgoing government approved a new census in its final days, meaning new electoral boundaries must be drawn up by the Election Commission.

The exercise of drawing fresh boundaries for hundreds of federal and provincial constituencies in a country of 241 million people may take six months or more, according to a former commission official.

No More Use Of Word Crime, While Dealing With Child: CJ

Says There Is Paradigm Shift While Dealing With The Children In Conflict With Law

SRINAGAR: The Chief Justice N. Kotiswar Singh inaugurated one day Annual Stakeholders Consultation on Children in Conflict with Law here at Tagore Hall in presence of Justice Tashi Rabstan; Justice Sindhu Sharma; Justice Puneet Gupta; Justice Javed Iqbal Wani; Justice Mohd. Akram Chowdhary and Justice Rajesh Sekhri. The Consultation meet was organized by the Juvenile Justice Committee, High Court of Jammu & Kashmir and Ladakh under the aegis of Child Welfare Committee, Supreme Court of India in association with the Social Welfare Department, UT of Jammu and Kashmir, and Social and Tribal Welfare Department, UT of Ladakh.

The Chief Justice in his inaugural address while stressing upon the theme of this year's meet traced the history of law relating to Child Rights and said that earlier the focus was on the victim of the offence and now there is paradigm shift towards the welfare of Child in Conflict with Law. The Chief Justice underlined that collaboration of stakeholders is needed to restore such children back into the system. Recalling the recent visits to Child Care Institutions at Nishat, Srinagar and Khansahib, Budgam, the Chief Justice appreciated the efforts of Social Welfare Department in creating and maintaining suitable infrastructure at both the places.

Highlighting the circumstances leading the child onto the wrong side of law Justice Tashi in his special address appealed to one and all to prioritize prevention over punishment. He called upon the stakeholders to extend empathy and unwavering commitment towards the wellbeing of children in conflict with law. The consultation unfolded across

a series of meticulously curated technical sessions that illuminated the multifaceted aspects of child protection. In the first technical session Ms. Sonali Kumari, Assistant Director, NIPCCD, Regional Centre, Mohali was the resource person, who deliberated upon the topic "Prevention and Early Intervention". In her Powerpoint presentation, she delved into detailed strategies that could pre-empt adversities, emphasizing the pivotal role of proactive measures. She was also the resource person for the fourth technical session in which continuing her presentation she explained in detail the rehabilitation mechanisms and the potential of restorative practices in rebuilding young lives. Both the abovesaid sessions were interactive and the participants also threw volley of questions to the resource person for clarification.

The 2nd and 3rd technical Sessions were on the topics "Diversion, Alternatives to Detention, and Noncustodial Alternatives" and "Right to Fair Trial and Child-Friendly Procedures" in which resource persons were Justice (Rtd.) B.A. Kirmani and Justice (Retd.) M.H. Attar. In his discourse. Justice B.A. Kirmani while referring to the report of Crime Record Bureaupublished for the year 2020-2021 highlighted that the popular notion about the Child in Conflict with law belonging to poor and marginalized section of the society, is misconceived as the figures for the State of MP and Maharashtra reveal otherwise. Justice M.H. Attar underscored the significance of child-friendly legal processes and a just trial system in nurturing a sense of justice in young minds.

In the last Technical session, the resource person, Owais Wani, DySP (HQ), Srinagar deliberated upon the topic "Minimum Age of Criminal Responsibility and Age of Criminal Majority (Preliminary Assessment)". He gave historical perspective regarding fixing of age of criminality in various jurisdictions and referred to various constitutional provisions as well as reasons for fixing the age of criminality at 18 years. He also presented the critical analysis of various provisions of Juvenile Justice (Care and Protection) Act 2015.

In his welcome address, Amit Kumar Gupta, Member Secretary, Juvenile Justice Committee gave an overview of the programme and said that this UT level Consultation is being organized by the JJ Committee in order to have deliberations by engaging experts, representatives of different organizations and frontline workers working with the children in conflict with law to take stock of the work done so far and for the identification of measurable concreate priority actions. On the occasion, vote of thanks was proposed by Ms. Harvinder Kour, Mission Director, Mission Vatsalya, J&K.

The inaugural session was physically attended by D.C Raina, Advocate General, Shahzad Azeem, Registrar General, MK Sharma, Principal Secretary to Chief Justice, Registry Officers and Officers from Civil and Police Administration. Besides this, Sheetal Nanda, Commissioner Secretary, Social Welfare Department, UT of J&K, Padma Angmo, Commissioner Secretary, Social and Tribal Welfare Department, UT of Ladakh, Spalzes Angmo, Member Secretary, Ladakh Legal Services Authority ioined the consultation virtually

Not only is the writer benefitted by the catharsis which the very act of writing brings with it, but the same aura of purgation and ecstasy dawns upon the reader who takes upon himself the task of reading – in other words participating in the poetic mystique of joy and wonder

hen Sheikh-ul-Aalam, Sheikh Noor Ud Din spearheaded an era of religious consciousness and social revolution via his poetry, he spoke for the marginal, the left-out, the neglected and the voiceless. No different for Lal Ded, who, in her pithy poetic compositions called Vakhs disarmed the then prevalent religious tyranny and spoke of eclecticism and equity which has ever since been the hallmark of Kashmiri Mystical Poetry.

Soothing the commoners of the burnouts of life and reassuring the helpless and oppressed of the universal call to truth and Justice, Kashmiri sufi poetry has continued to inspire generations and has been true to its calling. But it is not the poetry of the less privileged, the poetry to taste whose fruits you need to be poor – it has a lot to offer to the apparently affluent but spiritually poor. Sufi poetry has not only vouchsafed for social change, it has, more importantly addressed man in his loneliness, his mental unrest and the undying spiritual quest. Reading Kashmiri Mystical poetry, one is reassured that he is not sailing alone in the tumultuous waves of life, there are others besides him and more importantly, there is the master sailor who shall help us sail through.

People have known well that these assurances, as they emerge in mystical poetry, are no hollow parts or placebo effects, but something emerging from the deepest experiences of life and its profoundest caress across the human soul. This understanding not only helped readers to repose their trust on what they were reading, but to pragmatise these teachings in their lives and create a bulwark against the vicissitudes of life. But in our times, our indifference to and alienation from our rich literary tradition which has therapeutic and spiritual value and offers deep insights into some of the pressing issues of our life has deprived us of the rich and diverse source of wisdom and consolation.

Mystical poets created spaces of inclusion not only by virtue of their poetic structures appealing to men and women alike, but in the enactment of these compositions, which collated the entire society together by the force of universal brotherhood, love, amity and mutual respect. The message enshrined in these verses still possesses the power to undo the difference of caste, creed, gender and ideology which have torn our world and our own selves like a piece of paper. In a situation like this, mystical poetry emerges as the necessary first aid and remedial measure which can be of immense importance to restore the broken unity and heal the cleavage created by superficial differences in the human realm. No wonder that the musical fests held across the shrines of sufi saints even today pull together thousands of devotees from across the geographic divide and each individual benefits ac-

cording to his receptivity and understanding – but the very phenomenon of people coming together is phenomenal and is testimony to the perennial healing and uniting power of mystical poetry.

We have evidence, both by way of folklore and living testimonies, that sufi spaces have peculiar healing powers particularly in context of mental health disorders (). When a devotee recites/reads the poetry of these great mystics, he/she feels in direct communion and communication with the spirit of the mystic who offers panacea to his/her ailments by way of his insights and inspirations couched in the verbiage of poetry.

The attendance to mystical poetry has a special reference to and importance in Kashmir – a place torn apart by violence, victimhood, poverty and issues of hundred thousand faces. The therapeutic nature of poetry and literature has been known to people since times immemorial. Not only is the writer benefitted by the catharsis which the very act of writing brings with it, but the same aura of purgation and ecstasy dawns upon the reader who takes upon himself the task of reading – in other words participating in the poetic mystique of joy and wonder. Poetry, mystical poetry in this case, shall not however be seen as an escape and fleeing away

from the harsh and hard realities of life. It rather strengthens individual will to accept and helps us to recognise the fact that life is larger than the individual and enables us to stand open to the unforeseeable, unpredictable and unexpected in life.

This expectation of the unexpected may not avert the unexpected but acts as a shocker mechanism and cushions our life in the face of unforeseeable and the un-programmable. This element of unexpectedness is of heightened importance at a place like Kashmir which always stands in the midst of uncertainties of one sort or the other. The reign of hatred, difference and animosity from social media posts to neighbourhood to international affairs is not lost on anyone. Is it not thus needed to place our ears close to the mystical call of unity against all agents of dissipating diversity, a call that has exercised healing power across ages and continues to exercise the same.

The Electoral Math Of INDIA vs NDA

he contest for 2024 is heating up as the Congress and the BJP both finalising their alliances. A 26-party consortium named "INDIA" is set to compete with a 38-party NDA, offering voters an option they didn't have in 2019. The presence of the Congress in "INDIA" lends stability to the opposition alliance, and the reassures voters that, given a chance, they can complete a full five-year term.

What Does The Math Look Like?

The UPA, in its earlier avatar in 2019, bagged 91 seats with a 27% vote share. The rebranded INDIA has 144 MPs in the 545-member Lok Sabha with a 37.5% vote share. On the other hand, the NDA won 353 seats with a 45% vote share. Changes like the exit of the Janata Dal (United) and Uddhav Thackeray's Shiv Sena, and the entry of Ajit Pawar's NCP faction, bring down that tally to 332 seats with a 42.9% vote share. The mammoth 18% lead enjoyed by the NDA shrinks

Category of Contests in 2024

There are four categories of contests likely in 2024, based on the 2019 numbers. In 375 seats, the BJP is likely to be in contention, while the Congress will be in the game in 261 seats. Regional parties, whether in the INDIA alliance or the NDA, are likely to be in contention in 353 seats. Category 1 (BJP vs Congress)

The BJP and Congress locked horns in 190 seats in 2019. The BJP won 175 while the Congress, 17. The BJP recorded a lead of more than 20% in terms of vote share in these seats. The party that ranked 3rd won, on average, just a 4% vote share, implying these were mainly BJP versus Congress contests with limited role of regional parties in states like Madhya Pradesh, Chhattisgarh, Rajasthan, Gujarat, Uttarakhand, Himachal Pradesh, Delhi, Goa, Karnataka, Assam, Haryana, and parts of Maharashtra.

The Congress party's alliances are unlikely to bear fruits there and it is largely on its own. Its allies in INDIA, like the Samajwadi Party, Trinamool Congress, and the Left parties have limited presence there. However, the third ranked party secured more votes than the margin of victory in 19 seats, and 13 were won by the BJP.

Category 2 (BJP vs Regional Parties)

The BJP and regional parties contested on 185 seats in 2019, the BJP won 128 while regional parties 57. The BJP had a lead of 7% in vote share terms on these seats. The party that ranked 3rd won a similar vote share, indicating

ited benefit of alliances, or they are already in place, or they are difficult to forge. The third ranked party secured more votes than the margin of victory in 32 seats, and 21 of them were won by the Congress.

Category 4 (Regional vs Regional)

Regional parties contested against each other in 97 seats in 2019. In 59 of them, it was a UPA versus NDA contest. The difference in vote shares between the winner and runner-up was 15%, with the third party securing just 7% vote share. The Congress and the BJP were third on only nine and five seats respectively and had a meagre 0.3% vote share each.

that alliances could be a game changer there, mainly in Uttar Pradesh, West Bengal, Odisha, parts of Bihar and Maharashtra.

The Congress party was ranked 3rd on 88 seats here. The number three party secured more votes than the margin of victory in 55 seats, and 30 of them were won by the BJP.

Category 3 (Congress vs Regional Parties)

The Congress and regional parties contested 71 seats in 2019. The Congress won 37 while regional parties 34. In terms of vote share, it was neck-and-neck with both securing 41% each. The party ranked third recorded an almost 12% vote share, spoiling the chances of the runner-up.

In these states like Telangana, Punjab, parts of Tamil Nadu, Kerala, Bihar etc. there is lim-

Alliances are already set here like Bihar, Maharashtra, Tamil Nadu, but changes in dynamics play a role here as some allies have crisscrossed like JD(U), Sena and NCP. The third-ranked party secured more votes than the margin of victory in 24 seats.

Including the Category 1 and 2 seats where the BJP won 303, it is likely to be a close fight in 43 of these seats, where the BJP placed third and spoiled the chances of the Congress (13) and regional parties (30). These seats could swing in favour of the INDIA alliance. On the other hand, Prime Minister Narendra Modi has set a target of 50% plus for the NDA in the 2024 elections.

While some could brush it off, the BJP's vote share is set to increase as the party will be contesting more seats in Bihar, Maharashtra and Punjab, where allies have walked out. The target shouldn't be taken lightly by the INDIA alliance parties as the BJP achieved a similar feat in Gujarat 2022, when political pundits thought it had peaked. In Bihar alone it can gain a 1-1.5% vote share. As the BJP knows its opponents 10 months in advance, it has a lot of time to prepare and strategise to neutralise impact of opposition parties coming together.

Scenario Analysis

The BJP starts with a base of 303 seats. If there is a 5 per cent swing against the BJP on the seats it won in 2019, (implying the BJP's vote share declines by 5% and runner-up's vote share increases by 5%), the BJP's tally could decline by 80 seats, to 223. The swing could be due to local level anti-incumbency, the increase in popularity of the INDIA alliance, an inactive BJP cadre over-dependent on Modi, the Congress party's five promises gaining traction etc. To note, as per polls conducted post Karnataka results, including by CSDS, Prime Minister Modi's popularity and NDA's vote share remains intact.

On the other hand, if there is a 5% swing in favour of the BJP on the seats where it finished as a runner up in 2019, (implying the BJP's vote share increases by 5% and the winner's vote share declines by 5%), the BJP's tally could improve by 39 seats to 342. The swing could be due to a range of factors including pro-incumbency, the increase in popularity of Prime Minister Modi and the NDA, new schemes to tackle issues like inflation, unemployment, corruption, and differences within the INDIA alliance.

In effect, the BJP's range seems to be 223 seats (lower end) to 342 seats (upper end) depending upon how things shape up in the next 10 months and who seizes the narrative.

Zindagi Tamasha A Bold Statement on the Sensitive in Pakistan

A Cinematic Masterpiece Exposing Societal Hypocrisy In Pakistan Leaving Audience Think In Silence

Filmmaker Sarmad Sultan Khoosat's movie Zindagi Tamasha (premiered 2019, available on Youtube 2023) which was pakistan's official entry for the International feature film at the academy awards, couldn't see the light of the day in theatres for years across pakistan owing to outrage by religious organisations. After years of release hiccups, Sarmad Sultan Khosat has finally released the movie on youtube.

Rahat Khaja, a devout Naat reciter (a minstrel singing hymns for the praise of Prophet PBUH) played by protagonist Arif Hassan as in the movie is respected and revered among his relations and in his neighbourhood due to his pious work. He is an adherent of Islamic values and customs and is a simple man who besides being a reciter is also fond of music and dance.

One night at a marriage ceremony, he dances to the tunes of a classical song 'Zindagi Tamasha Bani' and the blow of life hits him and his family forever. The society that would cherish and look up to him as a pious man, suddenly dismisses him for an act that they deem is prohibited especially for a religious person like him.

Before he can register it, Rahat Khaja becomes an outcast. He is reproved by one-and-all; the young, the middle-aged as well as the older generation. His food offerings are not accepted by the neighbourhood and his relatives also join-in on the ostracisation and stop inviting him to family events like weddings.

The story makes a subtle but poignant statement to illustrate the cultural orthodoxy and religious conservatism which is hand-in-glove in the alienation of a family from the society.

Zindagi Tamasha does not stop here and goes on to make statements about blasphemy laws and its misuse in Pakistan. For instance, for a respectable reintegration intp the society, Rahat Khaja seeks validation from the clergy who hold a considerable authority across his locality. However, Khaja finds no luck with clergy either. This leads to his further estrangement with the mosque and its puritans.

The movie, by making an array into such sensitive areas attempts to make bold comments about the clergy's authoritative and unaccountable control over one's choices and personal freedoms, due to which an innocent man is left to suffer at the hands of their biases to the point of self-destruction.

In a spine-chilling scene, the protagonist is bullied into leaving a function hall and threatened with allegations of blasphemy lest he doesn't. Through such scenes, the film attempts to make bold and telling statements about the misuse of blasphemy laws across Paki-




The movie also tries to touch on the menace of viral videos where an inno-

cent gullible person's life is destroyed within seconds by virtual verdicts issued over social media. Khaja had danced his heart out not knowing that a camera is capturing or recording him, only to find out his life and reputation







had been torn down completely and a certificate had been issued which had exiled him out of the favours of the society forever.

Through his movie, filmmaker Sarmad Khoosat has also highlighted the challenges faced by transgender communities and how persons sympathetic to them are besmirched.

The feeling of proximity that a viewer feels and its telling impact on the audience owes itself to the film's realism. The movie depicts real life challenges faced by a middle class family. The food, cooking, rooms, walking, buying and selling of groceries, long walks, despair sittings on roads make the entire movie watching experience authentic and makes it easy to be empathetic towards the family.

The movie lends itself to no sensationalism. The silence, the gaps-and-silences, as well as the pauses in the conversations, especially between daughters and fathers make the audience think.

Some may be averse to the pace of the movie which should be excused as the film deals with a serious issue.

Zindagi Tamasha pushes the audience to unlearn and introspect over established cultural and religious norms. Perhaps, this is the story of modern day South Asia where puritans decide what's right and what's wrong. After the movie Bol, this is Pakistan's fresh attempt to open the envelope in the form of cinema against religious fundamentalism and extremism. Sadly, they did obstruct its theatre release. However, the film is on YouTube worldwide for billions to watch and celebrate.

Weight Loss: Drinking A Gallon Of Water A Day Probably Won't Help You Lose Weight

"t's often claimed that if you're trying to lose weight, one of the things you should do each day is drink plenty of water – with some internet advice even suggesting this should be as much as a gallon (about 4.5 litres).

The claim is that water helps burn calories and reduce appetite, which in turn leads to weight loss.

But while we all might wish it was this easy to lose weight, unfortunately there's little evidence to back up these claims.

Myth 1: water helps burn calories One small study, of 14 young adults, found drinking 500ml of water increased resting energy expenditure (the amount of calories our body burns before exercise) by about 24

While this may sound great, this effect only lasted an hour. And this wouldn't translate to a big difference at all. For an

average 70 kg adult, they would only use an additional 20 calories - a quarter of a biscuit – for every 500ml of water they drank.

Get facts about the coronavirus pandemic and the latest research Another study of eight young adults only saw an increase in energy expenditure when the water was fridge cold - reporting a very modest 4 per cent increase in calories burned.

This may be because the body needs to use more energy in order to bring the water up to body temperature, or because it requires more energy for the body to filter the increased volume of fluid through the kidneys. And again, this effect was only seen for about an hour.

So although scientifically it might be possible, the actual net increase in calories burned is tiny. For example, even if you drank an extra 1.5l of water per day, it would save fewer calories than you'd get in a slice of bread.

It's also worth noting that all this research was in young healthy adults. More research is needed to see whether this effect is also seen in other groups (such as middleaged and older adults).

Myth 2: water with meals reduces appetite This claim again seems sensible, in that if your stomach is at least partly full of water there's less room for food - so you end up eating less.

A number of studies actually support this, particularly those conducted in middle-aged and older adults. It's also a reason people who are unwell or have a poor appetite are advised not to drink before eating as it may lead to under-eating.

But for people looking to lose weight, the science is a little less straightforward.

One study showed middle-aged and older adults lost 2 kg over a 12-week period when they drank water before meals compared with people who didn't drink any water with their meal.

Younger participants (aged 21-35) on the other hand did not lose any weight, regardless of whether they drank water before their meal or not.

But since the study didn't use blinding (where information which may influence participants is withheld until after the experiment is finished), it means that participants may have become aware of why they were drinking water before their meal.

This may have led some participants to purposefully change how much they ate in the hopes it might increase their changes of losing weight.

However, this doesn't explain why the effect wasn't seen in young adults, so it will be important for future studies to investigate why this is.

The other challenge with a lot of this kind of research is that it only focuses on whether participants eat less during just one of their day's meals after drinking water.

Although this might suggest the potential to lose weight, there's very little good-quality evidence showing that reducing appetite in general leads to weight loss over time.

Perhaps this is due to our body's biological drive to maintain its size. It's for this reason that no claims can be legally made in Europe about foods which help make you feel fuller for longer with reference to weight loss.

So, although there might be some appetite-dulling effects of water, it seems that it might not result in long-term weight change - and may possibly be due to making conscious changes to your diet.

Revised I-T Rules Offer Tax Relief To Employees With Rent-Free Accommodation

NEW DELHI: Employees drawing substantial salaries and having rent-free accommodation provided by their employers will now be able to save more and get a higher take-home salary as the income tax department has revised norms for valuing such

The Central Board of Direct Taxes (CBDT) has notified amendments to the Income Tax Rules which will come into effect from September 1.

As per the notification, where unfurnished accommodation is provided to employees other than the central or state government employees and such accommodation is owned by the employer then the valuation shall be: (i) 10 per cent of salary (reduced from 15 per cent) in cities having population exceeding 40 lakh as per 2011 census (earlier, 25 lakh as per 2001 census), (ii) 7.5 per cent of salary (reduced from 10 per cent) in cities having population exceeding 15 lakh but not exceeding 40 lakh as per 2011 census (earlier, 10 lakhs but not exceeding 25 lakhs as per 2001 census).

AKM Global Tax Partner Amit Maheshwari said employees who are drawing substantial salaries and re-



ceiving accommodation from the employer will be able to save more since their taxable base is going to be reduced now with the revised rates. "The perquisite value shall be lower resulting in relief to them in the form of takehome pay.

AMRG & Associates CEO Gaurav Mohan said these provisions incorporate the insights 2011 census data and aim to rationalise the perquisite value calculation.

"Employees enjoying rentfree accommodation would see rationalisation of perquisite value leading to a reduction in taxable salary, increasing the net take-home pay. It is worth noting that the reduction in the perquisite value of rent-free accommodations will yield dual implications: on the one hand, it will generate tangible savings for employees, while on the other hand, it will result in a corresponding decrease in government revenue," Mohan

He further said this change will lead to disproportionate benefits for higher-income employees who receive expensive accommodations. Lower-income employees with more modest accommodations might not experience significant tax relief.

Moreover, this shift might prompt corporate employers to strategically revisit and potentially reshape their existing compensation frameworks, particularly if they can capitalize on tax advantages for their workforce, Mohan

Govt Imposes 40% Export Duty On Onion To Increase Local Supply, Check Price Rise

NEW DELHI: The government on Saturday imposed a 40 per cent duty on the export of onions to increase domestic availability amid signs of increasing prices.

The export duty, which is the first time ever on onion, has been imposed as the retail sale price of the kitchen staple, according to government data, touched Rs 37/kg on Saturday in Delhi.

Ministry Finance through a Customs notification imposed a 40 per cent export duty on onions till December 31, 2023.

Between April 1 and August 4 this fiscal, 9.75 lakh tonne of onions have been exported from the country. The top three importing countries in value terms are Bangladesh, Malaysia and the UAE.

Consumer Affairs Secretary Rohit Kumar Singh said in order to increase the availability of onions in the domestic market especially in view of the upcoming festival season, the government has decided to impose a 40 per cent duty on the export of onions.

"It was also being noticed that there was a sharp rise in exports in the recent past," Singh said.

The government had always used a minimum export price tool to curb onion exports. However, for the first time this year, export duty has been slapped for effective control of the outward shipment.

As per the data maintained by the consumer affairs ministry, the all-India average retail

price of onion was ruling at Rs 30.72 per kg on Saturday, with a maximum price at Rs 63 per kg and a minimum at Rs 10 per kg.

In Delhi, onion was ruling at Rs 37 per kg on Saturday, as per the data. The trade data showed onion prices ruling at Rs 50 per kg in the national

Onion prices have started inching up amid reports of lag in onion coverage in the ongoing kharif season.

According to the wholesale price index (WPI) data for July, onion inflation spiralled to 7.13 per cent, against (-)4.31 per cent in June.

The annual retail or consumer price inflation has touched a 15-month high of 7.44 per cent in July, against 4.87 per cent in June, amid a sharp spike in food prices.

The government has maintained 3 lakh tonnes of buffer onion this year. It has started disposing of it in the wholesale market since last week in key locations.

So far, 2,000 tonnes of buffer onion has been sold in wholesale mandis of Delhi, Assam, Himachal Pradesh, Telangana and Andhra Pradesh, the Secretary said.

The buffer onion is usually used for market intervention during the lean period between August and September till the arrival of the fresh crop from October onwards.

Onion is a politically-sensitive commodity. The restriction comes ahead of assembly elections in key states like Madhya Pradesh, Chhattisgarh, and Telangana due at year-end.

Distressed Family Waits For PMAY To Rebuild Earthquake-Damaged Mud House In Doda

Bhaderwah/Jammu: With winter just round the corner, the family of Vijay Kumar in Jammu and Kashmir's Doda district is eyeing the centrally-sponsored Pradhan Mantri Awas Yojana (PMAY) scheme to rebuild their earthquake-damaged

The house in remote Lamote village under Kursari Panchayat collapsed on August 8 due to the earthquake in Bhaderwah valley, virtually leaving Kumar's seven-month pregnant wife Nishu Devi (29) and her physically handicapped brother-inlaw and sister-in-law under the

Kumar is working as a driver and mostly stays outside the hometown searching for avenues to earn a living for the

"We had applied for the PMAY scheme to build a concrete house two years back. Despite submitting all the required formalities to get financial assistance, our pleas went unanswered till date," Devi, who is putting up in a damaged portion of the house, told PTI.

Holding the district administration responsible for their plight by not sanctioning a



house under PMAY in time, she said they are highly concerned about their safety in view of the approaching winter.

"How am I going to manage the situation with two handicapped members and my first child in the coming months, especially during harsh winter conditions is troubling me a lot. I want to appeal to the government to help me overcome this situation," she said.

She said all her efforts to provide a pucca roof for the family went in vain as despite knocking all the doors from Panchayati Raj Institution (PRI) members to political representatives and government officers

"If something untoward happens to any of my family members, the concerned authorities are to be blamed," Devi said. Additional

Deputy Commissioner Bhaderwah Dilmir Chowdhary said against a target of 1,523 beneficiaries spread over 30 panchayats of Bhaderwah block for the financial year 2022-23, as many as 1,118 cases were taken up under the PMAY but 209 among these were found bogus and were subsequently the cases were rejected.

beneficiaries also Many claimed that while they have received the first instalment of the money under PMAY, the

Located some 11 km from Bhaderwah town, one has to walk three kilometres uphill to reach Lamote village from the motorable road.

Sushma Devi (43) and her younger brother Naresh Kumar (35), both physically handicapped, had a narrow escape when their house collapsed.

"When the earth started shaking, I was sleeping and suddenly mud from the wall and roof fell on me. I could not run and thought that we would get buried under the debris but Nishu Devi dragged me out of the house. We had a narrow escape as within a few minutes, our house came down crumbling," Kumar said, expressing hope that the authorities will have some pity on the family and sanction the scheme in their favour.

Devi's neighbours also vouched for the poor family and questioned the delay in providing financial help under the PMAY scheme to them.

"The family with two handicapped members is living in complete distress. Didi (Nishu), despite being pregnant, is managing the family in trying circumstances. But it is scary to imagine what will happen to them when harsh winter sets in," Ranu Devi, who resides nearby in the village, said.

Devi maintained that after completing all the required formalities, she handed over the file to the local sarpanch but failed to find her name in the list of beneficiaries.

However, Sarpanch Kursari Panchayat, Sajid Mir said there is no denying that Devi's family is most deserving in the entire Panchayat but "unfortunately, none of the family members were present in the home during the survey of PMAY scheme.

'This was the main reason for the poor family remaining left out. We have prepared her file again and requested the concerned authorities to treat the case on priority for urgent assistance on humanitarian grounds," Mir said.

ADC Chowdhary admitted that the family is living in a miserable condition and their case is genuine.

"To rectify the mistake, we are trying to provide financial assistance to the family under PMAY from the savings of the centrally sponsored scheme as some sanctioned houses have been cancelled because the beneficiaries do not fall in the required category of the

HP rain fury: Death toll over past week climbs to 78; more rains forecast

Shimla: The death toll in rain-related incidents in Himachal Pradesh over the past week rose to 78 on Saturday with the recovery of another body from the debris of a collapsed temple here, officials said as the local MeT sounded an orange alert for the next two days.

The deceased has been identified as Eish Sharma (28). The body of his father P L Sharma, who was the chairman of the mathematics department at Himachal Pradesh University, was recovered on Thursday, the officials added.

Of the 78 deaths since Sunday night, 24 were in the three major landslides in Shimla alone -- 17 at the Shiv temple in Summer Hill, 5 in Fagli, and 2 in Krishnanagar, Superintendent, Shimla, Sanjeev Kumar Gandhi told PTI on Saturday. Joint operations of the Army,

National and State Disaster Response Force, Police and Home Guards are underway to retrieve the bodies from the landslide rubble and at least three persons are still feared buried under the temple debris, the

Drones are being used for identification of high-risk zones and monitoring of sliding sites in the state capital, he added.

Since the onset of the monsoon in Himachal Pradesh on June 24, 338 people have died in rain-related incidents and road accidents in the state while 38 people are missing, according to the state emergency operation centre.

Of the 338 deaths, 221 people have died in rain-related incidents in Himachal Pradesh, it said.

The emergency centre said that about 11,900 houses got partially or completely damaged, around 560 roads are still closed in the state and 253 transformers and 107 water supply schemes have been disrupted.

While assessing the damage in flood-affected areas of Indora and Fatehpur assembly constituencies in Kangra district, Deputy Chief Minister Mukesh Agnihotri, however, said Himachal Pradesh has suffered a loss of over Rs 10,000 crore, with 350 lives lost and 50 people still missing.

The local MeT office Saturday sounded an orange warning of heavy to very heavy rains on August 20 and 21 and a yellow alert of heavy rains on August 22 and 23. It also cautioned of moderate to high risk of flash floods in Shimla, Sirmaur and Chamba districts.

Heavy rains can result in landslides, flash floods and an increase in water level in rivers and drains besides causing damage to the standing crops, fruit plants and young seedlings, the MeT warned.

A red alert is a warning for extremely bad weather conditions that are certainly going to disrupt travel and power and pose a significant risk to life. An orange warning indicates extremely bad weather with the potential of disruption in commute with road and drain closures and interruption of power supply.

On Friday, the Himachal Pradesh government declared the state a "Natural Calamity Affected Area" in view of the damage caused by heavy rains leading to the loss of human life and extensive damage to

The state government has urged

the Centre to declare the tragedy a national disaster, Agnihotri said and added that the recent natural calamity in the state is the most devastating in the past 50 years.

The deputy chief minister said that according to initial estimates, the Jal Shakti Department has incurred a loss of more than Rs 2,000

Agnihotri said that the people of Indora and Fatehpur, particularly in the Mand area, of Kangra district have been severely affected by rising water levels of the Beas river. He said that 27 panchayats in the

Indora and Fatehpur have been impacted, with 22 panchayats suffering the most damage, due to flooding in the downstream area of the Pong reservoir.

The deputy chief minister said that according to initial estimates, the Public Works Department has incurred a loss of Rs 54 crore, the Jal Shakti Department Rs 31 crore, and the Electricity Department Rs 4 crore in these areas.

He also pointed out that illegal mining has emerged as a major cause behind the devastating floods in Indora and Fatehpur. This unlawful activity has led to

the deterioration of river banks, diverting water flow towards villages and fields in the region, he added. In order to prevent such incidents

in the future, the issue of phased channelisation of the Beas River has been raised with the Centre, and will be pursued further, Agnihotri said.

He said departments such as the public works, electricity and Jal Shakti have been directed to expedite works in the affected areas.

CAG Picks Holes criteria of the Socio- Economic Caste Census performance of various activities.

The aim is to improve affordability, accessibility, and quality of care for the poor and vulnerable section of the population.

The scheme has been launched for achieving a significant reduction in out-of-pocket expenditure due to health care costs and achieving reduction in proportion of households experiencing catastrophic health expenditures and consequent impoverishment. The eligible beneficiaries are entitled under AB-PMJAY for cashless and paperless access to services at the

empanelled hospitals. The report of the CAG contains results of the Performance Audit on AB-PMJAY covering the period September 2018 to March 2021.

Audit noted that the PMJAY Scheme, an ambitious and well-intentioned programme to provide healthcare access to most vulnerable sections in the country, has had a strong positive impact on the economically weaker sections of the society who need healthcare facilities. However, the implementation of the scheme needs improvement in the light of the findings made in the report.

"It is expected that the compliance to the observations and recommendations made in this report will help in improving the implementation of the scheme," it noted.

According to the report, in Jammu & Kashmir and Ladakh, during the period 2018 to 2021, 16865 and 335 numbers of ineligible beneficiaries respectively were identified by SHA (state health authority) after clearing the SECC data, thus indicating the existence of ineligible beneficiaries in the SECC database.

The report revealed that 15 hospitals were empanelled with delay. The CAG report further stated that in Jammu and Kashmir, 4, 97,358 cases were rejected and the maximum delay in days was 404.

The report further reveals that Rs 10.96 lakh were disbursed for the treatment of 48 patients who had previously been declared deceased in the scheme's database in Jammu and Kashmir.

Under the CAG's performance audit, it was found that In Jammu and Kashmir, (459) beneficiaries were charged for their treatment in empanelled Health Care Providers (EHCPs) resulting in an increase in out-of-pocket expenditure of beneficiaries.

Data analysis revealed that SHAs of Jammu & Kashmir and Ladakh failed to levy penalties amounting to Rs 20.93 crore and Rs 39.66 lakh respectively on Insurer for non-performance of various activities.

LIVERPOOL: Liverpool overcame an early deficit and a disputed red card to beat Bournemouth 3-1 at Anfield in the English Premier League on Saturday for its first win of the season. Bournemouth stunned the host by taking the lead through Antoine Semenyo in just the third minute after Liverpool turned the ball over cheaply deep inside its own half. But Luis Diaz equalized with an acrobatic volley in the 28th and

Liverpool was awarded a penalty when Joe Rothwell made light contact with Dominik Szoboszlai just inside the area, and the midfielder fell theatrically to the ground.

Mohamed Salah's spot kick was saved by Bournemouth goalkeeper Neto, but the Egypt striker slotted in the rebound to put Liverpool ahead.

Alexis Mac Allister was then shown a straight red card in the 58th for kicking Ryan Christie's leg after a mistimed challenge for the ball, giving Bournemouth hopes of a comeback. But going a man down seemed to only galvanize Liverpool, and Diogo Jota was on hand to turn in the rebound after Szoboszlai's deflected shot was palmed away by Neto in the 62nd.

After opening the season with a 1-1 draw at Chelsea last weekend, Liverpool has four points from its opening two games, while Bournemouth has one point. Salah's goal put him past Steven Gerrard into fifth place among Liverpool's all-time leading scorers, with 187.

Clash Of Styles As England, Spain Eye Women's World Cup

SYDNEY: Women's football will crown a first-time champion on Sunday when the ninth Women's World Cup concludes with England and Spain, both proud footballing nations, facing off in an intriguing final in Sydney.

The highly-successful tournament in Australia and New Zealand was destined to have a fresh winner from the quarter-finals when Japan joined the United States, Germany and Norway in making a premature exit. For all the excitement that accompanied Australia's run to the semifinals and Japan's brilliance in the early rounds, the consensus is that England and Spain are worthy first-time finalists.

"I think it's going to be a brilliant game," England captain Millie Bright enthused on Saturday.

"Two top teams coming head-to-head. And ultimately the game is about getting the ball in the back of the net and executing the game plan. So find a way to win "

The tournament has showcased the development of the women's game but the finalists do present a contrast in styles -- England pragmatic, ruthless, resilient and Spain displaying all the technical skill the country's football is famed for. both have grown into the tournament and were convincing semi-final winners.

The finalists have had their blips -- Spain thrashed 4-0 by Japan in their last group game and England taken to penalties by Nigeria in the last 16 -- but might not be too wide of the mark if England's 2-1 win in the European Championship quarter-final between the sides last year is any guide.

for Women. The PIL challenges the legality of statutory rape laws that criminalise consensual sex between adolescents who are above 16 years and below 18 years of age on the

India Closes In On Moon Landing As Russia Also Races To Lunar South Pole

India's space agency on Friday released images of the moon taken from its Chandrayaan-3 spacecraft as it approaches the lunar south pole, a previously unexplored region thought to contain water ice where Russia is trying to land first.

The video, taken on Thursday just after the separation of the rocket's lander from the propulsion module, showed a close-up of craters as Earth's only natural satellite spun around.

"The Lander Module (LM) health is normal. LM successfully underwent a deboosting operation that reduced its orbit to 113 km x 157 km," the Indian Space Research Organisation (ISRO) tweeted later.

The Indian space agency launched the rocket carrying the spacecraft on July 14, blasting off from the country's main spaceport in the southern state of Andhra Pradesh. The lander is scheduled to attempt a touchdown on Aug 23.

Russia launched its first moon-landing spacecraft in 47 years on Aug 11, taking a more direct course to reach the moon's south pole where scientists have detected water ice that could be used for fuel, oxygen and drinking water for future moon missions or a lunar colony.

Russia's moon mission is on track to land the Luna-25 on Aug 21, two days before India's spacecraft.

Rough terrain is expected to complicate a landing on



the lunar south pole. A previous mission by India's space agency, the Chandrayaan-2, crashed in 2019 near where the Chandrayaan-3 will attempt a

touchdown. Chandrayaan, which means "moon vehicle" in Sanskrit, includes a 2-metre-(6.6-foot)tall lander designed to deploy a rover expected to remain functional for two weeks running a series of experiments.

Both India and Russia have national interests in successful landings and in claiming the historic first at stake.

For Russia, the moonshot, which has been planned for decades, will test the nation's growing independence in space after its 2022 invasion of Ukraine severed nearly all of its space ties with the West.

Russia's space agency Roscosmos has said the Luna-25

mission would spend 5-7 days in lunar orbit before descending to one of three possible landing sites near the pole.

For India, a successful moon landing would mark its emergence as a space power at a time when Prime Minister Narendra Modi's government is looking to spur investment in private space launches and related satellite-based busi-

Since 2020, when India opened to private launches, the number of space startups has more than doubled. Late last year, Skyroot Aerospace, whose investors include Singapore's sovereign wealth fund GIC, launched India's first privately built rocket.

Indian officials have privately played down the race with Russia to land first, saying there was no competition.

Japanese Turn To Wearable **Tech To Beat The Heat**

TOKYO: Selling jackets with builtin fans, neck coolers and T-shirts that feel cold, Japanese firms are tapping into a growing market for products to help people handle the summer heat.

Japan — like other countries — is seeing ever-hotter summers. This July was the warmest in 100 years, with at least 53 people dying of heatstroke and almost 50,000 needing emergency medical attention.

makes Workman, which clothes for construction workers, launched a version of their fanfitted jackets adapted for the high street in 2020 as demand grew.

The mechanism is simple — two electric, palm-sized fans powered by a rechargeable battery are fitted into the back of the jacket.

They draw in air to then deliver a breeze — at variable speeds

– onto the wearer's body. The jackets retail for 12,000 to

24,000 yen (\$82-164). "As the weather gets hotter, people who have never worn fan-equipped clothing before want to find ways to cool down... so more people are interested in buying it," Workman spokesman

Yuya Suzuki said. "Just like you feel cool when you are at home with a fan, you feel cool just by wearing (the jacket) because the wind is blowing through your body all the time," he said.

Japanese summers are known to be hot and humid, but this July Tokyo really sweated.

The average temperature was 28.7 Celsius, the highest on record since 1875.

Heatstroke is particularly deadly in Japan, which has the second-oldest population in the world after Monaco. More

than 80 per cent of heat-related deaths in the past five years have been among senior citizens.

"Some people die from heat-stroke," said Nozomi Takai of MI Creations, a company selling neck-cooling tubes mainly to factory and warehouse workers. "Individuals as well as compa-nies are putting more and more effort into measures against it

every year," Takai said. The gel inside his firm's brightly coloured tubes — priced at 2,500 yen — is cool enough to use after 20 minutes in the fridge.

Wearing it on the neck will "considerably cool the whole body" for about an hour, she said. Takai's company joined an expo this year on "measures against ex-treme heat" in Tokyo to showcase new products that help users stay cool in the scorching heat.

At another booth, Tokyobased company Liberta had a series of clothing including Tshirts and arm sleeves using prints that make users feel cool - especially when they sweat.

The prints use materials such as xvlitol that feel cool when reacting with water and sweat, they said.

Chikuma, an Osaka-based company, has even created office jackets and dresses equipped with electric fans.

"We developed them with the idea that it could be proposed in places where casual wear is not allowed," Yosuke Yamanaka of Chikuma said.

Regular fan-fitted clothes can make the wearer look puffy, as they need to be zipped up, and cuffs are tight. But jackets developed jointly by Chikuma, power tool maker Makita and textile giant Teijin do not need to be buttoned up, thanks to a special structure that sandwiches the fans in two layers and keeps the cool air in, Yamanaka said.
