NIDM Report Lists Various Factors For 2014 Devastating Floods

'Rapid Urbanization, Poor Management Of Flood Spill Channels, Wetlands Encroachment Aggravated Flood Situation'

Srinagar: Rapid urbanization, population growth, loss of wetlands, deforestation, and unrestrained land use and land cover changes have made Kashmir Valley prone to floods, according to a report from the National Institute of

Disaster Management (NIDM). The report titled as "Kashmir Floods 2014-Recovery to Resilience", NIDM emphasized that the flood of 2014 in Kashmir was the worst flood in the last hundred years. The unprecedented rainfall was apparently the immediate cause of flooding in the Kashmir valley.

"However, it was aggravated by many other factors, for example, rapid urbanization, development activities like construction of railway



line across the Valley, poor management of flood spill

Valley, poor channels, encroachment of flood spill wetlands and land adjoining

river banks, the disappearance of wetlands, etc," the report said, a copy of which lies with Kashmir Observer.

"These factors contributed towards blocking of the natural drainage patterns and increased the severity of the flood," it added.

The report said the presence of railway line aligned through flood plains also made a difference in the observed inundation patterns during 2014 flooding and might be responsible for the higher levels of inundation observed in Kakapora, Nowgam, Lasjan and Srinagar City.

The 2014 flood caused 287 deaths, adversely affecting around two million people. It paralyzed Srinagar city for several weeks.

Prayers, Parties, Student Shows Planned For Chandrayaan-3 Landing

New Delhi: Excitement rose in India on Tuesday on the eve of a much-anticipated moon landing, with prayers held for its success, schools marshalling students to watch a live telecast of the event and space enthusiasts organising parties to celebrate.

The Indian Space Research Organisation's (ISRO) Chandrayaan-3 spacecraft is scheduled to land on the lunar south pole at 1234 GMT on Wednesday, days after the failure of a Russian vehicle trying to achieve the same feat.

Success for Chandrayaan-3 will make it the first to land on the lunar south pole, a region whose shadowed craters are thought to contain water ice that could support a future moon settlement.

India's second attempt to land on the moon after a failure in 2019 is being seen as a



display of the tenacity of its scientific institutions.

Authorities and educators also hope it will encourage scientific inquiry among millions of students in the world's most populous country.

Students have sent scores of messages wishing ISRO luck for a successful landing, the agency said.

The Uttar Pradesh government has ordered all schools to hold special screenings as "landing of India's Chandrayaan-3 is a memorable opportunity, which will not only encourage curiosity, but will also instill passion in

2300 Arrested For Terror Links Post Art-370

Jammu: Over 2,300 persons linked to terrorism were arrested in Jammu and Kashmir after the abrogation of Article 370, marking over five times increase in such arrests compared to the four-year period from 2015-2019, official data said.

Seventeen security indicators from August 5, 2019 to June 20, 2023 showed a remarkable improvement in the overall security situation with casualties among civilians and security forces, grenade attacks, IED blasts, terrorist recruitment and stone pelting on decline after the abrogation of Article 370.

The central government had on August 5, 2019 abrogated Article 370 granting special status to Jammu and Kashmir and bifurcated the erstwhile state into Union territories of J-K and Ladakh.

Art- 370 Never Ceased To Operate After 1957: SC

New Delhi: The Supreme Court Tuesday termed as "unacceptable" the submission that Article 370 of the Constitution ceased to operate once the term of the constituent assembly of Jammu and Kashmir ended in 1957 after drafting the state's Constitution.

The remark by a five-judge bench headed by Chief Justice DY Chandrachud came when senior advocate Dinesh Dwivedi, appearing for intervenor Prem Shankar Jha, argued that nothing of Article 370, which accorded special status to the erstwhile state, survived once the Constitution of J&K was enacted on January 26, 1957 and the term of the state's constituent assembly ended. >> More On P10

'No Leniency': Duo Gets Life Term For Acid Attack On Law Student

Court Refers to Jurists Lord Jennings Saying: "Punishment Should Reflect Revulsion Felt By Great Majority Of Citizens"

Srinagar: A court here on Tuesday awarded life sentence to two convicts in an acid attack on a law student at Nowshera Srinagar in 2014, observing that tangible loss and life-long emotional trauma suffered by the victim by the horrible act "far outweighs any hypothetical chance of rehabilitation" of the duo.

"Someone capable of holding

such harmful and hateful mentality and the capability to conspire and willingly go through with it over a matter as trivial as envy and jealousy cannot be trusted to be reintegrated into the society," Principal Sessions Judge, Srinagar Jawad Ahmed, said while awarding life sentencing to Irshad Amin Wani of Wazirbagh, Srinagar and Mohammed Umer Noor of



Bemina, the duo convicted by him on Thursday last for the "horrific" acid attack on the 20-year-old law student on 11 December 2014 while she was heading to college.

"After careful consideration of the submissions made by both the sides and having regard to the nature of the attack, the permanent disfiguration caused to the victim by the use of corrosive substance by the convicts in furtherance

of criminal conspiracy and the impact of the disfiguration on the future life of the victim both physical and emotional, I find that the convicts do not deserve leniency and no other punishment except the maximum punishment of life imprisonment prescribed under law for their act can do the real and complete justice to the victim," the court said, adding, The convicts are sentenced to suffer imprisonment for life and fine of Rs 5 lakh each for commission of offence punishable under Section 326-A RPC read with Section 120-B RPC".

The execution of the sentence shall be subject to the confirmation by the J&K and Ladakh High Court in terms of Section 376 CrPC Svt, 1989, the court said. The fine, when recovered, shall >> More On P10

Court Rejects Bail To Man Accused Of Killing 6 Voters

Srinagar: A court in Jammu and Kashmir's Bandipora district on Tuesday rejected the bail plea of a man accused of killing seven persons in 1996 for casting their votes in favour of a particular political party.

The accused, Muhammad Ayoub Dar, was absconding since the commission of the offence and was arrested in 2021. He also served in the Territorial Army before he was dismissed. The court of principal ses-

sions judge, Bandipora, rejected the bail application of Dar, a resident of the Hakabara area of Hajin in the north Kashmir district, citing the gravity of the charges against him.

Dar is accused of involve-

ment in the killing of seven persons at the Saderkoot Bala area of Bandipora in the year 1996 when he along with others opened indiscriminate firing on a truck.

The court said that from the material evidence on record, it is crystal clear that the accused was very much present on the date of occurrence in Saderkoot Bala.



"That due to this indiscriminate firing by these accused persons, seven persons were killed for only a single fault that they had cast their votes in the favour of National Conference," it added.

The court said it has arrived at the conclusion that in the given facts and circumstances, the personal liberty of the accused can be curtailed in the interest of society at large as well as taking into consideration the gravity of the charge against him.

'Illiterate' Appointed Instead Of Namesake

HADURA (BUDGAM) - Even as numerous scandals of fake appointments have surfaced in various government departments over the recent years, incidence of the wrong doing is far from being stamped out. Some diehards still manage to get a job in one or the other department by manipulating records and documents, and by tapping the 'right' person and the 'tight' timer.

An illiterate villager has got a government job allegedly by imper sonation, and got away with it, assurance of the finance minister to get the wrong undone notwithstanding. In the process, the genuine claimant for the appointment continues to be jobless. Reports said Nazir Ahmad Dar r/o Abdul Kabir Dar R/o Badipore, has passed his 12th (TDC) clam examination. But, it is his namesake in the neighbourhood who, though illiterate, has allegedly got a government job. The only difference between the two is in the names of their grandfathers. While the former's grandfather is named Abdullah Dar, the latter's name is Ahmad Dar.

According to reports, the uneducated Nazir Ahmad Dar was appointed in the horticulture department in 1996. He is posted in the district office at Budgam. Sources in the department said Dar managed to procure the certificates of his educated namesake which he produced in support of his claim. The department did not entertain the 'genuine claim of the educated Dar.

Though the serious case of alleged swap was brought to the notice of the state vigilance organisations, no action has been taken so far. The educated Dar approached the finance minister, Abdur Raheem Rather, who also happens to be his neighbour. He had assured him to get the right person appointed against the post. However, justice 'still eludes hint despite lapse of about four years

In another case, Mushtaq Ahmad Zargar s/o Ghulam Ahmad Zargar $\rm r/o$ Badipore has managed to secure a job allegedly by producing a fake certificate of academic qualification. According to reliable sources, he is barely read upto 4th standard. However, he managed to get a certificate of having passed his 9th class (under metric) examination from the government higher secondary school, Nagam, in 1996 allegedly, through his brother, Abdul Rasheed Zargar, who is a teacher at Badipore.

On the basis of the alleged fake certificate, Zargar was appointed as a peon in the animal husbandry department. He has been working at the veterinary dispensary here for about three years past. Sources said the department did not take any action to unravel the facts and bring the accused to justice even after the matter was brought to its notice.

Doctors' Body Seeks Withdrawal Of Mandatory Prescription Of Generic Medicines

NEW DELHI: The IMA has written to Union Health Minister Mansukh Mandaviya seeking withdrawal of National Medical Commission (NMC) regulations on mandatory prescription of generic drugs till there is quality assurance of all medicines.

The doctors' body also expressed concern over the



from attending conferences sponsored by pharma companies saying such a prohibition warrants reconsideration. It demanded associations and organisations should be exempted from the purview of NMC regulations.

Members of the Indian Medical Association and Indian Pharmaceutical Alliance on Monday had met Health Minister Mandaviya and expressed their concerns over the NMC

The National Medical Commission (NMC) in its 'Regulations relating to Professional Conduct of Registered Medical Practitioners' stated that all doctors must prescribe generic drugs, failing which they will be penalised and their licence to practice may also be suspended for a period.

It also asked doctors to avoid prescribing branded generic drugs. "It is a matter of great concern for IMA since this directly impacts patient care and safety. It is believed that less than 1 percent of the generic drugs manufactured in India are tested for quality. Patient care and safety are nonnegotiable for both, the government and the medical profession," the IMA said in its letter.

The quality assurance mechanism in our country is very weak, the association pointed out.

India has more than 3 lakh batches of 70,000 drug formulations, the quality assurance mechanism in our country can ascertain the quality control of only 15753 drugs annually, it said.

"In 2023, only around 12000 tests were conducted by CDSCO and State Drug Control Department together. If we consider one sample from each batch is tested, the minimum required number of tests was around 3,00,000," the IMA stated.

Iran Unveils New Mohajer-10 **Drone With 2,000km Range**

Tran unveiled its domestically produced Mohajer-10 drone during an event celebrating Defense Industry Day in Tehran on 22 August, which was attended by the President of the Islamic Republic, Ebrahim Raisi.

The enhanced drone retains a maximum flight duration of 24 hours at a peak altitude of 7,000 meters, and an operational radius of 2,000 kilometers.

According to Tasnim News Agency, the Mohaier drone is capable of accommodating 300 kg worth of cargo, from bombs to ammunition, as well as carrying up to 450 liters of fuel. The domestically manufactured drone also retains a maximum speed of 210 kilometers per hour.


The Arman-1 air-bound bomb was also showcased in addition to the Mohajer-10 drone. Raisi said that the Aerospace division of Iran's Islamic Revolutionary Guard Corps (IRGC) also include Tehran's strategic "Haj Qassem" and "Khorramshahr-4" missiles.

During the ceremony, the Iranian President warned against any attacks against Iran.

Centre To Bring Rules To Check Vulgar Content On Social Media, Streaming Platforms

NEW DELHI: The Centre has assured the Delhi High Court that its policy governing social media platforms and intermediaries will incorporate necessary rules and regulations to ensure the space occupied by them is free from vulgar language and profanities.

The Ministry of Electronics & Information Technology (MeitY), in an affidavit showing compliance of the high court's earlier directions, said it has taken note of the concerns expressed by the high court in its earlier orders.

The high court had earlier said framing rules and guidelines to regulate the content on social media and OTT platforms need urgent attention.

It had underlined the need for taking seriously the use of vulgar language in public domain and on social media platforms which are open to children of tender age

"It is stated that it is a policy decision and having taken note of the concerns of this court expressed through its directions, the concerned Ministry (MeitY), while undertaking its regular exercise of policy making, will incorporate rules/regulations to regulate the social media platforms, intermediaries for making it safer from the use of vulgar language including profanity, bad words, etc., as per the judgment of this court," Justice Swarna Kanta Sharma said in an order on August 17.

Considering the submission of the ministry, the high court disposed of the matter, saying it is a sufficient compliance of its previous orders.

"This court takes note of the fact that it is a policy decision

the Ministry and the legislature, it is sufficient compliance of the order of this court. This court has been assured that the concerns of this court expressed through the said judgment will be incorporated in the future rules and regulations which will be shortly undertaken," the high court said.

Coming down heavily on the language used in TVF web series 'College Romance', the high court had said the use of obscenities in the form of foul language degrades women so they may feel victims as the expletives and obscenities refer to women being objects of sex.

The high court's March 6 verdict had come while upholding an order of the Additional Chief Metropolitan Magistrate (ACMM) asking the Delhi Police to register an FIR against TVF, the show's director Simarpreet Singh, and actor Apoorva Arora under the Information Technology Act.

It had clarified that the direction to register FIR does not include a direction to arrest any of the accused or petitioner.

The court had said the challenge faced by India, as by many other countries, for enacting appropriate law, guidelines and rules to regulate the content on social media and OTT platforms needs urgent attention.

Surprise Night Inspection Finds 89 Girls Missing At UP **School Hostel**

GONDA, UTTAR PRADESH: A police case or FIR has been filed against four persons, including the warden of a state-government run residential school, after only 11 of the total 100 girl students registered there were found present on the premises during a surprise inspection at night, a senior official said today.

District Magistrate Neha Sharma said that the inspection at Kasturba Gandhi Residential Girls School, Paraspur, was conducted on Monday night.

"A total of 100 girl students are registered there, but only 11 girl students were found present in the school, Warden Sarita Singh could not give a satisfactory answer when asked about the absence of 89 girl students," the District Magistrate said.

"This is serious negligence. Residential girls' schools cannot run in this manner," the



District Magistrate said, adding she has ordered the registration of an FIR.

The district Basic Shiksha Adhikari (BSA), Prem Chand Yadav, said that on the instructions of the district magistrate, the FIR was lodged against the school warden, a full-time teacher, a watchman and a Prantiya Raksha Dal (PRD) jawan posted on gate duty at night under relevant sections.

NEW DELHI: Batting for resumption of dialogue with Pakistan, diplomat-turnedpolitician Mani Shankar Aiyar says India won't be able to take its due place in the world as long as its western neighbour is an "albatross around our necks".

The Congress leader, who served as India's consul general in Karachi from December 1978-January 1982, has dedicated a full chapter to his Pakistan stint in his autobiography "Memoirs of a Maverick -- The First Fifty Years (1941-1991)" that hit the stands on Monday.

In an interview with Press Trust of India on his new book, published by Juggernaut Books, Mr Aiyar said the high point of his bureaucratic career was undoubtedly his stint as consul general in Pakistan and he has dwelt at very great length on his three years in Karachi in the first volume out now.

For the last nine years all dialogue between India and Pakistan has been frozen, he

"Until Mr (Narendra) Modi became prime minister of India, almost every prime minister, if he had the time, was attempting some kind of a dialogue with the Pakistanis but now we are in a freeze and the victims of this freeze are not the army of Pakistan which is still swigging its scotch, it is the people of Pakistan whose relatives in large numbers live in India and many of whom have a desire to visit our country," he said.

perts are providing their opinion on the situation and if any wrongdoing by the cattle owner is found in the report of veterinary experts, necessary action under the law will be taken against the culprits accordingly," the statement said.

In the interest of peace and harmony in the district, the police urged the general public to refrain from sharing any content related to the incident on social media.

"Please abstain from spreading any further rumours. Those found engaging in such behaviour will be subject to legal consequences," it said.

HC Directs Ladakh Admin To Allot Plough Symbol To NC By Today

Asks CS, CEO Of UT To Appear In person In Default

SRINAGAR: The High Court of J&K and Ladakh has directed authorities in Ladakh to ensure "plough" symbol is allotted to National Conference, failing which Chief Secretary and Chief Election Officer of the UT have been ordered to appear personally before it on August 23.

Keeping in view the fact that the last date for filing nominations is 23.08.2023, the respondents (authorities) are directed to comply with the order dated 09.08.2023 read with order dated 14.08.2023, and file compliance report by the next date, failing which respondents 1 (CS) and 2 (CEO) shall appear in person on the next date of hearing," a bench of Justice Sindhu Sharma said while hearing a contempt petition filed by the National Conference through its general secretary. The contempt plea has been listed on August 23.

As per a notification issued by the election department on August 5, the election to 26 seats of the 30-member Ladakh Autonomous Hill Development Council (LAHDC), Kargil, is scheduled for September 10 and the counting of votes will

take place four days later.

The Ladakh administration had approached Division Bench of the court on August 14 against the single bench order of August 9 which directed the NC to approach the office of the Election Department of the Administration of Ladakh for notifying the reserved symbol (Plough) already allotted to for the polls. The order of the single bench was upheld by the Division bench.

"The Ladakh administration tried to get the HC order stayed. This was refused. They then tried to get the contempt proceedings of the HC stayed, this was also refused by the SC," senior NC leader Tanveer Sadiq said in a statement.

"If the order to allot us our symbol is not issued by this evening the contempt order of the HC will prevail. The CS Ladakh & Chief Election Officer will have to appear in person in the HC tomorrow," he said, adding, "We hope that the Ladakh Admin will follow the directions of the court & issue the order for allotment of our symbol. We fail to see why the administration has made an ego issue out of this symbol allotment."

Chadoora Court Comes To Rescue Of Grazers

Directs SHO To Ensure Compliance Of Order

BUDGAM: In a significant order the Court of Sub Judge Chadoora recently observed that grazers in Chaskani Nar meadow in Doodh Ganga forest range should not be evicted and deprived of the grazing rights.

The order pronounced by Mir Wajahat Sub Judge Chadoora on 17 August 2023 has directed the parties to the suit along with Station House Officer Chadoora (SHO) not to evict the defendants under the garb of the order dated 11th July 2023 passed by the same court. The court further observed that its July 11th 2023 order was limited to the effect that applicants/defendants numbers 1 to 10 were temporarily restrained from causing any sort of interference into the use and utilization of pasture land (Chaskani Nard) in any manner.

"However the said order is not pertaining to the eviction of defendants number 1 to 10 from the subject matter of the suit' observed the Court. The Court further clarified that the order passed on July 11th 2023 was not meant to evict the graz-

ers but the eviction can only be done if Forest Rights Act 2006 is violated by either of the parties. The Sub Judge court has directed the SHO Chadoora to ensure compliance of the order by the both the parties (complainants / respondents)

Pertinent to mention that Chairman DDC Budgam Nazir Ahmad Khan had also submitted a representation on this issue before Lieutenant Governor JK last month after a delegation of Gujjar community from Jabbad, Neengo and Brenwar villages of Budgam district had apprised him regarding denial f grazing rights to them by some influential families who were trying to evict the grazers hired by them.

The aggrieved had told DDC Chairman that the provisions of Forest Rights Act 2006 were being violated openly as no eviction of grazers can be done as the pastureland comes under Community Forest Rights. Pertinent to mention that the Chaskani Nard pastureland is located at altitude of 4000 meters in Doodh Ganga forest range of Pir Panjal Forest Division Budgam bordering Poonch district.

The said dengue caused by viruses carried by infected mosquitoes has always been a health concern and people need to take precautions to protect themselves from falling prey to the virus, he said. Meanwhile, the

have advised the people to use mosquito repellents and wear full sleeves shirts so as to save themselves from mosquito bites, which they said choose to breed in stagnant water accumulated by water logging mainly during monsoon. They said the mosquitoes that

spread dengue are active during

the day. "Cover as much of your body as possible and use mosquito nets if sleeping during the day and spray the nets with insect repellents," they said.

Wild Animal Attacks

he killing of a 59-year-old man identified as Ghulam Mohiudin Malik by a black bear at a Handwara village has once again highlighted the growing incidents of man-animal conflict in the Valley, more so, in parts of North Kashmir. Within a span of 24 hours, three separate incidents have occurred, raising alarm within the local community and prompting calls for swift action by the Wildlife Department. This incident closely followed the unfortunate demise of a young child and the grave injury of a woman due to earlier wild animal attacks in the same area.

As the incidents of wild animal encounters become more frequent, it is important for authorities to not only capture and relocate the roaming animals but also to implement measures that reduce the likelihood of such incidents occurring in the future. Balancing the needs of wildlife and the safety of human populations remains a delicate task that requires planning.

True, the Jammu and Kashmir Wildlife Department has been trying its best to secure local population from animal attacks. In May, the department captured a Himalayan brown bear in Handwara. The bear's behavior had become increasingly weird, raiding graveyards possibly in search of human carcasses and venturing into residential areas, which posed threat to lives and livestock. Similar encounters have been reported in other villages in the district. To protect the graveyards, villagers for a while took to taking turns to stand guard, but the situation remained challenging.

The unusual behavior of the bears has bewn attributed to insufficient food in their natural habitat. Last year, a study conducted by Wildlife SOS, an Indian wildlife conservation organization, revealed that a staggering 75 percent of the Himalayan brown bear's diet in Kashmir consisted of scavenged garbage, including harmful items such as plastic carry bags, milk powder, chocolate wrappers, and biryani.

The Himalayan brown bear, the largest animal in the Kashmir region, typically feeds on insects, plant roots, and small animals in their native habitat. However, the intrusion of human settlements into their territory has forced them to venture into lower altitudes in search of sustenance. As settlements expand, the bears' interactions with humans have increased, leading to dangerous encounters and conflicts.

The urgency of this situation cannot be overstated, as the global population of Himalayan brown bears is estimated to be less than 1,000, with half of that number residing in India. These bears are already classified as "critically endangered" on the IUCN Red List. A study predicts a substantial decline of up to 73 percent in their habitat by 2050, making preemptive habitat protection imperative for their survival. This is where the Wild Life Department needs to pay its role and step up to the public expectations.

chieving the ambitious goals of social representation in the Congress Working Committee (CWC) that the Congress set for itself at its brainstorming session in Udaipur, in May 2022 was never going to be easy. It took party president Mallikarjun Kharge nearly six months after he was authorised by the Raipur session of the All India Congress Committee (AICC) in February 2023 to finally announce the new CWC on Sunday, which also happened to be the birth anniversary of former Prime Minister Rajiv Gandhi. While combining experience and youth, Mr. Kharge has drawn up a list that significantly enhances diversity in the party's highest decision-making body. His opponent in the 2022 election for the top post, Shashi Tharoor, finds a place, in a commendable appreciation of internal democracy, and an encouraging signal to many sceptics of the party. Half the CWC, excluding invitees, are from Scheduled Castes, Other Backward Classes, tribals, and minority communities or women, which meets the Udaipur ambition. But when invitees are accounted for, the social composition tilts in favour of upper castes and minorities, even as it meets the '50 under 50' age criteria. A number of fresh faces from the middle rungs have made it to the list — former Punjab Chief Minister Charanjit Singh Channi, a Dalit leader at 60 and Kamleshwar Patel, the 49-year-old OBC leader from the election-bound Madhya Pradesh, are in, while Damodar Raja Narasimha, 64, from Telangana is a permanent invitee.

Mr. Kharge has the unenviable task of exercising his authority while three members of the Gandhi family - Sonia, Rahul and Priyanka — remain active, but he appears to be up to it. The list reflects the party's keen attention to the upcoming Assembly elections in the heartland. Chhattisgarh Minister Tamradhwaj Sahu, an influential OBC leader, is expected to play a crucial role. In Rajasthan, while Chief Minister Ashok Gehlot is given a free hand to lead the charge, the induction of his challenger Sachin Pilot and tribal leader Mahendrajeet Singh Malviya to the CWC is expected to reinforce party unity. The party has tried to reassure discontented social groups and assuage rebellious leaders in various States, and the constitution of the new body is largely representative of the geographical and social expanse of India. Though some disenchantment might surface in the days ahead, the new CWC reflects both imagination and compromise. While this is a good start, there is more that the Congress needs to do to be truly representative of this diverse nation, besides strategising for elections and improving political communication and becoming the centre of gravity of Opposition politics in the run-up to 2024.

At One Lakh per RTI?

RTI applicant charged one lakh rupees. PWD (R&B) must digitize its official record and make its proactive disclosure

he Public Works (R&B) department officers with an aim to demoralize an information seeker recently asked to pay 1 lakh as photostat charges for getting information under the Right to Information Act 2005 (RTI). The Assistant Executive Engineer (AEE) R&B Sub Division Sumbal District Bandipora through an official communication with his senior colleague (Executive Engineer R&B Division Bandipora) on 16th August 2023 in response to the RTI application filed by some local residents updated his boss that before providing the information the applicant may be asked to deposit Rs 1 lakh to prepare the information. The RTI application had been filed before the Executive Engineer and he seemed to have directed his AEE to provide the information. To make sure the applicant should not get hold of the information he wrote to his senior officer that applicant has to pay Rs one lakh as processing fees?

The Assistant Executive Engineer's -AEE's letter to Executive Engineer R&B Division Sumbal dated 16.08.2023 reads:

"With reference to the above captioned subject and reference number, it is to submit that this office has received an RTI application from Shri Shabir Ahmad Parray Shri Tariq Ahmad Parray and others wherein they have requested the following information: Certified attested copies of funds utilized for construction purpose in Hajin from 2018 till date including the name of building, road and allied works executed by R&B. Certified copies of NOCs issued for building permission from 2018 till date. Before framing the information the applicant may be asked to deposit an amount of Rs 1.00 lakhs approximately for preparing the information"

Background

The RTI applicants had sought the information regarding the utilization of funds for construction purposes in Hajin area of Bandipora district which comes under construction division Sumbal. The applicants had also sought the certified attested copies of NOCs issued for the building permission purposes from 2018 to 2023.

This is a clear case to demoralize the information seekers who are not familiar with the RTI laws. I believe this has been done intentionally with an aim that information seekers will not be able to access the information as they won't pay such a huge fee. I got to know about this case on the very next day when this letter was issued. Some local activist sent me the official letter on whatsapp and I was shocked. I posted the same on social media and many newspapers and digital media covered this news. The poor official isn't aware of the fact that information he has been asked to provide has to be made proactively available on the official website of R&B PWD or DC office Bandipora as per the provisions of section 4 (1) (b) of RTI Act 2005. Infact under e office and digital India programme also Govt offices have to keep all the information available in digital mode for the public. It seems AEE R&B Division Sumbal isn't also aware of the fact that he is a designated PIO under RTI Act 2005 or Assistant PIO-APIO and he has to specify how many pages of information he is going to provide to the applicant? If he is charging Rs 1 lakh that means his office has to make 50,000 photocopies as for each page Rs 2 are charged as per RTI Rules. But the officer has given a vague reply by demanding Rs 1 lakh fees.

Executive Engineer R&B Bandipora

In March this year, the Executive Engineer PWD R&B Division Bandipora asked an RTI applicant from below poverty line (BPL) category to pay more than Rs 4000 as xerox fees to get information under RTI Act 2005.

The letter signed by Executive Engineer R&B division Bandipora addressed to RTI applicant Parvaiz Ahmad Bhat who hails from Ajas Bandipora read as:

"Regarding the subject cited above, the requisite information as desired by you through RTI Act has been kept ready by this office and accordingly you are hereby informed to deposit the necessary photostat charges of the requisite documents Rs 4375"

On receiving the letter, the RTI applicant Parvaiz Ahmad got agitated as he had been asked to deposit huge charges to the Executive Engineer. The information seeker was not only agitated over the officer for demanding exorbitant fees but being an BPL RTI applicant, he was supposed to get the information free of cost as per the provisions of RTI Act 2005.

This is not the case with Parvaiz only but in Bonen Surasyar, district Budgam, the PMGSY engineers a few years back got a BPL ration card of an RTI applicant Mushtaq Ahmad cross checked through Assistant Director Food & Civil Supplies Budgam. I wish the Govt officers would have instead used such energy in digitizing their record and bringing more transparency in the Govt offices.

Sajad Hussain's case

Sajad Hussain Pandit S/O Ali Mohammad Pandit R/O Iskander PoraTehsil Beerwah District Budgam in June 2016 filed an application under the erstwhile J&K RTI Act 2009 before the PIO in the office of Financial Commissioner (FC) Revenue Srinagar.

RTI applicant was called in person by FC Revenue office Srinagar and was given an official letter No: FC (Adm-RTI) 02/2016 dated 20/6/2016. The information seeker was asked to pay an amount of three thousand eight hundred sixty six rupees (Rs 3866) for getting information with regard to appointment of Patwaris more than a decade back. The information seeker alleged that there was bungling and favoritism in the said appointment.

The FC Revenue office letter reads as:
"In continuation to this office

letter No FC(Adm-RTI) 02/2016 Dated 31/05/2016, I am to say that information demanded by you are428 pages out of which 383 pages are of A 4 size which costs Rs 766 and rest pages are large size which got copied from market on large photocopier and costs Rs 3100"

We all are aware that Rs 2 was charged per photocopy for A 4 size until a few years back and for the bigger size photocopy maximum cost cannot be more than Rs 10 per page. This indicates that for the remaining 45 pages the Information seeker had to pay Rs 450 only maximum, but he was asked to pay Rs 3100, plus Rs 766 for photocopying A4 size pages. When the information was received by the information, that was completely misleading and incorrect. He later on moved an appeal in the State Information Commission.

Info in Digital format

At a time when every bit of information is made public by the officers in J&K who don't want people to have access to information especially reacting to developmental projects with huge fundings. Nobody would appreciate making 50,000 photocopies on a Xerox machine in this digital era. The Assistant Executive Engineer PWD (R&B) Sub Division Sumbal District Bandipora could have given the information to RTI applicants in a PDF format and sent them via email or through a pen drive had his intentions been honest and clean. The information sought won't consist of more than 500 pages as the applicants only wanted information of the last 5 years (2018-2023).

Conclusion

The Public Information Officer (PIO) cannot charge any fees after the stipulated time of 30 days is over. Section 7 (6) of RTI Act 2005 reads

"Notwithstanding anything contained in sub-section (5), the person making request for the information shall be provided the information free of charge where a public authority fails to comply with the time limits specified in sub-section (1) (30 days)"

In the aforementioned case the Assistant Executive Engineer -AEE or the deemed PIO asked the applicant to pay Rs 1 lakh fees after a lapse of 2 months. The RTI applicant had filed an application on June 16th 2023 and he was not provided information within 30 days. The AEE has committed a legal blunder by asking applicants to deposit the fees after 60 days' time. This makes it clear that designated officers under RTI Act 2005 (PIOs, APIOs or Appellate Authorities) are ignorant about the RTI Act 2005 and its rules. The Government must take steps to train them. I am sure the J & K administration headed by Lt Governor Mr Manoj Sinha will take serious notice of it.

Exploring Love Through Poetry The Question of Happiness

The term hubb possesses the term khamr (wine) as a synonym, and khamr, in turn, was referred to as Umm Layla by the Arabs. Layla, in this context, refers to ecstasy and intoxication, and umm is present due to its induction of such a state, begetting it as a mother begets a child. Love, similarly, intoxicates the lover, and, in cases, overwhelms and maddens him, as was the case with Majnūn, whose very name refers to one who has been maddened; in this case, by love. Other terms used – uzn, sadam, kamad, and shawq, among others - all have similar implications, portraying the emotions experienced by lovers upon separation.

The question of happiness has received attention from a litany of traditions, but our perception of it comprises some fundamental differences. We disagree with the Aristotelian conception which treats the pursuit of happiness as the ultimate purpose of human life. If it is to be pursued, then there is the implication that it is absent. But neither is our philosophy so hedonistic or materialistic as to reduce the question of happiness to a matter of self-indulgence. Happiness, we hold, is a byproduct that stems from the certainty of knowing God 3 not only in terms of His existence, but that it is He who is in charge of all of man's affairs — in delight and grief, or in relief and worry — and directing our actions in conformity therewith. Insofar, however, as it is construed as a combination of delight and contentment, there are deeper aspects to unravel.

The above grants insight into the metaphysical aspect of spiritual happiness. While it influences the other existing facets, the psychological question of happiness – intimately connected to the contentment of the mind and the heart, in that both require propelling along with peace — requires specialized attention. The mind is in need of progress, as opposed to stagnancy, towards a future wherein its owner is needed. Aspirations are indispensable; the lack thereof generally portrays a weak mind. However, while the states of the mind and the heart are interconnected, each must be individually catered to, lest harmony be lost through negligence. To clarify, ambitions predominately pertain to the contentment of the mind. But man is not so simple as to be reduced to a matter of requiring novel experiences or ambitions for the sake of happiness, and nor can it be dismissed that there are novel needs he develops that may well be absent in the years prior - including and particularly romantic love.

Grammarians differ concerning the root from which ins n stems, with one group positing that it is from nasiya — to forget that the term is derived, contradicted by the second group which argues that anas is the root, meaning, to be amicable or covetous of companionship. While both are intimately connected to man's nature, critics of modernity often note the second facet, as modernity's idealization of hyper-individualism not only leads to the collapse of family structures but also to the destabilization of the community itself. Man had undertaken his Covenant with God individually, but that all of mankind was subject thereto shows the presence of a greater collective, therefore illuminating the distinction between al-fur al- ayn (personal obligations) and al-fur al-kif yah (communal obligations), since the collective reception of the pledge necessitates bilateralism insofar as rights are concerned.

Companionship, in the first sense of the collective, is not restricted to reciprocation in affection or supporting the needy, but rather extends to relying on another for one's own self in the process of cultivating true bonds. Love from this category — a parent for a child, or a friend for a friend — may be deep, and loss may incur obliteration.

The second is mentioned in the Qur n, recurs in poetry, and is apparent in the lives of the Messenger and the Companions themselves. By love, what is meant here is not the Platonic sort, but that which exists specifically between a man and a woman. develops, and culminates in the most beautiful of forms through strife and reciprocation. Ibn azm (رحمه الله) writes, "For my part, I consider Love as a conjunction between scattered parts of souls that have become divided in this physical universe, a union effected within the substance of their original sublime element."

Love is not a collection of interim emotions to be set alight, but rather an affair that unites souls, prompting a state wherein no affliction is greater than separation, and no pleasure greater than reunion. A man once remarked that separation was the brother of death, to which a philosopher replied, "No, but death is the brother of separation." The Naba poet Abd-All h bin Sbayyil writes,

Instruct me, please, in the mysteries of passion: You are steeped in its pleasure and rigor; Of the malady man keeps within him, He yearns to be treated but it only consumes



him more.

Ab al- ayyib al-Mutanabb muses,

And there is no separation between lovers,

Except that desires find a path to their souls.

Aware of the tranquility resulting from reunion, poets nevertheless classify love as a disease due to its vexing nature. In the words of Ibn Sbayyil, "I put my mouth to her sweet lips and took a draft, and felt my heart come home from long absence" quite seemingly in response to his own

My beauty, let me steal a kiss, just a little one, To revive a delirious heart overcome by thirst.

Al- usayn bin a āk laments,

I swear, a beautiful breast caused my demise And forced a deep sigh from me. Though I laughed from the pleasure it gave me, It made me fall apart with grief.

Ibn Hazm (رحمه الله) elucidates this well, "as for the lover, his soul is indeed free and aware of where that other is that shared with it in ancient proximity; his soul is ever seeking for the other, striving after it, searching it out, yearning to encounter it again, drawing it to itself it might be as a magnet draws the iron."

Time halts in both moments of reunion and separation, although with widely contrasting consequences. The former revives the heart, showering it with a form of peace that leads the mind to believe that the transcendental experiences shall continue till perpetuity; in cases of separation, it transmutes to a bottomless abyss wherein the lover forever falls, desperate for an escape from the seemingly endless torture.

Udhri poets uphold this throughout their works. Urwah, for example, anticipates the day he will meet Afra:

I love the Day of Judgment since I have been told That I shall meet her there.

Qays demonstrates the immortality of his love:

Our love will survive every event. And will visit us in the darkness of the grave.

Majnun declares,

O if only we could live together And if we die my bones lie beside her bones.

Jamil composes,

My heart was tied to hers before our creation after we were seeds and in the cradle. It grew, as grew our slumbers and awakenings. Shattered not was the Covenant upon our

but was honored in every moment, even as we entered the darkness of our tombs.

Al-Tabari (ra) commenting on the verse that the spouses are lib san (garments) for one another, writes that the term refers to the residence of and in the heart. Thus, although the beloved's physical presence may not be enjoyed, her timeless image hardly withdraws. Al-R z and Ibn Badr n 18 (رعم الله) agree in interpreting the term as embracement, as spouses become one via enfoldment, each resembling a garment worn by the other. The beloved ceases to merely be her own individual self, thereby becoming an extension of the lover, sharing in both his delight and pain. Forgetting, thus, in cases of separation, becomes impossible, for while the lover may divert himself from her remembrance, the act itself depicts his inability to overcome his grief. The Prophet , in spite of having deeply loved again, did not merely forget first true love: Khad ja (رضىالله عنها). As Ibn Sbayyil describes,

They said, "You should marry and forget her." "Ah, even if I took four wives I'd never forget her," said I.

Happiness, insofar as it is construed as delightful contentment, stems from a combination of all the factors mentioned thus. The heart seeks joy in the remembrance of its Lord and the souls which have taken the Covenant. Such culminates in the beloved, for there is no greater delight in this life than in her arms. Ibn azm adds, quite eloquently:

Were it not that this world below is a transitory abode of trial and trouble, and Paradise a home where virtue receives its reward, secure from all annoyances, I would have said that union with the beloved is that pure happiness which is without alloy, and gladness unsullied by sorrow, the perfect realization of hopes and the complete fulfillment of one's dreams. I have tested all manner of pleasures, and known every variety of joy; and I have found that neither intimacy with princes, nor wealth acquired, nor finding after lacking, nor returning after long absence, nor security after fear and repose in a safe refuge none of these things so powerfully affects the soul as union with the beloved, especially if it come after long denial and continual

The epitome of otherworldly beauty, she becomes the object of all curiosity and affection, as does what may be connected to her – her homeland, her preferences, irrespective of how minor, or her habits. Majn n says,

I pass by [Layl 's] places, kissing this wall Longing for her who lived in these places -Not the places themselves.

Qays declares,

I am not fond of your homeland; I am kissing the footprints of the one Who stepped over its soil.

Kuthayyir, during a journey, requests his companions:

My friends, this was the encampment of Stop and touch the earth which may have touched her skin.

And remain spending the night where she stayed and spent the night. And do not doubt that God will forgive your

If you pray where she prayed.

Lovers raise their beloved to unattainably high stations, often believing that the very earth they have tread must be infused with barakah. Driven to insanity, they touch the objects which may have contained their lovers, hoping to regain some semblance of reunion. Ma m d Darw sh, on this note, famously says,

They ask, "Have you been driven mad by Layl? I say, "There is no delight in life save for the insane.'

The depth of despondency is directly contingent upon the strength of love. Even Al ibn Ab lib (رضي الله عنه), a man renowned for his fortitude, could not resist disintegration and failing to see life as though it had more to offer than bleakness upon the loss of his beloved (رضي الله عنها) — وضى ُ اللهُ] evident from his words during her عنها) burial:

Why is it that I halt at the grave of the one who The grave of my beloved who no longer returns

my greetings? O, my love, why do you not answer me? Have you forgotten the intimacy we once shared?

The beloved said, "How may I respond when I am shackled to the earth?

The dirt has eaten away at my beauty, and I have forgotten you –

It has veiled me from my family and those I love. So I wish you peace and sever the bond by which we were once bound.

What then may be said about men who lacked the same resilience? It is not only the grief that assumes the reins of oppression, but the very object that had shown them that there is bliss to be found in life – the object through which the world could finally, after longevities of darkness, be seen in the litany of colors that granted it its magnificence - has now disappeared, taking away therewith the lovers' purpose and any semblance of life that their hearts may have contained. In the words of Majn n:

As if the mountain-roads were a circle of rings Around me, never increasing or decreasing in

What is portrayed is the stillness of time the monotony that man is doomed to suffer from the absence of his beloved. Ibn Sbayyil grieves,

If I die first, she says, "So-and-so passed away"; If she dies first, my life loses meaning.

She becomes his meaning, and therefore the lover does all to enrich, beautify, and commit that which grants her joy, as within the confines of true love, the lover attains happiness through sacrifice rather than confiscation. Jam 1 mourns,

I am pleased with the very little things accorded to me by Buthaynah.

They are so insignificant That if they were known by the man [who spies us], He would not be annoyed with my love. I am pleased even when she says 'no' or not' and when she makes me live on promises-Promises hoped for, but always disappointing. I am pleased with a quick glance at her, And even with spending a whole year without our meeting-

Neither at the beginning nor at the end.

The dreariness man witnesses is not contingent merely upon the weakness of his character. Love necessarily turns hearts soft. Even the strong one will find himself unable to resist dissolution at the thought of his beloved, and devoid of life should his love be unreciprocated or union be broken. As there is no greater delight to be experienced in life than in her arms, there is no greater grief than her reach disappearing

into the distance. Such grief may not be overcome. Transcending the boundaries of distress ceases to remain a possibility, and so the only choice man is left with is to tread forward with what plagues his heart. For some, there may come a time when the grief metamorphoses into nostalgia, particularly so if he is able to find love once again; with others, acceptance of their burdens is required as they await the wisdoms behind their trials. Regardless, the grief is to remain, triggered perhaps by words, images, or objects due to associations that he may consciously or otherwise form. Such are, however, associated with yet another extreme: beauty and love.

The lover is reminded of his beloved by the most ordinary of things. Where the onlooker may see, say, a tree, the lover perceives what shaded him during his confession of love; where all see mundaneness, the lover sees pearls. But in moments of separation or concern over whether the love will be cultivated to fruition, he is plagued by doubts and restlessness, which may even occasionally cause him to hurl imprecations. Jam 1 writes,

May God cast motes into Buthayna's eyes, May He blacken her brilliant teeth!

He wishes elsewhere,

I wish I were rid of you, love, Will you leave me no rest? Similar thoughts may be found in the verses

She'll sprinkle my heart before it wastes away Or is it her plan to let me die because of her? She is merciless — may His Mercy elude her kin: Her red-hot iron, Lord, tortures me to death.

Jam l, however, does not truly intend to curse Buthaynah, and nor does Ibn Sbayyil wish for his beloved to be deprived of God's Mercy. What underlies the words of the former is repulsion towards the notion of any man other than himself approaching Buthaynah, and those of the latter the pain borne from unreciprocated love, both effectively portraying the reality of their raging hearts.

Anger is often a byproduct of unrequited love. The lovers are agonized, forced to face that their desired future has slithered through their fingers, and so they begin to chase a distant dream. Ibn azm cites an anecdote wherein he speaks to a man whose eyes were, after the oceans of tears he had shed, dried with weariness, and his life drenched by the waters of sorrow. He recognized that there was no prospect for embracing his love, and yet when he prayed, he did so for union rather than relief. When the Im m, thus, asked God to aid him, he was only met with displeasure, as it was not mere relief that the man sought, but relief through reciprocation in his affections.

There is a frequent struggle between the dictates of the mind and that of the heart, for should we consider the mind the tool responsible for applying pure reason, we see that it urges man towards pragmatism; knowledge thereof is also to some degree connected to the outer state of the heart, for the heart may also witness what has been lost. The inner state, however, yearns for the lost object, and it is such a dilemma that yields chaos. Ibn Sbayyil's poem mirrors this concept:

The heart is a Sul n with despotic powers, It rules at the pleasure of its whims; The eye is the heart's scout sent to check, To-ing and fro-ing at the well from enemy to

Love is an affliction in perpetual motion, That offers no escape to the smartest game.

Although the realization of a long-awaited reunion plucks at the strings of the heart in a most exquisite manner, the perplexity arising from newfound love, or in the process of deliberation in terms of whether the dictates of the heart must be submitted to, or even from the knowledge that the beloved is no longer with the lover, steals all rest that eyes seek in the depths of darkness. Im mal-Sh fi (رحمهالله) wrote:

Some eyes alert, and others at rest, Over a matter which may or may not manifest. Avert the distresses your souls harness, For your burden of torment has driven you madness.

While ignorance is construed negatively, it is innate to us, rife its own wisdoms. It is because of our ignorance that we may hope, despite the grief that overtakes our hearts. for those who have witnessed the wisdoms behind their trials know that it is only gratefulness that their grief should birth. If loss is the price to be paid for wisdom, it is hardly high, for there is nothing greater than this lost property of the believer should it teach him that not a grain of his broken existence is detached from its Lord

.36 It is with a broken heart that man witnesses the essence of reality: therein is no existence unsustained by All h and no true existence apart from Him ; it is He who sustains all, as all else is a mere shadow – a passing manifestation without constancy. Should he make what is by nature evanescent, his life will cease to retain any meaning upon its dissipation. There is no love unaccompanied by grief, but should grief be the price man is to pay for love, man must still love for his heart knows that there is no greater beauty in life than what is found through it.

Man is not a product of his experiences, but of the stances he takes with regard thereto. He may descend into despair and lose what grants him life, or adhere to his hopes and perceive the events which he never imagined anything of inducing the unimaginable, if only he unceasingly relies on his Lord . Reliance is not a matter of hoping that one will receive what he hopes for, but that his affairs are in the Hands of his Guardian , and so when the price has been paid with grief, he must garner patience and step forward into what will content his Lord , as he awaits to be shown that he had a greater purpose by the Best of Planners . It is only fitting, thus, to conclude with the words of al-Sh fi

Indeed, your Lord has sufficed you in the days now past,

And He will suffice you in those to last. And Allah knows best.

Covid Vaccines Effective Against Severe Cases In Children Study Finds

accines are effective against severe cases COVID-19 in children and adolescents, according to a review of studies.

However, the study published in the journal BMJ Paediatrics Open shows that with most children already infected with the SARS-CoV-2 virus and building up a natural immunity, the additional benefit of

from other vaccine preventable diseases were considerably higher.

The review noted many countries have still not introduced proven lifesaving vaccines, including pneumococcal, rotavirus and human papillomavirus, into their immunisation schedules.

The resources required for COVID-19 vaccine roll-out in these countries posed a considerable challenge, it stated.

vaccination in healthy children is minimal.

The team, led by researchers Children's Murdoch Research Institute in Australia, explored the challenges and considerations of COVID-19 vaccination, especially in low- and middle-income countries with high levels of community transmission and infection-

derived immunity. The review found that any roll-out of COVID-19 vaccines in low- and middle-income countries should also complement routine childhood vaccine programmes that have a greater impact on illness and death, including for measles, pneumonia and

diarrhoeal disease. The study shows that despite most children having been infected and severe infection could occur, deaths were extremely rare in children.

Globally, 16,100 CO-VID-19 deaths have been reported in those up to 19 years old, according to the researchers.

They highlight that although COVID-19 vaccinations in children were effective at the time they were tested, the benefits were lower in the current context of high infection-derived

immunity. The study found that the extra gain was also much lower compared to other life-saving vaccines in low- and middle-income countries. where childhood deaths

John Hart from Murdoch Children's Research Institute said although there was not strong evidence to support routine vaccination of all healthy children, it was a different for high-risk children, especially those with disabilities and certain underlying conditions.

"Given the very high prevalence of risk factors for severe CO-VID-19 in low- and middle-income countries, vaccination against CO-VID-19 is an important consideration in all age groups, including children, he said.

However, decisions should be made considering the direct benefits to the individual child, not broader benefits to the household or community related to transmission, particularly as the effectiveness of the vaccines against infection is temporary, the researchers said.

Professor Fiona Russell from Murdoch Children's said there was also a lack of public health data in low- and middle-income counwhich under scored the importance of ensuring equitable access to safe and effective vaccines for future epidemics before exposure to infection.

"In low- and middleincome countries, most people were infected by the time vaccines became available, highlighting the profound inequity in global vaccine distribution," she added.

1) Killing or shifting stray dogs from one place to another place is illegal under the Animal Birth Control Rule, 2023 promulgated under the Prevention of Cruelty to Animals Act, 1960.

SMC to address the issue of stray dog-related concerns.

2) The only legal intervention allowed is the implementation of the Animal Birth Control and Anti Rabies Vaccination Programme in accordance with the Animal Birth Control Rules, 2023.

3) The Srinagar Municipal Corporation has been implementing Animal Birth Control & Anti Rabies Vaccination Programme in all its 35 Administrative Wards (74 Electoral Wards).

4) The Animal Birth Control and Anti-Rabies Vaccination Programme follow a sequence of processes that include:

A.Catching of stray dogs: The dog-catching team will catch and shift them to the designated Animal Birth Control Centre.

B.Sterilization of stray dogs: These captured dogs will be neutered/ spayed (removal of reproductive organs) by the Veterinarian at the ABC Centre. C.Anti-Rabies Vaccination: The sterilized dogs will remain in the ABC Centre for a few days for post-operative care of the surgical wound. The

neutered/spayed dogs are also vaccinated against Rabies. D.Release: Once the dogs have fully recovered, they are released back to their original territory. This step is crucial because it allows the dogs to return to their familiar surroundings without contributing to further population growth. Benefits of the ABC Programme

1) Stabilizes the stray dog population through humane methods.

2) Curbs the spread of rabies in humans as well as in animals. 3) Reduces the incidence of dog bite cases.

4) Checks cruelty issues of stray dogs.

5) A legitimate approach to address grievances concerning dog-related nuisances from the general public.

1. Don't disturb a stray dog, particularly if it is eating food, sleeping,

- or caring for its pups.
- 2. Don't chase, provoke, kick, shout, or throw stones at the dog.
- 3. Don't panic or start running at the sight of a stray dog.
- 4. Children in the age group of 4-9 years are the most common victims of dog bites; they need supervision when near dogs.
- 5. Avoid dogs displaying aggressive behavior such as growling, barking, or snarling.
- 6. If a dog bites, wash the bite wound with soap and running water for 15 minutes and visit the nearest hospital for treatment.
- 7. If you see a dog in the locality with an abnormal or aggressive behavior with froth dribbling from its mouth, keep away from such dogs and report immediately to Srinagar Municipal Corporation on the following helpline numbers: +911942474499, 1-800-180-7038, and +911942470465.
- 8. Citizens are requested to cooperate and coordinate with the Srinagar Municipal Corporation for the implementation of the Animal Birth Control and Anti-Rabies Vaccination Programme, in which stray dogs will be caught, sterilized, and vaccinated against Rabies and then released back to the pickup location.

Price Pressure In Food Items To Be Transitory; Elevated Inflation Warrant Greater Vigil: FinMin

NEW DELHI: The finance ministry on Tuesday said price pressure on food items is expected to be transitory, with tomato prices seeing a decline, but the government and RBI need to step up vigil to deal with elevated inflationary pressure.

Enhanced provision for capital expenditure by the government in the current fiscal is now leading to crowding in of private investment, and domestic consumption and investment demand would continue to drive growth going forward, said the ministry's Monthly Economic Review for July.

The consumer price index based retail inflation spiked to a 15-month high of 7.44 per cent in July 2023, with specific food commodities mainly driving the increase. Core inflation, however, stayed at a 39-month low of 4.9 per cent.

"The government has already taken preemptive measures to restrain food inflation which, along with the arrival of fresh stock, is likely to subside price pressure in the market soon... The price pressure in food items is expected to be transitory," the report said, adding, global uncertainty and domestic disruptions may keep inflationary pressures elevated

for the coming months, warranting greater vigilance by the government and the RBI.

Though food inflation in July is perhaps the third highest since the new CPI series began in 2014, only 48 per cent of food items have inflation of above 6 per cent, and this includes 14 food items with inflation in double digits, it said.

Items like tomato, green chilli, ginger and garlic witnessed inflation of more than 50 per cent. Hence, the abnormal increase in prices of certain specific items led to high food inflation in July 2023.

"Tomato prices are likely to decline with the arrival of fresh stocks by the end of August or early September. Further, enhanced imports of tur dal are expected to moderate pulses inflation. These factors, along with the recent government efforts, can soon materialise moderation in food inflation in the coming months," the ministry said.

Going forward, while domestic consumption and investment demand are expected to continue driving growth, global and regional uncertainties and domestic disruptions may keep inflationary pressures elevated for the coming months, warranting greater vigilance by the government and the RBI, it added

Centre To Launch 'Mera Bill Mera Adhikar' GST Reward Scheme In 6 States, UTs From Sept 1

NEW DELHI: The government will launch the 'Mera Bill Mera Adhikar' invoice incentive scheme, which offers cash prizes from Rs 10,000 to Rs 1 crore, from September 1, starting with six states and Union Territories.

The scheme, which is aimed at motivating customers to ask for a bill every time they make purchases, will be launched in the states of Assam, Gujarat and Haryana; and the UTs of Puducherry, Daman & Diu and Dadra & Nagar Haveli, Central Board of Indirect Taxes and Customs (CBIC) said.

Invoice incentive scheme allows to earn cash prizes on upload of GST invoices, CBIC tweeted.

All invoices issued by Goods and Services Tax (GST) registered suppliers to consumers will be eligible for the 'Mera Bill Mera Adhikar' scheme, under which monthly and quarterly draws of lots will be made and winners will be eligible for cash reward prizes beginning



from Rs 10,000 to up to Rs 1 crore.

The minimum purchase value for the invoice to be considered for the lucky draw is Rs 200 and individuals can upload a maximum of 25 invoices in a month beginning September 1.

The 'Mera Bill Mera Adhikar' mobile app will be made available on both IOS and Android platforms.

The invoice uploaded on the app should have the GSTIN of the seller, invoice number, amount paid and tax amount.

The scheme is conceptualised in a way to incentivise citizens and consumers to ask for genuine invoices from the seller when making business-to-consumer (B2C) purchases of goods or services.

Horticulture Dept Expects Bumper Apple Crop In Kashmir This Year

SRINAGAR- The horticulture department expects a bumper apple crop of 21-22 lakh tonnes in the Kashmir valley this year on the back of introduction of new varieties and higher acreage.

However, apple dealers and growers are not on the same page with the department as they expect the production to be less the last year due to damage to the crops because of adverse weather conditions and diseases.

They have also called for the setting up of controlled atmosphere (CA) stores in the valley so that growers can earn better prices, especially during the off-season.

According to the horticulture department, apple production was 20 lakh tonnes in the last year.

"This year's apple production will be around 21-22 lakh tonnes compared to 20 lakh tonnes last year. This is because orchardists are going for high-density plantations. Of this, 90 per cent of the crop falls under A grade," Shafiqa Khalid, Deputy Director of the Department of Horticulture, said.

She said there were plans afoot to bring 5,500 hectares of land under 12 crops in the next five years. "Most of it will have apple plantations," she said.

However, an organisation of fruit growers and dealers feel that the yield might not be that high.

"Due to adverse weather conditions, production is less than the previous year. Around 40 per cent of the crop is damaged due to hailstorms and diseases. It is obvious if the production will be low the size of the fruit will be better but the results are



mixed in many areas of Kashmir. There is a dearth of rain currently which is needed to help in gaining colour on the fruit," Bashir Ahmad Basheer, President Fruit Growers and Dealers Association, said.

Basheer said there was a deficiency of CA stores in the valley, especially in north Kashmir. "North and central Kashmir areas are facing a shortage of CA stores. Most of the CA stores are in South Kashmir," he added.

The demand for CA stores is getting louder as a substantial part of last year's apple production was wasted due to the frequent closure of the Srinagar-Jammu national highway.

Shafiqa Khalid said the transportation issue has been taken care of.

"Previous year's highway blockade issue has been taken care of as we have created groups which consist of teams from the Department of Traffic Police, Horticulture Planning and Marketing and Administrative Department of Horticulture. Everyone is working in coordination to keep close vigilance on the highway and other routes," she added.

ne added. She said there was a scheme under Mission for Integrated Development for Horticulture for setting up CA stores which will benefit the farmers by fetching them better returns during the off-season.

Basheer said there have been no problems so far this year.

While Kashmir valley contributes around 80 per cent of the apple production of the country, the erratic weather in Himachal and Uttarakhand has destroyed the crops in these two hill states, which is expected to translate into better prices for apples from the union territory.

"The market of Kashmiri apple is a bit better than that of Himachal Pradesh. The production is low in both Kashmir and Himachal Pradesh. In some areas, around 70 per cent of fruit has been damaged and in some only 10 per cent so in totality we can say around 30 per cent of fruit is damaged," he added.

Officials said 70 per cent of Kashmir's population is directly or indirectly dependent on horticulture, mainly apple cultivation. Although scab disease has hit high-density varieties of apple too, it has yielded satisfactory crops.

Centre Asks Onion Farmers Not To Worry About Export Curbs As Govt Restarts Procurement At Rs 2,410/Quintal

NEW DELHI: Consumer Affairs Minister Piyush Goyal on Wednesday alleged that some "political opponents" are creating a "wrong picture" about the export duty slapped on onion, and urged farmers not to worry as the Centre has restarted procurement at Rs 2,410/quintal for its buffer stock.

The minister asserted that the decision to impose a 40 per cent export duty on onion has been taken to protect the consumers' interest, but at the same time the Centre has also decided to purchase additional 2 lakh tonnes of onion from farmers to avoid any panic selling.

He also said the government will increase the size of the buffer stock and procure more from farmers if the need arise.

At a media briefing, Goyal announced that additional procurement of 2 lakh tonnes of onion for the buffer stock will be done at Rs 2,410 per quintal, which he said is an "historical rate" and much higher than the average Rs 1,800-1,900 per quintal the farmers normally get from exports.

"Some political opponents have been trying to present a wrong picture (about export curbs). I would urge all farmers in onion producing states not to worry and indulge in any panic selling. NCCF and NAFED have been directed to procure onion from farmers," Goyal said.

On August 19, the central government imposed a 40 per



cent export duty on onion to restrict outward shipments and boost the local availability amid apprehension about the kharif output and signs of firming of retail prices. It also decided to increase the size of the buffer stock of onion to 5 lakh tonnes for 2023-24 from the earlier 3 lakh tonnes which has already been procured.

The decision on export duty led to protests by farmers and traders in various parts of Maharasthra, especially in Nashik district.

The National Cooperative Consumers' Federation of India (NCCF) and the National Agricultural Cooperative Marketing Federation of India (NAFED) have recommenced the procurement operations in Maharasthra and Madhya Pradesh from Wednesday.

"Both consumers and farmers are important for us. ...The government has been taking decisions in the interest of both farmers and consumers," he said.

The minister said the Centre is constantly in touch with Maharasthra chief minister and two deputy chief ministers on this issue.

Govt Allocates Extrsa 2 Lakh Tonnes Sugar To Mills For Sales This Month

NEW DELHI: The Centre has allocated an additional quota of 2 lakh tonnes of sugar for sale during this month, over and above 23.5 lakh tonnes already allotted to mills, as part of its efforts to boost domestic supply and keep prices under check in the festive season.

"Keeping in view the strong demand for sugar for upcoming festivals of Onam, Raksha Bandhan, and Krishna Janmashtami, an additional quota of 2 lakh tonnes (over and above 23.5 LMT already allocated for the month of August 2023) is being allocated for the month of August 2023," an official statement said.

The additional sugar in the domestic market will ensure reasonable prices all over the country, it added.

Despite a 25 per cent increase in international sugar prices in the last year, the food ministry said that the average retail price of sugar in the country is about Rs 43.30 per kilogram and is likely to remain in range bound only. There has been less than 2 per cent annual inflation in the country in sugar prices in the last 10 years.

During the current sugar marketing year (October-September) 2022-23, India is es-



timated to have produced 330 lakh tonnes of sugar after a diversion of about 43 lakh tonnes for ethanol production. Domestic consumption is expected to be around 275 lakh tonnes.

"At the present stage, India has sufficient sugar stock to meet its domestic demand for the remaining months of the current 2022-23 season and optimum closing stock of 60 lakh tonnes (sufficient to meet sugar consumption for two-and-a-half months) will be available at the end of this season i.e. September 30, 2023," the statement said.

The recent increase in sugar prices will cool down soon as each year during July-September, just before the next season, prices increase and then come down on the start of cane crushing.

"Thus, the price rise in sugar

is very nominal and for a short duration," the ministry said.

Pakistani Rescuers Free 2 Children From Dangling Chairlift; 6 More Trapped

Peshawar, Aug 22: Two children were rescued by commandos on Tuesday more than 10 hours after they were trapped along with six others 900 ft mid-air when the wires of a chairlift snapped in northwest Pakistan as the army suspended aerial rescue operation due to darkness and launched a ground

mission to save others.

The two children were rescued by the Army's Special Services Group amid rough weather and following multiple attempts shortly before the sunset as part of an operation that involved four helicopters in the mountainous area in the Khyber Pakhtunkhwa's Battagram district, Dawn news portal reported.

Citing state broadcaster PTV News, it reported that the army called off the aerial operation due to "night and weather conditions" and launched rescue efforts through "alternative means".

The children were headed to school when the incident occurred at around 8 am in Battagram district's Allai tehsil.

According to Allai tehsil chairperson Mufti Gulamullah, the

chairlift was privately run by locals for transportation across the river as there were no roads or bridges in the area, the Express Tribune newspaper reported.

"A chairlift stuck at a height of about 900 ft midway due to breakage in one of its cables in Battagram. Eight persons, including 6 children, (are) stranded," the Geo News reported citing a statement from the

National Disaster Management Authority (NDMA).

Authorities have decided to continue the rescue operation from the ground with the help of the Pakistan Army so that the operation may be continued during night.

Rescue workers on ground began the process of laying down nets to prepare for any mishaps, the report said.

State-run Radio Pakistan reported that food and drinks are being supplied to the stranded

people via a small chairlift.

Television footage aired around 4:45 pm showed a rescuer suspended from a sling being lowered and positioned adjacent to the chairlift, Dawn news portal reported. The rescue mission is complicated due to gusty winds in the area and the fact the

helicopter's rotor blades risk further destabilising the lift, it said.

The chairlift is dangling in the middle of a deep ravine surrounded by towering mountains and a rocky surface, along with the Jhangri river beneath it.

Earlier, two helicopters belonging to the Pakistan Army and the Pakistan Air Force arrived at the site for a rescue operation.

mitigation and response planning had caused irreparable physical and economic losses to the community.

"Although disaster management systems may have been developed at various administrative levels, their functionality and effectiveness to respond to the disaster are still uncertain," it said.

The report revealed that although heavy rainfall was the triggering factor of floods in the valley, the impact of the disastrous event was aggravated by other factors, including the rapid urbanization, encroachment of water bodies and land adjoining river banks, the disappearance of wetlands, etc. has blocked the natural drainage patterns making the situation worse.

The study noted that despite several events of floods in Jammu and Kashmir, the region has not been identified as flood prone. Installation of flood forecasting and early warning systems at appropriate locations and their regular monitoring has been a big challenge, it said.

Notably, Jammu and Kashmir has three hydrological stations—Sangam, Ram Munshi Bagh, and Safpora installed by Irrigation and Flood Control Department on Jhelum River which runs through the Valley. However, the local authorities, according to the report, could not read the alarming signals of the rise in the water level as these stations were used to only monitor the flow of water from India to Pakistan and are not tagged as flood forecasting stations.

"Had the information by these stations provided flood forecasts to the state authorities, they would have prepared for flood recovery by providing an early window to evacuate people from low-lying areas, deployment of special teams and arrangement of relief supplies," the study noted.

The report said that failures in the flood forecasting systems and inadequacy of the existing early warning system probably contributed to the severity of the floods. The situation could have been controlled by proper communication networks and last-mile connectivity, it said.

The report suggested long-term measures in planning the flood preparedness, response and rehabilitation efforts in a well-coordinated manner by following the principle of Building Back Better.

The report said that the wetlands which acted as a natural sponge during the floods and shared the Jhelum waters are lost.

"About 44.4% of the lakes and wetlands have been lost in the suburbs of Srinagar during the turn of the 21st century and has affected the microclimate of the city, besides exposing them to the incurrent floods," the report said.

"The wetland has receded consistently and undergone tremendous land-use change owing to siltation coupled with floods and human interference. The Hokersar wetland has experienced fragmentation and changes in land use/land cover due to excessive siltation and biotic interference over the last four decades," the report said.

The study noted that most of the developmental activities are usually undertaken with utter disregard to environmental, geological, geomorphological and ecological conditions of the region.

"The ongoing construction boom is being fed by indiscriminate mining of sand, gravel, and boulders from riverbeds, which intends to weaken the existing flood control infrastructure which, in turn, makes the rivers more vulnerable to flash floods," it said.

2300 Arrested

data compiled by the police, a total of 2,327 terrorists and their associates were arrested post the Article 370 abrogation compared to 427 in 2015-2019.

Coupled with a 23 per cent decrease in terrorist recruitment from 597 in 2015-2019 to 461 in 2019-2023 and killing of hundreds of terrorists, the police said, the trend suggested improved intelligence gathering, proactive measures and an effective approach to counter-terrorism operations to disrupt the terror

Separately, officials said over 675 terrorists were killed in separate encounters with security forces from August 5, 2019 to June 2023, against over 740 in 2015-2019.

The police data exhibited a significant downward trend in the casualties among security personnel and civilians in the last four years.

Against the killing of 329 police and security personnel in terror attacks in 2015-2019, the number of fatalities had gone down by 56 per cent with 146 deaths reported post August 5, 2019.

The injuries to police and security personnel also indicated a decline of 68 per cent with 899 personnel reported injured in pre-Article 370 abrogation and 289 post-Article 370 abrogation period, the data stated.

The number of civilians killed in terrorist violence reduced from 119 in the pre-370 period to 107 in the post-370 period, reflecting a 10 per cent decrease. The instances of civilians killed during crossfire significantly decreased from 68 in the pre-370 to nine in the post-370 period, marking 87 per cent decrease, it said.

The data revealed that the number of civilians injured decreased from 263 in the pre-370 period to 175 in the post-370 period, rep-

resenting a 33 per cent decrease.

During the pre-Article 370 period, the region witnessed 162 grenade attacks. However, after the abrogation, the number reduced to 138, reflecting a 15 per cent decrease in such incidents, it said.

The number of IED blasts figures remained the same, with 19 such incidents reported in both pre and post-370 periods.

However, the casualties resulting from IED blasts significantly reduced from 57 in the pre-370 period to 13 in the post-370 period, indicating a remarkable 77 per cent decrease, the data said.

It stated that the stand-off fire and hit and run cases saw a notable decrease from 314 in the pre-370 period to 181 in the post-370 period, marking a 42 per cent decline, while the instances of weapon-snatching witnessed a substantial decrease, with the number dropping from 45 in the pre-370 period to 14 in the post-370 period, representing a 69 per cent decrease

The police said one of the most significant changes observed was the appreciable decrease in stone pelting incidents. The pre-370 period recorded 5,063 incidents, which significantly reduced to 434 in the post-370 period, marking a remarkable 91 per cent

The number of separatist-sponsored strike calls reduced from 339 in the pre-370 period to 46 in the post-370 period, reflecting a decrease of 86 per cent, the data said.

The encounters and counter-terrorism operations decreased from 423 in the pre-370 period to 342 in the post-370 period, representing a 19 per cent decrease.

The instances of abductions reduced from 28 in the pre-370 period to nine in the post-370 period, reflecting a 68 per cent decrease, while the incidents of arson saw a significant decrease, with the number dropping from 87 in the pre-370 period to 35 in the post-370 period, marking a 60 per cent decrease.

"The comparative analysis of the security indicators reveals a positive impact on the security situation in the region following Article 370 abrogation. Decreases in various security incidents highlight an improvement in public safety and the overall security landscape," the report said, highlighting the need for vigilant efforts in counter-terrorism operations and intelligence gathering.

It said a sustained focus on implementing effective security measures, enhancing community engagement and ongoing monitoring of security indicators will be essential to maintain and further improve the security situation.

Art- 370 Nevei

Jha, who has challenged the August 5, 2019 decision of the Centre to abrogate Article 370, raised the legal question about whether Article 370 ceased to operate or exist after the enactment of the Constitution of J&K and the dissolution of the constituent assembly.

This led the bench to raise queries on the legality of the submissions.

The bench, also comprising Justices Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surya Kant told Dwivedi that the court has to look at the Indian constituent assembly debates and the intent of the makers of the Indian Constitution in a manner in which the Article 370 was framed.

"I am arguing somewhat differently from what my friends have argued. They want some part of Article 370 to survive. My argument is that nothing survives. All the powers conferred under Article 370, I would show, cease to operate once the Constitution of Jammu and Kashmir was enacted," Dwivedi said.

The CJI said the consequence of the argument will be that the Constitution of India and its application to Jammu and Kashmir would "stand frozen as of January 26, 1957".

"Therefore, no further development in Indian constitutional law can at all apply, according to you, to the state of Jammu and Kashmir after 1957. How can that be acceptable?" he said.

The bench told Dwivedi, "You are asking us to read what is not there in Article 370. Your submission is that it will be frozen after the constituent assembly of J-K frames the Constitution but that does not appear to be following. We have to look at the constituent assembly debates in a manner in which Article 370 was framed."

Dwivedi said when the Article was framed, Jammu and Kashmir was in turmoil and the only legal entity was the state government and, therefore, the provision said there should be "consultation and concurrence" on the matters related to Union and concurrent list and those which do not fall under the Instrument of Accession.

"The constituent assembly was about to be set up. Hence, all the decisions which were taken in consultation and concurrence with the state government were to be placed before the constituent assembly of J-K. Therefore, Article 370 was a temporary provi-

sion," he contended.

The senior lawyer said looking at the provision and the constituent assembly debates, it can be clearly inferred that Article 370 was

temporary and ceased to exist after January, 1957.

The bench said what was being submitted was contrary to arguments advanced by others opposed to the abrogation as they said that the provision had acquired permanent status after the term of the state's constituent assembly ended.

"This is what is creating a problem. Perhaps our thinking in the manner which we have been tuned to think for the past 70 years is that there should be One Nation-One Constitution. But where is that prescribed? It should be prescribed in the Constitution which does not say so," the senior lawyer said.

CJI Chandrachud then asked can the court say that a speech made by a member of the constituent assembly, however weighty, represented the commitment of India to Jammu and Kashmir.

"This will have a bearing on the interpretation of the Constitution", the CJI said.

Justice Kaul also questioned Dwivedi on his line of argument and said according to him, Article 370 was a defunct provision and no purpose was served having it.

"Yet the provision continued to be there in the Indian Constitution. Constitution Orders (orders applying provisions of Indian Constitution to J-K) have been issued pre-1957 and post 1957. Yet nobody thought about removing it. The association of people with Article 370 was negatory and hence nothing survives. This is your argument?" Justice Kaul summed up Dwivedi's contentions.

Dwivedi told the bench that past practices would not justify the invalidity of a provision and this is a settled law.

"The law, as I understand, is that however long a past practice is if it is constitutionally illegal, it cannot be justified. What I am trying to show is the intent of our Constitution framers. We cannot read Article 370 dehors (other than) the intent is my question," he said.

Justice Kaul said it is difficult to accept that the constituent assembly debates amount to an assurance that Article 370 would dissolve itself after the Constitution of Jammu and Kashmir has been enacted and term of the state's constituent assembly comes to an end.

Senior advocate CU Singh, appearing for Mohammed Yousuf Tarigami and others challenged the enactment of the Jammu and Kashmir Reorganisation Act, 2019 and said the erstwhile state could not be divided into two union territories.

The hearing remained inconclusive and will continue on Wednesday.

Several petitions challenging the abrogation of the provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh - were referred to a Constitution bench in 2019.

J&K Setting

"We should take concerted action for more effective delivery of public services, benefits of welfare schemes, extending the benefits of self-employment schemes to youth and women and be adequately sensitive to their needs and aspirations," he added.

The LG directed the officers to ensure that there is no delay in extending revenue services like registration of property. He also sought the active participation of PRI members and other stakeholders in improving the literacy rate in the district.

"Our efforts for rapid progress in the education sector and increase in literacy rate can have its full impact only if PRIs, public and administration work together. This is the right time to move decisively in this direction," he added.

During his visit, the LG took a detailed review of various infrastructure projects including construction of Transit Accommodations for Kashmiri Migrant Employees and directed the concerned departments to expedite the implementation at the earliest.

He directed the district administration and all the line departments for saturation of old age, widow pensions, scholarships, marriage assistance schemes to eligible beneficiaries by organising special camps during Block Diwas.

"Effective implementation of development programmes for deprived sections of society, women, children and Specially-Abled is our top priority," he said.

Reviewing the progress of the Agriculture and allied sectors, the LG said that the Holistic Agriculture Development Program (HADP) will bring a new Agriculture revolution that is broad based and inclusive.

"The successful implementation of HADP is the responsibility of everyone associated with the sector," he said.

He further suggested the constitution of Cooperative Societies in every possible sector of rural areas to explore the possibilities for economic growth of the region. Besides, he directed the District Agriculture Officer for increasing the registration of farmers on Daksh Portal.

Reviewing the measures taken to promote tourism and industry sectors in the district, Sinha directed the officials to improve connectivity to tourist destinations of the district and effective measures to facilitate the tourists coming to Kulgam.

District Administration was directed to set up a help desk to facilitate establishment of Industrial units in the district. The LG asked the officials to hold regular meetings with banks and financial institutions for timely provision of credit under different government schemes. He further emphasized on promoting self-employment and extending support to aspiring youth of the district under the dedicated schemes of Mission Youth.

The meeting also discussed the utilisation of vacant Government buildings and encouraging youth to join NCC and Red Cross initiatives.

Later, the LG interacted with various public delegations including ULB, PRI representatives, Fruits Growers association, traders, transporters, Youth Club members, Bar Association, Gujjar Bakerwal and Pahari Community and assured speedy redressal of issues and specific grievances.

"For them it is a mistake to consider the object of punishment as being deterrent or reformative or preventive and nothing else. The truth is that some crimes are so outrageous that society insists on adequate punishment because the wrongdoer deserves it, irrespective of whether it is deterrent or not."

Meanwhile, the court also recommended the case of the victim to the Member Secretary, J&K Legal Service Authority for awarding the maximum compensation to the victim in terms of the J&K Victim Compensation Scheme, 2019.

"In view of the huge amount the victim has incurred on her treatment and the amount which is required for her further treatment, I deem it appropriate to recommend the case of the victim to the Member Secretary, J&K Legal Service Authority to award the maximum compensation to the victim in terms of the J&K Victim Compensation Scheme, 2019, of course subject to the adjustment of the interim compensation already paid to her under the scheme," the court said.

She said whatever her parents had saved

for her marriage; they disposed of everything besides the property to meet the expenses on her treatment."

As on date, she said, her father has spent Rs 37,16,508 on her treatment and does not

know how much more amount is needed for further treatment.

She also claimed that even from the Central lail, one of the convicts sent her a message

through an advocate from Anantnag, asking her to "compromise with him and marry her". She said that by the act of the convicts she

has become the story of every home.

She produced her photographs before the occurrence and after occurrence to make her point as to how beautiful she was before the occurrence and now to what extent her face has got disfigured. She stated that though, nothing can bring the glory of her physique back but, if the convicts, responsible for making her life a living hell, are given the maximum punishment prescribed under law, she would feel that justice has been done with her. 
said in a statement. Through the partnership, the EC seeks to address the challenges of urban and youth apathy towards voting.

Earlier, during the 2019 Lok Sabha elections, stalwarts such as MS Dhoni, Aamir Khan and Mary Kom had been the EC's national icons.

Outpost Al More Likely To Help Workers Than Take Their Jobs: UN



Artificial intelligence (AI) probably won't take over most people's jobs, but it will help automate certain duties, according to a United Nations study released on Monday.

Generative Al is capable of producing text, images, sounds, animation, 3D models and other data, which can potentially be used to complete or augment certain tasks.

"Most jobs and industries are only partially exposed to automation and are thus more likely

to be complemented rather than substituted by AI," the report by the UN's International

Labor Organization (ILO) said. This means that "the most important impact of the technology is likely to be of augmenting work," it continued.

The ILO calculated that 5.5% of jobs in high-income countries are potentially exposed to automation by generative AI, compared to 0.4% of jobs in low-income countries.

Clerical work most under threat

Nevertheless, the report

found that clerical work was most at risk of being impacted by generative AI.

A quarter of tasks in clerical roles are highly exposed to potential automation, according

to the ILO. This would particularly impact women, especially in wealthier countries.

"Therefore, for policymakers, our study should not read as a calming voice, but rather as a call for harnessing policy to address the technological changes that are upon us," the ILO said.

Delhi High Court Orders "End-Of-Life" Vehicles' Release On This Condition

New Delhi: The Delhi High Court on Tuesday directed the release of several seized "endof-life" vehicles on an undertaking by the owners to either permanently park them in private spaces or remove them from the city limits.

Justice Prateek Jalan was dealing with a batch of petitions against the seizure of cars by authorities for being in violation of judicial orders banning the use of petrol and diesel vehicles that are over 15 years and 10 years of age, respectively.

The court asked the Delhi government to frame a policy on dealing with such vehicles when owners are willing to assure that they would not be used here and give "due publicity" to the same.

It observed that the intention behind the policy was not to scrap the cars but ensure that the national capital is pollution free, and a balance has to be maintained between the right to use one's property and environmental interests.

"I am of the view that the petitioners' grievances can be balanced with the implementation of the orders of the NGT and Supreme Court by directing the release of the vehicles to owners subject to an undertaking to remove the vehicle from the territory of NCT of Delhi and not to ply/park them in public spaces within the NCT of Delhi," the court ordered.

"For parked cars, the petitioners will file an undertaking that they will not be plied or parked

in public space. Petitioners will provide evidence of private space either owned or leased," stated the court, adding that the enforcement officer concerned would facilitate the release of the vehicles of the petitioners

from the scrapping agency.

The court clarified that the undertaking to the transport department would state that the vehicles shall be towed or transported to the border of the NCT of Delhi for its removal, and that when the vehicle is registered in Delhi, the petitioner may apply for NOC for transfer of vehicles outside Delhi. Any breach of the undertaking by the owners would invite action from court, Justice Jalan said.

One of the petitioners argued that her vehicle, which has "deep sentimental value", was unauthorisedly and without the issuance of any prior notice

seized by the authorities earlier this year when it was merely parked outside her house.

The petitioner, represented by advocate Piyush Sharma and Aditya N Prasad, informed that she was not plying the car which purchased in the year 2000 and intended to convert it into an electric vehicle.

Similarly, another petitioner challenged the seizure of his 12-year-old diesel car which was "only parked for the purposes of denting, painting and other miscellaneous electrical work which was imperative in order to dispose of the car in another state".

The petitioner, represented by advocate Sahil Mongia, said that no law prohibits the mere keeping of old diesel vehicles and no prior notice was given to him before the vehicle was taken into possession.

Meanwhile, Delhi Transport

Minister Kailash Gahlot had on Monday directed the department secretary-cum-commissioner to stop seizing parked vehicles that have completed their stipulated life on the road.

Owners of such vehicles are fined if these are found plying on the roads. The minister said in a note that it is "unfortunate" that the transport department is continuing its drive to seize old vehicles, even if found parked on the road, and sending those for scrapping.

He cited "serious concerns" raised by the Delhi High Court in the matter while hearing petitions of people whose vehicles were seized by enforcement teams of the transport

Gahlot cited an office memo issued by the department dated June 27, saying the drive was not approved by the government.
