LAND FOR LANDLESS SCHEME

Only J&K Domiciles Eligible For Govt Land



Srinagar: In a significant development, the Lieutenant Governor-led administration on Thursday unveiled guidelines for allotment/ lease of land to landless beneficiaries of Pradhan Mantri Awas Yojana (Gramin).

The Revenue Department said on Thursday that five marlas of state land will be allotted on lease basis to landless PMAY (G)/Awas plus beneficia-ries out of Rural Development Department's permanent waiting list 2018-19.

Those eligible for allotment are people residing on state land; people residing on forest land; people residing in Rakhs and Farms; people in possession of custodian land; people residing on land already allotted by the Government near Dachigam Park for agricultural purposes, where construction is not permitted and any other category of cases who are otherwise eligible for Housing under PMAY-G, but don't have any land available for construction.

According to the guidelines, the deputy commissioner concerned shall allot 05 Marlas of state land to those who are domiciles of J&K.

"A person shall be considered landless if he is a domicile of J&K having a separate family and doesn't have land in his own name or in the name of any of his family members or is not

It further states that the deputy commissioner concerned shall lease out five Marlas of state land to the landless PMAY (G) beneficiaries who are figuring in the permanent waiting list 2018-19, surveyed by the Ministry of Rural Development, Government of India, and are otherwise eligible for housing assistance under PMAY(G)/Awas plus.

As per scheme guidelines, the land shall be granted on lease basis in terms of the Jammu and Kashmir Land Grants Act of 1960 and the Rules made thereunder. "The land shall be granted on lease on payment of a token amount of Rs 100/- per Marla as a one-time premium and a nominal amount of Rs 01/- per Marla per annum as ground rent, in relaxation of Jammu and Kashmir Land Grant Rules, 2022," reads the order.

The lease shall be for a period of 40 years, extendable further for a period of another 40 years, subject to the fulfillment of all codal formalities/norms. "However, if a person fails

to build house on allotted land within a period of two years, such lease shall be cancelled forthwith," reads the order.

ARTICLE-370 HEARING 'No Constitutional Fraud': Centre **Tells SC**

New Delhi: Commencing their arguments in support of abrogation of Article 370 in the Supreme Court, the Centre's top law officers Thursday asserted there was no "constitutional fraud" in annulling the provision that accorded special status to the erstwhile state of Jammu and Kashmir.

The five-judge constitution bench headed by Chief Justice D Y Chandrachud, which heard their contentions at length, told them they will have to justify the procedure adopted for abrogation as the court cannot postulate a situation "where the ends justify the means".

The petitioners opposing the repeal of Article 370 have been insisting that the provision could not have been abrogated, as the term of the Jammu and Kashmir Constituent Assembly, whose concurrence was required before taking such a step, ended in 1957, after it had drafted the erstwhile state's Constitution. 

Nearly Half Of Parents Have 'No Idea' How To Raise Kids Without Smartphone: Study

Nearly half of parents (43 per cent) have "no idea" how people raised their kids before the invention of smartphones, a new study has said.

According to the study by OnePoll.com in collaboration with phone company Three UK, parents depend heavily on smartphones when it comes to raising their children.

The study gathered data from 1,000 participants with children aged 6 and under.

About 61 per cent of respondents said that smartphones are the most helpful tool in parenting, while 77 per cent admitted to using their phones up to 77 times per week to search for childcare advice.

The study also revealed that mothers and fathers regularly use smartphones to shop for their kids.

"We know the important role phones play in people's lives. As the research shows, this role becomes even more important after you've had a child-your phone becomes a critical addition to your family," said Aislinn O'Connor, Marketing Director at Three UK.

"Playing the role of entertainer, doctor, connector



We know the important role phones play in people's lives. As the research shows, this role becomes even more important after you've had a child-your phone becomes a critical addition to your family

and much more in everyday life," she added. Moreover, the study found that the widespread use of smartphones has resulted in an increase in data

consumption.

Due to increased phone usage, nearly 34 per cent of parents reported having to upgrade their data plans. Parents continue to exceed their monthly data limits by five gigabytes on average. Parents downloading

entertainment for their children is one of the primary causes of this increase in data usage.

Streaming and downloading content for children was identified as one of the most significant data drains, with an average of 12 hours per week dedicated to these activities, according to the study.

Apart from entertainment, parents use their smartphones for a variety of purposes-about 67 per cent of parents use their phones primarily to take photos, 62 per cent enjoy sending WhatsApp messages, and 60 per cent use their phones to check the weather forecast.

Chinar Branch Falls On Residential Wall In Srinagar No Loss Of Life, Injury Reported

Srinagar: A major tragedy was averted after a large branch of a rotten Chinar tree fell on the wall of a residential house located in Gousia Colony Baghat-e-Kanipora on the outskirts of Srinagar on Thursday.

Residents of the area said that panic gripped the entire locality of Gousia Colony sector 1, Bagaat-e-Kanipora on city outskirts, when a huge branch of rotten Chinar tree fell on the wall and shop of a residential house of Abdul Majeed Wani.

The family members of Wani, who is a heart patient, screamed due to fear as the big Chinar branch fell on the HT wire before hitting the ground. A would-be groom, who is scheduled to get married in a few days, was passing through the road in a car, miraculously escaped. However, his mobile phone and car suffered damage.

Wani said they have been moving from pillar to post since past many years requesting the higher ups to remove the Chinar tree. "It is a big threat to many houses and also to those who walk on the road." he said. adding that repeated requests made to concerned Deputy Commissioner haven't

yielded anything. "In the incident, the outer wall of the house suffered damage. The newly electric meter and HT wires suffered damages as well. My son runs a fair price rice shop which also suffered damage," he said.

Locals also said the authorities shouldn't delay removal of Chinar tree as the same might become the cause of a serious tragedy, besides damages to property as well.

"This tree is rotten from the bottom and should be cut down immediately for the interests of inhabitants," he said, adding we are thankful to Almighty that no loss of life or injury to any individual took place as otherwise, little kids play under the shade of this rotten tree and luckily all of them had gone to private tuition when the incident took place.

Concerned Tehsildar Mudasira said that she will go for site inspection tomorrow and ensure that the tree is cut down for the safety of people living in the area.

"The case stands forwarded to higher ups already. Let me visit the spot myself tomorrow," she said. Meanwhile, locals of the Gousia Colony Sector 1, Bagaat-e-Kanipora threatened to block the main road if authorities failed to address the grave issue.

Well after "Operation Bluestar" my mother-in-law knew she was going to be killed. She knew that her days were numbered. She had spoken to my son (Rahul) In particular, Sonia Gandhi said in an interview to 'Star Talk' programme.

The late Prime Minister then spoke to my husband and I, and gave us instructions on what to do when this would happen, Sonia Gandhi said, adding she gave us instruction on her funeral, on what she wanted to be done.

Sonia Gandhi corroborated what P.C. Alexander had written in a book that she did not want Rajiv Gandhi to become Prime Minister and had literally begged him not to take it up because he would also be killed.

My husband answered "I would be killed in any case," she said. Congress President narrated in detail the moments after the Indira Gandhi was assassinated in her Prime Ministerial residence in 9184 and how she felt when her husband was killed in Spiperumbudur in the midst of an election campaign.

Board examinations will be conducted twice a year with students having the option to retain the best score, while class 11 and 12 students will have to study two languages instead of one, according to the Ministry of Education's new curriculum framework.

"In classes 11 and 12, students will have to study two languages and one of them has to be an Indian language," the final NCF (National Curriculum Framework) document accessed by PTI said.

Noida Call Centre Duping US Citizens Busted, 84 Arrested

NOIDA: The Noida police on Thursday said they have arrested 84 people, including 36 women, after a raid at a call centre on charges of duping US citizens of crores of rupees by pretending to be American government officials.

The accused had a database of around five lakh US citizens that included their names, contact numbers and some financial details which were used to target them and take them into confidence, they said.

The raid was conducted at the call centre located in Sector 6, having a capacity of 150 desktops, around 5 pm on Wednesday over inputs of such illegal operations being carried out from a facility during night, Deputy Commissioner of Police

lieved to be the masterminds behind this call centre have been identified but are at large, the officer said.

The US embassy has also been informed about it, while formal communication with the Federal Bureau of Investigation and Interpol is being established, the police said.

On the gang's modus operandi, Chander said they interacted with US citizens after contacting them using voice messages in which the callers would scare the gullible Americans by saying their 'social security number' -- a unique identity given by the government – has been "compromised".

"The gang would then tell the US citizens that for assistance in fixing the problem, they should press 1 on their phones after which the call would land at their call centre (in Noida) Using a software, these people talked to them and shared their personal details, further convincing them that they are government officials," he said. Once trapped, the gang would tell the gullible people that they can use the help of "US Marshals" to get rid of the problem. If people agreed, they were put in touch with "US Marshalls", who again would be the gang members disguising themselves as American government officials, the DCP added.

Supreme Court Frees UP Man Facing Death Penalty For Killing Son, Brothers

The Supreme Court has set free **I** a death row convict, acquitting him of the charge of setting afire his son and two brothers, who were allegedly against his second marriage, at his Bijnore home in 2014, saying the dying declarations of two victims were not in sync with the testimonies of key witnesses.

The top court also dealt in detail with the legal principle on dying declaration and its trustworthiness on the presumption that a person on death bead does not lie.

"Dying declaration while carrying a presumption of being true must be wholly reliable and inspire confidence. Where there is any suspicion over the veracity of the same or the evidence on record shows that the dying declaration is not true it will only be considered as a piece of evidence but cannot be the basis for conviction alone." a bench comprising justices B R Gavai, J B Pardiwala and Prashant Kumar Mishra said in its 36-page judgement.



The trial court had relied upon the dying declarations of Irshad and Islamuddin naming Irfan as the person who set them on fire.

While allowing Irfan's appeal, the top court referred to the legal position and judgements, both Indian and foreign, on trustworthiness of dying declarations in a case hinging on circumstantial evidence.



A Giant Leap For India

ndia achieved an unparalleled feat by successfully landing the Vikram lander of the Chandrayaan-3 mission on the south polar region of the moon. The achievement not only cements India's position at the forefront of lunar exploration but also highlights the nation's commitment to pushing the boundaries of scientific knowledge and space exploration.

As the Vikram lander touched down on the moon's uncharted south polar terrain at 6:03 pm, India scripted its name as the first country to achieve such a feat. This remarkable endeavor catapults India into the elite group of nations capable of lunar landings, with only the United States, Russia, and China preceding its achievement. This mission, with a relatively affordable price tag of \$74.6 million, stands in stark contrast to the enormous budgets of major spacefaring nations. This success not only emphasizes India's technical prowess but also underlines its ability to achieve more with less. Therefore. the mission's significance extends far beyond national pride, as it represents a giant leap forward for global lunar exploration efforts.

Prime Minister Narendra Modi applauded the ISRO for the successful moon landing. He said that the achievement sounded the bugle for a developed India. The PM, who is on an official visit to South Africa to attend the BRICS Summit, joined the scientists gathered at ISRO's Telemetry, Tracking and Command Network (ISTRAC) to view Chandrayaan 3's moon landing. Earlier he suggested the creation of a BRICS space consortium at the summit. The proposal will now be taken more seriously after Chandrayaan 3's success.



Saudi-Iran Ties on Mend

Iran and Saudi Arabia have started a new chapter of cautious and incremental diplomatic exchanges to revive the strained bilateral ties, which broke down in 2016

audi Arabia's Crown Prince Mohammed bin Salman (MbS) met Iran's Foreign Minister Hossein Amir Abdollahian, on 18th August, Riyadh. The meeting was the first in a series of high-level talks since both countries reconciled in March this year, after years of bitter rivalry that destabilised the region, in a peace deal brokered by China.

Saudi Arabia broke ties with Iran in 2016 after protesters attacked its embassy in Tehran in retaliation for Riyadh's execution of a prominent Shiite cleric, Nimr Al Nimr.

Rivalry between Iran's revolutionary, Shi'ite Muslim leaders and Saudi Arabia's Sunni ruling family dominated the Middle Eastern regional politics for years as they competed for influence in Iraq, Syria, Lebanon, Yemen and Bahrain.

After the meeting, Iran's semi-official news agency Tasnim reported Abdollahian as saying the de facto Saudi ruler had accepted his invitation to visit Tehran. This shows how MbS has pushed to reorient the Saudi foreign policy in recent years amid signs of troubles in its historically close relationship with the United States.

Earlier, the Saudi Foreign Minister Prince Faisal visited Tehran in June and said he hoped Iranian President Ebrahim Raisi

also retained good relations with Iran. This month it succeeded in getting China to attend a diplomatic meeting on Ukraine that Beijing had earlier avoided.

Iran also hopes that the Houthis in Yemen will be legitimised by the new relationship and that Iran's role in Iraq, Syria and Lebanon will grow. Iran also hopes to undermine the U.S. and Israel, through this reconciliation. These strategies are stated openly in Iran where officials boast about the decline of U.S. influence in the region.

However, Iran may not be the only one getting what it wants. Saudi Arabia also has an agenda and to achieve it, it has sought to reorient its policies in the region.

In addition Riyadh's independent policy now includes outreach to China and Russia and also an attempt to broker more deals in the region and abroad. This comes with increasing reports about positive development in potential Israel-Saudi ties.

Iran's attempts at inroads in Riyadh are not only for Tehran's benefit. Saudi Arabia also has seen how balancing ties with Iran and other countries can increase its clout in the West; this was the method that Qatar and Turkey have used in the past. Therefore, managing expectations is important for Iran and Saudi Arabia. both.

Meanwhile, Kuwait's Foreign Minister Sheikh Salem Abdullah ous countries continues to destabilise those countries. Iran also seeks to incite others against Israel and create tensions in the West Bank by using groups like Palestinian Islamic Jihad.

Iran's hope is to use this road to erode Saudi Arabia's room for manoeuvre relating to a potential deal with Israel. Riyadh is aware of all these machinations and therefore it is keeping expectations modest in terms of the incremental reconciliation with Tehran. Meanwhile, it also understands that cutting off ties with U.S. in one go may affect its defence preparedness.

Meanwhile, Talal Al Otaibi, an aide to the Saudi defence minister, met with Aziz Nasirzadeh, the deputy chief of staff of Iran's armed forces, during the sidelines of the 11th Moscow Conference on International Security, last week, according to a post by the Saudi defence ministry on the social media platform X. During the meetings, the officials reviewed bilateral relations in the defence and security fields, as well as ways to improve them, the ministry said. This shows that MbS is adopting prudential approach for the future and not putting all eggs in one basket, instead he is trying to spread the spectrum by easing relations with old rivals and break the U.S. hegemony in the region, by engaging with Russia and China, along side.

On the moon, over the moon

t 5.40 p.m. on August 23, the Chandrayaan-3 lander was a 1.7-tonne hunk of metal, plastic, and glass speeding in an orbit some 30 km above the moon. But in the next 23 minutes, it had made history by slowing down, righting itself, and — guided by a suite of sensors and actuators - gently descending to the moon's surface. As it touched down shortly after 6 p.m., people gathered at the various Indian Space Research Organisation (ISRO) centres, and across India were jubilant. India is only the fourth country in history to have softlanded a spacecraft on the moon, and the first to have done so in the moon's South Polar region. The feat illustrated a simple fact of complex space flight missions: by virtue of their enormous hunger for resources but at the same time capacity for caprice, succeeding at them is indistinguishable from a triumph of human will. That is why they are capable of galvanising people - as Chandrayaan-3 has now done for India. The immediate implication of the Chandrayaan-3 lander now sitting on the moon is that ISRO took away the right lessons from the failure of the preceding mission, Chandrayaan-2. In September 2019, as the Chandrayaan-2 lander was 2.1 km above the lunar surface, ISRO lost contact. Based on data transmitted by the lander until then and that from other sources, including the Chandrayaan-2 orbiter, ISRO pieced together the distal causes of the lander's premature demise. Experts at ISRO then modified 21 subsystems to give rise to the upgraded Chandrayaan-3 lander. The latter is particularly distinguished by the redundancies built into it: if one component or process had failed, another would likely have taken over.

Taking a broader view of time, Chandrayaan-3 sits at an important juncture. India is now a member of the Artemis Accords, the U.S.-led multilateral effort to place humans on the moon by 2025 and thereafter to expand human space exploration to the earth's wider neighbourhood in the solar system. Given the firsts that India has now achieved, it has an opportunity to lead the other Artemis countries interested in maximising the contributions of the space sector to their economies, alongside the U.S. While Russia and India were not racing to land on the moon this week, the failure of Russia's Luna-25 spacecraft on August 19 foretells the country's ability to contribute in more limited fashion, in this decade at least, to the International Lunar Research Station programme, which it leads together with China as a parallel axis to the Artemis Accords The Hindu

would visit the kingdom at the "appropriate time".

Apparently, after years of rivalry, and with some of the main regional arenas for their competition more stable than in previous years, both sides have reason to change tack.

Iran's Supreme Leader Ayatollah Ali Khamenei wants to end political and economic isolation imposed by the United States and saw new relations with Saudi Arabia as a way to do so, Iranian officials have been quoted as saying. Saudi Arabia had meanwhile

lost confidence in the U.S. commitment to shared regional security concerns and wanted to bolster ties with China, which has Al-Jaber Al-Sabah praised the Iranian visit, according to Arab News. Kuwait has taken a very pru-

dent view of things in the region over the last decades, watching tensions between Riyadh and Tehran, from the periphery. Kuwait also is more hostile to Israel than the UAE and Saudia. Therefore Kuwait views the reconciliation as a huge potential benefit for the Gulf.

However, we cannot ignore Israel's view on the latest developments. In a report published by Jerusalem Post, the newspaper opined that Iran-Saudi reconciliation could only go so far. There are many different issues in the region and Iran's role in numer-

This meeting between top defence officials creates an impression that things may move at a fast pace in the near future between the two old regional rivals, but they will be more in tune rather than opposing one another, and the main casualty in this might be the waning of the American influence in the region.

When partners approach the relationship from a place of emotional abundance, they are better equipped to offer genuine care and support to each other.

This includes fostering emotional self-awareness, working on self-forgiveness, building self-esteem, and enhancing self-efficacy. 4. Assertiveness as Part of Self-Compassion:

Unlocking The Secret To A Good Life The Path To Fulfillment And Happiness

The Conversation

w do we live good, fulfilling lives? Aristotle first took on this question in his Nicomachean Ethics arguably the first time anyone in Western intellectual history had focused on the subject as a standalone question.

He formulated a teleological response to the question of how we ought to live. Aristotle proposed, in other words, an answer grounded in an investigation of our purpose or ends (telos) as a species.

Our purpose, he argued, can be uncovered through a study of our essence the fundamental features of what it means to be human.

Ends and essences

Every skill and every inquiry, and similarly every action and rational choice, is thought to aim at some good; Aristotle states, and so the good has been aptly described as that at which everything aims.

To understand what is good, and therefore what one must do to achieve the good, we must first understand what kinds of things we are. This will allow us to determine what a good or a bad function actually is.

For Aristotle, this is a generally applicable truth. Take a knife, for example. We must first understand what a knife is in order to determine what would constitute its proper function.

The essence of a knife is that it cuts; that is its purpose.

We can thus make the claim that a blunt knife is a bad knife if it does not cut well, it is failing in an important sense to properly fulfil its function. This is how essence relates to function, and how fulfilling that function entails a kind of goodness for the thing in question.

Of course, determining the function of a knife or a hammer is much easier than determining the function of Homo sapiens, and therefore what good, fulfilling lives might involve for us as a species.

Aristotle argues that our function must be more than growth, nutrition and reproduction, as plants are also capable of this. Our function must also be more than perception, as non-human animals are capable of this. He thus proposes that our essence what makes us unique is that humans are capable of reasoning.

What a good, flourishing human life involves, therefore, is some kind of practical life of that part that has reason. This is the starting point of Aristotle's ethics.

We must learn to reason well and develop practical wisdom and, in applying this reason to our decisions and judgements, we must learn to find the right balance between the excess and deficiency of virtue.

It is only by living a life of virtuous activity in accordance with reason, a life in which we flourish and fulfil the functions that flow from a deep understanding of and appreciation for what defines us, that we can achieve eudaimonia the highest human good.

Existence precedes essence

Aristotle's answer was so influential that it shaped the development of Western values for millennia. Thanks to philosophers and theologians such as Thomas Aquinas, his enduring influence can be traced through the medieval period to the Renaissance and on to the Enlightenment.



During the Enlightenment, the dominant philosophical and religious traditions, which included Aristotle's work, were reexamined in light of new Western principles of thought.

Beginning in the 18th century, the Enlightenment era saw the birth of modern science, and with it the adoption of the principle nullius in verba literally, take nobody's word for it which became the motto of the Royal Society. There was a corresponding proliferation of secular approaches to understanding the nature of reality and, by extension, the way we ought to live our lives.

One of the most influential of these secular philosophies was existentialism. In the 20th century, Jean-Paul Sartre, a key figure in existentialism, took up the challenge of thinking about the meaning of life without recourse to theology.

Sartre argued that Aristotle, and those who followed in Aristotle's footsteps, had it all back-to-front.

Existentialists see us as going about our lives making seemingly endless choices. We choose what we wear, what we say, what careers we follow, what we believe. All of these choices make up who we are. Sartre summed up this principle in the formula existence precedes essence.

The existentialists teach us that we are completely free to invent ourselves, and therefore completely responsible for the identities we choose to adopt. The first effect of existentialism, Sartre wrote in his 1946 essay Existentialism is a Humanism, is that it puts every man in possession of himself as he is, and places the entire responsibility for his existence squarely upon his own shoulders.

Crucial to living an authentic life, the existentialists would say, is recognising that we desire freedom above everything else. They maintain we ought never to deny the fact we are fundamentally free. But they also acknowledge we have so much choice about what we can be and what we can do that it is a source of anguish. This anguish is a felt sense of our profound responsibility.

The existentialists shed light on an important phenomenon: we all convince ourselves, at some point and to some extent, that we are bound by external circumstances in order to escape the anguish of our inescapable freedom. Believing we possess a predefined essence is one such external circumstance.

But the existentialists provide a range of other psychologically revealing examples. Sartre tells a story of watching a waiter in a cafe in Paris. He observes that the waiter moves a little too precisely, a little too quickly, and seems a little too eager to impress.

Sartre believes the waiter's exaggeration of waiter-hood is an act that the waiter is deceiving himself into being a waiter.

In doing so, argues Sartre, the waiter denies his authentic self. He has opted instead to assume the identity of something other than a free and autonomous being. His act reveals he is denying his own freedom, and ultimately his own humanity. Sartre calls this condition bad faith.

Likely Impact Of Food Price Shock On Overall Inflation Prompted RBI To Keep Benchmark Rates Unchanged

MUMBAI: The possibility of a second round impact of food price shocks on the overall inflation prompted Reserve Bank Governor Shaktikanta Das to opt for the status quo on benchmark interest rate at the bi-monthly monetary policy review earlier in the month. The Reserve Bank at

its last bi-monthly monetary policy committee (MPC) meeting on August 10 decided to keep the benchmark interest rate (repo rate) unchanged at 6.5 per cent citing inflationary concerns.

All six members including M D Patra. Shashanka Bhide. Ashima Goyal, Jayanth R Varma and Rajiv Ranjan voted for status quo on the policy rate.

"Our task (of containing inflation) is still not over. Given the likely short-term nature of the vegetable price shocks,

monetary policy can look through the first-round impact of fleeting shocks on headline inflation.

"At the same time, we need to be ready to pre-empt any second-round impact of food price shocks on the broader inflationary pressures and risks to anchoring of inflation expectations," opined Das, as per the minutes of the meet-

ing released by the RBI on Thursday. According to RBI Deputy Governor ensuring Patra, the sustained easing of core inflation was crucial to the MPC's objective of bringing inflation down to the target

"This objective should not be undermined by supply shocks that show any signs of persisting and getting broader-based," he argued while voting for maintaining the status quo on the policy rate and for persevering with the withdrawal of monetary policy accommodation.

Today we can safely say that all four are likely to have lower growth rates than India in the foreseeable future.

work aims to assess vulnerabilities, minimise risks and enhance resilience.

CBI Books Visa Power For Bank Fraud Of Rs 1,964 Crore



Jio, Airtel Drive Telecom Subs Base In India Rose To 1,173.89 Mn In June

NEW DELHI: Telecom subscriber base in the country grew marginally to 1,173.89 million at the end of June on account of new customer additions led by Reliance Jio, sector regulator Trai said on Thursday.

The subscriber base growth was driven by mobile telephony where Reliance Jio added over 2.27 million new customers and Bharti Airtel added 1.4 million customers.

"The number of telephone subscribers in India increased from 1,172.57 million at the end of May-23 to 1,173.89 million at the end of June-23, thereby showing a monthly growth rate of 0.11 per cent," the Telecom Regulatory Authority of India (Trai) said in its monthly subscriber report. However, the overall

growth was mitigated by



the loss of subscribers by state-owned BSNL, MTNL and Vodafone Idea (VIL).

BSNL lost 1.87 million mobile subscribers, VIL lost 1.28 million subscribers and MTNL (1.52.912 subscribers). The net addition in wireless subscribers of telecom operators in the month of

Iune was 3.73.602. "Total wireless subscribers increased from 1,143.21 million at the end of May-23, to 1,143.58 million at the end of June-23, thereby register-

ing a monthly growth rate of 0.03 per cent," Trai said. After a marginal decline in May, wireline connections increased in June. The growth in the wire-

line segment was led by AP-

FPL which added 6,56,424 new connections. It was followed by Reliance Jio with the addition of 2,08,014 connections, Bharti Airtel (1,34,021), V-Con Mobile

and Infra (13,100), Tata Teleservices (12,617) and Quadrant added 6,540 connections in June. The total broadband subscribers increased to 861.47 million at the end of June 2023 from 856.81 million at the end of May with a

monthly growth rate of 0.54 per cent, the report said. "Top five service providers constituted 98.37 per cent market share of the

total broadband subscribers at the end of June-23. These service providers were Reliance Jio Infocomm Ltd 447.75 million, Bharti Airtel 248.06 million, Vodafone Idea 124.90 million, BSNL 24.59 million and Atria Convergence 2.16 million," the report said.

ED Files Charge Sheet Against Supertech Chairman R K Arora

NEW DELHI: The Enforcement Directorate (ED) Thursday filed a charge sheet against R K Arora, chairman and promoter of real estate major Supertech Group, his company, and eight others in a money laundering case, accusing them of hatching a "criminal conspiracy" to cheat home buyers.

They have been accused of defrauding at least 670 home buyers of Rs 164 crore.

nearly 100-page The complaint, prosecution ED's equivalent of charge sheet, was filed before Special Judge Devender Kumar Jangala, claiming there was sufficient evidence to prosecute Arora for laundering money. The court posted the matter for August 28 for taking cognisance of the charge sheet.

Arora was arrested on

June 27 under the criminal sections of the Prevention of Money Laundering Act (PMLA) after three rounds of questioning.

money-laundering The case against the Supertech group, its directors and promoters stems from a clutch of FIRs registered by police in Delhi, Haryana and Uttar Pradesh.

ED's Special Public Prosecutor N K Matta and advocate Mohd Faizan Khan had told the court that the antimoney laundering agency was probing the matter related to 26 FIRs registered by the Economic Offences Wing (EOW) of Delhi, Haryana and Uttar Pradesh police against Supertech Ltd. and its group companies for alleged criminal conspiracy, cheating, criminal breach of trust and forgery.

According to the charge sheet, the company and its directors hatched a "criminal conspiracy" to cheat people by collecting funds from prospective home buyers as advance against flats booked in their real estate projects.

The company allegedly did not adhere to the agreed obligation of providing possession of the flats on time and "defrauded" the general public, the agency said, adding the funds were collected by Supertech Limited and other group companies.

The company also took project-specific term loans from banks and financial institutions for the purpose of construction of housing projects, the ED said.

However, these funds were "misappropriated and diverted" for buying land in the name of other group companies which were pledged as collateral to borrow funds from banks and financial institutions, it added.

CS Directs NHAI For Immediate Improvement Of National Highway From Jammu To Kathua

Srinagar: Chief Secretary, Dr. Arun Kumar Mehta on Thursday took a review meeting with senior functionaries of National Highway Authority of India (NHAI) and Government of J&K to review the condition of road connectivity along the NH-44 from Jammu to Kathuaand to deliberate upon immediate steps required for improving the road condition to make the journey of commuters comfortable.

The review meeting was attended by Chairperson, NHAI, Santosh Kumar

Yadav, Principal Secretary PW(R&B) Department, Shailendra Kumar, ADGP Jammu, Mukesh Singh, Divisional Jammu, Ramesh Commissioner Deputy Commissioners, Kumar. Samba/Kathua, Regional Officer, NHAI and other senior officers of UT and NHAI.

At the outset, the Chairperson, NHAI briefed all present regarding the ongoing works on the National Highway-44, the current status of road connectivity from Jammu to Kathua, efforts being made to reduce the travel time from Jammu to Kathua and to re-

store the Tarnah Bridge. Thereafter, the Chief Secretary sought details of the stretches of the NH-44 which were majorly affected due to monsoon as also the ongoing works and reviewed the actions being taken to ease the travel of the

commuters on these stretches. On the issue of Tarnah Bridge, it was acknowledged that the break-down of the bridge was natural calamity which has increased the travel time substantially. The Chief Secretary was assured by NHAI that work to restore the bridge was going on war-footing basis despite the challenges being posed by the frequent flash-floods.

As an example, Mehta said the preamble of the Indian Constitution was made applicable to Jammu and Kashmir by way of Constitution Order under Article 370(1)(b) in 1954.

"Thereafter 42nd amendment took place in 1976 and the words 'socialist' and 'secular' came to be added in the Indian Constitution but that was not made applicable (to J-K) till August 5, 2019. The Constitution of Jammu and Kashmir was not having either the term 'socialist' or 'secular'," Mehta said, adding he will show the "devastating effect" Article 370 could have had if it were not repealed.

"This court has rightly flagged that end may not justify the means but I will justify the means also. They are constitutionally permissible," Mehta said.

The CJI asked the Centre to furnish a list of states out of the 562 princely states which merged with India without signing any merger agreement besides original papers existing with the Department of State under the Ministry of Home Affairs.

The solicitor general countered the argument of the petitioners that Article 370 was a special feature and it was a privilege given to the people of Jammu and Kashmir which could never be taken away, and said there were several similarly situated princely states, which put certain conditions for integration but eventually subsumed themselves with the Union because of Article 1 of the Constitution

The bench prima facie agreed with the submissions of Mehta and said the only difference was that princely states like Kathiawar, Saurashtra and Baroda did not follow the Article 370 route but still were integrated with India.

"For J-K the Constitution decided to go to Article 370 and for other states there was no provision like Article 370. They merged and they were integrated completely. They accepted List 1, they accepted List 3 and they accepted the ultimate powers of the legislature of dominion of India," the bench said.

The CJI said many of these states came into the Union of their own volition.

"We take it as voluntary but there may have been little bit of persuasion, there may have been politics involved. This is because of genius like Sardar Patel and there is no doubt about it. But the fact, however, remains is that in so far as J-K is concerned, it bucked that trend and went through the Article 370 route," CII Chandrachud added.

Mehta also countered the argument of petitioners that instrument of merger was a necessary attribute for complete integration otherwise there existed a kind of internal sovereignty.

"This court may recall that J-K never signed instrument of merger but then many states did not sign instrument of merger. But, from the date on which Constitution of into force and Article 1 came into force, they became integral part of India," he said. He also questioned the argument of the petitioners that although J-K gave up its external sovereignty, there existed internal sovereignty with the erstwhile state. "In my view, the petitioners are confusing internal sovereignty with autonomy. External sovereignty nobody can dispute it is with UOI (Union of India) and internal sovereignty in the facts of our case and the constitutional structure which we have accepted, would mean autonomy of a federating unit. This autonomy exists with every state," Mehta submitted The CJI agreed with the submission and said, "Yes, this is there with every institution. This exists with every autonomous institution. Like we have autonomous authority to decide the constitutional issue, so we can't say that internal sovereignty vests with us. We are an independent autonomous institution under the Constitution." The hearing remained inconclusive and will resume on August 28. Several petitions challenging abrogation of the provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh were referred to a Constitution bench in 2019. "Keeping in view seriousness of the matter, appropriate directions be passed to all officers and officials posted in your respective districts/ units to desist from ticketless travel and advisory from your concerned districts/ units should be issued with the advice to travel on valid tickets/passes and desist from ticketless train travels. In case any officer/official is found indulging in ticketless travel, appropriate action under law shall be taken. it added.

Meanwhile an official from the northern railways said the directions were issued following a complaint by the Chief Area Manager that besides locals, some personnel of police department also travel without tickets in trains, thus causing huge losses to the railway exchequer.

He said that an advisory is likely to be issued by all SSPs of the Kashmir Division in this regard soon with strict instructions to all police officials/ officers to refrain from such illegal activities.

You will have to answer how it will square up with clause 2 of Article 370 which specifically says the constituent assembly formed for the purpose of framing the constitution of that state....because, there is a textual answer which may militate against your line of approach," CJI Chandrachud told Mehta.

The solicitor general said he will try to satisfy the conscience of the court and explain the procedure adopted and how it was constitutionally permissible.

The relevant provision of Article 370, before its reading down in 2019, said: "Notwithstanding anything in the foregoing provisions of this article, the President may, by public notification, declare that this article shall cease to be operative or shall be operative only with such exceptions and modifications and from such date as he may specify: Provided that the recommendation of the Constituent Assembly of the State referred to in clause (2) shall be necessary before the President issues such a notification.'

On August 5, 2019, the newly inserted Article 367(4)(d) amended Article 370(3) by replacing the expression "Constituent Assembly of the State" with the "Legislative Assembly of the State".

"I will show how Article 370 worked till 2019. Some of the things are really shocking and I want the court to know about it. Because, practically two constitutional organs-state government and the President- in consultation with each other, can amend any part of the Constitution, whichever way they want and apply it to Jammu and Kashmir, Mehta said.

Praggnanandhaa Falls In Final Hurdle As Carlsen Wins World Cup

BAKU: Indian prodigy R Praggnanandhaa could not pull off a repeat of his giant-killing acts of the last few days as fancied Magnus Carlsen beat him 1.5-0.5 in the tiebreak to win the FIDE World Cup here on Thursday.

Praggnanandhaa's dream run in the tournament ended at the hands of the world No. 1 after the classical games ended in a stalemate. For the five-time World Championship winner and Norwegian superstar Carlsen, who has been at the top of the sport for over a decade now, this was his first-ever World Cup title.

Carlsen, who had been under the weather due to food poisoning and did not look at his best in the first classical game, showed why he is so tough to get past with his remark-able comeback in the tie-break.

He overcame a stiff challenge from his 18-year-old Indian opponent in the first tie-break game, winning it in 45 moves. Carlsen then saw off the problems he encountered due to Praggnanandhaa's enterprising play in the middle to turn the tables on the Indian and seize the advantage.

As fortunes swung from one side o other, the Indian surrendered the point after coming under time pressure in the first rapid game. Carlsen won game 1 in 45 moves and made full use of the advantage of playing with white pieces in the second game. Praggnanandhaa, playing with white in the day's first game, made the first move -e4 - and got into a better position due to some careful maneuvering. At one point of time, the play-



gan with e4. The first exchange happened when the sport's superstar took a pawn on the eighth move after Praggnanandhaa took a second pawn with the queen.

Faced with a must-win situation in the second game, the Indian teen came under time pressure early and chose to agree to a draw with white (Carlsen) holding the upper hand.

Earlier, the two classical games ended in draws that forced a tie-break to decide the World Cup champion.

Praggnanandhaa enjoyed an incredible run in the tournament, having beaten world No.2 Hikaru Nakamura and world No 3 Fabiano Caruana to set up a final date with Carlsen The results in the ongoing tournament also helped Praggnanandhaa qualify for the Candidates 2024 tournament, which will be held in Canada to determine the challenger to world champion Ding Liren of China. Praggnanandhaa also became the third youngest player after the legendary Bobby Fischer and Carlsen to qualify for the Candidates tournament.

<u>Outpost</u> Iranian filmmaker Ebrahim Golestan dies, aged 100

LONDON: Prominent Iranian filmmaker and author Ebrahim Golestan has died, aged 100.

In an Instagram post, his daughter Lili said her dad passed away on Tuesday at his home in the UK. "Father, you have left us. Farewell," she added.

Golestan was known for his multifaceted roles and innovative contributions to Iranian cinema and literature. Born in the south-cen-

tral Iranian city of Shiraz in 1922, he left Iran before the 1979 Islamic Revolution after emerging as a pioneer of modern and progressive cinematic artistry within Iran and internationally.

His politically and culturally charged works, which examined themes such as loneliness, alienation, and social injustice, established him as an intellectual who helped shape 20thcentury Iran.

After a short venture in journalism, he set up Iran's first film studio in 1957 and started producing documentaries and feature films such as "Brick and Mirror," an epic indictment of Iranian society.

Other notable movies included "The Hills of Marlik," "Secrets of the Treasure of the Jinn Valley," "Waves, Coral, and Rock," "From a Drop to the



Sea," and "A Fire," a highly visual treatment of a colossal oilwell fire in southwestern Iran, which earned him two awards at the Venice Film Festival.

Among his many achievements, he produced the documentary film "Black House," directed by his partner and Persian literature great Forough Farrokhzad, who died in a car accident at the age of 32.

Golestan moved to the UK in 1979, and during his career published several novels and short stories often influenced by the works of Western including Ernest wav and William authors Hemingway Faulkner.

In 2003, he experienced a personal tragedy when his BBC cameraman son Kaveh died in northern Iraq after stepping on a landmine.

"India Took A Walk On Moon": Pragyan Rover Embarks On 14-Day Lunar Mission

Bengaluru: Chandrayaan-3 mission's Lander Module which touched down on the lunar surface, has rolled out the rover, Pragyan, with ISRO saying "India took a walk on the moon".

On its official X handle, ISRO said the "rover ramped down." "Chandrayaan-3 ROVER: Made in India--Made for the Moon! The Ch-3 Rover ramped down from the lander and India took a walk on the moon!," it said. Official sources had earlier confirmed the development. President Droupadi Murmu congratulated the ISRO team for the successful deployment of Pragyan.

'Its rolling out a few hours after the landing of Vikram marked the success of yet another stage of Chandrayaan 3. I look forward with excitement, alongside my fellow citizens and scientists, to the information and analyses that Pragyan will acquire and enrich our under-standing of the moon", she said.

In precision landing, Chandrayaan 3's LM Vikram landing, touched down the lunar surface at 6.04 pm on Wednesday, sending the nation into wild celebrations. The ISRO had earlier said the

26 kg six-wheeled rover was scheduled to descend from the lander's belly, onto the Moon's surface, using one of its side panels as a ramp.



The lander (Vikram) and rover (Pragyan) -- with a total mass of 1,752 kg -- are designed to operate for one lunar daylight period (about 14 Earth days) to study the surroundings there. However, ISRO officials do not

rule out the possibility of them coming to life for another lunar day.

The rover will carry out insitu chemical analysis of the lunar surface during the course of its mobility. Both the lander and the rover have scientific payloads to carry out experiments on the lunar surface.

The rover would study the surface of the moon through its payloads APXS - Alpha Particle X-Ray Spectrometer - to derive

the chemical composition and infer mineralogical composition to further enhance understanding of the lunar surface.

Pragyan also has another payload--Laser Induced Breakdown Spectroscope (LIBS) to determine the elemental composition of lunar soil and rocks around the lunar landing site.

ISRO Chairman S Somnath had earlier said. "After powered descent (of lander) on to the landing site, there will be deployment of ramp and rover coming out. After this all the experiments will take place one after the other -- all of which have to be completed in just one day on the moon, which is 14 days.

How Cape Town Muslims saved South Africa's oldest Quran

An Indonesian imam who was exiled to the southern tip of Africa by Dutch colonizers over two centuries ago meticulously transcribed a Quran, and this historical manuscript now holds a place of immense pride among Cape Town's Muslim population.

Safeguarded within the Auwal Mosque in the city's historic Bo Kaap district, the Quran was discovered in the mosque's attic during renovations in the mid-1980s.

Imam Abdullah ibn Qadi Abdus Salaam, known as Tuan Guru or Master Teacher, is believed to have committed the Quran to memory after being banished to Cape Town as a political prisoner in 1780. His exile from Tidore Island in Indonesia was a punishment for his involvement in the resistance movement against Dutch colonizers.

Cassiem Abdullah, a member of the mosque committee, shared with the BBC that the attic had an air of disuse, untouched for more than a century, when builders stumbled upon the unbound Quran packed in a paper bag. Alongside this discovery were other religious texts authored by Tuan Guru.


Despite its age, the unnumbered loose pages of the Quran were in remarkable condition, except for the initial few pages



that exhibited fraying along the edges. The Arabic script, penned with black and red ink, was beautifully clear and remains so even now.

The principal challenge faced by the local Muslim community was the preservation of this cherished relic, which traces its roots back to 1694. The task of arranging the more than 6,000 verses of the Quran in the proper sequence was taken on by the late Maulana Taha Karaan, the chief jurist of the Muslim Judicial Council based in Cape Town, working alongside several local scholars of the Quran. This painstaking process, culminating in the binding of the pages, spanned three years.

The Auwal Mosque, founded by Tuan Guru in 1794 as the first mosque in present-day South Africa, became the permanent home for this precious Quran. Following three unsuccessful attempts at theft, the mosque committee decided to safeguard the invaluable manuscript within a fire- and bullet-resistant enclosure at the mosque's front a decade ago.
