

## Kashmir's Warming Climate: Fruits, Flowers And Nature's New Tune

Nestled in the tranquil environs of Nigeen Srinagar, a few square feet of Murtaza Ahmad's home-garden boasts the unexpected presence of orange trees. Its evergreen foliage, glossy and dark green creates a refreshing contrast against the bright blue sky. Nearly five years ago, Murtaza embarked on the journey of cultivating these trees, nurturing them with care and patience as they took root in this unlikely setting. It's not just him; many of his neighbours

have also started experimenting with citric fruits. While they look at these trees as personal triumphs, in reality, they hold a tale of nature's response to a changing world.

Within the realm of Kashmir, where vibrant fields of apple, saffron and paddy paint the landscape with their abundance, an ominous shift is taking place. The sun's fiery caress, extending its hot fingers across the valley, carries a subtle message—a message of change, of uncertainty, and of a world grappling with the ravages of climate change. This



year, Srinagar, the main city of Kashmir, recorded hottest June day after 18 years at 35.0 degree Celsius.

Over the past century, Jammu and Kashmir (J&K) has experienced a temperature rise surpassing the global average.

While the world's temperature has increased by around 0.8 to 0.9 degrees Celsius, Kashmir has witnessed a more pronounced rise of 1.2 degrees Celsius.

The Jammu and Kashmir State Action Plan on Climate Change, a comprehensive report compiled by the Climate Change Cell of the state government, underscores the urgency of the situation. The report emphasises that Kashmir is on a trajectory toward an exceptional climatic scenario characterised by a consistent rise in overall temperatures.

Experts say that as the

temperatures continue to increase, the implications for various sectors of Kashmir could be far-reaching. "Rising temperatures are speculated to affect all the water dependent sectors, be it agriculture, horticulture, hydropower production or tourism. Furthermore, it can also increase the incidence of cryosphere-related disasters like the thawing of frozen landscapes translating into landslides/ mudflows, glacial lake outburst floods, rock-ice avalanches etc.," Dr. Irfan Rashid, senior Assistant Professor, Department

## Met Issues Landslides, Flash Flood Advisory

## India Showed Its Capability By Hoisting Tricolour On Moon: PM

**Athens:** Prime Minister Narendra Modi said on Friday that India has shown its capability to the world by hoisting the tricolour on the Moon, asserting that its science and technology and innovation are creating a wave globally.

Addressing the Indian diaspora in Greece, he also cited several development feats achieved by his government in the last nine years and emphasised that never before has so much investment been made in the infrastructure sector.

Over 25 lakh km-long optical fibre cable has been laid in India since 2014 which is, he noted, more than six times the distance between the Earth and the Moon. India has taken indigenous

5G technology to around 700 districts in record time, he said, drawing cheers from the audience.

The world's highest-altitude rail bridge and motorable road besides the biggest cricket stadium and the tallest statue are in India now, he said.

Top global bodies like the World Bank and the IMF are praising the Indian economy with leading companies vying with each other to invest in India, he said, asserting that the country's role is changing fast in the post-COVID-19 world order.

Referring to the successful landing of Chandrayaan-3 on the lunar surface earlier this week, Modi said India has shown its capability to the world by hoisting the tricolour on the Moon.

## Mobile App Boosts Online Sale Of Kashmir's Medicinal Plants

Srinagar: Mohamad Shaban Bhat, 58, was struggling to sell Kahzaban (Arnebia benthami) and other medicinal plants that he had grown over 20 kanal of land in Central Kashmir's Budgam district with the help of Jammu and Kashmir forest department and he was unable to find buyers.

Bhat regretted that his investment of lakhs of rupees in growing medicinal plants got wasted. His worries, however, subsided when he came to know about an e-Charak mobile application as well as web portal for the promotion and marketing of medicinal plants and herbs.

"An official of the forest department informed me about the online portal. I don't know how to use it but my son is familiar with the portal," said Bhat. Within a month, Bhat sold all his medicinal plants online and generated good revenue in return.

The e-Charak mobile application and web portal was jointly launched by National Medicinal Plants Board (NMPB), Ministry of AYUSH and Centre for Development of Advanced Computing (C-DAC) for the



promotion and marketing of medicinal plants/herbs.

The e-channel is a platform to enable information exchange between various stakeholders, mainly farmers involved in the medicinal plants sector across

the country. The application supports different local languages and it also provides a fortnightly market price of 100 Medicinal Plants from 25 herbal markets across India.

Notably, the Jammu and Kashmir government is keen to promote and encourage the people to cultivate the medicinal plants in the valley. The government is making a strategy and mechanism for developing and cultivation of Medicinal plants across the UT.

The government has so far developed three nurseries of Medicinal Plants at Gurez Bandipora, Bhaderwah in Doda and Tappal in Samba. According to officials, the centre has approved medicinal plant nurseries for four more districts of the UT and the work on them will start soon.

Pertinent to mention that the UT is famous for its rich variety of plants with medicinal qualities, which are used in medical treatments. However, the demand from other countries have made medicinal plants vulnerable to smuggling.

## HC Permits Army To Carry Out Repairs In Sonamarg Says Security Forces Can Be Treated To Be Class By Itself Distinguishable From Other Commercial Enterprises'

Srinagar: Observing that the security forces "can be treated to be a class by itself distinguishable from other commercial enterprises", the High Court of J&K and Ladakh has allowed the army to carry out repairs and maintenance works in Sonamarg, the gold meadow.

A Division Bench of Chief Justice N. Kotiwar Singh and Justice M.A. Choudhary passed the orders while allowing an application filed by the army, seeking permission in the backdrop of restraint imposed by the Court to carry out maintenance and repairing works in respect of the existing structures in High Altitude Warfare School (HAWS) and other transit camps located in Sonamarg.

When the matter was taken up by the court, T M Shamsi,

DSGI, furnished the details of the works for maintenance and repairs required to be executed in the Army installations in Sonamarg (HAWS) and the Sonamarg Military Stations in a sealed cover and submitted that disclosure of the detail particulars may compromise with the security of these installations.

"Considering that carrying out the maintenance/repair works are urgently required, and the fact that this pertains to security of the Nation which is of paramount importance, and thus cannot be equated with other commercial enterprises engaged in profit making activities," the court said, adding, "The army/security forces can be treated to be a class by itself distinguishable from other commercial enterprises, we are of the view that an exception can be made to the

### Falling Tree Kills Man

A man died on Friday after coming under a falling tree in North Kashmir's Kupwara district. 45-year-old Mohammad Amin Cheechi was grazing cattle in Behak Wali top forest area of the district on Friday afternoon when a tree fell upon him injuring him critically, reports said. Cheechi died due to severe injuries even before he could be removed to the health-care facility for treatment. # Millions Of Carbon Credits Generated By Overestimating Forest Preservation: Study

Millions of carbon credits are being generated by significantly overestimating the levels of deforestation they prevent, according to a study published in the journal Science.

This means that many of the "carbon credits" bought by companies to balance out emissions are not tied to real-world forest preservation as claimed.

Carbon credits, also known as carbon offsets, are permits that allow the owner to emit a certain amount of carbon dioxide or other greenhouse gases.

An international team of scientists and

economists led by the University of Cambridge in the UK and Vrije Universiteit Amsterdam in the Netherlands found that millions of carbon credits are based on crude calculations that inflate the conservation successes of voluntary REDD+ projects.

Consequently, many tons of greenhouse gas emissions considered "offset" by trees that would not otherwise exist have, in fact, only added to our planetary carbon debt, the researchers said.

REDD+ schemes generate carbon credits by investing in the protection of sections of the world's most important forests -- from the Congo to the Amazon basin. These credits represent the carbon that will no longer be released through deforestation.

Organisations and individuals can then offset their own carbon footprint by purchasing credits equivalent to a given quantity of emissions.

Carbon credit markets have exploded in recent years. Over 150 million credits originated from voluntary REDD+ projects in 2021, with a value of US USD 1.3 billion. Some companies use carbon offsetting to claim progress towards "net zero" while doing little to reduce greenhouse gases, the researchers said.

The study authors argue that the booming trade in carbon credits may already be a type of "lemons market": where buyers have no way of distinguishing quality, so some sellers flood the market with bad

products, leading to a breakdown of trust and ultimately market collapse.

"Carbon credits provide major polluters with some semblance of climate credentials. Yet we can see that claims of saving vast swathes of forest from the chainsaw to balance emissions are overblown," said study senior author Professor Andreas Kontoleon, from Cambridge's Department of Land Economy.

"These carbon credits are essentially predicting whether someone will chop down a tree, and selling that prediction. If you exaggerate or get it wrong, intentionally or not, you are selling hot air," Kontoleon said.

# Tele-MANAS Receives Over 23,000 Calls In 9 Months

Srinagar: The UT-level Tele Mental Health Assistance and Networking Across States (Tele-MANAS) cell, established at the Institute of Mental Health and Neurosciences (IMHANS) Srinagar, is proving to be a boon for persons requiring assistance in stress, drug addiction, anxiety-related issues as it has received more than 23,000 calls since its inception in Jammu and Kashmir nine months ago.

The first-of-its-kind mental health helpline, launched on November 4, 2022, is a three-tier system that has mental health

counselors, clinical psychologists and psychiatrists available for patients' calls.

Dr Qazi Haroon, State Program Manager Mental Health J&K said that till date over 23,200 calls including those related to stress, drug addiction, suicidal tendencies and anxiety have been received.

Among these, around 600 were very distressing calls having suicidal tendencies who were counselled on time, he added.

"Tele-MANAS helped us to reach so extensively to common people in such a short period of time. In the near future, more and more people suffering from men-

tal health will find refuge in it," Dr Haroon said.

He said India's first Tele-MANAS chatbot, designed to engage with people in distress, that was launched in Jammu & Kashmir last month has managed to provide assistance to around 150 youngsters so far.

"The Chatbot provides round-the-clock access to health counselors, clinical psychologists, and consultants," he added.

The doctor said that Chatbot encourages individuals to avail the benefits of this service from the comfort of their homes, addressing privacy concerns and promoting accessibility.

## Officer Shifted For 7th Time, Goes On Leave

Srinagar - The principal secretary, revenue, Sonali Kumar, has proceeded on leave following the recent transfers and postings in the state administration.

The high-ranking bureaucrat has been transferred for the seventh time in the changes announced yesterday.

During the two-and-a-half year tenure of the coalition government, Kumar has been shifted six times from her posts.

Before the coalition government came to power, Sonali Kumar had been made the commissioner secretary, education, on May 1, 2002.

Soon after the new government took over, she was transferred to the technical education department as commissioner secretary in November 2003. In February the next year, she was transferred to industries and commerce, and four months later, in July 2003, to the higher and technical education department.

After serving on that post for one year, she was transferred again in July 2004, and made the principal secretary of the forest department. The government shifted her again in April 2005, this time to the health and medical education department.

Yesterday's revamp, which made her the principal secretary of the revenue department, was the sixth time she was transferred in 2-and-a-half years.

Fed up with the repeated transfers and postings, Sonali Kumar, has gone on leave in protest, sources told the KNS. She has asked the government to grant her leave till October.

## G20 SUMMIT

### Curbs On Public Transport In New Delhi

In view of the upcoming G20 Summit in the national capital, the Delhi Traffic Police on Friday imposed a ban on auto-rickshaws and taxis from entering or operating in the New Delhi district from 5.00 am on 9 September to 11.59 pm on 10 September.

Addressing a press conference, Special Commissioner of Police (Traffic) Surendra Singh Yadav stated that non-essential vehicles will be directed to use the Eastern and Western Peripheral Expressways and other alternate routes.

This restriction applies to Heavy Goods Vehicles (HGVs), Medium Goods Vehicles (MGVs), and Light Goods Vehicles (LGVs), which will not be allowed to enter Delhi. However, goods vehicles transporting Essential Commodities like milk, vegetables, fruits, and medical supplies, with valid 'No Entry Permissions,' will have entry permission.

Also Read: G20 poured record levels of public money into fossil fuels in 2022: Report Interstate buses, on the other hand, will be granted entry into Delhi.

"These buses will have designated termination points along the Ring Road. Buses already



present in Delhi will operate on the Ring Road and the road network beyond the Ring Road, heading towards Delhi's borders. These buses will be allowed to exit Delhi," stated the official.

Normal traffic, encompassing all types of commercial vehicles and buses already within Delhi, will be permitted on the Ring Road and roads beyond the Ring Road, leading to Delhi's borders.

Auto-rickshaws (TSRs) and taxis will be authorised to operate on road networks outside the New Delhi district. However, goods carrying residents and tourists with valid hotel bookings within the New Delhi district will be allowed to operate within that district's road network.

Facilitation of passenger movement to the Airport, New Delhi Railway Station, and Old Delhi Railway Station will be ensured. Passengers are advised to follow suggested routes and allocate sufficient travel time.

### Iran Stages 'Electronic Warfare' Drills Against Mock Enemy Drones

TEHRAN: Iran on Friday launched exercises to test its "electronic warfare" capabilities against mock enemy drones, fighter jets and helicopters, state television reported.

It said units from the military's navy, ground and air forces as well as air defenses took part in the drills in the central, largely desert region of the Islamic Republic.

The exercises featured domestically manufactured radars, drones, manned and unmanned fighter jets, micro aerial vehicles and other military equipment, state TV said.

"The army has the appropriate infrastructure, and we have achieved favorable results in countering threats in today's world and predicting future threats in this sensitive and

complicated arena," said Rear Admiral Habibollah Sayyari, deputy chief of the army's coordination department, according to the state-run English language Press TV.

Iran has developed a large domestic arms industry in the face of international sanctions and embargoes that bar it from importing many weapons. Tehran announced on Tuesday the building of an advanced, home-made drone named MoHajjer-10 with an improved flight range and duration as well as a greater payload capacity.

The United States has accused Iran of providing MoHajjer-6 drones, among other unmanned aerial vehicles, to Russia since its invasion of Ukraine last year. Tehran denies this.

Western military analysts say Iran sometimes exaggerates its weapons capabilities.

## Denmark Proposes Bill That Could See Ban On Quran Burnings

The Danish government presented a bill on Friday that could lead to a ban on burning the Quran in public.

Denmark's Foreign Minister Lars Lokke Rasmussen, told Danish radio that the move sends an "important political signal" to the rest of the world.

Burning a Quran under the new law would be an act punishable by fines or up to two years in prison.

Peter Hummelgaard, the justice minister, explained that the proposed law is intended to be written into the same regulation that curbs other countries' flags.

The Danish law would prohibit the "improper treatment of objects of significant religious significance to a religious community," he said.

Hummelgaard, speaking at a press conference, said that a spate of recent Quran burnings were "senseless taunts" aimed to incite "discord and hatred", adding that national security was the primary "motivation" for the ban.

The United States and United Kingdom governments recently announced that authorities in Denmark had disrupted a number of planned "terror" attacks and made



arrests following the Quran burnings.

"We can't continue to stand by with our arms crossed while several individuals do everything they can to provoke violent reactions," Hummelgaard said.

The bill would make it a criminal offence to burn the Muslim holy book, the Bible or the Torah publicly.

It remains unclear when the proposal will be presented to the 179-seat Danish Parliament.

The three parties in the governing coalition control 88 seats and are also supported by four politicians representing the semi-independent Danish territories of Greenland and the Faroe Islands.

Recent Quran burnings in Denmark and Sweden

In recent months, several copies of the Quran have been burned by far-right protesters and Islamophobic agitators in

Denmark and nearby Sweden.

Denmark, one of the most secular countries in the world, scrapped blasphemy laws in 2017. Sweden also has no blasphemy laws in place.

The provocative stunts, considered sinful by the Muslim world, have spurred anguish in several countries, where many have urged European governments to take stronger action and prevent the incidents.

In July, hundreds of protesters stormed the Swedish embassy in Baghdad in response to a planned Quran burning outside the Iraqi embassy in Stockholm, the Swedish capital.

The Swedish government recently ruled out any sweeping changes to its freedom of speech laws but repeated it would look into measures that would allow police to stop the burning of holy books in public if there is a clear threat to national security.



## Greece Confers PM Modi With Grand Cross Of The Order Of Honour

Prime minister Narendra Modi was conferred with the prestigious Grand Cross of the Order of Honour by Greek President Katerina N Sakellariopoulou on Friday, a special honour reflecting the strength of the India-Greece partnership.

The honour is bestowed by the Greek president to prime ministers and eminent personalities who, by reason of their distinguished position, have contributed to enhancing the stature of Greece.

In a tweet, Modi thanked President Sakellariopoulou, and the Government and people of Greece for conferring upon him The Grand Cross of the Order of Honour.

"This shows the respect the people of Greece have towards India," he said, sharing a picture of the event.

The Ministry of External Affairs in a tweet said it is "a

special honour reflecting the strength of the India-Greece partnership".

The citation, according to pmindia.gov.in website, says, in the person of Prime Minister Narendra Modi, an honour is bestowed upon the friendly people of India.

On the occasion of this visit, the Greek State Honours the Prime Minister of India, a statesman who has tirelessly promoted the global reach of his country and who works systematically for India's economic progress and prosperity, bringing about bold reforms. A statesman who has brought environmental protection and climate change among the top priorities of international activity, it states.

The Order of Honour was established in 1975. The head of goddess Athena is depicted on the front side of the Star with the inscription ONLY THE RIGHTEOUS SHOULD BE HONOURED.

## 'Death Better Than This Nightmare': Landslide Victims In Himachal Pradesh

"Death would have been better than going through this nightmare with nowhere to go and no shoulder to cry on," says Promila, who lost everything when a room in a building she stayed in crumbled in a landslide.

The landslide on the morning of 23 August partially damaged Prari House — a government accommodation in which Promila lived with her ailing mother near Indira Gandhi Medical College Hospital (IGMCH).

Narrating her plight to PTI on Friday, she said, "I live with my 75-year-old mother who is suffering from ovarian cancer and has been undergoing treatment since 2016. I also lost my job as a sales girl in a shop in Ram Nagar in the city market last week due to the recession as there were no customers."

"I slept at IGMCH on Thursday night as there is no place to go," says Promila, who is separated



from her husband. "I am desperately looking for a job and am willing to even clean and sweep as I am in dire need of money for my mother's treatment," she adds. "My mother is all I have."

"We could not salvage our belongings and the only things left are the clothes we were wearing while running out of the collapsed house," says Suman, whose room was adjacent to Promila's.

Suman, who works as a domestic help, says she has lost everything in the landslide and has no money to even pay her son's school

fees. She said they have no shelter, no clothes and that even the school books of her son, a student of class 5, were damaged in the landslide.

"Our plight is miserable but it did not attract the attention of the authorities as no casualty was reported in this landslide. What is the use of getting so many donations, if the state government cannot help the disaster victims?" she asks.

"We had food at a gurdwara and are shuttling between our relatives' houses, but we have not received any help or immediate relief," she adds.

## Andhra Pradesh Devotee Offers Rs 100 Crore Cheque At Temple, Had Only Rs 17 In Bank Account

VISAKHAPATNAM: A devotee deposited a cheque of Rs 100 crore in the 'hundi' (offering box) at Sri Varahalakshmi Narasimha Swamy temple in Simhachalam.

When the temple authorities sent the cheque to the bank concerned, they were shocked to learn that the devotee had only Rs 17 in his account.

The photograph of the cheque surfaced on social media on Thursday. The cheque was signed by Boddepalli Radhakrishna.

The devotee has not written the date on the cheque which belongs to Kotak Mahindra Bank. The cheque shows that the devotee is an account holder in the bank's branch in Visakhapatnam.

When the officials of the temple body found the cheque in the hundi, they



took it to the Executive Officer. He sensed something amiss and asked officials to check with the bank branch concerned.

The bank authorities informed the temple body that the person who issued the cheque has only Rs 17 in his account.

The temple authorities are planning to write to the bank to identify the donor. Sources said if the donor had the intention of cheating the temple authorities, the bank may be

requested to initiate cheque bounce case against him.

The devotee's action evoked interesting comments on the Internet. While some netizens commented that the man invited wrath of the God, some others commented that he may have made an advance payment to the God to answer to his prayers.

## Flight Makes Emergency Landing With Sick Passenger

JAIPUR: A Jabalpur-bound flight that took off from Delhi on Friday morning made an emergency landing at the Jaipur airport after a male passenger fell ill, officials said.

After the flight operated by Alliance Air took off from Delhi airport, a 52-year-old passenger fell sick mid-air and his blood pressure started dipping, officials at the Jaipur airport said.

In view of the man's health condition, the flight had to make an emergency landing here around 9.40 am, the officials said.

The passenger was taken to a nearby hospital for a checkup, after which the flight took off for its destination, they added.

## Lalu Yadav Playing Badminton After Bail On Medical Grounds: CBI To Supreme Court

NEW DELHI: The CBI on Friday told the Supreme Court that RJD supreme leader Lalu Prasad was playing badminton after being given bail in a fodder scam case on medical grounds, as it sought cancellation of the relief granted to the former Bihar chief minister.

Lalu Prasad Yadav's counsel opposed any move to cancel the leader's bail, saying he has undergone a kidney transplant recently.

The CBI has approached the seeking cancellation of Prasad's bail in the Doranda treasury case in which he has been sentenced to five years in prison.

Additional Solicitor General S V Raju, appearing for the CBI, submitted that the Jharkhand High Court order granting bail to the Rashtriya Janata Dal (RJD) leader was "bad in law" and "erroneous".

Senior advocate Kapil Sibal, representing Mr Prasad, opposed the CBI's



application on account of the former union minister having undergone a kidney transplant surgery.

Mr Sibal told the bench that Mr Prasad has served 42 months behind bars in the case.

"He is playing badminton. He has been granted bail after conviction in the case. I will demonstrate that the high court order is bad in toto. There's a short ques-

tion of law. The bail has been granted on the erroneous assumption that he has spent more than 3.5 years considering that sentences are concurrent and not consecutive," S V Raju told the court.

Lalu Prasad Yadav has so far been sentenced in five cases of the ₹950 crore fodder scam, which took place between 1992 and 1995 when he was the Bihar chief minister and held the finance and animal husbandry portfolios.

Huge money was withdrawn from different treasuries in Bihar and present-day Jharkhand on the basis of fake and forged bills and vouchers related to fodder, medicines and artificial insemination. A bench of Justices AS Bopanna and M M Sundresh adjourned the matter to October 17.

In his reply to the CBI's appeal seeking cancellation of his bail, Lalu Yadav said poor health and said no purpose would be served by keeping him in custody.

**JAMMU:** A court here has framed charges against 24 people, including a CMO in the Border Security Force (BSF) in connection with the police sub-inspector recruitment scam. The Chief Judicial Magistrate (CJM) Jammu Anjum Ara framed charges against BSF officer named Karnail Singh, Ashok Kumar, Ashwani Kumar, Jaisunya Sharma, Keval Krishan, Raman Sharma, Amit Kumar Sharma, Rakesh Kumar, Sunil Sharma, Suresh Kumar Sharma, Jagdish Lal, Kashmir Singh, Atul Kumar, Tarsem Lal, Yatin Yadav alias Nittu alias Guruji alias Ramu Sir, Vikas Sharma, Anil Kumar, Ashok alias Ashok Pandit alias Gaurav Pandit, Pawan Kumar, Ashesh Yadav alias Monu, Bajinder Singh, Surinder Kumar, Surender Singh alias Commando and Pradeep Kumar Katiyar. As per the prosecution case, vide letter No. GAD-VIGOCOMP/285/2022-04-GAD dated 08.07.2022, Dr Mohammad Usman Khan, Deputy Secretary, conveyed the decision of Govt of J&K for investigation by CBI into allegations of irregularities in written examination of Sub-Inspectors

posts in the J&K Police conducted by J&K Services Selection Board (JKSSB) on the basis of report of Inquiry Committee constituted by the Govt of J&K.

Perusal of the report of Inquiry Committee constituted by the Govt of J&K prima facie revealed criminal conspiracy amongst officials of JKSSB; M/s Merit Trac Bengaluru; beneficiary candidates and other accused persons causing gross irregularities in conduct of written examination of Sub-Inspectors posts in the J&K Police conducted by JKSSB. Accordingly, a regular case RC0042022A0008 was registered against accused persons under Section 120-B, 420 IPC.

"Prima facie it appears that accused have substantively committed the offences under Sections 420, 201, 411 IPC as such are required to be charged for offences. Therefore, prima facie commission of offences under Sections 120-B read with 420, 408, 201, 411 of IPC are clearly established against the accused persons. They are accordingly charged for commission of offences." CJM observed after hearing the arguments. (With agency inputs)

## LAND TO LANDLESS SCHEME

### J&K Parties Seek Clarity Over Beneficiaries

**SRINAGAR:** Political parties in Kashmir on Friday sought clarity over the eligible beneficiaries of the administration's land for landless scheme, saying the right to domicile should be given to permanent residents of the Union Territory only.

The Jammu and Kashmir administration has accorded sanction to the allotment of land on a lease basis to the landless people, with only domiciles of the Union Territory eligible for the scheme.

In a set of guidelines issued by the Revenue Department, the administration accorded sanction to the allotment of five Marla of state land on a lease basis in favour of landless PMAY (G)/Awas plus beneficiaries.

Peoples Democratic Party (PDP) chief spokesperson Suhail Bukhari called for greater transparency from the administration regarding the scheme's intentions and implications.

"Well, this whole policy which is purportedly called

land to landless is shrouded in mystery. Because, there have been statements coming from here and there, but the essential information that should have come out is still evading the people of Jammu and Kashmir," Bukhari told PTI here.

Initially, the administration informed that there were two lakh landless families, but later, they admitted that the number was lesser.

"And now, when they issued the guidelines, they said that the eligibility of this scheme would be the domicile of Jammu and Kashmir. Now, we know that this administration had issued domicile certificates to a number of people who essentially are not originally residents of Jammu and Kashmir. But, by means of this order they would be eligible for this scheme," he said.

Hence, the apprehensions that were raised by people at large which were also echoed and represented by the PDP and its president Mehbooba Mufti, seem to be getting strengthened, he said.

## Officer Faces Heat For Violating 'Flag Code of India'

**SRINAGAR:** The administration of J&K has decided to withhold two increments of an official in Kashmir Valley after a probe found him guilty of negligence in discharge of his official duty concerning the upkeep and distribution of national flags during last year's "Har Ghar Tiranga" programme.

The Housing & Urban Development Department has ordered withholding of two increments of the then executive officer municipal committee, Magam, Syed Aijaz Manzoor, who was put under suspension after it was found that national flags were being distributed in garbage hoppers in Magam, Budgam.

In an order, the HUDD said after news regarding alleged insult of national flags at Municipal Committee Magam went viral on social media on August 13, 2022, deputy direc-

tor (admin), urban local bodies, Kashmir visited municipal committee Magam to inquire into the matter.

The deputy director, ULB found that two hoppers parked in premises of Municipal Committee Magam were carrying national flags for distribution in connection with "Har Ghar Tiranga" programme.

According to the order, the sub-divisional magistrate Beerwah Budgam immediately placed the officer under suspension and ordered an enquiry into the matter.

Subsequently, the HUDD examined the case and served a memorandum, article of charges and statement of imputation to the officer.

After the officer submitted the statement of defence, the government appointed vice-chairman, Srinagar Development Authority as inquiry officer in the matter.

## Will Raise Issues Of People Of Ladakh In Parliament: Rahul

'Kargil Is Not Just A Place, It Is A Saga Of Valour'

**KARGIL:** Raising the Sino-India border issue here, Congress leader Rahul Gandhi on Friday said everyone in Ladakh knows that China has "taken away our land" and claimed Prime Minister Narendra Modi's assertion that not an inch of land was occupied was "absolutely false".

Gandhi addressed a public meeting here on the last day of his nine-day tour of Ladakh.

He said, "I visited the whole of Ladakh on my motorcycle over the past week... Ladakh is a strategic place and when I was at Pangong lake, one thing was clear that China had taken over thousands of kilometers of Indian land. Unfortunately, the prime minister... made a statement that not an inch of our land was taken away which is absolutely false."

"Every individual of Ladakh knows that China has taken away our land and the prime minister is not speaking the truth," he alleged.

The former Congress president's remarks came after Prime Minister Modi and Chinese President Xi Jinping held a conversation on the sidelines of the BRICS (Brazil, Russia, India, China, South Africa) summit in Johannesburg. The conversation was not a structured bilateral meeting and was an informal one.

Foreign Secretary Vinay Kwatra on Thursday said Modi conveyed to Xi India's concerns on the "unresolved" issues along the Line of Actual Control (LAC) in eastern Ladakh, underlining that maintenance of peace and tranquillity in border areas was essential for normalisation of India-China ties.

The ties between India and China came under severe strain following the eastern Ladakh border standoff that began in May, 2020.

The Indian and Chinese troops are locked in an over three-year confrontation in certain friction points in eastern Ladakh even as the two sides completed disengagement from several areas following extensive diplomatic and military talks.

This is the second time during his Ladakh tour that the Congress leader has raised the border issue with China.

Last Sunday, Gandhi had claimed that Modi's statement



that not an inch of the land in Ladakh had been taken over by China was not true.

Addressing the public meeting on Friday, Gandhi also extended his support to the Leh-based Apex Body and Kargil Democratic Alliance (KDA), which are fighting for full statehood and safeguards under the Sixth Schedule of the Constitution, and said his party would not allow the BJP to hand over the resource-rich land of the Union territory to its corporate friend.

The former Congress president said he was briefed by the people about their demands for political representation, safeguards for land, culture and language, unemployment, non-functional Kargil airport and the problem of cell phone coverage.

"I heard you and want to convey that the Congress is standing with you in your struggle, whether linked to the demand for safeguards or employment issues. All the people know that Ladakh is rich in natural resources. The 21st century is of solar energy and Ladakh has no dearth of it," he said.

"The BJP knows and understands that if you are given (political) representation, they cannot snatch your land," he said and alleged that the "BJP wants to take away your land to give it to (industrialist Gautam) Adani and we will not allow this to happen".

The two powerful bodies are jointly campaigning to press for their four-point demands, including full statehood, safeguards under sixth schedule of the Constitution, creation of two separate parliamentary constituencies for Leh and Kargil districts, recruitment and job reservation for the youth of Ladakh.

In an apparent reference to Modi's Mann Ki Baat radio broadcast, Gandhi said, "Some are speaking what is in their heart but I came here to know

what is in your hearts. One thing is clear that the ideology of Gandhi and Congress exists in the blood and DNA of the people of Ladakh."

He said migrant labourers from different parts of the country, including Bihar, Rajasthan, Uttar Pradesh and Jharkhand, told him that they feel that Ladakh is their second home as locals are lending a helping hand whenever they come forward to seek their support.

Referring to his Bharat Jodo Yatra from September 7, 2022 to January 30, 2023, he said the only goal of the foot march was to stand up against the "hatred and violence being spread by BJP and RSS" in the country and spread the message of love and brotherhood.

"The yatra was not supposed to end in Srinagar but in Ladakh. The administration did not allow us to continue the march due to harsh winter and we accepted it. My visit is in continuation of the Bharat Jodo Yatra. I visited every nook and corner of the region on the motorcycle and heard the people," he said.

He also thanked the people of Kargil for always standing with the country during crisis and war, and said, "All the people in the country, irrespective of their religion, language and culture are equal for us and we all want to live together with love and respect."

After his over 15-minute-long address, Gandhi walked past the security cover to interact with the gathering amid chants of "Jodo Jodo, Bharat Jodo".

Gandhi also visited the Kargil War Memorial in Drass and paid rich tributes to the Indian Army personnel who sacrificed their lives during the 1999 war with Pakistan.

The memorial is located on the 434-km Srinagar-Leh national highway and about five km from the city centre across the Tiger Hill, Kargil.

## CS Calls For Ways To Cut Travel Time On Srinagar-Jammu Highway

**SRINAGAR:** Jammu and Kashmir Chief Secretary Arun Kumar Mehta on Friday called for finding ways to reduce travel time on the Srinagar-Jammu national highway for heavy motor vehicles ahead of the fruit season this year.

The chief secretary held detailed deliberations with all stakeholders, including highway authorities, in this regard, an official spokesperson said.

During the meeting, the traffic authorities presented empirical data on the actual movement of Light Motor Vehicles (LMVs) and Heavy Motor Vehicles (HMs) on the highway and their driving patterns.

The traffic on the 70-km stretch of Navyug and Che-



nani-Nashri Tunnels for 15 days was considered, the spokesperson said.

Mehta asked officials to keep an eye on slow-moving vehicles and enquire from each of them about the reasons.

He also advised penalising erratic drivers who cause inconvenience to others.

Mehta asked highway authorities and deputy commissioners to designate no-halt zones.

He asked them to take steps to improve the roads near the

slide-prone stretches at Dalwas, Mehad, Cafeteria Morh and Sher-Bibi.

He insisted on better coordination between the traffic and district police.

Regarding movement of fruit trucks from the Valley, the chief secretary stressed on taking fruit associations on-board while devising the traffic plan.

Mehta asked for marking fruit-laden trucks with specially-designed stickers for their identification and giving unhindered access to reach the Mandis.

He also directed deputy commissioners of the Valley to establish district control rooms in their offices for giving real-time updates to fruit growers about the roads and other issues.

# Azad's Discourse Juggling



“Once a towering Congress politician, who held many important ministerial portfolios and senior organizational responsibilities at the national level, Azad's exit from the party and the subsequent floating of his own party has drastically shrunk his stature, confining him politically to his small region in Doda

Veteran politician Ghulam Nabi Azad created a stir when at a recent rally in a Doda village, he said almost all Muslims in India were descendants of Hindus. He, however, complemented the factual statement with more loaded ones, saying Islam is just 1500 year old while Hinduism is much older. Or that 600 years ago all of Kashmir's population was Hindu. And that all people in India are born into Hindu religion, whatever that meant. The fraught nature of his utterances, spoken against the backdrop of a polarized political climate in the country, was further reinforced by his clumsy articulation: the tone, body language and the overall vibes showed Azad's desperate need to nod to the reigning political creed in the country than to state any historical facts. In trying to counter the RSS narrative he ended up playing to it. Which of the two objectives was his intention is difficult to say. Or was the intention to play to both the narratives? If so, he has succeeded in pandering to the RSS side of the divide only, alienating large sections of Muslim population in the process. For, in the manner that Azad said it, he showed a certain defensiveness about being a Muslim.

That said, did Azad state any facts? He did, after broadly analyzing what he said, although some of his assertions do clash with the belief of Muslims. For example, Azad's claim that Islam is younger than Hinduism runs up against the belief among Muslims - or for that matter, even among Christians and Jews - that the provenance of their faith dates back to prophet Adam, the first human being according to Abrahamic religions.

But yes, as far as ancestry of Muslims in India, Azad is right: they are not outsiders but converts from Hinduism, a historical fact. Over a thousand years of Muslim rule, around one-third of Indians converted to Islam, a sizable chunk of the population which Jinnah came to describe as a "Muslim India". It is also



a fact acknowledged by the RSS chief Mohan Bhagwat. In 2021, speaking at a function organized by Muslim Rashtriya Manch, Bhagwat said that Hindus and Muslims in India shared the same DNA and so, in cultural terms, Muslims in India were actually Hindus - albeit, the later part of his argument would be contentious from a Muslim point of view.

While Azad's argument seems to spring from the same RSS thought process, it is geared to contest an extreme nationalist narrative which sees Muslims in India as outsiders, hence not entitled to a place in India or to equal rights. So, one can justify it as a viewpoint that not only takes on a certain nationalist view but also expands horizons of Muslim politics - or at least opens space for a political party led by a Muslim politician, such as Azad's own party. It makes the concession that even if one were to make accommodation for one's rage over Muslim invasions of India, one couldn't exact revenge on the Muslims who were native to India - Hindus who adopted a different faith. Whether volitionally or forcibly is not the debate here - to speak on behalf of either is a political opinion, not a historical fact.

What Hindu right, in fact, is doing is oppressing their own people to avenge a real or imagined history in which the latter had no role.

Also, if go down the history, we can't stop only at Muslim invasions: India has earlier witnessed the arrival of Aryans who swamped the then indigenous population, saw en masse conversion from Hinduism to Buddhism, then back to Hinduism, even as Buddhism that birthed in India spread throughout the world. And this time, Buddhism is the mainstream religion of China, the world's No 2 power and India's biggest global adversary. The point is that history is extremely complex, so using it for ideological ends could serve to sway public opinion and advance political goals—even though it doesn't guarantee that it's accurate.

Returning to Azad's statements, all that he has tried to do is to spin the nationalist argument to his favour - albeit unsuccessfully so. His motivations again are essentially political. Once a towering Congress politician, who held many important ministerial portfolios and senior organizational responsibilities at the national level, Azad's exit from the party and the subsequent

floating of his own party has drastically shrunk his stature, confining him politically to his small region in Doda. As things stand and with some revival of Congress party across the country and also within Jammu and Kashmir, Azad will find it increasingly difficult to stay relevant to the changing political scene. This calls for a certain modulation of his politics to suit the current political climate. He also needs to forge a political narrative that transcends his appeal across the Hindu-Muslim divide, building on his longstanding secular credentials that once made him acceptable to both Kashmir Valley and Jammu division. But then he was a national leader in a pan-India party like Congress. He currently leads a fledgling subregional party that hasn't yet endeared itself to the people, let alone boast of their support in significant numbers.

The suspense is over. India is celebrating the remarkable success of Chandrayaan-3, which landed on the moon's surface on the designated day, time and location. One of the markers of global leadership is technological advancement. After the US, Russia and China, India is now only the fourth country to have achieved this landmark.

Chandrayaan-3 landed at the southern pole of the moon and is the only space-faring nation to have selected a particularly challenging and little understood location for exploration. Scientists say that it is only the polar regions which still carry the original geology of the moon—most of its surface having been overlaid with the debris of large and small asteroids which have been bombarding the moon through millennia and accumulating, layer after layer.

The experiments which the moon rover will be carrying out over this space, including looking for sub-soil water, will bring new knowledge about our closest celestial neighbour. This will also help our understanding of the history and make-up of our own fragile planet.

This great success in space exploration comes, coincidentally, when prime minister Narendra Modi is in Johannesburg, South Africa, for the BRICS (Brazil, Russia, India, China and South Africa) summit.

Chandrayaan-3's success will boost India's profile and standing among its BRICS partners and enhance the influence of the BRICS itself as a grouping of economically and technologically capable states who are now peers among the constituency of developing countries.

Chandrayaan-3 succeeded where a Russian lunar landing craft—Luna-25—failed and crashed a few days earlier. It may have been a coincidence that Russia, already a seasoned space-faring nation, launched its moon landing project virtually days after India did. But Russian failure and Indian success will be assessed side by side. Russia's failure is already being seen as a symptom of its decline and inability, in terms of resources, to maintain its status as an advanced space power.

Space exploration is a high-risk and expen-



sive pursuit and India itself suffered disappointment when its Chandrayaan-2 also crashed on the moon's surface in September 2019. There is no reason to believe that Russia will not overcome this setback and pick up the pieces again. But perceptions matter. Chandrayaan-3 reinforces the international perception of India as a rising power and that of Russia as a declining power. If Russia undertook this project to counter the notion that it was no longer in the front ranks of technologically advanced countries, that the Ukraine War had not in any way dented that position, it failed. The political and psychological setback is obvious from the very limited coverage that the failed moon mission received in the Russian media.

China has always looked down upon India as being out of its league as a global economic and technological power. It sees India as pretending

to be a leading power without having the economic and technological capabilities to back it up with. India's earlier demonstrations of scientific and technological excellence, for example, in the nuclear and space fields or in its successful IT sector, have been received with surprise. They have often been dismissed as "borrowed" from other countries.

Chandrayaan-3's outstanding achievement may be difficult to dismiss in a similar manner. Perhaps this may lead China to shed some of its arrogance and approach India as a country which must be treated with respect rather than condescension.

The two countries can put their relations on an even keel only if they treat each other as equals. How China reacts to Chandrayaan-3's success will be a pointer to whether there is a shift in China's posture towards India after the

violent clashes at the Line of Actual Control in eastern Ladakh.

For India, Chandrayaan-3's success is also a boost to its status as the host country for the forthcoming G20 summit. One has no doubt that in the already pervasive publicity surrounding the summit, Chandrayaan-3 will add another prominent feather to India's cap. During the summit deliberations, India's voice will command greater attention. Its various initiatives will be considered with respect. Whether this will be reflected in substantive outcomes remains to be seen.

There are lessons for India and its development strategy. What Chandrayaan-3 has achieved is the result of the vision put forward by India's early leaders that the country, though poor and developing, should create and nurture institutions of excellence pursuing the most advanced science and technology.

The Atomic Energy Commission, which developed India's nuclear programme, was set up as early as 1948 with prime minister Jawaharlal Nehru as its chairman. This reflected the high importance attached to this advanced scientific pursuit by the then political leadership.

Originally, space research was entrusted to a committee under the Department of Atomic Energy known as Indian National Committee for Space Research (INCOSPAR), set up in 1961 under the well-known scientist, Vikram Sarabhai. This was later followed by the setting up of the Indian Space Research Organisation in 1972.

The Indian Space Commission was set up on the pattern of the Atomic Energy Commission, also under the chairmanship of the prime minister. These two commissions are the pillars of India's advanced science and technology, enjoying considerable autonomy and being well-funded.

It is these early, far-sighted decisions, followed by the efforts of India's scientists and technology workers, that have resulted in the success of India's latest space mission.

# A Game Of Carrom

I assume that you all will read this. Let's start with an assumption then. I think there is no harm in that. So, I assume that most of us, if not all, have played carrom or seen how the game of carrom works. During covid lockdown, carrom got a revival, if not a second life (assuming that this game was dead or dormant before). During lockdown days I used to play carrom with my elder siblings (who rarely had time before covid) and my nephew and little niece (jaun). Today, almost three years down the line I saw two students in the hostel basement playing the game with great focus and believe me they both were good players (a contested fact). Before proceeding further, I would like to put things in some context. Carrom has its origin from Indian soil (Soil: bollywood term). Remember the origin of the game is important here. It will tell us a lot about the society from which it emerged. After playing the game back home (Kashmir), I started to develop a keen interest in the game. Initially, comprehending the game's rules was bit of a challenge for me. Yet subsequently, it became apparent that this game serves as an intriguing avenue to grasp societal dynamics and the challenges it contends with. Aspects like racial bias, legal constraints, and gender discrimination are readily illuminated through this game, leading me to perceive it as a mirror to our society.

Presuming your continued presence, despite numerous suppositions, let's delve into the earlier conversation to comprehend the points discussed.

Color Discrimination: Within the game of carrom, distinct point types exist—white, black, Queen, and Striker. Notably, claiming a White point yields 20 rewards, whereas a black point garners merely 10.



Have you ever pondered the rationale behind this distinction? Given that both points share identical material and circumference, the basis for divergent point values solely rooted in color remains perplexing. Whether engaged in play or support, take a moment to question: why this differentiation based on color?

Being a student of law and society, a query emerges within me: "Is it feasible to confront this subtle (yet deeply ingrained) bias through legal means?" While law indeed tackles discrimination on societal and institutional scales, how would it respond to color

discrimination within such a context? The approach to addressing such matters is less apparent. Law is often considered an instrument of change, prompting the question: to what extent does it bring about transformation?

State restrictions and law: If you see, there are some lines drawn on the game. I feel these lines determine our rights and limits. You cannot win a point if it's on the line, but why? Who holds the authority to establish such a principle? What these lines tell us about the nature of rights. To explain this, let me take the example of rights: Positive and negative. Negative

rights compromise constitutional restrictions on the state. For example, Article 17 of the Indian constitution abolishes untouchability, removes a social evil. It hardly bestows a special privilege on the untouchables. While on the other hand, Positive rights are those rights which are subject to constitutional restrictions. Right to freedom, right to acquire, hold and dispose of property and right to religion and cultural and educational rights fall in the category of positive rights.

Then comes the striker, nothing must be noted that the striker is larger in circumference than the other points.

It enables you to disturb/ move the points from their points. "It dictates you". It's reasonable to assert that the striker essentially "determines" the outcomes on behalf of the other points.

Sexism: Apart from points (black and white) and striker, there is another point, it is termed as "queen". The gender being alluded to can be deduced directly from the name itself. You can't touch this point, be it black or white. There are conditions to it, you can change its position only by hitting it indirectly. And if one desires to win the queen. The process isn't the same as winning other points. In order to win a queen, you have to sacrifice the other point (black/white). So, to win a queen, you need to sacrifice the other points. It is only this sacrifice which opens your way to win the queen. Think of it this way, the respect of the board (home) if affiliated to the queen. ## Avoid This Mistake When Trying to Be More Disciplined

A new study published in the Journal of Experimental Social Psychology investigates common beliefs about self-control and how they might impact people's willingness to employ self-control strategies in their lives.

Psychologist Anamarie Gennara of Carleton University in Ottawa, the lead author of the paper, reported, "My colleague, Dr. Johanna Peetz, came up with this project idea following a conversation with a friend who dismissed the use of strategies for self-control—they said one should be able to do it without having to resort to such 'tricks.'"

The study defined self-control strategies as "actions and thoughts people take to design their environments in a way that make goal-directed choices easier and more likely." For instance, if an individual who is trying to lose weight struggles with cookie cravings, they can either put the cookies out of their reach or remind themselves of their weight-loss goals or the many demerits of processed foods and sugars when they feel vulnerable.

In recent years, we have seen a proliferation of such strategies in the name of productivity or focus hacks (like dopamine detoxes, task stacking and chugging, the Pomodoro method, etc.). While the strategies have been widely circulated, they have also received criticism, with many people writing them off as superficial tricks that are a poor substitute for strong "willpower."

To better understand the beliefs people hold about self-control and how they influence behavior, the researchers conducted five experiments in which participants were presented with fictional characters described as having high self-control and asked to assess whether these individuals were more likely to rely on willpower or strategies to resist temptations.

The initial findings showed that



individuals perceived people with high self-control as more likely to use willpower over self-control strategies. Also, in subsequent experiments, targets described as using strategies consistently received lower self-control ratings compared to those who employed willpower.

Remarkably, this perception gap disappeared for participants who strongly believed in the efficacy of strategies for self-control. When individuals read an article emphasizing the importance of self-control strategies instead of willpower, the difference in perception between strategy users and willpower users was notably reduced. Moreover, participants who firmly believed in the effectiveness of strategies expressed higher intentions to use these techniques

themselves. The results thus indicated that:

1. "Strategy users" were consistently perceived as having less self-control than "willpower users."
2. Those who read about the importance of strategies rated fictional persons using strategies as higher in self-control and expressed greater willingness to use those strategies themselves.

"Our research shows that people's beliefs about the importance of strategies for self-control significantly shape their perceptions of others who employ these strategies, as well as their own willingness to use them," Gennara reported. The findings have important

implications, as they highlight the impact of beliefs on perceptions and behavior. By understanding the link between self-control and our theories about it, interventions can be designed to promote the use of effective self-control strategies. The authors suggest that educating individuals about the value of strategies can shift their beliefs and lead to an increased willingness to employ these techniques. Such efforts could pave the way for easier and more effective self-control in various real-world contexts.

In practical terms, individuals seeking to improve their self-control and resist temptations more effectively should be open to experimenting with different strategies. There is no one-size-fits-all approach, as different strategies may work better

for different people. Instead of solely relying on will, people should be encouraged to discover and implement strategies that align with their unique goals and preferences.

Believing that willpower is more central to self-control than strategies might be a disservice to your untapped potential. However, Gennara states, merely informing people about the benefits of strategies may not lead to lasting change. Instead, she suggests linking the use of strategies to positive traits, such as discipline. Tapping into individuals' inherent desire to perceive themselves positively can encourage them to find greater motivation to adopt self-control strategies in their daily lives.

# Unlocking The Secret To A Good Life: The Path To Fulfillment And Happiness

Aristotle first took on this question in his Nicomachean Ethics arguably the first time anyone in Western intellectual history had focused on the subject as a standalone question.

He formulated a teleological response to the question of how we ought to live. Aristotle proposed, in other words, an answer grounded in an investigation of our purpose or ends (telos) as a species.

Our purpose, he argued, can be uncovered through a study of our essence the fundamental features of what it means to be human.

Ends and essences

Every skill and every inquiry, and similarly every action and rational choice, is thought to aim at some good; Aristotle states, and so the good has been aptly described as that at which everything aims.

To understand what is good, and therefore what one must do to achieve the good, we must first understand what kinds of things we are. This will allow us to determine what a good or a bad function actually is.

For Aristotle, this is a generally applicable truth. Take a knife, for example. We must first understand what a knife is in order to determine what would constitute its proper function.

The essence of a knife is that it cuts; that is its purpose.

We can thus make the claim that a blunt knife is a bad knife if it does not cut well, it is failing in an important sense to properly fulfil its function. This is how essence relates to function, and how fulfilling that function entails a kind of goodness for the thing in question.

Of course, determining the function of a knife or a hammer is much easier than determining the function of Homo sapiens, and therefore what good, fulfilling lives might involve for us as a species.

Aristotle argues that our function must be more than growth, nutrition and reproduction, as plants are also capable of this. Our function must also be more than perception, as non-human animals are capable of this. He thus proposes that our essence what makes us unique is that humans are capable of reasoning.

What a good, flourishing human life involves, therefore, is some kind of practical life of that part that has reason. This is the starting point of Aristotle's ethics.

We must learn to reason well and develop practical wisdom and, in applying this reason to our decisions and judgements, we must learn to find the right balance between the excess and deficiency of virtue.

It is only by living a life of virtuous activity in accordance with reason, a life in which we flourish and fulfil the functions that flow from a deep understanding of and appreciation for what defines us, that we can achieve eudaimonia the highest human good.

Existence precedes essence

Aristotle's answer was so influential that it shaped the development of Western values for millennia. Thanks to philosophers and theologians such as Thomas Aquinas, his enduring influence can be traced through the medieval period to the Renaissance and on to the Enlightenment.

During the Enlightenment, the dominant philosophical and religious traditions, which included Aristotle's work, were

reexamined in light of new Western principles of thought.

Beginning in the 18th century, the Enlightenment era saw the birth of modern science, and with it the adoption of the principle nullius in verba literally, take nobody's word for it which became the motto of the Royal Society. There was a corresponding proliferation of secular approaches to understanding the nature of reality and, by extension, the way we ought to live our lives.

One of the most influential of these secular philosophies was existentialism. In the 20th century, Jean-Paul Sartre, a key figure in existentialism, took up the challenge of thinking about the meaning of life without recourse to theology.

Sartre argued that Aristotle, and those who followed in Aristotle's footsteps, had it all back-to-front.

Existentialists see us as going about our lives making seemingly endless choices. We choose what we wear, what we say, what careers we follow, what we believe. All of these choices make up who we are. Sartre summed up this principle in the formula existence precedes essence.

## SEBI Submits Status Report On Adani-Hindenburg Probe, Says Awaiting Info From Tax Havens

**NEW DELHI:** Capital markets regulator SEBI on Friday informed the Supreme Court that it has completed the probe in all but two allegations against the Adani group and is still awaiting information from five tax havens on actual owners behind foreign investors investing in the conglomerate.

The Securities and Exchange Board of India in a status report to the Supreme Court stated that out of the 24 matters it was probing, findings in as many as 22 are final.

Without divulging the outcome of its investigations, SEBI gave a detailed breakdown of the steps taken by it during its probe, including related party transactions.

"SEBI shall take appropriate action based on the outcome of the investigations in accordance with law," the regulator said in the filing.

The probe reports finalised include allegations of manipulation of stock prices, alleged failure to disclose transactions

with related parties and possible violation of insider trading in some of the group stocks.

However, on the allegation of non-compliance with the minimum public sharing requirement by investing in its own companies through overseas proxies, SEBI said its investigation covered 13 overseas entities (12 foreign portfolio investors and one foreign entity).

These 13 were classified as public shareholders of the Adani group companies but allegations including the US short-seller Hindenburg Research termed some of them as close associates or run by Vinod Adani, the elder brother of group chairman Gautam Adani.

"As many of the entities linked to these foreign investors are located in tax haven jurisdictions, establishing the economic interest shareholders of the 12 FPIs remains a challenge," SEBI said adding efforts are still being made to gather details from five foreign jurisdictions pertaining to the actual owners of these investors.

## India's Real Estate Sector Expected To Expand To USD 5.8 Trillion By 2047: Report

**NEW DELHI:** International Property Consultant Knight Frank India in its latest report, 'India Real Estate: Vision 2047', prepared in association with the National Real Estate Development Council (NAREDCO) has projected that India's real estate sector is expected to expand to USD 5.8 trillion by 2047. A press release from Knight Frank said this estimated real estate output value will contribute 15.5 per cent to the total economic output in 2047 from the existing share of 7.3 per cent.

The report will be unveiled by M Venkaiah Naidu, Former Vice President, at NAREDCO's Silver Jubilee Celebration event here in Hyderabad, along with other dignitaries present at the event here tomorrow, it said.

By 2047, when India reaches 100 years of independence, the size of India's economy is estimated to be around USD 33 trillion, and for study purposes, Knight Frank has taken the mean estimated growth of the Indian economy to be valued at USD 36.4 trillion by 2047.

Commenting on the occasion, Rajan Bandelkar, President NAREDCO India said, "Vision 2047, not just for NAREDCO but for Indian Real Estate, is about the roadmap of India's economic growth, and

the role of real estate as one of the leading engines of that growth story.

Significant expansion of the Indian economy by 2047 will be powered by real estate. A multifold economic expansion will boost demand across all the asset classes -- residential, commercial, warehousing, industrial land developments etc -- will grow at a multiplier rate to accommodate the growing needs of the economy and consumption needs of the individuals, he further said.

According to Knight Frank India, in the next 25 years, cumulatively there will be an estimated 230 million units of housing requirement in India. In terms of market value, the residential market has a potential to generate an output equivalent of USD 3.5 trillion in 2047.

Shishir Bajjal, Chairman & Managing Director, Knight Frank India, said the next 25 years are going to witness a dramatic transformation in the Indian economy and the real estate sector. Factors like demographic advantages, improving business and investment sentiments, and government policy push towards high-value output sectors such as manufacturing, infrastructure etc will robustly support the economic expansion of India.

## Growth In June Quarter Should Be Good; Priority Is To Tame Inflation: FM

**NEW DELHI:** Finance Minister Nirmala Sitharaman on Friday said India's economic growth in the first quarter of this fiscal should be good and that the government's priority is to tame inflation, which has touched a 15-month high.

Addressing business leaders in the national capital, she said that green shoots of private capital expenditure upcycle can be palpably felt as the government's enhanced capital expenditure is now crowding in private sector investments.

While mentioning about the key priorities of the government, Sitharaman also stressed that the focus is on Aatmanirbhar Bharat (self-reliant India) but essential imports will not be stopped.

She also emphasised on the need for diversification of supply chains at the earliest to avoid shocks.

Noting that India is the fastest growing major economy, she said that in another few days, the GDP numbers for the first quarter of 2023-24 will be released.

"As things stand, nobody has a clue. But everybody feels that yes, the first quarter did go on well, so the numbers should be good," Sitharaman said while speaking at the B20 Summit India 2023, being organised by industry body CII.

The National Statistical Office (NSO) is scheduled to



release the Gross Domestic Product (GDP) data for April-June quarter on August 31.

She said there is a lot of interest on what the US Federal Reserve is going to say from Jackson Hole. "All of us are wondering how that is going to come out because its spill over is also something which we notice," she said.

Investors are awaiting cues on the US Federal Reserve's monetary policy from Chairman Jerome Powell's speech at the Jackson Hole Symposium on Friday.

According to her, the key priority for economic growth "is taming inflation" because persistently high inflation will weaken demand.

"It's basic economics. I'm not saying anything new. Equally, elevated interest rates for considerable time can come in the way of economic recovery," the finance minister said and added that the tendency to use interest

rates as the only solution for dealing with inflation has its own downside.

"And most economies do have this problem, because I think, for want of a better word, obsession with using interest rate as the only tool to deal with inflation and not manage the supply side factors will not give a complete solution for inflation.

"Temporarily it can give but sooner the supply side issues can creep the ugly heads up," she said.

Most of the central banks, including the Reserve Bank of India (RBI), have raised interest rates to tackle inflation following the outbreak of Russia-Ukraine war in February last year that has also disrupted global supply chains.

"... task for the central banks therefore... particularly in today's context is to keep in mind growth and growth-related priorities even as equally looking at controlling inflation," Sitharaman said.

She also said that India has showcased an accelerated pace of economic reforms in the last nine years of Prime Minister Narendra Modi-led government.

"Reforms have been continuing, wide ranging domains have been covered, whether it is fiscal, whether it is digital, whether it is physical infrastructure or social inclusion, you spoke about inclusion, yes on social inclusion as well.

## India-UK FTA Negotiations Going On, Making Good Progress: Goyal

**JAIPUR:** Commerce and Industry Minister Piyush Goyal on Friday said the negotiations between India and the UK for the proposed free trade agreement are progressing and both countries are committed to concluding the talks as early as possible.

"We are working hard, we are all committed to a fair, equitable, and balanced trade agreement, respecting each other's sensitivities, respecting the different levels of developments that both the countries have and respecting the future potential that each country brings to the table," Goyal told reporters here.

Keeping all of these circumstances in mind, the two countries have made "good" progress and the 12th round of talks is under-going, he added.

When asked about the deadline for concluding the negotiations, the minister said no country in the world works through specific deadlines.

"But I would like to see it happen tomorrow, the faster the better ... We are both committed to a good outcome, at the fastest possible speed," he added.

UK Business and Trade Secretary Kemi Badenoch

on Thursday said that India and Britain are actively discussing business mobility under the proposed free trade agreement (FTA) and the negotiations are now in the final stages.

The ministers were here to attend the G20 trade and investment ministers meeting.

Out of the total 26 chapters in the proposed FTA, 19 have been closed. Investment is being negotiated as a separate agreement (bilateral investment treaty) between India and the UK.

The bilateral trade between the countries increased to USD 20.36 billion in 2022-23 from USD 17.5 billion in 2021-22.



## DGCA Inspection Finds Lapses In Air India's Internal Safety Audits

**NEW DELHI:** A two-member inspection team of the Directorate General of Civil Aviation (DGCA) has found lapses in internal safety audits of Air India and the regulator is probing the matter, according to officials.

When contacted, an Air India spokesperson said that all airlines are subject to regular safety audits by regulators and other bodies.

"Air India actively engages in such audits to continually assess and strengthen our processes," the spokesperson said in a statement and added that the airline directly addresses any matters raised with the authority concerned.

According to the inspection report submitted to the DGCA, the airline was supposed to carry out regular safety spot checks in various areas of operations such as cabin surveillance, cargo, ramp and load but during a random inspection of 13 safety points, the team found that the airline prepared false reports in all 13 cases.

"Moreover, when cross-verified with CCTV, recordings, auditee statements, shift register documents, GD (General Declaration) list, passenger manifest

etc, it is understood that all the aforesaid 13 spot checks shown to be carried out in stations Mumbai, Goa and Delhi were verified and were established to have not been actually performed," the two-member team said in the 'Deficiency Reporting Form' (DRF).

The inspection found that these reports "were subsequently prepared/falsified when demanded by the DGCA team".

Further, the inspection report noted that these forged spot check reports were not signed by the Chief of Flight Safety (CFS) who has the authority to do it.

The team visited Air India's office in Gurugram in Haryana on July 25 and 26, and after inspection, they mentioned about the lapses in the DRF.

When contacted, DGCA Director General Vikram Dev Dutt said the matter is being investigated by the regulator.

According to the inspection report, the checklists were physically signed by an auditor from the Quality Management System (QMS) Department which does not fall under the approval and inspection scope of the DGCA and has different eligibility criteria/qualification industry standards.

## How Two 20-Year-Olds Beat Grim Market To Mint India's Newest Unicorn - Zepto

**NEW DELHI:** Zepto, an instant grocery startup founded by a duo of Stanford University dropouts, both 20, raised fresh funds at a \$1.4 billion valuation, creating a rare Indian unicorn amid a gloomy venture funding climate.

StepStone Group, Goodwater Capital and others invested a combined \$200 million in the Mumbai-based company, it said Friday in a statement. Zepto, built with backing from startup incubator Y Combinator, said it's on track to turn profitable within 15 months and intends to go public in two to three years.

Childhood friends Aadit Palicha and Kaivalya Vohra dropped out of Stanford's computer science program to return to India and build the startup when they were teenagers. They are now the youngest founders of any Indian unicorn.

"Quick commerce is India's fastest-growing consumer internet category, scaling far more rapidly than segments like ride-hailing and food delivery," Palicha said over video conference. "We are India's fastest-growing consumer internet company and will be Ebitda-positive within 15 months."

The Series E round comes at



a challenging time for the quick commerce segment globally, with startups like Gopuff in the US and Getir in Europe cutting jobs. Zepto itself faces stiffening competition from rivals in India, including Alphabet Inc.-backed Dunzo, Zomato Ltd.'s Blinkit and Naspers Ltd.-backed Instamart.

Startup momentum is sputtering worldwide. Venture funding declined by about 72% in the first half of the year compared with the same period in 2022, according to data from Tracxn Technologies Ltd. No new unicorns were created in the country the first half, compared with 19 unicorns minted in the year-earlier period, according to Tracxn.

Zepto was founded in July 2021 and now has more than 220 so-called dark stores, or neighborhood warehouses, across cities including Mumbai, Bangalore and New Delhi, with plans for expansion. Its early backers include Nexus Venture Partners and Lachy Group.

## AI Will Create More Jobs In India: N Chandrasekaran

**NEW DELHI:** Artificial intelligence will create more jobs in India as it will empower more people with little skill or no skill to perform higher level jobs, B20 India Chair N Chandrasekaran said on Friday.

In a panel discussion at the B20 Summit India 2023 here, Chandrasekaran, who is also the Chairman of Tata Sons, said India has made a "fantastic breakthrough" towards data privacy and protection by taking a technological approach.

Seeking to address concerns over privacy and jobs with the advent of artificial intelligence (AI), he said, "Actually in a country like us, it (AI) will create jobs because it will empower people with the little skill or no skill, will empower them with information skill so that they can perform a higher level of jobs."

He cited the example of

a nurse and said due to AI "the nurse will be able to take away the workload of a doctor and that's the way we are going to scale up".

Chandrasekaran, however, stated that the impact of AI will play out in different markets and different segments of the society differently.

"We talk about a country like India, we say that hundreds of millions of people have to have access... Additional 250 to 300 million people are coming into the market. They have access to information, they have access to goods and services in their own way, they start consuming, it just multiplies the whole GDP to a different level and then their per capita income goes up and we will see the benefit for a very, very long time," he said.

On the other hand, he said the ageing economies are also going to face longevity and all these people have to

be taken care of and they don't have enough human resources to provide the kind of service that needed to be provided to support these people once they get aged.

"Again, AI will come in handy or play a very very important role because a vast majority of the things that need to be taken care of can be done by AI. So the benefits are going to be different to different segments and in different markets but everywhere (AI) is going to create jobs, it is going to empower people to do high levels of jobs," Chandrasekaran asserted.

In markets where there are no people it is going to substitute for human beings and provide the service that is expected, he added.

On data privacy and protection, Chandrasekaran said, "I do believe that India has made a big breakthrough in this whole privacy space. India has taken a technical legal approach,"

## RBI Guv Asks NBFCs To Strengthen Governance Standards

**NEW DELHI:** Reserve Bank Governor Shaktikanta Das on Friday asked non-banking financial companies (NBFCs), including housing finance companies, to strengthen governance standards and assurance mechanisms.

The governor held a meeting with MD & CEOs of select large NBFCs. Government NBFCs and housing finance companies (HFCs) also participated in the meeting, the RBI said in a statement.

Reserve Bank Governor Shaktikanta Das on Friday asked non-banking financial companies (NBFCs), including housing finance companies, to strengthen governance standards and assurance mechanisms.

These entities constitute nearly 50 per cent of the total assets of all NBFCs, including HFCs. Acknowledging the important role played by the sector in delivering credit to the unbanked and underserved areas, Das advised that NBFCs and HFCs need to remain alert to avoid any complacency during good times.

"The governor highlighted the need for further strengthening the governance standards and assurance mechanisms viz. Compliance, risk management and internal audit in these entities," the central bank said.

## Sensex Declines By 365 Pts On FII Selling In Financials, Capital Goods Shares

**MUMBAI:** Benchmark Sensex declined by 365 points and Nifty settled below the 19,300 level in a volatile trade on Friday as financials, capital goods and oil shares took a hit amid concerns over potential rate hikes and weak trend in global markets.

Falling for a second day in a row, the BSE Sensex closed lower by 365.83 points or 0.56 per cent at 64,886.51. During the day, it dropped 519.77 points or 0.79 per cent to 64,732.57.

The NSE Nifty declined by 120.90 points or 0.62 per cent to end at 19,265.80.

From the Sensex pack, Larsen & Toubro, JSW Steel, IndusInd Bank, Power Grid, ITC, Mahindra & Mahindra, NTPC, HDFC Bank, ITC, Reliance Industries and Tata Motors were among the major laggards.

Bajaj Finserv, Asian Paints Bajaj Finance, Bharti Airtel and Axis Bank were among the gainers.

"Investor caution is evident globally, as concerns about potential rate hikes dominate the prevailing sentiment ahead of the Jackson Hole meeting. Furthermore, the minutes from the RBI MPC meeting reiterated their dedication to managing inflation within the target range, given the elevated domestic inflation levels," said Vinod Nair, Head of Research at Geojit Financial Services.

"Markets traded under pressure and lost over half a per cent, in continuation of Thursday's decline. All sectors traded in sync with the benchmark and, we saw profit-taking in the broader indices too," Ajit Mishra, SVP - Technical Research, Religare Broking Ltd, said. In the broader market,

the BSE midcap gauge fell by 0.85 per cent and small-cap declined 0.24 per cent.

Among the indices, capital goods went lower by 1.29 per cent, realty declined 1.27 per cent, power fell 1.26 per cent, utilities dipped 1.24 per cent, FMCG (0.91 per cent) and commodities (0.89 per cent).

Telecommunications emerged as the only winner.

On the weekly front, the BSE benchmark declined 62.15 points or 0.09 per cent and the Nifty dipped 44.35 points or 0.22 per cent.

In Asian markets, Seoul, Tokyo, Shanghai and Hong Kong settled in the negative territory.

European markets were trading in the green. The US markets ended lower on Thursday. Global oil benchmark Brent crude climbed 1.25 per cent to USD 84.40 a barrel.

Technocrats who have been associated with the steel industry for decades aver that this is the result of a well-planned sequencing schedule that has been executed brilliantly to achieve this unprecedented feat.

It may be recalled that Nagarnar Steel Plant had conducted cold trials of its Steel Melting Shop months before initiating blast furnace commissioning. Though there have been instances of faster steel making, Nagarnar Steel Plant's production of HR Coil within nine days of hot metal production is unusual. This was made possible by testing the capability of the Mills by rolling slabs and producing HR Coil even as preparations were underway for commissioning of blast furnace. This prior planning paid rich dividends.

Generally it takes a couple of weeks for the functioning of the blast furnace itself to stabilize. This is followed by synchronization of blast furnace production with the working of the Steel Melting Shop. This being a very dangerous zone it is approached with extra caution after which production process at the Mills is stabilized. That this was successfully accomplished in such a short duration attests to the latest equipment and technology used, as also the expertise of involved professionals.

With production of HR Coil initiated today, the Plant is engaged in stabilization of the production process to ensure that its produce is commercialized at the earliest. It is felt that the rapid commercialization of the Plant's produce is expected to greatly minimize, or even offset the losses that a green-field steel plant generally suffers in the first year of its commissioning.

#### Seasons in Flux

Farmers in Kashmir had always relied on the predictable rhythm of the seasons, the gentle touch of the monsoon rains, and the perfect balance of sunlight and warmth to bring forth bountiful harvests. But now, the delicate equilibrium of nature is teetering on the edge. The rising temperatures have become merciless, searing the once-fertile lands and causing crops to wither under the unrelenting heat.

"The surging temperatures would affect the soil water content which has direct implications for crop production. Additionally, it might cause pest outbreaks in agricultural fields and also reduce the shelf life of crops," Dr. Irfan said.

Dr. Irfan went on to emphasise that water scarcity presents another critical issue affecting agricultural productivity. "While Kashmir experienced limited snowfall during the winter, early spring conditions were relatively better. However, the elevated temperatures this year have accelerated the melting of snow across the landscapes. Any instances of water scarcity could adversely affect the availability of irrigation resources for agricultural fields, consequently leading to a decline in crop production," he cautioned.

According to a research titled "Climate Change and its Effects on Horticulture and Agriculture Crops in J&K" published in JK policy institute, the high temperature in Kashmir and the mid-temperature in Jammu have affected the horticulture crops. "J&K horticulture production has been facing the brunt of climate change. Its effect can be seen in the decrease in crop production, quality of specific crops, and their market in recent years. Walnut, saffron, and apple are some of the horticulture crops in the Kashmir valley that have declined rapidly due to change in climate, imports of a cheaper variety of crops, and poor irrigation," the paper reads. The Food and Agriculture Organization of the United Nations (FAO) also states that no other sector is more sensitive to climate change than agriculture.

Muhammad Ashraf Lone, a seasoned fruit-grower from South Kashmir, who has devoted a lifetime to apple growing, expressed that the dramatically changing climate over the years pose unprecedented challenges for fruit cultivation. Despite years of knowledge and expertise, he said that they find themselves navigating unfamiliar territory due to the changing weather conditions impacting their beloved apple orchards.

"Rising temperatures have affected the timing of various agricultural activities," Lone said, adding that spring arrives earlier, causing plants to bud and bloom sooner. "This shift in the timing of growing seasons can disrupt the overall natural balance of plant growth."

### Spurring Novel Cultivations

In the days of yore, who would have imagined that tropical fruits like lemon and oranges would find a home in the lush Kashmir valley? Yet, unexpectedly, the changing climate patterns have granted the zesty fruits a new territory to flourish. While the ability to grow lemon in a region known for its cooler climate might be due to advancements in agricultural practices and the use of protected cultivation methods, it can also be attributed, at least in part, to the effects of global warming.

Various studies also suggest that increasing temperatures could enable the cultivation of crops previously unsuited to cold regions, while traditional cold-adapted crops might struggle in less suitable climates. Certain plant varieties accustomed to warmer tropical conditions or extended growing seasons are now thriving in areas with more favourable temperatures. For instance, Kashmir that was historically too chilly for certain crops, like lemon or other tropical fruits, might now be able to support their growth due to the warmer temperatures.

However, Dr. Tariq Rasool, Senior Scientist and Assistant Professor of Plant Pathology at Sher-e-Kashmir University of Agricultural Sciences and Technology of Kashmir (SKUAST-K), pointed out that while certain individuals or small-scale gardens might endeavour to cultivate these fruits, achieving significant commercial success has proven to be a challenge.

"Some gardening enthusiasts may attempt to grow tropical fruit trees on a smaller scale, such as in home gardens or protected environments like playhouses, but despite these minor successes the survival and successful fruiting of these trees on a larger scale in Kashmir remain limited," Dr. Tariq told Kashmir Observer. It is true that global warming and climate change have contributed to shifts in weather patterns, but "it is important to consider other factors as well," he added.

### Pest and disease pressure

"Insects are heat loving creatures," Dr. Tariq said while explaining that the abnormal temperature patterns create a more favourable environment for pathogens, pests, and diseases that affect apple trees.

According to the horticulture expert, the increasing temperatures have amplified the need to use insecticides in apple orchards. "In the past, within certain high-altitude regions of Kashmir, farmers typically employed just one or two types of insecticides annually due to the cooler climate. However, an upward temperature trend has compelled them to increase the frequency of spray applications, owing to the significant risk posed by pests and diseases in the orchards," the expert explained. Floriculture is also facing the heat.

The once chilly winters, adorned with blankets of snow, are yielding to milder temperatures and longer, temperate days. As a result, not only fruit production, climate warming

has also led to changes in the timing and patterns of flowering for various plant species in the region. Locals also said that over the years an unusual phenomenon has been observed as many flowers are wilting and withering earlier than usual.

A study conducted by the Department of Botany, University of Kashmir has reported the shifts in spring flowering phenology of model plant species, *Sterbergia vernalis* – commonly known as Gul-e-toor in Kashmir. It unveiled that these flowers are flowering a month earlier, in response to the changing climate in Kashmir Himalayas.

Another study by the same department also observed a phenological shift, which refers to the stages of events in a plant's life cycle, in selected plant species under experimental warming. As the temperature increased, the time during which flowers bloomed became shorter.

"Plants are highly sensitive to environmental changes including temperature. And the withering of flowers can't be ruled out given the prevalent heat wave that Kashmir is experiencing," Dr Irfan said.

"Earlier it was very difficult to find the buyer and then you had to bargain on rates. Now the rates are fixed on websites and the buyers choose the product online," said Najar, a resident of North Kashmir's Gurez.

Waheed-ul-Hassan, technical officer at the J&K Medicinal Plants Board told Kashmir Observer that rates for the medicinal plants are provided by Regional Cum Facilitation Centres (RCFCs) to the growers, who put it on the web portal.

The RCFCs have been established by the National Medicinal Plants Board (NMPB).

He further said that the RCFC NR-II of SKUAST-Kashmir is exclusively looking after the medicinal plants sector in two UTs of J&K and Ladakh.

He said the department informs every grower how to use the application in every programme.

The demand for medicinal plants is increasing day by day and the government is encouraging more and more people to cultivate the plants in their land which will ultimately boost the economy of the region.

## Ahead Of Asia Cup, Pakistan Need 1 Win To Claim No.1 ODI Spot

**DUBAI:** Pakistan are just one win away from claiming the No.1 ODI team ranking ahead of the Asia Cup 2023 and ICC Cricket World Cup. Pakistan clinched an exciting one-wicket victory over Afghanistan in Hambantota on Thursday and in the process clinched an unassailable 2-0 lead in the three-game series.

That improved Pakistan's ODI team rating just short of first-placed Australia and the Asian side could claim the premier position as the No.1 ranked one-day side as early

as Saturday with a victory over Afghanistan in the third and final match of their series. Meanwhile, India are at third position followed by New Zealand and England in the latest ICC ODI ranking.

Notably, India will clash with arch-rival Pakistan in Kandy on September 2. In 10 ODI matches this year Pakistan have lost just three - all against New Zealand - and their form with both bat and ball during the ongoing Afghanistan series has them on the cusp of claiming the top ranking from Australia, as per ICC.

Pakistan also boast some of the highest ranked ODI play-

ers, with Babar Azam leading the way in the ODI Batter rankings and teammates Imam-ul-Haq (third) and Fakhar Zaman (fifth) not far behind. Following the completion of the series against Afghanistan, Pakistan will take part in the 2023 Asia Cup and their first match in that six-team tournament comes against Nepal in Multan on August 30.

They then take on New Zealand and Australia in official warm-up fixtures for the World Cup, with their first clash at this year's tournament coming against the Netherlands in Hyderabad on October 6. (ANI)

Half hour into the ticket sales, the website started working but by then a chunk of the fans had lost their patience.

The ticket sales for India games in Chennai, Delhi and Pune will go live on August 31 while the coveted ones for the India-Pakistan blockbuster in Ahmedabad will be put up for sale on September 3.

The BCCI and ICC had opted for a staggered sale process to offer a smooth experience to the fans.

The fans have already criticised the organisers

for their handling of ticket sales and schedule for the first ODI World Cup in India since 2011.

Earlier this month, the BCCI and ICC revised the schedule of as many as nine games after announcing the full schedule in June.

In contrast, the schedule of the previous World Cup in England and even the 2011 edition in India was announced well in advance.

## Spain's Govt. Starts Proceedings To Suspend Soccer Chief Rubiales

**MADRID:** Spain's government has started the legal proceedings seeking to suspend soccer federation chief Luis Rubiales for kissing World Cup star Jenni Hermoso on the lips after Spain's World Cup victory, an official said on Friday.

Rubiales refused to quit on Friday, fuelling anger among players and government ministers who decried his actions as unacceptable macho behaviour.

"The government starts today the procedure so that Mr Rubiales has to give explanations before the Sport Court and if the Sport Court agrees, I can announce that we will suspend Mr. Rubiales from his functions," Victor Francos, head of the state-run National Sports Council told a news conference on Friday.

Spanish football federation (RFEF) president Luis Rubiales said on Friday he would not step down in the face of pressure from politicians, players, unions and FIFA for kissing player Jenni Hermoso on the lips following Spain's World



Cup victory.

Speaking at an RFEF emergency assembly on Friday, Rubiales complained that "false feminists" were "trying to kill me". He described the kiss as a peck that was "free, mutual and consensual".

"Is a consensual peck going to take me out of here? I won't resign. I will fight until the end," Rubiales said, drawing applause from the predominantly male audience.

Condemnation has built throughout the week of the

incident which occurred while the players were being handed their medals after they beat England 1-0 in the World Cup final on Sunday. As players filed past, Rubiales grabbed Hermoso by the head and planted a kiss on her mouth.

It culminated with FIFA opening disciplinary procedures against him on Thursday after Hermoso said in a statement on Wednesday that her union was working to defend her interests and that such acts should "never go unpunished".

## Klopp Says Mo Salah Not For Sale As Saudi Rumor Swirls

**LIVERPOOL:** Liverpool manager Jurgen Klopp has downplayed speculation that Mohamed Salah could move to Saudi Arabia.

Sections of the British media reported Thursday that Al-Ittihad wanted to buy the 31-year-old Salah, who has two years left on his deal at Liverpool.

According to reports, Al-Ittihad are trying to lure the Egyptian to the Gulf state with a huge salary offer that would rival the deals that enticed Cristiano Ronaldo and Neymar to the Gulf kingdom. Salah signed a three-year contract extension at Anfield just




over 12 months ago and his agent has previously poured cold water on speculation of a move.

## 60% Bird Species in India Have Declined over 30 Years: Report

Of the 338 bird species studied in India for changes in numbers over the last 30 years, 60 per cent have experienced a decline, says a new report based on data from about 30,000 bird-watchers across the country.

Also, 40 per cent (142) of the 359 species evaluated for change over the last seven years have declined, according to the report titled "State of India's Birds".

The assessments rely on three indices: two are related to the change in abundance -- long-term trend (change over 30 years) and current annual trend (change over the past seven years) -- and the third is a measure of distribution range size within India.

Of the total of 942 species evaluated, long-term trends could be determined for 338 species. Of these, 204 species have declined, 98 are stable and 36 have increased, says the report published by a group of 13 government and non-government institutions, including the Bombay Natural History Society (BNHS), Wildlife Institute of India (WII), and Zoological Survey of India (ZSI). Current annual trends could



be determined for 359 species, of which 142 have declined (64 rapidly), 189 are stable, and 28 have increased.

The report classifies 178 species, including Northern Shoveler, Northern Pintail, Common Teal, Tufted Duck, Greater Flamingo, Sarus Crane, Indian Courser and Andaman Serpent Eagle, as "high conservation priority".

Fourteen species, including Indian Roller, Common Teal, Northern Shoveler and Common Sandpiper, have dropped by 30 per cent or more and have been recommended for IUCN Red List reassessment, the report says.

Generalist species like feral Rock Pigeon, Ashy Prinia, Asian Koel and Indian Peafowl are doing very well. Other common species like the Baya Weaver and Pied Bushchat are relatively stable, according to

the report prepared using the data uploaded to the online platform eBird. Habitat specialists -- particularly birds of grasslands and other open habitats, wetlands, and woodlands -- are declining rapidly.

In terms of diet, carnivores, insectivores, and granivores are declining more rapidly than omnivores or fruit-and-nectar eaters, the report shows.

Also, migratory species appear to be under greater threat than non-migrants while species endemic to the Western Ghats-Sri Lanka region are faring worse than others.

Certain groups of birds are faring particularly poorly, including open habitat species like bustards and coursers, riverine sandbar-nesting birds like skimmers and some terns, coastal shorebirds, open-country raptors, and a number of ducks.
