Families To Get Land **Compensation Soon**

Old Airfield Landowners Get Assurance From DGDE New Delhi

New Delhi: Over 600 families from Central Kashmir's Budgam district are likely to get compensation for their land acquired by the Defence Estates Department at Srinagar Old Airfield around 10 years ago.

The huge swath of land measuring 3879 kanal was acquired by the Defence Estates Department in 2012. For the last 11 years, around 600 families from Wathoora, Kralpora, Buchroo, Rangreth and other adjoining areas of Budgam district were seeking compensation for the acquired land.

Prior to 2013, the land owners were paid annual rent by the Army through the Defence Estates Department from 1957. In 2012, the government decided to acquire the land which is already in the possession of the Army. Although Rs 4.80 lakh per kanal

was already paid to each family but the rates were enhanced to Rs 18 to 20 lakh per kanal and the payment was not disbursed to the families over these years.

According to reports, a delegation of aggrieved landowners led by social activist Dr Raja Muzaffar Bhat had a detailed meeting with senior of DG Defence Estates Office in New Delhi on Monday.

President of Zamindar Committee Karewa Damodar, Ahmad Sofi, Vice President Mohammad Ameen Kuchay along with prominent RTI activist from Budgam Mushtaq Ahmad Lone were part of the delegation.

In a statement issued here, the Zamidaran Committee Karewa Damodar said that meeting was successful as the senior officers of DG Defence Estates Office in New Delhi said that payment to the tune of over Rs 600 Crore had been sanctioned by Govt of India and would be disbursed to the land owners through Defence Estates Officer Srinagar and Deputy Commissioner (DC) Budgam.

Pertinently the land owners of along with some prominent social activists had also raised the issue with GOC 15 Corps Lt Gen ADC Auila in Srinagar last year. They had apprised the senior army commander about the problems faced by affected families due to delay in release of the payments.

"The previous GOC 15 Corps Lt Gen ÂDS Aujla had taken our issue seriously and since then he had been making communication with the Defence Estates Department. Even after this transfer from Srinagar he facilitated the meeting with the top officers in DG Defence Estates Department and we are fully >> More On P10

Court Grants Bail To 'Conman' Kiran Patel

Srinagar: Nearly six months after his arrest, Kiran Bhai Patel, the man from Gujarat who allegedly conned the security establishment in Jammu and Kashmir into believing him to be a PMO official, was granted bail by a court here.

He had enjoyed five star pro-tocol "brazenly" for a considerable period of time prior to his arrest on March 2 this year.

The court of Chief Judicial Magistrate (CJM) Srinagar Raja Mohammad Tasleem granted the bail, Patel's lawyer said.

Earlier the court had rejected two bail applications by Patel, observing that he seemed to be a habitual offender in view of the fact that as many as five FIRs are registered against him in different places including his home State Gujarat. Besides, the court had observed that the nature of the offence against him was very serious as the accused has tried his level best to dupe the Government functionaries and seems to be "habitual in committing such type



of offences"

Kiran Patel, the alleged imposter hailing from Gujarat posed as an additional director (strategy and campaigns) in the Prime Minister's Office and enjoyed many perks, including a bulletproof car and security cover besides other hospitality. Leopard Mauls Minor To Death In Bandipora

Woman Among 3 Injured By Bear In Kulgam

Srinagar: In yet another deadly incident of man-animal conflict, a seven-year-old boy on Tuesday was mauled to death by a leopard in Nesbal area of North Kashmir's Bandipora district.

7-year-old Zaid Bashir had gone missing from his native Nesbal village on Monday evening following which a massive search operation was launched by Police, army's 13RR. CRPF with the assistance of the locals, officials said Tuesday.

According to them, blood-stains and clothes of the boy were found near a field, leading them to suspect that a leopard, which had been sighted often in the area, had attacked the boy.

After overnight search, the boy's mutilated body was found in a nearby hillock in Nesbal in the early morning on Tuesday.

After legal-medical formali-

ties, the body was handed over to his family members for last rites. Meanwhile, three people, including a woman were attacked and injured on Tuesday by a black bear in Damhal Hanjipora area of South

Kashmir Kulgam district. Muhammad Ramzan Malik, Muhammad Shafi Malik and Raja Begum were working in an orchard in their native Nagam village of DH Pora when a bear appeared there and attacked them, reports said. The trio sustained injuries in the surprise bear attack. >> More On P10

Police Arrests Imam For Sodomising 9-Yr Old Boy In Srinagar

Student Stabbed Inside Govt Polytechnic Bemina; Two Held

Srinagar: Police on Tuesday arrested a man on the charges of allegedly sodomising a minor boy at Malik Angan area of Safakadal in the old city and threatening him of dire consequences in case he disclosed the shameful act to anyone.

A police official told Kashmir Observer that a 9-years old boy was molested and sodomised by a cleric of a local mosque at Malik Angan locality in Safakadal.

He identified the accused cleric as Waseem Raja son of Ali Mohammad Malla of Noorbagh area in Srinagar. The accused, he said, was leading prayers at a local mosque in Safakadal.

A formal case FIR No. 30 of 2023 under IPC sections 377 and 5,6 POSCO Act was registered at Maharaj Gunj police station in this regard and

investigation was set into motion. Confirming the incident, Srinagar police on X said "One Waseem Raja S/o Ali Mohd Malla R/o Noorbagh presently working as Imam at Masjid Aisha Malikaagun arrested for committing unnatural sexual offence on a 09 years [old] child."

Meanwhile two youth were arrested by the police for attacking and injuring a teenager at Government Polytechnic for Women in Bemina area of Srinagar on Tuesday.

A 19-years old teenager from Sopore was hospitalized after being attacked by two youth with a sharp edged weapon at the college premises here this afternoon, a police official said.

Identified as Mehran Ahmad



son of Parvaiz Ahmad Khuroo of Sopore town in north Kashmir's Baramulla district, the student, police said, suffered injuries in his head, chest and lower back portion of the body in the attack.

The incident took place following an altercation between him and the accused in the college premises. The accused duo, police said in a fit of rage stabbed the victim multiple times, leaving him

critically injured.

'Illiterate' Appointed Instead Of Namesake

HADURA (BUDGAM) - Even as numerous scandals of fake appointments have surfaced in various government departments over the recent years, incidence of the wrong doing is far from being stamped out. Some diehards still manage to get a job in one or the other department by manipulating records and documents, and by tapping the 'right' person and the 'tight' timer.

An illiterate villager has got a government job allegedly by impersonation, and got away with it, assurance of the finance minister to get the wrong undone notwithstanding. In the process the genuine claimant for the appointment continues to be jobless. Reports said Nazir Ahmad Dar r/o Abdul Kabir Dar R/o Badipore has passed his 12th (TDC) clam examination. But, it is his name sake in the neighbourhood who, though illiterate, has allegedly got a government job. The only difference between the two is in the names of their grandfathers. While the former's grandfather is named Abdullah Dar, the latter's name is Ahmad Dar. According to reports, the uneducated Nazir Ahmad Dar was

appointed in the horticulture department in 1996. He is posted in the district office at Budgam. Sources in the department said Dar managed to procure the certificates of his educated namesake which he produced in support of his claim. The department did not entertain the 'genuine' claim of the educated Dar.

Though the serious case of alleged swap was brought to the notice of the state vigilance organisations, no action has been taken so far. The educated Dar approached the finance minister, Abdur Raheem Rather, who also happens to be his neighbour. He had assured him to get the right person appointed against the post. However, justice 'still eludes hint despite lapse of about four years In another case, Mushtaq Ahmad Zargar s/o Ghulam Ahmad

Zargar r/o Badipore has managed to secure a job allegedly by producing a fake certificate of academic qualification. According to reliable sources, he is barely read upto 4th standard. However, he managed to get a certificate of having passed his 9th class (under metric) examination from the government higher secondary school, Nagam, in 1996 allegedly, through his brother, Abdul Rasheed Zargar, who is a teacher at Badipore.

On the basis of the alleged fake certificate, Zargar was appointed as a peon in the animal husbandry department. He has been working at the veterinary dispensary here for about three years past. Sources said the department did not take any action to unravel the facts and bring the accused to justice even after the matter was brought to its notice

Imran Khan's Conviction, 3-Year Sentence Suspended By Islamabad High Court

ISLAMABAD: The Islamabad High Court today suspended Imran Khan's conviction and three-year sentence in the Toshakhana corruption case and ordered his release, in a big relief for the former jailed Pakistan prime minister.

A division bench comprising Islamabad High Court (IHC) Chief Justice Aamir Farooq and Justice Tariq Mehmood Jahangiri announced the muchanticipated verdict which was reserved on Monday.

"Decision of District Court (has been) suspended by IHC," Imran Khan's party Pakistan Tehreek-e-Insaf said in a short WhatsApp message

WhatsApp message.

"The copy of the judgment will be available shortly all we are saying now is that [Imran's] request has been approved," Justice Faroog said.

Khan's aide on legal affairs Naeem Haider Panjotha posted on X, formerly Twitter: "The CJ has accepted our request, suspended the sentence and said a detailed decision would be provided later." The judges reserved the verdict on Monday after the rival lawyers concluded their arguments on the suspension of the three-year sentence awarded by Judge

Humayun Dilawar on August 5. A trial court in Islamabad convicted and sentenced the 70-year-old Pakistan Tehreeke-Insaf chairman to three years in prison on August 5.



The cricketer-turned-politician was sentenced on charges of unlawfully selling state gifts acquired by him and his family during his 2018-2022 tenure. He has also been barred from politics for five years, preventing him from contesting an upcoming election.

Khan challenged his conviction within days and the IHC began a formal hearing on August 22. It adjourned the case on Friday after the lawyer representing the Election Commission of Pakistan (ECP) did not appear due to illness.

Imran Khan's lawyer Latif Khosa completed his argument on Thursday, asserting that the verdict was given in haste and was full of shortcomings.

He also urged the court to set aside the sentence but the defence team demanded more time to complete its arguments.

Separately, a three-member top court panel led by Chief Justice Umar Ata Bandial and comprising Justice Mazahar Ali Akbar Naqvi and Justice Jamal Khan Mandokhail is also set to resume hearing petitions against the Toshakhana case.

Insulting Woman, Being Rude To Her Is Not Outraging Modesty: Court

NEW DELHI: Insulting a woman or being rude to her and not behaving in a chivalrous manner will not amount to outraging the modesty of a woman, the Delhi High Court has held while setting aside an order putting a man on trial for calling a woman 'gandi aurat'.

The high court also said gender-specific laws are not meant to be "anti-opposite gender" but to serve the purpose of addressing unique issues faced by a particular gender.

It said the fact that a piece of legislation is gender-specific should not be misconstrued to mean that the role of a judge also changes from being neutral to tilting towards a particular gender, and irrespective of the gender-specific nature of a law, the judicial duty fundamentally requires unwavering neutrality and impartiality.

"Gender-specific legislation exists to address the unique concerns and challenges faced by particular genders within society. However, this does not imply that the judge is to be influenced or swayed by gender-related factors when administering justice unless specific

presumptions are legislated in favour of a particular gender in

"In essence, judicial neutrality is an indispensable cornerstone of the legal system, ensuring that all parties, regardless of gender, are treated fairly and equitably," Justice Swarana Kanta Sharma said.

The high court made the observations while setting aside a trial court's order framing a charge under section 509 (word, gesture or act intended to insult the modesty of a woman) of the IPC, saying a prima facie case was made out against

The prosecution's case was that the complainant woman and the accused were working in the same organisation and the man was her senior.

It was alleged that he used foul language against the woman when she refused to give him ₹1,000 and called her 'gandi aurat' (dirty woman).

The high court said the word 'gandi aurat', if read in isolation, without context, without any preceding or succeeding words indicating intent to outrage the modesty of a woman, will not bring these words within the ambit of Section 509 IPC.

China Provokes India, Includes Arunachal, Aksai Chin In New Map

BEIJING: China has officially released the 2023 edition of its "standard map," which shows the state of Arunachal Pradesh and the Aksai Chin region as part of its territory.

The map released on August 28 shows Arunachal Pradesh which China claims as South Tibet and Aksai Chin occupied by it in the 1962 war as part of its territory. Taiwan and the disputed South China Sea are also included within the Chinese territory in the new map.

The map also incorporates China's claims over the ninedash line thus laying claim to a large part of the South China Sea

Vietnam, the Philippines, Malaysia, and Brunei have all claims over the South China Sea areas.

The map was released by China's Ministry of Natural Resources during the celebration of Surveying and Mapping Publicity Day and the National Mapping Awareness Publicity Week on Monday in Deqing county, Zhejiang province, as per China Daily newspaper.

Recently Prime Minister Narendra Modi and Xi Jinping met on the sidelines of the BRICS Summit in Johannesburg, South Africa.

Foreign Secretary Vinay Kwatra had said in his con-



versation with President Xi Jinping, Prime Minister Modi highlighted India's concerns on unresolved issues along the Line of Actual Control in the Western Sector of the India-China border areas.

"The Prime Minister underlined that maintenance of peace and tranquillity in the border areas and observing and respecting the LAC are essential for the normalisation of the India-China relationship. In this regard, two leaders agreed to direct their relevant officials to intensify efforts at expeditious disengagement and de-escalation," Mr Kwatra had said.

The chief planner of China's Ministry of Natural Resources, Wu Wenzhong, said surveying, mapping and geographic information play an important role in boosting the development of the nation,

meeting the needs of all walks of life, supporting the management of natural resources, and helping the construction of ecology and civilization.

"The next step will be to accelerate the application of geographic information data such as digital maps and navigation and positioning in the development of the digital economy, such as location-based services, precision agriculture, platform economy and intelligent connected vehicles," Wu said, as per China Daily.

Zhejiang has in recent years focused on the deep integration of the digital and real economies and has continued to promote the development of the digital economy, according to Li Yaowu, deputy secretary-general of the Zhejiang Provincial People's Government.



Lok Sabha Polls Likely To Be Advanced: Nitish Kumar Backs Mamata Banerjee

NALANDA, BIHAR: The Lok Sabha elections are likely to be advanced as the BJP fears with time it will suffer more loss because of the opposition unity, Bihar Chief Minister Nitish Kumar said today, backing a similar claim made by Mamata Baneriee.

Ms Banerjee on Monday said that she was apprehensive that the Lok Sabha elections could be held in December this year, or in January.

Mr Kumar told reporters, "I
have been saying it for the
last seven-eight months that
the NDA government at the

Sabha polls, fearing more loss
to the BJP because of opposition unity."

"Therefore, all opposition parties must come together to defeat the BJP in the Lok Sabha polls. I am once again repeating that I have no desire for myself, I have no personal ambitions. My only wish is to unite the maximum number of parties (opposed to the BJP) before the elections," he added.

Mr Kumar, who recently said

that more parties are likely to join opposition coalition INDIA, declined to divulge any details.

"We have taken initiatives for unity among the opposition parties. The opposition coalition INDIA will further strengthen after the Mumbai meeting on August 31 and September 1," he said.

The chief minister was speaking to reporters after inaugurating the new campus of the Nalanda Open University.

Mr Kumar said the exercise for the cast survey has been completed, and it will be soon published.

"The exercise has been completed. Now, the data is being compiled and it will soon be published. The final data will enable the government to work for the development of various sections of society, including those who are deprived. This will help us to know which areas require development. Let the detailed data be published, I am sure that other states will also follow it," he said.

Mr Kumar said the decision to hold the caste-based survey was unanimous, and taken by the leaders of all political parties, including the BJP.

Raisi: Iran Will Not Yield To West's Attempts Of Isolation And Despair

During a news conference in Tehran on Tuesday, Iranian President Ebrahim Raisi claimed that efforts by the West to isolate Iran and bring despair to the Iranian people have been in vain, and while the country has forged strong relations, its enemies are also knocking on the door after trying to abandon it during the riots last year, after the death of the young Mahsa Amini.

"The enemy tried to follow two strategies of isolating Iran in the world and disappointing the people inside, which it failed in both," he said, adding: "That is because we follow numerous agendas in our foreign policy all at the same time, one of which is the JCPOA" citing the 2015 nuclear deal following the US' withdrawal.

"We've followed relations

"We've followed relations with the neighboring countries as well as Islamic and aligned states, and improved the level of political, economic and commercial relations where commercial ties have



grown 14 percent compared to the previous government," he noted.

"In the area of regional trade ties and business measures which some believed little can be done, the government broke the record, and it turned out that there are many capacities in the country."

Ready for negotiations with US Raisi continued that en-

Raisi continued that enemies "tried to anger the people by creating problems, but the people carried on vigilantly and with insight and disappointed the enemy." However, upon realizing that the people stood with its government and that progression did not stop, they turned to unrest.

"It thought that it could follow through with agitation. Even the Westerners left the negotiation table and pinned their hope on riots," he said, adding: "They thought that they could achieve their goals in riots, but the people let them down, after which, they immediately messaged that they wanted to go back to the negotiating table and start negotiations."

According to the Iranian president, signs like production, science, and technology indicators, alongside knowledge-based projects of the Iranian youths show "growth, effort and progress."

"Today is the day when Islamic Iran is known as an advanced and technological country".

In light of recent US reports the Biden administration has been negotiating discreetly to launch diplomatic channels with Iran, the latter has not commented, and Raisi asserted that they "have not abandoned the negotiating table for removing the sanctions".

"The other side left the negotiation table, and now they regret it, stating that they are ready to negotiate."

"Prisoner's Constitutional Rights": High Court Pulls Up Tihar Jail Over Prison Amenities

NEW DELHI: Observing that a prisoner's basic constitutional rights persist even behind bars, the Delhi High Court has constituted a four-member fact-finding committee of lawyers to "meticulously" inspect the living conditions in Tihar jail, including the status of drinking water, sanitation, overall hygiene and maintenance of washrooms in the prison complex.

While taking note of alleged lack of basic amenities in the largest prison complex in South Asia, the court remarked the right to life remains inviolable, irrespective of an individual's incarcerated status.

"Recognising the pressing nature of this issue, we deem it necessary to authorise an independent committee for a meticulous inspection of Tihar jail. To this end, we establish a factfinding committee consisting of Dr. Amit George, Santosh Kumar Tripathi, Nandita Rao, and Tushar Sannu.

"Their mandate is to impartially evaluate the present conditions and update us on the

status of drinking water, sanitation, overall hygiene, and the maintenance of washrooms/ toilets within the complex," a bench of Chief Justice Satish Chandra Sharma and Justice Sanjeev Narula said in an order passed on August 23.

The high court was hearing a public interest litigation (PIL) filed by the Delhi High Court Legal Services Committee (DH-CLSC), highlighting the pressing issue of supply of clean drinking water and maintaining hygienic sanitary conditions within the Tihar jail complex.

The petitioner drew the court's attention to a report stemming from an inspection conducted by a panel counsel which underscored a "worrying deficiency" in providing inmates with drinking water in jail.

The plea also described the

The plea also described the sanitary conditions there as less than satisfactory and added that many washrooms and toilets are in disrepair and even the basic privacy of inmates is compromised due to broken doors, hampering their ability to maintain personal hygiene in private.

Ms Srivastava is expected to take up her assignment in Islamabad shortly, said one of the people familiar with the matter.

Libyan Pm Sacks FM After Storm Over Israel Meeting

TRIPOLI: Libya's prime minister sacked the foreign minister on Monday in an effort to contain a growing furore over Najla Mangoush's meeting with her Israeli counterpart last week, which prompted protests in several Libyan cities.

Mangoush had said her meeting with Israeli Foreign Minister Eli Cohen in Rome was unplanned and informal, but an Israeli official said it had lasted two hours and was approved "at the highest levels in Libya".

Some reports in Libyan media said the foreign minister had left for Turkiye after the furore, but others said she was in the country and had been put on a no-fly list.

The meeting is contentious because Libya does not formally recognise Israel and there is widespread public support across the Libyan political spectrum for the Palestinian cause of creating an independent state in ter-



ritory Israel occupies.

The dispute over the meeting has fed into Libya's internal political crisis, giving ammunition to Prime Minister Abdulhamid Dbeibah's internal critics at a moment when the future of his interim government was already in question.

Libya has been without a stable central government since the overthrow of Muammar Qadhafi in 2011. Dbeibah's interim government, in office since 2021, is not recognised by some major factions and there is growing political momentum to replace it with a new unified administration aimed at holding national elections.

Protesters demonstrated in front of Libya's foreign ministry late on Sunday, causing some damage outside the building, where a large security presence was visible early on Monday.

Protests took place in other parts of Tripoli, as well as other cities.

Burning tyres blocked some major roads in Tripoli on Monday, but there was no sign of violence.

Mangoush's office tried to quell the anger late on Sunday, saying she had rejected a request for an official meeting with Cohen, but that they had met during an unplanned encounter while she was meeting Italian Foreign Minister Antonio Tajani.

'Bridge to West'
The Israeli official disputed that account. "The meeting was coordinated at the highest levels in Libya and lasted almost two hours. The Libyan prime minister sees Israel as a possible bridge to the West and the US administration," the official said.

SG's Arguments In SC Vindicate Our Stand: Mehbooba

SRINAGAR: PDP chief Mehbooba Mufti on Tuesday said the arguments by Solicitor General Tushar Mehta in Supreme Court

during the hearings on a batch of petitions challenging the abrogation of Article 370 vindicated her party's stand that the situation in Jammu and Kashmir was far from normal.

The Solicitor General on Tuesday informed a five-judge constitution bench of the apex court, headed by Chief Justice D Y Chandrachud, that the Union Territory status of Jammu and Kashmir is not a "permanent thing" and the Centre will make an elaborate statement on the vexatious political issue in the court on

The bench was hearing Mehta's submissions defending the Centre's decision to do away with the special status of the former state and its reorganisation.

"Despite GOI's tall claims, SG's statement before the SC today vindicates our stand that the situation is far from normal in J&K," Mufti posted on X, formerly Twitter.

She said the Solicitor General is making the argument only as an excuse to defend the Centre's "constitutional harakiri".

"Even to achieve this abnormal normalcy, J&K has been

turned into an open air prison. Tushar Mehta is now invoking our argument only as an excuse to defend GOI's constitutional hara-kiri,' she said on the microblogging site.

NC leader and former Jammu and Kashmir chief minster Omar Abdullah also called Mehta's argument a "diversion"

"The SG is a very competent & clever litigator. He's trying to divert the focus of the arguments to the centre's view of 'normalcy'. This is a trap best avoided," Abdullah said.

He underlined that the apex court has not been petitioned to rule on the security situation or normalcy in Jammu and Kashmir, adding that the "simple question for the Hon CJ & other judges on the bench is to decide whether the changes forced on J&K in 2019 were legal & constitutional or not".

"Everything else is a diversion," he added.

SRINAGAR: Jammu and Kashmir on Tuesday added 16 more online services offered by the Transport Department to its list after Chief Secretary, Dr Arun Kumar Mehta launched them under the e-Transport project of the Department.

With this, Jammu and Kashmir moved to first place in the country amongst States/UTs in offering the number of online services to its citizens. The UT had earlier taken its tally to 1016 online services overtaking Kerala and other top performing States as per the recent edition of NeSDA rankings.

Speaking during the launch of these services, the Chief Secretary maintained that the motive of the online services is to reduce the burden on our citizens

by providing them opportunities to access services from the comforts of their homes. He observed that the provisions of facial recognition, e-KYC authentication and jivan pramanpatra are few reliable means to ascertain the genuineness of claims. He asked for adopting measures under which the services are offered to the citizens seamlessly without having to make physical visits to government offices.

Dr Mehta further impressed that since volume of services has increased exponentially, it is time to assess digital maturity of these services. He made out that the quantity underpinned by quality would lead to desired results and satisfaction of citizens. He enjoined upon them that the integration with APIs should also be carried out to make single sign-on a prominent feature for all these services.

The Chief Secretary called it is an important milestone in tune with the resolve of the J&K administration to provide corruption free, convenient and accessible services to the common man. He made out that the 'Digital J&K Programme' that was launched in mission mode last year has been successful in making J&K to upgrade from 'line to online' and 'physical to digital' thereby ushering an era of transparency and efficiency in working of government offices

The Chief Secretary took the occasion to commend the efforts of the IT Department and NIC for the progress made in enhancing the number of online services of different departments. He gave credit to the team work and commitment of all those officers

and officials who contributed immensely to take UT at the top of the rankings today from bottom a couple of years back.

While providing details the Secretary Transport, G. Prasanna Ramaswamy revealed that by introducing these services in an online mode would make the Department faceless to a large extent. He gave out that these services would go a long way in resolving many of the issues faced by the Department in serving the citizens better.

He also disclosed that the redundant options like Hold, Inward in file disbursement have been done away with in this improved set-up to bring efficiency in the working of the department. He said that the most downloaded government application named 'NextGen m-Parivahan' having more than 10 Crore subscriptions would soon be adopted here in J&K to provide holistic information about the transport related services to its users. He added that the Department is soon going to add the feature of auto-appeal in order to curb the chances of delay in providing services to its applicants.

The services which were made online today includes Transfer of Vehicle ownership, Hypothecation termination/changes, issuance of duplicate RC, Change of address in RC, issuance of fresh permit, renewal of permit, renewal of authorization, temporary permit, duplicate permit, transfer/surrender of permit, application for Counter sign/duplicate counter sign, modification of documents, updation of mobile number, checking status and pending transactions.

Plastic Menace

Board has revealed a startling reality – the region generates a staggering 51,000 tonnes of plastic waste each year, which then is littered around the place. Kashmir alone contributes 31,000 tonnes to this overwhelming total, with the Jammu division accounting for an additional 20,000 tonnes.

A prevailing 'throw-away culture' has seen plastic bags clog city drainage systems, leading to drain blockages that exacerbate flooding during rains. The plastic litter also infiltrates the landscape, choking water bodies that are already burdened with pollution from multiple sources. The situation worsens when ready-to-eat food items are carried in bags that leach out the chemicals, inadvertently exposing consumers to potential hazards.

The J&K government has made strides in tackling this menace. The ban on polythene usage within the region is a commendable step toward curbing plastic waste. However, more needs to be done to enforce this ban effectively and promote public cooperation. While regulations and policies are integral, a collective commitment to reduce plastic consumption and encourage responsible waste management is paramount.

Public awareness campaigns can play a huge role in changing mindsets and behaviors. Education about the dangers of plastic pollution, along with advocating for the use of sustainable alternatives, can foster a sense of environmental responsibility among citizens. This collective effort will contribute to the preservation of the Valley's natural beauty for generations to come.

Now the situation is such that polythene is everywhere. There's hardly any shop in the Valley where you can't get polythene carry bags. Though polythene pollution is a worldwide phenomenon, in Kashmir the penetration seems to be even deeper. Supermarket bags, nylons and other plastics litter roads, croplands and water bodies. The impact has been highly damaging. The humble plastic bag and plastic drink container play a far greater role in changing the planet than has been realized.

Though several times bans have been imposed on the use of plastic bags in J&K over the last two decades, not much has changed on the ground. The reason is that the bans were never seriously implemented. Here's hoping that the current government finally gets the act right and ensures not only that the use of plastic is strictly banned but that the use of environmentally friendly products is aggressively promoted. There is an urgent need to end this criminal negligence towards our environment. More so in Kashmir, the paradise on earth, whose natural beauty draws lakhs of tourists every year.

Gold winner

eeraj Chopra scripted another glorious chapter by becoming the first-ever Indian to secure a gold in the World Athletics Championships in Budapest on Sunday. It was Neeraj's second and India's third medal after long jumper Anju Bobby George opened the account in 2003. Neeraj, the first Indian Olympic champion athlete, hurled the javelin to 88.17m in his second attempt to achieve the crown in a highly competitive field, also comprising Commonwealth Games champion Arshad Nadeem, who took the silver, the first-ever Worlds medal for Pakistan, with 87.82m. Neeraj, who recorded his season best 88.77m in the qualification round, continued his unbeaten streak this year to not only improve upon his 2022 Worlds silver in Eugene but also become the third athlete after Jan Zelezny and Andreas Thorkildsen to win the World and Olympics gold. He formally led India's javelin revolution at a global stage as compatriots, Kishore Jena (84.77m) and D.P. Manu (84.14m), took fifth and sixth spots. Neeraj's feat made India one of the three countries which earned their maiden vellow metal. The Indian men's 4x400m relay team members (Muhammed Anas, Amoj Jacob, Muhammed Ajmal and Rajesh Ramesh) ran out of their skin to create a new Asian record (2:59.05) and enter the final. Ultimately, they finished fifth. Woman steeplechaser Parul Chaudhary set a new national mark of 9:15.31.

However, the long jumpers, triple jumpers, hurdler Jyothi Yarraji and steeplechaser Avinash Sable's below par show brought disappointment. Even though leading athletes have been caught for doping this year, Neeraj, Chaudhary and the relay team's achievements will encourage the Indians for the Asian Games and 2024 Olympics. The mediocre performance of several athletes is a matter of concern for the Athletics Federation of India and the Sports Ministry and calls for an appraisal of the training. The World Championships witnessed several spectacular performances, including the U.S. 4x400m mixed relay team's world record. While the U.S. continued to dominate despite a reduced tally of 29 medals, including 12 gold, Canada improved to claim six, including four gold. With China not getting a single title, Asia's gold count dipped from five to three. U.S. sprinter Noah Lyles became the first male after Usain Bolt to win the 100m, 200m and men's 4x100m relay titles, Kenyan superstar Faith Kipyegon won a 1500m and 5000m double and Spaniard Alvaro Martin and Maria Perez swept the race walks, coinciding with the Chinese and Japanese walkers' failure, to make the edition exciting. The World Athletics would do well to promote track and field sport across the globe.

Emerging extravaganza in Kashmir marriages is exacerbating the plight of poor marriageable girls and their coerced parents. New trends in dowry, wazwan, wedding attires and other related rites have made the marriages very difficult to solemnize. Kashmiris are taking a lead in brazen showoff to win false public admiration and extolment. Marrying off a daughter sends shivers down the spine of their hapless father, because marriage of the daughter requires hefty amounts of money and material to perform.

The institution of marriage has become almost a nightmare for poor and lower-middle class families. With every passing day, we add toxic conventions and incomparably burdensome innovations to our weddings.

Size of Gushtaba and the number of cuisines served to invitees in a Kashmir marriage has become the benchmark of our living. Very recently, a harrowing video went viral on different social media platforms, where the traditional wazwan was served to invitees individually. Contrary to our cultural legacy and cherished customs, guests in the marriage were not served the great feast in big copper plates, but separately in small plates. The wazwan was not ladled out by wazas but by young men attired in three piece suits. Is this the inclusion of a new innovation to our social structure?

Why is our affluent class oblivious to the impact of their rituals on our social fabric? Though wazwan is the crown of our unprecedented cultural identity, we have made it onerous and perturbing. The gluttony has probably ceased our ability to feel the pain of others. We have stooped to the lowest of low.

Luxury tent houses to accommodate guests have become an ugly reminder of poverty and lack of means of parents. Glamour and glory of our marriages is unfortunately attributed to the size and elegance of a tent house. Exorbitant rents of the tent houses break the backs of these impecunious parents who strive hard to earn their livelihoods. But, it has become more than an obligation for us.

A hapless father either takes loans or debts from money-lenders which they fail to reimburse throughout their lives. Consequently, hundreds have gone bankrupt or have committed suicide. The unnecessary splurge and squandering has ruined the lives of insolvent parents.

Sophisticatedly lavish and fancy dry-fruit boxes with multiple compartments to hold varieties of juices, dates, cashew nuts, pistachios, raisins, figs, kiwis and apricots, have tormented the poor parents of girls. Even copper-made trays with several chambers are hitting new highs in our markets. Meenakari and papier mache designs on these boxes and trays make them inor-



dinately extortionate and expensive. An empty tray containing boxes with handmade designs, costs thousands of rupees. And the huge prices of dry fruits makes it a royal rite. How can a poor father bear all this sumptuous outlay? The showoff will neither win us the pleasure of Allah SWT nor the public adulation we intend to gain. It only spoils our here and hereafter. And we don't let others live freely.

Demanding or expecting unwarranted gifts like golden ornaments, embroidered suits, precious sweets, and other things in the name of token of love, from a bride and her family, is the crueldifference to souls with dead consciences. I, at times, suspect our human origin.

Our pretentious ways of performing marital rituals have begotten new miseries and troubles for destitute parents of girls. Birth of a girl child frowns the face of a father, given the ostentatious customs and conservatism etched to our wedlock ceremonies. Thousands of girls are exasperatedly looking at the thresholds of their homes, to have a glimpse of their grooms. Their hina has burnt down to our inappropriate social dictums. The virtual typhoon of profuse lavishness has destroyed their castles before they are con-

Sermons, advices, wisdom and fear of God makes no

structed. Hundreds of wretched and woebegone parents are cursing their fates, because their beloved daughters have become obsolete to get married. Their aspirations and longings to see off daughters in marriage, have vanished into the thin air.

No angel or prophet will liberate us from the clutches of our own wicked social by-laws. We have entangled ourselves like those opportunistic birds who sit on noose traps to peck dazzling baits. We must break the shackles of our poor mindset to get rid of this unchained slavery. Lukh Kya Wanan is the biggest impediment in the path of our salvation and liberation. These Are The Reasons Why Sparrow And Other Birds Are Disappearing

Sparrows are closely habitat with humans. The house sparrow is a bird that comes under the sparrow family Passeridae, found in most of the world. The house sparrow is strongly bonded with the human habitat. It builds its nest below the roof, ventilators, and walls of the house. It can adapt itself to the urban or rural environment. The seeds of grains and weeds are the foods of sparrow and insects also its typical food. It was seen in more significant numbers earlier in most cities, towns, and villages associated with human settlers.

But its number is rapidly decreasing recently and even it reached the stage of disappearing. There are many reasons like urbanization, rising of concrete towers and cell phone radiation, absence of native plants and use of insecticides and pesticides in farms, and pollution with harmful gases that might affect a house sparrow population. Here the list of reasons that makes the little sparrow disappearing from the ecology.

Loss Of Trees Or Deforestation



It is a known fact that trees are the primary habitat of birds. Cutting down trees will create a habitat loss for birds then why not a sparrow, it also loses

its nest

Change In Building Construction



Earlier, we can see the buildings with an open window, the gap between the roof and wall, an electric box outside the house, and a place for a lamp in the house, sometimes holes in the wall. These are the places where we can find the nest of birds, especially sparrows. However today constructions are changed with a closed wall with glass windows, no ventilators, and no gap even to enter mosquitoes then how the birds can build a nest. Again it is a loss of habitat.

Absence Of Native Plants And Shrubs



Other familiar places for nesting are native plants and trees such as mehndi, jasmine, neem, and many others, where the sparrow finds the perfect place for nesting. These plants and trees are very close to humans since sparrows are living closely with humans. The shrubs and dense hedges are also the nesting place for the sparrow. It finds these places to defend itself from its predators.

Difficulty In Finding Grains And Seeds



The street grocery stores are replaced with modern air-conditioned closed grocery stores. The sparrows are struggling to find seeds and grains in sacks placed outside the stores.

Radiation From Mobile Towers



The electromagnetic radiations from the mobile towers affect the birds. It becomes the reason for declining its population. The radiations are even affecting the human, then how the little sparrow can sustain. Birds are more sensitive to magnetic radiation.

Increase In The Number Of Other Bigger Birds

An increase in the population of more giant birds like pigeons and crows. It is also one reason for the disappearance of sparrows. It causes a deficiency for food and shelter for sparrows.

Pollution And Use Of Chemicals In Fertilizers

Pollution in cities makes the birds move out of the cities. It is not getting good seeds and grains and struggling for non-polluted water resources.

Using chemicals in fertilizers produces grains and seeds with more chemical content, spoiling sparrows and other birds' diets.

It is hard to see the disappearance of sparrows. We can save it if we try some alternative. We can place a nest box with some grains to feed. Plant native plants and trees to help the sparrow to built its own nest. Can set up a water bath for birds to drink

and bath. Encourage others in saving the sparrow. To raise awareness and protect the house sparrows and other birds the World Sparrow day is celebrated on March 20 every year from 2010. It was an initiative of the Nature Forever Society of India in collaboration with many national and international organizations worldwide.

Sometimes the natural disaster like tsunami and floods would also cause the shift of the habitat of birds. Happily, the terrace of some good-hearted people's houses has become the habitat of birds like parrots. Gene Therapy Offers Potential New Treatment For Liver Cancer

US researchers have found that a type of gene therapy can someday help treat people with hepatocellular carcinoma—the most common form of liver cancer—and metabolic diseases like diabetes.

The team led by University of California-Davis discovered a gene therapy that induces the body to create microRNA-22 (miR-22), a naturally occurring molecule, aided in treating mice with hepatocellular carcinoma.

The miR-22 treatment also reduced liver inflammation and produced better survival outcomes with no observable toxicity compared to the US FDA-approved liver cancer treatment lenvatinib.

"This research introduces miR-22 gene therapy as a promising and innovative approach for treating hepatocellular carcinoma," said Yu-Jui Yvonne Wan, Professor from the UC Davis Department of Pathology and Laboratory Medicine.

"The study's findings suggest that miR-22 therapy could provide better survival outcomes, enhance anti-tumour immunity, improve metabolism and reduce inflammation.'

In the study published in the journal Molecular Therapy, the researchers explained that the miR-22 acts like a brake, stopping the production of certain proteins, including cyclin

A, protein deacetylases and hypoxia-inducible factor—all that can fuel liver cancer growth.

Wan's previous research shows that metabolites produced by the gut microbiome help create miR-22 and have anticancer benefits. These metabolites include retinoic acid, short-chain fatty acids, bile acids and vitamin D3.

mice. However, the miR-22-treated mice had longer survival times without toxicity compared with lenvatinib-treated mice.

MiR-22 and lenvatinib reduced serum alanine transaminase (ALT), aspartate aminotransferase (AST), and cholesterol levels, indicating improved liver function. MiR-22-treated mice showed no blood or organ toxicity.



colon or liver cancer, signalling from these metabolites is reduced. which in turn reduces miR-22.

This was a clue for Wan that returning miR-22 to a higher level might act as a treatment for liver cancer.

For the study, Wan used an inactivated adenovirus, and introduced miR-22 into mice with a single intravenous injection.

The mice treated with the gene therapy were compared with mice treated with the current US FDA-approved drug lenvatinib (administered orally once a day), untreated mice and healthy mice.

Both miR-22 and lenvatinib inhibited the progression of liver cancer compared to untreated

At five weeks, untreated mice had enlarged livers, making up 33.5 per cent of their body weight. The treated mice had smaller, less diseased livers, with ratios of 10.9 per cent (miR-22) and 12.0 per cent (lenvatinib) of body weight.

The median survival rate was 46 days for the lenvatinib group and 50 days for the miR-22 group.

Two mice treated with miR-22 remained alive for 60 days. In contrast, the survival time for the untreated mice was about 40 days.

"The positive findings from this preclinical study give us hope that miR-22 could be a promising alternative to treat hepatocellular carcinoma." Hu said.

For Restful Sleep In Aged, Ambient Temperature Should Be 20-25 Degrees Celsius: Study

Ambient night-time temperature for older adults to have a restful sleep should be between 20 and 25 degrees Celsius, according to newly published research.

Further, sleep efficiency in the older adults, aged 65 years or above, was found to drop by 5-10

per cent as the ambient night-time bedroom temperature rose to 30 degrees Celsius, the study found. despite substantial differences among the individuals studied.

A lowered sleep quality in the long-term has been linked with cognitive decline and dementia in older adults, along with impacting their mood by making

them irritable and less productive in the day.

Sleep quality in older adults could, thus, potentially be enhanced by optimising home thermal environments, the study from Marcus Institute for Aging Research and Harvard Medical School, Boston, US, said about its findings which, it said, emphasised the importance of personalised temperature adjustments based on individual needs and circumstances.From a climate adaptation point of view, the study findings are important as cities are projected to become warmer due to a combination of both climate change and urban induced warming, it said.

It is not known how much the decision would cost the exchequer but Thakur said the Rs 200 per cylinder subsidy provided to Ujjwala consumers would cost Rs 7,680 crore in the current financial year ending March 31, 2024 (April 2023 to March 2024).

While Ujjwala beneficiaries are only 9.6 crore, there are some 33 crore domestic cooking gas users in the country.

The government in June 2020 stopped giving LPG subsidies. Cooking gas across the country was priced at market rate, which rose to Rs 1,103 in the national capital.

The only subsidy that was available was for poor women who got free connections under Pradhan Mantri Ujjwala Yojana. The government gave Rs 200 per cylinder subsidy for up to 12 refills in a year. This subsidy was transferred into the bank accounts of the beneficiaries, who bought LPG at market price from the dealer.

'BRICS+6 To Control 30 Pc Of Global GDP, 46 Pc Population'

NEW DELHI: The addition of six new members to the BRICS grouping will see it controlling 46 per cent of the world's population and 30 per cent of its economic output, according to a research paper. At the latest BRICS summit in Johannesburg last week, the present members -- Brazil, Russia, India, China and South Africa -- decided to add Argentina, Egypt, Ethiopia, Iran, Saudi Arabia and the United Arab Emirates as new members of the grouping.

The new members will become part of BRICS effective January 1, 2024. The acronym BRICS was originally coined in 2001 by Goldman Sachs economists led by Jim O'Neill. Later in December 2010, South Africa was added as the fifth member. Currently, the five-member grouping is home to 40 per cent of the world's population which controls 26 per cent of the global GDP. But with the six new members (BRICS+6), their GDP share will jump to 30 per cent and share of population will go up to 46 per cent, Soumya Kanti Ghosh, the Chief Economic Adviser to State Bank of India, said in a note.

However, the biggest impact will be on the share of global oil production that will increase to 40 per cent from the current 18 per cent, while their oil intake share will jump from 27 per cent to 36 per cent, according to the note. Similarly, their share in global merchandise trade will rise from 20 per cent to 25 per cent, and that of global services trade will increase to 15 per cent from 12, the note said, adding that their share in the global forex reserves will increase by 600 bps

to 45 per cent. Ghosh stated that the new grouping will lead to the rise of a new Global South as BRICS+6 will offer a credible alternative to the hegemony of the Global North when it comes to global affairs, trade, currency and energy security. He noted that BRICS+6 will be a game-changer as the terms of global trade will get rewritten as the new grouping could be the lynchpin of a new global order. However, even after the new addition. China and India will continue to contribute 74 per cent of the overall GDP of the grouping, it

India braces for driest August since 1901 amid intensifying El Nino

New Delhi: India is poised to experience the driest August since 1901 which, senior meteorologists say, is a clear result of intensifying El Nino conditions.

Also, the monsoon this year may end up being the driest since 2015, which recorded a rainfall deficit of 13 per cent, they said.

With a 32 per cent precipitation deficit in August so far and the prediction of only subdued rainfall activity over a large part of the country in the next three days, India is on track to record the driest August since 1901, an India Meteorological Department (IMD) official said, requesting anonymity.

August receives 254.9 mm of rainfall, accounting for around 30 per cent of the precipitation during the monsoon season.

India recorded a rainfall deficit of 25 per cent in August 2005, 24.6 per cent in 1965; 24.4 per cent in 1920; 24.1 per cent in 2009 and 24 per cent deficit in 1913, according to the IMD data.

chief Mrutyunjay Mohapatra said the primary reason for below-normal rain-fall in August are El Nino -- the warming of waters in the Pacific Ocean near South America -and the "unfavourable phase of the Madden Julian Oscillation (MJO) which is known to reduce

convection in the Bay of Bengal and the Arabian Sea"

El Nino is generally associated with the weakening monsoon winds and dry weather in India.

The MJO is a large-scale intraseasonal atmospheric disturbance originating in tropical Africa and travelling eastwards. It is like a pulse or wave lasting about 30 to 60 days.

During the active phase of the MJO, the atmosphere becomes more favourable for rainfall. This leads to increased cloud cover, stronger winds, and enhanced convective activity, resulting in heavier rainfall over the Indian subcontinent.

"The favourable phase of MJO results in rainfall even if there is no low-pressure system. July recorded above-normal rainfall due to the favourable phase of MJO," Mohapatra said.

Only two low-pressure systems developed over the Bay of Bengal (BoB) against a normal of five under the impact of the prevailing El Nino conditions, he

"Another reason for belownormal rainfall in August was a lower number of low-pressure systems in the South China Sea and they, too, moved northward," he said.

Low-pressure systems that develop over the South China

Sea typically move westward, reaching the north BoB after crossing Vietnam and Thailand.

India experienced the longest break in the monsoon -- from August 6 to August 17 since 2009 which recorded 13 such days as El Nino gathered strength.

The northward migration of the monsoon trough -- an elongated low-pressure area

extending from heat low over Pakistan to the Bay of Bengal --leads to break monsoon conditions or suppression of monsoon rain over major parts of India especially in the core monsoon zone or the rain-fed agricultural region spanning from Gujarat

The northward movement trough or of the monsoon

in the west to West Bengal and

Odisha in the east.

break-monsoon phase results in heavy rains along the foothills of Himalayas and parts of eastern

"Monsoon breaks and normal rains are part natural variability of the monsoon. However, El Nino causes these break monsoon phases to continue for a longer period. This is what we are seeing. The stronger the El Nino, the longer the break phase," Madhavan Rajeevan, former secretary at the Ministry of Earth Sciences, told PTI.

Owing to the positive Indian Ocean Dipole (IOD), the outlook for September is not very bleak,

"September is not expected to be as bad as August. Models suggest the September rainfall will be on the lower side of the normal," he said.

The senior meteorologist said El Nino is the primary reason for the high rainfall deficit in August.

"The absence of the positive phase of MJO must have also played a marginal role," he said.

At a press conference on August 1, the IMD had said El Nino and other unfavourable conditions may suppress rain in August, though cumulative precipitation in the second half of the monsoon season (August-September) is expected to be normal.

"Rainfall in September is likely to be on the lower side (94 per cent to 99 per cent) of the normal (422.8 mm)," Mohapatra

Rainfall recorded between 94 per cent and 106 per cent of the long-period average (LPA), or 50-year average, is considered

Normal rainfall is critical for India's agricultural landscape, with 52 per cent of the net cultivated area relying on it. Additionally, it plays a crucial role in replenishing reservoirs essential for drinking water and power generation throughout

the country.
Rainfed agriculture contributes to approximately 40 per cent of the country's total food production, making it a vital contributor to India's food security and economic stability.

and its reorganisation, said, "Democracy is important, although we agree that in view of the national security scenario, reorganisation of the state can be done."

The court said lack of electoral democracy

cannot be allowed to go on indefinitely.
"This has to come an end... give us the specific time frame as to when will you restore actual democracy. We want to record this,' the bench said, and asked Mehta and Attorney General R Venkataramani to seek instructions from the political executive and get back to the court.

"I have taken instructions and the instructions are that the UT status for Jammu and Kashmir is not a permanent thing. It will remain for Ladakh. However, I will make an elaborate statement on August 31," Mehta told the bench, also comprising Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surya Kant.

He read out from the statement Home Minister Amit Shah had made while tabling the Jammu and Kashmir Reorganisation Bill in 2019 saying J&K's statehood will be restored in due course of time.

As the hearing on the hugely contentious issue continued for the 12th day, the apex court wanted to know from the government's law officers was the abrogation of Article 370 "really a logical step" to achieve J-K's complete integration with India.

"The wide chasm between absolute autonomy, as it existed on January 26, 1950, and complete integration, as it was brought on August 5, 2019... that chasm has been substantially bridged by what was happening in between. So, really, in the sense it was not a complete migration from absolute autonomy to absolute integration.

"It is obvious that a substantial degree of integration has already taken place in the last 69 years. Therefore, what was done in 2019 was it really a logical step forward to achieve that integration?" the bench asked Attorney General R Venkataramani.

The top court also questioned the Centre about the validity of its decision to divide the erstwhile state into two Union Territories. saying the petitioners who have challenged its decision contended it was beyond the powers of Parliament.

Mehta said Jammu and Kashmir was divided into two Union Territories looking at its peculiar situation and the fact that being a border state the matter also involved national

The CJI while referring to creation of Chandigarh as UT said, "So, you make them as Union Territories, but at a later point of time when the situation stabilises, the union territories are made into a state. We understand that these are matters of national security and the preservation of the nation itself is the overriding concern. Equally, restoration of democracy is also important."

"Can the Union not have control over a stipulated period to bring stability? Whether it is a state or UT, if all of us survive, then the nation survives. Of course, if the nation survives, then only we survive, else everything is gone. Then should we not give that much leeway to Parliament that for some period a State is made into a UT and then, after a period, it becomes a state," he said.

The bench also questioned the attorney general as to how proviso 3 to Article 370 can be given a go-by while abrogating the provision.

Article 370 (3) says, "Notwithstanding anything in the foregoing provisions of this article, the President may, by public notification, declare that this article shall cease to be operative or shall be operative only with such exceptions and modifications and from such date as he may specify: Provided that the recommendation of the Constituent Assembly of the State referred to in clause (2) shall be necessary before the President issues such a notification."

The CJI contended that Article 370 says the recommendation of the constituent assembly shall be "necessary" and "before" the President issues a notification, and so it cannot be a post facto recommendation.

"There has to be a recommendation of constituent assembly and, secondly, it has to be before the president decides to abrogate the provision. Therefore, to say this recommendation is just an opinion and not binding is not correct," the bench said.

Venkataramani submitted it is just a recommendation and a recommendatory role was assigned to the constituent assembly of Jammu and Kashmir to ensure that the integration process was completed.

"So what is the sequitur (a logical conclusion)? Are you contending that this is purely recommendatory and therefore absence of recommendation (of the constituent assembly) does not make a difference? Is this your contention?" the CJI asked.

Mehta, intervened and said, "A President of India being bound by a body solely outside the Constitution of India (the J-K constituent assembly) may not perhaps be the correct interpretation of our Constitution. That is, if it says yes, the President can do it, and if it says no, the President cannot do it. The Constitution of Jammu and Kashmir is outside and beyond our Constitution of India"

However, the bench disagreed with Mehta's contention and said from the plain reading of Article 370, it appears that the Constituent Assembly of Jammu and Kashmir was given overriding powers in respect of the state government, as the matters were to be placed before the CA for approval, if concurrence or consultation had been obtained before it came into existence.

Justice Khanna said, "When Article 370 itself refers to constituent assembly, you cannot say that it is outside the Constitution of India. It is within the constitutional framework because it refers to it. Yes, your argument about what will happen once constituent assembly does not exist, is something which we will have to examine with regard to the procedure you have adopted."

The hearing remained inconclusive and will resume on Thursday.

Several petitions challenging the abrogation of the provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh - were referred to a Constitution bench in 2019.

ASIA CUP: Pakistan Play Nepal In Sweltering Multan

MULTAN: Pakistan will begin their campaign in the Asia Cup on Wednesday taking on Nepal in the city's sweltering heat as multi-team international cricket returns to the country after nearly 15 years.

It couldn't be confirmed as to how many tickets were put online during the pre-sale window for all India matches and the warmup games but it has been learnt that, after the sales opened at 6 pm IST, within an hour, all tickets on the day were exhausted.

The 'Book My Show' website put a 'Sold Out' caption on the Pakistan game, which wasn't the case for the other eight India games.

"Today it was only for those who owned a Mastercard (credit or debit, India and international). Only two tickets per person was allotted and naturally.

the tickets put on pre-sale were bought by fans within an hour. "However it is expected that another round will happen on September 3. The best part is that Narendra Modi Stadium has 132,000 capacity, so reasonable number of tickets could be expected to be put on sale on September 3," a BCCI source privy to the development told PTI on the condition of anonymity.

The ICC is allowing only two tickets to be booked per person for all India games along with semi-final and final while for non-India games, four tickets per person could be booked.

Delhi World's Most Polluted City; Residents To Lose 12 Years Of Life To Pollution: Study

New Delhi: Delhi has emerged as the world's most polluted city in a new study which has also found that its residents are on track to lose 11.9 years of life if the current levels of pollution persist.

The Air Quality Life Index (AQLI) released by the Energy Policy Institute at the University of Chicago also showed that all of India's 1.3 billion people live in areas where the annual average particulate pollution level exceeds the 5 µg/m3 limit set by World Health Organisation (WHO).

It also found that 67.4 per cent of the country's population lives in areas that exceed the country's own national air quality standard of 40 µg/m3.

The study said fine particulate air pollution (PM2.5) shortens an average Indian's life expectancy by 5.3 years, relative to what it would be if the 5 µg/m3 pollution limit set by WHO was met.

The AQLI said that Delhi is the most polluted city in the world with its 18 million residents on track to lose 11.9 years of life expectancy on average relative to the WHO limit and 8.5 years relative to the national guideline if the current pollution levels persist.

"Even in the least polluted district in the region — Pathankot in Punjab — particulate pollution is more than seven times the WHO limit, taking 3.1 years off life expectancy if current levels persist," it said.

Though particulate pollution in the northern plains is exacerbated by geologic and meteorological factors, the AQLI's dust and sea salt-removed PM 2.5 data imply that human activity plays a key role in generating severe particulate pollution.

That is likely because the

That is likely because the region's population density is nearly three times the rest of the country, meaning more pollution from vehicular, residential and agricultural sources, the study said.

Human-Caused Climate Change May Lead To 1 Billion Premature Deaths: Study

New Delhi: Climate change induced by human activity is likely to be responsible for the premature death of about one billion people over the next century, if global warming reaches two degrees Celsius, a study suggests

study suggests.

The oil and gas industry is directly and indirectly responsible for over 40 per cent of carbon emissions - impacting the lives of billions of people, many living in the world's most remote and low-resourced communities, the researchers said.

The study, published in the journal Energies, proposes aggressive energy policies that would enable immediate and substantive decreases to carbon emissions. It also recommends a heightened level of government, corporate and citizen action to accelerate the decarbonisation of the global economy, aiming to minimise the number of projected human deaths.

The researchers found the peer-reviewed literature on the human mortality costs of carbon emissions converged on the "1,000-ton rule," which is an estimate that one future premature death is caused every time approximately



1,000 tons of fossil carbon are burned.

"If you take the scientific consensus of the 1,000-ton rule seriously, and run the numbers, anthropogenic global warming equates to a billion premature dead bodies over the next century. Obviously, we have to act. And we have to act fast," said Joshua Pearce, a professor at the University of Western Ontario in Canada.

Mr Pearce hopes by changing and challenging the language and metrics of global warming, more policymakers and industry leaders will better understand the hard truths about the world's reliance on

fossil fuels.

"As predictions of climate models become clearer, the harm we are doing to children and future generations can increasingly be attributed to our actions," said Mr Pearce.

When this direct correlation is recognised, greenhouse gas emissions liabilities can no longer be ignored, the researchers said.

The study found that to limit these enormous future liabilities and save many human lives, humanity needs to stop burning fossil fuels as quickly as possible by following a more aggressive approach to energy efficiency and renewable energy.

G20 SUMMIT IN DELHI

Deploying Langur Mimics Among Authorities' Plans To Scare Off Monkeys

New Delhi: City authorities are taking steps to deploy langur mimics and put up cut-outs of the simians at vantage points to scare away monkeys during the G20 Summit in the national capital.

The unchecked population of monkeys has led to their ever-increasing numbers across the city, including in New Delhi areas (Lutyens' Delhi), with the animals loitering around and often attacking and biting people.

In view of this, the New Delhi

In view of this, the New Delhi Municipal Council (NDMC) and the Forest Department of the city government have taken steps to ensure that monkeys are not allowed to play spoilsport during the important G20 summit, to be held from September 9-10.

"All the important sites, including the main venue of the Summit, hotels where foreign dignitaries and delegates would be staying are being covered to ensure the monkey hordes are not visible there during the event," a government official said.

NDMC vice chairman Satish Upadhyay said the civic body will deploy 30-40 trained persons who can mimic langur voice to scare away the monkeys.

"These trained persons are registered with us and they



have been hired as they are effective in scaring away monkeys by making sounds of langur. We will deploy one each at hotels where delegates would stay, as well as in places where monkey sightings are reported," he said.

An official said over a dozen cut-outs of langur were placed strategically in areas, including Sardar Patel Marg, that are heavily infested with monkeys.

He said apart from other problems, the monkeys have damaged plants and flowers that were part of horticulture landscaping for the G20 Summit by different agencies.

Sardar Patel Marg that connects New Delhi to the IGI airport has been given a facelift with installations of statues, fountains, street furniture and lot of greenery and flowering plants since all the delegates and dignitaries for the Summit will pass through the road, the officials said.
