Seizure Of 3836 Vehicles In 1 Year Signifies Extent Of Illegal Riverbed Mining In Valley

ithin a year, the Geology & Mining Department seized 3,836 vehicles and 339 illegal mineral dumps besides imposing fines to the tune of Rs 7.80 crore against those involved in illegal extraction and transportation of river-bed minerals in various districts of Kashmir valley.

The action against the people involved in illegal river-bed mineral mining has been taken in accordance with the provisions of Jammu & Kashmir

Minor Mineral Concession, Transportation of Storage, Minerals and Prevention of Illegal Mining Rules 2016.

In its annual report 2022-23, the Department of Environment Ecology and Remote Sensing (DEERS) has revealed that the highest number of vehicles (655 vehicles), involved in transportation of illegally mined river-bed material, have been seized from south Kashmir's Pulwama district wherein a fine of Rs 1.64 crore has also been imposed on those involved in illegal mineral mining. China Building Bunkers, Tunnels In Aksai Chin: Reports

Barely two days after China released its official "standard map," including state of Arunachal Pradesh and the Aksai Chin region as part of its territory, satellite images have shown that Beijing is building tunnels and reinforced bunkers for soldiers and weaponry in the contested Aksai Chin region claimed by India as part of Ladakh, reports said Wednesday.

According to a report by Hindustan Times, the tunnels and bunkers are coming up in the area which is about 70km from the Line of Actual Control (LAC). Constructions seem to have started post 2021.

Giving reference to the satellite images by Maxar Technologies, the report said that personnel bunkers seem to be designed to protect soldiers from aerial attacks. Earth-moving machinery, new roads and multiple

entrances for the tunnels are also visible in the images at six locations within an area of roughly 15 sq km in Aksai Chin.

"Analysts believe the underground facilities are meant to protect sensitive equipment, ammunition and command posts from air or missile strikes during potential hostilities," the report

The reports of ramping up construction activity along the disputed area comes at a time when India registered strong protest against China's 2023 edition of its "standard map" that claimed Arunachal Pradesh and Aksai China as its territory

The "map" also showed the entire South China Sea as part of China as it featured in the previous editions of the 'map'.

External Affairs Minister S Jaishankar rejected China's "standard map" on Tuesday, stating that Beijing had even put out such maps in the >> More On P10

HC Quashes 4 PSA Orders

Srinagar: The High Court of I&K and Ladakh has quashed detention orders under Public Safety Act against four detainees and ordered their release from preventive detention if not needed in any other case.

"It needs no emphasis that the detenue cannot be expected to make an effective and purposeful representation which is his constitutional right guaranteed under Article 22(5) of the Constitution of India,

unless and until the material, on which the detention is based, is supplied to the detenue," a bench of Justice Sanjay Dhar said while quashing detention order against Imran Ahmad Ganie, ordered to be detained under PSA by

Baramulla on 9 April 2022. 'The failure on the part of detaining authority to supply the material renders the detention order illegal and unsustainable in law." The court also >> More On P10

Amarnath Yatra Concludes Today Record 4.5 Lakh Yatris Visit Cave Shrine

Srinagar: Chhari Mubarak (the holy mace) reached Panchtarni and will proceed towards the holy cave shrine on Thursday for the final puja to make the formal end of the 62-day-long Amarnath Yatra 2023.

The last batch of yatris left for the cave shrine on August 23 and since then, the pilgrimage has remained suspended, an official said.

He said that during the beginning of the yatra this year, there was a good rush of pilgrims; however, later it started declining with each passing day, forcing the authorities to suspend the yatra a week before its scheduled time.

This year, the overall flow was good after several years as around 4.5 lakh yatris visited the cave shrine, he said.

Over the last several years, Amarnath Yatra has been witnessing fewer footfalls. Compared to over 6 lakh pilgrims who visited the cave shrine in 2012, the number has come down to over 3 lakh in 2022 and 4.5 lakh this year. The 62-day-long pilgrimage commenced on July 1 this year and will culminate with the event of 'Chhari Mubarak' on August 31.

The official said that a group of sages led by custodian of the holy mace Mahant Deependra Giri carrying Chhari Mubarak will reach the Amarnath cave on Thursday and will spend tonight at Panchtarni.

The 145-kilometre Chhari Mubarak yatra starts from Dashnami Akhara in Srinagar and during the route, the sages perform hawans at Pampore, Bijbehara, Anantnag, Mattan, Aishmugam and → More On P10

Women Suffer Worse Heart Disease Outcomes Than Men: Study

Women suffer worse outcomes when diagnosed with and treated for cardiac issues, according to the results of fifteen studies from 50 countries, including India.

The researchers noted that the discrepancy is the result of women presenting with additional non-traditional chest pain symptoms including vomiting, jaw pain and abdominal pain.

If and when these symptoms are missed by doctors, or by the patients themselves, diagnosis and treatments are delayed, they said.

"We found stunning differences between men and women in the diagnosing of cardiovascular disease, treatment and symptoms," said Mahdi O. Garelnabi, Associate Professor at the University of Massachusetts Lowell, US.

"Women tend to go to the hospital later than men after the onset of symptoms and physicians are not admitting women to the hospital at the same rates as men," Garelnabi said.

The analysis, published in the journal Arteriosclerosis, Thrombosis, and Vascular Biology, also points out that heart



attack rates among women are climbing.

Heart attacks among women

aged 35 to 54 increased from 21 per cent to 31 per cent between 1995 and 2014, the study shows.

During the same period, the rate for men rose only slightly, from 30 to 33 per cent, according to the researchers.

"It's alarming that heart attack rates are increasing in younger women," said Garelnabi.

"Risk factors that are unique to women include premature menopause, endometriosis and hypertension disorders during pregnancy," the researcher said.

The findings are based on the results of fifteen studies from 50 countries, including Brazil, China, Egypt, India, Arabian Gulf countries and the US among others.

Smart Parking Burns A Hole In Car Owners Pockets, Authorities Numb

MOHUA Assures Action Against Private Agency If Found To Be At Fault

Srinagar: In what could be defined as burning a hole in gullible people's pockets, parking their vehicles at spaces designated under Srinagar Smart City Ltd, employees of a private agency, overseeing parking sites in parts of the city, levy parking charges from individuals at their own

The practice of random charging has led to the parking woes in Srinagar with people blaming the authorities concerned for the mess.

It is worth mentioning that an individual intending to park his car at a designated smart parking lot under a new arrangement has to pay Rs 20 for under

30 minute parking, Rs 40 for under one hour, Rs 70 for 89 minutes, Rs 100 for 119 minutes, Rs 140 for 149 minutes, Rs 180 for 179 minutes, Rs 230 for 209 minutes, Rs 280 for 239 minutes and Rs 340 for 269 minutes.

However, the workers assigned by a private agency for the job in addition to swindling customers, at times resort to manhandling.

Those who leave their cars in designated parking spots are not provided invoices and are instead asked for 10 times the amount of the prescribed rates when they return.

"These employees not only overcharge, but also mistreat consumers who muster courage to object to their conduct. I have also been the victim of random charging. They don't provide

invoices to people at the time of parking their vehicles and are instead asked for 10 times the amount of the prescribed rate when they return," Syed Ishafqul-Lah, a businessman from Srinagar said.

The authorities, he said, instead of taking punitive action against the agency, have maintained silence over the illegal practice, which he claimed was burning holes in the pockets of naive individuals.

Assuring action, Additional Director General, Media, Ministry of Housing and Urban Affairs, Rajiv Jain told Kashmir Observer that the matter will be taken up with the concerned agency and that action warranted under law will be taken against it, if found to be at fault.

India Launching Global Media Blitz On Kashmir

ASHINGTON: India is launching what has been described as "a global-scale media blitz" against Pakistan projecting the Indian interpretation of the 'reality' in Kashmir.

The multi-pronged campaign launched through print, electronic and cyberspace media in some 20 languages will coincide with the UN's millennium session. The idea is to embarrass Pakistan during General Musharraf's visit to New York and to help Indian PM Vajpayee plead India's case.

Full-page colour advertisements are being sought to be published in leading publications like The New York Times, The Washington Post, The Los Angeles Times, USA Today, The Wall Street Journal, The Chicago Tribune, The Times (London), The Straits Times (Singapore), The Bangkok Post, The Jerusalem Post, The Japan Times, The Sunday Times (London), The International Herald Tribune, the Economist, Time, Newsweek, The Financial Times and BusinessWeek, says a report in rediff, an online newspaper. It claims that funds for the campaign are being raised from Indians the world over through contributions.

However, a multi-million dollar campaign at this level cannot be launched without the support of the India government, say observers.

The campaign is likely to accelerate the ongoing India-Pakistan conflict to feverish heights, extending it to cyber warfare. The advertisements will project the theme 'Jehad' for Pakistan, agony for India' and portray /peace-loving' India's patience even in the face increasing casualties on its side in J&K, says report. Also in the pipeline are advertisements In French, German,

Swedish, Italian, Dutch, Portuguese, Spanish) Finnish/Turkish, Malay, Bahasa Indonesia, Russian, Chinese, Japanese, Bengali, Korean, Norwegian/Thai, Sinhalese and Arabic. The report says this will be complemented with campaigns in cyberspace via an exclusive Web site, agonyofindia.com & e-mails.

The full-page advertisements quote the utterances of Pakistan's Chief Executive General Pervez Musharraf to prove Pakistan's involvement in Kashmir insurgency.

Reportedly, The financial Times has expressed reservations about publishing the advertisement. It is claimed that leading ad agencies have been hired in New York and other major cities of the world to handle the latest campaign in multiple languages.

Pakistan Ex-Pm Imran Khan's Custody Extended By Two Weeks In 'Cypher' Case

Former Pakistani Prime Minister Imran Khan has been sent to judicial remand for two weeks on charges of leaking state secrets, his lawyer says.



Khan's custody was extended till September 13 to investigate him in the so-called "cypher" case after a special court held the proceedings on the jail premises in Attock city on Wednesday.

Khan's judicial remand comes a day after the Islamabad High Court suspended his conviction and three-year jail sentence on corruption charges.

The former prime minister is charged with making public the contents of a confidential cable sent by Pakistan's ambassador to the United States and using it for political gain.

"We have filed a bail petition in the court and it will be heard

on Saturday," Khan's lawyer Salman Safdar told Al Jazeera after the court heard the "cypher" case under the country's Official Secrets Act.

"We have also filed another appeal challenging the jail trial and have demanded that the case be heard in an open court and not in camera," he said.

What is the 'cypher' case?
The "cypher" case relates to a diplomatic cable that Khan had touted as proof that he was removed in April last year as part of a US conspiracy backed by the "establishment" – a euphemism for Pakistan's powerful military.

Khan alleges the cable proves his removal was at the behest of the US which he said pressed Pakistan's army to topple his government because he had visited Russia shortly before its invasion of Ukraine in February 2022.

The US and the Pakistani government and military have rejected the allegation.

The vice chairman of Khan's Pakistan Tehreek-e-Insaf (PTI) party, Shah Mahmood Qureshi, also a former foreign minister, has also been arrested in the same case.

While Khan was imprisoned this month, Pakistan's parliament was dissolved at the request of his successor Shehbaz Sharif and a caretaker government was formed to hold national elections.

80% Indians Have A Favourable View Of PM Modi: Pew Research Survey

WASHINGTON: About 80 per cent of Indians have a favourable view of Prime Minister Narendra Modi and around seven in 10 Indians believe their country has recently become more influential, according to a survey by the PEW Research Center.

The survey, released ahead of the G20 Summit, also noted that public opinion of India was generally positive across the world with a median of 46 per cent reporting favourable views of India as compared to 34 per cent unfavourable views. Sixteen per cent did not share an opinion at all.

Views of India are most positive in Israel, where 71 per cent say they have a favourable view of the country, the report said.

Pew said the survey was conducted from February 20 to May 22, among 30,861 adults in 24 countries, including 2,611 from India, to examine global views of Prime Minister Modi, the scope of India's global power and Indians' views of other countries.

About eight in 10 Indians report "favourable" views of PM Modi, including a majority (55 per cent) with a "very favourable" view, according to the survey result released on Tuesday. This is Narendra Modi's second term as Prime Minister and he is



also seeking a third term in the 2024 Lok Sabha elections. Only a fifth of Indians expressed an unfavourable opinion of PM Modi in 2023, the Pew survey found.

Responding to the results of the Pew survey, the BJP said the popularity of Prime Minister Modi remained intact.

"The popularity of Prime Minister Shri @narendramodi certainly remains intact! Majority of people in India and across the world believe that India's global influence is getting stronger!" the official handle of BJP said in a post on platform X, formerly Twitter.

It added that the Pew survey "stands as a testament to the above statements." "Indian adults are more likely to believe India's power is on the rise. Around seven in ten Indians believe their country has recently become more influential. This stands in comparison with a 2022 survey conducted across 19 countries, where a median of only 28 per cent said the same," Pew said.

Over 15,000 Indian Tech Workers Moved To Canada In 12 Months: Report

Of the more than 32,000 tech professionals who sought greener pastures, 15,097 chose Canada as their new home, underscoring the nation's allure in the tech industry.

Following India on the list of

Following India on the list of contributors was Nigeria, with 1,808 tech workers making their journey to Canada. Experts attribute this phenomenon to Canada's immigration-friendly policies and its competitive edge in terms of labour costs, as per Khalsa Vox.

Khalsa Vox is an online digest that brings the latest in Punjab politics, history, culture, heritage and more.

Mississauga and Montreal

are the two Canadian cities that stand out as the prime beneficiaries of this influx of global tech talent. Mississauga which boasts a

Mississauga which boasts a robust community of nearly 1,000 IT firms and an impressive workforce of over 300,000 tech experts, has become a hub for tech innovation. Meanwhile, Montreal has witnessed a remarkable 31 per cent growth in its tech ecosystem between 2015 and 2020.

The report, titled 'Tech Workforce Trends: The Migration of Tech Workers and Tech Jobs Since the Pandemic', sheds light on the significance of this surge in tech migration. It posits that the substantial migration of tech workers fulfils the critical demand for skilled professionals, a need that has become even more pronounced amid the ongoing global talent scarcity. This influx of tech talent is seen as a promising indicator of a prosperous future for Canada's tech industry, according to Khalsa Vox.

The migration data further reveals intriguing details about the tech worker flow. Mississauga welcomed 1,900 tech professionals from across the world, while Montreal witnessed the arrival of 959 tech experts during the specified period from April 2022 to March 2023.

Although the majority of the influx is attributed to India, Nigeria, and Brazil, the report also highlights the growing attraction of Canadian tech opportunities for American talent. Notably, Canada is drawing tech professionals from major US cities such as Washington DC, Boston, Chicago, and Philadelphia.

Uttar Pradesh: Bus Conductor Sacked For Halting Vehicle To Allow Passengers To Offer Namaz Found Dead

MAINPURI: The bus conductor, who was dismissed from service for allegedly halting the vehicle to allow two Muslim passengers to offer namaz on the road, was found dead on a railway track in the Ghiror area here, police said on Wednesday.

The body of Mohit Yadav (30) of Khushal village was found lying on a railway track at Kosma station Sunday night by the rail staff, they said.

Yadav's family members said he was under "acute depression" after his dismissal from service and might have ended his life by jumping before a train.

Yadav, who was a contractual employee with the Uttar



Pradesh Roadways, along with the bus driver, was sacked for stopping the vehicle in the middle of the night on June 3 to allow two passengers to offer namaz on the road.

Officials had said the action was taken as stopping the bus at a secluded place could have led to an untoward incident like loot and put at risk the lives of passengers who included women.

Mohit's body being found late Sunday night, Rohit Yadav, the younger brother of the deceased, told PTI.

He said his brother might have taken the extreme step by jumping in front of the train as he was "under depression".

Rohit also showed a video conversation with his deceased brother in which he is heard saying that the bus was stopped at the request of some passengers for urinating. He is heard saying that some passengers got down and two of them offered namaz during the halting time.

Passengers had raised objection for allowing two men to offer namaz and had made a video of the incident and made it public.



Netanyahu Thanks Saudis For 'Warm' Treatment Of Israeli Passengers

Israeli Prime Minister Benjamin Netanyahu thanked Saudi officials for "warmly treating" Israeli passengers aboard an Air Seychelles flight that unexpectedly landed in Jeddah on 28 August.

In a televised clip published by Netanyahu's office on social media, the prime minister stated, "I greatly appreciate the warm attitude of the Saudi authorities to the Israeli passengers whose plane got into trouble and had to make an emergency landing in Jeddah. I'm glad everyone's coming home. I really appreciate the good neighborliness."

The flight carried 128 Israelis from Seychelles to Tel Aviv but landed in Jeddah allegedly due to a technical problem one and a half hours before reaching its destination. However, the plane landed without using emergency procedures.

The Israeli passengers stayed in Jeddah overnight at a hotel before being transferred to a new plane and returning to Ben Gurion Airport in Tel Aviv the following day.

This is the first time a commercial plane has traveled between Saudi Arabia and Israel.

Passengers said they were nervous landing in a country

that has traditionally been hostile to Israel but were warmly welcomed.

"The reception we got from the Saudis was very surprising," Emmanuelle Arbel, one of the passengers, told Radio 103FM. "They said to us, 'You are most welcome' and were smiling. In truth, we were not expecting this."

"We made history, maybe we will also bring peace," said another passenger, Shai Kalmonowitz.

Israel's Channel 12 reported that Israeli security officials happened to be aboard, claiming they had been on vacation. The Kan public broadcaster also said that the brother of farright Otzma Yehudit lawmaker Almog Cohen was on the flight.

Almog Cohen was on the flight. The Israeli newspaper Yedioth Ahronoth said that Jeddah Airport had previously been identified as an alternative airport for flight paths to Israel and that Tel Aviv had gained approval for planes carrying Israeli passengers crossing Saudi air space to land there in emergencies.

In July 2022, Saudi Arabia announced that it would allow all airlines "that meet the conditions" to cross its airspace, including Israeli companies that do not necessarily fly to the Gulf states.

CBI Files Case Over Alleged Minority Scholarship "Scam"

NEW DELHI: A case has been filed in connection with the alleged minority scholarship scam, in which 830 "fake" institutions were benefitting, causing a loss of about ₹144 crore to the Ministry of Minority Affairs during 2017-22, officials said on Tuesday.

The FIR is filed against unidentified persons of banks, institutions and others under IPC sections of criminal conspiracy, cheating, forgery and provisions of the Prevention of Corruption Act, they said.

"Considering vari-

ous reports received

on embezzlement of funds under the Scholarship Schemes, the Ministry has engaged National Council of Applied Economic Research (NCAER) to carry out Third Party Evaluation of the Scholarship Schemes. Besides, the Ministry also carried out evaluation

through National Scholarship Portal (NSP) by generating Red Flags on doubtful Institutions/ Applicants," the Ministry had said in its complaint which has now become part of the FIR.

It said a total of 1,572 institutes were identified for evaluation based on red flags generated on NSP. "Out of 1,572 institutions from 21 states, 830 institutions are found either non-operational or fake or partial fake," it said.

The ministry has estimated the loss to the exchequer by counting financial implications for the year 2017-18 to 2021-22 for the institutes that are identified as fake and found a loss of ₹144.33 crore to the exchequer, against these 830 institutes, it said.

The ministry said it was able to detect the loss for the period during which digitized data on NSP was available and the scam could be going on much prior to 2017-18.

Kundu said when the mob was challenged to stop, it started raising slogans against police, manhandled them, and even snatched back their weapons from police vehicles.

Gujarat Man Poses As Scientist Who Designed Chandrayaan-3 Lander, Arrested

A complaint was lodged against the accused, Mitul Trivedi, after he was seen giving interviews after the Vikram lander successfully made a soft-landing on August 23, claiming to have designed the lander module of Chandrayaan-3, the official said.

Trivedi allegedly posed as the "assistant chairman" of ISRO's "Ancient Science Application department" and even produced a fake appointment letter dated February 26, 2022, he said

Over 50 Percent Work On AIIMS Awantipora Completed

Efforts On To Complete The Project By 2024 End: Official

SRINAGAR: The construction of All India Institute of Medical Sciences (AIIMS) in the Awantipora area of south Kashmir's Pulwama district is going on in full swing and every effort is being made to complete the project by the end of 2024, officials said on Wednesday.

The work is going on at "very full speed" and if it continues at this pace, the project will be completed on time, an official

He said that earlier there was a legal dispute over the acquisition of land needed for the access road essential for transporting construction material, followed by a clampdown after the abrogation of Article 370, and then issues with a nearby army base. The winter season and COVID-19 were also the reasons behind the slow execution of work on this mega project, he added.

The official said the work has been going on at full pace for the last several months now and the same pace should continue for around the next one and half years so as to complete the hospital by December 2024. A top official working on the

project said that in the last few years, there were some issues due to which the work was going on at a sluggish pace; however, all issues were resolved and currently, the work is going on at full pace. As of now, only construction

work is going on and the installation of machinery process will be taken up later, he said, adding that around 50 percent of work has been already completed and every effort is being made to complete the project before the deadline.

The government has set December 31, 2024, as the deadline for completion of this mega project.

The AIIMS was approved by the Central government in 2019 at an estimated cost of Rs 1,828 crore. The project entails the construction of approximately 57 buildings, including a hospital, hostels, residential quarters, a football ground, tennis courts, and gardens with medicinal plants, among other facilities.

The institute will add 1,000 beds to its current capacity in Kashmir, including 300 superspeciality beds. The ambitious project also includes a Medical College with a capacity of 100 students and a Nursing College with a capacity of 60 stu-

Illicit Traffic Of Narcotics Threat To Society's Health, Welfare: HC

SRINAGAR: Underlining that the illicit traffic of narcotics and psychotropic substances poses threat to the health and welfare of every citizen in the world, the High Court of J&K and Ladakh on Wednesday dismissed a plea by a Punjab resident, challenging his detention under PITNDPS.

On 27 December 2022, authorities had detained Happy Singh of Mehtabgarh, Kapurthala, Punj under the

According to authorities, Happy Singh was involved in trafficking 52.424 Kgs of heroin and was also caught in possession of 100 grams of it.

In the grounds of detentions, the authorities said Singh was actively involved in trafficking of narcotic drugs and psychotropic substances.

"The Court must be conscious that the satisfaction of the detaining authority is "subjective" in nature and the Court cannot substitute its opinion for the subjective satisfaction of the detaining authority and interfere with the order of detention," a bench of Justice Wasim Sadiq Nargal said, adding, "It does not mean that the subjective satisfaction of the detaining authority is immune from judicial reviewability. By various decisions, the Supreme

Court has carved out areas within which the validity of subjective satisfaction can be

In the present case, the court said, the detenue was involved in trafficking of huge amount of heroine and was also caught in possession of the same.

"The detaining authority recorded finding that this has serious impact on the economy of the nation and is also satisfied that the detenue has propensity to indulge in the same act of smuggling and passed the order of preventive detention, which is a preventive measure," the court said, adding, "Based on the documents and the materials placed before the detaining authority and considering the individual role of the detenue, the detaining authority satisfied itself as to the detenue continued propensity and his inclination to indulge in acts of prejudicial activities of illicit traffic of narcotics and psychotropic substances which poses threat to the health and welfare not only to the citizens of this country but to every citizen in the world."

The offences committed by the detenue are so interlinked and continues in character and are of such nature that these affect security and health of the nation, the court said and

SC's Pitch For J&K Statehood

he Supreme Court on Tuesday was informed by the central government that the union territory status of Jammu and Kashmir is not a permanent arrangement and that a statement on this issue would be made in court on August 31. This announcement comes in the midst of hearings on petitions challenging the abrogation of Article 370, a move that led to the region losing its special status. Solicitor General Tushar Mehta, who represented the government in the case, however, said that the union territory status of Ladakh will persist for some time.

The central government's decision to revoke Article 370 and bifurcate the state into union territories in 2019 was met with both support and opposition. Proponents of the move argued that it would pave the way for greater integration of the region with the rest of India and spur economic development. Critics, however, contended that the decision was taken without proper consultation with the people of Jammu and Kashmir, thereby undermining the principles of democracy.

The apex court acknowledged the importance of democracy while also recognizing the complexities posed by national security considerations. This balance between democratic ideals and security imperatives highlights the need for a measured and well-defined approach to the region's political future. However, the court expressed its reservations about the indefinite continuation of the absence of electoral democracy. It stressed the necessity of establishing a clear timeline for the restoration of full-fledged democracy in the union territory.

The government's willingness to engage in a discourse on the union territory status of Jammu and Kashmir suggests a recognition of the complexities involved and a commitment to finding a balanced solution that respects both the region's historical legacy and contemporary realities.

Meanwhile, people in Kashmir are eagerly waiting for the elections, as the exercise is expected to lead to the restoration of statehood. No less than the union home minister has made it clear that the statehood of J&K would be restored only after elections are held and a representative government is formed.

There have so far been no signs that the centre is reviewing its policy. The return of statehood also makes eminent sense from the centre's point of view. It seems that the union government wants to first see how the future elected government would look and what its political and governance priorities would be including its approach to the issue of the revocation of Article 370. Also, it is as yet unclear if the centre would be inclined to restore complete statehood or a truncated one on the pattern of New Delhi. All we can hope for now is that the elections are announced earlier than later.

A Fresh Start

he island nation had been sustained by donor support and 17 IMF programmes despite deficits in both budget and current account of balance of payments, with high inflation, high nominal interest rate and over-valued currency, even while subsidising foreign producers at the expense of domestic ones. Inevitably, over time, concessional assistance was phased out and the country became increasingly exposed to discipline imposed by international capital markets and rating agencies. The immediate causes of the 2022 crisis included wide-ranging tax cuts, the ban on chemical fertiliser, the pandemic and the effects of the Ukraine war. The poverty level, which was 6% before the pandemic, rose to 25% last year.

To their credit, the prime minister Narendra Modi, the finance minister Nirmala Sitharaman, and the foreign minister, S. Jaishankar, responded swiftly, extending emergencv assistance of \$4 billion, delivering food, fuel and medicine, and joining Japan and other creditor countries to negotiate the restructuring of Sri Lanka's external debt. From the 1980s, due to the ill-advised deployment of the Indian Peace Keeping Force, Sri Lankans have viewed India negatively. But that sentiment has now changed.

Thanks to the timely help mainly from India, along with other donors and the International Monetary Fund, which approved a programme of \$3 billion, considerable progress was made in stabilising Sri Lanka before Wickremesinghe's visit to New Delhi last month. Macroeconomic indicators improved and the mass protests subsided. Aggressive monetary tightening has been pursued by the Central Bank and inflation has declined from about 70% in September 2022 to 12% in June 2023. It should decline to 4%-6% by the end of this year. Fiscal outcomes have improved with a small primary surplus being achieved in the government budget in the first five months of this year. Tight monetary and fiscal policies, import and capital restrictions, and declining commodity prices have contributed to improvement in the balance of payments, the import bill has declined sharply, tourism is recovering and inward remittances are stable. With positive movements in government securities and share markets and \$2 billion in reserves as of last June, the shortages in fuel, food, pharmaceuticals and fertiliser have eased significantly. The government has given the Central Bank greater autonomy while increasing its accountability, seven parastatal organisations are to be disinvested, and the dominance of the Ceylon Petroleum Corporation and the Ceylon Electricity Board diluted. However, addressing the scourge of corruption is essential, including during the presidential and parliamentary elections that are due to be held separately within the next two years.

Recently, I got a chance to meet Gautam Malik, a Gurgaon based social entrepreneur who launched a startup "Jaggery Bags" which uses old car seat belts to make beautiful bags. I met Gautam during a regional huddle of Acumen Fellows in New Delhi recently. I am myself an Acumen Fellow from the 2017 cohort and Gautam joined last year.

Gautam's tryst with upcycling plastic bags began in New York where he was studying film and media in 2001. After almost 13 years, Gautam decided to start social enterprise Jaggery Bags with the active support of his wife, a conservation architect and mother who is a retired Physics professor. Jaggery Bags is converting old car seat belts into bags as they have a team of dedicated workers who do this work. Seat belt material in spite of being very strong, used to go to landfills. However, Gautam's intervention has changed this; he has converted almost 10.000 meters of seat belts into bags which are selling in the market efficiently.

During my long conversation with Gautam on the sidelines of the Acumen fellows meeting, he informed me that while people were recycling plastic waste and other waste materials. He could identify a gap in the survey here and decided to use the material for seat belts, a stronger material, which was not being recycled and was instead dumped in landfills. This was a Eureka moment for him and he decided to utilise this material for making bags.

Gautam also wants to use old army truck material, canvas and parachute material to make some good products. Infact he has already used canvas, parachute and other material used by defence forces to make bags but now Jaggery Bags wants to use this material on a large scale and he is now exploring to reach out to Indian Army and Airforce for the same. He is exploring that idea and we had a long discussion on that as well and we even decided to collaborate for starting this work in Srinagar, Jammu and Kashmir as well.

Gautam's social enterprise Jaggery Bags, has recycled more than 10,000 meters car seat belts and 6000 plus meters of cargo belts from landfills in Delhi/NCR. This project has international customers in US, Australia, Japan, Italy, France and Switzerland. It has already been accepted to the World Economic Forum's Catalyst 2030 for being a prominent part of the modern-day online community of impact makers. Gautam's Dr. Usha Malik and wife, Bhavna have been his great supporters, he told me.

Empowering marginalized

The Jaggery Bags is not only

making consumers aware about sustainability but his work is also empowering marginalized and disadvantaged communities as well. Women and men from low income groups are involved with Jaggery Bags who manufacture sustainable bags and other accessories. This work not only transforms fashion into activism by making individuals change their lifestyle and living. Through Jaggery, Gautam is fully dedicated to create a positive change by generating circular jobs and empowering underserved communities

Recycled material used by car industry

The awareness to use non-biodegradable waste and recycled material is gaining momentum across the world. The car manufacturers are making efforts to include more recycled materials in the construction of their new models. Czech car manufacturing company Skoda has recently introduced seat covers made from wool and recycled disposable bottles . The company is working with suppliers and the scientific community on various innovative materials that will then be used in mass production. The company has combined wool with recycled polyester from disposable polyethylene This helps to save energy, reducing greenhouse gas emissions and helping to tackle climate change. Advancing Environmental Justice With AI

climate change is undoubtedly the defining challenge of our time, but its effects are not equally distributed. In both developed and developing countries, environmental degradation disproportionately affects communities marginalized because of race, ethnicity, religion, and poverty. More often than not, these communities are already confronting systemic inequalities such as water scarcity and greater exposure to pollution and extreme weather events – all of which are exacerbated by the climate crisis.

It is a reality with which I am intimately familiar. As a child, my family had a farm on Dominica, a small Caribbean island state that faces the threat of hurricanes each year. One tropical storm could knock out power grids and wipe out entire harvests, destroying local livelihoods.

According to the World Bank, climate-related disasters push 26 million people into poverty annually. And because the world's poorest people often depend on agriculture – a sector highly dependent on favourable weather conditions – to support themselves, they urgently need access to technical, financial, and institutional resources to prepare for and respond to ever more frequent and intense extreme weather events.

Given its capacity to innovate climate solutions, the technology sector could provide the tools we need to understand, mitigate, and even reverse the damaging effects of global warming. In fact, addressing longstanding environmental injustices requires these companies to put the newest and most effective technologies into the hands of those on the front lines of the climate crisis.

Tools that harness the power of artificial intelligence, in particular, could offer unprecedented access to accurate



information and prediction, enabling communities to learn from and adapt to climate challenges in real time. The IBM Sustainability Accelerator, which we launched in 2022, is at the forefront of this effort, supporting the development and scaling of projects such as the Deltares Aquality App, an Alpowered tool that helps farmers assess and improve water quality. As a result, farmers can grow crops more sustainably, prevent runoff pollution, and protect biodiversity.

Consider also the challenges that smallholder farmers face, such as rising costs, the difficulty of competing with larger producers that have better tools and technology, and, of course, the devastating effects of climate change on biodiversity and weather patterns. Accurate information, especially about soil conditions and water availability, can help them address these issues, but has historically been hard to obtain.

One could imagine regional officials in a developing country deploying a machine learning algorithm to forecast future population growth and corresponding change in energy demand using temporal and spatial data. With this forecasting model, policymakers could optimize the country's energy network, redirecting supply to where it will be needed most. That is also something that we are supporting today.

Developing AI-powered mobile

apps and virtual assistants, and making them widely available, promotes equitable access to data and technical insights. With highly accurate weather forecasting, advanced agronomy techniques, and carbon-footprint calculations, as well as other predictions generated by AI, smallholder farmers can build greater climate resilience and boost both production and income by adapting to changing conditions more quickly and managing crops more sustainably.

At the same time, simply handing over these tools to disadvantaged communities will not solve the problem – apps alone are not an antidote to climate injustice. To implement AI-based

technology successfully, tech companies must be willing to share knowledge with users, including instructions on how to take measurements that will yield data. They must build in the ability for users to collaborate independently with one another, and solicit feedback from farmers and other users. To that end, an AI chatbot that automates question-and-answer exchanges could help minimize user-training challenges while democratizing access to information. As companies develop AI solutions, we also need to support local tech firms and app developers, as they are best positioned to put these tools to use.

Beyond increasing access to new AIpowered tools, the tech community, together with NGOs, governments, and international agencies, can help build an equitable, resilient future for disenfranchised communities by providing training in the technical skills and knowledge required for green jobs. As the transition to a low-carbon global economy accelerates, demand for so-called "green skills" is projected to outstrip supply. Preparing workers for the jobs of the future, in combination with the widespread adoption of new technologies, will strengthen climate resilience, especially in developing economies.

All of us – individuals, corporations, organizations, and governments – share the responsibility to address growing environmental threats. Tech firms, in particular, must channel more resources to combat global warming. That means investing in the development and implementation of Al tools and ensuring that those in the greatest need can access them. Finding climate solutions – and achieving environmental justice – depends on the private sector mobilizing its expertise for the greater good. – Project Syndicate

Unveiling The Microscopic World Through Revolutionary Imaging Techniques

he microscope is an iconic symbol of the life sciences and for good reason. From the discovery of the existence of cells to the structure of DNA, microscopy has been a quintessential tool of the field, unlocking new dimensions of the living world not only for scientists but also for the general public.

For the life sciences, where understanding the function of a living thing often requires interpreting its form, imaging is vital to confirming theories and revealing what is yet unknown.

This selection of stories from The Conversation's archive presents a few ways in which microscopy has contributed to different forms of scientific knowledge, including techniques that take visualization beyond sight altogether.

1. Seeing as identifying

Over the past few centuries, the microscope has undergone a gradual but significant evolution. Each advance has allowed researchers to see increasingly smaller and more fragile structures and biomolecules at increasingly higher resolution from cells, to the structures within cells, to the structures within the structures within cells, down to atoms.

But there is still a resolution gap between the smallest and largest structures of the cell. Biophysicist Jeremy Berg drew an analogy to Google Maps: Though scientists could see the city as a whole and individual houses, they couldn't make out the neighborhoods.

Seeing these neighbourhood-level details is essential to being able to understand how individual components work together in the environment of a cell, he writes.

Scientists are working to bridge that resolution gap. Improvements to the 2014 Nobel Prize-winning superresolution microscopy, for example, have enhanced the study of lengthy processes like cell division by capturing images across a range of size and time scales simultaneously, bringing clarity to details traditional microscopes tend to blur.

Another technique, cryo-electron microscopy, or cryo-EM, won a Nobel Prize in 2017 for bringing even more complex, dynamic molecules into view by flash-freezing them. This creates a protective glasslike shell around samples as they're bombarded by a beam of electrons to create their photo op. Cryo-ET, a specialized type of cryo-EM, can construct 3D images of molecular structures within their natural environments.

These techniques not only generate images at or near atomic resolution but also preserve the natural shape of difficult-to-capture biomolecules of interest. Researchers were able to use cryo-EM, for instance, to capture the elusive structure of the protein on the surface of the shape-shifting hepatitis C virus, providing key information for a future vaccine.



Further enhancements to science's visual acuity will reveal more of the fine details of the building blocks of life.

I anticipate seeing new theories on how we understand cells, moving from disorganized bags of molecules to intricately organized and dynamic systems, writes Berg.

2. Seeing as scoping

Microscopy images are often framed as snapshots circumscribed parts of a whole that have been magnified to reveal their hidden features. But nothing in an organism works in isolation. After discerning individual components, scientists are tasked with charting how they interact with each other in the macrosystem of the body. Figuring this out requires not only identifying every component that makes up a particular cell, tissue and organ but also placing them in relation to each other in other words, making a map.

Researchers have been charting the brain by stitching together multiple snapshots like a photo mosaic. They use different techniques to label a specific cell type and then image the whole brain at high resolution. Layer by layer, each run-through creates an increasingly detailed and more complete model. Neuroscientist Yongsoo Kim likens the process to a satellite image of the brain. Combining millions of these photos allows researchers to zoom into the weeds and zoom out to a bird's every view.

But building a map of a city, however detailed, is not the same as understanding its rhythm and atmosphere. Likewise, knowing where every cell is located relative to each other doesn't necessarily tell researchers how they function or interact. Just as important as charting out the landscape of an organ is coming up with a working theory of how it all fits together and performs as a whole. Right now, Kim notes, analysis lags behind technical advances in data collection.

Incredibly rich, high-resolution brain mapping presents a great opportunity for neuroscientists to deeply ponder what this new data says about how the brain works, Kim writes. Though there are still many unknowns about the brain, these new tools and techniques could help bring them to light.

3. Seeing as recognising

Every improvement in technology brings a parallel improvement in the data it collects, both in quality and in quantity. But that data is only useful insofar as researchers are able to analyse it high granularity isn't helpful if those details aren't appreciable, and high output isn't beneficial if it's too overwhelming to organize.

Automated microscopes, for example, have made it possible to take time-lapse images of cells, resulting in massive amounts of data that require manual sifting. Neuroscientist Jeremy Linsley and his team encountered this dilemma in their own work on neurodegenerative disease. They've been relying on an army of interns to scour hundreds of thousands of images of neurons and tally each death a slow and expensive process.

So they turned to artificial intelligence. Researchers can train an AI model to recognize specific patterns by feeding it many sample images, pointing out structures of interest and extrapolating the algorithm to new contexts. Linsley and his team developed a model to distinguish between living and dead neurons with greater speed and accuracy than people trained to do the same task.

They also opened the black box of the model to figure out how it was finding dead cells, revealing new signals of neuron death that researchers previously weren't aware of because they weren't obvious to the human eye.

By taking out human guesswork, (AI models) increase the reproducibility and speed of research and can help researchers discover new phenomena in images that they would otherwise not have been able to easily recognize, writes Linsley.

4. Seeing as appreciating

Even before they had the instruments to zoom in on samples, researchers had a tool in their arsenal to study the living world that they still use today: art.

Centuries ago, scientists and artists examined plants, animals and anatomy through illustration. Sketches of unfamiliar species in their natural environments aided in their classification, and drawings of the human body advanced study of its structure and function. With the help of the printing press, these artistic renderings which later included the view under the lenses of early microscopes popularised scientific knowledge about the natural world.

Though hand drawings have since given way to advanced imaging techniques and computer models, the legacy of communicating science through art continues. Scientific publications and BioArt competitions highlight laboratory images and videos to share the awe and wonder of studying the natural world with the general public. Using visualizations in classrooms and art museums can also promote science literacy by giving students a chance to look through the eye of the microscope as a scientist would.

Biologist and BioArt Awards judge Chris Curran believes that making visible the processes and concepts of science can grant a greater depth of understanding of the natural world necessary to being an informed citizen.

That those images and videos are often beautiful is an added benefit, she writes.

And the abstract qualities of science can be made tangible in ways that don't involve sight. Proteins, for instance, can be translated into music by mapping their physical properties into sound: amino acids turn into notes, while structural loops become tempos and motifs. Computational biologists Peng Zhang and Yuzong Chen enhanced the musicality of these mapping techniques by basing them on different music styles, such as that of Chopin. Consequently, a protein that prevents cancer formation, p53, sounds toccata-like, and the protein that binds to the hormone and neurotransmitter oxytocin flutters with recurring motifs.

It is a tool for the socio-economic growth of the region and its farming community. "It will double their income", he said.

In 2015, Prime Minister Narendra Modi had gifted organic Sulai honey to Queen Elizabeth during his visit to Britain.

The director also said the process for GI tagging of these products was initiated by the department and finally, it was granted on Tuesday.

"A geographical indication or geographical indication tag is a trade name or label applied to a particular product that designates a particular geographic region or country of origin. The GI tag's primary feature is its uniqueness, which guards against any form of third-party misuse," he said

According to him, the GI tag is a form of intellectual property right that identifies goods originating from a specific geographical location and having distinct nature, quality and characteristics linked to that

"Now, only an authorised user has the exclusive rights to use the geographical indication in relation to these products,' the director said.

Further, he said, "No person can copy it from beyond their geographical areas. This will prevent unauthorised use of these registered Geographical Indication goods by third parties and will boost exports and promote their brands at the international level".

Rs 200 LPG Price Cut On Oil Cos, Govt Unlikely To **Give Subsidy**

NEW DELHI: Bumper earnings in the first five months of the current fiscal and international benchmark coming off its highs will help state-owned oil companies absorb the Rs 200 per cylinder cut in cooking gas LPG prices, sources said indicating there may be no government compensation for that.

On Tuesday, the government announced a Rs 200 per cylinder cut in prices of domestic cooking gas to soften the impact of rising inflation on households as well as counter the promise of cheaper LPG made by the Congress party in upcoming assembly elections.

This resulted in the price of a 14.2-kg LPG cylinder in the national capital coming down to Rs 903 from Rs 1,103 earlier. For Ujjwala beneficiaries, the price will be Rs 703 after considering the continuing Rs 200 per cylinder subsidy.

State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL) posted bumper earnings in the April-June quarter and the trend is continuing in thereafter, government and industry sources said.

Also, Saudi CP - the price to which domestic LPG rates are benchmarked due to high import dependence - declined from USD 732 per tonne in March 2023 to USD 385 in July. Rates have gone up in August to USD 464 per tonne but still provide enough cushion for oil companies to cut LPG prices, they said.

Oil Minister Hardeep Singh Puri in television interviews on Wednesday said the three oil marketing companies cut the prices as "good corporate citizens" and the extension of "very healthy profits" of April-June



fiscal) in the following months will help their decision.

He however did not give a direct reply to questions on the government providing subsidy support for the decision.

Sources said the price cut is on oil companies and the government has so far not indicated any intention to provide for those.

The three firms booked under-recoveries or losses when Saudi CP had shot up in March/ April. The losses are yet to be recovered, they said.

What may have compounded their woes is the rise in rates in August. Saudi CP for propane has gone up to USD 470 per tonne in August and that for butane to USD 460. This compares to USD 400 per tonne rate for propane and USD 375 for butane in July.

A mix of propane and butane results in the creation of LPG.

An industry source said if the reduction in benchmark rate was the only criterion for deciding the price cut, LPG rates should have then been cut in July.

But the decision is political. Cooking gas prices have shot up in the last couple of years

and have become a major election issue. The Congress party used the high LPG prices, which had burnt a hole in the budgets of households already reeling under high inflation, effectively in the recently concluded as-

Noor was a member of RAF's Women's Auxiliary Air Force (WAAF) when she was recruited to the SOE in 1942 and went on to become one of only two members of the WAAF to be awarded the George Cross (GC) the highest award bestowed for acts of the greatest heroism,

or for the most conspicuous courage in circumstances of extreme danger.

"It was a proud moment to have the Queen unveil the portrait of Noor Inayat Khan at the RAF Club," said British Indian author Shrabani Basu, who presented a copy of her biography of Noor 'Spy Princess: The Life of Noor Inayat Khan' to the Queen at the unveiling ceremony.

"For me, it has been a privilege to tell her story. This wonderful portrait will now be seen by many young men and women for generations. Noor's story will never be forgotten," she said.

Born Noor-un-Nisa Inayat Khan in Moscow in 1914 to an Indian sufi saint father and American mother, Noor moved to London at a young age before settling in Paris for her school years. Following the fall of France during the Second World War, she escaped to England and joined the WAAF.

late 1942, she was

recruited into the SOE created to conduct espionage, sabotage, and reconnaissance in occupied territories during the war.

Her new portrait at the RAF Club was unveiled in the presence of her relatives, including 95-year-old cousin Shaikh Mahmood and nephew Pir Zia Inayat Khan.

The portrait has been created by celebrated British artist Paul Brason, a former President of the Society of Portrait Painters. He based his creation on the few available images of Noor Inayat Khan to capture her steely resolve as an undercover agent, who refused to crack under brutal Nazi interrogation before being shot by the Gestapo at Dachau concentration camp in Germany in 1944 with the word "liberty" on her lips.

"Noor was the first woman SOE operator to be infiltrated into France, and was landed by Lysander aircraft on 16 June 1943. During the following weeks, the Gestapo arrested most of the Paris Resistance

Group in which she worked. Despite the danger, Noor refused to return to England because she did not wish to leave her French comrades without communications and she hoped also to rebuild the Group," the RAF Club said in a statement.

"The Gestapo had a full description of Noor, who they knew only by her code name Madeleine', and in October 1943 she was captured by them. Despite brutal interrogation she refused to give any information, either as to her work or her colleagues. She was imprisoned in Gestapo HQ, during which time she made two unsuccessful attempts at escape, and was then sent to Germany for so called safe custody'. She was considered to be a particularly dangerous and uncooperative prisoner," it noted.

Noor was awarded the GC posthumously for displaying the most conspicuous courage, both moral and physical, over a period of more than 12 months.

Seizure of thousands of vehicles and hundreds of mineral dumps, as revealed by the report, shines a spotlight on the extent of illegal river-bed mining being carried out across Kashmir."...the unregulated activity as a whole is seen to have significant adverse impacts on environment and fluvial physical habitat characteristics," observes the DEERS report

In recent years, Jammu and Kashmir Expert Appraisal Committee (JKEAC), an eight-member committee of different subject experts constituted by the central government, has highlighted the negative impacts of illegal river-bed mineral mining several times. "The JKEAC has taken note of the news items circulating in the print and social media over the last fortnight relating to large scale illegal exploitation of river bed material in different streams of the Union Territory reportedly going on unchecked without any Environmental Clearance," JKEAC had noted in one of its meetings, minutes of which were available on the government website. It had also expressed concern on the non-availability of any authentic replenishment data, sketchy district survey reports as well as various other

According to the DEERS report, out of the 72 Minor Mineral Blocks identified in River Jhelum, 58 e-auctioned mineral blocks were cancelled by J&K Environment Impact Assessment Authority vide its circular no. JKEIAA/2020/2018/106/1697-98 dated: 18.12.2021 as it did not consider the Environmental Clearances for River Jhelum mining projects for being an in-stream mining

Residents living alongside rivers and streams in various areas of the valley have also been complaining about illegal riverbed mineral mining and are expressing their concerns about the harmful impacts of illegal mineral mining.

"The way these people carry out extraction of sand, gravel and boulders from the rivers, the day is not far when it would deprive us from cultivating our agricultural land altogether," said Mohammad Maqbool, a resident of Pulwama district, adding that large scale mining of river-beds is changing the courses of rivers and streams thereby making it difficult for farmers to irrigate their rice farms.

Abdul Majeed, a farmer in Kupwara district's Lolab area also expressed similar concerns. "Continuous mining in the Warnow Nallah has deepened its bed to such an extent that farmers have to struggle every year for diverting the water to the canals leading to rice farms," Majeed told Kashmir Observer.

According to research published by Centre of Mining Environment, Indian Institute of Technology (ISM), Dhanbad, the large-scale extraction of streambed materials, mining and dredging below the existing streambed, and the alteration of channel-bed form and shape leads to several impacts such as erosion of channel bed and banks, increase in channel slope, and change in channel morphology.

Besides causing losses to farmers and fishing communities, river-bed mining causes a number of other visible and invisible negative impacts. According to a report published by Wiley Online Library, river-bed mining is linked to many changes in ecological structure, processes, and biodiversity of freshwater systems, including habitat loss and degradation, reduction and changes to the diversity and abundance of macro invertebrate and fish populations, increased viability of invasive species, changes to food web dynamics, reductions in water quality and ground water levels, and alterations to riparian processes.

Prior to 2016, the extraction and transportation of river bed material (boulder, bajri and sand) was governed by J&K Minor Mineral Concession Rules, 1962 under which Short Term Permits on advance payment of royalty were issued to local extractors for a

specific period of time. "However, in light of the Apex Court Judgment in the case titled Deepak Kumar Vs State of Haryana & Ors dated 12.02.2012 all the State Governments and Union Territories were directed to frame fresh rules in respect of Minor Minerals under Section 15 and 23(c) of Mines and Minerals (Development & Regulation) Act, 1957," says

The Government of J&K framed and notified the new rules titled as "The Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals and Prevention of Illegal Mining Rules, 2016" vide SRO-105 of 2016 dated 31.03.2016. Under these rules the main mode of the grant of Mineral Concessions/ Mining Leases/License for mining of minor minerals is by way of e- auction in respect of State land.

"Accordingly in a Pre-auction process, the Department of Geology & Mining, J&K took up the identification and preparation of Georeferenced Minor Mineral Blocks with areas not exceeding 10 hectares in light of the provisions of the said rules read with Sustainable Sand Mining Guidelines 2016. 247 numbers of Minor Mineral Blocks were prepared in various nallas/Rivers of Kashmir Province along with the minimum reserve bid and after approval of the State/UT Govt. were forwarded to concerned Deputy Commissioners, Chairman District Auction Committee constituted vide Govt. Order no. 175-GAD of 2016 Dated; 01-03-2016, in pursuance to Rule 53 of J&K Minor Mineral Concession, Storage, Transportation and Prevention of Illegal Mining Rules, 2016, for putting them to e- auction, besides some Minor Mineral Blocks prepared were reserved for JK Projects Construction Corporation (02 no.) and JK Minerals Limited (03 no.)," the

Asked for his reaction to India's diplomatic protest by a Chinese state-run outlet, Chinese Foreign Ministry spokesman Wang Wenbin told a media briefing in Beijing on Wednesday that "on August 23, the Ministry of National Resources of China released the 2023 edition of the standard map".

"It is a routine practice in China's exercise of sovereignty in accordance with the law. We hope relevant sides can stay objective and calm, and refrain from over-interpreting the issue," Wang said.

UK air traffic control chaos caused by 'incorrect' flight data

London: The UK's air traffic control chief has said that "incorrect" flight data was the cause of the massive disruption that affected thousands of passengers stuck in planes and at airports as hundreds of flights to and from the country were cancelled, with knock-on effects continuing on Wednesday.

Martin Rolfe, the chief executive of National Air Traffic Services (NATS) which had faced the "technical issue" that triggered the chaos on Monday, said an initial investigation had found the failure was caused by flight data which its system could not interpret.

He also reiterated the government's previous statement that it was not caused by a cyber-attack.

"Initial investigations into the problem show it relates to some of the flight data we received," said Rolfe.

"Our systems, both primary and the back-ups, responded by suspending automatic processing to ensure that no incorrect safety-related information could be presented to an air traffic controller or impact the rest of the air traffic system. There are no indications that

this was a cyber-attack," he said. The air traffic chief reassured passengers that since Monday afternoon all NATS systems have been running "normally" but acknowledged that the "knock-on effects" continue to be felt at a particularly busy travel time of the year over the summer holidays.

gested the chaos may have been caused after a French airline misfiled its flight plan. Without confirming or denying the reports, Rolfe told broadcasters in interviews that the issue could be related to a single flight plan.

"We know it is something in the flight data and we will get to the bottom of it and understand why. We are conducting an investigation, we will conduct it incredibly thoroughly," he added. NATS – which is in charge of handling 2 million flights a year to and from the UK - said it has identified the issue around the way the system and "several levels of backups" reacted to the incorrect data, which should prevent similar delays in future.

It is, meanwhile, working with the UK's Civil Aviation Authority (CAA) on the investigation and said the conclusions of that report will be made public. As a result of the incorrect data, flight plans had to be uploaded to systems manually, slowing or cancelling air traffic across the UK. Thousands of passengers were affected, with many forced to spend the night at airports around the world and several still waiting for rescheduled flights.

Analysis of flight data found around 281 flights, including departures and arrivals, were cancelled on Tuesday at the UK's six busiest airports – 75 at Gatwick, 74 at Heathrow, 63 at Manchester, 28 at Stansted, 23 at Luton and 18 at Edinburgh.

Chandrayan-3 Confirms Sulfur, Other Elements Near Lunar South Pole

NEW DELHI: India's moon rover confirmed the presence of sulfur and detected several other elements near the lunar south pole as it searches for signs of frozen water nearly a week after its historic moon landing, India's space agency said Tuesday.

The rover's laser-induced spectroscope instrument also detected aluminum, iron, calcium, chromium, titanium, manganese, oxygen and silicon on the lunar surface, the Indian Space Research Organization, or ISRO, said in a post on its website.

The lunar rover had come down a ramp from the lander of India's spacecraft after last Wednesday's touch-down near the moon's south pole. The Chandrayan-3 Rover is expected to conduct experiments over 14



days, the ISRO has said.

The rover "unambiguously confirms the presence of sulfur," ISRO said. It also is searching for signs of frozen water that could help future astronaut missions, as a potential source of drinking

water or to make rocket fuel. The rover also will study the moon's atmosphere and seismic activity, ISRO Chairman S Somnath said.

On Monday, the rover's route was reprogrammed when it came

close to a 4-meter-wide (13-footwide) crater. "It's now safely heading on a new path," the ISRO said.

The craft moves at a slow speed of around 10 centimeters (4 inches) per second to minimize shock and damage to the vehicle from the moon's rough terrain.

After a failed attempt to land on the moon in 2019, India last week joined the United States, the Soviet Union and China as only the fourth country to achieve this milestone.

The successful mission showcases India's rising standing as a technology and space powerhouse and dovetails with the image that Prime Minister Narendra Modi is trying to project: an ascendant country asserting its place among the global elite.

Sick Leopard's Ordeal: Villagers Take Selfies, Try To Ride Animal In MP

Shocking videos of an ailing wild leopard being surrounded by a group of villagers, who are taking selfies with him and even trying to ride him, have emerged from Dewas district of Madhya Pradesh.
The incident occurred in

Iklera village in Dewas on Tuesday, 29 August. following which the forest department rescued the leopard. The animal, suspected to be suffering from a brain disorder, was admitted to a zoo in Indore city on Wednesday in critical condition, an official said. The official also expressed surprise that the male leopard neither attacked the group of people surrounding him, nor roared at them.



"The leopard was rescued on Tuesday from Iklera village, about 80 km from Indore," said Vikas Mahore, superintendent of the forest department's Kheoni sanctuary in Dewas. He said that villagers will be warned not to go near any sick wild animal in

future for their own safety. In the videos that have surfaced on social media, a group of men, some of them holding sticks, are seen either sitting or standing near the leopard. Some of them try to click pictures with the spotted feline, while some others touch the attempts. One video shows a man trying to ride the animal when the latter is walking.
