Art-370 Abrogation Was Not Executive Decision: Centre To SC

Says Entire Parliament Was Taken Into Confidence

New Delhi: The decision to abrogate provisions of Article 370 that accorded "special status' to the erstwhile state of Jammu and Kashmir was not made by the political executive alone and Indian Parliament was taken into confidence, the Supreme Court was told on Friday.

As the long-winded debate on the issue continued, the fivejudge bench headed by Chief Justice DY Chandrachud was also told by senior advocate Rakesh Dwivedi, appearing for intervenor Ashwini Upadhyay, that the word 'recommendation' in Article 370 meant that the assent of the constituent assembly of Iammu and Kashmir was not necessary for abrogation.

The abrogation of the provision was not an executive decision and that the entirety of Parliament which included Members of Parliament (MPs)



of Jammu and Kashmir had been taken into confidence," the senior lawyer said.

framing Constitution for Jammu and Kashmir, its constituent assembly did not enjoy the same freedom which the constituent assembly of India did, he said, while attempting to draw

Referring to Article 370(3), Dwivedi said, "The word 'recommendation' under Article 370(3) means that the assent of the Constituent Assembly was not necessary to abrogate Article 370.'

notwithstanding anything in the foregoing provisions of this article, the President may, by public notification, declare that this article shall cease to be operative or shall be operative only with such exceptions and modifications and from such date as he may specify: Provided that the recommendation of

the Constituent Assembly of the State referred to in clause (2) shall be necessary before the President issues such a notification.

The bench, also comprising Justices Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surya Kant, which was hearing arguments on the 14th day of hearing on a batch of petitions challenging the Centre's August 5, 2019 decision to abrogate the provision, was told by Dwivedi that "the Jammu and Kashmir Constituent Assembly was bound by various things including various dictats of Indian constitution."

"It had to ensure justice, liberty, fraternity. It was also bound by Article 1. It could not declare that we're not the federal unit of India. They couldn't say that any part of their territory could not be part of India," he submitted.

In a resolution passed at the meeting here, the INDIA bloc said it resolves to contest the forthcoming Lok Sabha elections together "as far as possible".


Seat-sharing arrangements in different states will be initiated immediately and concluded at the earliest in a collaborative spirit of give and take, it said.

He further said that the accused used WhatsApp to send photos of various young women, falsely claiming they

were ready for marriage. "These individuals convinced the victims on the other side to agree to marriage proposals, fix the Mehar money and make payments.

However, despite financial transactions no marriages were conducted and the money was not returned," the spokesperson said.

Old City To Get First Pedestrian Bridge Alike Zero-Bridge

Old Habba Kadal To Be Redesigned Under SSCL

Srinagar: In a bid to preserve the old heritage and to create a public place in the congested old City area, the Srinagar Smart City Limited (SSCL) has taken up a project to redesign the old Habba Kadal Bridge at the cost of Rs 1.8 crore. The old Habba Kadal Bridge is

being redesigned under the Smart City project.

Pertinently, the locals from time to time had urged the government to take necessary measures as the bridge was being used for the parking purpose, leaving less space for the people to travel or walk.

Chief Engineer, SSCL, Iftikhar Kakroo when contacted said that the bridge is being redesigned and will be constructed similar to the Zero bridge here where a huge rush of people could be seen visiting on a regular basis.

"We have taken up the project worth Rs 1.8 crore to redesign the old Habba Kadal Bridge here, which was currently not in use. Almost 50 per cent work on the project has been completed and it would take further two months to complete the project," Kakroo said.

The project has been taken up in order to create a public space and also preserve the old heritage in Shehr-e-Khaas, adding that it is very difficult to find a spot where public space can be created; luckily the spot was identified as the bridge was not in use at present and the work has been started in this regard.

The illumination and other works are still pending and the bridge will be completely redesigned in the next two months, he said.

The old Habba Kadal Bridge, which is being redesigned similar to Zero bridge, will have a lot of sitting spaces, Gazebos and kiosks on it after its completion.

The officials have made it clear that the bridge will be exclusively for pedestrian use only as the vehicles will not be allowed to

ployed as India hosts the world's most powerful leaders at a G20 summit in New Delhi this month, a showcase for Prime Minister Narendra Modi and the country's growing presence on the world

The two-day summit, starting September 9, will have the most high-profile guest list India has ever welcomed, from U.S. President Joe Biden to British Prime Minister Rishi Sunak and Saudi Arabia's Mohammed Bin Salman.



Govt Forms Panel To Study 'One Nation, One Election'; Former **President To Head Committee**

The government has consti-I tuted a committee headed by former president Ram Nath Kovind to explore the feasibility of "one nation, one election", opening the possibility of Lok Sabha polls being advanced so that they could be held with a string of state assembly contests.

Sources said on Friday that Kovind will explore the feasibility of the exercise and the mechanism to see as to how the country can go back to having simultaneous Lok Sabha and state assembly polls, as was the case till 1967. He is expected to speak to experts and may also consult leaders of different political parties, they said.

The government's decision comes a day after it decided to call a special session of Parliament between September 18 and 22, the agenda for which is under wraps.

Since coming to power in 2014, Prime Minister Narendra Modi has been a strong votary for the idea of simultaneous polls, which include those at local bodies, citing financial burden caused by almost continuous election cycle



and jolt to development work during the polling period.

Kovind too had echoed Modi's view and expressed his support ident in 2017.

Addressing Parliament, he had said in 2018, "Frequent elections not only impose a huge burden on human resources but also impede the development process due to the promulgation of the model code of conduct."

Like Modi, he had called for a sustained debate and expressed hope that all political parties ar-

rive at a consensus on this issue. With the Modi government approaching end of its second

With the ruling BJP under Modi always animated by grander themes and big ticket ideas to rally popular support, the issue will also suit the party politically and catch the opposition off-guard, leaders in the party believe. Assembly polls are due in five states- Mizoram, Madhya Pradesh, Chhattisgarh, Telangana and Rajasthan- in November-December and they are scheduled to be followed by the Lok Sabha elections in May-June next year.

Iran Foils 'Biggest' **Sabotage Plot Against Its Defense Industry**

Tranian intelligence forces I have thwarted a complicated sabotage plot against the country's defense industry.

The "biggest" sabotage plot against the missile and aerospace industry of the Defense Ministry was neutralized through the vigilance of the ministry's Intelligence Organization, the national TV reported on Thursday.

It added that the Israeli regime's spy services and its global vassals were behind the plot, aimed at harming Iran's defense power.

An official in the Defense Ministry's Intelligence Organization said that due to the effectiveness of Iran's missile power in creating deterrence against enemy threats, its missile industry has always been among the targets of enemy spy services.

The source explained that in recent years, multi-layer intelligence and security projects have been designed and implemented under the cover



of buying parts to deceive the enemy's spy services.

The Iranian intelligence forces managed to bust a professional network that had plotted to introduce "faulty and equipped parts" to be used in the production of advanced missiles in the Defense Ministry, the source added.

"Under direct orders from Mossad, this network, by selling the equipped parts, intended to convert the produced missiles into explosive devices to harm industrial lines and employees working in this field.'

The source further stated that the Israeli regime is frustrated over the huge blow it received with the dismantling of its sabotage network in Iran.

Cop Sacked For Playing Piano As Protesters Broke Into Sri Lanka President's House

COLOMBO: Sri Lanka's police force said Friday it had sacked an officer who entertained protesters with an impromptu piano performance after they entered the island nation's presidential compound last year. Constable R. M. D. Dayaratne was

deployed to help protect the colonial-era residence on the day it was taken over by protesters who forced then-president Gotabaya Rajapaksa to flee the country. Instead, he sat at a grand piano

in the compound and played a song to the crowd streaming through its

"Dayaratne was on social media playing the piano while the building was being vandalised," a senior officer, speaking on condition of anonymity, told AFP.

"He was our Nero," the officer added, referring to the ancient Roman emperor said to have played the fiddle while the city burned in a weeklong fire.

Police authorities concluded that the constable had breached discipline after a lengthy investigation. Before the compound was entered



in July 2022, protesters had been camped outside Rajapaksa's office for months demanding he step down over the island nation's unprecedented economic crisis.

Protesters seized the residence and were later seen frolicking in the presidential pool and jumping on Ra-

apaksa's four-poster bed. Rajapaksa was accused of precipitating corruption and mismanagement that triggered the downturn, which led to severe shortages of food, fuel and medicines.

He was forced to seek temporary exile in Singapore, from where he issued his resignation, though he has since returned to Sri Lanka

Man Dupes People Posing As Home Ministry, Probe Agency Official, Arrested

NEW DELHI: The Enforcement Directorate (ED) has arrested a person under the provisions of the Prevention of Money Laundering Act (PMLA) for duping people by posing as an ED and a Ministry of Home Affairs (MHA) officer.

The accused has been identified as Omveer Singh, the investigating agency said on Thursday.

He was arrested on Wednesday and has been sent into the custody of ED till September 2 by PMLA Court, Ahmedabad. ED investigation was initiated

on the basis of FIRs registered by Ahmedabad Police and Surat Police against Omveer Singh for the commission of offences of impersonation and cheating.

According to ED, Omveer Singh, fraudulently identifying himself as a senior official of the ED, duped one Coal trader to the tune of ₹1.50 Crore on the pretext of getting his tender work done through his highly placed contact persons.

"In another instance, he defrauded a Surat-based energy sector company for more than ₹2 Crore by imperson-



ating the Financial Advisor and Auditor at the Ministry of Home Affairs, Government of India," ED said.

ED investigation revealed that Omveer Singh had meagre sources of income till 2019 from his employment as a construction site supervisor. After that, he started to impersonate senior government officers working in different departments and started to allure various gullible persons on the pretext of getting their work

done and thus, defrauded them with crores of rupees.

"His modus operandi involves duping certain persons in a city and later changing his residence and identity to defraud a new set of people. The proceeds of crime acquired from impersonation and cheating were spent on the enjoyment of a lavish lifestyle," the federal probe agency said.

Further investigation into the matter is under progress.

JAMMU: Normal life was partially affected here Friday due to a 'chakka jam' called by the All Jammu and Kashmir Transport Welfare Association (AJKTWA) to press its demand for the removal of a toll plaza along the Jammu-Pathankot highway in Samba district.

Public and private transport was off the roads, hitting the movement of the people in the city. Lack of transport facilities also affected attendance in educational institutions.

However, shops and business establishments remained opened.

Led by AJKTWA Chairman Ajit Singh, hundreds of people from various associations assembled in the Bhagwatinagar area, and held protest demonstrations against the National Highways Authority of India (NHAI) over bad condition of the highway. They demanded abolition of the newly set up Sarore toll plaza.

Raising slogans against the NHAI, they took out a protest rally to the toll plaza. Hundreds of vehicles remained lined up in one tube of the highway during the protest

"We are protesting against the NHAI in view of the bad condition, damaged bridge and toll plaza issue. We are taking a rally to Sarore toll plaza to support the demand," Singh told reporters here.

He said that despite protests for months by various organisations, the "NHAI is yet to wake up and resolve the issue". The hunger strike by Dogra Aketa Front organised at Samba continued for 9th consecutive day on Friday.

A day-long bandh was observed on the issue last Saturday on a call given by the Jammu Chamber of Commerce and Industries (JCCI) and was supported by several political parties in Jammu and Kashmir, including the Congress, the National Conference and the Peoples Democratic Party.

Free Access To HMVs

11616 Trucks Traverse NH-44 During Past 3 Days

Truckers advised by the Deptt to strictly avoid overloading & check fitness of their vehicles before undertaking journey on the highway

SRINAGAR: What else can be more tiring than waiting and waiting for hours together doing nothing. It is no assumption or imagination but was the plight of truckers only a week back on the Jammu-Srinagar National Highway. These goods carriers were halted by the traffic authorities both during their up or down movement for hours or sometimes days together as a measure to manage the traffic better on this mountainous road.

Then what could be termed as a greatest relief measure for all the truckers traversing the Jammu-Srinagar National Highway on routine basis than to allow them ply freely with no more halts in-between the two capitals. These drivers can't be more happy than to use this road without any undue interruptions. They are fortunate to see the end of that tiring waiting period which they were made to do on the name of traffic management.

All this happened when recently a team led by the Chief Secretary, Dr Arun Kumar Meh-



ta took a holistic review of this road in-person upto Ramban from Srinagar and directed the concerned not to enforce any manual halts on this highway for HMVs. This resulted in issuance of fresh advisory by the traffic department ordering no hindrance on the movement of HMVs of less than 4-axle on the road and offering them smooth access to their destinations.

The fresh advisory was issued ahead of the fruit season during which several thousand additional vehicles laden with fresh produce traverse this road on daily basis. It also encouraged the field personnel to ensure that the HMVs laden with es-

sential items like fruits, vegetables and poultry to be given prior access on this road as these items are perishable in nature.

To ensure that there are no uncalled breakdown of any vehicle enroute the department advised the truckers to strictly adhere to the norms of carrying the load and do away with the overloading of their vehicles. It also asked them to allow only trucks that are fit in all respects to ply smoothly on this mountainous highway. It even told them to resort to an optimum speed that do not create hindrance for other categories of vehicles on this road thereby ensuring that each of them reaches to its destination in a duration of 8-10 hours only. During that visit the team

had taken note of the progress of several under-construction infrastructure projects like tunnels, viaducts and flyovers. Further it had directed the NHAI to keep the men and machinery in readiness in the difficult stretches at Dalwas, Mehad, Cafeteria Morh and other areas prone to landslides so that the minimum carriage way for two side movement of HMVs is maintained all the time.

Earlier on the directions of the Chief Secretary during his visit these new advisories were issued regarding giving of unhindered access to the vehicles having 4-axle and below. This immediately resulted in having no halting of such vehicles on the highway especially near Qazigund (Anantnag) or Jakhani (Udhampur). It even fructified into having the highway clearedoff of the hundreds of HMVs that used to be halted earlier at these places for hours together before

allowing to proceed ahead. Now if we have a fresh look of the data of the vehicles that have plied on this road from the last few days the story is different. It shows that 11616 HMVs including fruit, vegetable and poultry trucks were given free access on this highway from 28th to 30th of August.

While chiseling it further it details out that on 30th of August around 5386 HMVs traversed this highway from both sides including 3281 Trucks, 1138 Oil Tankers, 141 Gas Tankers, 654 fruit trucks, 69 vegetable laden trucks, 85 Poultry, 181 Food grain (FCI) trucks and 26 Sheep trucks.

It is also noteworthy to mention here that it also entails from this data that from the last 3 days 7427 goods trucks, 1041 fruit trucks, 277 vegetable trucks, 181 Food grain (FCI) trucks, 85 Poultry and 26 Sheep trucks including 255 buses crossed this highway from both sides. It further came out that these vehicles reached their destinations in the set timeframe of 8-10 hours facing least disruptions enroute during their travel on this treacherous road.

HC Rejects Kupwara Man's Plea For Quashing Rape Case

SRINAGAR: Observing that inherent powers under section 482 CrPC are to be exercised sparingly, the High Court of I&K and Ladakh has declined a petition by a Kupwara resident, challenging a case filed against him for alleged rape and recording of nude videos of a woman who had sought help from him to get her brother released from jail.

"A bare perusal of the complaint whereunder the impugned FIR has originatedwould reveal that the complainantin unequivocal and explicit terms has alleged the commission of offence of rape besides the offence of cheating and criminal intimidation against the petitioner herein (accused)," a bench of Justice Javed Iqbal Wani said.

"Whether the allegations in the FIR make out a cognizable offence or not or whether the said allegations are genuine or unfounded is not to be looked into by this court at this stage as the veracity or otherwise of the said allegations and counter allegations leveled by the accused petitioner herein ought to be looked and inquired into by the investigating agency vested with the power thereof," the court said, adding, "A plain reading of the FIR would prima facie disclose the commission of a cognizable offence under sections 376, 420 and 506 IPC alleged by the (woman).'

Consequently the court declined to exercise its inherent powers under section 482 Cr.PC to quash the FIR and dismissed the petition.

According to police, the case (FIR 97/2023) was registered on 9 May 2023 with police station Kupwara for commission of offences under section 376, 420 and 506 IPC based on a complaint by the woman.

She had alleged that her brother was lodged in a jail outside J&K and she being an uneducated lady approached the accused, Irshad Ahmad Ganie, being known to her, for extending help in getting her brother bailed out. The woman also alleged that she paid Rs. 3 lakhs to the Ganie, and that he several times molested her and committed rape on her without her consent. Besides she alleged that the accused recorded her nude videos and photographs and threatened her that in case she discloses the same to anyone, he will upload the videos and pictures on social media besides showing them to her in-laws and her

curious engineer was immersed in a tough math problem at his college library, sacrificing sleep to solve it. Despite numerous failed attempts, his perseverance paid off with a breakthrough. Excitedly, he went to his supervisor to share the news and asked for more time. Sadly, the request was denied, putting his college enrollment at risk for not meeting the project deadline. Disheartened, he returned to his room, weighed down by his dreams. Tragically, the next morning, he was found lifeless—depicted as Joy Lowbo in "3 Idiots," a young engineer overwhelmed by despair.

This scene depicted in the film resonates with the present scenario of two pivotal cases of suicide which have come up - the first one at Kolkata's Jadavpur University due to ragging in the university campus and the second one in Chennai, due to failure in the NEET examination. In this context, the classical sociologist Emile Durkheim's study of Suicide (1897) remains a stalwart. Durkheim's study was based on secondary data collected from the local police. In his study, the functionalist bestowed four major observations which hold relevance even in the contemporary globalized world. He used integration and regulation as two parameters to present four types of suicides, namely altruistic, egoistic, anomic, and fatalistic suicide. He used four variables for his theory, marital status (bachelor/married), locality (developed/ underdeveloped country), religious orientation (protestant/catholic), and sex (male/female).

Durkheim's study revealed that the rates of suicide were higher among bachelors and males than among married and females. It also revealed that suicide rates are less in underdeveloped countries in comparison with developed countries. According to the thesis, people with high suicidal thoughts are less integrated into society. In contemporary society, egoistic and anomic suicides are common. There are suicides that result from low integration of one in society and low regulation of individuals by society, as seen in the case of Joy Lowbo. Apart from this, family problems, marriage, and love-related problems, and illness account for two-thirds of cases in

According to a 2018 report from the World Health Organization



(WHO), suicide is one of the leading causes of death in the world with about 8,00,000 people committing suicide every year. Of these, about one-third occur among the youth. Suicide is one of the leading causes of death among 15-29-year-olds. The picture is even worse than it appears because, for every suicide, there are many more people who attempt suicide. The distressing trajectory from 2019 to 2022 unveils a disconcerting rise in the suicide rate, ascending from 10.2 to 11.3 per 1,00,000 individuals in the population. Notably, India's global share of suicides has undergone a marked shift, surging from 25.3% in 1990 to a notable 36.6% in 2016 concerning women, and from 18.7% to 24.3% concerning men. Reflecting a stark imbalance, the ratio of suicides between genders stands at 70:30, underscoring the urgency of addressing this multifaceted challenge, a

From a data-driven vantage point, it becomes apparent that Durkheim's enduring thewory retains its relevance, particularly in the realms of sex and marital status. However, when scrutinizing the variable of locality, the evidence suggests a departure from this pattern.

Acknowledging the grave issue of suicide, the Indian government has taken a decisive stance. In a proactive move, the Union Ministry of Health and Family Welfare has unveiled the inaugural National Strategy for Suicide Prevention, signifying a significant milestone. With a resolute objective, this pioneering strategy endeavors to curtail the nation's suicide mortality rate by a notable 10% within the span of a decade, setting its sights on the year 2030. Drawing inspiration from the well-established directives outlined by the World Health Organization (WHO) for Suicide Prevention in the South East Asian region, the structure of this national strategy closely aligns with these esteemed international guidelines.

The approach not only mirrors the guidelines set forth by the WHO but also intricately weaves them into India's unique socio-cultural context and its present social infrastructure. The core of this approach revolves around establishing robust surveillance mechanisms for monitoring suicides within a concise three-year timeframe. Fur-

thermore, a comprehensive plan is in motion to institute psychiatric outpatient departments as integral components of the District Mental Health Programme, ensuring the availability of vital suicide prevention services across all districts within a commendable five-year span. Actively encased within the framework of the Mental Health Act, this strategy serves as its prominent outer layer.

A pivotal aspect of this strategy lies in its meticulous consideration of the pervasive stigma enveloping mental disorders and suicidal tendencies. An exhaustive brainstorming process has yielded pragmatic guidelines, aimed at fostering responsible and sensitive media coverage of suicide incidents. Simultaneously, an innovative mental well-being curriculum is being conceived for integration into educational institutions. This pioneering endeavor holds profound significance, acting as a catalyst for elevating community awareness and dismantling long-standing taboos. It epitomizes the progressive essence of Indian society, poised to set a compelling example on the global stage

Giving Employment A Boost: It Can't Be Treated Merely As An Outcome Of Growth

t is necessary to pursue employment as an independent objective and not have it as an outcome of growth. More than ten million people entering the employment market every year cannot otherwise find jobs.

From 1972-73 to 1993-94, for every 1% of GDP growth, employment grew by 0.48%. During 1993-94 to 1999-2000, GDP grew 6.8% and employment grew by 1% annually. The period between 2004-05 to 2009-10 showed jobless growth with annual GDP growing at 8.7% and employment growing at 0.1% annually. During 2011-12 to 2021-22 (the latest period for which the employment data is available), average GDP growth was at 5.4%, with an average employment growth of 1.4%. We had demonetisation in 2016, introduction of the GST in 2017, and the pandemic in 2019-20. The changes up to the pandemic moderated both growth in income and jobs. Post the pandemic, with expansionary fiscal and monetary measures, there is a return to normalcy with growth averaging 7.5% in the last 10 quarters and employment showing signs of revival.

The Periodic Labour Force Survey (PLFS) was introduced in 2017-18. Prior to that, employment data gathering was a five yearly exercise. The last such data is from 2011-12. The Labour Bureau came out with an annual survey during 2011-12 to 2016-17, but there were issues of consistency and comparability, including the NSSO quality guarantee.

The PLFS 2017-18 indicated that overall employment has declined from 472 million in 2011-12 to 457 million in 2017-18. There was a decline of 25 million in the female workforce during this period. Job creation post 2017-18 improved, and in the four years since then, 86 million incremental jobs were created, while an additional 80 million were seeking jobs.

The accompanying graphic provides overall employment, compound average annual employment growth, growth of gross value added in the sectors and employment elasticity for two periods (period I being 1999-2000 to 2011-12, and period II being 2011-12 to 2021-22).

period II being 2011-12 to 2021-22).

The elasticity of employment was negative in agriculture in period I and positive in period II. Agriculture can't retain a large labour force. Adoption of sustainable technologies, freeing internal and external trade in agri-commodities, with government intervention only at critical times, and transfer of manpower to secondary and tertiary sectors through labour intensive manufacturing and higher growth in services are critical for a sustained growth of persons engaged in agriculture. Post pandemic, reverse migration has contributed to the positive employment elasticity

in agriculture.

The performance of manufacturing in period II was dismal. Notwithstanding available manufacturing centric policies, employment elasticity was just 0.1. This sector employs only 62 million people. Perhaps, manufacturing strategy needs a paradigm shift, and we are yet to understand the core issues that will enable manufacturing to reach 25% of



GVA. Manufacturing has been helped by a booming construction sector, including real estate and public infrastructure.

Spread of labour-intensive manufacturing in areas where labour is available by implementing policies favorable to positioning such industries will require sustained effort by both the Centre and the states. A collateral benefit in doing so will be increased consumption and exports of labour-intensive products in the country.

Construction has indeed been a sunrise sector. This relatively low-technology and labour-intensive sector had an employment growth of 9% in period I and 3% in period II, with a near unity in employment elasticity. This underscores the importance of MGN-REGA and infrastructure development and perhaps an easy shift of labour

from agriculture.

Trade, hotels, transport, and communication services has been the second-largest sector in absorbing labour. These entities are mostly in the household sector. They face challenges from organised retail, digital, and home deliveries. Increased digitisation and incorporation into the e-commerce ecosystem will help them. Enhanced technology usage in transport and communication along with reducing costs in regulation will further help them. Focus on skill development is bound to enhance employment. Financial and professional services will continue to perform well because of increased need for intermediation and consultancy. But these are upscale market jobs and not the point of first jump from unorganised to skilled.

other services are a heterogeneous

mix of public administration and defence, education, health, art and recreation, and other services. Public administration and defence account for nearly 20% of these services. With faceless delivery of public services, growth of employment in public administration is unlikely. Skill development, use of appropriate technology, and regulation and quality upgradation in health and education will make them more accessible and affordable.

Policies to increase female labour force participation ratio from the current 24% will help. This was 33% in 1993-94. To increase female participation, we need cultural acceptance, emphasis on female education, creation of auxiliary facilities for working women, and their skill upgradation. But an increase in labour force participation to even 45% would increase the number of new job seekers by 110 million by 2029-30, or an average 13 million persons per year. With agriculture looking for a net reduction in work force, the new job seekers need to get accommodated in industry and services raising the required rate of growth of employment even higher. As gig workers will contribute to substantial employment in this period, legally enforceable social security measures, as appropriate, must be put in place.

The new search feature, dubbed SGE (Search Generative Experience), will be available through Google's Search Labs in these markets and will introduce a new feature aimed at making it easier to find information in its AIpowered overviews.

"This week, we launched Search Labs in the first countries outside the US -- India and Japan -- enabling people to opt into SGE to help them better understand topics faster, uncover new viewpoints

SGE, which was first announced at this year's Google I/O Developer conference in May, adds a conversational mode to Google Search, allowing you to ask Google questions about a topic and have it respond with answers, similar to an AI chatbot.

Similar to the US, people in India and Japan will be able to use generative AI capabilities in their local languages, either by typing a query or using voice input.

In India, users will also find a language toggle to help multilingual speakers easily switch back and forth

between English and Hindi, and they can also listen to the responses, which is a popular preference. In both countries, Search ads will continue to appear in dedicated ad slots throughout the page, the tech giant said.

Along with these updates, SGE is introducing a new feature that will make it easier for people to discover and visit the web pages that support the information provided by AI.

"Starting today, when you see an arrow icon next to information in an AI-powered overview, you can click to see relevant web pages, and easily learn more by visiting the sites," Google said.

The feature is launching first in the US and will roll out to Japan and India over the coming weeks.

Two blood proteins, known to contribute to clotting, could help predict cognitive deficits 6 and 12 months after hospitalisation due to Covid, new research published in the journal Nature Medicine has found.

'Brain fog', or the inability to focus and pay attention, is one of the commonly reported post-Covid cognitive effects. Other such cognitive deficits include loss in executive function, memory, and learning.

The blood proteins, identified as fibrinogen and d-dimer, were highly correlated with post-acute COVID-19 cognitive deficits, the study from the University of Oxford, UK, found.

In this study, the researchers collected blood samples of 1,837 patients hospitalised for COVID-19 in the UK between January 29, 2020 and November 20, 2021.

They also got clinician-acquired and patient-reported data about the patients' cognition 6 and 12 months after hospital admission.

The clinician-acquired data was used in determining the Montreal Cognitive Assessment (MoCA) score, which measured the patients' objective cognitive deficits.

The patient-reported data was obtained through Patient Symptom Questionnaire (C-PSQ) and helped measure their subjective cognitive deficits.

Individuals with high levels of fibrinogen at the time of hospital admission relative to C-reactive protein (CRP), which is formed as a consequence of inflammation, showed significantly higher C-PSQ (subjective deficits) and lower MoCA score (objective deficits) at 6 and 12 months after Covid, the researchers found.

In other words, they wrote, high levels of fibrinogen compared to CRP were

linked to signs of both objective and subjective cognitive deficits at 6 and 12 months after Covid.

The researchers also found that raised levels of d-dimer compared to CRP translated into significantly higher C-PSQ, but not lower MoCA, along with occupational outcomes at 6 and 12 months after Covid.

Thus, elevated levels of d-dimer compared to CRP were linked with subjective cognitive deficits, as well as signs of occupational impact such as an impaired ability to work or an occupational change, at 6 and 12 months, they wrote.

The researchers think that fibrinogen, indicative of inflammation, may directly affect the brain through brain cell damage and eventually, binding of amyloid-beta, suggesting dementia.

Previous studies have associated raised fibringen levels with cognitive deficit and subsequent dementia.

Gene Therapy For Brain Tumour Shows Promise In Early Results: Lancet Study

therapy combining cell-killing and immune-stimulating drugs are safe and effective in extending survival for patients with gliomas, a highly aggressive form of brain cancer, according to a study published in The Lancet Oncology journal.

Given gliomas' poor prognosis and limited response to treatments like chemotherapy and radiation, the team looked to using the protein Flt3L to recruit immune cells, typically absent from the brain

These immune cells are required to kick start a more effective cancer immune response.

"Being able to move a novel therapy from bench to bedside in such a streamlined fashion is exciting, and represents a tour-deforce in translational medicine," said Oren Sagher, a professor of neurosurgery at the University of Michigan (U-M), US. The study focused on

two types of genetic therapies in high-grade gliomas. The first was a combination of HSV-1-TK, a protein, and Valtrex, a drug used to treat viral infections like cold sores and chick-HSV-1-TK turns Valtrex into a cy-

totoxic compound that kills actively dividing cancer cells. The second was Flt3L, a protein that recruits essential immune cells to the brain.

When used in combination, these therapies showed exciting early results, including improved survival, the researchers said.

Of the 18 patients enrolled in the trial, six survived more than two years, three survived more than three years, and one patient, who is still alive at the time of publication,

survived up to five years, they said.

With current standard-of-care, the life expectancy for a tumour of this kind of just over 14 months.

The study found that this treatment wasn't toxic to the patients, suggesting that the highest dose used in this trial could be used in future trials.

Though the adenoviral gene therapy vectors were supposed to be active for up to a month, the researchers discovered that activity from the adenoviral vector expressing the HSV1-TK was active for up to 17 months.



This discovery changes expectations of adenoviral gene therapy in the brain and extends the potential time during which the combination HSV1-TK and Valtrex might be harnessed to combat tumour recurrence, the researchers said.

'This originated from a theoretical idea based on evolutionary hypotheses and was first tested in experimental models of the disease," said Pedro Lowenstein, a professor

"Finally, after many years, we're thrilled to report the results of testing this approach in human patients, obtaining results that will lead to better treatments for this group of brain tumor patients," said Maria Castro, a professor at U-M.

RBI Says 93% Of Rs 2000 Notes Returned To Banks

MUMBAI: The Reserve Bank on Friday said that as much as 93 per cent of Rs 2000 currency notes that were in circulation on May 19 -- the day when the currency was withdrawn from circulation -- have been returned to banks.

According to the data received from the banks, the total value of Rs 2000 banknotes received back from circulation is Rs 3.32 lakh crore up to August 31, 2023, it said in a statement.

'Consequently, Rs 2000 banknotes in circulation as at the close of business on August 31, 2023 stood at Rs 0.24 lakh crore. Thus, 93 per cent of the Rs 2000 banknotes in circulation as on May 19, 2023, have since been returned," it said.

Data collected from major banks indicates that out of the total banknotes in Rs 2000 denomination received back from circulation, about 87 per cent is in the form of deposits and the



remaining around 13 per cent has been exchanged into other denomination banknotes.

The Reserve Bank of India had announced the withdrawal of Rs 2000 banknotes from circulation on May 19, 2023..

The total value of Rs 2000 banknotes in circulation, which amounted to Rs 3.62 lakh crore on March 31, 2023, had declined to Rs 3.56 lakh crore as at the close of business on May 19, 2023.

RBI requested the members of the public holding the highvalue banknote to utilise the remaining period until September 30, 2023, to deposit and/or exchange them.

Festive Demand, Strong Suv Offtake Propel Domestic Passenger Vehicle Sales To Record High In August

Tata Motors, however, saw a dip in domestic passenger ve-

"The month of August was a very good month for the industry. Passenger vehicle sales in August stood at 3,60,897 units. This is the highest ever in any year in the industry," Maruti Suzuki India (MSI) Senior Executive Officer (Marketing & Sales) Shashank Srivas-

tava said. The previous highest for the industry was 3,55,400 units reported in September 2022, he

The industry wholesales last month grew by 9.7 per cent to 3.60.897 units as compared with 3,26,980 units in August 2022. Srivastava said.

In the April-August period, the industry sales crossed the 17 lakh units mark which is a growth of 8 per cent over the same period of the previous

fiscal, he added. Srivastava noted that the SUV

segment continued to perform well and accounted for 48.6 per cent of the overall passenger vehicle industry in August.

The SUV contribution to the domestic passenger vehicle industry stood at 43 per cent in

The festive season which started with Onam in Kerala has led to a very positive retail growth of 25 per cent in Kerala, Srivastava said.

MSI reported its highestever monthly wholesales at 1,89,082 units in August on the back of robust sales in the SUV segment. The country's largest carmaker became the leading player in the domestic SUV segment in the April-August period on the back of models ike Grand Vitara, Brezza and

Jimny. The auto major's overall dispatches to dealers last month were 14 per cent higher as compared to 1,65,173 units in August 2022. The company previously reported its record monthly sales of 1,82,448 units in October 2020.

GST Collection Rises 11% To Rs 1.59 Lakh Cr In Aug On Improved **Compliance, Lower Evasion**

NEW DELHI: GST collections grew by 11 per cent to over Rs 1.59 lakh crore in August on the back of improved compliance and reduced evasion, with experts forecasting higher mop-up to continue in the upcoming festive season.

The gross GST revenue collected in August 2023 is Rs 1,59,069 crore of which Central GST is Rs 28,328 crore, State GST is Rs 35,794 crore, Integrated GST is Rs 83,251 crore (including Rs 43,550 crore collected on import of goods) and cess is Rs 11,695 crore (including Rs 1,016 crore collected on import of goods).

"The revenues for the month of August 2023 are 11 per cent higher than the GST revenues in the same month last year. During the month, revenue from import of goods was 3 per cent higher and the revenues from domestic transactions (including import of services) are 14 per cent higher than the revenues from these sources during the same month last year," the Finance Ministry said in a state-

The Goods and Services Tax (GST) collection was over Rs 1.43 lakh crore in August

Revenue Secretary Sanjay Malhotra said GST collections have grown more than the nominal GDP growth rate in the April-June quarter despite no increase in tax rates.

"This is because of better compliance and improved tax collection efficiency," Malhotra said, adding tax evasion and avoidance too have been

After Domestic LPG Price Reduction, Commercial LPG Prices Cut By ₹158

NEW DELHI: In a major relief to LPG consumers, Public sector Oil Marketing Companies (OMCs) have slashed the price of 19 KG commercial LPG gas the sources.

The new prices will be effective from today and Delhi's retail sales price of 19kg commercial LPG cylinder will be ₹1,522.

Earlier, on the eve of Raksha Bandhan, the price of Domestic LPG was reduced by ₹200 by the central government as a gift to women of the country.

Monthly revisions for both commercial and domestic LPG (liquefied petroleum gas) cylinders occur on the first day of each month, with the new rates becoming effective from September 1. Earlier in August, the prices of commercial LPG cylinders were slashed by ₹99.75 by the OMCs.



In July, the prices of commercial LPG gas cylinders were increased by ₹7 each. Before this hike, there had

been two consecutive price cuts for commercial LPG cylinders which were in May and June this year. While in May OMCs reduced the price of a commercial LPG cylinder by ₹172, in June it was reduced by ₹83.

In April, too, their prices were reduced by ₹91.50 per unit.

Petroleum and oil marketing companies had on March 1 this year hiked the prices of commercial LPG cylinders by ₹350.50 per unit and domestic LPG cylinders by ₹50 per unit.

Air India Onboarded 650 Pilots Since April This Year: CEO

MUMBAI: Air India group airlines have recruited and onboarded as many as 650 pilots since April this year, according to Air India CEO Campbell Wilson.

Besides, Air India's widebody Boeing 777 fleet will have two more B777s by the first week of this month, with one of them already added to the fleet, which will help the airline enhance services to the US and upgauge capacity, he said.

Air India group comprises full service Air India and its two wholly-owned subsidiaries -- Air India Express and AIX Connect (erstwhile AirAsia India).

Last year. Air India announced its plans to induct on lease 11 B777s -- six B777-300ER and five B777-200-LR, primarily to operate its flights on North American routes.

He also said that two of the three long-grounded Boeing 787s have also returned to service.

Significantly all this comes amid the aviation safety regulator DGCA temporarily suspending all training at Air India's Mumbai and Hyderabad facilities after it found certain "lapses" during a

spot check. The Mumbai facility imparts training to Boeing fleet pilots and the Hyderabad facility is used for training of operating the narrowbody Airbus A320 family fleet.

'The Group Hiring Cell (GHC) has successfully recruited and onboarded more than 650 pilots since April 1," Wilson said in his weekly message to Air India employees.

GHC is the airline's first integrated, cross-AOC (air operator certificate) and cross-functional teams.

Executives from the three airlines came together to recruit pilots en masse, he said, adding that recruitment is (still) going on.

Moreover, "the first week of September and this week saw the addition of not one but two new Boeing 777 aircraft to our fleet -- the fifth and sixth of the year so far," Campbell said.

Of these two, one is 777-200LR which will be deployed on North American routes, allowing Air India to upgrade more San Francisco and New York frequencies with a premium economy class as well, according to him.

The Central Board of Direct Taxes (CBDT), which is the apex decision-making body in direct taxes, also signed 32 Bilateral Advance Pricing Agreements (BAPAs) in 2022-23 being the maximum number of BAPAs in any financial year till date. The BAPAs were signed as a consequence of entering

into mutual agreements with India's treaty partners--Finland, the UK, the US, Denmark, Singapore, and Japan. Bilateral APAs help reduce the transfer pricing disputes that arise in respect of international transactions between related companies located in the two countries.

MUMBAI: Equity benchmark Sensex on Friday rallied around 556 points, logging its best single day in two months, while Nifty closed above the 19,400 level on value-buying in power, metal and oil stocks following strong domestic macro data and global cues.

The BSE barometer closed higher by 555.75 points or 0.86 per cent at 65,387.16 with 26 of its constituents ending in the green.

The index opened higher and later touched a high of 19,435.30 in day trading. It touched a low of 64,818.37. The broader Nifty spurted

by 181.50 points or 0.94 per cent to close at 19,435.30. As many as 44 Nifty stocks advanced while six declined.

NTPC was the lead gainer among Sensex stocks, rising by 4.84 per cent.

JSW Steel (3.37 per cent),

Maruti (3.24 per cent), Power Grid (3.07 per cent), IndusInd Bank (2.95 per cent), Bajaj Finance (2.12 per cent) and Tech Mahindra (2.22 per cent) were among major gainers. On the other hand, Ultratech

Cement, Sun Pharma, Nestle and L&T were the losers. Vinod Nair, Head of Re-

search at Geojit Financial Services said. "Domestic markets made significant gains, buoyed by favourable global cues, a higher-than-expected domestic manufacturing PMI, and positive GDP growth data."

This robust economic outlook propelled key manufacturing sectors to lead the rally, while strong sales figures generated increased interest in auto stocks, Nair added.

Official data released on Thursday showed that the Indian economy grew 7.8 per cent in the June quarter, mainly on the back of doubledigit expansion in the services sector, and retained its position as the world's fastestgrowing major economy.

In Europe, Britain's FTSE 100 rose 0.5 per cent, France's CAC 40 edged up nearly 0.1 per cent while Germany's DAX was little changed. Gains in US futures supported the positive sentiment. Dow futures was up 0.3 per cent and S&P 500 futures rose 0.2 per cent. Among Asian markets, Ja-

Death toll from Johannesburg fire rises to 76 as city turns to tough job of identifying victims

Johannesburg: Search teams finished checking a derelict Johannesburg apartment building a day after one of South Africa's deadliest fires broke out there as pathologists faced the grisly task Friday of identifying charred bodies and body parts that were transported in large trucks to mortuaries across the city.

The death toll rose from Thursday's predawn blaze rose to 76 after two people died in a hospital overnight, Health Minister Joe Phaahla told reporters. At least 12 of the victims were children, authorities said.

Homeless South Africans, poor foreign migrants and others who found themselves marginalized in a city often referred to as Africa's richest but which has deep social problems inhabited the downtown building.

The number of injured people hospitalised from the fire also increased to 88, according to a provincial health official.

After conducting three searches through each of the building's five stories, emergency services personnel believed that all human remains were recovered from the site, Johannesburg Emergency

Services spokesperson Nana Radebe said.

Police and forensic investigators took over the scene for their own examinations, Radebe said.

The remains of some of the victims were taken to a mortuary in the township of Soweto, in the southwestern outskirts of South Africa's economic hub, where people began to gather as authorities called for family members to help identify the

Motalatale Modiba, a Gauteng province health department spokesperson, said 62 of the bodies were so badly burned as to make them unidentifiable and the city's pathology department faced using painstaking DNA analysis to officially identify the majority of victims.

"Even if the family were to come, there is no way of them being able to identify that body," Modiba said.

Thembalethu Mpahlaza, the CEO of Gauteng's Forensic Pathology Services, said at a Thursday evening news conference that numerous unidentified body parts were found in the remnants of the building and his investigators needed to establish if they were from people already counted as dead

or came from additional fire victims.

Many of the dead were believed to be foreign nationals and possibly in South Africa illegally, making it more difficult to identify them, city officials said.

Local media reports, quoting residents of the building, said at least 20 of the dead were from the southern African nation of Malawi. At least five were Tanzanian nationals, the Tanzanian High Commission in South Africa said.

The fire ravaged a city-owned building that had effectively been abandoned by authorities and had become home to poor people desperately seeking some form of accommodation in the rundown Johannesburg central business district. The building was believed to be home to around 200 families.

Senior city officials conceded they had been aware of problems at the building since at least 2019.

Many witnesses said in the immediate aftermath of the fire that they were separated from family members in the chaos of escaping the inferno. Some said there were children walking around alone outside the building, with no idea if their parents

or siblings had survived.

Non-governmental organizations stepped in to help survivors with temporary accommodation, while religious leaders held prayer services outside the burned-out building.

Attention in South Africa also turned to who would be held responsible for the tragedy. Emergency workers and witnesses painted a picture of a building full of shacks and other temporary structures, and where multiple families were crammed into rooms. Some people stayed in the basement parking garage.

Local government officials said that people were trapped inside the building because security gates were locked and there were no proper fire escapes. Many bodies were reportedly found on top of each other near one locked gate where they became trapped. Others jumped out windows and died in the fall, witnesses and officials said.

At the building, twisted sheets and blankets still hung like ropes out of windows a day after, showing how desperately some had tried to flee the flames and smoke.

The police have opened a criminal case, although it was

unclear who might face any charges over the deaths as no official authority ran the building. South Africa's Parliament has called for a wider investigation. South African President Cyril

South African President Cyril Ramaphosa, who visited the scene on Thursday, said the tragedy was partly caused by "criminal elements" who had taken over the building and charged people to live there.

"The lesson for us is that we've got to address this problem," Ramaphosa said.

Ramaphosa's call was repeated by many figures from national and local government, who said it was time to resolve Johannesburg's housing crisis. People living in brokendown structures known as "hijacked buildings" is common in Johannesburg

The focus on the issue only after so many people were killed angered some in the city.

"We have seen the president calling this incident tragic," said Herman Mashaba, a former mayor of Johannesburg and now the leader of an opposition political party. "What do you mean tragic? You've been aware of this. We have seen the decay of this city over 25 years. It's not something that just happened overnight." (AP)

Double murder case: SC says ex-Bihar MP Prabhunath Singh to be sentenced for life

New Delhi: The Supreme Court said on Friday it will award life sentence to former Lok Sabha MP from Bihar Prabhunath Singh for killing two people on the day of polling for assembly elections in Bihar's Saran district in 1995.

"Life sentence, 10 lakhs each for both the deceased and five lakhs for the injured, both by the respondent two (Singh) and by the state separately," a bench headed by Justice Sanjay Kishan Kaul said orally in the court while hearing arguments on the quantum of sentence to be awarded to Singh, adding, "We have already announced that, the orders you will get".

However, the order uploaded later in the day by the apex court said, "Arguments concluded. Iudgment/order reserved".

The bench, also comprising Justices A S Oka and Vikram Nath had said, before the judgement was uploaded, that Singh

and the state of Bihar will have to pay Rs 10 lakh compensation each, separately, to the families of the two deceased, and Rs 5 lakh to an injured victim in the

"Never seen a case like this before," the bench observed without elaborating.

On August 18, the apex court had convicted Singh while overturning the orders of the trial court and the Patna High Court acquitting him in the case.

On Friday, the matter was fixed for hearing arguments on the quantum of sentence to be awarded to the convict.

At the outset, the hearch ob-

At the outset, the bench observed, "There are two options only, there is no third option available. Life (sentence) or death, these are the only two options".

The counsel representing Singh said it is not a case where the court may consider granting death sentence.

"Do you seriously feel that we



are considering death penalty?" the bench asked.

"Life sentence, 10 lakhs each for both the deceased and five lakhs for the injured, both by the respondent number two (Singh) and by the state separately," the bench said, adding, "We have already announced that, the

orders you will get". On the apex court's query

about Singh's age, one of the advocates said he is 70-year-old. While convicting Singh, the apex court had observed that it was dealing with a case which was an "exceptionally painful episode of our criminal justice

system".

The top court had observed there was not even an iota of doubt that Singh was instrumental in making all possible efforts to "wipe out" the evidence grainet him.

It had said the prosecution machinery, as also the presiding

officer of the trial court, were used as a tool of his "high handedness".

The top court had observed the three main stakeholders in a criminal trial -- the investigating officer, the public prosecutor and the judiciary -- have "utterly failed" to discharge the duties and responsibilities cast upon them.

The bench had convicted Singh, also a former MLA, for the murders of Daroga Rai and Rajendra Rai and for attempting to kill a woman.

It had noted that an FIR was registered on March 25, 1995 at Chapra on the statement of Rajendra Rai, who said that he along with eight-nine other villagers was returning after casting their votes when a car pulled

It was alleged that Singh, who was then contesting the assembly elections as a candidate of the Bihar People's Party, was sitting in the car and enquired as to

who they had voted for.

The FIR alleged when Rai answered that they had cast their votes in favour of another political party, Singh opened fire from his rifle and injured three people.

The offence of murder under section 302 of the Indian Penal Code (IPC) was added later as two out of the three injured, including Rajendra Rai, died during treatment.

The top court had delivered its August 18 verdict on an appeal challenging the December 2021 judgement of the Patna High Court which had dismissed a revision petition and confirmed the trial court order acquitting the accused in the case.

The apex court had not disturbed the acquittal of other accused in the case, saying their names were not reflected either in the dying declaration of Rajendra Rai or in the statement of his mother, who was a court witness.

Art-370 Abrogation

Article 370 was always considered to be a temporary provision and the speeches of Dr. BR Ambedkar, N.G. Ayyangar (in Constituent Assembly), Jawaharlal Nehru, and Gulzarilal Nanda (in Parliament) clearly indicate that complete assimilation of the State of Jammu and Kashmir at par with other States, in due course, was envisaged from the very beginning.

Therefore, Article 370 was mentioned in the Constitution of India as a temporary and transitional, he submitted.

"The framers were conscious that the constituent assembly would be dissolved after framing of the Constitution of Jammu and Kashmir, yet they did not provide that upon dissolution of J-K Constituent Assembly, the power of the President would cease or become defunct. They also did not declare Article 370 as a permanent provision," Dwivedi said.

The senior lawyer said this was done for a good reason as the power to repeal Art 370 was vested by the main part in the President of India, who is the head of the State, and is advised by the council of ministers, which is responsible to Parliament.

"The fact that the President has over the years issued several Constitution Orders and has brought about fuller assimilation of J&K and parity with the other States of India shows that the trust was rightly reposed in the President The constitutional practice shows all relevant actors understood the power of the President as continuing despite cessation of Jammu and Kashmir constituent accombly." he added

assembly," he added.
Senior advocate V Giri, appearing for intervenor 'All India Kashmiri Samaj' submitted that Article 370 of the Constitution, as is textually explicit, was intended by the framers of the Constitution as a temporary provision

"The cessation of operation of Article 370 has always been considered as dependent on a Presidential Order. Once Article 370 is abrogated, then the entirety of the constitutional provisions, including those providing for distribution of legislative power, exercise of executive authority, separation of powers among different organs of the state and provisions providing for a federal structure, would ipso facto apply," he said.

The hearing remained inconclusive and would continue on September 4.

Several petitions challenging the abrogation of the provisions of Article 370 and the

Jammu and Kashmir Reorganisation Act, 2019, which split the erstwhile state into two union territories - Jammu and Kashmir, and Ladakh - were referred to a Constitution bench in 2019.

Similarly, in 2015, 27 tremors were witnessed, including the 7.5 magnitude earthquake on October 26. In 2014, when Kashmir witnessed one of the worst floods, nineteen earthquakes hit the erstwhile state. In 2013, 2012, and 2011, the region recorded 25, 11 and 7 tremors, respectively. The year 2010 and 2009 witnessed 6 and 9 earthquakes, respectively.

J&K has witnessed at least 14 earthquakes powerful earthquakes since the year 1123. The most devastating earthquake, with its epicentre in north Kashmir's Baramulla occurred in 1885 and left 3,600 people dead.

Between 2008 and 2020, J&K has witnessed 164 earthquakes, but most of them have been of magnitude less than 5 on the Richter Scale, according to the data revealed by the National

Center for Seismology (NCS).

Most parts of Kashmir come under Seismic Zone V and are prone to earthquakes. Experts give varied reasons for earthquakes in J&K including various faults run through Kashmir and exploding of gases. Kashmir valley is vulnerable to disasters. At least 13 districts out of 100 districts in India have been identified as 'multi hazard districts'.

According to the Indian Meteorological Department, most parts of Kashmir covering the districts of Srinagar, Ganderbal, Baramulla, Kupwara, Bandipora, Budgam, Anantnag and parts of Jammu region, Doda, Ramban, Kishtwar come under Seismic Zone V and are prone to earthquakes. While the rest of the Union Territory comes under
