Properties of Pak Based Terrorists Being Seized: DGP

Jammu: The Jammu and Kashmir Police said on Tuesday that they are in the process of seizing properties of Kashmiri militants living in Pakistan.

"We have a list of terrorists who are natives of J&K and were operating in various parts of the UT but have fled to Pakistan to seek refuge there. Their properties are being confiscated and the process will continue," J&K Director General of Police Dilbagh Singh said on Wednesday after reviewing the security situation in Rajouri and Poonch districts.

"We have already prepared their data and have started a drive to attach their properties and declare them proclaimed offenders. There are people who are supporting them from this side. The cross-border relation to strengthen terrorism will be broken, squeezed and finished," the DGP said.

Referring to the declaration of 16 terrorists as proclaimed offenders with properties of some of them attached in Doda district last month, he said



similar action will be initiated against those involved in terrorism in Rajouri and Poonch as identification of such persons is

in progress.
Supporters of terrorists here will be dealt with "strictly" to thwart any fresh conspiracy from Pakistan to disturb peace in the region, he said.

He also asserted that the security grid has been strengthened and area domination ensured with massive searches.

'Warning Sounds' To Alert People In J&K About Emergency Events

DoT Soon To Launch New SMS Service To Enable Rapid Responses To Earthquakes, Flash Floods, Terrorist Attacks, Epidemics, And Law And Order Issues

Jammu: People in Jammu & Kashmir and Ladakh will soon have 'new safety messaging' with 'warning sounds' and 'auto-readout alerts' to warn them about emergency situations, an official said.

The feature is the consequence of a Cell Broadcast Alert System (CBAS), successfully conducted by the Department of Telecommunications (DoT)

"The tests have been conducted. These trials have resulted in a unique alert system that differentiates itself from the regular SMS tones... It has a separate tone, not a



normal SMS tone. The audio is high," Additional Director General (ADG) Telecom, Jammu & Kashmir, Vijay Kumar Surendra told PTI.

The high-pitched audio alerts are designed to capture

people's attention swiftly, enabling rapid responses to incidents such as earthquakes, flash floods, terrorist attacks, epidemics, and law and order

Admin Making Relentless Efforts To Bridge Health Gap: LG





HC Grants Bail To New Mother Month After Trial Courts Denial

Srinagar: The High Court of J&K and Ladakh has granted bail to a woman who delivered a baby last month but was sent back to prison in Baramulla after a trial court rejected her plea for extension of bail.

Allowing an appeal filed

by the woman, who was earlier granted interim bail on medical grounds by the trial Court, on account of her advanced stage of pregnancy of seven months, a bench of Justices Atul Sreedharan and Mohan Lal granted two months bail for the wellbe-

ing of the infant.

The woman had delivered a girl baby on August 2 and moved an application for extension of her bail, which was

declined by the trial Court and she was sent back to District Jail, Baramulla.

"The infant is just about a month old and with the onset of winter, she would be exposed to harsh conditions of low temperature in the prison," the court said, adding, "Therefore, in consideration of the infant, we allow the instant appeal and grant interface.

Job Insecurity Linked To Higher Risk Of Early Death: Study

eople without a stable job contract can reduce their risk of premature death by 20 per cent if they find permanent work, according to a study published in The Journal of Epidemiology and Community Reports by Karolinska Institutet. According to the researchers, the findings show that job security in Sweden has to improve. Precarious employment is a term that is used to describe jobs with short contracts (e.g. temping), low wages and a lack of influence and rights, all of which lead to a working life without predictability and security.

In the present study, the researchers have examined how this affects the risk of death. "This is the first study to show that changing from precarious employment to



secure employment can reduce the risk of death," says the paper's last author Theo Bodin, assistant professor at the Institute of Environmental Medicine, Karolinska Institutet. "It's the same as saying that the risk of early death is higher if one keeps working in jobs without a secure employment contract."

The researchers used registry data from over 250,000 workers in

Sweden between the ages of 20 and 55 gathered over a period from 2005 to 2017. The study included people who worked under insecure working conditions and who then shifted to secure working conditions. Those who switched from precarious to secure employment had a 20 per cent lower risk of death, regardless of what happened afterwards, compared to those who remained

in precarious employment. If they remained in secure employment for 12 years, the risk of death decreased by 30 per cent.

"Using this large population database allowed us to take account of many factors that could influence mortality, such as age, other diseases that workers can suffer from or life changes like divorce," explains Nuria Matilla-Santander, assistant professor at the same institute and the study's first author.

"Because of the methods we used, we can be relatively certain that the difference in mortality is due to the precariousness of employment rather than individual factors." She continues: "The results are important since they show that the elevated mortality rate observed in workers can be avoided. If we reduce precariousness in the labour market, we can avoid premature deaths in Sweden."



Unnecessary Referrals From SDH's Overburdens Tertiary-Care Hospitals In Srinagar

Srinagar: Unnecessary referrals of patients from districts continue to put a burden on men and machinery at the tertiary-care hospitals.

Doctors posted at the major tertiary-care hospitals in Srinagar said the unnecessary referrals of patients from sub-district and district hospitals are a matter of concern.

We receive dozens of patients

on a daily basis who can be managed at sub-district and district hospitals easily but are being referred here," said a doctor at SMHS Hospital here. He said there is a difference in

facilities available at district hospitals and tertiary-care hospitals but most of the time around 30 to 50 percent of patients are being referred unnecessarily.

Doctors at LD Hospital said,

"Though the hospital is the valley's largest tertiary-care Gynecology and Obstetrics facility, that doesn't mean you have to refer every case here to put pressure on limited resources.

They said that despite government orders to avoid unnecessary referrals, they continue to receive 20 to 40 referral cases per day and among them, only 50 percent are genuine while the rest are uncertain and can be easily managed at primary health centres, sub-district and district hospitals.

"Besides unnecessary referrals, pregnant ladies come here for check-ups from far-off places. They could easily visit peripheral hospitals for check-ups in their districts," they said, adding, this puts pressure on infrastructure as well as manpower and often delays

treatment to the patients in need. So far, the government has

They said the government has already improved the infrastructure status of peripheral hospitals and the need is for further improvement so that the doctors won't give any excuse and unnecessary referrals can be avoided.

The government had ordered an audit of all referrals from district-level hospitals to tertiarycare hospitals in order to optimize the manpower available in peripheries and patient services across the healthcare system.

'There must be monitoring committees in place in all hospitals which must have the power to take the call whether to refer the patient or not, otherwise this issue won't get resolved," the doctors said.

Valley Wide Alert As Experts Trace Adulterated Oil

rinagar- Officials of Food and Supplies Department and Srinagar Municipality in joint raids today seized tins of adulterated edible oil, capable of causing dreaded dropsy. Alert has been sounded and people warned not to use contaminated brands.

The joint teams today and yesterday fanned out in different directions of capital Srinagar and raided various godowns and retail outlets of edible oil, leading to the seizure of 7800 tins of P. Mark and over 100 cannisters of Hira Brand mustard oil. Sampling, followed by analysis on war footing of the

seized' edible oil tins was done by assistant public analyst from State's Drug and Food Control organisation. The assistant public analyst, Mushtag Ahmed Khateeb confirmed adulteration in Hira brand, packed under seal number 200- 201/PFAK, Dated 4-9-1998. P. Mark Bahadurgarh Haryana Brand was also

found adulterated, as per the officials, who warned the general public this evening not to use the two contaminated brands. The analysis of other brands seized by the teams is underway and reports are expected by Sunday.

Out of 225 samples analysed in the laboratory till now, reports of only 140 were received by this evening. While 139 samples tested negative, one tested positive. That was the sample taken from Hira brand, manufactured and marketed by M/S Grower Oil Mills, Private Limited, Bari Brahamana, Jammu.

The raids were conducted by the teams at Court Road, Sarai Bala, Tankipora, Hazuribagh and other parts of the city. More teams will conduct raids tomorrow to trace out adulterated oil.

Eight tins of adulterated Hint brand were seized from a dealer at Court Road. Reports revealed that the said dealer has sold off hundreds of tins of

Hira brand to retailers all across Kashmir. Messages have been flashed to different districts to trace out the adulterated brands.

Two edible oil factories -situated at Zainakote, have also been raided and samples taken for analysis. The two factories, reports said, import oil from Jammu in huge tankers. "The factories will be sealed if the samples test positive," a top official in Srinagar Municipality said on condition of anonymity.

With detection of contaminated edible oil, panic has

gripped the people in the Valley as thousands of them have been continuing their food preparations on these brands - now declared adulterated According to an eminent epidemiologist there is every chance of dropsy disease invading the state now.

IndiGo Notifies Passengers About Flight Cancellations Due To G20 Summit

NEW DELHI: IndiGo today said passengers have been notified about flight cancellations at the Delhi airport in connection with G20 Summit.

"Due to the G20 Summit 2023 taking place in New Delhi, IndiGo is offering one-time waivers for passengers travelling to and from Delhi between September 8 to 11, 2023," the airline said in a statement.

It did not provide details about the number of flights that are likely to be affected.

G20 Summit will be held in the national capital on September 9 and 10.

"Customers are being offered the option of rescheduling or cancelling their flights with refunds. Passengers have been notified about flight cancellations and to schedule changes in advance," the statement said. Scores of flights are likely to be affected at the Delhi airport and airlines are offering waiver of charges for customers planning to reschedule their travel

On Tuesday, officials in the know said airlines are making adjustments to their flight operations and select flights are being cancelled or rescheduled. One of the officials said that around 120 flights are likely to be impacted during the September 8-10 period.

The Indira Gandhi International Airport (IGIA), operated by DIAL, in the national capital is the country's largest airport and handles around 1,300 flights daily.

On August 26, DIAL said it had received requests from airlines for cancellation of 80 departing and as many arriving domestic flights during three days from September 8.

Jamia Millia Teacher Suspended For Collecting Funds For Turkey Earthquake

NEW DELHI: Jamia Millia Islamia (JMI) has suspended Middle School Physical Education teacher, Haris ul Haq, for his alleged association in fundraising from the students of the school for the earthquake-affected people of Turkey, a press release from the university's Public Relations Office said on Tuesday.

The fundraising was done without approval or prior permission of the competent authority in violation of the Central Civil Services (Conduct) Rules, it stated.

A police complaint dated July 31 was filed against Haris ul Haq by the university at Jamia Nagar Police Station for cheating, criminal breach of trust and criminal misappropriation. In the complaint, it was alleged that Haris ul Haq siphoned off ₹1.40 lakh in the garb of collecting money by misrepre-

senting for affected people of Turkey Earthquake.

It was also alleged that the money was collected by deceiving the students under a false pretext and the entire money had been siphoned off for personal gains.

The matter was placed before the Executive Council (EC) of the university in its meeting held on August 4. The EC vide resolution number 11 has resolved that disciplinary action may be initiated against Haris ul Haq as per rules, the release stated.

The EC also asked the University to take appropriate action for recovery of money or funds and pursue criminal complaint as per provisions of law.

It is also stated that there have been several complaints of misbehaviour, negligent attitude towards duty and insubordination against Haris ul Haq. He was earlier suspended in 2010 for misconduct, the press release stated.

Hottest September Since 1938 Awaits G20 Leaders in Delhi

NEW DELHI: Global leaders including US President Joe Biden are set to be greeted by stifling heat when they meet in New Delhi this week for the Group of 20 Summit, where climate change is set to be among key issues on the agenda.

Prime Minister Narendra Modi has sought to make progress on global issues such as climate change, and recent scorching heat in the nation's capital may help to highlight the plight of extreme weather to world leaders. On Monday, Delhi recorded a maximum temperature of 40.1 degrees Celsius(104F), the hottest

September day in 85 years, according to the country's weather bureau.

Extreme weather has swept across the globe this year, from flash flooding to wild-fires that have killed people, buckled power grids and damaged roads and homes. The world recorded its hottest June ever for land and sea, with ocean temperatures setting new highs for a third month in a row.

Almost 30 world leaders including Chinese Premier Li Qiang, UK Prime Minister Rishi Sunak and Crown Prince Mohammed bin Salman from Saudi Arabia - a heavyweight of the OPEC+ oil producing group - will gather in India's capital

this week for the G-20 meet.
Other parts of India are also seeing a rise in the mercury -

higher than usual for this time of the year - boosting demand for electricity from house-holds, farmers and industries. Temperatures normally peak in May and gradually fall with rolling monsoon, but the driest August in more than a century pushed average maximum temperatures for the month to the highest since 1901.

There is a hint of immediate respite for Delhi. Some parts of the city may get isolated rains in the coming days, followed by another dry patch for five days through Sept. 11, according to the India Meteorological Department.

"If China Wants To Be A Spoiler...": US Ahead Of G20 Summit

WASHINGTON: It is for China to decide what role it plays at the G20 Summit in New Delhi, a top US official has said, asserting that if Beijing wants to come in and be a "spoiler", that option is available to it.

US National Security Advisor Sullivan was responding to a question at a White House news conference on Tuesday on the impact of India-China border tensions on the G20 Summit.

"As far as the question of tensions between India and China affecting the (G20) summit - really that's up to China. If China wants to come in and play the role of spoiler, of course, that option is available to them," he said.

"What I think the Chair, India, will encourage them to do what we, the United States and every other member, virtually every other member of the G20 will do, is encourage them to come in, in a constructive way on climate, on multilateral development, bank reform, on debt relief, on technology and set aside the geopolitical questions and really focus on problem-

solving and delivering for the developing countries," Mr Sullivan said.

Chinese President Xi Jinping will not attend the G20 Summit in New Delhi this week and the delegation will be led by Premier Li Qiang, China's foreign ministry announced on Monday as it expressed Beijing's readiness to work with all parties to make the high-profile meeting a success.

At the invitation of the Government of India, Premier of the State Council Li will attend the 18th G20 Summit to be held in New Delhi, India on September 9 and 10, Chinese Foreign Ministry Spokesperson Mao Ning said in a brief statement.

India is hosting the annual G20 Summit in New Delhi on September 9 and 10.

At the G-20 Summit, Mr Sullivan said President Joe Biden will be clear that the United States expects real progress.

"He will be clear that we need all G20 members to be constructive and at the table, with no exceptions. We'll also be making progress on other key priorities, from climate to health to digital technology, including commitments, with respect to a more inclusive digital transformation and a responsible path and approach to AI development," he noted.

"In addition, we'll spotlight the progress that we've been making on the Partnership for Global Infrastructure Investment, or what we call PGI. We'll have some announcements that we're excited about. Now, we know that there will be continued focus on how the G20 deals with Russia's illegal and ongoing war in Ukraine," he said.

Mr Sullivan said the reality is that Russia's illegal war has devastated social and economic consequences, and the poorest countries on the planet are bearing the brunt of it.

As he has done before, President Biden will call for a just and durable peace founded in respect for international law, principles of the UN Charter, the precepts of territorial integrity and sovereignty," he

Mr Sullivan said Biden will continue to emphasise that the United States will support Ukraine for as long as it takes to redeem these principles.



PM Modi Spells Out Dos And Don'ts For Ministers During G20 Summit

NEW DELHI: Ahead of the G20 Summit, Prime Minister Narendra Modi today spelt out a set of dos and don'ts to be observed by ministers during the two-day event to ensure that the visiting dignitaries are not put to any inconvenience, sources said.

The ministers have been asked to ditch their official vehicles and use the shuttle service to reach the Bharat Mandapam and other venues of various meetings.

At a meeting of the Union Council of Ministers, the Prime Minister also asked them to download the G20 India mobile app and make best use of its translation and other features while conversing with foreign dignitaries, officials told Press Trust of India.

The G20 mobile app has an instant translation feature in-

corporating all Indian languages and that of G20 nations.

With nearly 40 world leaders, including those from international organisations, set to attend the summit on September 9-10, Foreign Secretary Vinay Mohan Kwatra briefed the ministers in detail about the protocol and related matters.

Some of the ministers are expected to be ministers in waiting for the world leaders who have started arriving for the summit

Supreme Court Rejects Petition Seeking Steps To Stop Religious Conversions

NEW DELHI: The Supreme Court today refused to entertain a petition seeking a direction to the Centre to take steps to curb fraudulent religious conversions in the country.

"Why should the court enter into this thicket? How can the court issue a writ of mandamus to the government," said a bench comprising Chief Justice DY Chandrachud and justices JB Pardiwala and Manoj Misra.

The lawyer, appearing for Karnataka-based PIL petitioner Jerome Anto, said Hindus

and minors are being targeted and they are being converted "fraudulently".

"If there is a live challenge and someone is prosecuted then we can entertain," the bench said while dismissing the petition.

"What kind of PIL is this? PIL has become a tool and everyone is coming up with petitions like these," it said.

On being argued where the petitioner should go with this kind of grievance, the bench said, "We are not in advisory jurisdiction. (The plea is) Dismissed".

Hugely Proud Of My Indian Roots: British PM Rishi Sunak

NEW DELHI: What does the British Prime Minister discuss at the dinner table with his Indian parents-in-law? Is it Indian politics or the challenges of running Britain? Neither. It's cricket.

"The most political we tend to get is in our discussion of cricket. I've agreed that my daughters can support India when it comes to cricket, as long as they support England when it comes to football!," Prime Minister Rishi Sunak told Press Trust of India.

Rishi Sunak's parents, both of Indian origin, came to the UK from east Africa. His wife Akshata Murty is the daughter of India's billionaire tech czar Narayana Murthy and philanthropist and educator Sudha Murty.

In an interview via email days ahead of his visit to New Delhi to attend the G20 summit on September 9 and 10, Rishi Sunak said today the response from the Indian people to his appointment as the prime minister was

ment as the prime minister was "overwhelming and humbling." "I am hugely proud of my In-



dian roots and my connections to India. As you know, my wife is Indian and being a proud Hindu means I will always have a connection to India and the people of India." he said.

The 43-year-old leader of the Conservative Party was first elected as an MP in 2015. He was made finance minister or chancellor of exchequer in February 2020 by then Prime Minister Boris Johnson.

In October last year, he became the first Indian-origin British prime minister, scripting history.

"One of the first things I did after becoming Prime Minister was to hold a reception for Diwali in Downing Street. Having the opportunity to welcome many British Indians into Number 10 and seeing the building decorated

from top to bottom with lights and flowers was an incredibly proud and emotional moment for me," Rishi Sunak said.

"Because my story is the story of so many people in Britain with deep and enduring links to India. The strength of our country lies in its diversity, and that's something I have seen first-hand many times since becoming Prime Minister," he said.

Asked whether he discusses Indian politics, technology or problems he faces in running Great Britain when he sits with his in-laws, Rishi Sunak said it is important to keep politics separate from family.

"It's very important to keep politics separate from family, but of course my wife and two daughters very much guide my values, as do my parents and parents-in-law." "I am, though, incredibly proud of my parents-in-law and what they have achieved -- going from nothing to building one of the world's largest and most respected companies, which employs thousands of people in both India and in the UK," he said.

Bandipora To Have Multi-Storey Car Parking Soon

SRINAGAR: The Bandipora administration has approved a three-storey parking project to combat the growing traffic congestion in the north Kashmir district.

As per the details, Rs 5 crore project was approved following extensive consultations with various stakeholders. Joint Director Planning, Bandipora, Imtiyaz

Ahmad said the facility will play a vital role in alleviating town road congestion; it can accommodate 147 vehicles across multiple levels. This project will offer much-needed relief

to residents and visitors grappling with limited parking options in the district, Imtiyaz The construction of the parking facility

will take place in two phases, he said: "The initial phase involves three storeys, and the subsequent phase will add a fourth which will further increase parking capacity.'

The Joint Director said the ground floor will house 38 vehicles, the first floor 39 vehicles, the second floor 35 vehicles, and the third floor 35 vehicles, which will offer a comprehensive solution to parking challenges faced by the community.

The news of the parking project has evoked an overwhelming response from locals who expressed their support for the initiative. They highlighted the potential impact it will have on mitigating the growing traffic congestion in the town.

Mudasir Ahmad, an advocate, said the parking project is a much-needed step which will not only ease traffic congestion but also stimulate business activity in the area.

Imtiyaz Ahmad, a local, said Bandipora has witnessed a rapid increase in vehicles, making parking a nightmare. "The parking facility will regulate the overall traffic situation in the town," he said—(KNO)

Battling The Drug Epidemic

he sentencing of two drug peddlers, Syed Ishfaq Shah and Khursheed Ahmad Gojar, by a Srinagar court to 20 years in prison for their involvement in drug possession should serve as a warning to narcotics traders in the Valley. The verdict, although seemingly harsh, carries a vital message - the menace of drugs, particularly among our youth, is an issue of overriding concern that demands immediate attention.

As it has turned out, Police had recovered 15 packets, each weighing one kilogram, filled with brown sugar from Shah and Gojar in 2019. So, in delivering the verdict, Judge Khemraj Sharma did more than just pass judgment: he also drew attention to the surging drug problem that plagues our society. "The menace of drugs is on the rise these days, and the main sufferers of this menace are the younger generation of our society," he rightly observed. He pointed out that the consequences of this menace extend beyond individual lives and families, warranting what he said, "an iron hand," against the people involved in the drug trade. Echoing the sentiment, the Additional Public Prosecutor, Dar Rashid, stressed that securing such convictions was important to prevent the menace from spreading further.

While the conviction of Shah and Gojar is a good beginning, the battle against drug addiction is far from over. It calls on all of us to unite in our efforts to protect the future of our society, our youth, from the clutches of this destructive menace. There should be zero tolerance for those who threaten the well-being of our youth with the scourge of drugs.

As is now well-known, the recent years have witnessed lakhs of our youth taking to drugs. So much so, that the Director General of Police Dilbagh was recently forced to say that drug addiction is now a bigger challenge than even militancy. According to data from India's Ministry of Social Justice and Empowerment, around 8 percent of the population, roughly 10 lakh residents, are drug addicts. The drugs being used include heroin, cannabis, opioids, and sedatives. This alarming situation calls for urgent attention and solution.

No doubt, law enforcement agencies have taken significant steps to address the crisis. Over the course of 2022, nearly 1,700 alleged drug peddlers were apprehended in Kashmir, with 1,021 cases registered under the Narcotic Drugs and Psychotropic Substances Act. Despite these efforts, the impact on the ground remains limited, as youth continue to resort to psychotropic substances, barbiturates, and sleeping pills. But we can't afford to give up. Otherwise, nothing can stop Kashmir from becoming the new Punjab.

Step In Time

he third time was good, but not lucky enough. In its third meeting in Mumbai, the Indian National Democratic Inclusive Alliance defined its priorities. All 28 Opposition parties in the alliance agreed that seat shares should be settled as early as possible in the run-up to the 2024 Lok Sabha elections, partly because the elections may be brought forward. Besides, experience suggests that this is often the most problematic issue in alliances, and an all-India plan would mean working out the nitty-gritty in every state, most of them with different regional parties. This should precede the planned joint campaigning and public rallies. Coordination committees have been formed to conduct these matters and a target date has been set in October to complete the seat-sharing agreements. But actual schedules remain vague. Mamata Banerjee's strong objection to Nitish Kumar as convenor of INDIA has delayed that matter too. So it is still too early to discern the alliance's campaign strategy.

A clear action plan would let the people know what IN-DIA has to offer. Rahul Gandhi expressed this need, but the initial agreements must be firmed up before that. Meanwhile, many leaders recommended that the government be confronted punctually on every issue. Facts stated clearly each time would create a perception of a powerful Opposition among the people while laying bare matters that the government would like to conceal or evade. China's movements, the mysterious importance of Gautam Adani and all other subjects ranging from Manipur to unemployment and the price rise would fuel these confrontations. Even the idea of 'one nation, one election' floated recently by the government was questioned as a possible build-up to a comprehensive assault on the federal system. If INDIA's progress seems slow, it could have much to do with its size and diversity – which is also its greatest strength. That 28 parties are determined to move together in spite of differences indicates their shared concern at the destruction of democracy, of the social fabric, of prosperity and peace being wrought by the present regime. That concern is the glue.

A First-Hand Look at Arba'een, the World's Largest Annual Pilgrimage

Arba'een, the immense annual gathering in Karbala, Iraq, got my attention after I article, "World's Biggest Pilgrimage Now Underway, and Why You've Never Heard of It!" After researching it, I knew Arba'een was something that I must experience

As the founder and president of Peace Worldwide Organization, I could not get the idea off my mind. In the US, we cannot have a concert with a few thousand attendees without some trouble. How in the world was it possible for millions of people to get together so lovingly and peacefully?

Finally, I took the journey. My experience with Arba'een opened my eyes to many possibilities to achieve global peace. I had never encountered such hospitality, love and generosity in my life. Although it was held in Iraq under the threat of terrorism. I spotted pilgrims from across the world eagerly participating. I was touched by the display of faith in humanity, the likes of which I had never seen anywhere else.

A multicultural gathering

Although it was originally initiated by Shi'a Muslims as a spiritual reawakening, I witnessed that Arba'een brought people together from all walks of life. It was a true representation of all people in the world. The participants included not just Shi'as but Sunnis, Ibadis, Christians, Jews, Hindus, Yazidis and Zoroastrians. There, we were all united in purpose and welcomed with the utmost respect, regardless of religion, culture, ethnicity, gender

Four years earlier, I had participated in the annual Islamic Hajj pilgrimage. In Karbala, I noticed the much greater crowds; Arba'een attracts five or more times more people than the Hajj. In contrast to the Hajj, which is riddled with accidents and troubles, my experience with the Arba'een event was peaceful. While the Hajj consists exclusively of Muslims, Arba'een breaks across identity barriers. Arba'een is truly unique.

As I had read, it was embellished with the longest continuous free dining table with a variety of foods and personal

sleep accommodations. Iraqis

were stationed throughout

the path of pilgrims to wash feet and massage feet, backs, shoulders and necks. Clinics and doctors were available to treat pilgrims. All amenities, down to baby diapers, were furnished free All services, including the tight security, were provided by volunteers. None of these were paid for by any government or corporation. They were all offered by Iraqis and others who had been saving for a year to serve pilgrims with pure love and compassion. They expected no pay; rather, they felt honored when we accepted their offerings or lodging.

On my journey, I was told that among the servers were the Iraqi Prime Minister Adil Abdul-Mahdi and the Chinese Ambassador along with his wife. I wondered why US officials were absent, especially when the US was generally unpopular in the region and had the largest embassy and military presence in the country. It would have been a great PR opportunity.

Arba'een rarely makes headlines, but when it does, it gives hope to humanity that universal peace is realizable.

Arba'een memorializes the end of the 40-day mourning period for the brutal 7thcentury killing of al-Husayn (Husayn), the Prophet Muhammad's grandson and third Shia Imam. His murder at the hands of the wicked Umayyad Caliph Yazid made him a martyr standing up against injustice. The event left an indelible mark on Islamic history. As Modarresi says, Husayn's "legend encourages, inspires, and champions change for the better, and no amount of media blackout can extinguish its light."

For me, Arba'een was a life-changing experience

Starting in 2014, ISIS freely roamed much of Iraq and committed atrocities that shocked the world. Armed with weapons and vehicles of Western manufacture, ISIS tortured suspects, raped women and girls, robbed, enslaved, used child soldiers and carried out genocide.

I read Modarresi's article in 2015 and learned that millions of people from all over the world ignored ISIS to attend Arba'een. ISIS, which takes an extreme anti-Shi'a stance, attempted to menace pilgrims into skipping Arba'een. The threat encouraged even more participation in defiance, a courageous audacity rarely seen anywhere around the world.

To the pilgrims, Husayn typifies the man who is spiritually connected to Allah, the Source of all things, which enables him to stand firmly against despotism and never to oppression or persecution Husayn did so even though it cost him his own life and those of his brothers, sons and other loved ones.

To me, Arba'een appeared to be a truer representation of cross-cultural participation and cohesiveness than even the United Nations. Like other political entities, the UN is riddled with favoritism and corruption. Unlike in the UN, all people are treated with equal respect in Arba'een.

For days, nights, weeks and months, I was preoccupied. Something deep inside me urged me to participate. I wanted to be a part of it. I needed to see it for myself and experience the event known to millions. I felt a strong zeal to take the journey, despite the imminent threat of ISIS against the pilgrims. I became excited and eager knowing there was a purpose.

With ISIS controlling much of Iraq, my family was adamantly against me traveling in the Middle East, especially within Iraq. I was compelled to delay my journey.

Thanks to Qassem Soleimani, Iran's late top general, things have since changed for the better in the region. In mid-2018, Iraq gathered strength with assistance from Iran and Russia to push ISIS out of Iraq. On the ground with Russian air support, Iraqi special forces led by Soleimani and Iraqi militia commander Abu Mahdi al-Muhandis soundly defeated ISIS. That brave action gave me an opportunity to convince my family to let me participate in Arba'een. I assured them that I would be careful traveling there. Knowing how badly I wanted to go there, they reluctantly agreed.

In 2018, Arba'een was at the end of October. I was astonished. The journey exceeded all my expectations; every moment was breathtaking. I stayed in Iraq for 12 days, and it cost me not even a dime for food. My lodging would also have been totally free, but I chose to stay a few nights in nice hotels to reflect. The hotels were around \$20 a night.

Step by step, side by side, I marched all 50 miles of the way on foot over three days, alongside millions of other pilgrims. The journey began at the mausoleum of Ali in the holy city of Najaf and terminated at Husayn's mausoleum in the holy city of Karbala.

As I looked over my shoulder, I saw children in the arms of their mothers and young men assisting the women and elderly in their quest to make the journey I saw folks with canes and crutches taking each intentional step forward. I found the weakened, aged or disabled rolling in wheelchairs as persistent and committed as those of us on foot beside them. There were no divides or differences. There, we were all one.

There was only hope in their eyes and love in their heart as the people moved beside me. Often, I would find myself interrupted in thought, taking in each individual, making individual picture frame memories of their faces, with the various Iraqi citizens lining the trail motioning to give us water and food or guiding us along the path. I could feel the energy pulsating throughout my body, my mind, my soulthe frequency around me was vibrating, unconditional, pure, wholehearted love.

It was with this powerful frequency that I then took each individual step. All of this beautiful, loving energy made what could otherwise be characterized as a marathon feel like a walk in the park. I had very little on me except for a backpack of clothes, yet I felt fully abundant.

I had never seen generosity to that extent in my whole life. Various kinds of food and comfortable lodging were freely available along the path everywhere. I was astonished to see that even the poorest Iraqis traveled on foot for days to get there, simply to offer the pilgrims dates here and there.

Heaven on Earth

I thought to myself: If Iraqis could continue that spirit for the rest of the year by treating one another with the same compassion and love, Iraq would once again be the Garden of Eden (Genesis 2:8), a place of happiness and peace. Imagine what the world could be if we existed in this nature

The instantaneous coming together of millions of people from across the world in Arba'een must be of Heavenly inspiration. It is equally magical how Iraqis work together providing the pilgrims safety and

security along with free food, lodging and other services. As Oregon's Southminster Presbyterian Church Pastor John Shuck described it, "... it is a divine interplay of an unchoreographed dance of love

In my journey, I learned that millions of the pilgrims began their journey on foot from Iran, Kuwait, Syria and Lebanon, along with cities in Iraq and the Gulf Arab States, towards Karbala. For days, young and old traveled miles through mountainous and rocky trails in the burning sun of the day and the freezing cold of the night to reach the holy city. Regardless of where they came from, they all simply wanted to connect to Allah and live in harmony and peace. To accomplish these noble goals, they knew that a level of unrelenting selfwill, accountability, good nature, kindness and endurance was required to win over oppression and persecution.

Husayn gave us many examples of courage in his stand against tyranny and injustice. Many of his quotes can be heard across the world, even if few are aware of the source of them. Over 1300 years ago, before he was viciously murdered, he said, "Death with dignity is better than a life in humiliation."

More than ever, I am now convinced that we can all learn a lot from religion in pursuit of harmony and peace. Religion is not inherently good or bad. It can be used as a positive force or abused for personal gain. The event of Arba'een symbolizes a religious occasion that annually brings the largest number of people from across the world together in the hope of promoting compassion, love, harmony and peace.

My journey was exceptional. My life's dream of unity and peace was realized in my travels. I watched people who were amazingly liberated from fear, judgment and the desire for control and power. I saw them all sharing their basic needs with strangers. I learned that the vision of the coming together of people from all walks of life united for the pursuit of compassion, love and peace ALREADY exists. Now, I can imagine an entire world through this vision, where I paint a picture in my mind as I lead the Peace Worldwide Organization and write about history, philosophy, politics, religion and spirituality.

Breast Milk Compounds Found To Enhance Children's Cognition In Long-Term

hildren's cognition enhanced when fed with infant formula, externally mixed with compounds known to be present exclusively in milk produced by lactating women, researchers have found.

The study added to the growing scientific support for the importance of ingredients found in breast milk in early human development, the researchers from the University of Kansas, US, said.

These compounds, milk fat globule membrane (MFGM) and lactoferrin, were added to infants formula and fed to children for 12 months.

The children's IQ raised by 5 points at 5 and a half years of age, the researchers said in their study published in the Journal of Pediatrics.


The effects were most evident in tests of children's speed of processing information and visual-spatial skills, they said.

Significant differences were also seen in children's performance on tests of executive function, which are complex skills involving rule learning and inhibition, they said.

"This is consistent with the idea that early exposure to these nutritional components contribute to the long-term structure and function of the brain," said John Colombo, the study's corresponding author.

Breast milk is widely acknowledged as the most beneficial nutrition for infants, but many families face medical or logistical challenges in breastfeeding.

"No one thought much about this membrane," Colombo said, "until chemical analyses showed that it's remarkably complex and full of components that potentially contribute to health and brain development." "The global nutrition research community has been looking at MFGM for about a decade," Colombo said.

"Because the membrane is made up of several different components, it isn't known whether one of the components is responsible for these benefits, or whether the entire package of nutrients act together to improve brain and behavioral development," said Colombo.

RBI Governor Asks Fintech Players To Form Self Regulatory Organisation

Fintech players should form a self regulatory organisation for an orderly growth of the industry that is projected to have revenues of USD 200 billion by 2030, RBI Governor Shaktikanta Das said on Wednesday.

Addressing the industry at the Global Fintech Fest here, Das said fintech players need to evolve industry best practices to avoid misselling, stress on ethical practices, pricing transparency and take care of privacy and data protection

"I would like to use this opportunity to urge and encourage the fintechs to establish a Self Regulatory Organisation (SRO) themselves," he said and assured all help from the Reserve Bank of India (RBI) for the process.

The fintech players should form the SRO at the earliest, Das said and hoped that such a platform will be ready at least by the next edition of the yearly event.

Stating that other industries also have SROs, Das said forming an SRO will help the players to voice their concerns.

He also said that having the SRO will reduce the burden of regulating a dynamic sector off the RBI's shoulders.



Das said regulators play a critical role in addressing arbitrage, ensuring compliance with existing laws, and adopting regulations as per technological advancements.

Further, he asked the fintech players -- most of them startups -- to avoid the "relentless drive for valuations" and profits, and asked them to focus on customer centricity.

to focus on customers means embracing a customercentric approach to innovation by understanding the needs of customers, making provisions that protect customer interests and earn their trust," he added.

He said that good governance will be key to durable and long term success of any company and in particular, the fintech players.

Technological innovation has "unprecedented potential" to make finance more inclusive, competitive and robust, Das said, adding that advancements in technology need to evolve in a "responsible" manner.

Over 4 Lakh Indians May Die Awaiting Employment-Based S Green Cards: Report

WASHINGTON: More than 10.5 lakh Indians are in the queue for an employmentbased Green Card and 4 lakh of them may die before they receive the much-soughtafter legal document of permanent residency in the US, according to a new study.

A Green Card, known officially as a Permanent Resident Card, is a document issued to immigrants to the US as evidence that the bearer has been granted the privilege of residing permanently. The per-country caps are numerical limits on the issuance of green cards to individuals from certain countries.

The employment-based Green Card backlog reached a new record of 1.8 million cases this year, according to the study by David J Bier of the Cato Institute, an American libertarian think tank.

About 1.1 million of the 1.8 million cases in the backlog are from India (63 per cent). Another nearly 250,000 are from China (14 per cent), it said.

The backlog consists of immigrants who are waiting to receive green cards, primarily the result of low Green Card caps for employer-sponsored



immigrants and investors.

Because no country may receive more than 7 per cent of the green cards (the country caps) unless they would otherwise go unused, the 1.1 million cases from Indians in the backlog bear most of the burden of the broken system, the study said.

New applicants from India will face a lifetime wait, and more than 400,000 will die before they receive a green card, it said.

The process starts when an employer files a petition for a worker. If no Green Card is available under the caps, the petition is wait-listed until a spot opens. Finally, a worker may file to adjust their status to permanent residence (the green card application) when a green card cap spot is available to them.

There's a similar staged process for investors and employment-based "special immigrants" who include Afghan interpreters as well as, strangely, abandoned immigrant children.

In March 2023, 80,324 employment-based petitions were pending, representing about 171,635 people with spouses and minor children of the workers included. Another 1.3 million were waitlisted, and 289,000 were pending adjustment of status applications, the study said.

There were also some employment-based immigrants waiting for immigrant visa adjudications at consulates abroad, but the State Department provides no information about the

FCIK Signs MOU With FOIJ To **Boost Industrial Development**

In a joint statement released for press, both the organisations regretted continued plight, miseries and difficulties of the existing industrial units for non-implementation of the industrial policies in their letter and spirit which had affected the working of existing units and put their very survival to risk.

"the 3% turnover incentive announced and promised to the existing industrial units in the current industrial policy was substantially being withdrawn for paucity of funds putting a question mark on government commitments" regretted two chambers.

The two organisations accused the government of withdrawing all marketing incentives during currency of the policy rendering all those units workless which had their dependence on the government procurements.

"How can the manufacturing units of Jammu and Kashmir with slew of disadvantages compete with their counterparts from industrially advanced states on GeM portal without being provided with any protection" questioned the two chambers adding that the withdrawal of price and purchase preference as also delay in release of due payments had wreaked havoc on these units.

BRUSSELS- The European Union on Wednesday unveiled the list of digital giants -- including Apple, Facebook owner Meta and TikTok parent ByteDance -- that will face tough new curbs on how they do business

Brussels is working through a dense legislative agenda to build tougher regulation of big tech, arguing it needs to protect European consumers online and to encourage competition in an industry dominated by US giants.

The latest announcement is a milestone in the application of the Digital Markets Act (DMA), which will force the largest firms to change their ways under a checklist of dos and don'ts and, regulators hone create a fairer market

SC upholds HC verdict restoring service of BSF constable accused of taking female doctor's pics

has upheld a Delhi High Court verdict that had revoked the dismissal of a Border Security Force constable accused of clicking pictures of a woman doctor while she was taking a

A bench of Justices J B Pardiwala and Manoj Misra dismissed the appeals filed by the Centre and the BSF administration challenging the February 2013 verdict of the high court which had also directed that he would be entitled to certain consequential benefits.

The appellants had also challenged in the top court the November 2013 order of the high court which had dismissed the plea seeking a review of the February 2013 verdict.

"In light of the discussion above and also taking into account that the minutes of the proceedings recording the plea of guilty did not bear the signature of the original petitioner (constable), in our considered view, the high court

dismissal of the original petitioner on the basis of the plea of guilty unwarranted and liable to be set aside in exercise of powers under Article 226 of the Constitution of India," the bench said in its verdict delivered on Tuesday.

It said the high court was also justified in not re-opening the proceeding from the stage where the "error crept in" by noticing that it would serve no useful purpose as there was hardly any evidence on record and nearly a decade had passed since the date of the alleged incident.

"For all the reasons above, we do not find it a fit case for interference in exercise of our jurisdiction under Article 136 of the Constitution of India. The appeals are dismissed," the bench said.

It noted that the man was a constable (General Duty) in the BSF and the case against him was that while he was posted as a security aide to a lady doctor,

he clicked her pictures while she was taking a bath in June

The apex court noted the allegations against him were that on the day of the alleged incident, the doctor had requested him to leave her quarter as she were to take a bath and while she was bathing, she noticed two camera flashes through the window of her bathroom after which she raised an alarm.

The matter was reported to the chief medical officer after which the BSF authorities investigated it and put the constable under open arrest, the bench noted.

Thereafter, under the orders of the Battalion Commandant, proceedings were initiated against him in respect of commission of an offence under section 40 of the Border Security Force Act, 1968, for committing an act prejudicial to the good order and discipline of the force and record of evidence was prepared.

HC slams Maharashtra govt for not appointing prosecutor yet

Appeals in 2006 Mumbai train blasts case

Mumbai: The Bombay High Court on Wednesday berated the Maharashtra government for not appointing a new special public prosecutor (SPP) to represent it in the appeals arising from the 2006 Mumbai serial train blasts case.

The government was not treating the case with seriousness, said a division bench of Justices Nitin Sambre and Rajesh Patil.

While the trial court sentenced five accused to death in the case in 2015, the hearing on its confirmation as well as the appeals filed by the accused in the high court is yet to start.

Seven blasts ripped through local trains during the evening rush hour in Mumbai on July 11, 2006, killing more than 180 people and injuring several others.

When the appeals came up for hearing on Wednesday, the court was informed that the state government was yet to appoint a special public prosecutor.

Senior advocate Raia Thakare

had been appointed as SPP as he had acted as prosecutor during the trial. But he expressed disinclination to act as SPP at the appellate level, so the hearing was adjourned.

The government approached Thakare again, requesting him to take up the brief. But the terms of his appointment were yet to be decided, the court was

When the government sought more time on Wednesday, the bench got irked.

"Is this the way you are treating these appeals? There is no seriousness with which the government is treating this issue. We will summon the chief secretary of the state home department to answer us tomorrow morning," the judges said.

Eventually, the high court directed the government to sort out the issue by September 8 and directed an officer from the law and judiciary department to be present on that day.

"We do not want mid-level officers, we want someone from the government. If there is a failure on the aforesaid issue on the appointment of SPP by the day after tomorrow, we will call upon the principal secretary of the law and judiciary department," Justice Sambre said.

The court also indicated that it was inclined to start hearing the appeals from October 5 on a day-to-day basis.

Between 2006 and 2008, the Anti Terrorism Squad (ATS) of Maharashtra Police arrested 13 alleged members of the terrorist organisation Indian Mujahideen in connection with the train blasts.

In September 2015, the trial court convicted 12 of the accused, imposed the death penalty on five of them and sentenced the others to life imprisonment. One of the accused was acquitted.

The state government then filed an appeal in the high court seeking confirmation of the death penalty (which is mandatory), while the convicts too filed appeals challenging their convictions and sentences.

Since then, the appeals have come up for hearing before nine different benches of the high

will be "broken, squeezed and finished" to thwart any fresh conspiracy from Pakistan to disturb peace in the region, Singh said.

"Under no circumstances, will we allow terrorism to raise its ugly head again in Rajouri and Poonch districts. Terrorism will be crushed with an iron fist and those supporting terrorism will be dealt with strictly," the police chief told reporters in Rajouri district.

Congratulating security forces and civilian volunteers, including village defence guards, for back-to-back successful operations against terrorists in Rajouri and Poonch, and Reasi in the past couple of months, he said the border grid has been further strengthened and this was evident as infiltration attempts were foiled this year.

"We are determined to thwart any fresh conspiracy of Pakistan. We have successfully foiled many infiltration attempts by terrorists this year, and we will not lower our guard," Singh said, adding that additional police personnel are being deployed to assist the army in further strengthening the border security

He said there were repeated attempts from Pakistan to revive militancy in Poonch and Rajouri districts but these were foiled with the cooperation of people.

"Security was strengthened and area domination was ensured with massive searches... these resulted in the killing of infiltrators on the Line of Control and those who managed to sneak in are being neutralised one after the other," the DGP said.

Asked about the measures taken to curb narcotic smuggling from Pakistan, Singh said security agencies are alert and strict action is being taken against perpetrators.

"Some of our people living ahead of the border fence are in contact with people from across the border. We have seized large consignments airdropped from drones along the Line of Control and the International Border,"

The DGP said police are taking stern action against those involved in smuggling of narcotics, weapons or facilitating infiltration of terrorists.

People also need to remain alert and help security forces identify the "bad elements" who are not only enemies of the nation but also ruining the lives of youngsters, Singh

On the number of active terrorists in the Rajouri-Poonch belt, the DGP said it is not possible to give an exact figure as they are constantly on the run and were moving from Rajouri-Poonch to south Kashmir's Shopian and Kulgam districts.

"Three groups with numbers ranging between nine and 12 have been sighted in the past...three more terrorists were recently neutralised in encounters at Khawas in Rajouri and Chassana in Reasi. We are active on both sides of the Pir Panjal Range and the rest of them will also be neutralised," he said.

He said one of the two terrorists killed in Khawas on August 5 was a Pakistani national who was active in Rajouri for a very long time. "He was suspected to have been involved in many terrorist acts and was also planning fresh attacks. His killing is a major success for security forces," Singh said.

The DGP said the terrorist killed in Chassana's Tuli area on Monday is also believed to be a Pakistani national. A search operation is on to neutralise his associate who managed to flee during the encounter, taking advantage of heavy rains and darkness, he

Earlier, the DGP reviewed the security situation in the border districts of Rajouri and Poonch, and also inaugurated a CCTV control room in Rajouri. He also released a book on terrorism, compiled by Deputy Inspector General of Police, Poonch-Rajouri Range, Haseeb Mughal.

defence PRO Lt Col Suneel Bartwal said. He said the operation was launched after two terrorists were observed crossing the LoC on the intervening night of Tuesday and Wednesday in the Mandi sub-sector of Poonch.

"A joint operation was launched by the Indian Army and police immediately to intercept the terrorists. The hostile terrain, dense jungle and steep gradient were utilised by the terrorists to bring down a heavy volume of fire on the troops," the PRO said, adding both the terrorists were eliminated on Wednesday.

The encounter along the LoC comes just two days after security forces gunned down a hardcore terrorist in the remote Gali Sohab village in the Tuli area of Reasi district.

However, another terrorist had managed to escape. A massive search operation launched to nab him entered the third day on Wednesday, the officials said. The border district of Poonch and Rajouri

Pakistan last visited India in 2012 for a white-ball tour. Asked about the possibility of resumption of bilateral cricket with Pakistan, Binny reiterated that they can't take a call on that.

India and Pakistan are currently engaged in the Asia Cup in Sri Lanka and will lock horns again in the much-anticipated World Cup clash on October 14 in Ahmedabad.

PCB Demands Compensation From ACC For Losing Asia Cup Matches

LAHORE: The Pakistan Cricket Board on Wednesday demanded compensation from the Asian Cricket Council for the loss of gate money it has suffered due to Asia Cup matches being held in Sri Lanka.

Although the PCB has not issued any official statement on the matter, some media outlets here have reported that the board's chairman Zaka Ashraf has sent a formal letter to the ACC president Jay Shah, demanding compensation. Ashraf has expressed his disappointment over the way the scheduling of the matches in Sri Lanka has been handled by the ACC.

Without taking any names, the PCB chief has also asked who was responsible for last-minute decisions to shift venues without taking the other ACC board members into confidence.

Ashraf's letter also mentions a meeting between some ACC members including those from Sri Lanka and Pakistan after the contest between India and Nepal. "In

the meeting it was agreed that since the forecast is that Hambantota would remain dry the matches in Colombo

Ashraf has written As per the letter, it was decided on September 5 by both the host countries and the ACC that matches should be moved to Hambantota, following which Sri Lanka's head curator was dispatched to prepare the pitches.

The letter says that the ACC sent an email to the PCB confirming it, which would be sending across a press release to announce the shift in venue.

Ashraf has expressed surprise that after a while, the PCB was told to not consider the email, but later it was announced that the matches would be held as per the original schedule in Kandy and Colombo.

He has also expressed displeasure on the way the hosts Pakistan have been ignored while key decisions on the tournament and venues were taken.

After Luring Neymar, Mane & A Slew Of Stars, The Saudi Transfer Window Is Set To Shut

MANCHESTER: A lavish spending spree that has seen Saudi Arabia lure some of soccer's biggest stars to the oil-rich kingdom will come to a halt on Thursday when its transfer window shuts.

Cristiano Ronaldo, Neymar and Karim Benzema have been the most notable signings of an ambitious recruitment drive that has shaken up the sport, while there were also attempts to land Lionel Messi, Kylian Mbappe and Mohamed Salah. More marquee names

could still head to the Saudi League before the window closes at midnight local time (10 PM UK), with Salah linked with a possible move to defending champion Al-Ittihad.

reportedly Liverpool rejected a bid worth 150 million pounds (USD 188 million) before last week's European transfer dead-

come back with an even higher offer to try to get the deal done.

Even if Salah does not move before Thursday's deadline, Saudi Arabia has established itself as a major player in global soccer in the space of less than a year.

Ronaldo's decision in December to head to Al-Nassr has opened the door to a slew of the game's top players following suit by swapping Europe's biggest leagues for one that was previously little known outside of Asia.

A host of UEFA Champions League winners have since made the move, with N'Golo Kante, Sadio Mane, Riyad Mahrez, Roberto Firmino, Jordan Henderson, Fabinho and Aymeric Laporte also taking up the riches on offer.

It is not clear where the spending will end, either, after the kingdom's Public Investment Fund (PIF)



took up a majority ownership stake in four of the country's top clubs, Al-Ittihad, Al-Ahli, Al-Nassr, and Al-Hilal.

The failed attempts to sign Messi and Mbappe were evidence that nothing is considered out of reach for the wealthiest Saudi teams. Al-Hilal was behind both of those moves, with



Mbappe a world record for soccer. It was no surprise then that it eventually secured the signing of one of the sport's biggest names in Neymar, who joined

from Paris Saint-Germain. Should Liverpool be convinced to sell Salah, it would be yet another coup for Saudi soccer in a short space of time and likely put Europe's top clubs on even higher alert as to the league's pulling power. Saudi Arabia has sought in recent years to buy its way into international sports.

Besides Ronaldo, whose contract reportedly earns him up to USD 200 million a year, Saudi-funded LIV Golf has shaken up profes-

The moves are cast as part of efforts by Saudi Crown Prince Mohammed bin Salman to leverage the kingdom's oil wealth to provide new jobs and opportunities for Saudi Arabia's youth. However, critics have dismissed the efforts as "sports-washing," attempting to leverage professional sports to clean up its public image in the face of its human rights record.

As well as investing in boxing, Formula One racing and tennis, there is also speculation that the country wants to host the 2030 men's FIFA World Cup.

Its transfer spree has been its most spectacular move yet. Al-Hilal is Saudi's most successful team, having won the league championship a record 18 times and the Asian Champions League four times. It was runner up at this year's FIFA Club World Cup, even before transforming its

team with a host of stars. As well as Neymar, it has signed Yassine Bounou, Kalidou Koulibaly, Sergej Milinkovic-Savic, Ruben Neves and Aleksandar Mitrovic.

Ronaldo has been joined at Al-Nassr by Mane, Marcelo Brozovic, Laporte and Alex Telles. Even before attempts to sign Salah, Al-Ittihad brought in Benzema, Kante and Fabinho. Al-Ahli have put together an impressive attack consisting of Firmino, Mahrez and Allan Saint-Maximin.

Among other signings are former Chelsea goalkeeper Edouard Mendy, midfielder Franck Kessie from Barcelona and Gabri Veiga. Al-Ettifaq is not among the clubs backed by PIF, but it has hired former Rangers and Aston Villa manager Steven Gerrard as coach, and signed ex-Liverpool captain Henderson. ITC Fined ₹1 Lakh After Man **Complains One Biscuit Missing** In Sunfeast Marie Pack

Tiruvallur: The district consumer forum here has directed ITC Ltd Food Division to pay a sum of ₹ one lakh to a consumer for alleged unfair trade practice after he complained that packets of the corporate's biscuit brand Sunfeast Marie Light had one biscuit lesser than that advertised on the wrapper.

The District Consumer Disputes Redressal Forum, in a recent order, also directed the company to "discontinue the selling of the disputed biscuits 'Sunfeast Marie Light' in Batch No.0502C36 with the specific endorsement." It dismissed the company's submission that the challenge made with regard to weight of biscuits would not apply. Complainant P Dillibabu of Chennai alleged there were only 15 biscuits inside the packets as against the advertised 16.

"It is argued by the learned counsel for the 1st opposite party (the company) that the product was sold only based on the weight and not on number of biscuits. Such arguments could not be accepted as the wrapper clearly provides the information to the buyers/consumers to purchase the product only based on the number of biscuits. The potential consumer would only see the wrapper to decide the purchase of the product as the product information available on the packing influences the consumer's buying behavior and that the product information available on the wrapper or label plays a significant role in customer satisfaction," the order said. In the

present case, the paramount allegation is only with regard to lesser number of biscuits.

"Thus we answer the point accordingly holding that the 1st opposite party being the manufacturer and marketer had committed unfair trade practice and deficiency in service in misleading the consumers and that the complainant had successfully proved the same by sufficient admissible evidence," it said.

While Dillibabu sought imposing 100 crore fine on the company and the store that sold it 10 crore as compensation for the alleged act of unfair trade practice and deficiency in service, it said the reliefs sought for by the complainant was exorbitant.

The 2nd opposite party being the shop keeper had no role to play with respect to reduction in the number of biscuits. "Hence, complaint dismissed against him," it said.

The consumer forum subsequently directed that one lakh be given as compensation to Dillibabu by the company and another

10,000 towards litigation expenses to be paid by it to him. In its defence, ITC submitted that there was no deficiency or defect in the 76-gram biscuit packs of Sunfeast Marie Light in terms of the quantity that the packs were required to maintain under law. Citing Legal Metrology Rules 2011, it contended that if a pre-packaged commodity has a declared net quantity between 50 gram to 100 gram, then a maximum permissible error in excess or in deficiency of 4.5 gram of the declared quantity was allowed on such items.

Over 14 Million Pilgrims in Karbala to Commemorate Arbaeen



KARBALA: The number of pilgrims visiting the holy city of Karbala on the occasion of Arbaeen has exceeded 14 million, the Karbala governor has said.

Irag's central holy shrine city of Karbala is packed with pilgrims from Iraq and all around the world as it prepares to mark the commemoration of Arbaeen in the remembrance of Imam Hussain (RA), the grandson of the Holy Prophet Muhammad (PBUH).

"More than 14 million people have reached Karbala so far to participate in the Arbaeen procession," Karbala Governor Nassif Jassim Al-Khattabi said, adding that this year's Arbaeen

procession is considered the biggest held over the past couple of years.

The official added that the Iraqi prime minister directly supervises and monitors the implementation of the plans serving the Arbaeen pilgrimage.

The number of Iranian pilgrims visiting Karbala has soared 12 percent over the past few days compared to the same period last year.

'So far, more than 3,350,000 Iranian pilgrims have crossed Iran-Iraq borders, which shows a 12 percent growth year on year," an Iranian official in charge of the Arbaeen pilgrimage said on Saturday.

The number of pilgrims

flocking to Iraq for Arbaeen is increasing yearly, with many opting to enter the country from Iran. More than 21 million pilgrims have visited Karbala since the beginning of

Ashura. Last month, the Iranian ministers of interior and health visited the shared border crossings to inspect the facilities and relief equipment at the border for Arbaeen pilgrims

The annual pilgrimage marks an end to the 40-day mourning period following the martyrdom of Imam Hussein (AS), the third Shia Imam, and his loyal companions who were martyred at the Battle of Karbala on Muharram 10, 680 CE.

Gujarat Family Attempts Mass Suicide Over Daughter's Love Marriage

Ahmedabad: Unhappy over their daughter's love marriage, a couple and their two sons allegedly consumed poison, following which the man and one of his sons died in Gujarat's Ahmedabad district, police said on Wednesday.

The family members decided to take the extreme step as they were not happy with the woman's decision to marry a man of her choice about a year ago, an official from Dholka police station said, adding both families

belong to the Dalit community. Kiran Rathod (52), his wife Neetaben (50), and their two sons Harsh (24) and Harshil (19) from Dholka town here allegedly consumed a poisonous substance on Tuesday night in a bid to kill themselves, he said.

The man and his elder son died, while his wife and younger son survived and were undergoing treatment, he said.

"When the neighbors got to know about the incident, they called an ambulance and informed the police. Doctors at a private hospital declared the man and his elder son dead, while the woman and the younger son are undergoing treatment," the official said.
