# World Leaders Converge In Delhi As G20 Summit Begins Today PM Modi Says Confident That The Conclave Will Chart New Path In Human-Centric Development

New Delhi: As world leaders converge at the G20 summit here, host India on Friday said the New Delhi Leaders' Declaration will reflect the voice of the global south and Prime Minister Narendra Modi expressed confidence that the conclave will chart a new path in human-centric and inclusive development.

Refusing to be drawn into the specifics of contentious issues such as the Russia-Ukraine war and climate-related topics, India's top G20 officials told a news conference on the eve of the two-day summit that the Declaration was "almost ready" and they were hopeful of clinching a joint communique by consensus.

US President Joe Biden, British Prime Minister Rishi Sunak, Japanese Prime Minister Fumio Kishida, Italian Prime Minister Giorgia Meloni and other leaders of the G20 grouping as well as chiefs of many leading world bodies like the International Monetary Fund,



World Bank and Organisation for Economic Co-operation and Development (OECD) gathered in the national capital for the summit beginning Saturday.

The leaders were welcomed by traditional dance performances by various troupes and a smiling IMF chief Kristalina Georgieva danced to the beat of the music at the airport.

Security was beefed up across the national capital, especially in New Delhi district, ahead

"Our New Delhi Leaders' Declaration is almost ready, I would not like to dwell on it because this declaration will be recommended to the leaders during the summit and the leaders will then accept it and only after it is accepted by the leaders, we will be able to talk about the actual achievements of this declaration," he said.

"India's expectation is that all G20 members will move towards a consensus and we are hopeful of a consensus on the communique," Foreign Secretary Vinay Mohan Kwatra said in response to a question on the possibility of Ukraine conflict holding up an agreement on the New Delhi Declaration.

The silver lining for India's presidency is likely to be the support by almost all G20 countries to its proposal to include the African Union as a permanent member of the bloc that has emerged as perhaps the most influential multilateral forum after → More On P10

#### **Scientists Grow Whole Model Of Human Embryo Without Sperm Or Egg**

cientists have grown human embryo like structures without using sperm, eggs or a womb, an advance that could help reveal the causes of many birth defects and types of infertility.


A research team at the Weizmann Institute of Science in Israel created the complete models of human embryos from stem cells cultured in the lab and managed to grow them outside the womb up to day 14.

The research, published in the journal Nature, shows that these synthetic embryo models had all the structures and compartments characteristic of this implants itself in the womb.

The scientists divided the cells into three groups. The cells intended to develop into the embryo were left as is. The cells in each of the other groups were treated only with chemicals, without any need for genetic modification, so as to turn on certain genes.

These genes cause these cells to differentiate towards one of three tissue types needed to sustain the embryo: placenta, yolk sac or the extraembryonic mesoderm membrane that ultimately creates the chorionic sac.

Soon after being mixed together under optimised, specifically developed conditions, the cells formed clumps, about 1 per cent of which self-organised into complete

stage, including the placenta, yolk sac, chorionic sac and other external tissues that ensure the models' dynamic and adequate growth.

The stem cell derived human embryo model "closely mimics the development of a real human embryo, particularly the emergence of its exquisitely fine architecture," said Jacob Hanna, a professor at the Weizmann Institute of Science.

The scientists did not use fertilised eggs or a womb. Rather, they started out with human cells known as pluripotent stem cells, which have the potential to differentiate into many cell types.

Some were derived from adult skin cells that had been reverted to "stemness." Others were the progeny of human stem cell lines that had been cultured for years in the lab, they said.

The researchers then reprogrammed pluripotent stem cells to revert these cells to an even earlier state known as the naive state in which they are capable of specialising into any type of cell.

This stage corresponds to day 7 of the natural human embryo, around the time it

The researchers said the stem cell based embryo-like structures (termed SEMs) developed normally outside the womb for 8 days, reaching a developmental stage equivalent to day 14 in human embryonic development.

That is the point at which natural embryos acquire the internal structures that enable them to proceed to the next stage: developing the progenitors of body organs,

The models faithfully emulated the process by which an early embryo gains all the structures it needs for beginning its transformation into a fetus.

"Many failures of pregnancy occur in the first few weeks, often before the woman even knows she's pregnant. That is also when many birth defects originate, even though they tend to be discovered much later," Hanna said.

"Our models can be used to reveal the biochemical and mechanical signals that ensure proper development at this early stage, and the ways in which that development can go wrong," she added.

#### **Lung Cancer Patient Managed Successfully With Bronchoscopic Intervention**

Srinagar: Continuing with the pursuit of upgrading and providing advanced health care services to the patients, Government Chest Diseases (CD) Hospital here has started another advanced technique 'Electro Cautery Knife and Controlled Radial Expansion (CRE) Balloon Dilatation' for palliative care of cancer patients.

A 60-year male with lung cancer was referred to Chest disease hospital with a history of shortness of breath and noisy breathing. For management of lung cancer, the patient had received chemo-radiotherapy. Bronchoscopy was done to visualize patients' airways, which revealed narrowing (stenosis) and obstruction of the patient's right side of the lung severe enough to cause patients symptoms.

Obstruction was relieved using an Electro-Cautery Knife and Controlled Radial Expansion (CRE) Balloon Dilatation. To avoid or reduce the chances of restenosis and obstruction, topical Mitomycin C was also applied locally (at the site of obstruction). The procedure was done under conscious sedation and the patient had relief of symptoms immediately post procedure. He was kept under observation for 12 hours and was discharged later.

Facility of various Bronchoscopic interventions for management of airway stenosis is available at Government Chest disease hospital, Srinagar. It has improved the management of patients with airway obstruction and will reduce the need of such patients to move outside UT.

The procedure was performed by a team of interventional pulmonologists led by Head of Department, Dr. Naveed Nazir Shah.The department headed by Dr Naveed with the support of Dr Khursheed and other faculty members has already started advanced interventional procedures like rigid bronchoscopy and stenting in cancer patients.

The department has expressed gratitude to the administration of CD hospital and Principal Government Medical College, Prof Masood Tanvir for providing support to the department for upgrading facilities to provide quality services to the public.

#### **Check Building Permissions Of All Commercial Establishments** In City: Com SMC

Srinagar: Commissioner Srinagar Municipal Corporation (SMC), Athar Aamir Khan has directed anti-encroachment and enforcements wings to check the building permission and registration of all the commercial establishments in the city.

An order issued by the SMC Commissioner in this regard said, as per law any commercial establishment can run in Srinagar city only in a building which has a commercial building permission from the Competent Authority and only after getting the registration of the establishment from the Srinagar Municipal Corporation.

"Now therefore, it is hereby ordered that the Anti-Encroachment and Enforcements wings of Srinagar Municipal Corporation to visit and check the building permission/ registration of commercial establishments in the city and ensure necessary action for enforcement as per law," the order reads.



## **High-Income Countries Of G20 Fall Drastically Short On Climate Action, Says Oxfam Paper**

**NEW DELHI:** Even if the highincome G20 countries, including the US, the UK, Australia and Germany, were to reduce their domestic emissions to zero by 2030, they would still fall significantly short of their fair-share benchmarks for emissions reduction, according to a new paper published by Oxfam International.

The paper by the global nonorganisation governmental evaluates the fairness and ambition of national greenhouse gas reduction targets, known as Nationally Determined Contributions (NDCs), of the G20 countries, using three distinct approaches. These approaches were employed to gauge the strength of the conclusions drawn. If all approaches arrived at similar results, it would suggest that the conclusions were robust.

The findings reveal that the G20, collectively as well as the most high-income countries of the bloc individually, are failing to meet the necessary levels of ambition required to limit the global temperature rise to 1.5 degrees Celsius.

The gap between the collective NDCs of G20 and the fairness or ambition benchmarks outlined by the three approaches ranges from 2.8 to 3.9 tons of carbon dioxide equivalent per capita by 2030.

This translates to an alarming excess of emissions in 2030, with the G20 countries alone accounting for a surplus of 14.1 to 20.2 billion tons of CO2 equivalent. It underscores



the urgent need for the G20 countries to significantly intensify their climate mitigation efforts, the paper read.

Delving further into the disparities among the G20 countries, the paper notes that the high-income nations of the grouping bear the primary responsibility for historic emissions and possess the technological and financial resources to address the climate crisis. But they are falling far short of their fair-share benchmarks, with emissions levels still exceeding what would be equitable by a large margin.

For example, the United States and Australia, both high-income countries, would need to enhance their 2030 NDC emission reduction targets by 240 per cent and 170 per cent respectively to align with the fair-share benchmarks. Similarly, Germany and the United Kingdom would need to increase their targets by 160 per cent and 124 per cent respectively.

The paper underscores that even if the high-income countries reduce their domestic emissions to zero by 2030, they will still not meet their fair-share benchmarks. These nations would need to provide substantial climate finance, technology transfers and support to other countries to bridge the emissions gap.

The middle-income G20 countries, while having lower historic responsibilities and fewer financial resources, are also found to fall short in achieving their fair share of global emissions targets, the paper says. This highlights the need for these countries to adopt more ambitious emissions reduction targets, consistent with the fairness benchmarks.

These findings are crucial as the Global Stocktake, set to be finalised by the end of 2023 at COP28, aims to guide countries in enhancing the ambition of their climate action.

The persistent failure of the G20 countries to meet their ambitious and fair emissions reduction targets exacerbates the climate crisis, disproportionately affecting low-income communities and marginalised groups, Oxfam said, adding that the consequences of climate inaction are not only devastating but deeply unjust.

#### PM Modi, Sheikh Hasina Hold Talks On Diversifying India-**Bangladesh Cooperation**

**NEW DELHI:** A day before the G20 Summit, Prime Minister Narendra Modi on Friday held talks with his Bangladeshi counterpart Sheikh Hasina on diversifying bilateral cooperation and discussed issues such as connectivity and commercial linkages.

In a post on his second bilateral of the day after holding talks with Mauritian Prime Minister Pravind Jugnauth, Modi said he had "productive deliberations" with PM Sheikh Hasina.

"The progress in India-Bangladesh relations in the last 9 years has been very gladdening. Our talks covered areas like connectivity, commercial linkage and more," Modi said.

In a post on X, the Prime Minister's Office (PMO) said, "PM @ narendramodi had productive talks with PM Sheikh Hasina on diversifying the India-Bangladesh bilateral cooperation. They agreed to strengthen ties in a host of sectors including connectivity, culture as well as people-to-people ties."

Modi is scheduled to hold about 15 bilateral meetings over the next two days.

"I will also be holding bilateral meetings with several leaders and Heads of Delegation to further deepen the bonds of friendship and cooperation," Prime Minister Modi earlier said.

The meeting between Modi and Hasina comes a day before the G20 meeting.

The G20 leaders will deliberate on pressing global issues at the grouping's annual summit here on September 9 and 10. India is hosting the summit in its capacity as the current G20 chair.

In its G20 presidency, India has been focusing on various issues such as inclusive growth, digital innovation, climate resilience and equitable global health access.

The G20 member countries represent around 85 per cent of the global GDP, over 75 per cent of the global trade and about two-thirds of the world

population. The grouping comprises Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkey, the UK, the US and the European Union (EU).

#### **G20 Summit 2023: Security Agencies Deploy Optical Target Locator To Protect Delegates**

NEW DELHI: As part of the stringent security measures for the G20 summit, the security agencies have deployed an 'Optical Target Locater' made by the DRDO at the summit venue in Pragati Maidan to help in sanitising VIP areas by detecting snipers.

The device, which has been developed by the DRDO (Defence Research and Development Organisation), can also detect and locate commonly used active and passive surveillance devices, DRDO officials said.

The 'Optical Target Locater' provides an important tool for the detection of camouflaged passive or active surveillance devices like optical day sight or sniper telescopes, night vision devices, or electronic sensors as in the Laser Range Finder, during day and night

operations in urban scenarios. The long-range 'Optical Target Locater' has an operational range of the order of 1500m in day and night operations, according to the DRDO.



Meanwhile, the local police and BSF jawans are keeping a vigil on the Yamuna River by patrolling it on boats in Delhi's Shahdara district.

The Delhi Police have heightened security across the city and continued their security patrols. The specially security members of NSG's dog squad, Zenon, Ming, Zone, Zozo, and Zinger, along with their handlers and bomb disposal units, have been checking the periphery of Rajghat to ensure a safe and secure summit.

#### Paris Mayor Strips Palestinian Leader **Of Honor Over Holocaust Outburst**

PARIS: Paris mayor Anne Hidalgo has stripped Palestinian president Mahmoud Abbas of the French capital's highest honor after he made remarks about the Holocaust that echoed anti-Semitic tropes, her office said on Friday.

Abbas could no longer hold the Grand Vermeil medal after he "justified the extermination of the Jews of Europe" in World War II, her office told AFP.

"The comments you made are contrary to our universal values and the historical truth of the Shoah," Hidalgo said in a letter to Abbas sent on Thursday. "You can therefore no longer hold this distinction.'

The text of the letter was published on X, formerly known as Twitter, by Yonathan Arfi, president of the Representative Council of French Jewish Institutions (CRIF), an umbrella organization representing French Jews.

"This important decision honors Paris and the city's ongoing commitment against anti-Semi-



tism," he wrote.

Abbas, 87, claimed Jews had been murdered in the Holocaust because of their "social role" and not religion, saying it was "not true" that "(Adolf) Hitler killed the Jews because they were lews.

Echoing anti-Semitic tropes, he claimed Europeans "fought (the Jews) because of their social role, and not their religion.

Because of usury and money." Abbas made the remarks during a speech late last month before senior members of his Fatah party in Ramallah, and a video of the event surfaced this

"You (...) justified the extermination of the Jews of Europe during World War II with a clear desire to deny the genocide," Hidalgo said in the letter.

"I vehemently condemn your remarks, no cause can justify revisionism and negationism," she added. Abbas had been given the award during a 2015 visit to A spokesperson for the Euro-

pean Union said: "the speech... contained false and grossly misleading remarks about Jews and anti-Semitism."

France's consulate in Jerusalem called the remarks "totally unacceptable.'

## **Britain Commemorates First Anniversary Of** Queen Elizabeth II's Death

Britain's King Charles III has thanked the public for their support in his first year as monarch, as he marked the one-year anniversary of the death of his mother, Queen Elizabeth II.

In a short statement published on Friday, the 74-yearold British head of state recalled the "great affection" for his mother, her life and public service.

"I am deeply grateful, too, for the love and support that has been shown to my wife and myself during this year as we do our utmost to be of service to vou all," he added.

Commemorations will be low-key on Friday, with the king - who is at his Scottish Highland estate of Balmoral - not expected at any official engagement.

He and wife Camilla will attend nearby Crathie Kirk, the late queen's place of worship, for private prayers and a moment of reflection.



His mother, who was on the throne for a record-breaking 70 years, died at Balmoral aged 96 after a period of declining health.

Throughout her reign, she did not publicly mark her accession, as it was also the anniversary of her own father King George VI's death in 1952. Last year, when she began her Platinum Jubilee year on February 6, she spent the day in private at her Sandringham

#### **School Heads Asked** To Teach At Least Two **Classes A Day**

**SRINAGAR:** In a significant move School Education Department Friday ordered that the principals and headmasters of government institutions shall take part in teaching students besides managing the administration of their respective schools.

#### **Arms Found Near Poonch Encounter Site**

## **J&K Witnessing Peace Due To Sacrifice Of Fallen Heroes: DGP**

JAMMU: In a stern warning to local terrorists operating from Pakistan, Jammu and Kashmir Director General of Police Dilbag Singh on Friday said they will not be allowed to live in peace even across the border.

He said security agencies have already started attaching the properties of Pakistanbased terrorists and the action will continue.

"We want to give a clear message to the traitors (local terrorists) who have gone across the border and (are) trying to revive terrorism here (in Jammu and Kashmir) that they cannot live in peace there because we will reach them and those who are supporting them from here will be dealt with sternly," the police chief told reporters on the sidelines of an event in Kishtwar.

The Chenab Valley comprising Kishtwar, Doda and Ramban districts was a target for terrorists in the past but the security agencies are vigilant and will not allow them to gain a foothold, he said.

"The Doda-Kishtwar range is being guarded heavily by security forces with the cooperation of locals. The bad elements trying to revive terrorism will be given a befitting reply," Singh said.

Asked about the recent busting of a hideout being used by Jehangir Saroori -- the longest surviving Hizbul Mujahideen terrorist -- in the higher reaches of Kishtwar, the police chief said action is underway to neutralise him and a couple of his associates.



that stage of his life where he is close to his grave. We want to take him there but if, somehow, he survives, he is himself nearing his end. Time is not far when he will be in his grave," Singh said.

He added that most of the people linked with Saroori have been neutralised but a couple of his associates are still accompanying him and they will also be neutralised soon. The security forces are keeping a close watch on the areas where Saroori and his associates are suspected to be hiding and action against them is underway.

Saroori's cave hideout was dismantled by the police in collaboration with troops of the Rashtriya Rifles and the Central Reserve Police Force in a meticulously planned opera-tion in the Paribag area of Bhadat Saroor on Tuesday.

Saroori joined militancy in the early 1990s and is believed to be hiding in the higher reaches of Kishtwar district. His brother Abdul Karim Butt was detained under the stringent Public Safety Act on "He (Saroori) has reached charges of being a terrorist associate on August 3.

Singh said strong action is also underway against terrorists in the twin border districts of Rajouri and Poonch.

"They (Pakistan-based terrorists) tried to sow the seeds of militancy in Rajouri and Poonch. Strong action to destroy this seed is going on," the police chief said and added that many infiltration attempts were foiled this year.

He said the terrorists planned to infiltrate through Rajouri into nearby Reasi and ultimately to Kashmir or directly into Kashmir from Rajouri but all these attempts were thwarted.

Singh also said that Jammu and Kashmir is witnessing growing peace and stability because of the sacrifices of the police's fallen heroes.

# A Case for Traditional Architecture in Kashmir

Architectural spaces and the spaces of traditional build-up are no mere moulds of brick and mortar; they are cultural integrators, emblems of tradition and the icons of identity

#### What has been

the fate of our traditional architecture and the vernacular buildings which had evolved over a course of centuries? Concrete jungles without any regard to the geological and ecological compatibility of the place have cropped up and with these haphazard, imported in a cyclostyle fashion, have brought with them aesthetic erasure and other vulnerabilities

gaze encountering traditional architecture not only draws us into awe but inspires in us hundred thousand feelings of varied nature. An entire epoch unfolds before us, the symbolism of the architecture plays with all its fancy before our eyes and invokes in us a sense of strong historical and national identity. Architectural spaces and the spaces of traditional build-up are no mere molds of brick and mortar; they are cultural integrators, emblems of tradition and the icons of identity. These are the motifs one relates with on many levels and are capable of fostering the sense of togetherness and cultural unity in a group of people. But modern day intrusion into our lives and ideas has caused not only hegemony and homogeneity of our language & literature, dress and diet, but has also created an architectural monolith The building in London is no different from a building in Lahore and the multiplex in Delhi doesn't differ from the one in Dublin. This uniformity carried under the aegis of globalization has outlawed and abolished the traditional forms of architecture and eroded the aesthetic sense of people which so much characterized the world till a few decades ago.

In the trilogy of "Satyam-Shivam-Sundaram", Indian civilization offered the supreme identity between truth and beauty and this beauty was made manifest in the mundane aspects of life from the habits of dining to the codes of construction. Same is true of other civilizations and cultures, which constructed their houses and other spaces in conformity with their underlying ideas, beliefs and mores. With the abandoning of traditional construction style, particularly in the Kashmiri context, we have not only lost an important aesthetic dimension of our construction and buildings, but have brought upon ourselves unforeseen structural ills and challenges. In the pursuit of universality, the locals have suffered not only ignorance, but outright abolition.

vations and careful advances. Traditional Kashmiri houses consisted of wooden framework and walls were made of mud and clay, insulating them from the cold and regulating the temperature inside the house. These were built with special care being paid to Kashmir's harsh winters and they provided natural insulation against the jaw locking cold. Not only this, traditional Kashmiri construction practices which include the Taq and Dhajji-Dewari styles are seen in places like

Srinagar. These have either masonry-

bearing walls (Taq) fastened with

timber or a rectangular timber

framework filled

with masonry

(Dhajji

Dewari). An analysis appearing in Scientific American explicitly notes that "To restore architectural resilience in the region, we must turn back to traditional ways of building. Governments at all levels must both promote earthquake safety in construction and treat local earthquake science with the seriousness it deserves'. But what has been the fate of our traditional architecture and the vernacular buildings which had evolved over a course of centuries? Concrete jungles without any regard to the geological and ecological compatibility of the place have cropped up and with these haphazard, imported in a cyclostyle fashion, have brought with them aesthetic erasure and other vulnerabilities.

London is an apt example of blending traditional architecture with modern developments without either eroding the traditional aesthetic or losing the merits of modern developments. But so much so has some people abandoned their aesthetic nerve that in Islamic world, Mecca and Medina have undergone structural changes that are undesirable and one can add profane order. This change in buildings, which may look naive or inconsequential at first, hosts the roots of historical alienation, the loss of sense of belonging and the communal ties. One often ventured into the countryside and discovered peculiar and particular construction style, the walls and rooftops carrying with them the cultural legacy and aesthetic heritage. But all that has been eroded behind the veneer of progress and development and one can't even plead that this development is coming at the cost of our identity and cultural uniqueness. But we, the moderns, have little time for these things, whose value we neither understand nor appreciate. And what about the city?

One can hardly improve upon Iqbal Ahmed's pithy observation, "Till eighties tourists were seen moving in streets of Downtown Srinagar with their cameras in hand and engaged in taking market shots. The wonderful architectural buildings and historic lanes and by-lines were the splendour of the old city, which has now almost disappeared. Neither that historic grace is visible, nor those foreign tourists any more seen in the historic streets".

The irony has spilled over limits and not only have the common houses in Kashmir undergone drastic architectural metamorphosis, but Mosques, which preserved the sense of sacred and transcendence and reverberated in their style of construction the otherworldly echoes have been secularized in their build up and hijacked by the modern day horizontal, profane architecture.

Shrines, constructed centuries ago and now perhaps the sole witnesses to our architectural legacy, whenever retrofitted, are given modern day touch, tarnishing the legacy and the historical continuity which they stand witness to. How long shall we mistake the progress with anti-traditionalism and how long shall the artificial glare of

ism and how long shall the artificial glare of concrete keep us blind to the exquisiteness, the uniqueness and the brilliance of our traditional architecture, construction styles and the elegance of our mores.

# Exploring Old Age Homes in a Changing Kashmir

midst the corridors of my primary school days, a mesmerizing English tale I remembered — "The Mountain That Ate People," an ancient Japanese folklore. This chronicle follows the journey of a proud young feudal lord, harboring a disdain for the elderly. He wielded a decree as merciless as it was haunting, directing those past sixty-one to a desolate mountain for their final sojourn a place of somber departure. Yet, as the sands of contemplation trickle through the hourglass of my thoughts, an alternative tableau beckons. Could we not superimpose this narrative onto the canvas of Kashmir?

Here, the very title retains its essence, while the protagonists shift to the sons of the land. These contemporary scions, tragically detached, consign their forebears to the confines of old age homes, where life's curtain descends in solitude.Kashmir, known for its close-knit families, a somber reality has emerged. The challenging conditions have led to a distressing situation where some individuals, once bound by unbreakable bonds, are now finding themselves separated from their aging parents. It's a poignant issue that highlights the need for attention and support. Does the need for old age homes not cast a shadow of reflection in a land where muslims are in majority? The wisdom of the Quran is evident in its exhortation to respect and love for our elders, a principle that prominently includes our parents. Even as the years pile on top of our parents, its lines softly beg us to cradle them in compassion. The central message of Surah Al-Isra (17:23) is "Worship none other than Him, and be kind to your parents." Never even say 'uff' to them or rebuff them; instead, speak to them with words of grace if they both or one of them reach old age during your

As per an autonomous study conducted by Dr. Zubair Salim, a staggering 60% of senior individuals embark on their hospital journeys unaccompanied, while a mere 35 to 40% are joined by attendants, predominantly comprising daughters or unmarried

astounded: a frail elderly gentleman, bearing his granddaughter's weight, quivered noticeably. The passage of sixty years had clearly dulled his oncevibrant nervous system, while the highway adjacent pulsed with a torrent of traffic resembling a deluge. I inquired about his presence in the marketplace, and his response resonated deeply within me. With a voice both weathered and poignant, he explained that his actions stemmed from necessity. "We, the elderly," he mused, "find ourselves not just guardians of our grandchildren, but guardians of sustenance. To relinquish this role is to court hunger for ourselves, and the risk of becoming irrelevant in our children's eyes."In the graceful theater of life, your treatment of parents weaves a tale uniquely yours. Remember, the story you pen today will be retold by your children tomorrow - echoing the timeless wisdom of Mawlana Rumi. ## **Transmission Ability Of 'Support' Cells In Brain Could Help Understand Disorders Better**

he discovery of neurotransmission ability of "support" cells in the brain have led neuroscientists to believe that it could help understand pathologies of epilepsy and Parkinson's disease, new research published in the journal Nature said.

The brain is known to be made of neurons and glial cells, or cells of the glia, which is the tissue surrounding and supporting neurons (nerve cells) in the central nervous system.

Some of these glial cells, called astrocytes and surrounding synapses, which are neuronal junctions where neurotransmitters are released to transmit information between neurons, have been found to play an active role in synaptic transmission and in information processing. the study from the University of Lausanne (UNIL), Switzerland, said.

Earlier research has established the role of astrocytes in supporting neurons, but not in releasing neurotransmitters.

To confirm or refute the

hypothesis that astrocytes can release neurotransmitters, the researchers first scrutinised the molecular content of astrocytes in mice to find traces of the machinery necessary for the rapid secretion of glutamate, the main neurotransmitter used by neurons.

"We also identified other

cells, which are essential for the function of glutamatergic vesicles and their capacity to communicate rapidly with other cells," said Ludovic Telley, assistant professor at UNIL, co-director of the study.

Next, the neuroscientists tried to find out if these hybrid cells were able to actually release glutamate with a speed comparable to that of synaptic transmission. They used advanced imaging techniques that could map glutamate released by vesicles in brain tissues and in living mice.

"We have identified a subgroup of astrocytes

responding to selective stimulations with rapid glutamate release, which occurred in spatially delimited areas of these cells reminiscent of synapses," said Andrea Volterra, honorary professor at UNIL and codirector of the study.

Further, this glutamate release also regulated neuronal circuits without which, the study showed, memory consolidation was impaired and that the memory of mice is impacted.

The implications of this discovery extend to brain disorders, the researchers said.

This is because, they said, the team observed links by disrupting these glutamatergic astrocytes with pathologies such as epilepsy, whose seizures were exacerbated.

They further found these astrocytes were found to be involved in regulating brain circuits related to movement control and could offer therapeutic targets for Parkinson's disease.

"Our next studies will explore the potential protective role of this type of cell against memory impairment in Alzheimer's disease, as well as its role in other regions and pathologies than those explored here," said Volterra.

## **Keto Diet Seen To** Improve Pcos Symptoms In Women, Research Says

hort-term ketogenic diet was found to significantly enhance weight loss in women having polycystic ovary syndrome (PCOS), according to new research.

Resorting to the lowcarbohydrate, high-fat diet for 45 days also improved women's hormonal imbalances usually seen in PCOS, the meta-analytical study by the Malaysian Ministry of Health found.

PCOS is a common hormonal disorder in women of childbearing age, characterised by irregular pe-

riods and low ovulation, high levels of male sex hormones such as testosterone and cysts in ovaries. Other symptoms may include excess hair growth, acne, infertility, and weight gain.

Keto diet intervention in women with PCOS markedly improved their reproductive hormone levels, along with lowering their folliclestimulating hormone (FSH) ratio, which meant they had a better chance of ovulating thereby, enhancing fertility, the study published in the Journal of the Endocrine Society said.

The researchers also saw reduced testosterone levels in these women.

The study was a metaanalysis of clinical trials in women with PCOS on the keto diet and examined

the diet's effects on their reproductive hormones and weight change. The overall analysis included 170 participants.

Following a ketogenic diet is one of the means through which the body can be made to enter the metabolic state of ketosis, in which fat is burned for energy in-

stead of carbohydrates. The diet was also found to normalise menstrual cycles and optimise cholesterol levels in these women having PCOS, which is known to heighten the risk developing diabetes, obesity and other metabolic health problems.



"We found an association between the ketogenic diet and an improvement in reproductive hormone levels, which influence fertility, in women with PCOS," said the study's corresponding author Karniza Khalid, Ministry of Health Malaysia.

"These findings have important clinical implications, especially for endocrinologists, gynaecologists and dieticians who, in addition to medical treatment, should carefully plan and customise individual diet recommendations for women with PCOS," said Khalid.

#### **RBI Decides To Withdraw Incremental CRR In Phased Manner**

MUMBAI: The Reserve Bank on Friday decided to discontinue the Incremental Cash Reserve Ratio (I-CRR), which was put in place to absorb surplus liquidity following the withdrawal of Rs 2,000 currency notes, in a phased manner beginning Saturday.

On August 10, the RBI mandated banks to maintain an incremental cash reserve ratio (I-CRR) of 10 per cent on the increase in their net demand and time liabilities (NDTL) between May 19, 2023 and July 28, 2023.

The measure was intended to absorb the surplus liquidity generated by various factors, including the return of Rs 2,000 notes to the banking

"On a review, it has been decided to discontinue the I-CRR in a phased manner," the central bank said in a statement.

Based on an assessment of current and evolving liquidity conditions, it has been decided that the amounts impounded under the I-CRR would be released in stages so that system liquidity is not subjected to sudden shocks and money markets function in an orderly manner, it added.

The RBI said 25 per cent of the amount of I-CRR maintained by banks will be released on Sat-urday and another 25 per cent



on September 23. The rest will be released on October 7.

While announcing the I-CRR, RBI Governor Shaktikanta Das had indicated that the provision was a temporary measure for managing the liquidity

The RBI had announced that the I-CRR would be reviewed on September 8, 2023, or earlier with a view to returning the impounded funds to the banking system ahead of the festival

Following the withdrawal of the Rs 2,000 notes, the liquidity with the banks had surged significantly, the I-CRR was aimed to absorb the excess cash.

As much as 93 per cent of Rs 2000 currency notes that were in circulation on May 19 -- the day when the currency was withdrawn from circulation -have been returned to banks.

The total value of Rs 2000 banknotes received back from circulation is Rs 3.32 lakh crore up to August 31, 2023.

#### Govt Rolls Out 3rd Phase Of **Mandatory Gold Hallmarking In** 55 New Districts In 17 States/UT

**NEW DELHI:** The government on Friday said the third phase of mandatory hallmarking of gold jewellery and artefacts has come into force in 55 new districts in 16 states and one Union territory.

Gold hallmarking is a purity certification of the precious metal and was voluntary in nature till June 16, 2021, when the government decided to implement mandatory gold hallmarking in a phased manner.

Currently, a total of 343 districts are covered under mandatory hallmarking. In the first phase, launched on June 23, 2021, 256 districts were covered, while the second phase from April 4, 2022, included 32 more districts.

According to the Consumer Affairs Ministry, an order for implementation of the third phase of the mandatory hallmarking of gold jewellery and gold artefacts was notified on September 8.

The third phase of the mandatory hallmarking will cover an additional 55 new districts in 16 states and one Union ter-

ritory, it said in a statement. Eight districts, including East Champaran, will be covered in Bihar, five districts each in Andhra Pradesh, Uttar Pradesh, and Maharashtra, and four districts in Telangana under the third phase.

Three districts each will be covered in Haryana, Jammu and Kashmir, Punjab, Karnataka and Tamil Nadu, while two districts each in Assam, Gujarat, Jharkhand, Madhya Pradesh, Uttarakhand and West Bengal.

In Rajasthan, the mandatory gold hallmarking will be implemented in one district --Jalore -- during the third phase.

Nodal agency Bureau of Indian Standards (BIS) has successfully implemented mandatory hallmarking in the last two phases, wherein more than 4 lakh gold articles are being hallmarked with Hallmark Unique Identification (HUID) every day.

Since the implementation of mandatory hallmarking, the ministry said, the number of registered jewellers has increased from 34,647 to 1,81,590, while Assaying and Hallmarking Centers (AHCs) rose to 1,471 from 945.

"Investors are increasing exposure to stocks of companies that are likely to play a major role in boosting the economy going ahead," said Amol Athawale, Vice President - Technical Research at Kotak Securities Ltd.

#### **'States, UTs Collected Rs 2 Lakh Crore** In FY23 From Real Estate Sector'

**NEW DELHI**: The real estate sector is one of the major contributors to revenue of states and UTs, which collected an estimated Rs 2 lakh crore during last fiscal year in various forms, including stamp duties, according to a Naredco-Knight Frank India report.

This is equivalent to 5.4 per cent of the total revenue collected by all states and UTs in India during 2022-23, it added.

"Real estate sector is one of the key contributors to the revenue of state governments. In FY 2022-23, an estimated Rs 2 trillion was collected by all states and UTs (Union Territories) in India from stamp duties, registration fees and land

revenue," the report said. Realtors' body Naredco and property consultant Knight Frank India recently released a report 'India Real Estate: Vision 2047'.



As per the projection of the report, the size of the Indian real estate sector is estimated to jump more than 12-fold to USD 5.8 trillion by 2047 from USD 477 billion last year. The sector will contribute over 15 per cent to the total economic output of the country in 2047 from an existing share of 7.3 per cent.

By 2047, when India reaches 100 years of independence, the size of the economy is estimated to be USD 33-40 trillion. For study purposes, Knight Frank has taken the mean estimated growth of the Indian economy at USD 36.4 trillion by 2047.

As per the report, the size of the residential real estate market is estimated to grow to USD 3.5 trillion (USD 3,500 billion) in 2047 from USD 299 billion last year.

The size of the office real estate market is likely to grow to USD 473 billion from USD 40 billion, while the warehousing market is expected to reach USD 34 billion from USD 2.9 billion.

In addition to state revenues, the report noted that the real estate sector has also evolved as a tool for financing infrastructure development in the country.

# Man held for flight attendant's murder found hanging in Mumbai police's custody

Mumbai: A 40-year-old man, who was arrested for allegedly killing flight attendant Rupal Ogrey, was found hanging in the Mumbai police's custody in the early hours of Friday, an official said. It is a suspected case of suicide, he said.

The accused, Vikram Athwal, was found hanging using a pair of pants as a noose inside the toilet of Andheri police station, he said.

Athwal took his life perhaps out of guilt, the police official said. However, the crime branch will probe into the death as he died in police custody, he said.

Ogrey, 24, was found dead with her throat slit late Sunday night in a rented flat in Marol area of suburban Andheri. She hailed from Chhattisgarh and came to Mumbai in April this year for training with a leading private airline.

Athwal, who was doing



housekeeping work over the last year in the residential society where the victim lived, was arrested on Monday on the charge of killing her. A local court had remanded him in police custody till September 8.

During the probe, the police recovered a knife allegedly used by him to kill Ogrey along with the clothes he was wearing at the time of the crime.

Athwal and Ogrey used to argue over petty issues, the police said, adding that as per their preliminary investigation, Athwal entered Ogrey's flat under the pretext of picking up a garbage bag and cleaning the commode and then killed her. On Friday morning, Athwal

had told the police personnel posted at the lockup that he was going to the washroom, the official said.

As he did not return after some time, cops entered the toilet only to find him hanging with his pair of trousers, the official said.

Senior police officials were alerted about the incident following which doctors were called to the police station, he said. Athwal was declared dead before being taken to the hospital.

His relatives have been informed about the incident. After a post-mortem, the body will be handed over to his family members, he said.

Since Athwal died in custody, the crime branch of Mumbai police will investigate the death, the official said. Police suspect Athwal, who

Guterres said India has been doing everything possible to fully represent interests o Global South in preparation of G20 Summit. He also said G20 leaders must show lead-

ership on climate and achieving sustainable development goals. On Russia-Ukraine conflict, Guterres said

he is not very hopeful of a peace solution in the immediate future.

The Russia-Ukraine conflict has been flagged as a key topic on the agenda for the UK during the summit discussions, with Downing Street saying India's role and influence is "vital".

Asked whether the G20 will be able to come out with the leaders' declaration at the summit in view of differences over the Ukraine conflict. President of European Council Charles Michel said it is still being negotiated.

The Russian Foreign Ministry claimed in a news release that the Group of seven industrialised countries(G7) are putting "pressure" on India in an attempt to have their unilateral approaches to the situation in Ukraine reflected in the final documents of the G20 summit.

Invoking Mahatma Gandhi, Prime Minister Modi said on X that it is important to emulate his mission of serving the underprivileged, the very last person in the queue, as he underlined India's great emphasis on a humancentric way of furthering progress.

"The garbage of all sorts, including animal carcasses and plastic bottles, get stuck under bridges. From industrial wastes produced by hotels and factories to household garbage, plastics and all kinds of scrap material left behind by the unmindful construction activities, everything seems to be finally finding its way into the river Jhelum," he said.

"The cost of fiddling with nature and mistreatment of Jhelum was there for all to see in 2014 when the fury of flood caused destruction all around. Nearly nine years have passed since the floods nearly wiped off Srinagar from the map, but very few lessons have been

The research "Massive land system changes impact water quality of the Jhelum in Kashmir Himalayas," published by Prof Shakil Ahmad Romshoo and others, to assess the changes in water quality from 1983 until 2016 shows an increase of nitrate-nitrogen in the river.

The concentration of nitrate-nitrogen in the river has increased from 185 to 672µgL-1, indicating an increase of 260 per cent over the years. It has happened due to the combined impact of urbanization, reckless application of pesticides and fertilizers, forest degradation and deforestation.

In a recent study, the turbidity level in the water of Ihelum has been found higher than permissible limits.

The permissible turbidity level of the Jhelum is 1.0-5.0 N.T.U while turbidity at Verinag has been found 0.9 while at Anantnag it is 9.8, 12.1 at Padgampora Pulwama, 12.6 at Larkipora Pulwama, 13.1 at Awantipora, 15.9 at Barsoo and 19.7 at Srinagar.

The Central Pollution Control Board (CPCB) last year declared four water bodies including Jhelum polluted based on Biological Oxygen Demand (BOD) indicating organic pollution.

The CPCB data had suggested that the entire stretch of Jhelum from Srinagar to Baramulla is polluted. The BOD level in Jhelum has been recorded at 7.8 and it falls in the priority class

The officials said that the restoration process of water bodies including Jhelum is going on and every effort is being made to conserve them from pollution and other things—(KNO)

The bench also asked the Ladakh administration to deposit Rs 1 lakh in the Supreme Court Advocates on Record Welfare Fund.

Earlier, the Jammu and Kashmir and Ladakh High Court had dismissed the Ladakh administration's plea against a single bench order allowing NC candidates to contest the upcoming polls for the Ladakh Autonomous Hill Development Council (LAHDC), Kargil, on the party symbol.

The administration had approached a division bench of the high court against the single bench order of August 9 which directed the NC to approach the office of the Election Department of the administration of Ladakh to notify the reserved symbol 'plough' already allotted to for in the polls.

According to a notification issued by the election department on August 5, the polls for 26 seats of the 30-member LAHDC, Kargil, are scheduled for September 10 and the counting of votes will take place four days later.

In Srinagar, NC leader Omar Abdullah said, "Election guidelines are very clear about the allocation of symbols. Clearly, the administration in Ladakh had a very biased agenda which is why they went all the way to the SC to deny us our right."

The former Jammu and Kashmir chief minister said the verdict by the Supreme Court has been scathing about the conduct of the Ladakh administration. "Biased Ladakh administration failed to stop us from contesting council polls," he said.

The team left Aru at 10 am in the morning and reached intermediate base camp at Satlanjan at 4pm and camped there for a night. On the next day, team moved towards Doodsar which is at an elevation of 3750m and established base camp there. Technical equipment and ration was distributed among the

team members before leaving for advance basecamp on the next day. On the morning of September

On the morning of September 5, the team moved towards Advanced Base camp, i.e., the main Kolahoi Glacier. Team roped up and started ascending the glacier; negotiating crevasses, icefalls and overhangs. The affects of global warming have also taken its toll on the main Kolahoi Glacier, making the route more treacherous and difficult. Team reached the advance basecamp (4700m ASL) at 1pm and immediately pitched tents as it started snowing.

On September 6 morning, the team approached the eastern ridge route to Kolahoi, the same which was taken by the first successful expedition, led by Kennith Mason and Dr. Ernest Neve in 1912.

Finally at 10:15 hours on September 6, the team successfully reached the snowcapped summit of Mt. Kolahoi.

The team completed the achievement in four days, as 15 members summited the peak in one go

# FIFA Study Shows English & Saudi Clubs' Spending Fuels Record Year For Transfers

GENEVA: Spending by English and Saudi Arabian clubs fueled a record-setting year for soccer's international transfer market that reached highs in deals done, money spent and agent fees, FIFA said Friday.

FIFA's analysis of male players moving between member countries from June through Sept. 1 counted 10,125 transfers, \$7.36 billion spent by clubs and almost \$700 million paid to intermediaries representing players and clubs.

senting players and clubs.
English clubs spent almost \$2 billion — while recouping \$956 million in sales of players abroad — and Saudi clubs spent \$875.4 million on international deals through FIFA's Sept. 1 cutoff. The Saudi trading period continued

for six more days through Thursday.

The study included all cross-border transfers that are processed by FIFA and require clubs to detail the finances of each deal.

FIFA's study is not a complete picture because it does not count transfers deals between two clubs in the same country. Those deals do not require a change of player registration between two FIFA member federations.

English clubs spent hundreds of millions more on buying players such as Moises Caicedo, Declan Rice, Mason Mount, Kai Havertz and Alexis Mac Allister from other Premier League teams.

FIFA's figure of \$696.6 million paid to agents during the European summer trading window — and



\$865 million in total so far this year — also omits domestic deals.

"The full revenue of all



football agents is thus likely to be even substantially higher," said soccer's world body, which aims to launch



mandatory licensing of agents on Oct. 1. The rules are being challenged by agents in multiple coun-

tries separately from a win for FIFA at the Court of Arbitration for Sport in July.

FIFA's research further shows how the soccer industry has recovered from the COVID-19 pandemic and seen the transfer market surpass records set in 2019.

The \$7.36 billion that clubs spent in transfer fees represents an increase of 26.8% compared to the previous record summer of 2019. The 10,125 international transfers from June-September beat the record four years ago of 9,093. Of those deals, 1,985 involved a transfer fee and more than half were for out-of-contract players.

Spending by Saudi Arabian clubs on transfer fees for players such as Neymar, Sadio Mané and Riyad

The average paid for a player aged at least 30 who moved for a fee was \$5.9 million, FIFA said. The average fee was \$4.1 million for a player aged 24-29 and \$3.32 million for those aged 18-23.

Germany collected \$1.11 billion in fees for international transfers — the first time clubs from a single association received more than \$1 billion in the summer window, FIFA said. German clubs spent \$762.4 million in transfer fees — the fourth highest after England, Saudi Arabia and

France.
FIFA will publish a more detailed analysis of the 2023 international transfer market early next year.

### Hong Kong Receives Heaviest Rainfall in 140 years

nong Kong issued its highest black rainstorm warning—black—after torrential rains caused flooding and submerged parts of streets, malls and metro stations.

The Chinese special administrative region saw the highest hourly rainfall since records began 140 years ago.

The black rainstorm warning is the first such warning being issued since October 2021, reported the South China Post. A trough of low pressure linked to the remnants of Typhoon Haikui has brought heavy rain to the coastal Chinese province of Guangdong, which borders Hong Kong.

All schools were shut due to "extreme conditions caused by extensive flooding and serious traffic disruption", announced the government.

Authorities asked workers to stay home as well. Videos circulating on social media showed streets turning into raging rivers. The functioning of the country's rail network has been disrupted. The stock exchange is set to remain closed as long as the black rainstorm warning is in place.

City leader John Lee expressed his deep concern about the flooding and said that he had instructed all departments to respond with "all-out efforts".

According to authorities, rescue operations were being conducted in various flooded districts. Authorities in China's south-eastern state of Shenzhen warned Hong Kong on Thursday, 7 September, that water might have to be discharged from the Shenzhen reservoir, which could cause further flooding, the Standard newspaper reported. Within the past week, Southern China witnessed two typhoons in quick succession—Saola and Ĥaikui. Hong Kong avoided the dreaded direct hit, however.

## Sumptuous Monsoon Menu Awaits G20 Delegates At President Murmu's Dinner

Preparations are underway and senior managers and staff members of a luxury hotel group are busy setting up the dinner tables at Bharat Mandapam, which will host the two-day summit.

Sources said the ceremonial dinner will be served in bespoke silverware made especially for the occasion.

"We have prepared a specially-curated menu, keeping in mind the culinary delicacies consumed during this (monsoon) season in India. Milletbased dishes will be on the menu too," a source in the luxury hospitality group told PTI.

Officials are tight-lipped on the exact menu but it is expected to reflect India's culinary diversity.

Murmu will host the grand

dinner at Bharat Mandapam after the end of the summit's first day. While the details of the menu are being kept "tightly guarded", the heads of state are in for an "Indian delight" that will leave a "pleasant and unforgettable taste" in their

mouths, another source said.
"Sweets of varied kinds such as gulab jamun, rasmalai and jalebi, etc are planned to be served," the source said, adding



that the serving staff will wear a special uniform. There has been no official word on the menu from the Indian government yet.

Asked if the delegates will use bespoke silverware, the luxury hospitality group source replied in the affirmative. A Jaipur-based metalware firm on Tuesday said several luxury hotels commissioned made-to-order tableware and silverware that would be used by the foreign delegates staying at their establishments and at the special dinner.

Most of the tableware have a steel or brass base or a mix of both with a coating of silver while some the plates that will be used to serve the welcome drinks have a gold plating, Laksh Pabuwal of Iris Jaipur had told PTI.

The company held a media preview on Tuesday of some of the silverware. About 15,000 silverware crafted by 200 artisans have been made for the summit, it had said.

The designs of the tableware are a nod to India's rich heritage and its global prominence, said Rajeev Pabuwal of Iris Jaipur.

"The tableware depict the glorious cultural heritage of India, motifs of flowers, the peacock -- our national animal -- graces the plates, and other items. The silverware will dazzle the heads of state with their cultural sparkle," he told PTI.

Some of the tableware will be sent to the luxury hotel group responsible for arranging Saturday's grand dinner. The group will cater the lunch and the dinner menus at the G20 Summit venue, the sources said. The G20 Leaders' Summit will be held at the newly-built international convention and exhibition centre—Bharat Mandapam—at Pragati Maidan on Saturday and Sunday.

#### 72 snakes stuffed inside baggage on Bangkok flight seized at Bengaluru airport

Bengaluru: Customs officials have seized 72 snakes and six dead Capuchin monkeys that were stuffed inside baggage that arrived on a Bangkok flight at Kempegowda International Airport here, an official statement said on Friday.

Airport have booked a case
of wildlife smuggling at
Terminal - 1, Kempegowda
International Airport, it said.

According to the statement issued by Bengaluru Customs department, the baggage which arrived by Flight no FD 137 Air Asia from Bangkok at 10.30 pm on Wednesday was found to contain a total of 78 animals comprising 55 ball pythons (in different colour morphs) and 17 king cobras. These were found alive and in active condition.

However, six Capuchin



monkeys were found dead. All the said 78 animals are Scheduled animals under the Wildlife Protection Act, 1972 and listed under Appendices of CITES, it said.

"The animals were seized under Section 110 of the Customs Act, 1962. The live animals have been deported to the country of origin and the dead animals have been disposed of with proper sanitary measures. Further investigation is under progress," the statement added.
