Launching a scathing attack on mainstream parties, the LG said that the conflict profiteers who kept the people of J&K away from mainstream development, those who built



#### Missina **Soldier's Body Found On Day 6**

Srinagar: The body of a missing soldier on Monday was recovered from Gadole forest area of Anantnag district, even as the operation to flush out terrorists entered the sixth day on Monday with security forces using drones to pinpoint the hideouts for carrying out attacks on the militants.

The body of Army man Pradeep, who had been missing alongside Major Ashish on Wednesday last week, was recovered on Monday and is being transported back, a local news agency KNO reported while quoting unnamed officials. With Pradeep's killing, the toll in the ongoing encounter, including the recovery of a charred body, has reached six.

### **Govt To Set Up Mental Health Authority**

All Professionals, Establishments To Be Registered With It; MD NHM To Be Chief Executive

Srinagar: The Government of Jammu and Kashmir has decided to establish a Mental Health Authority and all the mental health establishments for which the concerned professions in the Union Territory

will be registered with it.
As per a notification issued by the Health and Medical Education Department, the Mission Director National Health Mission J&K shall be the Chief Executive of the Mental Health Authority.

The rules for the new Mental Health Act have also been framed and these rules may be called 'The Jammu and Kashmir Mental Healthcare (Mental Health Authority) Rules, 2023', and shall come into force on the date of their publication in the official gazette.

## 'Toxic 'Forever Chemicals' In Plastics, Dyes Driving Cancers In Women'

day use products like plastics, nonstick cookware, dyes and may be playing a role in cancers of the breast, ovary, skin and uterus in women, suggests a study.

PFAS is referred to as "forever chemicals" and has contaminated water, food and people through products such as Teflon pans, waterproof clothing, stain-resistant

carpets and fabrics, and food packaging. While it does not prove that exposure to chemicals like PFAS (per- and poly-fluoroalkyl substances) and phenols (including BPA) led to these cancer diagnoses, researchers found that women who developed those cancers have significantly higher levels of these chemicals in their bodies.

The study, published in the Journal of Exposure Science and Environmental Epidemiology, showed that women in particular who were more exposed to PFDE, a long-chain PFAS compound, were twice as likely to have a previous melanoma (form of skin cancer) diagnosis.



### **Iran, US Complete Landmark Prisoner Exchange Deal**

Tran and the US on 18 Septem-■ber completed a long-awaited prisoner exchange deal brokered by Qatar that also saw the transfer of \$6 billion in frozen Iranian funds held by South Korea.

Ten prisoners were released: five US citizens detained in the Islamic Republic under espionage charges and five Iranians held in the US for allegedly violating Washington's sanctions regime.

According to Reuters, the five detainees released in Tehran were accompanied by Qatar's ambassador to Iran to the airport, where they flew out of the country in a Qatari jet.

Iran's foreign ministry said on Monday that two Iranians freed by Washington would remain in the US, and one would fly to a third country to join his family. The two others are set to return home.

"One of them, as he has family in another country, will be moved to join them in that third country, and apparently, two of our citizens imprisoned in the US have said they wish to remain there due to their history of staying there," foreign ministry spokesman Nasser Kanaani told reporters.

The two released detainees arrived at Doha airport on Monday evening, according to Iranian officials. "Simultaneously, the three other Iranian prisoners who lived in the US have been freed," Nournews reported.

The prisoner swap got underway after Qatar confirmed that previously frozen Iranian funds worth \$6 billion were transferred to Iranian bank accounts in Doha.

Central Bank of Iran (CBI) chief Reza Farzin confirmed on Monday that the Iranian banks that received the unfrozen billions in their Qatari accounts are Keshavarzi, Shahr, Pasargad, Gardeshgari, Karafarin, and Saman. He also revealed that the transfer was conducted by the international agents of two Qatari banks, Ahlibank and Dukhan Bank, through the SWIFT system.

A sanctions waiver provided by Washington earlier this month is reportedly how the Iranian banks were allowed to receive funds via SWIFT.

Despite claims to the contrary by US officials, Iranian authorities maintain that the unfrozen funds will used to acquire "whatever the Iranian people need."

This money belongs to the Iranian people, the Iranian government, so the Islamic Republic of Iran will decide what to do with this money ... Humanitarian means whatever the Iranian people need, so this money will be budgeted for those needs, and the needs of the Iranian people will be decided and determined by the Iranian government," President Ebrahim Raisi said last week during a televised interview with NBC News.

## Wilful Denial Of Sexual Relationship By Spouse Cruelty: Delhi High Court

**NEW DELHI:** Wilful denial of sexual relationship by a spouse amounts to cruelty, the Delhi High Court has ruled while upholding the divorce granted to a couple whose marriage effectively subsisted for barely 35 days and failed on account of

non-consummation of marriage. A bench headed by Justice Suresh Kumar Kait, while rejecting the wife's appeal against the family court order granting divorce, said the high court has ruled in a case that "marriage without sex is an anathema" and that "there is nothing (more) fatal to marriage than disappointment in sexual relationship".

In the present case, the court observed, the marriage was not consummated on account of resistance by the wife who also filed a police complaint claiming she was harassed for dowry about which there was "no cogent evidence". This can also be

termed as cruelty, it said. "In (a case), it (the high court

has) .. observed that wilful denial of sexual relationship by a spouse amounts to cruelty, especially when the parties are newly married and this itself is a ground for grant of divorce," said the bench, also comprising Justice Neena Bansal Krishna, in an order dated September 11.

"In the present case, not only did the marriage between the parties subsist for barely 35 days but failed completely on account of deprivation of conjugal rights and non-consummation of marriage," the court said referring to the period the woman spent at her matrimonial home.

It cannot be overlooked that such deprivation over a period of more than 18 years itself amounts to mental cruelty.

The court recorded the couple got married according to Hindu customs and rites in 2004 and the wife soon went back to her parental home and did not return.

The husband later approached the family court for divorce on the grounds of cruelty and desertion.

## **Saudi Arabia Ditches Allies** In Favor Of Direct Talks With Yemeni Resistance: Report

According to an 18 September report by Lebanese daily Al-Akhbar, Omani-mediated negotiations to end the war in Yemen have been taking place directly between Riyadh and the Ansarallah-led Sanaa government, without the participation of the parties loyal to the Saudi-led coalition.

The report also suggests that Saudi Arabia is looking to disregard US pressure on the negotiations.


Citing informed sources, it states that the Saudi-appointed Presidential Leadership Council (PLC) and Saudi and UAE-backed forces in Yemen "appear to have no role in the negotiations."

The report claims that Saudi Arabia is ignoring the secessionist aspirations of the UAEbacked Southern Transitional Council (STC) government and has rejected its demands to be included in the negotiations.

The talks have so far "achieved great progress," particularly in relation to humanitarian issues, the sources say.

These negotiations are almost at a "final" stage, the sources go on to reveal, adding that the role of coalitionbacked groups, namely the Saudi-appointed PLC and UAE-backed STC, "will not go beyond signing and attending the [upcoming] ceremony."

Khaled Salman, editor of Yemeni newspaper Al-Thawri, said via social media that "Saudi Arabia is seriously seeking a long-term peace with Sanaa on its own path, away from American pressure, to deprive Washington of any cards that may be used against it in the future." He added that there is an



"overwhelming" Saudi desire to withdraw from "the American mantle."

Early last month, it was announced that Omani-mediated peace talks were in motion once again after being suspended due to what the Ansarallah resistance movement referred to as US interference. At the time, the group accused Washington of trying to obstruct the payment of the salaries of public servants in Yemen, one of the Sanaa government's leading demands for peace.

On 14 September, an Ansarallah official announced the departure of its delegation to Saudi Arabia in order to resume Omani-mediated talks. Two days later, Sanaa's chief negotiator, Muhammad Abdul Salam, said while in the kingdom: "We are always optimistic ... Peace is our basic demand and the first option we are working on."

According to Al-Akhbar, Saudi Crown Prince Mohammed bin Salman (MbS) held a recent meeting in Muscat with a delegation from the Sanaa government. The main topics discussed were "the state's general budget, movement between provinces, and lifting the blockade on ports."

As part of the Saudi-led against Yemen, heavy restrictions remain imposed on the country's main port of Hodeidah, as well as Sanaa International Airport.

"Bin Salman provided guarantees to Sanaa regarding all points of disagreement, including the American position opposing peace," the report cites two sources - one of them being a Saudi foreign ministry advisor - as saying.

Tawfiq al-Humairi, information ministry advisor in the Sanaa government, said on 17 September: "Riyadh has accepted the terms that it had refused in the previous period to give space for discussion in all rounds."

This includes a full lifting of the blockade and the return of "looted funds," which Humairi said have been confiscated and held in the Saudi National Bank. These funds will be used to pay the salaries of all civil servants, he added.

"The pressures directed towards Saudi Arabia from Sanaa today outweigh the American pressures on Riyadh," Humairi said, referring to Ansarallah's threats of missile attacks against Saudi Ara-

## **Need To Get Over "West Is The Bad Guy Syndrome": S Jaishankar**

THIRUVANANTHAPURAM: External Affairs Minister S Jaishankar on Sunday said the West was not the "bad guy" as it was not flooding Asian and African markets with goods on a massive scale and that there was a need to get over the "syndrome" of seeing it in a negative way.

Mr Jaishankar, in an interview to Malayalam news channel Asianet, also made it clear that he was not batting for the West. He was in Thiruvananthapuram as part of the launch of the PM Vishwakarma scheme.

"It is not the West which is flooding Asia and Africa with goods on a massive scale. I think we need to get over the syndrome of the past that the West is the bad guy and on the other side are the developing countries. The world is more complicated, the problems are much more complicated than that," the minister said.

Former Indian diplomat T P Sreenivasan interviewed the minister for the channel.

On being asked whether Chinese President Xi Jinping did not attend the G20 summit in New Delhi because it did not want India to be seen as leader of the Global South, Mr Jaishankar said the reasons were up for speculation.

He said the issue today was the building up of a strong sense, over the last 15 to 20 years, over the inequities of globalisation where countries saw their products, manufacturing and employment come under



stress due to their markets being flooded by cheap goods -- an indirect reference to the Chinese trade and economic policies.

The minister said this underlying resentment and pain of those countries regarding the global economy was building up for the last 15 to 20 years and the COVID-19 pandemic and the Ukraine conflict resulted in prices of energy and food items going up.

So there was a sense of anger building up in countries about them being used as an extractive resource to fuel the economy of another nation and added that the West was not to be blamed for that.

He made it clear that he was not batting for the West and said that in today's globalisation there was a concentration of manufacturing that was being leveraged and subsidised and was affecting economies of various nations.

However, India's manufacturing, agriculture, scientific achievement like the Chandrayaan-3 mission, ability to vaccinate, etc all of that has created a sense among the Global South, which includes the African Union, "that one of us has the ability to stand, grow and

**NEW DELHI:** The Supreme Court Monday dismissed a plea seeking a single "con-stitutional religion" in the country, asking the petitioner can he prevent people from following their respective religious faiths.

A bench of Justices Sanjay Kishan Kaul and Sudhanshu Dhulia asked the petitioner from where did he get the thought of filing such a petition.

"You say there should be one constitutional religion. Can you prevent people from following their own religions? What is this?" the bench told the man who appeared as petitioner-in-person.

Petitioners-in-person are individuals or lawyers appearing in their individual capacity before a court. They have to obtain permission from the court's registrar before



person. The instant petition was filed by Mukesh Kumar and Mukesh Manveer Singh.

"What is this? What do you want in this petition?" the bench asked one of them who was present before it.

The petitioner, who said he is a social activist, told the bench he has filed the public interest litigation (PIL) under Article 32 of the Constitution on behalf of the people of India seeking "one constitutional religion".

The bench said the petition sought quashing of a constitutional order of 1950. It, however, did not mention which constitutional order it was referring to. The court then dismissed the petition.

Article 32 of the Constitution extends to the citizens of the country the right to approach the apex court through appropriate proceedings if they feel their fundamental rights have been violated.





Over 5.50 lakh patients avail treatment at a cost of nearly Rs. 1,225 Crores since Dec 2020

**SRINAGAR:** The AB-PMJAY SEHAT scheme in Jammu and Kashmir has proven to be a tremendous benefit to the public. Since its launch in December 2020, over 5.50 lakh patients have received treatment, amounting to nearly Rs. 1,225 Crores in healthcare expenses covered.

This initiative, under the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana SEHAT (AB PM-JAY SEHAT) scheme, aims to provide Universal Health Coverage to all the residents of Jammu

and Kashmir. Launched by the Hon'ble Prime Minister of India on December 26, 2020, it offers an annual health cover of Rs. 5 lakhs per family for secondary and tertiary care hospitalization across both public and private empanelled hospitals in India. Remarkably, Jammu and Kash-

mir is the only state or UT in India to implement such a comprehensive scheme, ensuring healthcare access for all residents, regardless of their socio-economic status. The UT boasts a total of 235 empanelled hospitals, both public and private, under the scheme. Additionally, national portability enables beneficiaries to receive treatment at nearly 28,000 empanelled hospitals across the country.

The Government of Jammu and Kashmir has diligently followed the guidelines of the National Health Authority (NHA), Government of India, for the scheme's implementation. This includes using the Model Tender Document issued by NHA for transparent selection of insurance companies and adopting Health Benefits Packages (2.2 version) for implementation. The IT solutions developed by the National Health Authority are integral to the scheme's operation.

Since the launch of AB PM-JAY SEHAT scheme, the Government of J&K has paid Rs. 982.59 Crores in premiums to insurance companies. In return, insurance companies have disbursed a total of Rs. 1,226.68 Crores in claims to empanelled hospitals (Rs. 638.81 Crores to public hospitals and Rs. 587.87 Crores to private hospitals) for the treatment of beneficiaries. A total of around 5.50 lakh patients

have availed treatment for various conditions under the scheme which, inter-alia, include 20,940 Cancer patients (amounting to Rs. 171.01 Crores), 19,177 patients with Cardiac ailments (amounting to Rs. 160.87 Crores) and 9,710 patients suffering from Chronic Kidney Diseases (amounting to Rs. 90.57 Crores). In the absence of such a scheme, most of the patients suffering from these Life Consuming and Life Threatening diseases could not have afforded such treatments which required prolonged medical management.

## **Tourism Players In** Kashmir Witness Uptick In **Number Of Bookings**

**SRINAGAR:** The valley is witnessing an increase in the number of tourist arrivals as the festive season is just around the clock in India.

Next month, Durga Puja will be celebrated across India, which will be followed by Chhath Puja and Diwali in the month of November.

The Puja holiday season, which typically falls in October, has historically been a peak time for tourism in the region. However, this year's bookings are witnessing an unprecedented uptick, with travel agencies and hoteliers reporting a surge in reservations and inquiries.

Travel agents told a local news agency KNO that the inquiries related to the bookings have gone up by 30 percent in the last two weeks as the festive season nears.

"We get a good number of inquiries from the tourist currently. Even though it is a kind of off-season for tourism right now but still travel agents get calls from clients in view of the festive season," said Faroog Ahmad Kuthoo, President Travel Agents Association of Kashmir

He said that travel agents re-

ceive the majority of inquiries from West Bengal, Maharashtra, Gujarat apart from other states where Durga Puja and Diwali

are celebrated with fervour. "We usually witness a good flow of tourists from West Bengal during the month of October. Tourists from Maharashtra, Gujarat mostly visit during the Diwali time. We expect the bookings by tourists will go up by 50 percent in coming weeks," Kuthoo said.

Travel agents said they have made special arrangements for the tourists visiting the valley during the festive season.

"We have included a religious tour for the tourists as well so that they can enjoy the festivals here while exploring the historic temples of the valley. Apart from that, other arrangements have also been made for making their stay very comfortable and enjoy-able," said Umar Ahmad, another travel agent.

The government is also expecting the number of tourist arrivals to further go up in the remaining months of the year.

On Monday Lieutenant Governor Manoj Sinha said that tourist arrivals in Jammu and Kashmir are expected to surpass 2.25 crores, with foreign tourist influx increasing by 59%.

## New Parliament, New Era

n the first day of a special parliamentary session, Prime Minister Narendra Modi reflected on the important decisions and nostalgic memories associated with the old Parliament building, setting the tone for a transition to the new building, and in turn, to a new era. The session, spanning five days, thus symbolizes more than just a change in location.

The Prime Minister in his address highlighted the "historic decisions" made during his government's tenure. He highlighted the abrogation of Article 370, a move that redefined the constitutional status of Jammu and Kashmir within the Indian Union, and the introduction of the Goods and Services Tax (GST), a game-changing economic reform. He also praised the implementation of 'One Rank-One Pension,' a significant policy aimed at ensuring equitable retirement benefits for the armed forces. The achievements, he said, were a testament to the parliament's role as a catalyst for transformation.

Modi fondly recollected the old building's "bittersweet memories," including the 2001 terror attack on Parliament. He paid tribute to the security personnel who had sacrificed their lives in defence of the building, underlining that the attack was not merely on a building but on the "Mother of Democracy." The Prime Minister also took a personal journey down memory lane, reminiscing about his humble beginnings as a child from a poor family, who grew up on a railway platform.

As the parliament shifts to a new expansive building, it is a momentous occasion for the country. It is true that the old Parliament building in India holds significant historical importance, as it witnessed major milestones in the nation's history, such as the declaration of independence from Britain in 1947 and the adoption of the Constitution that established India as a democratic republic. However, due to the country's growing population, the old building no longer fulfilled the requirements of being the seat of government for the world's most populous country. One of the main challenges with the old Parliament building was its limited space to accommodate the 543 members of the lower house, known as the Lok Sabha.

As India's population continues to grow, the number of legislators is expected to increase in the coming years, further exacerbating the space constraints. Here's hoping that the new temple of democracy ushers in a more vigorous democracy which is inclusive and at the same time truly reflective of the diversity of India. The new parliament building will be witness to the debates, decisions and moments contributing to India's steady rise in the comity of nations.

## Testing times

ndia's goods exports shrank for the seventh consecutive time and the ninth time in 11 months this August, while imports surged to hit the highest level since March this year. At \$58.6 billion, inbound shipments were still 5.2% below last August's levels, but exports fell by a relatively steeper 6.9%, leading to a \$24.2 billion trade deficit — the widest since October 2022. Goods exports are now down 11.9% so far this year and imports have dropped 12.1%. Services exports for last month will be known later, but Commerce Ministry extrapolations suggest that this engine that has been resilient so far through the global economic turmoil, is also beginning to feel the heat. For now, the 0.4% drop expected in services exports in August is minor and with intangible imports also likely dropping at a sharper pace, this will not exacerbate the trade balance yet. However, shrinking services exports imply that their ability to bridge the goods trade deficits that were up sharply last year, will be restricted, thus raising the possibility of wider

current account deficits from this quarter. With global commodity prices rising around 12% from June levels to hit a 15-month high this month, the pressure on the goods trade deficit is likely to escalate, especially as oil and gems and jewellery imports have fallen less than their exports so far in 2023-24. In the first four months of this fiscal, about half the decline in outgoing shipments has been fuelled by petroleum despite volumes rising 6%, as prices fell 27%. This may change if global oil prices, which crossed \$90 per barrel over the past week for the first time since November 2022, stay elevated. Export volumes of as many as 13 major items rose between April and July, but their value had declined owing to lower prices. That is a good omen about demand for Indian goods amid the gloom, and the government believes rising commodity prices will help trade tallies. But they could also be a double-edged sword for India as its strategic gambit to import more Russian oil has turned less lucrative. Moreover, sticky inflation could further dampen demand, especially in key markets such as the European Union, which just hiked interest rates to a record high. Inflation reheated in the United States last month, but not enough yet to dent festive demand that may lift order books in coming months. That engineering goods, which account for a quarter of India's exports, clocked their first uptick after eight months in August, with half of the 14 key segments of exports growing — the best performance in nine months — is a welcome sign. India needs to do all it can to nurture precious green shoots and support exporters.

## New Delhi Walked A Tightrope Between The West's Demands And Russia's Expectations

s was expected, the G20 summit turned out to be a loud, flamboyant gabfest that brought India and prime minister Narendra Modi's leadership into global focus. Most of the spotlight was of a favorable kind. The western powers led by the US were more than willing to acknowledge India's arrival on the global stage - of course, more as a power that could act as a countervailing force to China, now effectively the world's No 2 power raring to take over as the No 1. And to that end, the summit made quite a statement. More so, with Chinese president Xi Jinping and his Russian counterpart Vladimir Putin choosing to give the summit a conspicuous miss

But New Delhi has made it clear through its diplomacy that it doesn't want to be seen as taking sides between the US and China albeit, in recent years, the country has grown far more closer to the US than it ever was before. China's 2020 incursions at five points along the Line of Actual Control in Ladakh made India acutely aware of its need to secure its flanks. West's support came thus handy. But it is not that only India needs the west. The west, in a sense, needs India more than vice versa. The reason is that while India only needs west's cooperation to create space for its geopolitical maneuvering in the teeth of China, the west led by the US faces an existential situation vis-a-vis China and desperately needs allies in the fight. And what better than India, a subcontinental size country with a 1.4 billion population. What is more, by the current official estimates, India is also a fastest growing economy. The alliance with New Delhi thus not only offers a decisive geopolitical advantage but also a large market

As it has turned out, India has stayed well short of allying with either of the emerging cold war blocks. It has acted in its core national interest and zealously guarded its strategic autonomy. The country has now accumulated enough military and economic muscle to act largely independently and wherever possible even throw its weight around: for example, in its relations with Pakistan, or for that matter even against Canada, as the lukewarm approach towards Canadian president Justin Trudeau at the G20 summit underlined

The G2O declaration was a best example of India playing a deft hand in international affairs: it ensured that the declaration didn't come down hard on Russia and the world including the west went along. So, once again, India effectively asserted its strategic autonomy by walking a tightrope between the west's demands and Russia's expectations. This approach also doesn't pit India against the emerging China-led bloc as Russia is its most powerful member after China. So, whichever side wins or loses in Ukraine - West or Russia -India won't be the loser.

Another geopolitical factor that goes to the advantage of India is that the US-led unipolar world birthed by the break-up of the USSR in 1989 is giving way to a multilateral world - the continuing pre-eminence of the US notwithstanding. This has given New Delhi a greater diplomatic heft in regional and global affairs. And it is apparent in current geopolitical order: India is no longer equated with Pakistan. something the West was wont to do earlier. The country is now seen as a rival to China despite the large power gap between the two. Earlier this year, a report by Center for a New American Security said that a potential India-China conflict was now a bigger worry for the West than India-Pak tension. Over the past two decades, India has incrementally left Pakistan behind in terms of conventional military and

economic advancement. But it has yet to gain a decisive advantage over its longstanding adversary. The centre of gravity of regional power equation between the two countries is still far from shifting in favour of New Delhi.

Similarly, in the case of China, while India is now amply qualified to be a geopolitical rival it is still short of measuring up to Beijing's military and economic might. Result of this is that there is a complex geopolitics in operation regionally even as the new global cold war takes shape. India faces formidable challenges in navigating a non-aligned relationship between the West and China, but it is also aggressively wooed by the two. This has strategically located the country in a geopolitical sweet spot.

Where do we go from here? It could be more of the same in the near future. China and Russia's boycott of the G20 has added to the existing bitterness in the geopolitical affairs. Much will depend on the outcome of the ongoing war in Ukraine. America, despite its setback in Afghanistan, its failure to have its way in Syria, and its difficulties in pushing Russia out of Ukraine, remains the world's pre-eminent power. Its GDP and defense expenditure remains several times higher than its nearest competitor China. That said, we are at an interesting moment in history. The victor in Ukraine will determine the new global geopolitics if not the new superpower of the world. And as the G20 summit underlined, India won't be on the wrong side of the new order.

# The Secret to Staying Grounded Around Negative People

We all have them in our lives—people who complain constantly, who are hyper-focused on everything that's wrong or about to go wrong, and for whom life plays out on a backdrop of doom and gloom.

It's very hard to be around such people because their negativity begins to color our world as well. Emotions are contagious, after all, and even if they don't express their misery in words (which they regularly do), we can feel the heavy weight of their emotions.

I remember during the peak of the pandemic a couple of years ago, I and my four teenage kids were locked down in a tiny apartment in downtown Toronto. It wasn't an easy time for anyone, but, for them in particular, being pulled out of university to live with Mom again wasn't exactly the life they wanted.

Their negativity was constant, and nothing was ever right. Someone spoke too much, someone typed too loudly. The radiator was too hot, the weather was too cold, the professor was a farce, the chair was stupid because it broke their back. And now they couldn't work because Amazon was too slow...Really??

I may have found the humor in it if not for the fact that the barrage of complaints left me drained, mentally and emotionally. I was unable to focus and was struggling to meet deadlines on my book Goodbye, Perfect. And I was harming my physical health because I couldn't turn off my mind at night: Why are they so ungrateful? Can't they see millions have it way worse?

I've failed as a parent.

Two months in, and I felt I was losing my mind. Things needed to change. I told them their constant complaints, urghs, and other expressions of misery and anger had to come to an end. They had better keep their emotions to themselves so



we could have a relatively pleasant time together.

And there was no way I could ask them to

Little did I realize the far stronger force of unexpressed emotions. Even though the complaints fizzled, that heavy weight of negativity seemed to only get heavier. not feel. I'd arrived at the end of my locus of control.

It turned out to be a good thing after all because I was called to practice what I already knew from the science: When we're at the receiving end of someone's constant negativity, or when we're prone to pick it

up like sponges, we have to find the calm we seek within ourselves.

Practicing Self-Compassion

I truly believe that life challenges us to grow in areas where we have the greatest

room for growth. This was certainly one for me. I'd learned over time to manage my inner critic and replace it with the voice of compassion and nonjudgment toward myself.

But when my inner world was rattled by someone else's actions, I didn't even think of turning inward. It never dawned on me that I was suffering, and, again, I needed that same inner presence of compassion to hold me in her embrace and let me know she could feel my pain.

The more I learned to extend grace and compassion to myself for what I was going through, the more I was able to open my heart to my kids. Instead of trying to force perspective down their throats, I could remind myself that suffering doesn't become easier when we compare our struggles with those of others. It simply adds a layer of guilt to it.

If you're living or working with someone whose negativity is affecting you adversely, begin with self-compassion. It could be in the form of a self-compassion meditation that you practice every morning or whenever you're struggling. Or it could be a loving presence you build inside yourself and bring to mind when your internal world is being rattled.

## **Apple Has Switched From Its Lightning Connector To USB-C**

## Find Out Which Is Better And Why They Did It

The Conversation

fter many years of designing and selling a variety of different cables to power and charge its devices, Apple has slowly switched to USB-C chargers for all of its products.

The last device to swap is the iPhone, and it happened against Apple's will. In October last year, the European Commission requested all phones and laptop producers switch to the USB-C connector (which had earlier been agreed on as a common standard).

Apple could have chosen to ignore the request and stop selling in the EU, or to produce versions with USB-C for the European single market only. Instead, it chose to comply and follow the EU rules everywhere. The common charger for all devices is thus becoming a reality, at least until the world moves completely to wireless charging.

way. It might seem trivial now, but this was not the case with any other charger. If you are using the standard USB port on your laptop now, you are likely to spend a lot of time plugging the cable in and taking it out in order to find the right orientation. You're probably also complaining about how inconvenient it is. At least, that's what I do.

The USB-C connector came out about two years after the Lightning. There was nothing particularly novel or remarkable about it compared to Apple's cable. However, one notable feature was that it borrowed the Lightning connector's reversibility.

USB-C is just the name of the connector, not the entire cable. The cable and connector are part of a bigger technical specification called USB-4. USB-4 outperforms Lightning in every technical dimension conceivable. It can transfer data much more quickly: up to 40Gbps (gigabits per second) for USB-4 versus 480Mbps (megabits per second) for Lightning. It also charges devices more swiftly, to the point that Apple started selling Light-

ning to USB-C adaptors. The main difference between the two, however, is that UBS-C is not proprietary. It was developed by a consortium called the USB implementer forum. This consortium is composed of companies such as Intel and Microsoft – and also Apple.

All of the USB standards

can be used by any business. Apple, on the other hand, does not allow anyone else to use its proprietary accessories, unless they agree on a license. This means that USB-C is compatible with many more devices, including all recent Apple products, but not previously with the iPhone.

#### When it pays to be different

So, what's so special about the Lightning connection that made Apple stick with it for so long, despite repeated promises to join its competitors on a common standard? Why would Apple sabotage one of its own phones by keeping a substan-

dard charging connection? One possibility is that consumers are inattentive when they buy a phone, and do not directly factor in the cost of accessories such as chargers. If this is true, Apple would have needed these add-ons to remain proprietary and make sure no competitor could start offering them for a lower price. If so, forcing Apple to offer the better standard benefits all consumers.

The alternative explanation is that some consumers actually value the Lightning connection more. After all, the look is different, and Apple fans argue that it may be harder-wearing than other standards. It is also a signal of status and exclusivity.

We seem to have reached a stage in the market for smartphones where people who only care about everyday usage replace their device much less often. This is probably because technology is not evolving at the same pace it did in the past. Yet, it's also the case that demand for high end phones continues to increase.

This could be because they cater to a subset of consumers who either greatly value a marginally higher quality of camera or slightly bigger storage. But mostly, expensive phones are a way to signal social status.

People buy the latest phone not only because they want to own it, but also to be seen as owning one. This is certainly a factor that has helped Apple thrive because the company offers products that are visibly different from the cheaper alternative. And another sign of status for Apple users is having different accessories, including the proprietary chargers.

Apple has not always been so keen to reject common standards. Not only is it one of the participants in the USB consortium, but it is also the company that helped USB become the global standard by offering it on its first generation of iMacs.

At the time, however, Apple was the underdog in the market for personal computers, facing off against the tech giant Microsoft. And a big reason why many people did not buy Apple computers at the time was their fear they would not be compatible with Microsoft products.

### **India's Direct Tax Collection** Surges By 23.51%To Over **INR 8.65 Lakh Crore**

**NEW DELHI:** The net direct tax collection increased 23.51 per cent to over Rs 8.65 lakh crore till mid-September on higher advance tax mop-up from corporates, the Finance Ministry said on Monday.

The net collections have reached 47.45 per cent of the full-year budget estimates (BE) of Rs 18.23 lakh crore.

The steady growth in tax collection was helped by a 21 per cent growth in advance tax mop-up. September 15 was the last date for paying the second instalment of advance tax for 2023-24.

In a statement, the ministry said the net direct tax collection includes corporate income tax (CIT) at Rs 4,16,217 crore and personal income tax (PIT), including Securities Transaction Tax (STT), at Rs 4,47,291 crore.

The net direct tax collection of Rs 8,65,117 crore for the current fiscal as of September 16 grew at over 23.51 per cent, the ninistry said.

The advance tax collection stood at Rs 3.55 lakh crore till mid-September, a 21 per cent growth against Rs 2.94 lakh crore mopped up in the corresponding period of the preceding financial year.

The advance tax collection of Rs 3.55 lakh crore as of September 16 comprises CIT at Rs 2.80 lakh crore and PIT at Rs 74,858 crore.

Refunds of about Rs 1.22 lakh crore have been issued up to September 16.

On a gross basis, the direct tax collection for the financial year 2023-24 stands at Rs 9.87 lakh crore, an 18.29 per cent growth over Rs 8.34 lakh crore in the corresponding period of the preceding financial year.

The 2023-24 budget has pegged the direct tax collection at a little over Rs 18.23 lakh crore, a 9.75 per cent higher than Rs 16.61 lakh crore mopped up last fiscal.

## **CBI Files Case Against** Infra Firm In ₹3,847 Crore **Bank Fraud Case**

**NEW DELHI:** The Central Bureau of Investigation (CBI) has booked Mumbai-based Unity Infraprojects Ltd, its then CMD Kishore Krishnarao Avarsekar and others for allegedly defrauding a consortium of banks to the tune of ₹3,847.58 crore, officials said on Monday.

The CBI took action on a complaint of the SBI, one of the consortium members which alleged that the fraud took place at its Commercial Branch in Mumbai where the accused persons siphoned the "Bank's funds by doing fictitious transactions, manipulated and fudged books of accounts with an objective to defraud and cheat the bank and to gain. unlawfully at the cost of the Banks' funds"

The account of the 44-year old infrastructure company, which had taken ₹3,800 crore from 23 lenders against moveable and non-moveable assets besides personal and corporate guarantees, had become a non performing asset on June 24, 2014. Five years later it was



declared a fraud after forensic audit pointed irregularities.

The bank alleged that the fraud came to light in a forensic audit conducted by BDO India LLP, which submitted its report on September 25, 2019.

The report found fictitious transactions, improper adjust ment entries passed to accommodate fictitious accounting entries to defraud the bank by fudging the data, diversion of funds through non-consortium accounts among others.

It also cited unexplained excess pay-outs with intentions to siphon off bank funds and related party transactions to divert borrowed fund.

## Govt To Roll Out Credit, **Insurance Packages For Farmers Today**

**NEW DELHI:** Finance Minister Nirmala Sitharaman and Agriculture Minister Narendra Singh Tomar will on Tuesday inaugurate the 'Kisan Rin Portal' to help farmers avail subsidised loans under the Kisan Credit Card (KCC).

A door-to-door KCC campaign and a manual of the Weather Information Network Data Systems (WINDS) portal will also be launched at an event to be held at the Pusa complex.

According to the agriculture ministry, the Kisan Rin digital platform offers a comprehensive view of farmer data, loan disbursement specifics, interest subvention claims, and scheme utilisation progress, fostering seamless integration with banks for more focused and efficient agriculture credit.

There are about 7.35 crore KCC accounts as of March 30 with a total sanctioned limit of Rs 8.85 lakh crore, it said in a statement.

As per the official data, the government has disbursed agri-credit of Rs 6,573.50 crore at subsidised interest rate during April-August this fiscal.

To extend the benefits of KCC, the door-to-door campaign will reach non-KCC



holders of beneficiaries of the central scheme PM-KISAN, under which Rs 6,000 per annum is given to each identified beneficiary farmer's bank account.

In the case of the WIND portal, the ministry said the manual extends the impact of the Weather Information Network Data Systems (WINDS) initiative.

The portal -- launched in July -- leverages advanced weather data analytics to provide stakeholders with actionable insights on weather for informed decision-making in agriculture.

This comprehensive manual also provides stakeholders with an in-depth understanding of the portal's functionalities, data interpretation, and effective utilisation, empowering farmers, policymakers and various agricultural entities to make well-informed choices.

It also caters to the parametric crop insurance scheme of the ministry, in addition to non-scheme parametric insurance programmes for crop risk mitigation and disaster risk reduction and mitigation being run by the insurance industry, the statement said.

## **Indian Economy Gaining Strength Amid Weakening Global Prospects: RBI Article**

MUMBAI: Amid weakening global prospects, the Indian economy is gaining strength led by domestic private consumption and fixed investment with strong public sector capital expenditure, said an article published in the latest RBI bulletin.

The outlook for the global economy remains ambivalent, driven by a dichotomy in macroeconomic conditions across regions, the article on 'State of the Economy' stated.

While expectations of a 'Goldilocks' soft landing in the US are strengthening, concerns about slowdowns in China and Europe are rife, it said, and added that the impact of aggressive monetary tightening is spreading, with the services sector joining housing, bank lending and industrial production in a loss of momentum.

The article authored by a team led by RBI deputy governor Michael Debabrata Patra also noted that India's G20 Presidency and its outcomes with the ethos of 'Vasudhaiva Kutumbakam' as the vision of global progress assume significance in an environment where global economic activity is experiencing a loss of momentum with a dichotomy in macroeconomic conditions across regions.

"Amidst weakening global prospects, the Indian economy is gaining strength led by domestic drivers - private con-



sumption; and fixed investment with strong public sector capex.

"Supply responses are improving and headline inflation has softened in August from the previous month's peak," it said.

The central bank, however, said views expressed in the article are those of the authors and do not represent the views of the Reserve Bank of India.

The article further said India's space efforts are significant for the country's socio-economic development. The space industry plays a key role across several application areas, including weather forecasting, geological and oceanographic studies, disaster management and agriculture, to name a few.

It has also played a crucial role in the country's defence and security. Currently, India accounts for about 2 per cent of the global space economy, but this share is set to grow exponentially with rising private participation.

Chandrayaan-3 and Aditya L1 will boost India's capability to undertake complex space missions that contribute to the advancement of space technology for the betterment of humanity, the authors said.

**NEW DELHI:** The rupee depreciated for the fourth straight day to settle 13 paise lower at its lifetime low of 83.29 (provisional) against the US dollar on Monday, mainly due to risk aversion in global markets and rising crude oil

prices. Besides, strong Americurrency can against key rivals overseas and a negative trend in domestic equities weighed on investor sentiments, according to forex traders.

At the interbank foreign exchange, the domestic unit opened at 83.09 against the dollar and traded in the range of 83.09 to 83.30 against the

previous close. On Friday, the rupee fell 13 paise to settle at 83.16 against the US dollar. The dollar index, which

MUMBAI: Snapping its record 11-day winning run, Sensex declined by around 242 points on Monday as profit taking in metal, banking and telecom shares amid weak global trends dragged down the benchmark index from record high levels.

The 30-share BSE Sensex fell by 241.79 points or 0.36 per cent to settle at 67,596.84 in a volatile trading. During the day, it declined by 305.8 points or 0.45 per cent to a low of 67,532.83.

Retreating from its all-time high, the broader Nifty closed at 20,133.30, down by 59.05 points or 0.29 per cent, as 26 of its constituents closed in the red while 24 advanced.

BSE Sensex closed at a life-time high of 67,838.63 after 11 straight days of gains while Nifty settled at record 20,192.35 on Friday following positive macro data.

Among the Sensex firms, HDFC Bank fell the most by 1.98 per cent. Bharti Airtel (1.71 per cent), Infosys (1.4 per cent), Tata Steel (1.21 per cent), UltraTech Cement (1.19 per cent), Wipro (1.17 per cent), Kotak Mahindra Bank (1.02 per cent), Reliance Industries, Tech Mahindra and JSW Steel were the major laggards.

Power Grid, Titan, Mahindra & Mahindra

and NTPC were among the gainers. "Markets finally reversed the 11-session winning streak as profit-taking came into play in banking, realty, IT and telecom stocks. Along with concerns over rising global crude oil prices and uptick in dollar index and US treasury yields, investors trimmed their exposure ahead of the outcome of the US FOMC meeting on interest rates on Wednesday,"

Jammu: The State Election Commission Union Territory of Jammu and Kashmir on Monday notified the schedule for preparation of 2nd supplement to the Panchayat Electoral Roll, 2023 with 01-01-2023 as the qualifying date.

According to a public notice issued here in this regard stated that the electors of the area can accordingly submit (File) claims and objections regarding additions, deletions, corrections and transpositions of entries in the existing Panchayat Electoral Roll to concerned EROS with effect from 20.09.2023 to 29.09.2023.

The notice said that the Electoral Registration Officers (EROS) shall get Panchayat Electoral Roll, 2023 displayed at prominent locations in Halqa Panchayat on 20-09-2023 (Wednesday) along with public notice. Besides, special camps would be held at the Polling Booth Locations on 23.09.2023 (Saturday) and 24.09.2023 The Panchayat Election Booth Officials (PEBO i.e, VLW/MPW/GRS) along with the Assembly BLOS shall remain available at the Polling Booth Locations with the requisite Forms and Panchayat Roll, 2023 for guidance of the electors.

The document further added that disposal of claims and objections by ERO would be done with effect from 30.09.2023 (Saturday) to 06.10.2023 (Friday). Again, publication of voter list with the supplement will be done on 10.10.2023 (Tuesday).

The notice stated that as per sub rule 4 of Rule 4 of the Ĵammu and Kashmir Panchayati Raj Rules, 1996 (SRO 690 dated 25.10.2019), the Electoral Roll of constituencies of the Panchayat

Halqa shall be prepared in accordance with the provisions of J&K Panchayati Raj Act 1989 and the procedure prescribed by the Election Authority.

The Panchayat Electoral Rolls have been updated/revised with reference to 01.01.2023 as the qualifying date and the final Panchayat Electoral Rolls have been published on 10.02.2023. Likewise, the term of the present Panchayats is finishing on 09.01.2024 and as per section 42 of the Jammu & Kashmir Panchayati Raj Act, 1989, the Elections to Halqa Panchayat shall be held one month prior to the expiry of the term.

Jammu: Six hundred indigenously-manufactured neutralising anti-tank mines, known as "Vibhav", have been inducted into the Army to provide mobility kill against all enemy armoured vehicles, officials said on Monday.

The anti-tank mine is made of new-age plastic, which gives it adequate strength and durability to withstand the requirements of storage, handling and operating in varying field conditions, they added.

"It (the 'Vibhav' anti-tank mine) is already in production. It has been completed. It is now in demand. It has been inducted into the Indian Army. Six hundred mines have been inducted (recently)," an official of the manufacturing company told PTI.

Designed and developed

completely indigenously in a joint venture with the Defence Research and Development Organisation (DRDO) in India, "Vibhav" is a point-attack antitank munition, the officials said.

They said the mines are designed to provide mobility kill against all

enemy armoured vehicles.

The munition can be laid both mechanically or manually, he added. A host of safety and actuation mechanisms have been incorporated in "Vibhav" to make it safe to handle, lethal against targets and reliable, the officials said. The integrated explosive, mechanical and electronic

safety features ensure utmost operator safety, they added.

On the other hand, the lethality of the munition ensures effectiveness against all current and futuristic armoured vehicles, the officials said.

The munition also incorporates an electronic antihandling and anti-lift device (EAHALD) that stays active for 120 days once armed, they said.

"We have made three changes in this mine. It has mechanical timers now. Due to this, after 120 days, it will be selfneutralised. It was not available in the earlier mines," one of the officials said.

Every non-official member selected/nominated under rule 6 shall hold his office for a period of three years and shall be entitled to sitting allowance, travelling allowance, daily allowance and such other allowances as are applicable to non-official members of similar commissions/ committees of the J&K UT.

As per the rules, the Mission Director, National Health Mission, J&K would be the Chief Executive Officer of the Mental Health Authority, while a senior MBBS doctor with a Masters in Health Administration or Master in Hospital Administration would be nominated as a Medical Advisor to CEO.

The Mental Health Authority with the approval of the government shall determine the number, nature and categories of the officers and employees required for the discharge of

According to the notification, every mental health establishment in the Union Territory, except the mental health establishment under the control of the Central government, shall be registered with the Mental Health Authority of J&K UT.

Every such establishment as referred to in sub-rule (1) shall apply for registration along with details given there in Form B, and a fee of Rs 20,000 by way of DD in favour of Chairperson, J&K Mental Health Authority. The provisional registration certificate granted under sub-rule (3)of rule 10 of the Act shall be valid for a period of 12 months from the date of such grant.

For renewal, one should apply within 30 days of the expiry of the period of validity. The renewal fee for the same will be Rs 5,000. The authority shall maintain a digital register of all such establishments and professionals, category-wise including clinical psychologists, mental health nurses and social workers as mental health professionals.

The rules have been made for the proper implementation of the Mental Healthcare Act 2017 in J&K. Now the mental health establishments in I&K would be audited and inspected to ensure transparency, while the Mental Health Authority would maintain accounts of its income, expenditure, and online register

However, a candidate for the area moved to the Deputy Commissioner upon Khujuria figuring in waiting list of an examination conducted by JKSSB, contending that the certificate of ALC category issued in favour of the appellant in the year 2008 and renewed in the year 2013 by the Tehsildar, Akhnoor was contrary to and in violation of Jammu & Kashmir Reservation Act, 2004 and the J&K Reservation Rules, 2005.

Accordingly, vide his order dated 17.02.2018, the Deputy Commissioner, Jammu cancelled the certificate of ALC category issued in favour of Khujuria. The nation's largest lender, State Bank of India, is adopting a novel way to ensure timely repayments, especially by its retail borrowers, by greeting those likely to default on monthly installments with a pack of chocolates.

According to the bank, it has been found that a borrower who is planning to default will not answer a reminder call from the bank. So the best way is to meet them at their homes unannounced.

The move, aimed at ensuring better collections, comes amidst rising level of retail lending in the system coupled with increasing delinquency levels on the back of the upward movement in the interest rates.

SBI's retail loan book grew over 16.46 per cent to Rs 12,04,279 crore in the June 2023 quarter from Rs 10,34,111 crore in the year-ago period, making it the largest asset class for the lender whose total book stood at Rs 33,03,731 crore, growing at 13.9 per cent on-year.

In fact for the entire system, the double-digit loan growth of around 16 per cent has been led by retail loans only.

At Rs 61.8 crore, Amrita Sher-Gil's 'The Story Teller' Becomes Most Expensive Work By Indian Artist Ever

New Delhi: Fetching a whopping Rs 61.8 crore, avant-garde artist Amrita Sher-gil's oil on canvas "The Story Teller" has unseated Sayed Haider Raza's "Gestation" in becoming the most expensive work of Indian art sold at auction worldwide.

The 1937 artwork, sold here on Saturday at Saffronart's 'Evening Sale: Modern Art', was among the 70 plus art pieces by eminent artists including MF Husain, VS Gaitonde, Jamini Roy and FS Souza, featured in the auction.

It was only last month that Raza's 1989 "Gestation", also an oil-on-canvas painting, was sold at Rs 51.75 crore by Pundole's auction house in Mumbai, becoming the most expensive Indian artwork ever sold at auction.

"We are delighted to have set multiple artist records at our Evening Sale in New Delhi this September. Most significantly, the record price achieved by Amrita Sher-Gil's 'The Story Teller' is an important milestone in the Indian art market and testament

to the artist's immense skill and enduring legacy as one of India's art treasures," said Dinesh Vazirani, CEO and cofounder of Saffronart.

"The Story Teller", touted to be among the 12 works selected by Sher-Gil herself as her most important works, is widely considered an example of the artist's most honest and expressive compositions.

The dominant subjects for the eminent artist are women, primarily because she could lend her empathetic self most easily to their condition. The painting was first exhibited at Sher-Gil's successful solo exhibition at Faletti's Hotel, Lahore, in November 1937.

other well-known portraits of women include "Three Girls", "Women on the Charpai", "Hill Women", and 'Young Girls".

Born to Indian father and Hungarian mother on January 30, 1913 in Budapest, Hungary, Sher-Gil came to be known as one of the greatest avantgarde women artists for her

From the early age of five, Sher-Gil immersed herself in drawing and painting with watercolour. Her early works consisted of vibrant illustrations of Hungarian fairy tales with captivating characters. In 1921, the Sher-Gil family returned to India and settled in

It was there that she honed her observational skills, capturing the essence of those around her through meticulous sketches. She died at the young age of 28 in 1941.

In 1976, she was declared one of India's nine 'National Art Treasure' artists by the Archaeological Survey of India.

Besides Sher-Gil, the auction smashed a few other records as well. For instance, renowned painter and art educator KK Hebbar's 1959 untitled work, sold for Rs 2.64 crore -- more than seven times its higher estimate -- made a world record for the highest price achieved by the artist globally.

It also witnessed sale of Raza's monumental work "Earth" for Rs 19.2 crore, early expressionist Tyeb Mehta's "Red Figure" for Rs 9 crore and FN Souza's "Caribbean Palm" for Rs 4.56 crore.

# Bystanders Less Likely To Give Life-Saving CPR To Women Having A Cardiac Arrest In Public: Study

Bystanders are less likely to give life-saving CPR to women having a cardiac arrest in public than men, potentially leading to more women dying from the common health emergency, according to a study.

The research, presented at the European Emergency Medicine Congress in Spain, also shows that in private locations older people, especially older men. are less likely to receive cardiopulmonary resuscitation (CPR). "In an emergency when

not breathing properly, in addition to calling an ambulance, bystanders should give CPR. This will give the patient a much better chance of survival and recovery," said Alexis Cournoyer, an emergency medicine physician at the Hopital du Sacre-Coeur de Montreal, Canada.

"We carried out this study to try to uncover factors that might discourage people from delivering CPR, including any factors that might deter people from giving CPR to a woman," added Sylvie Cossette, a Ph.D. nurse researcher at the Montreal Heart Institute research center, Canada.

The yet-to-be peer-reviewed study used data from records of cardiac arrests that happened outside of hospital in Canada and the US between 2005 and 2015, including a total of 39,391 pa-

tients with an average age of 67.
They looked at whether or not a bystander performed CPR, where the emergency took place, and the age and gender of the patient. The team found that only around half of patients received CPR from a bystander (54 per cent). Overall, women were slightly less likely to be given CPR (52 per cent of women compared to 55 per cent of men).

However, when the researchers looked only at cardiac arrests that happened in a public place, such as the street, the difference was greater (61 per cent of women compared to 68 per cent of men). These lower rates of CPR in public were found in women regardless of their age, according to the researchers.

When they looked at cardiac arrests that happened in a private setting, such as a home, the data indicated that with every ten-year increase in age, men were around 9 per cent less likely to be given CPR during a cardiac arrest.
