4 Of Doda Family Killed In Highway Accident

Srinagar: Four members of a family, including a couple and their daughter were killed on Friday in a horrific road accident along the Srinagar-Jammu highway in Qazigund area of South Kashmir's Kulgam district.

The bone-chilling accident caught on camera in the early hours on Friday, went viral on social media platforms like Facebook and Twitter leaving netizens in shock and despair.

A Maruti Eeco van (JK06B 0901) carrying seven mem-bers of a family, was on its way to Srinagar from Doda when a speedy truck hit it near Levidora crossing in Qazigund area on Friday morning, reports said. The van driver was taking a turn at the crossing when the truck hit the extreme left portion of the vehicle pushing it several feet away.

All the seven inmates suffered serious injuries in the road accident and were removed to the Qazigund emergency hospital for treatment. However, the driver of the ill-fated vehicle succumbed to his injuries.

Other six injured members of the family, reports said, were



referred to Government Medical College (GMC) Anantnag for advanced treatment. However, four among those with critical injuries were referred to SK institute of medical sciences for specialized treatment.

Three among those later succumbed to injuries, talking the death toll in highway accident to four.

The deceased have been identified as Muhammad Nawaz Bhat, wife Mubeena and daughter Aisha. The fourth victim has been identified as Bhat's nephew Maroof Ahmed. The condition of another family member Ghulam Qadir Bhat is stated to be critical, while two

others identified as Mehvish and her brother Mumtaz Ahmed are out of danger. Meanwhile, police have seized >> More On P10

Delhi HC Refuses Bail To 'Terrorist Recruiter'

Cough Sounds Analysed For Assessing Covid Severity In Patients In A New Study

A cough analysis could soon reveal disease severity in COVID-19 patients, researchers said.

Differences in cough sounds depending on the severity of the respiratory condition were observed, the research team led by the Institute for Bioengineering of Catalonia (IBEC), Barcelona, Spain, said.

The results indicated that analysing coughs could help categorise Covid patients as mild, moderate, or severe and also monitor those with persistent infection, they said in their study published in the European Respiratory Journal Open Research.

Cough sounds of 70 patients with SARS-CoV-2 infection were recorded on the smartphone in the first 24 hours following hospital admission.

Previously, studies have analysed cough acoustics for diagnosing respiratory diseases, while this study "specifically investigates the connection between the acoustic characteristics of coughs and the varying levels of pneumonia severity in COVID-19 patients," said Raimon Jane, a senior co-author of the study and the principal investigator at IBEC.

Five frequency-based parameters of the cough sounds differed significantly with varying levels of



disease severity and pneumonia progression, the researchers found by statistically analysing data collected between April 2020 and May 2021 at Hospital del Mar in Barcelona.

These differences may reflect the progressive respiratory system changes in patients with COVID-19, they said.

Jane's signal processing group at IBEC developed the methodology and algorithms for the acoustic analysis of cough signals collected via smartphones.

Further, cough analysis can serve a dual purpose - early Covid detection and remote monitoring of disease progression. the authors said, adding that further research involving more patients



study findings.

Joaquim Gea. Despite being Covid-oriented, the study paved the way for applying this model in the context of other respiratory conditions, the researchers said, adding that the method presented a potential predictive, simple, and accessible tool to assess the risk of suffering severe pneumonia.

During the market checking drives conducted under the supervision of Assistant Commissioner Food Safety (Designated Officer under FSSA Srinagar), Yameen ul Nabi in and around Hazratbal area, Bemina and Qamarwari, Mobile Food Testing Van was put in place to

check the quality of ready to Eat Food being sold in the area during which as many as 40 samples of Ready to Eat Food were tested in Mobile Food Testing Van on the spot.

The Food Safety Department Srinagar also inspected food Canteens at JVC and Children Hospital Bemina.The checking teams also lifted about 14 surveillance samples and 6 legal samples were also sent for analytical purposes.

In this regard, the Deputy Commissioner, Srinagar has asked the Food Safety Department and other Market Checking teams to continue the drive in City markets to ensure all essential commodities are sold at Government approved rates as per the Food Safety Standards and Quality.

KU's Medical Store Faces Acute Shortage Of Medicines, Patients Aghast

Srinagar: The medical store at the health centre in Kashmir University is facing acute shortage of medicines which are provided on a free of cost basis to patients, students complained here on Friday.

The shortage of the medicines in hospital drug stores have been forcing patients admitted in the wards and the outdoor patient department (OPD) visitors, to purchase prescribed medicines from private chemist shops at higher rates.

The students alleged that the UT government had launched the free medicine scheme in all government health institutions but shortage of providing the essential drugs has exposed the inability of the health department to provide better health facilities.

"My friend was suffering from a high fever a few

days ago. We rushed to the university health center, but to our surprise, they only provided us with two paracetamol tablets and asked us to purchase the remaining prescribed medicines from private shops," said Adil Ahmad, a third-semester univer-

sity student. "I had a severe flu for a few days, and when I went to the university health center, they didn't have the necessary medications. They told me to go to a nearby pharmacy, which was an inconvenience," said Nida Khan, a

fourth-semester student at the university. Meanwhile, the students urged the senior health officials to address this issue promptly and ensure that essential medications are stocked at the health center to alleviate the suffering of patients.

Students can take shorter GRE from September 22 onwards: **Educational Testing Service**

2004 Doda Grenade Blast

HC Upholds Acquittal Of 3 Accused

JAMMU: The High Court of J&K and Ladakh on Friday upheld acquittal of three persons in connection with a grenade attack which according to police was aimed at police picket manned by CRPF but exploded in an adjacent residential house, killing two minor kids and injuring their parents in Doda district in 2004.

Subsequent to the filing of chargesheet against the trio, the trial court— Additional Sessions Judge, Doda acquitted the trio of the charge under Section 302, 307, 34 RPC on 2 June 2010. The state had filed appeal against the acquittal and a bench of Justice Sanjeev Kumar and Justice Puneet Gupta dismissed it, observing that it was not the case for interference with the judgment of acquittal recorded by the trial Court.

"Needless to emphasize that the scope of interference with the judgment of acquittal in appeal is circumscribed and even if, on evaluation of the evidence on record, two views are possible, the Appellate Court would take the view that favours the accused," the court said, adding, "It is cardinal principle of criminal jurisprudence that accused is presumed to be innocent unless proven guilty and this presumption gets fortified with the ac-

quittal by the trial Court." According to the prosecution, on the fateful day some unknown militants had hurled an RPG on a police picket with a view to killing CRPF personnel. The RPG,

however, missed the target and blasted in the house of one Mohammad Hanief due to which his two children, namely, Nassra Banu and Baber aged 1 ½ years and 9 years respectively were injured and succumbed to the injuries on spot, the prosecution said. Hanief's wife, Shahida Begum, was seriously injured and taken to Thathri hospital for treatment. Hanief too, was injured in the incident and was taken for treatment to Kahara.

Police had subsequently filed the case— FIR No.80/2004— for offences under Sections 302, 307, 34, 109 RPC and 7/27 Arms Act in Police Station, Gandoh.

Cong Stages Protest, Demands CBI Probe Into JJM 'Scam'

JAMMU: The Congress staged a protest here on Friday demanding a probe by the Central Bureau of Investigation (CBI) into an alleged scam of Rs 14,000 crore in the implementation of the Jal Jeevan Mission in Jammu and Kashmir.

Raising slogans against the BJP, the protesters tried to march from the Congress headquarters at Residency Road to the Raj Bhavan but were stopped by police. The protest was led by Jammu and Kashmir Congress unit pres-

ident Vikar Rasool Wani. Wani announced that the party's youth wing would start a signature campaign from Saturday to know whether the people want assembly elections or continuation of the Lt Governor rule. "Our signature campaign will try to find out the opinion of the public," Wani said in an apparent reference to Lt Governor Manoj Sinha's reported statement that a survey revealed 80 per cent population of Jammu and Kashmir do not want elections as they are satisfied with his administration. The Congress leader claimed that the people of Jammu and Kashmir were fed up with the BJP and wanted early restoration of a democratically elected government.

He said they are on the streets due to "wrong policies" of the BJP whose leaders are not listening to the people.

Wani said senior IAS officer Ashok Kumar Parmar who headed the Jal Shakti department claimed a scam worth Rs 14,000 crore in the implementation of the Jal Jeevan Mission in the Union territory.

"There must be a CBI probe into the allegations to unravel the truth," he said.

"As such, as and when any report of encroachment of Evacuee land is brought into the notice of the department, stern action in collaboration with Revenue/ Police Department should be taken" he said. The Custodian General J&K also asked the Deputy Custodians to liaise with the District identify Administration to evacuee land/property which has potential for commercial purpose including other lands which may be fenced and sign

boards installed to avoid any encroachment.

He further asked that the land not viable for departmental use be put to open auction through e-auction mode for which the department has already developed an e-auction portal.

Acting upon the directions of Custodian General J&K, the Evacuee Property Department Jammu through Dy. SRINAGAR: Political parties in Jammu and Kashmir on Friday strongly condemned BJP MP Ramesh Bidhuri's objectionable remarks in the Lok Sabha against BSP parliamentarian Danish Ali.

While National Conference leader Omar Abdullah said Bidhuri's remarks against the BSP MP revealed what the BJP thinks about Muslims, PDP chief Mehbooba Mufti said the BJP should "spray phenyl" to stop its leaders from using such foul language.

Bidhuri made certain objectionable remarks targeted at Ali on Thursday night during a discussion in the Lok Sabha on the success of

the Chandrayaan-3 lunar mission. Abdullah said he felt both ashamed and angry over it.

"If he had been only called a terrorist, I can understand as we are habitual to hear it. But he has been called such things that I do not want to repeat here. I am ashamed that such words were used in the Parliament... I am angry also because these words were used against all Muslims. I don't understand how the Muslims in BJP are bearing it," the former chief minister said. "The words that were used were for entire Muslim community, it was not only against one honourable MP. It reveals their thinking towards Muslims. The Parliament is new but the thinking is old, deplorable," he told reporters here. PDP leader Mufti, another former chief minister, also condemned the Bidhuri's remarks. "The BJP should have sprayed phenyl to clean the mouths of their people so that the beasts like him (Bidhuri) could not use such foul language," she told reporters.

When asked about steps that should be taken by the government in J-K, Abdullah said the biggest step will be to give the people their own government.

"Whoever wins the elections let them form the government. Why are they running away from elections, I don't understand. The situation is not so bad that you cannot hold elections. Let's see what they do next," he added. On the arrest of deputy superin-

tendent of police Sheikh Adil here on Wednesday following a warrant from a local court, Abdullah said if he has been arrested, the police must have evidence against him.

"I know Adil to the extent that he was posted at Airport few years ago where we would meet each other. He has relations with our party. He is son-in-law of one of our leaders. I can understand what they must be going through.

"Now, they have arrested him, let them proceed with the case. Whatever the court decides will be acceptable to all," he said.

f late, Jammu and Kashmir has witnessed a troubling series of events, each more disquieting than the previous ones. These occurrences have implicated teachers who, regrettably, have not only violated the trust placed in them but have also tarnished the sacred bond between teachers and students.

These incidents are forcing us to think whether a few individuals with questionable intentions have cast a shadow over this foundation. Hence, it is crucial that we delve into these deeply troubling instances of alleged sexual exploitation and improper behaviour taking place within our educational institutions, addressing them comprehensively to safeguard the integrity of this crucial relation-

ship. Few months ago, a principal of a higher secondary school was arrested, ignominiously, for allegedly molesting and harassing a girl student. This distressing incident served as the continuation of a string of similarly disheartening events that have deeply affected our society. The accusations encompass various transgressions, including phone calls and troubling leaks of inappropriate conversations, all of which undermine the fundamental trust within the teacher-student relationship.

This troubling pattern extends to religious schools as well, where Molvis have been accused of sexually molesting underage girls. An illustrative instance took place in Srinagar, involving a Molvi from Uttarakhand, Andhra Pradesh, underscoring the widespread occurrence of such troubling events within these institutions.

Pertinently, these occurrences are not isolated; they resonate throughout our country and reveal a widespread issue that we can no longer ignore.

The foundation of education is built upon the trust that students and their parents repose in their teachers. Parents send their kids to school with a firm belief that teachers are not only conveyors of knowledge but also their mentors who shape their character and impart values to live a decent life. Nevertheless, when a handful of educators violate this trust by exploiting their position for

personal satisfaction, it disrupts the very foundation of our educational system.

To tackle this serious problem, we need to embrace a comprehensive approach that goes beyond punitive actions and includes preventative and educational strategies. The establishment of sexual harassment cells within educational institutions, often staffed by untrained personnel, has proven to be an inadequate effort that produces limited outcomes.

In some instances, well-intentioned female teachers entrusted with conducting awareness campaigns have inadvertently exacerbated the problem by approaching the subject insensitively. This highlights the urgent need for professional and effective training programs that tackle the issue of sexual harassment head-on, facilitated by experts who possess a deep understanding of the intricacies involved in dealing with this sensitive issue.

Our teacher training programs are not structured to address such urgent situations, and when they do, they are presented in an unrefined manner. An instance from the online Nishtha teacher training module designed by the NCERT, New Delhi, on sexual harassment featured a question that was not only in poor taste but also highly objectionable.

The true-false question presented was: "Can one infer a child's engagement or interest in a sexual act if they do not vocalize distress, resist, physically oppose, or provide consent during the act?"

Hence, it becomes crucial to adopt a proactive approach to prevention by implementing thorough training programs for teachers right from the outset of their tenure. These programs should prioritize correct classroom conduct and establish explicit, unambiguous standards for appropriate interactions with students, with the aim of instilling a safer and more supportive learning atmosphere.

In addition to addressing the content, we should also consider the language used in these training modules. The terms "Good Touch" and "Bad Touch" have been widely criticized for their insensitivity, especially when there are alternative, less invasive terms and methodologies available. It is essential to choose words that encourage understanding and empathy, rather than perpetuating discomfort or misunderstanding.

The need of the hour is to transform these training modules into professional, sensitive, and effective resources that provide teachers with the necessary tools to recognize, prevent, and address issues related to sexual harassment. This transformation should be carried out under the guidance of experts who have a profound understanding of the subject matter. We cannot afford to trivialize or mishandle a topic as delicate as this one especially when the future of our students and the reputation of our education system are at stake.

While these incidents of sexual exploitation of students by teachers are not unique to our country, what sets us apart is our response to them. It is true that laws like the Protection of Children from Sexual Offences (POCSO) Act exist, but they are only generalized ones and do not specifically address misconduct within the educational context.

In contrast, countries like the United Kingdom take a firmer stance, barring teachers found guilty of such delinquent behaviour from returning to the classroom. It is high time that we consider implementing similar stringent measures in our country to safeguard our students and maintain the integrity of our education system.

In conclusion, there is no relationship as profound and influential as that between a teacher and a student. It is a bond that shapes minds, nurtures dreams, and holds the promise of a brighter future. However, the actions of a few delinquent individuals must not be allowed to cast a dark shadow over the entire teaching community. It is our collective responsibility to ensure that every child can learn and grow in an environment that is not just academically enriching but also safe, nurturing, and free from fear.

The Problem Of Being Big

Big Tech will run out of ways to keep up its scintillating growth and profits

ech has never been bigger. Alphabet, Amazon, Apple, Meta and Microsoft, put together, are almost a third of the S&P 500 market capitalisation. Last year, their total capital spending was \$360 billion. That alone is more than the GDP of Pakistan.

With developments such as generative AI, Big Tech may be at a point of inflection. For the incumbents, their bigness may become their biggest challenge in staying ahead. To be sure, 'big' in the case of tech is truly awesome. Be it revenue, profitability, consumer contact, community, ubiquitousness, Google's holding company—Alphabet—would qualify as the all-time, most successful combination of brand, business and technology in the history of the world. But what if big were to prove an eventual challenge?

Google search, the Android mobile operating system, the Chrome browser, Google Play Store for apps, Workspace productivity tools and YouTube each has more than 2 billion users per month. Add Google Maps, Translate, Google mail and more. The Economist reported that "humans collectively spend 22 billion hours a day on Alphabet's platforms."

What does Google sell and who are the buyers? It sells attention and engagement to advertisers. Revenues have grown at an average annual rate of 28% since its IPO in 2004 and almost 80% of inflows are for online ads. Never sliding back in any quarter, Alphabet has generated \$460 billion of cash. Its share price has risen 50-fold, making it the world's fourth-most-valuable company.

Isn't this enough, one would ask. Not quite. Alphabet's 'bread and butter' digital-ads business is maturing. Data is the new oil, attention the oil wells, and the internet its refinery. With a base of \$300 billion in annual revenues, new oil wells are not throwing up the gushers and growth is a challenge. Enough has been said about the end of third-party cookies and resulting impact, but given what's at stake, there isn't clarity—forget consensus—on available new means to reach, target and engage. It will impact measurements of effectiveness and its consequential monetisation.

It seems bizarre, given the context of Alphabet's awe-inspiring success, that now its investors want cost efficiency and capital discipline. Insider Intelligence expects the annual increase in global digital ads sales to stay within 10% or less in the next few years, down from a rate of 20% or so in the past decade. Hence, the anxiety is legitimate.

For a total pie of about \$700 billion, further share gain on part of Google will invite scrutiny from regulators. Sundar Pichai may be no Rockefeller, but there are enough concerns in the US concerning its search monopoly such as its arrangement with Apple and others, whereby it pays a reported \$10 billion a year to be the default search engine. This may be one area which ironically brings the liberals and the conservatives together as each suspects such scrutiny is manipulated by 'the other'. Action has ensued.

Although search remains immensely lucrative, with operating margins of nearly 50%, its pathways are mutating. Now direct video search on YouTube, TikTok, Instagram counts high up among the options. The flip side is that video doesn't monetise in equally profitable ways.

As chatbots and other "generative" AIs have seen burgeoning presence, based on the appeal of a likeness to human-generated content, Pichai's insistence that Alphabet is an "AI-native" company may ring true. That said, will its scale matter?

Alphabet shares trade at a lower price relative to earnings than Apple or Microsoft, and not much higher than the S&P 500 index of big American firms. This is a tell-tale data point. It seems bizarre, given the context of Alphabet's awe-inspiring success, that now its investors want cost efficiency and capital discipline. Insider Intelligence expects the annual increase in global digital ads sales to stay within 10% or less in the next few years, down from a rate of 20% or so in the past decade. Hence, the anxiety is legitimate.

Apple transformed itself from a desktop brand to a mobile-phone powerhouse. Microsoft matured from a desktop OS player to a cloudcomputing ace.

Investors and analysts may have demolished Mark Zuckerberg's bet on the metaverse, but let us remember that Apple and Microsoft spent years in the cold too. Specifically on the metaverse, Gartner is still hopeful. According to its analysis, the metaverse is still in its early stages of development, but it is rapidly gaining traction. Gartner predicts that by end 2023, it will reach a tipping point where it will become a mainstream platform for social interaction, commerce, and entertainment.

The year 2022 may have been Big Tech's an-

nus horribilis, but the firms are back in the circus. Artificial intelligence (AI) going mainstream will boost the fortunes of Big Tech and challenge them at the same time.

These giants—Alphabet, Amazon, Apple, Meta and Microsoft—have been growing revenues and profits in double-digits for 10 years and counting. That is unprecedented in the history of business of that size. But that may also be the undoing. Big Tech will run out of ways to keep up its scintillating growth and profits. This is the reason that at the first signs of slowdown, the markets punished these giants severely. Except Apple, each one has had multiple rounds of layoffs. The count is as high as 70,000 workers altogether.

Ambition will lead to tech cannibalism. All the big players operate in overlapping areas such as cloud computing, advertising, gadgets, new services.

Of course, like the traditional big corporations with sputtering growths, new-age tech giants may also look to purchase growth. Microsoft cut a \$69-billion deal to buy growth via the acquisition of Activision, which has revenues of \$8 billion per annum.

Margins will be strained. Growth will stall. Upstarts will bring new technologies to market. Then, Big Tech will start to shrink till incumbents give way to new players or effectively reinvent themselves.

This all may seem fantastical and highly unlikely now, but will come within half a decade. The future arrives in stealthy ways, especially to topple the 'Big'.

Diplomatic Tensions Between India And Canada Not Expected To Impact Exports: EEPC

NEW DELHI- The diplomatic row between India and Canada will not have a material impact on the country's exports, according to apex engineering body EEPC.

India's exports to Canada stood at USD 4.1 billion in 2022-23.

The export goods include pharmaceuticals, gems and jewellery, textiles, and machinery, while imports (USD 4.06 billion) include pulses, timber, pulp and paper, and mining products.

"We do not believe that the stand-off with Canada will have a material impact on our exports and trade, given our long-standing relationship. We expect the current standoff to be temporary and to be resolved," EEPC (Engineering Export Promotion Council of India) Chairman Arun Kumar Garodia told PTI.

He expressed hope that the stand-off would be resolved soon and India's outbound shipments to Canada will continue to grow.

"India and Canada have been good partners as far as trading and cultural relations are concerned, for a significant time.



The current stand-off between India and Canada seems to be a temporary one, and I'm sure that it is going to be resolved diplomatically," Garodia said. He added that though the talks for the proposed free trade agreement have been paused, it would resume as soon as political issues settle down.

Engineering exporter Nipha Group director Akash Shah said there would be no material impact on exports, and that trade would continue, and he hoped that the ongoing stand-off would be settled soon.

The comments come in the backdrop of an intense diplomatic row that erupted following Canadian Prime Minister Justin Trudeau's allegations of a "potential" involvement of Indian agents in the killing of a Khalistani separatist in June. India has rejected the charge as absurd.

SL-M is a type of order that automatically sells or buys a security at the market price when the trigger price is reached.

Sebi Levies Rs 55 Lakh Fine On 11 **Entities For Non-Genuine Trades**

NEW DELHI: Sebi has levied penalties totalling Rs 55 lakh on 11 entities for indulging in nongenuine trades in illiquid stock options segment on the BSE.

In 11 separate orders, the regulator slapped a fine of Rs 5 lakh each on Kamala Agarwal, Kamla Devi Bajoria, Kamla Jain, Kamaljeet Kour, Kamal Ramprasad Gupta, Kamal Kumar, Kamlesh Ahuja, Kailash Narottamdas Anam, Sanjay Kumar Daga HUF Pragma Suppliers Pvt Ltd and Aromatic Tie Up Pvt Ltd.

The orders came after the regulator observed large-scale reversal trades in the illiquid stock options segment on the BSE, leading to artificial volumes on the exchange.

Sebi conducted an investigation into the trading activities of certain entities engaged in the segment from April 2014 to September 2015.

The entities to be fined were among those who indulged in reversal trades, Sebi said in the 11 separate orders on Thursday.

Reversal trades are non-genuine as they are executed in the normal course of trading, leading to a false or misleading appearance in terms of generating artificial volumes, the regulator said.

By indulging in such trades, the entities vio-lated the PFUTP (Prohibition of Fraudulent and Unfair Trade Practices) norms, it said.

In a separate order on Wednesday, Sebi imposed fines totalling Rs 20 lakh on two entities for flouting disclosure rules in the matter of IFL Promoters Ltd.

In another order, the regulator suspended the registration of 3M Team Research Pvt Ltd for a period one year for violating the regulatory norms.

into the future of commerce in Kashmir.

"This trend is not confined to urban areas alone. We're delivering more parcels than ever before, and it's evident that online shopping is gaining a strong foothold in Kashmir. From the urban hubs to the remotest villages, e-commerce has become a part of daily life," Tanveer Ahmad, a courier service provider in south Kashmir's Kulgam said. "Sometimes we even deliver 2000 parcels in a day."

In a region as geographically diverse as Kashmir, Tanveer believes that efficient logistics and reliable delivery are crucial, and the improved logistics and delivery networks over the years have helped to make online shopping a viable and convenient option.

Unicommerce, an e-commerce enablement SaaS platform in India, in its report 'India E-commerce Index' 2023, highlights the consistently rising consumer inclination towards online shopping. It reported a significant 26.2% year-onyear increase in order volume and a 23.5% rise in annual GMV (Gross Merchandise Volume) compared to the previous fiscal year, indicating a maturing e-commerce landscape in the country. Experts project that this market will expand from US\$ 38.5 billion in 2017 to a staggering US\$ 200 billion by 2026.

Rage of smartphones in Kashmir

Experts opine that the rapid proliferation of smartphones in Kashmir has played a significant role in fueling the boom of online shopping in the region. As smartphones become increasingly affordable and accessible to a wider population, more people in Kashmir are now connected to the digital world and able to engage in online activities, including e-commerce.

"The region has witnessed a significant surge in the demand for smartphones," Aasif Ahmad, a mobile tech sales expert in Kashmir said, adding that consumers in Kashmir now have access to a wide range of smartphone options, including budget-friendly models as well as high-end flagship devices from renowned brands. "Even a 5th grader has a phone now," he said.

According to Aasif, the easy availability of fast and reliable internet connectivity has facilitated seamless browsing, making smartphones even more appealing to users who seek to engage in online shopping.

Over 97 percent households in Jammu and Kashmir possess mobile phones while 58 percent households have access to the internet, the National Health and Family Survey-5 (NHFS-5) had reported. The data from Stats of India—an independent e-resource providing socio-economic statistical informaseem to have lost their allure amidst the rapidly changing consumer behavior. "Customers often compare prices with online platforms, not considering the transportation charges, taxes, and other expenses that physical stores bear" he said. Despite their lack of realization, Faheem understands that he cannot stop customers from shopping online. He shares his frustration, "You

won't believe, there are days when I struggle to sell even one item. People blame inflation for the same, but the significant shift towards online shopping has a major part to play."

Other local traders, whom Kashmir observer talked to, also shared that the rise of online shopping has put a downward pressure on prices, leading to reduced profit margins or difficulties in maintaining pricing levels. "Online platforms often offer lower prices due to factors like lower overhead costs, direct sourcing, and bulk purchasing. This puts pressure on us to offer competitive prices to attract customers," an offline retailer said. Extending beyond trivial products, the availability of EMI (Equated Monthly Installment) options has made it possible for people to purchase a wide range of products, including electronics, appliances, furniture etc. "EMI's make it more affordable for individuals to spread the cost of expensive purchases over several months. I recently purchased an air conditioner from one of the leading online shopping sites using EMI option without bearing a substantial immediate financial burden," Wahid Ahmad, a student said.

Despite the increasing popularity of online shopping and the rise of smartphones in Kashmir, there remains a section of people who prefer traditional offline shopping. These individuals continue to embrace the experience of visiting physical stores and examining products in person.

"E-commerce has undoubtedly lured customers away from conventional retail stores, but I believe that it will ever reach a point where it entirely replaces them. Traditional stores are unlikely to vanish," 40-year-old Ghulam Nabi Bhat, said. "It is crucial for physical retail stores to adapt rapidly in response to the current situation."

Need for digital presence

As the dynamics of commerce evolve, many local traders have recognised the importance of embracing the digital realm. Offline stores have started to establish a virtual presence through websites, social media platforms, or e-commerce stores that allows them to tap into the growing online market. The Unicommerce report stated that during FY-2023, the number India that imr olementer omnichannel operations rose by 58.4% as compared to the last financial year. Saima Jan, a small business entrepreneur from Srinagar runs an offline ladies' store. But she started leveraging platforms like Instagram, Facebook, and WhatsApp to promote her products. "Social media has helped me connect with consumers from different parts of Kashmir and even from other regions. Virtual presence makes it easier to meet the expectations of digitally savvy consumers," Saima said. "I click good pictures of my products like bags and upload them with detailed descriptions, images, and prices. Now, most of the sales I make are through online selling." Walk into any neighborhood shop nowadays and you'll notice something new - a small black and white QR code (quick response code) discreetly placed near the cash counter. These codes represent a significant digital transformation that has swept through local markets and quaint corner stores. "Recognizing the importance of integrating technology into businesses, shopkeepers are now upgrading their stores with modern contactless payment processing. The adoption of digital payment methods, including mobile wallets and UPI (Unified Payments Interface) has facilitated transactions," Saima said.

The MEA said the neutral expert proceedings are ongoing and expected to continue for some time.

"India is committed to engaging in a manner that supports the resolution of issues in accordance with the provisions of the Indus Waters Treaty," it said.

India has not cooperated with the CoA process to resolve the dispute.

Addressing a large gathering at the sprawling mosque, 50 year old Mirwaiz said "that despite advocating for peace, it is unfortunate that he was branded as anti-national, anti-peace and separatist as well".

Earlier Mirwaiz broke down after he stood up on the pulpit amid intense sloganeering from the people present.

"I was allowed to deliver a sermon on the pulpit of Jamia Masjid after 212 consecutive Fridays. People are aware that after August, 04, 2019, I was kept under house detention and I was not being allowed to move out of my home, due to which I couldn't perform my duties as Mirwaiz" he said.

Mirwaiz said that after approaching the court, a few police officers visited him yesterday and informed that he is being released and can visit Jamia Masjid tomorrow to offer Friday prayers. "I cannot utter my sentiments, but it is all because of the pravers of people that I am here again to deliver the sermon," he said, adding that it was quite difficult for him to stay away from the pulpit for four years. He said that after August 5, 2019, people have faced difficult times as J&K's special identity was snatched and was bifurcated in two Union Territories. "As a Mirwaiz, I have the responsibility to raise the voice for the people. Since Hurriyat Conference continued to raise the voice, but the media stopped using our statements. I want to tell my people that it is the time to be patient, to keep faith in the Almighty," he said. He said that Hurrivat believes that J&K's one part is in India while the rest two are in Pakistan and China, and by merging them fully J&K will be complete, which it was on 14 August 1947. 'Therefore, this issue needs to be resolved. J&K issue can be a territorial issue for many, but for the people of J&K it is a humanitarian issue," he said. Reacting to the statement of Prime Minister Narendra Modi on the Ukraine issue, Mirwaiz said that he was right in saying that the present era is not of war. "We too have been advocating for the resolution of J&K issue through dialogue. "We interfere in those cases on issues of principles," it observed, adding, "Surely, we can't start running the command structure of the Army".

She said it was a case where the woman officer has been given permanent commission and she is a colonel in the Army. Arora said it amounts to "gross humiliation" of the woman officer who is now a colonel.

"Ordinarily, a colonel has to be put in a command post which will have a certain number of JCOs (junior commissioned officers), officers and others under them. Now people who are junior to me have been given units in those commands," she said.

"You have heard the grievance now," the bench told Attorney General R Venkataramani.

The apex court, which posted the matter for further hearing on September 27, said there are issues which can surely be sorted out by the authorities themselves.

The bench asked the petitioners to circulate a note, not exceeding two pages, setting out the grievances raised by them.

It said the respondent authorities will be at liberty to file their responses on the issues raised.

The bench clarified the pendency of these proceedings will not preclude the Army and Navy authorities from looking into the grievances raised by the petitioners and resolve them.

In a landmark verdict on February 17, 2020, the top court had directed that women officers in the Army be granted permanent commission, rejecting the Centre's stand on their "physiological limitations" as being based on "sex stereotypes" and "gender discrimination against women".

The apex court had directed that within three months all serving Short Service Commission (SSC) women officers have to be considered for permanent commission irrespective of them having completed 14 years or, as the case may be, 20 years of service.

Impact on local economy

Many think that when individuals choose to make online purchases, they often divert financial resources away from their local communities. In Anantnag's Lal Chowk, Faheem Ahmad, a clothing shop owner looks upon his meticulously arranged shelves, filled with a variety of textiles and garments. Once a flourishing trader, Faheem finds himself grappling with the challenges brought about by the onset of online shopping. The bustling streets that were once filled with enthusiastic customers have transformed into quiet lanes, and he witnesses a noticeable decline in footfall and customer engagement.

Faheem acknowledges that the charm and character of his shop

With an aim to bridge the gap between traditional businesses and the digital marketplace, several local e-commerce platforms and marketplaces like Koshur store, Kashmir Box, Kashmir origin, Jhelum Cart, Kashmir sales mart etc. have emerged in Kashmir.

koshurstore.com, an e-commerce marketplace founded in 2019 by 23-year-old Morris Shahmiri in Kashmir, has diversified into new markets, such as food, online pharmacy, and groceries, and successfully acquired other businesses, including Khen, Groceries-Daily, headed to the Jamia Masjid in Nowhatta area of the Old City and received a rousing welcome from hundreds of his supporters. People were seen holding garlands to welcome the Valley's head priest.

Emotions ran high when the Mirwaiz reached Jamia Masjid. He was greeted with slogans and praises by hundreds of his supporters. He was escorted to the pulpit of the Grand mosque, where he broke into tears.

Parties hail release

Meanwhile, political parties welcomed the release of Mirwaiz Umar Farooq, with National Conference vice-president Omar Abdullah expressing hope that Mirwaiz would resume his social and religious responsibilities.

"First of all we welcome this step by the government. Better late than never. He should not have been kept under house arrest for so long," Abdullah told reporters here.

The former chief minister, however, said the government has not done any favour to the Hurriyat chief by releasing him.

Abdullah said now all eyes will be on Mirwaiz. "...I hope that he will resume his socio-religious responsibilities. There are many issues in which he has a big role, especially in drug abuse," he said.

Another former chief minister, Mehbooba Mufti, also welcomed Mirwaiz's release, saying the Centre has corrected its mistakes which it committed after 2019 by arresting religious leaders in Jammu and Kashmir.

She said there is a race among BJP leaders and its allies to take credit for the release of the Mirwaiz.

"This is BJP's policy to turn J-K into a prison and throw its religious leaders into jails, and then after four-five years doing them a favour by releasing them. Keeping Mirwaiz under house arrest for four years was against democracy and humanity," Mufti told reporters here.

Asked about Mirwaiz's remarks about dialogue with Pakistan during his sermon at the Jamia Masjid, she said India needs to talk to and radicalise susceptible local youth with an aim to recruit and train them to participate in acts of terrorism, which included handling weapons, ammunition, and explosive materials.

These actions were intended to execute acts of terrorism involving attacks on civilians and security forces with the intention of spreading fear within the Kashmir Valley and in various regions of India subsequent to the revocation of Article 370, noted the court.

Sports Minister Cancels China Visit After Arunachal Athletes Denied Visa

NEW DELHI: Union Sports Minister Anurag Thakur on Friday decided to cancel his upcoming visit to Hangzhou for the Asian Games as a mark of protest against China's decision to deny visas to three Indian wushu players from Arunachal Pradesh.

Female players Nyeman Wangsu, Onilu Tega and Me-pung Lamgu have been denied accreditation, which also works as visa for the Asian Games that officially open on Saturday in Hangzhou.

"Union Minister for I&B and Youth Affairs & Sports @ ianuragthakur cancels visit to China for the Asian Games as India strongly protests China's targeted and pre-meditated discrimination against Indian sportspersons from Arunachal Pradesh by denying them accreditation and entry to the 19th Asian Games in Hangzhou, China," a Sports Ministry statement said.

The northeastern Indian state of Arunachal Pradesh is viewed by China in its entirety as Chinese territory. "Ministry of External Affairs, Government of India, issues statement underscoring the fact that in keep-



ing with our long-standing and consistent position, India firmly rejects differential treatment of Indian citizens on the basis of domicile or ethnicity. Arunachal Pradesh was, is and will always remain an integral and inalienable part of India," the statement added.

Wushu Athlete Goes Incommunicado, Family Worried

Wushu athlete Mepung Lamgu has gone incommunicado since being denied visa to travel to China for the Asian Games, leaving her family members in Arunachal Pradesh worried and clinging to hope that she wouldn't take any "ex-

treme step".

The 20-year-old is one of the three wushu players from Arunachal Pradesh who were denied visas to travel to China for the Hangzhou Asian Games.

'Now she's not even taking our calls, and it's coming switched off. So we are also very worried about her, kahin kuch kar na de ro ro ke (hope she doesn't take any extreme step as she is crying inconsolably),' Gandhi told PTI from Itanagar.

Spain Removes The Word 'Women' **From National Team Name**

MANCHESTER: By eliminating the phrase for "women's soccer" from the name of its national team, the Spanish Football Federation is hoping to show it has made a "conceptual shift" in its view of the sport.

It remains to be seen if more countries will follow suit.

Spain made the move towards greater equality this week as part of an agreement between the governing body and its World Cup winning team, which have been in dispute since former federation president Luis Rubiales kissed player Jenni Hermoso on the lips during the trophy ceremony as Spain was crowned world champion in Australia last month.

The name for the women's team traditionally included the phrase "de fútbol femenino" translated as "women's soccer." Going forward, the men's and women's national teams will both officially be known as "Selección Española de fútbol" or 'Spain's national soccer team."



change, we want this to represent a conceptual shift, and recognition that soccer is soccer, regardless of who plays it," the federation's interim president Pedro Rocha said.

European soccer's governing body, UEFA, has previously held informal discussions about how countries can handle such name issues, but no official proposal has been made.

Other countries, such as England and United States, have "More than a symbolic created parity in the names by referring to them as the "men's" and "women's" national teams.

But there is less parity when it comes to leading tournaments. European club soccer's elite men's competition is simply called the Champions League. The women's equivalent, however, is called the Women's Champions League.

Likewise, next year's European Championship for men is called Euro 2024. The women's 2025 version is called the Women's Euro.

Germany Hires Julian Nagelsmann As National Football Team Coach

BERLIN: Germany hired Julian Nagelsmann to lead the men's national soccer team on Friday, entrusting the former Bayern Munich coach with doing a better job than the last Bayern Munich coach who tried.

The German soccer federation said Nagelsmann was taking over on a short-term contract through next year's European Championship. Germany is hosting the tournament.

"We have a European Championship in our own country. This is something special, something that only happens every few decades,' Nagelsmann said. "Having a great tournament in a great country is the priority. I'm very keen to take on this challenge ... We will be a closeknit bunch next year."

At 36, Nagelsmann is the youngest Germany coach since 34-year-old Otto Nerz was appointed in 1926.

Nagelsmann succeeds Hansi Flick, the first Germa-



Nagelsmann previously took over from Flick when he became Bayern coach in 2021 with Flick leaving to coach the national team. Nagelsmann led his team to another Bundesny coach ever fired from the liga title – its 10th straight –

but was fired by the Bavarian powerhouse in March amid management concerns that he wasn't getting the best from the squad.

Germany next has friendlies against the United States in East Hartford, Connecticut, on Oct. 14, then Mexico in Philadelphia four days later. The team will continue its Euro 2024 preparations against Austria in Vienna on Nov. 21.



Outpost Overcrowded Jails, Delayed Justice A Concern: Parliamentary Panel

A parliamentary panel has observed that overcrowding in jails and delayed justice have become pressing concerns, leading to a series of consequences for both the prisoners and the criminal justice system as a whole. The parliamentary standing committee on home affairs, headed by BJP MP Brijlal, also recommended that special attention be given to pregnant women on the line of a judgement of the Supreme Court where it was observed that a jail must have adequate facilities for prenatal and postnatal care for female prisoners as well as their children.

"The committees, notes that the issue of overcrowding and delayed justice has become a pressing concern, leading to a series of consequences for both the prisoners and the criminal justice system as a whole. The committee recommends that prisoners from overcrowded jails may be transferred to other jails with vacant cells in the same state or other states by signing MoUs to that effect. This kind of an arrangement can be mutual in nature between the states signing the MoU," it observed.

The panel recommended that babies born in prison be allowed to stay with their

mothers until the age of 12 in order to provide a nurturing environment during their early years while ensuring their well-being and development. According to guidelines, emphasis should be given towards proper care of children relating to food, shelter, medical care, education, and physical growth, it further said.

Apart from this, sports and entertainment facilities are also to be provided to these children. The committee said transgender prisoners are to be provided the same standards of healthcare available to other inmates and should have access to necessary healthcare services without discrimination on the grounds of their gender identity It observed that the overcrowding in Indian prisons has long plagued the country's criminal justice system. Despite various steps to reduce the number of inmates from jails, the total inmates in India stands at 5.54 lakh against the total

prison capacity of 4.25 lakh. The national average occupancy rate in prisons across Îndia is 130.2 per cent and the states of Uttar Pradesh, Bihar, Madhya Pradesh, Maharashtra, Punjab and Haryana together make up for more than 50 per cent of the total prisoner population in the country.

Booker Prize shortlist offers 'terrors' and 'pleasures'

LONDON: The shortlist for the 2023 Booker Prize was announced in London on Thursday, with the final six books offering "terrors, pleasures, joys and consolations."

Twice-shortlisted novelist Esi Edugyan, who chairs the judging panel, said the chosen novels "offer a full range of human experience" that "transport us not just outside reality but outside the common language of the everyday."

The prestigious literary prize is open to works of fiction by writers of any nationality, written in English and published in the UK or Ireland between October 1, 2022 and September 30, 2023. The final list is made up of

authors from the US, Ireland, Kenya and Canada. The six novels were drawn from 158 works, which were then reduced to a 13-strong longlist. Among them is Irish author

Paul Murray's "The Bee Sting", which looks at the role of fate in the travails of one family in a tragicomic saga.

Kenyan writer Chetna Maroo's moving debut novel "Western Lane" about grief and sisterhood, which follows the story of a teenage girl for whom squash is life, also makes the cut. Taking a dark turn, dystopian

Having Productive Conversations With Authors: OpenAI On New Lawsuit

The Authors' Guild and well-known authors like Jonathan Franzen, John Grisham, George R.R. Martin, and Jodi Picoult have filed a fresh lawsuit in the Southern District of New York against OpenAI.

According to the complaint, OpenAI "copied plaintiffs' works wholesale, without permission or consideration" and fed the copyrighted materials into large language models (LLMs).

OpenAl told Forbes that it has been "working coopera-tively to understand and discuss their concerns about AL" "We're optimistic we will continue to find mutually ben-

eficial ways to work together to help people utilise new technology in a rich content ecosystem," the Microsoftbacked company said. The authors alleged that

OpenAI's LLMs could result in

derivative work "that is based on, mimics, summarises, or paraphrases" their books, which could harm their market.

OpenAI could have trained GPT on works in the public domain instead of pulling in copyrighted material without paying a licensing fee, they alleged.

This is not the first time authors have sued OpenAI for copyright violations and illegally using their works to train its chatbot called ChatGPT.

Earlier this month, authors Michael Chabon, David Henry Hwang, Rachel Louise Snyder and Ayelet Waldman alleged in a lawsuit that OpenAI benefits and profits from the "unauthorised and illegal use" of their copyrighted content.

In July, comedian and author Sarah Silverman, along with authors Christopher Golden and Richard Kadrey, sued OpenAI and Mark Zuckerberg-owned Meta over dual claims of copyright infringement.

The lawsuits alleged that OpenAI's ChatGPT and Meta's LLaMA (a set of large language models) were trained on illegally-acquired datasets containing their works.

Chandrayaan-3 lander, rover set to 'wake up' from 'sleep' on moon

India is set to become the first nation in the world to witness the "waking up" of Chandrayaan-3 mission's lander and rover after the end of a twoweek long "sleep" due to sunset on the moon, as the sun is set to rise during the early hours of 22 September, Science and Technology Minister Jitendra Singh informed Lok Sabha on Thursday, 21 September.

"Tomorrow when the nation will be rejoicing the passage of the Women's Reservation Bill, we may also hopefully become the first nation in the world to make our Chandrayaan-3 mission land on the moon's South Pole (which happened last month) and then witness the

resumption of navigational activities of both lander Vikram and rover Pragyan after a 14-day slumber (owing to a fortnightlong sunset on the moon)," Singh said while replying to a discussion on Chandrayaan-3 mission's success in Lok Sabha. In his more than an hour-long

reply, the minister, while responding to Congress MP Shashi Tharoor's comment earlier in the day that the BJP creates an impression that all scientific accomplishments occurred only after 2014, referred to the famous photograph of scien-

tists carrying rocket parts on a

cycle, said, "That miracle was of pre-2014 days. Unlike in the Nehruvian era when we were devoid of resources, we are now technologically advanced."

To another Tharoor's remark that unlike in Parliament, women don't need reservation in scientific fields, Singh said that there are more women scientists in ISRO than ever before and informed that even the Aditya L-1 mission is headed by a woman scientist.

He also countered Tharoor's another observation that the space department budget is minimal. "Between 2014 and now there has been a 142 per cent increase in the budget of science and technology as well as space departments," Singh said.

China announces 'strategic partnership' with Syria

HANGZHOU: Chinese President Xi Jinping announced a "strategic partnership" with Syria on Friday during talks with President Bashar al-Assad, who

China is one of only a handful of countries outside the Middle East that Assad has visited since the 2011 start of a civil war that killed more than half a million people, displaced millions and battered Syria's infrastructure and industry.

Assad is the latest in a string of leaders ostracised by the West to be feted by Beijing, with Venezuelan leader Nicolas Maduro and Iran's President Ebrahim Raisi visiting this year, as well as top Russian officials. "Chinese President Xi Jinping and his Syrian counterpart

Bashar al-Assad on Friday jointly announced the establishment of the China-Syria strategic partnership," according to Chinese state news agency Xinhua.

The leaders were each flanked by nine aides at a large rectangular wooden table, a CCTV video showed, as two flags from each country were set in front of a Chinese painting in the meeting room.

Relations between the two countries "have withstood the test

of international changes", Xi said. "China supports Syria in opposing foreign interference. opposing unilateral bullying, safeguarding national independence, sovereignty, and territorial integrity," the Chinese leader added.

Assad, in turn, said he "thanked the Chinese government for everything you have done to stand alongside the Syrian people in their cause and their trials", according to a readout from Syrian state news agency SANA.

"This visit is extremely important due to its timing and circumstances because a multipolar world is being formed today which will restore balance and stability to the world," he said.
