### **NIA Court Rejects Bail Plea Of 10 Separatists**

Srinagar: A special NIA court here on Monday rejected bail application of ten second-rung separatist leaders and activists who were arrested earlier this year in connection with a case regarding reviving the banned outfit JKLF.

On 9 July this year, police had taken 43 persons to po-lice station Kothibagh Srinagar from Habib Restaurant here. Police had later let off 33 persons and arrested 10 accused. As per the Investigation Officer, these 33 persons-32 adults and one juvenile were allowed to go after furnishing bonds, because nothing "incriminating" was found against them.

Additional Sessions Judge Srinagar, special judge designated under the NIA Act, Sandeep Gandotra, rejected the pleas of the ten accused, saying if they were enlarged on bail at this stage, it will put at risk the interests of the public and the state.

# Season's First Snowfall Dips Mercury In Kashmir

Srinagar- Snowfall in higher reaches of Kashmir and rains in the plains ended a prolonged dry spell and brought down the mercury significantly in the Valley which experienced record high temperatures this month, officials said on Monday. Moderate rains lashed most parts of the valley. Srinagar city recorded 18.3 mm of rainfall till 8.30 am on Monday. Snowfall was recorded in higher reaches of south Kashmir including around the holy cave shrine of Amarnath and Gulmarg in north Kashmir, they said.

The downpour has ended the heatwave which was witnessed in the second week of September. The Valley saw high temperatures which broke the record of 89 years.

ceive light rainfall on Monday. "On the 26th the weather will remain cloudy but better than today, the 27th and 28th of September, the weather will remain dry. There will be wet weather on the 29th and 30th due to Western Disturbances," he added. He said some places in Kashmir valley received good amounts of rainfall. 

disappeared long ago, leading to its extinction several decades ago. However, the recent frequent sightings of the Hangul are a source of joy for everyone, as it appears that this magnificent animal has gradually returned to the valley," he added. The sustainability of a robust

Hangul population serves as an indicator of a thriving ecosystem and, in turn, contributes to the sustenance of other biodiversity, the official said.

He further said that the Kashmir stag inhabits the forests of Kishtwar and Bhaderwah, in addition to being found within Dachigam National Park in Kashmir, where it thrives at an elevation of 3,035 metres.

The wildlife department records paint a concerning picture of its population. In 2015, the population stood at a mere 186, marking the lowest count in any decade. This sharp decline is a stark contrast to historical figures, where the Hangul once thrived with an estimated population ranging from 3,000 to 5,000 during the first half of the last century.

Till date, nine censuses have been carried out during 2004, 2006, 2008, 2009, 2011, 2015, 2017, 2019, and 2021, and the Hangul population estimates in the past were 197, 153, 127, 175, 218, 186, 214, 237, and 261.





### Food Insecurity, Drying Rivers Stare Kashmir In The Face

RINAGAR- Kashmir is teetering dangerously on food insecurity as precious paddy land shrinks by conversion to rain-fed orchards and climate change wreaks havoc with rivers, reducing their level by two-thirds over the past forty years, a recently conducted study says.

Kashmir's current 40 per cent food grain deficit is likely to touch over 60 per cent in the next 10 years, a report on climate change released here Monday said. The ActionAid International, an NGO working in over 40 countries, in a 28-page report on climate change and its impact in Kashmir, 'On the brink' said that more and more paddy land is being changed into rain-fed orchards resulting in the food grain deficit.

The report also reveals that the deficit in food production in Kashmir valley region has reached 40 per cent putting food security to a greater risk. The food deficit was just 23 per cent in 1980-81

Kashmir runs in deficit in food grain production while its horticulture sector earns a revenue of Rs 20 billion.

The report warns that the large scale transition from paddy cultivation to rain-fed crops poses risk to food security in Kashmir.

"In the post-World Trade Organisation scenario, as foreign fruits mainly apples have started flooding Indian markets, demand for Kashmir fruits is likely to reduce and the low demand could cripple the capacity of poor and small farmers to buy food grains from the market," says Arjmand Hussian Talib, the author of the report.

Action Aid International had carried a sample survey which revealed that 1489 acres of paddy land have been converted into rain-fed dry land in north Kashmir districts of Kupwara, Baramulla and Bandippra, south Kashmir districts of Pulwama, Kulgam and Shopian and central Kashmir district of Budgam.

## **US Govt Readies For Potential Shutdown As Funding Impasse Continues**

With the US government on the brink of a shutdown this week as Congress remains at an impasse on a funding deal, federal departments and agencies have begun the mandatory process of planning to bring non-essential functions to a halt, local media reported.

In October 2021, US President Joe Biden had signed a short-term funding bill after Congress passed the measure, averting a partial government shutdown. Every department and

agency has its own set of

plans and procedures in the event of a shutdown. That guidance includes information on how many employees will be furloughed, which employees are essential and will work without pay, how long it will take to wind down operations in the hours before a shutdown, and which activities will come to a halt. Those plans can vary from shutdown to shutdown, CNN reported.

On 22 September, the office of management and budget reminded senior agency officials to update and review shutdown plans.

**US Has Failed To Compensate Tortured** Victims Of Its Iraq Prisons: HRW

wo decades on, the United States has failed L to provide redress or compensation to Iraqi victims of its military's torture and abuse at Abu Ghraib and other prisons, according to Human Rights Watch (HRW).

An HRW report published on Monday said the New Yorkbased group found no evidence that the US government has paid any compensation or other redress to victims, nor has it issued any individual apologies or other amends.

Between 2003, when the US invaded and occupied Irag, and 2009, when it closed its largest detention centre in the country, about 100,000 Iraqis were believed to have been held by the US and its coalition allies.

## Armies Of India, US To Kick-Start 2-Week War Game In **Alaska On Monday**

NEW DELHI: The Indian and US armies will kick-start a two-week war game in Alaska on Monday that will feature a number of complex drills, officials said.

**NEW DELHI:** The multiple entry and exit system is being operated by Western educational institutions quite effectively but Indian institutions are likely to face several issues in its implementation, a parliamentary panel has noted.

The Parliamentary Standing Committee on Education, Women, Children, Youth and Sports, headed by Rajya Sabha MP Vivek Thakur, said in its report tabled in the Upper House last week that the institutions have not thought very clearly about this problem and how they will resolve it when it is at their doorstep.

"New Education Policy (NEP) proposes multi-entry and multi-exit options for the students. While it looks like a flexible system, which is being operated by Western education institutions quite effectively, Indian institutions are likely to face several issues in implementing this system. Due to the high population, the estimated intake of students in higher education every year is quite high.

"If institutions allow MEME (multiple entry and multiple exit), it would be very difficult for the institutions to predict how many students would exit and how many would join midway. Since institutions would not know the in- and outtraffic, it will certainly disturb the Pupil-Teacher Ratio," the report said.

The panel has noted that uneven geographical distribution of higher education institu-

tions would create hurdles in managing MEME in several ar-

eas, mostly countryside. "The institutions have not thought very clearly about this problem and how they will resolve it when it is at their doorstep," it said.

According to the "Guidelines for Multiple Entry and Exit in Academic Programmes offered in Higher Education Institutions" issued by the University Grants Commission (UGC), flexible learning is important to choose one's academic pathway leading to the award of certificate, diploma, and degree.

"There are occasions when learners have to give up their education mid-way for various reasons. The records of the clearance of credits for such incomplete academic programmes remain unaccounted for. Some contingency approaches are followed in a few HEIs by allowing the learner to settle for a lower level of certification. Such rigid boundaries need to be removed to ensure zero-year-loss to students in the event of exiting in between," the guidelines stated.

"It will reduce the drop-out rate, thus improving Gross Enrolment Ratio (GER), which is one of the major objectives of the National Education Policy, (NEP), 2020. Flexible learning also facilitates lifelong learning. These objectives can be achieved on the principle of a multiple entry and exit system along with the opportunity of learning from anywhere, anytime," according to the guidelines.

Speaking to reporters, Kottayam SP K Karthick IPS said it was close to midnight when the search team, also comprising officers from the nearby Gandhinagar police station, arrived at the location.

"We did not expect there would be so many dogs here

by a person retired from the BSF, but was kicked out from there for asking questions like how to make dogs bite someone wearing khaki," the SP said. The top officer of the district police also said the accused under the guise of being a dog trainer was selling drugs and the same was evident from the seizure of over 17 kgs of ganja from the site.

"According to our preliminary investigation, he (accused) was living here on rent and was known to everyone in the area as a dog trainer. Therefore, people used to leave their dogs with him, at the rate of ₹1,000 per day, when they went outside and he would look after the canines," Mr Karthick said.

Regarding other interventions he suggested that the Tiger can be brought in easily by 15th and Lion by 25th of October vey easily. He remarked that such animals are liked by most of the people and would allure most of the visitors including children. He enjoined upon them to think about bringing in Hippopotamus as an added attraction to the Zoological Park. The Chief Secretary also

remarked that given the hot weather of Jammu in Summer season, the authorities should envisage keeping the Zoo open for public in morning and evening hours too. ## Mirwaiz's Release

The release of Mirwaiz Umar Farooq, the chairman of the moderate Hurriyat faction, on September 22 has marked a significant shift in the political landscape of Kashmir. Addressing a congregation of worshippers at Srinagar's Grand Mosque, Mirwaiz reiterated the Hurriyat stance, stressing the need for a peaceful resolution to the longstanding issue of Kashmir. He expressed the desire for the unification of all three parts of Kashmir, currently divided between India, Pakistan, and China, under a peaceful resolution. Mirwaiz positioned himself as a "realist resolution-seeker," distancing from the label of "so-called separatists" and "peace disrupters."

Mirwaiz's release has been met with a sense of relief and surprise. It signifies a rare deviation from the central government's hardline policy in Kashmir. His earlier petition challenging his detention and seeking freedom under the Constitution had prompted the Jammu and Kashmir High Court to seek a response from the administration, ultimately leading to his release.

This is not the first time Mirwaiz has been released; a similar instance occurred on March 4, 2021, following the India-Pakistan ceasefire agreement. However, subsequent denial to him to address a Friday sermon at the Grand Mosque had led to protests. This time, his arrival at the Grand Mosque was greeted warmly, and the prayers passed off peacefully.

Over the past four years, the administration has taken a harsh stance against separatist groups and leaders, resulting in the imprisonment of major figures such as Yaseen Malik, Shabir Shah, Masarat Alam, Naeem Khan, and Shahidul Islam. The passing of Syed Ali Shah Geelani, the chairman of Hurriyat G faction, in September 2021, further dealt a blow to the separatist movement.

The situation has reached a point where the once-prominent separatist conglomerate, the Hurriyat Conference, has crippled its ability to engage in political activities. Even if the separatist leaders were free, the government has cracked down on any signs of separatist activity, raising the costs for any leader or activist championing the cause. Thus, Mirwaiz's conduct in this altered political environment will be closely watched. So, will be the fresh moves of the central government. It will be interesting to see how New Delhi would like to deal with the union territory in the run up to the parliamentary elections next year. Four years after the withdrawal of Article 370, there are no signs that the Assembly elections will be held in the region. Nor is there any hope that statehood will be restored. With the release of Mirwaiz, the centre, however, has initiated an important Confidence Building Measure. Here's hoping it leads to further improvement in the Valley's situation.

# India's South East Asia Policy

Earlier this month, the diplomatic bustle at the national level was focussed on the G20 Summit. However, in addition to that the Prime Minister also focussed on India's Look East policy and participated at ASEAN and East Asia Summit in Indonesia, focussing on ways to counter China's regional dominance

he G20 New Delhi Summit in early September was in fact a global brand and image making exercise for the Government of India. An exercise in which the Prime Minister Modi, G20 Sherpa Amitabh Kant and Minister of External Affairs S Jaishankar were equally involved and committed and achieved the task with a finesse. The cherry on top was the adoption of the New Delhi Declaration, which was adopted unanimously at the summit.

However, Prime Minister Modi as a leader of the Global South and keeping in mind India's strategic and regional priorities, in spite of his heavy commitment to the G20 Summit, undertook a whirlwind tour of the Indonesian capital Jakarta, in order to attend the ASEAN and East Asia Summit.

This shows the priorities of the GoI at both the regional and global level. On one hand India was hosting the prestigious G20 Summit but on the other hand it didn't overlooked its regional priorities and strategy.

Let's take a look at the reasons for PM Modi to fly to Jakarta to participate at these two events. In fact, India is evolving into a strategic actor in Southeast Asia.

It has promoted ties – diplomatic, trade, defence and people to people, with almost all countries in the region from Vietnam, to Philippines to Indonesia, Malaysia, Cambodia, Laos, Brunei, Thailand, Singapore, Japan and S. Korea.

Over the years, India has signed an arms deal with Vietnam, stood with Philippines over China on sovereignty disputes in the South China Sea, and has increased defence cooperation with Indonesia.

The manner it has managed the balance-ofpower politics in the region is a classic model of diplomacy. Basically, China's aggressive posture in and around the South China Sea is driving India and its partners in the region together. Though these bilateral and multilateral relationships have not transformed into any formal alliances, but the trend is clear. India's regional forays will increasingly complement the United States' Indo-Pacific strategy to counter China in the coming years.

India initiated its Look East policy in 1991, which was transformed into an Act East policy in 2014, when India initiated a proactive engagement policy in the region to prevent it from falling a prey to the Chinese dom-Under Prime Minister Modi India ir ination recent years has steadily strengthened key partnerships across Southeast Asia, particularly with countries along the maritime rim of the Indo-Pacific. These moves are clearly designed to cooperate with Southeast Asian partners, who besides supporting the international rules-based international order insist on regional norms of behaviour in the face of rising Chinese assertiveness in the region. Currently, India and Vietnam enjoy a "comprehensive strategic partnership" after Modi visited Vietnam in 2016. In contrast, the United States is only a "comprehensive partner" for Vietnam, two levels below India's status. Washington has struggled to raise the partnership and President Biden's recent visit to Vietnam was part of this endeavour. The Philippines, an old and U.S.'s treaty ally, has also expanded security partnership with India. Late last month, Philippine Foreign Secretary Enrique Manalo visited New Delhi and met with his Indian counterpart, S. Jaishankar. For the first time, India recognised the legitimacy of the 2016 arbitration ruling by the Permanent Court of Arbitration in The Hague in favour of Philippine sovereignty claims over China in the South China Sea.

India has also remained committed to evolve a security partnership with Indonesia. Indo-Indonesian defence relations got a boost in 2018, when Modi visited Jakarta and elevated relations to a comprehensive strategic partnership. The two nations also initiated a new naval exercise, Samudra Shakti, which incorengagements further, to include cybersecurity. Perhaps of greater importance is the economic side of their relationship. In a nod to New Delhi's original Look East policy, Bangkok implemented its own Look West policy in 1997, in part to tap into the enormous Indian market. Moreover, Thailand and India are partnering with Myanmar to construct the India-Myanmar-Thailand Trilateral Highway that will significantly upgrade transport links between Southeast Asia and South Asia. Once the highway is completed, Modi and his government also want to add connections to Cambodia, Laos, and Vietnam - another clear rival

porated a warfighting component. In addition the two countries are exploring potential air force cooperation as well. Indonesia may also follow in the footsteps of the Philippines by purchasing BrahMos missiles.

India is also cooperating with Malaysia, on the basis of an enhanced strategic partnership signed in 2015. Although Kuala Lumpur's decision earlier this year to cancel a deal to purchase Indian-made Tejas fighter aircraft may have dampened the partnership somewhat, the intent clearly remains to strengthen ties in line with unholding the mutual goal of maintaining the rules-based international order in the region - especially internationally recognised maritime borders and freedom of navigation, neither of which Beijing accepts. Brunei is another emerging partner for India along the South China Sea. In 2021, the two nations renewed their defence agreement for five years, and they regularly engage in joint exercises, port visits by navy and coast guard ships, and official defence exchanges. India's strategic partnerships with Singapore and Thailand are also close and longstanding. Singapore regularly engages in bilateral exercises, high-level dialogues, visits, and professional training with India. Modi visited Singapore twice in 2018, and on the first trip, he signed 35 memoranda of understanding agreements on a range of security and economic issues.

India further has good relations with both Cambodia and Laos. In May, Cambodian King Norodom Sihamoni visited India, and the two sides reaffirmed "the strong civilisational bond" between the two nations. Phnom Penh and New Delhi cooperate on a range of socioeconomic projects, de-mining, water conservation, and heritage protection. India's engagement with Laos is less robust, but nevertheless, New Delhi and Vientiane are likely discussing ways to boost economic ties. This is all the more remarkable as both Phnom Penh

## Esports, from arcades to the Asian Games

Leaving behind dingy arcades in shopping streets and scoldings of parents for squinting into dimly lit screens, esports is scheduled to make a mammoth entry into public consciousness, by becoming a medal sport at the Asian Games in Hangzhou. A glitzy sci-fi spaceship-like arena over 80,000 sq metres was built specifically for this grand debut. Tickets were sold by lottery system and were priced as high as USD 137, higher than most other events. Seven game titles, including League of Legends, DOTA 2, and Honor of Kings, which belong to the multiplayer online battle arena game genre, and Street Fighter, which is MMA on screen, will test strategy, teamwork, and the individual skill of participants.

The success at the Asiad will be a marker for the Olympics as it is keen on catering to a younger demographic. The contours of violence in many battle arena games is a major roadblock to their inclusion at the Summer Games, but with the staggering popularity of several game titles, esports hopes to push past that apprehension. Hangzhou will witness the super fandom of League of Legends Korean player Lee "Faker" Sang-hyeok, whose popularity can be compared to mega K-Pop stars. Thailand will field Thum "MindRPG" Homchuen, winner of the Olympic Esports Series, and equally renowned in his country.

With a huge footprint across Asia, esports hopes to get the new generation hooked, as gaming gets mainstreamed into Games programmes. Chinese tech interests will get propped up, with tech and entertainment giant Tencent which boasts of many gaming subsidiaries, deeply involved in Hangzhou's emergence as a hub for esports. Elsewhere, esports LAN tournaments are increasingly being hosted at stadia and arenas, and gamers are earning in crores. Crossing over into the Olympics will remain the ultimate goal for esports, but China, which manufactures a fair few games, will look to advance its interests by putting up a grand spectacle at Hangzhou.

## **Response to Op-ed on Housework**

he write-up, "Should housewives be compensated for housework?" (September 21, 2023) was an eye-opener and emphasizes the fact that housewives are no less equal when compared with the male working members in families.

From household chores to planning family events, homemakers have multifarious skills that many earning male members cannot match. In fact, years ago the Supreme Court objected to the census, listing homemakers as 'non-workers', and called for laws to quantify their contribution to the economy. A woman's role as a mother, a wife and a homemaker should in itself be considered a productive work, which is something beyond any monetary value, as she brings emotional attachment to the family through her concrete and selfless service. The society's view excessively focuses on housewives as sole nurturers of the family, and hence, by default, it does not respect her as an individual, independent of her role in the family.

It took some intelligent minds and many women, who understood the value of the so-called 'housewives' to provide it with a better nomenclature - 'homemaker.' It may be recalled that in September 2020, the Madras High Court enhanced a monetary compensation from Rs. 8.46 lakhs to Rs. 14.07 lakhs to a homemaker, awarded by the Motor Accidents Claims Tribunal in Salem in Tamil Nadu. The judgment held that the homemaker stood on a higher pedestal than other earning family members. The MHC also noted that the value of the homemaker's contribution to the family was irreplaceable and cannot be compared to that of an "ordinary employee." No wonder, the judgment was widely reported and rightly applauded. Women's unpaid household work must be valued as productive work and not simply as work done for the welfare of the family. The reality is that in most cases women have little choice when it comes to housework. It is time the contribution of homemakers to the household is duly recognised in terms of monetary compensation.

The updated manual also places renewed focus on accessibility, advocating for structures that cater to diverse needs and abilities. By embracing these novel provisions, the manual aims to elevate construction standards, fortify disaster preparedness, and foster a more inclusive and environmentally conscious urban landscape in the region. The manual is based on the most recent building codes and IS criteria, and it aims to assure the construction of high-quality structures that are safe, durable, cost-effective, visually pleasing, and ecologically friendly. The Manual provides a solid viewpoint on many areas of building construction

• Natural light is important to the health and psychological well-being of households and for office uses. • Provisions for using Shear Walls in RC Structures with different possible geometries.

• Provisions for Reinforcing the Beam column joint using closely spaced closed loop steel ties around

column bars to hold together concrete in a joint region.

· Emphases on conservation of heritage buildings through a process chart of conservation.

• The contractor or the equipment manufacturer must execute a series of inspections and testing during the installation and completion of electromechanical operations, it adds.

## How to decarbonise India's coal power

The recent G20 declaration gives much guidance on agreed positions on clean energy transition. For example, the nations could have "net zero pathways of their own choice" depending on their "national circumstances" while "ensuring uninterrupted power supply" are some of the guarded positions negotiated. For India, the coal sector is the largest one to undergo a massive transition over the next two decades. India is in its growth phase, with per capita electricity consumption of 1,200 units, when the world average is 4,000. Considering the expected economic growth over the coming decades, more than three times additional electricity may be needed around 2050; of course, with the maximum growth of non-fossil sources and efforts for energy efficiency. Therefore, some growth of new coal plants is unavoidable.

India has nearly 600 coal power generation units of varying vintage, size and location that are operating currently. India is also building new units for reliable delivery of power supply. They use more than 800 million tonnes of coal and generate nearly 212 GW, providing 70% of the power gener-ated in the country. While China increased coal capacity from 580 GW in 2009 to 1,100 GW in 2019, India might barely go from 212 GW to 280 GW in the next 10 years, due to timely decarbonisation efforts and commitment to a net zero pathway.Given the magnitude of the problem and the concern of ensuring reliable power supply that is critical for a growing economy, how do we navigate the gradual closing down the plants while ensuring reliability and also growth? How do we gradually transit to the renewable energy(RE) future, given RE cannot deliver continuously and uniformly, even as we move to shut down coal-based



generating units? We examine some criteria here.

### Age of plants

Closing down old plants, say, above 25 years or 30 years, has become an oft-repeated suggestion. But this is a simplistic solution, often suggested by activists. At present, 52% of the plants in operation have been built in the last 15 years. They usually have a lifetime of 40 years at least. But they often recover capital deployed only in 20-25 years. Thereafter, they give power at competitive prices, challenging even renewables. Moreover, some coal plants would be needed to provide flexible power,

when RE is not available—at least for some time. Therefore, they are valuable and may provide an alternative to expensive storage solutions, if flexibility is assured.

Technical efficiency The quantum of kwh/kw delivered by a plant can decide its productivity and also its economic competitiveness. However, this often depends on other factors such as proximity to high demand centres and not necessarily technical efficiency alone.

CO2 coefficients of the power plants Typically, they range from 0.7-1.2 kg/ kwh. However, the high values are for older plants, which are fewer and may be used for flexible power on a temporary basis.

### Location-related factors

During 2016- 2019 period, the Central Electricity Authority issued closure in-structions for plants totalling a produc-tion capacity of nearly 9,000 MW , mostly coal-based, on the basis of the lack/concern over availability of land, water and coal. The land-use issues for highly urbanised locations are important, mainly due to the resulting air pollution and forgone value of expensive land. Water near some areas also

is increasingly getting scarce.

Distance from coal mines Retiring those plants that are quite far from the mines earlier may avoid transport costs as well as CO2 emissions.

Thus, the conventional thinking of closing because of age, technical efficiency and CO2 coefficients has limited validity.

As mentioned, the coal sector also has to grow, though guardedly. The new coal plants can be located near the coal mines (or the coast, if the coal is imported), to reduce additional costs and CO2 emissions from its transport. The new plants can mainly come up near coal mines(except a few), as not all locations can satisfy their demand with RE in the immediate future.

In conclusion, India would need a roadmap for growth and decarbonisation that considers granularity at the plant level. Although micromanagement using any single criterion should be avoided, a broad set of criteria could be made clear. Location-wise exercises may be needed, but these should, again, be at the regional level without rigid rules, not at the state level. The criteria for closure should focus on requiring less new plants and maintaining reliable supply rather than aiming for minor CO2 gains. Adding more transmission links would be a very effective way to manage the demand due to scattered RE sources. Even connecting with hydro power from Nepal, Bhutan, and Arunachal Pradesh may be perhaps the first level of defence to avoid new coal-based capacity. A new Irade study shows that it could save several hundred million tonnes of CO2, depending on various scenarios.

## **Sleep Preparation Behavior Hard-Wired** In Brains For Survival, Says Study

Scientists tired out mice only to find that it triggered them to "build a nest", or in other words, to "get ready for bed".

The team of researchers, led by Imperial College London, made the mice sleepy by presenting them with Lego bricks and other toys every half an hour for five hours and preventing them from napping.

The researchers then observed their behaviour and brain activity when they were eventually allowed to fall asleep using optogenetics, whereby particular brain cells can be artificially activated by a flash of light.

As the mice became progressively more tired, the prefrontal cortex at the top of the brain sent signals to the hypothalamus at the base of the brain, the researchers observed.



## Love Forms And Intensity Mapped On Human Body In A New Study

esearchers have created a map of the human body showing where different forms of love are felt and the intensity with which they are felt.

For building the map, the researchers from Aalto University, Finland, used data collected by surveying hundreds of participants about how they experienced 27 different types of love, such as romantic love, sexual love, parental love, and love for friends, strangers, nature, God, or themselves.

They also asked them where they felt the different types of love in their body and how intensely they felt it physically and mentally.

The findings suggested that the different types of love form a continuum from weaker to stronger, the researchers said in their study published in the journal Philosophical Psychology.

The strongest forms of love were felt most widely throughout the body, they found from the responses, most of which came from young women in higher education. "It was noteworthy, though not

very surprising, that the types of love associated with close relationships are similar and are the most strongly experienced," said philosopher Parttyli Rinne, who coordinated the study.

The participants were asked to colour in a body silhouette to show where they felt each type of love, how they felt the different types physically and mentally, how pleasant the feeling was and how it was associated with touch. Finally, they were asked to rate the closeness of the types of love.

"Love between persons is divided into sexual and non-sexual. The types of love that are particularly close to each other are those that have a sexual or romantic dimension," said Rinne.

While all the types were felt strongly in the head, their intensity differed throughout the rest of the body - some spread only to the chest, while others were felt all over, the researchers found.

"It was also interesting to find a strong correlation between the physical and mental intensity of the emotion and its pleasantness. The more strongly a type of love is felt in the body, the more strongly it's felt in the mind and the more pleasant it is," said Rinne.

"When we move from more strongly experienced types of love to less strongly experienced types, the sensations in the chest area become weaker.

"It may be that, for example, love for strangers or wisdom is associated with a cognitive process. It may also be that there are pleasant sensations in the head area. This is something that should be investigated further," said Rinne.

MUMBAI: Protecting depositors' hard-earned money is a sacred duty for a banker, and more important than visiting a religious place, RBI Governor Shaktikanta Das said on Monday.

He said the task is more important because the entire banking system runs on deposits, which are accumulated from small savers, middle class and retirees.

"Protection of depositors' money is the most important responsibility of a bank. It is a sacred duty. It is a sacred duty like going to a temple or masjid or gurdwara to bow down, it's a sacred task. In fact, I would say this is much more," Das said.

In the comments, made during a speech to directors of urban cooperative banks (UCBs), Das reminded the audience that this is the "biggest responsibility" cast on each one of them

It is also the responsibility of the Reserve Bank to work with all the banks to ensure that depositors' money is safe, and hence the Central bank keeps coming out with regulations and supervision efforts.

## **India Eases Planned Restrictions On Laptop, Tablet Imports: Report**

NEW DELHI: India is loosening its planned restrictions on imports of laptops, tablets and other IT hardware, giving manufacturers such as Apple Inc., HP Inc. and Dell Technologies Inc. more time to prepare for potential curbs. The country is doing away

with a compulsory licensing requirement for tech importers, and will instead only ask such companies to register under its so-called import management system, people familiar with the policy said. The system will start operating on November 1, they said, asking not to be named as the matter isn't public.

India is seeking to boost local production while trying to ensure sufficient availability of consumer electronics. The government last month shocked companies such as Apple and Samsung Electronics, as it announced a plan to curb laptop and tablet im-

ports without a suddenly required license. As part of the latest plan, all companies bringing everything from tablets and laptops to desktop computers and servers into India will have to register. But unlike

under the previously considered licensing regime, where companies were expected to cut back imports immediately, the new rules won't limit inbound shipments for about six to nine months, the people said.

A quota on imports could gradually kick in as companies begin to manufacture laptops, tablets and other hardware locally. The size of each company's quota will depend on its local production, import of IT hardware as well as export of such products from India, the people said.

The planned new rules don't apply to smartphones.



## Sensex, Nifty Edge Up On Gains In **Financials Shares Amid Weak Global Trends**

MUMBAI: Benchmark indices Sensex and Nifty closed marginally up in highly volatile trade on Monday, snapping their four-day losing streak even as weak global trends and foreign fund outflows dented the investor sentiment.

After gyrating 461.6 points during the day, the 30-share BSE Sensex eked out a marginal gain of 14.54 points or 0.02 per cent to settle at 66,023.69. During the day, it hit a high of 66,225.63 and a low of 65,764.03.

Snapping its four-day losing streak, the broader Nifty settled marginally up 0.30 points at 19,674.55 as 24 of its components advanced while 26 declined. Gains in financials, consumer durables, realty and banking shares were offset by losses in IT, oil & gas and pharma shares.

In the four sessions to Friday, the 50-issue barometer declined 3.37 per cent or 518 points while Sensex plunged 1,829 points or 3 per cent following a record 11-day rally. Analysts said a fresh uptick in US treasury yields is making investors jittery amid

rising concerns over inflation and high interest rates while FIIs continue to offload shares in local equities.

Bajaj Finance jumped the most by 4.64 per cent. Bajaj Finserv, Kotak Mahindra Bank, Asian Paints, UltraTech Cement, ICICI Bank, NTPC, JSW Steel and Tata Steel were among the major gainers.

NEW DELHI: Delhi traders' body CTI on Monday urged the Central government to ban import of lentil (masur) from Canada, over Ottawa's allegations relating to the killing of a Khalistani separatist on Canadian soil.

In a letter to Union Commerce Minister Piyush Goyal, the Chamber of Trade and Industry (CTI) said that there was a need to exert economic pressure on Canada.

A growing dispute between India and Canada has erupted following allegations made by Canadian Prime Minister Justin Trudeau over the killing of Khalistani separatist Hardeep Singh Nijjar.

Chairman of CTI, Brijesh Goyal, said that the development has sent ripples through the business world. Indian traders have demanded that India should ban import of lentils from Canada, which is a major supplier.

"Canada is becoming a stronghold of Khalistanis and their anti-India sentiment was displayed by protests at the Indian embassy. However, Trudeau is making politically motivated statements in view of upcoming elections in Canada," he said.

## **Apple Plans To Increase Production** Over 5 Times In India To \$40 Bn In 5 yrs

**NEW DELHIL** iPhone maker Apple has plans to scale up production in India by over five-fold to around \$40 billion (about 3.32 lakh crore) in the next 4-5 years, according to government sources.

According to a government official, who did not wish to be named, the company has crossed the \$7 billion production mark in the last financial year.

"Apple has plans to increase production in India to over \$40 billion in the next four-five years. It has crossed \$7 billion in the last fiscal," the official said. An email query sent to Apple did not elicit any reply.

Apple manufacturers iPhones in India and has plans to start manufacturing Airpods from next year. The officer said that Apple has no immediate plans to make iPads or its laptops in India.

"They don't have any plans to participate in IT hardware PLI. They may come at a later stage but as of now their focus is to scale up existing production lev-



els," the officer said. The company globally sold iPhones worth \$191 billion and products worth

\$38.36 billion in the wearable, home and accessories segment in the financial year ended on September 25, 2022.

In the first nine months of the current fiscal, the company recorded about a 4 per cent dip in iPhone sales at \$156.77 billion and a slight decline in the wearable, home and accessories segment at \$30.52 billion.

The company has become the largest exporter of mobile phones from India. According to industry sources, sales of Apple's iPhone 15 series registered a 100 per cent growth com-

pared to that of the iPhone 14 series on the launch day on Friday.

Apple has launched four models in the iPhone 15 series. Two variants-iPhone 15 and iPhone 15 Plus-are also being made in India.

The company has for the first time made available the 'made-in-India' iPhones on the same day it started selling the devices in other parts of the globe.

According to market research firm Counterpoint Research, Apple led the ultra-premium segment, with phones priced above Rs 45.000 apiece, with 59 per cent market share in the first quarter of 2023 and India is among the top-five markets for the company now.

### SC sets up seven-judge bench to reconsider 1998 verdict granting immunity from prosecution to MPs/MLAs

New Delhi: A seven-judge bench of the Supreme Court, headed by Chief Justice D Y Chandrachud, will reconsider the apex court's 1998 verdict granting MPs and MLAs immunity from prosecution for taking bribe to make a speech or vote in Parliament and state legislatures.

A notice, uploaded on the apex court website, said the bench will hear the matter on October 4

'Constitution Bench comprising the Chief Justice of Îndia, Justice A S Bopanna, Justice M M Sundresh, Justice Pamidighantam Sri Narasimha, Justice J B Pardiwala, Justice Sanjay Kumar and Justice Manoj Misra is constituted to hear criminal appeal no. 451/2019 titled Sita Soren vs Union of India on October 4 (Wednesday)," the notice said.

Nearly 25 years after the JMM bribery scandal rocked the country, the apex court had on September 20 agreed to reconsider its 1998 judgment, saying it was an important issue having a significant bearing on "morality of polity".

A five-judge bench of the apex court had decided to refer the issue to a larger sevenjudge bench.

### Rawalpindi.

## **India Women Clinch Asian Games** Cricket Gold, Beat Sri Lanka In Final

HANGZHOU: Rookie pacer Titas Sadhu singlehandedly earned a gold medal for the Indian women's cricket team in its maiden appearance as it defeated Sri Lanka by 19 runs in a low-scoring final of the Asian Games here on Monday.

On a pitch difficult for batting, the Indian women's team struggled to 116 for seven but it was just about par score.

However sensational Titas, who is just four days shy of her 19th birthday, bowled a devastating first spell and finished with superb figures of 4-1-6-3 to

play a big role in restricting Sri Lanka to 97 for eight in 20 overs. She had an able ally in leg-spinner Devika Vaidya (4-0-15-1), who kept a tight leash on the islanders.

Left-arm spinner Rajeshwari Gayakwad (3-0-20-2) and offspinner Deepti Sharma (4-0-25-1) started off badly but were on target during the back-end as Indian women always looked in

complete control. This was one gold medal that India were expected to win,

but the standard of cricket was pretty poor, and the nature of wicket didn't help matters. The Indian women's team is

missing a genuine quick bowler in its ranks since the retirement of Jhulan Goswami and Titas looks to be a worthy successor. Earlier, Harmanpreet's decision to bat first was a correct one as the pitch, which wasn't conducive for stroke-play, only got slower as the match progressed. Smriti Mandhana (46 off 45 balls), who hit four boundaries and a six, along with Jemimah Rodrigues (42 off 40 balls), added 73 runs for the second wicket. ## **Pakistani Players Issued Indian Visa For World Cup Travel: ICC**

DUBAI: Members of the Pakistan cricket team were on Monday issued Indian visas for the ODI World Cup, the International Cricket Council (ICC) confirmed, hours after the PCB raised serious concerns with the global body over the delay in the national team's travel to Hyderabad.

The visa clearance came less than 48 hours before Pakistan's scheduled travel to India in the wee hours of September 27. They play their first warm-up game against New Zealand in Hyderabad on September 29.

Visas have been issued to Pakistan," an ICC spokesperson told PTI. However, confusion remained in the Pakistan camp over the grant of visa.

"We have not got the call from Indian High Commission yet over visa clearance. Member of our team is stationed there," PCB spokesperon Umar Farooq told PTI. The confirmation from the ICC came after the PCB wrote to ICC CEO Geoff Allardice on Monday over the visa delay besides claiming the anxious wait has adversely impacted the team's preparation for the 50-over showpiece.

Pakistan were supposed to have a two-day team bonding session in Dubai before their scheduled arrival in Hyderabad on September 27 but

Pakistan last visited India for the T20 World Cup in 2016. The arch-rivals only play each other in the Asia Cup and ICC tournaments due to the tense relations between the two countries.

PCB sources informed that flight tickets of around 35 members have been rebooked now that the Dubai trip is off. The team will now leave for Hyderabad from Lahore in the wee hours of September 27 and reach Hyderabad via Dubai in the night.

'The warm-up game is less than four days away and players are in a state of uncertainty. If the players are having to experience delays, one can only wonder what will happen to visa applications of fans and journalists," a source said.

Visa applications from Pakistan require clearances from three ministries -- home, external affairs and sports.

Pakistan's second warmup game will be against Australia on October 3, also in Hyderabad. They will remain in the city for their opening two World Cup games against Netherlands and Sri Lanka on October 6 and 10 respectively before flying to Ahmedabad for the big game against hosts India on October 14. Only two members from the current Pakistan squad have toured India for cricket -- Mohammad Nawaz and Salman Agha.

## **BCCI AGM: Dalmiya, Dhumal Re-Elected In IPL GC**

NEW DELHI: Former CAB president Avishek Dalmiya and current IPL chairman Arun Singh Dhumal have been re-elected in the IPL governing council as per decisions taken at the Annual General Meeting of the BCCI held in Goa on Monday.

The general body was apprised about BCCI earning more than 38 per cent from annual revenue generated by the ICC and also Rs 67 crore (approx) per match earning from media rights during the next cycle of bilateral series.

"All routine decisions happened. The list of names for the cricket committees and the subcommittees will be prepared by the office bearers as entrusted by the House. As far as IPL GC is concerned, IPL chairman Arun Dhumal and Avishek Dalmiva were supposed to be elected and it happened on expected lines," a state unit representative told PTI. It has also been learnt that

Ombudsman-cum-Ethics Officer

will continue as per his contract which is due to expire next year.

"The Ombudsman-cum-Ethics Officer will continue till June, 2024. He will serve his full contract," the state unit source said.

The board members were also apprised about the new budget and the profit that BCCI made in the last financial year.

Former India left-arm spinner Pragyan Ojha will no Îonger be Indian Cricketers' Association's representative in the Apex Council.

There were talks about removal of Salil Ankola from the national selection panel as chairman of selectors Ajit Agarkar, who is also from Mumbai, is already a part of the panel. The BCCI has a convention that five selectors represent five zones and this time, there are two from West Zone.

'There has been no such discussion about this during the AGM. If there is anything, it can only happen after the World Cup. As of now, no selector is being changed," the source said.

# US Provided Canada With Intelligence On Killing Of Sikh Separatist Leader

merican spy agencies provided information A provided information to Ottawa after the killing of a Sikh separat-ist leader in the Vancouver area, but Canada developed the most definitive intelligence that led it to accuse India of orchestrating the plot, according to Westernallied officials.

In the aftermath of the killing, US intelligence agencies offered their Canadian counterparts context that helped Canada conclude that India had been involved. Yet what appears to be the "smoking gun" - intercepted communications of Indian diplomats in Canada indicating involvement in the plot – was gathered by Canadian officials, the allied officials said.

(On Saturday, the US ambassador to Canada revealed that intelligence shared among the Five Eyes partners helped Canadian Prime Minister Justin Trudeau arrive at the decision to publicly allege an Indian government hand in the killing of Khalistani separatist Hardeep

## **Delhi High Court Issues Fresh Notice To BBC Over Defamatory Documentary On Modi**

The Delhi High Court on Monday issued fresh notice to the British Broadcasting Corporation (BBC) on a plea by an NGO seeking damages, claiming its documentary "India: The Modi Question" casts a slur on the country's reputation and makes false and defamatory imputations against Prime Minister Narendra Modi and the Indian judiciary.

Besides BBC (UK), Justice Sachin Datta also issued fresh notice to BBC (India) on the plea filed by Gujaratbased NGO Justice On Trial.

The counsel for the petitioner NGO informed the high court that notices were issued to BBC (UK) and BBC (India) earlier but they could not be served. Advocate Siddharth Sharma, representing the NGO, sought more time to serve the notices to the defendant



"Issue fresh notice to the defendants through all permissible modes," the high court ordered, and listed the matter for further hear-

ing on December 15. It had on May 22 issued notice to the defendants on the plea which has said BBC (UK) is the national broadcaster of the United Kingdom and has released the news documentary --"India: The Modi Question" which has two episodes

and BBC (India) is its local operations office. It said the two episodes were published in January 2023.

The petitioner has sought damages of Rs 10,000 crore in favour of the NGO and against the defendants on account of the "loss of reputation and goodwill caused to the Hon'ble Prime Minister of India, the Government of India, the Government of the State of Guiarat as it was during

the period of the Gujarat Riots, and also the people of India".

The documentary relates to the 2002 Gujarat riots when Modi was the state's chief minister. The government had

banned the documentary soon after it was released.

The plaintiff organisation, which says it is a society registered under the Societies Registration Act, 1860 and also registered as a Public trust under the provisions of the Bombay Public Trust, 1950, has filed the suit for damages and also sought permission to file as an indigent person.

It has contended that the documentary contains content which casts a slur on the reputation of the country and also makes false and defamatory imputations and insinuations against the Prime Minister of India, the Indian judiciary and the Indian criminal justice system
