

## Kashmir Valley Loses 1 Lakh Kanals of Paddy Land in 7 Yrs

While the rice yield per hectare of paddy land is increasing in Kashmir, the paddy land is continuously shrinking across the valley as per official figures.

From 1,35,000 hectares of land under paddy cultivation seven years earlier, the land currently under paddy cultivation has come down to 1,29,000 hectares, according to Director Agriculture Kashmir, Choudhary Mohammad Iqbal,

though he added that there has been a significant increase in rice yield per hectare.

"This year, there is going to be a record yield as our estimates suggest that the yield per hectare will be between 63 to 65 quintals this year as compared to last year's 60 quintals per hectare," he said. "This is because of the fact that the paddy plantation was done at the most opportune time this year (before June 15) and was later helped by timely rains and proper temperature



for the crop to flourish. It is also because of the Prime Minister's schemes being successfully implemented by our

staff on ground with good support from farmers," Iqbal told Kashmir Observer.

He, however, accepted that there is a continuous decline in paddy land "which should end as soon as possible." From 1,35,000 hectares of paddy land seven years back, he said, the land currently under paddy cultivation has come down to 1,29,000 hectares. One hectare is equivalent to nearly 20 kanals. "But, it is not only because people are building houses over paddy land. The paddy

land is also shrinking because of other factors such as shifting cropping patterns. For example, it makes more economic sense to some farmers to grow vegetables on paddy land or to some other farmers to convert paddy land into orchards," Iqbal said and added that this is why there is a continuous decline in paddy land.

When asked if his department is doing anything about stopping the trend of converting paddy land into other land uses, he said that **More On P10**

## Kargil All Set For Hill Council Polls Today

Srinagar: Authorities in the Ladakh region have put in all the arrangements for the smooth conduct of 5th general LAHDC Kargil polls on Wednesday.

Initially, the election was scheduled to be held on September 10 but was later changed to October 4 following the Supreme Court verdict.

As per details, a total of 85 candidates belonging to parties such as National Conference, Congress, BJP, AAP and Independent are in the fray.

Officials said that the polling will start at 8 am and end at 4 pm tomorrow (Wednesday). The counting will be held on October 8 and overall election process will end on 11.

Officials said that there are a total of 26 constituencies and 278 polling stations have been set up.

## Power Crisis Deepens In J&K, Govt 'Finding Ways'

Srinagar: The power crisis in Jammu and Kashmir is becoming worse as consumers are facing long power cuts during the day with authorities claiming that the talks to resolve the issue are on and in the coming days "things would improve."

However, the local consumers here told a local news agency KNO that the power scenario has worsened across the valley as just 4-5 hours of electricity is being supplied to them on a daily basis at a time when smart meters have been installed in almost half of Srinagar city with a promise of 24x7 power supply.

The irked consumers said that in both metered and non-metered areas, the erratic power supply from the past over two weeks have caused immense hardships to them.

"We were expecting an improvement in the power scenario after the installation of smart meters and also the augmentation of power infrastructure in the past four years, but all in vain as the situation has worsened ahead of the winters in Kashmir," the consumers said.

Meanwhile, Chief Engineer, Kashmir Power Distribution Corporation limited (KPDCL), Javed Yousuf Dar said that the government is finding ways to resolve the issue of power paucity in J&K.

"The talks are going on with NTPC and others to get extra electricity for the people in J&K. We are expecting to get additional electricity in the coming days, which would help in resolving the present electricity situation," he said.

He, however, stated that he was not aware about the huge debt of electricity purchase from outside. **More On P10**

## Dal Lake Loses Sheen To Red Algae Bloom Environmentalists Links Issue With Rising Pollution, Abundant Nutrients; Officials Say Nothing To Worry

Srinagar: Much to the disappointment of tourists and the inhabitants, a major portion of the famed Dal Lake has been badly affected by red algae bloom, changing the appearance of the splendid water body. The part of the lake from Nehru Park to Mughal garden Nishat, has been badly affected by "eutrophication," an ageing process of aquatic ecosystems.

In contrast to the assertions made by environmentalists, who linked the issue with rising pollution levels in Dal Lake, authorities defined the red algae as a natural phenomenon that will end on its own a few days after its occurrence.

Ajaz Rasool, a well-known environmentalist asserted that protecting Dal Lake from pollution is the best way to prevent red algae blooms in the future. He said the sewage-derived

nutrients have a key role in the algal bloom, which is green in the morning and turns brick red with the rise in day temperature.

"The primary cause of the issue is the growing pollution in Dal Lake; it is not a natural occurrence and the only way I think to prevent red

algal bloom is to keep Dal Lake clean," Ghulam Rasool told Kashmir Observer.

He claimed that diffused aeration enhances water quality from the ground up while the dewatering or dredging process severely affects the lake bed. "Diffused aeration is a shore-mounted **More On P10**

## Court Denies Bail To Man For Uploading Woman's 'Nude' Pics

Srinagar: A court here on Tuesday rejected the bail application of a man accused of uploading "nude pictures and videos" of a woman in August this year.

According to a police report, Cyber Police Station Srinagar received a complaint from the woman, alleging "cyber harassment and sharing of explicit contents."

The woman stated that she was in a relationship with the accused named Junaid Majeed Khanday of HMT Umerabad Srinagar following a marriage proposal.

However she said that after some time, the accused made "unauthorized and forcible" access into her mobile device and misused it.

The woman said that accused uploaded "nude and explicit videos and photos on different platforms as snapchat,

Instagram and virtual number generated by him and he has exposed my person to virtual world and violated my privacy rights, as a result of resistance shown by me against his torture and harassment."

The woman said that the accused threatened her that he will get her brother trapped in militancy and drugs case and will drag her father to the road if she refuses to marry him.

Moreover, he threatened her that he will make photos and videos viral which were taken by his phone. Subsequently, the accused shared the "nude videos and photos" on various online platforms on August 10.

On perusal of contents of the application and evidences provided by her including the act of Instagram, Snapchat and WhatsApp, police filed an FIR under section 66, 43, 66, 67, 67-A IT act besides **More On P10**

details for the assistance. Amidst the emotional scenes witnessed in Srinagar, the district administration of Srinagar provided immediate assistance to the fire victims of Parimpora Ghat.

According to details, on the directions of Deputy Commissioner (DC) Srinagar, Mohammad Aijaz Asad, a team of district administration, Srinagar, visited Parimpora locality in Shalteng Tehsil where 17 residential sheds were gutted in a fire incident on Sunday.

On the occasion, the team provided immediate assistance to the fire victims of 17 families, residing in the residential sheds which got damaged in a massive fire incident.

The team assessed the damages caused due to the fire incident and expressed sympathy on behalf of the district administration Srinagar with the affected families on the loss of property.

# 39,000 Embrace Bicycle Service, Shedding Pounds and Saving Money

Srinagar: Ever since the government started bicycle service in the city, 25-year-old Adil Ahmad Khan has made it his routine to use the service for commuting.

Not was he only able to save his money, but his body also witnessed changes as he lost the extra fat. "I have been fond of bicycles since my childhood. After the government introduced this service, I daily hired a bike and took the shortest route to my office," he told the news agency.

Like Khan, majority of the Srinagarites have embraced the green and fit transport by availing the

bicycle service introduced by the government earlier in May.

Since May, more than 39000 people have registered themselves for the service to commute within the city.

Mohammad Yasir Shah, a Srinagar-based official of Chartered Bikes, said that as many as 39980 customers registered themselves with the app.

"We are witnessing a great response for the service. So far 39980 Srinagarites have sought registration for the service via our app," he said.

He said more than 1000 people commute daily within the city using bicycles.

Shah said 20 more stations are

coming up within the city, which he said will further popularise the service.

"We have identified 20 spots wherein stations will be established so that more and more people use our bicycles. Right now we have established 80 stations across the city wherein a person can book a ride to another destination," he said.

On May 4, the Jammu and Kashmir administration as a part of the Smart City Mission introduced Chartered Bikes- bicycles, in Srinagar as a mode of transport to reduce pollution and overcome traffic snarls.

Since then the majority of the people have been taking support of these bicycle services to commute from one place to another.

### J&K Team For Tibet To Find Truth Of 'Shahtoosh Threat'

Srinagar- Chief Minister Farooq Abdullah today said the Centre would be approached to seek China's permission for facilitating the visit of a team to Tibet to find if continuing Shahtoosh trade threatens antelope.

Speaking at a function held in observance of the mil-lennium's first wildlife week here this afternoon, the chief minister said the team will comprise wildlife officials and representatives of Shahtoosh traders whose trip would be sponsored by the government. "If the team feels threat to antelope as genuine, the Shahtoosh traders will have nothing to do with it", he said, adding that with this the controversy over the issue would end once for all.

The chief minister said that as a result of measures taken to preserve wildlife, their population is on increase in the state. He stressed for creating awareness among the people especially students about the need for protecting wildlife and said that two zoos would be set up at Manda in Jammu and Dachigam in Srinagar for people to see nature's fauna. He asked for preparing comprehensive plans for conservation of various sanctuaries like Hokersar, Hygam and Mirgund.

Abdullah called for evolving a mechanism and adopting an integrated programme for making use of dead wood as fuel by those living near forest while stringent measures would be taken for preserving the green trees. Steps have to be taken for bridging the gap between energy-need and energy source. This has become imperative in view of growing pressure of forest resource since other sources of energy like electricity and LPG have become costlier and scarce. He made a fervent appeal to the people for making judicious use of electricity, generation of which is affected during winter due to lesser water flow.

## Khamenei: 'Israel', KSA Normalizing is 'Betting On A Losing Horse'

Iranian leader Seyyed Ali Khamenei stated on Tuesday that nations seeking to normalize relations with "Israel" "are betting on a losing horse," according to Iranian state media.

"The definite position of the Islamic Republic is that countries that make the gamble of normalization with 'Israel' will lose. They are betting on a losing horse," the leader said.

The Israeli Foreign Minister Eli Cohen claimed last month that a US-brokered deal to normalize ties between "Israel" and Saudi Arabia could happen by early next year after all three nations demonstrated progress in the negotiations.

"Existing differences can be overcome. It will take time, but there is progress. I think there is certainly a possibility that in the first quarter of 2024, four or five months from now, that is, there will be a moment when we can finally negotiate all the details," Cohen said in an interview for the Israeli occupation army radio.

This comes after Moraya Fulberg, the political affairs com-

mentator on the Israeli Channel 13, stated on Sunday: "While we are on the right path, there are still many obstacles in the way, and this poses a significant challenge."

"There are discussions within the security and military establishment, and it is expected that prominent Israeli figures will soon arrive in Washington. Furthermore, the Prime Minister is also expected to visit in November," she added.

Just 10 days earlier, Saudi Crown Prince Mohammed bin Salman admitted that Saudi Arabia was getting closer to normalizing ties with the Israeli occupation in an interview with Fox News, adding that if Iran acquires a nuclear weapon, "we have to get one."

"Every day we get closer," Bin Salman said when asked to describe the discussions focused on normalizing diplomatic ties between Saudi Arabia and "Israel."

Responding to a question on the requirements of a normalization deal, the de facto Saudi leader claimed that "the Palestinian issue is very important. We need to solve that part," adding that there had been "good negotiations" so far.

## 'Does Congress Want To Clip Muslims' Rights?' PM's Big Caste Census Charge

**JAGDALPUR:** Prime Minister Narendra Modi on Tuesday slammed Congress over its nationwide caste census pitch and accused the party of trying to divide Hindus, and sought to know if it wants to curtail the rights of Muslims by advocating a population-based distribution of resources.

PM Modi said that for him, the poor form the biggest chunk of the country's population and they should have the first right over resources, irrespective of their caste or community. He also accused the Congress of dividing the society on caste lines for votes.

The PM's statements came a day after the Nitish Kumar government released a caste survey that revealed Other Backward Classes and Economically Backward Classes constitute a whopping 63% of Bihar's population.

Congress MP Rahul Gandhi, whose party is a constituent of the ruling bloc in the state, welcomed the caste survey and said the country needs a caste census to give people rights as per their proportion in population.

Addressing the BJP's "Parivartan Mahasankalp" rally in Jagdalpur, the headquarters of Bastar district in Chhattisgarh, PM Modi claimed that the Congress has entered into a "secret pact" with a foreign country and takes pleasure in speaking against India, and urged people to be alert.

The country's oldest party is being run not by its leaders but by some "behind the curtain" elements who are in nexus with anti-national forces, he claimed.

"Since yesterday (Monday), the Congress has started speaking a different tune. Congress leaders say the 'abadi' (population) of people will decide the rights (on resources), but for Modi, poor people are the biggest 'abadi' of the country and they have the first right over resources. Welfare of the poor is my aim," he said.

The BJP's star campaigner referred to a 2006 statement of then-Prime Minister Manmohan Singh advocating that minorities, particularly Muslims, must have the "first claim" on resources.

"I was wondering what would former Prime Minister Manmohan Singh ji be think-

ing? Manmohan Singh ji used to say minorities have the first right over resources of the country and that too the Muslims. But now the Congress is saying proportion in population will decide who will get how much share of rights. Does that mean they want to curtail the rights of Muslims?" he asked.

"Whose population is more?" the PM asked and wondered if it will be possible to ensure distribution of the rights according to social groups' share in the demographic mix.

"If they want to divide the rights on the basis of population, then who will have the first right (over resources)? Whose population is more? Congress leaders should clarify whether the rights will be given according to share in population, whether the Congress wants to take away the rights of minorities. Should Hindus, who have the biggest population in the country, come forward and claim all the rights?" he asked.

Attacking the Mallikarjun Kharge-led party, the PM said the national outfit wants to destroy India by dividing the Hindus.

## As Opening Of Ram Temple In Ayodhya Nears, Construction Of Dhannipur Mosque Yet To Begin

**LUCKNOW:** As the opening of Ayodhya's Ram temple nears, the construction of a proposed mosque some kilometres away is yet to begin with the Indo Islamic Cultural Foundation saying it does not have the money even to pay the project's "development charges".

The IICF is a trust formed to build a mosque and other community facilities including a hospital on the 5-acre plot at Dhannipur in Ayodhya as mandated by the Supreme Court in the Ram Janmabhoomi-Babri Masjid verdict.

The land for the mosque complex was given to Uttar Pradesh Sunni Central Waqf Board by the state government.

"In February this year, the board of Ayodhya Development Authority gave its approval for the mosque project after some procedural delay. Thereafter, we came to know that the amount of development charges to be submitted to the authority for the entire project would run into a few crores of rupees," Athar Hussain, spokesperson of IICF trust, told PTI on Tuesday.

"As we don't have enough



money to pay the development charges, we decided to defer the construction of a hospital at the site as it consists of around 90 per cent of the entire project. We will first build the mosque as the development charges for it will be less," Hussain said.

He hoped that in the next two months, the IICF trust will be able to mobilise funds for the construction of the mosque.

"We are in the process of mobilising funds for the mosque's construction... Since the trust was brought into the public domain, different accounts were opened for the mosque, hospital and community kitchen. At the moment, the funds in the account of the trust are around Rs 40 lakh," the IICF spokesperson added.

When asked about any fund

raising drive for the project, he said, "Fortunately or unfortunately, this project was compared with the Ram Mandir project... The response that we expected from people for the mosque project could not be materialised.

"Now, we plan to approach some rich people of the community in metro cities so that fund mobilisation for the project can become easier." Dhannipur village is around 22 km from the spot of the Ram temple in Ayodhya.

In Ayodhya, preparations are in full swing for the grand opening of Ram temple in January next year.

Prime Minister Narendra Modi is expected to participate in the 'pran pratishtha' (consecration) ceremony at the newly constructed temple.

## 107 MPs And MLAs Have Hate Speech Cases Against Them: Report

**NEW DELHI:** A total of 107 MPs and MLAs have hate speech cases against them and 480 candidates with such cases have contested elections in the last five years, according to poll rights body Association for Democratic Reforms (ADR).

The ADR and National Election Watch (NEW) have analysed the self-sworn affidavits of all the incumbent MPs and MLAs, besides the unsuccessful candidates in the Assembly and Lok Sabha polls held in the country in the said period.

The analysis reveals that many of the MPs and MLAs, who are designated lawmakers, have actually declared cases related to "hate speech" against themselves. The analysis is based on the affidavits submitted by the MPs and MLAs prior to the last election they contested.

According to the analysis, 33 MPs have declared cases related to hate speech against themselves -- seven from Uttar Pradesh, four from Tamil Nadu, three each from Bihar, Karnataka and Telangana, two each from Assam, Gujarat, Maharashtra and West Bengal and one each from Jharkhand, Madhya Pradesh, Kerala, Odisha and Punjab.

In the last five years, 480 candidates with declared cases related to hate speech have

contested elections to state assemblies, the Lok Sabha and the Rajya Sabha, the ADR said.

It said 22 MPs with cases related to hate speech are from the ruling Bharatiya Janata Party (BJP), two from the Congress and one each from the Aam Aadmi Party (AAP), AIMIM, AIUDF, DMK, MDMK, PMK, Shiv Sena (Uddhav Balasaheb Thackeray) and the VCK, besides one Independent MP.

Seventy-four MLAs have declared cases related to hate speech against themselves. Nine each are from Bihar and Uttar Pradesh, six each from Andhra Pradesh, Maharashtra and Telangana, five each from Assam and Tamil Nadu, four each from Delhi, Gujarat and West Bengal, three each from Jharkhand and Uttarakhand, two each from Karnataka, Punjab, Rajasthan and Tripura and one each from Madhya Pradesh and Odisha.

Twenty MLAs with cases related to hate speech against them are from the BJP, 13 from the Congress, six from the AAP, five each from the SP and YSR-CP, four each from the DMK and RJD, three each from the AIUDF and SHS, two from the AIUDF and one each from the AIMIM, CPI(M), NCP, Suheldev Bharatiya Samaj Party, TDP, Tipra Motha Party and TRS, besides two Independent MLAs.

## India Climbs 72 Places In Global Mobile Speed Rankings, Thanks To 5G Push

The launch of 5G services in India turbocharged mobile download speeds here, pushing the country's ranking 72 notches higher to 47th spot in Speedtest Global Index, ahead of nations like Japan, the UK and Brazil, according to Ookla.

India's speed performance has zoomed up 3.59 times since the introduction of 5G, it said dubbing the country's 5G advancement as "remarkable".

In this global pecking order, India ranked not only ahead of its neighbours like Bangladesh, Sri Lanka, and Pakistan, but also some G20 countries, such as Mexico (90th), Turkey (68th), the UK (62nd), Japan (58th), Brazil (50th place), and South Africa (48th place).

India's speed performance has seen a 3.59 times increase since the introduction of 5G, with median download speeds improving to 50.21 Mbps in August 2023, from 13.87 Mbps in September 2022.

"This improvement has led to India's rise in the Speedtest Global Index, moving up 72 places, from 119th place to the 47th position," it said.

The 5G deployments have led to an improved overall user experience across all telecom circles with operators investing in backhaul infrastructure.

The launch of 5G technology by operators like Reliance Jio and Bharti Airtel has led to a substantial increase in 5G subscribers, and operators still have ambitious roll-out plans, with the deployment of a significant number of 5G base stations across the country.



In fact, 5G has not only brought faster speeds but also higher customer satisfaction, as indicated by the Net Promoter Score (NPS), which shows that 5G users in India consistently rate their network operators more positively compared to 4G users.

"Additionally, 5G Fixed Wireless Access (FWA) services have been introduced to provide broadband connectivity in areas where laying fiber is costly or impractical," it said.

Mobile users in India are among the most data-intensive consumers in the world. Yet, India's 4G networks have been unable to keep pace with consumer expectations, primarily due to network congestion caused by population density, lack of cellular infrastructure, backhaul, as well as spectrum constraints.

"Following the 5G spectrum auction, operators have been able to address some of those issues and help to offload 4G traffic onto 5G networks, thus reducing 4G network congestion," it said.

The strategy has proven successful already, as 25-35 per cent of traffic is already getting offloaded on 5G from 4G.

## Clash At AMU Hostel Turns Ugly, Leads To Gunfight, 3 Injured

**ALIGARH, UTTAR PRADESH:** Three youths were wounded by gunshots in a fight between two rival groups allegedly belonging to two separate hostels of the Aligarh Muslim University in UP, officials said today.

The incident took place Monday night and the injured, Sadiq, Firoz Alam, and Abdullah, are undergoing treatment at the Jawaharlal Nehru Medical College, they said.

Police claimed the three were AMU students. Varsity publicity in-charge Prof Asim Siddiqui, however, said they were outsiders.

Mr Siddiqui said a clash had taken place Monday night between two student groups at VM Hall.

A short while later, a group

of armed youths barged into Sir Syed Hall (North) where a gunfight ensued and three young men were shot and wounded.

The university has not issued any explanation yet on how these "outsiders" entered the hostels so late at night.

Acting Circle Officer, Civil Lines, Sanjay Jaiswal said police are in the process of filing an FIR in the gunfight, which was connected to an old rivalry between two student groups.

An uneasy calm prevailed on the AMU campus this morning when the university opened.

Student protesters blocked the campus' two main entry gates - Baab-e-Syed and Centenary Gate, forcing the varsity authorities to divert traffic to Faiz Gate and Sir Syed House Gate, which normally remain closed.

## Breath Analyser Tests: DGCA May Ask Pilots Not To Use Perfume, Mouthwash, Tooth Gel

**NEW DELHI:** Pilots might soon be asked not to use perfume, mouthwash and tooth gel as that may result in positive breath analyser test.

The Directorate General of Civil Aviation (DGCA) has sought comments on a draft Civil Aviation Requirements (CAR) wherein it has also proposed barring crew from using any "drug/formulation or use any substance such as mouthwash/tooth gel/perfume or any such product which has alcoholic content".

Comments have been sought on the CAR, which pertains to procedure for medical examination of aircraft personnel for alcohol consumption, till October 5.

Under the DGCA norms, for all scheduled operators, each flight crew member and cabin crew



member shall be subjected to pre-flight breath analyser examination at first departure airport during a flight duty period.

For all scheduled flights originating from destinations outside India, post-flight breath analyser

examination of each flight crew and cabin crew shall be carried out at first port of landing in India, as per the norms.

As per the draft CAR, no crew member shall consume any drug/formulation or use any substance such as mouthwash/tooth gel/perfume or any such product which has alcoholic content.

"This may result into positive breath analyser test. Any crew member who is undergoing such medication shall consult the company doctor before undertaking flying assignment," it noted.

About the draft CAR, a former Air India pilot said a direction with respect to the use of perfume, mouthwash and tooth gel will be for the good of pilots but it should be in the form of an advisory rather than being part of the regulations.

Reviews of regulations are done from time to time but there should not be too many restrictions on pilots, he added.

Among others, all maintenance personnel/flight crew shall be subjected to breath analyser examination before undertaking any taxi operation of the aircraft.

According to the draft CAR, operators shall make available at least two serviceable breath analyser equipment fuel cell technology based, capable of giving accurate digital value up to three decimal places with a memory to store and recall at least last 1,000 records.

Stringent punishments are in place when a crew tests positive in a breath analyser test, depending on whether it is repetitive. It is applicable for both pre and post flights.

Mufti, a former chief minister of Jammu and Kashmir, said the raids were extremely perturbing as she accused the central government of championing press abroad and attacking it at home. "GOI claims India is the mother of democracy & about press freedom abroad yet in the same breath uses state agencies to the crackdown on the remaining handful of independent media outlets.

"Even telephone devices have

been forcibly snatched only for a fishing expedition. The repeated illegal pattern of arrest first & creating fake charges later is extremely perturbing (sic)," Mufti wrote in a post on X.

Delhi Police's Special Cell Tuesday morning conducted raids at the premises of online portal NewsClick and its journalists, triggering outrage against the action among scribes.

The Special Cell has registered a new case and started an investigation, officials said. Abhisar Sharma, a senior journalist, wrote on X, "Delhi police landed at my home. Taking away my laptop and phone."

Another journalist, Bhasha Singh, wrote on X, "Finally last tweet from this phone. Delhi police seizure (sic) my phone."

## Oppn Parties To Hold Peaceful Protest In Jammu On Oct 10: Dr Farooq

**JAMMU:** Leaders of various opposition parties met under the chairmanship of National Conference president Farooq Abdullah here on Tuesday and unanimously decided to hold a peaceful protest against the BJP in Jammu next week.

The BJP, however, termed it a "conspiracy" and claimed that it would not be successful because the people were aware of the "misdeeds" of these leaders.



Interacting with reporters after the two-hour-long meeting at a hotel here, Abdullah claimed that the Constitution has been suspended and the democratic rights of the people of Jammu and Kashmir were under attack.

"We all have decided to stage a peaceful protest on October 10 and are seeking necessary permission from the divisional commissioner," he said.

"We do not understand this." PDP president Mehbooba Mufti said the meeting condemned the raids by the Delhi Police's special cell at the residences of NewsClick journalists.

"In this Amrit Kaal, speaking the truth has become the biggest sin. The one who tells the truth and questions this government over unemployment, inflation and rapes are slapped with the Unlawful Activities (Prevention) Act.

When asked whether the Democratic Progressive Azad Party led by Ghulam Nabi Azad and the Apni Party headed by Altaf Bukhari were invited to the meeting, the National Conference president replied, "They are government parties."

He said it was imperative to hold the "much-delayed" assembly elections to fill up the political vacuum in Jammu and Kashmir.

"This was initially done against journalists in Jammu and Kashmir, but now it has become a norm across the country," she said and asked the Editors Guild of India to take notice of such developments.

CPI(M) leader M Y Tarigami, who attended the opposition parties' meeting, said they held a detailed discussion on the emerging situation in Jammu and Kashmir and the problems being faced by all sections of the society in the Union Territory.

"They (government) first talked of completing the delimitation process and then of voter list before holding elections. Both the exercises are complete. So what is pending now for which they are delaying the elections?" Abdullah asked.

our pain and stand with us for our rights at this crucial juncture", he said.

"The constitution is suspended in Jammu and Kashmir which is not an ordinary thing... we want to appeal to the countrymen that they (BJP) are talking about integrating Jammu and Kashmir but the reality is that this government has separated us from the constitutional order," the Left leader alleged.

Following the abrogation of Article 370 of the Constitution in 2019, the Central government has now claimed improvement in the situation while the lieutenant governor is saying that Jammu and Kashmir is marching on the path of development, he said.

Meanwhile, the BJP's Jammu and Kashmir unit president Ravinder Raina said the people of the Union Territory have rejected these leaders and they are now resorting to conspiracies by forming the Gupkar alliance and sometimes by forming the INDIA bloc to mislead the people.

"If everything is alright, what prompted the overnight change of thought about the holding the urban local body polls and panchayat elections (scheduled for later this year)? It means that what you said at the G20 event is not right," Abdullah said.

He said that depriving the people of electing a government of their choice was tantamount to suspension of their constitutional and democratic rights.

"This government has deprived the people of their constitutional rights which are akin to anti-nationalism. It is a loss to the nation and our future," Tarigami said, adding that former chief ministers, ex-MLAs and MPs will come together in Jammu on October 10 to defend the constitution and the rights of the people of Jammu and Kashmir.

When it comes to holding elections, the situation suddenly becomes bad, he said.

He said the BJP is ready for every election. "We have full confidence that with the way the Modi government has worked in Jammu and Kashmir, I believe the BJP will form government in the Union Territory (whenever the elections are held)," he added.

## In Gurez People Keep Age-Old Marriage Traditions Alive; Ferry Brides On Doli's, Zapans

**GUREZ:** While urban areas of Kashmir embracing technology and abandoning old traditions, the people of Tulail valley along the line of control (LoC) in north Kashmir's Bandipora district continue to uphold the centuries-old tradition of "Doli," where a bride is carried to her matrimonial home in a "Zapan," a carriage or cot, by close family members during marriage ceremonies.

"Yes, while such marriages are infrequent, they are still witnessed. Tulail is one such remote area where the centuries-old tradition of Guer Mahraaz and Dol-e-Khandar is occasionally observed," stated

Shahnawaz Ahmad, a senior citizen from the Gurez valley said.

"Despite having well-constructed blacktopped road connectivity in Tulail, the local villagers continue to uphold the tradition of using horses and Doli during marriages. As modern means of communication developed and the socio-economic conditions of the people improved significantly over time, the age-old customs of Dol-e-Khandar (marriage with the bride carried on a palanquin) and Guer Mahraaz (marriage with the groom carried on a horse) began to wane," he explained.

"Kashmiris have cherished the timeless traditions of wedding ceremonies for generations. The act of giving away the bride is a unique custom that not only symbolizes bidding farewell to the bride but also encourages her to embark on a new journey in life," he noted.

"In the days of yore, even Kashmiri families in cities would arrange a 'Doli' or 'Zapan' (a carriage or cot) to transport the bride to her marital home. This task was typically carried out by close family members or hired helpers known as 'Qahars' in Kashmir. They would ceremoniously convey the bride to her new family's residence," Ahmad added.

"Even in Gurez town, villagers continue to opt for Doli and horses to celebrate the weddings of their loved ones, thus ensuring the preservation of this time-honored tradition," he added.

"Recently, a marriage ceremony in Dawar town followed the same tradition, attracting several tourists who eagerly participated and enjoyed this cultural spectacle," he added.

"For the past few years, marriage ceremonies in Gurez and Tulail have been celebrated with grandeur, resembling traditional weddings, as the fear of cross-border shelling has diminished. People are now wholeheartedly participating in these marriages, especially during this season, which was previously marred by the threat of shelling," Ahmad added—(KNO)

## Unscheduled Power Cuts

The people in many parts of the Valley including in Srinagar are growing increasingly frustrated with unscheduled power cuts that have persisted for several days. Complaints have poured in from various Uptown and Downtown areas, especially in regions where smart meters have been installed. Residents who had been promised uninterrupted power supply are now grappling with multiple power cuts, causing inconveniences in their daily lives.

Residents in Downtown areas have reported major power cuts for weeks. Prolonged outages have disrupted their routines, impacting not only daily work. Hazratbal's outskirt areas have also raised concerns about unscheduled power cuts. One big impact has been on the ongoing wedding season. Frequent power outages are playing spoilsport during the ceremonies, making people rely entirely on the power generators.

Traders in Srinagar have not been immune to this issue either, as many depend on uninterrupted power supply for their businesses. The power cuts are negatively affecting productivity for local businesses.

The Kashmir Power Distribution Corporation Limited has attributed the surge in power cuts to reduced power generation in the region, linking it to lower water levels in the rivers due to decreased precipitation. The Corporation is prioritizing power supply to essential facilities like hospitals, critical installations, metered areas, and industrial estates. Unfortunately, this has led to scheduled load shedding to bridge the demand-supply gap. Metered areas are facing unscheduled power cuts of 5 to 6 hours per day, while non-metered areas endure even longer cuts, up to 9 hours.

Besides, as the temperature drops, there has been an increased demand for electricity, placing further strain on the already limited supply. Power generation within the region has dwindled to a mere 500 MW, far below the increasing demand. As is usual during this season and the winter ahead, the KPDC is working on arranging power supply from outside Kashmir. So, it is expected that the situation will improve in the next couple of days.

Jammu and Kashmir, despite its significant hydropower potential and its realization in the form of some power projects over the last two decades has always faced a severe power crisis, more so in the cold season. The power deficit in Kashmir alone ranges from 300 to 400 MW, with demand surging to 1500 MW during peak times. However, the available supply falls significantly short, creating a substantial gap between supply and demand. But it is hoped that going forward the administration will take concrete steps to address the growing shortfall. We have now a situation where people are ready to pay for the power consumption even at prevailing higher rates but the administration is failing to meet the demand.

## Capturing the monsoon

Beginning April, there were enough indications that the monsoon would be subdued with an El Niño on the horizon. This cyclical warming of the central and eastern Pacific Ocean usually corresponds to a decline in rainfall over India, particularly the north-west. Between 2019 and 2022, the Indian monsoon was significantly impacted by the converse phenomenon – a cooling La Niña – that sometimes is associated with above normal rainfall. By those metrics, the expectations of a normal monsoon in 2023 were muted. However, the experience of the monsoon this year was far from the ordinary. About 9% of the country received 'excess' rainfall with 18% getting 'deficient' and the rest of the country, 'normal' rainfall. While on one hand, August – the second-most important monsoon month – posted a third less than its normal, several States in north India, which were expecting minimal rainfall, were deluged following multiple episodes of record rainfall. July, for instance, saw exceptionally heavy rainfall in Chandigarh, Haryana and Himachal Pradesh, resulting in floods and landslides. Several cities were left grappling with serious flooding over several days. Cloudbursts were reported in Himachal Pradesh in August. It is worthwhile to note here that these episodes of intense rain were due to so-called western disturbances that are extra tropical storms from the Mediterranean region and normally not expected to play a major part in the monsoon. Thus, these are fingerprints of the wide-ranging impacts of anthropogenic warming.

At the other end of the spectrum were drought-like conditions in Maharashtra. Extreme water stress was also reported out of Chhattisgarh, Bihar and Karnataka, where in the case of Karnataka, matters came to a head with neighbouring Tamil Nadu over the sharing of water from the Cauvery river. The India Meteorological Department has also forecast a 'normal' north-east monsoon from October to December and 'normal to above-normal rainfall' over large parts of north-west India and south peninsular India. The signs are there of increased rains in several parts of south India. The spatial and temporal variance of the monsoon reiterates the need to invest in more resilient infrastructure that can be an all-weather insurance against the increasingly unpredictable vagaries of the global climate. The pattern in recent years is to improve forecast models that are better able to warn of significant changes in weather a week or two ahead than having approaches that fail to capture the dynamics of the Indian monsoon. More money and expertise should be directed towards this

## 10th year of Swachh Bharat Mission Open Defecation is History but Unscientific Waste Management Persists

PM Modi during his address to the nation from New Delhi's Rajpath on October 2nd 2014 said that clean India would be the best tribute India people could pay to the father of nation Mahatma Gandhi. October 2nd 2014 was the day when Swachh Bharat Mission (Clean India Campaign) was formally launched across India. The campaign was aimed to achieve the vision of a 'Clean India' by 2nd October 2019 which was marked as Gandhi Ji's 150th birth anniversary. A lot has been achieved indeed vis a vis countering open defecation problem but when it comes to scientific waste management, that still remains a big challenge across India. This is a burning issue in Jammu & Kashmir as well and in Kashmir valley the situation remains more demanding as Swachh Bharat Mission (SBM) enters 10th year of its launch.

The Swachh Bharat Mission-SBM also called Swachh Bharat Abhiyan-SBA is the most remarkable sanitation campaign initiated by the Government of India under leadership of PM Narendra Modi. Infact, sanitation campaigns like Total Sanitation Campaign -TSP was taken up in the past also during Congress led UPA Govt, but this scheme had low budget and didn't address open defecation in India, but SBM addressed this issue to a great extent. The waste management which is part of SBM Phase 2 still remains a challenging task for all the local bodies and PRI institutions.

Youtubers and SMB

Prime Minister Narendra Modi on completion of 9 years of Swachh Bharat Mission-SBM said that SBM became a big campaign in the last nine years and everyone contributed to it including children who brought an emotional power to it. In his video address at YouTube Fanfest India PM Modi said, celebrities gave the campaign heights and people in all corners of the country turned it into a mission and YouTubers made cleanliness more cool. He said, but we do not have to stop here. The Prime Minister said, till the time cleanliness does not become India's

identity, the nation will not stop. He said, therefore, cleanliness must be a priority for each citizen of India.

40 Million Toilets in 4 years

In 2019-2020, the Govt of India announced that all the SBM targets had been met. The figures were impressive as than 40 million toilets were built in four years, meaning access to sanitation rose from under 40% in 2014 to nearly 100% in 2020. This success was "formalised" the following year when the annual report from the Joint Monitoring Programme (JMP) run by the United Nations (UN) noted a reduction of nearly 50% in the number of people in the world practising open defecation. The better sanitation services in India has brought a great revolution and previously struggling indicators has considerably improved at global level because India being a huge country had a large population that was defecating in the open and that has come down dramatically in the last 7 to 8 years.

Non functional toilets

The UN's Joint Monitoring Programme -JMP had noted that the figures provided by the Govt were a bit less optimistic as Government agencies only measure the presence or absence of toilets while the UN establishes a "ladder of services". Thus a poorly contained or shared latrine or one with an outlet into a waterbody like stream, irrigation canal or a wetland will be categorised as "unimproved" or "limited" sanitation by the JMP. The Governments in states and UTs on the other hand counts it as a toilet even if it is not properly functioning like having being blocked or not having water connectivity or having an outlet in a waterbody. In a Govt High School at village Sani Darwan - Charar e Sharief in district Budgam this summer I noticed that 4 to 5 washrooms had been constructed more than 3 years back but they were non operational due to not being connected to a water pipeline. During the visit of Chairman District Development Council Budgam Nazir Ahmad Khan in June this

year, the female students of this school raised this issue. I was also present on the occasion and seeing this pathetic condition I quickly made a video on it. I uploaded it on social media. The Mission Director Jal Jeevan Mission J&K Dr G N Itoo was kind enough to take cognizance of the matter and within 24 hours the washrooms were functional. On papers these washrooms were shown to be operational and functional for 3 years but the situation on ground was quite different. We have many such cases wherein community toilets are non operational but they are shown to be functional.

Conclusion

The Govt of India has successfully countered open defecation across the country but managing waste is still a big challenge. This is more challenging in Jammu & Kashmir especially. Infact huge funds have been pumped to J&K by Govt of India under SBM Gramin phase 2 and SBM Urban phase 2. At an average Rs 4.50 lakhs are provided to each Gram Panchayat for constructing segregation sheds, compost pits and soakage pits. For 5000 village panchayats across J&K more than Rs 225 Crores has been allocated. In addition, crores of rupees have been spent on purchase of steel trash bins as well. Rs 23.40 lakhs are given to each panchayat halqa every year plus share from 14th FC, DDC and BDC grants. This indicates the deficiency of funds is not at all an issue especially from the last 2 to 3 years. We lack better coordination and work culture in the Rural Development Department. The SWM Consultants at district level were not hired by Govt which is mandatory as per SBM Gramin phase 2 guidelines. The civil engineers in RDD have done the work themselves which isn't showing any results on the ground. Our forests, wetlands, lakes and streams in villages are choked with trash. These things need to be addressed once for all.

# Many Attributes Of The Prophet

NEVER has so much been written by so many on the life of one human being, of any time, than on Prophet Muhammad (PBUH). Eminent people from other faiths, too, have showered him with praise.

Thomas Carlyle was not the only one to pay him tribute in his lecture on 'Hero as a Prophet', choosing him over all those mentioned in the Old Testament, from Adam through Abraham, to Moses and Jesus.

Napoleon Bonaparte in Bonaparte et Islam is quoted as saying: "Moses revealed the existence of God to his nation. Jesus to the Roman world, Muhammad [PBUH] to the old continent.... Arabia was idolatrous when, six centuries after Jesus, Muhammad [PBUH] introduced the worship of the God of Abraham, Ishmael, Moses and Jesus.

"The Aryans ... had disturbed the tranquillity of the East by agitating the question of the nature of the Father, the Son and the Holy Ghost. Muhammad [PBUH] declared that there was none but one God who had no father, no son.... I hope the time is not far when I shall be able to unite all the wise and educated men of all the countries and establish a uniform regime based on the principles of the Quran which alone are true and which alone can lead men to happiness."

And this from George Bernard Shaw: "If any religion had the chance of ruling over England, nay Europe, within the next hundred years, it could be Islam. I have always held the religion of Muhammad [PBUH] in high estimation because of its wonderful vitality.



It is the only religion which appears to me to possess that assimilating capacity to the changing phase of existence which can make itself appeal to every age. I have studied him, the wonderful man, and in my opinion far from being an anti-Christ, he must be called the Saviour of Humanity.

"I believe that if a man like him were to assume the [leadership] of the modern world he would succeed in solving

its problems in a way that would bring it the much-needed peace and happiness: I have prophesied about the faith of Muhammad [PBUH] that it would be acceptable to the Europe of tomorrow as it is beginning to be acceptable to the Europe of today."

Muslims everywhere, too, shall pay the Prophet special tribute in this month of Rabi-ul-Awwal to celebrate his birthday. Many will rejoice, as

there will be illuminations, particularly in the mosques. Religious scholars will recount anecdotes from his life, highlighting his character and achievements, and recalling his sayings on different aspects of human life before gatherings of devotees. Naat recitations and milads (sessions singing praise to the Prophet) will be held everywhere.

Scholars will dwell upon his attribute of Rahmatilil Aalemeen ('Mercy for all the worlds' —including those of the birds and beasts, of insects and worms, etc.), because a Muslim is adjoined to not hurt any living being except in the way of God. Scholars will explain what the Prophet said to his followers about how to treat women, how to interact with people of other faiths and how to carry oneself in one's everyday life.

Yet, unfortunately, many will forget the profound and inspired discourses as they leave their respective congregations. A few of those who may be swaying in ecstasy at the mention of the Holy Prophet's name would go back to indulge in sectarian hate and killing.

As Rahmatilil Aalemeen, the Prophet gave protection to Christians through a covenant signed in 628 CE, when a delegation from St Catherine's Monastery visited him seeking his protection. (The monastery, located at the foot of Mount Sinai, is the world's oldest, and a treasure house of rare manuscripts, icons and Christian history.) The covenant's words are as follows:

"This is a message from Muhammad ibn Abdullah, as a covenant to those who adopt Christianity, near and far, we are with them.

"Verily I, the servants, the helpers, and my followers defend them, because Christians are my citizens; and by Allah! I hold out against anything that displeases them.

"No compulsion is to be on them ... Neither are their judges to be removed from their jobs nor their monks from their monasteries.

"No one is to destroy a house of their religion, to damage it, or to carry anything from it to Muslims' houses.

"Should anyone take any of these [belongings], he would spoil God's covenant and disobey His Prophet. Verily, they are my allies and have my secure charter....

"No one is to force them to travel or to oblige them to fight. Muslims are to fight for them.

"If a female Christian is married to a Muslim, it is not to take place without her approval. She is not to be prevented from visiting her church to pray.

"Their churches are to be respected. They are neither to be prevented from repairing them nor [barred] the sacredness of their covenants." "No one of the nation is to disobey the covenant till the Last Day (of Judgment)."

It is important to remember that this covenant was made binding on all Muslims for all times, past, present and future, till the Day of Judgment. How this covenant has come to be violated in some Muslim countries should shame anyone who claims to love or follow the Prophet of Islam.

Starting Monday, Muslims all around the world began celebrating his birthday for one week. The celebration is known as Milad-un-Nabi in Arabic.



But why does the average American know so little about a man who was so influential and successful? The reasons are prejudice and irrational fears — dating back to the Crusades — plus Islam phobia and propaganda, which has created a mental block against Islam.

Prophet Muhammad is regarded as a great and noble man, a successor to Adam, Abraham, Moses, Noah and Christ. He was the last of the prophets. If one wants to know how Muslims see him, one ought to take a good look at his life and teachings. It would be wrong to judge him by the doings of al Qaida, Taliban or the rulers of the Arab Nations.

Who was Muhammad?

Born in Mecca in the year 570, he was a descendant of Abraham. Orphaned at 6, he was brought up by his grandfather and uncle. He received his first revelation at 40 through the angel Gabriel and continued to receive revelations for 23 years on topics ranging from the

oneness of God, life after death, stories of earlier prophets, morality and social justice. All these revelations became collectively known as the Quran.

Prophet Muhammad created a

model government based on justice and human rights. He devised a constitution in which the rights of religious minorities and the rights of women were protected. He established laws protecting trees, animals

and the environment. He encouraged free trade but protected the rights of individuals to forbid usury.

He condemned racism, saying "there is no superiority of an Arab over non-Arab, or a white man over a

black man, except in righteousness." He condemned domestic violence and granted women many rights not dreamed of in Europe until centuries later, including the right to an education, to own property, to reject arranged marriages and to seek divorce.

In the short time of less than one generation, the Prophet Muhammad successfully transformed the vast majority of people from idolatry to strict monotheism, from tribalism to brotherhood, from drunkenness to soberness, from wickedness to piety, from lawlessness to discipline.

Human history has never seen such a transformation of the faith and the cultural of the people of Arabia. And within 100 years and with no high-tech communication technology, Prophet Muhammad had touched the hearts and minds of millions in Africa, Asia and parts of Europe all the way to Russia.

Prophet Muhammad was a religious teacher, a moral guide, a social reformer, a loving father and a devoted husband.

Nineteenth century British historian Thomas Carlyle wrote, "How one man single-handedly could weld tribes and wandering Bedouins into a most powerful and civilized nation in less than two decades." And Michael Hart wrote in his 1978 book, "The 100: A Ranking of the Most Influential Persons in History" —

"My choice of Muhammad to lead the list of the world's most influential persons may surprise so many readers and be questioned by others, but he was the only man in history who was supremely successful on both the religious and secular levels."

On this auspicious occasion of the birthday of the Prophet Muhammad, one should read the biography of a remarkable person who has influenced the life of billions of people over the last 1,400 years.

# 'New 'Inverse Vaccine' Shows Potential To Treat Multiple Sclerosis, Diabetes'

A new type of "inverse vaccine" has been shown in the lab setting to completely reverse autoimmune diseases like multiple sclerosis and type 1 diabetes, all without shutting down the rest of the immune system, according to a study.

A typical vaccine teaches the human immune system to recognise a virus or bacteria as an enemy that should be attacked.

However, the new vaccine developed by researchers at the University of Chicago's Pritzker School of Molecular Engineering (PME) in the US does just the opposite: it removes the immune system's memo-

ry of one molecule.

While such immune memory erasure would be unwanted for infectious diseases, it can stop autoimmune reactions like those seen in multiple sclerosis, type 1 diabetes, or rheumatoid arthritis, in which the immune system attacks a person's healthy tissues, the researchers said.

The vaccine, described in the journal Nature Biomedical Engineering, takes advantage of how the liver naturally marks molecules from broken-down cells with "do not attack" flags to prevent autoimmune reactions to cells that die by natural processes.

The team coupled an antigen a molecule being attacked by the im-



mune system with a molecule resembling a fragment of an aged cell that the liver would recognise as friend, rather than an enemy.

The team showed how the vac-

cine could successfully stop the autoimmune reaction associated with a multiple-sclerosis-like disease.

"In the past, we showed that we

could use this approach to prevent autoimmunity," said Jeffrey Hubbell, the Eugene Bell Professor in Tissue Engineering and lead author of the new paper.

"But what is so exciting about this work is that we have shown that we can treat diseases like multiple sclerosis after there is already ongoing inflammation, which is more useful in a real-world context," Hubbell said.

Today, autoimmune diseases are generally treated with drugs that broadly shut down the immune system.

"These treatments can be very effective, but you're also blocking the immune responses necessary to fight off infections and so there are a lot of

side effects," said Hubbell.

"If we could treat patients with an inverse vaccine instead, it could be much more specific and lead to fewer side effects," he added.

Initial phase I safety trials of an antigen therapy based on this pre-clinical work have already been carried out in people with celiac disease, an autoimmune disease that is associated with eating wheat, barley and rye, and phase I safety trials are under way in multiple sclerosis, the researchers said.

Those trials are conducted by Swiss pharmaceutical company Anokion SA, which helped fund the new work and which Hubbell co-founded and is a consultant, board member, and equity holder.

## Short Bouts Of Activity Like Chores Can Reduce Heart Attack, Premature Death Risks: Lancet

Short bouts of incidental activity, the kind done as part of daily living and including household chores, has shown to reduce risk of heart attack, stroke and even premature death, new The Lancet Public Health research shows.

However, duration and intensity of the activity matters, the research team from the UK and Australia, led by the University of Sydney, said, having tracked more than 25,000 UK adults over roughly eight years.

"From walking up the stairs to speedily mopping the floors; in recent years we've come to understand that it is not just structured exercise that is good for our health, but we know very little about how these short bouts of incidental activity translate to health benefits," said the study's senior author Emmanuel Stamatakis, University of Sydney.

The adults studied were aged 42-78, all of whom self-reported no

more accessible to people who are unwilling or unable to take part in structured exercise," said Matthew Ahmadi, Postdoctoral Research Fellow at Sydney, adding that data showed that the length and intensity of these activities mattered.

Further, 'moderately' or 'vigorously' intense activity in these slots were associated with a steep decrease in major cardiac events, like heart attack or stroke, and death by any cause, they found.

Also, those who huffed and puffed for at least 10 seconds per minute, or 15 per cent of one physical activity bout or slot, saw the greatest benefit, they found.

"If you are huffing and puffing and unable to hold a conversation for some of that time (in one bout) you have hit the sweet spot," said Stamatakis.

"The take-home message here is any type of activity is good for your health, but the more effort you put into those daily tasks and the longer you



participation in exercise or sport.

The researchers used wrist-worn wearables data from the UK Biobank and machine learning and analysed their seven-day incidental physical activity patterns down to a 10-second time window.

They then compared these physical activity micropatterns with the participants' health records, by following them for close to eight years to understand the health impacts of the duration and intensity of the physical activity bouts.

The researchers found that nearly all of the entire day's physical activity, 97 per cent, was accumulated in multiple slots, each lasting less than 10 minutes, with longer slots being better.

"The idea of accruing short bouts of moderate to vigorous activity through daily living activities makes physical activity much

keep up that energy, the more benefits you are likely to reap," said Stamatakis.

In their study, the authors write, "If verified in future research, our findings could inform future public health messaging targeting the general population raising awareness of potential health benefits from short physical activity bouts in everyday life, especially for adults who do not or cannot exercise."

Eligibility:

For Anganwadi Workers

- The candidate must be domicile of the UT of J&K.
- Women candidates in the age group of 18-37 years shall be eligible.
- The candidate should be a resident of the electoral Ward where Anganwadi Centre is situated. Name in the voter list for the ward shall be considered as the proof of residence of the candidate. In case the name of the candidate appears in the voter list along with her parents, then she must provide certificate of being un-married issued by the concerned Tehsildar. Wherever, there is any dispute as to residence for any reason, then a residence proof certifying the ward of residence from the concerned SDM/ACR shall be considered.
- Minimum qualification for Anganwadi Worker shall be 10+ 2 and maximum graduation. In case no 10+2 pass candidate is available in the ward, 10+2 pass candidate from the adjoining ward shall be considered which would require prior approval of Mission Director, Mission POSHAN.
- In case suitable candidate is not available for adjoining ward, candidate from the nearest ward within the Panchayat/MC can be considered subject to the approval of the MD, Mission POSHAN.
- Weightage shall be given on the basis of marks obtained in 10+2 and selection shall be done purely on merit basis and no other criteria to be considered.
- In case of tie in merit of the eligible candidate, candidate with higher age will be preferred.
- Candidate with qualification higher than graduation shall not be considered.

A. Anganwadi Helpers

- The selection of Helper shall be restricted to the electoral ward where Anganwadi Centre is located.
  - Women candidates in the age group of 18-37 years shall be eligible.
  - The candidate must be domicile of the UT of J&K.
  - Minimum qualification for Anganwadi Helper shall be matriculation.
  - In case no matriculate candidate available in the ward, candidates with qualification not less than 8<sup>th</sup> standard shall be considered.
  - The committee shall select the (Anganwadi Helper) amongst eligible applicants, a married women on the basis of marks obtained in the class 10<sup>th</sup>. However, in rarest of rare cases where selection committee finds a widow headed household with no income source or a completely destitute lady with zero source of income, in such cases preference may be given, if other things are equal. In case no married candidate is available, unmarried candidate may be considered.
- B. In case eligible candidate is available within the family of retiring AWW/AWH, the said candidate shall qualify for additional two percent points.

## Indian Economy To Grow At 6.3% In FY24: World Bank

**NEW DELHI/ WASHINGTON:** The World Bank on Tuesday retained India's growth forecast at 6.3 per cent for current financial year on the back of robust services activities despite global headwinds.

According to a World Bank report released on Tuesday, India continues to show resilience against the backdrop of a challenging global environment.

In India, which accounts for the bulk of South Asia region, growth is expected to remain robust at 6.3 per cent in 2023-24, India Development Update of the World Bank said.

The World Bank had projected 6.3 per cent GDP growth in its April report as well. India recorded 7.2 per cent growth in 2022-23.

Last month, Asian Development Bank (ADB) marginally lowered India's growth forecast to 6.3 per cent for current financial year.

As per RBI's latest forecast, the Indian economy would grow at 6.5 per cent in 2023-24.

The Organisation for Economic Cooperation and Development (OECD) in its latest report upped the GDP growth projection for India to 6.3 per cent from the previous estimate of 6 per cent.

While global rating agency Fitch retained India's growth forecast at 6.3 per cent, S&P



Global Market Intelligence raised it to 6.6 per cent from the earlier projection of 5.9 per cent.

Sharing sectoral growth projections, the World Bank report said, the agriculture sector is expected to clock a growth of 3.5 per cent, industry 5.7 per cent and services 7.4 per cent during 2023-24. At the same time, investment growth is projected to remain robust at 8.9 per cent.

"An adverse global environment will continue to pose challenges in the short term. Tapping public spending that crowds in more private investments will create more favourable conditions for India to seize global opportunities in the future and thus achieve higher growth," said Augustine Tano Kouame, World Bank's Country Director in India.

On inflation, the report said, it is expected to decrease gradually as food prices normalise and government measures help increase the supply of key commodities.

Retail inflation is expected to remain elevated at 5.9 per cent during the year, it said.

## CAIT Files Complaint Against Flipkart, Amitabh Bachchan For 'Misleading' Ad

**NEW DELHI:** Traders' body CAIT has filed a complaint with the Ministry of Consumer Affairs against a Flipkart advertisement featuring Bollywood star Amitabh Bachchan on the upcoming Big Billion Days sale, terming the advertisement as "misleading".

The Confederation of All India Traders (CAIT) in its complaint to the Central Consumer Protection Authority (CCPA) termed the advertisement "misleading" and against the country's small retailers. It has also sought withdrawal of the advertisement, according to a statement.

CAIT demanded that a penalty be imposed on Flipkart as per relevant provisions of the Consumer Protection Act for "false or misleading advertisement" and imposition of a Rs 10 lakh fine on Bachchan.

An email sent to Flipkart did

not elicit a response. Bachchan could not be contacted for comments.

"As per the definition under Section 2(47), Flipkart, acting through Amitabh Bachchan (endorser), has misled the public regarding the price at which mobile phones are being made available by sellers/suppliers in the smartphone market of India.

"This has the effect of disparaging the goods, services or trade of another person," CAIT Secretary General Praveen Khandelwal said in the complaint.

Further, he said as per rule 4 of the Guidelines for Prevention of Misleading Advertisements and Endorsements for Misleading Advertisements, 2022, the advertisement by Flipkart "is misleading because it doesn't contain truthful and honest representation and is wholly incorrect, malicious, misleading and manipulative".

## Hyundai Motor India Says All Its Vehicles To Come With 6 Airbags

**NEW DELHI:** Hyundai Motor India on Tuesday said all its models in the country would now come with six airbags as standard.

The automaker also announced that it has decided for voluntary participation in the recently introduced Bharat NCAP with 3 models to begin with, and more models to follow.

Under the Bharat NCAP programme, car manufacturers can voluntarily offer their vehicles tested as per the Automotive Industry Standard (AIS) 197.

Based on the performance of the car in the tests, the vehicle will be awarded star ratings on a scale of 0-5, for adult occupants (AOP) and child occupants (COP).

Potential car customers can refer to these star ratings to compare the safety standards of different vehicles and accordingly make their purchase decision.



The carmaker also announced that its mid sized sedan Verna has received a five-star rating in adult and child occupant protection by Global NCAP. Hyundai Motor India MD & CEO Unsoo Kim said safety for all is the company's utmost priority.

"We have been benchmark creators in standardisation of vehicle safety features. Now, we are elated to announce the standardisation of six airbags across all models and all variants," he added.

Hyundai Motor India COO Tarun Garg said with rising road network and increase in speed limits it is natural to upgrade the cars.

## Sebi To Introduce Centralised Mechanism For Verification In Case Of Demise Of Investors

**NEW DELHI:** Capital markets regulator Sebi on Tuesday announced a centralised mechanism for reporting and verification through the KYC Registration Agency in case of the demise of an investor.

Also, the regulator has put in place operational norms, including the obligations of regulated entities and registered intermediaries that have interfaces with investors or account holders who are natural persons.

The new framework will come into effect from January 1, 2024, the Securities and Exchange Board of India (Sebi) said in a circular.

Sebi said that listed companies wishing to provide beneficial access to such a centralized mechanism to their investors holding securities in physical form can establish connectivity with KRA through their RTAs.

After receiving intimation about the demise of an investor, the concerned intermediary will have to obtain the death certificate along with

the PAN from the notifier or nominee and verify the death certificate through online or offline mode.

If the concerned intermediary, after receiving information about the demise of the investor from the notifier or nominee, is not in a position to obtain the death certificate, then it will have to inform the nominee that the KYC status of the deceased investor has been flagged off as "On Hold" and require them to furnish the death certificate of the concerned investor.

## India's Manufacturing Sector Activity Falls To 5-Month Low In Sep: PMI

**NEW DELHI:** Manufacturing activities in India fell to a five-month low in September as new orders rose at a softer pace, which tempered production growth, a monthly survey said on Tuesday.

The seasonally adjusted S&P Global India Manufacturing Purchasing Managers' Index (PMI) fell to 57.5 in September, down from 58.6 in August -- the lowest in five months.

The September PMI data pointed to an improvement in overall operating conditions for the 27th straight month. In PMI parlance, a print above 50 means expansion while a score below 50 indicates contraction.

"India's manufacturing industry showed mild signs of a slowdown in September, primarily due to a softer increase in new orders which tempered production growth.



"Nevertheless, both demand and output saw significant upticks, and firms also noted gains in new business from clients across Asia, Europe, North America and the Middle East," said Pollyanna De Lima, Economics Associate Director at S&P Global Market Intelligence.

On the inflation front, supply-chain conditions were broadly stable, which helped drag down the rate of input price inflation to its weakest in over three years, the survey said. However, greater labour costs, upbeat business confidence and buoyant demand facilitated a sharp increase in output charges.

## Scientists Agostini, Krausz And L'Huillier Win 2023 Nobel Prize In Physics

Stockholm: Scientists Pierre Agostini, Ferenc Krausz and Anne L'Huillier won the 2023 Nobel Prize in Physics for "experimental methods that generate attosecond pulses of light for the study of electron dynamics in matter", the award-giving body said on Tuesday.

The prize, which was raised this year to 11 million Swedish crowns (about \$1 million), is awarded by the Royal Swedish Academy of Sciences.

"The laureates' experiments have produced pulses of light so short that they are measured in attoseconds, thus demonstrating that these pulses can be used to

provide images of processes inside atoms and molecules," the award-giving body said in a statement.

Physics is the second Nobel to be awarded this week after Hungarian scientist Katalin Kariko and U.S. colleague Drew Weissman won the medicine prize for making mRNA molecule discoveries that paved the way for COVID-19 vaccines.

Created in the will of dynamite inventor and businessman Alfred Nobel, the prizes for achievements in science, literature and peace have been awarded since 1901 with a few interruptions, becoming the arguably highest honour for scientists everywhere.

While the award for peace can hog the limelight, the physics

prize has likewise often taken centre stage with winners such as Albert Einstein and awards for science that has fundamentally changed how we see the world.

Last year, Alain Aspect, John Clauser and Anton Zeilinger won the prize for work on quantum entanglement, where two particles are linked regardless of the space between them, something that unsettled Einstein himself who once referred to it as "spooky action at a distance".

Announced on consecutive weekdays in early October, the physics prize announcement will be followed by ones for chemistry, literature, peace and economics, the latter a later addition to the original line-up.

## Delhi Police Seals NewsClick Office, Arrests Founder

New Delhi: The Delhi Police on Tuesday arrested NewsClick founder Prabir Purkayastha and HR head Amit Chakravarty after searching more than 30 locations and questioning several journalists in a case filed under the anti-terror law UAPA following allegations the portal received money for pro-China propaganda.

Police sealed NewsClick's office in Delhi, officials said, adding 46 suspects were questioned and digital devices, including laptops and mobile phones, and documents were taken away for examination.

They said 37 male suspects were questioned at the office of

Delhi Police Special Cell, while nine female suspects were quizzed at their respective places of stay.

Two accused — portal founder and editor-in-chief Prabir Purkayastha and Human Resources head Amit Chakravarty — have been arrested, Delhi Police spokesperson Suman Nalwa said.

The searches began early in the morning and were concentrated in Delhi-NCR. Earlier in the day, portal founder and editor-in-chief Purkayastha was taken to the Special Cell's office for questioning.

Among those questioned were journalists Urmilsh, Aunindyo Chakravarty, Abhisar Sharma, Paranjay Guha

Thakurta as well as historian Sohail Hashmi, satirist Sanjay Rajoura and D Raghunandan of the Centre for Technology & Development.

After being questioned for over six hours, they were allowed to go.

"After a day long interrogation by Delhi special cell, I am back home. Each and every question posed will be answered. Nothing to fear. And I will keep questioning people in power and particularly those who are afraid of simple questions. Not backing down at any cost," Abhisar Sharma posted on X.

Addressing a gathering in Bhubaneswar, Union Information and Broadcasting Minister Anurag Thakur said

probe agencies in the country are independent and work in accordance with law.

"... If someone has done something wrong, probe agencies work on it... Nowhere it is written that if you have got money in an illegal manner or done something objectionable, then probe agencies cannot investigate that," Thakur said.

Police sources said investigators posed a list of 25 questions on various issues, including their foreign travels, protests against the Citizenship (Amendment) Act in Shaheen Bagh as well as the farmers' agitation.

Those being questioned have been divided into three categories, A, B and C, sources said, but did not divulge details on this.

it is not his department's job or mandate to stop people doing so. "Our job is to ensure that farmers get help improving the quality of crops and the yield. We are doing that job diligently," he said and added that there are other departments which are authorised to allow or disallow paddy land conversion into other land uses.

The shrinkage of paddy land has been a continuous worry for the stakeholders in Kashmir. In a letter to the government in March 2016, the then director of agriculture, Kashmir, had reported that "due to the hazardous land conversion, the agricultural land has considerably shrunk as per door to door surveys conducted by the field workers of this [agriculture] Department."

Researchers at Sher-e-Kashmir University of Agriculture and Technology (SKUAST) also corroborate that paddy land is shrinking in Kashmir and opine that it is because of the technological advances in recent years that the drastic decline in land availability appears not that threatening.

"Paddy land is indeed shrinking across Kashmir, mostly because of conversion of paddy land into orchards. But, the technology has made it possible to get far greater produce from agricultural land than we used to get earlier. Essentially, we now get a good rice production using least resources," said Farhat Shaheen, an agricultural economist at SKUAST.

For example, he said that earlier it would take 10 hectares to get 10 metric tonnes of rice, but now technology and the extension programmes have made it possible to get as much rice over just one hectare of land. "Our breeders at SKUAST have developed SR4, a very high yielding variety of rice which has brought a revolution in rice production in the Kashmir valley thanks to popularization of this variety by our university and the agriculture department," Shaheen told Kashmir Observer.

He said that these days, Kashmir is witnessing vertical growth in rice cultivation because of utilization of resource-efficient technology and our research and development institutions. "Having said that, it is a sad reality that we are losing agricultural land to built-up areas. I hope this trend stops very soon so that we are able to make good use of our land," he said and added that it is not only about rice cultivation, "we can even grow vegetables on a far greater scale than we do currently if land resources are utilized properly."

Because of the ongoing rice harvesting season, farmers can also be found discussing issues including declining paddy land. Abdul Rashid, a farmer in north Kashmir's Nutanusa village has heard on radio that the central government has imposed a ban on rice exports from India. This, he says, was done because the government thought there had to be enough supplies of rice available to the people across the country before exporting it to other countries.

Rashid is not off the mark. The ban was exactly imposed by the central government to ensure enough stocks of rice are available within the country for keeping prices under control. Also, in December last year, the central government announced that it will provide free food grains to about 81.35 crore (813 million) beneficiaries under the National Food Security Act (NFSA) for one year starting from January 1, 2023 for which more than two lakh crore rupees will be spent as food subsidy.

On July 20, the union Ministry of Consumer Affairs, Food & Public Distribution said that it had imposed a ban on export of non-basmati white rice "in order to ensure adequate availability of Non-Basmati White Rice in the Indian market and to avert the rise in prices in the domestic market, Government of India has amended the Export Policy of [non-basmati white rice] from 'Free with export duty of 20%' to 'Prohibited' with immediate effect."

An intelligent and knowledgeable farmer, 56-year-old Rashid says that the rice export ban has an important message for farmers. "Farmers

do not only hold the key for food security, but can also determine, with their hard work in farms, how markets behave," Rashid told Kashmir Observer as he and other farmers sat for the tea-break while harvesting rice. Rice harvesting is currently going on across Kashmir with entrancing scenes of farmers reaping the rewards of their months-long hard work.

"But, it is so tragic that we are wasting our land by going for a construction spree rather than seeking to improve upon our agricultural production," Rashid said. "We have to understand that agriculture is our backbone both in terms of food and livelihoods as it provides some sort of livelihood to the majority of households in our valley," Rashid went on to say. Ghulam Hassan, another farmer in the group who was curious to chip in while Rashid was making his point, said rather sarcastically: "For us Kashmiris, it hardly matters whether our local rice production survives or not, we should have large houses and large roads even at the cost of agricultural land."

Hassan said that he has witnessed people selling off their small parcels of agricultural land and using that money for setting up grocery shops and Tata sumos (passenger cars are mostly referred to as Tata sumos in local parlance). "I also witness many of those people now staying idle as we can't have too many passenger cars and grocery shops in small villages with all of them making money," he said.

According to another farmer, Ghulam Rasool, it is not only the fault of common people, successive governments are also responsible for not doing enough for protecting the agricultural land. "If you go to any village or town, you can see people constructing houses or other structures wherever they wish. On paper, there has been a ban on constructing agricultural land, but the fact remains that the ban has not helped protecting the land," Rasool said.

Rashid interrupted him and observed that whatever has happened so far has done a lot of damage, but now it needs to be stopped. According to him, the government should seriously think of making a housing policy for each and every village in Kashmir. "As long as a proper policy is not in place, people are not going to stop constructing agricultural land. Most of them do it with the plausible argument that their families are expanding which compels them to use their precious farmland for housing. But, my question is how long?"

Farmers in other parts of Kashmir narrate similar tales of built-up areas steadily stretching while more and more agricultural land is rapidly coming under housing. "Twenty years back, there were large swathes of agricultural land separating our town from Srinagar, but now, the two towns have joined with buildings and houses built on the agricultural land in these years," said a farmer who lives near Ganderbal town.

Kashmir Observer spoke with farmers in villages near Srinagar city and most of them talked about how farmlands are shrinking giving way to built-up areas. They said that they often hear lorries carrying land-filling material buzzing around their villages. "It has been happening for years and has entirely changed our surroundings, which are now in total contrast to when we were young," said Abdul Samad, an elderly villager.

In global agricultural development discourse, "small is good" is a common refrain and small farmers anywhere in the world are considered very crucial for the global food supply chain. According to the World Economic Forum, the 600 million smallholder farmers around the world working on less than two hectares of land, are estimated to produce 28-31% of total crop production and 30-34% of food supply on 24% of gross agricultural area.

"Our over-reliance on smallholder farmers to feed our growing population cannot be overstated... the truth is that no-one has food security until everyone has food security, and the secret to achieving the levels of

supply and storage required to feed the planet lies in policymaking and interventions on the ground that empower, rather than entangle, smallholder farmers worldwide," says a policy paper of World Economic Forum. Small and smart farmers like Rashid understand it, but need the institutional support for helping all the regions of the world to attain food security.

compressor, weighted air lines, and submerged diffuser assembly that makes up the conventional system. On the lake's bottom, these diffusers are resting in one or more sites. This will certainly enhance water quality and prevent red algal from reoccurring," he added.

Manzoor Ahmad, a Dal dweller, blamed the Lakes Conservation Management Authority (LCMA) for the mess, alleging that the agency never took the problems with delicate nature seriously, thus endangering the beautiful water body.

"First of all, we need to figure out who is poisoning Dal Lake—Dal residents or hotel owners along Boulevard Road. The same is seen from coasts where red algal has surfaced, and those who reside in Dal Lake cannot be its killers, he added.

Ajaz Rasool, however, said that red algal blooms occur in the summer and slow down in the winter when the daytime temperature falls below normal.

"Red algal resurfaced first in 1990 and then in the year 2018 again after the diffused aeration system was removed. See the more you go with dweeding, the more it affects the lake bed. Apart from maintaining cleanliness, I think aeration is the only weapon to combat algae bloom in Dal Lake," he added.

Chairman of the Nigeen Lake Conservation Organization (NICO), Manzoor Ahmad Wangnoo said that Pollution in Dal Lake is the outcome of human activity. He also claimed that problems like red algal blooms will persist as long as Dal Lake is contaminated.

"Dal Lake must be cleaned from one end to another for the water to flow smoothly and to significantly lessen the risks of red algae in the future," Wangnoo said.

"I believe that only people are to be blamed for the problem being instrumental in continuously poisoning the water body. You can see that human interference has caused springs and rivulets to dry up," he added.

Vice-Chairman Lakes Conservation Management Authority (LCMA), Bashir Ahmad Bhat said the Red algal bloom is a natural process that would cease on its own in the next four to five days.

"Red algal bloom occurs in dead pockets, so it's not a serious issue and won't have any impact on Dal Lake at all," Bhat said, adding, the department has taken a slew of measures to deal with the issue of less concern.

He said the department has installed aerators at several locations in the lake and that the same will help contain reoccurrences of red algal in Dal Lake.

"Red algal is quite a natural process, it surfaces mainly in the summer season when day temperatures go high and lessen with the onset of winter. It's not an issue of major concern," he added.

**NEW DELHI:** England hope to ride their formidable batting firepower to a second successive World Cup title but if India's crafty spinners and sprightly pace attack can fully exploit home conditions the country's cricket-mad fans could have something to celebrate.

Since failing to make it out of the pool phase at the 2015 Cricket World Cup, England have been transformed into limited-overs juggernauts, winning the 2019 title and last year's Twenty20 World Cup.

They have been blessed with a steady supply of exciting match-winners, which has encouraged them to try to re-define test cricket with their relentless, aggressive approach to the game.

Illustrating the embarrassment of riches at their disposal, England axed world-class opener Jason Roy from their World Cup squad to accommodate Harry Brook, who at 24 has already been marked out as a superstar in the making.

Eight members of their triumphant 2019 squad are back to help England try to become only the third team to defend the ODI World Cup title after West Indies and Australia.

## Saudi Team Refuses To Play In Iran Over Statue Dispute

**C**ristiano Ronaldo scored his first goal in the Asian Champions League in Al-Nassr's 3-1 win over Istiklol on Monday to shift attention back to soccer after an earlier match between Sepahan of Iran and Saudi Arabia's Al-Ittihad was controversially canceled.

The Saudi club did not take to the field at Naghsh-e-Jahan Stadium in Isfahan because of busts of Gen. Qassem Soleimani — who commanded Iran's elite Quds Force before he was killed in a U.S. drone strike in neighboring Iraq in January 2020 — and other political banners, Saudi Arabia's Al Ekhbariya TV reported.

Soleimani was seen as playing a key role in arming, training and leading armed groups across the region, including fighters from the Houthi rebel group in Yemen. Saudi Arabia has been at war with the Iran-aligned rebels in Yemen since 2015.

Three busts of Soleimani were placed on the sideline at the Ira-



nian stadium. After around a 30-minute delay, the Saudi league champions, whose stars include N'Golo Kante and Fabinho, left the stadium where an estimated 60,000 fans were waiting.

The Asian Football Confederation said in a statement that the Group C match was canceled "due to unanticipated and unforeseen circumstances," without elaborating. The match has been initially classified as postponed.

Another Saudi club, Al-Hilal, which is a four-time winner of

the Asian continental title, was scheduled to play Nassaji Mazandaran in Tehran on Tuesday.

Al-Nassr took control against Tajikistan's Istiklol in the second half at Riyadh. Ronaldo, who joined the club in December, equalized with a delicate chip midway through the second half. Senin Sebai had put Istiklol ahead just before the break.

Ronaldo scored for the seventh successive game, and then two goals in quick succession from Brazilian forward Anderson Talisca gave Al-Nassr the win.

## João Félix & Barcelona Face FC Porto In Champions League

**BARCELONA:** It has taken João Félix several years and a couple of false starts, but the creative forward who left Portugal to aim for greater heights in Spain has finally found a team where he can flourish.

Or so it seems after a handful of games with Barcelona, the team he joined in August just hours before the transfer window closed after a frustrating stint at Atletico Madrid.

Félix is now heading back to Portugal when Barcelona faces FC Porto in its second game of the Champions League group stage on Wednesday. Félix played for Porto as a youngster before eventually joining fierce rival Benfica at age 15, where he broke out as a teenager and was signed by Atletico in 2019.

But after he repeatedly chafed under Diego Simeone's defend-first, attack-second playing style, Félix eventually fell out with Atletico's coach and spent the sec-



ond half of last season on a disappointing loan stint at Chelsea.

On returning to Atletico in the offseason, Félix did what he could to force a move to Barcelona by publicly stating that he wanted to play for Xavi Hernández's side. He then accepted a pay cut to help fit within Barcelona's wage limits, which were already strained.

The move has so far paid off for both player and team.

The 23-year-old Félix has scored three goals and meshed

well with his teammates since he joined Barcelona. Two of those goals came against Antwerp in Barcelona's 5-0 rout in their Champions League opener last month.

The game at Estádio do Dragão is billed to be the toughest game of the group phase for Barcelona. Both clubs have three points atop Group H. Antwerp and Shakhtar Donetsk have zero before they meet in Belgium also on Wednesday.
