Srinagar: Faced with acute power shortage resulting in frequent and long power cuts, the Jammu and Kashmir administration has started to purchase electricity from Uttar Pradesh to tide over the crisis.

Principal Secretary of Power Development Department (PDD) H Rajesh Prasad told Kashmir Observer on Wednesday that the power crisis in Kashmir is almost over as the department has purchased electricity from Uttar Pradesh government to meet the electricity demand.

"Around 250 MW electricity has been purchased from the UP government on banking bases. We have also taken-up the matter with the central government and the winter allocation quota has been granted," Prasad said.

Srinagar: A student was shot and injured on Wednesday by suspected terrorists in South Kashmir's Anantnag district.

16-year-old Sahil Bashir Dar was shot at and injured by unknown terrorists in his native village of Watrigam on Wednesday evening, reports said. A class 10th student, Dar sustained injuries in the surprise terror attack.

He was immediately rushed to a nearby health facility for treatment. However, the doctors there referred him to district hospital Anantnag for advanced treatment.

8 Dead In Sikkim Floods, 69 Missing

Gangtok: At least eight people died and 69 others, including 22 army personnel, went missing on Wednesday after a cloudburst over Lhonak Lake in north Sikkim triggered a flash flood in the Teesta River basin, officials said. Three of the dead were

washed up in north Bengal, they said. The flood in Sikkim that started around 1.30 am was made worse by the release of water from Chungthang dam, the officials said.

2 Terrorists Killed In Kulgam: Police

Srinagar: Two local terrorists of Hizbul Mujahideen (HM) were killed in an encounter with security forces in South Kashmir's Kulgam district, police said on Wednesday.

Acting on a specific input regarding the presence of terrorists, a joint cordon and search operation was launched by Police, Army's 1 Rashtriya Rifles and Central Reserve Police Force (CRPF) in the Kujjar area of Kulgam, a police spokesperson said.

During the search operation, he said, as the joint search party approached towards the suspected spot, the hiding terrorists fired indiscriminately upon them, which was retaliated effectively leading to an encounter.

Man Chargesheeted For Selling State Land

Srinagar: The Crime Branch of police on Wednesday filed chargesheet against a man for allegedly selling state land to a woman in North Kashmir's Baramulla district.

The charge sheet was produced by the Special Crime Wing before the Court of Sub Judge Pattan on September 30 against Mohammad Ashraf Wani of Utikoo village of Baramulla for his involvement in commission of offences punishable under section 420,511 RPC, an official spokesperson said.

Traditional Walnut Harvesting Methods Cost Climbers Dear In Kashmir

Srinagar: Walnut, the organic super food from Kashmir, is in global demand with prices peaking during the harvesting season but the trade is taking toll on the poor climbers who risk their lives as they use traditional methods and ignore advisories on their safety.

At least five climbers in Kashmir have lost their lives and scores injured during walnut harvesting in Kashmir this season and the count is growing with reports from different areas reflecting on deaths due to use of traditional methods.

One among the cases reported this season was of 35-year-old Ali

Commercial Tree Planting Not Biodiverse Enough, Environmentalists Advocate For Conserving Intact Ecosystems

nvironmentalists argue that commercial planting of trees to offset carbon emissions might come with costs for biodiversity and other ecosystem functions.

Instead, they advocate for conserving and restoring intact ecosystems in their study published in the journal Cell Press.

"Current and new policy should not promote ecosystem degradation via tree plantations with a narrow view on carbon capture," write the authors, led by Jesus Aguirre-Gutierrez, Environmental Change Institute at the University of Oxford, UK.

Tropical ecosystems, including forests, grasslands, and savannahs, are attractive sites for tree plantations because their climate and physical features promote rapid tree growth, meaning rapid carbon capture, their study said.

While some tree plantations involve reforestation of degraded land, in many cases forests are planted in undegraded and previously unforested regions such as grasslands, which is "afforestation", they said.

Tree planting for carbon capture is often assumed to benefit biodiversity and enhance socioeconomic benefits.

For the private companies, carbon is easy to measure and monetise, compared to parameters such as biodiversity and ecosystem services, and thus, they invest in carbon-capture through plantations, the authors write.

They further argue that such plantations are limited in their ability to capture carbon, as opposed to their ambitious commitments.

"An area equivalent to the total summed area of USA, UK, China, and Russia would have to be forested to sequester one year of emissions," they said in their study.

Instead, we should prioritise conserving intact ecosystems, they say. Tropical grasslands and savan-

nahs are already carbon sinks.

When intact, tropical grasslands and savannahs store large quantities of carbon below ground. In contrast to the commercial plantations, which predominantly store carbon above ground, these below-ground carbon sinks, which get lost when afforested, are less susceptible to disturbances such as drought and fire, the authors write.

Thus, they say that overemphasising the benefits of tree planting for carbon capture "can disincentive the protection of intact ecosystems and can lead to negative trade-offs between carbon, biodiversity, and ecosystem function."

Government Rescues 14 Child Beggars in Surprise Raid at Lal Chowk

Srinagar: Acting swiftly after receiving repeated complaints about child begging in the capital city of Srinagar, Child Welfare Committee (CWC) of the district Wednesday swung into action and conducted a "surprise raid" in the city centre Lal Chowk where 14 child beggars were rescued and taken for counselling.

This was for the first time that a 'special surprise drive' against child begging was launched by the CWC at Lal Chowk. "We had been receiving complaints about frequent child begging in various parts of Srinagar. Today, we decided to conduct a surprise check at Lal Chowk where we caught hold of 14 child beggars including four girls," CWC head for Srinagar, Dr Khair-un-Nisa told news agency.

She said while they were taking the child beggars to a shelter Pillow System' To 'Revolutionise' home at Nishat 'their parents

started begging for the release of their kids. "This is what makes our job tough. There is a nexus between parents and kids. Ironically, the parents of the kids rescued today were also beggars," Dr Nisa said, adding that "we will counsel all the 14 kids (all of them minors) and handover them to the CWCs of their respective districts/States."

Asked about any tentative number of outside beggars in Srinagar, she said there is no accurate data available as the same may be lying with the Labour department. "Majority of these beggars are from Punjab, Bihar and Uttar Pradesh," she said. "In three months, we have rescued 32 child beggars including today's 18.'

Dr Nisa said that the special drive will continue in the days ahead as complaints of large numbers of street children including those indulging in begging outside major shrines and markets of Srinagar.

"So far, the previous cases

have been transferred to CWCs of other places outside J&K for their rehabilitation as almost all among them were non-J&K residents. All of them were migrants and were shifted to their native places," she said.

She said an eight-year-old domestic helper was also rescued from Srinagar after a neighbour called the CWC. "Our primary job is to counsel and rehabilitate the rescued persons and hand them over to their respective CWCs," Dr Nisa said. She said that all the residents of Srinagar who have minor domestic helpers at their should voluntarily approach the CWC. To a query about how she feels to lead the drive against children in street situations being a woman, Dr Nisa said that she has done LLB and being a lawaware person, she forgets about gender and focuses on her duty while on the streets.

IAS Officer, Others Face Prosecution For Fraud

rinagar - Kashmiri officialdom was never very particular about how contemptibly low it stoops to plunder public funds, but it must have required an unusual degree of neanness to cheat backward Gujjars and Bakarwaals of their paltry government compensation for losses suffered due to hailstorms and heavy rain . In this 7-year-old case, the then deputy commissioner Pulwama -incidentally, a sennior IAS officer - S. D. Lone; another deputy commissioner, Muhammed Akram Hajam: the then assistant commission¬er, revenue, and presently director, land records, Srinagar, Muhammed Afzal Bhat and the then tehsildar Pulwama, Habibullah Mir, along with nearly half-a-dozen petty of-ficials of the district DCs office have been challaned by the vigilance organisation for misappropriating Rs 15 lakh which the state had santioned as relief to the nomads for livestock losses during natural calamities s in the hilly areas of Shopy¬an and Pulwama. The entire amount had been placed at the disposal of the then DC, who had been charged with the responsibility of disbursing it to the deserving members of the community after proper verification.

Vigilance investigations revealed that the officers named m the case, in collusion with four private persons (who have asked been charge sheeted had manipulated records to show that Rs 14,80,940 had been distributed among 652 members of the Gujjjan and bakarwaal community.

Sixty-two persons among the supposed beneficiaries selected at random by the VO, denied having received any relief, and the finger impressions on acquaintance rolls did not tally with the fingerprints. Expert established that thumb impressions supposed to be the marks of 181 different recipients were in fact the thumbprints of only a few people repeated over and over on the rolls. The VO also found that recipients who were shown belonging to the Udhampur and Rajoun districts were only fictitious names and that Rs 3.75.090 were deposited with Reshi Gas Agency lather than going to a sufferer.

Having prima-facie established the officers' involve-ment in the fraud; the VO has pressed charges against them under relevant laws before the special anti -corruption court in Srinagar.

Shrinking Paddy Land

he past decade has witnessed a worrisome trend in the Valley's farm sector: While the rice yield per hectare of paddy land is increasing, the paddy land itself is diminishing at an alarming rate, as revealed by a report published in this paper. According to official figures, over the past seven years, Kashmir has lost a staggering 6,000 hectares of paddy land, reducing the total land under paddy cultivation from 1,35,000 hectares to 1,29,000 hectares. Although there has been a significant increase in rice yield, this trend of diminishing paddy land demands immediate attention.

What has led to this state of affairs? Many people rightly blame the conversion of farmland into real estate and the increasing urbanization. However, the senior officials from the department of agriculture have also blamed the shifting cropping patterns and economic considerations as factors contributing to this decline. Some farmers find it more profitable to cultivate vegetables or convert paddy land into orchards. While this diversification is understandable, it exacerbates the shrinking of paddy land.

Successive governments have often been criticized for failing to enforce bans on construction on agricultural land effectively. The need for a comprehensive housing policy for every village in Kashmir is therefore emphasized as a potential solution to this pressing issue. The government must take proactive measures, including the formulation of robust housing policies, to address the issue and safeguard the region's agricultural heritage.

Domestic crop production already falls far short of the food requirement in the Valley and we have to import heavily to meet the shortfall. However, there is still a degree of self-sufficiency in our countryside. And if the crop production in the countryside too goes down as the facts cited in our story reveal, it will further complicate the situation. But, this is an area which doesn't command the attention of the government. Both in urban and rural Kashmir, the agriculture land is being relentlessly converted into housing colonies. This is despite the fact that the government has imposed due restrictions on doing so. This makes it imperative for the government to step in and frame policies that not only encourage agricultural production but also stop massive conversion of land into real estate.

The shrinking of paddy land in Kashmir is a concerning issue that threatens both food security and the livelihoods of its people. While technological advancements have boosted rice yields, it's essential to prioritize the preservation of agricultural land for a sustainable future. And the government needs to play a role required of it.

Making Disability-Friendly Provisions, Disabled-Friendly

while back, the government issued an order related to the specially-abled persons to get their document of disability re-verified. The purpose of this order was to expose the corrupt elements. Basically, there was a large proportion of people who had registered themselves as persons with disabilities when in reality they were physically fit and healthy.

On one hand, it was a good initiative to expose those masquerading as persons with disabilities. On the other hand, it was the beginning of a hectic process for those suffering from the slings and arrows of damaged body parts. They were made to wander from pillar to post to get their documents verified like Unique Disability Identity card (UDID), which a person could get only at certain places; a document to be verified at the concerned Bank authorities; an affidavit from a first class magistrate; and an e-ticket from food and civil supplies department and the list is endless. Another major problem faced by them was that they could not send anyone to help them out; they had to do it themselves. The burden of the biometric lay on their head much like everything else. They had to visit each department multiple times to get their documents verified. The time-gap between the appointments (visits) was in itself frustrating. For example, to get a UDID card, specially-abled persons had to first visit the concerned department to get the appointment. Almost a week or two later, they were again supposed to visit it to get their biometric done. The third time, they had to visit the local computer operator

to get it downloaded or printed out. Similarly, they were to get an e-ticket from the food and civil supplies department. They had to submit the documents on the first visit and almost ten to fifteen days later, the e-ticket was issued in their favour.

The sufferings of specially abled people did not end here. Not only did they have to wait for about half a month to get the documents verified but they also had to navigate their way through the buildings of these institutions or departments which were not disability-friendly. This, despite recent legislations like Rights of Persons with Disabilities Act, 2016 and recent campaigns like the Accessible India Campaign. With no disability-friendly infrastructure in place, persons with disabilities had to struggle to get to different floors of government offices and had to rely on the help of people to physically lift them to various chambers for documentation. After completing the formalities of re-verification documentation, their ordeal was far from over. They had to again rely on other people waiting in line to get them downstairs as well. They were left to the good-will of onlookers who may or may not have helped them. The whole ordeal accentuated their sufferings instead of making anything more accessible and easy for them. The entire process of making the world more democratic and accessible fell flat as they were reminded of their disability again and made to suffer because of it despite the fact that it was the infrastructure's disability in the first place and not theirs. The government needs to ensure that no one is left behind. It is not only the fault of those various institutions, but the state

too is responsible. Changing the name of disability to speciallyabled is not enough. Delivering speeches on disability day won't improve their condition. No doubt the state took this step to bring transparency and allow the real beneficiaries to avail benefit. But the manner of its implementation was not disabled-friendly.

It is the collective responsibility of society to not let them feel that they have any disability. The state must restructure the pattern of their buildings, shifting the main office to the ground floor or making special arrangements so that the specially-abled person will not suffer to get their work done. The state may also provide an increment in their pension. The criteria to avail various documents must be made simple and easy. Their work must be given a top priority to avoid frequent visits. A separate department apart from the social welfare department must be there that would have a link with all the concerned institutions or departments, so that specially-abled people need not visit various departments to get their work completed. No doubt there are numerous NGOs who tirelessly work for improving the standard of specially-abled persons. Still, there are deficiencies and loopholes about their policies - and it requires immediate attention.

Nobel Prize For Medicine Acknowledges Possibilities Of mRNA Vaccines For A Range Of Diseases, From Cancer To Malaria And AIDS

Wery October, Katalin Kariko's mother would faithfully listen to the radio, hoping to catch the news that her daughter had finally won a Nobel Prize. "Many scientists work very very hard," Kariko recalled pointing out to her, in an interview published by the University of Pennsylvania this week. And forget a Nobel, Kariko had never even got a grant for her dogged pursuit to unlock the potential of mRNA to help cure diseases, with her research being described as "unworkable". That she has, along with her fellow pursuer of the seemingly impossible, Drew Weissman, won the Nobel Prize for Medicine this year, comes as a vindication of their conviction that mRNA research holds the key to unlocking the future of medicine.

Kariko and Weissman sought to use mRNA — the messenger which carries instructions from DNA to our cells on manufacturing specific proteins — as an agent that could help the body develop its own cures. This went against the prevailing orthodoxy which had long dismissed the possibility of introducing mRNA into the body without it being attacked by the body's immune system. This had been seen in numerous trials on animals, in whom synthetic mRNA led to severe inflammation. Kariko and Weissman's discovery was that the mRNA could be modified in a specific way, so that the immune system wouldn't attack it. But this elicited little interest and the 2005 paper documenting the breakthrough was largely ignored. It drew attention only in 2020, when its potential to develop effective vaccines quickly to arrest Covid-19's devastating sweep through the world, began to be explored.

The vaccines developed using Kariko and Weissman's discovery saved millions of lives. Beyond that, their work has also opened a wide vista of possibilities for tackling a range of other diseases, from cancer — with mRNA being possibly tailored to target individual patients' tumours — to malaria, HIV and Zika. The Nobel Prize is an acknowledgement of this promise.

Nobel Prize in Physics Unveiling the Secrets of Electrons

The 2023 Nobel prize in physics has been awarded to a trio of scientists for pioneering tools used to study the world of electrons.

Electrons are sub-atomic particles that play a role in many phenomena we see every day, from electricity to magnetism. This year's three Nobel physics laureates demonstrated a way to create extremely short pulses of light in order to investigate processes that involve electrons.

Pierre Agostini from The Ohio State University in the US, Ferenc Krausz from the Max Planck Institute of Quantum Optics in Germany and Anne L'Huillier from Lund University in Sweden will share the prize sum of 11 million Swedish kronor (£822,910).

Changes in electrons typically occur in a few tenths of an "attosecond", which is a billionth of a billionth of a second. In order to study such brief events, special technology was needed.

The laureates developed experimental methods that produced pulses of light so short that they are measured in attoseconds. These could then be used to study the fleeting dynamics of electrons in physical matter – something that wasn't previously possible.

The attosecond pulses, the shortest flashes of light ever produced, sparked a revolution in photonics – the science of light waves. They were used to take snapshots of electrons in different physical systems, such as in atoms, chiral molecules – molecules that are mirror images of one another – and very tiny nanoparticles among others.

The laureates have all contributed to enabling the investigation of such processes.



For the first time, these quick pulses allowed scientists to match up the time scale of their observations to the natural, very fast time scales at which electron dynamics occurred.

This achievement required significant innovations in laser science and engineering - innovations that this year's Nobel laureates worked on for decades.

L'Huillier discovered a new effect that arose as the result of interactions between laser light and atoms in a gas. This interaction could be used to produce pulses of ultraviolet light that were each a few hundred attoseconds long. Agostini and Krausz took this discovery

Agostini and Krausz took this discovery even further. In 2001, Agostini was able to produce short light pulses and measure their width. The series of bursts produced using something called the RABBIT technique lasted just 250 attoseconds.

At around the same time, Krausz developed a different experimental approach, using it to successfully isolate a light pulse that lasted 650 attoseconds.

The two approaches developed by Agostini and Krausz form the basis for much attosecond research carried out today.

Exciting applications

There are some exciting potential applications for these attosecond pulses.

They could be used to study previously unknown physical phenomena in different types of material.

A spin-off area known as ultra-fast switching could also one day lead to the development of very fast-working electronics.

Attosecond pulse science could also find uses in medical diagnostics. By exposing a blood sample to a very fast pulse of light, scientists can detect tiny changes in the molecules in that sample. This could lead to a new way of diagnosing disorders, including cancer.

Our team at King's has been working to combine the resolution on physical processes that attosecond pulses enable with novel advances in quantum information processing. This would create pulses of quantum light at the attosecond time scale that could have applications in quantum computing.

have applications in quantum computing. The award of the Nobel prize in this field inspires us to redouble our efforts to break novel ground. We wish our colleagues continued success, and we are eager to see what they will surprise us with next.

SC Says Will Examine Immunity To Lawmakers From Prosecution If Criminality Attached To Their Acts

New Delhi: The Supreme Court said on Wednesday it will examine whether the immunity granted to lawmakers from prosecution for taking bribe to make a speech or vote in Parliament and state legislatures extends to them even if criminality is attached to their actions, as it began reconsideration of its 1998 judgement in the JMM bribery scandal that rocked the country 25 years ago.

The apex court's 1998 verdict granted MPs and MLAs immunity from prosecution for taking bribes to make a speech or vote in legislature.

At the outset of the daylong proceedings, Solicitor General Tushar Mehta urged the seven-judge constitution bench headed by Chief Justice D Y Chandrachud that the court need not go into the immunity aspect under Article 105 of the Constitution and the controversy, possibly, can be narrowed down in view of the fact that the offence of bribery is complete when a bribe is given and accepted by the lawmaker, something which can be tackled under the Prevention of Corruption Act.

Article 105(2) stipulates that no member of Parliament shall be liable to any proceedings in court in respect of anything said or any vote cast in Parliament or any committee thereof. A similar provision exists for MLAs under Article 194(2).

The bench, referring to the 1998 judgement, said it was held that irrespective of the criminality, immunity is available to the lawmakers

"We will have to ultimately deal with the issue of immunity as well. Since we are sitting in the combination of seven (judges), we are not required to see the immunity in all circumstances. We have to decide a very narrow issue whether that immunity is attached (to

lawmakers) when there is an element of criminality," said the bench, which also comprised justices A S Bopanna, M M Sundresh, P S Narasimha, J B Pardiwala, Sanjay Kumar and Manoj Misra.

The bench, however, took note of the submissions of the solicitor general that it should not venture into the larger conspectus of immunity available to the lawmakers.

lawyer Raju Senior Ramchandran also urged the court to not interfere with the carefully considered and well reasoned 1998 judgement which was not unconscious of constitutional morality and that "there is no ground to upset the view taken".

"Political corruption is the fact of life and misuse of law is equally a fact of life... and this court has come to help the citizens and lawmakers who have suffered unjust persecution," Ramchandran told the court, adding lawmakers were given immunity from prosecution to protect them from unjust harassment. "Should we grant immunity

to political corruption just on the ground of apprehension of misuse of the law?" Chief Justice Chandrachud quipped. Since this apprehension of

misuse has been at the root of grant of parliamentary privilege from historical times, the court is only being asked to continue what has stood the test of time. Ramachandran said.

"We should not be entering into issues which do not arise before us. The law has evolved in our country... Because the whole purpose was to encourage free speech and free dialogue in Parliament and in state legislatures and that we must preserve. The legislatures in both the Union and the states are an important part of the na-

tion," the CJI said. The court referred to Article 105(2) and Article 194(2) of the Constitution relating to immunity to lawmakers.

"Suppose a legislator has taken a bribe for casting a vote in a particular manner or making a speech...the court cannot invalidate the vote because it was motivated by a bribe. Suppose a person is convicted for an offence of bribery, can the court say the vote should be excluded from counting parliamentary majority. It's still a valid vote," the bench said. The bench, however, said immunity cannot be at-

tached when there is "criminal wrongdoing". "So once an MP either casts his vote and speaks in the House, he will not be answerable to any court or in any proceedings for the vote which he has cast and the speech made," it said, adding one cannot dispute a legislation on grounds that the votes cast in its favour was vitiated by criminal wrongdoing.

"But that immunity, which attaches to vote, does not attach to crime that takes place independent of casting of vote or rendering of speech," the bench observed.

Senior advocate P S Patwalia, assisting the bench as an amicus curiae (friend of court), said the object of Article 105 was not to protect lawmakers against ordinary criminal law but to protect "the integrity of House" and its legislative proceedings.

The bench asked whether immunity against prosecution will be available if bribe is paid to lawmakers to not speak or vote.

"The offence (of bribery) is complete if the bribe is accepted... Even under normal law, if you take a bribe for doing a legal act, you are guilty. Even if you take a bribe and don't do the act, you are guilty. Only offer and acceptance have to be proved. That is the law," Patwalia said.

advocate Gopal Senior Sankaranarayanan, appearing for an intervenor, supported the revisiting of the 1998 judgement and will commence his submissions on Thursday.

Nearly 25 years after the JMM bribery scandal rocked the country, the apex court had on September 20 agreed to reconsider its judgment, saying it was an important issue having a significant bearing on "morality of polity".

A five-judge bench of the apex court had decided to refer the issue to a larger seven-judge bench.

five-judge constitu-А tion bench had in its majority verdict delivered in the PV Narasimha Rao versus CBI case held that parliamentarians have

immunity against criminal prosecution for any speech made and vote cast inside the House under Article 105(2) and Article 194(2) of the Constitution.

The issue came under the Supreme Court's lens again in 2019, when a bench headed by then chief justice Ranjan Gogoi was hearing an appeal filed by Sita Soren, JMM MLA from Jama and daughter-in-law of party chief Shibu Soren, who was an accused in the JMM briberv scandal. The Justice Gogoi-led bench had referred to a fivejudge bench the crucial question, noting it had "wide ramification" and was of "substantial public importance".

Sita Soren was accused of taking bribe to vote for a particular candidate in the Rajya Sabha election in 2012. She had contended that the constitutional provision granting lawmakers immunity from prosecution, which saw her father-in-law being let off the hook in the IMM bribery scandal, be applied to her.

She had moved the apex court against the Jharkhand High Court order of February 17, 2014 refusing to quash the criminal case lodged against her.

The three-judge bench had then said it will revisit the SC verdict in the sensational IMM bribery case involving Shibu Soren, a former Jharkhand chief minister and ex-union minister, and four other party MPs who had allegedly accepted bribes to vote against the no-confidence motion threatening the survival of the P V Narasimha Rao government in 1993.

The Narasimha Rao government, which was in a minority, survived the no-confidence vote with their support.

The CBI registered a case against Soren and four other JMM Lok Sabha MPs but the Supreme Court quashed it citing immunity from prosecution they enjoyed under Article 105(2) of the Constitution.

New Delhi: Scientists are exploring whether the strong earthquake that struck Nepal and the surrounding region on Tuesday is responsible for the south Lhonak lake outburst, which triggered a flash flood in the Teesta river basin in Sikkim. The lake outburst also re-

sulted in the breach of the Chungthang dam, which is the largest hydropower project in the state. This dam is part of the 1,200-megawatt (MW) Teesta Stage III Hydro Electric Project, in which the state government is the majority stakeholder.

Satellite images released by the Hyderabad-based National Remote Sensing Centre showed that the area of south Lhonak lake reduced by over 100 hectares compared to its size on September 17. This suggests that the lake outburst caused a flash flood in the Teesta River basin in north Sikkim.

Officials said at least eight people died and 69 more, including 22 army personnel, were missing. Scientists are exploring

whether the earthquake that hit Nepal might be a cause of the flash floods in Sikkim. The lake was already vulnerable and covered an area of 168 hectares. Its area has now reduced to 60 hectares, indicating that about 100 hectares of water volume has breached the level, explained a senior official at the Central Water Commission (CWC) to PTI. The official stated that while

it's difficult to determine right now, a cloud burst does not cause such results. Some experts who have visited the site believe that the earthquake may have triggered the floods there.

The flood alerts were also shared with Bangladesh. The NRSC satellite imagery

Pertinent to mention that the Valley is experiencing dry weather and above normal temperatures for eight weeks and has adversely affected horticulture and agriculture sector production, particularly apple.

The ongoing dry weather has also led to a fall in the water level of Jhelum and other water bodies. The water volume in the water bodies of the valley has dropped around 75% than normal, according to reports.

A Junior Engineer from the KPDCL told Kashmir Observer that the Jammu and Kashmir has the potential to generate around 20,000 megawatts of hydel power but generates only around 1200 megawatts.

"But in winters the UT is able to generate only 300 MW of electricity against the demand of over 1800 MW's," he said.

The officials blame rainfall deficit and the melting of glaciers as the reason for less generation of electricity.

"Since there was less rainfall and the glaciers melt very fast in summers only, we are unable to generate the power" he added.

Another KPDCL official informed Kashmir Observer that they require water from the Jhelum and its tributaries for electricity generation. However, the water levels in these sources are currently low, hampering their ability to produce electricity.

"In such circumstances, we are compelled to resort to power cuts. During the daytime, we wait for water to accumulate and then activate the turbine during peak hours," the official said, requesting anonymity, citing a lack of authorization to speak to the media.

Furthermore, the official explained that during the summer months, when water flow is ample, they can generate a significant amount of electricity without needing to employ this process.

Pertinently, the Horticulture Department Kashmir and J&K Disaster Management Department every year issues advisories with do's and don'ts to avoid casualties during the walnut harvesting season.

An official of the Horticulture department told Kashmir Observer that most of the climbers fail to use safety gear during the harvesting.

"People need to avoid traditional methods of walnut harvesting and use the latest methods of collecting the walnuts that the department shares from time to time," he said.

As per the advisory issued by the Horticulture Department, the general public shall adopt SOPs and guidelines while harvesting the walnuts and only trained and experienced persons should be involved in harvesting/thrashing of walnuts with safety gears.

"The climber must wear a helmet and tie a safety harness rope while harvesting and use of tall ladders to climb the trees and wearing of nonslippery shoes should be avoided. Also they should use safety nets or thick stacks of hay, around the tree, to prevent injury in case of accidental fall. The harvester must ensure that power transmission lines passing through walnut trees are shut at the time of harvesting/thrashing walnuts," reads the advisory.

Medical Superintendent Bone and Ioint Hospital Dr Mian Suhail told Kashmir Observer that most individuals who fall from the walnut trees suffer from Polytrauma. Polytrauma which means that a patient sustained multiple injuries, some of which may cause significant disability and may be life-threatening.

"They typically sustain injuries to their head, brain, spine, chest, abdomen, and limbs, resulting in longterm paralysis," he said.

Mother-Daughter Chargesheeted For Cheating Man Of Rs 12L

JAMMU: Economic Offences Wing Crime Branch Jammu chargesheeted mother-daughter duo for duping a man of Rs 12 lakh for sending her daughter to Canada for higher education.

In a statement, a spokesperson said that Balwant Kour and Simran Mann of Chandigarh had duped the man of Rs 12 lakh after they promised him to send his daughter to Canada for higher education but later cheated him.

The statement reads that the chargesheet was produced in the court of law for judicial determination.

"The case was registered on a written complaint lodged by Raj Kumar Nischal of Jammu wherein it was alleged that his daughter Aditi Nischal while doing private job as graphic designer in 2016 she came in contact with accused Simran Mann who was also serving there as IELTS teacher assured to her to Canada for higher studies by charging Rs 12 lakh," it reads.

It reads that on the request of his daughter, the complainant transferred the amount to the account of accused. "When his daughter approached the accused Simran Mann for necessary documentation she dodged her on one pretext or other and finally cheated them."

It added that on receipt of the complaint, a preliminary verification was initiated and the allegations were prima-facie established and subsequently, the instant case was registered for in-depth investigation.

"Relevant record was seized, statement of witnesses recorded, scientific, circumstantial and other material evidence was gathered and offences of cheating against the accused for luring the complainant and cheating them were established."
