Centre Launches 12th City Gas Distribution (CGD) Bidding Round For J&K, N-E

Srinagar: Over two years after Finance Minister Nirmala Sitharaman announced the first gas pipeline project for the Union Territory of Jammu and Kashmir, the central government has offered a bidding round for retailing compressed natural gas (CNG) and piping the fuel to household kitchens and industries in the UT.

According to reports, the government has offered bidding rounds in eight geographical areas (GAs) under the 12th city gas distribution (CGD). These areas include Arunachal Pradesh, Meghalaya, Manipur, Nagaland, Sikkim, the Union Territory (UT) of Jammu & Kashmir and Ladakh.

The electronic bids would be invited from October 13 and the last date for submission of bids is January 11, 2024.

The Petroleum and Natural Gas Regulatory Board (PNGRB) will award the distribution of CNG to the companies by 2024.

Notably, Sitharaman in her budget speech in February 2021 has announced the maiden gas pipeline project for J&K.

A government official from the divisional commissioner administration told Kashmir Observer that the 725 km-long, upcoming Bhatinda–Jammu–Srinagar project will be operated by GSPL India Gasnet with a maximum diameter of 24 inches, and will start in Punjab and to the valley. Union Minister Earlier, Hardeep Singh Puri has said since the ground situation in Jammu

and Kashmir has changed after the abrogation of Article 370, the technical survey on the 175-km Gurdaspur-Jammu gas pipeline has been completed.

He said that the pipeline's establishment will bolster the energy security of the area by streamlining the transfer of natural gas from Gurdaspur, located in Punjab, to Jammu.

"This development presents a dependable and more environmentally friendly energy solution to satisfy the increasing energy needs of these regions," he said. The minister conveyed that

Contributes In Ground Breaking Research On World's First Flu-Resistant Chicken Developed By Scientists

Srinagar: In a major scientific milestone, researchers have developed the world's first fluresistant chicken by altering their genes.

The ground-breaking research published in the prestigious Nature Communications journal has the potential to greatly benefit the poultry sector across the world by reducing the risk of avian influenza outbreaks in farms, which can save poultry farmers from significant losses.

Interestingly, one of the scientists who co-authored this important study hails from Kashmir-- Dr Salik Nazki, presently working as an Immunologist at Professor Sarah Gilbert's laboratory in the University of Oxford.

Speaking exclusively to Kashmir Observer, Dr Salik said



the first-of-the kind research shows how to create chickens that are resistant to avian influenza, a disease that can se-

verely impact poultry farming. Titled, "Creating resistance to avian influenza infection through genome editing of the ANP32 gene family," the study published on October 10, 2023, is a collaborative effort between the Roslin Institute of

The University of Edinburgh, The Imperial College London, and The Pirbright Institute. "We used a powerful genetic tool called CRISPR/Cas9 to edit the genes of chickens. Imagine it like making precise changes in the genetic code of chicken. The key to this resistance is a protein in chickens called

ANP32A, which the flu virus needs to multiply and spread. We modified the ANP32A protein in the chickens by changing two of its building blocks (amino acids), preventing the flu virus from using it effectively," he detailed out. When the researchers ex-

posed these gene-edited chickens to the flu virus, nine out of ten of them did not get infected, which is a very promising result. This is because the virus couldn't interact with the modified ANP32A » More On P6

Volcanic Eruptions Behind Lethal Climate Change Millions Of Years Ago: Study

assive volcanic eruptions and subsequent environmental crises caused changes in climate over the past 260 million years, leading to mass extinction of life during these periods, according to a study.

The research, published in the journal Earth-Science Reviews, shows that these eruptions released large amounts of carbon dioxide into the Earth's atmosphere, causing extreme greenhouse climate warming and bringing about said Rampino.

However, the researchers caution that their findings have no bearing on 20th- and 21stcentury climate change, which scientists have shown to be driven by human activity.

The studied pulses of volcanic eruptions last occurred about 16 million years ago.

The latest analysis supports the well-established impact of carbon dioxide emissions on climate warming.

The scientists focused on continental flood-basalt (CFB) eruptions, the largest volcanic eruptions of lava on Earth, with flows covering nearly a halfThese included ocean anoxic events, periods when the Earth's oceans were depleted of oxygen, thereby creating toxic water as well as hyper-thermal climate pulses, or rapid rises in global temperatures, and resulting periods of mass extinctions of marine and non-marine life.

They found that CFB eruptions frequently coincided with these other lethal geological phenomena, illuminating the larger impact of volcanic activity.

The connection with astronomy is evidenced by the commonality of the multimillion-year regular cycles of volcanism and extreme cli-



near-lethal or lethal conditions to our planet.

These events which occur every 26 to 33 million years coincided with critical changes in the planet's orbit in the solar system, the researchers said.

"The Earth's geologic processes, long considered to be strictly determined by events within the planet's interior, may in fact be controlled by astronomical cycles in the solar system and the Milky Way gal-



The Earth's geologic processes, long considered to be strictly determined by events within the planet's interior, may in fact be controlled by astronomical cycles in the solar system and the Milky Way galaxy mate with known cycles of the Earth's orbit in our solar system and in the Milky Way galaxy, the researchers said.

They found that the agreement between the geological and astrophysical cycles is much too close to be merely a chance occurrence.

A major remaining question, they add, is determining how the planet's astronomical movements perturb the Earth's internal geological engines.

Delaying Dealing with EARTHQUAKE Vulnerabilities in Kashmir Risks Millions of Lives

The recent earthquake disaster in our neighbourhood region

ver 1,000 people lost their lives in the twin quake sequence of magnitude 6.3 that struck the war-torn nation of Afghanistan on October 7, 2023, and the death toll is expected to rise. Such a small-intensity quake will generally cause no harm to a country prepared to handle earthquake hazards, signifying that ordinary risks turn into disasters because of unpreparedness, which is linked to the overall political, administrative, and economic stability of a nation. Similar devastation was witnessed on June 21st, when a magnitude 5.9 earthquake struck the border region of Afghanistan, highlighting the dire consequences of unpreparedness made worse by the many decades of the protracted political conflict. That is why a relatively small magnitude earthquake at a shallow depth of 10 km posed a significant threat to a nation grappling with political turmoil and economic crisis, to name a few. These tragic events serve as reminders of the importance of disaster preparedness, not only for Afghanistan but also for regions like Kashmir, which share similar seismic and geopolitical risks.

Afghanistan's tumultuous political history has left it ill-equipped to handle medium to large earthquakes and other hazards, which means any ordinary earthquake risk will have the potential to turn monstrous. In contrast, nations like New Zealand and Japan, with robust disaster mitigation measures, would likely experience minimal damage and casualties from a similar earthquake. It is imperative to acknowledge that the devastation in Afghanistan is, in many ways, a human-made disaster born out of neglect and lack of planning linked to geopolitical and economic stability, which demands international attention to save lives in the future quakes, expected in the region.

I and many other earthquake scientists have repeatedly warned that the earthquake threat is looming over South and Southeast Asia, including Afghanistan, Pakistan, India, Bangladesh, Nepal, and Indonesia, due to the tectonic interaction between the Indian and Eurasian plates. Tectonic plates, unlike zones of earthquakes, which includes the area of Jammu, Kashmir and Ladakh.

Kashmir's history is marked by numerous devastating earthquakes, leaving their imprints in the sediment and rocks of the valley. Earthquake hazards are intrinsic to the region's geological and tectonic architecture, which, over the past centuries, have caused cure, but when our buildings are prone and vulnerable to earthquake risks, we do not run to the earthquake-building experts to save our buildings, lives and assets; oddly though.

The recent earthquake disaster in our neighbourhood region of Afghanistan and also in Morocco should alert us of our area, which is tectonically much more dangerous than those



damaging earthquakes. The threat of the next earthquake of significant intensity to strike Kashmir is real. It is based on the evidence preserved in sediments, rocks etc., which links the earthquake hazards to the continuous push of the Indian plate under the Eurasian, which is building strain in rocks only to get released in a major earthquake(s). The timing of when that will happen is not known because earthquakes remain unpredictable for obvious scientific reasons. Anyone who tries to offer earthquake two countries. The responsibility is on us and the administrative authorities to impose strict seismic safety building regulations codes to avoid forecasted earthquake hazards transforming into major disasters. The existing buildings and other structures must be checked for seismic vulnerability to improve the overall safety of structures to withstand earthquake shaking, liquefaction, and other related primary and secondary consequences of quakes. There is no time to waste; waiting means less

political boundaries, cross over the nations, and South and SE Asian regions are connected by tectonic plate boundaries, which are the regions that cause damaging earthquakes. It means that tectonic boundaries can cause an earthquake in one nation, and the damage can spread to other neighbouring countries because of the linkage and proximity of earthquakecausing faults. India's northward journey over the past 50 million years culminated in its collision with the Eurasian plate, giving rise to the breathtaking mountain ranges, valleys, and rivers that define the region's landscape and predictions makes up false stories; there is no science to such tales. Do not listen to such people who are relying on pseudoscience.

The simple earthquake safety procedure is to build earthquake-resistant buildings, which can save lives. I know it is not a culture to do that in Kashmir, and I have no answer why people have chosen to ignore our repeated earthquake hazard warnings, which can come true anytime. We wish that never comes true, but the reality remains it has all the reasons to revisit Kashmir and other parts of the region. When we are ill, we rush to the doctor for a preparation time to avoid forecasted disasters.

Why It's Time For India To Attempt Mediation In Israel

The Vantage Take

India has launched another mission to help Indians get home. It's called Operation Ajay. The first flight with 230 passengers from Israel landed in New Delhi this morning. We expect many more such flights in the days ahead because there are thousands of Indians in Israel, about 18,000.

Many moved here for work or higher education. There are plenty of Indians working in Israel's healthcare sector as well. India and Israel are friendly countries, the people-to-people ties are strong, but right now, New Delhi believes that Indians need to come back home because the war is escalating.

The consul general of Israel, Kobbi Shoshani, sent out this message yesterday: "There are around 18,000 Indian citizens in Israel ... once we win this war against Hamas, ISIS terrorists, Jai Hind".

This is not the first such mission to bring Indians home. Earlier this year, the government had launched Operation Kaveri to bring Indian citizens home from the Sudan. That conflict is still on. Last year, India airlifted its students from Ukraine after the war broke out.

And now, they're at work in Israel. India's ministry of external affairs has been working on a war footing. New Delhi says its priority is the safety of Indian citizens.

But let's also discuss what next? What happens after Indians are brought back? Will that be the end of New Delhi's role in this crisis? Will India try to negotiate or mediate like other regional and international powers? We ask because India is once again uniquely placed. It has leverage on both sides – Israel and the Arab world. Historically too, India had a good equation with Palestinians.

So, what is New Delhi's position on this crisis? Here's what the government says. Arindam Bagchi, spokesperson, Indian ministry of external affairs, says: "Our policy has been longstanding and consistent. India always advocated the resumption of direct negotiations towards establishing a sovereign, independent and viable state of Palestine, living within secure and recognised borders, side by side at Our policy has been longstanding and consistent. I think that position remains the same"

peace with Israel. I think that position remains the same".

He says that India's position remains the same and that India has always wanted peace in the region, but will India make an effort to build that peace? Will India leverage its ties? Will it offer to mediate? If it does, it will be a departure from the past because India has never been a power broker in West Asia. That has traditionally been American turf, although it's been changing of late. China stepped in a few months ago to mediate between Iran and Saudi Arabia, and this is in West Asia, far away from China's traditional sphere of influence, yet Beijing waded in.

Time for a policy shift?

So West Asia and its power politics is changing. What about India? India refrains from unilaterally entering conflicts. India participates through multilateral platforms. India sends troops to conflict zones as part of the UN peace keeping mission. But all of that is part of India's traditional approach.

In recent years, we've seen some shifts. Six years ago, India dehyphenated Israel and Palestine. A week ago, the Indian prime minister called Hamas terrorists. In the last one year India has called out western hypocrisy at the highest levels – refused to take sides in the Ukraine war, pulled off a wildly successful G20 summit, showed its diplomatic heft by forging consensus, demanded its rightful place at the U.N high table. India is ready to join the big league, but is India also looking at taking up big challenges? And right now, none seems bigger than this one in West Asia. So, will New Delhi step up? Or will it work behind the scenes?

"In the world of diplomacy, we are always engaged in conversation and contacts. Of course we maintain close contacts with all relevant stakeholders at various levels," said Arindam Bagchi yesterday. This was in response to a question about India reaching out to the UAE. He said India is engaging with all stakeholders. At this point, it's hard to say what's shape and scope of this engagement. We'll be tracking this space for you.

In South Iran, Harisa is still a celebrated mutton recipe today. It's a culinary masterpiece where bruised wheat is meticulously boiled to the perfect consistency, and then en-riched with meat, butter, cinnamon, and fragrant herbs. The artisans behind this dish are known as "Harisa-Paz" or "Harisa-Gar" in Persianspeaking regions.

Earlier this year, I read an Amaliah Muslim Twitter roundup where a sister tweeted: "Women don't get their fair share of ibadah...". The comment haunted me the entire month. as I went on to read sisters lamenting about menstruating and "missing the first days of Ramadan". Days later, I heard female scholars answering questions on Instagram like: "Do I get less reward for not fasting due to menstruation?", "Do women earn rewards for Qur'an recitation while menstruating?", "Is getting your period during Hajj or Umrah a punishment from Allah?"

I was heartbroken at the sentiment made evident by these questions and inquiries – some Muslim women seriously see their periods as an obstacle in their path to Allah.

Perhaps a concoction of cultural biases, menstrual difficulties, and legal rulings of ritual purity stir conflict in the hearts of Muslim women about how to receive their monthly bleed. However, honoring the womb is written in the timeless revelation of the Our'an and demonstrated in the Walking Qur'an, Prophet Muhammad ³⁸, as he regularly and lovingly interacted with menstruating women. He 🛎 even narrates an intimate conversation between Allah and the womb as narrated by Abu Hurayra:

"Allah created the creations, and when He finished from His creations, the womb said, '(O Allah) at this place I seek refuge with You from all those who sever me.' Allah said, 'Yes, won't you be pleased that I will keep good relations with the one who will keep good relations with you, and I will sever the relation with the one who will sever the relations with you.' It (i.e. the womb) said, 'Yes, O my Lord.' Allah said, 'Then that is for you'." [Sahih al-Bukhari 5987]

This hadith affirms what Allah, the Exalted, reminds us in the Qur'an:

"O mankind, fear your Lord, who created you from one soul and created from it its mate and dispersed from both of them many men and women. And fear Allah, through wombs you, an Observer." [Surah al-Nisa 4:1]

The lofty mention of the womb might sound ethereal and incomprehensible, but the Prophetic biography manifests honouring the womb through keeping family ties, recognising the sanctity of motherhood, and positively interacting with menstruating women. How then can we revive the sunnah of period positivity in societies where menstruation is neither acknowledged nor celebrated?

When I entered Islam at 19 years old, I was unabashedly period-positive. I felt liberated after discovering that vegetarianism relieved my painful and heavy periods. I sat in monthly circles with women of colour where we spoke of our wombs as significant and sacred. We openly discussed the use of menstrual cups. reusable cloth pads, and organic period products. As I encountered the Muslim community, I assumed that my sisters in faith would also share my reverence for the womb and concern for the planet, but I rarely heard menstruation mentioned in a positive way, nor a discussion of period products and their environmental impact. Instead, I learned about all the acts of worship that menstruation prevented.

I limited my period-positive views to my circle of friends and associates for many years until 2020, when my in-person womb steaming practice pivoted to an online educational platform called Honored Womb. Speaking openly on Instagram about periods garnered the attention of sisters from around the world who were seeking holistic ways to have healthy, pain-free periods, no longer wanting to resent their time of the month. Many of them knew who to contact for their fiqh questions, but had little space to discuss or learn about menstrual health in their families and communities. Instead, there were recurring stories of being expected to conceal their period from male family members, being shamed for wanting to slow down while menstruating, and being told that having a

To combat these misconceptions and misunderstandings about menstruation and Islam, I hosted an online event in July 2023 to bring together Muslimah scholars and wellness practitioners to bridge the gap I saw between the world of womb wellness and women of faith.

According to popular culture, one might assume that honouring your womb means dancing nude under moonlight, painting with menstrual blood, or calling yourself a goddess. But as Muslim women, we have our own unique ways to express reverence for our wombs while honoring the Giver of Wombs, al-Rahman. Much like the Ansari women of Medina, we can celebrate first periods. knowing that to be a bleeding woman is a blessing, not a curse.

In conversation with Shaykha Shaista Maqbool about Menstruation in the Seerah, she shared the tender story of Umayyah bint Qays (Allah be pleased with her), a girl who became a woman while riding on the she-camel of Prophet Muhammad *a* en route to the battle of Khaybar. Though she tried hiding traces of her menstrual blood that soiled the luggage she sat behind, our beloved Prophet # noticed both the stain and her discomfort. He lovingly acknowledged Umayyah's circumstances, instructed her in how to cleanse herself, and later gifted her with a necklace from the battle that he placed on her neck with his own blessed hands. This gift was so dear to her, she never removed it and asked to be buried with it [1].

When our mother Aisha (Allah be pleased with her) was saddened by the fact that she was menstruating during Hajj, our Prophet # comforted her by saying, "This is a matter Allah has decreed for all the daughters of Adam." [Sahih al-Bukhari 5559] She was then encouraged to continue fulfilling the other rites of Haii with the exception of tawaf (circumambulating the Ka'bah).

Islam recognises that menstruation is the biological and spiritual reality of bringing forth life. How then can it be concluded that the

When I asked artist and chaplain Mona Haydar about menstruation, she replied:

"The word haydh in Arabic is really beautiful. It comes from the idea of a current or a flow, a flowing water. And in English, it's so interesting because it's a period. It's the end of something. Whereas in Arabic, it's something that's moving with life. Menstruation is not an enemy, it's not an ending, it's not a period.

It's an ineffable sacred blessing and responsibility, and so when we look at it in that way through the lens of the Qur'an, through the Arabic language instead of through Western civilization and culture, we come to understand actually that our haydh (menstruation) and our nifas (postpartum period) are opportunities to connect to Allah (SWT)." [2]

In conversation with Ustadha Iffet Rafeeq, she further emphasized how our spiritual work is directly impacted by our relationship to our wombs. She reflects:

"I have seen how many women's spiritual journeys are hindered because of their unhealthy womb, irregular periods, fertility issues, hormonal problems, and all of the mental health issues that come with hormonal health issues. When we work on hormonal health, when we restore balance back into our wombs, I've seen how women can then travel so much faster in their journey to Allah and in their spiritual journey because the body is back in reset. Even if there are oth-

issues connected to the womb seem to have a massive impact on spiritual journey and spiritual improvement. [3]

When our hormonal health is chaotic...we have poor sleep, we have mental health issues, we have gut issues, we have adrenal fatigue, women can get thyroid issues, we can have so many diet problems. When the endocrine system is out of whack, so much chaos is happening inside the body. So when we decide to attend a spiritual gathering or take on an Islamic studies course, we can't seem to tap into the strength to do the work because

of the chaos happening inside of us. Biologically speaking, what Ustadha Iffet mentions speaks to the far-reaching effects that our menstrual cycles have on an array of body systems - including our mood, mental focus, digestion, metabolism, immunity, hair and skin quality, libido, communication, organisation, self-analysis, etc. Varied levels of hormones literally shift our physiology, such that our desire for acts of worship like fasting, night vigil prayers, marital intimacy, community service, or Qur'an memorization can literally be facilitated in certain menstrual phases and challenged when hormones are imbalanced. If we have grown attached to static ways of worship that revolve around a fixed daily routine, we might feel disappointed when our female design demands that we orient to Allah in other ways.

When Shaykha Dr. Tamara Gray encourages women to call their time of menstruation "dhikr week", it reflects the type of reframing that allows us to shift from what we can't do to what we can do. She encourages students to have beautiful baskets and sacred spaces of worship prepared for this special time with uplifting books, litanies of remembrance and supplication, and translated copies of the Our'an or Tafseer texts, so we can deepen and widen the breadth of our worship, enriching both its quality and feminine tenderness.

Aside from intentionally seeking

tend to our wombs in the following ways to encourage a more easeful and peaceful period:

- Prioritise warmth while menstruating to support improved circulation. Slow and sluggish blood, also known as blood stagnation, is more likely to turn dark, form clots, and result in uterine cramps. Drinking and eating warm beverages and foods, while sipping on warming teas like ginger, saffron, and turmeric can help move blood throughout the body.
- Intend rest as an act of worship. When our wombs are menstruating, we are literally carrying a heavier load, as they are engorged with blood and thickened lining. Laying down can slow down heavy bleeding and long periods by relieving pressure on our uterine arteries. Naps, gentle walks and stretching, and longer nights of rest help us emerge rejuvenated and refreshed for the month ahead.

Be particular about your period 0 care. Opting for non-toxic period products is an act of selfcare for your vulva and womb. Choose organic, chemical-free pads, reusable cotton pads, or period panties to receive your bleed. Some of my clients report that simply swapping to more natural period care products alone helped relieve their infections, irritation, heavy bleeding, and pain.

The idea of Allah speaking to the womb is a conversation and connection that we may not fully comprehend. But our wombs are continually talking to us through our monthly periods and associated symptoms. If we can start to approach our period care as being in conversation with our womb, perhaps we will be written amongst those who kept good relations with the womb and find Allah keeping good relations with us in return.

the gas pipeline stretched approximately 14,000 kilometers in length. "We've now set our sights on a 33,500-kilometer target, and we've already accomplished 23,000 kilometers of it," he stated.

that it has noted that if the petitioner (Bhat) had taken recourse to the legal remedy to challenge the order of detention even before it was executed, it is not open for him to contend that it should be quashed because there is no live link between the existing/subsequent situation and the previous situation.

"We are of the opinion that this is not a case where the learned Writ Court (Single Bench) could have passed the interim order suspending the detention order dated 27.04.2023," the court said and allowed the appeal filed by the government.

The main grievance of the government was that the Single Judge ought not have stayed the operation of detention order at the first instance on the day of motion and that it will be against the well settled principle that in the matter of preventive detention, the Court ought be very careful in passing any interim order of suspending the detention order at the pre-execution stage.

Pertinently, Bhat had approached the Court, challenging the detention order No. Div. Com dated 27.04.2023 passed by the Divisional Commissioner, Kashmir, on the grounds, inter-alia that the detention order was illegal and that he was falsely implicated in FIR No. 04/2022 u/s 8/22 of NDPS Act of P.S. Chanapora, in which, he was granted bail by the competent court on 11.11.2022.

Dr Salik explained, however, when the scientists working on the study tried a higher dose of the flu virus, some of the chickens did get infected. "But what was interesting is that the virus had changed its own genes to adapt to the modified ANP32A in the chickens. It's like the virus learned to get around our genetic modification."

To make chickens truly resistant to the flu, the researchers realized that they might need to make more genetic changes. "In some experiments, we removed the entire ANP32A gene from chicken embryos. But then the virus found a way to use other similar proteins. ANP32B and ANP32E, to grow in the chickens," he added.

His role in the research study focused on testing and confirming the resistance of these birds to avian influenza, which could be a significant advancement in preventing outbreaks in poultry farms in future.

Asked if the gene-edited poultry is safe to consumed, Dr Salik maintained that consumption of gene-edited poultry would be classified as a genetically modified food and therefore undergoes stringent regulatory scrutiny before gaining approval for human consumption.

The scientist said the next steps in creating flu-resistant chickens involve making further genetic improvements, evaluating the long-term health of such chicken, obtaining regulatory approvals for their use, addressing ethical and social concerns, maintaining farm biosecurity, making the technology costeffective and accessible, and gaining public acceptance.

"Challenges in this process include the need to enhance the resistance to the flu in chickens, monitor their long-term health, navigate regulatory procedures, address public concerns, maintain biosecurity on farms, make the technology affordable, and ensure public acceptance of gene-edited animals," Dr Salik said.

Recent Snowfall Spurts Queries By Tourists In Kashmir

SRINAGAR: The recent snowfall in the upper reaches of Kashmir has led to the spurt in booking inquiries by the tourists.

Kashmir earlier this week recorded snowfall in the higher reaches while the MeT department has also predicted further snowfall in the mountainous regions.

Tourists from different states of India have started inquiring about tour packages for Kashmir, which during the autumn presents a blend of red and white hues.

"Winter is one of the peak seasons for tourism in Kashmir. We are already recording a good increase in the number of bookings due to the Puja holidays, the recent snowfall in the upper reaches has further enhanced it," Umar Ahmad, a travel agent said.

He said as such inquiries for the Gondola cable car are very common, especially after the fresh snowfall in upper reaches. "Tourists love to witness snow in Kashmir. The second

phase of Gondola cable car also recorded a brief snowfall and tourists often inquired whether they could witness snowfall at the station," he said.

Travel agents also said that this year inquiries are also

coming in numbers for the winter season.

"The airfare has skyrocketed for the last few weeks. Tourists who are planning to visit the valley during winter book their tours in advance. At present they get good deals while hotels also don't have full occupancy," said Aijaz Ahmad dar, a tour operator.

Some of the most popular winter activities in Kashmir include skiing, snowboarding, snowshoeing, and ice skating. Visitors can also go on sleigh rides, visit frozen lakes, and explore the region's many historical and cultural attractions.

Pertinently, the year so far has been lucrative for the tourism players as record-breaking tourists visited the valley in the last nine months.

Till August, as many as 1.6 Cr tourists including 31,000 foreign guests have visited Kashmir. Last year, a total of 26.73 lakh tourists visited Kashmir.

The government this year is planning a series of events during the autumn and winter seasons to ensure full adventure tours to the visitors.

While the rush of foreigners is expected to increase further during autumn, the government has started planning for winter adventures to enthrall the visitors during their stay in Kashmir-(KNO)

3,000 Dengue Cases In **J&K So Far This Year**

SRINAGAR: The Union Territory of Jammu & Kashmir has witnessed an alarming increase in dengue cases this year, with approximately 3,000 cases reported so far.

State Surveillance Officer, Dr Harjeet said that there were three deaths due to the mos-

quito-borne disease. Dr Rai advised the public to take "preemptive" measures in the absence of a dengue vaccine and called for proactive prevention to combat this painful ailment. He, however, assured that the authorities are implementing effective measures to control the spread.

Panic is unnecessary, but vigilance and preventive measures are crucial, he said.

According to Dr Harjeet, individuals who test positive for dengue should prioritise physproper hydration, and consume a diet rich in fruits and

insecticides in outdoor water storage containers.

Highlighting the primary vector of dengue, the Aedes aegypti mosquito, Dr Harjeet said that it has adapted to urban habitats and breeds primarily in man-made containers such as buckets, mud pots, discarded containers, used tires, and stormwater drains. These breeding sites should be regu-

larly cleared and cleaned. The Aedes aegypti mosquito is most active during dusk and dawn, so people are advised to wear clothing that minimises skin exposure to these mosquitoes, he said.

Dr Rai reported that dengue testing labs are available in every district of Jammu division, with around 27,000 tests conducted this year so far, of which roughly 3,000 have yielded positive results.

Out of the 3,000 positive ical and mental rest, maintain cases, 1,047 required hospitalisation, and 89 active patients are currently under treat excluding three fatalities in Udhampur, he informed. The doctor informed that the helpline number 104 for assistance from 9 am to 6 pm daily. He said positive patients are provided counselling and guidance through the helpline. In addition to dengue, approximately 80 cases of chikungunya, another mosquito-borne disease, have been reported this year. professionals Healthcare recommend eliminating stagnant water that serves as mosquito breeding sites at home, schools, workplaces, and their surroundings to prevent dengue. They advise avoiding mosquito bites by covering the body and using mosquito nets when sleeping during the day, which should be sprayed with insect repellents.

In strict adherence to the guidelines of the General Financial Rules (GFR) 2017, the procurement process guaranteed transparency, competition, fairness,

and the eradication of arbitrariness. The qualification criteria mirrored those specified by the National Health Authority, ensuring a just selection process.

The bidding document, explicit and comprehensive, was accessible on www.jktenders.gov.in, with all modifications and clarifications duly conveyed to bidders. A generous period of 22 days was allocated for bid preparation and submission.

Following the pre-bid meeting and the public unveiling of technical bids, meticulous scrutiny by the Central Tender Committee affirmed that three out of four bidders, including IFFCO Tokio General Insurance Company, Bajaj Allianz General Insurance Company, and National Insurance Company, met the specified requirements, qualifying for the subsequent stage.

Opening financial bids revealed IFFCO Tokio General Insurance

Company Ltd. as the lowest (L1) bidder with a quoted rate of Rs 1840/- per family.

With the imminent expiration of the policy with Bajaj Allianz GIC on December 25, 2021, SHA J&K sought an interim arrangement to prevent service disruption. Bajaj Allianz GIC responded by offering to continue implementing the scheme at a quoted price of Rs 3,261.60 per beneficiary family unit on a Pro-Rata basis for the requested coverage period.

To prevent service interruption, SHA J&K entered into an agreement with Bajaj Allianz GIC to continue services on a Stop Loss basis until the selection of a new Insurance Company is finalized. The Insurance Company would not share the risk of loss of claims, and the entire claims outgo would be borne by the Government of J&K and the National Health Authority. The financial details underscore

that the Interim Arrangement,

with 15% administrative charges, was the most cost-effective option, serving public interest during the transition period. Panic Grips Gaza as Israel Demands 1.1 Million People Leave in 24 hours

GAZA: Frightened Palestinians packed belongings and left their homes in northern Gaza on Friday after Israel's military demanded that more than 1 million civilians leave the blockaded coastal strip within 24 hours. Many say the waning is a possible precursor to ground invasion but one that the United Nations warned could be calamitous.

The U.N. warned that so many people fleeing en masse - almost half the Gaza population – would be calamitous. Hamas, which staged a shocking and brutal attack on Israel nearly a week ago and has fired thousands of rockets since, dismissed the evacuation order as a ploy and called on people to stay in their homes.

Many Gazans were in a fix as the Israeli military was preparing for a ground invasion that will likely turn the overcrowded Palestinian territory into one of the world's bloodiest war zones. "Our people reject the threat of the occupation (by Israeli) leaders and (the) call to flee to the south or Egypt," the group said. "We are steadfast on our land and in our homes and our cities. There will be no displacement," Hamas said in a statement.

Israel's retaliatory airstrikes since Saturday, deadlier and more widespread than in its past campaigns in Gaza, have wiped out entire neighborhoods, brought the medical system to the brink of collapse and forced about 400,000 people into temporary shel-



ters as they face dire shortages of food, water and fuel. Gaza's health ministry said that 1.537 Palestinians, including 500 children, had been killed since Saturday, and that 6,612 people, onequarter of them children, had been injured.

evacuation order The sparked widespread panic among civilians and aid workers already running from Israeli airstrikes and contending with a total siege of Gaza. Israel has cut off all food, water and supplies and caused a territory-wide blackout. "Forget about food, forget

about electricity, forget about

fuel. The only concern now is just if you'll make it, if you're going to live," said Nebal Farsakh, a spokesperson for the Palestinian Red Crescent in Gaza City, as she broke into heaving sobs. The United Nations pleaded

for Israel to rescind the demand for a forced relocation out of fear of a humanitarian disaster. Some Gazans who want to flee with their families don't have vehicles, and were setting out either on foot or catching rides in trucks. Others said the roads have been damaged by nearly a week of Israeli airstrikes and were difficult to navigate.

Some Gaza residents said they feared the expulsion could end up being the start of another permanent mass displacement like the one in 1948, when more than 700,000 Palestinians either fled or were expelled from their homes in present-day Israel during the war surrounding the nation's estab-lishment. But it was too soon to tell.

"As I am packing my things I am wondering, is this really another Nakba? I am taking my house key and thinking, will I ever return to my home, will I ever see my home again?" said Dr. Arwa

El-Rayes, 56, a doctor of internal medicine, speaking in the last moments before she fled her childhood home in Gaza City in the north, the main city in the territory. The Nakba, which means catastrophe, is how Palestinians refer to the displacement of 1948.

Gaza resident Mahmoud Shurrab said he saw the warnings to evacuate the northern part of the Gaza Strip on Facebook on Friday morning and quickly packed a backpack with important documents. He then began driving with his mother south seeking safety

On the way, he said, he saw droves of people lining to fill their gas tanks, and others loading luggage into their cars. He, along with many other Gazans, reached a town just south of the evacuation zone but still close to their homes in the north. He and his mother are staying out on the streets for now, without shelter.

"We are disoriented. We don't know whether we will return or not. Nobody understands what's going on. The biggest problem is that we have no idea where to go," The New York Times quoted him as saying.

UN RESPONSE

However, the demand to move over a million people at short notice, during a war, has been criticised by the United Nations, which warned Israel of "devastating consequences". "... impossible for such a movement to take place without devastating humanitarian consequences," the UN said.

The big (and very obvious) concern for aid agencies is where? And how do you move 1.1 million men, women and children, as well as injured and infirm, while being bombarded by Israeli forces?

Israel has already indicated its willingness to inflict collateral damage, including killing civilians.

THE GAZA STRIP

Gaza is 41 km long and between six and 12 km wide. It is divided into five areas - North Gaza, Gaza, the Middle Area, Khan Younis, and Rafah. The Strip has two land borders - Israel on its north and east, and Egypt on its south. Both are closed. To its west is the Mediterranean Sea, also closed.

About 1.1mn of Gaza's population of more than 2mn live in the northern part of the enclave, which includes Gaza City and its outskirts.

Gazan airspace is controlled by Israel; their airport was destroyed by the Israelis in 2022. It is, therefore, completely cut off from the world; the narrow 365 sq km patch of land, which is among the most densely populated on the world, relies (almost) en-

tirely on Israel for food, fuel, medicines, drinking water and other essentials, and, to a lesser extent, on international aid agencies.

ISRAEL'S DEMAND

Israel has demanded 1.1 million Gazans move from North Gaza to southern areas, potentially a 40 km journey in 24 hours, and as far down as Rafah and the border with Egypt.

There are two main entry/ exit points on Gaza's land border through which people are allowed - the Erez Crossing in the north that is controlled by Israel, and the Rafah Crossing controlled by Egypt.

Both have been closed to Gazans looking to flee the fighting. There is a third crossing - Kerem Shalom - which is controlled by Israel also but is normally only used to move goods.

The Gaza side of the Rafah Crossing was bombed even as civilians were looking to flee, raising questions over how serious Israel is about not deliberately targeting non-combatants.

Man, 89, Refused Divorce By Supreme Court After 27-Year Case

NEW DELHI: The Supreme Court has denied an octogenarian man the right to divorce his wife of six decades, 27 years after he first applied to dissolve their marriage.

Divorce remains taboo across much of India with only one in every 100 marriages ending in dissolution, often owing to family and social pressure to sustain unhappy marriages.

Those seeking divorce must get approval from the courts, which typically only grant it if proof of cruelty, violence or undue financial demands is presented.

Nirmal Singh Panesar, 89,

married in 1963 but said in filings with notoriously glacial criminal justice system that his relationship had broken down irretrievably in 1984.

That year his wife Paramjit Kaur Panesar, now 82, had refused to move with him to Chennai when the Indian Air Force posted him there.

Nirmal first filed for divorce in 1996 on the grounds of cruelty and desertion, granted by a district court in 2000 but overturned later that year after an appeal by Paramjit.

His case took another two decades to make its way before the Supreme Court, which denied the divorce petition despite agreeing their marriage was "beyond salvation".
