Delhi Gasps For Breath As Haze Persists For 5th **Consecutive Day**

Dollution levels in Delhi and its surrounding areas dipped marginally overnight due to a relatively better wind speed, though the concentration of poisonous PM2.5 was still over 80 times the healthy limit prescribed by the World Health Organization (WHO).

A thick toxic haze lingered over the city for the fifth consecutive day, with doctors expressing concerns that air pollution is causing an increase in respiratory and eye problems among children and the elderly.

The concentration of PM2.5, fine particulate matter capable of penetrating deep into the respiratory system and triggering health problems, exceeded the

government-prescribed safe limit of 60 microgrammes per cubic metre by seven to eight times at multiple locations throughout Delhi-NCR. It was 80 to 100 times the healthy limit of 5 microgrammes per cubic metre set by the WHO.

Air quality in Delhi-NCR declined over the past week due to a gradual drop in temperatures, calm winds that trap pollution, and a surge in postharvest paddy straw burning across Punjab and Haryana.

Data from the Central Pollution Control Board shows that Delhi's air quality index increased by over 200 points between October 27 and November 3, culminating in a descent into the "severe plus" category (above 450) on Friday.

However, the 24-hour average AQI, recorded at 4 pm every day, marginally improved from 468 on Friday to 415 on Saturday.

Friday's 24-hour average AQI was the worst since the previous high of 471 recorded on November 12, 2021.

The air quality in neighbouring Ghaziabad (394), Gurugram (404), Noida (408), Greater Noida (490) and Faridabad (438) also reported hazardous air quality. Delhi's air quality ranks

among the worst in the world's

capital cities

A report by the Energy Policy Institute at the University of Chicago (EPIC) in August said that air pollution is shortening lives by almost 12 years in Delhi.

The hazardous pollution levels compelled many to forgo their morning walks, sports, and other outdoor activities.

Parents are a worried lot as health experts say children breathe faster, taking in more pollutants

Unfavourable meteorological conditions, combined with emissions from vehicles, paddy straw burning, firecrackers, and other local pollution sources, contribute to hazardous air quality levels in Delhi-NCR during the winter every year. According to an analysis con-

ducted by the Delhi Pollution Control Committee (DPCC), the capital experiences peak pollution from November 1 to November 15 when the number of stubble burning incidents in Puniab and Haryana increases.

Smoke from stubble burning accounted for 24 5 percent of the PM2.5 pollution in Delhi on Saturday, dropping from 35 percent on Friday, according to a numerical model-based system developed by the Punebased Indian Institute of Tropi-

cal Meteorology. Officials at the Commission for Air Quality Management, a central government panel that formulates strategies to combat pollution in Delhi-NCR, expect pollution levels to further decline due to comparatively better meteorological conditions and curbs imposed on certain polluting activities, including non-essential construction work, starting Thursday.

On Friday, the commission deferred the implementation of stricter measures under the air pollution control plan, called the Graded Response Action Plan, citing a declining trend in the AQI in the region.

A day earlier, the pollution ontrol body had ordered a ban on non-essential construction work and specific categories of polluting vehicles.

Over 50 Haryana Schoolgirls Accuse Principal Of Sexual Harassment, Case Filed

CHANDIGARH: Over 50 female students of a government school in Jind district have accused their principal of sexual harassment, the Haryana State Commission for Women said on Friday as it pulled up the police for their lackadaisical approach to the complaints.

The commission said they had forwarded the complaints from a few female students of the school to the police on September 14 but action was taken only on October 30.

The Haryana police had on Monday booked the school principal, days after he was suspended by the Jind admin-istration over allegations of sexual harassment of a few students

The Jind police have formed teams to arrest the accused, a police official from the district said on Friday, stating that the principal, who is aged around 55 years, is evading arrest. Speaking to reporters in Pancĥkula, the State Commission for Women's chairperson Renu Bhatia said, "We have received 60 written complaints against the principal from the girl students. Out of this, 50 are complaints from girls who stated physical abuse at the hands of the accused. Ten other girls, in their complaint, said they knew the principal was into such things," Ms Bhatia added that all the complainants were minor.

approach" of the Jind police in the matter.

"The girls later contacted us again. We spoke to the Superintendent of Police after which an FIR was registered," she added. Ms Bhatia also asked why the accused was not arrested immediately once the FIR was registered, which gave him time to abscond.

A woman District Education Officer's alleged lapse is also being investigated by the commission to find out why she did not act when she received the complaints, Ms Bhatia said.

A female teacher's role who allegedly supported the principal is also being investigated, she added.

She said some girls contacted the commission on Thursday evening alleging that they received phone calls from unknown persons who pressurised them to recall their statement. The commission's chairman urged the Haryana DGP and the Jind Superintendent of Police to ensure that the accused is arrested immediately. "Such persons deserve to be sent behind bars immediately," she said. Ms Bhatia said the commission had proof that the principal used to call some of the girls on their phones and tried to chat with them, adding that he had kept at least three mobile phones which were not known to his family or anyone else. The accused had allegedly installed a tinted door at his office in the school, the police had said. The principal did not have a good record in other schools too where he was posted, Ms Bhatia said, adding that there were complaints of misbehaviour with female students against him at two other schools, she said.



Class 10 Student Dies By Suicide After Mobile Taken **By School Authorities**

BHUBANESWAR: A student of Class 10 allegedly died by suicide on his school premises in Khurda district after his mobile phone was "seized" on Friday, police said.

The minor boy, who stayed at the school hostel, was found hanging from a tree on Friday morning, a police officer said.

He took the extreme step after his mobile phone was reportedly seized by the school authority.

"We have recovered the



body and informed his family members. Investigation has been started into the unnatural death," said SDPO (Khurda Sadar) Dilip Das.

"A number of Hamas terrorist operatives were killed in the strike. We have information which demonstrates that Hamas' method of operation is to transfer terror operatives and weapons in ambulances," CNN quoted the statement as saying.



But the UN Relief Works Agency (UNRWA) has said that "a convoy of ambulances evacuating patients from Shifa hospital in Gaza city to the Rafah crossing with Egypt, was struck three times in the vicinity of the hospital".

Citing initial reports, the UN body said that at least 13 people were killed and 26 injured.

Earlier Friday, a spokesman for the Gaza-based Palestinian Health Ministry had also said that the ambulance was in a medical convoy from the hospital, traveling to the Rafah border crossing, and had informed the International Committee of the Red Cross

about the move. On its part, the ICRC confirmed it was aware of the scheduled movement of a convov of vehicles carrying wounded patients from northern Gaza to the south,

but it was not part of it. "We were informed by the MoH (Ministry of Health) about the planned convoy, but we were not part of it," the ICRC told CNN.

"Even if we were not present, this is still medical convoy, and any violence towards medical personnel is unacceptable... No doctors, nurses, or any medical professionals should ever die while working to save lives."

The victims alleged that the accused used to call them to his office and "indulge in obscene acts", she said.

"Initially, we received a complaint on September 13 from some female students and forwarded it to the police the very next day. From September 14 to October 29, there was no action on their end," Ms Bhatia said, pointing at the "lackadaisical

Alarming Rise Of Drug Abuse: A Collective Failure

rug addiction has surged dramatically over the past decade, catching everyone off guard and leading to catastrophic consequences not only for the victims of drug abuse but also shrouding our entire societal fabric in a cloud of despair and gloom. It is primarily a collective failure of society to prevent our youth from succumbing to the drug menace. Unfortunately, as integral members of society, our approach has been abysmal in recognizing and addressing such activities in our midst, often dismissing the potential fatal consequences. We often think, "It's not related to my immediate family members, so why should I speak out against it?" This pessimistic approach has allowed the drug menace to deeply infiltrate our social structure, making it seemingly uncontrollable. The damage already inflicted is irreparable, as we've lost numerous young individuals to drugs, with many others seeing their potential and careers tarnished. The economic distress imposed on the families of drug-affected youth is also unimaginable.

The geographical location of Jammu and Kashmir makes it susceptible to drug trafficking, especially across the Union Territory. The Kashmir valley is one of the hardest-hit regions by drug abuse. Various factors contribute to this menace, including unemployment, the conflict-ridden history of Jammu and Kashmir, peer pressure, unfulfilled aspirations, expectations placed on children by parents, poverty, and corruption. Researchers have identified major drugs of abuse in the UT of Jammu and Kashmir, such as tobacco, cannabis, alcohol, benzodiazepines (including sleeping pills like alprax and valium), opiates (like codeine, heroin, and morphine), brown sugar, and inhalants (like fevicol, SR, glue, paint thinner, petrol, shoe polish, etc.).

Drug addiction has become a matter of grave concern, with a significant increase in the consumption of hard drugs like heroin and other opioids. Data presented by the Union Minister for Social Justice and Empowerment in Parliament is alarming, indicating that nearly 10 lakh people in Jammu and Kashmir are victims of the drug menace. This number has seen an unprecedented upward trend over the years. Shockingly, 1.44 lakh people in Jammu and Kashmir are active consumers of cannabis, including 36,000 females. Such statistics are a shock to the collective conscience of our society, as the most vulnerable segment is increasingly falling prey to substance abuse. It's worth noting that 5.34 lakh men and a substantial number of 8,000 women are involved in opioid addiction, while 1.6 lakh men and 9,000 women are victims of sedative addiction. A recent survey by the Institute of Mental Health and Neurosciences (IMHANS) in Srinagar has revealed that Jammu and Kashmir has even surpassed Punjab, known as the drug menace capital of India. Official figures from the Jammu and

Kashmir Government indicate that 41,110 drug addicts sought treatment for drug abuse in Kashmir in 2022, nearly double the number from the previous year, which was 23,403. Dr. Yasir Rather, a Professor of Psychiatry at IMHANS, Srinagar, attributes this increase to the rising cost of heroin due to a decrease in its supply. He also notes that the cost of a gram of heroin has risen from Rs 2000-3000 in 2022 to around 6000 in 2023. Consequently, many abusers have been left with no choice but to seek treatment. According to a study titled "Prevalence and Pattern of Substance Use Disorders in Kashmir (2022)" conducted by IMHANS, heroin is the primary drug in the valley. This study also reveals that the average cost incurred by one person con-



suming a gram of heroin per day amounts to 8,183, signifying significant economic implications. The study further indicates that over two-thirds of drug addicts started substance abuse between the ages of 11 and 20. Additionally, 91.9% of patients studied exhibited multi-substance abuse, with inhalant use being predominant among adolescents. Nicotine, cannabis, alcohol, opioids, and benzodiazepines were more prevalent in the age group of 21 to 30.

Research in the southern landscape of the Kashmir valley highlights a disturbing lack of awareness regarding drug de-addiction centers among drug abusers and their families. A significant percentage of respondents are unaware of the existence of these centers, NGOs working in the field of drug de-addiction, or the centers operating in the Kashmir valley. This widespread unawareness exacerbates the problem and underscores the need for extensive efforts to combat this menace.

Drug abuse and the rise in societal crime

It is a well-acknowledged reality that the increasing trend in drug abuse cases has led to a surge in heinous crimes within society. The need for a substantial amount of cash to procure highly sedative drugs has pushed drug abusers to explore illegal means to acquire them, no matter the cost. One of the most concerning ramifications of drug abuse today is the rise in homicide cases, especially among young individuals. It has become commonplace for drug abusers to resort to theft from their families and relatives to sustain their drug addiction. Dr. Yasir Rather, a Professor of Psychiatry at IMHANS Srinagar, unequivocally asserts that the escalating crime rate in Kashmir may be linked to the surge in heroin abusers. Some addicts resort to burglary and even murder out of desperation and frustration to acquire drugs. Over time, some addicts become drug peddlers to ensure a continuous cash flow.

For instance, in March of this year, a 32-year-old resident of Dangerpora village in Sopore, North Kashmir, strangled his 70-year-old mother. The evident reason was the drug addiction of the perpetrator, and his sole intention in murdering his mother was to satisfy the unjust demand for money to buy drugs. Another similar incident occurred in Gopalpora village, Anantnag, where a teenager, along with a friend, brutally attacked his mother, blaming his father initially for the heinous crime. Such incidents are not isolated and are unfortunately becoming more common in the Southern region of the Kashmir valley. The incident of a baker in Aishmuqam Pahalgam has also shaken the conscience of residents. The baker, allegedly under the influence of drugs, attacked his own family members and neighbors, resulting in the death of three individuals, including his mother, and injuring seven others.

Our society is facing a critical crossroads, and we seem to be hesitant to take the necessary actions to curb this menace. It is high time that we address this issue with a sense of urgency and implement a comprehensive action plan to counter the drug menace.

A Remedial Action Plan to Counter the Drug Menace

The widespread lack of awareness about the existence of drug de-addiction centers highlights the urgent need to operationalize large-scale centers accessible to substance users seeking treatment.

Additionally, parents play a pivotal role in keeping their children away from drugs. Unreasonable expectations placed on children by their parents can lead to increased mental distress. When children can't meet their parents' expectations, they often turn to drugs to cope with the resulting mental trauma, trapping themselves in the vicious cycle of drug abuse. Parents should provide support to their children and collaborate with them in pursuing careers of their choice, rather than pressuring them into careers they don't desire.

The community can be an effective tool in combating the drug menace, provided it acts as a cohesive unit, vocally opposing the unscrupulous elements.

s Israel and Hamas keep their daggers drawn, destabilising the Middle East, New Delhi should keep alternative strategies in mind, especially its Act East policy. This becomes important as it is a region with which India may have to postpone the strengthening of economic and trading ties. The Act East policy is intended to strengthen India's strategic and trade relationships with Asia-Pacific/East Asian/Southeast Asian countries—especially with Japan and South Korea, and with the ASEAN.

Trade has long driven development in the Asia-Pacific. For instance, Japan and South Korea have achieved highincome status through export-driven development strategies. Meanwhile, the strengths of emerging economies in the region explain why, in part. They account for 17% of global goods and services, with India contributing 1.8%. Their dual strategy aims at countering China while having it as a member of two of their three most prominent trade organisations—the Regional Comprehensive Economic Partnership (RCEP) and Asia-Pacific Economic Cooperation (APEC).

Simultaneously, they also hold that China can only be checkmated if their own economies grow stronger. The shift in global supply chains triggered by the pandemic, Russia's war in Ukraine, and a possible prolonged conflict in the Middle East could affect their economies. Additionally, since their largest markets are in the Asia-Pacific itself, they have

favoured trade integration in the region.

That is why intra-regional trade accounted for more than half of the total export growth of East Asia in the last decade, while exports to the US, European Union (EU), and Japan accounted for 30% in 2021. Semiconductors and other computer equipment, computers, TV sets, and mobile phones were exported from highly developed economies like Japan, South Korea, China, and Taiwan after being assembled in less developed Asia-Pacific countries including Malaysia and Vietnam, and sometimes also China.

One result has been the growth of consumer demand in East Asian countries over the last 10 years. This growth poses a political dilemma, since China has surpassed the US and the EU as their largest customer. They have dealt with this problem by lowering barriers to regional trade and subsequently to regional integration. This includes non-tariff barriers, especially on digital goods. Their rationale is that stronger intraregional trade and economic integration will diversify supply chains. Also, such trade—and countries that demand their goods—can offer protection against uncertainties and shifts in global trade and growth.

India is not a member of the Partnership (CPTPP) which excludes China, and the RCEP and APEC, which include China. The 21-member APEC includes Asia-Pacific, Western, and Latin American countries. Home to over 2.9 billion people, it is a major force in shaping regional economic policies, promoting trade, investment and cooperation between its members, who can simultaneously share, and learn from, the experiences of other member-states.

India could benefit from joining APEC. This could provide APEC members with the opportunity to create more investment opportunities in the country. Membership could also increase their access to India's labour force and expand its markets. Aligning with APEC by simplifying and harmonising trade procedures and regulations could boost India's exports, attract foreign direct investment and support domestic initiatives like Make in India. To increase trade, India should also invest more in the ASEAN, which was a top recipient of FDI in developing regions (second after China in 2021).

Despite their different political systems and attitudes to China and the US, countries are also investing in one another. For instance, the Asia-Pacific's fast-growing economies, sometimes hailed as the world's factories, have expanding markets because their percentage of buyers is growing. At the moment, 54% of the ASEAN's population comprises 29% of the world's consumer middle-class population. Some 65% of the ASEAN's population could join the international consumer class by the end of this decade. Optimists predict that East Asia could become the largest consumer market by then.

More domestic jobs and household

consumption can act as a shock absorber for global economic crises. Additonally, policies to lower barriers to regional trade could deepen regional integration. This is why Asia-Pacific countries keep trying to reduce, if not remove, non-tariff barriers, especially in digital services.

Finally, India should pay more attention to the linkages between trade, investment and services that are integral to global supply chains (GSCs). Many of its trading friends-including Japancomplain about its increased protectionism over the last few years. Its limited economic liberalisation hampers its integration with GSCs. This, in turn, could stand in the way of taking advantage of the China-Plus-One strategy, which the West-and the World Bank-hope will dissuade countries from investing mainly in China and encourage them to diversify their businesses to alternative destinations.

India's emergence as a reliable investment base and its introduction of tariffs that are comparable to those of Asia's strong emerging market economies for its manufacturing sector could realise its potential for integration into GSCs. This would certainly be to India's economic and strategic advantage.

How Reading Fiction Can Save the Day

There is a fair chance that someone in your close circle of friends and family will be using a smartphone, e-reader or tablet computer to read the latest bestseller over

Now how do we get young people – our so-called digital natives – to read without being constantly distracted by their various social networks and other communication tools ? Here are a few more tips.

the holidays this year. Since the 2007 and the introduction of Kindle in 2010, such devices have changed the way that people engage with books. Most newspapers, including the 166-year-old New York Times have completed their digital transition, and some are now exclusively online. In academia, journal articles are increasingly published first in digital form, and sometimes exclusively so. But when it comes to books, the paper form has shown unexpected resilience.

Ground-breaking inventions

The digital or screen revolution we are living today is on the same scale as two other major events that radically changed humanity: the invention of writing 6,000 years ago in the form of clay inscriptions in Mesopotamia and Gutenberg's invention of printing with moveable type in the 15th century.

These ground-breaking inventions were regarded with suspicion by many contemporaries. Plato considered writing a threat to human memory, and monks agonised over the demise of their way of life. In 1492, for example, the abbot Johannes Trithemius wrote De laude scriptorum manualium, which he had printed in 1494 for better effect. In both cases the contemporary sceptics were right.

Human powers of memory are nowhere near what they were before the advent of writing, and printing spelled the end of the monastic scriptorium.

Not surprisingly, the screen revolution, too, has its detractors, and once again, their criticisms frequently have their basis in truth. In the E-READ research network, to which we belong, we are trying to understand the function of reading in the digital age especially at a time where research points out the negative impact of screens.

Screen addiction

Smartphone usage among teenagers has been compared to drug addiction. Worldwide surveys show that a whole generation has been growing up constantly



online, checking the smartphone up to 75 times a day. These so-called "digital natives" are, according to a recent Italian study, less autonomous and less happy than their predecessors. They face new social anxieties like "FOMO" (fear of missing out) and "vamping" (late-night texting).

The device as a medium is not to blame, but its online nature encourages a 24/7 connectivity, inducing greater distraction and more fragmented reading habits. The prime victim here is deep or immersive reading, whether in literature or all sorts of narrative and argumentative texts, included academic ones.

Is it possible for us to counter these unwelcome side effects of the digital revolution? The good news is yes. Part of the solution lies in changing our habits by reading fiction and enjoying solitude.

Experience solitude

Thuy-vy Nguyen, along with his colleagues from Rochester University found that solitude can lead to relaxation and stress reduction. The researchers define solitude as "as being alone for a period of time with no access to devices, personal interactions, external stimuli, or activities." In all four studies, the solitude lasted 15 minutes and the subjects were instructed to sit alone and not engage in any activities or to carry out an activity alone as to think either positive or neutral thoughts. In one part of the experiment, subjects were provided with a short recreational reading, titled "Glamorous Crossing: How Pan-Am Airways Dominated International Travel in the 1930s". The results were similar to that of the other activities carried out in solitude: people were more relaxed and calm.

Reading carried out in "fertile solitude" fosters readers' resilience and greater impermeability to social pressures and expectations, such as those encountered especially on social media. It may of course also incite people to do their reading on paper, simply because they find that more relaxing than using an online device. But if reading is good for you, reading fiction is even better.

Find the good in you

Scholars have indeed recently provided empirical evidence for claims that literary reading positively affects social cognition social skills and empathy. Psychologist Raymond Mar and his colleagues found that the more fiction people read – and it can be of any kind – the better they scored on tests that measure a form of empathy.

In another experiment, professor of psychology Dan Johnson found that participants who read an excerpt from a novel about the plight of an Arab-Muslim woman showed a significant increase in empathy for Arab-Muslims and in their intrinsic motivation to reduce prejudice.

Literary readers could actually counterbalance the unhealthy trend of hatred and indifference which is rife on the Internet. In experiments related to an ongoing project at the Institute for Advanced Study in Paris, we could show that literary readers feel compassion for morally positive characters but not for morally bad ones. At the Max-Planck-Institute for Empirical Aesthetics in Frankfurt, we ran an experiment manipulating a literary text.

In one version, the protagonist is a doctor volunteering in Africa, in the other he is a Nazi who fled to South Africa. In the two versions we changed only four sentences concerning the moral nature of the protagonist and preserved the rest of the text almost entirely in form and content. 120 German subjects read either the text with the morally positive protagonist or the one with morally negative protagonist and afterwards rated the aesthetic and moral value of the text and answered several empathy/sympathy-related questions. While the results have not yet been published, they clearly show that the sympathy measures were affected by the moral nature of the protagonist.

Thus, literature can be considered a moral laboratory which enhances our prosocial traits.

Teach people how to (really) read

To ensure that literature regains (or gains) a central place in people's reading aspirations, the didactics of literature in the digital age must be drastically overhauled. While text and author-oriented approaches are still dominant in European schools, new studies show the need to implement "experiential approaches" where the focus should be on the addressee of the text – for example, students. Research suggests that listening to student preferences (instead of imposing texts) and helping them choose the right book to fit a particular moment in their lives instigates much greater engagement.

That way we can make literary fiction mean a great deal more to adolescent readers and enhance what they can gain from it for their social lives and for their personal development.

Incidentally, it may be that paper itself is an invaluable ally here. Research has been shown that its material properties suit our memory better. Psychologist Rakefet Ackermann, also a member of the E-READ network, explained that despite immense technological advances, learners still prefer studying text from hardcopy pages rather than computer screens. She revealed that while learning performance on digital devices is not worse than on paper, surprisingly, it's our metacognitive capacity fails us. When reading an article on screen a person is less prepared to evaluate how much she has understood or – in case of studying also – memorized.

What our own experiments on the appeal of paper books showed is that readers of works on paper engage more deeply while those who use digital devices tend to read more shallowly.

So do we want to really sharply contrast digital and paper reading, and do we oppose reading from screens? No. We need to adapt our tools to our needs and to develop them in order deliberately to make reading a profound component of our social and cultural habits. The more we understand about digital reading the more we can salvage from the precious past we inherited.

Is Salt Really A New Culprit In Type 2 Diabetes?

hen people think of foods related to type 2 diabetes, they often think of sugar (even though the evidence for that is still not clear). Now, a new study from the US points the finger at salt.

The study, conducted by researchers at Tulane University in New Orleans, used data on about 400,000 adults, taken from the UK Biobank study. This observational study followed the participants for nearly twelve years. In that time, around 13,000 developed type 2 diabetes.

In a press release, the principal investigator on the study said that "taking the saltshaker off the table can help prevent type 2 diabetes". But is it really as simple as that?

For a start, this type of study, called an observational study, cannot prove that one thing causes another, only that one thing is related to another. (There could be other factors at play.) So it is not appropriate to say removing the saltshaker "can help prevent".

My colleague Dan Green and I have previously criticised university press releases such as this as they can lead to misleading news stories. The Tulane study can only suggest an association between salt use and the risk of developing type 2 diabetes nothing more.

This is before considering the quality of the data itself.

The data used to assess salt use, was based on the simple question: "Do you add salt to your food?" (It specifically excluded salt added in cooking.)

The question the participants in the study answered only had the options: "never/rarely", "sometimes", "usually" or "always". This means it is not possible to estimate from the answers how much salt might be associated with an increased risk of developing type 2 diabetes.

Processed food is the biggest source

Normal salt intake in countries like the



UK is about 8g or two teaspoons a day. But about three-quarters of this comes from processed foods. Most of the rest is added during cooking with very little added at the table.

The NHS advises that people should limit their daily salt intake to around 6g. Although people in the UK have reduced their salt intake over the last couple of decades, there is still a way to go.

Given that salt reduction is a public

health goal, it is important to be able to quantify intake to see if there is potential for what is known as a "dose-response" effect. The data reported was unable to suggest if consuming 2g of salt a day added at the table increases the risk of developing type 2 diabetes more than consuming, say, 1g a day.

The researchers used other tests of salt intake, including an estimate of how much salt participants lost in their urine over 24 hours. This is the most accurate way to measure sodium or salt intake.

This approach also suggested that higher sodium in the urine was linked to a higher risk of developing type 2 diabetes. However, what participants ate was not considered at all in this analysis. So it is not clear if salt can be directly implicated in increasing a person's risk of developing type 2 diabetes.

There is some evidence that increasing salt intake, as measured by sodium in urine may be linked to increased levels of the stress hormone cortisol. This has been linked to increased blood pressure and the reduced effectiveness of the hormone insulin.

Insulin normally controls blood glucose levels and is a key part of how type 2 diabetes develops. However, evidence for this mechanism has only been shown in rats.

Reducing salt is still a good idea

What we can be more sure about is that people with type 2 diabetes, who often also have high blood pressure tend to see their blood pressure improve when they consume less salt.

So the take-home message is: using less salt as part of a healthy diet, which is known to reduce the risk of type 2 diabetes, is a good idea.

This study did not show how much we need to reduce our salt intake by, it only suggested a weak association between adding salt to food and risk of developing type 2 diabetes. So it is better to focus on what is known to reduce the risk of developing type 2 diabetes, which is to maintain a healthy weight, be physically active and eat a healthy diet.

iPhone Owners Keep Devices Longer Than Android Smartphone Users: Report

Apple iPhone users keep their devices for a longer period than Android smartphone users, for at least two years or more, a new report has revealed.

About 61 per cent of iPhone buyers kept their previous iPhone for two years or more in the US, compared to 43 per cent of Android owners.

Far more iPhone owners (29 per cent) owned their previous iPhone for three years or more than Android owners (21 per cent), according to data from Consumer Intelligence Research Partners.

DGCA Proposes Changes To Flight Crew Duty Norms

NEW DELHI: Aviation regulator DGCA has proposed various changes to norms governing duty timings of flight crew, including more rest time for pilots, amid concerns over fatigue.

In recent times, the issue of fatigue among pilots has come to the fore, especially after the death of an IndiGo pilot, who had collapsed at the boarding gate of Nagpur airport.

The Directorate General of Civil Aviation (DGCA) has proposed a weekly rest of continuous 48 hours, and reduced flight duty period of 10 hours for pilots operating flights at night.

Besides, the heads of operations of scheduled airlines have to submit a quarterly report to the DGCA on the fatigue reports received and action taken during the preceding quarter, as per the draft norms.

"An operator shall ensure that the minimum weekly rest of continuous 48 hours including two local nights is provided such that there shall never be more than 168 hours between the end of one weekly rest period and the start of the next," it said. Currently, the rest period is 36 hours.

Changes have been proposed to the Civil Aviation Requirement (CAR) pertaining to 'Duty Period, Flight Duty Period, Flight Time Limitations and Prescribed Rest Periods -- Flight crew Engaged in Scheduled Air Transport Operations' and comments have been sought on the draft till December 4.

Congress, NC, CPI(M) slam J&K admin for warning employees against protests

Jammu: The Congress, National Conference (NC) and CPI(M) criticised the Jammu and Kashmir administration on Saturday for warning its employees against staging protests, describing the move as an attempt to "crush every voice of dissent" in the Union Territory.

The lieutenant governor-led administration warned the employees on Friday against going ahead with their proposed agitation, saying such acts will attract disciplinary action.

The Jammu and Kashmir Employees Government (Conduct) Rules, 1971 make it clear that no government employee shall resort to or, in any way, abet any form of strike in connection with any matter pertaining to his service or the service of any other govern-

ment employee. "The aforesaid provision of law is not merely declaratory in nature and shall definitely entail consequences in the event of any such employee found immersive in such acts," the order said.

Reacting to the develop-Pradesh Congress ment, Committee (PCC) senior vicepresident and media in-charge Ravinder Sharma said, "The administration under the central government wants to crush every voice of dissent, which is very dangerous, anti-employees and anti-people.

He said the employees have a fundamental right to protest against the failure of the administration to address their genuine issues.

"The Congress fully defends and supports the democratic and fundamental rights of every citizen, including the employees, and demands immediate withdrawal of the order," Sharma said, accusing the Bharatiya Janata Party (BJP) and the Union Territory administration of adopting a "dictatorial attitude" against the employees.

NC's provincial secretary Sheikh Bashir Ahmad said the order makes it clear that nobody is allowed to speak in Jammu and Kashmir.

"An employee is governed by rules, but he has every right to defend any injustice against him.... After August 5, 2019 (when the BJP-led Centre abrogated the provisions of Article 370 and bifurcated the erstwhile state into Union territories), Jammu and Kashmir was virtually turned into a prison for more than a year. So what can be expected from this administration?" he asked. The NC leader claimed that

the current situation is such that even political activists are hesitant to speak, fearing imprisonment.

Recently, former MP Sheikh Abdul Rehman had to spend a night at a police station to stop some activists from holding demonstrations against the Gaza-Israel war. What type of democracy is this?" he asked, adding, "You are free in Jammu and Kashmir with your mouth locked and hands and legs tied." Senior Communist Party

of India (Marxist) leader M Y Tarigami said the order contravenes the International Labour Organisation (ILO) conventions to which India is a party. "Government employees

only stage demonstrations or take out rallies when their legitimate and just demands are not fulfilled. The directive is yet another assault on the employees' and workers' constitutional rights," he said.

Asserting that the Left party will resist any attempt to curb the legitimate rights of the working class, Tarigami alleged that the Jammu and Kashmir administration has nothing to offer to its employees, especially the daily wagers and scheme workers who have not received their salaries for months.

HC imposes Rs 20K cost on Centre for not paying pension to 96-year-old freedom fighter

New Delhi: The Delhi High Court has imposed cost of Rs 20,000 on the central government for its "lackadaisical approach" in granting pension to a 96-year-old freedom fighter.

The high court said the case reflected "complete sad state of affairs" as freedom fighter Uttim Lal Singh was made to wait for over 40 years and run from pillar to post to get his rightful pension.

Justice Subramonium Prasad directed the Centre to pay Swatantrata Sainik Samman Pension to Singh within 12 weeks with interest from 1980. "It is painful to see the way

in which the freedom fighters are being treated and the insensitivity shown by the Union of India towards freedom fighter who has fought for the independence of the country," the high court said.

"For the lackadaisical ap-proach of the Union of India, this court deems it fit to impose costs of Rs 20,000 on the Union of India. Let the costs be paid to the petitioner within 6 weeks from today," the court said in its judgement passed on November 2.

It noted that the government of Bihar had recommended the petitioner's case and sent the original documents to the central government in March 1985. However, the documents got lost while they were with the central government. The court noted that the

Dar was shot dead on October 31. Talking to reporters outside Dar's residence, Swain said police have vowed to bring the perpetrators of the terror crime to justice.

"We have lost a member of our police parivar, a noble man, a father, a brother and a citizen of Kashmir. All the officers, including the ADGP. DIG. SSP and SHO, have vowed to go to the bottom of the matter and identify the killer and all those who supported him in any way and bring them to justice," Swain said.

He said the investigation into Dar's killing is on but the details cannot be shared.

"Pakistani land is not under our control and they send people, arms and ammunition or narcotics here. They are not sending money to build hospitals, schools or roads. But we will be successful in foiling their attempts when no one here will be ready to support them.

"We will create such a situation here and in this regard, our first action will start from this winter. We will not allow any loss of life of our colleagues or civilians. Whoever supports them, whether they are sitting across the border or here, will be brought to justice," Swain asserted.

Sri Lanka Cancel Training Due To 'Severe' Air Pollution In Delhi

NEW DELHI: Sri Lanka cancelled their opening training session in the national capital on Saturday due to "severe" air pollution but Bangladesh braved the adverse weather conditions to train, a day after choosing to skip their practice session.

Bangladesh, who arrived here on Wednesday, had decided against practising on Friday as the pollution levels in the city hit the "severe plus" category.

Sri Lanka followed them into staying indoors on Saturday when the Air Quality Index stood at 407 in the morning. "It was cancelled owing to the air quality issue," said a SLC source, referring to the Saturday's training session.

However, Bangladesh players, wearing masks, came out for practice at the Feroz Shah Kotla. An AQI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500 "severe".

It is unlikely that the International Cricket Council (ICC) will shift the game out of Delhi but the call on whether the match will go ahead will only be taken on that day.

"We are currently assessing the situation. The ICC and our hosts the BCCI take the well-being of all participants seriously and are monitoring the air quality in Delhi. We are taking expert advice to assess the situation," an ICC spokesper-



son told PTI.

The air quality is usually assessed by match officials on the day of a game. It is not the first time that Sri Lanka are having to deal with Delhi's notorious air pollution. The players had to wear masks during the Test series back in 2017. Even the Bangladesh cricketers resorted to wearing masks in Delhi ahead of a T20 in 2019. On Friday, Bangladesh team director Khaled Mahmud said the players devel-

oped cough after going out in the city and therefore the management decided to cancel the first training session. On Friday, the air quality plummeted to the

157 Killed As 6.4 Magnitude Earthquake Jolts Nepal's Mountainous Western Region

At least 157 people were killed and over 160 others injured when a powerful 6.4 magnitude earthquake, the worst since 2015, struck Nepal and destroyed hundreds of houses in the Himalayan nation's remote mountainous region, officials said on Saturday.

According to the National Earthquake Monitoring and Research Centre, the earthquake with an epicentre in Jajarkot district, about 500km west of Kath-

mandu, was recorded at 11:47 pm on Friday. Friday's earthquake is the most devastating one in Nepal since the 2015 earthquake that killed around 9,000 people and injured more than 22,000 others. The impact of the quake was

felt in Kathmandu and surrounding districts, and even in New Delhi in neighbouring India. The Nepal Army has mobilised

its personnel to carry out rescue work in the quake-hit areas, according to Nepal Army spokesperson Krishna Prasad Bhandari. Rescue workers on Saturday

dug through the rubble of collapsed houses to find survivors. The Jajarkot and Rukum dis-

tricts of western Nepal were worst hit by the quake. As many as 157 people were killed so far in the quake, Home Ministry officials said. While 105 people were killed in Jajarkot, 52 died in Rukum West, they said, adding that 166 people were injured in Jajarkot, Rukum West, Dailekh and Jumla districts. Aroum

Deputy Mayor Sarita Singh of Nalgadh Municipality in Jajarkot was among those killed in the quake, officials said.

The death toll is expected to rise, they said.

The Nepal government has announced Rs 50 million each for Jajarkot and Rukum districts as immediate relief.

Additionally, the Home Ministry decided to allocate Rs 5.5 million to the disaster relief funds of both the Jajarkot and Rukum West districts, aiming to support the rescue and relief operations for the affected individuals.

India has also offered to extend all possible assistance to Nepal.

În a post on X, Prime Minister Narendra Modi said he is deeply saddened by the loss of lives and damage due to the earthquake in Nepal. "India stands in solidarity with the people of Nepal and is ready to extend all possible assistance," he said.

The US embassy in Kathmandu said the United States stands ready to assist Nepal as it "recovers from this terrible earthquake". China has also offered to provide emergency materials worth NPR 100 million to the affected districts of Jajarkot and Rukum, officials said.

Around 159 aftershocks have been recorded following last night's earthquake, the National Earthquake Monitoring and Research Centre reported.

Many people spent the night in the open because of fear of further quakes and damage to their houses. People were seen digging through the rubble to rescue trapped people from the remains of collapsed buildings, according to posts on social media.

As the roads were blocked and bridges damaged, rescue and relief work at the quake-hit sites have been obstructed, according to officials.

The Ministry of Home Affairs has dispatched initial relief supplies via the Nepali Army's helicopters.

Prime Minister Pushpakamal Dahal 'Prachanda' on Saturday toured the quake-hit region with a medical team Saturday morning

ing. During the visit, he gathered information about the extent of the damage and inspected the affected areas. Later, he returned to Surkhet from Jajarkot, along with seven injured people and their family members.

UK MP Who Told Activist To 'Go Back To Bahrain' Guilty Of Racial Abuse

London: A British lawmaker who once commanded UN peacekeeping troops in Bosnia was fined on Friday, after being found guilty of racial abuse.

Conservative MP Bob Stewart, 74, was convicted of a racially aggravated public order offence and ordered to pay £600 (\$743) plus costs after a one-day trial at a court in central London. The former army officer had

been confronted by human rights activist Sayed Ahmed Alwadaei after an event at the Bahraini Embassy in December last year. Alwadaei, who was protesting

outside, shouted: "Bob Stewart, for how much did you sell yourself to the Bahraini regime?" The MP replied: "Go away, I

hate you. You make a lot of fuss. Go back to Bahrain." In footage played during a

Trial at Westminster Magistrates' t Court, Stewart told Alwadaei: E "You're taking money off my f country, go away". t He also said: "Now shut up, c

He also said: "Now shut up, you stupid man."

The activist told judge Paul Goldspring he was exercising his right to protest alleged corruption and human rights violations in the Middle Eastern country by



The protester also claimed that during a trip to the country, Stewart had chanted "God save the king of Bahrain".

"I feel that I was dehumanised, like I was someone who is not welcomed in the UK," Alwadaei said when asked about the exchange.

Alwadaei, the director of the London-based Bahrain Institute for Rights and Democracy, said if he did return to Bahrain, he would "undoubtedly be killed and tortured".

Stewart, apologised for his remarks last December, telling the Guardian newspaper, which first reported the incident, he had been "persistently taunted".

He commanded United Nations peacekeeping forces in Bosnia during the Balkans conflict in the 1990s, retiring from the military in 1996 before becoming an MP in 2010.

During the hearing, Stewart insisted: "I am not a racist."

Goldspring said: "I accept he is not racist per se, but that is not the case against him. Good men can do bad things."
