# Possible Outbreak Of Mumps Virus Worries Doctors In Kashmir

Health Experts Say Symptoms Of Covid-19, Mumps Alike; Urge Masses To Stay Alert

Srinagar: Mumps, a highly contagious and painful viral infection caused by Mumps Virus (MuV) is quite common in Kashmir these days, with the majority of patients unaware of what they are actually suffering from.

According to healthcare practitioners, the paramyxovirus, a frequent source of infection conveyed by airborne droplets from the upper

respiratory tract, is the root cause of contagion. Fever, headache, muscular pains, fatigue, and appetite loss, they said, usually appear a few days after the condition

The disease, the doctors said, is serious and can take the symptoms including parotid or salivary gland discomfort, trouble chewing, neck ache, pain and tenderness, fever, headache, muscular pains, and fatigue two to three weeks to manifest after contracting the virus.

"Mumps may

sneezes, coughs, speaks, or laughs. The virus spreads by microscopic droplets of fluid. It can also spread through contact with items people use, such as straws, drinking glasses, and soiled tis-

**Jammu:** A court here on Wednesday remanded former Jammu and Kashmir minister Lal Singh in seven-day custody of the Enforcement Directorate (ED), a day after the agency arrested him in a money laundering case.

Singh, the chairman of the Dogra Swabhiman Sangathan Party (DSSP), was arrested from a house in Chawadi area of Sainik Colony here on Tuesday evening within hours after a special court dismissed his anticipatory bail application.

Singh was under investigation by the Enforcement Directorate in connection with a case against an educational trust run by his wife and former legislator Kanta Andotra.

public prosecutor Special Ashwani Khajuria said the arrested accused was produced before the special court which granted the ED his seven-day remand instead of 14 days sought by the agency.

The special judge took note of the complaint of physical discomfort made by the accused and asked for his proper medical checkup, Khajuria told PTI, quoting the order.

Officials said Singh was shifted to the Government Medical College (GMC) Hospital in the early hours of the day after he complained of uneasiness.

He was discharged from the hospital around 3 pm and straightway taken to the court.

However, Singh alleged that though he was taken to the hospital but was not given proper medical aid.

"I was present in the emergency ward of the hospital but was denied proper medical treatment and even my admit file was not prepared and several tests not done. They have compelled the doctors to say that it is me who refused to take a CT he told reporters while being es-

corted to the court. Scores of his supporters had assembled outside the hospital and chanted slogans against the BJP, claiming that their leader was being framed in a baseless case ahead of the Lok Sabha elec-

tions next year. Singh, a two-time MP and three-time MLA, switched from the Congress to the BJP in 2014 and was also a minister in the previous PDP-BJP government which collapsed in June 2018 after the national party pulled out

of the alliance. Several months before the fall of the government, Singh resigned from the BJP and floated the DSSP, following an uproar over his participation in a rally in support of the accused in the rape and murder of an eight-year-old girl in Kathua in January 2018.

However, he defended his participation in the rally stating that he was there to "defuse the situation".

Last month, the Enforcement Directorate had conducted searches in Jammu and its adjoining areas as part of the money laundering probe against the educational trust of Andotra and a former government official in connection More on P10



### **SIA Raids Multiple Spots In** J&K, Delhi

Srinagar: The Jammu and Kashmir Police's Investigation Agency (SIA) on Wednesday raided multiple locations in the union territory and Delhi in connection with a terror funding case, the agency said.

"Continuing with its endeavour to dismantle terror support systems in J&K, the SIA Kashmir conducted searches at houses and offices at 22 locations in J&K and Delhi," the investigating agency said.

These locations include 18 in Srinagar, one each in Anantnag and Pulwama, and two in Delhi.

"The pre-dawn searches were carried out simultaneously by special teams of the SIA. During the search operation. incriminating material in the shape of bank documents, cash books, credit cards, debit cards, cheque books, invoices, mobile phones, SIM cards and passports etc., was seized, which will be analysed for further investigation," the SIA said.

The case pertains to illegal raising, layering and laundering of proceeds of crime by the accused persons. These proceeds of crime might subsequently have been used More on P10

Srinagar: On a specific tipoff, a team of Food Safety wing of Drugs & Food Control Organization, Kashmir comprising Intelligent Cum Legal Cell and Food Safety Wing Srinagar today conducted surprise inspections of Bemina, Qamarwari and Dalgate area.

During the inspection, the team found two sweets and bakery manufacturing units operational in contravention of provisions of FSSA 2006, as the bakery and sweets items were being manufactured under unsanitary/ unhygienic both units conditions, were sealed. 1.5 quintals of sweets were seized and samples were forwarded to the Food testing laboratory for testing of quality and safety parameters.

It was announced that the raids will continue in the coming days in view of the festive season to ensure quality sweets and other food items are available to the consumers.

Meanwhile, Food Safety authorities have warned all the Food Business operators particularly those dealing with the manufacture of Sweets, Bakery item and milk & milk products to strictly adhere to the guidelines and provisions of Food Safety & Standards Act, any kind of deviation/ violation shall call strict penal action warranted under law.

## At Least 30 Syrian Soldiers **Killed in Fresh ISIS Attack**

IDLIB: Islamic State group attacks killed at least 30 pro-government forces and soldiers in the Syrian desert, a war monitor said Wednesday, in one of the deadliest such assaults this year.

The Britain-based Syrian Observatory for Human Rights said there had been "30 dead, four of them soldiers and 26 from the National Defence Forces, in simultaneous attacks carried out by the Islamic State group on Wednesday morning on checkpoints and military positions" in the Syrian desert.

The attacks took place in locations between Raqa, Homs and Deir Ezzor, added the Observatory, which has a vast net-

work of sources on the ground. Observatory chief Rami Abdel Rahman warned the count could rise, citing an unspecified number of wounded, some in serious condition.

The war monitor said Russian warplanes launched strikes on IS positions in the desert, reporting casualties among the

jihadists. ISIS or Daesh proclaimed a "caliphate" in June 2014 across swathes of Syria and Iraq and launched a reign of terror.

It was defeated territorially in Syria in 2019 but its rem-

nants continue to carry out deadly hit-and-run attacks and ambushes, particularly from desert hideouts, targeting both pro-government forces and

ISIS was blamed for a string of deadly attacks on government loyalists earlier this year.

In August, 33 Syrian soldiers were killed when ISIS ambushed their bus in the desert near Mayadeen, in Deir Ezzor province, the Observatory said at the time

Days earlier, 10 loyalists were killed in an ISIS attack in Raqa province, the jihadists' former stronghold in Syria, the Observatory reported.

Also in August, the rebels attacked a convoy of oil tanker trucks guarded by the army in the Syrian desert, killing seven people including two civilians.

The same month, ISIS announced the death of its leader and named his replacement -the group's fifth chief -- as Abu Hafs al-Hashimi al-Qurashi.

The fresh rebel attacks have intensified as Israel launched a major onslaught on the neighbouring Gaza strip killing more than 10,000 Palestinians this month.

Syrian government with backing of Iran and Hezbollah has been battling ISIS and other Jehadist rebel groups since 2011.

## **US State Department Approves \$320 Million Sale To Israel Of Equipment For Kits That Are More Advanced**

The US state department has approved a \$320 million sale to Israel of equipment for kits that turn unguided bombs into more precise, GPS-guided munitions, according to a letter sent by the department to Congress that was obtained by The New York Times.

The order comes on top of an earlier one for the same equipment that was valued at almost \$403 million.

Israel has been using the kits during its bombing campaign in Gaza. According to the Gaza health ministry, which is part of the Hamas-run government in the enclave, the Israeli strikes have resulted in the

deaths of about 10,000 Palestinians, 40 per cent of whom are young children and teens.

Israel has ordered more munitions from the US alongside the equipment for guided bomb kits. Modern militaries generally add guidance systems onto bombs with the goal of minimising civilian casualties, although the damage can still be devastating, especially in urban areas.

Israel's arsenal of air munitions is made up largely of 453- 907-kg bombs, among the largest used by any military force. Israel dropped at least two 907-kg bombs in an airstrike on October 31 on the dense Jabalia neighborhood of Gaza. That strike killed dozens of people and injured many more, according to Gaza authorities.

Israel says it had successfully targeted a senior Hamas commander who helped plan the October 7 attacks launched from Gaza, in which Hamas fighters and other armed assailants killed what Israel says was more than 1,400 people, most of them Israeli civilians, and abducted more than 240 others. Hamas denies that any of its commanders were in the Jabalia area at the time of the October 31 strike.

The state department happened to send its letter on the new sale of bomb equipment to congressional offices on the day of that strike on Jabalia.

## **India, US To Review** Bilateral Ties, Key Global Issues At '2+2' Dialogue

**NEW DELHI:** India and the US will carry out a comprehensive review of their fast-expanding strategic ties at the next edition of the '2+2 foreign and defence ministerial dialogue here on Friday.

US Secretary of State Antony Blinken and Defence Secretary Lloyd Austin are visiting India for the dialogue. The Indian delegation will be led by External Affairs Minister S Jaishankar and Defence Minister Rajnath Singh.


"Defence Minister Rajnath Singh and Minister of External Affairs S Jaishankar will welcome US Secretary of State Antony J Blinken and Secretary of Defence Lloyd J Austin III for the fifth India-US 2+2 Ministerial Dialogue in New Delhi on November 10," the External Affairs Ministry (MEA) said on Wednesday.

It said the '2+2' dialogue will enable a high-level review of progress being made in crosscutting aspects of defence and security cooperation, technology value chain collaborations and people-to-people ties.

"The ministers will take the opportunity to progress the futuristic roadmap for the India-US partnership as envisioned by Prime Minister Narendra Modi and President Joseph Biden, in their discussions in June and September this year," the MEA said in a statement It said both sides will also take stock of contemporary regional issues and exchange views about shared priorities for augmenting cooperation in multilateral platforms, and through frameworks such as Quad.

Singh and Jaishankar are also scheduled to have bilateral meetings with their American counterparts, which will "mark a continuity of Ministerial Dialogue and reaffirm the India-US Comprehensive Global Strategic partnership", the MEA said.

## **Proposal To Change The** Name Of Aligarh To **Harigarh Passed**

After Allahabad became Prayagraj, it is now time for Aligarh to become Harigarh in Uttar Pradesh

The Aligarh Municipal Corporation has unanimously passed a proposal to change the name of Aligarh to Harigarh.

The proposal was presented by Mayor Prashant Singhal in a meeting on Monday and was supported by all councillors.

If the Uttar Pradesh government approves the proposal to rename Aligarh, it will add to the growing tally of places renamed in the BIP-ruled state.

Aligarh mayor Prashant Singhal said, "In the meeting, a proposal was presented to change the name of Aligarh to Harigarh. All councillors unanimously supported this. Now, this proposal will be sent to the administration. I hope that the administration will take cognizance of this and fulfil our demand to change the name of Aligarh to Harigarh. This demand has been pending since long." It may be recalled that a proposal to rename Aligarh to Harigarh was cleared by a zila panchayat meeting in 2021 and sent to UP Chief Minister Yogi Adityanath.

In 2019, Chief Minister Adityanath had indicated that his government will keep up with its spree of renaming places across the state.

"We did what we felt was good. We renamed Mughal Sarai as Pandit Deen Dayal Upadhayay Nagar, Allahabad as Prayagraj and Faizabad district as Ayodhya district. Where will take the steps required,' Yogi Adityanath had said then.

Members of the ruling BIP have, over the years, demanded that other cities be renamed as well. An Agra lawmaker had proposed that Agra be renamed Agravan or Agarwal, while another suggested that Muzaffarnagar be renamed Laxmi Nagar and Mainpuri as Mayan Nagar.

A state government can change the name of any city or area within the state. After a municipal body unanimously approves a proposed name change resolution, it will write to the state government. The resolution will then be sent by the state government to the Ministry of Home Affairs for approval. If the ministry and other relevant agencies approve the resolution, the state government can officially change the name.

## **HC Seeks Centre, Delhi Govt** View On PIL To Distinguish **Religion From Dharma**

The Delhi High Court on **■** Wednesday sought the stand of the Centre and city government on a public interest litigation seeking a direction to the authorities to use the proper meaning of the term religion and not use it as a synonym of dharma in official documents.

Justice Satish Chandra Sharma granted time to the governments to respond to the petition by lawyer Ashwini Kumar Upadhyay.

The petition also sought a direction to include a chapter on "dharma and religion" in syllabus of primary and secondary schools in order to educate the masses and control the religion-based hatred and hate speeches.

There is a colonial mindset which is being continued, said the petitioner before the bench, also comprising Justice Tushar Rao Gedela.

In his petition, the petitioner asserted that dharma is not religion as the former is nondivisive, non-exclusive and transcends narrow boundaries

of religion. If we try to define religion

then we can say that religion is a tradition, not dharma. Religion is a cult or a spiritual lineage that is called a 'sampradaya' (community). So, religion means community, the plea said as it prayed that dharma should not be used as synonym of religion in documents like birth certificate, aadhaar card school certificate, ration card, driving licence, domicile certificate death certificate and bank account etc.

In daily life, we say this person follows 'Vaishnav dharma' or Jain dharma, or someone follows Buddhism or Islam or Christianity that's not right. Instead, we should say that a person follows 'Vaishnav sampradaya' or this person follows 'Shiv sampradaya' or follows 'Buddha sampradaya'. This person follows Islam or Christan sampradaya, the petition submitted.

There have been many wars and war-like situations for religion. Religion works on a mass of people. In religion, people follow someone or someone's path. On another side, dharma is

a work of wisdom, it explained. The petitioner further said religion has been one of the most potent divisive forces in all history while dharma is different because it unites.

## **Suicide Bombings After Taliban** Takeover In Afghanistan'

'Pakistan Witnessed 500% Rise In

aretaker Prime Minister Anwaarul Haq Kakar said on Wednesday that terror attacks in Pakistan rose 60 per cent and suicide bombings by 500 per cent after the Taliban came to power in neighbouring Afghanistan.

"After the establishment of the interim Afghan government in August 2021, we had a strong hope that there would be long-term peace in Afghanistan. Strict action would be taken against Pakistan-opposing groups, especially the Tehreeke-Taliban Pakistan (TTP), and they would absolutely not be allowed to use Afghan soil against Pakistan," Kakar said at a press conference in Islamabad.

"But unfortunately, after the establishment of the interim Afghan govt, there has been a 60 per cent increase in terror incidents and a 500 per cent rise in suicide attacks in Pakistan," he said.

He said that 2.267 Pakistani citizens were killed in the past two years due to the attacks by the TTP using Afghan soil.

"During this time, 15 Afghan citizens were also among the people involved in suicide attacks. Other than this, till now, 64 Afghan citizens were killed while fighting Pakistan's law enforcement agencies during the counterterrorism campaign," he said.

Kakar asserted that the details of the attacks were in the knowledge of the Afghan interim authorities, but no action was taken against the TTP despite assurance by the Taliban.

His terse remarks come after a spate of attacks in the past week, including on Mianwali Training Air Base in the Punjab province, which was claimed by the Tehreek-e-Jihad Pakistan and the killing of soldiers in an ambush in Gwadar, claimed by the Balochistan Liberation Front.

The hardline Taliban seized power in Afghanistan in August 2021 bringing to an end the government in Kabul when the army, trained and equipped by the US and allies. melted away with a speed that surprised even the rebels.

## All About Zolgensma, The Rs 17 Crore **Injection For Spinal Muscular Atrophy**

**NEW DELHI:** A staggering Rs 17 crore for a single jab! That's the cost of one Zolgensma injection used for children under two suffering from spinal muscular atrophy (SMA), the disease and its treatment once again in the headlines over a 15-month-old boy in Karnataka staring at an uncertain tomorrow.

The gene therapy, one of the world's most expensive drugs, offers promising results but experts caution that it is not a definitive solution for the rare nerve condition that leads to muscle wasting and weakness. It can't cure but limits the progress of the disease.

Karnataka Chief Minister Siddaramaiah recently wrote to Prime Minister Narendra Modi seeking help for the treatment of a 15-month-old child

from the state diagnosed with SMA. Though it is yet to be approved in India, insiders estimate that about 90 children have received Zolgensma in



the last few years. Given that the single shot infusion is out of reach for everybody except the super-rich, most of this is through humanitarian programmes or crowd funding. The drug can be imported following a doctor's recommendation and government approval.

Worldwide, the incidence of SMA is one in 10,000 live-born babies and is the leading cause of death in the infantile age group.

"In the West, the carrier frequency - number of people carrying the gene - of the SMA is 1 in 50. In a recent Indian study, however, the SMA carrier Another study from north India found it to be 1 in 30," said Sheffali Gulati, child neurologist, All India Institute of Medical Sciences (AIIMS), New Delhi.

"The survival of children with SMA type 1 has increased recently with the availability of supportive care such as physiotherapy, nasogastric feeding (through a tube) and invasive or non-invasive respiratory care," Gulati told PTI.

As concern mounts over the incidence of the disease and the astronomical cost of the single injection, experts decode what it exactly is: WHAT IS ZOLGENSMA? Zolgensma, developed by Swiss pharmaceutical company Novartis, is designed to treat SMA, a rare genetic disease affecting motor neurons - complex circuits throughout the body that allow for movements of glands and muscles. SMA is caused by mutations in the SMN gene, leading to muscle weakness and, in severe cases, paralysis and even death.

### People Should Be Told Reasons Behind Mobile Internet Suspension: Omar

**SRINAGAR:** After mobile internet was shut in some areas of Pulwama district in Jammu and Kashmir, National Conference (NC) vice president Omar Abdullah said on Wednesday that the authorities should tell people the reasons for such actions.

Talking to reporters in Bandipora, Abdullah, a former chief minister, said he was not aware of the reason for the mobile internet shutdown.

"It would be good to let the people in those areas know the reasons behind it. People are not fools...they would not protest on such a thing, but they want to understand the reason behind stopping the services," he said.

Telecom service providers were directed to suspend mobile data within three km radius of Wampora and Hunipora areas of Pulwama from 7 pm on November 5 to 7 pm on November 8, officials said.

The suspension order mentioned the possibility of mobile data services being misused by anti-national elements, which may cause deterioration in public order.

To a question on youngsters currently in detention in various jails, Abdullah said those who do not face serious allegations should be released soon.

"We have raised this before



as well, in Parliament and at the all-party meeting with the prime minister on Kashmir (in June 2021)...that whoever has been arrested, especially after 2019, should be released. Those who do not face serious allegations, they should be released," he said.

Earlier, addressing a party workers' convention, Abdullah said only the NC will protect the rights of people and the unique identity of Jammu and Kashmir.

"The other parties only talk about development. Any government is bound to work on a developmental front. We also talk about development, but at the same time we also talk about protecting our unique identity."

"We have repeatedly said that there is no trade-off between development and our rights. Both have to go hand in hand. Our right to live with dignity is as important as our right to have basic facilities. It is only us who are working on multiple fronts," he said.

### J&K's Ex-Dy CM Muzaffar Baig Visits Mehbooba's residence

He was conferred the Padma Bhushan -- the country's thirdhighest civilian award -- the same year.

### THE JOURNEY TO ODF PLUS:



## **Erratic Power Supply**

he power situation in Kashmir remains bleak, despite the effort by the Power Development Department (PDD) to mitigate this issue by purchasing 500 megawatts of electricity from Uttar Pradesh, Erratic power supply has drawn outrage from various quarters, including trade associations, businessmen, industrialists, and regional political parties. The crisis is particularly severe during the morning and evening hours, when electricity is in high demand, affecting not only households but also students.

For the student community, the erratic power supply has been nothing short of a nightmare. With a slew of competitive exams on the horizon, thousands of aspirants are preparing in their homes and coaching centres. However, incessant power cuts have forced them to study by candlelight, as not all of them have inverters.

The Kashmir Chamber of Commerce and Industry (KCCI) recently held a press conference to vent their frustration and criticized both the government and the Kashmir Power Distribution Corporation Limited (KPDCL) for their inability to meet the electricity demands of the businesses in the Valley. However, KPDCL has attributed the power shortage to a gaping demand-supply gap. The Valley's electricity demand stands at 1600 megawatts, while the department can only produce 1100 megawatts. This shortfall is exacerbated by factors such as rainfall deficit and the consequent low discharge in river Jhelum, both of which impact electricity generation.

To address this situation, the department has implemented a curtailment schedule, with metered areas facing 4.5 hours of power cuts, and non-metered areas experiencing six hours of outages. In some parts of the Valley, power cuts extend even beyond these schedules based on electricity availability. These power cuts have disrupted daily life, inconveniencing residents and affecting economic activities.

The power crisis in the Kashmir Valley is a grim reminder of the challenges faced by the region's residents during the winter season. As temperatures drop and the demand for electricity soars, the government and the power department must collaborate to find sustainable solutions to this persistent issue.

The situation is straightforward: our region exports electricity while buying it at a high price for our own needs. It's imperative for the government to devise a strategic plan and take action to secure a regular supply of electricity, especially during the winter season. Kashmir confronts various obstacles, ranging from nature's unpredictability to infrastructure shortcomings, but these challenges are not insurmountable. With a focused and coordinated effort from the government, the region can overcome these hurdles and ensure a reliable power supply in the long run.



## The Deepfake Challenge

This video is not a one-off. Of late, there have been quite a few such fake videos. Deepfakes, as they are known, employ artificial intelligence tools to create fake images, audio and videos. The dramatic spread of Artificial Intelligence platforms has made it easier to create such persuasive deepfakes. There is a deepfake video of Ukrainian President Volodymyr Zelenskyy asking his soldiers to put down their weapons. The relative ease with which such deepfakes can be created and quickly disseminated and consumed, made possible by the wide reach of social media platforms, has become a matter of global concern. More so

in times of polarised politics. Such concerns were acknowledged at Bletchley Park in the UK last week during the first AI safety summit. The Bletchley Declaration, signed by 28 countries including the US, UK, France, China, Japan and India, noted the risks "stemming from the capability to manipulate content or generate deceptive content", and called for global action to address the potential risks stemming from AI. Across the world, countries have opted for different approaches when it comes to regulating AI. While some are in favour of strict oversight and regulation, others are veering towards a lighter touch. For instance, last week, US President Joe Biden issued an executive order to establish "new standards for AI safety and security". The order requires that companies share the results of their safety tests with the US government. It also involves the setting up of standards for "extensive" testing in order to ensure that they are safe before they are publicly released. In India, TRAI had in July outlined the broad contours a regulatory framework could take. It proposed a risk matrix (high or low risk) to classify AI use cases and also called for setting up a statutory authority and a multi-stakeholder body to advise it.

This means that such students have to spend a lot on the cost of living in such big cities as well. ## JKPSC's Rare Faux Pas

ecently, the Jammu and Kashmir Public Service Commission (JKPSC) released the result of the Combined Competitive Examination (CCE) 2023 preliminary exam which was riddled with errors. JKP-SC has earned the trust of aspirants over the years due to its efficient working. Therefore, when aspirants, such as I, found glaring errors in the final key, it came as a huge surprise to us. Over 10-12 questions in the new key have been revised incorrectly according to many serious aspirants. The errors are so obvious that they can be easily identified by sources as basic as the NCERTs. How experts have overlooked such evident errors is baffling.

Two answer keys were issued by

JKPSC for the CCE prelims examination. In the key considered final, many answers have been unexpectedly revised and are incorrect. This has played against aspirants who have found themselves out of the final selection list even after performing well in the examination.

What's important to note is that aspirants are judicious and careful in the number of questions they attempt. Therefore, 10-12 questions are decisive in their selection. Even one oversight can jeopardise their chances in an exam where each incorrect answer earns candidates negative marks. With questions being deleted and revised willy-nilly, many aspirants lose the opportunity to compete fairly.

As per media reports and aspi-

rants who have filed representations challenging the final key, JKPSC is insisting on entertaining revisions to two questions only. The passion with which the final key is being defended by JKPSC is confusing as the aspirants' challenges to the revised key agree with the first key issued by JKPSC itself. How is it that the first key was approved by experts and subsequently altered to such an extent? What qualifies the second set of experts (who have evaluated the final key) over the first set of experts (who had evaluated the first key)?

While it is normal for a few revisions to happen, how is it that such extensive revisions have been made with so many aspirants vouching for the first key with proofs?

An institution trusted by the

young in a place where opportunities don't come easy, must prioritise aspirants' concerns instead of being unnecessarily protective about its image or the fear of some extra administrative work.

It is admirable that JKPSC has been democratic and welcoming towards aggrieved aspirants. One can only hope that they remain committed to the interests of aspirants and ensure that it meets the standards it has set for itself.

# One List for All

pecies lists are one of the unseen pillars of science and society. Lists of species underpin our understanding of the natural world, threatened species management, quarantine, disease control and much else besides.

The people who describe new species and create lists of them are taxonomists. A few years ago, a headline in the journal Nature accused the taxonomic community of anarchy for not coordinating a common view of species, leading to confusion about our knowledge of life on earth.

Many in the taxonomic community took umbrage at this. Taxonomists were concerned that the ideas proposed would limit their freedom of expression and they would be tied to a bureaucracy before they could publish new species de-

Taxonomists certainly argue - disputation is essential to the practice of taxonomy, as it is to science in general. Ultimately, however, a taxonomist's life is spent trying to discern order in the extraordinarily diverse tree of life.



The results of a new survey published today in the Proceedings of the National Academies of Science, show just how much taxonomists really do like order.

### Hardly a group of anarchists

The argument was about how to solve



disagreements between taxonomists. Eventually, the two sides came together to produce principles on the creation of a single authoritative list of species.

This group then went to the taxonomic community to survey their views on whether a global species list is needed and how it should be run.

The newly published results show that a large majority (77%) of respondents – which included over 1,100 taxonomists and users of taxonomy across 74 countries – have expressed support for having a single list of all life on Earth.

They also agreed there should be a governance system that supports the list's creation and maintenance. Just what that governance system would entail is not yet specified. Deciding that will be the next step in the process.

### Taxonomists propose hypotheses, not

Why is this important? Many may not realise that when a taxonomist names a new species description, they are proposing a scientific hypothesis, not presenting an objective scientific fact.

Other taxonomists then look at the evidence provided in the description and decide whether they agree. If people making species lists judge that there is agreement about a hypothesis, the new species goes to mention misspellings on their list.

Only after a species is listed can it be protected, studied, eradicated, ignored or whatever else governments decide is appropriate. Scientists and conservation advocates also need species to be listed before they can include them in their work. Until listed, the species remains, for

all practical purposes, invisible.

However, not all lists are equally trusted. Very rarely taxonomists do go rogue. One notorious taxonomist has been blacklisted for "taxonomic vandalism". He published all sorts of new names – some even commemorated his dog - with little justification. If accepted, his field (herpetology) would have been thrown into chaos.

The work of rogue taxonomists wastes everyone's time and money. In one instance, poor taxonomy has even killed people - an antivenom labelled with the wrong name for a snake was distributed in Africa and Papua New Guinea with disastrous results.

Even without rogue taxonomists, there is an enormous problem with so-called synonyms - different people giving different names for the same species. Some species have tens of scientific names, not



This leaves users uncertain what name to use. Sometimes they use different names but mean the same species; sometimes the same names but mean different species. The only way to clarify this confusion is by having a working master list of species names linked to the scientific literature.

The newly released survey shows taxonomists and users of taxonomy have achieved an agreement that good lists need good governance. Species lists need to reflect the best science, independent of outside influence. They need dispute resolution processes. And they need involvement and agreement from the taxonomic community on their contents.

Governance of science does not work unless a large majority of scientists agree with the rules, because participation is voluntary. There's no such thing as science police.

Agreement and compliance is best achieved if scientists themselves are involved in the creation of the rules. This helps to increase buy-in among the community of peers to make sure rules are kept.

Based on the survey results, the Catalogue of Life – the group that has the most comprehensive global species list to date, and the one we're involved in – is piloting ways of measuring the quality of the lists that make up their catalogue.

These are being trialled first with the creators of lists, everything from viruses to mammals. Then, they will be tested with the taxonomic community at large for further feedback.

Good taxonomy is far more valuable than people realise. One recent study in Australia found that, for every dollar spent on taxonomy, the economy gained A\$35. The value of taxonomy globally is likely to be colossal.

But the value will be higher still if everyone the world over is able to use the same list of species.

## **Indian-Origin Researcher Uses AI To Develop Vaccine For Gonorrhoea**

A team of researchers, led by one of Indian-origin, used artificial intelligence (AI) to identify key ingredients of a vaccine for antibioticresistant gonorrhoea—a sexually transmitted bacterial infection that affects more than 80 million people worldwide every year.

Gonorrhoea has become resistant to almost all known antibiotics. That makes it notoriously difficult to treat, but if left untreated, the infection could lead to serious or even fatal complications. It also increases a person's risk of contracting HIV

In the study published in mBio iournal, researchers reported the

identification of two promising antigens as candidates for a gonorrhoea vaccine.

The researchers used an AI model called Efficacy Discriminative Educated Network, or EDEN, to identify the protective proteins.

They also used EDEN to generate scores that accurately predicted how well antigen combinations would reduce pathogenic bacterial populations of Neisseria gonorrhoeae, the microbe that causes gonorrhoea.

"To the best of our knowledge, this correlation has not been shown before," said infectious disease researcher Sanjay Ram, at the University of Massachusetts Chan Medical School.

For the study, the team applied the AI model to the proteomes of 10 clinically-relevant strains of Neisseria gonorrhoeae to predict a set of bacterial proteins that, in a vaccine, could help teach the body's immune system to recognise and fend off the bacteria.

The team tested and validated the vaccine candidates in mouse models. The group first tested combinations of two or three antigens in mice.

That analysis identified two proteins involved in cell division as promising candidates, neither of which were previously known to be exposed on the surface of the cell.

In lab experiments, blood samples taken from mice immunised with these two proteins killed bacteria from multiple strains of gonorrhoea in vitro. Those findings lined up with EDEN's predictions.

The 30-share BSE Sensex advanced by 33.21 points or 0.05 per cent to settle at 64,975.61. During the day, it hit a high of

The broader Nifty went up by 36.80 points or 0.19 per cent to close at 19,443.50 with 29 of its components closing in green and the rest 21 in red.

Among the Sensex firms, Asian Paints, Titan, Larsen & Toubro, JSW Steel, ITC, Hindustan Unilever, Maruti and Reliance Industries were the major gainers. ICICI Bank, NTPC, Infosvs, Tech Mahindra, Tata Steel and Bajaj Finance were among

the laggards. The domestic market traded rangebound with a positive

bias. And further confidence may be derived from the global market cues post the FED chair speech. Oil prices continued to fall, which will provide respite to the domestic economy and navigate a downward trajectory to inflation & fiscal," said Vinod Nair, Head of Research at Geojit Financial Services.

"Markets remained rangebound and ended marginally in the green. After the flat start, Nifty oscillated in a narrow range till the end and finally settled at 19,443.50 levels," said Ajit Mishra, SVP - Technical Research, Religare Broking Ltd.

In the broader market, the BSE midcap gauge climbed 0.78 per cent and smallcap index gained 0.60 per cent.

Among the indices, realty jumped 1.40 per cent, services climbed 1.07 per cent, oil & gas (0.96 per cent), capital goods (0.86 per cent), consumer discretionary (0.84 per cent), auto (0.80 per cent) and energy (0.77 per cent).

## Will Take India Among Top 3 Economies Of World In **My Third Tenure: PM Modi**

**DAMOH-** Prime Minister Narendra Modi on Wednesday said in his third tenure as PM, he will take the country among the top three economies in the world.

Addressing a public meeting in Madhya Pradesh's Damoh town ahead of the November 17 state assembly polls, Modi also said he will continue to fight against corruption.

People gave power to the Congress in Chhattisgarh and Rajasthan, but their chief ministers were found involved in "satta" (betting) and generating black money, he

Modi said that after 2014, the country's economy climbed to 5th position from 10th, leaving behind the UK, which ruled the country for over 200 years.

"In 2014, when we came to power, the country's economy was at the 10th position. Gradually it moved to 9th, 8th, 7th and 6th but nobody was talking about it. When it reached the 5th position and left behind the UK, which ruled the



nation for 200 years, everybody was surprised and started looking at India," he said.

Modi said during his third tenure as PM, he will take the country's economy among the top three in the world.

The Lok Sabha elections are due next year.

The PM said if the Congress comes back to power, the "85 per cent commission system' will work in the states as once stated by a prime minister of that party.

Notably, former prime minister Rajiv Gandhi had said only 15 paise of every Re 1 re-

leased by the Centre reached the targeted beneficiary,.

Modi also said that Congress leaders are saying they will complain to the Election Commission about his promise to extend for five years the free ration scheme for the poor people.

"Let them do this sin, I will continue to do good work for the people," he said.

The prime minister also said he will continue to fight against corruption and asked people whether he should do so or not, to which they replied in the affirmative.

## **Sebi Streamlines Process For Investors To Access Unclaimed Funds** In REITs, InvITs, Debt Securities

**NEW DELHI-** Capital markets regulator Sebi, on Wednesday, came out with detailed procedures for dealing with unclaimed funds of investors lying with entities having listed non-convertible securities, REITs and InvITs.

The regulator has also put in place a manner of claiming such unclaimed amounts by

The new framework will come into effect from March 1. 2024, the Securities and Exchange Board of India (Sebi) said in three separate circulars.

The move is aimed at pre-

scribing a uniform process of claim for such unclaimed funds in a streamlined manner for the ease and conve-

This came after the board of Sebi in September approved amendments to rules about the IPEF (Investor Protection and Education Fund) disclosure, real estate investment trusts (REITs), and infrastructure investment trusts (In-

Going by circulars, Sebi has defined the manner of handling the unclaimed amounts lying with REITs, InvITs, and in the escrow accounts of the listed entities (which are not companies), transfer of such amounts to IPEF and claim

thereof by the investors. Additionally, the regulator has standardised the process to be followed by a listed entity, REITs and InvITs for the transfer of such amounts to escrow accounts and by the investors for making claims thereof.

Investors may approach the debt-listed entity/ REIT/InvIT to claim their unclaimed amounts, thereby ensuring minimal disruptions in the

claim process for investors. Under the rule, any amount transferred to the escrow account remaining unclaimed for a period of seven years shall be transferred to IEPF.

## **Growth In October GST Mop-Up Due To Economic Activity: CBIC Chief**

**NEW DELHI:** CBIC Chairman Sanjay Kumar Agarwal on Wednesday said the growth in October GST collections, which is the second highest ever, is on account of economic activity and not due to show cause notices to online gaming companies.

Goods and Services Tax (GST) revenue in October grew 13.4 per cent to Rs 1.72 lakh crore.

GST collection in October is the second highest ever since roll-out on July 1, 2017. In April, the mop-up was highest at Rs 1.87 lakh crore.

"The growth in October GST collections was riding on economic activity and not because of notices that was sent (to online gaming companies). Growth has come purely on the economic activity which has taken place in the country," Agarwal told reporters on the sidelines of the DPIIT-CII National Conference on Ease of Doing Business.

The Central Board of Indirect Taxes and Customs (CBIC) has been issuing notices to companies for short payment of taxes in 2017-18 fiscal. The last date for sending notices for that fiscal was September 30, 2023. Agarwal said October GST collection was not only because of domestic GST supplies, but also due to

IGST on imports also. "The imports were healthier as compared to previous months," Agarwal said, adding the imports were healthier as compared to previous months maybe because companies were replenishing their stocks or inventories or due to the upcoming festive season.

The CBIC in September had issued notices totalling about Rs 1 lakh crore to online gaming and casinos operators in September for alleged tax evasion.

## 17 years after killing beggar to fake his death for Rs 80 lakh insurance, UP man held in Gujarat

man from Uttar Pradesh been arrested from has Ahmedabad, where he had been residing by assuming a new identity for the last 17 years after allegedly killing a beggar with the help of his family members in order to fake his own death and claim Rs 80 lakh in insurance money, said police on Wednesday.

Acting on a specific-tip off, crime branch officials nabbed the man, Anilsingh Vijaypalsingh Chaudhary, a native of Bhatta-Parsaul village in Gautam Buddha Nagar district of Uttar Pradesh, from Ahmedabad city's Nikol area, said a police release.
On July 31, 2006, the

Rakabganj police station in Agra had lodged an accidental death report after a car driver, then identified as Anilsingh Chaudhary by his father, died of burn injuries when his vehicle got gutted in a fire following an accident, said the release.

Recently, the Ahmedabad crime branch learnt from its sources that Anilsingh Chaudhary is still alive and living in the Nikol area under a new name, Rajkumar Chaudhry, it said.

After the arrest, Anilsingh Chaudhary admitted he and



his father had hatched a plan to usurp accident insurance money by staging his death. As per the plan, Anilsingh Chaudhary took an accidental death insurance policy in 2004 and then purchased a car, said the police.

Later, Anilsingh Chaudhary, his father and brothers lured a beggar, who begged for alms in trains, with an offer of food. They took the beggar to a hotel near Agra and served him food laced with sedatives, said the release.

The accused then dumped the unconscious beggar in their car and deliberately rammed the vehicle against an electricity pole to portray it like an accident. They subsequently placed the beggar on the driver's seat and set the car ablaze to show the vehicle caught fire due to the accident, said the

Anilsingh Chaudhary's father Vijaypalsingh identified the body as that of his son and cremated it in his native village in Gautam Buddha Nagar district. As per the plan, Vijaypalsingh Chaudhary claimed Rs 80 lakh in accidental death insurance of his son and distributed the sum among family members, said the police.

After collecting his share, Anilsingh Chaudhary came to Ahmedabad in 2006 and never went back to his native village in Uttar Pradesh, said the release.

He changed his name to Rajkumar Chaudhry and obtained a driving licence as well as an Aadhaar card by that name. He purchased an autorickshaw and then a car on loan to earn his livelihood, said

# Air quality in Delhi 'severe' again, farm fires major contributor

New Delhi: Air quality in Delhi and its suburbs dropped to the 'severe' category again on Wednesday with smoke from post-harvest paddy straw burn-ing in neighbouring states accounting for over one-third of the air pollution in the national

The city's 24-hour average Air Quality Index (AQI), recorded at 4 pm every day, stood at 426, worsening from 395 on Tuesday.

Several cities across the Indo-Gangetic plains reported hazardous air quality. Neighbouring Ghaziabad (384), Gurugram (385), Noida (405), Greater Noida (478) and Faridabad (425) also reported hazardous air quality.

According to data from the Decision Support System, a numerical model-based framework capable of identifying sources of particulate matter pollution in Delhi, stubble burning in neighbouring states, especially Punjab and Haryana, accounted for 38 per cent of the air pollution in Delhi on Wednesday. It is likely to be 27 per cent on Thursday.

In view of the worsening air pollution, the Delhi government on Wednesday rescheduled the December winter break of all schools, which will now be from November 9 to November 18.

Delhi Environment Minister Gopal Rai said the entry of appbased taxis into Delhi has been banned as per the Supreme



Court's order.

He also said the odd-even car rationing scheme will be implemented in the national capital after the Supreme Court reviews its effectiveness and issues an order. The matter will be next heard on Friday.

On Tuesday, the apex court questioned the effectiveness of the Delhi government's car rationing scheme, aimed at curbing vehicular pollution, and referred to it as "all optics".

Anticipating further deterioration of air quality post-Diwali, Rai had on Monday announced that the flagship scheme, which permits cars to operate on alternate days based on the odd or even last digit of their registration numbers, would be enforced between November 13 and November 20.

The government also issued

start the Connaught Place smog tower and a study to identify the sources of pollution in the capital. The two projects were unilaterally stalled by Delhi Pollution Control Committee (DPCC) Chairman Ashwani Kumar without informing the government, Rai had claimed.

According to the Ministry of Earth Sciences' Air Quality Early Warning System for Delhi-NCR, the region is likely to experience 'severe' air quality for another five to six days.

Doctors say breathing in the polluted air of Delhi is equivalent to the harmful effects of smoking approximately 10 cigarettes a day.

Prolonged exposure to high levels of pollution can cause or exacerbate respiratory problems such as asthma, bronchitis and

chronic obstructive pulmonary disease (COPD) and dramatically raise the risk of cardiovascular disease, said Rajesh Chawla, senior consultant in pulmonology and critical care at the Indraprastha Apollo Hospital.

Stringent restrictions mandated under the final stage of the Central government's air pollution control plan for Delhi-NCR called the Graded Response Action Plan (GRAP), have also been implemented in the capital.

The restrictions under Stage IV of GRAP, including a ban on all kinds of construction work and the entry of polluting trucks into Delhi, took effect on Sunday after the air quality in the city dropped to 'severe plus' (AQI above 450) levels.

GRAP categorises actions into four stages: Stage I - Poor (AQI 201-300); Stage II - Very Poor (AQI 301-400); Stage III - Severe AQI 401-450); and Stage IV -Severe Plus (AQI above 450). Unfavourable meteorological

conditions, combined with vehicular emissions, paddy straw burning, firecrackers and other local pollution sources contribute to hazardous air quality levels in Delhi-NCR during the winter every year.

According to a DPCC analysis, the capital experiences peak pollution from November 1 to November 15 when the number of stubble burning incidents in Punjab and Haryana increases.

chance of community spread if preventive measures are not implemented promptly. The symptoms of the two contagious diseases including Covid-19 and the Mumps, are similar, however swollen glands are the hallmark of Mumps caused by MuV," said Dr Nisar, who is also the President of Doctors Association of Kashmir (DAK)

He said that a patient testing positive for the virus must go for self isolation for at least three to five days to contain the spread of the highly contagious disease to other families and

"Since there are many symptoms that are similar to the Covid-19 and Mumps, it is vital that people get vaccinated against both viruses. These both might become epidemics and spread throughout communities," he added.

When asked how a patient can find if he is infected with Mumps, Dr Nisar said that blood tests and buccal swabs, which involve taking a sample of cells from inside the mouth or nose painlessly, can confirm a positive result.

The DAK president said the recommended course of treatment for Mumps includes, drinking lots of fluids, avoiding sour or acidic beverages like, orange juice and lemonade gargling with warm salt water to relieve sore

"In order to relieve discomfort and reduce swelling, he said applying hot, wet substances to the afflicted organs—such as the cheeks and jaws—are strongly advised. The most effective treatment for reducing cheek and throat edema is fomentation." he said.

Dr. Nisar also cautioned patients with mumps against poultry and red meat consumption since they are hard foods that strain the iaw and cause discomfort.

"Consume soft diet that doesn't need chewing such as bananas, soups, oatmeal, and pasta. It is recommended to stay away from citrus fruits and spicy foods as they might exacerbate pain by inducing the glands to produce more saliva. Steer clear of fatty and difficult-to-digest items, such red meat and processed foods," he suggested.

He advised the patient to stay away from work or school for a few days following the onset of symptoms, often wash hands with soap and throw away tissues when sneezing.

Leading Pulmonologist and Head of the Department at Chest Diseases Hospital Srinagar, Dr Naveed Nazir Shah said the initial symptoms of Mumps are non specific which includes fever, headache, malaise, muscle pain and loss of appetite.

"These symptoms are followed by painful swelling of the parotid glands, called parotitis, which are the most common symptoms of the Mumps. Symptoms typically occur after two weeks of exposure to the virus and resolve within two weeks," Dr Naveed told Kashmir Observer, adding about 1/3rd of patients with Mumps are asymptomatic.

He said the Mumps virus complications are rare, but if ignored, they can result in deafness and a variety of inflammatory disorders, the most prevalent of which are inflammation of the tentacles', breasts, ovaries, pancreas, meninges, and brain.

"Mumps is transmitted by exposure to someone having already contracted the virus. It is primarily transmitted by respiratory secretions, such as droplets and direct contact with an infected person. Mumps is highly contagious and spreads easily in densely populated settings. The transmission can occur from one week before the onset of symptoms to eight days after contracting the virus," he added.

Kumar who had held the post from December 2019 after his premature repatriation from central deputation, officials said

His posting in Kashmir came shortly after the abrogation of Article 370 of the Constitution and bifurcation of the erstwhile state of Jammu and Kashmir into Union Territories of Jammu and Kashmir and Ladakh in August 2019.

As the head of the Kashmir Police, Kumar is credited with bringing massive transformation in the overall security situation in the Valley by putting an end to separatist-sponsored street violence and strike culture which had become the order of the day in the militancy-hit region over the past three decades, the officials said.

Having a vast experience in anti-insurgency operations, Kumar had earlier served as Sub-Divisional Police Officer of Ganderbal, Superintendent of Police (SP), Special Operations Group Pulwama, SP Awantipora, SP Kulgam, SP Kupwara and Deputy Inspector General of Police (South Kashmir), they said.

On central deputation, he has served in the CRPF as DIG-Delhi Range, IG-CoBRA, IG-Operations and IG-Chhattisgarh sector.

The works done under his command include a new funeral and burial arrangement for slain terrorists, incident-free conduct of the first ever District Development Council (DDC) election in November-December 2020 and effective COVID-19 lockdown management, the officials said.

The handling of the situation post the death of hardline separatist leader Syed Ali Shah Geelani in September 2021, zero-killing of civilians by law enforcement agencies during law and order situations, minimum collateral damage during encounters and dramatic reduction in recruitment of youth into terrorism - from 210 in 2018 to 10 in 2023 - are some other highlights of his tenure as the Inspector General of Police, they said.

Kumar is also credited with successful conduct of the third G20 Tourism Working Group Meeting in May, Amarnath Yatra in 2022 and 2023, and allowing Muharram procession in Srinagar city after 34 years besides facilitating an incident-free Bharat Jodo Yatra' of the Congress in January, the officials said.

On the investigation front, 1,395 cases of Unlawful Activities (Prevention) Act were disposed with a disposal percentage going up to 87. The conviction in UAPA cases also started from 2021. Hundreds of terrorists and terror

associates were also arrested in the past four years, they said.

Kumar also aptly handled the situation in the aftermath of an encounter in Hyderpora locality of Srinagar in November 2021 and another at Amshipura village in Shopian district of south Kashmir in July 2020, the officials said.

Four persons were killed in the encounter in Hyderpora with families of the deceased claiming that they were civilians and not linked to any terror group, prompting police to set up a Special Investigation Team which later indicated that there was no wrongdoing on part of the security forces.

However, the killing of three men dubbed as terrorists in Amshipura proved to be a "fake encounter" with an army court recommending life imprisonment for a captain.

The Jammu and Kashmir Police had also constituted a Special Investigation Team which filed a charge sheet against three people, including the accused captain, for "staging a fake encounter"

committing the fraud since 2019 until now. The case was registered on the direction of the 30th Kurla court under Indian Penal Code sections 420 (cheating), 120-B (conspiracy), IT Act (for cyber terrorism) and the Gambling Act, the official said.

As per the FIR, the accused have defrauded people of nearly Rs 15,000 crore.

The Enforcement Directorate last week claimed that a forensic analysis and a statement made by a 'cash courier' had led to "startling allegations" that Mahadev betting app promoters have paid about Rs 508 crore to the Chhattisgarh chief minister so far, and that

"these are subject matter of investigation". Later, the BIP released a video of Shubham Soni saying he was the owner of the app and had the "proof" of paying Rs 508 crore so far to Chhattisgarh CM Bhupesh Baghel.

# Gill & Siraj Attain Top Spots In ODI Rankings

DUBAI: Indian opener Shubman Gill and pacer Mohammed Siraj on Wednesday grabbed the top positions in the batting and bowling charts, respectively, in the International Cricket Council ranking for One Day International (ODI).

While Gill replaced Pakistan skipper Babar Azam from the top of the batter's chart, Siraj displaced South Africa spinner Keshav Maharaj in the bowlers list.

Gill displaced Babar on coming back with his solid start to India's campaign at the ongoing World Cup and in the pro-cess became the fourth player from his country behind Sachin Tendulkar, Mahendra Singh Dhoni, and Virat Kohli to hold the first ODI batter ranking.

The right-hander has contributed scores of 92 against Sri Lanka and 23 against South Africa over the last week, and amassed a total of 219 runs from six innings at the ongo-



ing tournament.

Babar has totaled 282 runs from eight knocks at the World Cup and dropped six rating points below Gill into second place. His reign of more than two years as the first ranked ODI batter in the world came to an end.

Among other Indian batters, Virat Kohli has risen to fourth place following his sensational run in the World Cup, while skipper Rohit Sharma is placed sixth.

Kohli is currently India's highest run-scorer, amassing 543 in eighth innings at an av-

erage of 108.60, including two centuries and four fifties.

Kohli is one rating point ahead of third-placed Quinton de Kock of South Africa. Middle-order batter Shreyas Iyer also rose 17 spots to be placed 18th in the rankings.

Pakistan opener Fakhar Zaman (up three spots to 11th) and Afghanistan counterpart Ibrahim Zadran (up six spots to 12th) also made good ground.

Meanwhile among bowlers, Siraj rose to the top spot with his impressive effort so far in the tournament.

Siraj has grabbed 10 wickets so far in eight matches at an economy rate of 5.23 to displace Maharaj from the top.

Among other Indian bowlers, fellow Indian pacer Jasprit Bumrah has risen three spots to eighth, while Mohammed Shami jumped seven spots to be placed 10th on the chart.

Left-arm wrist spinner Kuldeep Yadav also climbed three places to be placed fourth, while fellow tweaker Ravindra Jadeja has moved up eight rungs to the 19th spot.

Bangladesh skipper Shakib Al Hasan is leading the all-rounders' chart, while Jadeja is the highest-ranked Indian at the 10th spot.

Jadeja is India's third-highest wicket-taker in the competition so far, scalping 14 wickets from eight matches at a good economy rate of 3.76, including a five-for. With the bat, he has piled up 111 runs in four innings at an average of 55.50.

## **Rain Threat Looms As New** Zealand Take On Sri Lanka

**BENGALURU:** New Zealand's campaign has hit a disheartening flatline after their early domination and the Kiwis will have to rediscover their bowling mojo for a World Cup reboot when they face knocked-out Sri Lanka here on Thursday.

Ahead of their last league match which is under rain threat, New Zealand are hobbling on eight points, aware of the fact that a defeat or a washout can throw them out of the tournament. They are now fourth on the table. Pakistan (+0.036) and Afghanistan (-0.338), who also have eight points apiece, can also potentially reach 10 points with a win over England and South Africa in their respective final league match.

In that context, the Kiwis (+0.398) have to win sufficiently big to take care of the Net Run Rate as well. So, it is not an all too bright scenario for New Zealand, but a victory will at least keep them in the race to the semifinals for the time

Unlike backmarkers England, New Zealand's batting has not really collapsed except against South Africa but their bowling lacked sting when it was needed. The Kiwis made 400 against Pakistan at this venue but their bowlers continued the rudderless ways, leaking runs in plenty and left clueless against Fakhar Zaman's onslaught. The Kiwis bowlers failed in critical thinking when the going was getting tough for them, and it was quite surprising to see even experienced bowlers like Trent Boult and Tim Southee operating without a Plan B.

An underwhelming Sri Lanka might not have similar firepower as Pakistan but unless the New Zealand bowlers regroup quickly, the Islanders still can inflict some damage as they have efficient batters in Pathum Nissanka and Sadeera Samarawickrama.

**NEW DELHI:** Glenn Maxwell has been one hell of a freak. Whether it's his breathtaking shots that leaves everyone in awe or the bizarre accidents he has met with -- snapping his knee at a house warming party and more recently, falling off a golf cart that forced him to miss a World Cup game.

Before one found a grimacing Maxwell on the ground against Afghanistan, he laid on the lawn of his friend's home for over an hour, last year. Many didn't know what was in store for him. He heard his left knee snap while playfully chasing a friend, who was also his ex-teacher. The moment he slipped and his entire body weight fell on his left leg, he knew that he had done some serious damage to his left leg. He simply couldn't get and fell, leaving a bruise on his up in fear as other friends got a makeshift tent and covered

'Maxwell has a (golf) swing of 400 metres," former Pakistan skipper Misbah ul Haq said on A Sports.

Maxwell was also a decent tennis player in his teens and hence the free swing of arms that was visible against a shell shocked Afghanistan was training of years.

Those who play golf and practice swing know that all it needs is arm extension and a swivel of hips with no feet movement when one is hitting

Those hours at the golf course did Maxwell a world of good when he couldn't move his leg due to cramps as he created a stable base and just with minimal hip movement and maximum arm speed (something that tennis players develop), hit those 10 towering sixes.

But even before Maxwell became an international superstar and months before he made his Australia debut in 2012, he was picked by Delhi Daredevils. He played only two games that year and the world hadn't really warmed up to

But those who witnessed his training sessions knew what brute strength he had. There was one training session held to mark the inauguration of the Sehwag International School in Jhajjar, Haryana.

Not many of the top line players came all the way for that session at Sehwag's boarding school but Maxwell, a junior overseas player did turn

And some of the sixes he hit that afternoon with minimal footwork was a sight to remember. One man, who got a pasting was young off-spinner named Tejasvi Yadav, who was also a part of the DD squad.

Like hitting bowlers out of the park was Maxwell's calling, Tejasvi soon found his calling in politics and now is the Deputy Chief Minister of Bihar.

## Cricket Stars Choke In Toxic Air As Pollution Shrouds World Cup In India

India's worsening smog has been called out by global cricket stars as they compete in suffocating conditions during the men's world cup, highlighting the country's noxious air ahead of its bid to host the Olympic Games.

Several large cities which are hosting World Cup matches in the past few weeks - continue to see "unhealthy" to "very unhealthy" air quality levels, according to monitoring firm IQAir. New Delhi, Mumbai and Kolkata are currently among the world's top 10 cities in air pollution.

Ahead of their match on Monday in New Delhi, Bangladesh and Sri Lanka canceled a training session over the weekend on the advice of doctors. Some players with asthma stayed at their hotel. The game went ahead even though the capital was ranked the world's most polluted major city last week by IQAir.

While India has suffered from deadly air quality for years, especially in New Delhi, the images of cricketers slogging it out in this year's toxic haze is being broadcast at a critical time. Prime Minister Narendra Modi is gearing up to lure the Olympics for the first time to the country in 2036 to bolster the country's stature much like the Beijing games did for China in 2008.

Last week, cricket captain Rohit Sharma expressed shock at pollution levels in his home town of Mumbai while speaking at a press conference. He said it was "not ideal" before a game against Sri Lanka, while voicing wider concern for the country's children.

The intervention by such an "influential figure" like Sharma is particularly significant and may help change Indian attitudes toward the country's deadly air, said Karthik Ganesan, a director at the New Delhi-based Council on Energy, Environment and Water research institute.

England's Ben Stokes was seen huffing from an inhaler during a training session in the southern tech hub of Bengaluru last month.

### 'Eating Air'

Stokes's team mate Joe Root said playing in Mumbai was like

"It just felt like you couldn't get your breath," Root told reporters a week after his team was trounced by South Africa in the city. "It was unique."

The global and local governing bodies - the International Cricket Council and the Board of Control for Cricket in India - didn't immediately respond to requests for comment.

While some people have been "kind of dismissive of it" in the past, "clearly over time there has been a change in their attitude to air pollution," Ganesan said.

Each year, the areas surrounding Delhi are swathed in dirty smog as farmers begin to burn their fields in October and November to quickly clear away rice stubble ahead of wheat planting. The region's cooler air and a lack of rain helps trap in those fresh pollutants with existing emissions.



## Hottest October Globally Marks Fifth Record-Shattering Month

Last month was the hottest October on record globally, Europe's climate monitor said Wednesday, as months of exceptional heat likely to make 2023 the warmest year in history.

With temperatures soaring beyond previous averages by exceptional margins, scientists say the pressure on world leaders to curb planet-heating greenhouse gas pollution has never been more urgent as they prepare to meet in Dubai for the UNCOP28 climate conference this month.

Drought parched parts of the United States and Mexico during October, while huge swathes of the planet saw wetter than normal conditions often linked to storms and cyclones, said the EU's Copernicus Climate Change Service (C3S).

Sea surface temperatures were the highest ever recorded for the month, a phenomenon driven by global warming that scientists say plays a key role in driving storms to be more ferocious and destructive.

"October 2023 has seen exceptional temperature anomalies, following on from four months of global temperature records being obliterated," said Samantha Burgess, C3S Deputy Director.

"We can say with near certainty that 2023 will be the warmest year on record, and is currently 1.43 degrees Celsius above the preindustrial average. The sense of urgency for ambitious climate action going into COP28 has never been higher."

The landmark Paris Agreement saw nearly 200 countries pledge to limit global warming to well below two degrees Celsius since the pre-industrial era and preferably a safer 1.5C.

These temperature thresholds will be measured as an average over several decades, rather than a single year.

This year has also seen the beginning of a warming El Nino weather phenomenon -- which warms waters in the southern



Pacific and stokes hotter weather beyond -- although scientists expect the worst effects to be felt at the end of 2023 and into next year.

October was 1.7C warmer than an estimate of the October average for the preindustrial era, Copernicus said.

Global average temperatures since January have been the highest in records going back to 1940, the monitor added, registering 1.43C above the 1850-1900 preindustrial average.

Beyond these official records, scientists say proxy data for the climate going back further -- like tree rings or ice cores -- suggests the temperatures seen this year could be unprecedented in human history, potentially the warmest in more than 100,000 years.

'Uncharted territory'
Average sea surface temperatures for the month excluding the polar regions also reached all-

time highs for October, at 20.79C.
Oceans have absorbed 90 percent
of the excess heat produced by human activity since the dawn of the

industrial age, according to scientists.

Warmer oceans are linked to an increase in the intensity of storms and the melting of crucial ice shelves buffering the vast ice sheets of Greenland and Antarctica, threatening destructive sea level rise.

A warmer atmosphere also holds more moisture, resulting in heavier rainfall.

Leaders meeting in the United Arab Emirates for the November 30 to December 12 COP28 conference will have to respond to a damning progress report on the world's Paris pledges after major scientific reports have made clear that the world is far off track.

Carbon emissions -- largely from fossil fuels -- continue to creep up when they need to be slashed in half this decade.

Just under 1.2 degrees Celsius of temperature rise above preindustrial levels has triggered a range of calamitous and costly weather extremes. People across the planet have faced heatwaves and droughts this year, while severe flooding has struck in the US, China and India and beyond.

In Canada, record wildfires partly related to climate change released more carbon dioxide than the country's total 2021 greenhouse gas emissions, according to a "State of the Climate" report published by a group of prominent scientists last month.

The report warned that humanity had veered into "uncharted territory" with warming that imperils life on Earth.

Lead author William Ripple, a professor at Oregon State University said it was likely that annual average temperatures would start to be recorded above 1.5C.

"As warming continues, we face increasing danger from amplifying climate feedback loops and tipping points such as ice sheet melting and forest dieback," he said.

"Once crossed, these tipping points could change our climate in ways that may be difficult or impossible to reverse."

## Record 7.5 Million Diagnosed With Tuberculosis Globally In 2022: WHO

New Delhi: A total of 7.5 million people were diagnosed with tuberculosis in 2022, the highest recorded since WHO began global TB monitoring in 1995, according to a report featuring data from 192 countries and areas.

The World Health Organization (WHO) 2023 Global tuberculosis (TB) report also shows that globally, an estimated 10.6 million people fell ill with TB in 2022, up from 10.3 million in 2021.

The report underscores a significant worldwide recovery in the scale-up of TB diagnosis and treatment services in 2022. It shows an encouraging trend starting to reverse the detrimental effects of COVID- 19 disruptions on TB services.

The increase in diagnosis is attributed to good recovery in access to and provision of health services in many countries, WHO said.

India, Indonesia and the Philippines, which together accounted for over 60 per cent of the global reductions in the number of people newly diagnosed with TB in 2020 and 2021, all recovered to beyond 2019 levels in 2022, it said.

"For millennia, our ancestors suffered and died with tuberculosis, without knowing what it was, what caused it, or how to stop it," said Tedros Adhanom Ghebreyesus, WHO Director-General in a statement.

"Today, we have knowledge

and tools they could only have dreamed of. We have political commitment, and we have an opportunity that no generation in the history of humanity has had: the opportunity to write the final chapter in the story of TB," Ghebreyesus said.

Geographically, in 2022, most people who developed TB were in the WHO Regions of South-East Asia (46 per cent), Africa (23 per cent) and the Western Pacific (18 per cent), with smaller proportions in the Eastern Mediterranean (8.1 per cent), the Americas (3.1 per cent) and Europe (2.2 per cent).

The total number of TB-related deaths (including those among people with HIV) was 1.3 million in 2022, down from 14 million in 2021, according to the report.

However, during the 2020-2022 period, COVID-19 disruptions resulted in nearly half a million more deaths from TB. TB continues to be the leading killer among people with HIV, it said.

The report noted that multidrug-resistant TB (MDR-TB) remains a public health crisis. While an estimated 410,000 (4.1 lakh) people developed multidrug-resistant or rifampicin-resistant TB (MDR/RR-TB) in 2022, only about two in five people accessed treatment.

There is some progress in the development of new TB diagnostics, drugs and vaccines. However, this is constrained by the overall level of investment in these areas, according to WHO.
