# **Widened Tracks Meant For Yatris, Not Vehicles: BRO**

**Srinagar:** The Border Roads Organisation on Friday said it widened the "narrow and vulnerable" tracks leading up to the Amarnath shrine to make the movement of yatris travelling on foot/palkis/ponies more comfortable and convenient.

Organisation (BRO) recently released a video that showed the first set of vehicles reaching Amarnath after the road connectivity up to the cave shrine was expanded.

"Project Beacon is involved in the restoration and improvement of Amarnath Yatra tracks. Border Roads (Organisation) personnel completed the formidable task and created history with the first set of vehicles reaching the holy cave," the BRO had said in the post on

its official handle on X. The news of vehicles reaching the cave shrine, however, triggered huge criticism. Political parties demanded a relook into allowing vehicles near the cave shrine nestled in the Himalayas and said the move would be

detrimental to the environment. In a statement on Friday, the BRO clarified that it had been

quoted in print and social media as having stated that the pilgrims visiting Amarnath would soon be able to access the cave shrine through the vehicular road.

"Rebutting the news, the BRO quoted this to be factually incorrect," the statement said.

The work assigned to the BRO for maintenance and upgradation of the yatra track by the Union Territory government in September 2022 is going on at a steady pace during the working window available, it said.

The work of widening of tracks leading to the holy cave has been undertaken in line with the directions of the Hon'ble Supreme Court of India," it added.

The Supreme Court, on a writ petition filed in 2012, inter alia issued directions for sufficient widening of the tracks to facilitate pedestrian traffic and address congestion, improvement of critical stretches of the existing track, and providing safety railings and retaining walls along the vulnerable stretches, keeping in view the environmental concerns, it added.

Jammu, Nov 10: The High Court of J&K and Ladakh has sought an additional affidavit from Commissioner Transport Secretary, Department, regarding various steps taken and use of the equipment to deal with the traffic accidents and other violations which lead

to fatal mishaps.
Hearing a Public Interest Litigation, a division bench of Justice N. Kotiswar Singh and Justice Moksha Khajuria Kazmi passed the order after perusal of an affidavit filed by the government, mentioning certain steps taken for "proper management of traffic and also to prevent accidents."

However, the court said, in the affidavit filed by

Commissioner/Secretary, Transport Department, "who is in a better position to apprise this Court about the various steps taken, these details are lacking, and, there is reference to purchase of certain equip-ments under Road Safety Measures during the financial year 2018-19.

"Since we are on the verge of the completion of year 2023, we would like to have an additional affidavit from Commissioner/Secretary, Transport Department as to the various steps taken and also purchase and use of the equipments to deal with the traffic accidents and other violations which lead to fatal accidents," the court said, adding, "Let the same be done within a period of one month." Srinagar: The High Court of I&K and Ladakh has quashed two orders under Public Safety Act, observing that if the detention order is a verbatim copy of the dossier, it speaks about "non-application of mind by the detaining authority."

Quashing tion order (No. 50/ DMK/PSA/2022), dated 25 June 2022 by District Magistrate against Ahmad Kulgam Khanday of Bugam Kulgam, a bench of Justice M A Chowdhary The referred to a Supreme Court's judgment, observing that "liberty of a subject is a serious matter and is not to be trifled with in this casual, indifferent and routine manner."

"In a case titled 'Iai & Ors. v. State of Jammu & Kashmir' reported as AIR 1985 SC 764, it has been observed that if the detention order is verbatim copy of the dossier, it speaks about non-application of mind by the detaining authority," the court said and ordered Khanday's release

forthwith provided he is not required in connection with any other case(s).

The court also quashed the detention order (No. 02/DMP/ PSA/22) dated 7 April 2022 passed by District Magistrate Pulwama by virtue of Aamir Amin Dar of Noorabad Tral was booked under PSA.

'The law is well settled that if the order of detention comes to an end either by revocation or by the expiry of the period of order of detention, there must be fresh facts for passing a subsequent order of detention," the court said,

adding, "When the detention order has been quashed by the Court, the grounds of said detention order are not to be taken into consideration either as a whole or in part even along with the fresh grounds of detention in order to pass a fresh detention order and, if such previous grounds of detention are taken into consideration while passing a fresh detention order, the order of detention will be vitiated." # **Cutting-Edge Tech Unveiled At IIT Open House: Robotic Device Detects Slippery Floors**

A robotic device to detect slippery floorings, a wearable pressure sensor to analyze gait patterns and postural deformities, an engineered microbiome and a digital microscope, are among the key technologies showcased at the annual Open House at Indian Institute of Technology, Delhi.

The 16th edition of the Open House, its flagship event for school students, was conducted on Saturday wherein some of the cutting-edge research works were displayed for them by the institute faculty and students.

"The objective of the Open House is to show school students what IIT Delhi is doing in science and technology and showcase our work in the areas that impact the real world. The whole idea of the Open House, where

interactive sessions and lectures were also organised, is to encourage school students to make informed decisions about their future," IIT Delhi Director Rangan Banerjee said.

Around 2,000 school students from more than 40 schools in the Delhi-NCR visited the Open House which exhibited an extensive collection of innovative research and product development projects.

The researchers showcased around 50 functional demos and 100 research posters highlighting cuttingedge technologies.

Kusum Saini, a PhD Scholar Vasant Matsagar (Dogra Chair and Professor) from the Department of Civil Engineering displayed a new approach developed by them for utilising solid waste like agro-residues for making sustainable and affordable homes to contribute towards the solution of problems above, and to fulfil the vision of India toward a green future, while effectively addressing the air pollution issues, making the construction practices environment friendly, and at-large ensuring sustainability and climate actions.

The Injury Mechanics Lab (DIML) has developed a novel cost-effective, portable and biofidelic floor friction tester to accurately evaluate the effectiveness of the slip resistance ability of floorings.

This robotic device mimics the actual human slipping motion and calculates the available friction during its motion. The device's structure is highly modular and is fully programmable for its slipping speeds, normal loads, and slipping angles to take into account different slipping scenarios," said Arnab Chanda, Professor at the Centre for Biomedical Engineering.

#### **Open Garbage, Biomass Burning Emits Toxic Gases, Says PCB Scientist**

Srinagar: Urgent measures are needed to stop open garbage and biomass burning as they release toxic gases contributing to air pollution and adversely affecting public health, said a senior scientist at the Pollution Control Board in Srinagar.

Dr Bilgees Ara said that according to data shared with the Central Pollution Control Board, Srinagar ranks as the fourth cleanest air city in India.

However, she stressed the importance of addressing the two primary sources of air pollution during autumn: open burning of garbage and biomass.

"Open burning of biomass and garbage introduces toxic gases into the air. with the added concern of plastic, rubber, and other harmful materials present in the waste. The emission of toxic gases contributes to air pollution, impacting the health of the general public," Dr Ara said while urging the youth to actively participate in preventing open burning and creating awareness among the public.

She said there is a need for proper ventilation in homes to mitigate the effects of indoor air pollution. Combustion pollutants released during activities such as cooking with wood can have detrimental effects on health. Major indoor combustion pollutants include carbon monoxide (CO), nitrogen dioxide (NO2), fine and ultrafine particles, polycyclic aromatic hydrocarbons (PAHs), and formaldehyde, she informed.

Dr Bilqees also mentioned the risks associated with smoking in enclosed spaces, saying toxic elements generated by smoking not only harm smokers but also pose risks to the other people present there. So, collective efforts are needed to maintain a pollution-free environment and air, she stressed

In August this year, Srinagar secured 4th position among Top Ranking Cities of India in the Swachh Vayu Sarvekshan – 2023 (Clean Air Survey) conducted by the Central Pollution Control Board, Union Ministry of Environment, Forest and Climate Change (MEFCC) under its National Clean Air Program.

Srinagar has the fourth spot among clean air cities with a population exceeding 10 lakhs. The city follows Indore, Agra and Thane City, which secured 1st, 2nd and 3rd ranks respectively.

# **Admin Conducts Surprise Inspection Of IVF Centers, Clinical Establishments**

Srinagar: District Administration Srinagar Friday undertook a surprise inspection of various Clinical establishments operating in the City in order to ensure proper regulation and operationalization of Clinical Establishments in Srinagar District and contain the mushrooming of Clinics.

The inspection was carried out on the directions of the Deputy Commissioner (DC) Srinagar, Mohammad Aijaz Asad to stop mushrooming growth of ill equipped pathological and microbiological laboratories and other clinical establishments lacking in infrastructure and technical expertise to ensure up to mark healthcare facilities to the patients in the District.

The inspection teams headed by Sub Divisional Magistrate East, Murtaza Ahmad and Sub Divisional Magistrate West, Primroze Bashir accompanied by District Health Officer. Dr Rubeena, Nodal Officer for Clinical Establishments, Dr Asifa, Zonal Medical Officers, Doctors from JLNM & Gousia Hospital, Officers from Legal Metrology, Health Department and other concerned.

During the scrutiny, the inspection team undertook a thorough inspection of various IVF Centers located at Bemina, Hyderpora, Lal Chowk, Rajbagh, Magarmal Bagh and Methen Bye pass during which the inspection teams found infirmities and deficiencies in some IVF centers. The centers were directed to complete their deficiencies and fulfill the criteria as per the medical codes and norms within a week's time failing which sealing orders will be issued against the violators.

In order to prevent any overcharging for diagnostic/ tests at these centers, the rates of different pathologic tests were also checked.

Speaking regarding the drive, the Deputy Commissioner Srinagar, Mohammad Aijaz Asad stressed on intensifying such inspections of the clinical establishments in Srinagar to ensure that such establishments are running according to laid down guidelines and regulations to the best satisfaction of the patients.

The DC urged the medical practitioners in the private sector, chemists, and druggists to strictly follow the guidelines, norms and medical ethics while discharging their professional duties and responsibilities

He also asked the Health Department to conduct frequent inspections to ensure that the rules in vogue are followed in letter and spirit by these medical establishments.

US Election Drama Drags On; Trailing Gore Wants Hand Count, Loses Faith In Machines

ASHINGTON: Republican George W. Bush's lead over Democrat Vice-President Al-Gore has been pegged at 327 votes after a final unofficial recount in Florida, prompting the Bush camp to ask Gore to concede defeat but the outcome of the US Presidential election will not be known till next week as several thousand postal ballots are expected from abroad.

Vice president Al-Gore, who the recounts showed was trailing by 327-votes to Republican George W Bush has demanded more vote recounts in crucial Florida state particularly hand counts in four of the 67 counties. Saying machines make mistakes.

Meanwhile, news reports said a court in Palm Beach had or-dered a freeze on the recount process in the county pending a hearing next week on alleged irregularities that could hurt Gore.

Three days after the voting, the election to the White House was mired in uncertainty facing legal challenges and the world yet to know as to who is the next incumbent.

The unofficial count by the Associated Press county-by-county slightly boosted Bush's tally after earlier counts had showed the margin as 225 votes. The recount shoved Bush won Florida, Bush's

communica-tion director Karen Hughes claimed in a statement in Austin, Texas, asking Gore to concede. The Gore camp hit back saying contrary to claims

by the rival side this election is not over. Again we want the true and accurate will of the people to prevail and that means the legal system to run its course. If at the end of that process, George Bush is the victor, we will respect that result, Gore campaign chair-

# **Ensuring Right To Education In J&K: Challenges And Imperatives**

**The recent** directions by the High Court of J&K and Ladakh indicate a recognition of the challenges and a call for more stringent enforcement. To truly uphold educational equity in the region, it is imperative that all stakeholders, including the government and private schools, collaborate to ensure that every child can access the education they deserve

ducation is the cornerstone of personal and societal development, serving as a powerful catalyst for positive change. Access to education ensures that opportunities are not limited by socio-economic status. gender, or other societal barriers. It is a transformative force that empowers individuals to reach their full potential. It equips them with knowledge, skills, and critical thinking abilities necessary to navigate life's challenges. Access to education provides a pathway out of poverty, enabling individuals to break the cycle of deprivation and contribute meaningfully to their communities. A society that values education for all is inherently more just and equitable.

The Right of Children to Free and Compulsory Education Act, 2009, was a pivotal step pertaining to the concept of education for all. It aimed at ensuring that every child in India, regardless of their socioeconomic background, had access to quality education. Section 12(1) C of this act mandated unaided private schools to reserve 25% of their entry-level seats for children from economically weaker sections and disadvantaged groups. It recognized education as a fundamental right and sought to ensure that all children, regardless of their economic background, had access to education. The Act aimed to eradicate illiteracy, promote inclusive education, and bridge socioeconomic gaps.

In April 2012, the Supreme Court while affirming the constitutionality of the Right of Children to Free and Compulsory Education Act, 2009, directed all schools, including those privately operated, to provide free education immediately to students from socially and economically disadvantaged backgrounds from class-I until they reach the age of 14 years. The bench, comprised of Chief Justice S H Kapadia and Justices K S Radhakrishnan and Swatanter Kumar, specified that private unaided minority schools would be an exception to the RTE Act, relieving them from the mandate that 25% of their student body must consist of boys and girls from economically underprivileged families.

As of the 2021 report from the National Commission for Protection of Child Rights (NCPCR), the specified provision has been put into practice in 16 states and Union Territories [UTs] nationwide (NCPCR, 2021). Assam, Bihar, Chandigarh, Chhattisgarh, Delhi, Gujarat, Himachal Pradesh, Jharkhand, Karnataka, Madhya Pradesh, Maharashtra, Odisha, Rajasthan, Tamil Nadu, Uttarakhand, and Uttar Pradesh have implemented this particular section.

In the Union Territory of Jammu and Kashmir, the RTE Act was extended in 2019 under section 95 and the fifth schedule, Table-1. However, its implementation has fallen short, denying underprivileged students their fundamental right to education.

Despite the RTE Act's noble objectives, it has faced numerous challenges in Jammu & Kashmir. The government and private schools have not taken adequate steps to enforce the Act's provisions, resulting in the continued exclusion of disadvantaged students from the benefits of the Act. Section 12(1)C, a provision that was intended to bring about socio-economic equality, has largely remained unfulfilled in the region. The act's implementation raises serious concerns about the government's commitment to ensuring that every child receives the education they deserve.

People from different quarters have raised their concerns over the violations of the provisions of RTE Act from time to time. In December 2022, AAP leader and former education minister Harsh Dev Singh, on Friday, voiced his concern over the failure to implement the foremost provisions of the Right to Education (RTE) Act. Highlighting the obligation of private schools under the RTE Act to enroll a minimum of 25% students from economically weaker sections (EWS), Harsh Dev

Singh expressed disappointment over the insufficient execution of these provisions by the UT administration RTE Act in J&K.

Adding to the chorus of concern in 2022, Young Lawyers Forum, filed a PIL before the High Court of J&K and Ladakh, seeking the implementation of the Act in J&K. In response to the PIL, the High Court of J&K and Ladakh, in March this year took action by ordering the government to provide a status report on the steps taken to implement the RTE Act in Jammu and Kashmir. The fact that such legal action was necessary underscores the pressing need for more rigorous enforcement of the RTE Act in the region to safeguard children's right to education and promote a more

The promising initiative of the RTE Act, designed to provide quality education to all children in India faces a critical juncture in Jammu and Kashmir. The recent directions by the High Court of J&K and Ladakh indicate a recognition of the challenges and a call for more stringent enforcement. To truly uphold educational equity in the region it is imperative that all stakeholders, including the government and private schools, collaborate to ensure that every child can access the education they deserve. Through a united effort, we can promote inclueducation and lay tion for a more equitable society.

Ensuring that every child has equal access to quality education is not just a legal obligation but a moral imperative that needs to be upheld. Addressing the challenges and extending the reach of this provision is essential for the holistic development of our nation's future generations, regardless of their socio-economic backgrounds.

# How Do We Measure Well-Being?

#### **MEASURING HAPPINESS**

One possibility is to use large opinion surveys in which individuals answer simple questions on their degree of happiness or life satisfaction. These have revealed robust patterns, confirming that economic growth has a weaker than expected effect on satisfaction, and that other aspects of life, such as health and unemployment, are important.

These simple survey measures seem credible. But according to psychologists, happiness and life satisfaction do not coincide. Life satisfaction has a cognitive component individuals have to step back to assess their lives - while happiness reflects positive and negative emotions that fluctuate.

A focus on positive and negative emotions can lead to understanding well-being in an "hedonic" way, based in pleasure and the absence of pain. Looking instead to individuals' judgements about what is worth seeking suggests a

possibility we discuss below). People judge all sorts of different things to be worth seeking.

In other words, happiness may be an element in evaluating one's well-being, but it is not the only one.

#### THE CAPABILITY APPROACH

Nobel Prize winner Amartya Sen has pointed out that understanding well-being on the basis of feelings of satisfaction, pleasure, or happiness have two problems.

The first he calls "physicalcondition neglect". Human beings adapt at least partially to unfavourable situations, meaning the poor and the sick can still be relatively happy. One striking study by a team of Belgian and French physicians has shown that even in a cohort of patients with chronic locked-in syndrome, a majority reported being happy.

The second problem is "valuation neglect". Valuing a life is a reflective activity that should not be reduced to feeling happy or unhappy. Of course, Sen admits, "it would be odd to claim that a person broken down by pain and misery is doing very well".

We should therefore not fully neglect the importance of feeling well, but also acknowledge it is not the only thing people care about.

Together with Martha Nussbaum, Sen formulated an alternative: the capability approach, which stipulates that both personal characteristics and social circumstances affect what people can achieve with a given amount of re-

Giving books to a person who cannot read does not increase their well-being (probably the opposite), just as providing them with a car does not increase mobility if there the person manages to do or to be - such as being wellnourished or being able to appear in public without shame - are what really matter for well-being. Sen calls these achievements the "functionings" of the person. However, he further claims that defining well-being only in terms of functioning is insufficient, because well-being also includes freedom. His classic example involves

nally dealing with trade-offs requires having one single ultimate measure. Adherents of the capability approach who succumb to this thought often mistrust individual preferences and apply instead a set of indicators that are common to all individuals.

So-called "composite indicators" - like the United Nations' Human Development Index, which adds together consumption, life expectancy and educational performance

Some people think that hard work is necessary to have a valuable life while others prefer to spend more time with family. Some think that going out with friends is key, while others prefer reading a book in a quiet place.

The "preference-based" perspective starts from the idea that people are better off when their reality matches better what they themselves

consider to be important. Preferences thus have a



undernourished individuals. The first person is poor and cannot afford food; the second is wealthy but chooses to fast for religious reasons. While they achieve the same level of nourishment, they cannot be said to enjoy the same level of well-being.

Therefore, Sen suggests that well-being should be understood in terms of people's real opportunities - that is, all possible combinations of functionings from which they can choose.

Beyond the subjective approach and the capability approach, a third perspective the preference-based approach to well-being – takes into account that people disagree about the relative importance

This does not coincide with subjective life satisfaction. Recall the example of patients with the locked-in syndrome reporting high levels of satisfaction because they have adapted to their situation. This does not mean that they would not prefer to have their health back - and it certainly does not mean that citizens without locked-in syndrome would not

One example of a preference-based measure, advocated by the French economist Marc Fleurbaey, directs people to choose reference values for all non-income aspects of life (such as health or number of hours worked). These reference values will depend on the individual: everyone probably agrees that not being ill is the best possible state, but a workaholic lawyer is likely to place a very different value on work hours than someone with an arduous and hazardous factory job.

Fleurbaey then suggests that people define a salary that, combined with the nonincome-based reference value, would satisfy the individual as much as their current situation.

The amount by which this "equivalent income" differs from the person's actual workbased income can help answer the question: "How much income vou would be willing to give up for better health or more free time?"

Some psychologists are sceptical about preference-based approaches because they assume that human beings have well-informed and wellconsidered ideas about what makes a good life. Even if such rational preferences exist, one struggles to measure them because these are aspects of life – family time, health – that are not traded on markets.

#### **DOES ALL THIS MATTER IN** PRACTICE?

The following table, compiled by the Belgian economists Koen Decancq and Erik Schokkaert, shows how differing approaches to well-being can have practical consequences.

It ranks 18 European countries in 2010 (just after the financial crisis) according to three possible measures: average income, average life satislent income" (taking into account health, unemployment, safety and the quality of social interactions).

Some results are striking. Danes are much more satisfied than they are wealthy, while France is the opposite. These large divergences are not seen when comparing equivalent incomes, however, which suggests that satisfaction in these two countries is heavily influenced by cultural differences.

Germany and the Netherlands also do worse on satisfaction than on income, but their equivalent income rankings confirm that they do relatively worse on the nonincome dimensions.

Greece has a remarkably low level of life satisfaction. Cultural factors may play a role here, but Greece is also characterised by high income inequality, which is not captured by the averages in the table.

These differences among various measures of wellbeing hint at the important issues involved in deciding which measure of well-being - if any - to select. If we want to use the measure to rank nations' performance at providing well-being, then we will be pulled towards a single, simple measure, such as subjective happiness. If we seek to keep track, for policy purposes, of whether individuals are doing well in the respects that really matter, we will be pulled towards a more multi-dimensional assessment, such as that offered by the capability approach. And if we are most impressed by disagreement among individuals as to what matters, we will have reason to understand well-being along the lines suggested by the preference-based approach.

After the handing over of the yatra tracks by the Union Territory government in September 2022, the BRO has undertaken the work on widening the tracks in many stretches, improving the gradients, providing stronger safety railings and retaining walls on vulnerable stretches, keeping in view the environmental concerns, it added.

"This contributed to substantial improvement in satisfaction level of the yatris, and making the movement of vatris on tracks safer," it said.

In order to continue with the work, which could not be completed before the last yatra, the organisation, by engaging men and machinery, has widened many remaining portions of the tracks that were narrow and vulnerable, the BRO said.

"This will make the movement of yatris visiting the holy shrine on foot/ palkis/dandies and ponies more comfortable and convenient," it added.

"The SSEB will keep our jawans safe at a temperature of 18-19 degrees at altitudes where it drops up to minus 45 degrees, while a drone service to take medicine and eatable supplies to high altitude BOPs will not just be immensely useful for our personnel but also for people living in the border village. It is a great new beginning," Shah

For the first time in the history of ITBP, the prime minister has approved seven battalions together for the force. which four will shortly be deployed, he said.

# SIA Searches House Of Key Accused In Poonch

JAMMU: The Jammu and Kashmir Police's Special Investigation Agency (SIA) on Friday searched the house of a key accused in a narco-terror module case in a hamlet near the Line of Control in Poonch district, officials said.

A SIA team had taken accused Mohmmad Iqbal, who was arrested from Himachal Pradesh's Mandi district in October, along with it to Karmara, they said.

The case pertains to cross-border smuggling of arms, explosives and narcotics into Poonch, the officials said.

Three accomplices of Iqbal were caught with a huge cache of arms, explosives and narcotics near the border fence in Poonch's Karmara area on the intervening night of May 30 and 31, they said. Iqbal was at large since then.

He had fled from the area, and using technical surveillance as well as

intelligence inputs, it was found that he was hiding in Mandi district, the officials said and added that he was arrested by SIA in October.

The handler of the module, Mohmmad Javed, who was also absconding, was arrested on August 19 by the SIA in an operation in Delhi. This further led to the arrest of another accused, Liyaqat, on August 25 from Poonch, they said.

So far, six arrests have been made in the case and forward and backward linkages of the module are being established, they said.

Mohd Zubair (22) were arrested and an AK assault rifle, two pistols, six grenades, a 10-kg IED and 20 packets of suspected heroin, which they were trying to smuggle into the country, were seized.

The accused persons were intercepted by army personnel and there was an exchange of fire between them, in which a soldier and a terrorist had suffered injuries.

The SIA had also conducted raids at several places in Poonch for three consecutive days from July 26 to 28, following the recovery of seven kg of heroin, more than Rs 2 crore cash and a pistol along with some ammunition from the house of a drug smuggler Rafiq Lala in Danna Doyiyan area of Sathra on March 3.

Lala was arrested under the Public Safety Act (PSA). However, the SIA tool his remand on July 1 for questioning over his alleged links across the border.

**SRINAGAR:** In Jammu and Kashmir, the Aggregate Technical and Commercial (AT&C) loss of Power Development Department is one of the highest in India—causing a gap between power purchase cost and revenue realisation.

Currently, the AT&C losses are of the order of 50 percent against the national average of 19.73 percent. The official documents states, "The AT&C losses of J&K Power Development Department are one of the highest in the country."

"The present AT&C losses are of the order of 50 percent against the national average of 19.73 percent. Due to these losses, the gap between power purchase cost and revenue realisation is huge," it reads. It further said that there was a high cost of power supply to the exchequer due to the scattered and remote location of Households.

The document states that

in Jammu and Kashmir, a substantial quantum of electricity is lost as electrical efficiency (I^2R) loss leading to high cost of power supply.

"Due to the existence of long Low Tension (LT) lines carrying electricity to distant and scattered households over mountain tops, a substantial quantum of electricity is lost as I2R loss leading to high cost of power supply," it reads.

It also states that the electricity demand was surging in the UT of J&K with a continual growth of around 8-10 percent year on year, attributable mainly to the rapid pace of urbanisation and addition of a large number of households through recent electrification schemes.

The document further reveals that the upsurge in the usage of electronic and electrical appliances and improvement in the standard of living was also adding to the electricity demand in Jammu and Kashmir—(KNO

#### DAK Urges Admin To Start Heating System In Kashmir Hospitals

**SRINAGAR:** Urging Jammu and Kashmir (JK) administration to start heating system in Kashmir hospitals, Doctors Association Kashmir (DAK) on Friday said patients are shivering with cold as heating systems of hospitals have not been started yet.

With temperatures dipping, DAK President Dr Nisar ul Hassan said patients face huge inconvenience as heating systems of hospitals are not operational yet.

Dr Hassan said lack of heating in hospitals is putting the lives of patients at risk.

"Cardiac and Stroke patients in hospitals are at increased risk of death as cold thickens blood and constricts the arteries," he said.

"Even the condition of Asthmatics and patients with Chronic Obstructive Lung Diseases worsens in hospitals because of cold conditions," he added.

The DAK President said the cold conditions in hospitals increase the risk of expectant mothers having premature delivery.

"Children and elderly are especially prone to hypothermia that can lead to respiratory and cardiac dysfunction and even death," he said.

Dr Nisar said it is difficult for doctors, nurses and paramedical staff to work in cold conditions especially during night hours when temperatures fall sharply.

"The majority of the peripheral hospitals are without inbuilt central heating systems and they rely on traditional heaters without vent which do more harm than good to patients," he said.

# Pakistan Take On England With Impossible Task At Hand

KOLKATA: Nothing less than a miracle will help Pakistan as they face a near-impossible task of making the semifinals by winning an unthinkable margin, while a charged-up England will look to qualify for the Champions Trophy when the two sides clash in the World Cup here on Saturday.

New Zealand's net run-rate boosting five wicket-win over Sri Lanka has virtually shattered Pakistan's semifinal hopes. The 1992 champions now have to beat England by an improbable margin.

New Zealand's NRR is +0.743 while Pakistan's is +0.036, and for the Babar Azam-led side to eclipse the former to qualify as the fourth side, it has to win by around 287 runs batting first. While chasing, Pakistan need to win with 284 balls to spare. That is an impractical task. For defending champions England, the World Cup title defence dream may have been over for quite a sometime now but the Jos Buttler-led side will aim to finish inside top-8 to



Champions Trophy.

As things stand, it's a fourway race with Bangladesh, Sri Lanka and the Netherlands also in the mix with England.

Their 160-run win over the Netherlands in the last match has given the down-and-out England the much-needed late charge as they have climbed up to the seventh spot and face the easiest equation among the four teams.

A win against Pakistan should seal the spot, considering that both Bangladesh and the Netherlands face tough opponents in Australia and India respectively, and also have inferior NRRs than

# **South Africa Wrap Up WC Group Stage With** Win Over Afghanistan

AHMEDABAD: South Africa saw off a spirited fightback from Afghanistan to win by five wickets in their final World Cup group game and consolidate second place in the standings. South Africa have 14 points from their nine games, two points ahead of Australia who play Bangladesh on Saturday. Both South Africa and Australia have already qualified for the semi-finals.

Afghanistan wrapped up their best ever World Cup campaign with four wins and also sealed a place in the Champions Trophy. Afghanistan opted to bat first and posted 244 in 50 overs on the back of Azmatullah Omarzai's unbeaten knock of 97, which included seven boundaries and three sixes, while Gerald Coetzee was the pick of the South African bowlers with figures of 4-44.

In response, South Africa opener Quinton de Kock set up the chase with a breezy 41 that took him to the top of the tournament's scoring charts on 591 runs. Rassie van der Dussen (76 not out) then guided the Proteas home, stitching together a 65-run partnership with Andile Phehlukwayo, who smashed the winning runs with a massive six over deep mid wicket in the 48th over.

# Palestinian Football Team Prepares For WC Qualifying Games Against A Backdrop Of War

GAZA: Makram Daboub may be struggling to prepare his Palestinian team for the start of 2026 World Cup qualification but he takes some comfort, for now at least, that his players stuck in Gaza are safe.

The national football team's head coach wanted to include Ibrahim Abuimeir, Khaled Al-Nabris, and Ahmed Al-Kaved in a training camp in Jordan ahead of World Cup qualifying games against Lebanon next Thursday and Australia on Nov. 21.

But they were unable to make it out of Gaza because of the Israel-Hamas war, now in its second month. "So far they are fine," Daboub told The Associated Press. "Many of their relatives have died, however, as a result of the bombing."

Two players from Gaza, Egypt-based Mohamed Saleh and Mahmoud Wadi, are expected to join the Palestinian team in Jordan.

Daboub, who is from Tunisia, acknowledged it will be difficult for players to focus on football while many have families in danger.

"With the death and destruction in Gaza, the players are in a difficult psychological state," Daboub said.

But for Susan Shalabi, the vice-president of the Palestine Football Association, there's no question that the players and the people want the games to go ahead.

"This is a people that wants to be heard and seen by the rest of the world, wants to live normally like everyone else, so people care about their national team," Shalabi told The AP. "It represents the yearning to be recognized as a free and sovereign nation."

The Palestine Football Association became a full member



of FIFA, football's international governing body, in 1998 and has had some success at the re-

Appearing at the World Cup in 2026 would be a dream for a team that has never come close to reaching the finals via the

Asian Football Confederation's qualifying route.

There is a little more hope this time as Asia's automatic

qualification allocation has increased from four places in 2022 to eight in 2026, when the tournament will be cohosted by the United States, Mexico and Canada.

The Palestinian team, which reached a highest FIFA ranking of 73 in 2018, appeared at the Asian Cup in 2015 and 2019 and has qualified for the 2023 continental tournament coming up in Qatar.

'There is no match that you can win in advance," Daboub said. "But we have a good chance of reaching the next round of the World Cup qualifiers."

To be among the 18 teams that advances into that next stage of Asian qualifying, the Palestinians need to finish in the top two of a group containing Australia - expected to take first spot - Lebanon and Bangladesh. They're currently ranked No. 96, eight places higher than Lebanon and 87

above Bangladesh.

Palestine had initially been drawn to host Australia to start this round of qualifying, but t he game has been shifted to a neutral venue in Kuwait.

Preparations have already been interrupted as players were unable to leave to participate in a tournament in Malaysia last month. Now the team is based in Jordan to be sure of being able to travel for games.

A win against Lebanon in the United Arab Emirates next week - the game has also been moved from Beirut because of security concerns - would be a huge step toward the next stage.

"We will do our best," Daboub said. "Football is the most popular game in the world. It brings people together. We aspire to achieve good results and qualify to show the Palestinian identity and that this is a people who deserve
