And the most important and imperative thing is that peace is to be maintained. Establishing peace is not only the job of police force or administration. For this, citizens too have an important role to play," Sinha said.

'Admin Committed To Eliminating Terror Ecosystem'

The Jammu and Kashmir administration is committed to eliminating the terror ecosystem in the Union Territory, Lieutenant Governor Manoj Sinha said on Thursday during a meeting to review security measures. Sinha's statement came during a meeting here to review the security situation and development projects in ten districts of the valley. "Chaired a high-level meeting in Srinagar today to review the security and development scenario in all 10 districts of Kashmir Division," the office of J&K LG posted on X. The LG said the Jammu and Kashmir administration is "committed to eliminating the terror ecosystem and ensuring inclusive and progressive development" of the Union Territory, the post added. According to reports, the meeting was aimed to finalise the 'winter strategy' to be adopted by the security agencies during the winter months—'November to March'. #### Panel To Probe Deadly Bus Crash In Doda Press Trust Of India

Jammu: The Jammu and Kashmir administration has setup a three-member panel to probe the circumstance leading to the bus accident in Doda district even as one more passenger succumbed to injuries, taking the death toll in the incident to 39, officials said Thursday.

ficials said Thursday. The bus skidded off the road and rolled down into a 300-foot gorge in Doda district on Wednesday.

Twenty injured passengers were admitted to a hospital where one of them succumbed to injuries late Wednesday night.

Divisional Commissioner Ramesh Kumar said a committee has been constituted to inquire into the circumstances leading to the accident near Assar in Doda district.

The committee shall inquire into the incident and furnish a detailed inquiry report to his office within a week, officer said.

The members of the committee are Dr Ravi Kumar Bharti, additional district magistrate (ADM), Doda, superintending engineer and assistant road transport officer.

Locals have blamed frequent accidents in the area to bad conditions of roads in the district coupled with rash driving and overloading of vehicles.

**'Nearly 60% J&K Colleges Lack NAAC Accreditation'**

"Out of 147 colleges, presently 59 colleges have already been granted National Assessment and Accreditation Council (NAAC) accreditation," reads an official document.

The Kashmir University was awarded with 48th rank and Jammu university with 66th rank among the top 100 universities in the country as per India rankings 2021 university MoE for Gol.

Evidence suggests that smoking influences the body's ability to regulate blood sugar levels, which can cause type-2 diabetes, the WHO said in a statement.

Type-2 diabetes one of the most prevalent chronic diseases worldwide, accounting for over 95 per cent of all diabetes cases, the UN agency said.

However, it is often preventable, and factors that contribute to developing type-2 diabetes include being overweight, not getting enough exercise, and genetics, according to the WHO.

The IDF estimates that 537 million people have diabetes, a number that continues to rise making diabetes of diabetes and, if they have the ninth highest cause of diabetes, help avoid complideath globally, the statecations. ment said. The IDF is a non-

essential safeguards against the onset and progression of this and many other chronic diseases." said Ruediger Krech, WHO's Director of Health Promotion. November 14 is observed as the World Diabetes Day.

## Save wetlands

s we head into winter, Kashmir's wetland reserves are witnessing the arrival of migratory birds from across the world. Flying across continents, they seek refuge from the winter harshness of their habitats. And this has been happening over centuries. Last year alone, around twelve lakh migratory birds descended upon these waters.

The birds, coming from places like Siberia, China, the Philippines, Eastern Europe, and Japan, start arriving in October, seeking respite from extreme cold conditions. The wetlands of Kashmir, including Hokersar, Wular Lake, Haigam, Shalbugh, among others, become bustling habitats for these visitors until March when they return to their homelands.

But the birds face two challenges: one, the threat of poaching and second, the vanishing wetlands. has been a concern for both the migratory birds and the Wildlife Department. Efforts have been made to mitigate this threat, with increased vigilance and regular checks conducted to curb illegal hunting activities. Measures to maintain adequate water levels in the wetlands have also been undertaken to ensure a conducive environment for the visiting birds.

A recent report from the Government of India has revealed that between 2006 and 2018, Jammu & Kashmir lost over 2372 kanals of precious wetlands. This loss equates to more than 120 hectares and signifies a grave environmental challenge. The wetland ecosystems in Kashmir, including Dal Lake, Anchar, Wular, Haigam, Shallabugh, Narkara, and Hokersar, have suffered a drastic reduction in size over the years. These waterbodies, once revered as "nature's kidneys," are now at the brink of extinction.

Hokersar wetland, hailed as the 'queen wetland of Kashmir' and designated as a site of international importance under the Ramsar Convention in 2005, has lost 5.75 square kilometers of its area over the last forty years.

And this should be a cause for deep concern. As for poaching, the Wildlife Department should mount increased vigilance and periodic crackdowns to prevent it. But saving wetlands themselves calls for a much broader effort. The government needs to adopt comprehensive measures to safeguard vital ecosystems. To start with, we need an immediate and concerted action to counter the factors contributing to their decline, something that has been absent so far.

The recent designation of Shallabugh and Haigam as Ramsar sites offers some hope as it signals international acknowledgment and commitment to protecting these fragile habitats. However, mere recognition is not enough. It demands concerted efforts, collaborative action, and stringent measures to stem the tide of degradation.

kraine's ambitions of joining the European Union (EU) received an important boost on Wednesday 8th November, when the bloc's executive body said detailed negotiations on Ukraine's membership should begin next year.

A recent EU report has said that the so-called accession talks should finally start; 18 months after the EU accepted Ukraine as a candidate state. The same report recommended that the process should also begin with Moldova, which borders Ukraine.

On Wednesday 8th November, EU President Ursula von der Leven said: "Today is a historic day, because today the Commission recommends that the Council opens accession negotiations with Ukraine and with Moldova.<sup>3</sup>

Ukraine has long held ambitions to join the EU. In 2013, then-President Viktor Yanukovych was ousted after weeks of street protests when he decided to scrap a trade deal with the EU and instead shift towards Russia, this was followed in March 2014 by Russia's illegal annexation of Crimea. Historically, the aim of joining the bloc - along with NATO - has formally been part of Ukraine's constitution since 2019.

Ukrainian President Volodymyr Zelensky, who applied for EU membership in February 2022, shortly before Russia invaded his country, welcomed Wednesday's announcement.

Zelensky said that history of Ukraine and the whole of Europe has taken the right step. Despite all the difficulties, we are moving forward. And although Ukraine welcomed Brussels' suggestion that talks are open and it fully expects the 27 EU member states to agree and adopt the position later this year, the recommendation comes with some caveats that will be hard for Kyiv to comply with at this moment, particularly around the issue of fighting corruption.

cial and military support, their support for Ukraine joining Western institutions like the EU and NATO, many European officials have privately expressed wonder at precisely how long Europe has not only remained focused, but also not torn itself apart on the issue, as reported by the CNN.

Remarkably, Ukraine has had what the European diplomat described as "our undivided attention" for the best part of two years.

Since February 2022, Zelenskyy has become a master at using the media to further his political aims. He has been able to persuade various Western governments to supply Ukraine with more weapons, ammunition and money for the defensive campaign against Russia using the moral pressure of defending the Ukrainian citizens.

This sentimental sale has resulted in Ukraine getting many advanced armaments, which might not have been possible in the peaceful time, such as heavy artillery, modern air defence systems, Leopard 2 tanks and even F-16 fighter jets - all weapons systems whose delivery to Ukraine had previously seemed unfathomable.

Significantly, Ukrainian officials have been concerned that lately global and in particular the U.S. attention has shifted from Ukraine to the Middle East since the Hamas attacks on Israel on 7th October

This trend could be noticed in the manner in which President Joe Biden has requested a further \$106 billion from Congress for Israel, Ukraine and the Pacific Rim. But the Republicans have put a spanner in his plans, Mike Johnson, the new speaker of the House, has agreed to wave through \$14 billion for Israel, but hasn't released even a single cent for Ukraine. Similarly, in the Senate, the Republicans only want to release the money for Kyiv if the U.S. government tightens its rules for asylum-seekers. In reality any end to U.S. aid would be no less than a disaster for Ukraine. Its army is suffering from huge shortages after more than 600 days of war. At the moment Kyiv's list of priorities are weapons for air defence – from portable devices

including Stinger missiles to stateof-the-art missile defence systems like Europe's Iris-T. Artillery and electronic warfare equipment to defend against Russian drones are also urgently needed in this war of attrition.

Commenting editorially on the development The Guardian commented editorially, that responding to recent talk of "war fatigue" in the west, President Volodymyr Zelenskiy recently acknowledged the gruelling nature of the attritional conflict that has been forced on Ukraine by Vladimir Putin. Nevertheless, he added, he was confident that support for Ukraine in its struggle against Russian forces remained robust.

The Guardian's editorial further opined that this view was vindicated on Wednesday, when Ms von der Leyen recommended that the European Union begin membership talks with Ukraine. This was a necessary and much-needed act of solidarity - all the more so at a time when international attention is focused on the tragic events in the Middle East.

This is due to the fact that traditionally the U.S. can't leave Israel, one of its most staunch allies, alone at this juncture, as this may transform into a completely reworked geopolitical scenario in the region with its accompanied global impact, and which the U.S. could least afford at present, with President Joe Biden facing one of the most crucial times of his presidency, with attacks from the liberal elements throughout the country accompanied with the Republican offensive for the next year's presidential elections.

## Life over death

t is disappointing that the parliamentary committee that examined the Bharatiya Nyaya Sanhita (BNS), the proposed criminal statute likely to replace the IPC, has not made a recommendation to abolish the death penalty. Instead, the standing committee on Home Affairs, despite submissions from experts and jurists on abolition, chose to make a bland recommendation "that the matter may be left for the government to consider". Its observation is limited to a remark that it "has understood that the reason for a passionate argument against the death penalty is that the judicial system can be fallible and to prevent an innocent person from being wrongly sentenced to death". However, domain experts had made some persuasive submissions before the panel: that instances of trial courts awarding death were on the rise, whereas statistical trends showed that the Supreme Court of India was leaning away from capital punishment; that social scientists had demonstrated it had no deterrent effect and that global opinion was in favour of its abolition. The Court awarded the death penalty to only seven people from 2007 to 2022, while all death sentences were either set aside or commuted to life in 2023, as they did not fall under the "rarest of rare cases"

Members who added notes of dissent to the report also highlighted the argument that capital punishment has been shown to be no deterrent; that imprisonment for the remainder of the convict's natural life will be a more rigorous punishment and provide scope for reform; and that most of those on death row came from underprivileged backgrounds. They have also made the point that the three Bills proposing a new body of criminal law are substantially the same as the existing IPC, Code of Criminal Procedure and Evidence Act. If at all, Parliament moves to enact the draft Bills, with changes suggested by the parliamentary panel, it will be in the fitness of things if it is used as an occasion to reconsider the need to retain the death penalty. The BNS has defined 'life imprisonment' as a term for the remainder of one's natural life, and this should be the default alternative to death sentences. The case for abolition will gain strength if the trend of seeking premature release of life convicts on political grounds is arrested and life terms without remission become more common. Remission should be a humanitarian act and never a source of political controversy. Removing capital punishment from the statute book and introducing a rational and universal remission policy will be a substantive reform in the justice system.

young woman, just out of college, is teaching at my son's play school. She works from 10:00 - 3:00 pm. Young toddlers such as mine are very difficult to handle and one would think that these teachers would be compensated fairly for their work. Would you believe me if I say that these teachers who take care of so many toddlers and give a full working day worth of time every single day a week in every month. are paid as low as three thousand rupees a month!

While we often applaud teachers for their dedication and contributions to society, it is disheartening

to witness the exploitation of these educators, particularly in the critical early childhood education sector.

Play schools serve as the foundation for a child's educational journey, where teachers play a pivotal role in shaping young minds. However, the teachers in Srinagar's play schools are facing dire financial circumstances due to inadequate compensation. Most of these play schools aren't even registered! These educators, responsible for nurturing the intellectual and emotional growth of our children, are often subjected to meager salaries that do not align with the value of their work

Low wages not only lead to fi-

nancial stress for teachers but also hinder their ability to provide quality education. Underpaid teachers may struggle to make ends meet, resulting in reduced motivation and, ultimately, a decline in the quality of early childhood education. This vicious cycle affects the very foundation of a child's learning experience.

It is essential for the government, educational institutions, and society as a whole to recognize the significance of early childhood education and the vital role teachers play in it. Adequate compensation is not only a matter of fairness but also an investment in the future of our children. Well-paid and motivated

teachers are more likely to deliver high-quality education, ensuring that our youngest learners receive the best possible start in their educational journey.

I urge the relevant authorities and stakeholders in Srinagar to address this issue promptly by implementing fair compensation packages for play school teachers. ## How Iran's 'National Poet' Hafez Shirazi **Captivated Hearts Worldwide With His Verse**

urrounded by mighty trees and beautiful orchards lies the mau-Soleum of Hafez Shirazi in the cultural capital of the Islamic Republic of Iran, Shiraz. The 'national poet' of Iran is resting peacefully, visited by legions of his devotees from across the world everv dav.

While I was lost in deep thought staring at his grave, a rosy-cheeked boy came rushing and insisted that I consult Hafez for divination and promised that the poet would provide answers to my questions.

Hafez is not confined to Hafezieh, the up-scale area where his final resting place is situated in Shiraz, but seeped into the everyday life of Iranians, young and old, urban or rural.

At every place and on every important occasion, Iranians consult the Persian poet's masterpiece 'Divan e Hafez' to seek answers, help and guidance. The poet never disappoints.

Poetry, in particular, that of Hafez. occupies a significant place in Iranian society. This art form is an important part of the lives of all Iranians.

From the crowded streets of Tehran to the sleepv hamlets of Khorasan, from the vast deserts of Yazd to the dense forests of Mazandaran, poetry resonates everywhere.

A taxi driver reciting Maulana Rumi, a baker quoting Khayyam, or a doctor using verses of Saadi to communicate an idea to his patients is a common sight in Iran.

However, among all Persian poets, Hafez occupies a special place for Iranians.

They not only consult him to foresee their future through "Faal-e-Hafez" (augury), but the poetry of the celebrated poet has had a lasting influence on great people, including the founder of the Islamic Revolution, Imam Khomeini.

Khawaje Shams-u-Din Mohammad Hafez Shirazi was born in 1315 in the city of Shiraz. Having memorized the Holy Quran at a young age, he was bestowed the title of "Hafez".

The spiritual enlightenment that Hafez attained and personified traveled beyond the borders of Iran and influenced the great minds of the world, in both the East and the West.

Reciting the poetry of the master lyricist in Persian acts as a soothing balm for parched souls. For many, his poetry is a rendezvous with nature where the whistling of the breeze, the songs of the birds, the murmuring of the streams of water, and the whole orchestra of nature help them enjoy the joy of life.

#### HAFEZ AND THE WEST

The influence of Hafez extends far beyond contemporary Iran. The poetry of the Nightingale of Shiraz has had a hypnotic influence only on the East, but his verses also inspired poets in the West.

Founding oriental studies as an academic field, the prominent orientalist, Joseph von Hammer Purgstall, translated the Diwan e Hafiz in 1846. The translated work inspired Goethe to create a collection of poems titled The West-Eastern Divan.

The poetry of Hafez led Goethe, the legendary German philosopher, to call him "Saint Hafiz" and a "Celestial Friend", as it oozes with spiritualism and asceticism.

For Goethe, Persian poetic language

reached its zenith in the verses of Hafez in whom he was able to find the magnificence of ideas and the view of the world he had been searching all his life.

Inspired by Goethe's West-Eastern Divan, a number of German poets, including Friedrich Ruckert and August von Platen, composed poems on the model of Ghazal.

Hafez's poetry is considered the very epitome of the Ghazal tradition.

Prominent among the German thinkers fascinated by Hafez was Friedrich Nietzsche, who repeatedly mentioned him in his seminal works.

Nietzsche was deeply interested in Hafez and praised him as an ideal poet and spent many years reading his works. The Persian poet appears almost a dozen times in the writings of Nietzsche.

"Nietzsche praised Hafez for 'mocking blissfully'. For him, Hafez is the Oriental free-spirit man who keeps celebrating the joys and sorrows of life. Nietzsche commends such an attitude as a sign of a positive and courageous valuation of life." writes Dariush Ashouri, a prominent Iranian thinker

According to Ashouri, Nietzsche finds in Hafez a prime example of 'Dionysian' ecstatic wisdom, which he extols extensively in his philosophy.

In a poem dedicated to Hafez, Nietzsche glorifies the insight of the Persian poet and his poetry.

"The tavern you have built with your hand is far greater than any house, the wine you have made therein all the world fails to imbibe, the bird which was once called the phoenix is now dwelling in your house, the mouse which gave birth to a mountain is yourself, you are everyone and no one," he writes.

"You are the tavern and the wine you are the phoenix, the mountain and the mouse you keep pouring in yourself, and you keep filling with yourself the deepest valley you are the brightest light you are the intoxication of all intoxication you are what need do you have to ask for

wine.

For Sir William Jones, the famous British philologist, the poetry of Hafez was a form of meditation on divine perfection. The first poem of Hafez to have appeared in the English language was translated by Jones in the eighteenth century.

The poem was titled "A Persian Song" and played a significant role in introducing the bard of Shiraz to the Englishspeaking world.

According to the famous German orientalist Annamarie Schimmel, Hafez is like a pure decorated jewel with endless colors. His words are not restricted by time, but he is a poet who has crossed the limitations of time and space and is universal belonging to all times.

However, as per Schimmel, understanding Hafez is not easy as he uses a secret language, and only those who can understand the culture of Hafez can understand him and his poetry.

While discussing Hafez and his poetry in a conversation with the Press TV website, Sonia, a French student of Islamic studies said, "The knowledge of God is essential for the attainment of love."

"Even prayer without love is meaningless, Hafiz teaches us to love and perfect our prayer," she said.

The influence of Hafez stretched from Europe to America, when Ralph Waldo Emerson, the famous American poet and philosopher got acquainted with Hafez. While introducing the Persian poet, Emerson described him as "the prince of Persian poets.'

"His extraordinary gifts add to some of the attributes of Pindar, Anacreon, Horace and Burns...He accosts all topics with an easy audacity," Emerson writes.

"He fears nothing. He sees too far; he sees throughout; such is the only man I wish to see and be."

According to mystics, God created the world as a mirror to reflect His grandeur and glory. For Hafiz, the whole world with all its diverse forms and phenomena is a manifestation of God.

Praising the acclaimed lyricist Emerson said, "Leave him but a corner of nature, a lane, a den, a cowshed ... he promises to win to that scorned spot the light of the moon and stars, the love of man, the smile of beauty, and the homage of art."

Under the influence of Hafez's Saki-Nameh, the American philosopher poet wrote Bacchus, which is widely regarded as one of the finest poems in English literature.

"I find Hafez to be a poet of penetrating insight into the true nature of reality. His poetry is masterful, combining literary excellence with experiential wisdom." American Ph.D. scholar of mystic studies said in a conversation with the Press TV website.

Hafez in Indian sub-continent Hafez's literary reputation reached the

Indian subcontinent during his lifetime. One of the oldest manuscripts of

Diwan-e-Hafiz preserved in an Indian library shows that Humayun and Jahangir, the Mughal emperors of India, frequently consulted it for faal.

Abul-Fazl, author of Akbarnama, writes that Divan-e-Hafez was one of the main books read in the court of the Mughal emperor Akbar.

Praised as an incomparable master of the Ghazal tradition, this genre of literature which conquered new heights in the Urdu language was hugely influenced by the Ghazals of Hafez Shirazi.

Shahab Ahmed, a Pakistan-American scholar of Islam referred to Hafez's Divan as "the most widely-copied, widely-circulated, widely-read, widelymemorized, widely-recited, widelyinvoked, and widely-proverbialized book of poetry in Islamic history."

In the sub-continent, the verses of the great Persian poet and thinker have also been written in amulets to get spiritual benefits and ward off evil forces.

Hafiz is still read and still loved in India, which is evident from the fact that Dr. Balram Shukla, Director of the Swami Vivekananda Institute Tehran, has translated parts of Divan-e-Hafez into Hindi language.

"In India, previous generations could enjoy Hafez from the original Persian, hence we don't find its translations in Indian languages," Dr. Shukla said in a conversation with the Press TV website.

"But now as Persian is not very much in vogue in India, it is our duty to translate these magnum opuses into our languages, otherwise our new generation would be deprived of these great minds."

#### **Russian artist who** protested Ukraine war gets 7 years in prison in latest crackdown on free speech

Tallinn: A Russian court on Thursday convicted an artist and musician for swapping supermarket price tags with antiwar messages, sentencing her to seven years in prison in one of the highest-profile cases involving the recent crackdown on free speech.

Sasha Skochilenko was arrested in her native St. Petersburg in April 2022 and charged with spreading false information about the military after replacing price tags with ones that decried Russia's invasion of Ukraine.

"The Russian army bombed an arts schools in Mariupol. Some 400 people were hiding in it from the shelling," one read. Another said, "Russian conscripts are being sent to Ukraine. Lives of our children are the price of this war."

A customer at the supermarket who found the slogans reported them to authorities.

Skochilenko's arrest came about a month after authorities adopted a law effectively criminalising any public expression about the war that deviates from the official Kremlin line. The legislation has been used in a widespread crackdown on opposition politicians, human rights activists and ordinary citizens critical of the Kremlin, with many receiving lengthy prison terms.

Skochilenko, 33, has not denied replacing the price tags but rejected the accusation of spreading knowingly false information. She did not intend to disparage the military, but

rather wanted to stop the fighting, her lawyer Yana Nepovinnova told The Associated Press last week.

"She is a very empathetic, peace-loving person. To her, in general, the word war' is the most terrible thing imaginable, as is the suffering of people," Nepovinnova said.

Russian independent news site Mediazona quoted Skochilenko as saying in her final statement in court on Thursday that the case against her was "weird and ridiculous" so much so that officials in the facility where she is detained "open their eyes widely and exclaim: Is this really what people are being imprisoned for now?"

She also alleged that an investigator working on her case even quit his job, telling one of her lawyers that he "didn't join the Investigative Committee to work on cases like (the one) against Sasha Skochilenko."

## Delhi's air quality severe, vehicular emissions largest contributor

New Delhi: Delhi's air quality worsened within the severe category on Thursday as unfavourable meteorological conditions hindered the dispersion of pollutants.

Recent findings from a joint project by the Delhi government and IIT-Kanpur found that vehicular emissions accounted for about 38 per cent of the capital's air pollution on Wednesday. This reduced to 25 per cent on Thursday.

Secondary inorganic aerosols -- particles such as sulfate and nitrate that are formed in the atmosphere due to the interaction of gases and particulate pollutants from sources like power plants, refineries, and vehicles -- is the second major contributor to Delhi's foul air, accounting for 30 to 35 per cent of the air pollution in the city over the last few days.

Calm winds and low temperatures are allowing accumulation of pollutants and relief is unlikely over the next few days, an official at the India Meteorological Department (IMD) said.

An improvement in the wind speed November 21 onwards might bring air pollution levels down, he said.

Delhi's 24-hour average Air Quality Index, recorded at 4 pm every day, stood at 419 on Thursday. It was 401 on Wednesday, 397 on Tuesday, 358 on Monday and 218 on Sunday, 220 on Saturday and 279 on Friday.

Noida (340), Noida (355) and Faridabad (424) also recorded very poor to severe air quality.

An AQI between zero and 50 is considered good, 51 and 100 satisfactory, 101 and 200 moderate, 201 and 300 poor, 301 and 400 very poor, 401 and 450 severe and above 450 severe plus.

Delhi's air quality dropped over the last few days despite the state government implementing stringent measures, including a ban on construction work and the entry of dieselguzzling trucks into the city, to control pollution.

According to IQAir, a Swiss company that specialises in air quality monitoring, Delhi was the most polluted city in the world on Thursday, followed by Baghdad and Lahore.

A system developed by the Pune-based Indian Institute of Tropical Meteorology to identify the contribution of different pollution sources showed stubble-burning accounted for 7.5 per cent of the air pollution

all the departments involved in the enforcement of pollution control measures and submit a report to the government daily, Environment Minister Gopal Rai told reporters.

Earlier this week, Rai had said the city government may implement the odd-even car rationing scheme if the AQI crosses the 450 mark.

The government last week postponed the implementation of the scheme, which permits cars to operate on alternate days based on the odd or even last digit of their registration numbers, after a notable improvement in the city's air quality due to rain on Friday.

Doctors say breathing in the polluted air of Delhi is equivalent to the harmful effects of smoking approximately 10 cigarettes a day.

Prolonged exposure to high levels of pollution can cause or exacerbate respiratory problems such as asthma, bronchitis and chronic obstructive pulmonary disease (COPD) and dramatically raise the risk of cardiovascular disease, they said.

Unfavourable meteorological conditions, combined with vehicular emissions, paddy-straw burning, firecrackers and other local pollution sources, contribute to hazardous air quality levels in Delhi-NCR during winters.

According to a Delhi Pollution Control Committee (DPCC) analysis, the city experiences peak pollution from November 1 to 15, when the number of stubble-burning incidents in Punjab and Haryana increases.

## **Gaza Evacuated Kashmiri Woman Looking Forward To Her Homeward Journey**

**CAIRO:** After being evacuated from war-torn Hamas-ruled Gaza with the help of Indian missions in the region, Lubna Nazir Shaboo is now looking forward to her homeward journey from Cairo to Kashmir. Lubna, an Indian from Jammu & Kashmir living in Gaza, and her daughter Karima had crossed the Rafah border on Monday evening and

reached the Egyptian capital the next day. "I safely crossed over from Gaza at the Rafah border and am now awaiting my return to Kashmir." Lubna Nazir Shaboo

told PTI from Cairo. She said the return journey plan was in the works.

She profusely thanked the Indian diplomatic missions in the region -- in Ramallah, Tel Aviv, and Cairo -- for making the evacuation possible from the war-torn area. Soon after the Hamas-Israel conflict broke out on October 7, Lubna reached out to PTI on October 10 seeking help.

Lubna's one son and one daughter have been studying in Cairo. Soon after she reached Cairo,

the Indian Embassy in Cairo tweeted along with a photo of the Indian ambassador to Egypt Ajit Gupte with Lubna and her daughter: "Amb @Ajit-VGupte received Mrs Lubna Nazir Shaboo, Indian national who has just arrived safely in



Cairo, after being evacuated from Gaza. She and her family are in good health. Mrs Lubna expressed deep gratitude to @ indembcairo, @indemtel and @ROIRamallah for their assistance (sic).

She also shared a video with PTI, which she had recorded at the Rafah border after reaching the Egyptian side.

The situation was too bad in Gaza. We did not have water, electricity or internet and the telecommunication was too bad. We went through a very bad phase over there. The situation is worsening day by day. There are people who are dying every day and there are people who are injured and there are dead people who are also lying under the debris."

"There is a scarcity of everything. Food supplies, medicines. There is no medical care. Hospitals are out of service. Bombardment is happening everywhere," she said in the video and added: "I hope that this video will reach the

people and it will convey the message that Gaza is getting choked by every second.

"There is no phone, there is no electricity. There is no in-ternet and on Thursday, they are going to declare Gaza to be out of any telecommunication service. There will be no communication anymore. And we will not be knowing what is going on in Gaza anymore. Gaza is in a very bad situation (sic)," she described.

Narrating the conditions in the Gaza Strip, pounded by Israel after the October 7 Hamas attack, and how babies, children, women, and civilians in general have been killed, Lubna said, "We don't know what more is going to happen in the coming days. There is hope that this thing will stop at once and pray for peace in this place."

More than 11,000 Palestinians have been killed in the Gaza Strip since Israel began attacks after Hamas attack killed over 1200 Israelis.

KISHTWAR: When Saksham and his younger brother Riksham left home with their mother on Wednesday to return to school in Jammu, no one in their family could have imagined it would be their last journey together.

While Saksham, 14, and his mother Ashu Devi died after their bus fell into a 300-ft-deep gorge in Doda, Riksham, 11, is fighting for his life in the district's Government Medical College (GMC) Hospital.

The young boys' father Ajay Parihar, an exserviceman and a Sena Medal awardee, is shattered and numb with shock.

Ajay's elder brother said on Thursday that Saksham and Riksham had come home to attend his daughter's wedding.

"After attending the wedding, they were returning to Jammu to annear for their exams " he

added.

Another relative of the family, Suresh, said Ajay wanted his sons to join the Army. Ajay wanted to give his sons the best education and they were studying in a premier institution

## **Battle-Hardened By Tough Win Over** NZ, India Await Final Test

MUMBAI: Unbeaten India passed their first real test in the World Cup in the semi-final against New Zeaand on Wednesday and the hosts will hope that the win over their bogey team will make them battlehardened for the final.

India arrived at the Wankhede Stadium, where they lifted their second and last World Cup trophy in 2011, looking invincible, winning all nine round-robin matches without any stiff challenge, including a fourwicket win over New Zealand. But then the Black Caps had also ended India's strong run at the same stage of the 2019 edition while Kane Williamson's team also beat them in the inaugural World Test Championship final two years ago.

India had also exited the 2015 edition of the 50-over World Cup at the semi-final stage with a defeat to Australia.

"Today being the semi-finals, I wouldn't say that there was no pressure," India captain Rohit Sharma told host broadcaster Star Sports, adding that the team wanted to treat the match as just another roundrobin game.

"Whenever you play the game, there is always pressure, and obvi-ously, semi-final adds a bit of extra there. But I think the guys were doing the job."

As Daryl Mitchell and Williamson grew in confidence during their third-wicket stand of 181 during New Zealand's chase of 398, the stadium



went silent while millions of fans across the country probably won-dered if the Black Caps would be the cause of another heartbreak for India.

"It was important to stay calm. At one point, the crowd went absolutely silent, that's the nature of the game," Sharma said. "But we knew that we had to pull something up from our sleeves and need a magic, either a good catch or a run out or maybe a magic delivery."

Fast bowler Mohammed Shami provided that touch of magic with 7-57 - the best figures by an Indian in an one-day international and also his third five-wicket haul in the tourna-

ment taking him to the top wickettakers list with 23. India looked uncharacteristically sloppy on the field

against New Zealand, with Shami dropping a fairly simple catch off Williamson, Ravindra Jadeja giving away overthrows and the hosts also muddling up run-out opportunities.

Sharma will be hoping that his team leave the mistakes behind as they head Ahmedabad for Sunday's final where they will meet Australia.

"We knew there would be pressure on us at some stage. We just had to stay collected. That's what we did. We were very calm even though we were sloppy in the field," Sharma said.

"But that can happen. We've got nine perfect games on the field. So these things are bound to happen. But I'm glad that we could get the job done in the end."

**SHARJAH:** Palestine drew 0-0 with Lebanon on Thursday in a World Cup qualifier played without fans in the United Arab Emirates due to the Israel-Gaza conflict. The match had been scheduled to be played in Beirut but Israel's response to the attack by Hamas on Oct. 7 caused officials to switch the match to Sharjah.

The whole Palestinian team wore traditional keffiyeh, chequered black and white scarves, before the national anthems and there was a minute's silence for those killed in the conflict before kickoff. Despite starting official training only four days ago, the Palestinians started the game well.

Yet Lebanon captain Hassan Maatouk had the first chance after 12 minutes, with his longrange shot going wide, before Atta Gaber responded for the Palestinians with a header on the half-hour mark that went over. Karim Darwish missed a good chance for Lebanon three minutes into the second half and Palestine, ranked 94th by



FIFA, had a Tamer Seyam shot of the nine groups advance saved by Lebanon goalkeeper Moustafa Matar.

Lebanon's Ali Al Haj shot into the side netting after 87 minutes before Matar saved Dabbagh's close-range shot with his out-stretched leg in the final minute. This week's matches marked the start of the second phase of qualifiers for the expanded 48-team 2026 World Cup, when Asia will have eight guaranteed berths plus a possible ninth available through an intercontinental playoff.

Before the game, Palestinian midfielder Mohammed Rashid had said the team would give their best.
