Srinagar: At a time when people in Kashmir are grappling with severe electricity crisis, the Jammu and Kashmir government's solar energy project has come out as a viable option to reduce burden on the hydroelectricity and to provide hassle-free electricity supply to the people

Introduced by the Jammu Kashmir Energy Development Agency (JAKEDA)

rooftop solar plants are garnering an exceptional response within the Union Territory, especially Kashmir Valley which faces acute power crisis with the onset of winter.

Under Ministry of New & Renewable Energy (MNRE), GoI's Phase - II rooftop solar scheme, domestic electricity consumers across the UT can install rooftop solar power plant at subsidized rates (1-10 kW capacity)

of India and 25% from UT administration), resulting in a substantial reduction in energy bills for residents.

"The scheme reduces the burden on the Power Distribution Transformers as the energy is produced at the consumers end, thus preventing frequent faults in transformers," an official from JAKEDA told Kashmir Observer.

"It also supplements energy generation which in turn reduces power curtailment hours. It also customises the

Solar Power Plants as per consumer's energy requirement to completely off-set the monthly electricity bills," he added.

To avail the facility, he said, the consumers can apply online through the web portal www.jk.ahasolar.in following which the system will be installed through JAKEDA empanelled vendors to avail the offered subsidy.

# PDD Withdraws 15% Electricity Duty In Its Revised Tariff

Jammu: In a strategic move to alleviate the impact of a 15% tariff increase, the Jammu and Kashmir Power Development Department (PDD) on Friday announced the withdrawal of Electricity Duty (ED) in its revised power tariff.

The decision, effective from 1st December 2023, comes following the issuance of a new tariff order by the Joint Electricity Regulatory Commission (JERC),

Jammu & Kashmir. The JERC, after thorough consideration and adherence to standard procedures, implemented a 15% tariff hike while maintaining fixed charges at their existing levels, an official spokesperson said Friday. Notably, the revised overall tariff rate remains below the actual procurement cost incurred by the corporations in supplying power to consumers, he said.

"To safeguard consumers from an increase in their electricity bills, the J&K government has taken a proactive step by withdrawing the 15% ED previously applied to energy charges in the existing tariff structure. This calculated decision ensures that the overall impact on consumers' electricity bills is nullified," he added.

spokesperson said that a sample calculation for a domestic consumer consuming 500 units per month reveals energy charges of Rs. 2185 (calculated at Rs. 3.80 per unit, plus 15% Electricity Duty), fixed charges of Rs. 40, resulting in a total electricity bill of Rs. 2225.

In comparison, he said, the new tariff for 2023-24 sees an increase in energy charges to Rs. 2175 (calculated at Rs. 4.35 per unit), maintaining fixed charges at Rs. 40, resulting in a total electricity bill of Rs. 2215.

"Notably, despite the 15% tariff increase, the withdrawal of the 15% Electricity Duty en-Giving an example, the sures no increase in the final electricity bill for consumers,"

#### **'2400 MWs Electricity Procured** To Meet Demand'

crisis in the Valley, the government on Friday said that the Lieutenant Governor has given approval for the procurement of 2400 MWs of electricity from NTPC and Solar Power Corporation of India. "The power demand in Jammu and Kashmir has increased and at present it is 3200 MWs while the in house generation availability is only 1350 MWs. This issue has been witnessed every year in the winters as the demand usually goes up during this period," Principal Secretary, **Power Development Department** (PDD), H Rajesh Prasad said while addressing a news conference in Jammu. He added that the power generation in our own houses usually decreases during winters. "At present it is 85 per cent lower compared to the summer season. In summers, we had a power generation of 1050 MWs in June-July, but now it is

only 150 MWs. It is because of

Srinagar: The mercury rose above freezing point at most places in Kashmir last night as residents got respite from cold and fog, officials said on Friday.

Srinagar, the summer capital of Jammu and Kashmir, recorded a minimum temperature of 0.9 degrees Celsius, the officials said.

They said the minimum temperature stayed above freezing point in the city for the first time

Bandipora, Baramulla, Ganderbal, Kokernag, Kulgam and Kupwara also recorded minimum temperatures between zero degrees Celsius and 1.7 degrees Celsius.

Pahalgam tourist resort in south Kashmir Anantnag district was the coldest recorded place in the valley at minus 3.3 degrees Celsius, followed by Shopian where mercury settled at minus 2.5 degrees Celsius.

Gulmarg ski resort in north Kashmir recorded a low of minus 2.0 degrees Celsius.

The weatherman attributed the rise in minimum temperature last night to the arrival of a western disturbance that is expected to affect the system.

The rise in temperature has resulted in a reduction in early morning fog.

## Indian Doctors Call For Raising Surveillance, Hygiene Measures

New Delhi: Amid a cluster of pneumonia cases in China. Indian doctors have called for increasing surveillance as well as hygiene measures, if such situation arises in the country.

A recent post on ProMED Mail, the online reporting system of the International Infectious Society for Diseases, reported China experiencing a major pneumonia outbreak with no known cause in children. It said the outbreak, causing symptoms such as high fever, and some developing pulmonary nodules is overwhelming paediatric hospitals in the country.

On Thursday, the Union Health Ministry noted that it is "closely monitoring the



reported outbreak of H9N2 cases and clusters of respiratory illness in children" in northern China.

"There is low risk to India from both the avian influenza case reported from China as well as the clusters of respiratory illness," said a statement from the ministry.

It added that the country is prepared for any exigencies that may emerge from the current influenza situation in China. Doctors, however, called

for educating the public on preventive measures such as hand hygiene, influenza vaccinations, while "maintaining composure".

"Únlike Covid, which predominantly affected adults, the new pneumonia outbreak in China raises concerns about a potential vulnerability in children. Given the limited information available, it is essential to prioritise preventive measures such as hand hygiene, influenza vaccinations, isolating affected children. and using face coverings,' said Sachin Kumar, Senior Consultant, More on P10



## **Physicists Detect Second-Most Powerful Cosmic Ray From Beyond Our Galaxy**

esearchers have detected the second-most powerful cosmic ray to have come from outside our galaxy. But the exact origin of this "ultra-high-energy" particle from outer space remains a

mystery. Observed in Utah, this is believed to be the most powerful cosmic ray detection since the 'Oh-My-God' particle in 1991 that left physicists puzzled.

Named 'Amaterasu' particle after the sun goddess in Japanese mythology, the second-most powerful cosmic ray has energy

equivalent to "dropping a brick on one's toe from waist's height", the international team of physicists mentioned in their study published in the journal Science.

The energy of the particle was measured at 2.4 x 10<sup>2</sup>0 electron Volts (eV) and was detected on May 27, 2021, the researchers said.

Cosmic rays are charged particles like protons or electrons travelling through the universe at nearly the speed of light. The charged particles could be remnants of celestial events that have broken down matter to its subatomic constituents.

Because the particles are charged, their flight path resembles a ball in a pinball machine as they zigzag against the electromagnetic fields through the cosmic microwave background, the researchers said.

Referring to 'Amaterasu', John Matthews, study co-author said, The particles are so high energy, they shouldn't be affected by galactic and extra-galactic magnetic fields. You should be able to point to where they come from in the sky."

This research was conducted at the Telescope Array at the University of Utah (US), which was also witness to the discovery of the highest-energy cosmic ray ever in 1991 during the 'Fly's Eye' experiment. Dubbed as the 'Oh-My-God' particle, the most

powerful cosmic ray shocked astrophysicists as it was believed that nothing in our galaxy had the power to produce it and it was theoretically not possible for cosmic rays travelling to Earth from other galaxies.

The scientists said they are yet to find a "conventional explanation" for these events and believe that this rare phenomena might pertain to particle physics unknown to science.

"But in the case of the Oh-My-God particle and this new particle, you trace its trajectory to its source and there's nothing high energy enough to have produced it. That's the mystery of this..." said Matthews.

Particles with 'Oh-My-God' and 'Amaterasu' energy blast through intergalactic space were relatively unbent. Only the most powerful of celestial events can produce them, the team said.

"Things that people think of as energetic, like supernova, are nowhere near energetic enough for this. You need huge amounts of energy, really high magnetic fields to confine the particle while it gets accelerated," said Matthews.

Analysing the cosmic ray composition for clues of its origins, the researchers said the 'Amaterasu' particle is likely a proton, owing to its relatively unbent trajectory.



## **Employees AT SKIMS Bemina Experience 'Work-Stress'**

#### Medical Superintendent Orders 'Psychiatric' Checkcup

Majid Nabi

Srinagar: The medical superintendent of SKIMS Medical College Bemina has ordered a psychiatric checkup of employees for their personal as well as the wellbeing of patient care, since the strain of staff members has escalated, resulting in 'psychiatric breakdown'.

An excessive workload, disagreement with superiors or coworkers, or impending deadlines might cause a decline in job performance, anxiety and despair among the staffers, according to a psychiatrist at the Psychiatric Hos-

Stress-related issues, he said, are reported from all hospitals where patient traffic remains high and the pressure on staff is severe.

The Medical Superintendent of SKIMS Medical College Bemina in an official communiqué to the Head of the Department (HoD) Psychiatry has claimed that the frequency of work-related stress has been high in the hospital.

"It has been observed that the employees of the hospital side are having stress symptoms at work, the frequency seems at the higher rate as is evident from various episodes that are happening on a day to day basis," reads MS's letter, dated November 18, 2023.

Muzaffar Jan, secretary to the Medical Superintendent, SKIMS Medical College Bemina told Kashmir Observer that a periodic psychiatric examination is a standard practice to ascertain an employee's mental health.

"These kinds of drills happen occasionally, so there's no need to freak out. Employees too are humans and experience stress occasionally for a variety of reasons, that does not always indicate that the issue is more serious. We still review the order tomorrow to see what needs to be done," he added.

#### **Follow Orders If You Want To** Do Business In India: Delhi High **Court To Domain Name Registrars**

**NEW DELHI:** The Delhi High Court on Friday cautioned domain name registrars (DNRs) against non-compliance of judicial orders and said if they want to do business in India, then they should follow its directions on taking action against those indulging in illegal activities online, or run the risk of being "blocked" by

A bench headed by Acting Chief Justice Manmohan said DNRs cannot "become instrument of syndicating scams" and called upon them to "remain vigilant" in the face of misuse of known trademarks to register websites to carry out illegal and fraudulent activities.

'If you have to do business in India, we will lay guidelines and you have to comply. We will lay down a mechanism.. These (DNRs) people have to comply. We can't allow millions to be cheated. Some serious matter is going on here," said the bench, also comprising Justice Mini Pushkarna.

The court observed that there was a huge magnitude of business in the country for DNRs who cannot be allowed

to become "scam units".

"We can't change the international system but if you operate in India,we will ask you to follow certain (norms).. We will tell MEITY (Ministry of Electronics and Information Technology) to block the DNR if you don't comply," it said.
The court's observations

came while dealing with a case initiated by it on its own in relation to the issue of misuse of trademark of several entities through fraudulent websites and the role of DNRs in such situations.

The court said that filing of repeated cases by aggrieved parties, whose trademarks are illegally used by offenders for registering their websites, has to stop and the DNRs should look into preventing registration of such offending domains in the first instance.

The court made GoDaddy and the Ministry of Home Affairs parties to the proceedings and listed the matter for further hearing on January 9.

"You are a major player. You know when fraud is taking place," the court told GoDadday's counsel, adding that the entity should "think about" the concerns raised by it during the hearing in the

#### **Board Games, Cards, Yoga** For 41 Trapped Workers In **Uttarakhand Tunnel**

UTTARKASHI/DEHRADUN: Rescuers plan to provide board games and playing cards to the 41 workers trapped inside the Silkyara tunnel for 12 days as the operation to evacuate them continues to get disrupted by multiple delays, an official said on Thursday.

Late on Thursday, boring through the rubble of the collapsed tunnel was put on hold again, apparently after cracks appeared in the platform on which

Dr Rohit Gondwal, one of the psychiatrists at the rescue site, told PTI, "We are planning to provide ludo and chess boards and playing cards to help them labourers) relieve (trapped stress. The operation is getting delayed and it appears that it will take some more time." He said all 41 workers are fine but need to stay healthy and mentally fit.

The latest obstacle came hours after the rescue operation resumed earlier in the day, following a six-hour delay to cut through an iron girder that came in the way of the auger machine late on Wednesday.

This is the third time that the drilling exercise has been alted since the multi-agency rescue mission began on November 12 after a stretch of the under-construction tunnel in Uttarakhand's Char Dham route collapsed.

Officials said the rescuers have managed to drill the rubble up to 48 metres. However, another 10 metres remain to be covered to allow the trapped labourers to be evacuated.

A team of a dozen doctors, including general physicians and psychiatrists from Uttarkashi and Dehradun, are stationed at the site.

## Israel, Gaza Begin Four-Day **Ceasefire After Nearly 7 Weeks Of Bloody War**

GAZA/ISRAEL BORDER: The first İsraeli women and children hostages due to be released under the first ceasefire deal of the war with Hamas were being freed on Friday, Israeli TV channels reported, and Thailand said 12 Thai workers were also released.

Israeli media reported that the Israeli hostages had been handed to the Red Cross and to an Egyptian security team. Reuters could not immediately confirm this.

Thai Prime Minister Srettha Thavisin said in a social media post that the 12 Thai workers had been released from captivity in Gaza. A source briefed on the negotiations said the release of the Thais, who were all men, was unrelated to the truce negotiations and followed a separate track of talks with Hamas mediated by Egypt and Qatar.

Under the terms of the fourday Israel-Hamas truce, 13 women and children out of around 240 hostages captured by Hamas fighters on a killing spree in southern Israel on Oct. 7 were expected to comprise the first group to be released.

They had been due to be freed with the aid of the Red Cross and an Egyptian security team at 4 p.m. (1400 GMT), nine hours after the start of the ceasefire, and to be flown

home under military guard. In exchange, Israel was due to release the first 39 Palestinians from its jails on Friday, among them 24 women and 15 teenagers.

A total of 50 hostages and 150 Palestinian prisoners are to be freed under the fourday truce, though Israel has said the ceasefire could be extended if Hamas continues to

## What Is The Humanitarian **Situation In Besieged Gaza?**

**GENEVA:** Israel and Hamas started a four-day ceasefire in Gaza on Friday with aid agencies hoping to use the pause in fighting to ramp up aid deliveries into the besieged enclave. Shortages of food, fuel,

drinking water and medicines have worsened in recent weeks and U.N. agencies have warned of mass disease outbreaks that could cause death rates to surge. Parts of northern Gaza has been cut off from outside help for weeks, with one U.N. spokesperson describing it as a "hell on earth".

Over 1.7 million people of Gaza's population of 2.3 million are estimated to be internally displaced. Of them, about 1 million are staying in at least 156 shelters run by the U.N. Palestinian refugee agency (UNRWA), according to the U.N. humanitarian office (OCHA).

Shelters are overcrowded and at more than four times capacity, with tens of thousands of civilians having fled south to escape the bulk of Israeli bombardments in recent days. However, the south has



also been hammered by Israeli air strikes that have killed and injured non-combatants.

Most displaced men and older boys are sleeping in the open, next to the external walls of the shelters. Some families have pitched tents outside a shelter in Khan Younis, OCHA said. **HOSPITALS** 

None of the hospitals in northern Gaza are functioning normally due to bombardments and lack of fuel. OCHA says that only eight of 11 facilities in the south are functional and only one of them can perform complex surgery, according to the World Health Organization (WHO).

The WHO says it has been asked to help evacuate three northern hospitals and plans are underway.

The number of premature births has risen by almost a third in Israeli-besieged Gaza over the past month as moth ers suffer growing stress and trauma, according to Oxfam. **AID DELIVERIES**

#### Kerala Man Arrested For Threatening To Blow Up **Mumbai Airport**

MUMBAI: A Kerala resident was arrested by the Maharashtra Anti-Terrorism Squad (ATS) on Friday for allegedly threatening to blow up the Chhatrapati Shivaji Maharaj International Airport here if he was not paid "one million US dollars in Bitcoin", an official said.

The ATS started a probe after the Mumbai International Airport Limited, which operates the airport, received a threatening email in its feedback inbox at 11.06 am on Thursday, the police official said.

"This is a final warning to your airport. We will blast Terminal 2 in 48 hours unless one million US dollars in Bitcoin is transferred to the address. Another alert will be after 24 Hrs." the email read.

A First Information Report (FIR) was registered under Indian Penal Code sections 385 (putting a person in fear of injury in order to commit extortion) and 505 (1) (b) (statements made with intent to cause fear or alarm to the public or against the public tranquillity) at the Sahar police station.

The ATS cyber cell, which started a parallel investigation, traced the IP address from which the email had been sent to Kerala, following which a team flew to the southern state and arrested the accused.

He was being brought to Mumbai and would be handed over to Sahar Police, the official said without disclosing the accused's identity.

## Panchayat, Assembly Polls **Should Be Held With LS Elections: AJKPC**

**SRINAGAR:** The All Jammu and Kashmir Panchayat Conference (AJKPC) on Friday said the panchayat and Assembly elections should be held simultaneously with the Lok Sabha polls in the Union Territory.

"The panchayat elections should be held in Jammu and Kashmir before January 9 to fulfil the constitutional and democratic requirements. Elections should be held simultaneously for the panchayats, Assembly and the Parliament," president of the panchayat conference Anil Sharma told reporters in Srinagar.

Sharma said the people of Jammu and Kashmir should be given the right to elect their new representatives.

"The decision to defer the polls is unconstitutional and undemocratic and we are fighting against it. If the government can hold the Par-

liament elections, why not the Assembly and panchayat polls? They have made preparations for the Lok Sabha polls, they have appointed the nodal



officer, why cannot they hold other elections?" he added.

Responding to a question, Sharma said the security situation was conducive for holding elections in Jammu and Kashmir.

"We believe that the situation is good enough for holding elections. The government is also saying that the situation is good. After formation of the Union Territory, the perspective of the government towards democracy has changed. Elections were held in 2011 (panchayat) and in 2014 (Assembly and Lok Sabha).

That was a time when people were not participating in the elections. Today, the people are demanding holding of elections in Jammu and Kashmir," he added.

Sharma alleged the aim of the BJP government is to win the five Lok Sabha seats of Jammu and Kashmir. "They are making the rural population of the Union Territory the sacrificial lamb for it."

Sharma said the government was raising the issue of delimitation in the panchayats as a delaying tactic for holding the "...Why did the government

not do it last year? The delimitation exercise requires eight to nine months. They should have done it last year," he said.

India's Leap into Virtual Universities and the Path to a Digital Future

ocietal and business transformations unfold with significant impact when unforeseen circumstances prompt widespread exploration of innovative concepts. A prime example is seen during World War II, where the absence of American men led to women showcasing their competence in traditionally male roles, demonstrating their capability with excellence. In the same way, the Coronavirus pandemic forced global experimentation with remote teaching, thereby making us realise that online learning is the future of education.

In recent years the landscape of conventional education has undergone a significant transformation. The confines of a traditional classroom are no longer the sole avenue for learning. With the advent of the internet and cutting-edge technologies, education has transcended physical boundaries. Today, the opportunity for a high-quality education presents itself anywhere and anytime, as long as one has internet access. We find ourselves on the brink of a new epoch – the evolution of online learning.

The conventional model of brick-and-mortar universities faces a challenge from the emergence of virtual institutions. These virtual institutions have become more than just an alternative; they have become a necessity. In a country as diverse and populous as India, the need for virtual universities is paramount.

This strategic decision follows the introduction of two state-run digital universities in India: the Kerala University of Digital Sciences, Innovation and Technology established in January 2020, and the subsequent announcement of a digital university in Jodhpur, Rajasthan, in February 2021.

#### Why Virtual Universities

An imperative driving the establishment of virtual universities in India is the drive to enhance accessibility and inclusivity. The vast geographical expanse of the country often poses obstacles for students in remote or rural areas to access quality higher education. Virtual universities can bridge this gap by providing an online platform that eliminates the need for physical relocation, making education accessible to all, regardless of their geographic location.

India currently has 35 million students enrolled in higher education, resulting in a gross enrolment ratio (GER) of 26 percent. Comparatively, China, with a larger population, boasts a significantly higher GER of 51.6 percent. To achieve the goal of a 50 percent GER by 2035, as stipulated in the NEP 2020, prioritizing online learning is paramount. The NEP's provisions for flexible entry-exit points and credit banks will be optimally realized in an online setting. It will pave the way for the digitisation of higher education enshrined in the National Education.

One of the primary objectives of virtual univer-



sities is the universalization of education, and in a state where the literacy rate is as low as 67.16% according to the 2011 census, the establishment of a full-fledged virtual university akin to the successful model in Kerala, where various professional and non-professional courses are offered, could prove instrumental in elevating educational standards. The introduction of a virtual university in Jammu and Kashmir has potential to bring in a new era of educational accessibility, addressing longstanding challenges and unlocking a myriad of benefits for the region.

A significant issue that has plagued Jammu and Kashmir is the migration of students to other states in pursuit of higher education opportunities. The departure of Kashmiri students not only deprives the state of its intellectual capital but also inflicts a substantial economic toll. Astonishingly, around Rs 1500 crore drains from the Valley each year due to this migration, exacerbating the region's financial challenges and impeding sustainable development

The nationwide lockdown in response to the Covid-19 pandemic further underscored the challenges faced by Kashmiri students studying outside the state. The J&K government reported over 10,000 stranded students in different states during the lockdown, highlighting the urgency of bridging the educational gap within the region. ir pollution is a pan-India problem. In 2022, the average PM2.5 levels across the country were 10.7 times higher than the WHO standard. This means that almost the entire country breathes air considered unsafe by the WHO. The cost of this pollution is around 1.2 million premature deaths and 3% of GDP. Multiple studies show that air pollution in rural areas is as severe as in urban areas, and about 70% of premature deaths from air pollution happen in villages.

The question thus is: Where does all this PM2.5 (particulate matter less than 2.5 microns in size) come from? Recent iFOREST research has attempted to answer this question. Using globally accepted methodology and government data, the research shows that India emits approximately 5.2 million tonnes (MT) of PM2.5 annually, excluding dust from natural and manmade sources.

About 48% of these emissions come from the use of biomass, such as fuelwood and dung cakes, for cooking and heating. Open burning of crop residues contributes an additional 6.5%, making biomass burning responsible for 55% of total PM2.5 emissions. Industry and power plants are the second-largest emitters, contributing about 37%. The transport sector, a major focus of air pollution mitigation, contributes about 7% of the total PM2.5 emissions.

But how could this be? How can emissions

from all industries and power plants (India has the world's second-largest fleet of coal-based power plants) and 300 million plus vehicles plying on roads be less than those from the chullahs of the poor? The answer is simple: unlike automobiles and industries where some pollution control devices are used, biomass cookstoves and open burning in fields emit all of their pollutants unconstrained into the air. Thus, PM2.5 emission per kilogram of biomass in cookstoves is tens to hundreds of times more than those from per kg of coal in power plants or diesel in automobiles. ral areas suffer equally from air pollution.

The Regional Emission Inventory in Asia (REAS), an initiative by researchers from Japan to estimate air pollution from Asian countries, provides data on India's PM2.5 emissions from 1950 to 2015 for specific sectors. iFOREST research, which follows REAS's methodology, has estimated the emissions for 2021. The analysis of both datasets indicates that the emissions from the industry sec-

tor are on an upward trend, while those from the transport sector and power plants peaked in 2010 and have declined marginally.

The most significant emissions decline has happened from residential cooking. PM2.5 emissions from cooking have dropped by 13% or about 0.3 MT during 2010-2021 due to the shift to LPG. Thus, the 50 million households that have shifted to LPG as their primary cooking fuel between 2010 and 2021, thanks to programs like Pradhan Mantri Ujjwala Yojana (PMUY), have contributed the most to reducing air pollution.

To address air pollution decisively, we must go beyond "optics" like odd-even, banning construction, spraying water, inducing artificial rains, etc. and focus on energy transition.

Energy transition in the residential sector would provide the biggest gains. Thus, shifting households to LPG, biggas, or electricity for cooking and heating would eliminate 48% of India's PM2.5 emissions. Doing so would also eliminate

800,000 premature deaths directly caused by exposure to PM2.5 inside the household and enable the country to achieve its commitments under Sustainable Development Goal 7 to provide "clean energy to all by 2030". While this is a herculean task, it can be achieved with focused policy interventions like PMUY.

Similarly, energy transition in industry, especially MSMEs, and rigorous monitoring and enforcement would be necessary to decrease industrial pollution. On the other hand, a shift to EVs in the automobile sector would be necessary to reduce vehicular pollution.

Lastly, eliminating stubble burning is essential to decrease severe and hazardous pollution days in Delhi-NCR. This practice contributes to PM2.5 emissions equal to those from all of India's vehicles. Both incentives and penalties should be deployed to eliminate this environmentally damaging practice.

These are the steps for controlling air pollution in the country; anything less would not suffice.

ashmir, paradise on earth, is a place famous for its picturesque beauty. Apart from its abundant and mesmerizing nature, handicrafts add another feather on Kashmir's cap. The rich culture of handicrafts ubiquitous in Kashmir has been an asset not just for the region but for the entire nation.

Kashmiri handicrafts provide a comprehensive option for visitors to choose from. The traditional artisans painstakingly make handlooms, wood carving, home decors, everything of Kashmir. Tourists always have a satisfactory experience with their souvenir collection, thanks to Kashmiri handicrafts.

The long tradition of handicrafts has been a vital part of the communities in Kashmir. Kashmiri handicrafts' locus is in the districts of Srinagar, Ganderbal, and Budgam. The rich culture of these places, along with some other neighbourhoods, brings to life the distinctive heritage of the Kashmiri handicrafts.

The unique artistic experiments with shawls, bedsheets, inkstands, boxes, palkis, spoons, and trunks were famous across India and abroad. The art of shawl making was native to Kashmir. The notable hand-crafted works of the traditional artists of Kashmir have come a long way and have become eminent due to their efficiency as high-quality art globally.

Papier Mache is an art form that was cultivated in China. The Chinese papermodelling art form from the Hans Dynasty travelled far and wide in the wake of craft trade across the globe. The art form came to India in the 14th Century with Mir Syed Ali Hamdani, a Persian mystic.

The Kashmiri style of representing Papier Mache is unique. The intrinsic designs, the colourful dyes, and different objects made with Papier Mache are of the highest quality. There are two steps in making Paper Mache. The first step is called Sakhtsazi, and the second step is called Nagashi.

The fashion of carpet weaving also came to India with Persian travellers. Sultan Zain-ul-Abidin is thought to be the one to bring carpet weavers from Persia and Central Asia to Kashmir, India. The term 'Kal Baffi' is used for hand-knotted carpets. The locals of Kashmir took an interest in the art and business and learned the tradition to pass it from generation to



generation.

Three main features decide the quality of the carpets: the design, the yarn, and the weaving style. The more complex the delicate works are, the more price it will fetch. The hand-woven carpets and rugs of Kashmir have caught people's attention from different parts of the world. The Persian style of weaving carpets has become a very intricate part of Kashmiri

Pashmina weaving is probably one of the most famous handicrafts in Kashmir. The name Pashmina inevitably calls to mind the place Kashmir. Pashmina has come a long way from being a piece of clothing protecting people from the extreme cold of Kashmir to becoming a fine luxury item.

Completing a Pashmina product requires a lot of skill and hard work. Retention of the softness of the fabric, deciding

colours, selecting a pattern, and finally weaving unique designs all require expert knowledge and skill. The tradition of Pashmina making is quintessential to Kashmir, and the fine quality of the items and its more delicate construction of patterns make Pashmina an asset to Kashmiri handicrafts.

The art of wood carving is essentially a special kind of handicraft. Kashmir houses many artisans who specialize in the art of wood carving. The wood from the walnut trees primitive in Kashmir serves as the base on which artists show their calibre of wood carving. The wood from the walnut tree is very sturdy and is the right choice for producing hard work. Wood carvings result in a lot of products. Willow Wicker Craft, also known as Keani Keam in Kashmir, is a handmade craft

involving the weaving of willow reeds. Willow weaving is a local economic tradition in the valley. While other crafts' products are mostly used for decoration, the uniqueness of this craft is that a willow product may be used as both a decoration and a domestic utility item to store and transport culinary items on special occasions such as Eid or a wedding ceremony.

Copperware making has long been a part of Kashmiri culture. Historians think that artists and dealers from Iran and Iraq introduced this beautiful craftsmanship about 700 years ago. Mir Sayyid Ali Hamdani, an Islamic teacher from Persia, was essential in popularising copperware among the locals, and he brought craftsmen from Central Asia to train locals.

During the reign of King Budshah Zain-ul-Abideen, however, the copperware craft prospered. During the Mughal Empire, Kashmiri metallurgy specialised in the production of cannon barrels and

swords. The handles of swords were decorated using techniques such as casting and forging iron, as well as enamelling, or Meenakari as it is generally called. With the demise of the Mughal era at the end of the nineteenth century, Kashmiri metalworkers refocused their expertise on manufacturing vessels, now embellished with Meenakari.

Beautiful household utility and décor abound in Srinagar's downtown bazaar. Shehr-e-Khaas has been a centre for copperware since the 19th century, with the old markets of Zaina Kadal still maintaining this beautiful craftsmanship. Artistic utensils still adorn the downtown shops

Namda refers to a type of matting. Bed covers and mattresses are also made of it. Namdas are most commonly used as traditional matting to decorate homes. Namda creation is a rare and unusual skill that involves felting wool rather than weaving it to create magnificent floor pieces. There is a culture of sitting on the floor in every Kashmiri household, whether it be a royal castle or a humble hut. During the winter months, when the weather is typical, with heavy snowfall, icy cold winds, and sub-zero temperatures, the floor becomes agonisingly cold, and Namda comes to the rescue to create a comfortable sitting arrangement on the floor.

The Namda market is mostly found in Kashmir's downtown neighbourhoods of Shehr-e-khaas, Anantnag, Rainawari, and Baramulla. For many artisans in the Valley, Namda craft remains their sole source of income.

Kashmiri handicraft holds in different stores kinds of embroidery that catches the eye of tourists and locals both. Following are some of the variant types of embroidery authentic as Kashmiri handicrafts.

Kashmir's serene nature and rich culture are a source of many traditions of the different communities. Kashmiri handicrafts and their continuous practice for generations show how important handicrafts are. Buying an authentic Kashmiri handicraft will be a long-term investment for the beauty, durability, and uniqueness of the products, which remain for a long time. Kashmiri handicrafts are, therefore, an industry that thrives and grows with each passing day.

# Forget Dystopian Scenarios, AI is Pervasive Today

The turmoil at ChatGPT-maker OpenAI, bookended by the board of directors firing high-profile CEO Sam Altman on Nov. 17, 2023, and rehiring him just four days later, has put a spotlight on artificial intelligence safety and concerns about the rapid development of artificial general intelligence, or AGI. AGI is loosely defined as human-level intelligence across a range of tasks.

The OpenAI board stated that Altman's termination was for lack of candor, but speculation has centered on a rift between Altman and members of the board over concerns that OpenAI's remarkable growth – products such as ChatGPT and Dall-E have acquired hundreds of millions of users worldwide - has hindered the company's ability to focus on catastrophic risks posed by

OpenAI's goal of developing AGI has become entwined with the idea of AI acquiring superintelligent capabilities and the need to safeguard against the technology being misused or going rogue. But for now, AGI and its attendant risks are speculative. Task-specific forms of AI, meanwhile, are very real, have become widespread and often fly under the radar.

As a researcher of information systems and responsible AI, I study how these everyday algorithms work - and how they can harm people.

AI is pervasive

Al plays a visible part in many people's daily lives, from face recognition



unlocking your phone to speech recognition powering your digital assistant. It also plays roles you might be vaguely aware of - for example, shaping your social media and online shopping sessions, guiding your video-watching choices and matching you with a driver in a ride-sharing service.

AI also affects your life in ways that might completely escape your notice. If you're applying for a job, many employers use AI in the hiring process. Your bosses might be using it to identify employees who are likely to quit. If you're applying for a loan, odds are your bank is using AI to decide whether to grant it. If you're being treated for a medical condition, your health care providers might use it to assess your medical images. And if you know someone caught up in the criminal justice system, AI

could well play a role in determining the course of their life.

Algorithmic harms

Many of the AI systems that fly under the radar have biases that can cause harm. For example, machine learning methods use inductive logic, which starts with a set of premises, to generalize patterns from training data. A machine learning-based resume screening tool was found to be biased against women because the training data reflected past practices when most resumes were submitted by men.

The use of predictive methods in areas ranging from health care to child welfare could exhibit biases such as cohort bias that lead to unequal risk assessments across different groups in society. Even when legal practices prohibit discrimination based on attributes such as race and gender – for example, in consumer lending – proxy discrimination can still occur. This happens when algorithmic decision-making models do not use characteristics that are legally protected, such as race, and instead use characteristics that are highly correlated or connected with the legally protected characteristic, like neighborhood. Studies have found that risk-equivalent Black and Latino borrowers pay significantly higher interest rates on government-sponsored enterprise securitized and Federal Housing Authority insured loans than white bor-

Another form of bias occurs when decision-makers use an algorithm differently from how the algorithm's designers intended. In a well-known example, a neural network learned to associate asthma with a lower risk of death from pneumonia. This was because asthmatics with pneumonia are traditionally given more aggressive treatment that lowers their mortality risk compared to the overall population. However, if the outcome from such a neural network is used in hospital bed allocation, then those with asthma and admitted with pneumonia would be dangerously deprioritized.

Biases from algorithms can also result from complex societal feedback loops. For example, when predicting recidivism, authorities attempt to predict which people convicted of crimes are likely to commit crimes again. But the data used to train predictive algorithms is actually about who is likely to get re-

AI safety in the here and now

The Biden administration's recent executive order and enforcement efforts by federal agencies such as the Federal Trade Commission are the first steps in recognizing and safeguarding against algorithmic harms.

And though large language models, such as GPT-3 that powers ChatGPT, and multimodal large language models, such as GPT-4, are steps on the road toward artificial general intelligence, they are also algorithms people are increasingly using in school, work and daily life. It's important to consider the biases that result from widespread use of large language models.

For example, these models could exhibit biases resulting from negative stereotyping involving gender, race or religion, as well as biases in representation of minorities and disabled people. As these models demonstrate the ability to outperform humans on tests such as the bar exam, I believe that they require greater scrutiny to ensure that AI-augmented work conforms to standards of transparency, accuracy and source crediting, and that stakeholders have the authority to enforce such standards.

Ultimately, who wins and loses from large-scale deployment of AI may not be about rogue superintelligence, but about understanding who is vulnerable when algorithmic decision-making is

## 'People With Joint, Muscle Disorders Expected To Increase By 115 Pc By 2050'

ore than a billion people globally are expected to have disorders of joints, muscles, bones, ligaments, tendons and spine by 2050, up from about half a billion in 2020, according to a new study published in The Lancet Rheumatology journal.

The projected figure of musculoskeletal disorder cases is an increase of about 115 per cent from

that of 2020, and most regions were projected to have at least a 50 per cent increase in cases between 2020 and 2050, the international study by The Institute for Health Metrics and Evaluation, University of Washington, US, found.

"We highlight there is a substantial burden of what are categorised as 'other' musculoskeletal disorders that would otherwise go unrecognised," said joint first author Manasi Murthy Mittinty from Flinders University College of Medicine, Australia.

The musculoskeletal disorders



studied were a large and growing source of disability in the world that requires public policy consideration, she said.

"Not only are the number of people worldwide living with other musculoskeletal conditions such as systemic lupus erythematosus and spondylopathies increasing but so will be their healthcare needs in 2050 and beyond," said Mittinty.

The musculoskeletal disorders were prevalent 47.4 per cent higher in women than in men, and increased with age to peak at 65-69 years in both the sexes, the re-

search found after analysing data from 23 countries. It then estimated prevalence of these disorders in 204 countries and territories from 1990 to 2020 and made projections for 2050 using statistical analyses.

"A factor which may add to the projection of course is the emergence of post-COVID-19 implications where a growing cohort of related conditions characterised by musculoskeletal symptoms and loss of mobility are recognised, adding further pressure on health systems and communities," said Mittinty.

## 'Chlorine Disinfectant No More Effective Than Water At Killing Hospital Superbug'

ne of the primary chlorine disinfectants currently being used to clean hospital scrubs and surfaces does not kill the most common cause of antibiotic-associated illness in health care settings globally, according to a study.

Researchers at the University of Plymouth in the UK found that spores of Clostridioides difficile, commonly known as C. diff, are completely unaffected despite being treated with high concentrations of bleach used in many hospitals.

They found that the chlorine chemicals are no more effective at damaging the spores when used as a surface disinfectant than using water with no additives.

The study, published in the journal Microbiology, shows that susceptible people working and being treated in clinical settings might be unknowingly placed at risk of contracting the superbug.

With incidence of disinfectant overuse only serving to fuel rises in antimicrobial resistance (AMR) worldwide, the researchers call for urgent research to find alternative strategies to disinfect C. diff spores in order to break the chain of transmission in clinical environments.

"With incidence of anti-microbial resistance on the rise, the threat posed by superbugs to human health is increasing," said Tina Joshi, Associate Professor at the University of Plymouth, who carried out the study with Humaira Ahmed, a fourth-year Medicine student at the university.

"But far from demonstrating that



our clinical environments are clean and safe for staff and patients, this study highlights the ability of C. diff spores to tolerate disinfection at in-use and recommended active chlorine concentrations," Joshi said.

C. diff is a microbe that causes diarrhea, colitis and other bowel complications and is known to infect millions of people all over the world each year.

The study examined spore response of three different strains of C. diff to three clinical in-use concentrations of sodium hypochlorite.

The spores were then spiked onto surgical scrubs and patient gowns, examined using scanning electron microscopes to establish if there were any morphological changes to the outer spore coat.

"Understanding how these spores and disinfectants interact is integral to practical management of C. diff infection and reducing the burden of infection in health care settings," Joshi said.

"However, there are still unanswered questions regarding the extent of biocide tolerance within C. diff and whether it is affected by antibiotic co-tolerance. With AMR increasing globally, the need to find those answers--both for C. diff and other superbugs--has never been more pressing," she added.

## DGCA Issues Circular On Measures To Deal With Signal Interference In Airspace

**NEW DELHI:** Aviation watchdog DGCA has issued a circular to airlines and the Airports Authority of India (AAI) on measures to deal with threats from jamming and spoofing of the Global Navigation Satellite System (GNSS) amid reports of such interference in the Middle East.

The circular provides comprehensive mitigation measures and action plans for aircraft operators, pilots, Air Navigation Service Providers (ANSP) and air traffic controllers. This includes the development of contingency procedures in coordination with equipment manufacturers and assessing operational risk by conducting a safety risk assessment.

AAI is the country's ANSP, and air traffic controllers also come under it.

In a release on Friday, the Directorate General of Civil Aviation (DGCA) said it has released an advisory circular on GNSS interference in the airspace.

The watchdog said the circular highlights the emerging threats of GNSS jamming and spoofing, the various geographical areas where it has been observed, and its potential impact on aircraft and ground-based systems.



Generally, GNSS spoofing and jamming refers to attempts to manipulate a user's navigation system by giving false signals.

In the wake of the reports of GNSS interference over airspace in the Middle East in the recent past, DGCA formed an internal committee on October 4.

The committee took stock of the situation, sensitised operators, and started discussions with leading experts from around the world on the subject.

After taking the inputs into account, DGCA said recommendations have been included in the circular for tackling the emerging threat considering the best practices, latest developments and ICAO (International Civil Aviation Organisation) guidance on the matter.

Besides, the circular pro-

vides a mechanism for ANSP to establish a threat monitoring and analysis network in close coordination with DGCA for preventive as well as reactive threat monitoring and analysis of reports of GNSS interference to generate valuable insights with data and new developments to have a robust and immediate threat response.

According to DGCA, the aviation industry is grappling with uncertainties due to new threats and reports of GNSS jamming and spoofing.

The circular gives the much-needed guidance and clarity to all concerned with a practical roadmap and action plan to deal with the threat of GNSS interference in airspace in an effective manner, it added.

GNSS is vital for aircraft navigation.

## IBC Recoveries Declining, Resolution Timelines Getting Prolonged: Crisil

MUMBAI: Introduction of a focused bankruptcy law has helped improve the credit culture in India, but the last few years have seen a decline in recoveries and the resolution timelines getting prolonged, Crisil Ratings on Friday.

In a note to observe the seven years of the Insolvency and Bankruptcy Code (IBC), the rating agency said the recovery rates have fallen to 32 per cent in September 2023, from 43 per cent in March 2019.

At the same time, the average resolution time has increased from 324 days to 653 days, versus the stipulated 330 days, it said.

The IBC has helped in resolving debt worth Rs 3.16 lakh crore stuck in 808 cases in the past seven years, the leading credit rating agency said.

Its senior director Mohit Makhija said the IBC is "the most potent code" in India's corporate loan history, which has brought a "behavioural change" in borrowers.

"The fear of losing companies has led to over Rs 9 lakh crore of filed debt being settled before the cases arrived at the IBC doorstep for admission. This is around three times the stressed debt resolved via the code in the past seven years, underscoring its deterrence effect," he said.

The agency also recommended solutions around the current challenges on recoveries and timelines, saying there is a need to remove some impediments

It reasoned that there is a



limited judicial bench strength and delays in identification and acknowledgement of default which is leading to some of the troubles.

The recovery rates have been suppressed because of significant delays in the pre-IBC admission stage, it said, pointing out that the same has increased to 650 days in FY22 from 450 days in FY19 increased from about 450 days in fiscal 2019, it said.

The rating agency said 90 amendments have been carried out to the law so far, including some over the last year like approval for sale of assets/ resolution plan on a segregated basis, increasing the number of National Company Law Tribunal benches to 16 and extending timelines for filing claims.

Its director Sushant Sarode said Capacity augmentation, Digitalisation and Expansion of pre-pack resolutions to large corporates can help improve the efficiency of IBC.

There is a backlog of 13,000 cases under IBC, which includes 2,073 ongoing corporate insolvency resolutions, he said.

The agency argued that the recoveries from IBC are better than the earlier debt resolution mechanisms, which averaged between 5-20 per cent.

## Sebi Proposes Flexibility In Framework Of Trading Plans Under Insider Rules

**NEW DELHI:** Capital markets regulator Sebi on Friday came out with a proposal to provide flexibility in adopting trading plans by persons, who are perpetually in possession of unpublished price sensitive information.

Under the rule, 'Trading Plans' (TP) enable persons like senior management or Key Managerial Personnel (KMP), who are perpetually in possession of Unpublished Price Sensitive Information (UPSI), to trade in securities in a compliant manner.

"Since the introduction of trading plans in 2015, data and market feedback suggest that the current regulatory requirements in respect of trading plans are onerous and consequently, trading plans are not very popular," Sebi said in its consultation paper.

Accordingly, Sebi constituted a working group that was mandated to review provisions of TP under the insider trading

As per the consultation paper, the working group has recommended that a minimum cool-off period between disclosure of TP and implementation of TP should be reduced to four months from six months at present.

In addition, the minimum

coverage period requirement should be slashed to two months from the current twelve months.

It has also been suggested that the requirement of blackout period for trading in TP should be done away with.

"The insider shall have flexibility, during formulation of TP, to provide price limits i.e. upper price limits for buy trades and lower price limits for sell trades. Such price limit shall be within +/-20 per cent of the closing price on date of submission of TP.

"If price of the security, during execution, is outside the price limit set by the insider, the trade shall not be executed. If no price limit is opted for, the trade has to be undertaken irrespective of the prevailing price," the working group has recommended.

It has been suggested that contra-trade provisions should be applicable on trades executed under TP as well and there should be a disclosure of TP proposed to be done in two days from the date of approval of such plan to stock exchanges.

While there is no prescribed format for disclosure of TP, it typically contains the personal details such as name and designation of the insider along with the trades planned to be undertaken.

## Delhi Airport To Cross 70 Mn Passenger Traffic In FY24: DIAL Chief

**NEW DELHI-** The Delhi airport will cross the pre-pandemic passenger traffic level at more than 70 million this fiscal and expects to complete the expansion of Terminal 1 by the end of February next year that will increase the domestic air passenger handling capacity by 23 million, a top official said on Friday.

Besides, airport operator DIAL CEO Videh Kumar Jaipuriar said Terminal 2 (T2) will be converted into an international terminal for a short term.

Currently, T2 is for domestic flights and has a passenger handling capacity of 15 million.

The Indira Gandhi Interna-

tional Airport (IGIA) in the national capital is the country's largest airport and is operated by the Delhi International Airport Ltd (DIAL).

Currently, the airport has three terminals -- T1, T2 and

three terminals -- T1, T2 and T3 -- and depending on traffic trends, the operator will take a decision on having T4. At present, only T3 has international operations.

In an interview to PTI here, Jaipuriar said there is a good revival of passenger traffic.

"This (financial) year, we are going to end up (with) higher than pre-Covid (passenger traffic level). We had a maximum of 69.3 million



passengers during pre-Covid. Last (financial) year, we did 65.3 million and this financial year, we will cross 70 million." he said.

Out of the total, over 52 million will be domestic passengers and around 18 million will be international passengers.

DIAL will also revisit its master plan for the airport that was prepared in 2016 and the current capacity levels are based on that plan.

The expansion of T1 is likely

The expansion of T1 is likely to get completed by February end next year. Once it is complete, the terminal's passenger handling capacity will increase from 17 million to 40 million, Jaipuriar said.

"Then, we will have an overall domestic capacity of 40 million in T1 and 25 million in T3. (Currently), the domestic capacity at T2 is 15 million," he said and added that the international passenger handling capacity at T3 is around 20 million.

From the projections, he said, "we are very comfortable with domestic capacity but we are going to be tight in two years from now (when it comes to) international capacity".

As part of the 2016 master plan, T4 is supposed to be developed with a capacity of around 40 million. So, the master plan is talking about T4 being fully domestic, T3 getting converted fully into international and T1 being completely domestic, he noted.

According to the DIAL chief, the plan is that instead of being a domestic terminal, T2 will be converted into an international terminal for a short term.

On T2 conversion, Jaipuriar said DIAL still has to do the stakeholders' consultations.

"If everything gets finalised... by June-July next year, we should be able to convert T2 into international (terminal)," he added.

## RBI Slaps Penalties Totalling Rs 10.34 Cr On Citibank, Bank Of Baroda, IOB

**MUMBAI:** The Reserve Bank on Friday imposed penalties totalling Rs 10.34 crore on Citibank, Bank of Baroda, and Indian Overseas Bank for contravention of various regulatory

The highest penalty of Rs 5 crore has been imposed on Citibank NA for non-compliance of norms related to depositor education and awareness fund scheme, and code of conduct on outsourcing of financial services, the RBI said in a statement.

A fine of Rs 4.34 core was imposed on the state-owned

Bank of Baroda for violation of certain directions related to the creation of a central repository of large common exposures, and others, another release said.

Chennai-based public sector lender Indian Overseas Bank was slapped with a Rs 1 crore fine for contravention of directions concerning loans and advances.

In all three cases, the Reserve Bank of India said, penalties are based on deficiencies in regulatory compliance and not intended to pronounce upon the validity of any transaction or agreement entered into by the banks with their customers.

## This City Recorded Highest Jump In Average Residential Property Prices In 3 Years

**NEW DELHI:** Buoyed by strong housing demand, the average residential property prices in key markets across the top seven Indian cities saw a significant surge in the last three years.

According to real estate consultancy firm Anarock's research data, it indicated that among the key micro markets, Hyderabad's Gachibowli recorded the highest 33 percent jump in average residential prices between during the past three years (October 2020-October 2023), followed by Kondapur with a 31 percent rise.

In Gachibowli, the average residential prices as of October 2023-end stand at approximately ₹6,355 per sq. ft. In the corresponding period of 2020, average prices in this locality were ₹4,790 per sq. ft.

Hyderabad's Kondapur recorded a 31 percent average price rise in this period - from ₹4,650 per sq. ft. by October-end 2020 to ₹6,090 per sq. ft. by October-end 2023,

Anarock data showed.

Gachibowli and Kondapur fol-



lowed Bengaluru's Whitefield with a 29 percent jump in this three-year period - from ₹4,900 per sq. ft. to ₹6,325 per sq. ft. now.

Key areas in the Mumbai Metropolitan Region and Delhi NCR also saw average prices surge between 13-27 percent in this three-year span. In NCR's Greater Noida West,

average prices have increased by 27 percent in the period. In Mumbai, Lower Parel saw average prices appreciate by 21 percent. Here are some of the city-wise

"The end of October, marking the end of the festive season, typically denotes the culmination of the year's peak housing sales period. Barring discounts, 2020 was a year of price stagnation and a year most developers would prefer to forget. The scenario in 2023 is markedly different - backed by strong demand, housing sales across the top seven cities have created a new peak this year with sales far exceeding the previous peak of 2014,' said Prashant Thakur, Regional Director and Head - Research, ANAROCK Group.

Up to the pandemic year of 2020, average residential prices across cities had remained largely range-bound.

"Among the top seven cities, key areas in the IT-led cities Hyderabad, Bengaluru, and Pune saw the highest surge in average prices," said Mr Thakur.

However, people can directly apply through the online portal," he noted.

Notably, the JAKEDA inked Memorandum of Understanding (MOU) with J&K Bank for loans with a quantum of Rs 2.6lakh for the purchase of solar power plants by the people.

He further said the solar plant provides electricity to homes with clean solar energy. The plant occupies only 80-100 sq. ft roof area per KW and generates 120-140 units of energy per KW per month on an average. The project also saves approx. Rs 500/- per KW per month in electricity bills.

The official further said that the plant offsets about 0.73 tons of carbon emission annually per KW which is equivalent to planting

Maqsud Ali Banka, Executive Engineer of JAKEDA told Kashmir Observer that most of the smart meter consumers have installed the solar plants and efforts were afoot to cover 10,000 households under this scheme.

"As of now, over 1600 individuals with smart meters have installed the plants with a cumulative capacity of 8.5 MW. Smart meters are imperative for installing the solar plant,"

"But if anyone wants to install solar panels in a non-metered area, we provide net energy meters that record import and export of the energy," he added.

Regarding the surplus power, Banka said that the energy will be imported and exported through smart meters.

Citing an example, Banka explained, "If you produce 5KW of electricity but only utilize 3KW, it implies that you've exported 2KWs of electricity, and this surplus will be evident in your monthly bill,"

He said there is only one variant of the plant. The solar rooftops are available from 1 KW to 10 KW capacity and five years free maintenance is also provided to the consumers.

Banka said people mostly prefer 3 KW plant which costs around Rs 1.57 lakh. The UT government provides Rs 39, 445 subsidy while MNRE provides Rs 63,112. A consumer has to pay only Rs 55,224 to get the solar plant

Notably, the department has organised many week-long mega solar Expos across the Valley aiming to raise awareness among the people about the benefits of rooftop solar plants and other beneficiary oriented

Asked if Pakistan intends to push more terrorists in the coming months to disrupt upcoming elections, including the Lok Sabha polls, he answered in the affirmative without going into details.

On the number of active terrorists in the south of Pir Panjal, he said the number of terrorists in the Rajouri-Poonch belt fluctuates as the area is connected with the national highway. "Roughly there is a possibility of 20 to 25 terrorists operating in the area but the way army, police and other intelligence agencies have intensified their operations, we are sure to control the situation within one year,' Lt General Dwivedi said.

Mentioning the killings of the terrorists in the Bajimaal encounter, he said, "They have created an ecosystem and their killing has dealt a severe blow to Pakistan to disturb the

He said the sacrifice of the five soldiers led to the neutralisation of the two dreaded terrorists and it is a big achievement. "The two terrorists were active for the last one year and we were not able to find them. Someone was providing weapons, ammunition and also information," Lt General Dwivedi said.

It was very important to neutralise them as they were responsible for 10 civilian killings in Dhangri and TCP in Rajouri town besides masterminding attacks on security forces at Kandi in which five army personnel lost their

The army commander said it was possible that they were trained in several countries, including Pakistan and Afghanistan.

"They were highly trained foreign terrorists and our brave soldiers without paying attention to their safety got into the operation and eliminated them. The troops have done a laudable job," he said.

Also, several appellants who were initially appointed as Constables (Operator) as per the merit list/select list prepared district-wise, in terms of an advertisement issued on 09 March 2007 and their appointments were successfully challenged by the private respondents primarily on the ground that appointments to these posts were to be made on the basis of the select list prepared at the State level and not by preparing district wise select list.

The appellants, the court said are stated to be numbering 151 and who are presently serving as Wireless Assistants, shall forthwith be appointed as Constables (Operator) on regular basis by adjusting against the 170 vacant posts of Constables (Operator) and their appointments shall be given effect notionally from the date they were initially appointed as Constables (Operator), without any back wages.

"The services of those persons who are already appointed as Constables (Operator) after the services of the appellants were terminated vide order dated 19.01.2017 will remain undisturbed and will be en-bloc senior to the appellants in the LPAs (appeals) as the seniority of the Constables (Operator) should be based on the state level merit list which was prepared in terms of the direction issued by the Single Judge in the impugned judgment and order dated 09.05.2014 ....as this would truly reflect the comparative merit of the candidates, irrespective of the fact that they may be appointed on different dates and in different districts," the court said In the 41page judgment.

The authorities, the court said, in order to avoid any such similar future litigation shall also clarify the status/position of the "Constable (Operator)" as regards "Constable" as provided in the J & K Police Rules, 1960.

"The private respondents who have continued to pursue their claim till now, stated to be numbering 63, shall be appointed as Wireless Assistants against the resultant 151 (one fifty-one) vacant posts of Wireless Assistants, subject to their suitability and on attaining the benchmark in terms of the performance in the recruitment process pursuant to the advertisement dated 09.03.2007, as may be decided by the appointing authority within a period of one month from today.'

The court also observed that the public notification or the advertisement, which is an invitation to the eligible candidates, will ordinarily be a mirror reflection of the provisions of the service rules governing the posts, as appointment to such advertised posts has to be in accordance with the service rules.

"As a corollary, the terms and conditions mentioned in the public notification/advertisements cannot be in conflict with the service rules, as the service rules are generally statutory in nature and thus have the force of law and have to be meticulously followed," the court said, adding, "The terms and conditions mentioned in the advertisement, thus, cannot be in derogation of the service rules.'

The advertisement for the posts, the court said, should also indicate the manner in which the recruitment is to be conducted as provided under the service rules.

"The way the recruitment process is to be carried out, must be in conformity with the service rules and if there be any deviation from the service rules, the recruitment process will be vulnerable to impeachment and may be rendered invalid

"Various factors, including viral mutations or environmental conditions, can contribute to the new pneumonia outbreak in China. While the outbreak raised concerns of a new virus or a mutation in an existing respiratory virus, China assured the World Health Organisation that they did not detect any unusual or novel pathogen.

The WHO said that China, on Thursday, provided data indicating an increase in outpatient consultations and hospital admissions of children due to Mycoplasma pneumoniae pneumonia since May, and RSV, adenovirus and influenza virus since October.

Mycoplasma pneumoniae is a common respiratory pathogen and a common cause of paediatric pneumonia, and is readily treated with antibiotics.

"Chinese authorities advised that there has been no detection of any unusual or novel pathogens or unusual clinical presentations, including in Beijing and Liaoning," the WHO said in a statement.

China said there has been a "general increase in respiratory illnesses due to multiple known pathogens. They further stated that the rise in respiratory illness has not resulted in patient loads exceeding hospital

Some of these increases are earlier in the season than historically experienced, but not unexpected given the lifting of Covid-19 restrictions, as similarly experienced in other countries. No changes in the disease presentation were reported by the Chinese health authorities, the UN health body said.

## Barcelona & Real Madrid Return To Action After Spate Of Injuries

BARCELONA: Barcelona and Real Madrid will be without three of their top young players when the Spanish league returns this weekend, after they were injured during the international break.

Barcelona lost 19-year-old Gavi for the rest of the season when the allterrain midfielder tore the anterior cruciate ligament in his right knee and damaged his lateral meniscus during Spain's final European Championship qualifier. Spain was already qualified for next year's tournament in Germany before it beat Georgia 3-1 on Sunday.

National team coach Luis de la Fuente has come under criticism in Spain's sports media for not substituting Gavi when his knee buckled inward during a collision with an opponent. He played on for a few minutes only to collapse in tears before limping off. He will now undergo surgery that will most likely also rule him out for Spain at Euro 2024.

Gavi, despite his age, has emerged as a key player for Spain and for his club. He is Barcelona's best tackler in midfield and replacing him



will be no easy task for coach Xavi Hernández.

Barcelona visits Rayo Vallecano on Saturday. It sits third in the league standings, four points behind surprising leader Girona and two points behind Real Madrid.

Gavi has played the second most minutes of any outfield player this season for Barcelona, only behind Ilkay Gundogan. The player from near Seville had taken on more im-

portance in recent weeks when fellow midfielders Pedri and Frenkie de Jong were both recovering from muscle complaints

Pedri returned to play for Barcelona before the international break and De Jong is back training for the first time since he was hurt in September. Fermin López, 20, should continue to have opportunities after impressing since moving up from Barcelona's youth teams.

Goalkeeper Marc-Andre ter Stegen is also doubtful after he hurt his back while with Germany. If he can not play at the 10th-placed Rayo, then rarely used Iñaki Peña will be in goal.

Madrid visits 16th-place Cadiz on Sunday needing to find replacements for forward Vinícius Júnior and multi-use midfielder Eduardo Camavinga.

Vinícius tore a leg muscle in his left leg during Brazil's 2-1 loss at Colombia on Friday. That should sideline the player who was key to Madrid winning its 14th European Cup

two seasons ago for several weeks. Vinícius' injury leaves Carlo Ancelotti without one of his top scorers after Karim Benzema left in the offseason for Saudi Arabia. Newcomer Jude Bellingham has so far picked up the scoring load with a league-high 10 goals and 13 goals in all competitions. The 23-year-old Vinícius has

chipped in with six goals overall. Vinícius' absence could open the door for Joselu to start alongside Rodrygo in attack, and perhaps lead to more minutes for Luka Modric or Brahim Díaz. The 38-year-old Modric has become a second-half substitute for Ancelotti this season after being a career starter.

The 21-year-old Camavinga tore a ligament in his right knee in training with France.

His absence leaves Ancelotti without one of his most versatile players, who can play as a holding midfielder or at right back. Camavinga started all four of Madrid's Champions League games and appeared in all 13 of its Spanish league matches this season.

Girona has been defying expectations by winning 11 of 13 games. It next faces Athletic Bilbao at home on Monday.

Midfielder Aleix García became the first ever Girona player to play for Spain last week.

Striker Artem Dovbyk and winger Viktor Tsygankov both started for Ukraine in its scoreless draw with Italy on Monday. That result sent Italy into Euro 2024 and Ukraine to a playoff to see if it can join them next

# How music evokes deep emotions and boosts memory

Tave you ever wondered why a particular song can transport you back in time, evoking powerful emotions and vivid memories? A new study published in Nature Communications has shed light on the remarkable connection between music, emotions, and memory, unraveling the mysteries behind our profound reactions to certain melodies. The study reveals that musicians and composers who skillfully weave emotional events together to tell a story are actually imbuing our memories with a rich temporal structure and a longer sense of time. It seems that the very fabric of music has the power to shape our perception of time, leav-

ing a lasting imprint in our minds.
Dr. McClay, one of the lead researchers, explains, "Intense moments of emotional change and suspense, like the musical phrases in Queen's 'Bohemian Rhapsody,' could be remembered as having lasted longer than less emotive experiences of similar length." In other words, music has the ability to stretch time, making emotionally charged moments

feel more substantial and everlasting. Interestingly, the direction of emotional change also plays a crucial role in memory integration. The research suggests that memories of sequential items feel closer together in time when the shift in emotions is towards positivity. On the contrary, a shift towards more negative emotions tends to separate and expand the mental distance between new memories. This finding highlights the significance of positive emotional experiences in consolidating memories and recalling their order accurately.

The study didn't stop at exploring the immediate effects of music on memory and emotions. Participants were surveyed the following day, revealing that intense positive emotions led to better memory retention. This suggests that feeling more positive and energized can fuse different elements of an experience together in memory, creating a more comprehensive recollection of the event.

Dr. Sachs, another researcher involved in the study, emphasized the potential of music as an intervention technique. "Most music-based therapies for disorders rely on the fact that listening to music can help patients relax or feel enjoyment, which reduces negative emotional symptoms," he stated. However, this study offers a new perspective, proposing that emotionally dynamic music might directly treat the memory issues associated with such disorders. By leveraging the power of positive emotions, music could potentially help individuals with post-traumatic stress disorder (PTSD) reintegrate traumatic memories and prevent them from spilling over into everyday life.

Dr. Clewett, a researcher specialising in PTSD, expressed optimism about the impact of these findings on individuals with trauma-related disorders. He explained, "We think we can deploy positive emotions, possibly using music, to help people with PTSD put that original memory in a box and reintegrate it, so that negative emotions don't spill over into everyday life." This groundbreaking approach could revolutionise the treatment of PTSD by harnessing the profound emotional impact of music to facilitate the healing process.

## From Solo To Team: Uncovering The Benefits Of Cooperative Gaming

team of researchers at the University of Konstanz is on a mission to uncover the secrets of how our brains work together when we collaborate. This captivating study poses an intriguing challenge for the field of cognitive neuroscience.

Led by a doctoral candidate named Karl-Philipp Flösch, the researchers, based at the Centre for the Advanced Study of Collective Behaviour, recently published their groundbreaking discoveries in the journal Psychophysiology.



To study cooperative behavior in a controlled environment, they cleverly chose the iconic video game Pacman, which has captured the hearts of gamers worldwide for decades.

But this wasn't just any ordinary game of Pacman. In this

modified version, two players connect through screens and must work together to guide Pacman to the goal. However, here comes the twist: only one player can see the path ahead, while the other player must rely on special symbols shown on the screen to communicate. Cooperation becomes the key to success as players seamlessly collaborate to navigate the hidden maze.

During these gameplay sessions, the researchers used a special technique called EEG to measure the players' brain activity. EEG, short for electroencephalography, allows scientists to capture the brain's responses with incredible precision, down to the millisecond.

The scientists focused on analyzing a specific brain reaction called the P3 component, which is known to become stronger when we encounter important and relevant information. They hypothesized that the players' roles in the game would significantly influence their brain reactions.

Their findings confirmed their hypothesis and shed light on the crucial role that different roles play in cooperation.
