Security Situation Not Alarming In J&K: DGP

Says Terror Attacks Nothing But Pin-Pricks Caused By Pakistan

Jammu: Jammu and Kashmir Director General of Police (DGP) R R Swain on Saturday said the situation in the Union Territory is not alarming as is being projected, while describing terror attacks in the valley as "pin-pricks" orchestrated at the behest of Pakistan with a sole motive to sell the bloodshed to keep its politics and economy running.

However, Swain said all the security agencies, with active public support, are determined to put an end to such "pin-pricks or cuts" as the Indian State and its government have the will to defeat terrorism and not allow it to become a cause of concern where normal life is derailed.

The police chief also said they have, at times, thought of getting photographs of slain foreign terrorists circulated through the Interpol so that their parents at

least get to know that their children are dead.

The DGP was interacting with reporters during his first public grievance redressal meeting at the police headquarters in the winter capital of Jammu.

Replying to a question on the security situation in Jammu and Kashmir in the wake of a recent encounter in Rajouri where five Army personnel and two foreign

terrorists were killed, he said, "I do not think we should be overalarmed. Yes, there is a porous and difficult border and a whole country (Pakistan) and a whole system is subverted and convoluted, so we have a challenge.

"No one is shying away from the reality that there is a challenge, but the Indian State and its government have the will and resoluteness to defeat it (terrorism) and not allow it to become a cause of concern where normal life, business activities, peace and security would be derailed (in Jammu and Kashmir)," Swain said.

He said people, especially those living in Jammu province, should remain mentally alert because the intent of the adversary continues to be inimical even as its capability to harm is not as it intends to project.

DOODH GANGA RESTORATION

J&K Govt Sanctions Rs 32 Cr After NGT Rap

Srinagar: The Jammu and Kashmir administration has sanctioned Rs 32 crore for the restoration of the Doodh Ganga and Mamath Kull streams in the valley after the NGT directed it to pay compensation for discharging untreated sewage into the water bodies.

In October last year, the National Green Tribunal (NGT) said there were "serious lapses" on the part of the administration in waste management as well as in failing to control illegal mining and asked it to pay a compensation of Rs 35 crore.

"There lapses on the part of the administration in waste



management and in failing to control illegal mining which has resulted in huge damage to the environment and public health," the NGT had said in an order while hearing an application moved by activist Raja Muzaffar Bhat.

The tribunal said the amount be used for the restoration of the environment, which will include preventing the discharge of sewage in an unscientific manner in drains or otherwise and improving the water quality of the drain.

While filing its response in the tribunal on Thursday, the Counsel appearing for the State submitted that the action plan in terms of the directions of the tribunal

has been approved. He provided the details of the sanctioned amount of Rs 32 crore which included a Sewerage Treatment Plant for daily dry weather flow discharging into Doodh Ganga Nallah at an amount of Rs 28.93 crore.

The counsel also told the tribunal that Rs 3.07 crore has been sanctioned for the beautification and restoration of the aesthetic view of the Mamath Kull and Doodh Ganga in Budgam district.

The tribunal has directed the counsel for the state to disclose if the aforesaid sanctioned amount has been released by filing of the fresh report, on the next date of hearing -- February 7, 2024. | More on P10

KPDCL Gets Rs 29.89 Cr **Revenue in 4 Days**

Srinagar: Intensifying its ongoing crackdown against power pilferage and deconsumers, the faulting Kashmir Power Distribution Corporation Limited (KPDCL) snapped power supply to over 1000 domestic, commercial and industrial units in the Valley, besides recovering a revenue of Rs 29.89 core in the last four days.

In order to provide relief to the genuine consumers, KPDCL has escalated its night patrolling and inspection drives to tighten noose against erring consumers who indulge in widespread hooking, violation of agreed load and bypassing of the meters, a KPDCL spokesperson said Saturday.

The corporation, he said, also collected a revenue of Rs.29.89 crore from consumers over the last 4 days amidst scaled up drives to check energy pilferage that primarily results in outages and damage to transformers, thus bringing hardships upon genuine consumers. On Friday, he said, Rs.9.18 crore as pending arrears were col-

lected by the Corporation. Giving more details, the spokesperson said that out of 1153 inspections carried out in Kashmir Division on Saturday, 98 were conducted in Circle I Srinagar, 233 in Circle II Srinagar, 367 in Circle Ganderbal, 140 in Circle Pulwama, 142 in Circle Bijbehara and 154 in Circle Sopore. 

Indian Doctor's Issue Warning As Mystery Disease Spreads In China

NEW DELHI: Amid the reported outbreak of H9N2 cases and clusters of respiratory illness in children in northern China, Ram Manohar Lohia Hospital Director Dr Ajay Shukla advised people to be careful, follow routine practices of cleanness and if there's someone who has got this respiratory illness or infec-tion they should try to maintain distance from other people.

"I would just advise people to be careful. Follow routine practices of cleanness and if you feel that there's someone who's got this respiratory illness or infection, since a lot of these cases are viral and they can be transmitted, try to maintain distance from other people," Dr Shukla said on Friday.

The advice comes after an undetermined pneumonia outbreak in China is hitting children hard, with media reports describing overwhelmed children's hospitals in multiple locations.

"Because we are also dealing with pollution if you're going out, and if you can afford it, it's better you should use a mask, preferably an N95 and N99 mask. Wash your hands and maintain safe, healthy practices," he added.

Palestinian Families Rejoice Over Release Of Minors And Women In Wartime Prisoner Swap

BEITUNIA (WEST BANK): Over three dozen Palestinian prisoners returned home to a hero's welcome in the occupied West Bank on Friday following their release from Israeli prisons as part of a cease-fire deal between Israel and Hamas.

The procession of freed prisoners, some accused of minor offences and others convicted in attacks, at a checkpoint outside of Jerusalem stoked massive crowds of Palestinians into a chanting, clapping, handwaving, screaming frenzy.

Fifteen dazed young men, all in stained grey prison sweatsuits and looking gaunt with exhaustion, glided through the streets on the shoulders of their teary-eyed fathers as fireworks turned the night sky to blazing colour and patriotic Palestinian pop music blared.

Some of those released were draped in Palestinian flags, others in the green flags of Hamas. They flashed victory signs as they crowd-surfed.

"I have no words, I have no words," said newly released 17-year-old Jamal Brahma,



searching for something to say to the hordes of jostling journalists and thousands of chanting Palestinians, many in national dress. "Thank God."

Tears fell down his father Khalil Brahma's cheeks as he brought his son down from his shoulders and looked him in the eye for the first time in seven months. Israeli forces had arrested Jamal at his home in the Palestinian city of Jericho last spring and detained him without charge or

"I just want to be his father again," he said.

The release of the Palestinian prisoners from Israeli jails came just hours after two dozen hostages, including 13 Israelis, were released from captivity in Gaza in the initial exchange of Israeli hostages and Palestinian prisoners during the four-day cease-fire that started Friday.

Under the deal, Hamas is to release at least 50 hostages, and Israel 150 Palestinian prisoners, over the four days. Israel said the truce could be extended an extra day for every additional 10 hostages freed. Although the atmosphere was festive in the town of Beitunia near Israel's hulking Ofer Prison in the West Bank, people

Israeli-Owned Ship Hit In **Suspected Iran Drone Attack** Agencies **DUBAI:** An Israeli-owned cargo

ship was damaged in a suspected drone attack by Iran's Islamic Revolutionary Guard Corps in the Indian Ocean, a US defence official said on Saturday.

"We are aware of reports that there was a suspected IRGC-initiated Shahed-136 UAV (that) struck a civilian motor vessel in the Indian Ocean," the official said, confirming the attack on Friday and adding that "the ship incurred minor damage" and there were "no injuries".

Maritime security company Ambrey said the Malta-flagged, French-operated container ship was reportedly damaged when the unmanned aerial vehicle exploded close to it.

The vessel was managed by an Israeli-affiliated company, which was assessed to be the reason why it was targeted," Ambrey said, adding that in the days before the attack, the ship's tracking transmissions had stopped shortly after departing port in the United Arab Emirates.

The reported attack comes almost a week after Yemen's Iran-backed Huthi rebels seized an Israel-linked cargo ship in the southern Red Sea.

Ambrey said in a separate incident on Friday the Huthis cautioned a tanker southwest of Yemen's Red Sea port city of Hodeida "to change course and warned that an attack would follow if they did not follow the instructions"

The security firm said the warning was issued several times, adding it is "likely a Huthi operation is imminent".

The Huthis, declaring themselves part of the "axis of resistance" of Iran-affiliated groups, have launched a series of drone and missile strikes targeting Israel since October, following an unprecedented attack by Hamas militants on Israel.

Israel has vowed to "crush" Hamas, which controls the Gaza Strip, after the Palestinian militants killed about 1,200 people and took around 240 hostages on October 7, according to Israeli authorities.

Gaza's Hamas government says nearly 15,000 people have been killed in Israeli aerial bombardment and ground operations in the Palestinian territory since then.

On Monday, the Huthi rebels pledged further maritime attacks until Israel halts its Gaza

Escaped from Al-Shifa, A Palestinian **Surgeon Recalls Impossible Choices**

BERLIN: With the power out, the water off, medical supplies short and hundreds of war injured and sheltering Palestinians crowding the Al-Shifa hospital in Gaza City, Ahmed Abunada was faced with impossible choices.

"Who do I let die, this woman or that man?... I do not have the time to do reconstructive surgery on this child, I will have to amputate," said the 47-year-old surgeon, who left Gaza earlier this month to escape the fighting between Israel and Hamas.

"These are very difficult decisions for a doctor," said the German doctor of Palestinian origin.

Abunada was received on Friday by German President Frank-Walter Steinmeier along with seven of his compatriots, who were evacuated from the Gaza Strip when the Rafah border crossing between the Palestinian territory and Egypt was opened to foreign



"We were operating on the floor, on gurneys. There were no beds left," he told AFP about his time in the hospital.

'The week that I left the hospital, the situation got worse. We had no more electricity, no more water, no more oxygen," he said. Without oxygen, it was no longer possible for Abunada to operate. "That is why I left, on the 28th day of

Al-Shifa, the largest hospital in the Gaza Strip, was a key focus for the Israeli military, who said Hamas used a tunnel complex under the compound to stage attacks -- a claim the Palestinian militants and hospital officials denied.

"I worked there as a doctor and I did not notice anything like that." Abunada said, when asked about Hamas's alleged presence at the facility.

Last week, the hospital's director Mohammad Abu Salmiya, who has been frequently moted by international media about conditions inside the complex, was arrested by Is-

Delhi Man Gets Himself Shot At To Frame Lenders In False Case

NEW DELHI: To implicate lenders in a false case, a 43-year-old man allegedly got himself shot at with a country-made pistol in northeast Delhi, police said on Saturday. The man allegedly asked his 19-year-old nephew to fire a bullet at his arm and throw the weapon used in the crime in a pond, which was later recovered, said the investigators.

"On Friday morning, at around 6 am, we got a call that a man had been shot at near an agricultural land in Kodhi Colony, Tahirpur of Nand Nagri. A team was sent at the location," Deputy Commissioner of Police (northeast) Joy Tirkey said.

Police said that it was found that Sundar, a resident of New Seemapuri, had sustained a convincing. He had thrown the gunshot injury on his right upper arm. And an empty shell of

(point)-315 bore was found at the spot. His nephew, Himanshu alias Anshu was also present with him.

"They told police that they were feeding fish at the pond when a person came and shot at Sundar from behind after abusing him. Sundar was taken to the GTB Hospital, where he is undergoing treatment and his condition is stated to be out of danger," said the DCP.

Police said that during the investigation, it was found that Sundar owed money to some people and was trying to implicate them in the firing incident.

During interrogation, his nephew Anshu, allegedly admitted that he had shot his uncle as part of their conspiracy. He had planted an empty shell at the spot to make it loo country-made pistol into the pond after the incident.

Kashmir Hospitals Witness Surge In Patients With Respiratory Tract Infections

Doctors Advise People To Wear Masks, Stay Hydrated, Consume Fruit And Vegetables

SRINAGAR: With the onset of winter, the hospitals across Kashmir are witnessing a surge in patients with respiratory tract infections. This surge is attributed to the influenza virus and its subtypes, including H3N2 and partly H1N1.

Doctors from various hospitals informed that there is an increase in patients seeking treatment for respiratory tract infection symptoms. They said the replication of different respiratory infection-causing viin India, as per ICMR, are very similar to other seasonal flu symptoms. They include a runny or stuffy nose, sore throat with cough, headache, fever, chills, body aches, fatigue, diar-

rhoea, and vomiting.

According to the Indian
Council of Medical Research (ICMR), the H3N2 virus has been responsible for a significant increase in flu cases in India in recent weeks.

Doctors from other hospitals stressed the importance of covering the nose and mouth when sneezing, staying at home if ill



ruses, including influenza and RSV, peaks in winter.

Dr Fayaz Ahmad, Assistant Professor at General Medicine SKIMS Soura, said many patients with upper respiratory tract symptoms have been visiting hospital OPDs, with most presenting flu-like illness. He called upon the people to wear masks, especially in crowded places, shops, malls, and public transport. People should keep themselves warm and hydrated, consume more fruits and vegetables, and consider getting flu shots if they haven't already

The symptoms of the H3N2 flu virus currently circulating to prevent the spread of the virus, and avoiding high sugar and salt-containing foods to reduce dehydration. They recommended drinking plenty of water, eating fruits and green leafy vegetables, taking adequate rest and practising good hand hygiene.

Doctors said that respiratory tract infections are common in Kashmir from October to March due to cooler temperatures, increased indoor crowding, reduced humidity, and a weakened immune system. While there is no need to panic. they advised taking precautions to avoid the severity and spread of infections—(KNO)

n Jammu and Kashmir, a region marked by historical conflict that deeply affected its work environment, individuals who previously wielded influence entrenched themselves in the conflict, exercising a significant control on almost all the spheres of life. From time to time, they issued strict directives that disrupted the work culture, especially within the Education sector.

For years if not decades, a persistent issue plagued the schools in our region. The self-styled managers of the conflict would arbitrarily force the closure of schools for extended periods.

At the slightest provocation or due to their interference, schools would shut down for weeks on end, causing a substantial loss of instructional days throughout the academic year. This recurring practice persisted unchecked, resulting in a significant impact on students' education and disrupting the entire schooling system.

The routines of all staff members, particularly teachers, were so disturbed that specific individuals with vested interests manipulated the entire system, causing the education system in the valley to almost collapse. akistan is accustomed to living dangerously. Iskander Ali Mirza was Pakistan's last governor-general and its first president under the 1956 Constitution. His was the career of a military officer-turned-civil servant and, then, after the creation of Pakistan, he turned to politics. As president, he went on to stage a de facto coup, abrogate the Constitution, declare martial ity to return from exile twice; to ministen Novag Sharif andire he

own country were turned down.

To tell his side of the story of why he abrogated Pakistan's Constitution and paved the way for Ayub Khan — his nemesis — and of Pakistan's long tryst with military rule, Mirza had written an autobiography that had remained unpublished. Its publication now in Pakistan has reignited curiosity about the many ironies of his life and political career. Perhaps the greatest of these was that as a Bengali, he was the initiator of Pakistan's abrogation of its first

law, and appoint the then chief of army staff, Ayub

Khan, as the chief martial law administrator. But

within days, he found himself deposed and exiled to

London. Denied permission to return to Pakistan,

he died in London in relative obscurity in 1969. He

was buried in Tehran; requests for a burial in his

Constitution as well as its martial-law regime. His story also has parallels with the last days of another military dictator, General Pervez Musharraf, who died in exile in Dubai, although his body was buried with military honours in Karachi. These two instances of military generals and coups ending with exile also underline the contrast with the trajectories of civilian politicians. In the latter category, we find that alongside instances of being deposed, assassinated or even executed, there is a template of triumphal return from exile — a template denied to Pakistan's generals.

The late Benazir Bhutto demonstrated this abil-

ity to return from exile twice; the former prime minister, Nawaz Sharif, ending his exile in London and returning this October to spearhead his party's effort to regain political power is an even more striking illustration of the same screenplay.

With his return to Pakistan last month, a sliver of clarity over Pakistan's political direction has started emerging: the general election will be held in early February 2024. The pressure on the other former prime minister, Imran Khan, now in jail, continues and the vectors in favour of Nawaz Sharif appear to have an irreversible traction. There are still naysayers however — after all, February is still some time away.

Nawaz Sharif being a key element in a military-led concert expected to form the next government is ironic. He had been ousted by the army thrice—through backroom conspiracy, through a military coup and, finally, through what was a judicial coup. His countrymen have taken this in their stride. Things in Pakistan are seldom straightforward: as Benazir Bhutto once wrote, "There are always circles within circles, rarely straight lines."

Will Nawaz Sharif's return to power and a smooth interface with the military provide Pakistan with the stability it so desperately needs? Many hope so. But even the most optimistic are daunted given the scale of issues Pakistan confronts even beyond its splintered politics and perpetually imbalanced civil-military relationship. A tottering economy for which there are no easy answers is eas-

ily at the top of the list. Perhaps even more serious is the erosion of public confidence and morale as terrorist attacks acquire a frequency and intensity reminiscent of Pakistan's age of trouble between 2007 and 2015.

The latest attack on a Pakistan air force base recalls earlier episodes when defence installations were targeted almost at will by the Tehrik-e-Taliban Pakistan. This latest attack also coincided, as in the past, with a deterioration in Pakistan-Afghanistan relations. There is in Pakistan a deep sense of grievance that the Taliban, which has been in power since August 2021, has not done anything to curb the Tehrik-e-Taliban and its attacks on Pakistan. This accumulated tension has now acquired a new front. After a series of terrorist attacks, Pakistan has started deporting a large number of Afghan refugees regarded as unregistered and 'illegal' residents.

The presence of numerous Afghan refugees in Pakistan has been a central factor in the relationship between the two countries for four decades. That Pakistan used these refugees to advance its interests is well-known: various mujahideen groups and the different iterations of the Taliban were all incubated in the refugee camps of Pakistan. But the other aspect of this story is seldom heard outside Pakistan—that it has shouldered an extraordinary burden of 3-4 million refugees for such a long period of time notwithstanding its own resource constraints. It is a measure of the failure of Pakistan's

Afghan policy that its search for the elusive 'strategic depth' in Afghanistan has meant that it has comprehensively squandered the goodwill it could have legitimately earned from the refuge it has provided to so many Afghans for so long. The large-scale deportations now underway mean that even more trouble in the coming months can be easily forecast across the Af-Pak border.

Notwithstanding the drama of its domestic issues, what is also present in Pakistan is an extraordinary level of interest in the daily tragedy unfolding in Gaza. This is not surprising; there is always high priority attached to what is happening in the world of Islam and the interest is even higher if the contestation is with a non-Islamic player. To many in Pakistan, Palestine is a metaphor for its own failure vis-à-vis Kashmir as well as a more general indictment of the West and the loss of power of the Islamic world.

The Gaza situation may not directly impact Pakistan in a tangible way but it contributes to the cocktail of different frustrations brewing in that country — a restive Af-Pak border, mounting terrorist attacks, and a failed economy. In case Nawaz Sharif's present trajectory continues uninterrupted and the February election tilts in his favour, he may well find his next tenure as prime minister to be the most onerous of all. Triumphal returns may be the politicians' preserve in Pakistan but they can also be a crown of thorns.

Shining A Light On Winter Depression


inter does not officially begin until Dec. 21, but as the days grow shorter and sunlight exposure becomes scarcer, seasonal affective disorder (SAD) becomes more common. SAD is a type of depression that occurs during the late fall and early winter and often ends by spring or early summer. The exact cause of SAD is unknown, but research points to lack of light as the main contributor.

"SAD is not a minor condition, but because people typically experience it only during certain months, they don't see it as a serious issue. However, it is imperative to treat," says Dr. Paolo Cassano, a psychiatrist who specializes in low-level light therapy at Harvard-affiliated Massachusetts General Hospital.

Chemical imbalances

How does SAD occur? Sunlight exposure stimulates the hypothalamus, a part of the brain that helps control your circadian rhythm – the body's internal 24-hour sleep-wake

Lack of light can throw off your circadian rhythm. This can cause your brain to produce too much of the sleep hormone melatonin and to release less serotonin, the feel-good brain chemical that affects mood. The result of this chemical imbal-



ance? You feel low and lethargic. Other common symptoms of SAD include lack of sexual energy, overeating (especially from craving high-

carbohydrate and high-calorie comfort food), and social withdrawal. SAD affects more than just mood.

cognitive function, including problems with concentration and working memory – like having trouble It is also associated with impaired recalling just-learned information or finding the right words when speak-

People who live in the northern states, where there's noticeably less light in fall and winter, tend to suffer more from SAD than those who live in the south. A family history of SAD or depression also raises your risk.

Drugs and light therapy

The most common drugs used to treat SAD are antidepressants. Bupropion (Wellbutrin) primarily increases levels of dopamine, while selective serotonin reuptake inhibitors (SSRIs) and serotonin-noradrenaline reuptake inhibitors (SNRIs) increase mostly serotonin levels.

If medication is not for you, or you want to avoid drugs because of possible side effects, then light therapy may be a better option. The idea behind light therapy is to replace the missing sunshine with artificial light.

Light therapy uses light boxes that produce a bright white light. As far as your brain is concerned, artificial light works just like natural sunlight. "Even if you don't yet have the clinical signs and symptoms of SAD, using light therapy during the winter may help prevent it," says Dr. Cassano.

There are many light boxes available online. Here are some tips for finding the right one and using it

Get enough exposure. Your light box should have 10,000 lux exposure. ("Lux" is a measure of light intensity.) A bright sunny day is 50,000 lux or more.

Don't stare. Keep your eyes open, but don't look directly at the light. Keep the box in front of you or just off to the side and about a foot away. "Spend your time reading, meditating, or watching TV," says Dr. Cassano.

Get enough time. You should absorb light for about 30 minutes a dav. You don't have to do it all at once, either

Begin in the morning. Try to get in some light time before 10 a.m.

"As days become longer and sunnier, you will use light therapy less often, or may even stop during the spring and summer except for the occasional cloudy weeks," says Dr. Cassano.

Light therapy is relatively safe, although there can be some minor, temporary side effects like headaches and irritability.

Also, some medications, especially antibiotics like tetracycline, can make your skin more sensitive to light, and if you have a family history of macular degeneration, exposure to light therapy over the years may increase your risk. If any of these situations applies, check with your doctor before trying light therapy.

Sebi To Amend Rules To Facilitate Small And Medium REITs

MUMBAI: Sebi on Saturday decided to bring entities facilitating fractional investment in real estate under a regulatory framework, whereby they will be required to operate as Small and Medium Real Estate Investment Trusts.

Such SM REITs should be set up as a trust with the ability to establish separate scheme for owning real estate assets through wholly-owned special purpose vehicles constituted as a company, the regulator said.

Sebi's board, at its meeting on Saturday, approved amendments to REITs (Real Estate Investment Trusts) Regulations. 2014 in order to create a regulatory framework for the facilitation of SM REITs, with an asset value of at least Rs 50 crore vis-a-vis minimum asset value of Rs 500 crore for exist-

'SM REITs shall have the ability to create separate scheme (s) for owning real estate as-



sets through special purpose vehicle(s) constituted as companies, 'Sebi said in a release after its board meeting.

The proposed regulatory framework would help to develop the real estate market, provide investor protection measures and lead to an orderly development of the market.

The regulatory framework approved by the board for SM REITs provides for the structure, migration of existing structures meeting certain specified criteria, obligations of the investment manager including net worth, experience and minimum unit holding requirement, investment conditions, minimum subscription, distribution norms and valua-

Sebi Plans To Introduce Same Day Trade Settlement By March 2024

NEW DELHI: Capital markets regulator Sebi aims to introduce sameday settlement of trades on stock exchanges by March 2024 and eventually have real time settlement, its Chairperson Madhabi Puri Buch said on Saturday.

Already, the watchdog reduced the settlement timelines to as short as one day.

"Sebi wants the T plus zero (T+0) settlement norm to be in place from March-end 2024 and T plus instantaneous settlement 12 months from thereon," Buch told reporters here after the regulator's board meeting.

T+0 refers to the same-day settlement of trades and instantaneous settlement means settling the

transactions on a real time basis. According to Buch, market markers are of the view that it makes better sense to move directly from T+1 hour to T+instantaneous as there is no benefit to be drawn from the middle ground which is T+0.

The investment banker-turnedregulator said that Sebi is "fully open" to the suggestions made by the market makers on instanta-

neous settlement of trades. She said that the new settlement

will be parallel to the existing settlement system and will fully be optional.

Moreover, it will be available on select large products, and even that will be optional to choose from.

4 convicts get rigorous life sentence for killing TV journalist Soumya Vishwanathan in 2008

New Delhi: In a rare order, a Delhi court on Saturday handed down double rigorous life imprisonment to four members of an organised crime syndicate for killing TV journalist Soumya Vishwanathan around 15 years

The special court awarded two life imprisonments to Ravi Kapoor, Amit Shukla, Baljeet Malik and Ajay Kumar under Section 302 (murder) of the Indian Penal Code (IPC) and U/s 3 (1) (1) of The Maharashtra Control of Organised Crime Act (committing organised crime resulting in the death of any person) and made clear that they will run "consecutively".

Vishwanathan, who was working with a leading English news channel, was shot dead in the early hours of September 30, 2008, on south Delhi's Nelson Mandela Marg while she was returning home from

The special court did not agree to the vehement submissions of the prosecution seeking the death penalty, saying the act of the four convicts to murder the victim does not fall within the category of "rarest of rare cases".

Referring to some apex court verdicts, guidelines regarding the sentencing policy, submissions on behalf of the state and on behalf of the convicts and the pre-sentence report as filed

by the probation officer, the court said, "the present case and the act of the (four) convicts to murder the victim do not fall within the category of rarest of rare cases category in which the death penalty can be imposed.'

The court also observed that it was "unfortunate" that Vishwanathan who was a "young, dynamic and hardworking journalist" lost her life due to the act of the convicts.

While sentencing Kapoor, Shukla, Malik and Kumar to double life imprisonment, the court also imposed a fine of Rs

It also handed down three years of simple imprisonment to the fifth convict Ajay Sethi under IPC section 411 (dishonestly receiving stolen property).

It, however, underlined that Sethi had remained in custody for more than 14 years and accordingly the convict was sentenced to the period already undergone in incarceration during the trial for the offences under IPC Section 411 and MCOCA provisions for conspiring to abet, aid, or knowingly facilitate organised crime and receiving

proceeds of organised crime. The court imposed a fine of Rs 7.25 lakh on Sethi.

During the trial, the prosecution sought maximum punishment of death penalty for the four convicts, saying they had murdered the victim in a coldblooded manner, without any reason or previous enmity, to rob her for the financial

syndicate. It said the convicts had caused the victim's death by firing upon her "while treating her as a prey" and there was no provocation on the victim's part.

Citing an International Labour Organisation (ILO) report, the court said, 52 per cent of women in India express a

desire to work either in paid jobs or in both paid jobs and care for families and home, but India's female work participation rate has been declined over past two decades, dropping from 32 per cent in 2005 to 19 per cent in 2021.

"One of the reasons for the decline in the women's workforce is that women face a higher risk of harassment, abuse and assault while travelling to the workplace from their home and from the workplace to their home," the court said.

"Women empowerment in the workforce will get momentum if the women's safety during their daily commute is ensured. After the incident of the Nirbhaya case, the Indian Parliament has enacted and the government has formulated many welfare legislations and schemes... to ensure the safety and well-being of the women at

workplace...," the court added.
The court further said that if the total fine amount was paid by all the convicts, then Rs 12 lakh was to be released as compensation to the parents of the victim, Rs 20,000 be deposited as litigation expenses and Rs 5,000 be paid as fine to the state.

According to the prosecution, Kapoor shot Vishwanathan with a country-made pistol while chasing her car to rob her. Shukla, Kumar and Malik were also with Kapoor. Police recovered the car used in the murder

It may take long time to rescue 41 workers trapped in Silkyara tunnel: NDMA

New Delhi: The operation to rescue 41 workers trapped in the Silkyara tunnel may take a long time with the auger machine for horizontal drilling facing repeated hurdles, and rescuers are now preparing to start vertical drilling. the National Disaster Management Authority (NDMA) said on Saturday.

The vertical drilling will start in the next 24 to 36 hours, NDMA member Lt Gen (retd) Syed Ata Hasnain said, adding the front part of the auger machine was broken and efforts are being made to retrieve those from the tunnel.

"We need to have patience as it is a dangerous operation ... 'is operation main lamba samay lag sakta hai' (this operation may take a long time)," he said, without mentioning any timeline for the completion of rescue

According to Hasnain, this rescue operation is getting technically more

He also said that advanced machinery is required to cut the stuck parts of the auger inside the tunnel, and the assistance of the Indian Air Force is being sought to airlift this machinery.

Besides the two options being adopted now, we may perhaps adopt a third method of drift tunnel as well. However, there is no certainty about it

The multi-agency rescue effort began November 12 when a portion of the under-construction tunnel on Uttarakhand's Char Dham route collapsed following a landslide, trapping workers inside. Asked to comment on micro tunnelling expert Arnold Dix's remarks that the 41 trapped workers would come home by Christmas, Hasnain said, "When you look at any problem from a distance, then you get the correct picture."

"Wahan par se kisi ka yeh kehna ki 20 din ya 45 days lag jayega rescue karne me, toh main nahi samajhta hun ki woh shobha deta hai' (It will be insensitive on the part of anyone to say that rescue operation to bring workers out will take 20 days or 45 days)," he added.

New Study Challenges Common Belief About The Brain's Ability To 'Rewire' Itself

Anew study is challenging the long-held belief that the brain possesses the extraordinary ability to rewire itself in the face of adversity. Scientists from the University of Cambridge and Johns Hopkins University have launched a daring assault on the widely accepted notion that the brain reorganises and repurposes specific regions to compensate for vision loss, amputation, or

Published in the eLife journal, Professors Tamar Makin and John Krakauer present a paradigmshifting revelation: the brain isn't rewiring itself; it's unearthing hidden talents that lie dormant

Traditionally, it was believed that individuals who lost their sight, or were born blind, witnessed their visual cortex rewiring to process sounds, enabling them to navigate through the world using an astonishing form "echolocation." Similarly, stroke survivors were thought to enlist alternative brain areas to regain control over their paralyzed limbs.

Renowned neuroscientist John Krakauer, Director of the Center for the Study of Motor Learning and Brain Repair at Johns Hopkins University, acknowledges the allure of the brain rewiring concept. The captivating tales of the blind acquiring superhuman echolocation skills and stroke victims achieving miraculous recoveries fueled this captivating notion. However, Krakauer boldly claims that the explanation behind these phenomena is

fundamentally flawed. Makin and Krakauer meticulously dissected ten influential studies that supported the brain rewiring theory. They contend that while these studies indeed demonstrate the brain's ability to adapt, they fall short of substantiating the creation of entirely new functions in unrelated regions. Instead, the brain taps into latent capacities that have been silently present since birth.

Drawing from her own groundbreaking research, Makin's 2022 study replicated the effect of amputation using a nerve blocker. Astonishingly, the findings unveiled that signals from adjacent fingers were already mapped onto the brain region responsible for the soon-to-be-amputated finger. Consequently, the brain region didn't exclusively process signals from the forefinger but rather amplified the processing of existing signals from other fingers.

Makin emphasises that the brain's response to injury isn't about seizing control of new brain regions for entirely dif-ferent purposes. Rather, it's a matter of existing brain regions enhancing or reshaping their pre-existing architecture through repetition and learning. The researchers passionately stress the importance of grasping the true nature and boundaries of brain plasticity to set realistic expectations for patients and guide rehabilitation practitioners.

'Amaterasu' Particle: Mysterious Cosmic Ray Leaves Physicists In Awe

Scientists have recently made an intriguing discovery by detecting the second-most powerful cosmic ray originating from beyond our galaxy. This "ultrahigh-energy" particle, named the 'Amaterasu' particle after the sun goddess in Japanese mythology, has left researchers astounded by its sheer power.

Cosmic rays are charged particles, like protons or electrons, that travel through space at nearly the speed of light. These



cosmic rays may be remnants of celestial events that have disintegrated matter into its subatomic components. Due to their charged nature, cosmic rays

follow a zigzagging flight path as they navigate through electromagnetic fields in the cosmic microwave background.

The research was conducted at

the Telescope Array located at the University of Utah, the same facility where the highest-energy cosmic ray ever recorded, known as the 'Oh-My-God' particle, was discovered in 1991. This particle was a source of great perplexity for physicists as it was believed that nothing within our galaxy could generate such high-energy cosmic rays. Moreover, it was previously thought to be impossible for cosmic rays to reach Earth from other galaxies.

Published in the journal Science, the study describes how the international team of physicists measured the particle's energy at a remarkable 2.4 x 10^20 electron Volts (eV). The discovery of the 'Amaterasu' particle has provided scientists with more questions than answers.

Scientists are still searching for a conventional explanation for these phenomena and speculate that they may involve particle physics yet to be discovered. The trajectory of the 'Amaterasu' particle, cannot be traced back to any known high-energy source, adding to the mystery surrounding these cosmic rays.
